Joblessness Rate In J&K Down By 9% In September: Report

ven as there was a substan-**⊿**ployment rate in Jammu and Kashmir in the month of August, the joblessness rate has come down by over 9 percent in the Union Territory in September, as per Centre for Monitoring Indian Economy (CMIE).

According to the CMIE data, even though J&K's unemployment rate was higher than the national average, it still saw a decline in September as the rate came down to 23.2 percent

compared to the previous month's 32.8 percent. The latest UR for the month of September has brought some respite as the UT registered a 9.6 percent decline in the joblessness rate against the previous month.

As per reports, J&K's higher than national average unemployment rate is primarily because of the slower economic growth resulting in fewer job opportunities and also due to a much lower resilience to absorb the pandemic shock.

In August, J&K's unemployment rate had soared up to a six



year high when it touched 32.8 percent. Amid the unrest of 2016, J&K's unemployment rate stood at 25.3 percent in September, 26.3 percent in October and 29.9 percent in November.


The latest unemployment figures have also brought forth that Rajasthan has the highest Unemployment rate at 23.8 percent followed by J&K and Haryana where the UR stood at 22.9 percent. J&K has the second highest Unemployment rate in India, as per CMIE. As per the data available, unemployment figures in the UT have sporadically changed since the start of 2022, showing an astronomical rise since last year.

As per CMIE, since the start of this year, there has been an increase of over 11 percent in

the month of January, the data notes, J&K's UR stood at 15 percent. Though in the month of February it dipped down to 13.2 percent but in March the rate took an ugly turn and jumped to a grueling 25 percent. However, the rate came down in the following months till July.

Pertinently, a superficial look at the month of march, when I&K was standing at an unemployment rate of 25%, had brought into forth that roughly over 1.1 million people were jobless in J&K. | More on P10



COVID-19 Pandemic Linked To Altered Personality In Young Adults: Study

The COVID-19 pandemic may have changed personality of people, especially in younger adults, according to a study conducted in the US.

Previous studies have found no associations between collective stressful events -- such as earthquakes and hurricanes and personality change, the researchers said.

However, the coronavirus pandemic has affected the entire globe and nearly every aspect of life, they

The researchers from Florida State University College of Medicine in the US used longitudinal assessments of personality from 7,109 people enrolled in the online Understanding America Study.

They compared five-factor model personality traits -neuroticism, extraversion, openness, agreeableness and conscientiousness --between pre-pandemic measurements (May 2014 - February 2020) and assessments early (March -December 2020) or later (2021-2022) in the pandemic. A total of 18,623 assessments were analysed.

Participants were 41.2 per cent male and ranged in age from 18 to 109. Consistent with other studies, there were relatively few changes between pre-pandemic and 2020 personality traits, with only a small decline in neuroticism.

However, the study published in the journal PLOS ONE, found declines in extraversion, agreeableness, and conscientiousness when 2021-2022 data was compared to pre-pandemic personality. The changes were about one-tenth of a standard deviation, which is equivalent to about one decade of normative personality change, the researchers said.

The changes were moderated by age, with younger adults showing disrupted maturity in the form of increased neuroticism and decreased agreeableness conscientiousness, and the oldest group of adults showing no statistically significant changes in traits, they said.

Srinagar: A meeting of District Road Safety Committee (DRSC) was Saturday held under the Chairmanship of Deputy Commissioner (DC), Srinagar, Mohammad Aijaz Asad to review the measures taken with regard to review of decisions taken in last DRSC meeting to decongest heavy load routes for smooth traffic flow in Srinagar City.

The meeting held threadbare deliberations on various issues with regard to management of Traffic in Srinagar City including identification of black spots, improvement of lighting on vital roads, Traffic Management System, decongestion of traffic pressure on various routes, behavioral change towards road safety, analysis of accidental data, establishment of Inspection & Certification Centre (ICC), status of road accident funds, rescue and evacuation measures by health Department etc.

On the occasion, the DC stressed upon all the officers to be proactive in implementation of the Road Safety Action Plan on priority basis for better management of the traffic system. He stressed on the concerned officers to take all required measures to decongest the City roads to ensure smooth flow of traffic.

The DC stressed for repairing black spots, initiating remedial measures, installation of signages and painting of roads at appropriate spots and generation of awareness for making roads safer in the district. He directed the R&B Department to improve roads marking and signage to eliminate high risk stretches, black spots, improvement of junctions on all cross-roads and improve road lighting near habitations.

Further, the DC instructed to remove road side objects that hinder smooth traffic ply. He also asked the officers to take measures to improve traffic congestion and facilitate movement of pedestrians as well as commuters.

With regard to behavioural change towards road safety, the DC emphasised on conducting awareness programs by the line Departments on Traffic rules and regulations for mass sensitization to inculcate traffic sense among them.

During the meeting, it was decided to prepare DPRs for construction of underpass roads at major traffic crossings in various parts of the City like Jehangir Chowk, Bemina, Nowgam and SMHS Hospital to facilitate the people crossing over the road and avoid accidents.

European Team Arrives On Fact-Finding Mission

RINAGAR - Top diplomats from four European Union (EU) countries, including the European Commission envoy in New Delhi, arrived here Monday on a factfinding mission. The team led by EC ambassador Mi-chel Caillouet met the leaders of All Parties Hurriyat Conference at their Rajbagh headquarters soon after their arrival in the capital. The delegation is scheduled to have meetings with top government officials as well tomorrow.

The team includes ambassadors Guy Trouveroy of Belgium, Bernard de Monteferrand of France and Johaa Nordenfelt of Sweden. The delegation spent an hour and a half at the APHC headquarters where top leaden of the alliance including Chairman Prof Abdul Ghani, Syed Ali Geelani, Maulana Abbas Ansari and Sheikh Abdul Aziz were present. Emerging from the meeting EU ambassa¬dors ducked questions from reporters present there about the nature of discussions with the APHC leaders. When the French envoy Monteferrand was asked specifically whether they had brought a new proposal for solving the Kashmir issue, he parried the question and said the purpose of their visit was of the same nature as the previous ones. He said the Indian government was aware of the purpose of their current visit.

Sources however said during the meeting the EU delega¬tion informed the APHC leaders that India and Pakistan were being persuaded to resume talks on Kashmir. The delegation was keen for APHC to enter into a dialogue with New Delhi and wanted to know the reasons for Hurriyat's reluctance for such their current visit. Afghan Women Protest "Hazara Genocide" After 20 Die In Kabul Bombing

Kabul: Dozens of women from Afghanistan's minority Hazara community protested in the capital Saturday after a suicide bombing a day earlier killed 20 people -- mostly young women

from the ethnic group.

A bomber blew himself up on Friday at a Kabul study hall as hundreds of pupils were taking tests in preparation for university entrance exams in the city's Dasht-e-Barchi area.

The western neighbourhood is a predominantly Shiite Muslim enclave and home to the minority Hazara community -a historically oppressed group that has been targeted in some of Afghanistan's most brutal attacks in recent years.

Police said at least 20 people were killed but the United Nations has put the number at 24.

On Saturday about 50 women chanted, "Stop Hazara genocide. it's not a crime to be a Shiite", as girls," protester Farzana Ahmadi, 19, told AFP.

"We demand a stop to this genocide. We staged the protest to demand our rights.'

Protesters later gathered in front of the hospital and chanted slogans as dozens of heavily armed Taliban, some carrying rocket-propelled-grenade launchers, kept watch.

Since the hardline Taliban returned to power last August, women's protests have become risky, with numerous demonstrators detained and rallies broken up by Taliban forces firing shots in the air.

No group has claimed responsibility for Friday's attack at the Kaaj Higher Educational Centre.

But the jihadist Islamic State (IS) group regards Shiites as heretics and has previously claimed attacks in the area targeting girls, schools and mosques.

The Taliban also regard the Hazara community as heathens, and rights groups often accused



they marched past a hospital in Dasht-e-Barchi where several victims of the attack were being treated.

Dressed in black hijabs and headscarves, angry protesters carried banners that read: "Stop killing Hazaras", an AFP correspondent reported.

Witnesses have told AFP that the suicide attacker detonated in the women's section of the gender-segregated hall.

"Yesterday's attack against the Hazaras and Hazara the Islamists of targeting them during their 20-year insurgency against the former US-backed government.

Since returning to office the Taliban have pledged to protect minorities and clamp down on security threats.

However, rights group Amnesty International said Friday's attack was "a shamefaced reminder of the inaptitude and utter failure of the Taliban, as de-facto authorities, to protect the people of Afghanistan".

India Abstains From UN Vote Against Referendums In 4 Ukraine Regions



United Nations- India has abstained on a draft resolution tabled in the UN Security Council which condemned Russia's "illegal referenda" and annexation of four Ukrainian territories and called for an immediate cessation of violence while underlining the need to find pathways for a return to the negotiating table.

The 15-nation UN Security Council on Friday voted on the draft resolution tabled by the US and Albania that condemns Russia's "organisation of illegal so-called referenda in regions within Ukraine's internationally recognised borders." The resolution declares that Russia's "unlawful actions" with regards to the "illegal so-called referenda" taken on September 23 to 27 this year in parts of Ukraine's regions of Luhansk, Donetsk, Kherson, and Zaporizhzhya that are under Russia's temporary control can have "no validity" and cannot

form the basis for any alteration of the status of these regions of Ukraine, including any "purported annexation" of any of these regions by Moscow.

The resolution failed to get adopted as Russia vetoed it. Of the 15-nation Council, 10 nations voted for the resolution while China, Gabon, India and Brazil abstained.

In the explanation of the vote, India's Permanent Representative to the UN Ambassador Ruchira Kamboj said that India was deeply disturbed by the recent turn of developments in Ukraine and New Delhi has always advocated that no solution can ever arrive at the cost of human lives.

"We urge that all efforts are made by concerned sides for the immediate cessation of violence and hostilities. Dialogue is the only answer to settling differences and disputes, however daunting that may appear at this moment," she said.

"The path to peace requires us to keep all channels of diplomacy open," she said, adding that Prime

Minister Narendra Modi "unequivocally conveyed" this in his discussions with world leaders, including with Russian President Vladimir Putin and Ukrainian President Volodymyr Zelenskyy.

She also referred to statements made by External Affairs Minister S Jaishankar on Ukraine during the high-level General Assembly session last week.

Referring to Modi's remark to Putin on the sidelines of the SCO Summit in Uzbekistan's Samarkand that "today's era is not an era of war", Kamboj said New Delhi sincerely hopes for an early resumption of peace talks to bring about an immediate ceasefire and resolution of the conflict.

"India's position has been clear and consistent from the very beginning of this conflict. The global order is anchored on the principles of the UN Charter, international law and respect for sovereignty and the territorial integrity of all states. Escalation of rhetoric or tension is in no one's interest," she said

Varanasi University Guest Lecturer Sacked After Social Media Post On Navratri Fast

Varanasi: The Mahatma Gandhi Kashi Vidyapeeth has dismissed a guest lecturer and banned his entry "in view of the university atmosphere getting vitiated and examinations affected" after he wrote on social media that women should read the Constitution and the Hindu Code Bill "instead of fasting for nine days during navratra"

Registrar Sunita Pandey said the action was taken after students complained about Mithilesh Kumar Gautam, the guest lecturer, through a letter.

In his social media post in Hindi, Gautam had written, "For women, it is better to read the Constitution of India and the Hindu Code Bill instead of fasting for nine days Navratra. Their lives will be

free from fear and slavery. Jai Bheem." In an office order, Pandey said, "On September 29, students

had complained through a letter stating that Dr Mithilesh Kumar Gautam, a guest lecturer in political science department, had posted some material on social media, which is against Hindu religion." Pandey cited "widespread resentment" among students against Gautam for the action.

"...In view of the university atmosphere getting vitiated and examinations affected, I have been directed that Dr Mithilesh Kumar Gautam be dismissed with immediate effect, and his entry into the university campus be banned in view of security," Pandey said in the order.

Gautam could not be contacted for comments despite repeated efforts. His phone was switched off.

Anuj Srivastava, an office-bearer of the Akhil Bharatiya Vidyarthi Parishad, said Gautam's comments were "wrong", and the university had taken an "appropriate step".

However, Lucknow University Associate Professor of Hindi Ravikant Chandan questioned

"I had seen that post. There was nothing unconstitutional in it. Our Constitution says that there should be scientific India. We have the freedom of

expression, and the post is related to freedom of women. It is a simple and ordinary post. Now, the question

is whether logic ceases to exist in new India. Secondly, he (Mithilesh Kumar Gautam) is a Dalit teacher," Chandan told PTI.

"First they (apparently referring to the BJP) had attacked Muslims, and now they are targeting Dalit activists, teachers and social workers. And this is happening in educational institutes, because educated people are there. Nobody will ask how many hours a teacher has taught.'

Dubai: Saudi Crown Prince Mohammed bin Salman's new title of prime minister, announced this week, could prove more significant abroad than inside the kingdom where he already wields enormous power. The appointment by royal decree comes ahead of a deadline for US President Joe Biden's administration to weigh in on whether Prince Mohammed qualifies for immunity from lawsuits filed in American courts.

The 37-year-old de facto ruler of the world's biggest crude exporter has been targeted in multiple such lawsuits in recent years, notably over the 2018 killing of Saudi journalist Jamal Khashoggi in the kingdom's Istanbul consulate, which temporarily turned him into a pariah in the West.

His lawyers have argued in filings that he "sits at the apex of Saudi Arabia's government" and thus qualifies for legal immunity.

Human rights activists and government critics immediately speculated this week that make ing Prince Mohammed prime minister was a bald-faced attempt to strengthen the immunity claim and skirt legal exposure. Sarah Leah Whitson, executive

director of the NGO Khashoggi founded Democracy for the Arab World Now (DAWN), told AFP it was a "last-ditch effort to conjure up a new title for him" -- in other words, "a title-washing ploy". Saudi officials did not respond to requests for comment about the move.

Hit squads and hacks

In October 2020, two years after Khashoggi's death, DAWN filed a complaint in the United States along with Khashoggi's fiance, Hatice Cengiz, accusing Prince Mohammed of involvement in a "conspiracy" that led to Khashoggi being kidnapped, bound, drugged, tortured and assassinated.

Last year, Biden declassified an intelligence report that found Prince Mohammed had approved the operation against Khashoggi, an assertion Saudi

He was also named in a law-

suit filed by Saad al-Jabri, a former top intelligence official who fell out of favour as Prince Mohammed manoeuvred to become first in line to the throne in 2017.

That complaint accuses Prince Mohammed of trying to lure Jabri back to Saudi Arabia from exile in Canada -- then, when that didn't work, "deploying a hit squad" to kill him on Canadian soil, a plot foiled when most of the would-be assailants were turned back at the border.

In yet another case, Prince Mohammed was accused by Lebanese journalist Ghada Oueiss of involvement in a scheme to hack her mobile device and disseminate "stolen personal images" to defame her and prevent her from reporting on human rights issues.

The immunity question appeared to come to a head over the summer, when a US judge gave Biden's administration until August 1 to say whether it believed Prince Mohammed qualified.

After Biden visited Saudi Arabia in July, abandoning a previous pledge to turn Saudi Arabia into a "pariah", his administration requested an additional 60 days to decide whether to weigh in on the matter.

The new deadline falls no later than Monday.

'In control' at home

Before this week's announcement, Prince Mohammed, often referred to by his initials "MBS", had been serving as deputy prime minister and defence minister, managing major portfolios from energy to security and beyond.

Little is expected to change within the kingdom because of his new title, said Umar Karim, an expert on Saudi politics at the University of Birmingham.

"MBS was already completely in control, and there was no threat as such to him that could be countered by him becoming prime minister," Karim said.

At the same time, it is not clear whether becoming prime minister will significantly bolster Prince Mohammed's claim of immunity, given that King Salman remains head of state.



During last 5 days, the team had comprehensive discussion with Project Management Unit of Jhelum Tawi Flood Recovery Project and various Project Implementation Units JKERA, PWD (R&B), I&CD, SMC, which are executing various sub-projects under different components of World Bank funded Jhelum Tawi Flood Re-

covery Project. Dr Syed Abid Rasheed Shah, Chief Executive Officer J&KERA, during his meeting with World Bank team, said that 143 sub-projects, out of the total of 213 sub-projects, have been completed under different components of JTFR project. He added that an expenditure of Rs 1131.51 crore has been incurred under the project, so far. The completed sub-projects in-

teractions with school children and teachers at these newly constructed BaLa schools.

During visit to two 300 LPM Oxygen Generation Plants constructed by J&KERA at Gaghwal and Hiranagar Hospitals, the team interacted with medical professionals working in these hospitals.

Team also visited under construction (50m) steel motorable bridge from Katheel Ganjoo to Barsoa over Ghordi Nallah and 50 M span steel bridge from Barsoa to Patri over Barmeen Nallah in Udhampur district being constructed by J&KERA at a cost of Rs 13.24 crore.

Meanwhile, a PowerPoint Presentation was also made by the Director Technical, J&KERA giving out details of progress achieved on implementation of World Bank funded Jhelum Tawi Flood Recovery Project in Jammu division.

Available Options

ith both the Congress and the Peoples Democratic Party (PDP) stuck on the issue of the chief ministership, it seems that the state is heading for another spell of the Central rule. The Congress Party that has returned to the center stage of the state politics after a gap of nearly thirty years without ostensible props from New Delhi is looking forward for consolidating otherwise its fragile base in the state. It believes that it can convert the proxy support, which it got during the elections, into real support if it has its own Chief Minister. Mufti Muhammad Sayed being an inside man, the Congress is equally apprehensive of him for being capable of weaning away rank and file from it. The former home minister who has a deeper knowledge of the Kashmir politics and better understanding of intricacies believes that both the National Conference and the All Parties Hurriyat Conference can be fought back by playing on the regional sentiments. Addressing a press conference in Srinagar on Tuesday he said that the people of Kashmir have given a verdict in favour of his party, the PDP. He also said that a regional party would be able to deliver more than the Congress because a national party has its own limitations and constraints.

There can be no denying that the rise of the PDP against the ruling National Conference has been phenomenal. Having suffered the atrocious rule of the National Conference during past six years the people particularly in the rural areas looked at the PDP as a better choice for local governance. But it is naïve of the party leadership to think that it cannot contribute much towards its agenda with out having a Chief Minister from the party. It is question of understanding one's role. It is God send opportunity to the party to create a place in the minds and hearts of people of Kashmir. It will wield more power by supporting the Congress party from outside and play a key role in improving ground situation in the state. Instead of asking for a greater slice of power it can even extend a conditional support to the Congress. There are many important issues on which the party needs to enter into an agreement with the national party before extending support to it. Many a draconian laws were introduced during the Central rule in the state and Farooq Abdullah government only provided sharper teeth to these laws. Many an extra-constitutional authorities have come up in the state during past few years. Barrages of miseries have descended on people during past six years. These extra-constitutional authorities who are outside the purview of any law have immensely contributed to the miseries of the people. If PDP succeeds in winding up these authorities it would be far more important contribution than building a bridge or a culvert. The people of the state at this juncture need a healing touching. If PDP is in a position to make the Congress Party to agree to institution of a commission against the misrule of National Conference and if it succeeds in getting delinquent super bureaucrats who had taken the state as their fiefdom it would be greatest achievement of the Party. "Kaun Baneygha Chief Minister" should not come in the way of formation of the government. The issue can be resolved amicably. There are many an options for coming out of the stalemate. The coalition partners can have a Chief Minister on term basis or there can be Chief Minister from one party and Deputy Chief Minister from the other. Both the PDP and Congress need to play a constructive role. Another spell of the

Preaching Meliorism

Gandhianism and Its Universal Relevance

on-violence is the greatest force at the disposal of mankind. It is mightier than the mightiest weapon of destruction devised by the ingenuity of man."

THE above lines were articulated by one of the towering figures of the world whose instrument of transforming the society was based on the notion of love, courage, self-analysis, patience, tolerance, humility, ahims and Satyagraha.

This eminent figure practised the already present principles and philosophies of non-violence and truth by experimenting with them in every facet of life. The man whose moral dictums became the symbol of "resolute will and determination" and the courage of conquering "evil with good" against apartheid in South Africa made people to confer upon him the cognomen, Mahatma. American historian, Will Durant, best known for writing The Story of Civilization, rightly remarked that "Not since Buddha has India so revered any man. Not since St. Francis of Assissi has any life known to history been so marked by gentleness, disinterestedness, simplicity of soul and forgiveness of enemies. We have the astonishing phenomenon of a revolution led by a Saint".

Mohan das Karamchand Gandhi, a lawyer by profession, eliminated the darkness of colonialism by becoming the torchbearer of the freedom movement and ultimately making people drink the pearl of liberation. Although he was influenced by Russian author Leo Tolstoy, English art critic John Ruskin and American writer Henry David Thoreau, his philosophy had the "freshness and originality". He was deeply inspired by the sacred religious texts which include the Quran, the Bible, Gita and Upanishads. Buddhism and Jainism also left profound impressions on his mind. Tolstoy enunciating on social service, power and Thoreau's self experiments and civil disobedience gave Gandhi the technique of utilising non-violence for solving major and minor social and political issues. Thus these influencers implanted in him the seed of "simple and service-oriented personality" and he polished them in a remarkable way. Gandhi not only propounded or emphasised the notion of Non-violence and Truth but he walked through these principles; he ingrained and absorbed these tenets to the depth of its core.

Non-violence and Truth: The kernel of Gandhi's philosophy

According to Gandhi, Non-violence and Truth are inextricably bound together and it's hard to untangle them; he allots a superior position to the latter one because he contends, it is the end which can be achieved by the means of ahims. He highlighted 'means' and 'end' in order to assert the significance of journey and destiny; both are unalienable to each other. Furthermore, underlining the notion of ahims , Gandhi defined negative and positive element of it where the latter aids in discerning the essence of the former. The word ahimsa is inferred as a non-injury to any living being but Gandhi goes beyond this by defining ahims, a method of avoiding violence in any form whether thought, action or deeds. Gandhi took the notion of non-violence from Jainism but he didn't heed to its rigid perspective rather he opined non-violence in certain circumstances is inevitable. He states "injury to any life can be an act of violence under certain conditions which include anger pride hatred and bad intention". Thus, the negative connotation of ahims is non-injury. Gandhi posits,


"In non-violence, one restrains all impulses. There is non-violence in violence as in the case of using violent methods to restrict the activities of a drunkard. As long as we live a mundane life, we cannot escape violence, but it is possible for us to restrict ourselves. Ahimsa is thus the highest type of renunciation"

Gandhi explained non-violence as the soul-force, a weapon of the strong while violence as the sign of weakness. He elucidates that the one who is violent conceals his/her anger under the cloak of violence accordingly exhibiting his inward fear through outward anger/violence. One can contend that Gandhi finds non-violence like a "radium, which works silently and ceaselessly, and transforms the whole mass of the diseased tissue into a healthy one"; similarly an infinitesimal quantity of true ahims can bring out an egalitarian society. Drawing inspiration from the Gandhi film director and producer Lord Richard Attenborough said, "When asked what attribute he most admired in human nature, Mahatma Gandhi replied, simply and immediately, 'Courage'. 'Nonviolence', he said, 'is not to be used ever as the shield of the coward. It is the weapon of the brave." Thus, one can speculate that Gandhian Ahims is based on the foundation of courage, love, self-restraint, and faith in God.

Love which is the strongest force in the world becomes the substratum for Gandhian philosophy of Ahims. Gandhi believes it is the love which cleans the inner self and elicits the feelings like "compassion, tolerance, generosity and sympathy for others". The absence of ill – will that Gandhi defends is not only confined for near ones/relatives but also for the opponents; according to Gandhi "Ahims is the largest love and the greatest charity".

Gandhi associates the concept of God with Ahims. He contends that true faith in God will assist an individual in achieving the tenet of ahims. It is prerequisite to generate the inner strength for attaining the faith, which eventually will act as a catalyst for developing the love for humanity. Gandhi says,

"Non-violence succeeds only when we have a living faith in God. Buddha, Jesus, Mohammed, they were all warriors of peace in their own style. We have to enrich the heritage left by these world teachers. God has His own wonderful way of executing His plans and choosing His instruments. The prophet and Abu Bakr trapped in a cave were saved



from their persecutors by a spider which had woven its web across the mouth of that cave. All the world teachers, you should know, began with a zero".

It is essential to comprehend the paradigm of ahims that Gandhi has put forth. The ending of desires and the elimination of evil from the hearts, acquired the highest seat in the Gandhian philosophy of non-violence. The simplicity and profundity of his message of love pellucidly make one realize that being selfless in love without any motive of gaining in return, elevates an individual to the highest state of ahims . As Gandhi rightly asserted, "Love never claims, it ever gives. Love ever suffers, never resents never revenges itself."

Gandhi was a strong votary of truth, he placed truth before non-violence. He claimed, "As a Jain muni once rightly said, I was not so much a votary of ahimsa as I was of truth, and I put the latter in the first place and the former in the second. For, as he put it, I was capable of sacrificing non-violence for the sake of Truth. In fact, it was in the course of my pursuit of Truth that I discovered non-violence".

He calls truth as the "moral virtue" which can be acquired through "fearlessness and nonpossession" because of these two one can stand against the injustice. And this will aid in realizing the truth in "metaphysical sense in which it is identical with God". He states the truth is "a cornerstone of the edifice" that leads to the path of God. He asserted "Ahimsa is my God, and Truth is my God. When I look for Ahimsa, Truth says 'Find it through me'. When I look for Truth, Ahimsa says, 'Find it out through me'. But he

In a nutshell, it postulates the annihilation of the disease, not the one who is affected by it. The base of Satyagraha is love, suffering, divine love – God. And the Satyagrahi has to be disciplined, honest, open-minded, determined and fearless. It is worth mentioning that Former US Vice-President and environmentalist Al Gore stated, "Mahatma Gandhi's philosophy of satyagraha can be translated to mean truth force. It is this truth-force which can help us to fight this battle honestly and with people's participation"

Is Gandhian philosophy Utopian?

It is important to question the pertinence of Gandhi in the contemporary time period. Many claim that Gandhian philosophy at present is limited to the classroom and books; they are sceptical if at all it can ameliorate the social, economic and political havoc generated not only in the Indian subcontinent but also in the world. What is palpable is the chasm that the world is encountering with the rise in nationalistic fervour, intolerance, moral hypocrisy, violence and political populism across the globe. If this is the current status quo then it is important to not only give prominence to Gandhi's theories and philosophies but to utilize them in order to dust off the menaces prevailing all across the globe.

Gandhi came as a herald to bring political transformation in a country which was scuffling with so many challenges. He believed that attainment of political emancipation from the colonists won't suffice

made a distinction between the relative and absolute truth; according to him the glimpses of the former one can be achieved but the absolute truth is hard to achieve.

On this Gandhi opines, "The relative truth must, meanwhile, be my beacon, my shield and buckler. Even the Himalayan blunders have seemed trifling to me because I have kept strictly to this path. I have gone forward according to my light. Often in my progress, I have had my faint glimpse of the Absolute Truth, God and daily the conviction is growing on me that he alone is real and all else is unreal...he who would go in for novel experiments must begin with himself. That leads to a quicker discovery of Truth, and God always protects the honest experimenter".

What is theoretical can be brought to practice when the true emphasis is laid upon values that Gandhi put forth. Therefore, it is imperative to understand the technique of ahimsa in order to achieve the moral virtue of life. He expressed that the truth should be of the speech, action, thought and it could be achieved through constant effort and discipline. It is in the truth, all knowledge is encapsulated and what is outside it is not the truth and hence is not knowledge. He calls Satyagraha as the truth-force against "violence, evil and injustice". It is this force which can create an equilibrium, that is, evil can't be demolished with evil rather what Gandhi propounded, eye for an eye leaves the whole world blind stands true in this context.

In Satyagraha, the method of "conversion" is used instead of "coercion". Gandhi believed that there is no enemy or opponent but just wrongdoers who would come to the right path only by the force of love and "change of the heart" should be the objective for achieving an end. Gandhi while differing to relate passive resistance with Satyagraha, propounded Satyagraha does not involve any element of force not is there any element of injury. Moreover, it has the highest respect for the law- Law of Truth and God. It is based on the notion of appeal rather than force.

The social disparities in the form of atrocities against the women, minorities- Dalits and Muslims are proliferating day by day. The mushrooming of lynching cases has become the new normal for India. Hyderabad gang rape, Asifa or the recent Hathras gang rape – all such horrendous atrocities – call for Gandhian doctrines. Gandhi rightly said, "The day a woman can walk freely on the roads at night, that day we can say that India has achieved independence." Gandhi emphasised on education – the only way of eradicating perils from society.

Furthermore, one concedes that resentment breeds vengeance and when this takes the shape of political colour then tolerance, sympathy and love which is the sine qua non for unity becomes elusive. In one of the articles of Moulana Wahiduddin Khan, "Fulfilling Gandhiji's Unfulfilled Mission" states, "In this world, unity is achievable only by learning to unite in spite of differences, rather than insisting on unity without differences. For their total eradication is an impossibility. The secret of attaining peace in life is the tolerance of the disturbance of the peace".

Therefore, Gandhi's philosophy of non-violence is the elixir which can stabilize the society plunged into a disastrous dungeon. Gandhi the progenitor of non-violence enunciated on every issue that threatened India's stability. From being secular to the promotion of peace or importance of ethics Gandhi voiced on every subject. His idealism or utopianism was "completed by realism".

Aabshar-e-Ahrabal THE DREAMY WATERFALL OF KASHMIR

ashmir, a global tourist destination, has the potential to contribute to J&K's economy substantially. Unfortunately, its contribution to the UT's GDP is less than 10% every financial year.

Doesn't this make you wonder as to how a place like Kashmir, bestowed with beauty by nature, with uncountable destinations generates such little revenue?

Perhaps, among the many reasons like meagre government spending on tourism, there's also a lack of effort towards tapping into all destinations available in Kashmir for tourism. One such place which has been ignored is Ahrabal (Harbal- place of Vishnu), a marvel of grace, known for its dreamy waterfall — a popular tourist spot situated on the right bank of river Vishew. The wondrous sight of the deep gorge formed by the majestic waterway is nature's bliss.

Located in the Noorabad area, it is about 28 Km west of Kulgam. Although it falls in the Kulgam district, this place is very close to Shopian. The winding road passes through the pretty woodland of Sedov and meets the road that comes from Kulgam near Gurwatan. This narrow but scenic road gives much more comfort to tourists than the safe and wide Ahrabal-Kulgam route.

Kashmir is at par with Switzerland in ethereal charm, still, we praise the latter overlooking the surreal beauty of our gorgeous paradise. The reason being natural beauty there has been given artificial touch to present an astonishing view to visitors. It looks more attractive than Kashmir. However, the artistic view and exquisiteness of the Kashmir mountains are invincible.

Only fifteen years back, there was nothing here to entice tourists. The way down to the waterfall was a craggy slope difficult to proceed along. If one wanted to go down and see the waterfall, there was a risk of falling into the river below. That's why most people used to see it from above. By this, you will get an idea of how Ahrabal looked earlier. But now, I am happy to report that construction and development work is going on in full swing. This should not stop here, more work needs to be done. Ahrabal craves special attention from the government authorities.

Recently, a festival was organised by the district administration Kulgam at Ahrabal in collaboration with other departments including the J&K tourism. It is the second time in a year that such a lavish event took place; earlier, a winter carnival was held in February to showcase its beauty and harness its adventure potential.

Yet, despite huge publicity, it still does not attract enough tourists There are many reasons

- in time.

 Instead of spending great riches on organising festivities, the government needs to invest money in providing basic facilities and services at such places which cater to tourist's demands. The sightseers would like to go to a place that has all the necessary installations and not to a deserted place like.
- Ahrabal.

 2. More than a hundred visitors can't lodge at Aharbal at a time. Currently, there are only a few buildings which include hotels, restaurants and huts. Of these, only two hotels are functional, one under construction and a VIP hut reserved for official guests.

 3. The area near the waterfall is prone to accidents and needs to be monitored properly by installing CCTV cameras. The youngsters deliberately cross the iron fence to click good shots near a waterfall. Most parents don't allow their children to visit Ahrabal. The sad thing is many suicide incidents are reported from this place every year.

The clues we have received so far show that Ahrabal was already inhabited by ancestors.



This means that it is quite habitable and that only some work needs to be done on it. Last year, this place was in the news when a fossil site was discovered on the way to the Kongwatan meadow. It caught the attention of archaeologists and they found traces on stones in a large area. They believe its history will take us back to some geological era of earth.

I heard from my mentor, the famed Naji Munawar popularly known as The poet of Children, that there was a place at Ahrabal popularly known as Khazanbal, where there were ancient ruins in large numbers. In his museum there is a flat carved stone, maybe a temple remnant bought from the same place. Unfortunately, we don't find any such traces there at present but we have the historic 'Pandav Dul'the cooking pot of Pandavas. It is a unique memorable stone. already positioned upside down by natural forces, found near the Gurwatan bridge. Though Kashmir was never part of the ancient Pandva kingdom, everything is related to Pandavas here.

DID ANYONE COME TO SEE AHRABAL IN PAST?

Yes, it is true that from the ruling class to common people,

everybody used to come here to make merry. We have many references to kings and European travellers who visited the famous Kounsarnag lake. King Zain-ul-Aabdeen, historian Pir Hasan Shah, and many Sufi saints vis-

Shah, and many Sufi saints visited this place from time to time. Zafar Khan Ahsan, the Mughal governor of Kashmir during the Shahjahan's time acclaimed the beauty of Kashmir in his poetry. About Ahrabal waterfall he said...

Ze Jannat Chand Gooi Aye Sukhanwar

Nadarad Aabshar-e- Ahrabal G. T. Vigne, a European traveller visited Kounsarnag in early December in the year 1835. In his book 'Travels in Kashmir, Ladakh, Iskardo' he mentioned some striking grasslands in the surroundings of Kounsarnag like Astanmarg, Chiranbal, Zajimarg, etc.

The Britishers in Kashmir founded the Cashmir Climbing Club now called Jammu & Kashmir Mountaineering & Adventure Club, headed by C. E. Tyndale Biscoe, in the year 1934. In his book 'Kashmir In Sunlight & Shade', Tyndale Biscoe has kept a record of expeditions in Kashmir. In one such expedition, he led the way a group of fourteen which include the notable Mr. Jacob and

R. D. Thompson to visit Kounsarnag lake. The adventurers also climbed nearby Bramshakri peak (4500 m), the highest in this area. They had bought a rubber canoe from Srinagar to go boating on the lake.

S. C. Koul who was a part of this trip cited in his book 'The beautiful valleys of Kashmir' that once an American professor tried to measure the depth of a lake and while fixing the machine in the centre the screws somehow became loose and a part of his machine sank thus experiment was not successful.

TREKS AND TRAILS

My club Glacial Trails carried out about fifty expeditions in a decade-long exploration of the Noorabad area of Kulgam District

The club almost toured three dozen alpine meadows. Along with Bramsar, Chirsar and Indersar lakes, the club visited Kounsarnag lake two times, from two different routes, first in 2008 and then again in the year 2020.

Here is a list of treks and trails that start from Ahrabal and pass through the dense forests and beautiful meadows to end at the least known alpine lakes of Kulgam...

1. Sangam Lake Trek

2. Kounsarnag Lake Trek 3. Indersar- Donthsar Lake Trek

Bramsar- Chirsar Lake Trek
 Sarkant- Parinag Lake Trek

A narrow trail starts from Gurwatan and passes through the mountain slope covered by pine forests, along the right bank of the river Vishew it takes the trekkers to the wide charming meadow of Sangam. After crossing the river at the meadow end there are two ways- the right turn leads to the unexplored Sangam Lake Trek where one can see at least two alpine lakes, and taking the left turn brings us to the beautiful meadows of Kongwatan and Sekijan. These two lovely meadows are situated on the opposite banks of the Kounsarnag stream (nallah), parallel to one another.

The famous Kongwatan meadow and Mahinag serve as the two important campsites on way to Kounsarnag Lake. Up to Mahinag, one can enjoy striding on a rough stony path with an easy trail. It becomes a little bit difficult when a gradual ascend of 300 metres from Mahinag led the track to the banks of famous Kounsarnag Lake (3500 m). In antique books, the name of this lake is Kramasara/ Vishnu Pad

lake is Kramasara/ Vishnu Pad. In the same row, there are up to ten lakes that can be accessed from Kounsarnag Lake. However, casual trekkers should not go through this path. The difficult terrain is filled in with snow for most of the year. Only alpinists can take this route to accomplish tasks in a couple of days.

While moving towards the left at Kongwatan along the bank of Zajinad or Chiranbal river three prized meadows serve as a base camp for these lakes. From Chiranbal, Hakwas and Zajimarg all these lakes surrounded by delightful meadows can be visited at very ease. Before planning to go trekking you should have a look at a detailed trekking map below.

NOTE

There are so many alternate trek routes in Noorabad to reach these lakes. You can approach them too by five accessible passages like Manzgam, Avil, Khur, Yadikhah, and Nandimarg routes.

THE FUTURE PLAN

For the beautification of Ahrabal government needs to think about these points:

- I. There is only one garden I.e Zeal Shah Park near the waterfall and a rough patch in front of hotels near Gurwatan where tourists can hang out. However, many places between Ahrabal and Gurwatan can be used to build more gardens as well as amusement parks for children.
- Along the left bank of the river Vishew on the Shopian side, there is a scope of building viewpoints. The small patch of land above the waterfall can be used to accommodate small gatherings connected by a pedestrian bridge.
- 3. The bewitching landscape of Kashmir almost looks the same everywhere. But the unique thing about Ahrabal is its glorious waterfall. People come to Ahrabal just to see the waterfall. Year after year, the height of the waterfall is constantly decreasing. Hence its height needs
 - to be increased. A portion near the waterfall should be left untouched to preserve its sublimity. However, it becomes necessary to decorate the corridor that leads to the waterfall. The rock art should be applied to two big unique rocks near stairs. It would be a much loving activity to catch glimpses of the waterfall from below. Therefore there should be a way down near springs to reach the bank of the river.
- The meandering Vishew below the waterfall should be developed as a river rafting point.
- 6. The open space near the hutment area should be developed as a popular campsite provided with necessary camping facilities.

isai Co. and partner Biogen Inc. said their Alzheimer's drug significantly slowed the disease, making it the first medicine to clearly blunt the progression of the most common type of dementia in a definitive, large-scale trial.

Lecanemab reduced the pace of cognitive decline in people with early disease by 27% over 18 months when compared with a placebo, meeting the main goal of the trial, the companies said in a statement. The benefit came with side effects, including brain swelling and bleeding, though severe cases were rare.

The clear-cut positive result marks a major milestone for researchers who have been trying in vain for decades to stop the inexorable decline tied to the disease, but how much of a difference it will make for patients and families is less obvious. The medicine appears to unambiguously slow the disease, though it doesn't restore mental capacity or completely stop its

The consistent pattern of improvement "is what the field has hoped for, and should result in favorable regulatory actions," said David Knopman, a clinical neurologist at the Mayo Clinic in Rochester, Minnesota. **Cautionary Note**

There is an important cautionary note, however: the magnitude of the delay - which was a slowing of decline - was small," he said. "We can only hope that the benefit is durable and could grow with time. Those long-term properties are unknowable at this time.'

Eisai was untraded at its upper limit in Tokyo as bids outweighed offers by more than 19 times. Eli Lilly & Co, which develops a drug that works similarly to Lecanemab, rose 6.7% in the US after-hours trading Tuesday. Biogen's shares were halted.

The Alzheimer's Association welcomed the results, saying they were the most encouraging findings among clinical trials treating the underlying causes of Alzheimer's to date. Pharmaceutical analysts were equally bullish.

"We finally have what we believe to be a clean win in Alzheimer's disease," said Evan David Seigerman, an analyst at BMO Capital Markets. "The top-line data are



clear to us - lecanemab slows the rate of cognitive decline," he wrote in a note to clients.

The trial met all key secondary goals, which included several other measures of cognitive function and the ability to perform activities, according to the companies' statement. Lecanemab is already being reviewed by US regulators under a special "accelerated approval" pathway. The companies said they would apply for full approval based on the results by March.

The treatment comes with some serious side effects, however, including brain swelling and bleeding. In the trial of 1,795 patients, 21.3% of those who received the drug experienced brain swelling or brain bleeding, while only 9.3% of those on a placebo had those problems. While most of these cases were asymptomatic, 2.8% of people on the drug had symptomatic brain swelling, the companies said.

Amyloid

Lecanemab is the latest in a long line of drugs aiming to remove amyloid, a toxic protein that clutters the brains of Alzheimer's patients. Numerous previous trials of amyloid-lowering drugs have failed or produced mixed results.

The results bolster the amyloid hypothesis: a longheld but controversial theory that the buildup of amyloid over time is one of the main causes of the disease. The Eisai success is likely to raise hopes for other antiamyloid drugs in testing, including medicines in finalstage trials from Roche Holding AG and Eli Lilly & Co.

The new study results "prove the amyloid hypothesis," Haruo Naito, chief executive officer at Eisai, said

Eisai is developing lecanemab in collaboration with Biogen, which will share in half of the profit from the drug. A previous amyloid-lowering antibody that they developed together, called Aduhelm, was approved in the US in June 2021 despite contradictory trial results. While the drug slowed the decline modestly in one big trial, the other big trial showed no effect; and both trials were halted early. But the Medicare program for the elderly refused to pay for the drug outside of clinical trials, and it ended up a commercial failure.

The drug is likely to receive full approval by the US Food and Drug Administration based on the study results, said Lon Schneider, professor of Psychiatry and Behavioral Sciences at the University of Southern California. That's not the end of the discussion, however.

"The debate is going to be about the small effect size" and whether it is clinically meaningful, Schneider said in an interview.

Other questions also remain. There are doubts about reimbursement, while potential rivals may be on the horizon, Jefferies analyst Stephen Barker has said. The success will increase the confidence about the potential of Lilly's competing candidate, which will complicate investors' view on the commercial opportunity, according to Barker.

Eisai and Biogen have already applied in the US for so-called accelerated approval of lecanemab based on its ability to remove amyloid. The new study findings, though, will allow the companies to apply for full Food and Drug Administration approval, which could eventually lead to broad Medicare coverage.

March 2023 Target

Eisai said it would apply for full approval for lecanemab by the end of March 2023. It also said it would apply for marketing authorization in Europe and Japan based on the new results in the same time frame.

In the statement, the companies didn't go into details about the findings. The full results are expected to be presented at a medical conference on November 29. and the companies also said they would publish the results in a medical journal.

Dogs Can Detect If People Are Stressed: Research

Washington: According to a new study conducted by Queen's University Belfast researchers, dogs can detect stress in humans from their sweat and breath.

The research findings have been published in PLOS ONE. The study was carried out by Clara Wilson (PhD researcher) and Kerry Campbell (MSc student) in the School of Psychology. They were supervised by Catherine Reeve, with support on collecting the human physiological measures from Zachary Petzel

The study involved four dogs from Belfast - Treo, Fingal, Soot and Winnie - and 36 people.

Researchers collected samples of eat and breath from participants before and after they did a difficult maths problem. They self-reported their stress levels before and after the task and researchers only used samples where the person's blood pressure and heart rate had increased.

The dogs were taught how to search a scent line-up and alert researchers to the correct sample. The stress and relaxed samples were then introduced but at this stage, the researchers didn't know if there was an odour difference that dogs could detect.

In every test session, each dog was given one person's relaxed and stressed samples, taken only four minutes apart. All of the dogs were able to correctly alert the researchers to each person's stress sample.

Clara Wilson, a PhD student in the School of Psychology at Queen's, explains: "The findings show that we. as humans, produce different smells through our sweat and breath when we are stressed and dogs can tell this apart from our smell when relaxed even if it is someone they do not know.

"The research highlights that dogs



do not need visual or audio cues to pick up on human stress. This is the first study of its kind and it provides evidence that dogs can smell stress from breath and sweat alone, which could be useful when training service dogs and therapy dogs.

"It also helps to shed more light on the human-dog relationship and adds

to our understanding of how dogs may interpret and interact with human psychological states."

One of the super sniffer canines that took part in the study was Treo, a two-year-old Cocker Spaniel. His owner Helen Parks says: "As the owner of a dog that thrives on sniffing, we were delighted and curious to see Treo take part in the study. We couldn't wait to hear the results each week when we collected him. He was always so excited to see the researchers at Queen's and could find his own way to the laboratory.

"The study made us more aware of a dog's ability to use their nose to "see" the world. We believe this study really developed Treo's ability to sense a change in emotion at home. The study reinforced for us that dogs are highly sensitive and intuitive animals and there is immense value in using what they do best - sniffing!'

Uncombable Hair Syndrome: New Study Finds The Genes Responsible

It's a hair condition that has frustrated parents for decades, now scientists believe they have found the genes responsible for uncombable hair syndrome. Yes, it really

Uncombable hair syndrome is more than just difficult hair. As its name suggests, it's hair that sticks out at all angles, making it almost impossible to tame let alone comb. It usually starts in children between the ages of three months and 12 years and is characterised by straw blond or silvery blond frizzy hair.

It's usually wavy, dry and brittle and, thanks to its appearance, it's sometimes called spun glass hair, pili trianguli et canaliculi or cheveux incoiffables.

Boris Johnson or Albert Einstein might spring to mind, but while those high-profile men are famous for their unruly locks, with very few cases of uncombable hair syndrome in the world, it's highly unlikely they have or had the condition. Besides, the condition tends to improve or even disappear by adulthood.

There hasn't been much research on this rare condition. which first appeared in published articles in the 1970s. Since then, fewer than 70 publications have appeared, most being case reports.

One of the more recent studies involving 11 children with uncombable hair, was performed by geneticists at the University of Bonn, Germany. They found that the condition seemed to be explained by mutations in three genes that code for well-known proteins in the hair follicle. However, since that study

was widely reported by the press, more families with kids with this condition came forward and now the same scientists have repeated the genetics with over 100 chil-

They have confirmed that in 76 of these children, the cause is linked to mutations in the PADI3 gene as well as the involvement of two other genes, all three of which code for important proteins involved in hair-fibre

Human variation in appearance, including in hair, is a result of the many small variations in our genes in the global population. When a mutation happens in a gene, sometimes it leads to a change in the function of the protein. If that protein is in the hair follicle, it's more than likely that the hair will look different. So this can be brown, blond, curly, thick, straight, red or even bald.

There are a few well-known inherited variations in hair fibre shape and curl, but rarely are these linked to any serious illness. Interestingly, often the proteins that are affected are in the inner root sheath: three layers of the hair follicle that help put the shape into the hair fibre

We also know that uncomb-

able hair is a recessive genetic characteristic. In other words, both parents must be carriers of the mutated gene, although they may not have it themselves. Then, if their child inherits one copy of the affected gene from each parent, they will have the syndrome.

So why study such genetic hair disorders? This type of genetic study generates enough information such that parents can now request a genetic test that may help allay any concerns about other rare conditions that can affect the hair.

From the scientific perspective, it also helps the hair biology research community understand more about normal hair growth and the importance of different proteins for controlling hair shape and appearance. For example, we can now explain why changes to PADI3 might alter hair shape by finding out more about how it works in the follicle.

Hair is one of the most culturally distinctive and personal attributes. Its style, shape, colour and indeed absence is something everyone thinks about every day. A huge hair-care industry has developed over the last century to help us all manage our hair.

So when a rare condition leads to such a fascinating yet impossible to manage change in hair, it is easy to appreciate why scientists want to understand how it happens and to help the families with affected children understand it better too.

GST Mop-Up In Sept At Rs 1.47 Trn; Festival Season To Push Up Revenues

NEW DELHI: GST collections remained above Rs 1.40 lakh crore for the seventh month in a row at Rs 1.47 lakh crore in September, a 26 per cent increase over last year, reflecting buoyancy in tax collection and stability of the GST portal, the finance ministry said on Saturday.

With the ongoing festive season, the collections are expected to go up in the coming months, experts said.

The gross GST revenue collected in the month of September 2022 is Rs 1,47,686 crore, of which Central GST is Rs 25,271 crore, State GST is Rs 31,813 crore, Integrated GST is Rs 80,464 crore (including Rs 41,215 crore collected on import of goods) and Cess is Rs 10,137 crore (including Rs 856 crore collected on import of goods)," it said.

The GST collections had touched a record Rs 1.67 lakh crore in April, while in August it was over Rs 1.43 lakh crore.

The revenues for the month of September 2022 were 26 per cent higher than those recorded in the same month last year. During the month, revenues from import of goods were 39 per cent higher, while from domestic transaction (including import of services) the mop-up was 22 per cent more than the amount collected from these sources in the year-ago month.

The growth in GST revenue till September 2022 over the same period last year is 27 per cent, thus continuing to display very high

In August 2022, a total of 7.7 crore e-way bills were generated, which was marginally higher than 7.5 crore in July 2022.

We Cannot Afford To Lose Sheen of IBC: FM

NEW DELHI: Amid concerns in certain quarters over the pace of the insolvency resolution process, Finance Minister Nirmala Sitharaman on Saturday said that one can neither afford to have the legislation "lose its sheen" nor let early stress warnings go unnoticed.

The minister, who is also in charge of the corporate affairs ministry, touched upon the disruptions being faced by companies due to global developments and emphasised that "we have to keep our ears very close to the ground to know actually what is developing in the system (due to global develop-

In the context of the Insolvency and Bankruptcy Code (IBC), which provides for a market-linked and time-bound resolution of distressed companies, Sitharaman stressed the importance of resolution professionals and that the efforts are more to keep companies as going concern.

"I want all of us, including me, to be conscious that we cannot afford to have IBC lose its sheen... whatever it takes for all of us to keep it (IBC) as sparkling as it was when we brought it...," she said while speaking at a function here to celebrate the sixth annual day of IBBI.

Unemployment Rate Drops To 6.43% In Sep: CMIE

MUMBAI: India's unemployment rate has drastically dropped to 6.43 per cent in September due to an increase in labour participation in the rural and urban areas, according to data from the Centre for Monitoring Indian Economy (CMIE).

During August, India's unemployment rate surged to a one-year high of 8.3 per cent as employment sequentially fell by 2 million to 394.6 million.

"In September, the unemployment rate has fallen significantly with an increase in labour participation in both urban and rural areas," CMIE managing director Mahesh Vyas told PTI over the phone on Saturday.

The unemployment rate in the rural areas fell to 5.84 per cent in September from 7.68 per cent in August, while in the urban areas it dropped to 7.70 per cent against 9.57 per cent in the previous month, according to the data. The nearly 8 million increase in labour

participation is a sign that the economy of the country is doing well, Vyas added. According to the CMIE data, the unemployment rate was the highest in Rajasthan at 23.8 per cent in September, followed by Jammu

and Kashmir at 23.2 per cent, Haryana at 22.9 per cent, Tripura at 17 per cent, Jharkhand at 12.2 per cent and Bihar at 11.4 per cent.

Rs 2 Additional Excise **Duty On Fuel Deferred**

NEW DELHI: The government has put off by one month the levy of an additional Rs 2 per litre excise duty on petrol that is not doped with ethanol, and by six months for diesel that is not blended with bio-diesel. The government relaxed the deadline for supplying ethanol-blended petrol to avoid the extra levy to November 2022 and that for supply of bio-diesel doped diesel to April 2023 in a bid to give the industry more time to implement the oil import cutting measure.

The finance ministry, in a Gazette notification issued late on Friday (September 30), stated that the additional excise tax on petrol will now be levied from November 1, 2022 and that on diesel from April 2023.

Union Finance Minister Nirmala Sitharaman had in her Budget for the fiscal year beginning April 2022 brought a Rs 2 per litre additional levy on petrol and diesel that is not blended with ethanol and bio-diesel, respectively. This duty was to be applicable from October 1, 2022, but now has been differed to November 1 for petrol and April 1, 2023 for diesel. Presently, 10 per cent ethanol, extracted from sugarcane or surplus foodgrain, is blended or mixed in petrol (meaning 10 per cent of ethanol mixed with 90 per cent of petrol) with a view to cutting oil import dependence and providing farmers with an additional source of income.

UPI Transactions Up Over 3% At 678 Crore In Sep

NEW DELHI: UPI transactions grew by over 3 per cent to 6.78 billion in September from a month ago, data from NPCI showed on

In August 2020, the total number of Unified Payment Interface (UPI) based digital financial transactions stood at 6.57 billion (657 crore).

In value terms, 6.78 billion (678 crore) transactions in last month corresponds to transactions worth Rs 11.16 lakh crore, up from Rs 10.73 lakh crore in August, as per the National Payments Corporation of India (NPCI) data.

In July, India processed 6.28 billion UPI transactions worth Rs 10.62 lakh crore. UPI is becoming a preferred mode among

users and it is simple to use, fast and a secure payment method.

Among other payments methods under the NCPI umbrella, the instant inter-bank payments through IMPS stood at 462.69 million (46.27 crore) in September slightly lower from 466.91 million (46.69 crore) in the preceding month. In July, it was 460.83 million (46.03 crore).

Aadhaar number based AePS transactions stood at 102.66 million in September, as against 105.65 million a month earlier.

7 Children From Kargil With Congenital Heart Ailments Undergo Surgery At Gurugram Hospital

New Delhi: Seven underprivileged children from Kargil suffering from structural congenital heart defects underwent surgery at a private hospital in Haryana's Gurugram, a statement said.

These children were part of a group of 300 who were screened for cardiovascular issues at a camp organised in Kargil recently.

The three-day camp was organised at the 300-bed district hospital in Kurbathang by Paras Hospitals, Gurugram in association with Dream for Change Foundation and Ladakh Autonomous Hill Development Council, Kargil.

Of the 300 children who were examined at the camp, around 50 were diagnosed with structural congenital heart defects. Out of these 50, seven required early open heart surgery and cardiac interventions, the statement issued by Paras Hospitals

It was difficult to make parents understand the complications but the doctors patiently suggested immediate cardiac surgery and intervention for the seven vulnerable cases at Paras Hospital, Gurugram, it said.

The heart diseases in children varied from simple heart defect requiring medical management to complex congenital heart defects requiring early surgery to



give them a one-time complete cure and prevent their progression to an inoperable state, said Dr Mahesh Wadhwani, chief, cardiac surgery and head of department, paediatric and adult cardiac surgery at Paras Hospitals.

"The cardiac camp initiative in Kargil has helped a lot of patients there who otherwise would have suffered miserably... in search of proper diagnosis. There were cases of having a hole in the heart among children and this led to a shocking loss in their weight," he said.

"We came across one-yearold babies weighing 5-6 kgs and 15-16 years old (children) with a weight of around 25-30 kgs. From having a hole in the heart (Patent Ductus Arteriosis) to complex cyanotic heart diseases, their conditions were miserable and we are proud to say that all these babies underwent successful open-heart surgery and interventions," he said.

The patients were discharged within a week and are back to their normal lives, he said.

UT administration had sanctioned the 200-crore Wular Action Plan for the conservation and management of the lake.

Wani said that so far1 lakh willows have also been removed from the lake during restoration works so far which has generated revenue of Rs 24 crore to the government. He said the dredging has increased the capacity of the lake.

"Few years ago, you wouldn't be able to see the water near the Garoora area of the district but we removed 64 lakh cubic meter silt from an area of 4.5 sq kms during the restoration process," Wani added.

Around 30 villages are dwelling on the banks of the lake. It also supports the livelihood of a huge population and is a habitat for migratory water birds.

WhatsApp Bans Over 23.28 Lakh Indian **Accounts In August**

New Delhi: WhatsApp banned over 23.28 lakh Indian accounts in August, of which over 10 lakh accounts were proactively taken down before any report from users, the messaging platform said on Saturday.

This is lower than the level seen in the previous month. Over 23.87 lakh Indian accounts were banned by WhatsApp in

"Between 1 August, 2022 and 31 August, 2022, 2,328,000 WhatsApp accounts were banned. 1,008,000 of these accounts were proactively banned, before any reports from users,' WhatsApp said in its monthly compliance report.

An Indian account is identified via a +91 phone number.

Over 22 lakh Indian accounts banned were WhatsApp in June on the basis of complaints received via its grievance redressal channel and through its own mechanism to detect viola-Earlier,

19 lakh such were banned by WhatsApp in May, 16 lakh accounts in April, and 18.05 lakh in March. The tougher IT rules, which

came into effect last year, mandate large digital platforms (with over 50 lakh users) to publish compliance reports every month, mentioning the details of complaints received and action taken.

Big social media firms have drawn flak in the past over hate speech, misinformation and fake news circulating on their platforms. Concerns have been flagged by some quarters time and again over digital platforms acting arbitrarily in pulling down content, and 'deplatforming' users.

The government is in the midst of formulating new social media norms that propose to give users a grievance appeal mechanism against arbitrary content moderation, inaction, or takedown decisions of big tech companies.

According to the latest report, as many as 598 grievance reports were received, and 19 accounts were "actioned" between August 1 and August 31, 2022.

Of the total reports received, 449 pertained to 'ban appeal' while others were in the categories of account support, product support and safety, among

June, circulated the draft rules that propose a panel to hear user appeals against inaction on complaints made, or against content-related decisions taken by grievance officers of social media platforms.

At present, "there is no appellate mechanism provided by intermediaries nor is there any credible self-regulatory mechanism in place", the ministry had said.

The government had last year notified IT rules to make digital intermediaries more accountable and responsible for content hosted on their platforms.

In its compliance report, WhatsApp said: "We will continue with the transparency to our work and include information about our efforts in future reports.

5G Launched In India - A 1GB File Will Now Download In...

New Delhi: Reliance Jio, the nation's biggest telecom firm, will expand 5G telephony services offering ultra-high-speed internet connectivity to every part of the country by December 2023, its chairman Mukesh Ambani said on Saturday.

Jio had in September 2016 made an entry into the telecom sector, offering free voice calls and dirt-cheap data, forcing the competition to either match or fold up/consolidate.

Ambani has now promised affordable 5G services.

"Today, I want to reiterate lio's commitment to deliver 5G to every town, every taluka, and every tehsil of our country by December 2023," he said at the India Mobile Congress (IMC) conference here.

Ambani had at his flagship Reliance Industries Ltd's annual shareholder meeting in August announced the rollout of 5G services across multiple key cities, including metro cities of Delhi, Mumbai,

Chennai and Kolkata, by Diwali. Most of Jio's 5G is developed in India, and hence carries the stamp of 'Atmanirbhar Bharat', he said, adding 5G and 5G-enabled digital solutions can bring affordable and high-quality education and skill development within the reach of common Indians.

It can deliver high-quality healthcare to rural and remote areas by turning existing hospitals into smart hospitals without much additional investment, making the services of the best doctors digitally available anywhere in India as well as improving the speed and accuracy of diagnostics and enabling real-time

clinical decision making. 5G can also bridge the gap between urban and rural India by accelerating digitisation and intelligent data management of



agriculture, services, trade, industry, informal sector, transportation and energy infrastructure, he

"By bringing AI into every domain, 5G can power India's emergence as the world's intelligence capital. This will help India become a major exporter of high-value digital solutions and services," he said, adding all these will trigger a huge explosion of entrepreneurship in the country, which in turn will attract even larger investments and create millions of new jobs.

Ambani said by harnessing the combined power of demography and digital technologies, India can become the world's leading digital society, accelerating growth by making the country a USD 40 trillion economy by 2047, up from USD 3 trillion now and increasing per capita income rapidly to over USD 20,000, from USD 2,000.

"It will not be an exaggeration to say that 5G is like a Digital Kamadhenu, the heavenly cow that grants whatever we desire," he said.

With 5G, India will take longer and faster strides towards 'Sab Ka Digital Saath and Sab Ka Digital Vikas', he said. "India

may have started a little late, but we'll finish first by rolling out 5G services that are of higher quality and more affordable than anywhere else in the world." Ambani further said 5G is much more than just the next generation of connectivity technology, offering foundational technology that unlocks the full potential of other transformative technologies like artificial intelligence (AI), internet of things, robotics, blockchain, and metaverse.

Speaking to reporters later, Ambani said Jio's 5G services will be launched by Diwali, but did not comment on tariffs. The company's 5G services will be affordable, he said, adding "Jio is always affordable".

"Today is a historic day where as a country we started 5G, and I am very grateful to the PM for his Digital India vision... We have implemented his vision and I think this is really a new era in terms of connectivity, and what the PM has outlined, we in the telecom industry will work together to achieve this and make India and Indian connectivity ecosystem best in the world and the most affordable in the world," Ambani said.

In the category of best performing states in 'Swachh Survekshan Awards 2022', Madhya Pradesh has secured the first position, followed by Chhattisgarh and Maharashtra.

Indore and Surat retained their top positions in the big cities category this year, while Vijaywada lost its third spot to Navi Mumbai.

Among the states having fewer than 100 urban local bodies, Tripura has bagged the top rank, according to the survey results.

President Droupadi Murmu on Saturday gave away the awards to the winners at an event here also attended by Union Housing and Urban Affairs Minister Hardeep Singh Puri and others.

In the category of cities having population fewer than one lakh, Maharashtra's Panchgani was ranked number one, followed by Chhattisgarh's Patan (NP) and Maharashtra's Karhad.

Haridwar was adjudged the cleanest Ganga town in the category of more than 1 lakh population, followed by Varanasi and Rishikesh. PTI BUN Bijnor was ranked the first among Ganga towns with fewer than one lakh population. followed by Kannauj and Garhmukhteshwar respectively.

In to the survey, Maharashtra's Deolali was adjudged the country's cleanest Cantonment Board.

The 7th edition of Swachh Survekshan was conducted to study the progress of the Swachh Bharat Mission (Urban) and rank the Urban Local Bodies (ULBs) based on various cleanliness and sanitation parameters.

The Survekshan has evolved from being an assessment of 73 cities in 2016 to covering 4,354 cities this year.
