Protein Could Be Used To Produce Life-Saving Antifungals: Research

Yeast cells and human immune system cells rely on surprisingly similar chemical reactions to know when to grow. University of Arizona scientists have identified subtle differences between the two cell types that could help spur the development of antifungal drugs that are able to attack disease-causing yeasts in the body while sparing the immune system.

Their findings, published in the journal eLife, not only have implications for drug development, they also provide important insight into the evolution of an ancient growth control pathway found in all multicellular organisms.

It is well known in the scientific community that a conglomerate of proteins called TORC1 -- short for Target of Rapamycin kinase Complex 1 -- controls the growth of cells in everything from humans to yeasts. But researchers have now identified and named the protein that triggers this process in yeasts -- a nutrient sensor and TORC1 regulator they named Ait1. When working normally, Ait1 shuts down TORC1 in yeasts when cells are starved for nutrients, blocking cell growth.

"Ait1 is kind oflike a hand holding TORC1 in place, with a finger that reaches over the top and flicks TORC1 on and off depending on how many nutrients a cell has," said study coauthor Andrew Capaldi, an associate professor in the UArizona Department of Molecular and Cellular Biology and BIO5 Institute member.

The Capaldi Lab is interested in determining how cells sense stress and starvation and then decide how fast



to grow. Understanding how TORC1 is triggered in different organisms is important for developing treatments for a

wide variety of diseases. TORC1 was originally discovered in yeast, but it is also critical for the activation of cells in the human immune system to mount a response. When TORC1 isn't working as it should, it can trigger the development of cancer, diabetes and various neurological disorders including epilepsy and depres-

"If TORC1 is too active, it can give rise to cancer or epilepsy. If it's underactive, then it can cause depression," Capaldi said. "We call this Goldilocks

regulation." But the fact that human bodies depend on the same TORC1 pathway as yeast presents a problem.

Capaldi said if scientists develop drugs that inhibit the growth of diseasecausing yeasts by controlling TORC1, "we are in big trouble since TORC1 also

controls the growth of human immune cells and more.

"As an example, you can block the growth of yeast very easily using rapamycin -- a drug that binds directly to and inhibits TORC1 -- so that would fight any infection well," Capaldi said. "However, that very same drug is regularly used in transplant patients to suppress their immune system, so that would be a disaster."

The researchers found that while the TORC1 pathway is very similar in yeast and humans, humans don't rely on Ait1 to regulate TORC1. So, drugs that specifically target Ait1 should inhibit the growth of yeast and not human im-

mune cells. Ait1 has only evolved in the last 200 million years, which is relatively recent in evolutionary terms. About 200 million years ago a TORC1 regulator called Rheb seems to have disappeared from the cells of various organisms exactly Government of Union Territory Jammu & Kashmir





Nearly All Of Bangladesh Without Electricity After Grid Failure

Dhaka: At least 130 million people in Bangladesh were without power on Tuesday afternoon after a grid failure caused widespread blackouts, the government's power utility company said.

More than 80 percent of the country was hit by the sudden outage shortly after 2 pm local time (0800 GMT), according to the Power Development Board.


Apart from some locations Bangladesh's northwest, "the rest of the country is without power", agency spokesman Shamim Ahsan told AFP.



Bangladesh has suffered a major power crisis in recent months as a result of higher global energy prices following Russia's invasion of Ukraine.

Public anger has intensified over lengthy blackouts in the South Asian nation, which is struggling to pay for enough imported diesel and gas to meet electricity demand.

Bangladesh last witnessed a major unscheduled blackout in November 2014, when around 70 percent of the country went without power for nearly 10 hours.



Ahsan said 130 million people or more were without electricity and it remained unclear what had caused the fault.

"It is still under investigation," he said, adding that a technical malfunction was the likely reason.

UN Chief: World Is In `Life-Or-Death Struggle' For Survival

UNITED NATIONS: U.N. Secretary-General Antonio Guterres warned Monday that the world is in "a life-or-death struggle" for survival as " climate chaos gallops ahead" and accused the world's 20 wealthiest countries of failing to do enough to stop the planet from overheating.

The U.N. chief said emissions of global-warming greenhouse gases are at an all-time high and rising, and it's time for "a quantum level compromise" between rich developed countries that emitted most of the heat-trapping gases and emerging economies that often feel its worst effects.

Guterres spoke as government representatives opened a meeting in Congo's capital Kinshasa to prepare for the major U.N.-led climate conference in the Egyptian resort of Sharm el-Sheikh in November. It's a time of immense climate impacts around the world from floods that put one-third of Pakistan under water and Europe's hottest summer in

500 years to hurricanes and typhoons that have hammered the Philippines, Cuba and the U.S. state of Florida

In the last few weeks, Guterres has amped up a push for climate's version of asking polluters pay for what they've done, usually called "loss and damage," and he said Monday that people need action now.

"Failure to act on loss and damage will lead to more loss of trust and more climate damage. This is a moral imperative that cannot be ignored.

Guterres said the COP27 meeting in Egypt "must be the place for action on loss and damage."In unusually critical language, he said commitments by the so-called G20 group of the world's 20 leading economies "are coming far too little, and far too late." Guterres warned that current pledges and policies "are shutting the door on our chances to limit global temperature rise to 2 degrees Celsius, let alone meet the 1.5 degree goal."

"We are in a life-or-death struggle for our own safety today and our survival tomorrow." he said. "COP27 is the place for all countries - led by the G20 - to show they are in this fight, and in it together,"Guterres said. "And the best way to show it is by showing up at COP27 in Sharm el-Sheikh.

Rich countries, especially the United States, have emitted far more than their share of heat-trapping carbon dioxide from the burning of coal, oil and natural gas, data shows. Poor nations like Pakistan and Cuba have been hurt far more than their share of global carbon emissions

Loss and damage has been talked about for years, but richer nations have often balked at negotiating details about paying for past climate disasters, like Pakistan's flooding this summer.

The issue is fundamental for the world's developing countries and Guterres is reminding rich nations "that they cannot try and brush it under the carpet ... G20 nations have to take responsibility for the great need their actions have caused," said Mohamed Adow of Power Shift Africa, which tries to mobilize climate action in Africa

Congress Contest: Shashi **Not Expecting Support** From "Big Leaders"

Mr Tharoor, also the MP from Thiruvananthapuram, told reporters here he was not going to betray those who supported him till now in this endeavour of his by backing off from the election.

"I was not expecting any support from the big leaders of the party and I am not expecting that now either. In fact, I met party workers at Nagpur, Wardha and then Hyderabad. They are the ones asking me to contest and not back away from it.

"I assured them I will not back away. I will not betray those who have supported me till now. Their confidence in me is what gives me the strength to move forward," he said.

He also said that while the "majority of his supporters are young party leaders and party workers", he needs support from everyone and was not going to discount anyone.

China Keen On Importing Donkeys And Dogs From Pak

Islamabad: China has shown interest in importing donkeys and dogs from Pakistan. officials have told a parliamentary committee as the cash-strapped country is trying to overcome a major economic crisis.

During a brief ing on imports and exports on Monday

between the officials of the Ministry of Commerce and Senate Standing Committee, one of its members, Dinesh Kumar said that China has expressed interest in importing donkeys as well as dogs from Pakistan Geo News reported

Senator Abdul Qadir also informed the committee that the Chinese ambassador had also talked about exporting meat from Pakistan several times.

One of the members of the committee also suggested that since animals are comparatively cheaper in Afghanistan, Pakistan can import from there and then export the meat to China.

However, the committee was informed by the officials of the commerce ministry that animal import from Afghanistan has been temporarilv banned as there have been reports of lumpy skin disease among animals in the neighbouring country.

China's keen interest in donkevs is because they use

the animal's hide in manu-

facturing traditional Chinese medicines, "eijao" or donkeyhide gelatin that supposedly has medicinal properties, traditionally used to nourish the blood and enhance the immune system.

vhich has the world's third largest population of donkeys, currently having 5.7 million animals, has earlier also exported the animals to China.

Last year, the Punjab government set up a donkey farm over 3,000 acres in Okara district in Punjab province intending to export donkeys to help with the country's drying foreign cash reserve.

The first-of-its-kind government-owned farm is used to rear donkeys of "great breeds" including American, to increase the export to China and other countries. China earlier used to import its stock of donkeys from Niger and Burkina Faso, until the two West African countries banned their export.

Nobel Prize In Physics Awarded To Scientists Aspect, Clauser And Zeilinger

cientists Alain Aspect, John Clauser and Anton Zeilinger won the 2022 Nobel Prize in Physics for their advances in quantum mechanics on the behaviour of subatomic particles, opening the door to encrypted communication.

The awards were given for "experiments with entangled photons, establishing the violation of Bell inequalities and pioneering quantum information science", the award-giving body said on Tuesday.

The Royal Swedish Academy of Sciences said the laureates -- Aspect is French, Clauser American and Zeilinger Austrian -- enabled further fundamental research and also potentially cleared the way for new practical technology.

The scientists all conducted experiments into quantum entanglement, where two particles are linked regardless of the space between them, a field that unsettled Albert Einstein himself, who once



referred to it in a letter as "spooky action at a distance".

"It was very kind to receive your phone call just about an hour ago and I'm still kind of shocked, but very positive, so thank you very much," Zeilinger told a news conference over the phone.

"I have to say that I was I was always interested in quantum mechanics from the very first moment when I read about it. I was suddenly struck by some of the theoretical predictions because they did not fit in all the usual intuition which one might have."

The incident occurred at historic Greater Iqbal Park's 'Poet Restaurant' on September 27. The minors are still undergoing medical treatment at a hospital.

According to the FIR, a copy of which is available with PTI, Muhammad Adil said he had a family birthday party at the Poet Restaurant.

"As the staff served the water bottles my nephew Ahmad washed his hands with it. Soon afterwards he started crying and we witnessed that his hands and arms suffered burn injuries as acid contained the water bottle," complainant Adil said.

Meanwhile, his two-and-ahalf-year-old niece Wajiha started vomiting as she had drunk the acid in another water bottle.

Both were rushed to the hospital where the condition of Wajiha is stated to be critical.

Police have registered a case against the restaurant manager and five other employees under section 336B (punishment for hurt by corrosive substance) of the Pakistan Penal Code.

We have arrested the restaurant manager Muhammad Javed and raids were being made for the arrest of others nominated by the complainant," police officer Tahir Waqas told PTI on Monday.

Ex-German Chancellor Wins UN Award For Resettling Syrian Refugees

eneva, Switzerland: For mer German chancellor Angela Merkel on Tuesday won the United Nations refugee agency's prestigious Nansen Award, receiving praise for her determination to protect asylum seekers while in office.

Pointing to the more than 1.2 million refugees and asylum seekers welcomed by Germany in 2015 and 2016, at the height of migrant crisis sparked especially by the war in Syria, the UN-HCR selection committee hailed Merkel's "leadership, courage and compassion."

At the time, the woman who lead the German government for 16 years said the situation "put our European values to the test as seldom before. It was no more and no less than a humanitarian



UNHCR chief Filippo Grandi hailed Merkel's determination to protect asylum seekers and to stand up for human rights, humanitarian principles and international law

"By helping more than a million refugees to survive and rebuild, Angela Merkel displayed great moral and political courage," he said in a statement.

"It was true leadership, appealing to our common humanity, standing firm against those

who preached fear and discrimination," he said.

"She showed what can be achieved when politicians take the right course of action and work to find solutions to the world's challenges rather than simply shift responsibility to oth-

The selection committee highlighted that in addition to protecting people forced to flee war, Merkel was the driving force behind Germany's collective efforts to receive them and help them integrate into society.

The Nansen Award, awarded annually, was created in 1954 in honour of the first UN High Commissioner for Refugees, Norwegian Arctic explorer and humanitarian Fridtjof Nansen, to mark outstanding work on behalf of

IAS Officer, Others Face Prosecution For Fraud

rinagar - Kashmiri officialdom was never very particular about how contemptibly low it stoops to plunder public funds, but it must have required an unusual degree of meanness to cheat backward Gujjars and Bakarwaals of their paltry government compensation for losses suffered due to hailstorms and heavy rain. In this 7-year-old case, the then deputy commissioner Pulwama -incidentally, a se¬nior IAS officer - S. D. Lone; another deputy commissioner, Muhammed Akram Hajan; the then assistant commission er, revenue, and presently director, land records, Srinagar, Muhammed Afzal Bhat and the then tehsildar Pulwama, Habibullah Mir, along with nearly half-a-dozen petty of-ficials of the district DCs office have been challaned by the vigilance) organisation misappropriating Rs 15 lakh which the state had santioned as relief to the nomads for livestock losses during natural calamities in the hilly areas of Shopy¬an and Pulwama. The entire amount had been placed at the disposal of the then DC, who had been charged with the responsibility of disbursing it to the deserving members of the community after proper verification.

Vigilance investigations revealed that the officers named m the case, in collusion with four private persons (who have asked been charge sheeted had manipulated records to show that Rs 14,80,940 had been distributed among 652 members of the Gujjjar and bakarwaal community.

Sixty-two persons among the supposed beneficiaries selected at random by the VO, denied having recieved any relief, and the finger impressions on acquitance rolls did not tally with the fingerprints. Expert established that thumb impressions supposed to be the marks of 181 different recipients were in fact the thumbprints of only a few people repeated over and over on the rolls. The VO also found that recepients who were shown belonging to the Udhampur and Rajoun districts were only fictitious names and that Rs 3,75,090 were deposited with Reshi Gas Agency lather than going to a sufferer.

Having prima-facie established the officers' involve-ment in the fraud; the VO has pressed charges against them under relevant laws before the special anti-corruption court in Srinagar.

Record Tourism

ammu and Kashmir has witnessed a tourism boom this year. And incidentally, 43 percent of the tourists are pilgrims to two Hindu shrines — Vaishno Devi in Jammu and Amarnath in Kashmir. But these visitors come on short trips to the union territory so the administration is trying to prolong their stay. And to this end, the J&K Tourism Department has lined up an all-India devotional song competition, cultural programmes, and multimedia exhibitions in Jammu during the ongoing Navratri period.

Similar arrangements were made during the Amarnath pilgrimage this year. The number of tents along the road to the shrine were increased from 29,000 in 2018 to 70,000. Government wants Amarnath pilgrims to also visit health resorts in Srinagar, Gulmarg and Pahalgam in the Valley. The UT government has now increased the options for tourists by developing more resorts. For example, Aharbal, Yusmarg, Tosamaidan, Gurez, historic old city in Srinagar are finding a prominent place on the tourist map of Kashmir. These places need further development of tourist infrastructure and also wider publicity for people to visit.

And in the Jammu division, the government is promoting Patnitop, Sanasar and Bhaderwah to be go-to places for the Vaishno Devi pilgrims. Besides this, the government is also trying to bolster the tourism infrastructure in the UT. There is a plan to set up three five star hotels in the Valley and the government is in the process of identifying land for them.

J&K has received the highest-ever tourist footfall of 1.6 crore this year, and the administration expects the number to cross 2 crore by the end of this year. Around 3.65 lakh pilgrims visited the Amarnath shrine this year and 65 lakh visited Vaishno Devi

With winter approaching, the tourist inflow is only going to further increase. The Valley already received the season's first snowfall on Monday. Affarwat in Gulmarg and Pir Panjal range of mountains are draped in white blanket of snow. Snowfall in the Valley has been traditionally a great attraction for the people in mainland India, since snow is a novelty for them.

Tourism, one of the mainstays of the Kashmir economy, is one of the sectors that has been hit the hardest over the two years following the abrogation of Article 370 with successive Covid -19 lockdowns also crushing the sector. As a result, a large section of people was largely without employment. Their savings had been depleted. This included also the people associated with tourism. Here's hoping that things improve from hereon. The waning pandemic and the return of normalcy has created conditions for unhindered tourism in the Valley. The future looks bright if things stay the same way.

Old problem

ne of the many boons of modernity has been an increase in life expectancy. People around the world are living longer, with life expectancy worldwide rising from 46 to 68 years between 1950 and 2010. As of 2019, there were 703 million senior people aged 65 and above globally, most of whom live in East and Southeast Asia, followed by Europe and North America. This number is projected to double over the next three decades; there will be over 1.5 billion elderly persons by 2050. A recent report by the UN department of economic and social affairs, World Population Prospects 2022, has projected that India will be the most populous nation in the world in 2050. Significantly, the country's elderly population will be twice as much by the middle of the century. So the International Day of Older Persons — it fell on October 1 — should be an occasion for policymakers to reflect on the attendant opportunities and challenges of an ageing population.

The rise in longevity must ideally be accompanied by an improvement in the quality of life for the elderly with regard to access to healthcare services, nutrition, and physical as well as emotional care. India faces severe structural challenges in each of these areas. Consider the economic dependency of the elderly population. Pension plans are inadequate, hardly accounting for rising inflation, causing considerable hardship. There seems to be policy inertia when it comes to reimagining the able among the aged as an economically productive constituency, augmenting their financial dependence. This prejudice stems from preconceived cultural notions of the elderly being inefficient or cognitively challenged. Insurance coverage often proves to be prohibitively expensive, reducing access to healthcare. Many among the elderly thus find it difficult to bear the costs of a major illness at a time when their health begins to fail. With the fragmentation of the family as a principal care-giving unit, the costs of meeting the welfare of senior citizens is rising. India, which spends 0.032 per cent of its GDP on geriatric care, seems to be hell-bent on encouraging a model of privatised care for the old, a template that is notoriously vulnerable to profiteering and poor quality of care. The ostensible veneration for the elderly in India is not matched by the services provided by the State, family or the market. International Day for Older Persons thus remains a solemn occasion.

India's Growing Defence Exports

ndia's defence exports to various countries have increased manifold in recent years, the latest deal is to export Indian rocket launchers to Armenia

According to reports, India would supply the 'Pinaka' multi-rocket launcher system, which can fire a salvo of 12 HE rockets in 44 seconds to Armenia besides anti-tank missiles and a variety of ammunition as part of a package agreement. The complete details of these armaments have not yet been disclosed. Pinaka saw service during the Kargil War, where it was successful in neutralising enemy positions on the mountaintops.

While the deal's value has not been disclosed, the report claims armament worth \$250 million or INR 2,000 crores would be sold over the next few months. The deal was signed earlier this month and supplies are to be fast-tracked.

It is not the first time that Armenia has received weapons equipment from India. In 2020, India triumphed over Russia and Poland in a \$40 million defence agreement with Armenia providing it with four indigenous 'Swathi' counterbattery radars.

This disclosure comes days after India called on the "aggressor side" in fresh fighting along the Armenia-Azerbaijan border to "immediately cease hostilities" without directly naming Azerbaijan. Latest fighting erupted between the two sides on September 13.

India's Defence Exports

Meanwhile, it seems the Armenian-Azerbaijan conflict has helped India to boost its arms exports. According to reports India recently announced figures for the highest-ever defence export growth that swelled by a staggering 334% over the last five years.

In fact India is chasing an even higher target. In 2020, the Modi government had set a target of Rs 35,000 crore (\$ 5 billion) export in aerospace, and defence goods and services in the next five years. This is part of the turnover of Rs 1.75 lakh crore (\$ 25 billion) in defence manufacturing by 2025 that the government is aiming to achieve.

India's defence exports touched a record Rs 13,000 crore in 2021-22, "eight times" of what it was around five years ago.

Besides the strategic importance of the deal with Armenia, the export order is a boost for the indigenous defence industry with the Indian government keen to increase the value of Indian arms exports.

India had also signed a contract with the Philippines in January 2022 for the sale of Brah-

Currently, India exports defence equipment to 75 countries and these include weapon simulators, tear gas launcher, torpedo loading mechanism, alarm monitoring & control, night vision monocular & binocular, light-weight torpedo & fire control systems, armoured protection vehicle, weapons locating radar, high-frequency radio, coastal surveillance radar among others.

Armenia-Azerbaijan Conflict

The issue of the conclave of Nagorno-Karabakh has always been the bone of contention between Armenia and Azerbaijan ever since the two countries became independent republics, after gaining independence from the erstwhile USSR.

The disputed region of Nagorno-Karabakh lies in Azerbaijan and is inhabited mostly by ethnic Armenians. The conflict escalated into a full-scale war in the early 1990s which later transformed into a low-intensity conflict until four-day escalation in April 2016 and then into another full-scale war in 2020.

A ceasefire signed in 1994 in Bishkek was followed by two decades of relative stability, which significantly deteriorated along with Azerbaijan's increasing frustration with the status quo, at odds with Armenia's efforts to cement it.

Azerbaijan, for one, has received backing from its traditional allies and supporters, Turkey and Israel. During the 2020 skirmish between the two combatants, Baku turned the tide in its favour by overwhelmingly deploying Turkish Bayraktar and Israeli kamikaze drones.

While Armenia has often turned to Russia

for support, Moscow's preoccupation with the on-going war against Ukraine has resulted in not a very supportive response, this time.

In the face of rising hostilities and little military aid, the defence deal with India may prove to be a shot in the arm for a beleaguered Armenia.

Azerbaijan-Turkey-Pakistan Relationship

India's military assistance for Armenia comes against the backdrop of its regional rival's bonhomie with Azerbaijan. Pakistan has consistently backed Azerbaijan in the Nagorno-Karabakh conflict and has refused to establish diplomatic ties and legally recognise Armenia as an independent state.

Azerbaijan is seen by many as part of an emerging axis with Turkey and Pakistan. It has used Turkish drones to fight war against Armenia, and is also in talks with Pakistan to buy the JF-17 fighter aircraft.

In 2017, Turkey, Azerbaijan, and Pakistan had signed a Trilateral Ministers Agreement that established security cooperation, and built upon previous bilateral military aid arrangements. These three countries also conducted a joint exercise named 'Three Brothers' last year.

The rise of Azerbaijan with increased Turkey-Pakistan military cooperation is a direct warning to India. Azerbaijan has acquired many deadly weapons by increasing friendship with Turkey and Pakistan in the name of Islam. Indian fears that other countries may also go along this route in the name of Islamic countries are not unfounded.

However, in spite of these developments, an interesting fact is that India has stronger economic ties with Azerbaijan than with Armenia. Indian company ONGC has also invested heavily in Azerbaijan's gas sector. The Indian bilateral trade with Azerbaijan in 2019 stood at \$1093 million, while with Armenia it was only \$48 million in 2020.

Broadly, this latest defence deal will place India as one of the emerging global powers with rising defence exports capability. In addition it will also allow it to play a significant role in the central Asian republics and regionally, both.

Mental health of Children

hildren's emotional wellbeing is just as important as their physical health. Good mental health helps them develop the resilience to cope with whatever life throws at them and grow into well-rounded, healthy adults. Most children grow up mentally healthy, but surveys suggest that more children and young people have problems with their mental health today than 30 years ago. Mental health problems affect around one in six children. They include depression, anxiety and conduct disorder (a type of behavioural problem), and are often a direct response to what is happening in their lives. Alarm-

ingly, however, 75% of children and young people who experience a mental health problem aren't getting the help they need.

Now, a new UCLA study has found that young adults who have experienced discrimination have a higher risk for both short and long-term behavioural and mental health problems. The findings of the study were published in the journal 'Pae-diatrics'. Researchers examined a decade's worth of health data on 1,834 Americans who were between 18 and 28 years old when the study began. They found that the effects of discrimination may be cumulative - that the greater number of incidents of

discrimination someone experiences, the more their risk for mental and behavioural problems increases.

The study also suggested that the effects of discrimination in young adults are connected with disparities in care for mental health concerns and institutional discrimination in health care overall, including inequities in diagnoses, treatment and health outcomes.

Previous studies have linked discrimination - whether due to racism, sexism, ageism, physical appearance or other biases - to a higher risk for mental illness, psychological distress and drug use. While previous research has examined the correla-

tion in childhood or later adulthood, this new study is the first to focus on the transition to adulthood and to follow the same group of individuals over time.

The findings are particularly relevant in light of the stresses young adults are facing nationwide today. The last two years of COVID-19 pandemic has brought to the forefront new mental health challenges - particularly for vulnerable populations. We have the opportunity to rethink and improve mental health services to acknowledge the impact of discrimination, so we can better address it to provide more equitable care deliveries.

The Spooky World Of Quantum Mechanics

he 2022 Nobel prize for physics has been awarded to a trio periments in quantum mechanics, the theory covering the micro-world of atoms and particles.

Alain Aspect from Université Paris-Saclay in France, John Clauser from J.F. Clauser & Associates in the US, and Anton Zeilinger from University of Vienna in Austria, will share the prize sum of 10 million Swedish kronor (US\$915,000) "for experiments with entangled photons, establishing the violation of Bell inequalities and pioneering quantum information science".

The world of quantum mechanics appears very odd indeed. In school, we are taught that we can use equations in physics to predict exactly how things will behave in the future - where a ball will go if we roll it down a hill, for example.

Quantum mechanics is different from this. Rather than predicting individual outcomes, it tells us the probability of finding subatomic particles in particular places. A particle can actually be in several places at the same time, before "picking" one location at random when we measure it.

Even the great Albert Einstein himself was unsettled by this - to the point where he was convinced that it was wrong. Rather than outcomes being random, he thought there must be some "hidden variables" – forces or laws that we can't see - which predictably influence the results of our measurements.

Some physicists, however, embraced the consequences of quantum mechanics. John Bell, a physicist from Northern Ireland, made an important breakthrough in 1964, devising a theoretical test to show that the hidden variables Einstein had in mind don't exist.

According to quantum mechanics, particles can be "entangled", spookily connected so that if you manipulate one then you automatically and immediately also manipulate the other. If this spookiness - particles far apart mysteriously influencing each other instantaneously - were to be explained by the particles communicating with each other through



hidden variables, it would require faster-than-light communication between the two, which Einstein's theories forbid.

Quantum entanglement is a challenging concept to understand, essentially linking the properties of particles no matter how far apart they are. Imagine a light bulb that emits two photons (light particles) that travel in opposite directions away from it.

If these photons are entangled, then they can share a property, such as their polarisation, no matter their distance. Bell imagined doing experiments on these two photons separately and comparing the results of them to prove that they were entangled (truly and mysteriously linked).

If light didn't behave quite as the physicists thought, perhaps his results could be explained without entanglement. These explanations are known as loopholes in Bell's test, and Aspect was the first to challenge this.

Aspect came up with an ingenious experiment to rule out one of the most important potential loopholes in Bell's test. He showed that the entangled photons in the experiment aren't actually communicating with each other through hidden variables to decide the outcome of

Bell's test. This means they really are spookily linked.

In science it is incredibly important to test the concepts that we believe to be correct. And few have played a more important role in doing this than Aspect. Quantum mechanics has been tested time and again over the past century and survived unscathed.

QUANTUM TECHNOLOGY

At this point, you may be forgiven for wondering why it matters how the microscopic world behaves, or that photons can be entangled. This is where the vision of Zeilinger really

We once harnessed our knowledge of classical mechanics to build machines, to make factories, leading to

the industrial revolution. Knowledge of the behaviour of electronics and semiconductors has driven the digital revolution.

But understanding quantum me chanics allows us to exploit it, to build devices that are capable of doing new things. Indeed, many believe that it will drive the next revolution, of quantum technology.

Quantum entanglement can be harnessed in computing to process information in ways that were not possible before. Detecting small changes in entanglement can allow sensors to detect things with greater precision than ever before. Communicating with entangled light can also guarantee security, as measurements of quantum systems can reveal the presence of the eavesdrop-

Zeilinger's work paved the way for the quantum technological revolution by showing how it is possible to link a series of entangled systems together, to build the quantum equivalent of a network.

In 2022, these applications of quantum mechanics are not science fiction. We have the first quantum computers. The Micius satellite uses entanglement to enable secure communications across the world. And quantum sensors are being used in applications from medical imaging to detecting submarines.

Ultimately, the 2022 Nobel panel have recognised the importance of the practical foundations producing, manipulating and testing quantum entanglement and the revolution it is helping to drive.

I am pleased to see this trio receiving the award. In 2002, I started a PhD at the University of Cambridge that was inspired by their work. The aim of my project was to make a simple semiconductor device to generate entangled light.

This was to greatly simplify the equipment needed to do quantum experiments and to allow practical devices for real-world applications to be built. Our work was successful and it amazes and excites me to see the leaps and bounds that have been made in the field since.

'I Hate My Life...Dear Death Waiting For You': JK Cop Murder Case Accused Wrote In Personal Diary

JAMMU: From "I hate my life" and "Dear death I am waiting for you" to Bollywood songs about sadness and the final farewell, the recent diary entries of a man who allegedly killed Jammu and Kashmir Director General (Prisons) Hemant K Lohia reveal he was

"under depression".

Yasir Loĥar, the 23-year-old domestic help, was arrested following a major manhunt through the night. It seemed, according to police, the school dropout was fed up with life.

In Hindi and broken English, he has also written in his diary one-line sentences like: "I want Restart My life", "Zindagi

to bas taklif deti hai, sukoon to maut hi deti hai (life only hurts, death brigs peace), and "everyday starts with expectation but ends with bad experience".

Lohar, a school dropout, has also scribbled in his diary a popular Bollywood song from movie Ashiqui 2 -- "Bhula dena mujhe, hai alvida tujhe" -- in

which the lyrics talks about separation and goodbyes. He wrote he was "99 percent

sad" in his life but wore a "fake smile 100 percent". "I am 10 percent happy,

having zero percent love in life and 90 percent tension in life. I hate my life which only gives pain and waiting for death to restart my life," he wrote.

DG (Prisons) Lohia was found dead at his residence on the outskirts of Jammu on Monday night. His throat was slit and there were burn injuries on the body.

According to Additional Director General of Police, Mukesh Singh, Lohar was working in this house for nearly six months.

"Initial investigations reveal he was quite aggressive in his behaviour and was also under depression," he said.

The ADGP said a preliminary examination of the crime scene indicated that Lohia must have been applying some oil on his foot, which was swollen. The killer allegedly

suffocated Lohia to death and

used a broken ketchup bottle to slit his throat and later tried to set the body afire.

"The suspect had bolted the room from inside while he was rubbing balm on his foot. He repeatedly attacked him with a sharp object and even threw a burning pillow towards him in an apparent bid to set the body ablaze," he said.

Goyal To Meet Export Promotion Councils On Oct 7

NEW DELHI- Commerce and Industry Minister Piyush Goyal will meet different export promotion councils on October 7 to discuss ways to promote the growth rate in the country's outbound shipments, an official said.

The meeting assumes significance as India's exports contracted by 3.52 per cent to USD 32.62 billion in September against USD 33.81 billion in the same month last year, while the trade deficit widened to USD 26.72 billion during the last month.

Representatives from export bodies, including the Federation of Indian Export Organisations, Apparel Export Promotion Council and Council for Leather Exports, would participate in the meeting, the official said.

According to an export council, issues which would figure in the meeting include export credit refinance facility, increase in interest subsidy rates, removal of GST (Goods and Services Tax) on exports freight, exports benefits for rupee shipments to Russia and other countries, and removal of

exports duty on some products. Exporters have urged the government to continue with the GST exemption on export freight.

UPI Payment Crosses Rs 11 Lakh Cr Milestone In Sep

NEW DELHI: Payment through Unified Payments Interface (UPI) has crossed a milestone of Rs 11 lakh crore in September, as per the data released by National Payments Corporation of India (NPCI).

During the month, 678 crore transactions in volume terms were done on the platform launched in 2016.

Payment through UPI had crossed Rs 10 lakh crore in May this year. Last month, as many as 657.9 crore transactions worth Rs 10.72 lakh crore had taken

UPI is an instant real-time payment system which facilitates inter-bank peer-topeer (P2P) transactions. The transaction is done through mobile in easy steps. Besides, there are no charges applicable for the UPI transaction so far. Moreover, UPI has played a key role in the country becoming almost

cashless economy. The inexpensive medium for cashless transactions has been gaining traction month on month basis.

As per NPCI data, in June 2022, the transaction value under UPI digital payments moderated marginally at Rs 10,14,384 crore from Rs 10,41,506 crore in May. It increased to Rs 10,62,747 crore in July.

Rupee Rises 29 Paise To Close At 81.53 Against **US Dollar**

MUMBAI: The rupee appreciated by 29 paise to end at 81.53 (provisional) against the US dollar on Tuesday as heavy buying in domestic equities and weakness in the greenback strengthened investor sentiment. However, rising crude prices in the international market capped the rupee's gain, forex

At the interbank forex market, the local unit opened strong at 81.66 against the greenback. It witnessed an intra-day high of 81.36 and a low of 81.66 during the session.

It finally ended at 81.53, up 29 paise from its previous close. In the previous session, the rupee had settled paise 42 lower at 81.82 against the dollar. "Rupee retraced from its all-time lows after the RBI raised rates by 50 bps. The dollar retraced from high levels after the manufacturing PMI number released from the US came below

"Volatility in major crosses continues to remain high as updates on the change in economic policies keep market participants on the edge. Today, the focus will be on the factory order number to gauge a view for the dollar. We expect the USD/ INR (Spot) to quote in the range of 81.20 and 82.05," Gaurang Somaiya, Forex & Bullion Analyst, Motilal Oswal Financial Services, said.

The BCCI was awaiting medical reports while the pacer did his rehab at the National Cricket Academy but it was a foregone conclusion that he would be out for months. He was initially ruled out of the ongoing three-match T20I series against South Africa due to a back injury.

Bumrah has a history of back problems due to his slinging unorthodox front-on action which puts a lot of load on his back.

Stadium Tragedy Exposes Indonesia's Troubled Football History

SEOUL: Gaining the right to host next year's Under-20 World Cun was a major milestone in Indonesia's football development, raising hopes that a successful tournament would turn around long-standing problems that have blighted the sport in this country of 277 million people

The death of at least 125 people at a league game between host Arema FC of East Java's Malang city and Persebaya Surabaya on Saturday is a tragic reminder, however. that Indonesia is one of the most dangerous countries in which to at-

Since Saturday, the domestic league has been suspended. President Joko Widodo has ordered the sports minister, the national police chief and the football federation to conduct a thorough investigation into the deadly stadium crush.

Indonesia was the first Asian team ever to play at a World Cup participating in 1938 as Dutch East Indies — but despite an undoubted national passion for the sport, it has never returned to the global stage because of years of corruption, violence and misman-

Data from Indonesia's football watchdog, Save Our Soccer, showed 78 people have died in game-related incidents over the



past 28 years.

Those accused are often associated with supporter groups that attach themselves to clubs, with the biggest boasting hundreds of thousands of members.

Arema's intense rivalry with Surabaya meant that no visiting fans were allowed in the stadium on the weekend. Yet violence broke out when the home team lost 3-2 and some of the 42,000 Arema fans, known as "Aremania," threw hottles and other objects at players and football officials.

Restrictions on visiting fans also have failed in the past. In 2016, despite Persib Bandung supporters being banned from a game with hitter rival Persiia Jakarta, they were blamed for the death of a Ja-

karta supporter A month earlier, a Persib fan had been beaten to death by Jakarta

In 2018, local media reported a seventh death in six years related to Indonesia's biggest football rivalry.

Football fans have accused security officials of being heavy-handed in the past and on the weekend, with witnesses describing officers beating them with sticks and shields before shooting tear gas canisters directly into the crowds. In 2016, police were accused of killing 16-year-old supporter Muhammad Fahreza at a game between Persiia and Persela Lamongan, resulting in mass demonstrations demanding

an end to police brutality. FIFA, football's world governing body, advises against the use of tear gas at stadiums by on-field security or police who control and have responsibility for safety op-

HC Grants Bail To Former Maha Home Minister Anil Deshmukh In Money Laundering Case; ED to move SC

Mumbai: The Bombay High Court on Tuesday granted bail to former Maharashtra home minister Anil Deshmukh in a money laundering case registered by the Enforcement Directorate observing "two components of credits" in the account of his family trust were not "proceeds of crime.

The HC, however, stayed the order till October 13 as Additional Solicitor General (ASG) Anil Singh said the ED would challenge it in the Supreme Court.

Two components of credits (Rs 10.42 crore and Rs 1.12 crore) in the account of a trust controlled by the Deshmukh family, flagged by the ED, were not "proceeds of crime," a single-judge bench of Justice N J Jamadar noted in the order.

The high court also said the statements given by for-mer Mumbai Police commissioner Param Bir Singh and dismissed cop Sachin Waze alleging that Deshmukh had taken money from police officers for

favourable postings were "prima facie hearsay".

"These statements ex-facie lack the element of certainty as to the source, time and place. They prima facie appear to be hear-say," the order said.

The Nationalist Congress Party leader, arrested on November 2, 2021, is also facing a corruption case registered by the Central Bureau of Investigation (CBI).

Justice Jamadar stated the bail plea has been allowed and Deshmukh shall be released on a bond of Rs 1 lakh.

The HC noted that the possession of unaccounted property acquired by legal means may be actionable for tax violations, yet will not be regarded as proceeds of the crime unless it constitutes an offence which is included in the Schedule.

"For being regarded as proceeds of crime, the property associated with the scheduled offence must have been derived or obtained by a person as a result of criminal activity relating to the concerned scheduled offence," the judgment said.

Deshmukh, who was a minister in the previous MVA government, is lodged in Arthur Road jail in Mumbai.

The HC in April 2021 directed the CBI to carry out a preliminary inquiry over allegations of extortion levelled by Param Bir Singh. The CBI, based on this inquiry, registered an FIR against Deshmukh and his associates for alleged corruption and misuse of official power. The ED began its probe after the CBI registered the case.

The ED claimed Deshmukh had misused his official position and collected Rs 4.70 crore from various bars and restaurants in Mumbai.

The money was channelled to Nagpur-based Shri Sai Shikshan Sansthan, an educational trust controlled by the Deshmukh family, it alleged. But the high court noted in the order on Tuesday that two components of credits in the trust's account were not "proceeds of crime".

"The third component (of credit) amounting to Rs 1.71

crore depends on the statement of Sachin Waze which after discussion this court has held that it falls in favour of the applicant (Deshmukh)," the court said.

Justice Jamadar noted that the statements given by Waze and Param Bir Singh only said that they "heard or learnt" that Deshmukh had taken money from police officers in exchange for favourable postings.

"These statements ex-facie cannot bear the weight of the allegation of generation of proceeds of crime out of the alleged predicate offence of exercise of influence over the transfers and postings of the police officials," the court said.

The HC also raised questions as to who was the "No 1" Waze kept referring to while collecting bribe money from bar and restaurant owners.

The bench noted there are two versions - while some say in common parlance the Commissioner of Police is referred to as "No 1", while the prosecution's case is that Waze was referring to Deshmukh.

Leopard Caught In Ganderbal

Srinagar: The officials of Wild Life department on Tuesday captured a leopard in Kundbal village of Central Kashmir's Ganderbal district. The leopard was roaming in the peripheries of the village for quite some time and in order to trap the animal, the employees of the Wild Life Department had placed a number of cages at different places, officials said.

In- charge of Wildlife Control Room Ganderbal, Shabir Ahmad told a local news agency KNT that the leopard will be released in the upper reaches of Ganderbal forest. (KNT)

J&K Reports Six New Covid Cases

Srinagar: Jammu and Kashmir reported six fresh covid-19 cases even as there was no death due to the virus during the last 24 hours, officials said on Tuesday. They said four cases were reported from Jammu and two from Kashmir Valley, taking the overall tally to 479180. Among the cases, 173994 are from Jammu division and 305182 from Kashmir Valley. Giving district wise details, they said, Jammu reported 4 and Srinagar 2.

There was no death due to the virus during the time. So far 4785 people have succumbed to the virus and among them include 2352 from Jammu division and 2433 from the Valley. Besides, they said, fifteen Covid-19 patients recovered during the last 24 hours—five from Jammu division and ten from Kashmir Valley. There are now 105 active cases— 41 in Jammu and 64 in Kashmir.

The number of terrorist incidents between 2006 and 2013 was 4,766 whereas after the abrogation of Article 370, terrorist incidents in the period from 2019 to 2022 have come down from 4,766 to just 721. Along with this, there is a decrease in the casualties of the security personnel. This shows that Jammu and Kashmir is now safe," he said.

The Home Minister said that earlier there were reports of stone pelting, but now this does happen because the PM has replaced stones in the hands of the youth with laptops, has provided them employment and this change is very important for Jammu and Kashmir.

Shah also assured that now no one can suppress the rights of people as PM has ensured that democracy is not restricted within three families, but 30 thousand people become part of it.

The Home Minister also reiterated the PM's promise of holding the elections after completion of delimitation process.

"The earlier delimitation was not done as per the rules of the commission, but to benefit only the three families. But now for the first time after Independence, a real delimitation has been completed and seats have been increased in the hill areas. By initiating the delimitation process, Prime Minister Modi has ensured justice to the people in Rajouri, Poonch, Doda and Kishtwar," Shah said.

Coming down heavily on the Opposition in Jammu and Kashmir, Shah said earlier just three political families used to rule the erstwhile state, but now power is with 30,000 people who were elected to panchayats and district councils through fair elections.

"Prime Minister Modi is giving free health facilities up to Rs. five lakh to 27 lakh families of Jammu and Kashmir, which these three families never provided in the last 70 years as they were corrupt and grabbed money coming from Delhi," he said.

"I want to appeal to you to free Jammu and Kashmir from the clutches of these three families and to make hands of Modi strong for betterment and welfare of Jammu and Kashmir," he added.

Shah, however, did not take names of the three families.

Promises Quota

Jammu and Kashmir will get reservation benefits in accordance with the recommendations of the Justice Sharma Commission which examined the issue of quota. He said this while addressing a rally organised in this town, situated at the foothills of the Pir Panjal mountain range along the Indo-Pak border.

Shah also said there will be no decline in ST quota of Gujjars and Bakerwals and Paharis and everyone will get their share.

He said the abrogation of Article 370 in 2019 has paved the way for providing reservation benefits to the deprived sections of the society in Jammu and Kashmir.

"The Justice Sharma Commission has recommended that Paharis, Bakerwal and Gujjars should be included for ST quota benefits. These recommendations have been received and soon after completion of legal procedure, Gujjars, Bakerwals and Paharis will get the reservation benefits," he

The home minister said some people have tried to instigate the Gujjars and Bakerwals in the name of ST status being given to Paharis but the people have foiled their design.

There have been reports of protests by the Gujjars and Bakerwals in Jammu and Shopian in Kashmir recently against the move to grant ST status to the Paharis.

The Gujjars and Bakerwals constitute 40 per cent of the population in the border districts of Rajouri and

Paharis also live in the same area but they are numerically small.

The Gujjars and Bakerwals are the

third largest ethnic group in Jammu and Kashmir after Kashmiris and Dogras.

Since April 1991, they have enjoyed benefits of a 10 per cent quota for STs in jobs and educational institutions.

The Paharis are also seeking the same benefits, which was opposed by the Gujjar and Bakarwals.

Since January 2020, the Paharis have been getting 4 per cent quota benefits in jobs and educational institutions in Jammu and Kashmir following a change of rules by the Union Territory administration.

This was also opposed by the Gujjars and Bakerwals, saying they get benefits under other categories such as OBC. EWS.

He also appreciated the Union territory administration's decision to announce a holiday on the occasion of the birth anniversary of Maharaja Hari Singh, the erstwhile ruler of Jammu and Kashmir, who signed the instrument of accession.

The home minister said on the last day of Navratri he paid obeisance at Mata Vaishno Devi temple and prayed for peace in Jammu and Kashmir.

Shah also praised the people living in Rajouri and Poonch who are "standing like rocks for the security of India" and the entire country salutes them.

"Paharis, Gujjars and Bakerwals always stood for their country whenever there was risk in India. Mountains of Rajouri and Poonch are guardians of LoC of India," he said.

The DG (prisons) was found dead on Monday night at his friend's house on the outskirts of Jammu, with burn injuries on his body and his throat slit.

Police said initial investigations did not point towards a terror angle.

Though a terror group, People's

Anti-Fascist Front (PAFF), claimed responsibility for the murder, Director General of Police Dilbag Singh, who visited the crime scene, told reporters "these terror groups shamelessly own everything and anything".

"There was no clue which suggested involvement of any terror group. For the time being, the terror angle is ruled out but if, during investigation, such a thing comes to light, we will see to it," he said.

Terming the murder an unfortunate incident, the police chief said the force has got relevant clues from the scene which indicate that the accused had a history of aggressive behaviour.

He said the suspect had bolted the room from inside when the DGP (prisons) was rubbing balm on his foot.

The domestic help repeatedly atacked him with a sharp object and even threw a burning pillow towards him in an apparent bid to set ablaze the body of the victim.

The 57-year-old Lohia, who was promoted and appointed as Director General of Prisons in the Union Territory in August, had shifted to his friend's house only a few days back.

Additional Director General of Police, Mukesh Singh said, "In a major manhunt launched by the Jammu and Kashmir police throughout the night. the accused involved in murder case of the DG prisons has been apprehended. Interrogation of the accused

Earlier, the ADGP had said that preliminary examination of the crime scene indicated that Lohia must have been applying some oil on his foot which showed swelling.

The killer suffocated Lohia to death and also used a broken ketchup bottle to slit his throat and later tried to set the body afire, he said.

The guards present at the residence of the officer saw fire inside his room and broke open the door, the ADGP

The officials said raids were conducted by special teams at different places including the domestic help's home town in Halla-Dhandrath village in Ramban district where some persons including his fiancee were detained for questioning.

The ADGP said the CCTV footage collected from the incident site showed the accused running away after the commission of the crime.

"Lohar was working in this house for nearly six months Initial investigation revealed that he was quite aggressive in his behaviour and was also under depression, he said.

"A thorough probe is on to rule out any possibility (of terror angle). The weapon of offence has been seized besides some documentary evidence reflecting his (domestic help's) mental state," he said. Officials said the body of the de-

ceased officer was shifted to the Government Medical College (GMC) hospital Jammu for a postmortem and it will be cremated with full honours here on Wednesday.

Sharing some pages from the diary of the accused, a police official said Lohar, a school dropout, was apparently fed up with his life. The domestic help wrote in his diary

that he was 99 percent sad but wearing a 100 percent 'fake smile'. "I am 10 percent happy, having zero percent love in life and 90 percent ten-

sion in life. I hate my life which only gives pain and waiting for death to restart my life," he wrote in the diary. The official said the accused admit-

ted to his involvement in the murder and his interrogation is on to unravel the motive behind this henious crime. "The police is looking from all angles. The accused had left his house two years back and was working as

a cook at this house for the last six months," he said. Condemning the murder of the of-ficer, J&K Congress chief Wikar Rasool Wani said the insecurity has increased manifold in Jammu and Kashmir which can be guaged by the spurt in targeted killings by terrorists in the

"Shah (Home Minister) on the floor of the house (parliament) on August 5, 2019 talked about a new beginning and rooting out of terrorism and separatism. A DG-level officer is murdered, a terrorist group is claiming responsibility...if a DG-level officer is not safe, how are the ordinary citizens safe in

J&K," Wani told reporters here. The Aam Aadmi Party (AAP) termed Lohia's killing unfortunate and asked the Jammu and Kashmir police and government to ensure an indepth probe is conducted professionally and all links associated with the murder are unearthed.

"The incident shows deteriorating law and order situation in Jammu and Kashmir where even senior police officers are unsafe, what to talk of common masses," the party said in a statement.

"So sad to hear about the tragic murder of Hemant Lohia. He was a fine gentleman and a professional police officer. My heartfelt condolences to his family and colleagues. May his soul rest in peace. #HemantLohia," National Conference leader Nasir Aslam Wani (Sogami) wrote on Twitter.

Senior vice president of Apni Party and former minister Ghulam Hassan Mir described Lohia as a charming personality.

"I recall his meeting on Republic Day at Srinagar. What a charming personality. Miss him very much. RIP, Mir said in a tweet.

"Deeply saddened by the tragic demise of Shri Hemant Lohia IPS, Director General (Prisons) @JmuKmrPolice. My thoughts and prayers are with his family and colleagues, Srinagar Mayor and Apni Party spokesperson Junaid Azim Mattu tweeted.

that SDM physically assaulted him and passed casteist slurs and abuses against him besides using derogatory words against SC/ST community to which he belongs.

Pertinently, Magray in his application had alleged that he had registered a complaint against SDM Gurez and Bandipora administration with Lieutenant Governor's Grievance Cell after he was assigned the 'undignified' duty of overseeing the main gate during the Gurez Festival held last month with much fanfare.

In view of the complaint, the accused SDM was instructed by ADC Bandipora to redress the grievance of the lecturer. As per Magray's application, when the lecturer was directed by the Head of the Institution to reach the SDM office in connection with the said grievance, the SDM ordered his peon to "close the office door from outside and not to let anyone in, without his permission" as soon as he reached the SDM's office.

"That accused person misused his official position as Public Servant and resorted to illegal, unreasonable, unfair and unjust acts aimed against the applicant because the applicant filed his grievances before the Governor's Grievance Cell...," Magray had alleged in his complaint. Magray had also alleged that he was then beaten, abused and threatened with dire

consequences. The applicant further alleged that he being a law-abiding citizen had approached SHO Police Station Gurez requesting him to register the FIR but the Police refused to do so despite recording his statement and verifying medical records in Sub-District Hospital Gurez where Magray had gone for

treatment after alleged assault. Magray approached the Court of Judicial Magistrate Gurez after his attempts to persuade the police to register an FIR failed.

According to his application, he besides having approached SHO Gurez, had also written to SP Bandipora and SDPO Bandipora requesting them to direct the registration of FIR and also informing them about the rights of the applicant under the SC/ST Act and also the ill-treatment he was subjected to being the member of the socially backward community but to no avail.

The Court presided over by Towfeel Ahmad Mir noted that "After hearing the applicant and after perusal of the application along with annexed record prima facie it seems that cognizable offences have been committed by the accused. The act of the accused makes out the essentials of cognizable offences, which warrants registration of FIR".

While invoking an example from another case, the court said that In Lalita Kumari us Govt. of UP & Ors, it was held by Supreme Court that registration of FIR is mandatory under Section 154 of the Code, if the information discloses commission of a cognizable offence and no preliminary inquiry is permissible in such a situation.

"Thus, I am of the considered view that the acts as alleged to have been committed by the accused does not fall with the protection of sec 197 CrPC as they are far away from the acts committed by him while acting or discharging his official duties. As such there is no need of any prior sanction before registration of FIR against the accused," reads the court order, a copy of which lies with Kashmir Observer.

The court also said that such sanction is necessary if the offence alleged against the public servant is committed by him 'while acting or purporting to act in the discharge of his official duty' the yardstick to be followed is to form a prima facie view whether the act of omission/commission for which the accused is charged had a reasonable connection with the discharge of his duties.

The court also observed that prima facie there seems that cognizable offences have been committed against the applicant but concerned SHO has failed to register the FIR.
