Aadhaar Alert For Cards Issued Over 10 Years Ago

New Delhi: Aadhaar holders who were issued the unique ID more than 10 years back but have not updated their details since then are being urged to update identification and residence proof documents, UIDAI said.

In a statement, UIDAI -- the government agency that issues Aadhaar numbers -- said the updation can be done online as well as at Aadhaar centres.

It said those who were issued the unique identification number more than 10 years back and have not done any updation since the issue are being "requested" to update their documents.

UIDAI, however, did not say if this updation is mandatory.

"Any person who had got their Aadhaar made 10 years back and not updated the information in any of the subsequent years are being requested to do

The updation of identification documents and proof of residence is being done on payment of the requisite fee.

Scientists Develop A New Printable, Wearable Insect Repellent



new type of insectrepellent delivery device has been developed by scientists

from the Martin Luther University Halle-Wittenberg (MLU). With the help of a 3D printer, the active ingredient is first "encapsulated" and formed into the desired shape, such as a ring, which can then be worn



and releases an agent designed to repel mosquitoes for a long time. The team has presented its work in the International

Journal of Pharmaceutics. The researchers have developed their prototypes using "IR3535." an insect repellent developed by MERCK. "Mosquito

sprays containing IR3535 are very gentle on the skin and have been used all over the world for many years. That's why we've been using the agent for our experiments," says Professor René Androsch from the MLU. It is usually applied as a spray or lotion and offers several hours of

protection. However, Androsch and his team are looking for ways to release the agent over a much longer period, such as by encapsulating it in a wearable ring or bracelet.

The researchers used a special 3D printing technique to insert the insect repellent into a

biodegradable polymer in a controlled manner and to shape the mixture of substances in various ways. "The basic idea is that the insect repellent continuously evaporates and forms a barrier for insects," explains the lead author of the study, Fanfan Du, a doctoral candidate at the MLU.

The rate at which the insect repellent evaporates depends on many different factors, including temperature, concentration and the structure of the polymer used. After conducting various experiments and simulations, the team predicts that the insect repellent needs well over a week to evaporate completely at a temperature of 37°C (98,6 °F, i.e., body temperature).

While the researchers have proven that it is absolutely possible to develop a wearable insect repellent, the rings and other forms created for the study are only prototypes. According to Androsch, further research needs to be carried out to determine how well the rings function under actual conditions. The encapsulation material could also be further optimized.

SC Asks Animal Welfare Body To Submit Data On Dog Bites

New Delhi: The Supreme Court Wednesday directed the Animal Welfare Board of India (AWBI) to submit data on dog bites in the last seven years across the country and the steps taken to check such incidents.

A bench of Justices Sanjiv Khanna and J K Maheshwari directed the AWBI to file an affidavit mentioning the details and also indicate whether it would like the court to lay the guidelines.

It also clarified that its 2015 order does not prohibit the authorities or individuals including registered societies from approaching high courts or jurisdictional courts.

"We do not think it is the intent of this court in the said order that all writ petitions or proceedings before HCs, civil courts and authorities should come to a standstill and no effective orders can be passed by HCs in cases pertaining to stray dogs," the bench said.

The top court had earlier said a balance has to be maintained between the safety of people and animal rights, and suggested those who feed stray dogs could be made responsible for vaccinating them and bearing the cost of treatment if somebody is attacked by the animal.

RSS Launches JK Trifurcation Campaign

RINAGAR- The Rashtriya Swayamsevak Sangh (RSS) has formally launched its campaign for the trifurcation of Jammu and Kashmir coming out in the open, for the first time, in support of the division of the only Muslim majority state. Advocating Reorganisation of the state by what it perceives as isolation of the Muslim majority valley from rest of the state, the organisation (visualizes the move as a step towards early solution of the Kashmir problem).

According to a report earned by The Times of India today. the RSS has planned "mass action programme' and has floated an umbrella organisation - the Jammu and Kashmir Nationalist Front (JKNF) - and was 'subtly' promoting groups to organist mass agitations to get the state divided into Hindu Jammu, Muslim valley and Budhist Ladakh The Front held its first dharna in Jammu interestingly on Gandhi Jayanti. In fact, according to the report, the RSS plan would not stop

at the mere 'trifurcation' of the state It favours further division of the Muslim dominated valley by carving out a separate homeland for the migrant Kashmiri Pandits. The movement envisages mobilisation of public opinion in the Muslims majority districts of Poonch, Rajoujri and Doda, besides the Gujjar community against what it describes as 'Kashmiri hegemony'.

Quoting M G Vaidya, an RSS spokesman in New Delhi, the report said, Trifurcation doesn't mean surrender to the Two-Na-

tion theory. The reorganisation is basically an administrative measure." The Sangh Parivar believes that Kashmiri extremism can be dealt with only by separating the valley from rest of the state and focussing on the insurgency operations in the Muslim majority valley, the report said.

While the RBS-backid JKNF was gaining ground, the

report said, the BJP had, curiously, kept itself away so far. The recent dharna in Jammu was joined by even the mainstream parties like the Janata Dal (U) and Bhin Singh's Panther's party. explaining the reasons, the co-convenor of the JKNP, Yesh Bhasin, a former RSS Parcharak and state BJP leader, told the newspaper, "The BJP is not openly supporting us since they are bound by the NDA's policies.

"Get Registered Within A Month Or...": Uttarakhand's **Ultimatum To Madrasas**



Dehradun: Madrasas in Uttarakhand have been ordered to get themselves registered with the state education department within a month or face closure.

There are around 400 unregistered madrasas in the state, according to the government.

"Madrasas have been served an ultimatum to register with the state education department within a month. If they fail to meet the deadline, steps will be taken to shut them," Uttarakhand Social Welfare and Minority Welfare Minister Chandan Ram Dass said.

Currently, 419 madrasas are registered with the Uttarakhand Madrassa Board. Of these, 192 receive grants from the Centre and the state government.

The state government estimates that there around 400 more madrasas and they remain unregistered.

"Not registering with the state education department is harming the future of the students who study there as they face problems in getting admis-

sions after Class V," Dass said. The direction to get regis-

tered is aimed at the welfare of the students because only then can they avail of benefits of the central and state government

schemes, he added. As there were allegations that the grants given to the madrassas were not being appropriately utilised, Chief Minister Pushkar Singh Dhami had recently underlined the need to have them surveyed.

State Waqf board chairman Shadab Shams said he had a word with the chief minister regarding the issue and a committee will soon be set up to survey the madrasas.

Soon after taking over as the state Waqf board chairman last month, Shams had made a strong pitch for providing modern education in madrasas.

He said the board plans to introduce the state education board syllabus in madrasas and provide similar education to its students as children in private

and government schools. CCTV cameras will also be installed in madrasas to ensure transparency in their activities,

Uttarakhand Waqf Board runs 103 madrasas.

Biden Vows "Consequences" For Saudis **After OPEC+ Cuts Output**

President Joe Biden said on Tuesday there will be "consequences for Saudi Arabia as the Riyadhled OPEC+ alliance moves to cut oil production and Democratic lawmakers call for a freeze on cooperation with the Saudis.

Biden suggested he would soon take action as aides announced that the administration is reevaluating its relationship with the kingdom in light of the oil production cut that White House officials say will help another OPEC+ member, Russia, pad its coffers as it continues its nearly eight-month war in Ukraine.

Democratic Sen. Richard Blumenthal of Connecticut and Rep. Ro Khanna of California introduced legislation that would immediately pause all US arms sales to Saudi Arabia for one year.
This pause would also halt

sales of spare and repair parts, support services and logistical support. But it remains to be seen how far Biden is willing to go in showing his displeasure with the Saudis, a vital but complicated ally in the Middle East.

Biden came into office vowing to recalibrate the US relationship because of Saudi Arabia's human rights record but then paid a visit to the kingdom earlier this year.

Biden said in a CNN interview he would look to consult with Congress on the way forward, but stopped short of endorsing the Democratic lawmakers' call to halt weapons sales.

There's going to be some consequences for what they've done,



with Russia, Biden said. I'm not going to get into what I'd consider and what I have in mind. But there will be there will be conse-

John Kirby, a White House National Security Council spokesman, said Biden believes it's time to take another look at this relationship and make sure that it's serving our national security interests. Press secretary Karine Jean-Pierre said on Tuesday the White House has no timeline for its review nor has the president appointed an adviser to serve as point person.

Meanwhile, officials underscore the central role that Saudi Arabia plays in addressing broader national security concerns in the Middle East.

Blumenthal and Khanna unveiled their legislation one day

after Sen. Robert Menendez, a New Jersey Democrat, said it was unacceptable that OPEC+ had moved to cut oil production and effectively assist Moscow in its war on Ukraine.

Menendez promised to use his position as chairman of the Senate Foreign Relations Committee to block any future arms sales to the Saudis.

Menendez did not warn the White House before announcing his intention to block future Saudi arms sales, Kirby said. OPEC+, which includes Rus-

sia as well as Saudi Arabia, announced last week it would cut production by 2 million barrels a day, which will help prop up oil prices that are allowing Russian President Vladimir Putin to keep paying for his eight-month inva-

Hezbollah Pledges To Remain On Alert Until Lebanon-Israel Maritime Deal Is Signed

The Secretary General of Hezbollah, Hassan Nasrallah, cautiously welcomed the landmark agreement between Israel and Lebanon to settle a maritime border dispute during a speech on 11 October.

"We don't need to send out drones or carry out maneuvers because the goal was for the enemy to understand that the resistance is serious," the Hezbollah chief said, adding that "Israel is more afraid of war than the Lebanese."

Nasrallah went on to say that, despite the agreement reached on Monday, the resistance will remain "vigilant" until the documents are officially signed.

"We will wait, as long as Lebanon and Israel don't sign on paperwork in Naqoura, we don't have a deal yet," Nasrallah said.

The resistance leader also dismissed accusations made against Hezbollah claiming it sought to derail the deal, saying: "It is strange that some in Israel and in the Arab media are claiming that Hezbollah wants to sabotage the deal. We have no problem when the Lebanese officials say that the agreement meets the Lebanese demands."

"We only care about the ex-

traction of oil and gas from Lebanese waters and our stance on demarcation is known," Nasrallah went on to say, noting that he does not recognize Israel's border.

"Don't dare accuse us of not caring for Lebanon's rights. If you ask me about our maritime border, I'd say it extends to the sea of Gaza. We and the Palestinians are one and we don't separate our borders.'

"Tonight we will not issue threats. Tonight there will only be joy and clapping," Nasrallah added during a televised address marking the birthday of the Prophet Muhammad.

Earlier on Tuesday, Lebanese and Israeli officials announced their acceptance of a US-drafted proposal for the first-ever mutually agreed upon boundary between the two nations, to determine control of two offshore natural gas fields.

The two countries have no direct diplomatic relations and are technically in a state of war.

Since mid-June – when Tel Aviv deployed drilling and extraction vessels to the disputed Karish gas field in the Mediterranean Sea – Hezbollah threatened to bomb the rigs if Israel began extracting gas without delimiting the maritime borders first.



Iran to Stage Joint Naval Exercise with China, Russia



Ahigh-ranking Iranian military commander says the Islamic Republic of Iran Navy plans to hold a joint naval exercise with China, Russia and a number of other countries in the northern tip of the Indian Ocean in the near future.

Iranian Navy Commander Rear Admiral Shahram Irani said on Wednesday that the forthcoming naval drill is meant to boost up the combat capabilities of Iranian forces, and falls within the framework of maritime diplomacy so as to ensure sustainable security.

He noted that Iran has invited a number of member states of the Indian Ocean Naval Symposium (IONS) – a forum aimed at increasing maritime cooperation among the littoral states of the Indian Ocean region, to take part in the joint exercise.

tively participate in the joint drill, Irani stated, adding that the war games have been designed in accordance with an instruction book compiled by the Iranian Navy.

The Iranian Navy commander also noted that Iran is currently holding a joint naval rescue and relief exercise with a number of friendly states and allies.

Iran, Oman stage joint naval drill Meanwhile the Iranian and Omani naval forces launched a joint military exercise in the Sea of Oman and the northern parts of the Indian Ocean. The military exercise, backed by helicopters from both countries and Iranian drones, was held in the presence of the heads of the joint military friendship commissions of the two countries and their members.

NATO To Conduct Nuclear Exercise Next Week Despite Russian Warnings

NATO will push ahead with longplanned nuclear exercises next week despite rising tensions over the war in Ukraine and President Vladimir Putin's insistence that he is not bluffing about using all available means to defend Russian territory, NATO Secretary-General Jens Stoltenberg said Tuesday.

The exercise, dubbed Stead-fast Noon, is held annually and usually runs for about one week.

It involves fighter jets capable of carrying nuclear warheads but involve any live bombs Conventional jets, and surveillance and refuelling aircraft also routinely take part.

Fourteen of the 30 NATO member countries will be involved in the exercise, which was planned before Russia invaded Ukraine in February.

"The main part of the manoeuvres would be held more than 1,000 kilometres from Russia." a NATO official said.

"It would send a very wrong signal if we suddenly now cancelled a routine, long-time planned exercise because of the war in Ukraine. That would be absolutely the wrong signal to send," Stoltenberg told reporters on the eve of a meeting of NATO defence ministers in Brussels.



"NATO's firm, predictable behaviour, our military strength, lation," he said. "If we now created the grounds for any misunderstandings, miscalculations in Moscow about our willingness to protect and defend all allies, we would increase the risk of escalation," he added.

With the Russian army retreating under the blows of Ukrainian forces armed with Western weapons, Putin raised the stakes by annexing four Ukrainian regions and declaring a partial mobilisation of up to 300,000 reservists to buttress the crumbling front line.

As his war plans have gone awry, Putin has repeatedly signalled that he could resort to nuclear weapons to protect the Russian gains. The threat is also

aimed at deterring NATO nations from sending more sophisticated

NATO as an organisation does not possess any weapons. The nuclear weapons nominally linked to NATO remain under the firm control of three member countries the US, UK, and France, The alliance's secretive Nuclear Planning Group will meet on Thursday among defence ministers.

Stoltenberg described Putin's spiralling nuclear rhetoric as dangerous and reckless, and underlined that the allies have also conveyed clearly to Russia that it will have severe consequences if they use nuclear weapons in any way.

"We are closely monitoring Russia's nuclear forces," Stoltenberg said. We have not seen any changes in Russia's posture, but we remain vigilant.

14 Arrested Members Of Banned Group PFI File Plea Seeking Compensation

New Delhi: Fourteen PFI members, arrested in a massive crackdown on the radical Muslim outfit over its alleged terror links, Wednesday approached the Delhi High Court seeking their release and compensation, claiming they were unlawfully detained.

Three separate petitions came up before a bench of Justices Siddharth Mridul and Amit

Sharma which granted time to the petitioners' counsel to file additional documents and relevant judgements to support their case. The bench listed the matter for further hearing on November 21.

During the hearing, Delhi Police raised preliminary objection over validity of the petitions and said habeas corpus pleas cannot lie as most of the petitioners have been released on bail.

A habeas corpus petition is filed seeking direction to produce a person who is missing or has been illegally detained.

were arrested from their respective homes here on the night of September 27 when police personnel in civilian clothes as well as in uniform barged in and picked them up without informing them or their families anything about the reasons for their

> The petitioners have sought an independent, appropriate enquiry against the authorities so the erring officials could meet the justice.

A large number of alleged PFI activists were detained or arrested in several states during the massive raids preceding the nation-wide ban imposed on the organisation on September 28.

The government banned the PFI and several of its associate organisations for five years under the stringent anti-terror law UAPA, accusing them of having links with global terror groups like the ISIS.

'Alive': Plane Crash Survivors On Eating Dead **Bodies, Fighting To Live**

Montevideo: The first night was the worst, Roy Harley recalls of the 10 weeks he and other survivors of a plane crash 50 years ago managed to cling to life on an Andean glacier without food or shelter, and very little reason for hope.

Of the plane's 45 occupants. 16 made it home from the 72-day ordeal that became known as the "Miracle of the Andes".

The only way to survive was to eat the flesh of the dead. But for Harley, a retired engineer now aged 70, that was not the worst of the nightmare made famous by the 1993 film "Alive".

After the initial shock of their plane crashing into the Andes mountains on that fateful Friday the 13th of October 1972, Harley and 31 other survivors found themselves in the pitch dark in minus 30 degrees Celsius (-22 Fahrenheit) at an altitude of some 3,500 meters.



Many of them not yet 20 -the plane was flying an amateur Uruguayan rugby team and family members to a match in Chile -- none were dressed for the cold.

Several were badly injured. Those who could squeezed into what remained of the fuselage between dead bodies and the screams

of the wounded. "That night, I experienced hell," Harley told AFP.

"At my feet was a boy who was missing a part of his face and... choking on blood.

"I didn't have the courage to reach out to him, to hold his hand, to comfort him. I was afraid. I was very afraid."

By morning, four more were dead, and so started a seemingly relentless torment that would eventually whittle the number of survivors down to 16. 'No words'

There were too many dark moments to list.

"I don't have words to describe how cold it was," said Harley's former rugby teammate, fellow survivor and friend Carlos Paez, 68. "We were so cold, it was so difficult, that I have no words to describe it."

Many times they thought it was the end. On Day 10, the survivors heard on the plane radio that the search for them had been called off. "One of the most painful things was... to realize that the world was

going on without us," said Paez,

who today travels the world as a motivational speaker. But it was also the jolt the survivors needed to take matters into their own hands and start trying to find a way off the glacier, he recalled.

Another tribulation was having

to broach the topic of anthropoph-

agy -- the eating of human flesh.

"He (petitioner) was in the highest category of blacklisting. There was a lot of material because of which he had to be deported. There is more to it than meets the eyes,' the central government lawyer told



the court on Wednesday. He also urged the court to peruse the relevant file as it was not possible to "disclose everything on an affidavit".

Justice Yashwant Varma, however, asked the Centre to first file its written response in the matter before any privileged document is considered by the court.

"File an affidavit. It would be unfair to the petitioner that we

independently peruse something which is produced in a sealed cover and they don't get to know what it is. If that affidavit lays the foundation for us to see some documents which are privileged... then we will consider looking into it," said the judge, granting four weeks' time to the Centre to file the response. In his plea, the petitioner has said the reasons behind his "forceful" deportation from the airport and the de-

nial of entry in spite of a valid visa are "unknown" and his representations to the authorities remain unanswered. He has claimed the conduct of

the authorities was "unfair, unjust and arbitrary" as well as ultra vires the Constitution of India, international law and fundamental hu-

man rights and dignity.
"Shockingly, when the petitioner landed in Thiruvananthapuram at 3.05 AM after a journey of about twenty hours with a layover in Dubai - he was denied entry and was forcibly deported.

Samples Of Two Monkeypox Suspects Return Negative

SRINAGAR: The samples of two suspected Monkeypox cases from Uri area of north Kashmir's Baramulla district have turned negative, officials said here on Wednesday.

J&K Parties Slam Order On Registration Of New Voters

SRINAGAR: The National Conference, PDP, Congress and other prominent political parties in Jammu and Kashmir on Wednesday flayed the Jammu administration's order on facilitating the registration of new voters who are from outside the union territory, while the BJP defended it saying it is in line with the laws.

They were reacting after the Jammu administration authorised tehsildars (revenue officials) to issue a certificate of residence to those residing in the winter capital for more than a year to enable their registration as

While Peoples Democratic Party (PDP) president Mehbooba Mufti alleged that the Centre's "colonial settler project" has been initiated in the region, the National Conference urged people of J-K to defeat these conspiracies at the ballot box.

Former Congress leader and Democratic Azad Party chairman Ghulam Nabi Azad said the order would increase social tensions in J-K, while the Peoples Conference termed the Jammu's DC order "highly suspi-

"The ECI's latest order for registration of new voters makes it clear that GOIs colonial settler project has been initiated in Jammu. They will bear the first blow to Dogra culture, identity, employment & business," Mufti

Talking to reporters in Kulgam district in south Kashmir, Mufti said her party has been saying that the BIP has an illegitimate intent behind the abrogation of Article 370.

"Their aim is to change the population ratio in J-K. It will start in Jammu when a sea of people will come from outside, which will not only harm the Dogra culture there but the business, employment and resources there will be attacked. The crime rate there has increased manifold since they opened the doors for the outsiders," she alleged.

The National Conference (NC) claimed the BJP is "scared" of the elections and knows it will lose badly.

The Government is going ahead with its plan to add 25 lakh non-local voters in J&K and we continue to oppose this move. BIP is scared of the elections & knows it will lose badly. People of J&K must defeat these conspiracies at the ballot box," the NC

NC state spokesperson Imran Nabi Dar said the fresh order was an extension of what the then Chief Electoral Officer Hridesh Kumar had said at his press conference in Jammu.

The party had opposed it then and continues to oppose it now, he said." "The only antidote that will defeat

all these controversies is that the people of Jammu and Kashmir that includes Dogra Muslims, Kashmiris, Gujjars, Paharis and other sections, they need to register themselves as voters and when the election comes, they should come out and vote in large numbers. That is the only way we can defeat their nefarious designs," Dar told PTI.

The People's Alliance for Gupkar Declaration (PAGD), headed by National Conference president Farooq Abdullah, had on Saturday announced the formation of a 14-member committee to chalk out a strategy on the issue of any attempt of manipulation and inclusion of non-locals in the revised electoral rolls.

The panel has members from the five PAGD constituents and several other political parties such as the

Congress, the Shiv Sena, the Dogra Swabhiman Sangathan Party (DSSP) and the Dogra Sadar Sabha (DSS).

The Peoples Conference said in a statement that the Jammu DC order "reinforces the apprehensions in the minds of locals that outsiders are being enabled to register as voters to change the demographic profile of I-K"

It urged the Election Commission of India as well as the J-K administration to come clean on the matter.

'We will always oppose making a non-resident a voter because Article 370 biggest benefit was that outsiders will not become voters here. This is not right, not right for the state and it will increase social tension," Azad told reporters.

The Special Summary Revision of electoral rolls was started in the Union Territory on September 15 for the registration of new voters, deletion, correction, and transposition of voters who have migrated or died since the last summary revision.

The cat is out of the bag finally and we will not allow this (giving voting rights to non-locals) to happen. We are against such a move because it is a conspiracy hatched by BJP to divest locals of their rights and control power with the support of outsiders," J- K Pradesh Congress Committee president Vikar Rasool Wani told reporters in Jammu. The Congress leader also de-

nounced the recent government order allowing departmental stores to sell beer and Ready-to-Use drinks and said such an order should be immediately revoked to honour the religious sentiments of the people.

J&K BJP president Ravinder Raina, however, said the guidelines are in accordance with the Representation of the People Act.

There is nothing wrong in people from outside J&K getting enrolled as voters in the Union Territory, a right which is given to them by the Constitution. After the abrogation of Article 370 (in August 2019), the Act came into force in J-K as well, he said.

He accused opposition parties including the National Conference, Congress and PDP of unleashing propaganda under a conspiracy to mislead the people.

Aam Aadmi Party (AAP) leader and former minister Harsh Dev Singh, however, accused the BJP of misrepresenting and misinterpreting the Representation of Peoples Act (RPA) to justify the inclusion of non-local voters.

He said that nowhere does the RPA state that the voter of one State/UT can get himself registered as a voter in some other State/UT for elections to the legislative assembly of that State/UT. In the absence of an express provi-

sion in RPA to the effect, the existing law is being misinterpreted by the vested interests to sub-serve their political motives, he alleged.

Singh said uniform yardsticks cannot be applied for Parliamentary and Assembly elections. What right do the outsiders have to decide as to who should represent J&K as its MLAs or ministers, Singh questioned.

We welcome giving voting rights to Pakistan-occupied Jammu and Kashmir, Balmiki and Gorkha community, but the decision to give voting rights to non-locals camping in Jammu and Kashmir for just one year cannot be tolerated. Shiv Sena leader Manish Sahni said.

He warned that all the opposition parties are united over this issue and a mass movement will be launched against any such attempt.

Slowing Economic Growth

ccording to the IMF, the impact of the Russia-Ukraine war, tightening monetary conditions worldwide, the greatest inflation in decades, and the lingering effects of the pandemic will cause a general slowdown across the world, including India, in the upcoming year. India's growth has been projected to decline to 6.8 percent after registering a healthy increase of 8.7 percent in the last fiscal year. However, finance minister Nirmala Sitharaman who is in Washington, asserted that India will grow at 7 percent this year. She, however, observed that the Indian economy is not exempt from the impact of the world economy.

Ukraine war has been the singlemost factor for the current setback to the global economy. In today's globalized world, events in one part of the world trigger far-reaching fallout in other parts. There have been foodgrain and fuel shortages which have driven up prices and this has been a matter of great concern for developing countries.

The continuing war, however, is bad for the world economy as the shrinking of the US economy through the April to June quarter shows. A slowing US economy will have far-reaching effects on the world. And this is happening at a time when the global economy was gradually recovering from the debilitating fallout of the Covid-19 pandemic, a once-in-a-century event. The countries were opening up and letting the economy function normally. International travel has also returned to pre-pandemic levels.

The IMF's dismal growth forecast for Indian economy is not a good news after a year of healthy growth. For two years after the advent of Covid-19 pandemic, Indian economy performed well below even some sub-saharan countries. The pandemic and the consequent lockdown also dealt a body blow to the global economy. And Indian economy was the worst hit, losing one-fourth of its GDP in the first quarter of 2020. The extended lockdown hit the economy hard leaving millions of people jobless. It also disrupted the supply lines and forced migrant workers to head home.

Kashmir economy also suffered. According to an estimate by the local business bodies then, the Valley suffered a loss of over Rs 50,000 crore during the extended lockdown from August 2019 to in May 2020. Its fallout on the ground was grim. Sectors of the economy like tourism, handicrafts, hotel industry, IT, transport etc were crushed. People were forced to shut down their old unviable businesses and start new ones. Now Kashmir is witnessing a bumper tourist year which has brought growth and jobs back.

But the ongoing war in Ukraine remains a danger. If the war drags on, the global economy, and with it the Indian economy, is likely to come under severe stress again. Therefore it is incumbent on the world to come together to resolve the crisis in Ukraine and find a solution that addresses the concerns of all the parties involved. Otherwise, as prophesied by leading economists, the world is heading inexorably toward recession.

World's Ice is Melting. Humanity Must Prepare

s this month's unseasonably high temperatures drove unprecedented melting of the Greenland ice sheet, experts delivered a chilling message: Get used to it. Massive stores of ice sit atop land in Greenland and Antarctica, and if even a small fraction melted into the oceans, sea levels would rise dramatically. Scientists are still figuring out how fast this might happen. But new research leaves little room for optimism.

Over the course of this century, countless millions of people will have to reckon with rising seas. There are few easy answers, but humanity must — with urgency — prepare now.

In a new paper in the journal Nature Climate Change, researchers estimated that Greenland's "zombie ice" — immense chunks destined to melt because of the changes that have already occurred — will boost sea levels by nearly a foot. The scientists calculate that some 3.3 percent of the island's ice sheet is bound to disappear into the oceans, much of that over the course of this century, which equates to 110 trillion tons of ice. These estimates, based on direct observations of Greenland, are more pessimistic than previous projections, which relied on computer modeling. According to the researchers, their new estimates represent the minimum that could happen if global warming were to continue.

These estimates do not take into account melting occurring in other areas, particularly Antarctica — and news from scientists on that end of the world, announced this month, was not good.

The world has been amply warned. Scientists have raised the alarm: sea-level rise is not a matter of "if" but a matter of "when and how much." The nation's leaders must not wait for the floodwaters to inundate their communities — or the wildfires to get worse, or the droughts to become more severe — to plan for the new reality.

Building Kashmir Into a Disaster-resilient Community

uman-induced climate including more frequent and intense extreme events (hot extremes on land and in the ocean, heavy precipitation events, drought and fire weather), has caused far and wide adverse impact and related losses and damages to ecosystems, people, settlements and infrastructure, beyond natural climate variability. Terrestrial, freshwater, and coastal and open ocean marine ecosystems have also been seriously affected. Additionally, it has made it harder to meet Sustainable Development Goals by reducing food and water security.

There has been a high death and morbidity rate in all regions due to extreme heat events. Over 2,000 people died in Spain and Portugal from heat-related causes over roughly a week by an unprecedented heat wave in July this year. In 2018 alone, the EU recorded 104,000 heat-related deaths among the elderly people, over one third of the global total, according to the Lancet Countdown report published in December 2020.

The occurrence of climate-related food-borne and water-borne diseases has increased. The spread of animal and human diseases, including zoonoses, is occurring in new locations. Climate-sensitive cardiovascular and respiratory distress has been linked to increased exposure to wildfire smoke, atmospheric dust, and aeroallergens.

Some losses have already become irreversible, whereas others are on their way to irreversibility, such as the impacts of hydrological changes resulting from the retreat of glaciers, or the effects of permafrost thaw on mountain and Arctic ecosystems.


It is becoming increasingly difficult and complex to manage the effects and risks of climate change. There will be multiple climate hazards occurring simultaneously, and multiple climatic and non-climatic risks interacting, compounding overall risk and cascading across sectors and regions.

Jammu and Kashmir has been witnessing an increase in a number of extreme events from the past 10 years. Massive flood in 2014, river Jhelum crossing the flood declaration mark five times in 2015, 2 dozen cloudbursts in Kashmir valley in 2015, cloudbursts at Kishtwar and Amarnath Cave Sonamarg in 2021 and 2022, respectively, extreme snow and rain spells in 2021 when the south Kashmir plains were buried under up to five feet of snow within a period of three days, untimely heavy November snowfall in 2018 and 2019, October snowfall in south Kashmir plains in 2021 and April snowfall in Kashmir plains in 2017, are a few of the extreme events that I have mentioned here. There have undoubtedly been many more. This agrees with the Intergovernmental Panel on Climate Change's (IPCC) 6th Assessment Report 'Climate Change 2021: The Physical Science Basis' - a 3,949page report based on more than 14,000 scientific papers, written by 234 scientists, which states that extreme temperature events that used to occur once every 10 years are occurring 2.8 times more frequently nowadays, extreme precipitation events with 1.3 times more frequency and agricultural and ecological events with 1.7 times more frequency and their frequency will only increase as the temperature

By limiting global warming to less than 1.5°C in the near future, human systems and ecosystems will have substantial reductions in projected losses and damages as compared to higher warming levels.

Adaptation, as defined in the second part of the Sixth Assessment Report of the IPCC, in human systems is the process of adjustment to actual or expected climate and its effects in order to moderate harm or take advantage of beneficial opportunities and in

Projected changes in extremes are larger in frequency and intensity with every additional increment of global warming



Urban planning and infrastructure design that is sustainable, such as green roofs and facades, parks and open spaces, the management of wetlands and forests, urban agriculture, and water-sensitive design, can be used to mitigate and adapt to climate change in settlements. These options can improve air quality and benefit health as well as reduce flood risks, pressure on sewage systems, and urban heat island effects

natural systems, the process of adjustment to actual climate and its effects. It plays a key role in reducing exposure and vulnerability to climate change.

The adoption of effective adaptation options and public policies will help enhance food availability and stability, reduce climate risks, and increase the sustainability of food systems. Cultivar improvements, agroforestry, community-based adaptations, farm and landscape diversification, and urban agriculture are among the effective options. Agroecological principles and practices, ecosystem-based management in fisheries and aquaculture, and other approaches that work with natural processes support food security, nutrition, health and well-being, livelihoods and biodiversity, sustainability, and ecosystem services. These services include pest control, pollination, buffering of temperature extremes, and carbon sequestration and storage. Adaptation strategies that reduce food loss and waste or support balanced diets contribute to nutrition, health, biodiversity, and

other environmental benefits. The combination of non-structural measures like early warning systems with structural measures like levees has reduced the number of people killed in inland flooding. Further reducing flood risks can be accomplished by restoring wetlands and rivers, implementing land use planning measures such as no-build zones, and managing upstream forests. The management of on-farm water, storage of water, soil moisture conservation, and irrigation are some of the most common adaptation responses that reduce vulnerability as well as provide economic, institutional, and ecological benefits. Several livelihood benefits can be derived from irrigation, which reduces drought risk and climate impacts in many regions. However, proper management is required to avoid adverse outcomes, such as accelerated depletion of groundwater and other water sources and increased soil salinization.

Measures to conserve, protect, and restore natural forests are part of forest adaptation. Sustainable forest management, diversifying and adjusting tree species compositions to build resilience, managing pest and disease risks, and managing wildfire risk are examples of adaptation strategies used in managed forests. In general, improving sustainable forest management, restoring natural forests and drained peatlands, restoring and conserving natural ecosystems and biodiversity, reforestation and avoiding deforestation, agroforestry, soil carbon management, and reducing CH4 and N2O emissions from livestock and soil in agriculture can boost the resilience of carbon stocks and sinks.

resilience of carbon stocks and sinks.

A combination of conservation, protection, restoration, and targeted management to adapt to the unavoidable impacts of climate change reduces the vulnerability of biodiversity to climate change.

In order to promote urban and rural system transitions, inclusive, integrated, and long-term planning is essential at the local, municipal, sub-national, and national levels, together with effective regulation and monitoring systems in addition to financial and technological resources and capabilities. The ability of vulnerable people to adapt to changing conditions is improved when governments, civil society, and private sector organizations work together across scales.

Human health and well-being will be protected and promoted by strengthening health systems' climate resiliency. An effective adaptation option for extreme heat is a Heat Health Action Plan that includes early warning and response systems. Improvements in access to potable water, reducing exposure of water and sanitation systems to flooding and extreme weather events, and

improving early warning systems are some of the most effective adaptation options for water-borne and food-borne diseases. In the case of vector-borne diseases, effective adaptation options include surveillance, early warning systems, and vaccine development. Improved surveillance, access to mental health care, and monitoring of psychosocial impacts of extreme weather are effective adaptation options for reducing mental health risks under climate change.

By improving knowledge of risks, impacts, consequences, and available adaptation options, societal and policy responses will be strengthened. As a result of a wide range of top-down, bottom-up, and collaborative processes and sources, climate knowledge and sharing can be deepened, including capacity building at all scales, educational and information programs, use of the arts, participatory modelling, climate services, indigenous and local knowledge, and citizen science. In addition to raising awareness, these measures can influence behaviour and heighten risk perception.

A substantial reduction in overall fossil fuel use, the adoption of lowemission energy sources, the use of alternative energy carriers, and energy efficiency and conservation are all essential to reducing greenhouse gas emissions across the full energy sector. By moving toward net-zero emissions through low-emission development pathways, urban areas can increase resource efficiency and significantly reduce greenhouse gas emissions. It is possible for cities to reach net-zero emissions, but only if they reduce emissions within and outside of their administrative boundaries through supply chains, which will then have positive cascading effects across other sectors.

The most significant potential for decarbonization in land-based transport is offered by electric vehicles powered by low-emissions electricity. The use of sustainable biofuels in land-based transport can provide additional mitigation benefits in the short and medium term. It is possible to reduce CO2 emissions from ships, aircraft, and heavy-duty land transportation by using sustainable biofuels, low-emission hydrogen and derivatives (including synthetic fuels). However, improvements in production processes and cost reductions are needed in order to achieve these goals. A number of mitigation strategies in the transport sector can have various co-benefits. These include improved air quality, improved health, equitable access to transportation services, a reduction in congestion, and a reduction in material consumption.

Urban planning and infrastructure design that is sustainable, such as green roofs and facades, parks and open spaces, the management of wetlands and forests, urban agriculture, and water-sensitive design, can be used to mitigate and adapt to climate change in settlements. These options can improve air quality and benefit health as well as reduce flood risks, pressure on sewage systems, and urban heat island effects.

The mitigation of land-related impacts with adaptive benefits may include agroforestry, cover crops, intercropping, perennial plants, restoring natural vegetation, and restoring degraded land. By maintaining land productivity and protecting and diversifying livelihoods, these measures can increase resilience.

A number of feasible and effective adaptation options exist which can reduce risks to people & nature, and the people & government of Jammu and Kashmir can implement some of them at least

Earthquake and flood hazards turn into disasters because of human inaction; evidence is Kashmir

The earthquakes and floods in any part of the world are turning into disasters mainly because of our inaction; this concern was the central theme of the #NoNaturalDisasters Conference in London, held in September 2022. The first such conference in the world that takes a radically different stand on how disasters are unnatural. The name of the conference suggests the unnaturalness of disasters, which is why the campaign started in 2017 and has attracted some traction internationally. The main goal of the forum and the campaign is to alert people nationally and internationally about using the word Natural in disasters because it blames nature when disaster strikes and gives an easy route to authorities, including politicians, to escape responsibilities and

questions on how hazards turn into disasters. The scientific data suggest that most disas-

The scientific data suggest that most disasters are caused by human inaction. For example, when the magnitude 7.6 earthquake occurred in Muzferabad, Pakistan, in 2005, it instantly became a catastrophe by killing more than 80 000 human lives, causing innumerable losses to other forms of life, including livestock, and billions in economic losses. A much higher magnitude earthquake occurred in New Zealand in 2016 and resulted in the loss of two people. The quake was of magnitude 7.8 and struck on November 14, the largest earthquake in the country in the past 100 years.

Comparing the losses in the two earthquakes mentioned above clearly maps the unnaturalness of disasters. Pakistan was not ready to face earthquakes, while Newzealand was ready, which made the difference. And the main question is about who should

take responsibility for inaction. For example, we routinely get a quick reaction from parents and authorities when an educational institute does not perform in a competitive examination; either the teachers have to explain their position, or other action will

be taken. Therefore, it is straightforward to map who should take the blame when a hazard turns into a disaster.

At the conference, I demonstrated through evidence-based research that the inaction of authorities and people in Jammu and Kashmir had turned past hazards and disasters, including floods and earthquakes. Unfortunately, even now, no systematic planning is in sight, which would have given us a sense of safety and security incase of an earthquake or flood. Therefore, we are bound to face problems in the future, which could be much harsher than what Pakistan witnessed in 2005. Only thinking about it sends chills down the spine.

I am not sure how people can sleep peacefully in a region like Kashmir, where the occurrence of earthquakes is always looming, a doubtless forecast. What surprises me is that

the ground is not prepared for it, which is very scary. Therefore, we must generate a sense of urgency by involving people, scientists, and other stakeholders worldwide to campaign for the safety and security of nations that face dangerous hazards that could turn into disasters. The fact that most of the threats are turning into disasters by the inaction of humans makes it evident that humans have to take responsibility and ought to act responsibly for safety and security from floods, earthquakes, and so on. And if there are apparent lapses in stopping a hazard from becoming a disaster, we must ask questions and take appropriate actions. It is time to do that and not wait for the dangers to become disasters.

rinagar- Eight years after devastating floods hit the Kashmir Valley, the Jal Shakti, previously known as Irrigation & Flood Control Department is carrying out a study for assessing the flood hazard risk wherein an Integrated Forecasting System (IFS) coupled with a Decision Support System will be made for effective and prompt response for any flood related disaster in the Union Territory.

According to the government, the consultancy for this assignment has been outsourced to M/S RMS Pvt. Ltd.

The department has said this in a detailed status report submitted before the High Court (HC) of Jammu & Kashmir and Ladakh regarding framing of scheme for flood control and improvement of embankments of river Jhelum.

The status report was filed by Principal Secretary, Irrigation & Flood Control (I&FC) in pursuance to the directions of the High Court order.

The government submitted that under long term measures, several studies are underway and are likely to be completed within the next six months.

"The outcome of these studies shall lay foundation for future strategies to be adopted for Comprehensive Flood Management in Kashmir Valley which is aimed to help us in mitigating floods of 1, 15, 000 Cusecs at Sangam as witnessed during 2014," the status report reads, a copy of which lies with Kashmir Observer.

The government submitted that the Jal Shakti department through the Project Management Unit of Jhelum: Tawi food Recovery project (JTFRP) has undertaken Morphological Study of River Jhelum for the Flood mitigation.

"The study is currently going on wherein a 2D- Hydrodynamic model is being made and the various possible structural and non-structural measures will be studied and a comprehensive DPR for the same shall be formulated and put up to the government for approval," the status report noted.

Pertinently, the court was hearing a PIL filed by Environmental Policy Group (EPG), an Environment-Social think tank, through its Convenor, Faiz Ahmad Bakshi alleging that the Jal Shakti department miserably failed in increasing the carrying capacity of river Jhelum, Wullar and



other water bodies.
The Court then passed the direc-

tion asking Principal Secretary, Jal Shakti Department to file the status report.

The government submitted that after the devastating floods of September 2014 and on subsequent instructions of Prime Minister of India, a three members group headed by Chairman, CWC was constituted by Ministry of Water Resources (MoWR, RD&GR), Govt. of India on 18 September 2014 to conduct an in-depth study and analysis of the unprecedented floods in J&K so as to make suitable recommendations along with a detailed action plan to manage the future flood threat in Kashmir Valley.

It submitted that the core group comprising of Chairman Central Water Commission, Commissioner Indus and the Director National Institute of Hydrology Roorkee recommended immediate, short term and long term measures.

IMMEDIATE MEASURES AFTER 2014 FLOODS

The government submitted that under this, the department plugged all the breaches and restored 3316 number of spots under temporary restoration and 1235 spots under Permanent Restoration at a cost of Rs. 172.7383 Cr. and Rs. 153.4335 Crore. The department also executed numerous flood restoration works throughout the valley like Re-sectioning, Channelization of River, Nallahs, Crate Protection works, Strengthening/ Raising of embankments of both Jhelum and its tributaries for which the funds were released

SHORT TERM MEASURES

The Jal Shakti department said that in the short term the measures were conceived in two phases Phasel and Phase-ll.

PHASE-I

The department submitted that till the long-term food mitigation measures would get conceived and approved, a Priority Fond Management Project was formulated for urgent works wherein the main objective was to remove the immediate and the major bottlenecks in the River Jhelum & Flood Spill Channel to provide immediate relief from floods of low to moderate magnitude.

In phases-I of the project, the department used Rs. 399.29 Crore released by the central government for comprehensive plan for Flood Management Works on Jhelum It may be noted that phase-I was supposed to be completed in the year 2018, however the department missed several deadlines and the project is yet to be completed. The department submitted that the work in the Phase-1 is nearing completion with the date of completion slated as August, 2022.

The department said the after the Phase-I, the carrying capacity of Jhelum was enhanced to 31800 cuses to 41000 cuses from Sangam to Padshahi Bagh and from 27000 cuses to 32000 cuses at Ram Munshibagh in Srinagar while in North Kashmir, the carrying capacity of the Jhelum was enhanced from 20000 cusec to 22700 cuses at Nigli in Wullar, and from 31000 cusec to 35000 cusec at river Jhelum in Sopore.

PHASE-

The department said, as per the recommendations of the CW, the discharge carrying Capacity of the River Jhelum is proposed to be increased to 60,000 cusec at Sangam and 61110 cusec at Ningli Sopore.

It said the department during the execution of the Phase-I, started preparations of formulation for the DPR for Phase-II by first carrying out the Mathematical Model Studies of River Jhelum through Central Water power Research Station, Pune, at an estimated cost of Rs. 5411.54 Cr. and the same was submitted to the central government on 17 January 2019 for approval.

The court has now sought a response on the status report from amicus curiae, Advocate Nadeem Qadri.

Mediterranean Diet Improves Immunotherapy Response Rates, Progression-Free Survival In Melanoma Patients

Mediterranean diet high in fibre, monounsaturated fatty acids, and polyphenols has been linked to improved immunotherapy response rates and progression-free survival in patients with advanced melanoma, according to a new study.

Experts anticipate that the diet will play an important role in the success of immunotherapy and trials are being expanded to investigate outcomes for different tumour types, including digestive cancers.

A Mediterranean diet, containing mono-and polyunsaturated fats from olive oil, nuts and fish, polyphenols and fibre from vegetables, fruit, and wholegrains, was significantly associated with an improved response to immunotherapy drugs called Immune Checkpoint Inhibitors (ICIs). ICIs, which have been highly successful in treating melanoma, work by blocking immune system checkpoints, which then force the body's own T-cells to attack cancers.2 The new multi-centre study by researchers from the UK and the Netherlands, recorded the dietary intake of 91 patients with advanced



melanoma, who were treated with ICI drugs and monitored their progress with regular radiographic response

As well as having a significant association with overall response rate, a Mediterranean diet was significantly associated with progression-free survival at 12 months.

Laura Bolte, author of the study and PhD candidate under supervision of Prof. Rinse Weersma from the University Medical Center Groningen, Netherlands, commented, "ICI has helped to revolutionise the treatment of different types of advanced cancers. Our study underlines the importance of dietary assessment in cancer patients starting ICI treatment and supports a role for dietary strategies to improve patient outcomes and survival." The study also found that eating wholegrains and legumes reduced the likelihood of developing drug induced immune-related side effects, such as colitis. In contrast, red and processed meat was associated with a higher probability of immunerelated side effects.

"The relationship of ICI response with diet and the gut microbiome opens a promising and exciting future to enhance treatment responses. Clinical trials investigating the effect of a high fibre diet, ketogenic diet and supplementation of omega-3 are underway. Since ICI therapy is being expanded to various tumour types, including digestive cancers, these studies could unlock treatment benefits for a large group of cancer patients in the future," added Laura Bolte.

Adult Brain Has The Ability To Restore Vision: Research

A new insight into how some visually impaired adults can begin to see offers a fresh perspective on the brain's capabilities. According to new research, the adult brain has the potential to recover partially from inherited blindness. The team was examining treatment for Lever congenital amaurosis. known as LCA. The term refers to a group of inherited retinal diseases distinguished by severe visual impairment at birth. The condition, which stems from mutations in any of over two dozen genes, causes degeneration or dvsfunction in the retina's photoreceptors

Administering chemical compounds that target the retina, called synthetic retinoids, can restore a notable amount of vision in children with LCA. The UCI team wanted to find out if the treatment could make a difference for adults who have the condition.

"Frankly, we were blown away by how much the treatment rescued brain circuits involved in vision," said Sunil Gandhi. professor of neurobiology and behavior and the corresponding author. Gandhi is a fellow of UCI's Center for the Neurobiology of Learning and Memory and a member of the Center for Translational Vision Research. "Seeing involves more than intact and functioning retinae. It starts in the eye, which sends signals throughout the brain. It's in the central circuits of the brain where visual perception actually arises." Until now, scientists believed that the brain must receive those signals in childhood so that central circuits could wire themselves correctly.

Working with rodent models of LCA, the collaborators were surprised by what they found. "The central visual pathway signalling was significantly restored in adults, especially the circuits that deal with information coming from both eyes," Gandhi said. "Immediately after the treatment, the signals coming from the opposite-side eye, which is the dominant pathway in the mouse, activated two times more neurons in the brain. What was even more mind-blowing was that the signals coming from the same-side eye pathway activated five-fold more neurons in the brain after the treatment and this impressive effect was long-lasting. The restoration of visual function at the level of the brain was much greater than expected from the improvements we saw at the level of the retinae. The fact that this treatment works so well in the central visual pathway in adulthood supports a new concept, which is that there is latent potential for vision that is just waiting to be triggered."

The finding opens exciting research possibilities. "Whenever you have a discovery that breaks with your expectations about the possibility for the brain to adapt and rewire, it teaches you a broader concept," Gandhi said. "This new paradigm could aid in the development of retinoid therapies to more completely rescue the central visual pathway of adults with this condition."

RBI To Send Centre Report On Its Failure To Check Inflation Since January

NEW DELHI: With inflation staying above the upper tolerance limit for nine straight months, the Reserve Bank will now have to submit a report to the central government detailing reasons for the failure to contain prices and remedial

steps to rein in the price rise. The Reserve Bank of India Act mandates that in the case of the inflation target not being met for three consecutive quarters, the central bank has to submit a report to the government

explaining the reasons and detail the remedial actions it will be taking to check the price rise. This will be the

first time since the onset of the Monetary Policy Framework which came into effect in 2016 that the RBI will be made to explain its actions in a report to the government.

As per the mandate given to the Reserve Bank by the Union Government, the central bank is required to ensure retail inflation remains at 4 per cent with a margin of 2 per cent on either side.

Now, the Secretary to the MPC, which factors in retail inflation while arriving at bimonthly monetary policy, will now schedule a separate meeting of the rate-setting panel to discuss and draft the report to be sent to the Central Government under the provisions of the Reserve Bank of India Act.

The one-day meeting of MPC from January.

Last month, RBI Governor Shaktikanta Das had said the central bank considers the communication to the government for missing the inflation targets as privileged communication and will not be making it public.

India's Debt Ratio Projected To Be 84% Of Its GDP: IMF

WASHINGTON: India's debt ratio is projected to be 84 per cent of its GDP by the end of 2022, which is higher than many emerging economies, but its debt is a little bit easier to sustain, a senior IMF official has

Stressing that it is important for India to now have a very medium-term objective on the fiscal, Paolo Mauro, Deputy Director, Fiscal Affairs Department,

International Monetary Fund, said there's still not a whole lot of clarity on the fiscal

"It would be very important to give reassurance to people and to investors that things are under control, cent of the GDP right now. and things are going to become less vulnerable over time."

Mauro, told PTI in an interview. "In terms of the debt ratio, India right now at the end of 2022, we're projecting it at about 84 per cent of GDP. That is higher than in many emerging economies, he said.

Of course, India has a lot of special features being the most populous country in the world by now and being a very large, emerging economy, he said.

The other things that are special in a way or distinctive compared with other emerging economies are that most of India's debt is in non-indexed domestic currency and there's a large investor base from India. So those are good features to have and that's what makes this debt a little bit easier to sustain. Mauro said.

Retail Inflation Moves To 5-Month High Of 7.41% In Sep On Costlier Food Items

NEW DELHI: Retail inflation rose to a five-month high of 7.41 per cent in September mainly due to costlier food items, reason enough for the Reserve Bank to continue with its rate hike cycles it has resorted to since May 2022.

Inflation in the food basket rose to 8.60 per cent in September from 7.62 per cent in August. It is for the ninth month in a row that retail inflation has remained above the Reserve Bank of India's upper tolerance level

of 6 per cent. Official data released by National Statistical Office (NSO) on Wednesday showed that the retail inflation based on Consumer Price Index (CPI) was at 7.41 per and 16.88 per cent respectively cent in September as against 7 per cent in August.

In the year-ago month, it was at a comfortable level of 4.35 per cent.

The central government has mandated RBI to ensure that retail inflation remains in the range of 2-6 per cent.

The Reserve Bank of India Act mandates the central bank to show up with a report to the government as to why it failed to show deflation at (-)1.79 per to contain inflation within the cent in September, albeit at a targeted band.

One of the RBI's main functions is to contain inflation at 4 per cent with a bias of 2 per cent on either side.

In September, RBI Governor Shaktikanta Das said acute imported inflation pressures felt at the beginning of this fiscal year have eased but it still remains elevated across food and energy items.

However, next month's data and US Fed's policy will decide whether we see 35 or 50 basis points hike by the RBI in December 2022. In any case, we continue to expect that the terminal rate will be 6.5 per cent and there will be a pause in global monetary policy in CY23," Gupta said.

In another set of data released by the government, India's industrial production slipped to an 18-month low, contracting by 0.8 per cent in August mainly due to a decline in output of the manufacturing and mining sectors.

Supreme Court Says Aware Of 'Lakshman Rekha' But **Will Probe Notes Ban**

NEW DELHI: The Supreme Court said on Wednesday it is aware of the "Lakshman Rekha" on judicial review of government policy decisions but will have to examine the 2016 demonetisation decision to decide whether the issue has become a mere "academic" exercise.

A five-judge bench headed by Justice S A Nazeer said when an appearing for the Centre, said the issue arises before a constitution bench, it is its duty to answer.

Govt To Give Rs 22,000 Cr

NEW DELHI: The government will extend a one-time grant of Rs 22,000 crore to three state-owned fuel retailers to cover for the losses they incurred on selling domestic cooking gas LPG below cost in the last two years, I&B Minister Anurag Thakur said on Wednesday.

The Union Cabinet headed by Prime Minister Narendra Modi at a meeting on Wednesday, approved the one-time grant to three oil marketing companies - Indian Oil Corporation (IOC), Bharat Petroleum Corporation Ltd (BPCL) and Hindustan Petroleum Corporation Ltd (HPCL), Thakur told a news briefing.

The grant will be for covering the losses they incurred on selling LPG below cost to consum-

ers from June 2020 to June 2022. The three firms sell domestic LPG at government-regulated prices to consumers.

Between June 2020 to June 2022, the international prices of LPG soared by around However, to insulate consumers from fluc-

tuations in international LPG prices, the cost

IMF Praises RBI For Tightening The Monetary Policy

WASHINGTON: The International Monetary Fund (IMF) on Tuesday praised the Reserve bank of India (RBI) for tightening the monetary policy to curb inflation in the country.

The RBI has appropriately been tightening to fight inflation as the inflation is above target, and since May, if my memory serves me well, it sort of delivers 190 basis points rate hikes and we think further tightening is needed to bring inflation to its target, Garcia Pascual, Deputy Division Chief of the Monetary and Capital Markets Department of the IMF, told reporters at a news confer-

Tobias Adrian, Financial Counsellor and Director of the Monetary and Capital Markets Department of the IMF, said that monetary policy has tightened in India, similar to other emerging markets as well, where

inflation has been above target. And certainly, inflation has been above the RBI's target recently, so we do expect a tightening of monetary policy going forward as well, he said in response to a question.

In terms of financial stability, there are some pre-existing vulnerabilities, both in the banks and in the non-banking system, in India that is certainly still there and that is a cause of concern, he said.

Budget To Address Growth, Inflation Concerns: FM

WASHINGTON: Faced with twin challenges of slowing growth rate and high inflation, Finance Minister Nirmala Sitharaman on Tuesday said her Budget for the next financial year will be 'very carefully structured' to help the economy sustain growth momentum and rein in prices.

She identified high energy prices among the biggest problems facing the Indian economy in the near future.

"Specifics (of the next budget) may be difficult at this stage because it's a bit too early. But broadly, the growth priorities will be kept absolutely on the top. Even as I speak about the concerns that inflation brings before me. So, inflation concerns will have to be addressed. But then how would you manage growth would be the natural question," Sitharaman said.

Visiting Washington DC to attend the annual meetings of the International Monetary Fund and World Bank, the finance minister was responding to a question on the next year's budget at a fire-side chat with eminent economist Eshwar Prasad at the prestigious Brookings Institute.

She is scheduled to present the annual budget for the fiscal starting April 2023 on February 1.

NGT Imposes Rs 900-Cr Fine On Delhi Govt For Improper Solid Waste Management

New Delhi: Observing that "citizens cannot be faced with an emergency situation due to lack of governance", the National Green Tribunal (NGT) has directed the Delhi government to pay Rs 900 crore as environmental compensation for improper management of solid municipal waste.

A bench headed by chairperson Justice Adarsh Kumar Goel noted that around 80 per cent of legacy waste at the three landfill sites -- Ghazipur, Bhalswa and Okhla -- was not remediated and the quantity of legacy waste at the three dumpsites was 300 lakh metric tonnes.

The bench, also comprising Justice Sudhir Agarwal and expert members A Senthil Vel and Afroz Ahmad, said that the scenario presented a grim picture of environmental emergency in the national capital.

Citizens cannot be faced with an emergency situation due to lack of governance, the bench

There was continuous emission of methane and other harmful gasses along with



groundwater contamination, the bench said, adding even minimum safeguards against repeated fires were not adopted.

Needless to repeat the hazardous consequences of accumulated and unscientifically stored huge quantum of garbage which are mountains, the bench said.

The green tribunal further said that scarce and costly public land was occupied by the waste dumpsites.

The area is 152 acres and its price even at a conservative rate is more than Rs 10,000 crore at the applicable circle rate and thus the urgency to retrieve the said public asset for beneficial

public use, it said.

The NGT said that there was a serious violation of the rights of citizens and a failure of the public trust doctrine to protect the environment and public health by the authorities concerned.

Steps taken so far do not meet the mandate of law and are not commensurate to the grim factual emergency situation, constantly threatening the safety and health of citizens and the environment with no accountability of officers entrusted with the task, it said.

Fixing accountability of the state authorities for past violations, the bench said, We hold the National Capital Territory of Delhi liable to pay environmental compensation of Rs 900 crore having regard to the quantity of undisposed waste which is to the extent of three crore metric tonnes at the three landfill sites.

The amount could be placed in a ring-fenced account to be operated under the directions of the chief secretary, Delhi, for restoration of the environment by remediation of waste and other measures, the bench said.

It also directed the authorities to ensure that current waste is not added to the legacy waste sites and the waste was disposed of as per norms.

To control foul smell and improve aesthetics, turfing of landfill sites could be done through boundary walls or fencing by plantations of at least three rows of fast-growing and tall native trees in the periphery of landfill sites, the tribunal said.

DU Issues Academic Calendar For Semester 1 Students, Classes From Nov 2

New Delhi: The Delhi University (DU) issued an academic calendar for the first semester students on Wednesday announcing that the classes will begin on November 2 with a four-day break between the first and second semesters.

The first semester will start in November 2022 and end in March 2023 and the second semester will be from March

Notably, the first semester will begin even before the third round of the admission process for undergraduate courses commences.

This year, the university is admitting students through Common University Entrance Test (CUET) scores instead of their Class 12 marks. On September 12, the university released its admission-cum-allocation policy -- Common Seat Allocation System (CSAS).

The first seat allocation list will be declared on October 18, the second will be announced on October 30 and the third list on November 10.

Teachers have held the imposition"

the CUET responsible for the

DU Registrar Vikas Gupta rejected the teachers' claims and attributed the delay in start of semester to the pandemic.

According to the academic calendar, the theory examination for first semester will be conducted from February 27 to March 15 while the theory examination for second semester will be held from July 17 to July

The university has declared that preparation leave and practical examination for the first semester will begin from February 17 to 26 and that for the second semester from July

The semester break, which usually lasts for 15 days, will be of four days only from March 16 to March 19 this academic year.

Democratic Teachers' Front Secretary and Miranda House Professor Abha Dev Habib deemed it an "extremely hopeless situation" for students and teachers.

"No vacations or mid-semester breaks for students to assimilate what is being taught! What a student should cover in 180 days spread over a year is being finished in nine months or so," she said.

"This tragedy is because of the mindless imposition of CUET. We could have tried to finish admissions in August or mid-September after the announcement of Class 12 results in July," she added.

Abha Dev also pointed out that 50 per cent or more admissions may happen after November 2.

"We are barely ending the second round of CSAS on November 3. Earlier, the academic session would start only after six or eight cut-off rounds," she noted.

Another DU teacher Rajesh Jha alleged that the messedup semester is a deliberate attempt to divert students from public-funded institutes to private ones.

"It could have been easily avoided. What was the need to impose CUET in such a haste? It is a deliberate attempt to divert students from public-funded institutes," he said.

"Many parents got their children admitted to private institutes as the admission process at the university got delayed,"

In order to ensure smooth implementation of the JKHRMS, it is imperative that the details of the employees captured in various formats must be correct and updated. The portal of JKHRMS shall be made live on October 17 and can be accessed at https:// hrms.ik.gov.in.

"The employees can register themselves by using CPIS Numbers and check the basic as well as other service related details," it said, adding, "In case the employee related information is not updated or incorrect, the employee must fill up the requisite Correction Form' available on the dashboard and send it to DDO for approval." The informative videos regarding registration, filling up of correction forms etc. shall also be made available on the portal for facilitation of the employees, the circular reads, "Accordingly, it is impressed upon employees of all the Departments across Union Territory of J&K to visit Jammu & Kashmir Human Resource Management System (JKHRMS) on https://hrms.jk.gov.in from 17.10.2022 onwards and register on the system by using CPIS Numbers and check/modify their basic as well as other service related details," it said, adding, "All DDOs shall ensure that the information of all employees under their control is updated and verified as per service record of the employee."

DDOs shall be personally responsible for any mismatch in the verification of all formats, it said.

"Further, salary for the month of October, 2022 shall be disbursed only in favour of such employees who have registered/updated their service details on the JKHRMS portal and DDOs have verified the same."

Delhi Sees Season's First Fog; Minimum Temperature **Settles At 20 Degrees**

New Delhi: A thick layer of fog shrouded Delhi on Wednesday morning, lowering visibility to 350 metres in some parts of the capital.

Senior scientist at the India Meteorological Department (IMD) R K Jenamani said this was the capital's first fog of the season. Delhi recorded a minimum temperature of 20.2 degrees Celsius, a notch below the normal. The maximum temperature is likely to settle at around 31 degrees Celsius.

Partly cloudy weather is predicted during the day. An IMD official had earlier said it was heavy mist due to prolonged

According to the official, visibility at the Safdarjung Observatory, Delhi's primary weather station, had dropped to 600 metres and to 350 metres at the Palam weather station at 8.30 am.

This improved to 2,100 metres at Palam by 9 am and at Safdarjung by 10 am.

At 9 am, the capital's air quality index stood at 66, which falls in the "satisfactory" category.

The government of New Zealand has proposed a plan to tax greenhouse gasses created by farm animals, hoping to slash carbon emissions as part of a decades-long climate change initiative, despite vocal criticism from agricultural organizations.

Prime Minister Jacinda Ardern announced the proposal on Tuesday morning, saying the plan is the first of its kind ever attempted and would put New Zealand on track to hit its targets for reducing methane emissions over the next decade.

"No other country in the world

Madrid: An one-year-old Spanish girl has become the world's first recipient of a successful intestine transplant from a donor who died of heart failure, Madrid's La Paz hospital said on Tuesday.

"The child has now been discharged and is in perfect condition at home with her parents," it said in a statement.

Spain is a global leader in organ transplants, with over 102 of them per million inhabitants performed in 2021, a rate only surpassed by the United States, according to Spanish health ministry data.

The infant, Emma, had been diagnosed with intestinal fail-

ure when she was just one month old because her intestine was too short, and her health rapidly deteriorated until receiving the multivisceral transplant.

Aside from the intestine, Emma also received a new liver, stomach, spleen and pancreas.

"The good news is that life goes on, that Emma is very brave and proving every day that she wants to keep on living," her mother told reporters before thanking the donor's family and the doctors. She said Emma is now 17 months old.

Asystole donations proceed from a dead person after doctors confirm the absence of a heartbeat and breathing func-

The donor's organs are then artificially preserved - despite the lack of oxygenated blood - through a system known as Extracorporeal Membrane Oxygenation (ECMO).

What makes Emma's case special is the difficulty in preserving an intestine from asystole donation due to the digestive organ's characteristics.

Most transplanted organs stem from donors who have suffered brain death but retain a heartbeat, as this keeps the organs intact.

However, since the development of modern asystole donations, the technique's popularity has grown to make up about one-third of all donations in Spain, La Paz said.

'Russian Cosmonaut' Swindles \$30,000 From **Japanese Woman**

Tapanese police are investigating an alleged "romance scam" after a local woman was duped thto paying some 4.4 million yen (\$30,000) to a person claiming to be a 'Russian cosmonaut' working at the International Space Station (ISS) - and needing money to return back to Earth.

The bizarre scheme began in July and was reported this week by local media. The victim, a 65-yearold woman from the central Shiga Prefecture, got acquainted with the alleged swindler on social media, police told the journalists. The scammer, whose profile was full of various space pictures, claimed to be a "Russian cosmonaut" currently stationed at the ISS.

The woman took the bait and communicated with the scammer for weeks through the messaging app Line before their relationship turned into a fairly standard, yet space-flavored, marriage scam. The con artist repeatedly told the woman he loved her and insisted he wanted to start a new "life in Japan" and would marry her.

"Will you marry me when I arrive in Japan? I love you," the phony spacefarer reportedly told his victim on multiple occasions.

Before doing so, however, he had to return to Earth first, the faux cosmonaut told his victim, claiming he had to pay rocket expenses for his return and massive "landing fees." The woman believed the story and transferred some 4.4 million yen (\$30,000) to the scammer.

While the sum requested was already astronomical, her would-be-groom continued to demand more money for his purported space-faring endeavors. The woman ultimately grew suspicious and reported the whole affair to the police.

The woman might not be the only victim of the scheme, local media suggested. TV Asahi spoke to a Japanese woman in her 40s who claimed she had also been contacted on Instagram by a man pretending to be a Russian cosmonaut. The would-be scammer tried to guide the potential victim to the same messaging app Line, vet the woman refused and severed contact with the individual.
