Govt Withdraws Order On Registration Of New Voters

Jammu: Following an outcry by non-BJP parties, the Jammu administration has within hours withdrawn a notification authorising tehsildars (revenue officials) to issue a certificate of residence to those residing in the winter capital for more than a year to enable their registration as voters.

The order was withdrawn by Avny Lavasa, deputy commissioner of Jammu, and communicated through media, putting to rest the controversy that flared up after rival parties accused the BJP of subverting fresh voter rolls in its favour.

'The order stands withdrawn," a senior official told PTI on Thursday.

On Tuesday, Avny Lavasa, who is also District Election Officer, issued the order on electoral rolls after taking serious note of some eligible voters facing hardships in registration as voters for non-availability of required documents.

The Special Summary Revision of electoral rolls has been started in the Union Territory with effect from September 15 for registration of new voters, deletion, correction, transposition of voters who have | More on P10



Zanzarka (Guj): Union Home Minister Amit Shah on Thursday blamed India's first prime minister Jawaharlal Nehru for the issues plaguing Kashmir and credited the Narendra Modi government for solving them by removing Article 370.

Srinagar: The Jammu and Kashmir government on Thursday ordered premature retirement of 36 police personnel on charges of their involvement in corruption and criminal activities.

These personnel conducted their duties in ways which were unbecoming of public servants & in violation of the established code of conduct, official sources said Thursday.

The exercise, they said, was conducted as part of a regular process of scrutiny of records of officials, who cross benchmarks of age service period in terms of Article 226(2) of J&K CSRs.

"These employees were found involved in illegal activities, remained unauthorizedly absent from duties for a considerable period, underperformed, penalized in departmental enquiries and some of them found involved in corruption cases, facing serious criminal charges, and had doubtful

Pfizer, BioNTech's Updated **Booster Protects Against Omicron In Human Trial**

Pfizer and its German partner BioNTech said their COVID-19 vaccine booster, adapted for the BA.4 and the BA.5 subvariants, generated a strong immune response and was well tolerated in testing on humans.

With the results, which the companies described as consistent with preclinical data, the partners are following up with human trial data that had previously been missing from their successful filings for regulatory approval.

In a joint statement on Thursday, the companies said data from a trial in adult patients showed the booster dose led to a substantial increase in neutralising antibody levels against the BA.4/BA.5 variants after one week.

Omicron-tailored shots made by Pfizer and Moderna Inc have already been given the green light by several countries, including in the United States for adults and, more recently, for children as young as 5 years.

Healthcare regulators for the European Union and the United States had already approved the upgraded shot last month, even though trial data from testing on humans had at the time not been available.

But they felt sufficiently encouraged from human study results on a similar variant than the established shot based

While the European Medicines Agency has also cleared shots that address the BA.1 subvariant, the U.S. Food and Drug Administration has focused its response for immunity against the fast spreading Omicron variant only on BA.4/5-adapted shots.

Both are known as bivalent in that they target both the original virus as well as Omicron subvariants.

The preliminary data on Thursday also showed that, in the age group of adults older than 55, the new bivalent shot triggered a better neutralizing antibody response against the Omicron BA.4/5 subshot targeting the BA.1 subvariant and on the initial form of the virus.

Apple To Roll Out 5G In India In December Amid Early Adoption Push

Apple Inc will start upgrading its iPhone models in India in December to make them compatible with 5G networks, the company said on Wednesday, as Indian authorities pressed mobile phone manufacturers to adoption the high-speed network.

The company said it would push software upgrades to recent models, including the iPhone 14, 13, 12 and iPhone SE, which, industry sources say, do not support the network currently.

"Pandits and Muslims are integral part of Jammu and Kashmir and they have to live together and fight the designs & Pakistan jointly", he emphasised.



Russia Warns Of World War III If Ukraine Joins NATO: Report

Moscow: The admission of Ukraine to NATO could result in a third world war, the deputy secretary of the Security Council of the Russian Federation, Alexander Venediktov, told the state TASS news agency in an interview on Thursday.

"Kyiv is well aware that such a step would mean a guaranteed escalation to a World War Three," TASS cited Venediktov

"Apparently, that's what they are counting on - to create informational noise and draw attention to themselves once again."

Venediktov also repeated a Russian position that the West, by helping Ukraine, indicated that "they are a direct party to the conflict".

Ukrainian President Volodymyr Zelenskiy announced a surprise bid for fast-track membership of the NATO military alliance at the end of September, after President Vladimir Putin held a ceremony in Moscow to proclaim the four partially occupied regions as annexed Russian land

In Pakistan, A Woman Is Raped Every 2 Hours, **Convictions Only 0.2%: Report**

Islamabad: A woman is raped in Pakistan every two hours, according to a recent survey, highlighting the unsafe conditions for women in the country where cases of honour killing is

The survey, which was conducted by Pakistani channel SAMAA TV's Investigation Unit (SIU) based on the data collected from the Punjab province's home department and Ministry of Human Rights, also found that spiked, the conviction rate remained an abysmal 0.2 per cent.

"Newly collected and compiled data showed that as many as 21,900 women were reported to have been raped in the country from 2017 to 2021. This meant that around 12 women were raped across the country daily, or one woman every two hours," said the survey.

According to the surveyors, these reported cases could be just the tip of the iceberg since societal stigma and fear of retributive violence prevent women from reporting the incidents to the authorities.

The data showed that in 2017, some 3,327 cases of rape were reported. This jumped to 4,456 cases in 2018, 4,573 cases in 2019, dipped to 4,478 cases in 2020 before rising to 5,169 cases in 2021, the report said.

In 2022, the media reported 305 rape cases across the country. As many as 57 cases were reported in May, June (91), July

(86) and August (71).
Previously media reports have said that in Punjab, around 350 rape cases were reported from May 2022 to August 2022 but no data was available for the first four months of the year.

In 2022, as many as 1,301 cases of sexual violence against women were heard in 44 courts in Pakistan. The police filed charge sheets in 2,856 cases. But only 4 per cent of the cases went to trial, the report said.

The conviction rate in rape cases during this period recent, the report highlighted.

In 2020, the United Nations Development Programme ranked Pakistan top among the 75 countries with an anti-women bias in courts.

In July this year, a report released by the World Economic Forum placed Pakistan as the second-worst country in terms of gender parity and put it at the 145th spot in a survey of 146 countries. The only worse performer than Pakistan was Af-

Pakistan (145th) has a population of 107 million women, and in 2022 has closed 56.4 per cent of the gender gap that affects them.

This is the highest overall level of parity Pakistan has posted since the WEF report was launched.

Pakistan has also been urged by international bodies, including the United Nations, to take action against the rising cases of honour killings in the country.

Hijab Ban To Continue In Karnataka Schools **And Colleges: Minister**

Karnatka: Karnataka Primary and Secondary Education Minister B C Nagesh on Thursday said the Karnataka High Court order upholding the state government's ban on hijab on school and college campuses will remain valid following a split verdict by the Supreme Court on the issue.

The Supreme Court on Thursday delivered a split verdict on a batch of pleas challenging the Karnataka High Court judgement refusing to lift the ban on hijab in educational institutions in the state.

wWhile Justice Hemant Gupta dismissed the appeals against the high court verdict, Justice Sudhanshu Dhulia allowed them.

At a time when there is a movement happening against hijab and burqa across the globe and the freedom of women is a talking point, the Karnataka government had expected a better judgment that will bring an order in the education system but a split verdict has come, Nagesh

The matter has now been referred to a higher bench, Nagesh said adding the Karnataka government will wait for the verdict by a higher bench.

"The Karnataka High Court order will remain valid. Hence, in all our schools and colleges Karnataka education act and rule, there will be no scope for any religious symbols. So our schools and colleges will run as per the Karnataka High Court order. Children will have to come to the schools accordingly," Nagesh said.

"The ban on hijab will continue. As you know that the Karnataka Education Act and Rule does not permit any religious items inside the class. So we are very clear that no student can wear hijab inside the class," Nagesh explained.

Karnataka Home Minister Araga Inanendra said he saw the hijab verdict in the media where one judge has dismissed the petition while the other has dismissed the Karnataka High Court order.

"There is a split verdict and the case has gone to the Chief Justice's bench. It depends on the decision taken by the CJI. The Karnataka government is awaiting an order by the CJI," Jnanendra told reporters.

On January 1 this year, six girl students of a college in Udupi attended a press conference held by the Campus Front of India (CFI) in the coastal town protesting against the college authorities denying them entry into classrooms wearing hijab.

This was four days after they requested the principal's permission to wear hijab in classes which was not allowed. Till then, students used to wear the headscarf to the campus, but entered the classroom after removing it, the college principal Rudre Gowda had said.

"The institution did not have anv rule on hijab-wearing as such and since no one used to wear it to the classroom in the last 35 years. The students who came with the demand had the backing of outside forces," Gowda had said.

China Only US Competitor That Can Reshape World, **Says Team Biden**

The Biden administration labeled China as the nation's top competitor, while Russia remains a danger to be constrained in a new defense strategy that also calls inflation a threat to global security.

Jake Sullivan, President Joe Biden's national security adviser, said Wednesday that the US is in "the early years of a decisive decade" in which "the terms of our competition with the People's Republic of China will be set."

The PRC's assertiveness at home and abroad is advancing an illiberal vision across economic, political, security and technological realms -- in competition with the West," he said at a Georgetown University event following the release of the administration's long-delayed National Security Strategy.

Russian President Vladimir Putin's invasion of Ukraine prompted a major rewrite of the congressionally mandated document, which provides a window into the White House's thinking on foreign policy and national security issues.

This war has loomed large in the formulation of the strategy, as it should, but we do not believe it has blotted out the sun," said Sullivan.

The new 48-page public document describes China and Russia as "increasingly aligned" with each other, but says the two countries pose distinct challenges.

It calls China the US's only competitor "with both the in-

tent to reshape the international order and, increasingly, the economic, diplomatic, military, and technological power to do it." The challenge of handling Russia is described as one of "constraining a still profoundly dangerous" force.

Biden officials released their strategy more than 600 days into his administration, compared with the just over 300 days it took former President Donald Trump's team. The Trump document portrayed China and Russia as coequal threats.

By the 2030s, the US for the first time will need to deter two major nuclear powers, according to the strategy, in reference to those countries. "To ensure our nuclear deterrent remains responsive to the threats we face, we are modernizing" the US nuclear force "as well as strengthening our extended deterrence commitments to our allies," it says.

When it comes to China, the Biden administration is seeking to reinforce that they're "looking for competition but not conflict -- and we're not looking for a new Cold War."

Inflation Threat

The document also mentions inflation, Democrats' biggest political liability, as among the threats to global security, less than a month before midterm elections which will determine if Biden's party retains control of the House and Senate. It lists inflation as one of the cross-border issues "people all over the world are struggling to cope with."

There Should Be No Hijab, Other Dresses In Schools But Only Uniforms: BJP

New Delhi: The BJP on Thursday asserted that it will always be opposed to students wearing hijab or any dress other than uniforms in schools, and said religious freedom cannot be used to promote "separatism".

Soon after the Supreme Court gave a split verdict on the ban on hijabs in Karnataka educational institutions, BJP national general secretary C T Ravi, a senior party leader from the state, said it will not be appropriate for him to comment on the judgment.

But he will always speak against the "separatist mindset" that, he claimed, promotes the use of Muslim headscarf in schools.

"Uniform in schools is meant to promote uniformity among students. I believe that separatism is promoted in the garb of issues like promotion of burqa or hijab. This mindset was the reason behind India's partition. This separatism progressively morphs into extremism which can be a source of terrorism," he claimed.

Rules mandating wearing uniforms in Karnataka schools have been in force since 1965, he said. Citing popular protests in Iran, an Islamic country, against



the mandatory use of hijabs, he claimed that religious freedom in India cannot mean the promotion of "separatist" designs.

He added that the issue is not about wearing or not wearing hiiab but what to wear in schools. And there should be no hijab or other dresses in schools but only uniforms, he said.

Following the split verdict, the twoiudge Supreme Court bench referred the matter to the chief justice of India for constituting a larger bench.

While Justice Hemant Gupta dismissed the appeals against the March 15 verdict of the Karnataka High Court that had refused to lift the ban and held that hijab is not part of "essential religious practice" in the Islamic faith, Justice Sudhanshu Dhulia allowed the pleas and observed that it is ultimately a "matter of choice". During the arguments in the top court, a number of the counsel appearing for the petitioners had insisted that preventing Muslim girls from wearing the hijab to

Insisting that the agitation in support of wearing hijab in educational institutions was not a "spontaneous act" by a few individuals, the state's counsel had argued in the top court that the government would have been "guilty of dereliction of constitutional duty" if it had not acted the way it did.

Supreme Court Refuses Urgent Hearing On Plea Against Firecracker Ban In Delhi

New Delhi: The Supreme Court today refused to accord urgent hearing to a plea against an order banning storage, sale, and use of all types of firecrackers in the national capital till January 1, 2023. A bench of Chief Justice UU Lalit and Justice Bela M Trivedi asked the lawyer, who mentioned the matter seeking urgent hearing, to approach the Delhi High Court.

"Let the high court decide, we will not get into this," the bench said.

The lawyer, who sought the urgent hearing, submitted before the bench that the high court has taken a view that the matter is pending before the Supreme Court and listed it on October 18.

The Delhi High Court had earlier deferred hearing on the plea of green cracker merchants against an order banning storage, sale, and use of all types of firecrackers till January 1.

The petitioners contended that the absolute ban by the Delhi Pollution Control Committee is in contravention of the orders of the Supreme Court and the National Green Tribunal, which never provided for such a blanket prohibition.

The top court on Monday had refused to stay the Delhi government's order banning storage, sale, and use of all types of firecrackers till January 1 to check pollution levels in the national capital, saying it did not want to add to the air pollution.

ED Files Chargesheet Against Journalist Rana Ayyub In Alleged Money Laundering Case

The Enforcement Directorate (ED) has filed a chargesheet against journalist Rana Ayyub under the anti-money laundering law, accusing her of "cheating" the public and utilising charity funds worth Rs 2.69 crore for creating her personal assets, and also violating the foreign contribution law.

The federal agency filed its prosecution complaint against Ayyub before a special Prevention of Money Laundering Act (PMLA) court in Ghaziabad, Uttar Pradesh, on October 12.

the 'Ketto platform' starting from April 2020 and collected funds totalling Rs 2,69,44,680," the ED said in a statement issued on Thursday. Ketto is an online crowdfund-

ing platform. The campaigns, it said, were meant to raise funds for slum



to help those impacted by CO-VID-19 in India.

The probe found that the funds raised on the online platforms were received in the accounts

of Ayyub's father and sister and subsequently transferred to her personal accounts, the ED alleged.

"Ayyub utilised these funds to create a fixed deposit of Rs 50 lakh for herself and also transferred Rs 50 lakh to a new bank account. Investigations found that only about Rs 29 lakh was used for relief work," it claimed.

"In order to claim more expenses towards relief work, fake bills were submitted by Ayyub and subsequently, bank balances in the accounts of Ayyub amounting to Rs 1,77,27,704 (including FD of Rs 50 Lakh) were attached under the PMLA vide a provisional attachment order dated 04.02.2022," it said.

Fee Fixation Panel Cracks Whip On Private Schools

Asks Schools To Return Money Collected From Parents In Name Of Security Deposit, Refundable Fund

SRINAGAR: The Committee for Fixation and Regulation of Fee of private schools (FFRC) in Jammu and Kashmir on Thursday banned educational institutes from charging huge money in the name of security deposit, refundable fund or admission fee.

FFRC chairperson Justice (retd) Muzaffar Hussain Attar said most of the parents, who constitute a voice-less class, cave-in to the illegal, unethical and immoral demands of the "few big" school managements.

The FFRC order came after complaints of several school managements allegedly asking the students or parents to pay huge amounts in the name of security deposit, refundable fund and in some cases as admission fee as well.

In the times of unequal bargaining position, few school managements are taking undue advantage of their higher bargaining position by allegedly asking the students for payment of huge amounts in the name of security deposit, refundable fund and in some cases as admission fee as well, the FFRC chairperson said in an order.

Adopting this most unfair practice has the potential of causing immense damage to social fabric. On the one hand, the children of lesser mortals lose those few big schools who are Justice (retd) Attar said.

JERC Revises Power Tariff In J&K, Effective From Oct 1

JAMMU: The Joint Electricity Regulatory Commission (JERC) for Jammu Kashmir and Ladakh has revised the power tariff from the third quarter of current financial year and it will be effective from 1st October 2022. In this regard, an order is-

sued by the Commission states that the new tariff has been designed in such a way so as to ensure minimum inconvenience to the citizens, while at the same time protecting the interests of the domestic, commercial, agricultural and industrial sectors.

The order adds that the average overall nominal increase the previous tariff last revised in 2016-17 is just 8%, whereas the inflation rate in the corresponding period is 24% (the CPI Combined: All India General Index (All Groups) has risen from 131.1 in April 2017 to 162.5 in July 2022), thus it being safe to say that there is an effective decrease in tariff by 16% (adjusted for inflation).

The order further reads that it has been ensured that the tariff in Jammu and Kashmir is significantly lower than any other neighbouring state, and is in fact almost half when compared to states like Haryana, Delhi and Rajasthan.

According to order, "the rates for Below Poverty Line consumers have been kept unchanged at Rs 1.25 for upto 30 units per month while as for domestic

category consumers, for upto 200 units per month, the rate will be Rs 2 per unit, almost unchanged from before, for 200 to 400 units per month, the rate will be Rs 3.50 per unit, an increase of 6% in 5 years and for more than 400 units per month, the rate will be Rs 3.80 per unit, an increase of 8% in 5 years".

"The corresponding rates for Himachal Pradesh, Uttarakhand, Punjab, Haryana and Delhi are Rs 5.95, 6.25, 7.30, 7 and 8 per unit respectively", it adds.

The order also reads that the fixed charges shall be marginally increased from Rs 5.50 per kW per month to Rs. 8, the charges for flat metering shall be Rs 175 for the first quarter kW, then quarter kW till a load of 2 kW, beyond which the charges will be Rs 500 for every quarter kW.

Abating pandemic

his year the world has witnessed a slow recovery from the Covid-19 pandemic, paving way for the reopening of the economies and return of growth. The world economy is now more challenged by the ongoing war in Ukraine than the Covid contagion. However, in some countries such as China, the recurrent Covid outbreaks have forced temporary but strict closure of business activities. On a positive note, the number of cases around the world has marked a steep decline. In India, the cases now average between 2000 to 3000.

However, this is no reason to take things easy. These numbers are not alarming but the virus continues to be a matter of concern. Across the world, Covid-19 cases average around 5 lakh daily. On average, over 1,500 Covid positive people die daily. Those who recover run the risk of long Covid symptoms,

What is more, the pandemic is returning with new virus strains - albeit not as deadly as their earlier versions which killed millions around the world, with India being one of the hardest-hit countries. India was swamped by an avalanche of cases, more so during the second wave that broke out in January and February 2021. The third wave began in January-February 2022. But thankfully, the wave soon subsided. Ever since there have been sporadic outbreaks but none of them were as fatal or virulent as the first three waves. The number of mortalities has also progressively gone down. But that is no reason to let our guard down. We have to gear up to face and defeat the new variants.

With the abating of the Omicron wave which broke out early this year, there was a temporary sense of relief across the world. The economies started re-opening in most parts of the world. But fresh surges in some countries, especially in China, should be a warning that the virus is here to stay for some more time. In fact, it has already become endemic now.

So far, Covid-19 has turned out to be a very stubborn virus. Despite full vaccination by a large mass of people across the globe, the outbreaks have not stopped. Here's hoping that the new Covid variants become milder so that people can live with them. But meanwhile, the governments and the people can't afford to take the fresh strains lightly. There is a need to continue to follow Covid precautions in public. Our best defence against the pandemic remains vaccination, physical distancing and mask-wearing.

ast week, the World Health Organization sounded the alarm on four cough syrups manufactured in India, citing the presence of "unacceptable amounts of diethylene glycol and ethylene glycol as contaminants" that allegedly led to the death of 66 children in The Gambia. The Haryana-based company, which manufactured all four products responsible for the tragedy, has now been ordered to shut operations. But this intervention has come a little too late in the day. It must be noted that African countries are heavily dependent on imported pharmaceutical goods to bolster the continent's rickety healthcare network. As of 2019, around 70-90 per cent of the drugs consumed in sub-Saharan Africa and 99 per cent of vaccine doses were imported. Dishearteningly, India and China have been accused of exporting substandard drugs to African countries — Nigeria received fake antimalarial drugs that were produced in China. Around 42 per cent of all spurious drugs reported to the WHO are from this region.

Since the WHO linked The Gambia deaths to the Indian manufacturer, the Union health ministry has revealed that the four paediatric medicines were "not licensed for manufacture and sale in India". This, however, raises further questions about how the authorities had allowed the export of products that have been flagged over quality issues. In fact, lax supervision by medical regulatory bodies is not new. In 1986, 14 patients died at JJ Hospital in Mumbai because of contaminated medication. The Lentin Commission report, which followed the incident, pointed fingers at a corrupt nexus between manufacturers and regulatory bodies that is responsible for the availability of spurious drugs. The Indian Pharmacopoeia Commission specifically mentions tests for DEG and EG levels and, yet, this crucial step was most likely skipped by the errant firm in this instance. The Indian government should not only conduct a thorough probe and bring the culprits to book but must also show its commitment towards providing quality medication by reviewing the licences of manufacturers as well as solvent vendors. India has a long history of providing humanitarian aid. The Indian government was lauded for providing Covid-19 vaccines to developing nations at the height of the pandemic. The incident in The Gambia has tarnished India's image as a reliable donor. The diplomatic gains over the years would be lost if India does not undertake corrective action in the pharma sector.

OPEC+OIL CUT

Are Saudi Arabia And UAE Tosting
The Limits

n 5 October, Opec+ members announced a plan to cut oil production targets by 2 million barrels, starting in November, the first major cut since 2020.

With an effective cut of less than half of this, the oil markets have mostly shrugged it off, strengthening only modestly. The actual market impact of the cut will be less than the announced headline cut.

As many members of the group are already under-producing their targets, the net production cut is likely to be between 600,000 and 900,000 barrels a day, non-negligible given the recent trends, but not as extensive as the headline.

However, the impacts of the cut on energy politics and US-GCC and West-GCC relations are much greater. This decision adds to the distrust between these major economies over energy policy and reduces resilience to the looming issue of Russian fuel supplies and longer-term issues about energy transition and investment.

Beyond the cut itself is the political and geopolitical posturing surrounding the announcement, which highlights increased fragility and volatility of the market ahead of a planned EU embargo and G7 price cap on Russian oil.

SLUGGISH DEMAND

Despite their attempts to focus on the "technical" nature of the decision, both Opec+ ministers and the US did little to de-escalate - meaning that the partly economic and commercial reasons for the cut, including sluggish demand around the world, were lost amid a sea of recriminations and concerns about the future.

On the demand side, Opec+ cuts reflect concerns about sluggish global, and especially Chinese, demands, which remain constrained by selective Covid lockdowns, weak consumer demand and property market woes.

Signalling this cut through the end of 2023 implies a major reversal of the prior Opec view that strong demand would boost the call on Opec oil next year.

In large part, disappointments continue to come from China, where Zero-Covid policies continue to depress domestic demand and mobility, and property market woes restrict other parts of domestic demand.

Given some demand destruction earlier this summer, some degree of cuts reflect fundamentals even if prices are far from low. Oil producers put some of the blame on other parts of the energy complex including sharp rises of natural gas prices which are exacerbating weak global demand.

With central banks forced into more defensive hiking, including in developed economies, the risk is that the global slowdown will be more extensive, also hitting oil demand.

KEEPING RÜSSIA IN

The argument that a higher price would prompt more investment within Opec+ countries seems less realistic given that the issues on scaling up supply seem far from purely economic. They include domestic issues in a number of producing nations as well as a rising domestic demand in Africa.

Some Opec+ members, especially the UAE, have added to a capacity that remains well in excess of production, and some non-Opec countries like the US are also adding supply as the commercial arguments dictate, but those FOR INDIA AND TURKEY, trade with Russia has increased. Much of this trade is still legal but tough, and these countries will face more pressure to abide by widening

"Verily I, the servants, the helpers, and my followers defend them, because Christians are my citizens; and by Allah! I hold out against anything that displeases them.

"No compulsion is to be on them ... Neither are their judges to be removed from their jobs nor their monks from their monas-

'No one is to destroy a house of their religion, to damage it, or to carry anything from it to Muslims'

"Should anyone take any of these [belongings], he would spoil God's covenant and disobey His Prophet. Verily, they are

my allies and have my secure charter.... "No one is to force them to travel or to oblige them to fight. Muslims are to

fight for them. "If a female Christian is married to a Muslim, it is not to take place without her approval. She is not to be prevented

from visiting her church to pray. "Their churches are to be respected. They are neither to be prevented from repairing them nor [barred] the sacredness of their covenants."No one of the nation is to disobey the covenant till the Last Day (of Judgment),"

It is important to remember that this covenant was made binding on all Muslims for all times, past, present and future, till the Day of Judgment. How this covenant has come to be violated in some Muslim countries should shame anyone who claims to love or follow the Prophet of Islam.

Why We Need To Read "AFTER THE PROPHET"

orn in a world where the Muslim community has been divided into two indefinite sects makes for a reality that we have come to accept and also overlook. The conflict between Sunnis and Shias is the news of everyday, but there has never been a proper, unbiased understanding of the real

Where did all of this animosity really stem from? The Sunnis have their version and the Shias have theirs.

Lesley Hazleton is a British-American author whose work focuses on the intersection of politics, religion, and history, especially in the Middle East. She answers the question in an unbiased account of history, taking a neutral approach to what actually happened and why this turmoil between one of

the major religions came to be. Through her writing, you come to see her fondness for the people at heart of the story and just how politics and religion made the world we live in today. She acknowledges that her main source was Muhammad ibn Jarir al-Tabari, generally known as the most prestigious and authoritative early

Islamic historian. The book of roughly 200 pages is clearly divided into three parts and recounts history in the most exquisite way possible, so much so that events begin to make sense and putting the book down becomes impossible. You see, we've solely grown up with a general

idea of what the issues were that ultimately brought about the rift, but Hazleton brings more to the table. She brings an account of history that many of us haven't truly bothered to find out. We've only

"Hazleton ties today's events to their ancient roots, resurrecting seventh-century Arabia with respect and vivid immediacy. Here are rich recreations of the lives of the Prophet Muhammad and his beloved wife Aisha; here are often overlooked details (why is green the color of Islam? why do some Muslim women veil?) filling in the contours of the narrative.

This book is a mandatory read for anyone trying to understand the sectarian war within Islam that refuses to end and for those who love history.

NOVEL, POTENTIAL TARGET FOR BROAD-SPECTRUM ANTIVIRAL THERAPIES IDENTIFIED

Scientists have found a new way to stop a number of viruses in their infectious tracks, identified a promising strategy for developing broad-spectrum antiviral therapies.

Scientists from the Ohio State University, US, conducted experiments in cell cultures and mice and found that blocking a specific enzyme present in all cells from functioning triggered a powerful innate immune response, the body's first line of defence against any foreign invader.

This response, according to the study, when challenged by several types of viruses, dramatically lowered the replication of viral particles and protected mouse lungs from damage.

"Typically, in antiviral development, the saying is, one bug, one drug', said Jianrong Li, from the Ohio State University, and co-senior author of the study published in the journal Proceedings of the National Academy of Sciences.



"A drug that can stimulate the immune system to have broad antiviral activities would be very attractive -- one drug against multiple bugs would be an ideal situation," Li said.

The discovery was enabled in part by a technique the researchers used to map the precise location of an RNA modification they were studying, and to see which enzyme made the modification.

The mapping led them to determine that this enzyme's work happens not in viruses, but in mammal hosts that viruses want to infect.

"It turns out the key here is not a viral RNA modification, but a host RNA modification, and it triggers a host immune response," said another cosenior author Chuan He, University of Chicago.

The RNA modification itself, known as cytosine-5 methylation, or m5C, is actually what needs to be altered to

trigger the immune system response. It is one of roughly 170 known chemical modifications on RNA molecules in living organisms that affect bi-

ological processes in a variety of ways. In lieu of targeting the modification itself, researchers were able to inhibit the function of a key enzyme in that process,

called NSUN2, to stop the RNA change.
They found that blocking NSUN2's function in cells exposes RNA snippets that, despite belonging to the host, are seen as foreign invaders, which triggers the type 1 interferon produc-

in the innate antiviral response.

viruses trying to cause infection.

Amazingly, blockage of NSUN2 almost completely shuts down the replication of vesicular stomatitis virus, a model virus that normally kills the host cells within 24 hours and replicates to a very high titer, and strongly inhibits both RNA and DNA viruses, said study co-first author Yuexiu Zhang, a PhD student in Li's lab.

The researchers verified this sequence of events during experiments in multiple types of cells and human lung models before observing the effects of blocking NSUN2 in mice.

We compared NSUN2-deficient

We compared NSUN2-deficient mice with wild-type mice to see how the viruses act, Li said.

"Once we inhibited NSUN2, viral replication in the lung decreased and there was less pathology in the lung, and that correlated with enhanced type 1 interferon production.

This finding in mice and our other experiments proved that NSUN2 is a druggable target, Li added.

Facebook Owner Meta Unveils \$1,500 VR Headset: Will It Sell?

Racebook parent Meta unveiled a high-end virtual reality headset on Tuesday with the hope that people will soon be using it to work and play in the still-elusive place called the "metaverse."

The USD 1,500 Meta Quest Pro headset sports high-resolution sensors that let people see mixed virtual and augmented reality in full colour, as well as eye tracking and so-called "natural facial expressions" that mimic the wearer's facial movements so their avatars appear natural when interacting with other avatars in virtual-reality environments.

Formerly known as Facebook, Meta is in the midst of a corporate transformation that it says will take years to complete. It wants to evolve from a provider of social platforms to a dominant power in a nascent virtual-reality construct called the metaverse — sort of like the internet brought to life, or at least rendered in 3D. CEO Mark Zuckerberg has

described the metaverse as an immersive virtual environment, a place people can virtually "enter" rather than just staring at it on a screen. The company is investing billions in its metaverse plans that will likely take years to pay off.

pay off.

VR headsets are already popular with some gamers, but Meta knows that won't be enough to make the metaverse mainstream. As such, it's setting office — and home office — workers in its sights.

"Meta is positioning the new Meta Quest Pro headset as an alternative to using a laptop," said to Rolf Illenberger, founder and managing director of VRdirect, which builds VR environments for businesses. But he added that for businesses, operating in the virtual worlds of the metaverse is still "quite a stretch."

Meta also announced that its metaverse avatars will soon have legs — an important detail that's been missing since the avatars made their debut last year.

The reported cancer incidence in India this year is estimated to be 19 to 20 lakh, whereas real incidence is 1.5 to 3 times higher than the reported cases, according to a study by FICCI and EY titled "Call for Action: Making quality cancer care more accessible and affordable in India".

India is faced with a sizable cancer incidence burden, which continues to grow exponentially. The 2020 WHO ranking on can-

The 2020 WHO ranking on cancer burden in terms of new yearly cases being reported had ranked India at the third position after China and the US, respectively.

"For cancer prevention, early diagnosis and widespread public awareness will be integral and will serve as a beacon of light to strengthen India's strategy for cancer care and other non-communicable diseases," said Ashok Kakkar, Chair, FICCI Task Force on Cancer Care.

Cancer disease burden in India is characterized by poor detection with not more than 29 per cent, 15 per cent and 33 per cent of breast lung and cervical can-

cers being diagnosed in stages 1 and 2, respectively.

The cancer of the head and neck are found to be progressing at a CAGR of 23 per cent, prostate cancer at 19 per cent, ovarian cancer at 11 per cent and breast cancer at 8 per cent, which is faster than the overall growth rate of incidence.

Six states, which represent 18 per cent of India's population, have 23 per cent share of the country's reported incidence burden and have the highest crude incidence rates.

Kerala Mizoram Tamil Nadu

Kerala, Mizoram, Tamil Nadu, Karnataka, Punjab, and Assam report the highest overall crude incidence rates of cancers which is greater than 130 cases per lakh population, the report mentioned. Estimates indicate that the to-

tal deaths owing to cancer were 8 to 9 lakh in 2020, causing the mortality to incidence ratio for different cancer types in India to be among the poorest compared to global counterparts.

"To address the dual challenge of rising incidence and sub-optimal mortality to incidence ratio, it is imperative to drive mass awareness campaigns, focus on effective prevention and enable improved screening coverage as a primary response, a said Srimayee Chakraborty, Life Sciences Partner, EY India.

Lab-Grown Brain Cells Learn To Play Video Game Pong



Scientists Have Grown 800,000 Brain Cells In A Lab

Scientists have grown 800,000 brain cells in a lab that they say have learned to play the 1970s tennis-like video game, Pong.

The research, published recently in the journal Neuron, has for the first time shown that brain cells living in a dish can perform goal-directed tasks.

The team, including researchers from Monash University, RMIT University, University College London and the Canadian Institute for Advanced Research are now going to find out what happens when their DishBrain is af-

fected by medicines and alcohol. To conduct the experiment, the researchers took mouse cells from embryonic brains as well as some human brain cells derived from stem cells and grew them on top of microelectrode arrays that could both stimulate them and read their activity.

Electrodes on the left or right of one array were fired to tell Dishbrain which side the ball was on, while distance from the paddle was indicated by the frequency of signals.

Feedback from the electrodes taught DishBrain how to return the ball, by making the cells act as if they themselves were the paddle, the researchers said.

"We have shown we can interact with living biological neurons in such a way that compels them to modify their activity, leading to something that resembles intelligence," said study lead author Brett Kagan, Chief Scientific Officer of Melbourne-based biotech start-up Cortical Labs.

Adani Group Co Likely To Be Rated Higher Than Sovereign

NEW DELHI: An Adani Group firm is likely to be soon rated above India's sovereign rating as the ports-to-energy conglomerate helmed by Gautam Adani, Asia's richest man, sees rapid growth in business and lower debt.

Adani Group CFO Jugeshinder (Robbie) Singh told a select group of investors on October 10 in New Delhi that an announcement will soon be made of one of the group firms becoming the first Indian firm with all its business in the country, to be rated higher than the sovereign, according to two persons present at the meeting. Singh, however, did not name the company.

Global credit rating agencies such as S&P and Fitch have assigned the lowest investment grade rating of 'BBB-' to India.

Most companies including public sector giants are rated at par or below the sovereign rating. In June last year, Fitch Ratings upgraded rival billionaire Mukesh Ambani's Reliance Industries Ltd to a notch above India's sovereign rating citing an improving debt profile.

Presently, Adani Transmission Ltd - one of the six listed firms of the Adani Group is rated at par with the sovereign.

Rupee Closes At 82.38 Against US dollar

MUMBAI: The rupee traded in a narrow range and settled 5 paise lower at 82.38 against the US dollar on Thursday, tracking a muted trend in domestic equities amid weak domestic macroeconomic data.

Besides, risk aversion sentiment among investors weighed on the local unit.

At the interbank foreign exchange, the rupee witnessed range-bound trading. It opened at 82.30 against the US dollar, then fell further to close at 82.38, registering a fall of 5 paise over the last close. It was moving in a tight range of 82.25 to 82.42.

On Wednesday, the rupee fell by 12 paise to close at 82.33 against the greenback.

"Asian currencies fell amid caution as traders awaited Thursday's US inflation data for clues on how much the US Federal Reserve will raise rates," said Dilip Parmar, Research Analyst, HDFC Securities.

Parmar further added that along with weak regional currencies, dismal domestic economic data weighed on the Indian rupee. On the forward market, the one-year forward USD/INR premium declined as the central bank was at the receiving end.

"Spot USD/INR has been trading in the narrow range this week amid the central bank intervention on both sides. In the near-term, spot USD/INR is having resistance at 82.85 and support at 82.10," Parmar noted.

DM Jammu Issues Regulatory Orders For Sale Of Firecrackers

Jammu: District Magistrate Jammu, in exercise of the powers vested under section 144 Cr.Pc, ordered that no fireworks, crackers or explosive material shall be stored or sold in any place other than those specified by the DM office for the areas within Jammu Municipal Limits and by the respective SDMs/Tehsildars for the areas outside Jammu Municipal limits in Jammu District.

Stalls for sale of fireworks, crackers etc, shall be put by concerned dealers only at places mentioned in their permissions after getting clear-ance from the Deputy Director Fire Services, Police, Municipal and Revenue authorities.

The maximum amount of explosives which may be kept at any particular time at licensed premises shall not exceed the quantity given in class 7 Div. 2, Sub Div, II, of the explosive rules SCIV.

Electrical fittings in the premises shall be affixed properly, without any loose wires. Also one CFL tube shall be installed in the close vicinity of the stock of the explosives for proper illumination of the area.

No person under 18 years of age or who is in the state of intoxication or of unsound mind shall be employed for loading/ unloading or transportation of explosives or be allowed to

enter in the licensed premises. Explosives which are not authorized under rules or prohibited under section 6(A) of Act shall not be possessed or sold from the premises.

Chocolate Bomb, Chain cracker, (Kali Pataka, Loose Dhani Pataka,

Dodoma, Seven Shots, Rocket Bomb, Garlant Patakas, Stat Bomb etc, shall not be allowed to be sold by any wholesale cracker dealers/retail cracker dealers in the district to curb noise pollution.

Imported fireworks containing sensitive chemical substances which are not permitted under Indian statute and also do not comply with the Indian Noise Level Standards shall not be sold by wholesale cracker dealer/ Retailer.

No retail sale of crackers or other fireworks shall be undertaken by any authorized person at his shop/premises after the Diwali Festival.

Crackers and other explosive material shall contain a price tag which shall not be more than the price printed on each explosive. The price printed shall be deemed to include all local taxes even if the printed specifically reads "Local Tax Extra".

In case any wholesale or retailer contravenes any of the conditions specified above, not only the permission granted in his favour shall be cancelled and his stock seized but shall be liable for prosecution under relevant provisions of law.

Only green crackers are allowed to be sold as per advisory issued by competent authority.

This order shall come into force with immediate effect and shall remain in force for till 24-11-2022.

Any person, who contravenes this order, shall be liable to be punished in accordance with the provision of section-188 of the IPC. Since it is not possible to serve notice to all stakeholders the order is being issued ex-parte.

Jammu: Secretary, Planning Development & Monitoring Department (PD&MD), Dr. Raghav Langer Thursday chaired a at Civil Secretariat Jammu regarding the implementation of Civil Registration System (Registration Births and Deaths Rules 2022) in the UT of J&K.

Secretary Health & Medical Education, Bhupinder Kumar was also present in the i

The GoI has made the civil registration as a legal binding on every individual of the country

legislation called as Registration of Births and Deaths Act, 1969 and is applicable to the whole of the country including UT of J&K. Accordingly, revised Registration of Births and Deaths Rules, 2022 have been notified by the Planning Department vide S.O 494 dated 10th October, 2022 with the approval of Central Government on the basis of Model Rules of Registration of Births and Deaths Rules 1999 issued by Ministry of Home Affairs, Office of Registrar General of India.

The major changes introduced

in the Registration process is that, the Block Development Officers have been designated as the Registrars in Rural areas instead of Station House Officers (SHO's) of the concerned Police Stations.

Similarly, Director General Economics & Statistics J&K has now been designated as the Chief Registrar of Births & Deaths for the Union Territory instead of DG Health and Family of the district continue to be the District Registrars. DSEO's / Additional District Registrars

have been authorised to give permissions for delayed registrations after 30 days but within 01 year. Health Officers in JMC/ SMC, CEO's in Cantonment Boards & Executive Officers in Municipal Committees/ Councils shall continue to be the Registration Authorities.

Noteworthy that, Registration of Births and Deaths Rules were notified in the erstwhile State of Jammu and Kashmir in the 26th November, 1975. After issuance of revised statutory orders for implementation of Civil

Registration System in the UT of J&K, the Registration Hierarchy existing as per RBD Rules 1975 have been replaced with revised RBD Rules 2022, bringing J&K UT at par with rest of the country.

During the course of the meeting the duties and responsibilities of each of the Registration functionaries was highlighted with the direction for implementing the provisions of the Act and to coordinate and supervise the work of registration in the UT for securing and efficient system of registration. Emphasis was laid for organizing public awareness campaigns in the District / Block/Panchayat/Municipal areas in coordination with District Administration and steps for shifting to online Registration through CRS portal to be fully implemented before 1st of January, 2023 for issuance of Births and Deaths certificates etc.

Dr. Langer emphasized in the meeting that, pivotal role under the renewed system is to be played by seven types of functionaries who Registration of Births and Deaths which includes; Auxiliary Nursing Midwives (ANM), Accredited

Social Health Activist (ASHAs). Dais, Anganwari Workers, Head Masters of Government Schools, Village Chowkidars, Caretaker/ In-Charge of Cremation Grounds/ Burial Grounds.

Secretary Health & Medical Education assured that all requisite manpower, IT equipments shall be provided to oversee the successful roll out of the CRS in J&K. Sensitisation workshops and trainings shall be organised in all public health institutions and private hospitals/nursing homes to fully capture the institutional births & deaths data.

The match was the last in the round-robin section of the tri-series and came after the tournament finalists already had been determined. Pakistan and New Zealand will meet in the final on Friday.



This Is World's Most **Expensive Art Collection To Be Auctioned**

Los Angeles: Auctioneers unveiled the most expensive art collection ever to go under the hammer Wednesday, which belonged to Microsoft co-founder Paul Allen and is valued at \$1 billion.

Five centuries of touchstone works featuring some of the most significant creators in history are being sold next month. The collection of more than

150 pieces includes work by Vincent Van Gogh, Claude Monet, Paul Gauguin and Jasper Johns.

"I think this is a sale that sort of exhausts superlatives," said Johanna Flaum, vice-chairman



of 20th and 21st Century Art at auctioneers Christie's.

"This is... the most valuable

collection ever sold at auction. It's really a once-in-a-generation type of event."

Highlights include "La montagne Sainte-Victoire" by Paul Cezanne, which is expected to fetch at least \$120 million, and "Verger avec cypres" by Van Gogh, whose hammer price is estimated at over \$100 million.

Allen co-founded Microsoft with Bill Gates in 1975, becoming fabulously rich as the company grew into the computing behemoth it is today.

By the time he died in 2018 at the age of 65, he had bought some of the most important works created in the last half a

"The collection is quite wideranging, it really makes Paul Allen a unique collector in that sense," said Flaum.

The previous most expensive collection sold at auction was the Macklowe collection whose two tranches netted \$922 million.

Global Wildlife Populations Have Sunk 69% Since 1970: Report

LONDON: The world's wildlife populations have declined by more than two-thirds since 1970 as forests have been cleared and oceans polluted, according to an assessment released on Thursday.

This "serious drop ... tells us that nature is unraveling and the natural world is emptying," said Andrew Terry, director of conservation and policy at the Zoological Society of London

ZSL). The World Wildlife Fund (WWF) report, which used 2018 data from ZSL on the status of 32,000 wildlife populations covering more than 5,000 species, found that population sizes had declined by 69% on average. Deforestation, human exploitation, pollution, and climate change were the biggest

drivers of the loss. Wildlife populations in Latin American and the Caribbean were hit especially hard,



experiencing a 94% drop in just five decades. One population of pink river dolphins in the by 65% between 1994 and 2016, the report said. Its findings were broadly

Brazilian Amazon plummeted

similar to those in WWF's last assessment in 2020, with wildlife population sizes continuing to decline at a rate of about 2.5% per year, Terry said.

'Nature was in dire straits and it is still in dire straits," said Mark Wright, director of science at WWF-UK. "The war is definitely being lost.
