# Birdsong can reduce anxiety and paranoia, study reveals

**BERLIN**: Are there plenty of birds in your neighborhood? A new study finds they may be great for your mental health. Researchers in Germany have found that songbirds help to reduce anxiety and feelings of paranoia among people who listen.

In a study of 295 participants, a team from the Max Planck Institute for Human Development and University Medical Center Hamburg-Eppendorf examined the impact of hearing birds versus various traffic sounds. Although birdsong did not positively impact levels of depression, it did ease the severity of other mental health issues.

Before and after hearing these sounds, the group completed questionnaires assessing their mental health, as well as a cognitive test.

"Everyone has certain psychological dispositions. Healthy people can also experience anxious thoughts or temporary paranoid perceptions. The questionnaires enable us to identify people's tendencies without their having a diagnosis of depression, anxiety, and paranoia and to investigate the effect of the sounds of birds or traffic on these tendencies," says first author Emil Stobbe, a predoctoral fellow at the Lise Meitner Group for Environmental Neuroscience at the Max Planck Institute, in a university

Results show birdsong did not influence depressive states among the

participants. However, it did reduce levels of anxiety and paranoia. Conversely, traffic noise worsened depression, especially if the audio clip contained multiple traffic sounds.

The team says this is the first report to document the positive impact of birds singing on feelings of paranoia. Interestingly, the researchers found that birdsong and traffic noise did not have any effect on cognitive performance.

#### What makes birdsong so beneficial to menta health?

Study authors believe birdsong "is a subtle indication of an intact natural environment. It distracts the listener from other stressors that they would normally view as a threat.

"Birdsong could also be applied to prevent mental disorders. Listening to an audio CD would be a simple, easily accessible intervention. But if we could already show such effects in an online experiment performed by participants on a com puter, we can assume that these are even stronger outdoors in nature,"

says Stobbe. 'We were recently able to perform a study showing that a one-hour walk in nature reduces brain activity associated with stress," adds the research group's head Simone Kühn. "We cannot say yet which features of nature smells, sounds, color, or a combination thereof - are responsible for the effect. The present study provides a further building block to clarify this

# **MoU Contained Some Deficiencies**

SRINAGAR: In a candid admission, the chief minister, Dr Fa-rooq Abdullah, today said the Centre had taken him for a ride when the former union energy Minister P K Kumaramanglam, obtained his signatures on the memorandum of understanding (MoU) whose contents later turned out to be detrimental to the state's interests

According to a CNS report Dr Abdullah told the state assem-bly during an obituary reference to the late Kumaramanglam that a MoU had been signed between him and union minister. However, when the documents were prepared the union energy minister allegedly with malafide intentions, obtained his signa-tures on such papers which, on closer scrutiny later revealed that these were against the interests of the state.

However an official handout issued today said the chief min-ister had said "the MoU signed by him with the then union en-ergy minister had been signed in good faith to benefit the State." However the handout said "Later on the state officials pointed out some deficiencies." He said he immediately up the matter with Kumaramanglam who "readily agreed". But before correc-tion could be effected, the union Minister passed away. "These clauses have to be modified to protest the interests of the State" Dr. Abdullah added.

When contacted the principal secretary power development department Ajit Kumar told Observer News Service, the 'defi-ciencies pertained to the state's claim for reimbursement of the expenditure it had already incurred on the power projects. The MoU did not mention this. However, Kumar said the Centre had agreed to reimburse the expenditure and necessary modifica-tions would be incorporated in the MoU shortly.

### **Can Accused Be Convicted** If Weapon Not Recovered? What Supreme Court Said

on Friday said an accused in a murder case can be convicted even in the absence of recovery of the crime weapon, if there is direct evidence in the form of an eyewitness.

The Supreme Court set aside the June 2018 verdict of the Madras High Court which had acquitted three accused in a murder case.

A bench of Justices M R Shah and Krishna Murari said the submission by the counsel for the accused that the original informant and other independent witnesses have not been examined and recovery of weapon not been proved, and so the accused should be acquitted cannot be ac-

The bench noted that the accused, who were arrested in August 2013, were tried for committing murder of a man.

According to the prosecution, the accused had obstructed the car, in which the victim and others were travelling, and assaulted him due to which he sustained injuries and

# **Clash Between NATO &** Russia Will Lead to 'Global **Catastrophe': Putin**

MOSCOW: Russian President Vladimir Putin has warned of a "global catastrophe" in the event of a direct clash of NATO troops with Russia. Putin made the comments at a news conference at the end of a summit in Kazakhstan. Just a few days back, Moscow hit Kyiv and other Ukrainian cities with its heaviest missile attacks since the start of its invasion on February 24.

"In any case, direct contact, direct clash of (NATO) troops with the Russian army is a very dangerous move which could lead to a global catastrophe. I hope that those who are saying this are smart enough not to take such a step," Putin said.

Putin said that the missile strikes were a retaliation for the attack on Crimea bridge and there was no need for further attacks right now.

"We do not set ourselves the task of destroying Ukraine. No, ers. of course not," Putin said.

He said there was "no need for massive strikes" now because most designated targets had been hit

Putin also spoke about Moscow's current situation and said Ukraine last month, a move its soldiers were advancing.

# Woman Alleges Top Bureaucrat, Officials Raped Her, Special Team To Probe

# **Costs of War**

'he second Gulf War has begun. How the war will progress, how Saddam Husain will respond, and how military and political events will unfold cannot be predicted. And what after the war? The first casualty of the war has already occurred: it is the United Nations. America and Britain have fatally harmed it by stripping the world body of its international authority and by establishing a dubious principle - that if it suits a state or a group of states, the UN can be bypassed. What matters is the unabashed pursuit of geopolitical and commercial interests. If the UN stands in the way, it should be brushed aside. By refusing to table a second resolution for fear it may not get a Security Council majority or it may be vetoed, the US and UK have seriously undermined the world body. The world should now get ready to witness a descent into the law of jungle. All this talk about the war ushering in an era of democracy in the Middle East is poppycock. Democracy cannot be imposed from above; it has to grow from within as a result of a people's home-grown struggle.

Saddam may disappear from the scene, enabling the US to occupy Baghdad, install an interim administration there and pacify resistance elsewhere; or he may succeed in resisting at length, in Baghdad or elsewhere, forcing the US into a long fight. Or he could disappear, but others emerge to resist the US. The possibilities are endless.

If the United States is sincere in its assurance that all it wants is the destruction of Iraq's alleged weapons of mass destruction, it will have no difficulty in living up to the world's much reduced expectations.

However, only the ignorant or foolish believe in any of that anyway. America has more farreaching goals in Iraq. It will not be content to stop at destroying Saddam's arsenal of weapons of mass destruction, if indeed such an arsenal exists. Nor will it be content to depose Saddam himself and then install a civilian government in his place. Nor will it rest once the mechanisms for a democratic future in Iraq are a reality, if in fact they are really a part of the vision.

Rather, US ambitions are for nothing less than complete control of Iraq and its oil reserves, and for a redrawing of the map of the entire region according to its own -- and crucially, Israel's -- agenda. On its way toward achieving that goal, the US has amassed the most terrifying arsenal of weaponry ever dispatched from its soil into the Persian Gulf. The weapons themselves -- awesome though they may be in their destructive power and technical sophistication -- are of course not foolproof. Just how smart are the famed "smart bombs" the US are proposing to unleash on Irag? Previous conflicts -- in Kosovo, for instance -- revealed that a large percentage of them go horribly astray. They have even landed in the wrong country on occasion. How safe will Iraq's civilians be when all hell comes raining down on them? The prospect of a bombardment, the extent of which can barely be imagined, is terrifying.

How can such a force fail to cause significant "collateral damage" -- the Pentagon's deceptive euphemism for blowing into pieces men, women and children, whose misfortune it is to have been born citizens of Iraq? As the region braces itself for a full fledged war, two images crystallize in the mind one is of Saddam Hussein -- isolated and perhaps long out of touch with reality in the identical bunkers between which he moves, all the time contemplating his lack of a future. We must not forget, after all, that he has ultimately brought this fate upon himself and upon the Iraqi people, whom he has for so

long terrorized.
The second image is of an Iraqi mother with her small children in a small house, which has had only intermittent power supplies for the 12 years of sanctions, her children robbed of an education. They are caught in a situation for which she was never even given a chance of bearing responsibility, but for which they will pay the ultimate price.

# A Case for Part-time Jobs in Kashmir

Who financed your college or university degree? The latest smartphone you have in your hand, did you pay for it with your own hard-earned money? Or how much of the wedding jewellery you have was not bought with your parents' but your own savings? Is it your friend or a sibling who pays the cab fare when you go for a job interview? Well, if it's usually a person other than you who pays your bills, then you are very unlike those working part-time or shift jobs. There's also a likelihood that you live in Kashmir because part-time work is still a taboo here.

Kashmir being a class-conscious society, associates different kinds of jobs with different classes. For instance, the educated upper and middle classes are typically associated with white collar jobs and the lower or uneducated class is associated with blue collar jobs. As a result, white collar jobs are valued highly whereas blue collar jobs are looked down upon. This class-based hierarchy of the job market in Kashmir has created a stigma around part-time work, which due to lack of a robust private sector mainly includes blue collar jobs.

Traditionally, government has been the biggest employer in Jammu and Kashmir and young educated people especially in Kashmir Valley have banked on full-time government jobs for their employment and job security. Most of the people in the Valley are averse to private sector jobs that do not guarantee job security. This dependence on government jobs as the only securework has also added to the stigma around part-time work among Kashmiris.


Consequently, a large number of young people— students, college or university pass outs, people planning their marriages, people wanting to earn some extra money on top of their jobs or ventures or simply those in need— miss out on a lot of part time-work or possibilities of making money. The educated but unemployed youth who aspire for nine to five administrative or managerial office jobs are unwilling to accept part-time blue-collar jobs as an alternative, at least for the time being. Even the unskilled and uneducated youth is reluctant to work as a part-timer.

Moreover, as the data released by Centre for Monitoring Indian Economy (CMIE) depicts, the Union Territory of J&K is reeling under high unemployment rates. J&K reported a 17.1% unemployment rate, 3rd highest in the country for January-April quarter of 2022. In the May-August quarter, the rate was at 19.1%, again 3rd highest in the country. And in the month of September 2022, the unemployment rate jumped to 2nd highest in the country at 23.2%. This comes in the backdrop of huge economic devastation caused by crippling lockdowns necessitated by CO-VID-19 pandemic. During the lockdown periods, J&K's major economic sectors like

horticulture, tourism, transport and trade were among the least performing and also the most damaged sectors. According to CMIE, more than five lakh people in J&K lost their livelihood between June 2020 to March 2021. Daily wagers & labours depended upon NGOs or other volunteer organisations for their basic needs like food. Many businesses like local handicrafts suffered irrecoverable losses while some

All these figures and facts put up an extremely worrying reality of Kashmiri soci-

tremely worrying reality of Kashmiri society in front of us. To deal with such issues, why can't we, as in the developed world, set aside the stereotypes associated with part-time or blue-collar jobs and simply let people work and earn according to their needs?Therefore,it is high time we



of the business units were closed down due to non-payment of loans and debt. The overall economic activity in Kashmir during the pandemic was almost zero. The losses incurred by Kashmir's economy during the pandemic were estimated by various trade and commerce bodies to be around 40000 crores.

Given the cumulative effect of class consciousness, unemployment and pandemic, it would be an informed guess that many people in the valley are living in precarious economic conditions. And in a society like ours, where your class determines whether you take up a certain kind of a job or not, you are basically cutting down on your chances of achieving some level of financial stability. For example, if you are a person in need-you are currently unemployed or your first business tanked or you don't want to miss the EMI of your education loan-taking up a part-time job would be the ideal respite from your financial worries, however, if at the same time you are living in a class-conscious Kashmiri society, probably there won't be an easy respite from your financial woes because of the cultural demeaning of part-time or

In Kashmir we see many young people who have attained the marrying age either being unable to afford their marriages or totally depending on their parents for getting married as well as their post marriage life. This has led to an upward trend of late marriages. According to a study done by the Sociology Department of Kashmir



WHAT DOES THE FUTURE HOLD FOR KASHMIR? The probability is that it will be more of the same. Even if the BJP loses power in the future, the Article 370 move remains a fait accompli. break the taboo around part-time work culture in Kashmir and inculcate dignity of labour in our society so that people are encouraged to take up part-time jobs in whatever form.

Additionally, working in a part time job doesn't always have to be driven by need. Those seeking part-time work voluntarily or involuntarily shows an upward trend across the globe particularly across the developed world. According to the data

provided by Organization for Economic Co-operation and Development, the proportion of persons employed part-time among all employed persons in 2021 for various countries is as—36% in Netherlands,25.6% in Japan, 25.3% in Switzerland, 22.2% in Germany, 21.7% in UK and 20.3% in Norway

In the present world scenario, Millennials (26-41) and Gen Z (8-25) are more financially sophisticated than any previous generation was at their age. According to the 2022 Investopedia Financial Literacy Survey conducted in United States, 54% Gen Z adults already hold some kind of investment in the stock market. So again, why can't people in Kashmir earn and learn to manage their finances at a young age? We need to encourage our youth, particularly students, to develop the temperament for simultaneous work-study culture. Besides part-time work being essential for students sponsoring their own education, it helps students acquire skills for managing finances and solving realworld problems early in their lives.

There is also a dire need for normalizing part-time or blue-collar jobs existing in Kashmir's job market.Hardworking people who come here from outside J&K can teach us a lot because the jobs a local Kashmiri finds himself averse to are the same jobs they fill up after travelling long distances and away from their home. Although Kashmir doesn't have a huge part-time job market, opportunities like working as a barista at restaurants or as a sales person at retail stores, driving a cab or guiding tourists on weekends are still up for grabs. Freelancing opportunities are opening up in fields like journalism. Online jobs that pay on hourly basis like content writing also exist.

It is very important to realize the fact that low-status associated with part-time or blue-collar jobs is purely a social construct and this construct is hampering people to mitigate effects of financial uncertainty particularly in the times of record unemployment and high inflation. We need to create a culture free of any constraints on seeking financial independence.

Yes, part-time work especially blue-collar jobs don't provide the kind of job security or financial development one looks for but part-time work is definitely something better than idleness. More often than not, working as a part-timer benefits rather than harm or does nothing for you. The unemployed youth of Kashmir regardless of its educational status or class needs to show up for such jobs, at least for the time being.

# A Perfect Storm In US Foreign Policy

The old adage is that a good foreign policy is the reflection of the national policy. A perfect storm is brewing on the foreign policy front in America triggered by the OPEC decision on Thursday to cut oil production by 2 million barrels a day, which will on the one hand drive up the gas price for the domestic consumer and on the other hand expose the Biden Administration's lop-sided foreign policy priorities.

At its most obvious level, the OPEC decision confirms the belief that Washington has lost its leverage with the cartel of oil-producing countries. This is being attributed to the deterioration of the US' relations with Saudi Arabia during the Biden presidency. But, fundamentally, a contradiction has arisen between the US interests and the interests of the oil producing countries.

Contradictions are nothing new to the geopolitics of oil. The 1970s and 1980s witnessed two major "oil crises." One was man-made while the other was an interplay of historical forces — the Yom-Kippur War of 1973 and the Iranian Revolution of 1979.

President Nixon asked petrol stations not to sell gasoline from Saturday night through until Monday morning. The crisis affected industry more than the average consumer.

morning. The crisis affected industry more than the average consumer. In 1979, the Iranian Revolution hit oil production rates and the world's oil supply shrunk by 4%. Panic set in, demand for crude oil shot up and price more than doubled.

The Biden Administration tempted Fate by underestimating the importance of oil in modern economic and political terms and ignoring that oil will remain the dominant energy source across the world for the foreseeable future, powering everything from cars and domestic heating to huge industry titans and manufacturing plants.

A smooth transition to green energy over time is largely dependent on the continued availability of plentiful, cheap fossil fuel. But the Biden Administration ignored that those who have oil reserves wield a huge amount of power over our oil-centred energy systems, and those who buy oil are on the contrary, cripplingly dependent on the market and the diplomatic relations which drive it.

The Western powers are far too naive to think that an energy superpower like Russia can be simply "erased" from the ecosystem. In an "energy war" with Russia, they are doomed to end up as losers.

Historically, Western nations understood the imperative to maintain good diplomatic relations with oil-producing countries. But Biden threw caution into the wind by insulting Saudi Arabia calling it a "Pariah" state. Any improvement in the US-Saudi relations is not to be expected under Biden's watch. The

Saudis distrust American intentions.
The congruence of interests on the part of the OPEC to keep the prices high is essentially because they need the extra income for their expenditure budget and to maintain a healthy investment level in the oil industry. The International Mon-

a healthy investment level in the oil industry. The International Monetary Fund in April projected Saudi Arabia's breakeven oil price — the oil price at which it would balance its budget — at \$79.20 a barrel.

The Saudi government does not disclose its assumed breakeven oil price. But a Reuters report sug-

oil price. But a Reuters report suggested that a preferred price level would be around \$90 to \$100 a barrel for Brent crude — at which level, it won't have a huge impact on the global economy. Of course, over \$100 will be a windfall.

Meanwhile, a "systemic" crisis is brewing. It is only natural that the OPEC views with scepticism the re-

brewing. It is only natural that the OPEC views with scepticism the recent moves by the US and the EU to push back Russia's oil exports. The West rationalises these moves as aimed at drastically reducing Russia's income from oil exports (which translates as its resilience to fight the war in Ukraine.) The latest G7 move to put a cap on the prices at which Russia can sell its oil is taking matters to an extreme.

The OPEC regards it as a paradigm shift, as it implicitly challenges the cartel's assumed prerogative to ensure that global oil supply matches demand, where one of the key measures of supply-demand balance

is price. Arguably, the West is de facto setting up a rival cartel of oilconsuming countries to regulate the oil market.

No doubt, the West's move is precedent-setting — namely, to prescribe for geopolitical reasons the price at which an oil-producing country is entitled to export its oil. If it is Russia today, it can as well be Saudi Arabia or Iraq tomorrow. The G7 decision, if it gets implemented, will erode OPEC's key role regulating the global oil market.

Therefore, the OPEC is proactively pushing back. Its decision to cut down oil production by 2 million barrels per day and keep the oil price above \$90 per barrel makes a mockery of the G7 decision. The OPEC estimates that Washington's options to counter OPEC+ are limited. Unlike in the past energy history, the US does not have a single ally today inside the OPEC+ group.

Due to rising domestic demands for oil and gas, it is entirely conceivable that the US exports of both items may be curtailed. If that happens, Europe will be the worst sufferer. Without doubt, this is a tectonic shift in geopolitics which may probably turn out to be more important than the conflict in Ukraine in the making of the multipolar world order.

This perfect storm in Biden's foreign policy can also impact the midterms in November and deliver a Republican majority in the Senate,

which could set the tempo for the 2024 US presidential election.

The Kremlin spokesman Dmitry Peskov has said that by turning away from Russian energy, Europe has become a captive market for the US oil companies which are now making "crazy money," but the high cost of it is draining away the competitiveness of the European economy.

"Production is collapsing. Deindustrialization is coming. All this will have very, very deplorable consequences for the European continent over probably, at least, the next 10-20 years," Peskov said.

Russia could be the biggest "gainer" of OPEC+cuts. The expert opinion is that oil prices will move higher from current levels through yearend and next year. That is to say, Russia will not cut any output while the price of oil is set to rise in the coming months! As oil price rises, Russia will not have to cut even a barrel of its production so long as it has a big enough market after December to sell the crude now going to Europe. Again, Russia, for its part, reiterates that it will not supply oil to countries that would join the G7 price cap. It is matching the Biden Administration's non-market instruments.



# Reading Sir Sayyid's Stance on Islam's Conformity with Rationalism and Science



s Islam compatible with science? Or is there conformity between reason and revelation? This was one of the fundamental issues faced, and addressed, by the Muslim modernists of 19th century, including Sir Sayyid. Besides demythologizing the Qur'anic interpretation and calls for renewed ijtihad, one of the crucial and significant themes in the writings of Sir Sayyid was to characterize congruence in between the Sacred Text and science and reason

ir Sayyid Ahmad Khan (1817-1898) was undoubtedly a multi-dimensional personality: a pioneer of Islamic modernism, educational and political activist, theologian, journalist, and the chief organizer of 19th century Islamic reformist thought in the Sub-Continent. Recognized as the first Indian Muslim to felt the need, and working, for a fresh orientation of Islam, Sir Sayyid called for a bold new theology (jadid ilm al-kalam) or reinterpretation of Islam. His contribution mainly falls in the educational and socio-religious reformation.

Back in 1960s, Aziz Ahmad (in his Islamic Modernism in India and Pakistan) argued that Sir Sayyid's achievements as a religious thinker in the context of Islamic modernism can be recognized as tackling with two broadly distinct problems: (i) the rationalization of the minutiae of non-essential dogma" and (ii) "the liberalization of Islamic law". Regarding latter, Sir Sayyid's work is so dynamic and constructive that it made tremendous impression on modern Islam in general and on Indian Islam in particular. Similarly, Wilfred Cantwell Smith (in his Modern Islam in India) remarked that the "ideas which Sir Sayyid was putting forth, and the religion he fashioned, was explicitly and in fact an Islam thoroughly compatible with progress, liberal and humanitarian morality, and its scientific rationalism". This is how Sir Savvid's thought and contribution. as a socio-religious reformer, was perceived in the 20<sup>th</sup> century.

Coming straight to the 21st century, Dr Farhan Ahmad Nizami (in his lengthy Forward to Prof. A. R. Kidwai's edited volume, Sir Syed Ahmad Khan: Muslim Renaissance Man of India) states that Sir Sayyid was, "one of the architects of a Muslim intellectual renaissance in India hardly imaginable in the mid-nineteenth century", for his efforts and contribution as a "scholar, social reformer, theologian, political thinker, journalist, legislator, cultural historian, pioneer in comparative religious studies, advocate for mass education", and in many other fields. He, and his legacy, remains relevant even today for many reasons, and one of the major reasons, for Nizami, is that "the issues he faced 150 years ago are, for Muslim communities everywhere, as current as they were then, and perhaps even more intractable."

These statements are self-evident regarding the impact, influence and relevance of

Sir Sayyid's scientific and rational thought, both in past and present. In this context and keeping in view the birth anniversay of this great reformer, this article presents an assessment of Sir Sayyid's scientific thought, by highlighting his stance on Islam's conformity with Rationality and Rationalism nd his views on Religion-Science compatibility and how his scholarship has been received by the Mulsim and non-Muslims.

Sir Sayvid's Stance on the Religion-

Science Compatibility: Is Islam compatible with science? Or is there conformity between reason and revelation? This was one of the fundamental issues faced, and addressed, by the Muslim modernists of 19th century, including Sir Sayyid. Besides demythologizing the Qur'anic interpretation and calls for renewed ijtihad, one of the crucial and significant themes in the writings of Sir Sayyid was to characterize congruence in between the Sacred Text and science and reason. A staunch believer of Religion-Science compatibility, he considered natural law and divine law to be the same, because, he believed, revelation cannot be opposed to scientific actuality and that an agreement between God's word and work is essential. His object was to remove apparent contradictions between Islamic teachings and science—hence his oft-repeated thesis: 'Islam is nature and nature is Islam'. He, thus, proposed a rule in case of perceived conflict between a law of nature and the Qur'anic verse: the Work (nature) qualifies the Word (verse) of God; i.e., the Our'an as the word of God cannot be in conflict and contradiction with Nature as the Work of God: "There is no matter in the Qur'an disagreeing with the laws of nature'

He puts forth this thesis as: "it would be highly irrational to maintain that God's work and God's word are different and unrelated to one another. All beings, including humans, are God's work, and religion is His word; the two cannot be in conflict". Thus, he concluded that "Islam is in full accordance with nature" because "Islam is nature and nature is Islam"

Furthermore, Sir Sayyid argued that if we keep in view the principles deducible from the Quran itself, we shall find that there is no contradiction between the modern sciences, on the one hand, and the Quran and Islam, on the other.

He also believed that in secular matters where Islam is silent, Muslims should imitate the western practices. He believed in religious pluralism and considered it absurd to believe that God's prophets appeared only in Arabia and Palestine to reform a handful of Arabs and Jews, and that other peoples were denied knowledge of the divine. He may be considered, as Riffat Hassan argues (in her chapter on South Asia in Shireen T. Hunter's *Reformist Voices in Islam*) as a pioneer in "Inter-faith Dialogue" as "he worked for greater understanding and goodwill and harmony among Muslim sects and between Muslims and non-Muslims"

Thus, the ideas put forth by him, and the religion fashioned by him, was, to use Smith's terminology, in fact an Islam thoroughly compatible with progress and the "[Western] scientific rationalism. It will not be an exaggeration to call Sir Sayyid as being, undoubtedly, the most rational in his approach and ideas

proach and ideas. Sir Sayyid's 'Rational Interpretation' of Islam and its Scholarly Reception: Various writings, both in past and present, have emphasized and appreciated different areas of Sir Sayyid's thought and activity, social, political, religious, educational and culturalin which he made reforms. But almost all agree that his prime achievement was a revival of Muslim morale and prestige in British India. and that to him goes the credit for having re-established the dynamism of the Muslims in India as a socio-political force. Sir Sayyid's socio-religious reforms, of various sorts, which he initiated and introduced, have been highly appreciated, though sometimes criticized (especially by some *Ulama*) as well. In this context, below is presented a brief summary of the views, praise and appreciation of some of the scholars and writers (both Muslims and non-Muslims), revealing both the importance as well as relevance of Sir Sayyid's rational interpretation of Islam and his reformist thought.

For example, Aziz Ahmad regards his efforts as a "dynamic and constructive achievement that made a tremendous impression on modern Islam. In the words of Khaliq Ahmad Nizami, Sir Sayyid was one of the towering personalities in the galaxy of the 19th century Muslims reformers, who zealously worked to bring about a change in the Muslim thought and behavior and in fact contributed many essential elements to the development of modern Indian society. For Trara Chand, he brought "a revolution in Muslim thought" and Bashir Ahmad Dar (in his *Religious Thought of Sayyid Ahmad Khan*) considers Sir Sayyid as "the first man

in modern India to realize the necessity for a new interpretation of Islam that was liberal, modern, and progressive.

Similarly, Sir Sayyid's reformist efforts, as summarized by FrancisnRobinson (in his chapter on South Asia in 5th volume of *The New Cambridge History of Islam*), were "aimed to fashion Muslims who were able to operate with success in the world of Western knowledge and British power". In his opinion, Sayyid Ahmad's achievement was more than just the fashioning of Islamic modernism and creating the key institution of Muslim higher education; he inspired innovation across a broad front designed to help Muslims embrace modernity, which came to be called the Aligarh movement.

It is an undeniable fact that a significant and systematic activity introduced by modernists like Sir Sayyid was an emphasis on the need to reinterpret Islamic law through dynamic legal tools (like *Ijtihad*) and through rational approach.

To cut a long story short, it is not an exaggeration to say that Sir Sayyid was a true heir of Shah Waliullah's reformist legacy and one of the pioneers of Islamic modernism. He emphasised, in high terms, the socioreligious and intellectual reform and is truly recognized as the initiator of a revolution in Muslim thought, who called for a new theology to respond to the modern challenges and change. Emphasizing a rationalist approach to Islam and to religious matters, Sir Sayyid held the view that there is no contradiction between Word of God (Quran) and Work of God (Nature). In keeping with his rationalist attitude, he underscored the importance of Ijtihad and a rational interpretation of Islamic religious sources and thought, for he believed that both of these were necessary to make Islam acceptable to the new age, and that Muslims would not understand Islam and others would not appreciate it unless it was presented rationally. He, thus, proved as the pioneering representative of Islamic modernism in South Asia who presented a new orientation of Islam and reacted to the



# **Symptomatic Covid Infection Linked With Poor Mental Health: Lancet Study**

aving symptoms of COVID-19 infection is associated with poorer men-tal health and lower life satisfaction, according to a study published in The Lancet Psychiatry journal

The team, led by researchers at King's College London and University College London (UCL) in the UK, looked at the impact of COVID-19 infection on subsequent

mental health and wellbeing. Data was taken from 11 longitudinal studies between April 2020 and April 2021, in which there were 54,442 participants with and without self-reported COVID-19. Researchers found that rises in psychological distress, depression, anxiety, and lower life satisfaction were associated with prior self-reported COVID-19.

The associations with poorer mental health did not lessen over time after infection, highlighting the potential enduring impacts of the disease and the need for a longer follow-up process from healthcare

Self-reported COVID-19 was consistent ly associated with psychological distress, regardless of whether people tested positive for antibodies to the virus.

These effects of infection were felt similarly in different groups of gender, ethnic-

This might reflect that older people are more likely to experience more severe COV-ID-19 symptoms, greater worry around infection, and increased risk of blood vessel (microvascular) or brain (neurological) changes after infection, the researchers said

This contrasts to the effect of the pandemic overall on mental health, where previous studies have shown that women and adults aged 25-44 have had the greatest adverse impacts, they

"These findings suggest that there were pro-longed mental health consequences of CO-VID-19 infection for some people at the beginning of this pandemic," said study joint first au-thor Ellen Thompson from King's ae London. "Understanding

why this is the case will be key to finding treatment strategies for those affected as well as preventing such effects in future pandemic waves," Thompson said.

The study brings together many of the

UK's longitudinal studies to provide a comprehensive overview of the impacts of COV-ID-19 infection on population mental health. 'Compared to most studies to-date that have focussed on more severe and hospitalised cases, this study demonstrates the impact of infection during a pandemic on overall population mental health and well-

being," said study senior author Professor Praveetha Patalay from UCL.



# **GOOGLE** MEET 🗗 To Automatically Zoom In On Your Face

For More Visibility

ech giant Google has announced a new feature for Meet users to improve visibility by automatically framing the video. Before a user attends a meeting, Meet will automatically frame the video to ensure that everyone is equally visible, the company said in a blogpost.

There are no motion disturbances that could draw attention away from the meeting's subject because the automatic framing only happens once. But the video can be reframed manually at any time. This feature does not have an admin control. By default, this function will be disabled, however, it can be turned on by the user. The new feature is scheduled to roll out on November 2, the company said.

The feature was first announced during the Google Cloud Next 2022.

Earlier, the company had announced a Meet feature that enable users to unmute themselves by holding down the spacebar and to mute themselves again by releasing it.

The company said it will make it easier for users to participate in their meetings by quickly unmuting to say something.

"This feature helps in situations where you forget to mute again after unmuting yourself. This feature is OFF by default and can be enabled in the Google Meet settings," the company said.

The company said it changed how the "Hey Google" voice control works for Google Meet hardware devices.

With this update, the Google Assistant will only be active when a device is not in a meeting and within 10 minutes of an upcoming meeting.

# **Problems Conceiving Are Not Just About Women**

or the first time, IVF clinics in Australia and New Zealand have reported data about the scale and range of male fertility problems in couples who have IVF. New data released by the Australia and New Zealand Assisted Reproduction Database (ANZARD) today reveal about one-third of all IVF cycles performed in 2020 included a diagnosis of male infertility.

Although most male fertility problems can't be prevented, there are things men can do to improve sperm quality and the chance of natural conception.

Most male infertility is due to the testes failing to make any or enough normal sperm to allow conception. A low sperm count, sperm not moving normally, or a high proportion of abnormally shaped sperm reduce capacity to fertilise eggs.

In most cases, the cause of male infertility is unexplained. A specific cause can only be pinpointed in about 40 per cent of infertile men.

They include genetic abnormalities, past infection, trauma to the testicles, and damage to sperm production for example from cancer treatment. Some men have no sperm in their ejaculate (a condition called azoospermia). This can be due to blocked sperm tubes, which may be a birth defect, or follow vasectomy or other damage.

In a minority of cases, infrequent or poorly timed intercourse, or sexual problems such as erectile dysfunction or ejaculation failure cause the infertility.

The least common problem is deficiency of hormonal signals from the pituitary gland (a gland on the brain which makes, stores and releases hormones). This can be genetic or follow issues such as a pituitary tumour. Treatment with hormone injections aims to restore natural fertility.

Chronic diseases such as obesity or diabetes, environmental exposures (such as chemicals in the workplace) and lifestyle factors (such as smoking and recreational drug use) can contribute to or exacerbate poor sperm quality.

For couples with male factor infertility, intracytoplasmic sperm injection (ICSI) is

needed to fertilise the eggs and give them a chance of having a baby.

ICSI follows the same process as IVF, except ICSI involves the direct injection of a single sperm into each egg using technically advanced equipment, as opposed to IVF, where thousands of sperm are added to each egg in the hope one will fertilise it.

The just released ANZARD report shows the chance of a baby for men with male infertility is comparable with other infertility diagnoses. However, studies show that for couples who don't have male factor infertility, ICSI offers no advantage over IVF

in terms of the chance of having a baby. Although most male infertility is not

preventable, there are some things men can do to keep their sperm healthy. It takes about three months for sperm to mature, so making healthy changes at least three months before trying for a baby gives the best chance of conception and having a healthy baby. Here are five things you can do to look after your sperm.

Cigarette smoke contains thousands of harmful chemicals that cause damage to all parts of the body, including sperm. Heavy smokers make fewer sperm than nonsmokers. Smoking can increase the number

of abnormally shaped sperm and affect the sperm's swimming ability, making it harder for sperm to reach and fertilise the egg.

Smoking also damages the DNA in sperm. which is transferred to the baby. This can increase the risk of miscarriage and birth defects in a child. One study found heavy smoking (more than 20 cigarettes a day) by fathers at the time of conception increases the child's risk of childhood leukemia.

There is no safe limit for smoking the only way to protect yourself and your unborn baby from harm is to quit. The good news is the effects of smoking on sperm and fertility are reversible, and quitting will increase the chance of conceiving and having a healthy baby.

On average, men who are overweight or obese have lower sperm quality than men who are a healthy weight. Carrying too much weight can also reduce your interest in sex and lead to erection problems.

The good news is, even losing a few kilos can improve sperm quality. Getting support, setting realistic goals and giving vourself enough time to achieve them. learning about nutrition and healthy eating, and exercising regularly increase your chance of losing weight and keeping it off.

Taking androgenic steroids for bodybuilding or competitive sports causes testes to shrink and affects sperm production. And it can have a lasting impact. It takes about two years for sperm to return to normal after stopping steroids.

A man's fertility can also be harmed by other drugs like cannabis, cocaine and heroin, as they reduce testosterone levels and sex drive (libido).

Alcohol is OK in small amounts, but heavy drinking and binge drinking can reduce sperm count and quality. We've all heard about men in their 80s and 90s fathering children, but this is rare and risky.

Although men continue to produce sperm throughout life, which means they can potentially reproduce into old age, men under 40 have a better chance of conceiving than older men.

It takes longer for partners of older men to conceive, and sperm quality declines with age and this increases the risk of miscarriage and health problems for the baby.

# Deaths Linked To Cough Syrups: Govt Panel Says Info Shared By WHO So Far Inadequate To Determine Aetiology

New Delhi: The committee set up by the government to examine reports potentially linking the death of 66 children in The Gambia to four made-in-India cough syrups has observed that the clinical information shared by the World Health Organization so far is inadequate to determine the aetiology. This was conveyed to the WHO by Drugs Controller General of India (DCGI)

V G Somani on Saturday. Rutendo Kuwana from the WHO on October 13 had written to the DCGI seeking to know the progress with the investigation of the manufacturer of the four cough syrups -- the Sonipatbased Maiden Pharmaceuticals.

In an email response, Dr Somani on Saturday said the Union Ministry of Health has constituted a committee of technical experts to examine and analyse the details of the adverse event reports and all related details shared by or to be shared by WHO and to recommend follow up action.

Somani said the four-member committee chaired by Dr Y K Gupta, Vice Chairperson, Standing National Committee on Medicines, in its first meeting has examined the reports and communications so far received from WHO and has made several observations.

Mentioning the observations, Dr Somani said, "The clinical features and the treatment received by the children as shared by WHO so far are inadequate to determine the aetiology.'

The details of initial illness, sign and symptoms, duration of anura in the cases, results of laboratory investigations conducted including various markers and parameters, specific investigations for diethylene glycol and ethylene glycol on critical samples of the patients, treatment received before and after hospitalization at the tertiary hospital in Gambia, treatment received before and after acute kidney injury was suspected and reasons thereof, names and brands of the drug formulations used in the treatment before and after hospitalization, their manufacturers, their expiry other relevant information in each of the cases, are necessary, he said.

Dr Somani further said in case, verbal autopsy was conducted, a detailed report may be shared by WHO.

Dr Somani has sought details on the number of stool samples collected and analysed and the number of children with a similar

clinical presentation to acute kidney injury from whom the biological samples were collected.

He also sought the details of the product samples collected and tested (with their compositions, manufacturers) which were reported to be negative for EG and DEG, the details of cases who received these products.

"You are therefore requested to share the report on causal relations along with above details, as observed by the said Technical Committee at the earliest for further examination and follow up action at our level." he wrote.

The DCGI further informed that the investigation of the manufacturer in question has progressed.

"The manufacturing site has been inspected, test reports of sampled products from the laboratory are awaited and all the manufacturing activities of the manufacturer in question have been stopped," he said. The Union Health Ministry

Reacting to the killing of Bhat, Jammu and Kashmir Pradesh Congress Committee (JKPCC) working president Ramban Bhalla said it as a grave failure of the Union Home Ministry which directly deals with the law and order situation in the Union Territory.

Bhalla, who chaired a meeting of senior leaders here, called for urgent and effective measures to save innocent lives in Kashmir.

The party condemns the killing, which is in line with a series of such shocking incidents. It reflects that the situation in Kashmir is very grim, contrary to the claims of normalcy by the central and J-K administration, the party said in a statement.

It said the BJP-led central government has utterly failed to ensure the safety and security of common people in Kashmir, which is very unfortunate.

Bhalla and other party leaders demanded that the culprits should be identified and dealt with sternly Home Minister Amit Shah should

speak about the series of incidents of selective and targeted killings, especially of the minority community in the recent past, Bhalla said. The Aam Aadmi Party (A

condemned the incident and said the bloodbath is going on unabated in Kashmir and the BJP government as well as the LG administration are busy in spreading claims of normalcy through numerical figures and is treating loss of precious human lives as a number game.

Things are not well in any context as people are not even safe in their lawns and orchards where gunmen appear from nowhere, fire volley of bullets, take innocent human lives and then escape from the scene, AAP state spokesperson Nawab Nasir said in a

He said the loss of every single human life irrespective of caste, color, creed and religion is painful and the society should stand against it to condemn the inhumane act.

The Hurriyat Conference led by Mirwaiz Umar Faroog also expressed shock and grief over the killing.

In a statement, the Hurriyat said every single life lost in this manner is very painful and sad. It extended condolences to the bereaved family and expressed solidarity with them in their hour of great sorrow.

#### **Angry KPs Block**

The Pandits, employed under the Prime Minister's employment package, have been protesting at relief commissioners office in Jammu over the past five months following the killing of their colleague Rahul Bhat in Kashmir last May.

As the news of the latest killing of Kashmiri Pandit broke out, they came out of the protest site and marched towards the main road and blocked the highway, amid high pitch sloganeering to denounce the target killings by militants and the alleged failure of the government to deal with the situation.

"Our worst fears have once again come true with the latest killing. We have already fled the valley otherwise we feel many of us have been done to death," one of the protesters, Nikhil Kaul said.

He said they have been saying that the situation in the valley is not safe for them but "this government remained unmoved and paid no heed to their pleas for relocation.'

Yogesh Pandit, another protester,

said the administration is trying to pressure them to rejoin their duties by issuing "death warrants" in the form of making biometric attendance man-

datory and stopping their salaries. "The killing of Bhat exposed the government claims about the improved security situation in the valley. We will not return till the situation becomes normal in true sense," he said.

Pandit said they have tried to reach the government through memorandums and protests for their relocation from the valley following the series of targeted killings over the past one

"This government is deaf, dumb and blind," the agitated Pandit said, asking what was their fault for which they are being brutally killed by militants.

Rashtriya Bajrang Dal activists also joined the protesters and set ablaze an effigy of Pakistan to condemn the frequent target killings by militants in the valley.



SYLHET: India maintained their dominance in the Women's Asia Cup with an eight-wicket demolition of a self-destructing Sri Lanka in the final here on Saturday for their seventh title in eight editions.

# 5.3 Billion Cell **Phones To Be Dumped** In 2022: Report

LONDON: Roughly 5.3 billion mobile or smartphones will drop out of use this year, and only a small number of them will be disposed off properly, according to a report.

Brussels-based Waste Electrical and Electronic Equipment (WEEE) Forum conducted surveys to understand why so many households and businesses fail to bring electronic gadgets in for repair or recycling.

The surveys show that, of the 8,775 European households across five European Union countries — Portugal, Netherlands, Italy, Romania and Slovenia — and a separate UK survey, the average household contains 74 e-products such as phones, tablets, laptops, electric tools, hair dryers, toasters and other appliances (excluding lamps).

Of those 74 average total eproducts, 13 are being hoarded -- 9 of them unused but working and 4 broken.

Stacked flat atop one another at an average depth of 9 mm that many disused phones would rise roughly 50,000 km -- 120 times higher than the International Space Station; one-eighth of the way to the Moon, according to a statement.

Further, despite their valuable gold, copper, silver, palladium and other recyclable components, experts expect a majority will disappear into drawers, closets, cupboards or garages, or be tossed into waste bins bound for landfills or incineration.



The top five hoarded small electrical and electronic equipments in Europe are small consumer electronics and accessories (headphones, remote controls, etc.), small household equipment (clocks, irons, etc.).

These also include small information technology equipment (external hard drives, routers, keyboards, mice, etc.), mobile and smart-phones and small equipment for food preparation (toasters, food processing, grills, etc.).
"We focussed this year on

small e-waste items because it is very easy for them to accumulate unused and unnoticed in households, or to be tossed into the ordinary garbage bin," said Pascal Leroy, Director General of the WEEE Forum, the organisation behind International E-Waste Day.

"People tend not to realise that all these seemingly insignificant items have a lot of value, and together at a global level represent massive volumes," Leroy said.

The report says LED lamps rank top of the list of products most likely to be trashed.

Mother on her crown in 1937. There were speculative reports in the British media about the possibility of Camilla wearing the Kohinoor diamond when she is crowned Queen Consort at a ceremony on May 6 next year.

# Heir To Dutch Throne Forced To Stay Home Amid Security Fears

**THE HAGUE:** The teenage heir to the Dutch throne has been forced to give up on Amsterdam's student life and live instead at her parents' palace, the latest indication of just how much of a threat organized crime poses to Dutch society.

A visibly emotional Maxima said at the end of a state visit to Sweden on Thursday that the 18-year-old princess "doesn't live in Amsterdam and can't really go out." She said that despite the

The Queen's words offered a rare insight into the sense of unease felt by the royal house. It's also indicative of the fear shared by the Dutch and others across Europe that criminal gangs involved in the lucrative drug trade are fanning.

The Dutch justice minister last week hosted a meeting at which six nations pledged to step up cooperation in the fight against organized crime.

That meeting came after security around Belgium's justice minister, Vincent Van Quicken-



borne, was beefed up following the arrest of four Dutchmen in the Netherlands on suspicion of

a plot to kidnap him.

Belgium and the Netherlands are home to the ports of Antwerp and Rotterdam, two key hubs for networks trafficking huge

amounts of cocaine into Europe. Another example underscoring the gravity of the gang threat was a move by Dutch prosecutors this week to add terrorism to charges that a suspect faces in the slaying of popular crime reporter Peter R. de Vries who was

gunned down last year. Prosecutors said the suspect posted on social media a grisly video he recorded of De Vries after he

was shot in a downtown Amsterdam street to amplify the impact.

Amalia, 18, is studying Politics, Psychology, Law and Economics at Amsterdam University and was supposed to be living in a house with other students in the heart of the city's historic canal network. Instead, she is still at home in nearby The Hague, her mother said. "She doesn't have a

student life," Maxima said. Prime Minister Mark Rutte, who reportedly also has had his personal security beefed up amid threats, called it "terrible news" for Amalia.
