J&K Reported 7 Dengue Deaths This Year So Far

Srinagar: At least 3,784 dengue cases and seven deaths have been reported in Jammu and Kashmir this year so far with six from Kashmir division.

A top health official said that around 15003 tests have been conducted so far and 4,649 have been tested positive.

Of 4,649 cases 90percent of cases which is 3,784 cases are from Jammu district only.

They added that cases include 154 from Samba, 64 from Kathua, 320 from Udhampur, 83 from Reasi, 47 from Rajouri, 22 from Poonch, 116 from Doda, 29 from Ramban, 13 from Kishtwar and six from Kashmir besides that 12 from other states. Also,

seven people have died.
As per the data, today 37 dengue cases in two children and 35 adults were reported in J&K.

According to official data, the highest number of 1.837 cases were reported in 2013 but this year, the figure has surpassed the previous one—(KNO)

10 KP Families Migrate From Shopian To Jammu

Jammu: As terrorists carried out a number of targeted killings recently, 10 Kashmiri Pandit families have left their village in Shopian district in south Kashmir out of fear and reached Jammu.

The residents of Choudharygund said the recent terrorist attacks have triggered a fear psychosis among the Pandits who lived in Kashmir through the most difficult period of terrorism in 1990s and did not leave their homes.

Kashmiri Pandit Puran Krishan Bhat was gunned down by terrorists outside his ancestral house in Choudharygund village of Shopian district on October 15. On October 18, Monish



Kumar and Ram Sagar were killed in a grenade attack by terrorists while they were asleep in their rented modation in Shopian.

"Ten families comprising 35 to 40 Kashmiri Pandits have

migrated out of our village due to the fear psychosis," a resident of Choudharygund village who faced a threat recently told PTI.

He said the village was now empty. | More on P10

Facebook's Bitmoji-Style Avatars Now Coming To WhatsApp

🔻 ocial media giant Facebook's Bitmojistyle avatars, which earlier invaded Instagram and Messenger, are now also coming to Whatsapp.

According to The Verge, a report from WABetaInfo suggests that WhatsApp is rolling out support for customizable avatars in the latest 2.22.23.9 beta on Android, but only for some users.

Those with access to the feature will see a new 'Avatar' category in their settings menu that they can use to customise the digital version of themselves.

Similar to Meta's other apps, WhatsApp will then generate a sticker pack with the avatar in various poses, which users can use to express themselves when messaging family and friends.

This feature was first spotted by WABe-

taInfo last month but now it's actually rolling out to users. It's unclear when WhatsApp will roll out the feature to all users on Android, or when it plans on bringing the feature to iOS, reported The Verge.

Meta first introduced avatars on Messenger and the News Feed in 2019 before they became available to use in Facebook comments and stories in 2020.

Earlier this year, the company gave its avatars a new 3D look and started letting users add them to feed posts, Facebook profile pictures, and Instagram Stories.

As per The Verge, at the time, Meta's general manager for avatars and identity, Aigerim Shorman, touted the update as part of Meta's efforts toward building out its idea of the metaverse, which not only includes virtual and augmented reality, but also bridges "more familiar platforms like your phone and computer.'

'Less Than 5 Hours Of Night Sleep Linked To Risk Of Chronic Diseases'

■ leeping for less than five hours in midto-late life is associated with the risk of developing at least two chronic diseases, a UK study has found.

Researchers from the University College London (UCL) in the UK found that people who reported getting five hours of sleep or less at age 50 were 20 per cent more likely to be diagnosed with a chronic disease.

They were also 40 per cent more likely to be diagnosed with two or more chronic diseases over a follow-up period of 25 years, compared to those who slept for up to seven hours.

The study, published in the journal PLOS Medicine, also found that sleeping for five hours or less at the age of 50, 60, and 70 was linked to a 30 per cent to 40 per cent increased risk of multimorbidity, or being diagnosed with two or more chronic diseases, when compared with those who slept for up to seven hours.

"Multimorbidity is on the rise in high income countries and more than half of older adults now have at least two chronic diseases," said study lead author, Severine Sabia. "This is proving to be a major challenge for public health, as multimorbidity is associated with high healthcare service use, hospitalisations and disability," Sabia said. The researchers also found that sleep duration of five hours or less at age 50 was associated with 25 per cent increased risk of mortality over the follow-up period.

This can mainly be explained by the fact that short sleep duration increases the risk of chronic diseases that in turn increase the risk of

"As people get older, their sleep habits and sleep structure change. However, it is recommended to sleep for 7 to 8 hours a night - as sleep durations above or below this have previously been associated with individual chronic diseases," said Sabia.

The researchers examined the relationship between how long each participant slept for, mortality and whether they were multimorbid such as with heart disease, cancer or diabetes over the course of 25 years.

The study analysed the impact of sleep duration on the health of more than 7,000 men and women at the ages of 50, 60 and 70, from the Whitehall II cohort study, which was conducted

from 1985 to 1988 and examined the health of 10,308 civil servants aged 35 to 55, of whom two thirds were men and one third women.

"Our findings show that short sleep duration is also associated with multimorbidity. To ensure a better night's sleep, it is important to promote good sleep hygiene, such as making

sure the bedroom is quiet, dark and a comfortable temperature before sleeping.

"It is also advised to remove electronic devices and avoid large meals before bedtime. Physical activity and exposure to light during the day might also promote good sleep," said Sabia.

As part of the study, researchers also assessed whether sleeping for a long duration, of nine hours or more, affected health outcomes. There was no clear association between long sleep durations at age 50 and multimorbidity in healthy people.

However, if a participant had already been diagnosed with a chronic condition, then long sleep duration was associated with around a 35 per cent increased risk of developing an-

Researchers believe this could be due to underlying health conditions impacting sleep.

The researchers noted that because the data used for the study was self-reported by the participants, it was likely to be subject to reporting bias, even though the findings were confirmed through electronic measurements of the sleep

of 4,000 participants. The research only involved members of the civil service, who were all employed when recruited to the study and likely to be healthier than the general population, they added.

Veteran Kashmiri Leader Molvi **Abbas Ansari Passes Away**

Thousands join funeral prayers at Zadibal

Srinagar: Veteran Kashmiri leader Maulana Muhammad Abbas Ansari passed away after protracted illness on Tuesday morning.

Maulana breathed his last at his residence in Khankhai Sokhta Nawakadal family sources said.

Amid moist eyes, many prominent Shia and Sunni scholars participated in the funeral.

Thousands of people from all walks of life joined his funeral procession from Khanqah e Sokhta, Nawa Kadal to Alamgari Bazar where his funeral prayers were offered. He was laid to rest at Baba Mazar graveyard at Zadibal and his funeral prayers were led by Maulana Abdul Baqi Rizvi.

Popularly known as Molvi Abbas, he was the last surviving politician of the Plebiscite Front era.

An alumni of Najaf seminary, Maulana Abbas founded Anjuman-e- Ittehadul Muslimeen after his return from decade long stay in Iraq in 1962. Molvi Abbas spent years behind bars for his relentless struggle for rights of Kashmiri people.

In 1987 Abbas became founding convener of Muslim United Front (MUF) which changed the political landscape of Kashmir.

After his release from prison he co-founded the All Parties Hurriyat Conference. He led several rounds of talks with New Delhi during Atal Behari Vajpayee era as he was a strong proponent of peaceful settlement of Kashmir dispute. However his differences with Pakistan's approach later led to his ouster from the multiparty combine.

Abbas virtually retired from active political life and was mostly engrossed in spiritual pursuits.

Molvi Abbas has penned scores of books on spiritual aspects of Islam.

His autobiography penned during his jail stay titled "Khare Gulistan" meaning "thorn of garden" was released

WhatsApp Back Online After Global Outage

eta Platforms said it has fixed an issue with its messaging service, WhatsApp, after users across Europe, Asia, and the United Kingdom were not able to use the application for hours.

At around 0750 GMT on Tuesday, outage reporting site Downdetector showed over 68,000 users reporting problems with the app in the United Kingdom. Problems were reported by 19,000 people in Singapore and 15,000 people in South Africa, as well.

"We know people had trouble sending messages on What-sApp today. We have fixed the issue and apologise for any inconvenience," a spokesperson for WhatsApp parent company Meta Platforms said.

The company did not disclose the reason for the outage. WhatsApp has become a critical means of communication for households and businesses. When WhatsApp had an hourslong outage last October, it hit trading of assets from cryptocurrencies to oil, before traders switched to alternative platforms such as Telegram.

WhatsApp's latest outage came during the festive season in India – its biggest market by user count – when people use the platform even more than usual to send season's greetings.

Shares of WhatsApp-parent Meta Platforms fell 0.7 percent to \$128.85 in premarket trading following the outage.

The company had not sent any fresh updates as users in Asia, India and the United Kingdom started seeing some connections come back online.

In Vice-Chancellors Row, Kerala Chief Minister's Stern Warning To Governor

Thiruvananthapuram: Kerala Governor Arif Mohammed Khan's move to seek the resignation of Vice-Chancellors of nine universities has kicked up a huge political storm in the southern state with Chief Minister Pinarayi Vijayan on Monday issuing a stern warning to the Constitutional head asking him not to cross the limits of his powers.

Meanwhile, the ruling LDF announced two-day state-wide protests beginning on Tuesday.

Amid growing tension between the Raj Bhavan and the Left government, Mr Khan, using his powers as the chancellor, issued show-cause notices to Vice-Chancellors of nine universities after they refused to send their resignation letters to him before 11.30 AM on Monday as per his directive on Sunday. The Vice Chancellors have been given time till November 3 to respond.

The "unusual steps" initiated by Mr Khan also led to a legal battle with eight vice-chancellors challenging the chancellor's move in the Kerala High Court.

The high court held a special sitting on Monday evening, despite being a holiday for Diwali and ordered that the vice-chancellors can continue in their respective posts and they can be removed only after following due procedure.

Justice Devan Ramachandran, who heard the urgent plea filed by the eight vice-chancellors, said the communication sent by the Chancellor was not proper.

The court noted that since the chancellor has given time till



November 3 to the vice- chancellors to show cause as to why they should not be ousted, the communication seeking resignation lost its importance.

In their pleas, the VCs told the court that the entire action of the chancellor asking them to resign within 24 hours was illegal, if not malafide.

Mr Khan, in a press conference, justified his actions against the Vice-Chancellors, saying the notices were issued upholding the verdict of the Supreme Court, which has declared as "void ab initio" any appointment as a Vice-Chancellor made on the recommendation of the Search Committee, which is constituted contrary to the provisions of the UGC regulation.

"Now, they have refused to resign. Now formal notices have been issued," Mr Khan said.

The Governor also rejected the allegations of Chief Minister Pinarayi Vijayan that the VCs have been denied natural justice.

"I only suggested an honourable way out. I have not sacked them", the Governor said.

Rishi Sunak Appointed As Britain's First Indian-Origin Prime Minister By King Charles III

LONDON: Rishi Sunak on Tuesday scripted history when he was appointed by King Charles III as Britain's first Indian-origin Prime Minister after being elected unopposed as the new leader of the governing Conservative Party on Diwali.

The 42-year-old former Chancellor of Exchequer, a devout Hindu, is the youngest British prime minister in 210 years.

He is also the first Hindu Prime Minister of Indian heritage in the UK.

Sunak became the ruling Conservatives' new leader on Monday after rival contender Penny Mordaunt failed to secure enough nominations from Tory MPs, and Boris Johnson dramatically aborted a comeback bid.

In his first address as Tory leader soon after the result was declared on Monday, Sunak said his priority would be to bring the country together and said he was "humbled and honoured" to get the "greatest privilege" of his life to give back to the country "I owe so much."

Salman Rushdie Loses Sight In Eye And Use Of One Hand After Knife Attack: Report

New York: Salman Rushdie has lost sight in an eye and his one hand is incapacitated following the brutal knife attack on the acclaimed Mumbai-born author in August, his literary agent said.

Rushdie, who faced Islamist death threats for years after writing "The Satanic Verses" book, was stabbed in the neck and stomach on stage in front of a stunned audience by 24-year-old New Jersey resident Hadi Matar, a US national of Lebanese origin.


The attack on 75-year-old Booker Prize-winning author came as he was getting ready to speak at a literary event at the Chautauqua Institution in Western New York.

Rushdie's wounds "were profound, but he's [also] lost the sight of one eye... He had three serious wounds in his neck. One hand is incapacitated because the nerves in his arm were cut. And he has about 15 more wounds in his chest and torso. So, it was a brutal attack," his literary agent Andrew Wylie told the Spanish-language newspaper El País in an interview.

When asked if Rushdie was still in the hospital, Wylie said he cannot give any information about the celebrated author's whereabouts.

"He's going to live...That's the more important thing," he said. He was asked if the attack on Rushdie so many years after the fatwa was issued against him meant that "we're living at a particularly dangerous time for freedom of expression in the world"

"I think the attack was probably something that Salman



and I have discussed in the past, which was that the principal danger that he faced so many years after the fatwa was imposed is from a random person coming out of nowhere and attacking [him]," Wylie replied.

"So, you can't protect against that because it's totally unexpected and illogical. It was like John Lennon's murder," he said.

India had condemned the "horrific attack" on the celebrated novelist and wished him a speedy recovery.

"India has always stood against violence and extremism. We condemn the horrific attack on Salman Rushdie and we wish him a speedy recovery," External Affairs Ministry Spokesperson Arindam Bagchi said at his weekly media briefing in August.

The attack on Rushdie had triggered global condemnation and an outpouring of support for the author.

Rushdie spent years in hiding after Iran's supreme leader, Ayatollah Ruhollah Khomeini, issued a 'fatwa' in 1989 calling for his death following the publication of his novel 'The Satanic Verses'.

Delhi's Air Quality Turns 'Very Poor' As People Burst Crackers Despite Ban

New Delhi: A large number of high-decibel firecrackers thundered throughout Diwali night on Monday as people in Delhi flouted the ban imposed on these by the city government.

Delhi Environment Minister Gopal Rai last week said bursting firecrackers in the national capital on Diwali will attract a jail term of up to six months and a fine of 200.

Despite the legal deterrent in place, people in many parts of the city, including in south and northwest Delhi, started bursting crackers by dusk. High-intensity firecrackers could be heard going off on the ground or mid-air.

And, as the night progressed the intensity of firecrackers increased breaching permissible decibel limits, prompting some to wonder "if there was any ban at all".

Bursting of firecrackers on Diwali is an age-old tradition, but authorities in Delhi said the decision to restrict it was taken after considering environmental concerns and health hazards associated with it.

Delhi's air quality turned "very poor" on Monday amid an increase in stubble burning, bursting of firecrackers and moderately unfavourable meteorological conditions which allowed the accumulation of pollutants.

However, the 24-hour average air quality index (AQI) of 312 was still the second-best for Diwali in seven years. The city recorded an AQI of 281 on Diwali in 2018.

Earlier in the day, experts feared that if the volume of firecrackers burst goes up again this year, the air quality is likely to dip further.

In case firecrackers are burst like last year, the air quality may plunge to "severe" levels on the night of Diwali itself and continue to remain in the "red" zone for another day, the System of Air Quality and Weather Forecasting and Research (SAFAR) had earlier predicted.

Notwithstanding the ban, people burst firecrackers with impunity in various areas, starting around 6 pm.

In south Delhi's East of Kailash, and neighbouring places like Nehru Place and Moolchand, fire-crackers going off mid-air could be heard in the evening. Some residents burst crackers in their neighbourhood like every year.

In Burari too, many residents burst firecrackers despite widespread dissemination of information about the ban.

Fearing Mob Justice, Thief In Bangladesh Calls Cops On Self

Dhaka: An alleged professional burglar in Bangladesh brought a premature end to his career when he called the police and reported his own crime after an angry mob caught him in the act.

Yasin Khan, 40, broke into a closed grocery store in southern Barisal city early on Wednesday morning to steal goods from the shelves, local police chief Asad uz Zaman said.

"When he finished the job and was about to go out, Khan realised it was not dark anymore and people woke up and started coming to the market," Zaman told AFP Friday.

With an angry crowd gathered, and fearing a violent attack, Khan called the police emergency line to plead for a rescue.

"We went to the shop and brought him out and took him in our custody before the mob



"I have never seen such an incident in my career," the police chief added.

Jhontu Mia, the store owner, told reporters that Khan had stuffed a big bag with valuable items but had been unable to escape the scene. Khan was arrested and sent to jail after admitting to the break-in, the local police station said.

From Schools To Sects — Kashmir Mourns Its 'Patron of Unity'

mong the mourners carrying Aposters and coffin of Kashmir's veteran leader on the regulated stretch of Old Srinagar Tuesday were some sentimental schoolboys.

Those young pallbearers raised faint cries of faith and shed tears in silence for the man whose demise was personal to many of them.

"These schoolchildren are Maulana Muhammad Abbas Ansari's torchbearers," said Mustafa Ali, a teacher from Budgam. "He wasn't merely a political or spiritual leader, but a luminary whose thrust on education uplifted masses and produced some finest professionals."

In a first daytime funeral procession post abrogation of Article 370, the presence of these schoolchildren made the patron's passage a collective bereavement in Kashmir.

As the procession moved from Nawa Kadal towards his resting place at Zadibal under the sharp gaze of police force, oral historian and sociocultural researcher Ilyas Rizvi showed up as a mourner.

"I couldn't stop myself to pay obeisance to a multi-dimensional personality," said Rizvi, following thousands of mourners under the warm October sun. "His educational campaign empowered less privileged masses who were grappling with an unjust system

in the valley."

Maulana's most important role, Ilyas said, was his foundation of a chain of schools named Madina Public Schools.

Those schools have illuminated hundreds of candles in those pockets of Kashmir where poverty and backwardness has kept people in darkness," he

"These schools have changed the educational landscape of vast areas of North and Central Kashmir. The contemporary history of Kashmir is incomplete without a chapter on him."

"Maulana Abbas was the pioneer of Muslim unity in Kashmir who tirelessly worked for the cause of Kashmiri people. He played a crucial role at various stages of Kashmir history in past six decades and his role in contemporary times has been crucial and important. I feel short of words to describe his stature.'

Popularly known as Molvi Abbas, he was the last surviving politician of the Plebiscite Front era.

An alumni of famous Najaf seminary Maulana Abbas founded Anjuman-e- Ittehadul Muslimeen after his return from decade long stay in Iraq in 1962. He rose to a star position during Moi-Muqaddas movement of mid sixties.

In 1987 Molvi Abbas became founding convenor of Muslim United Front (MUF) which changed the political landscape of Kashmir.

He spent years behind bars for his relentless political campaign and penned his autobiography-"Khare Gulistan"as a political prisoner.

After his release from prison he co founded All Parties Hurriyat Conference. He led several rounds of talks with New Delhi during Atal Behari Vaipayee era as he was a strong proponent of peaceful settlement of Kashmir dispute. However his differences with Pakistan's approach later led to his ouster from the multiparty combine by the hardline camp.

Molvi Abbas virtually retired from active political life and was mostly engrossed in spiritual pursuits. He has penned scores of books on spiritual aspects of Islam.

"The demise of Abbas sahab is a tragedy for all Kashmiris regardless of sects," said Maulana Khurshid Ahmad Qanoongu, Imam of Astana Aalya Mirza Kamil Sahab

"Abbas sahib has been a champion of Muslim unity. Despite many ups and downs in his life, he preached the message of Prophet Muhammad [PBUH] and his Ahlulbait [A.S]. His contribution to Kashmir will be remembered for all times to come," said Maulana Mir Mustafa.

As thousands of mourners followed his coffin from Khanqahi Sokhta to Zadibal via Eidgah for funeral prayers, the whole town erupted with elegy for the man who touched countless lives during his lifetime.

The sentimental scene only heaved the emotions of the schoolchildren who collectively gave a tearful farewell to their patron.

End Of Pandemic?

n what has happened for the first time since the advent of the Covid-19 pandemic, Jammu and Kashmir has reported no fresh COVID-19 cases and no death due to the virus in the last 24 hours. There are now just 23 active Covid cases in the union territory. So far 4785 people have succumbed to the virus and among them, 2352 are from the Jammu division and 2433 from the Valley. On an all-India level too, just 1,334 fresh coronavirus infections have been recorded, the lowest in 188 days. The number of active cases has declined to 23,193.

However, this is no reason to let our guard down. The virus is now a part of lives and it has already become endemic. Besides, the new variants of the virus keep triggering fresh outbreaks. For example, India has recently witnessed the emergence of a new Omicron sub-variant XBB, which is expected to be the dominant strain of the COVID-19 virus in India within a month. According to data, there were 71 confirmed cases of XBB-driven COVID-19 infection in India in the beginning of this month, and the number jumped to 235 on October 24.

But the overall trend remains one of a steep decline in the cases. Though there is some cause for optimism here, things could still turn messy if the existing pandemic-related precautions are thrown to the winds. The Omicron wave early this year was gigantic in nature but its fallout was cushioned by the relatively moderate nature of the virus. But the continuously mutating sub-variants of the Omicron virus could in time trigger yet another wave. So people have to continue to take care. It is too soon to abandon the masks or give up the use of sanitizers. The Standard Operating Procedures remain as relevant as they did when the pandemic broke out in early 2020. Meanwhile, we can celebrate our triumph on the Covid pandemic with the least number of Covid cases and fatalities to date.

In Kashmir, there is a greater need for precaution in winter, generally the season of flu. Though zero cases and zero fatalities in the last 24 hours is a heartening development, the situation can stay this way if people don't give up SOPs. Meanwhile, the drastic reduction in Covid cases is a cause for celebration. It is also a boon for tourism which has witnessed a bumper year so far with over one crore people visiting the union territory. We can't afford to let this momentum slow down.

On The Supreme Court Order Against Hate Speech

here is good reason for the Supreme Court of India to ask the police to be proactive in dealing with hate speech by taking immediate legal action without waiting for a formal complaint. The Court has also warned of contempt action if the police showed any hesitation in compliance. Directed at the police in Delhi, Uttar Pradesh and Uttarakhand, the order is in response to the "unending flow of hate speeches" highlighted in a writ petition before it. The Court has referred to the growing "climate of hate", and taken note of the inaction in most instances, despite the law containing provisions to deal with the phenomenon. It is quite apparent that the governments at the Centre and in some like-minded States do not share the Court's concern for communal harmony, fraternity and tranquillity; in fact, some of them may be contributing to the vitiated atmosphere either by studied inaction or complicity in allowing provocative speeches in purported religious gatherings by majoritarian elements. Intervention by the highest court has become necessary in the light of some controversial religious leaders getting away lightly after making unacceptable comments, some of them tinged with a genocidal tenor. It is in such a backdrop that the Court has underscored the constitutional values of secularism and fraternity among all religions and social groups.

It was a religious conclave held in Haridwar late last year that set the tone for the 'hate speech' case that is being heard now. Even then, the Court had called for corrective measures, leading to another conclave being prevented by local authorities in Roorkee in Uttarakhand. While the intervention may have halted a few meetings at that time, it cannot be said that such transgressions have ended. There has been a disconcerting pattern of Hindu festivals becoming an occasion for the conduct of religious processions that end in clashes caused by provocative behaviour. In the name of dealing with the resulting clashes or disturbances, officials have resorted to demolishing the houses of those allegedly involved in the incidents, without following any process of law. Such developments have given rise to new curbs on minorities, such as unwarranted police probes into the holding of group prayers, and new allegations of purported plots to infiltrate Hindu events. Some television channels have been adding to the bigotry by their manner of functioning. Administrative bias on the one hand and the spread of social prejudice on the other cannot be allowed to vitiate the national mood. Towards that end, the Court must do everything possible to nudge authorities to enforce the law against the propagation of hate.

Rishi Sunak Is a New and Old-Fashioned Tory

t is a nice coincidence that Rishi Sunak has won the leadership of the Conservative Party, and hence the prime ministership, on the most important day of Diwali, the "festival of light" celebrated by Hindus, along with Sikhs, Jains and some Buddhists. Diwali supposedly marks the triumph of "light over darkness, good over evil, knowledge over ignorance." It is also associated with wealth and prosperity. In February 2020, Sunak took his oath of office as chancellor of the exchequer holding a copy of the Bhagavad Gita and celebrated Diwali by putting lights outside his official residence at Number 11 Downing Street. He will now be the first Hindu to become UK prime minister. His time in office will hinge on his ability to deliver a reasonable measure of prosperity to a country that is in dire economic straits.

Sunak has a fighting chance of restoring order to the Conservative Party and the UK government. Certainly better than Penny Mordaunt, who dropped out of the race at the very last moment. While popular, she is relatively inexperienced, having only served for a few months in the cabinet as defense secretary. We don't have to recite the resume of Boris Johnson, a one-man wrecking ball. Perfectly turned out in a suit and narrow tie, Sunak cuts a commanding presence compared to Johnson. Fitting the two men into Max Weber's equation, Sunak is "ethic of responsibility" made flesh while Johnson is his "ethic of irresponsibility."

In many ways, Sunak is a completely conventional British prime minister. He was educated at Winchester College (where he was head boy or "Sen. Co. Prae" in the idiosyncratic language of that institution) followed by Lincoln College, Oxford where he read PPE (that is, received a degree in philosophy, politics and economics, the staple subject of aspiring politicians and civil servants). He is inordinately fond of football. If the naughtiest thing that Theresa May did while growing up was to run through a field of wheat, the naughtiest thing that Sunak did as a schoolboy was to smuggle a handheld television into the school so that he did not miss any key Euro 96 matches. On his 18th birthday, he received a card signed by the entire squad of his favorite team, Southampton, a gift that became one of his most prized possessions.

Soon after making his fortune as in the world of finance, he went into parliament in 2014, inheriting one of the safest seats in the country, Richmond, Yorkshire, from a previous Party leader, William Hague. He rose rapidly and smoothly up the ministerial ranks, becoming undersecretary of state for local government in 2018, chief secretary of the treasury in 2019, and chancellor in 2020, a meteoric rise that saw him enter the cabinet just 50 months after winning his seat.

In other ways, starting with his Hindu faith, he is unconventional. He is part of a wave of upwardly mobile ethnic minorities who flooded into the Conservative Party in defiance of the leftwing illusion that non-Whites are natural socialists. (Kwasi Kwarteng, Liz Truss's chancellor, was another example of this phenomenon.) His parents immigrated to Britain from India after a spell in East Africa and made their careers in the health service — his father as a doctor in Southampton, his mother as the owner of a small pharmacy. The fact that Sunak just missed getting a scholarship to Winchester, an expensive as well as an academically demanding private school, meant that the family had to scrimp to afford the fees.

Sunak is more of a global citizen than most of his fellow Tories. He completed his education at Stanford Business School, in the heart of Silicon Valley, where he met his Indian-American wife, Akshata Murthy. He laid the foundations of his personal fortune working for Goldman Sachs Group Inc. in New York before joining a US hedge fund. He loves the American, particularly the Californian, entrepreneurial spirit, and has a house in Santa Monica, Los Angeles.

He is also much richer — indeed, arguably

the richest prime minister since Arthur Balfour whiled away his time in office playing golf on the two golf courses in his estate in Scotland. His wife is the daughter of one of the richest men in India, N.R. Narayana Murthy, one of seven founders of the outsourcing and IT giant, Infosys. He's a plutocrat in a party that has been taken over by the struggling bourgeoisie.

Sunak belongs to the governing Conservative wing that swings wildly between responsible government and irresponsible populism. He's an excellent manager who has received plaudits from the permanent civil service in every department that he's been part of. Tom Scholar — the former permanent secretary of the treasury who Liz Truss sacked in one of the first moves that doomed her premiership — has waxed lyrical about Sunak's abilities as a newly arrived chief secretary of the treasury. He's also a natural technocrat who speaks the same language as technocrats the world over.

This doesn't mean that he's any less of a Tory as some of his critics imagine, including Brexit ideologue Jacob Rees-Mogg who has dubbed Sunak a "socialist." (Rees-Mogg is establishing some kind of record by becoming more ridiculous as he gets older.) Sunak was a Brexiteer when Johnson was still undecided on the subject, regarding Europe as a hidebound backwater in a world that would be increasingly dominated by Asian giants and American dynamism. The incoming prime minister is also a long-standing believer in a small-state and tax cuts. In a budget debate in July 2015, two months after he was first elected to parliament, he declared that "in normal times public spending should not exceed 37% [of gross domestic product]. That is the best estimate of our income as a government and therefore the best guide to what we can afford to spend.

His disagreement with the Tory right was about timing and pragmatism — not about the desirability of allowing money to fructify in the pockets of the people. He favored "a big bazooka" during the Covid epidemic in order to prevent a collapse in demand ("this is not a time for ideology and orthodoxy"); and he opposed Truss's combination of tax cuts and increased public spending because he thought that it would crash the economy.

Sunak, then, is a traditional post-Thatch-

erite Tory whose heart is in the same place as most other Tory MPs but who is also devoted to good government. This combination will go down well with the markets, which want nothing more than stability over the chaos of recent weeks, and with technocrats, in Brussels, Washington and elsewhere, who recognize Sunak as one of their own.

But his ascension threatens to produce serious tensions among the Tories. The Conservative Party contains a dangerous little-England strain. In an interview on radio station LBC that has gone viral, a Tory Party member proclaimed that he was backing Johnson because Sunak is a globalist with Indian roots who doesn't love England the way Johnson does. The fact that Sunak kept his US green card when he was chancellor and that his wife claimed tax exempt status by claiming not to be a UK resident provide little Englanders, on both the left and the right, with powerful ammunition. She has since renounced the status and he has surrendered his American residency.

The Party also contains an even larger populist strain that rails against the rule of technocrats and experts — resents constraints on the popular will, whether they come from judges or bond traders. Both little Englandism and populism have been significantly strengthened by the very Brexit policy that Sunak supported for very different reasons.

Sunak has supporters from across the party from left to right. He also has a taste for order and process. But whether the Conservative Party in its current incarnation — traumatized by Brexit, schooled in rebellion and divided over fundamental principles — can come to heel and behave sensibly is still to be discovered.

eing a Kashmiri, it has been a very disturbing and disappointing trend for me to observe that there is a steady increase in the number of Kashmiri youngsters who are addicted to smoking. Whereas there has been a decreasing predilection towards smoking in Western youth, there seems to be no cessation in the habit of our young generation in Kashmir.

Smoking is a serious health hazard because tobacco contains some 4000 chemicals, 43 of which are known carcinogens. Some of these like nicotine, a poisonous alkaloid, tar and carbon monoxide are well known but acrolein, ammonia, prussic acid and other substances though less known are no less malicious.

Cigarette is a number one cause of lung cancer all over the world and a major culprit in the cancers of larynx, oral cavity, pharynx and oesophagus and is a contributing cause in the development of bladder, pancreas, uterine cervix, kidney, stomach cancers and a number of leukaemias. Cardiovascular disorders including hypertension, strokes and other heart attacks have also been increasingly linked with smoking.

COPD is a dangerous incurable and highly probable disorder associated with this habit. The list of smoking related maladies in an unending listening of debilitating and often fatal complications. Lung cancer and COPD being most formidable and prevalent of the lot will be the focus herein.

LUNG CANCER

Lung cancer is the leading cancer killer around the world. It also is the most tragic in being preventable, since smoking is its number one cause. 87% of all lung cancers are caused by smoking. The two major types of lung cancers are: Small cell cancers and non-small cell cancers. Non-small cell cancer is the most prevalent and spreads slower to different sites in the body than the other type. Squamous cell carcinoma, adenocarcinoma and large cell carcinoma

are the three sub types within this type. Non small cell cancers account for 80% of all lung cancers.

The development of lung cancer is insidious with an interval of upto 30 years, before the onset of a symptomatic disease. There is no apparent threshold in the dose response relationship between exposure to tobacco smoke and incidence of the disease, but higher incidence rates are associated with higher lifetime levels of tobacco consumption and early age of starting the habit. Lung cancer is a passive killer, in its symptoms being rarely felt till the disease

has reached an advanced stage. Overall, lung cancer prognosis is not good. Only about 13% patients survive 5 years after diagnosis of the disease. These low numbers reflect the advanced stage of the most lung cancers. Prognosis for a young patient whose tumour has been surgically removed is much better. However, lack of symptoms and screening procedure means that most tumours are already advanced when detected.

Treatment options depend on the stage

In latter stages of the disease, the heart may be severely affected. Eventually death occurs when the function of the lung and heart is no longer abdicate to deliver, oxygen to the body organs and tissues.

The only effective weapon against COPD is prevention; avoiding or cessation. Avoiding smoking almost always prevents COPD from developing and ceasing smoking slows the disease process. The preventive course of action is thus only hope as COPD is incurable. Smokers

not only jeopardize their health but also expose people around them to unnecessary health hazards by way of passive smoking.

Diet Can Influence Your Mood

uring the long seafaring voyages of the 15th and 16th centuries, a period known as the Age of Discovery, sailexperiencing visions of sublime foods and verdant fields. The discovery that these were nothing more than hallucinations after months at sea was agonizing. Some sailors wept in longing; others threw themselves overboard.

The cure for these harrowing mirages turned out to be not a concoction of complex chemicals, as once suspected, but rather the simple antidote of lemon juice. These sailors suffered from scurvy, a disease caused by a deficiency of vitamin C, an essential micronutrient that people acquire from eating fruits and vegetables.

Vitamin C is important for the production and release of neurotransmitters, the chemical messengers of the brain. In its absence, brain cells do not communicate effectively with one another, which can lead to hallucinations.

As this famous example of early explorers illustrates, there is an intimate connection between food and the brain, one that researchers like me are working to unravel. As a scientist who studies the neuroscience of nutrition at the University of Michigan, I am primarily interested in how components of food and their breakdown products can alter the genetic instructions that control our physiology.

Beyond that, my research is also focused on understanding how food can influence our thoughts, moods and behaviors. While we can't yet prevent or treat brain conditions with diet, researchers like me are learning a great deal about the role that nutrition plays in the everyday brain processes that make us who

Perhaps not surprisingly, a delicate balance of nutrients is key for brain health: Deficiencies or excesses in vitamins, sugars, fats and amino acids can influence brain and behavior in either negative or positive ways.

VITAMINS AND MINERAL DEFICIENCIES

As with vitamin C, deficits in other vitamins and minerals can also precipitate nutritional diseases that adversely impact the brain in humans.



For example, low dietary levels of vitamin B3/niacin - typically found in meat and fish - cause pellagra, a disease in which people develop de-

Niacin is essential to turn food into energy and building blocks, protect the genetic blueprint from environmental damage and control how much of certain gene products are made. In the absence of these critical processes, brain cells, also known as neurons, malfunction and die prematurely, leading to dementia.

In animal models, decreasing or blocking the production of niacin in the brain promotes neuronal damage and cell death. Conversely, enhancing niacin levels has been shown to mitigate the effects of neurodegenerative diseases such as Alzheimer's, Huntington's and Parkinson's, Observational studies in humans suggest that sufficient levels of niacin may protect against these diseases, but the results are still inconclusive.

Interestingly, niacin deficiency caused by consumption of excessive amounts of alcohol can lead to similar effects as those found with

Another example of how a nutrient deficiency affects brain function can be found in the element iodine, which, like niacin, must be acquired from one's diet. Iodine, which is present in seafood and seaweed, is an essential building block for thyroid hormones – signaling molecules that are important for many aspects of human biology, including development, metabolism, appetite and sleep. Low iodine levels prevent the production of adequate amounts of thyroid hormones, impairing these

essential physiological processes. Iodine is particularly important to the developing human brain; before table salt was supplemented with this mineral in the 1920s, iodine de-

ficiency was a major cause of cognitive disability worldwide. The introduction of iodized salt is thought to have contributed to the gradual rise in IQ scores in the past century.

KETOGENIC DIET FOR EPILEPSY

Not all dietary deficiencies are detrimental to the brain. In fact, studies show that people with drug-resistant epilepsy – a condition in which brain cells fire uncontrollably - can reduce the number of seizures by adopting an ultralow-carbohydrate regimen, known as a ketogenic diet, in which 80% to 90% of calories are obtained from fat.

Carbohydrates are the preferred energy source for the body. When

they are not available - either because of fasting or because of a ketogenic diet - cells obtain fuel by breaking down fats into compounds called ketones. Utilization of ketones for energy leads to profound shifts in metabolism and physiology, including the levels of hormones circulating in the body, the amount of neurotransmitters produced by the brain and the types of bacteria living in the gut.

Researchers think that these dietdependent changes, especially the higher production of brain chemicals that can quiet down neurons and decrease levels of inflammatory molecules, may play a role in the ketogenic diet's ability to lower the number of seizures. These changes may also explain the benefits of a ketogenic state - either through diet or fasting - on cognitive function and mood.

SUGAR, SATURATED FATS AND ULTRAPROCESSED FOODS

Excess levels of some nutrients can also have detrimental effects on the brain. In humans and animal models, elevated consumption of refined sugars and saturated fats - a

combination commonly found in ultraprocessed foods - promotes eating by desensitizing the brain to the hormonal signals known to regulate

Interestingly, a diet high in these foods also de sensitizes the taste system, making animals and humans perceive food as less sweet. These sensory alterations may affect food choice as well as the reward we get from food. For example, research shows that people's responses to ice cream in brain areas important for taste and reward are dulled when they eat it every day for two weeks. Some researchers think this decrease in food reward signals may enhance cravings for even more fatty and sugary foods, similar to the way smokers crave cigarettes.

High-fat and processed-food diets are also associated with lower cognitive function and memory in humans and animal models as well as a higher incidence of neurodegenerative diseases. However, researchers still don't know if these effects are due to these foods or to the weight gain and insulin resistance that develop with long-term consumption of these diets.

TIME SCALES

This brings us to a critical aspect of the effect of diet on the brain: time. Some foods can influence brain function and behavior acutely – such as over hours or days – while others take weeks, months or even years to have an effect. For instance, eating a slice of cake rapidly shifts the fatburning, ketogenic metabolism of an individual with drug-resistant epilepsy into a carbohydrate-burning metabolism, increasing the risk of seizures. In contrast, it takes weeks of sugar consumption for taste and the brain's reward pathways to change, and months of vitamin C deficiency to develop scurvy. Finally, when it comes to diseases like Alzheimer's and Parkinson's, risk is influenced by years of dietary exposures in combination with other genetic or lifestyle factors such as smoking.

In the end, the relationship between food and the brain is a bit like the delicate Goldilocks: We need not too little, not too much but just enough of each nutrient.

Genes Link Bipolar Disorder And Schizophrenia, Once Thought Unrelated

hen Chastity Murry had her first psychotic break, she went into her bathroom and downed a whole bottle of pills, hoping to die. Her teenage daughter had to perform CPR to save her life.

Around that same time more than a decade ago, the man who would become her husband, Dante Murry, also lost touch with reality and considered suicide.

Different illnesses led them down similar paths bipolar disorder in her case and schizoaffective disorder in his conditions long considered by many to be distinct and unrelated.

But a growing body of research shows that bipolar disorder, schizophrenia and the in-between diagnosis of schizoaffective disorder share common genetic underpinnings as well as overlapping symptoms and signs.

"They can be considered as part of a spectrum, said Dr. Morgan Sheng, who codirects a psychiatric research center at the Broad Institute of MIT and Harvard.

Bipolar disorder is known for causing extreme mood swings. Schizophrenia is characterized by delusions, hallucinations and disordered thinking. Schizoaffective disorder includes symptoms of both.

The theory that they exist on a continuum has gained ground as more and more studies have found that variations in some of the same genes influence how susceptible people are to these conditions. One of the latest examples is the AKAP11 gene, which scientists at Broad and elsewhere pinpointed as a strong risk factor for bipolar disorder and schizophrenia in research published in the journal Nature Genetics this year.

Experts say these insights will help doctors better understand what drives the illnesses, how they affect the body's most notoriously bewildering organ and what more can be done to help people. Down the road, experts envision the research could help guide treatment and lead to better drugs.

For now, they hope it reinforces the idea that such disorders are biologically rooted and not moral failings or mysterious, unknowable conditions

That's what the science is giving us a clear indication that there are genetic markers and risk factors, said Dr. Ken Duckworth, chief medical officer for the National Alliance on Mental Illness.

The Murrys who met through the alliance and married in 2020 hope the research provides answers for them and so many others with mental illness who they've gotten to know. With they help of doctors and one another, they are keeping their disorders in check and have found purpose helping others in similar straits.

Chastity Murry, 48, called them perfect partners; He's the peanut butter; I'm the jelly. Yes, Dante Murry, 50, added with a smile. She's sweeter than I am.

PASSING DOWN PUZZLING CONDITIONS

Mental illness runs in both of their families haunting hers for at least five generations, she says.

Knowing this helped me to understand why this is happening to me, Chastity Murry said. That possibility was always there.

Sheng said genetics plays a big part in bipolar disorder, schizoaffective disorder and schizophrenia. But experience and environment also play a big part, and these things interact in subtle ways. So it's not like everyone with risk genes is destined to become ill.

Morgan said a severe risk gene for schizophrenia, for example, may increase the chance of getting the disease 10-fold. But that only brings it up to 10%, since the population-wide risk of developing the illness is 1%. Given those odds, parents with the gene might not have any children with the illness. But if you take a whole extended family that has that risk gene, there will be a number of cases popping up, Morgan said. It's a roll of the dice.

Experts say other illnesses along what



some call the psychosis continuum are also more likely. When you look at a family, if you have one person with schizophrenia, you're more likely to have schizophrenia yourself, but you're also more likely to have bipolar, said Dr. Fernando Goes, a psychiatrist at Johns Hopkins University.

The same is true for schizoaffective disorder, studies show.

There are no tests for these conditions which together affect around 9 million U.S. adults so diagnosis is based on history and the sometimes overlapping symptoms. For instance, psychosis can happen in all three illnesses.

This can make diagnosis difficult. Sally Littlefield of Oakland, California, was diagnosed with bipolar disorder, then schizoaffective disorder, after spiraling into psychosis during a work meeting in 2018. For 10 months, she was convinced a team of psychologists had assumed control of her life and were experimenting on her against her will.

At one point during a manic episode, Littlefield wandered the streets of San Francisco, breaking into houses and cars, shoplifting and jumping from one car rooftop to another. She was eventually tackled by police and hospitalized. She came to realize she was ill when her delusions got so grandiose she believed she was president of the United States.

She said she's now doing well and willing to tell her story to help dispel stigma, discrimination and shame, which prevents a lot of us from recovering.

A VERY LONG JOURNEY

People with mental illness hope stigma fades as doctors learn more about how these disorders arise and affect the brain.

A 2019 study said a growing number of experts now recognize that schizophrenia, schizoaffective disorder and bipolar not only share common genetic risk factors and symptoms but also look similar in neuro-imaging and may have common treatment regimens. The mood stabilizer lithium, for example, is often used to treat bipolar and schizoaffective disorder. The recent Broad Institute research may provide clues to how

the drug works, since AKAP11 interacts with what's thought to be lithium's target.

Other drugs also treat more than one of the illnesses. The Murrys take several of the same medications.

Someday, experts said genetic insights might allow doctors to intervene earlier in the disease process. While few people get genetic testing now except perhaps to see how they might react to a particular drug scientists said that could change in the future. If people knew their genetic risk and family history, Sheng said, they could seek help if something didn't seem quite right, before an illness caused major problems.

Some scientists, while acknowledging common genetic underpinnings of bipolar, schizoaffective disorder and schizophrenia, are skeptical about framing them as on a psychosis continuum, particularly if that leads to changing categories doctors use to diagnose people with each disorder. They say the current criteria are useful in deciding treatment and care.

Scientists agree that more research is needed. Finding new illness risk genes, for instance, is only the first step toward developing new medicines. A Broad road map says researchers must also figure out how the genes function, understand disease mechanisms and identify targets for the drugs.

NAMI's Duckworth said it might be 5 to 50 years before genetic findings translate into changes in clinical practice. It's a very long journey.

Meanwhile, many people living with mental illness rely on peer support in addition to medication and psychotherapy. The Murrys check on each other daily.

I can always tell when he's having a bad day. He can always tell when I'm having a bad day, said Chastity Murry, who has also been diagnosed with borderline personality disorder and an anxiety disorder. If I'm acting a little off or something, he'll ask me: Have you taken your meds today? But I don't get offended because I know he's got my best interest in mind.

Anxiety Disorder Has No Effect On Vaccine Hesitancy: Study

Individuals who deal with anxiety are no less hesitant to get the Covid-19 vaccine compared to those without anxiety, according to new research.

The new study led by the University of Waterloo in Canada aimed to investigate the relationship between vaccine hesitancy, psychological factors associated with anxiety, and individuals' reasoning for and against getting the vaccine.

"People with anxiety difficulties were not more hesitant about the vaccine. Rather, the more discomfort they had with uncertainty, the less hesitant they were," said Dr Christine Purdon, professor of Clinical Psychology at Waterloo in a paper published in the Journal of Anxiety Disorders.

"The opposite was true of those without anxiety, suggesting that discomfort with uncertainty may be an important factor when addressing vaccine hesitancy," Purdon added.

To conduct the study, the researchers surveyed 148 participants with and without anxiety disorders. All participants completed an online questionnaire examining Covid-19 vaccine hesitancy along with other related variables such as conspiracy beliefs, individualism, and intolerance of uncertainty.

They also surveyed the top rea-

sons why individuals were motivated to get the vaccine and the top reasons why they were hesitant.

by individualistic worldviews, conspiracy beliefs, and a lack of trust in authority.



The most common reasons that participants were hesitant to get the vaccine were related to the vaccine's effectiveness and novelty, and fear of adverse effects.

In contrast, the most frequent reasons that participants were motivated to get the vaccine were to protect others, to protect self, and to return to a sense of normalcy.

The researchers found that anxious and non-anxious participants did not differ in vaccine hesitancy. However, discomfort with uncertainty predicted greater vaccine hesitancy in non-anxious participants, and in both groups' vaccine hesitancy was predicted

Aliya McNeil, lead author of the study, said that the findings could suggest that people without anxiety disorders are concerned with uncertainty related to the vaccine itself, whereas people with anxiety disorders might view the vaccine as an opportunity to reduce stress and uncertainty related to the virus.

This may indicate that vaccine hesitancy is related to how one values independence.

The researchers hope that their findings will help aid in future research that continues to explore vaccine hesitancy and interventions to promote vaccine uptake.

Starlink Signals Could Work As GPS Alternative: Report

The Starlink constellation is, by far, the largest in history, with almost 3,000 satellites in orbit, and offers enormous potential for worldwide connection.

Recent research asserts that its signals might be processed and utilised to replace conventional GPS, with or without SpaceX's approval.

there is only so much Todd Humphreys and his colleagues at the University of Texas at Austin can learn about the "signal structure" of the Starlink downlink without having access to inside information from the corporation itself, they did uncover a lot of important information, reports TechCrunch.

Satellites must pass their signal down to the ground at some point, and in Starlink's case, it is pretty much a constant stream. That does not mean anyone can tap in, though the signal itself is structured and encoded in a proprietary way that, presumably, SpaceX has decided best for the kind of orbital broadband it's providing, the report said.

The exact parameters of this signal are not known, but to make sure packets are arriving in order and intact, the transmission -- like any data transmission these days -- includes very precise timing data and other telemetry so the receiver

and sender can stay in sync. By carefully analysing an incoming signal from a single satellite and combining that data with what is known about the satellite's exact position, the time down to the nanosecond, and so on, Humphreys was able to decode the transmission to a certain extent.

Markets Halt 7-Day Rally On Profit-Booking

MUMBAI: Equity benchmarks nursed losses on Tuesday as investors booked profits after a seven-session rally amid weak Asian market cues and foreign fund outflows.

The 30-share BSE Sensex failed to hold on the early gains and declined 287.70 points or 0.48 per cent to finish at 59,543.96. During the day, it hit a low of 59,489.02 and a high of 60,081.24. On similar lines, the broader NSE Nifty fell 74.40 points or 0.42 per cent to end at 17,656.35.

Nestle India was the top loser in the Sensex pack, slipping 2.83 per cent, followed by Hindustan Unilever, Bajaj Finserv, Kotak Mahindra Bank, HDFC, Reliance Industries, Bajaj Finance and Asian Paints.

Market heavyweight Reliance Industries was the biggest drag on the benchmark following lacklustre Q2 results. In contrast, Tech Mahindra, Maruti, Larsen & Toubro, Dr Reddy's, SBI, NTPC and M&M were among the winners, climbing as much as 3.29 per cent.

"The domestic market pared its early gains with FMCG and private banks pressuring the benchmark. Market attention has shifted to central bank policy announcements since the European Central Bank is expected to hike interest rates at its upcoming policy meeting.

States Borrowing Cost Again Rises Sharply

MUMBAI: After falling last week, the marketfunding cost for the states continues to head north, with the latest auction seeing the average cut-off rate or yield jumping by as much as 12 bps to 7.84 per cent, but for the Centre, it remained flat.

After rising for four weeks in a row, the average price that the states pay to their debt investors fell by 11 bps to 7.72 per cent at the auctions

The weighted average cut-off rose by 12 bps to 7.84 per cent from 7.72 per cent in the last auction, with a rise in weighted average tenor to 13 years from 12 years, Aditi Nayar, the chief economist at rating agency Icra said in a note.

As against this, the benchmark 10-year G-sec yield only inched by 1 bps to 7.44 per cent, while the weighted average cut-off of the 10-year state bond jumped 10 bps to 7.83 per cent. Accordingly, the spread between the weighted average cut-off of 10-year state debt and the 10-year Gsec yield increased to 39 bps from 30 bps.

Tuesday's auction was the first so far this fiscal wherein the states borrowed more than what was notified in the quarterly auction calendar, as 14 states have drawn down Rs 25,200 crore, which is 3 per cent more than indicated (Rs 24,500 crore) in the auction calendar. This auction was also the second largest this fiscal.

Apple Urges Global Supply Chain To Decarbonise By 2030

As the impacts of climate change are increasingly felt, Apple also announced new initiatives and investments aimed at helping decarbonise the global economy and promote climate solutions for communities.

Sebi Fines 6 Entities In Deutsche Mutual Fund Front-Running Case

NEW DELHI: Capital markets regulator Sebi has imposed penalties totalling Rs 15 lakh on six entities in a case pertaining to front-running the trades of Deutsche Mutual Fund, which is now known as DHFL Pramerica Mutual Fund.

Those penalised by Sebi are -- Kanchan Jena, Hemlata Dei Jena, Malati Lata Jena, Jayant Chhaparia, Abhishek Chhaparia and Progressive Share Brokers.

They have been directed to pay the fine within 45 days, according to two separate orders passed by Securities and Board of India (Sebi) on Friday.

Sebi found that the Fund Manager (FM) of Deutsche Mutual Fund (DMF) and his parents had employed a scheme to 'front run' the orders of the DMF and also were involved in every step that led to the fruition of the scheme, from the beginning till the withdrawal of the wrongful gain of the front running

However, three sisters -- Kanchan Jena, Hemlata Dei Jena, Malati Lata Jena -- Jayant Chhaparia, Abhishek Chhaparia facilitated them in executing front-running trades during the investigation period from September 2014 and May 2015.

ESIC Scheme Adds 14.62 Lakh New Members In August

NEW DELHI: Around 14.62 lakh new members joined the ESIC-run social security scheme in August 2022, according to official data released on Tuesday.

The latest data is part of a report -- Payroll Reporting in India: An Employment Perspective - August 2022 -- released by the National Statistical Office (NSO).

It showed that the gross new enrolments with Employees' State Insurance Corporation (ESIC) rose to 1.49 crore in 2021-22, from 1.15 crore in 2020-21. It was 1.51 crore in 2019-20 and 1.49 crore in 2018-19.

From September 2017 to March 2018, around 83.35 lakh new subscribers joined the ESIC scheme.

The report said gross new enrolments with ESIC from September 2017 to August 2022 were 7.22 crore.

The NSO report is based on the payroll data of new subscribers of various social security schemes run by ESIC, the Employees' Provident Fund Organisation (EPFO) and the Pension Fund Regulatory and Development Authority (PFRDA).

According to the report, net new enrolments with retirement fund body EPFO stood at 16.94 lakh in August 2022.

Delhi's Post-Diwali Air 'Very Poor' But Best Since 2015

New Delhi: Delhi recorded "very poor" air quality on Tuesday after residents flouted the ban on firecrackers in many parts of the capital on Diwali night, but the pollution levels for the next day were the lowest since 2015 thanks to favourable meteorological conditions that diluted the effect of the fireworks and stubble burning.

However, the neighbouring cities of Ghaziabad (266), Noida (299), Greater Noida (272), Gurugram (292) and Faridabad (289) reported "poor"

An air quality index (AQI) between zero and 50 is considered "good", 51 and 100 "satisfactory", 101 and 200 "moderate", 201 and 300 "poor", 301 and 400 "very poor", and 401 and 500

The firecracker emissions pushed the PM2.5 concentration at most places in the capital over 550 micrograms per cubic metre by 1 am. However, the PM2.5 levels dropped below 150 micrograms per cubic metre by 4 pm due to warm and windier conditions, which are favourable for the dispersion of pollutants.

PM2.5 are fine particles that are 2.5 microns or less in diameter and can travel deep into the respiratory tract, reaching the lungs and entering the bloodstream.

Delhi recorded an AQI of 310 at 11 pm on Monday. It increased to 326 by 6 am on Tuesday, remained stable till 9

am and started decreasing thereafter. The 24-hour average AQI at 4 pm stood at 303, the lowest for the day after Diwali since 2015, when the Central Pollution Control Board (CPCB)

started maintaining air quality data. Delhi's AQI on the day after Diwali stood at 360 in 2015, 445 in 2016, 403 in 2017, 390 in 2018, 368 in 2019, 435 in 2020 and 462 in 2021.



Since Diwali was observed early in the season this year, moderately warm and windier conditions prevented rapid accumulation of pollutants from firecrackers bursting and reduced the effect of stubble burning.

Diwali was celebrated on November 4 in 2021 and on November 14 in 2020, when the temperatures were considerably low and the winds calm.

"Early Diwali, with slightly better meteorological conditions and comparatively lower fire counts, had a lower pollution base compared to the last few years," Sunil Dahiya, an analyst at the Centre for Research on Energy and Clean Air (CREA), said.

"Bursting of firecrackers led to a sharp increase in the air pollution with the PM2.5 concentration, on an average, jumping to 540 micrograms per

cubic metre across Delhi by 12:30 am. Several monitoring stations in the capital recorded PM2.5 levels above 950 micrograms per cubic metre between 10 pm and 1 am," Dahiya told PTI.

Meanwhile, Chief Minister Arvind Kejriwal said the results of the residents' efforts to curb pollution in the city are encouraging, but there is still a long way to go.

"Delhiites are working hard to curb pollution. The results have been very encouraging but there is still a long way to go. We will make Delhi the best city in the world," Kejriwal said in a tweet in Hindi.

Environment Minister Gopal Rai said the city saw fewer incidents of firecracker bursting this year and consequently, the air pollution levels dropped by around 30 per cent.

"The people of Delhi were very thoughtful on Diwali this year and I want to thank them. Today, the pollution level is the lowest in five years," Rai told reporters.

The Aam Aadmi Party (AAP) government last month announced a complete ban on the production, sale and use of all types of firecrackers till January 1, including on Diwali, a practice it has been following for the last

Rai had earlier said bursting of firecrackers in Delhi will attract a jail term of up to six months and a fine of Rs

He had said production, storage and sale of firecrackers will be punishable with a fine of up to Rs 5,000 and three years in jail under section 9B of the

A total of 408 teams have been formed to implement the ban. The Delhi Police has set up 210 teams under assistant commissioners of police, the Department of Revenue has set up 165 teams and the Delhi Pollution Control Committee (DPCC) has constituted 33 teams.

The Delhi Police has reported 23 infractions of the ban on bursting of firecrackers and 150 violations of the ban on the sale of fireworks since October

V K Soni, the head of the India Meteorological Department's **Environment Monitoring and Research** Centre, said: "The people of Delhi need to be applauded as firecrackers bursting and vehicular traffic were less as compared to the previous years."

The better AQI this year can be attributed to a proactive implementation of measures under the second stage of the Graded Response Action Plan (GRAP) three days ahead of Diwali, he added.

Earlier, the authorities would implement the measures only after the PM2.5 and PM10 concentration touched a particular threshold.

Also, fewer instances of burn in-

juries were reported in the hospitals than in 2021.

Doctors, however, warned that it is too early to reach a definitive conclusion about the prevalence of respiratory illnesses post-Diwali since people tend to come to hospitals only when their condition worsens.

Experts and forecasting agencies said the number of farm fires in Punjab and Haryana has increased but their contribution to pollution on Diwali remained low.

"Farm fires raged across Punjab and

Haryana on Monday but the wind direction changed to south westerly. which is unfavourable for the transport of smoke. Hence, the contribution of stubble burning to Delhi's pollution (five to eight per cent) was also not very significant," said Gufran Beig, chair professor, National Institute of Advanced Studies, Indian Institute of

Dahiya said stubble burning in Punjab and Haryana peaks only in October-end and November and hence, its contribution to air pollution on Diwali was not very significant. However, it is likely to rise sharply in the upcoming days.

Emissions from firecrackers and farm fires have contributed significantly to Delhi's PM2.5 pollution on Diwali over the years.

The share of farm fires in Delhi's PM2.5 pollution was 25 per cent on Diwali in 2021, 32 per cent in 2020 and 19 per cent in 2019.

According to the Early Warning System of the Indian Institute of Tropical Meteorology (IITM), the air quality is forecast to remain in the "very poor" category on Tuesday and is likely to improve slightly over the next two days.

Delhi recorded a 24-hour average AQI of 312 at 4 pm on Monday -- the second best for Diwali in seven years. The city had recorded an AQI of 281 on Diwali in 2018.

Delhi had recorded an AQI of 382 on Diwali last year, 414 in 2020, 337 in 2019, 319 in 2017, and 431 in 2016, according to the CPCB.

On Sunday evening, the city reported a 24-hour average AQI of 259, which was the lowest for Diwali eve in seven years.

The Indian Agricultural Research Institute reported 1,019 farm fires in Punjab, 250 in Haryana and 215 in Uttar Pradesh on Monday evening.

CBI Files Chargesheet Against 12 In Bengal Teacher Recruitment Scam

Kolkata: The CBI named 12 people, including former chairman of West Bengal Central School Service Commission (WBCSSC) Subiresh Bhattacharya, in a charge-sheet filed at a court here on Tuesday in connection with its probe into alleged illegal appointment of assistant

The Central Bureau of Investigation (CBI) also named an ex-advisor, a former assistant secretary of the WBCSSC, two former programme officers of the commission and six others in the charge-sheet submitted to special judge, Alipore, an official of the CBI said.

"It was found that the accused, including public servants and private persons, entered into conspiracy with one another in order to extend to unqualified candidates undue appointments to the post of assistant teacher for Classes IX and X in secondary and higher secondary schools in West Bengal in 2016, after the expiry of that year's panel," he added.

Of the 12 named in the chargesheet, six of them -- the former chairman, ex-advisor, and then assistant secretary of WBCSSC, then president of an adhoc committee of West Bengal Board of Secondary Education,



and two private persons -- are presently in judicial custody.

"Further investigation is underway to find out if there was a larger conspiracy involved and also the role played by each of the accused," the CBI official said. Earlier, the central agency

had filed another chargesheet at a court naming 16 people as accused in the case.

The Calcutta High Court has directed the CBI to look into the alleged irregularities involved in the recruitment of Group-C and D staff as well as teachers in government-sponsored and -aided schools on recommendations of the commission. The Enforcement Directorate (ED) is tracking the money trail in the scam.

The ED has so far arrested former chairman of West Bengal **Board of Primary Education and** Trinamool Congress MLA Manik Bhattacharya, former Bengal minister Partha Chatteriee and his alleged close associate Arpita Mukherjee in the case.

India, China Should Seek Common Ground For Development And Resolve Differences Through Dialogue: Chinese Envoy

New Delhi: As neighbours, it is natural for China and India to have some differences but the focus should be to seek common ground for development while resolving the pending issues through dialogue, outgoing Chinese Ambassador Sun Weidong said on Tuesday.

His comments came at the end of his little over three-year tenure that saw the ties between India and China coming under severe strain following the Galwan Valley clashes on June 15, 2020, which marked the most serious military conflicts between the two nu armed neighbours.

"China and India are important neighbours to each other. It is only natural for China and India having some differences. The key is how to handle the differences," Sun said in his farewell remarks.

"We should be aware that the common interests of the two countries are greater than differences. Meanwhile the two sides should strive to manage and resolve differences. and look for a proper solution through dialogue and consultation, instead of defining China-India relations by differences," he said.

"If the Western theory of geopolitics is applied to the China-India relationship, then major neighbouring countries like us will inevitably view each other as threats and rivals. Consequently, competition and confrontation will be the main mode of interaction, and zerosum game will be inevitable

"But the reality is that geographical proximity is an objective existence. It should be an opportunity for us to have more interaction and cooperation, tap our potential and learn from and complement each other," the ambassador said.

The ambassador mentioned three specific dimensions of the Sino-India ties, emphasising on enhancing mutually beneficial cooperation be-

tween the two sides. "We should enhance communication and cooperation. China and India have established dialogue mechanisms in various levels and departments. We should make full use of all the communication channels, deepen mutual understanding in order to avoid misunderstanding and miscalculation," he said.

Lumpy skin disease: J&K sets Nov 5 deadline for inoculation of cattle

Jammu: The Jammu and Kashmir administration on Tuesday set a deadline of November 5 for completing vaccination of all eligible cattle against lumpy skin disease (LSD) in all districts of the Union territory, officials said.

No LSD case has been reported in several districts of Jammu division since last week, they said.

Additional Chief Secretary (ACS), Agriculture Production Department, Atal Dulloo, on Tuesday reviewed status of LSD vaccination in all districts, and directed the staff to expedite the vaccination process, the officials said. Reviewing district wise data,

the ACS underlined that the rate of infection and mortality is higher in Kashmir division and immediate measures should be taken for its containment. Dulloo directed the officials

to ensure availability of vac-

cines in both the divisions in sufficient quantity to meet the requirement. He also directed to constitute


