

ZOMBIE WORLDS

Mystery Behind Five Spooky Planets Orbiting Dead Stars

The Conversation

Il stars, including the Sun, have a finite lifetime.
Stars shine by the process of nuclear fusion in which lighter atoms, such as hydrogen, fuse together to create heavier ones. This process releases vast quantities of energy which counteracts the ever-present inward pull of the star's gravity. Ultimately, fusion helps stars to resist gravitational collapse.

This balance of forces is called "hydrostatic equilibrium". However, there will come a time when the supply of fuel in the core of a star starts to run out and it eventually dies.

Stars with more than about eight times the mass of the Sun will typically burn through their fuel in less than 100 million years. Once fusion ceases, the star collapses – generating a massive instantaneous final burst of nuclear fusion which causes the star to explode as a supernova.

Supernovas release enough energy to outshine the entire galaxy in which they occur. What's left afterwards are collapsed, dead stellar cores called neutron stars or, if the progenitor star was massive enough, a black hole.

Any planets orbiting a star when it goes supernova

would be obliterated. Mysteriously though, a handful of

"zombie planets" have been detected orbiting neutron stars.
And they are some of the weirdest worlds in the cosmos.

Neutron stars are extremely dense, containing as much mass as the Sun squashed into a sphere only a few miles across. Some neutron stars emit beams of radio waves into space – and it is around these "pulsar" stars that planets

have been found.

As the pulsar spins, its radio beams sweep through space generating regular radio flashes. Pulsars were discovered in 1967 – you can listen to the sounds of the radio

emission from some of them here.

The regularity of these radio pulses make pulsars ideal for hunting nearby planets. If a pulsar has a planet, they will both orbit a shared gravitational centre. This means the radio emission will be periodically stretched and compressed in a predictable fashion – allowing us to detect the planet.

Phobetor, Draugr and Poltergeist

Some 2,300 light years from Earth lies the pulsar PSR B1257+12. It flashes 161 times per second and has been nicknamed "Lich" after an undead creature in western folklore. It is orbited by three rocky, terrestrial planets named Phobetor, Draugr and Poltergeist.

These planets hold a special place in the history of astronomy, as they were the first beyond our Solar System (exoplanets) to be discovered back in 1991. A few years ago, NASA released this "zombie worlds" poster of them:

Their discovery challenged ideas about planetary formation, which normally takes place as a new star forms. In contrast, these planets must have formed after the dying star's supernova.

It is not yet known with certainty how this happened. Material in a disk of debris orbiting the pulsar may have coalesced into planets after the supernova.

Draugr, named after an undead creature in Norse mythology, is the innermost of the three. It has about twice the mass of the Moon and is the least-massive planet currently known, orbiting Lich every 25 days. Its larger cousins, Poltergeist and Phobetor, orbit every 67 and 98 days respectively, and are each about four times the mass of Earth.

Pulsars have powerful magnetic fields which may allow electric currents to arc through space between the pulsar and an orbiting planet. So if any of these planets have atmospheres, they might constantly be bathed in the unearthly light of powerful aurora (similar to our northern lights).

If you were to stand on the surface of one of these zombie worlds, you would see, through the powerful hue of the aurora, the incandescent Lich in the sky projecting two powerful and tightly confined beams of light outwards in opposite directions into the blackness of space.



members of the community after proper verification.

Vigilance investigations revealed that the officers named m the case, in collusion with four private persons (who have asked been charge sheeted had manipulated records to show that Rs 14,80,940 had been distributed among 652 members of the Gujjjar and bakarwaal community.

Sixty-two persons among the supposed beneficiaries se-lected at random by the VO, denied having recieved any relief, and the finger impressions on acquitance rolls did not tally with the fingerprints. Expert established that thumb impressions supposed to be the marks of 181 different recipients were in fact the thumbprints of only a few people repeated over and over on the rolls. The VO also found that recepients who were shown belonging to the Udhampur and Rajoun districts were only fictitious names and that Rs 3,75,090 were deposited with Reshi Gas Agency lather than going to a sufferer. Having prima-facie established the officers' involve¬ment

in the fraud; the VO has pressed charges against them under relevant laws before the special anti-corruption court in Srinagar.

Catalyst For Peace

he regional security summit of sixteen Asian nations at Almaty, Kazakhstan, ended at a very somber note after leaders of two important countries of the region refused to meet. In the wake of December 13 terrorist attacks outside the Parliament House at New Delhi the tension between India and Pakistan touched dangerous heights. More than a million soldiers armed to teeth supported by war machinery are facing each other eyeball to eyeball for over six months now. In many areas along the Line of Actual Control the two sides have been exchanging fire. Many an innocent lives have been consumed by mortars and shells along this dividing Line . The war hysteria is at its peak in the two countries and there are possibilities of war breaking out between the two hostile nuclear neighbours any time and any moment.

With the two countries poised for a war, the Almaty summit meet had provided the Asian leaders an opportunity to iron out there differences and define broader parameters for a dialogue. Hopes of Indian Prime Minister Atal Bihari Vajpayee meeting Pakistan President General Pervez Musharraf were belied after Prime Minister Vajpayee publicly refused meeting Pakistan President. The two leaders despite attending the same summit failed even to exchange greetings. The stubborn attitude of leaders of the two countries has disappointed the international community. Russian President Vladimir Putin despite making all out efforts to make the two leaders of the South Asian region to talk to each other miserably failed. He exhausted all his diplomatic skills after Indian Prime Minister refused to enter into any sort of dialogue with his neighbour. The Russian President compared the prevailing situation to Cuban missile crisis of early fifties when US and Ex Soviet Union returned from the brink and resolved the most crucial issue through dialogue. There can be no denying that India and Pakistan are sitting on an active volcano, which can explode any time and bring about unimaginable devastation. The statistics published in a New Delhi weekly suggests that Pakistan has 25-50 nuclear bombs against India's 75-100. Both have very capable delivery systems. The bombs of both the countries are capable of bringing about mass destruction. The effects of a nuclear war can be far more devastating than the human mind can think off. In these wars there are no winners but only losers. The great loser is the humanity.

It is unfortunate that BJP Government has shut doors of its mind to suggestions even from Indias trusted friends. True, the United States has not been a friend of India and its offering hand of friendship at this juncture can also not be without asking for a pound of flesh. But Russia is a time tested and trusted friend. It has stood on Indian side during the most critical times. India should have welcomed the Russian Presidents offer of mediation. It is naive of Indian leadership to reject third party mediation for resolving the dispute which has remained unresolved for more than half a century now and cause of constant friction between the two. Mediations work as catalyst for bringing about lasting peace and helping in resolving most complex issues. Instead of remaining prisoner of acrimonious past with Pakistan there is need for writing a new chapter of peace and prosperity in the South Asian region.

Is Your Child Safe Within Your Safety?

hen a mirror is presented to an individual or a society to contemplate and redress the bruises and scars veiling its face, the reaction is usually one of denial and blaming the mirror. The analogy best depicts the scenario of child abuse in Kashmir and the popular reaction to it. Despite all evidences to the contrary, people still claim Edenic innocence and challenge all the qualitative and quantitative indicators pointing to the rise and pervasion of child abuse in our society. This mode of denial in unison with lack of awareness on the intricacies of child abuse has only aggravated the problem and made its solution an inaccessible path. The lack of agencies dedicated to this cause of elimination of child abuse, the legal illiteracy, the innocence of children to recognise what is happening to them and their inability to report the same have all deepened and complicated the issue of child abuse. The present article attempts to delineate the contours of child abuse and the possible mitigation measures that can be of help in neutralising and checking the malice.

Child abuse is an umbrella term and is used to define physical, sexual and psychological maltreatment of a child or children, especially by a parent or a caregiver. A WHO report suggests that nearly 3 in 4 children - or 300 million children - aged 2-4 years regularly suffer physical punishment and/or psychological violence at the hands of parents and caregivers. One in 5 women and 1 in 13 men report having been sexually abused as a child aged 0-17 years. 120 million girls and young women under 20 years of age have suffered some form of forced sexual contact. The dimensions of child abuse has each its subtleties, complications, complexities and a host of resolution challenges associated with it. For the fact that sexual abuse presents a salience of its own and has long term traumatizing affects, goes largely unnoticed and has consequences outscoring those of any other form of child abuse, the same has been deemed important for the present article. The abuse of children has been a phenomenon quite common in history, across geographic and class divide. "Throughout history, violence against children has been manifested in every conceivable form: physically, emotionally, sexual exploitation, cruel labour. Esteem for children has been slow to appear in his-



tory. In the 17th century, there was a shift from communal to family groups, and the child gradually achieved a place of honour in the family. Generally, protective services have consisted of institutionalizing children or placing them in foster care. In spite of good intentions, children have suffered physical and psychological damage under this system. Increasingly laws have been enacted to limit the rights of the father to manage his children as he wills", writes S X Rabdill. Children are vulnerable and are left to the whims of elders/ parents/caretakers and this vulnerability and inability to understand what is happening to them leaves them shield-less against the myriad forms of violence they are exposed to.

The cases of sexual violence and abuse against the children have been on the rise and apart from statistical testimonials certifying the same, the undocumented, unreported and unrecorded horrendous stories of sexual offences against the children strike our ears regularly and with increasing frequency. The gruesome and challenging aspect of the problem has been that parents, teachers and instructors have been found perpetrating sexual offence against the children, thereby making the problem too entangled and sensitive, defying the traditional remedial approaches.

At the individual level, perpetrators of child sexual abuse have poorly developed socio-emotional skills, attitudinal and cognitive distortions, and possess similar attributes to sex offenders against adult women, namely a sense of sexual entitlement, empathy deficits, a construction of masculinity emphasizing sexual performance and dominance, and a history of childhood victimisation. At the institutional level, such as in

schools and religious institutions, child sexual abuse is more likely to be perpetrated, concealed, and to continue when there is a rigid power hierarchy, a culture of silence protecting the institution's reputation, and an absence of protective regulatory mechanisms including robust organizational policy, employee screening, codes of conduct, incident reporting processes, and staff education. At the societal level, child sexual abuse is enabled when children's rights are not recognized, laws and policies do not prohibit and prosecute sexual offending, social norms against sexual violence are weak, gender inequality persists, constructions of masculinity emphasize aggression and sexual dominance, there is ignorance about sex and sexual violence, and opinion leaders in social institutions lack the will to act. We need to get out of the "culture of denial" and shun the assumption that bad things can happen only to other people's children. It is also needed to understand that it is not always the outsiders who can harm our child's physical, social and emotional health. Family members and close relatives can also do the same. n a world where the millennial generation (26-41 years) accounts for around thirty per cent of the global population as of 2020, is the notion of a per-

ceivably "lost" generation, a paradox? Having faced multiple economic headwinds in the job market, be it a recession or the pandemic, millennials seem to have moved away from conventional lifestyles, particularly in North America and in developing South Asian countries like China and India. Imagining Band'pur Through Geography

and'pur is a small town in the northern part of Kashmir valley, and it is a two hours drive from Srinagar. It is looked over by beautiful mountain peaks on its east and north. From south and west, Wullar lake holds it in its arms.

It is said that Band'pur is "the cradle" of knowledge, hospitality and water. However, that is a thing of the past and people who still believe this is the case are being delusional. There are multiple reasons for arguing that it is out of date to think that it continues to be the land of knowledge, hospitality and water. Geographical, political and historical reasons are all together at play here to work to the disadvantage of this place.

Let's take an imagined journey through Band'pur and an eagle's eye view, with geography taking precedence over other factors.

Locating Band'pur in Kashmir valley is similar to finding Kashmir valley in South Asia. Jehlum drains Kashmir Valley, hence a part of the Indus Basin. The Basin's mouth is at Karachi, which merges with the Arabian Sea. The Kashmir valley is in the North-East if we look at it from Karachi. Moreover, Kashmir valley would have been just another extension to the plains of Punjab if Pirpanjal mountain range had not divided it. Therefore, Kashmir valley is a trans-Pirpanjal depression in the Himalayas that only connects to mainland India and Pakistan through a couple of passes in mountain ranges. This premise gives us an idea of how the valley of Kashmir is geographically isolated, which plays an essential part in providing a distinct identity to Kashmir and its people culturally, socially and, more importantly, economically.

Looking at the map of Kash-



mir valley, Band'pur falls in the same North-East, albeit the valley. Zooming down onto the Band'pur town, Wullar lake holds it on the west and south. Drawing a parallel with how the Valley of Kashmir is situated in the subcontinent

Band'pur town in Kashmir Valley follows the same geographic pattern. Therefore, Band'pur can also be identified as a trans-Wullar landmass.

For admirers of beauty, it may be beautiful and idyllic; however, Band'pur has a disadvantageous relief that hinders the holistic prosperity of the area. As pointed out at the start, it is confined by mountains in the North and East. Undeniably then, Band'pur is sandwiched between the foothills of the Himalayas and the Wullar lake.

Band'pur has only two 'openings' (routes leading to Band'pur)

because one other major route stopped functioning after the ceasefire line divided the erstwhile princely state of Jammu and Kashmir. Band'pur used to connect Kashmir valley to Gilgit-Baltistan through Burzil Pass and, therefore, used to be a vital trading part of the route connecting Kashmir Val-

ley to Central Asia. Now, if we compare Band'pur skeletally to its adjoining towns like Sopar and Sumbal, one observes that both the towns tend to have a structure like a spider web while Band'pur is more linear. In other words, Band'pur has less connectivity with other parts of the valley.

Picking up from what we discussed above, Band'pur is prone to receive less economic attention from people living in Band'pur and those residing outside Band'pur. Due to the amount of risk involved, there are fewer investments by people in business and entrepreneurs, which hinders the creation of new economic opportunities. People from the town and adjoining areas generally go to Srinagar and Sopar for economic opportunities and to spread their businesses.

Furthermore, and more importantly, the point to argue here is that since there is almost negligible capital in Band'pur, it lacks stateof-the-art infrastructure. The most crucial being schools. If Band'pur is "the cradle" of knowledge, where are the schools that impart education of the highest quality? Education in modern times can not only thrive on imparting it in traditional classrooms. Even if there may be new schools, the geographical jinx may not allow them to get on par with the best in the valley. The other argument may be that building a private school with state-of-the-art infrastructure requires enormous investment. Since there is no capital, who will take the initiative?

These are some musings on Band'pur — an aerial view — a scattered rambling; a well-meaning one at that. More soon.

History Behind 'House of the Dragon'

In three decades of teaching medieval European history, I've noticed my students are especially curious about the intersection of the stories told in class and the depictions of the Middle Ages they see in movies and television.

Judged by their historical accuracy, cinematic portrayals are a mixed bag.

However, popular fantasy, unencumbered by the competing priority of "getting it right," can, in broad strokes, reflect the values of the medieval society that inspires it.

"House of the Dragon" is one of those TV shows. A king, lacking a male heir to his throne, elevates his teenage daughter to be his named successor, and a complex dynastic drama ensues.

This storyline reflects the real obstacles facing women who aspired to exercise royal authority in medieval society.

THE QUEEN AS A CONDUIT TO POWER

George R. R. Martin, whose novels were the foundation for the HBO series "Game of Thrones," has made no secret of his inspiration for "House of the Dragon": the Anarchy, a two-decade period, from 1135 to 1154, when a man and a woman vied with each other for the English throne.

The story went like this: Henry I sired two dozen or more children out of wedlock. But with his queen, Matilda, he had only a daughter, the future "Empress" Matilda, and a son, William. With William's birth, the foremost responsibility of medieval queenship was fulfilled: There would be a male heir.

Then tragedy struck. In 1120, a drunken 17-year-old William attempted a night-time channel crossing. When his also-ine-briated helmsmen hit a rock, the prince drowned.

The queen had died two years earlier, so Henry I remarried – Adeliza of Louvain – but they had no children together. The cradle sat empty and the sands in Henry I's hourglass ran low, so he resolved that his lone legitimate child, Matilda, would have the throne as a ruling queen.

The move was unprecedented in medieval England. A queen could exert influence in her husband's physical absence or when, after a king's death, their son was a minor. Her role, moreover, as an intimate confidant and counselor could be consequential.

But a queen was not expected to swing a sword or lead troops into battle and forge the personal loyalties on which kingship rested, to say nothing of the misogyny inherent to medieval English society. The queen was the conduit through which power was transferred by marriage and childbirth, not its exclusive wielder.

A similar scenario drives the plot of "House of the Dragon." The absolute preference in the fictional kingdom Westeros for a male ruler is expressed in the series' opening scene.

The old king, having outlived his sons, empowers a council of nobles to choose his successor between two of his grand-children, the cousins Rhaenys and Viserys. Rhaenys, a female, is the older of the two.

Yet the male Viserys becomes king and Rhaenys, "the queen who never was," later ruefully concedes that this represented "the order of things."

Once installed, however, Westeros' new king would have understood the plight of England's Henry I.

Aemma, Viserys' queen, suffers still-births and miscarriages and produces only a daughter, Rhaenyra. A fading hope for a son is dashed when a breached birth and a brutal Caesarian section, intended to save the child, ends up killing Aemma. The boy – the desperately desired heir – doesn't live out the day.

Sonless, Visery's named heir is his

younger brother, the debauched, sinister Daemon. When Daemon's conduct becomes intolerable, Viserys disinherits and banishes him. Left with his young daughter Rhaenyra, he decides to make her a ruling queen, a role the girl relishes as she seeks to change "the order of things."

Westeros is not 12th century England. For Martin, the author, the Anarchy does not serve to establish historical fact but is a wellspring for his creative vision. The firebreathing dragon – that denizen of the medieval imagination – exists in Westeros. Rhaenyra's pursuit of the throne may be fraught with difficulties, but she is a dragon-rider, and dragons were the most fearsome military asset in the kingdom

BUILDING SUPPORT FOR A RULING QUEEN

The challenge for a medieval king, whether Henry I or the fictional Viserys, was to persuade the nobles to overcome their prejudices and not just accept but actively support

a woman's ascension to power.

Henry I pursued measures to make his daughter palatable to them. Matilda, who had married the Holy Roman Emperor Henry V in 1114, returned to England a widow in 1125. Henry I, determined to forge a sacramental bond between his daughter and England's magnates, compelled his barons in 1127 to swear their support for her as his successor. Henry I then turned to arranging a marriage for Matilda so she could give birth to a grandson and buttress her position.

After Matilda's nuptials with Geoffrey, count of Anjou, the barons were summoned to renew their oath to her in 1131. A son, Henry, was born two years later, and a third pledge followed. Henry I died two years later of food poisoning after eating eels, a favorite dish of his.

The durability of his arrangements for Matilda's rise to authority was immediately tested. Viserys in "House of the Dragon" works from a similar playbook. The worthies of Westeros vow their loyalty to Rhaenyra as royal successor. Once Rhaenyra becomes marriageable, Viserys fields a plethora of suitors for her hand. A reluctant bride, Rhaenyra finally accedes to a union in which she would "dutifully" produce a male heir but then let her heart have what it wanted.

The unfortunate result is her inability to conceive with her husband while having three sons by a lover. Her situation is further complicated by Viserys' remarriage to the

lady Alicent, who gives him sons. Dangers stalk Rhaenyra's path to power. In Westeros, as in England, a princess is expected to guard her chastity closely until marriage and, once wed, to be monogamous and not to "sully" herself in order to ensure the legitimacy of her children – a blatant double standard when noblemen frequently had children out of wedlock

Yet even rumors of female infidelity could threaten succession. Lineage matters. Blood binds, as evident in the streams of it running from family crest to family crest in the series' opening credits.

WAR ENSUES

Did these strategies work?

Not for Matilda. Stephen of Blois, a son from the marriage of Henry I's sister Adela to a French count, aggressively registered a claim to the crown after Henry I's death. Many English magnates conveniently forgot their oaths to Matilda, and Stephen became king.

Matilda was not without supporters – her half-brother Robert, earl of Gloucester; her husband, the count of Anjou; nobles disaffected by Stephen's rule; and opportunists seeking personal gain from the conflict. Matilda resisted and the Anarchy ensued.

Forces supporting Matilda invaded England in 1139 but, save for a moment in 1141, she never ruled. She then focused instead on elevating her son to the crown.

Prosecution of the war ultimately passed to the young Henry. His mounting military successes jogged the barons' memory of their past commitments, and the contending parties reached a settlement. Henry would succeed Stephen. With Stephen's death, Henry became Henry II. England wouldn't have another ruling queen until the ascension of Queen Mary I in 1553, nearly four centuries later.

BUT WHAT OF RHAENYRA?

Westeros is not 12th century England. For Martin, the author, the Anarchy does not serve to establish historical fact but is a well-spring for his creative vision. The fire-breathing dragon – that denizen of the medieval imagination – exists in Westeros. Rhaenyra's pursuit of the throne may be fraught with difficulties, but she is a dragon-rider, and dragons were the most fearsome military asset in the kingdom.

This makes her dangerous in a way Matilda of England could hardly have conceived. Nonetheless, "House of the Dragon," through the lens of fantasy, reflects a slice of the English medieval experience.

Chandigarh: The Punjab and Haryana High Court has allowed the custody of a 16-year-old girl to her husband while reiterating that a Muslim aged 15 and above can marry a person of her choice and such a marriage will not be void.

A Bench of Justice Vikas Bahl heard a habeas corpus petition of Javed (26), seeking custody of his 16-year-old wife who was kept at a children's home in Haryana's Panchkula.

The petitioner had stated that at the time of their marriage, his wife was more than 16 years of age and the marriage was performed out of their free will and without any pressure.

The petitioner through his counsel had submitted that both were Muslims and they performed 'Nikah' on July 27 at a mosque in Mani Majra here.

The petitioner's counsel, while relying upon the judgment of a coordinate Bench of the High Court in Yunus Khan vs State of Haryana case, argued that the custody of the girl should be handed over to the petitioner.

However, the state's counsel had opposed the petition and submitted that she was a minor, therefore, she was being kept at Ashiana Home.

Nagarnar Steel Plant Commissions Coke Oven Battery No.1

Nagarnar: NMDC's Nagarnar Steel Plant inched closer to its commissioning today when Somnath Nandi, Director Technical, NMDC commissioned Coke Battery No.1 in the presence of K Praveen Kumar, ED Incharge, Nagarnar Steel Plant and other senior officials.

The first batch of coke was discharged this afternoon paving the way for sequential commissioning of subsequent key units.

Nagarnar Steel Plant being a greenfield integrated steel plant, several major units need to be commissioned sequentially so that their interdependence can be established smoothly.

Battery No. 2 is due for commissioning in the next few days and the process will eventually culminate in the commissioning of the Hot Strip Mill and Thin Slab Caster in the coming months. Nagarnar Steel Plant aims to produce 2.89 million tonnes of high quality HR Coils, Plates and Sheets annually, using state of the art technology and achieving the highest level of energy efficiency.

Sumit Deb, CMD, NMDC appreciating the collective effort described the development as "an important day in the

history of Nagarnar Steel Plant and a significant milestone in commissioning of 3 MTPA Integrated Steel Plant".

He exhorted the Collective to, "put all-round sincere efforts as a team to achieve the final milestone of commissioning the Plant". Commenting on the achievement, Somnath Nandi, Director Technical, NMDC said, "This is the first major step towards commissioning of the steel plant. Today's development inspires confidence that we will soon fulfil the dream of a steel plant in Bastar."

Mr. Praveen Kumar, ED Incharge, Nagarnar Steel Plant highlighted that these ecofriendly coke oven batteries will produce coking coal without releasing any toxic fumes. He referred to today's commission as 'a validation of the team's commitment' and expressed confidence that the steel plant commissioning will also follow soon hereafter.

The annual metallurgical coke production capacity of Nagarnar Steel Plant's Coke Oven Complex is 1.76 million tonnes, when fully operational. Constructed at a cost of Rs.1978 crore, the Project executed by a consortium comprising of BEC (Bhilai), M/s Giprokoks (GPK) of Ukraine,

M/s CUI and M/s Concord.

The Coke Oven Complex consists of 2 batteries of which Battery No. 1 was commissioned yesterday. Each battery has 67 ovens that are 7 metre tall and a Coke Dry Cooling Plants (CDCP) which will ensure dry quenching of coke using nitrogen. This effectively protects against pollution and also helps in utilising the heat to generate power.

When fully functional, Nagarnar Steel Plant has the capability to generate in-house 80MW of power of its total requirement of about 296 MW

By-Product Plant also Commissioned

By-product plant, a critical unit that is intrinsically linked to Coke Oven, was also commissioned. This is an absolute prerequisite for starting a coke oven battery because all toxic elements produced during the coke making process are captured, treated and commercialized by the By-product Plant. This unit effectively aids pollution free coke production by extracting Tar, Napthalene, Sulphur and Ammonia as by-products. M/s Hutni of Czechoslovakia is the technology provider.

UN probe demanded in killing of Pak journalist Arshad Sharif in Kenya

Islamabad: Salman Iqbal, a prominent Pakistani media personality and businessman has demanded a probe by the UN into the killing of journalist Arshad Sharif in Kenya as he does not have faith in the investigation carried out by the current PML-N government.

Sharif, 49, fled Pakistan in August for the UAE and later went to Kenya where he was killed on Sunday night. The Kenyan police later said it was a case of mistaken identity during a search for a similar car involved in a child abduction case.

Salman Iqbal, the President and CEO of ARY Digital Network as well as having multiple businesses, was associated with his channel and it is alleged that he asked Sharif to flee the country and also persuaded him to go to Kenya.

Iqbal issued a statement on Twitter on Friday after Interior Minister Rana Sanaullah levelled allegations against him during his press conference and demanded that he should be brought back from the UAE for the probe.

It has been stated that I should be included in the investigation into the killing of Arshad. I do not believe in the independence of the investigation being undertaken by

the present (Pakistan Muslim League (N) PML-N government but will answer any questions put to me.

I am calling for an independent investigation overseen by the UN Human Rights Office, and will of course provide my full cooperation to any such investigation seeking to get to the full truth behind the killing of Arshad Sharif with a view to bringing those responsible to justice, he said.

He said that it was not easy to be a journalist in Pakistan and there were threats to Sharif.

We knew that threats to Sharif's life were legitimate. He repeatedly appealed in writing to all relevant sectors of government for protection. Instead of receiving help, he was targeted with cases of sedition, multiple FIRs and arrest warrants, which compelled him to make the difficult choice to leave Pakistan, he said.

Iqbal condemned the smear campaign against him by the incumbent government.

Sharif, a senior journalist and former ARY News anchor was killed in Kenya where he was living in self-exile. A seasoned journalist, he was one of Pakistan's top news anchors.

His death has created a storm in Pakistan where allegations are being traded among politicians, apparently to gain political mileage.

Delhi AIIMS to replace parking stickers with RFID tags from Apr 2023, install GPS in electric shuttles

New Delhi: All parking stickers issued by AllMS here will become invalid from April 1, 2023 and be replaced with RFID tags, while all electric shuttles will be fitted with GPS, according to a new traffic circulation plan issued by the hospital.

Electric shuttles are used to transport patients and their attendants across the All India Institute of Medical Sciences' campus.

According to an office memorandum (OM) issued on October 27, AllMS Director Dr M Srinivas recently took rounds of the East Ansari Nagar and Masjid Moth campuses and noted that there is a lot of traffic congestion, unauthorised parking and lack of internal transport facilities for patients and their attendants.

"Private and public vehicles are noted to be using AIIMS as a thoroughfare at high speed which is causing discomfort to wheelchair-bound patients and pedestrians and is also leading to increased pollution levels within the campus."

"Also, in the absence of access control, such thoroughfare is posing a risk for students residing in girls and boys hostels and is also leading to penetration of anti-social elements in the premises," the OM stated.

Ahead of the bone-chilling cold and 10-day intermittent wet spell, the KPDCL has stated that the men and machinery are ready to tackle any eventuality. Chief Engineer, KPDCL, Javed

Yousuf Dar, said that "If we go just three years back, we were supplying a peak of 1200 MWs during the winter time. Due to the capacity addition at transmission and at distribution level, a number of new grid stations have come, while the existing grid stations capacity have been enhanced. On the distribution side, we have been able to add more than 80 receiving stations in the last three years. Similarly, the distribution transformers have been added to the system, because of which we are in a position to district," he said. supply more power."
