Unemployment Rate In J&K Declined By 10% In Last 3 Months: CMIE

Srinagar: Even as there was a substantial increase in the unemployment rate in Jammu and Kashmir in the month of August, the joblessness rate has come down by over 10 percent in October, as per Centre for Monitoring Indian Economy (CMIE).

CMIE, which conducts its own employment survey, showed that the increase in the unemployment rate in October is on account of sharp increase in rural unemployment which rose from 5.84 per cent in September to 8.04 in October, whereas the urban

unemployment rate fell slightly from 7.7 to 7.21 per cent. According to the CMIE data, even though J&K's unemployment rate was higher than the national average, it still saw a decline in October as the rate came down to 22.4 percent compared to the previous month's 23.2 percent. The latest

brought some respite among the youth in the valley. As per reports, J&K's higher than national average joblessness rate is primarily because of the slower economic growth resulting in fewer job opportunities and also due to a much



lower resilience to absorb the J&K's Unemployment rate had pandemic shock. In August, soared up to a six year high

when it touched 32.8 percent. Amid the unrest of 2016, J&K's unemployment rate stood at 25.3 percent in September, 26.3 percent in October and 29.9 percent in November.

Among the 25 states for which data is available with the CMIE, six states registered the unemployment rate in double digits. Haryana registered highest unemployment the rate of 31.8 per cent followed by Rajasthan (30.7 percent), Jammu & Kashmir (22.4 percent), Jharkhand (16.5 percent), Bihar (14.5 percent) and Tripura (10.5 percent).


"Only police and forces cannot bring lasting peace. Elected representatives and other rings of administration will also play a big role in it," he said.

India Rejects China-Pak Statement On Kashmir

New Delhi: India on Thursday strongly rejected references made to Jammu and Kashmir in the China-Pakistan joint statement issued during Pakistan Prime Minister Shehbaz Sharif's recent visit to Beijing, and asserted that the Union Territory as well as Ladakh "are and will always" be "integral and inalienable" parts of India. External Affairs Ministry Arindam spokesperson Bagchi, referring to the so-called China-Pakistan Economic Corridor (CPEC), said New Delhi has consistently conveyed its "protests and concerns" to Beijing and Islamabad over the CPEC as it includes projects on the sovereign territory of India.

Bagchi said India "resolutely rejects" any attempts to utilise such projects to change the status quo in the area and that any attempts to involve third parties in such activities are "inherently illegal, illegitimate and unacceptable".

Additionally, the new headset features 4000 x 2040 high dynamic range (HDR) video format (2000




x 2040 per eye), which will provide next-generation gaming experience to the players.

rain changes in autism are comprehensive throughout the cerebral cortex rather than specific areas thought to impact social behaviour and language, a new study has found. According to the study, it rep-

resents a comprehensive effort to characterize autism spectrum disorder (ASD) at the molecular level.

While neurological disorders like Alzheimer's disease or Parkinson's disease have well-defined pathologies or pathways, autism and other psychiatric disorders have had a lack of defining pathology, making it difficult to develop more effective treatments, it said.

The study, led by University of California, Los Angeles, finds brainwide changes in virtually all of the 11 cortical regions analyzed, regardless of whether they are associated with higher functions such as reasoning, language, social cognition and mental flexibility or primary sensory regions. The findings are published in Nature.

'This work represents the culmination of more than a decade of work of many lab members, which was necessary to perform such a comprehensive analysis of the autistic brain," said study author Daniel Geschwind.

"We now finally are beginning to get a picture of the state of the brain, at the molecular level, of the brain in individuals who had a diagnosis of autism.

"This provides us with a molecular pathology, which similar to other brain disorders such as Parkinson's, Alzheimer's and stroke, provides a key starting point for understanding the disorder's mechanisms, which will inform and accelerate development of diseasealtering therapies," he said.

For this new study, researchers examined gene expression in 11 cortical regions by sequencing RNA

study said.

Researchers also found strong evidence that the genetic risk for autism is enriched in a specific neuronal module that has lower expression across the brain, indicating that RNA changes in the brain are likely the cause of ASD rather than a result of the disorder.

Geschwind led the first effort, over a decade ago, to identify autism's molecular pathology by focusing on two brain regions, the temporal lobe and the frontal lobe. Those regions were chosen because

from each of the four main cortical lobes. They compared brain tissue samples obtained after death from 112 people with ASD against healthy brain tissue, the study said.

While each profiled cortical region showed changes, the largest fall in gene levels were in the visual cortex and the parietal cortex, which processes information like touch, pain and temperature. The researchers said this may reflect the sensory hypersensitivity that is frequently reported in people with ASD, the

they are higher order association regions involved in higher cognition especially social cognition, which is disrupted in ASD.

One of the next steps is to determine whether researchers can use computational approaches to develop therapies based on reversing gene expression changes the researchers found in ASD, Geschwind said, adding that researchers can use organoids to model the changes in order to better understand their mechanisms

Srinagar: As one passes from the newly developed walkway along the Brari Nambal Lagoon in the Baba Demb area of Srinagar, a pungent smell emerging from the Lagoon makes it impossible to walk. The Ghats developed by the government along the banks of the Lagoon

fail to attract people. "I had a look from the Ghat to the Lagoon and it is not a sight to remember" said a passerby.

However, for locals living in the vicinity of the lake, the stinky smell has made their life

hell. Heaps of garbage, unending stretches of obnoxious weeds, stinking waters are the only remnants of this once sparkling

body to its pristine glory. However, in recent months algae has engulfed the surface of the lagoon. Moreover, an on ground visit shows illegal constructions have been coming up in the vicinity of the lagoon making its

lagoon

survival more difficult. The authorities say they have been doing their bit to restore the water body to its original state. However, on ground things are quite different.

The Brari Nambal Lagoon comes under the jurisdiction of Lake Conservation and Management Authority (LCMA), some of its area comes under the jurisdiction of Srinagar Municipal Corporation (SMC).

Earlier speaking to media, VC LCMA Bashir Bhat said that they were carrying out anti-encroachment drives regularly to ensure that no structure was set up in the area.

He, however, said that LCMA does not have jurisdiction over the full area of Brari Nambal.

VC LCMA Bashir Bhat acknowledged that some temporary structures have come in the vicinity of the lagoon but he said that structures will be raised to the ground.

"We will do our bit and ensure no illegal construction comes up," Bhat said.

A senior SMC official also voiced similar views and said that they are doing their bit to stop illegal constructions.


SMC Begins Upgradation Work **Along Jehlum Embankments**

Agha Mahdi Among 6 Killed

RINAGAR: A former Congress leader and son of a prominent Shia Muslim cleric was killed with five other people in a landmine blast at Mazhama in the central district of Budgam Friday afternoon, a police spokesman said. Agha Syed Mahdi (44) was travelling with five others

includ-ing his security guards and his domestic servant when his bul¬let-proof jypsy was blown apart by the landmine at Mazhama near Magam on Srinagar-Gulmarg road at around 14:30 hrs

Mahdi was the son of the prominent religious leader of Kashmir's Shia community, Agha Syed Mustafa al-Mosawi-al-Safawi. He was the younger brother of senior Hurriyat leader, Agha Syed Hasan, and cousin of minister of state for education, Agha Syed Mehmood.

A caller identifying himself as a spokesman of Lashkar-e-Karbala rang up CNS news agency claiming responsibil¬ity for the blast. According to BBC, Hizbul Moomineen had owned the explosion. Meanwhile, a late night KPS report said Hizbul Momineen had denied its involvement in the explosion. Quoting its chief, Shuja Abbas, who called the agency from Pakistan, the report also denied the existence of Lashkar-e- Karbala.

Those killed in the blast apart from Agha Mahdi were identified as PSO Ghulam Mohi-ud-din, and constables Fa¬rooq Ahmad Kuttay, Showkat Hussain and Muhammad Ja¬far, and his domestic servant. Saijad Hussain Mir.

Reports said Agha Mahdi was on his way to Sofi mohalla, Magam, to attend the Walima function of one of his disciples, Ghulam Ahmad Sofi. When his vehicle reached a point near a flour mill between Mazhama and Kawoosa villages, 5 km from the destination, it stumbled on the landmine. In the ensuing blast, Mahdi and others with him were blown, along with the vehicle.

Soon after the news reached nearby Magam, life in the township came to a standstill with shopkeepers pulling down their shutters and people converging on the streets to stage demonstrations, Tension also gripped in Budgam, the district headquarter, and thousands of abated people gathered out-side the residence of slain leaders father, Aga Mustafa.

Reports of angry people taking to the streets have come from various places on Srinagar Baramulla highway. Ac¬cording to CNS, irate mobs at Hartrath Singhpora beat to death one Meraj-ud-din Dar and set ablaze six residential houses. Vehicular traffic on the highway was disrupted for several hours- Reports of stone pelting have also come ftom Saidakadal and Nigeen areas of the city.

Mahdi shot into prominence in 1997 when he, though a big crowd-puller because of his father's clout, unsuccessfully contested on Congress ticket against the National Conference candidate and chief minister's son, Omar Abdullah. Earlier, he had contested against the Muslim United Front (MUF) can-didate as an independent from Budgam constituency in the rigged 1987 assembly' poll. He also fought assembly elections in 1996 as 'Congress candidate but resigned before he contested parliamentary elections in 1998 as an independent candidate.

Another prominent pro-India Kashmiri Shiite leader, Maulvi Iftikar Hussain Ansari survived two attempts on his life this year.While Maulvi was slightly injured and three po¬lice personnel were killed in a powerful landmine explosion at Matipora village in September in an earlier attack 16 of Maul¬vis followers were killed when a mine exploded in midst of a Majlis Hussayni at Gund Khwaja Qasim in June this year. LCMA Conducts Demolition Drive In City Areas

Srinagar: The Enforcement Wing of Lake Conservation Management Author-(LCMA) on Thursday itv launched a demolition drive in the areas of Baba Demb, Chandpora Harwan, Friends Colony Shalimar and Ishber.

"During the drive, one wooden Shed, two single stories with compound walling, one Plinth block, shuttering, compound walling (Block Bricks) and one second storey raised illegally were demolished on the spot" LCMA in a statement said.

Moreover, a demolition drive was also conducted in the interior areas of Dal lake viz. Kand Mohalla, Sofi Mohalla and Tinda Mohalla.

During the demolition process, the areas being sensitive in law and order, some miscreants assembled at several places and hurled stones and bricks on the demolition team thereby trying to disrupt the process of demolition. But the demolition team remained on forefront

and managed to demolish one wooden shed, one plinth and one house boat platform near Ghat No.2. In this regard, legal action was also initiated against the miscreants.

LCMA urged the public residing within the LDA jurisdiction and in-lake directed not to go for any sort of illegal constructions as the Enforcement wing will continue with demolition of illegal constructions/ removal of encroachments.

LCMA also directed the Tipper and Load carrier owners not to ferry any construction material in the prohibited areas of Dal, Nigeen Lakes without getting proper permission and in case anybody found shall be dealt with as per law.

Also CCTV Cameras have been installed and barricades have been erected in order to curb the transportation of illegal building material.

Moreover, the locals residing in the area of LCMA Jurisdiction are informed to apply for online building permission through LCMA online official website.

AHMEDABAD: Long caught between two polarities, Gujarat's electoral field has expanded to include a third party with the Aam Aadmi Party challenging the ruling BJP as well as the opposition Congress that has lost ground but still has significant presence.

Elections to the 182-member state assembly will take place over two phases on December 1 and 5, the Election Commission announced on Thursday in the backdrop of the Morbi bridge collapse four days ago. As campaign knives get sharpened, the October 30 tragedy in which 135 people lost their lives could find emotive resonance.

Besides, the freebie versus welfarism debate - over which challenger AAP and BJP have been sparring over the last several weeks -- and the ruling party's main poll planks of Hindutva, 'double engine' growth' and continuity in governance are likely to remain centrestage.

Though elections were announced today, the buzz for what dependent one and five seats are will be a three-cornered contest vacant, including three after Conhas been getting steadily louder gress MLAs resigned.

Prime Minister Narendra Modi and several Union ministers have been making frequent visits to the state. PM Modi was in Morbi on November 1 to review the situation. The elections are crucial for BJP, which has won six successive terms and aims at retaining power in PM Modi's home state, as well as for AAP, hoping desperately that a win in Gujarat will propel it to a pan-India political force, the third state in its bag after Delhi and a victory in Punjab in March this year.

The Congress, on its part, hopes to end its 27-year stint in the Opposition but has so far been quiet with its national leaders conspicuous by their absence.

To Speak To Journalist For Not Wearing A Bindi

MUMBAI: Right-wing leader Sambhaji Bhide on Wednesday courted controversy after he refused to speak to a female television news reporter as she had not put a 'bindi' on her forehead.

The incident, caught on camera, took place after he met Maharashtra Chief Minister Eknath Shinde at Mantralaya (state secretariat) in south Mumbai, and promoted the state women's commission to issue him a notice

In a video, Sambhaji Bhide was heard telling the female reporter, who sought sound byte from him about his meeting with Eknath Shinde, that she should apply a 'bindi' (a decorative dot worn in the middle of the forehead by women) before coming to take his byte, and declined to speak to her.

He also told the journalist that a woman is akin to Bharat Mata and that she should not appear like a "widow" by not sporting a 'bindi.

The single judge failed to consider the facts of the case as a judicial officer can be transferred during the currency of three years if it is necessary in the administration of justice, and in the appellant's case, the single judge had not held that the transfer of the appellant is in the interest of the administration of justice.

"The finding of the Single Judge that the appellant cannot be said to be prejudiced in any manner by his transfer as a Presiding Officer, Labour Court, Kollam district is not against the transfer order. Earlier, correct. The appellant is a Special Grade District Judge and was discharging duty as Principal District and Sessions Judge, and that post is occupied by the senior most Special Grade District Judge therefore, transferring and posting the appellant will necessarily result in prejudice," the plea said.

Politically Mature People Will Judge Parties **On Merit: Azad**

SRINAGAR: Democratic Azad Party Chairman Ghulam Nabi Azad on Thursday questioned the delay in elections, saying, "If everything is normal, why elections are not being held in J&K". Azad who recently formed

his own party DAP after severing decades-long ties with Congress party, said the claims of normalcy in Jammu and Kashmir being disseminated by Government of India and J&K have proven hoax as the way for the conduct of assembly elections is being obstructed one way or the other. "If everything is normal, why GoI is hesitating in conduct of assembly elections in J&K", Azad said.

Azad said that delay in election cannot be justified by few incidents. "The past is witness that elections were held despite militants fired thousands of bullets everyday in Kashmir. If today Government is delaying elections, then their claims of normalcy are doubtful", the DAP chief said.

He said there is no room for delay in conduct of elections as people are craving for public representatives to whom they approach and address their de-



mands. "Elections should have been held before four years. When everything is normal. When there is no stone pelting, no hartals, no agitation even when militancy, according to security forces is about to over, so what is the purpose of delay in elections in J&K", Azad questioned.

Azad while praising the role of Lieutenant Governor Manoj Sinha said he cannot change things on his own. "The LG Sinha is a good person. I want J&K becomes state and him as fullfledged Governor. He cannot reach out to everywhere, he can't work on behalf of 90 MLAs, he is also human being ", Azad added. Regarding a question about different roadmaps floated by different parties, he said, "People in J&K are politically mature, they will judge everyone on merit."

"If J&K is back to normalcy, I don't think there is need of Governor rule further", he added. (KNS)

Pakistan Turmoil

usted Pakistan prime minister Imran Khan's protest march towards the Pakistani capital Islamabad has once again plunged the country into chaos. The Pakistani government has unsuccessfully tried to stop the march but to no avail. Khan has been claiming his government was toppled by the United States miffed with his growing closeness to Russia and China. He has been demanding the resignation of the government and the holding of the fresh elections. While the Pakistan government, backed by the military establishment, is unlikely to resign in the near term, Khan's stubborn political campaign has destabilized the country. At the same time, his popularity has skyrocketed and in case of an early election, he is expected to return to power with a landslide majority.

One fallout of this troubled situation in the country is that there is no hope for an India, Pakistan dialogue. The three and a half years of Khan's term saw relations between the two neighbors nosedive. And with the revocation of Article 370 in August 2019, the ties deteriorated almost to the point of no return. Khan became one of the fiercest critics of the Indian government. But in February 2021, the militaries of the two countries dramatically signed a ceasefire agreement. The move came reportedly following an extended back-channel dialogue between the two countries. But thereafter there were no efforts to improve the relations. Or to resume dialogue that otherwise appeared a logical course of action following the ceasefire. The reason for this was Pakistan's insistence that India reverse the repeal of Article 370 but for New Delhi, the move is now a fait accompli.

Going forward, the situation looks bleak. Should Sharif's government continue, there will be little chance of the relations between India and Pakistan reviving in near to medium future. That is, if at all there was any chance at all.

Meanwhile, a halt to the frequent firing exchanges along the Line of Control has made a redeeming difference to the lives of lakhs of border residents on both sides of the border. But it won't change anything as far as the situation in the Valley where militancy continues to linger. This problem could certainly have been addressed through a dialogue between the two countries, whose chances now look slim until after the fresh national elections are held, first in Pakistan in 2023 followed by one in India in 2024. Sharif's survival in power or otherwise will make no difference to this reality.

witter is free. You can go on there and type your embarrassing little thoughts for the whole world to see any time you like. Millions of us have been doing this for years. Revealing to everyone how dumb your inner thoughts are may cost you your reputation, sure, but it won't cost you any money. Not even if you're the richest man in the country.

So why spend \$44bn to buy it? That's a fair piece of change, even to someone whose net worth hovers above \$200bn. It's also much more than the company is actually worth, as evidenced by Elon Musk's desperate attempt to get out of the deal almost as soon as he had gotten irretrievably into it. The price is too high to be a pure lifestyle purchase - if vou want a media property just for the social cachet and party invitations, it can be had much cheaper. Fellow villainous mega-billionaire space tourist Jeff Bezos bought the Washington Post for a mere \$250m, less than 1% of what Musk just paid for a cacophonous global collection of weird, hollering self-promotion.

In truth, Musk probably bought Twitter for the same reason that sickeningly rich people throughout history have become press barons: to try to control the conversation. About themselves, in particular, and secondly about their own economic interests, and thirdly about their own inevitably selfish, bizarre, half-witted political beliefs. Once you have ascended the ladder of wealth past buying real estate and cars and boats and models and the other tawdry baubles that come with money, there comes a time when a hardworking plutocrat begins to be irked by the fact that, beyond their sphere of servants, people are still talking trash about them. It upsets their sense of omnipotence. After the thrill of bending the material world to their whim has worn off, the desire to bend the public conversation - and, by extension, the public mind - to their own liking takes root.

This has always been a hitand-miss proposition. It's easiest for those who are interested in straightforward political influ-



about what they are doing, well, the possibility for hilarious disaster is very real.

Elon Musk is, ironically, the exact type of person for whom Twitter is poison. Wealthy, powerful and celebrated, he could have kept his mouth shut and let his work speak for itself: instead. he uses Twitter, and reveals to all of us that the richest man in the richest nation in the history of the world is an unfunny meme guy easily seduced by the same sorts of ideas that grab the minds of Reddit-scrolling 13-year-old boys. There is a lesson there about the inability of wealth to make someone interesting – but, setting that aside, there is a more relevant lesson about the danger of vast concentrations of wealth. Because when you mix the immature, half-baked, self-righteous grandiosity of a guy like Elon Musk with the ability to buy and sell multibillion-dollar global public corporations like toys, you have a recipe for chaotic, destructive stupidity on a staggering scale.

Many on the left suspect that Musk is in fact a Rupert Murdoch of the tech generation, planning to use Twitter's algorithms to disperse and promote rightwing ideas. Others say this was all a way for him to diversify his finances and sell off a ton of Tesla shares without sparking investor panic. Those tidy explanations would be more satisfying than the likely truth: this guy saw a chance to put his sophomoric ideas about "free speech" into practice on his favorite app, and he did.

important to the future of civilization to have a common digital town square, where a wide range of beliefs can be debated in a healthy manner." OK. Sure. Forty-four billion dollars seems like a lot to pay for the right to grandly reinstate @NaziAnime666's right to post gifs about Pizzagate or whatever, but a fool and his money are soon parted and all that.

You may notice that Musk's stated goal of being an angel of open, civilized discourse is not wholly compatible with all billionaires' natural desire to bend the content of that discourse in a direction that they agree with. Reconciling these two competing mandates is one of the oldest and most central tasks of news media companies, or discourseshaping social media companies, owned by rich guys. Many thoughtful journalists, pundits and professors have spent their careers wrestling with this tension - unfettered truth versus the blinkered logic of capitalism. Two hundred years into the history of American journalism, it's still an open question how it will all be resolved.

But I do know one thing for sure: Elon Musk, zillionaire king of the nerds, alt-right meme lord, and committed union buster, is not the guy who's gonna figure it out. If you are wondering what lies in store for all of us after his big purchase, just assume the dumbest possibilities will come true. An owner who is not cool or funny will do things that he thinks are cool or funny. Trouble will ensue. Tech and media are both inherently unstable industries, so the good news is that the possibility of Twitter spectacularly imploding does not make them that much different from everywhere else. Enjoy it while it lasts. Stay focused on eradicating billionaires forever. And, if you have the misfortune of working at Twitter, get yourself a union as soon as possible.

razil has a new leader — who is also its old leader. On Sunday, South America's largest nation elected Luiz Inácio Lula da Silva as its president, yet again. His win in a run-off against the former president, Jair Bolsonaro, capped a dramatic political resurrection for a man who ruled the nation from 2003 to 2010 but was then jailed in 2017 on corruption charges that were subsequently overturned. Mr Bolsonaro, who emerged as an iconic figure of the Brazilian far-right, had indicated before the election that he might not concede a loss. He has spent months questioning the credibility of the democratic process — much like his friend, Donald Trump, the former president of the United States of America, has done since his 2020 loss to Joe Biden. However, on Tuesday, Mr Bolsonaro appeared to suggest that he would allow a smooth transition of power to Mr Lula. That is welcome in a major democracy that shed military rule — which Mr Bolsonaro has expressed admiration for — only 37 years ago. It is, however, also reflective of the stakes on offer in politics in Brazil and across Latin America, where Mr Bolsonaro and other conservative leaders might be down but are far from out.

In Brazil, Mr Bolsonaro might not be president for a second term, but his party won a record number of seats in the Congress at the start of October. Brazil's single-largest party, it effectively controls half of the lower House with allies. Mr Lula's party will therefore struggle to pass major laws to undo Mr Bolsonaro's policies, which depleted the Amazon rainforests and attacked women, LGBTQ people and indigenous communities. In effect, Mr Bolsonaro will remain a major force to reckon with in a Brazil that has broadly moved to the right. That shift in Brazil is also reflected in Mr Lula's choice of the business-friendly leader, Geraldo Alckmin, once his rival. It would also be a superficial understanding of the region to view Mr Lula's win as part of a broader 'pink tide' of socialist-leaning governments in South America. Chile, Peru, Colombia, Argentina and Bolivia all have left-leaning governments today. However, deep divisions exist among them on everything, from Ukraine and the US to relations with leftist authoritarian figures like Venezuela's Nicolás Maduro and Nicaragua's Daniel Ortega. How Mr Lula adjusts to this complex regional and domestic landscape will shape the next four years for Brazil - and the continent that it dominates.

Are You Scared of Life's Uncertainty? Here are the Consequences and Ways to Cope

Today more than any other time in history, uncertainty is all around us. Uncertainty has been identified as a defining characteristic of modernity, with economist Barry Eichengreen arguing that we are living in an "age of hyper-uncertainty". Much of what lies ahead in life remains unpredictable, whether it has to do with the worldwide pandemic such as COVID-19 that the whole world got engulfed into, economy, your relationships, finances, or health. But at the same time, we as human beings yearn for security. We want to feel secure and in charge of our lives and wellbeing.

As per English dictionary, uncertainty is a state of doubt about the future or about what is the right thing to do.

From a psychological point of view, Uncertainty is defined as "the state of incomplete information or knowledge about a situation, or the possible alternatives or the probability of their occurrence, when their outcomes are not known by the person".

It can also be defined as a state wherein "details of the situation are ambiguous, complex, unpredictable, or probabilistic; when information is unavailable or inconsistent; and when people feel insecure in their own state of knowledge or the state of knowledge in general".

Uncertainty is a constant in life and cannot be avoided. We can never know with certainty what will actually happen on any day, because we cannot look into the future. The capacity for accepting uncertainty varies among people. To put it another way, although some people can handle a great deal of uncertainty, others find that even a little bit of it makes them uncomfortable.

You might experience stress, anxiety, and a sense of helplessness about the course of your life if you live in a state of constant fear and uncertainty. It can deplete you emotionally and keep you mired in a never-ending cycle of "what-ifs" and dreadful possibilities for the future.

What is intolerance to uncertainty?

Intolerance of uncertainty has been defined as "a dispositional characteristic that results from a set of negative beliefs about uncertainty and its implications and involves the tendency to react negatively on an emotional, cognitive, and behavioral level to uncertain situations and events".

- Procrastination/avoidance: Some people simply put things off or steer clear of people, places, or situations because uncertainty might create anxiety. You don't have to be unsure about anything if you don't do it. Distraction: Many people who are uncomfort-
- Distraction: Many people who are uncomfortable with uncertainty keep themselves "occupied" for the most of the day to avoid having to reflect on all the unpredictability in life.

You might have realized that a lot of time and effort are needed to carry out each of these behaviors. Changing a mindset is obviously difficult, even if you believe that being more accepting of uncertainty would be beneficial. As per Cognitive Behavioral Therapy, thoughts, feelings, and behaviors are all interconnected, and if you alter one, you can influence the others.

The following tips may be useful if you struggle to deal with uncertainty.

1. **Develop self-awareness:**

Consider developing self-awareness to under-

It is clear that most people tend to feel a little uneasy around uncertainty, which is understandable. We try to know that the place we are visiting for lunch has food we enjoy, that people we know will be at the party we were invited to join, and that our boss will be honest with us about how we are doing at work. We feel more at ease having this information than not knowing anything about the restaurant we are going to, not knowing who will be at the party, and not knowing whether our boss thinks we are doing a good or bad job.

What are the various behaviors shown by a person who is intolerant of uncertainty?

If you can't handle uncertainty in your life, you might probably take steps to either completely eliminate uncertainty from day-to-day circumstances or actively avoid them.

When someone is unwilling to accept uncertainty, they may exhibit specific behaviors, such as:

Excessively looking on others for validation and reassurance: If you need to make a decision (even smaller ones), you might do this every time by consulting your friends or family.

- 1. List-making: Some people will create lengthy, in-depth "to do" lists, often multiple lists each day, as a strategy to remove uncertainty.
- 2. Confirming twice: For instance, continually calling loved ones to "make sure" they are alright or carefully checking emails numerous times to ensure that they are flawless and error-free.
- 3. Refusing to assign duties to others: Many people who are uncomfortable with uncertainty refuse to assign certain chores to others at work or at home because they cannot be "confident" that they will be completed correctly

The fun of life can frequently be taken away by a need for absolute certainty since surprises or unanticipated events seem threatening. A dislike of uncertainty may also force you to avoid or put off taking advantage of many excellent possibilities in life.

How can intolerance of uncertainty lead to mental health issues especially emotional disorders?

Intolerance of uncertainty is similar to being allergic to a certain thing. For instance, if you have pollen allergy, exposure to even a small quantity of pollen will cause you to sneeze, cough, and your eyes to get red and teary.

We as human beings have a natural tendency to be sure and secure about important things in our life, but some people take this tendency to next level and try to eliminate uncertainty of any degree from almost all the areas of their life. This leads to more and more intolerance to uncertainty.

People who are significantly intolerant of uncertainty have a strong reaction when exposed to even a small amount of uncertainty just like allergy. They worry and try everything in their power to avoid, reduce, or get rid of the uncertainty. However, being extremely intolerant of uncertainty can be problematic since it might result in a lot of time-consuming and exhausting behaviors (some of which we discussed above), adds to stress and anxiety, and is a huge source of worry. This struggle with uncertainty is what can lead them into various types of emotional disorders such as Generalized Anxiety Disorder (GAD), Obsessive Compulsive Disorder (OCD), and Depression etc.

How can I develop greater tolerance for uncertainty?

stand how to deal with uncertainty. Recognizing the particular situations that may create anxiety can be accomplished by first admitting that you struggle with dealing with things outside of your control. Try to be mindful and aware of the patterns of thinking, emoting and behaving in such situations and how have these patterns impacted your relationships/ career/hobbies/emotional state.

This is not to feel awful about not being able to deal with uncertainty. Instead, it's to be aware of what sets off your anxiety response, how it affects your life, and what chances each scenario presents for possible personal growth.

2. Take a pause and name the feeling:

Try to give your fear of uncertainty a name so you can handle it when it starts to arise. "I'm worried about this because I'm afraid of this or that."

By doing this, you might be able to take a moment to reflect on what is occurring and why.

For instance, your boss offers you the chance to work on a fascinating new project. You think it sounds like fun, but you're actually nervous and anxious. Your reaction is to decline the offer, because you're unsure of how it will turn out or because you have doubts about your skills or abilities to finish the assignment.

Instead of being afraid of the situation, take a step back and tell yourself, "I recognize I'm anxious because I'm frightened things won't work out well. However, I have no control over things, and this is an excellent chance. These are the advantages of my taking the offer".

3. **Concentrate on the facts:**

Try to evaluate the situation based on the evidence rather than your anxious thoughts while making a decision. Your fear may make you believe that the worst-case situation is more likely to occur. You can make a more accurate assessment of the situation by using reasoning.

situation by using reasoning. Cognitive distortions are filtered ideas that could lead you to perceive a situation more adversely than is actually the case. You can turn away from them and concentrate on the evidence by recognizing them.

Using the previous example, you might conclude that you have the ability to provide results and that you are a top performer. You recall that the previous project you oversaw was challenging but a wonderful success. This could be yet another fantastic chance for growth.

4. Accepting that sometimes things might go wrong and then making peace with the past:

Even if it may be what you fear the most, bad things do happen in life. Not always, but occasionally. You might purchase a cloth on a whim and subsequently regret it. You might attend a party and become utterly bored. Going to the most expensive restaurant could result in indigestion or stomach upset. It happens.

You might want to conduct some research before making major decisions, such as going to college or purchasing a new car. Nevertheless, it's critical to recognize that, occasionally, even when you do your research, things cannot turn out as you had intended and that is O.K.

You eventually learn something from every mistake and failure. You'll figure out a method to overcome obstacles, whether it involves returning the clothing or changing colleges.

Although "making the incorrect decision" can be frightening, understanding that it will pass and that you can control any consequence at least at the emotional level may help you deal with it.



Applied to services like parcel delivery and waste collection, autonomous technology also promises to address worker shortages and reduce congestion.

Technological progress and regulatory approval are key enablers of autonomous vehicles and their mass adoption. But there is one factor that will make or break their success: public acceptance, which represents a significant hurdle.

The issue of public acceptance not only relates to whether people feel comfortable riding inside a driverless car, it also extends to how other road users interact with the vehicle. Early trials of driverless cars have been met with public backlash, including attacks on vehicles and threats against operators.

Even behavior that is not intended to cause physical damage but is born out of curiosity, such as stepping in front of a driverless car to see its reaction, significantly affects their operational efficiency. A recent study further found that trust remains a concern expressed among all respondents.

Researchers have linked these behavioral patterns and lack of trust to the absence of nonverbal communication cues between vehicles and other road users. For manually driven vehicles, these non-verbal cues, such as eye contact and gestures, are essential to ensuring safety, understanding and trust.

This is particularly pertinent in unstructured traffic and in situations involving vulnerable road users, such as a pedestrian crossing the road in front of a vehicle or in areas where pedestrians and vehicles share the same space.

To overcome the lack of non-verbal cues, studies have investigated ways to communicate the intention of autonomous vehicles, their awareness – what they 'see' – and even frustration when being challenged by a pedestrian deliberately stepping into its path. This vehicle-to-pedestrian communication is achieved through designing so-called external human-machine interfaces that may take the form of simple text or visual displays attached to the front of the vehicle, projections onto the road, and auditory alerts.

In a more distant future, this information could be communicated through augmented reality, as suggested by a study proposing to overlay autonomous vehicles with relevant visual cues.

External human-machine interfaces are a necessary evolution of the traditional blinker, which became widely adopted by car manufacturers in the late 1940s. At their core, fully autonomous vehicles are robots, requiring more advanced communication channels than simple light signals.

But unlike the depiction of Johnny Cab's driverless taxi in the movie Total Recall, they don't come with a humanoid robot driver. Instead, they are part of an automated infrastructure, where the city itself becomes a disBut this relies on bidirectional communication and the ability of the robot to understand human input, which was clearly not the case for a rogue robot driving right into a crime scene.

It is a long road toward robots roaming the city and getting the human-machine interaction right for public acceptance is challenging. This is not only because of the costs of fully functional autonomous vehicles but also the risks associated with real-world studies.

To overcome this risk, many researchers have turned to study digital replicas or 360-degree recordings of real-world situations in a virtual reality environment.

Results from these studies are promising,



autonomous vehicles. In a study of crossing scenarios, 81 per cent of participants reported they felt safer if an external display communicated the vehicle's intention.

In more complex scenarios, such as those in unregulated mixed-traffic environments, the combination of several factors was found to contribute to study participants expressing trust in the vehicle.

These factors include observing the vehicle's interactions with other pedestrians, implicit cues, such as the vehicle slowing down and explicit cues, such as external light signals showing intent and awareness.

Historically, car manufacturers have primarily focused on the safety of their passengers. It's a business strategy as manufacturers can use safety as a selling point. Mercedes-Benz's manager of driver assistance systems even publicly stated that the company would prioritize the safety of passengers over pedestrians in their autonomous vehicle technology.

As we are moving closer to a future in which the city and its infrastructure become automated, this approach requires rethinking. This is key to encouraging active transport and transitioning towards a greener and healthier urban living, reflected also in the United Nations' Sustainable Development Goal 11.

Manufacturers of autonomous vehicles have a unique opportunity to be a leader in this emerging and rapidly growing market by complementing their focus on technology with a strong understanding of social and human challenges.

The successful adoption of autonomous vehicles in and by cities also requires innovative policies. Regulatory bodies need to emphasize how these vehicles interact with pedestrians and other vulnerable road users not only algorithmically but also through vehicle-to-pedestrian communication channels.

Instead of regulating how cars adopt automation, what might policies look like if we think about cars more as robots that operate in close proximity to people?

India's Services Sector Sees Upturn In October On **Improved Demand**

NEW DELHI: India's services sector activities witnessed an upturn in October on the back of stronger gains in new business and increased hiring amid strengthening demand, a monthly survey said on Thursday. The seasonally adjusted S&P

Global India Services PMI Business Activity Index rose from September's six-month low of 54.3 to 55.1 in October, pointing to a quicker and marked rate of growth.

The headline figure was above the neutral 50 threshold for the fifteenth straight month. In Purchasing Managers' Index (PMI) parlance, a print above 50 means expansion while a score below 50 denotes contraction.

"The October results show us that service providers had no trouble securing new work in October, despite lifting their charges again. Hence, the sector remained firmly inside expansion territory as business activity and payroll numbers were raised to support strengthening demand," Pollyanna De Lima, Economics Associate Director at S&P Global Market Intelligence, said.

According to the survey, the domestic market was the main source of new business gains, as foreign sales decreased further at the start of the third fiscal quarter. "Monthly de-teriorations in international demand have been registered since the onset of COVID-19 in March 2020," it noted.

Ongoing increases in new business and output requirements continued to support job creation in the service economy. Employment rose for the sumer services led growth of



fifth month in a row and at the second-fastest pace in more than three years.

Optimistic growth projections also boosted job creation in October, with 30 per cent of survey members forecasting higher volumes of business activity by October 2023. Overall, confidence was at its highest level in just under eight years.

"Buoyed by the ongoing recovery in new work, service providers again took on extra staff, with an improvement in business confidence also supporting hiring activity," the survey said. On the inflation front, the

survey said there were mild accelerations in inflation rates for nput costs and output charges. 'Many companies indicated

that higher food, fuel and retail prices pushed up their overall expenses in October. With some of this additional cost burden shared with customers, prices charged for the provision of services likewise rose," Lima said.

At the sub-sector level, con-

business activity, new orders and employment. Finance & insurance came in second place in the rankings for these three measures while transport, information & communication was at the bottom.

Meanwhile, the S&P Global India Composite PMI Output Index -- which measures combined services and manufacturing output -- rose to 55.5 in October from 55.1 in September, pointing to a marked rate of expansion that outpaced its long-run average.

'There was a mild acceleration in growth of private sector activity in India, as a stronger increase in the service economy more than offset a slowdown among goods producers," it added.

The S&P Global India Services PMI is compiled by S&P Global from responses to questionnaires sent to a panel of around 400 service sector companies. The panel is stratified by detailed sector and company workforce size, based on contributions to GDP. Data collection began in December 2005.

Bank Of England Makes Biggest Interest Rate Hike In 30 Yrs

LONDON: The Bank of England has announced its biggest interest rate increase in three decades as it tries to beat back stubbornly high inflation fuelled by Russia's invasion of Ukraine and the disastrous economic policies of former Prime Minister Liz Truss.

The central bank boosted its key rate by three-quarters of a percentage point on Thursday, to 3 per cent, after consumer price inflation returned to a 40-year high in September.

The aggressive move was expected after a more cautious half-point hike six weeks ago and comes as the bank sees a "very challenging outlook" for the UK economy.

"High energy, food and other bills are hitting people hard. Households have less to spend on other things. This has meant that the size of the UK economy has started to fall," the bank said in its November monetary policy report.

In its latest projections, the bank expects the country "to be in recession for a prolonged period" and inflation to stay above 10 per cent in the near term.

The interest rate decision is the first since Truss' government announced 45 billion pounds (USD 52 billion) of unfunded tax cuts that sparked turmoil on financial markets, pushed up mortgage costs and forced Truss from office after just six weeks. AP

Rupee Falls 8 Paise To 82.88 Against US Dollar

MUMBAI: The rupee depreciated by 8 paise to close at 82.88 against the US dollar on Thursday, after the US Federal Reserve raised interest rates and maintained a hawkish stance.

At the interbank foreign exchange market, the local unit opened at 82.87 and witnessed a high of 82.74 and a low of 82.92.

It finally settled at 82.88 against the American currency, registering a fall of 8 paise over its last close of 82.80.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, rose 1.39 per cent to 112.89.

Global oil benchmark Brent crude futures slipped 1.16 per cent to USD 95.04 per barrel.

On the domestic equity market front, the 30-share BSE Sensex fell 69.68 points or 0.11 per cent to end at 60,836.41, while the broader NSE Nifty declined 30.15 points or 0.17 per cent to 18,052.70.

Foreign Institutional Investors (FIIs) were net buyers in the capital markets as they purchased shares worth Rs 677.62 crore on Thursday, according to exchange data.

Meanwhile, the Reserve Bank's rate setting panel on Thursday met to finalise a report for the government on why it failed to keep retail inflation below the target of 6 per cent for three consecutive quarters since January this year. PTI

Markets Extend Losses Post Fed Rate Hike

MUMBAI: Market benchmarks stayed on the backfoot for the second session on the trot on Thursday, in tandem with a lacklustre trend overseas after the US Fed delivered the fourth straight 75-bps interest rate hike to tame scorching inflation.

The 30-share BSE Sensex declined 69.68 points or 0.11 per cent to settle at 60,836.41. During the day, it tanked 420.95 points or 0.69 per cent to 60,485.14. Similarly, the broader NSE Nifty dipped 30.15 points or 0.17 per cent to end at 18,052.70. Tech Mahindra was the top laggard in the Sensex pack, dropping 2.66 per cent, followed by PowerGrid, NTPC, Infosys, Wipro, M&M and TCS.

In contrast, SBI, Titan, Bharti Airtel, Tata Steel, HUL and IndusInd Bank were among the winners, climbing up to 1.89 per cent.

"The US Fed hiked rates by 75 bps to a range of 3.75 to 4 per cent, which is at its highest level since 2008. However, it also indicated a tapering off of subsequent hikes in order to bring inflation back to around the 2 per cent target.

"This could be indicative of a similar position taken by the central bank in India to continue raising the repo rate in lower increments going forward to keep a check on inflation until global macros reach some level of stability," said Karan Desai, Founder - Interface Ventures. PTI

'India, UK Working Sincerely **On Free Trade Agreement'**

NEW DELHI: India on Thursday said it is working "sincerely" with the UK for finalisation of the proposed free trade agreement, days after Prime Minister Narendra Modi and his British counterpart Rishi Sunak agreed on the "early conclusion" of the deal.

"Both sides are working sincerely on the free trade agreement," External Affairs Ministry Spokesperson Arindam Bagchi said. His comments came when asked about the FTA during a media briefing.

"As we have said earlier, the matter of negotiations is best left to the trade ministers and their teams of officials. I cannot comment on the status. I certainly do not have any target date," Bagchi said. The issue of the FTA figured in the first telephonic conversation between the two prime ministers on October 27.

In a tweet on his talks with Sunak, Modi said: "Congratulated him on assuming charge as UK PM. We will work together to further strengthen our Comprehensive Strategic Partnership. We also agreed on the importance of early conclusion of a comprehensive and balanced FTA." In April, the two sides had set a Diwali deadline for concluding the FTA but the deal could not be finalised in view of differences over certain issues.

It is learnt that External Affairs Minister S Jaishankar and British Foreign Secretary James Cleverly took stock of the ongoing negotiations for the FTA during their talks here last week. PTI

Pertinently, a superficial look at the month of march, when J&K was standing at an unemployment rate of 25%, had brought into forth that roughly over 1.1 million people were jobless in I&K.

Another credible labor survey report which substantiates the chronic unemployment scenario in the region was published by the Union Ministry of Statistics and Programme Implementation. The urban unemployment since the highly infective second Covid wave in Union Territory of Jammu and Kashmir, remained at very high levels, as per the periodic labor force survey (PLFS) data.

However, as per the administration, unemployment in Jammu and Kashmir has remained a big concern for the past 70 years and in the absence of a private sector, people used to do anything to get a prestigious government job as it was considered a guarantee for a secure future.

For the first time in history of J-K, recruitments have been done on merit basis, in a transparent manner which is a living example of how corruption-free, transparent and just system contributes to the progress of the marginalized class and wherever wrongdoings were alleged, investigation was launched by credible and top law enforcement agencies, the administration said.

Even J&K's Lt Governor Manoj Sinha, last year, had said his focus is on providing job opportunities to 80 percent of the young population within the next five years.

Meanwhile, as per CMIE, India's national average was recorded at 7.6 percent.

and Vegetable Traders president Metha Ram Kriplani told PTI.

Kriplani, who is also a member of the Delhi Agricultural Marketing Board and president of the Kashmir Apple Merchants Association, listed several reasons for this.

"There was a quality bumper crop this season, but the expenses like packaging and transportation charges have almost doubled compared to last year. The rates are directly linked to the supply and demand, and since the supply is more, the product rate is down by about 30 per cent," he said.

Grower-cum-trader Bashir Ahmad Baba, a resident of Chrar-e-Sharief in central Kashmir's Budgam district, said hopes of a good return for the produce this season have dashed, and most of the growers and traders were apprehensive of their financial wellbeing.

"The frequent closure of the Srinagar-Jammu national highway due to landslides during the peak harvesting season and the stranding of fruitladen trucks for days together have had its impact as we were late to the mandis," Baba said.

The Jammu and Kashmir administration shifted the senior superintendent of police, Srinagar-Jammu national highway, in September after political parties slammed it for alleged failure to facilitate smooth movement of fruit-laden trucks from Kashmir to outside markets.

Chief Secretary A K Mehta visited the landslide-prone areas on the highway several times to ensure that debris was removed immediately and fruit-laden trucks cleared on priority. Baba said the expenses on each apple box weighing 16 kg is over Rs

500, which includes packaging, freight charges and use of pesticides and fertilizers but "we are only getting an average of Rs 400 per box"

More than half of Kashmir's population is directly or indirectly linked to the horticulture industry, which is said to be worth Rs 10,000 crore. The annual production of apple is around 21 lakh metric tonnes. It is cultivated over an area of 1.45 lakh hectares of land.

"The government has to come forward and rescue us, otherwise it is very difficult to overcome the huge losses given the prevailing conditions," Baba, who is also the Budgam district president of the Kashmir valley fruit growers and dealers union, said.

"The apple from both plains and hilly areas reached the markets in bulk together. Usually, the apple from plains of the valley comes before those from the hilly areas, especially Himachal Pradesh, which has also recorded a good crop this season," Ahmad said, adding that the markets failed to stabilise after the initial jerk.

"We have consistently rejected such statements and all parties concerned are well aware of our clear position on these matters. The Union Territory of Jammu and Kashmir and the Union Territory of Ladakh are and always will be integral and inalienable parts of India. No other country has locus standi to comment on the same," he added.

"As regards the so-called China-Pakistan Economic Corridor, we have consistently conveyed our protest and our concerns to China and Pakistan. CPEC includes projects on the sovereign territory of India under forcible and illegal external occupation.

In his talks with President Xi, Sharif reaffirmed his government's willingness to "commit to high quality development" of the Belt and Road Initiative(BRI) and highlighted the salience of the CPEC to Pakistan's economic and social development, according to the joint statement.

The statement said the Chinese side reiterated that the Kashmir issue was a "dispute left from history" that should be properly and peacefully resolved based on the UN Charter, relevant UN Security Council resolutions and bilateral agreements".

Supporting Baba's demand, Kriplani said the central government has to pay full attention to the horticulture industry in Jammu and Kashmir which has a lot of potential to generate employment across the country.

"It is our humanitarian and religious duty to safeguard them (growers) The government can provide subsidies on the products used in packaging, provide good quality cardboards, fix transportation charges and abolish tax on trucks transporting fruit. If there is a decline in expenses, farmers and those linked with the (apple) trade can be saved from distress," he said.

Kriplani advocated a waiver of interest on bank loans and also soft loans for farmers, saying, "The situation is such that they might lose a huge chunk of their capital this season and may not be able to pay back their monthly installments on loans."

He said the chamber was ready to share its experience, including organising regular workshops in the Valley, to modernise the horticulture sector.

Kriplani, a frequent visitor to Kashmir over the past many decades, suggested construction of macadamised roads covering all orchards for fruit transportation, setting up of controlled atmosphere (CA) cold stores at the village level and encouraging farmers to install the latest machinery for grading.

Advocating a duty on apples imported from Iran via Afghanistan to avoid taxes, he said it was the government's job to ensure that farmers in the country can sell their produce at right costs.

"Kashmiri apples are also exported to different countries, including Bangladesh. The government should take measures to include the product in duty-free items after taking up the issue with the governments concerned," he added.


