# **Chances High Of Big Earthquake In Himalayas, Need To Prep: Scientists**

Dehradun: Scientists on Wednesday said there is a strong possibility of a major earthquake in the Himalayan region and underlined the need for better preparation to minimise the damage to life and property. Tremors were felt in

Uttarakhand after a strong 6.6-magnitude earthquake iolted the remote mountainous region of western Nepal early Wednesday, killing six people. Senior geophysicist of Wadia

Institute of Himalayan Geology Ajay Paul said the Himalayas

have come into existence as a result of a collision between Indian and Eurasian plates. Due to constant pressure of the Eurasian plate on the Indian plate, strained energy accumulating under it keeps releasing itself from time to time in the form of earthquakes, Paul said.

"Occurrence of earthquakes due to accumulation of strained

energy under the Himalayas is a normal and relentless process. The entire Himalayan region is highly vulnerable to tremors and the strong possibility of a major earthquake is always there," Paul said. The magnitude of future earth-

quake might be of seven or more on the richter scale, he claimed. however, said the Paul,

magnitude 6.6 earthquake has struck Nepal, killing at least six people, injuring several others, and destroying multiple houses in the northwestern district of Doti, officials said. The earthquake, which hit at about 2am local time on Wednesday (20:15 GMT), sent tremors into northern India. Bhola Bhatta, deputy superintendent of police in Doti, said that four children were among the fatalities that occurred when eight houses collapsed after the earthquake Felt In New Delhi struck the mountainous western region. # Early Snowfall Blocks Leh Highway, Mughal Road

Light To Moderate Rain, Snow Till Nov 11: MeT Dept


Srinagar: The higher reaches of Kashmir Valley received fresh snowspell on Wednesday while rains lashed the plains, leading to the closure of strategic Srinagar-Leh highway and Mughal Road, connecting South Kashmir with Poonch and Rajouri districts in Jammu division.

According to a meteorological department official, the upper reaches of the Valley, including the famous hill stations of Gulmarg, Sonamarg and Pahalgam received fresh overnight snowfall.

The Affarwat mountain range in the ski resort, he said, was draped in a white blanket following fresh snowfall.

Also, the official said that Gulmarg recorded a low of minus 2 degrees Celsius while the maximum temperature was recorded 1 degree Celsius. Reports of snowfall have also been received from Chandanwari, Pisso Top, Sheshnag and the areas around Amarnath cave shrine in South Kashmir.

In the last 24 hours till 0830 nours Wednesday, the MeT



official said Pahalgam received 0.5mm of rainfall while Gulmarg amassed 2cms of fresh snowfall. The MeT official said that from November 9 evening to November 11 forenoon, light to moderate rain/snowfall over higher reaches is expected at many places

However, he ruled out the possibility of a major rain or over

snowfall during the spell. The official also said that on November 11, the weather will be generally cloudy, while from

November 12-16; it will remain "fair to partly cloudy". Regarding probable impacts, he said, snowfall and low temperature may lead to temporary disruption of surface transportation, mainly Highway, Leh-Manali road on November 10 and 11.

# Army's Operational Readiness Should **Always Be At Peak: DM**



Delhi: Defence New Minister Rajnath Singh on Wednesday called on top Army commanders to always maintain the force's operational readiness at its peak level amid the lingering border standoff with China in eastern Ladakh.

In an interaction with the commanders at their ongoing biannual conference, Singh reasserted the faith of the billion-plus citizens in the Indian Army as one of the "most trusted and inspiring organisations" in

the country. In the five-day conference that began on Monday, the commanders are carrying out a comprehensive review of India's national security challenges along the borders with China and Pakistan besides delving on ways to bolster the 1.3 million-strong force's military prowess.

The main highlight of the third day's proceed-ings was Singh's interaction with the senior leadership of the Army, which was preceded by a briefing on 'Transformational



imperatives for a future ready force'.

The Army said the defence minister commended the force for maintaining high operational readiness towards ensuring security

and national sovereignty. "I have full faith and confidence in the Indian Army and its leadership," he said. The defence minister also noted that the Army ought to be prepared for any operational contingencies, and hence the operational readiness should always be at its peak level.

In a tweet, Singh described his interaction with the commanders as "productive". | More on P10

### **Justice** Chandrachud **Sworn In As** 50th CJI

New Delhi: Justice Dhananjaya Y Chandrachud, who was part of several Constitution benches and landmark verdicts of the Supreme Court, was on Wednesday sworn in as the 50th Chief Justice of India, stepping into the shoes of his father 44 years after he became the country's top judge.

President Droupadi Murmu administered the oath of office to Justice Chandrachud, the senior most judge of the Supreme court who was involved in historic judgements like on the Ayodhya issue that paved the way for the construction of a Ram Temple at the disputed site in Uttar Pradesh and Right to Privacy, at a brief ceremony at the Rashtrapati Bhavan. Justice Chandrachud took the oath in English and in the name of God.

Justice Chandrachud, often referred to as DYC in legal circles and who is known for giving law a human face, began his first day as the CJI garlanding the Mahatma Gandhi statue in the Supreme Court premises.

"Serving common people is my priority. Please look forward. I will work for all the citizens of the country. Be it in technology or be it in registry...or be it in judicial reforms, I will take care of citizens in every aspect," said Justice Chandrachud in his brief interaction with journalists as he took a round of the apex court premises.

Justice Chandrachud, who was accompanied by his wife Kalpana Das, said heading the Indian judiciary was a "great opportunity and responsibility".

In response to a query as to how he will ensure trust of people in judiciary, he said, "I will ensure trust of citizens not only through words but through my work".

Justice Chandrachud, who succeeded Justice UU Lalit, will be the CJI until November 10, 2024, a day before he completes 65 years. Justice Lalit had a short tenure of 74 days.

Justice Chandrachud, who had dubbed dissent the "safety valve of democracy" during an earlier court hearing,

# **RS 87.88 CR BANK FRAUD CASE CBI Arrests Two Ex-Directors Of Jammu Firm**

Jammu: The CBI has arrested two former directors of a private paper manufacturing company in a multi-crore bank fraud case in Jammu and Kashmir's Kathua district, an official said on Wednesday.

The case against Bharat Papers Ltd and others, including its managing director and directors, was regis-tered on February 12, 2020 on a complaint from State Bank of India's, SAM Branch in Ludhiana, Punjab, a CBI spokesperson said.

The two then directors Anil Kumar and Praveen Kumar were arrested on Tuesday evening and produced before a magistrate who remanded



them to seven days in CBI custody on Wednesday.

According to the CBI, the accused in the conspiracy with unknown SBI officials had cheated the bank of Rs 87.88 crore (which with interest amounted to Rs 121.13 crore)



# **Air Pollution Exposure Linked To Higher Cardiovascular Disorder Risk: Study**

ong-term exposure to air pollution is associated with additional risk of cardiovascular disorders in those already having an underlying heart condition, according to a study.

The research, published recently in the Journal of the American College of Cardiology (JACC), evaluated the association between long-term exposure to small particulate matter 2.5 (PM2.5) and 10 (PM10), and coronary vasomotor disorders in patients with nonobstructive coronary artery disease (NOCAD), which is associated with poor cardiovascular outcomes.

Coronary vasomotor disorders are characterised by impaired ability to adequately adjust coronary blood flow to oxygen demand due to dysfunctional vasomotor function.

The researchers from Catholic University of the Sacred Heart in Rome, Italy and colleagues studied patients with myocardial ischemia and NOCAD undergoing coronary angiography and intracoronary provocation test, an established method for assessment of coronary artery spasm.

Both patients with chronic myocardial ischemia and nonobstructive coronary arteries and myocardial infarction with nonobstructive coronary



arteries (MINOCA) were enrolled.

Based on each case's home address, exposure to PM2.5 and PM10 was assessed.

The study included 287 patients with a median age of 62 years. 149 of the participants were male and 161 had myocardial ischemia and nonobstructive coronary arteries while 126 had MINOCA. Higher exposure to PM2.5 and

PM10 in patients with myocardial

ischemia and NOCAD is associated with coronary vasomotor abnormalities, the researchers said.

In particular, PM2.5 is an independent risk factor for the occurrence of epicardial spasm and MINOCA as clinical presentation, they said.

"Our study shows for the first time an association between long-term air pollution exposure and the occurrence of coronary vasomotor disorders, suggesting a possible role for pollutants in determining myocardial ischemia in patients with NOCAD," the authors of the study noted.

"In particular, we show that PM2.5 and PM10 are independently associated with a positive coronary provocation test in these patients, and that PM2.5 is positively related to the occurrence of epicardial spasm as opposed to microvascular spasm," they added.

# Leakage In Pipeline Damages House In Baghwanpora

Srinagar: A Resident of Baghwanpora, Lal Bazar has alleged that the Public Health Engineering (PHE) department has failed to fix leakage in a pipeline near Masjid-e-Imam Hussain (AS) which has rendered serious damage to his house.

Ghulam Mustafa, who lives near Imam Hussain Mosque alleges that it has been around two weeks that the issue has been brought up to the notice of PWD officials. However, he says that PWD officials have not been able to come to the rescue of the affected family.

Mustafa says his house has developed major cracks and he and his family are living in constant fear.

"The leakage in the PWD pipeline is causing severe damage to my house, walls are developing cracks and the water is seeping deep down the earth which may

damage the foundations of my house" Mustafa said. "The officials are priori-

tizing a road over my house," are we awaiting a human catastrophe" he questioned.

Mustafa's family members also alleged the inordinate delay in fixing the pipeline is causing distress to the family. Speaking to Kashmir Ob-

server, Executive Engineer PWD Ishfaq Ahmed said that he is aware about the issue and he has sought permission from R&B city roads so that they can dig the road and fix the pipeline.

"The road has been macadamized recently and without the permission of the R & B department we cannot dig the road. I am awaiting permission, once we get it, I will restore it in the next hour. Everything is not in my hand" Ishfaq said.

"I have written a letter to the R&B officials and as soon as I get the permission we will fix the leakage" he added.



# **'Congestion In Old City Makes It Vulnerable To Fire Incidents'**

Srinagar: The Joint Director Fire and Emergency Services (F&ES) Kashmir Bashir Ahmed Shah on Wednesday stated that the fire incidents have shown a considerable decline in Kashmir in the last few years but downtown Srinagar continues to be a challenge and vulnerable to fire given congested localities and narrow lanes Bashir Ahmed Shah further

said that given the figures available with them since 2016, fire incidents have shown a tremendous dip across Kashmir. "Reasons are obvious that people use very less wood in the construction. Wooden roofs first and second storeys of new houses have been replaced by concrete cemented slabs," said Shah. He said that final roofing is made of wood and overall there is concrete construction including walls etc of new houses.

Shah, however, said that downtown areas of Srinagar continue to remain vulnerable to fire incidents given congested localities and narrow lanes which makes it difficult to maneuver for the firemen when it comes to dousing of flames. He urged people across Kashmir, especially downtown, not to call police stations in case of a fire incident and instead right away dial 101 and give the exact location of the incident site.

As per the figures available, property worth over Rs 70 Crore has been damaged in various fire incidents across Kashmir highest after 2016 when the figure was property worth Rs 87.41 crore was damaged. The data states that this year, Srinagar recorded the highest ever fire calls at 384 followed by Baramulla at 252. "In Srinagar, property worth 2914, 96 lakhs were damaged in the ensuing year in various fire related incidents," the figure suggests.

Replying to a query about shortage of manpower in the F&ES department, the Joint Director said that after 700 employees were inducted in the department through recruitment in 2020, the shortage of manpower was addressed to a large extent but the shortage of officers' remains. About availability of new vehicles, he said even though the department procured some new vehicles while as world bank also provided some fire dousing vehicles, but majority of the vehicles available with the department are outdated and need to be replaced by latest ones—(KNO)



# US hostage's wife wants write-ups back

rinagar-The wife of an American hostage missing in Kashmir for more than five years has issued an emotional appeal for the return of draft articles he wrote for foreign journals.

"If I never see my husband again, at least to have something he wrote would be of comfort to me Jane Schelly said in a letter sent to media offices in the Kashmir summer capital.

Schelly is the wife of Donald Hutchings, who was abducted along with five other foreigners in Kashmir by Muslim militants in July 1995.

One of the hostages escaped, one was beheaded and the other four—included Hutchings remain missing, presumed dead.

Schelly said Hutchings used to write for some journals, and the rough articles were with Him when he was kidnapped.

"Some of the pages of that written material might exist somewhere, left in some hut or home, passed to the side and forgotten, she said, appealing to anyone who might have found the papers to send them to her.

Hutchings would have been 48 on November 12, and Schelly said the return of his writings would comprise the perfect birthday gift.

"I have done my utmost to find out what has happened to him... There is no conclusive answer," she wrote. If 1 have no closure to this sad situation ...only the assumption that my husband and three westerners were most likely killed. (AFP)

## **Indians Make Up Largest Foreign-Born Residents In England And Wales: Census**

early one in six people living in England and Wales last year were born outside the country and Indians constituted the largest chunk at 1.5 per cent of residents, according to the latest

statistics based on the country's 2021 census data. The UK's Office for National Statistics (ONS) found that India remained the most common country of birth outside of the UK last year at 9,20,000 people, followed by Poland at 7,43,000 people or 1.2 per cent of residents and Pakistan at 6,24,000 (1 per cent).

One in six usual residents of England and Wales were born outside the UK, an increase of 2.5 million since 2011, from 7.5 million (13.4 per cent) to 10 million (16.8 per cent), the ONS said in a release.

India remained the most common country of birth outside the UK in 2021, it said.

The top three countries of birth outside the UK for England and Wales remain unchanged as India, Poland and Pakistan since the last census 10 years ago, with the numbers rising across all categories - India from 6,94,000, Poland from 5,79,000 and Pakistan from 4,82,000 in 2011.

The census data also shows that Polish (760,000, 1.3 per cent), Romanian (550,000, 0.9 per cent) and Indian (369,000,

since 2011 when 36.7 per cent of London residents were non-UK born and 21.0 per cent had a non-UK passport. The number of people who listed Romania as their country

of birth grew by 576 per cent since the previous census, from 80,000 in 2011 to 539,000 in 2021 marking the highest out of any country, driven by working restrictions for Romanian citizens being lifted in 2014.

"The census paints a picture of how the make-up of the population has changed in the past decade. That decade, of course, saw us leave the EU as well as live with the pandemic," said Jon Wroth-Smith, Census Deputy Director.

"While these events may have had an impact on people's decisions or ability to migrate or travel at a given time, the census tells us about the change over the whole decade who was living here in March 2021, compared with March 2011. We can see Romanians have been a big driver in this change, while there have also been increases due to migration from India, Pakistan and Poland, as well as southern European countries such as Italy," he said.

"We can also see that migration in the year prior to the census was lower in 2021 than it was in 2011. This is likely, in large part, due to the various travel restrictions in place during the coronavirus pandemic," he added

London remained the region with both the largest proportion of people born outside the UK and the largest proportion of people with non-UK passports. In 2021, more than four in 10

(40.6 per cent) usual residents in London were non-UK born, and more than one in five (23.3 per cent) had a non-UK passport. This is a marginal increase

The United States and Jamaica fell out of the top 10 non-UK countries of birth in 2021. Italy entered the table in sixth place behind Romania (fourth) and Ireland (fifth), and ahead of Bangladesh (seventh), Nigeria (eighth), Germany (ninth) and South Africa (10th).

Those born in the European Union (EU) made up 3.6 million (36.4 per cent of all non-UKborn residents) of the population, an increase from 2.5 million in 2011.

### **Chennai Man Forges RBI** Permission Letter To Run Bank, Arrested

CHENNAI: The Chennai Police has arrested a person for forging RBI permission certificate for running a bank in different parts of the state. Fake passbooks, deposit forms, debit and credit cards among others were found in his possession, a police release said.

The man identified as Chandrabose, operated the Rural and Agriculture Farmers' Cooperative Bank (RAFC) in 9 cities including Chennai and Erode.

Action against him was taken based on a complaint from the Reserve Bank of India (RBI) The arrested man even procured credit

cards of another bank and pasted his 'bank's' sticker on them to be given to customers, police said.

There was no permission from RBI for Chandrabose to run the bank and he had forged a permission letter, they said.

"He has some idea of banking.. had prepared passbooks, deposit slips..." Chennai Police Commissioner Shankar Jiwal said.

A luxury car was recovered from him while ₹56.65 lakh money held in the fake bank's deposit has been attached.

## SC To Rule On Azam Khan's **Disgualification Today**

**NEW DELHI:** The Supreme Court on Wednesday directed the Election Commission not to issue till November 10 the notification for the assembly bypoll in Rampur Sadar in Uttar Pradesh, which fell vacant following the disqualification of Samajwadi Party MLA Azam Khan after his conviction in a hate speech case.

A bench headed by Chief Justice DY Chandrachud directed a special sessions court to hear and decide on Thursday itself the appeal of Azam Khan seeking a stay on his conviction so that he survives disqualification as a lawmaker.

The Supreme Court said the Election Commission can issue the notification for the bypoll on or after November 11 once the sessions court decides on Khan's plea.

On October 27, Azam Khan was convicted in the hate speech case and sent to three years in jail by a Rampur court. The MP-MLA court in Rampur

also granted bail to the MLA in the 2019 case.

On October 28, the Uttar Pradesh Legislative Assembly Secretariat had announced the disqualification of Khan from the House.

# When Herd Of 24 Elephants Drank **Country Liquor**

**KEONIHAR:** People of a village in Odisha went inside a forest to prepare 'mahua', a traditional country liquor, but found that a herd of elephants already devoured the water fermented with the intoxicating flowers and are

in deep sleep. The villagers living near Shilipada cashew forest in Keonjhar district saw that a total of 24 jumbos, who were drunk, apparently were sleeping near the place where mahua flowers were kept in water in large pots for fermentation. "We went into the jungle at around 6 am to prepare mahua and found that all the

pots were broken and the fermented water is missing. We also found that the elephants were sleeping. They consumed the fermented water and got drunk," Naria Sethi, a villager, said.

There were nine tuskers, six females and nine calves.

'That liquor was unprocessed. We tried to wake up the animals but failed. The forest department was then informed," he said.

Forest department personnel after reaching the spot in the jungle under the Patana forest range had to

beat drums to wake the herd up. The elephants then went deep inside the forest, said Ghasiram Patra, the forest ranger. Sethi said the herd left the place at around 10 am.

ephants got drunk after consuming fermented mahua.

"Maybe, they were just resting there," Patra said.

Villagers, on the other hand, insisted that they spotted the elephants sleeping in intoxicated conditions at various places close to the broken pots on Tuesday.

The flowers of Mahua tree (Madhuca longifolia) are fermented to produce an alcoholic drink also called Mahua. Tribal men and women in various parts of India traditionally make this liquor.

JAMMU: The Jammu and Kashmir government on Wednesday deployed the Visiting Officers of the just concluded Phase IV of 'Back to Village' Programme, as the Prabhari Officers for the concerned Panchayat(s) for the next one year or till decided otherwise.

The Visiting Officers had been nominated by the General Administration Department or by the Deputy Commissioners before the beginning of the Phase IV of the B2V programme across the Union Territory of Jammu and Kashmir.

According to an order issued by the General Administrative Department, the Prabhari Officer(s) shall make quarterly physical follow up visits to the Panchayat(s) that he or she was allotted besides monthly virtual participation on First Monday of every month. The first follow up visit shall be held from December 1-15, 2022.

Prabhari Officer The shall guide and mentor the Panchayat(s), support and monitor all developmental activities and remove bottlenecks, if any, in the developmental process.

The Panchayat Prabhari shall ensure resolution of legitimate grievances and demands, and follow up on the several deliverables of the 'Back to Village' Programme. The order has elaborated the deliverables as "Swachh Gram Programme saturation, dissemination of information regarding Jan Bhagidari, issuance of Land Passbooks, 100% saturation of Golden Cards, completion of pending inheritance mutations by the concerned Revenue officers, distribution of e-Shram cards among all eligible beneficiaries, 100% Aadhar Seeding/ Penetration, rejuvenating selfemployment across all Panchayats by facilitating interaction of eligible youth with concerned agencies/marketing awareness programmes, banks and other agencies/line departments,

progress on Jal Jeevan Mission, progress on Panchayat Paani Samitis, formation/activation of Panchayat Youth Clubs and progress achieved under Mission Amrit Sarovar.

The Prabhari Officer(s) shall lay special focus on 101 deliverables of various departments inter-alia priority areas mentioned above. They shall maintain a continuous liaison with the people of the Panchayat and facilitate appropriate communication between the Panchayat and local administration/line departments, ensuring redressal of grievances/issues locally. All line departments shall ex-

tend cooperation to the Prabhari officers to their satisfaction. Any non-responsiveness/non cooperation by the representatives of line departments shall be reported to the concerned Sub-Divisional Magistrate/District Magistrate for appropriate action.

The government has ordered that the Department of Rural Development and Panchayati Raj shall be the Nodal Department for coordinating the exercise, and shall devise an objective format/mechanism for monitoring the progress of the above deliverables.

# **Climate** Crisis

nited Nations chief Antonio Guterres has warned the world leaders gathering in Egypt for the COP27 climate summit that mankind must choose between cooperating or committing "collective suicide" in the fight against global warming. Nearly 100 heads of state and government are assembling in the Red Sea resort of Sharm el-Sheikh, where they are being urged to further reduce emissions and provide financial support to developing nations already suffering from the effects of global warming. "Human-ity has a choice: cooperate or perish," Guterres told the summit on Monday.

This year the world has been buffeted by successive natural disasters that have taken thousands of lives and cost tens of billions of dollars. The countries such as Kenya, and Somalia witnessed droughts, Nigeria and Pakistan were wracked by devastating floods and vast swathes of the globe including the United States experienced unprecedented heatwaves. This has made people across the world understand the urgency of the creeping climate change and they want world leaders to act.

The Indian subcontinent is one of the worstaffected regions of the world. In recent years, the region has experienced the detrimental fallout of climate change. India, Pakistan and Bangladesh between them are home to around 1.7 billion people and any major disruption in the climate pattern could severely impact them. So, the three countries, as well as other countries in the region need to wake up and work toward a global response to the looming catastrophe.

To be sure, India has supported global action and initiatives to combat climate change. Addressing the COP26 summit last year at Glasgow, Prime Minister Narendra Modi said 'one sun, one world, one grid' can be crucial to re-establishing the environmental balance.

A report last year by an UN-appointed panel warned of the far-reaching effects of climate change if no immediate measures were taken to remedy the damage already done. The report caused a global alarm after its release.

There is thus an urgent need for the world to come together and take remedial measures to preempt the catastrophe. In Kashmir too, climate change has led to considerable changes in weather patterns. Triggering alarm bells is the slowly shrinking glaciers that are the source of the Valley's water bodies. But the factors causing climate change are global in nature and so any effort to reverse the damage has to be backed by the world. And this should be done sooner than later. Time is running out fast.

#### OTHER OPINON

Muddying the waters rought by the Centre in 2019, this was challenged on the ground that it provides reservation only on the basis of economic criteria, excludes the poor among the scheduled castes/scheduled tribes/other backward castes, and breaches the 50% cap on reservation set by the apex court in its Indira Sawhney judgment. Given how research has shown that educational attainment, which is necessary for upward mobility, has a strong link with economic background than caste, the apex court is on the right track. For a long time now, there has been resentment among many general category constituents who are deprived of better education and job opportunities as they do not get the "benefit" of reservation. While the petitioners had argued that reservation was a tool for representation to address discrimination and not deprivation through financial upliftment, the apex court endorsed the view that reservation is affirmative action, available to disenfranchised groups. The apex court was also right in calling for a sunset stipulation for reservation. Indeed, the Constitution itself, through Article 334, had envisioned a winding down of reservations accorded to the groups that had faced discrimination throughout history. After all, there is a defined sunset of 2030 for SC/ST reservations in legislatures. The entre and civil society activists need to build consensus on a similar end-date for SC/ST/OBC reservations under Articles 15 and 16 of the Constitution. Reservation is neither an end in itself, as Justice JB Pardiwala reminds in the majority judgment, nor should it be allowed to become a "vested interest" furthering divisions through competitive caste politics. However, the apex court's verdict that the EWS quota doesn't violate the basic structure of the Constitution on the 50% cap on reservations will muddy the waters for a long time to come. Indira Sawhney had set a "Lakshman rekha" for the quantum of reservation that could be given, with a provision for exception in "extraordinary circumstances". But the states' trigger-happy use of the exception provision has meant that Tamil Nadu, Andhra Pradesh, and Chhattisgarh, to name a few, have already breached the cap. Indeed, the Supreme Court, when it declared Maharashtra's Maratha reservation law "unconstitutional", had said that it didn't find any substance "to revisit the Indira Sawhney judgment or referring it to a larger bench. The judgment has been upheld by at least four Constitution Benches". So, the latest SC view has the potential to open the flood gates for a never-ending race on providing more reservations. If the government goes ahead and argues in favour of creating a category of reservations beyond the 50% cap, it will compromise merit as the opportunities for those left in the non-reserved general category will shrink further. The other point that needs to looked into is the setting of an annual family income of `8 lakh as a ceiling to determine if someone belongs to the EWS category. Pakistan is on the edge, Imran Khan's shooting could tip it over



was foreshadowed.

Thursday's assassination attempt on former Pakistani Prime Minister Imran Khan was shocking, if not surprising. In a rally in his home constituency of Mianwali in early October, he had asserted that he had information of a plan to kill him. If it were to happen, a video revealing those names would be released, he said, adding that the motive would be religious.

He blamed Maryam Nawaz, daughter of Pakistan Muslim League-Nawaz (PMLN) chief Nawaz Sharif and niece of Prime Minister Shehbaz Sharif, and other leaders from her party of accusing him of blasphemy. In Pakistan, the mere whisper of blasphemy can carry an executioner's sword.

A confessional video of the alleged gunman on Thursday, Naveed Ahmed, appears to support Khan's accusation. A resident of the area where the rally was attacked, he offered no remorse, instead regretting that he did not manage to kill Khan, who received a bullet wound to his leg.

"Imran Khan thinks he is the Prophet," Ahmed said. On his phone reportedly were videos of the leader of the extreme-right political party Tehreek-e-Labbaik (TLP). The TLP has weaponised blasphemy for votes and protests, with assassinations embedded in its DNA.

The TLP's icon is Mumtaz Qadri, who shot dead the governor of the Punjab Salman Taseer in 2011. Taseer had been publicly campaigning for a presidential pardon for a Christian woman Asia Bibi, who ath row victed of blasphemy. When Qadri was executed for assassinating Taseer, the massive crowds at his funeral portended the subsequent rise of the TLP.

PTI leaders were continuing to play the religion card against their rivals even after the shooting.

Indeed, the TLP has main-streamed both blasphemy and the rightward shift of major parties. Religion sells in Pakistan, on TV, at the mall, and at the polling booth. More worrying is that it isn't rightwing parties – which have effective street power but limited electoral power - that are cashing in, but more mainstream ones such as PTI and PMLN

Khan himself has used religion effectively on the comeback trail after he was ousted from power through a parliamentary vote in April by a coalition of parties led by the PMLN and the Pakistan People's Party (PPP). He has framed his struggle to return to power as a jihad, a battle between good and evil.

Arrayed on the side of evil is the current political set-up - a coalition of parties representing the old guard and the military establishment - who removed him from power allegedly at the behest of the US.

Khan's recipe of victimhood a dollop of righteousness, a sprinkling of anti-Americanism, a dash of nationalism and a spoonful of corruption allegations against his opponents — is being lapped up by a fiercely loyal supporter base, young voters and fence-sitters. He has pulled in the votes in byelections, and the crowds at rallies across Pakistan. Indeed, the PTI and Khan have been able to resurrect themselves after an unpopular turn in government.

Khan was on day seven of his long march to push the military esKhan's subsequent announcement of the march indicated that those talks had broken down. It was clear that the focus of Khan's onslaught had shifted from the usual political rivals, to also include his former benefactors — the military.

Although Khan's playbook is new in Pakistan, his falling out with the military establishment that helped him to power in 2018, and the questions around the assassination attempt against him follow all-toofamiliar patterns.

Former Prime Minister Nawaz Sharif's repeated fallouts with the military have led to a coup and two exiles. Benazir Bhutto was removed from power several times with the assistance of the military. She also accused former military dictator Pervez Musharraf of threatening her prior to her return to Pakistan and subsequent assassination. While Bhutto's killers were allegedly the Tehreek-e-Taliban Pakistan, Musharraf acknowledged potential state involvement in her death. He was declared a fugitive in her murder case. The subsequent investigation smacked of a cover-up.

Since the attempt on Khan's life, there have been pockets of protests across Pakistan, most notably in front of the Peshawar Corps commander's residence. In a video message on behalf of Imran Khan, senior PTI leader Asad Umar accused a serving general of being behind the attack, as well as Shehbaz Sharif, the current prime minister. PTI's former information minister Fawad Chaudhry has called for revenge. Khan may no longer have the army on his side, but he certainly has both popular support and a wave of sympathy, and his party seems to be looking to press the advantage. Pakistan is on the edge — of something old and something new. In this tinderbox of religion, hate, populism, an unequal civil-military relationship and poor governance, one tiny spark could also mean more violence. Perhaps it was foreshadowed.

tablishment and government to call elections, when he was shot. With inflation at eye-watering levels and no story of hope or hate to tell, the current government and the powerful military have been unable to dent his rising popularity.

The march coincides with the likely announcement of a new army chief this month. That's no coincidence. Khan has said he doesn't think the current leadership has the moral standing to appoint the head of the most powerful institution in Pakistan.

He has also accused members of the top and mid-tier military brass of being traitors for supporting the "crooks" in power and ordering the torture of key aides. But he held off announcing a march during backchannel talks with the army under General Qamar Javed Bajwa, who is on an extension in his tenure.

# Kashmir Out of Valley In Winters, When My Father Wears Pheran, People Get Very Curious About His Attire. They Sometimes Say, 'We Were Waiting For You To Wear It This Season.'

Dyuti Raina, a resident of Uttam Nagar in Delhi, lives in a cluster for a reason. "It might help us in preserving our culture," she says.Kashmiris living outside Jammu and Kashmir (J&K) have preserved their culture in the toughest of times. Be it unwanted circumstances or the desire for better economic opportunities, Kashmiris away from their land are fighting for their identity.

"It may sound stereotypical," Dyuti says, "but one thing is for sure that one can take Kashmiris out of Kashmir, but not Kashmir out of Kashmiris."

There are only two Kashmiri families living other than hers in the same locality. Dyuti's family has been living in Delhi for the last 30 years and she believes that people still do not know much about their culture. "For them," she says, "we are just Pandits from Kashmir whom they assume to be vegetarians."

A majority of Kashmiri Pandits are followers of Shaivism and are non-vegetarians. KPs have very different cultural practices from the people living in other parts of the country when it comes to culture and religious practices.

Dyuti still remembers an incident when one of her friends gave her a strange look while she was having fish and mutton in Prasad (an item served after pooja).

"Hindus here find it very amusing," she says. "They say, 'Oh my god! You call yourselves Brahmins?" She opines that the Kashmiri Pandits living outside J&K are often stereotyped.

A good number of Kashmiri Pandits who migrated to other states believe that they are living here just for survival and the actual place where they belong, is Kashmir.

Giving an example of Pamposh Enclave, a Delhi neighbourhood largely dominated by Kashmir Pandits, Dyuti strongly believes that if Kashmiri migrants live together in large clusters, they can sustain their culture and rituals.

The thing that disturbs her the most is that many Kashmiri Pandits of her generation are drifting away from their culture



and language. "A good number of KPs are trying to instill Kashmiri values in their children, but I wonder if the same continues with the next generation."

Other than Pamposh and a few colonies in Faridabad, many Kashmiri migrants are scattered in different parts of Delhi and its neighboring cities.

Shriya Bhat's family has been living in Noida for many years and they never faced any resistance from non-Kashmiris for following their rituals and customs. "I personally have never faced such a situation," he says.

Shriya agrees with Dyuti that living together might help the migrants to inculcate their cultural values, but her parents have always tried to adhere to the traditional practices of their community.

"Some people are indifferent," he says, "but at the same time many people are curious also, to know about our culture."

Shriya's family has been living outside J&K for almost three decades now. "My parents tell me that many people used to have a lot of red meat when they were in Kashmir, but now because of different climatic conditions, people do not eat red meat very often."

While talking about her family's style of living, Shriya adds a pinch of humour. "In winters, when my father wears pheran, people get very curious about his attire. They sometimes say, 'We were waiting for you to wear it this season.'"

Talking of carrying forward the culture and language to the coming generation, he says the surrounding matters a lot. "I have been to Kashmir a couple of times and everyone speaks Kashmiri there, which is not the case here in the National capital Region (NCR)."

Apart from Kashmiri Pandits, many Kashmiri Muslims are also living in other states of India for many years.

Nayaab Shahir left Kashmir in 2000 and settled in the NCR when he was just two years old. "Initially," he says, "we used to live in Daryaganj (a suburb in Old Delhi), it was a Muslim dominated area and my family witnessed a huge cultural amalgamation there. My father tells me that they used to have very simple Iftaar back in Kashmir, but now my family prepares iftaari just like people do here."

For Nayaab, Kashmir is still a home away from home. He regularly visits his native hometown with his family. He asserts that Kashmir is very rich in culture and cuisine. "There are few things you can only get in Kashmir, such as Kashmiri Saag."

Though his family has adapted to the environment here, their heart still lies in Kashmir. Similarly, a community that equally belongs to Kashmir and is still lesser known, is the community of Kashmiri Sikhs.

Navneet Kaur belongs to a Kashmiri Sikh family but was born and brought up in Punjabi Bagh area of Delhi. Although Kaur has never been to Kashmir, she gets nostalgic when she hears anyone talking about the place.

"Whenever my father comes across a Kashmiri, an end to end grin appears on his face," she says cheerfully. "You can clearly see the never ending-bond of Kashmiriyat which is still intact."

This brethren feeling binds all and sundry living outside their homeland. Not only they cherish their culture, but celebrate their unique identity, especially on the special occasions and festivals.

Faisal Wangnoo is living in Delhi since 1999 with his family. While he calls himself a Delhi boy, inside he is still a Kashmiri Delhi wala.

Apart from nostalgia, Faisal believes that there are many stereotypes attached to Kashmiris living outside Kashmir. "People ask me about Kashmir as if I am still living there."

Faisal is of the view that a large number of young Kashmiris are moving out of J&K in search of better opportunities and livelihood. But the shift is not always easy, especially for a Kashmiri.

"But it's the Kashmiriyat that has helped the Kashmiris living outside Kashmir in preserving their culture," he says. "The art and values which are integral to our culture are driving us, even outside Kashmir."

# Threat to Kashmir Fish

# Nonindigenous species are posing a threat to the native fish of Kashmir.

Kashmir houses a plethora of rivers, lakes, and fast running streams. An angler's paradise, the valley is gifted with the alluring water bodies like Dal Lake, Wular Lake, Nageen Lake, Indus, Jhelum and snow-fed streams like the Sindh, Hipora, Aripal.

Kashmir provides ample opportunities for the development of fisheries. Fishing is a big business in Kashmir through spring and summer. Several species of fish like Schizothorax, Oreinus, Glyptothorax are characteristically Palearctic fish that have reached Kashmir across the Himalayas. Palearctic region comprises of terrestrial ecoregions of Europe, northern Himalayas in Asia, northern Africa and central parts of the Arabian Peninsula.

Johann Jakob Heckel, an Australian zoologist, found out that no fish of Indian plains could reach the valley since they have to cross through 30-miles of rapids and rocky gorges, concluding that the fish in the valley is completely different from the rest of India.

Schizothoracine fish or snow trouts locally known as Alegad inhabit both lentic (standing) and lotic (flowing) water bodies of Kashmir. Five species of snow trouts are present in the valley which include Schizothorax esocinus (Chirru) Schizothorax curvifrons (Satter gad), Schizothorax niger, Schizothorax plageostomus and Schizothorax labiatus.

The endemic fish have elongated and subcylindrical fleshy bodies and are known to be tastier and free of diseases. A pollution-free water body is characterized by the presence of snowtrouts. Sunder Lal Hora, an ichthyologist, found out in his study that the origin and evolution of Schizothoracine occurred during the first interglacial period when turbulent streams were formed in Central Asia on account of the melting of ice. In recent years Alegad has seen a rapid depletion in the valley. Heckel who vis-

ited Kashmir in 1838 reported 16 species of snowtrouts but at present only five species of the fish are found in the valley. Several man-made factors are responsible for the deterioration of the endemic species.

An internal study conducted by Wildlife Institute of India, Dehradun reported by Times of India has revealed, "Climate change will affect around 150 native fish species of the Himalayan states, including Uttarakhand, Himachal Pradesh, Jammu & Kashmir and Arunachal Pradesh." Common snow trout, found in the Himalayan region and much sought after as a food fish, alone would lose around 21% of its existing space of 16,251 square kilometers, adds the study.

Brown trout introduced by the Britishers in Jammu & Kashmir in 1860 for fishing sports, has turned out to be a consequential threat to the snowtrouts. The nonindigenous breed is carnivorous and is found at high altitude in cold water unlike the endemic species which is herbivores and is found in cool water in mild altitude.

The increasing temperature forces Schizothorax niger move upward in search of food and that causes the conflict between the two species. The eggs and young ones of the snowtrouts become easy targets for the brown trout.

The introduction of exotic species like carp having prolific breeding, in Kashmir valley has resulted in a sharp decline of the native species. Carp was introduced in Kashmir in 1959 to accelerate fish yield, since then it has become the major commercial fish in the valley.

Excessive use of herbicides, pesticides, and fertilizers by the farmers results in eutrophication that is another major cause of the declining number of Alegad.


Eutrophication is the excessive growth of nutrients on the surface of the water body which causes a dense growth of algae, blocking the sunlight from reaching the aquatic flora and fauna.

Schizothoracine which survives in clean water finds it difficult to accommodate in such conditions resulting in heavy loss of the species.

Also, due to deforestation, a significant amount of eroded soil has entered the water bodies and destroyed the breeding ground for the fish.

During the spring season, lakes, rivers, and streams have an abundance of water due to the unprecedented melting of glaciers as a result of global warming.

The fish try to go upstream and lay their eggs in shallow areas during spawning. Once the melting stops the water level decreases and the fingerlings are trapped, finding it difficult to go back to the mainstream.

# **Twitter Job Cuts** What Are Digital Layoffs And What Do They **Mean For Employees And Companies?**

lon Musk is progressing plans to slim down Twitter since he bought the 396 million-member platform for USD 44 billion (38 billion euros) on October 27.

Musk's deal has taken Twitter private, dissolved the platform's board and enhanced his unilateral power as CEO. But mass redundancy announcements made since he took control have been scrutinised globally.

Musk's plans to restructure Twitter began with laying off top executives, before notifications were emailed to around half of the Twitter global workforce that they were being made redundant or that their jobs were at risk.

In a memo to staff, Musk defended the firings as "an effort to place Twitter on a healthy path" and "unfortunately necessary to ensure the company's success moving forward".

The widely reported memo also informed employees that they would find out their fate by email. It said: Given the nature of our distributed workforce and our desire to inform impacted individuals as quickly as possible, communications for this process will take place via email.

But tweets by some employees showed they found out before the email arrived when they could not access their work accounts or other internal systems. And a class action lawsuit filed in the US on November 3 claims Twitter locked employees out of their accounts, with at least one of the five plaintiffs being "terminated without notice or severance pay", according to news reports.

#### **Digital lavoffs**

Dismissing staff in this way seems impersonal, blunt and lacking in compassion.

Certainly in Ireland, the home of Twitter's European headquarters, the Taoiseach (prime minister of Ireland) has called out Twitter's actions as "unacceptable" and pointed out that workers should be treated with dignity and respect.

Unfortunately, Twitter's approach resembles strategies adopted by a



cent years. Klarna, a Swedish financial technology company sent a prerecorded message to inform employees of 700 layoffs last May, while P and O ferries dismissed 800 staff over Zoom in March.

Mortgage company Better.com made 900 employees redundant by Zoom in 2021, a year after electric scooter company Bird used a Zoom webinar to dismiss more than 400 workers.

Twitter operates globally and employment regulation varies between countries, and even among states in the US. Indeed, the communications sent to Twitter employees differed depending on where they were based.

In the US, the federal Worker Adjustment and Retraining Notification (WARN) Act requires employers with 100 or more employees to provide workers with 60 days' notice for mass sackings.

Alternatively, employers can provide workers with 60 days of redundancy pay. After Twitter employees filed their lawsuit in California on November 3, Musk tweeted the following night that every dismissed employee will be offered three months of severance pay.

Twitter is also expected to provide advance warnings of mass redundancies to California's Employment Development Department. A representative for the agency told the New York Times that no warning had been given by the evening of November 3.

Under UK and EU law, companies must consult with staff over mass redundancies. This may explain why Twitter employees in the UK and Ireland are reported to have received a slightly differently worded email informing them that their job is "potentially" impacted or "at risk".

An email sent to UK employees on Friday November 4 said they had until 9 am the following Tuesday to nominate someone to represent them in a formal consultation.

Twitter has notified employees in Ireland that they should also nominate employee representatives to engage in a formal consultation process.

Twitter did not respond to requests for comment on this process or about its communications with employees concerning these redundancies.

#### **Reputational risk**

With this level of uncertainty, it's not surprising that some Twitter employees have been joining unions ahead of the redundancies. In the UK, Prospect is representing at least some Twitter employees and says it will support members to defend their livelihoods.

The Irish Congress of Trade Unions has argued the case highlights the need for workers across industries to have better opportunities and rights to join unions as a form of collective voice.

Similarly, the United Nations, which advocates for "decent work and economic growth", has even felt compelled to comment following Musk's acquisition of Twitter.

The UN's high commissioner for human rights, Volker Türk, issued an open letter urging Musk to ensure that human rights are integral to the management of Twitter under his leadership, saying: Reports that Twitter's entire human rights team and all but two of its ethical AI team have been fired this week are not from my perspective an encouraging start.

Civil society groups and alliances were already concerned about the direction Twitter may take following its takeover. Musk has called out "activist groups" for supposedly pressurising advertisers to stop working with Twitter.

Pfizer, General Mills and Volkswagen are some of the companies that have recently paused their advertising on the platform. Others may follow after the redundancy announcements.

Twitter users have also already been moving to alternative social media platforms, and this kind of migration could continue following news of the mass job cuts. One such alternative, Irish microblogging site Mastodon, claims more than 230,000 people have moved to it since Twitter's takeover deal.

#### Worried about digital layoffs?


The Twitter chaos certainly seems to be far from over, with reports indicating that the company is now asking some dismissed employees to return to work.

Redundancies have risen sharply right across the tech sector in recent months, with firms including Facebook owner Meta and payments company Stripe recently announcing job cuts, although not all have implemented digital layoffs.

If you face redundancy – whether digitally or face to face - it's important to know your rights. Unions can provide information about this and can also support and represent employees before and after redundancies are announced

# How A SARS-CoV-2 Virus Protein **Damages The Heart, Study Finds**

cientists have identified the mechanism behind how SARS-CoV-2 virus damages the heart tissue. People infected with COVID-19 are at a significantly higher risk for developing inflammation of the heart muscle, abnormal heart rhythms, blood clots, stroke, heart attacks, and heart failure for at least a year after infection, compared to those who have not been infected with the virus, said the study.

The scientists, who are from the University of Maryland, Baltimore, US, then used a drug to reverse the toxic effects of the SARS-CoV-2 virus protein on the heart.

"Our research shows that individual SARS-CoV-2 proteins can each do major damage to specific tissues in the body similar to what has been found for other viruses like HIV and Zika," said senior author Zhe Han.

Their findings, based on research with fruit flies and mouse heart cells, were published in Nature Communications Biology.

Although scientists around the world rapidly developed vaccines and medications to lessen the severity of COVID-19 disease, the study said that these therapies did not protect the heart or other organs from the damage that could be done by even a mild infection.

"To treat patients in the long run, we must first understand the mechanism behind what is causing the disease. By identifying these processes of injury in each tissue, we can test drugs to see whether any can reverse this damage; those drugs that show promise can then be further tested in clinical research studies," Han said.

Last year, Han and his team identified the most toxic SARS-CoV-2 proteins in studies using fruit flies and human cells. They found a drug 'selinexor' reduced the toxicity of one of these proteins, but not the other one, known as Nsp6, according to the study.

In their latest study, they found that Nsp6, turned out to be the most toxic SARS-CoV-2 protein in the fly heart.


Next, the study said, they found that the Nsp6 protein hijacked the fruit fly's cells in its heart to turn on the glycolysis process, which enables cells to burn the sugar glucose for energy. Typically, heart cells use fatty acids as an energy source, but switch over to sugar metabolism during heart failure as these cells to try to repair the dam-

The researchers also found the Nsp6 protein did added damage by disrupting the cell's powerhouse, called the mitochondria, which produces energy from sugar metabolism, according to the study.

The team then blocked sugar metabolism in fruit flies and mouse heart cells using the drug 2-deoxy-D-glucose (2DG). They found that the drug reduced the heart and mitochondria damage caused by the Nsp6 viral protein, the study said.

infected animal's cell machinery to change its metabolism to steal the cell's energy source, so we suspect SARS-CoV-2 does something similar. The viruses can also use the byproducts of sugar metabolism as building blocks to make more viruses," Han said.

"So, we predict this drug that changes the metabolism in the heart back to what it was before infection would be bad for the virus, by both cutting off its energy supply and eliminating the pieces it needs to repli-

cate," Han said.

The researchers said that fortunately 2DG is inexpensive and is used regularly in laboratory research. Although 2DG has not been approved by the U.S. Food and Drug Administration to treat disease, the drug is currently in clinical trials for treatment of COVID-19 in India, the study said.

Too many Americans who have recovered from COVID wind up with dangerous heart conditions weeks or months later, and we need to learn the fundamental reasons for why this is happening," said Mark T. Gladwin, Vice President for Medical Affairs at University of Maryland.

With this research elucidating the pathways of the Nsp6 protein, we can refine the treatments we target for future research with the ultimate aim of reversing further heart damage in these patients."

## **Insurance Contracts Have Very Little Option For Consumers: Supreme Court**

NEW DELHI: Insurance contracts prepared by an insurer have very little option or choice for a consumer, except to sign on the dotted lines, the Supreme Court said on Wednesday.

A bench of Justices Surya Kant and M M Sundresh made the observation while setting aside an order passed by the National Consumer Disputes Redressal Commission in a case seeking compensation for a shop which met with a fire accident.

"Contracts of Insurance are prepared by the insurer having a standard format upon which a consumer is made to sign. He has a very little option or choice to negotiate the terms of the contract, except to sign on the dotted lines. The insurer, who being the dominant party, dictates its own terms, leaving it to the consumer, either to take it or leave it. Such contracts are obviously one-sided, grossly in favour of the insurer due to the weak bargaining power of the consumer." the bench said. The top court said the concept of freedom of contract loses significance in a contract of insurance. "Such contracts demand a very high degree of prudence, good faith, disclosure and notice on the part of the insurer, being

different facets of the doctrine of fairness. Though, a contract of insurance is a voluntary act on the part of the consumer, the obvious intendment is to cover any contingency that might happen in future.

"A premium is paid obviously for that purpose, as there is a legitimate expectation of reimbursement when an act of God happens.Therefore, an insurer is expected to keep that objective in mind, and that too from the point of view of the consumer, to cover the risk, as against a

plausible repudiation," it said. In this case, the appellant Texco Marketing Pvt. Ltd. secured a policy from TATA AIG General Insurance Company Ltd and was meant to cover a shop situated in the basement of the building. However, the exclusion clause of the contract specified that it does not cover the basement.



#### **Govt Announces Framework** For Sovereign Green Bonds

NEW DELHI: The government on Wednesday came out with a framework for sovereign green bonds and proceeds from the issue of the bonds will be used for funding public sector projects that seek to reduce carbon emissions.

The government aims to mobilise Rs 16,000 crore through the issuance of green bonds in the current fiscal ending March 2023.

Finance Minister Nirmala Sithraman on Wednesday said the framework will strengthen India's commitment towards the Nationally Determined Contribution (NDC) targets adopted under the Paris Agreement as well as help attract global and domestic investments into eligible green projects.

According to the framework announced by the finance ministry, the eligible expenditures will be limited to government expenditures that occurred maximum 12 months prior to issuance of the green bonds. It will be endeavoured that all the proceeds get allocated to projects within 24 months following the issuance.

The proceeds from the green bonds issuance cannot be used for extraction, production and distribution of fossil fuels or where the core energy source is fossil-fuel based, and nuclear power projects, an official statement said. PTI

#### India's FY24 Growth To Slow To 5.5%: UBS India

MUMBAI: India's GDP growth will slow down to 5.5 per cent in FY24 from the 6.9 per cent expected in the current fiscal 2022-23, a Swiss brokerage said on Wednesday. The slowdown was attributed to slowing global growth and tightening of monetary policies in the report by economists at UBS India. It said India will be among the "lesser affected economies" in the world, but made it clear that the world's fifth largest economy is not immune from global headwinds. "Factoring in the delayed impact of monetary tightening on domestic demand, we continue to expect India's growth to remain below consensus in FY24. In our base case, we expect India's rea GDP growth to slow from 6.9 per cent in FY23 to 5.5 per cent in FY24 before settling at the long-run average of 6 per cent in FY25," the report said. Responding to high domestic inflation and rate hikes by global central banks, the RBI has already hiked the policy rate by 1.90 per cent since May this year and is only expected to hike more, which can have an impact on growth with a lag. The brokerage said it expects a normalisation in consumer spending after the spurt seen in the immediate aftermath of the COVID reopening fades, and households' purchasing power is impacted by tight monetary policy, the depletion of accumulated pandemic savings and an incomplete labour market recovery. #### Meta Cuts More Than 11,000 Jobs: Biggest Cull In Its History

NEW YORK: Facebook parent Meta is laying off 11,000 people, about 13% of its workforce, as it contends with faltering revenue and broader tech industry woes, CEO Mark Zuckerberg said in a letter to employees Wednesday.

The job cuts come just a week after widespread layoffs at Twitter under its new owner, billionaire Elon Musk.

There have been numerous job cuts at other tech companies that hired rapidly during the pandemic.

Zuckerberg as well said that he had made the decision to hire aggressively, anticipating rapid growth even after the pandemic ended.

"Unfortunately, this did not play out the way I expected," Zuckerberg said in a prepared statement.

"Not only has online commerce returned to prior trends, but the macroeconomic downturn, increased competition, and ads signal loss have caused our revenue to be much lower than I'd expected. I got this wrong, and I take responsibility for that."

Meta, like other social media companies, enjoyed a financial boost during the pandemic lockdown era because more people stayed home and scrolled on their phones and computers.

But as the lockdowns ended and people started going outside again, revenue growth began to falter. AP

launched, while Mr Josh said he is seeking legal advice. 'We are extremely sorry to hear about what must have been a very distressing experience for Josh. The safety of our products is our priority," a Unilever spokesperson was quoted as saying by Metro.

## **Tremors Of Nepal Quake Lead** To Panic In Delhi, Triggers Meme Fest On Twitter

New Delhi: Strong tremors in Delhi-NCR early on Wednesday not only woke many people out of their deep sleep but also triggered a meme fest on Twitter with several users sharing their experiences of rushing outside their homes amid poor air quality. A strong 6.6-magnitude earthquake jolted the remote

mountainous region of western Nepal early Wednesday, killing six people.

Several people took to Twitter to get a confirmation whether an earthquake had actually taken place.

"Omg just had #earthquake .. I feel that in Delhi, hope everything is fine in Nepal." Krish Andrew tweeted.

"Ghar mein earthquake, bahar pollution. Fir bolte ho Delhi walo ko itna gussa kyon aata hai! (Earthquake inside the house, pollution outside; and then people ask why people of Delhi get angry)," another user

tweeted. The tremors jolted people

out of their sleep with many of them coming out of their houses in panic. "It's 2am in the morning and

people are having a stroll on the streets... Reason - #Earthquake in #DelhiNCR #earthquake," Aakash Biswas tweeted, sharing an 11-second video outside a residential building where

people had gathered outside. While a few users pointed out how their sleep was disturbed, others were amazed that even such a strong earthquake could not wake them up. "Today I came to know that even an earthquake of 6.3

magnitude can't wake me up," Bhumica Agarwal said in a Twitter post. "Bruh legit like last 1 minute se PC shake hora mera, ab

realise hua Earthquake aaya," Nischay Malhan, another user, tweeted.

Delhi Chief Minister Arvind Kejriwal also took to the microblogging website.

"I hope all of u (you) are safe," he wrote.

Many Resident Welfare Associations (RWAs) said there were no reports of any kind of damage or casualty in their areas. The earthquake jolted many people out of their sleep and there was panic for some mo-

ments, they said. "We have not received any report of any structural damage or injury from any of the RWAs. However, there was a little panic during the night when people could not figure

out what was happening. "We were scared. People came out of their homes for a few minutes. However, things calmed down after a while,' Atul Goyal President of United **Residents Joint Action.**

Instead of fearing earthquakes due to their unpredictability, it is important to keep ourselves prepared to deal with them in a better way and minimise the damage they might cause to life and property, he said.

The constructions should be earthquake resistant, people should be made aware of what can be done by way of preparations before earthquakes, at the time of their occurrence and after they have happened, Paul said. Mock drills should be conducted at least once every year, he said, adding that if these things are done, the damages by an earthquake can be reduced by 99.99 per cent. Citing the example of Japan, Paul said due to its better preparedness, the country does not suffer much damage to life and property despite being constantly hit by medium intensity earthquakes. He said the Wadia Institute of Himalayan Geology also keeps sending its teams to villages and schools to create awareness about what can be done to minimise the effects of an earthquake. Another senior geo-physicist at the institute Naresh Kumar said Uttarakhand has been placed in seismic zone IV and V due to its vulnerability to earthquakes. Around 60 earthquake observatories have been set up in Himachal Pradesh and Uttarakhand to register seismic movements round the clock, he said.

Western Nepal had been jolted by a magnitude 4.8 earthquake at a depth of 10km hours earlier, at about 9pm (15:15 GMT) local time.

A resident of Gorakhpur city in India's Uttar Pradesh – more than 350km from the epicentre – wrote on the EMSC's website that they had felt the tremors.

"The building was shaking. I'm on the 9th floor," they wrote.

Local media reported that tremors were felt in India's capital. New Delhi located 400km (250 miles) west of the epicentre.

#### Justice Chandrachud

is the son of the longest serving CJI Y V Chandrachud, who held the top judicial post from February 22, 1978, to July 11, 1985. This is the first instance of a father and son occupying the highest seat of justice.

After taking a round of the apex court premises, Justice Chandrachud went inside his chamber and bowed to the Indian tricolour there.

He entered the CJI's courtroom around 12.10 PM for hearing the matters listed for the day.

Apologies for keeping the members of the Bar wait for so long. I will try to make it a no-stress court for everyone, he said after settling on the CJI's chair. Lawyers including Solicitor General Tushar Mehta greeted the CJI and wished him the very best for his twovear-long tenure.

The CJI then took up the listed cases including the plea of Samajwadi Party leader Azam Khan who had moved the top court against his disqualification as an MLA of Rampur assembly seat in UP due to his conviction in a hate speech matter.

He dismissed an appeal of the Tamil Nadu government against an order of the Madras High Court granting relief to a sweeper by extending him the benefit of regular appointment.

"I could not take up some cases today since we assembled late. I hope it is only once in my career that I am late since I was sworn in, the CJI said while rising for the day.

Minister Rijiju also met the new CJI and and congratulated him.

"I am looking forward to work in close coordination, and to provide support in ensuring speedy delivery of Justice to the citizens," he tweeted after the meeting.

Counted as a judge who enriched the verdict docket' of the apex court, Justice Chandrachud, who has played a pivotal role in digitisation of the judiciary, is viewed as sharp, articulate and forward looking.

Expected to advance judicial frontiers, he was a member of benches that delivered judgements on decriminalising part of Section 377 of the IPC that criminalises consensual unnatural sex between consenting adults and on allowing entry of women of all ages into the Sabarimala temple in Kerala.

The list of important judgments in which Justice Chandrachud was a part and which settled many a debate is long.

Justice Chandrachud, born on November 11, 1959 and considered a Delhi University product who studied in St Stephen's College and the Campus Law Centre before going to Harvard, was elevated to the top court on May 13, 2016.

He was also part of an important verdict expanding the scope of the Medical Termination of Pregnancy Act and the corresponding rules to include unmarried women for abortion between 20-24 weeks of pregnancy.

Justice Chandrachud, a former Chief Justice of the Allahabad High Court, was among the two judges of the apex court collegium who recently objected to the method of "circulation" adopted for eliciting the views of its members on the appointment of judges to the top court.

During the COVID-19 pandemic, a bench led by Justice Chandrachud passed several directions to address the miseries faced by people while terming the second wave a "national crisis". The bench, for instance, directed the Centre to ensure supply of oxygen to hospitals across the nation

South Korea's hopes at the World Cup, which begins in less than three weeks, rest heavily on captain Son, who has scored 35 goals in 104 appearances for his country. They will kick off their campaign on Nov. 24 against Uruguay and also face Ghana and Portugal in Group H.

Meanwhile, England and Chelsea right-back Reece James says he is "devastated" to miss out on England's World Cup squad.

The Chelsea defender is recovering from a knee injury sustained last month and on Wednesday confirmed he will not be going to Qatar.
