Srinagar: The Jammu and Kashmir government on Friday directed strict adherence to biometric attendance in its offices, PSUs, Institutions and Corporations and asked Drawing and Disbursing Officers (DDOs) to furnish daily Action Taken Report (ATR) in this regard to General Administration Department. "In terms of Government

Order No. 650-JK(GAD) of 2022 dated 02.06.2022, instructions were issued to all Government Offices/PSUs/ Institutions/Corporations across Jammu and Kashmir to switch over to Biometric System (Aadhar or Finger Print Based) with immediate effect and all employees were directed to necessarily mark their attendance both at arrival and departure as per the notified office hours of various offices," reads a circular issued by the



government. Further, it said, all Administrative Secretaries/ HoDs/Managing Directors PsUs/Corporations/ of Institutions were directto ensure installation ed Biometric Attendance Systems/Equipments in all offices and institutions under their administrative control by or before 15th of June, 2022. All DDOs, it said, were also directed to draw salaries of employees only on the basis of satisfactory biometric attendance. | More on P10

### We Have To **Separate Religion From Politics: Azad**

**Srinagar:** Democratic Azad Party (DAP) chief Ghulam Nabi Azad on Friday said there was a need to separate religion from politics.

"Everyone has a right to put across his or her viewpoint but they should talk about uniting people, not create divisions. They should not divide people on the basis of politics or religion.

"We will have to separate religion from politics," Azad said at a party function here.

Azad also said elections should not be an excuse to spread hate, adding, "Elections have been held in the past as well.'



Srinagar: The University of Kashmir has been ranked 110 in Southern Asia in the QS Asia University Rankings 2023 that feature 760 Asian universities.

Published on November 8, the QS University Rankings evaluate the Asian varsities on the basis of 11 key parameters including Academic Reputation, Employer Reputation, Faculty/ Student Ratio, International Research Network, Citations Per-Paper, Papers-Per Faculty, Staff with PhD, Proportion of International Faculty, Propor-tion of International Students, Proportion of Inbound Exchange Students, and Proportion of Outbound Exchange Students.

In the category of Overall Rank, the University features in the range of 451-500 and has performed among the top 60% in the Asia University Rankings.



### Buldozers Demolish Structures Inside Last Monarchial Resort

Trinagar- Was it message that Farooq Abdullah wanted to send across to his cabinet colleagues that nothing can deter him from taking a stern action against any one of them or did it speak of the growing schisms in the Abdullah cabinet when speeding bulldozers demolished a newly constructed building in Karan Mahal here today.

Giving credence to the belief that Abdullah government writ does not run even in the cabinet, the Information Minister had refused to take cognizance of the notifications served on him by the Lake and Water Ways Development organization.

Adding to the belief that New Delhi has asked Chief Minister, Dr. Farooq Abdullah to tighten noose around his cabinet members after action against the business concerns of the Urban Development Minister, Molvi Iftikhar Ansari, and the Minister for information is second. Rumours are rife that Abdullah is looking for alibi's to throw out some of his cabinet colleagues who in future dispensation may not suit his political requirements

The operation to demolish the' illegal' structure inside the minister's estate was conducted jointly by the three departments of Housing and Urban Development Ministry, Srinagar Municipality, Lakes and Water Ways Development Authority (LWWDA) and Srinagar Development Authority here today.

The entire single-storey structure was bulldozed by the employees of the three departments, which are under the total control of Iftikhar Hussain Ansari. Following resistance by the employees and the guards posted at Ajat Shatru's estate yester-day a posse of police men accompanied the demolishing squad.

Iftikhar, it is learnt, was in constant touch with the three officers of three departments, who were supervising the demoli-tion today. He was also reportedly in touch with IG Police, Kashmir range to prevent any possible clash between the police

and the guards posted at the estate. The Vice Chairman of LAWDA when contacted claimed that the Sports Minister had violated SR0-109 of J&K Government. The area of construction, the Vice Chairman said, falls under green belt and violated the norms for the preservation of the lake Dal. Secondly the single storey house was constructed without any permission from the Srinagar Municipal Committee. Thirdly the area also falls under Srinagar's master plan.

The Supreme Court on Friday extended the interim order granting protection of the area where a 'shivling' was claimed to have been found inside the premises of the Gyanvapi mosque. A bench comprising Chief Justice of India DY Chandrachud, Justice Surya Kant and Justice PS Narasimha extended the May 17 order until further orders.

The bench allowed the Hindu parties to move an application before the Varanasi district judge for consolidation of all the lawsuit filed on the Gyanvapi row. It also directed the Hindu parties to file their replies within three weeks on the appeal filed by the management committee of the Anjuman Intezamia Masjid challenging the Allahabad High Court order on the appointment of a survey commissioner.



### **Israel's President To** Ask Netanyahu To Form **New Government**

JERUSALEM: Israeli President Isaac Herzog announced on Friday that he will assign the task to form a new government to former Prime Minister Benjamin Netanyahu following consultations with leaders of all the political parties that have been elected to Parliament in November 1 elections, a move likely to end the political impasse in the country.

The announcement was made after Herzog held discus-sions with the political parties over three days, starting Wednesday when he received the final poll results from the Chairman of the Central Elections Committee.

"In sum, 64 members of Knesset recommended to the President that he assign the task of forming a government to Likud Chairman Benjamin Netanyahu MK (Member of Knesset). Twenty-eight MKs recommended Yesh Atid Chairman Yair Lapid MK, and four factions, representing 28 members of Knesset, decided to abstain from making any recommendation," a statement from the Presidency said.

"Following the consultations, Office of the President Director-General Eyal Shviki phoned



requested to invite Benjamin Netanyahu MK to receive from the President the role of forming a government on Sunday (13 November 2022)," it added. Netanyahu will have to form the government in 28 days from the day he is handed over the mandate by the President. If an extension is required, the President has the legal authority to grant an extension of up to fourteen additional days.

Besides Netanyahu's Likud party, he received the backing of the right wing bloc including, Shas, United Torah Judaism, Religious Zionism, Jewish Power and Noam. Caretaker Prime Minister Yair Lapid's name was recommended by his Yesh Atid party and the Labour party.

National Unity, Yisrael Beitenu, United Arab List (Ra'am) and Hadash-Ta'al decided not to recommend any name to be tasked with the responsibility.

AHMEDABAD: Ruling Bharatiya Janata Party (BJP) and Aam Aadmi Party (AAP) have rewarded several leaders, who quit rival political parties and joined them, by offering tickets to them to contest the upcoming Assembly polls in Gujarat, while Congress has preferred to field party loyalists, including 21 sitting MLAs.

The BJP, opposition Congress and the Arvind Kejriwal-led AAP have so far declared candidates for 160, 89 and 174 seats, respectively, for the election to the 182-member Assembly to be held in two phases on December 1 and 5.

According to the BJP's list of 160 candidates it released on yesterday, out of 20 MLAs who resigned from the Congress after winning the 2017 Assembly

BJP's list. Some of these former MLAs are Raghavji Patel (Jamnagar Rural) and Balwantsinh Rajput (Sidhpur).

Mr Rajput had resigned in July 2017 ahead of the Rajya Sabha election and went on to

contest the polls on BJP ticket. Patel was expelled from the Congress for voting against the party mandate in the Rajya Sabha election. He was defeated in the 2017 Assembly election, but won the byelection in 2019 after the then sitting Congress MLA from Jamnagar rural seat, Vallabh Dharaviya, resigned and joined the BJP.

No leader from rival political parties who joined the Congress in the recent past has figured in the list of 89 candidates released by the 'grand old party' so far. Congress's state party chief Jagdish Thakor said party workers will be the first a

### **Delhi Police Arrests** Man Who Was Declared "Dead" 24 Years Ago

DELHI: The Delhi Police has arrested a man who was declared dead in official documents 24 years ago.

As the man, wanted in a theft case in 1991, was declared 'dead' in all official papers, the Delhi Police stopped looking for him 24 years ago.

However, the Bawana police was recently tipped off about the accused and Delhi Police later worked on the lead to arrest him.

After his arrest, the Delhi Police informed that a case of theft was registered against the accused in 1991 and the matter was in court. However, he was declared 'dead' in official documents submitted in court in 1998.

The city police said he forged the documents and went into hiding. He was on the run for the next 24 years.

Accepting that the accused was dead, the court left his file pending. It remained pending till he was finally arrested. Speaking on the case, DCP Outer-North District Devesh Kumar Mahla said the police are questioning the accused for leads on the person who faked his papers. (AGENCIES)

### 'Religious Tattoo' Found **Unfit For Central Forces, Man Approaches Court**

NEW DELHI: A man who was declared unfit for recruitment in Central Armed Police Forces, National Investigation Agency (NIA) and other forces for having a "religious tattoo" on the dorsum of his right hand has approached the Delhi High Court challenging the authorities' decision.

The counsel for the authorities opposed the plea saying that the right arm is the saluting hand and this tattoo was not permissible under the relevant guidelines of the Ministry of Home Affairs.

The court, which was told by the petitioner that he was willing to remove the tattoo by a minor laser surgery, noted the detailed medical examination and the review medical examination showed there were no other defects found in him.

It disposed of the petition by giving liberty to the man to appear before the new medical board constituted by the authorities after removal of the tattoo.

"Keeping in view the aforesaid position as well as in the interest of justice, we hereby dispose of the present petition by giving liberty to the petitioner to appear before the freshly constituted medical board of the respondents after two weeks from today after having the tattoo in the dorsum of the right hand removed," the court said.

"...in case the petitioner is found fit by the said medical board, the respondents shall further process the selection of petitioner for the post in question in accordance with law," a bench of Justices Suresh Kumar Kait and Saurabh Banerjee said in its order.

The petitioner submitted that he was found unfit in the detailed medical examination held on September 28 and thereafter, in review medical examination on September 29 for the post of constable (general duty) in Central Armed Police Forces, NIA, SSF and Rifleman GD in Assam Rifles Examination, 2021 on the ground that he has a religious tattoo marks on the dorsum of right hand which was not permissible.

He sought quashing of the results of the two examinations and that he be appointed to the post.

### **Billionaire Gautam Adani Lands In The** Middle Of India-China Fight In Sri Lanka

small group of fishermen ply the shallow coastal water Along Pooneryn in northern Sri Lanka, an impoverished, remote area within striking distance of India's southern tip. It's where Gautam Adani -- who is Asia's richest man and has vaulted ahead of Jeff Bezos this year -- plans to build renewable power plants, thrusting him into the heart of an international political clash.

With Sri Lanka in the throes of its worst economic crisis since its independence from Britain in 1948, India is reengaging and attempting to tilt the balance in a strategic tussle with China on the island, a pivotal battleground because it lies on key global shipping lanes and plays into India's fear of encirclement from its Asian rival.

At the forefront of those efforts is Mr Adani, who is a long-time supporter of Prime Minister Narendra Modi, and has been accused by some Sri Lankan lawmakers of signing opaque port and energy deals closely tied to India's interests, something his group has always denied, saying the invest-



ments meet Sri Lanka's needs.

Sitting atop a \$137 billion wealth pile, Mr Adani controls a sprawling empire that spans ports, coal plants, power generation and distribution.

While he derives the vast majority of his fortune from India, Gautam Adani has gradually made more overseas deals and told shareholders in July that he seeks a "broader expansion" beyond India's borders with "several" foreign governments approaching his conglomerate to develop their infrastructure.

Those moves and Mr Adani's perceived closeness to Prime Minister Modi's administration have spurred suggestions the tycoon

could be the cash cow for India's pushback against China, whose Belt and Road infrastructure drive is intended to increase Beijing's influence in strategic countries and on the global stage.

"In countries that the Indian government has better relations than the Chinese government, Adani could find success." said Akhil Ramesh. a resident fellow at the Pacific Forum research institute in Honolulu.

While India lacks the financial firepower of its neighbor, Mr Adani's investments in countries such as Israel and Sri Lanka compete with Chinese state-owned firms.

And it's in Sri Lanka where that tension is playing out most acutely.

Mr Adani's investments there were described to Bloomberg News by multiple Indian and Sri Lankan officials as advancing Prime Minister Modi administration's objectives on the tear-drop shaped island, in much the same way that his businesses in ports, power and cement coincide with the government's economic priorities at home. Mr Adani has repeatedly denied that his firms receive special treatment from Prime Minister Modi's government.

An official told a local news agency KNO that Prof. Ashai was attached for physically as-saulting Registrar CUS over some official issue in presence of Vice Chancellor CUS, Deans and other administrative staff members of the University.

"Prof Ashai had visited CUS in connection with some offi-

cial work and was seeking some documents. While discussing the matter, he lost his control and physically assaulted Registrar CUS," an official said.

He said the VC CUS who was present at the spot immediately wrote to LG office and HED following which Prof Ashai was attached with HED civil secretariat Jammu.

"The VC CUS took the matter seriously and submitted his complaint to HED. The Principal Secretary HED also took immediate action and ordered to attach Prof Ashai," the official said.

Meanwhile, in a separate order the HED has initiated an inquiry into the matter and sought a detailed report within 15 days.

As per the HED order, Additional Secretary HED Sushil Kumar Khajuria has been appointed as an inquiry officer to conduct detailed enquiry in the case of in-charge Principal GDC Pattan Prof. Tariq Ashai "with respect to serious allegations levelled against him."

While chairing the meeting, Principal Secretary directed the concerned officers to adopt a proactive approach to address the needs and requirements of the people; especially those living in far-flung and snowbound areas and directed them to ensure that there is no scarcity of drinking water during the winters and take proper steps forehand in this regard so that all the issues are ironed out. He directed the Chief Engineers to prepare a well though out plan about the list of problems that may crop up in future so that most planned and appropriate measures are taken well in advance. While taking stock of the implementation of the directions passed in the previous meetings, he asked the officers to closely monitor the winter preparations and directed them to work in a synchronized manner and put in dedicated efforts to avoid any inconvenience to the people of J&K by putting in place a much comprehensive and viable win-

ter preparedness mechanism.

Regarding the freezing of water sources during winters, he directed the officers to compile details of vulnerable areas based on past experience and take immediate measures as a first line of action and look out for solutions which are permanent in nature. He said that immediate measures have also to be taken where pipes are exposed and bursting occurs during freezing temperatures.

He said that an institutional mechanism should be developed so that an emerging problem is brought to the notice of the relevant authorities and prompt action is taken and we should have our resources readily available to address the same. It was given out in the meeting that mapping of all vital installations and listing out all the locations of roads leading to water supply schemes and lift stations has been done. It was also given out that sufficient quantity of tankers is available across J&K. He directed the officers that monitoring and regulating use of water tankers should be carried out on a regular basis. Principal Secretary further directed the officers to ensure power supply is available at all the required places and make alternate power supply in case of disruptions and fuel stocking is done well in advance.

B ridging two of the city's busiest markets; beggars, peddlers and buses crowd the road. A place where the whole city can be found, it is not a place to hang around and chat. But in the lanes surrounded it people are interested to talk on the controversial guest control law.

In the quiet of riverside Bund walk, Showkat Shafi, lecturer of mass communications at Srinagar University, takes time to reflect on the law in a wider context.

"The Wazwan is impressed deep into the Kashmiri psyche. It is part of our inheritance from Central Asia. It will be very difficult to change this tradition. We are meat eaters here, Kashmiri men like meat and they like the Wazwan. This law needed a lot more paperwork. It will not be a ground reality, especially when the people who imposed the law are themselves the most extravagant, holding feasts which last for days," he said.

"I suppose the law is good for the poor people, those who can't afford it, but those who can should be able to celebrate, the limit for the number of people is very small. It should be risen," said Waseem Ahmed, a businessman, outside the lines of jewelers shops opposite Hanuman temple, where many go to buy wedding gold to compliment the feast.


"This law is right. It is foolish to spend so much money on food! Why waste your money on meat! I don't agree with dowry, but the gold jewellery around here is a more worthwhile way to spend money," said Badhir Ahmad, who is a follower of Jammat-Islaami.

### Chatsa-Kadal

In the heart of downtown, this narrow wooden bridge is the ancient route that connected the two parts of old Srinagar.

"When the rich people throw lavish parties, the ordinary people benefit. Wazwan is an industry in itself, it employs not only Wazas, but tent-wallahs, decorators and many extra people," said Imitiaz Hussein, floricultural.

Recently, a video of a young man hitting and abusing a school-going girl went viral on Kashmir's social media. The incident took place at KP road, Anantnag and soon after the boy was arrested by the police.

The incident was alarming in itself, yet, what was more jarring was the reactions it had invited. Surprisingly, some people assumed the duo to be romantically involved. There was no evidence of this from the video. Infact, the video was filled with violence with no semblance of sanity. However unsubstantiated or groundless such an assumption, it did expose a perception of man-woman relationships in our society which is predicated on normalised violence. The power dynamics, performance and perception in conjugal or even non-conjugal romantic relationships is framed in a way that it not only allows violence but also normalises it. What has sanctioned these lopsided dynamics and who glorifies these? Perhaps the answer starts with patriarchy and the agents which legitimise it. Popular culture is a site of this liaison. Movies, especially from Hindi Cinema, have been notorious in being complicit with the systems that promote social evils. Whether it is the famous Kuch Kuch Hota hai which glorifies a mainstream understanding of femininity or Padmavat which legitimises sati — we've all been fed with unethical, exclusionary and uncritical ideas. This process of indoctrination is not explicit and is almost always clever. However, as a woman, it has become very easy to identify narratives that seek to harm me. This realisation is quite unsettling and presents itself in situations that were otherwise meant to be recreational. After I first saw Kabir Singh (2019), Shahid Kapoor and Kiara Advani's apparently epic 'love' story that had audiences in an awed grip and social media in a frenzy. I remember being unable to put into words what exactly about the film that made me uncomfortable to the point of wanting to leave the theatre. After recently coming across the video in which a young man is being violent and abusive towards a girl in Anantnag, the same feeling came rushing back with force. The stance of the man looming over the girl as she stands quietly was so jarring yet so similar. I had seen it before, countless times on countless different screens. But the recall to Kabir Singh, perhaps courtesy of it being the most recent in a lineup of male chauvinist centric Bollywood films, was the strongest. Was it the gross portrayal of abuse and its consequences that gave rise to this feeling of frustration and discomfort? Yes, of course. However, more than that, it was the horrific realisation that this ridiculous amalgamation of the languages of domestic violence, substance abuse, and 'romance' is nothing new - neither in Bollywood or the communities that consume and celebrate its content. From the

motif of the hero grabbing the heroine's wrist, bangles breaking from the force of it to the narrative of the hero falling into frenzied love with the heroine at first sight and chasing after her despite constant rejections, stalking and harassment litters the landscape of Bollywood's romance flicks. Time after time, what are clearly acts of violence against women on screen are repackaged as declarations of passionate love without giving thought to the social ramifications of such a twisted reading of romance and desire.

The most widespread form of violence against women across the world is intimate partner violence perpetrated by either the husband or a male partner. According to statistics presented by UN Women for Asia and the Pacific, '33 per cent of partnered women aged 15-49 will experience physical and/or sexual violence from a current or former husband or male partner at least once in their lifetime'. The number of reports filed by women experiencing domestic abuse is already higher than the global average of 27% in countries across Asia, with India at 35%, without taking into account the fact that a large chunk of women do not report in fear of retaliation from the perpetrator, rejection by family and community, and victim blaming by society. Many excuse the violence as a consequence of drug and alcohol addiction, falling into the trap of believing that it is the substances that are corrupting an 'innocent' man. Others are shamed into hiding the abuse and many more are trapped due to economic factors, especially those

with young children to support. The consequences of this can be deadly, with deaths of women at the hands of male partners numbering in tens of thousands across Asia every year.

Keeping the aforementioned context in mind, Bollywood's association of violence with passion and love becomes even more heinous. What makes Kabir Singh and its success especially offensive is the timing of its release. With an emerging group of creators embracing the 'concept' of activism, making films on all sorts of issues such as destigmatising menstrual health (Padman, 2018) and consent (Pink, 2016), the arrival of Kabir Singh is less of a step back than it is a reinforcing of the

her fingers in an effort to get the images to move. At the time the iPad was relatively new and we were still really impressed at how quickly babies who could barely hold a crayon could master a touchscreen. The creator of the video wittingly titled it, 'A Magazine Is an iPad That Does Not Work'. Phones and iPads have become pacifiers, a bit like what TV was to parents in the 1980s. Research suggests that technology is not the best early experience to fire the neurons. How much screen time should they have in the early years? Is the addictive nature troubling?

An article in India Today quotes from à 2018 study conducted by AllMS and the Department of Biotechnology, Ministry of Science and Technology, according to which, every third child among the

7,000 students surveyed in Delhi's private schools suffer from obesity. Cases of mobile phone addiction among children who are beginning to show symptoms of health conditions are on the rise. Many of them are addicted to games such as PUBG. What parents don't understand is that children cannot buy mobile phones on their own. Why should parents give it to them? 'It is high time this was controlled', says Dr Saxena of AIIMS.

controlled', says Dr Saxena of AIIMS. These are alarming statistics by themselves, and when exemplified by the case studies quoted at length in the piece, there is a genuine fear that this will only escalate. Take the example of four-year-old Rihaan, whose restlessness was difficult deal with and

c o u l d only be managed with kiddie videos on his mother's smartphone. There were complaints from the teachers at his playschool that he was becoming increasingly aggressive unless he had a device to play with, and the principal advised the mother to consult a doctor. Rihaan had developed what doctors' call Screen Dependency Disorder, or SDD, a condition that needs medical intervention!

Sadly, Rihaan isn't an exception. Every day, doctors in the national capital get at least four to seven cases of children addicted to electronic screens. Of these cases, children in the age group of four


to twelve years of age, more often than not, grow up to be obese, diabetic and/or suffer from sleep disorders, said doctors. unless he had played games on his father's mobile phone. Initially, his mother thought he was suffering from insomnia and consulted a pediatrician at AIMS. He was referred to a child psychologist who asked his parents to keep him away from phones and keep him busy with books and toys instead.

According to Dr Aruna Broota, a child psychologist based in Delhi, she sees atleast four to seven children every day in the age group of four to twelve years who are addicted to electronic screens.

She believes the problem often begins at home.

'Why can't children be allowed to play and run around, even if within the confines of their homes? Rather than attend to them, the parents often take the easier option of handing them a mobile phone or a tablet', she points out.

...Studies have proved that children who engage in physical activities show better development of the brain than those who are home-bound and stationary. They stay more focused, develop stronger memories and are less impulsive



In another case study, the threeyear-old child could not fall asleep chones, and are less impuisive.

### **'Personalised Cell 'Editing' Used To Treat Cancer Patients For First Time'**

cientists have, for the first time, used CRISPR technology to insert genes that allow immune cells to attack cancer cells, potentially leaving normal cells unharmed and increasing the effectiveness of immunotherapy.

The CRISPR gene editing technique has been previously used in humans to remove specific genes to allow the immune system to be more activated against cancer.

The research, published in the journal Nature, used CRISPR to not only take out specific genes, but also to insert new ones in immune cells efficiently redirecting them to recognise mutations in the patient's own cancer cells.

When infused back to patients, these CRISPR engineered immune cells preferentially traffic to the cancer and become the most represented immune cells there, the researchers said.

The human immune system has specific receptors on immune cells that can specifically recognise cancer cells and differentiate them from normal cells.

These are different for every patient, so finding an efficient way to isolate them and insert them back into immune cells to generate a personalised cell therapy to treat cancer is key to making the approach feasible on a large scale.

The researchers found an efficient way to isolate these immune receptors from patient's own blood.

After isolation, the immune receptors are used to redirect immune cells to recognise cancer using CRISPR gene editing.



### **The human immune system** has specific receptors on immune cells that can specifically recognise cancer cells and differentiate them from normal cells.

"This is a leap forward in developing a personalised treatment for cancer, where the isolation of immune receptors that specifically recognise mutations in the patient's own cancer are used to treat the cancer," said Antoni Ribas from the University of California, Los Angeles (UCLA), US.

"The generation of a personalised cell treatment for cancer would not have been feasible without the newly developed ability to use the CRISPR technique to replace the immune receptors in clinical-grade cell preparations in a single step," said Ribas, corresponding author of the research paper.

The researchers report treating 16 patients with a variety of solid cancers including colon, breast and lung cancers.

The patients had immune cells isolated from their blood based on their binding to capture reagents that displayed up to 350 mutations from the patient's own cancer, for a total of over 5000 mutations being targeted across 34 flavours of HLA subtypes of the immune system.

The genes of the immune receptors that allowed the immune cells to specifically recognise the cancer mutations were then sequenced, totaling 175 newly isolated cancerspecific immune receptors.

They were then inserted back into the patient's own immune cells using a one-step CRISPR editing, which included the knock-out of the existing immune cell receptors and knock-in of the immune receptors that could redirect those cells to specifically recognise mutations in their cancer.

Patients had the expected side effects from chemotherapy, and two patients had potential side effects from the gene edited cells, one with fevers and chills and the other with confusion, both recovering promptly, the researchers said.

### **Google Confirms Bug In Fitbit App That Counts Inaccurate Calories**

ech giant Google has confirmed a bug in the Fitbit app of the Pixel Watch that counts calories inaccurately.

According to 9to5Google, Pixel Watch users have noticed that calories counted on the Pixel Watch differ from those of other smartwatches or fitness trackers, such as the Galaxy Watch 5 or Apple Watch.

As smartwatches will never be 100 per cent accurate in terms of calorie counts, it was odd to notice Google's new smartwatch varying so much.

The folks over at Android Police discovered that, when compared to a Galaxy Watch 4, their Pixel Watch would count up to 50 per cent more calories burned.

Google has since confirmed to the outlet that this isn't meant to happen, and is instead a software glitch, reports 9to5Google.

The Pixel Watch calculates calories burned based on the users' heart rate, and activities, and compares that with their age, height, and weight, just like other smartwatches and fitness trackers.



Google also clarified that calorie counts during workouts are behaving as normal.

If there is a difference between the Pixel Watch and other devices in that regard and the user's data is accurate, the difference can be chalked up to the different algorithms that Fitbit uses versus the competition, said the report.

may increase the risk of organ failure and death, according to a study which suggests that people should practice vigilance to reduce their chances of reinfection.

The research, published on Thursday in the journal Nature Medicine, found that repeat COVID-19 infections contribute significant additional risk of adverse health conditions in multiple organ systems.

Such outcomes include hospitalisation; disorders affecting the lungs, heart, brain, and the body's blood, musculoskeletal and gastrointestinal systems; and even death, the researchers said.

Reinfection also contributes to diabetes, kidney disease and mental health issues, they said.

"During the past few months, there's been an air of invincibility among people who have had COVID-19 or their vaccinations and boosters, and especially among people who have had an infection and also received vaccines; some people started to referring to these individuals as having a sort of superimmunity to the virus," said senior study author Ziyad Al-Aly, from Washington University School of Medicine, US.

"Without ambiguity, our research showed that getting an infection a second, third or fourth time contributes to additional health risks in the acute phase, meaning the first 30 days after infection, and in the months beyond, meaning the long COVID phase," Al-Aly said.

The study also indicated that the risk seems to increase with each infection.

"This means that even if

Limiting exposure to the virus is especially imporatnt with new variants emerging, mutating and already causing an upswing in infections in some parts of the world.

"People should do their best to prevent repeat infections by

Of the latter group, most people had two or three infections, with a small number having had four infections and no one with

"We really need to do our best to reduce the chance we will have a twin-demic of both COVID-19 and the flu this winter season," he added.

The researchers analysed about 5.8 million de-identified medical records in a database maintained by the US Department of Veterans Affairs, country's largest integrated health-care system. Patients represented multiple ages, races and sexes.

They created a controlled data set of 5.3 million people who did not test positive for CO-

five or more infections, the researchers said.

Statistical modeling was used to examine the health risks of repeat COVID-19 infections within the first 30 days after contracting the virus and up to six months after, they said.

The study accounted for COVID-19 variants such as Delta. Omicron and BA.5. Negative outcomes occurred among the unvaccinated as well as those who had received shots prior to reinfection.

Overall, the researchers found that people with CO-VID-19 reinfections were twice as likely to die and three times more likely to be hospitalised than those with no reinfection.

### **Better Tax Collection To Help** Meet FY23 Fiscal Deficit Target Of 6.4%: Report

### **Press Trust Of India**

MUMBAI: The Centre is likely to meet the key fiscal targets led by the deficit getting contained at the budgeted target of 6.4 per cent in the current financial year, mainly due to better tax collection, according to a report.

Bank of America Securities on Friday said the key risks to budgeted fiscal deficit include higher subsidies, lower divestment proceeds, excise duty cut on petrol and diesel. But the offsetting factors include better than estimated tax revenue buoyancy, higher nominal GDP growth, and lower capex loan to states, it said in a report.

Accordingly, the brokerage said it expects the government to meet the budgeted FY23 fiscal deficit target at 6.4 per cent of GDP despite upside risks.

The report also noted that it was expecting the government to undershoot the fiscal deficit target when the budget was presented at 6 per cent.

However, as the year progressed, the outbreak of the Ukraine war started to exert meaningful pressure on global commodity prices, particularly food, fuel and fertilisers. This implied upside risks to the already-elevated subsidy bill, stressing revenue expenditure estimates, it added.

On the capital expenditure front, however, the report said that it sees some savings from the budget estimates due to lower-than-expected loans and advances to the states.

On the receipts side, the report said the revenue foregone due to the excise duty cut on petrol and diesel and potentially lower-than-planned divestment proceeds, further dimmed

the fiscal outlook for the year. Though in absolute terms, the fiscal gap will be turning out to be higher than budgeted, it said the number will be contained at or under the target given that the government has used up only 37.3 per cent of the full year borrowing target by September. This is because in spite of the expenditure run rate being a shade higher than the median expenditure run rate which is typical of the first half, sharply higher tax revenues led to this outperformance, the report said. Further, the brokerage projected the net tax revenue to exceed the budget estimate by Rs 1,15,000 crore while non-tax revenue may fall short by Rs 20,000 crore.

As per the report, on the expenditure side, the subsidy bill is expected to exceed the budget estimate by Rs 2,15,000 crore, and the capex falling short by Rs 80,000 crore mainly due to lower loans and advances to the states. This will lead to the total expenditure exceeding the budget estimate by Rs 1,35,000 crore, it added.

### Moody's Cuts India's Growth Projection For 2022 To 7% On **Global Slowdown, Rising Rates**

NEW DELHI: Moody's on Friday slashed India's GDP growth projection to 7 per cent for 2022, saying that global slowdown and high domestic interest rates would dampen economic momentum. This is the second time in as

many months that Moody's Investors Service has cut India's growth estimates for 2022. In September, it had cut projection for the year to 7.7 per cent from 8.8 per cent pegged in May.

"For India, the 2022 real GDP growth projections have been lowered to 7 per cent from 7.7 per cent. The downward revision assumes higher inflation, high interest rates and slowing global growth will dampen economic momentum by more than we had previously expected," said the Global Macro Outlook 2023-24.

Moody's expects growth to decelerate to 4.8 per cent in 2023 and then to rise to 6.4 per cent in 2024.

The Indian economy grew 8.5 per cent in 2021 calender year, according to Moody's. As per official GDP estimates, the economy expanded 13.5 per cent in April-June 2022-23, higher than 4.10 per cent growth clocked in January-March. GDP figures for September quarter would be released at the end of this month.

Moody's said the weakening of the rupee and high oil prices

continue to exert upward pressures on inflation, which has remained above the RBI's tolerance level of 6 per cent for much of this year.

Retail inflation increased to 7.41 per cent in September, while wholesale inflation remained in double digit for the 18th straight month at 10.7 per cent.

The central bank has hiked interest rates by 190 basis points between May and September to 5.90 per cent to contain inflation.

Moody's expects the RBI to raise the repo rate by another 50 basis points or so as part of its objective to tame inflation and support the exchange rate. Eventually, the RBI will likely shift from inflation management to growth considerations, provided that the rate increase has the desired effect of taming inflation. it said.

Moody's joins a host of agencies which have slashed

India's economic growth projections for current fiscal year (April-March) citing slowdown in global economy, Russia-Ukraine war, rising interest rates and inflation.

While the World Bank has revised down its growth estimate for India by 100 basis points to 6.5 per cent, IMF has trimmed it to 6.8 per cent from 7.4 per cent The Asian Development Bank too has cut its projection to 7 per

cent, from 7.5 per cent earlier. S&P Global Ratings revised down its growth forecast to 7.3 per cent for current fiscal year from 8.7 per cent. The RBI expects economic growth at 7 per cent for this fiscal year.

Moody's said the underlying growth dynamics are fundamentally strong, boosted by a rebound in services activity. Government capital expenditure and manufacturing capacity utilization have also improved.

### **'Domestic Airlines Industry** Likely To Report Rs 15,000-17,000 Cr Loss This Fiscal'

**MUMBAI:** The domestic airlines industry is projected to post a loss of Rs 15,000-17,000 crore in the current fiscal as their financial performance is likely to remain under pressure in the near term, a report said on Friday.

Credit rating agency ICRA said the recovery in domestic passenger traffic has been healthy but elevated Aviation Turbine Fuel (ATF) prices will continue to pose a major threat to earnings and the liquidity profile of the airlines in the near-to-medium term.

The domestic passenger traf-

provement in passenger traffic is expected in FY2023, the pace of recovery in the industry earnings will be sluggish and the industry is expected to incur a net loss of around Rs 150-170 billion owing to elevated costs.

"However, this will be notably lower compared to the estimated net loss in FY2022, primarily driven by a recovery in passenger traffic and lower interest burden, following the significant reduction in Air India Limited's debt before the divestment by the Government of India," ICRA said.

Further, it said the hardening of airfares driven by strong cost fic grew around 26 per cent headwinds and a recent issue year-on-year to about 114 lakh of supply disruptions for spares



in October.

In the year-ago period, the number was 90 lakh passengers. However, the latest October figure remained 8 per cent

lower when compared to the pre-pandemic traffic level, the rating agency said in a report. ICRA has a negative outlook on the domestic aviation industry.

According to the report, the depreciation of the Indian rupee against the US dollar will have a major bearing on the airlines' cost structure.

The debt levels, including lease liabilities, are expected to be around Rs 1,00,000 crore in the ongoing financial year.

The airlines' efforts to maintain and/or grow their market share will limit their ability to expand margins in an elevated fuel cost environment, which will pose a serious challenge to the industry's earnings recovery in FY23, the report said.

Lately, the airlines have been steadily raising airfares but the same has not been adequate to offset the impact of the sharp rise in ATF prices, it said.

In ICRA's view, the domestic yields for H1 FY2023 are expected to have increased by around 30-35 per cent over the pre-Covid levels.

In addition to the surge in airfares, delays in the delivery of components and spares for aircraft and engines have been lately impacting the sector, thereby leading to the grounding of certain aircraft for some domestic airlines.

The airlines are in discussions with the Original Equipment Manufacturers (OEMs) for easing the supply issues and are also looking at leasing aircraft, including wet lease, to counter capacity constraints during the upcoming winter holiday sea-

### Ambani, Adani Among 13 **Bidders For Future Retail**

NEW DELHI: Firms run by billionaires Gautam Adani and Mukesh Ambani are among the 13 companies that have submitted initial bids to acquire Future Retail Ltd, a filing by the debt-laden company said.

Ambani's Reliance Retail Ventures Ltd, a subsidiary of Reliance Industries Ltd, submitted the expression of interest (EoI) under insolvency proceedings initiated to recover dues Future Retail owes to lenders.

April Moon Retail Private Ltd, a joint venture between Adani Airport holdings and Flemingo group, also submitted an EoI.

The deadline for submission of EoI ended on October 20, Future Retail, which was once the country's second-largest retailer, said in the stock exchange filing. Future Retail was dragged into bankruptcy proceedings by banks after it defaulted on loans and its lenders reiected a Rs 24.713-crore takeover of its assets by Reliance amid a legal challenge by Amazon.

Other entities that have submitted EOIs include Boomidala Enterprises Pvt Ltd, Capri Global Holdings Pvt Ltd, Shalimar Corporation Ltd, Nalwa Steel & amp; Power, United Biotech, WHSmith Travel, and United Biotech Pvt Ltd.

### **Embattled Crypto Exchange** FTX Files For Bankruptcy

NEW YORK: Embattled cryptocurrency exchange FTX, short billions of dollars, is seeking bankruptcy protection following its collapse this week.

FTX and its CEO and founder Sam Bankman-Fried are under investigation by the Department of Justice and the Securities and Exchange Commission to determine whether any criminal activity or securities offenses were committed. The person could not discuss details of the investigations publicly and spoke to The Associated Press on condition of anonymity.

The investigation is centering on the possibility that the firm may have used customers' deposits to fund bets at Bankman-Fried's hedge fund, Alameda Research. In traditional markets, brokers are expected to separate client funds from other company assets. Violations can be punished by regulators.

FTX had agreed earlier this week to sell itself to bigger rival Binance after experiencing the cryptocurrency equivalent of a bank run. Customers fled the exchange after becoming concerned about whether FTX had sufficient capital.

The crypto world had hoped that Binance, the world's largest crypto exchange, might be able to rescue FTX and its depositors. However, after Binance had a chance to look at the books of FTX, it became clear that the smaller exchange's problems were too big to solve. AP

### Rupee Gains 62 Paise To Close At 80.78 Against USD

MUMBAI: The rupee appreciated by 62 paise to close at 80.78 against the US dollar on Friday, as moderating US inflation data coupled with a fall in the dollar index boosted investor sentiments.

Forex traders said positive domestic equities and sustained foreign fund inflows also supported the local unit.

At the interbank foreign exchange market. the domestic currency opened at 80.76 and touched an intra-day high of 80.58 and a low of 80.99 against the greenback.

The local unit finally settled at 80.78, registering a rise of 62 paise over its previous close of 81.40. The rupee has now appreciated for five straight sessions.

The Indian rupee appreciated on weak US Dollar and positive domestic markets. Sustained FII inflows also supported Rupee," said Anuj Choudhary - Research Analyst at Sharekhan by BNP Paribas. However, a surge in crude oil prices capped sharp gains.

US inflation and core inflation declined to 7.7 per cent and 6.3 per cent in October from 8.2 per cent and 6.6 per cent in September, respectively, amid hopes that inflation may have peaked and Fed will not raise rates aggressively, Choudhary added. "We expect Rupee to trade with a positive bias on rise in risk appetite in global markets and weakness in the greenback," Choudhary said. PTI

### **Chinese Incursions Into India Strategically Planned, Coordinated Expansionist** Strategy' To Gain Permanent Control Of Disputed Border Areas: Study

New York: Chinese infringements into the Aksai Chin region are not random, independent events but are part of a strategically planned and coordinated expansionist strategy to gain permanent control of the disputed border area, according to a study on Chinese border incursions into India by a team of international experts.

The study Rising tension in the Himalayas: a Geospatial Analysis of Chinese Border Incursions into India' by Northwestern University, Technical University of Delft in the Netherlands and the Netherlands Defence Academy presented a geospatial analysis of the incursions, using an original dataset that covers the past 15 years.

We find that the conflict can be separated into two independent conflicts, west and east, centered around the major contested areas of Aksai Chin and Arunachal Pradesh. Building on insights from game theory, we conclude that the Chinese incursions in the west are strategically planned and aim for a permanent control, or at least a clearer status quo of the contested areas, the study said released on Thursday said.

For the study, the team defined an incursion' as any movement of Chinese troops across the border by foot or in vehicles into areas that are internationally accepted as India's territory. Then, they plotted each location on a map, identifying 13 hotspots where incursions happen most frequently.

In the 15-year dataset, the researchers noted an average of 7.8 incursions per year even though the Indian government's estimates are much higher. The India-China border dispute



covers the 3,488-km-long Line of Actual Control. China claims Arunachal Pradesh as part of southern Tibet while India contests it. Aksai Chin is a vast area in Ladakh which is currently under Chinese occupation.

According to Indian government data in 2019, the Chinese Army transgressed into Indian territory 1,025 times between 2016 and 2018. Then Minister of State for Defence Shripad Naik told the Lok Sabha in November 2019 that the number of transgressions by the Chinese Army in 2016 was 273 which rose to 426 in 2017. The number of such cases reported in 2018 was 326.

The study's authors are Jan-Tino Brethouwer and Robbert Fokkink of the Technical University of Delft, Delft Insititute of Applied Mathematics in Netherlands, Kevin Greene of Princeton University's School of Public and International Affairs, Roy Lindelauf of Netherlands Defence Academy, Faculty of Military Sciences in Breda, Netherlands, Caroline Tornquist of Dartmouth College's Department of Computer Science and V.S. Subrahmanian of Northwestern University's Department of Computer Science and Buffett Institute for Global Affairs in Evanston, US.

A press release from Northwestern said that the authors assembled a new dataset, compiling information about Chinese incursions into India from 2006 to 2020 and used game theory and statistical methods to analyse the data.

The researchers found that conflicts can be separated into two distinct sectors: west/middle (the Aksai Chin region) and east (the Arunachal Pradesh region).

Chinese incursions across India's west and central borders are not independent, random incidents that happen by mistake, the release said.

While the researchers learned that the number of incursions are generally increasing over time, they concluded that conflicts in the east and middle sectors are part of a coordinated expansionist strategy, it said.

Subrahmanian, the study's senior author and the Walter P. Murphy Professor of Computer Science at Northwestern's McCormick School of Engineering and a Buffett Faculty Fellow at Northwestern's Buffett Institute for Global Affairs, said that by studying the number of incursions that occurred in the west and middle sectors over time, it became obvious, statistically, that these incursions are not random. The probability of randomness is very low, which suggests to us that it's a coordinated effort.

When we looked at the eastern

sector, however, there is much weaker evidence for coordination. Settling border disputes in specific areas could be an important first step in a step-bystep resolution of the entire conflict, Subrahmanian said.

Knowing there are more incursions in the western sector is not a surprise, Subrahmanian said. Aksai Chin is a strategic area that China wants to develop, so it's very critical to them. It's a vital passageway between China and the Chinese autonomous regions of

Tibet and Xinjiang. The study, which notes the June 2020 Galwan clash that killed 20 Indian soldiers and an an unknown number of Chinese soldiers, said that reports of Chinese incursions into Indian territory are now a frequent occurrence.

This rising tension between the world's most populous countries poses risks for global security and the world economy. The militarisation of the region has a negative ecological impact, it said.

India and China are locked in a lingering border row in eastern Ladakh for over 29 months. The bilateral relationship came under severe strain following the deadly clash in Galwan Valley in eastern Ladakh.

The militaries of the two sides disengaged from a number of friction points following a series of diplomatic and military talks.

However, there has been no progress yet on resolving the standoff in the Demchok and Depsang regions.

India has been consistently maintaining that peace and tranquillity along the LAC are prerequisite for the overall development of the bilateral ties.

The study said that States respond not only to the actions directed toward them, but also respond to the actions directed within their alliance and rivalry networks.

India's participation in the Quad, the security dialogue between the United States, India, Japan and Australia, may serve as a trigger for Chinese activity along the China India border. China, on the other hand, is involved in cooperative activities with Pakistan, and is ready to step in the void that is left behind after the retreat of the western powers in Afghanistan.

China's foreign policy has become increasingly aggressive, stepping up its military exercises around Taiwan and extending its presence in the South China Sea. To counter China's expansive policies, Australia, the UK, and the USA have entered a partnership and one option for India is to align itself with the AUKUS countries, it said.

The study said that India and China remain at a constant state of high alertness and there are no signs that this situation will improve in the near future but a resolution of the conflict would be of great benefit for international security, the world economy, and for the preservation of the unique ecology of the Himalayas.

In a previous paper published by Nature Humanities and Social Sciences Communications in 2021, Subrahmanian and his collaborators studied when incursions are most likely to occur and found that China attacks when it feels most vulnerable.

We found an uptick in incursions when China is experiencing economic stress, such as low consumer confidence, Subrahmanian said. We also see upticks when India gets closer to the United States.

### Hate Speeches: SC Discharges Uttarakhand Govt, **Dgp From List Of Parties In Contempt Plea**

New Delhi: The Supreme Court on Friday discharged the Uttarakhand government and the police chief from a list of parties in a contempt plea filed by activist Tushar Gandhi pertaining to alleged inaction in cases of hate speeches made at religious assemblies in Haridwar in the state and the national capital last year.

A bench comprising Chief Justice D Y Chandrachud and Justice Hima Kohli took note of the submissions of the Uttarakhand government that a plea related to the hate speeches made at Haridwar is pending before another bench and hence it cannot be continued here.

"The state of Uttarakhand and the Director General of Police the state are accordingly

discharged," the bench said. It, however, asked the Delhi Police to file its response on action taken in the hate speeches made here within two weeks.

At the outset, Deputy Advocate General for Uttarakhand, Jatinder Kumar Sethi, informed the bench that two other benches presided over by justices K M Joseph and Ajay Rastogi are also dealing with similar issues and the present PIL of Gandhi be also sent to one of the benches.

Sethi said the state police had not only filed five FIRs in the hate speech related cases but had also filed charge sheet against the accused who were now facing trial. He said the Uttarakhand

Police had filed a detailed status report in matters pending before another bench and that

court was satisfied with its action, but Gandhi had now filed contempt petition before this court without referring to that matter.

### Fed Up Young Climate **Activists: "Adults Aren't Listening**"

he climate change generation is saying officials are talking too much, listening too little and acting even less. And they are fed up.

Instead of talking about how to solve the climate crisis, they negotiate about how to continue polluting, said Mitzy Violeta, a 23-year old indigenous activist from Mexico. Youth movements are realising the solution isn't going to be in international gatherings, like the one taking place in Egypt.

We're upset with the inaction that's being done, said Jasmine Wynn, 18, of the environmental group Treeage.

With decades of warmer and extreme weather ahead of them, young climate activists envision a future that has them frustrated and anxious, according to more than 130 activists questioned by The Associated Press.

Most of them said they think their strikes and protests are effective. But lately in high-profile, attention-grabbing actions, a handful of activists have gone beyond skipping school to targeting art work, tires and fossil fuel depots.

Experts and funders expect these in-your-face actions to escalate.

They will do whatever is nonviolently necessary. They're on fire, said Margaret Klein Salamon, a clinical psychologist who runs the Climate Emergency Fund that financially backs

some of the in-your-face protest events. They're so passionate. Some of that comes from youth, sure. But it is powered by reality, by having a sort of confrontation with the truth.

At one of the more traditional protests in New York City in September, 14-year-old Truly Hort said she was scared about the future: I've always had all these dreams, and now I'm like God, I can't do that.'

The trouble, she said, is that leaders talk about what they hope to do, but it's not a lot of people taking action.

Also mentioning her anxiety at the same protest 16-yearold Lucia Dec-Prat said, it's one thing to worry about the future and it's another to get out there and do something about it.

But protesting only does so much, Dec-Prat said: I honestly feel that adults aren't listening. Governments and interna-

tional organisations are advancing too slowly to fight climate change, many of those interviewed said about climate conferences. A vast majority of activists asked agreed with Greta Thunberg's characterisation of climate negotiations as all talk and no action, or blah blah blah, as the Swedish activist put it in a speech last year.

So rather than just making noise to contribute to the blah blah blah, make noise for action. I think that has to be the critical thing," said 25-year-old Jevanic Henry of St. Lucia in the Caribbean. We are driving action.

### Word Populaton Will Reach 8 Bilion In **Our More Days - UN**

he United Nations estimated on Monday that the world's population will reach 8 bilon on Nov. 15 and that India wil replace China as the word's most populous nation next year

În a report released on World Population Day, he U.N. also said global population growth fell below 1 per cent n 2020 for the first time since 1950.

According to the atest U.N. projections, the world's population could grow to around 8.5 billion in 2030. That number will ump to 9.7 billion in 2050 and a peak of around 10.4 billion during the 2080s. t is forecast to remain at that evel until 2100.

The report says more than half the projected increase in popula-tion up to 2050 will be concentrated in just eight countries: Congo, Egypt Ethiopia, India,

Nigeria, Pakistan, the Philippines and Tanzania.

The eport, Word Population Prospects 2022," puts the word's population at 7.942 billion now and forecasts it will reach 8 billion in mid November.

John Wilmoth, director of the U.N. Population Division, said at a news conference to release the date when the U.N.'s projection line crosses 8 billion is Nov. 15.

### **Twitter Reinstates** "Official" Account Tag As \$8 **Blue-Tick Option Vanishes**
