#### **CBI Files Chargesheet Against** 24 Accused

New Delhi: The CBI on Saturday filed a charge sheet against 24 people, including a former BSF commandant, in a case related to the police subinspector recruitment scam in Jammu and Kashmir, officials said.

In its charge sheet filed before a special court in Jammu, the CBI said Yatin Yadav of Rewari, the mastermind, had accessed the question paper of the examination conducted by the Jammu and Kashmir Services Selection Board through Pradip Kumar Katiyar, an employee of a printing press based in Delhi's Okhla.

Yadav used a network of middlemen and officials of Jammu and Kashmir Police and central paramilitary forces to target aspirants willing to cough up Rs 20-30 lakh to get through the recruitment process, the officials said.

Through the exam, 1,200 posts in the Jammu and Kashmir Police were to be filled up.

Those charge-sheeted include Yadav, Katiyar and former Border Security Force (BSF) commandant Karnail Singh. Central Reserve Police Force (CRPF) and BSF personnel and middlemen, most of them in judicial and police custody, are also among those charge-sheeted.

The Central Bureau of Investigation registered a case in the matter on August 3 this year on a reference from the Jammu and Kashmir administration to investigate the allegations of | More on P10

#### **DC Bans Heating Gadgets Ahead Of Winter, Faces Flak**

Srinagar: The administration in Central Kashmir's Ganderbal on Saturday imposed a blanket ban on the sale, storage and use of electric appliances during winters, evoking sharp criticism from the political parties.

Invoking orders under Section 144 CrPC OF 1973, the Deputy Commissioner Ganderbal Shyambir imposed blanket ban on the storage, sale, possession and use of heavy heating appliances like blowers, heaters, radiators, etc to avoid any collateral damages to electric supply.

"It has been apprehended that non-judicious use of electric appliances such as blowers, heaters, radiators, etc may cause damages to transmission lines due to heavy load resulting in disturbance in the hassle-free power supply," the order reads.

In view of the fast-approaching winter season and to avoid collateral damage to the electricity supply due to heavy load on the transmission system by use of heavy heating appliances which are not permissible... the District Administration Ganderbal imposes a blanket ban on the sale, possession, storage and use of such electric appliances in the district, the order further reads.

According to the order, by using the above-mentioned electric appliances there is every apprehension of short circuits which ultimately results in fire incidents during the winter season which causes loss of life and property.

## Fruit And Veg: Is It Better To Peel Them?

any people's default when preparing fruit and vegetables is to peel them. But often, it's not necessary. There are important nutrients in the peel. And, what's more, discarded fruit and veg peels contribute to climate change.

Fruit and vegetables are rich sources of vitamins, minerals, fibre and many phytochemicals (plant chemicals), such as antioxidants (substances that protect your cells from harm). Not consuming enough of these nutrient-rich foods is linked to an increased risk of chronic diseases, including cardiovascular disease and type 2 diabetes. In 2017, the World Health Organization reported that around 3.9 million deaths a year worldwide were attributable to people not eating enough fruit and veg.

Eating 400g of fruit and vegetables a day, as the WHO recommends, is difficult to achieve for many people. So could consuming fruit and vegetable peel help with this issue by adding important nutrients to people's diets?

They can certainly contribute. For example, nutritionally important amounts of vitamins, such as vitamin C and riboflavin, and minerals such as iron and zinc, are found in the peel of seven root vegetables: beetroot, field mustard, wild carrot, sweet potato, radish, ginger and white potato. And the US Department of Agriculture shows that unpeeled apples contain



15% more vitamin C, 267% more vitamin K, 20% more calcium, 19% more potassium and 85% more fibre than their peeled equivalents. Also, many peels are rich in biologically active phytochemicals, such as flavonoids and polyphenols, which have antioxidant and antimicrobial properties.

Another reason to not discard peels is their effect on the environment. According to the UN's Food and Agriculture Organization, uneaten food, including peel,

generates 8%-10% of the world's greenhouse gas emissions. (Food rotting in landfills releases methane, the most potent greenhouse gas.) New Zealand alone reports an annual wastage of 13,658 tonnes of vegetable peels and 986 tonnes of fruit peels - a country with a population of only 5.1 million people.

Given the nutrient content of peel and its contribution to food waste, why do people peel fruit and vegetables at all? Some must be peeled as the outer portions are inedible, don't taste nice, are hard to clean or cause harm, such as banana, orange, melon, pineapple, mango, avocado, onion and garlic. Also, peeling may be a necessary part of the recipe, for example, when making mashed potato. But many peels, such as potato, beetroot, carrot, kiwifruit and cucumber, are edible, yet people peel them anyway.

Pesticide residue

Some people peel fruit and veg because they are concerned about pesticides on the surface. Pesticide residues are certainly retained on or just below the surface, although this varies according to plant species. But most of these residues can be removed by washing. Indeed, the US Food and Drug Administration recommends that people wash produce thoroughly under cold water and scrub it with a stiff brush to remove pesticides, dirt and chemicals.

Cooking techniques, such as boiling and steaming, can also reduce pesticide residue. But not all pesticide residues are removed by washing and cooking. And people who are concerned about their exposure to pesticides may still wish to peel. Lists of pesticide contents for fruit and vegetables are available in some countries, for example, the Pesticide Action Network produce one for the UK. This can help you to decide which fruit and veg to peel and which peels can be eaten.

If you want to find out more about fruit and vegetable peel and what to do with it, there is lots of advice online including help on how to use peels for composting, to feed a wormery, or incorporation into recipes. With a little investigation and creativity, you can help to reduce waste and increase your fruit and vegetable intake. Surely it's worth a try? And you'll be helping to meet one of the UN's sustainable development goals: to halve food waste by 2030.

## '50 Percent Indians

FEW DELHI: Almost 60 per cent of Indians using government ser¬vices end up paying bribes, according to a recent survey commis¬sioned by India's Central Vigilance Commission (CVC). But only 20 per cent actually filed complaints against such corrupt practices.

The study was carried out by the Centre for Media Studies (CMS), which interviewed 2,576 visitors to government offices in five cities across the country from October 31 to November 4.

More than 60 percent of respondents said the problem of cor-ruption was not being tackled seriously and that the judiciary was largely ineffective. Most of the respondents agreed the offices for securing driving licenses and civil supplies were the most corrupt in all five cities — New Delhi, Lucknow, Madras, Hyderabad and Pune.

One-third of respondents admitted to using "influence or fa¬vour" to get the service they needed. The survey noted that mem¬bers of the business community and the self-employed topped the list of bribe givers. According to the survey, the government departments in Lucknow and Hyderabad were the most corrupt. About 42 per cent of people said the departments operated "Middle men" who acted as a paid conduit between the public and officials. The public departments covered by the survey included electricity and telephone boards, civil supplies,

driving license and local and urban development offices. (Kashmir Observer, November 13, 2000)

### **Afghanistan Living** World's Most Severe **Hunger Crisis: UN**

The UN Food and Agricul-ture Organization (FAO) warned in a report on 11 November that Afghanistan faced an unprecedented crisis in 2021, leading to a rapid increase in acute food insecurity this year.

Since March 2022, the country has been suffering one of the largest and most severe hunger crises in the world; affecting 22.8 million people equivalent to more than half of the population — as a result of prolonged drought, the US-led conflict, political instability and Covid-19, the document reflects.

The Afghanistan Chamber of Agriculture and Livestock warned of the severe agri-food crisis facing the country and called on international aid organizations to support the agricultural sector.

"We call on the (FAO) to support Afghan farmers for the coming year, and on the Taliban government to prevent food

prices from rising," said the deputy director of the Chamber of Agriculture and Livestock (ACAL), Mirwais Hajizada.

According to ACAL statistics, more than 40,000 hectares of agricultural land were destroyed by floods throughout Afghanistan.

Meanwhile, the government of US President Joe Biden is still in the process of deciding whether to return half of Afghanistan's foreign reserves currently held in the Federal Bank of New York.

Earlier this year, the White House unilaterally decided to keep half of Afghanistan's \$7 billion in reserves, with the other half having been earmarked to pay the families of the 11 September victims.

Other countries hold some \$2 billion of Afghan reserves.

According to the UN, Afghanistan's food crisis was severely exacerbated after Washington and other donors halted aid that funded 70 percent of the government budget.

#### **Centre On Why Scheduled Castes' List Excludes Dalit Christians, Muslims**

**NEW DELHI:** The Centre has defended the exclusion of Dalit Christians and Dalit Muslims from the list of Scheduled Castes, saying historical data shows no backwardness or oppression was ever faced by them.

Contending that Dalit Christians and Dalit Muslims cannot claim benefits which Scheduled Castes are entitled to, the Ministry of Social Justice and Empowerment in an affidavit in the Supreme Court said the Constitution (Scheduled Castes) Order of 1950 does not suffer from any unconstitutionality.

The affidavit was filed in response to a plea of NGO Centre for Public Interest Litigation (CPIL) seeking extension of reservation and other benefits to people from Dalit communities who converted to Islam and Christianity.

The ministry also submitted that the identification of Scheduled Castes is centred around a specific social stigma that is limited to the communities identified in the Constitution (Scheduled Castes) Order, 1950.

The Constitution (Scheduled Caste) Order, 1950, "does not suffer from any unconstitutionality inasmuch as the exclusion of Christianity or Islam was due to the reason that the oppressive system of untouchability that leads to economic and social backwardness of some Hindu castes was not prevalent in Christian or Islamic societies", the affidavit said.

The Order "was based on historical data which clearly established that no such backwardness or oppression was ever faced by members of Christian or Islamic society", it said.

"In fact, one of the reasons for which people from Scheduled Castes have been converting to religions like Islam or Christianity is so that they can come out of the oppressive system of untouchability which is not prevalent at all in Christianity or Islam," the affidavit said.

The ministry also refused to agree with the report of the Justice Ranganath Mishra Commission that recommended inclusion of Dalit Christians and Dalit Muslims in the Scheduled Castes list, and said it took a myopic view.

## Rajiv Gandhi Killers Walk **Out Of Jail After 31 Years**

CHENNAI: Nalini Sriharan, her husband and three other convicts in the Rajiv Gandhi assassination case were released from Tamil Nadu prisons on Saturday evening.

Immediately after she was released from the special prison for women in Vellore, Nalini went to the Vellore central prison from where her husband V Sriharan alias Murugan was released and became emotional upon seeing him.

Murugan, along with Santhan, both Sri Lankan nationals, were taken in a police vehicle following their release to the special refugee camp in Tiruchirappalli in the state.

Two other Lankan nationals -- Robert Payas and Jayakumar released from the Puzhal prison here, were taken to the special refugee camp in Tiruchi-rappalli to be lodged there.

Earlier, another convict who was set free in May earlier, Perarivalan, along with his mother Arputhammal received the duo at the Puzhal prison.

The prison officials set into motion the process of releasing all six of them including four Sri Lankan nationals,



following the receipt of the Supreme Court's Friday order copy setting them at liberty.

The Supreme Court on Friday set free Nalini Sriharan and five other remaining convicts, who are serving life terms for about three decades in the Rajiv Gandhi assassination case, noting that its earlier order releasing another convict A G Perarivalan was equally applicable to them.

Earlier in the day, with relief writ large on her face, Nalini on parole for a month was escorted by the police to sign at the Katpadi police station.

Late in the afternoon, she was taken to the Vellore prison to complete the formalities pertaining to her release.

Similarly, the Supreme Court's order copies were sent to the Puzhal and Madurai central prisons where the remaining persons have been lodged.

"Nalini Sriharan is all set to walk out of the prison this evening. She will be a free woman and would decide on her future," her advocate P Pugazhendi, said when contacted.

It was not immediately clear if she would stay in Chennai or join her daughter in London. "She will take a call on this," Pugazhendi told PTI.

Asked about the fate of her husband, a Sri Lankan national, the senior counsel said the state government would decide.

"Santhan had already expressed his intention to return to Sri Lanka. Initially, they may be lodged at the Sri Lankan refugee camp," he said.

### **Ayurveda's Spread Was** Stopped By Invaders, **Reviving Again: RSS Chief**

NAGPUR: Rashtriya Swayamsevak Sangh (RSS) chief Mohan Bhagwat on Saturday said the spread of Ayurveda had stopped because of invasion by foreigners earlier, but now this ancient system of medicine is getting recognition again.

He also said steps need to be taken so that Ayurveda gets global recognition.

Bhagwat was speaking at 'Ayurveda Parv', an international conference organised here by the Ministry of Ayush. Ayush stands for Ayurveda, Yoga, Naturopathy, Unani, Siddha and Homeopathy.

Union Ayush Minister Sarbanand Sonowal and Goa Chief Minister Pramod Sawant were present on the occasion.

"Spread of Ayurveda among people had stopped due to invasion by foreigners. But Ayurveda is again getting recognition and it is time to expand the knowledge related to Ayurveda," Bhagwat said.

"So how should we take Avurveda forward? The way is that everyone should get affordable and simple medical treatment, and for this, there is no better option than Ayurveda," he added.



Ayurveda in its purest form should be practised, so that it gets international recognition, Bhagwat said.

Speaking on the occasion, Sonowal said that since the last seven years, Ayurveda has been getting international recognition.

He praised Prime Minister Narendra Modi for boosting Ayurveda by forming as separate Ayush ministry, and said this system of medicine was earlier neglected.

"Until 2014, the market size of the Ayush industry was only USD 3 billion. But in the past eight years, it has grown to USD 18.1 billion globally and will further rise to USD 23 billion by 2023," the Union minister added.

Sawant said Ayurveda is seeing 'achhe din' under the leadership of PM Modi.

#### **Israel Admits Shin Bet Tracked Journalists Using Mobile Phone Data**

**¬**he Israeli government has admitted that its national intelligence service, the Shin Bet, used databases of cell phone companies to monitor the activities of journalists, as well as other professionals trained to protect privileged information, such as doctors or clergy, according to Haaretz.

Using the database, the agency can work out where a journalist is based on their mobile phone location, as well as who they talked to and for how long.

This was revealed by Tel Aviv in response to a petition filed with the Supreme Court by the NGO Association for Civil Rights in Israel (ACRI), which asked the court to strike down a clause in the law regulating Shin Bet onerations concerning its power to require operators to hand over information on calls or messages, according to Middle East Eye (MEE).

The law, passed in 2002, has been criticized for its semiclandestine nature as it is not subject to public scrutiny, although the head of the Shin Bet is obliged to seek permission from the prime minister

and the attorney general every three months, and once a year before a committee of the Knesset.

The Supreme Court is now analyzing the regulation since, in the opinion of ACRI, it incurs several unconstitutional errors by involving an invasion of privacy and taking away journalists' right to the protection of their sources.

The government now has three months to inform the Supreme Court whether or not it decides to amend this law, Haaretz says. However, the Israeli state has already asked the Supreme Court to dismiss the request on the grounds that "data collection is vital to the agency's operations" and "has already provided essential help in dismantling terrorist attacks and saving lives."

On 26 October, Israeli forces managed to track down and kill at least two leaders of the Lion's Den resistance faction after infiltrating the group's infrastructure using the blacklisted Pegasus spyware.

According to Israeli newspaper Yedioth Ahronoth, Pegasus helped Tel Aviv obtain "accurate intelligence information and thwart [retaliatory] operations" by the resistance.

## **Himachal: Moderate Polling As Voters Trudge Through Snow To Elect New Govt**

SHIMLA: From Shimla to the icy heights of Spiti, people across Himachal Pradesh voted on Saturday to elect a new state government. The state recorded a voter turnout of 65 per cent.

It is a crucial test for the BJP hoping to beat precedent and return to power as well as for the Congress looking for electoral revival. Voting began at 8 am on a slow note but picked up as the day progressed and the sun warmed the winter chill.

By 3 pm, 55.65 per cent of the electorate had voted, the Election Commission (EC) said. Polling was scheduled to end at 5 pm.

The highest polling of 62.75 per cent was recorded in Lahaul and Spiti district, followed by 60.38 per cent in Sirmour and 58.9 per cent in Mandi, Chief Minister Jairam Thakur's home district.

As voting got underway, people could be seen basking in the sun as they waited for their turn, and some, in the higher reaches of the mountains, trudging through the snow to reach



polling stations. IN PICS | Himachal polls: Voters turn up from high altitude to snow-capped regions

Till 3 pm, Seraj in Mandi and Sujanpur recorded 65 per cent polling, the highest among the 68 assembly constituencies. Anni constituency recorded polling of 62.4 per cent, Arki 40 per cent, Churah 34.68 per cent and Dalhousie 38.44 per cent, among others.

In an early morning message to voters, Prime Minister Narendra Modi urged them to enthusiastically participate in the "festival of democracy" and register a voting record. In a tweet, Modi also greeted young voters who will be exercising their franchise for the first time.

Braving the cold, a large number of centenarians voted in the assembly elections with 105-year-old Nari Devi exercising her franchise in Churah in Chamba and 103-year-old Pyar Singh in Shimla. The EC had made special

arrangements for the elderly and persons with disabilities at polling stations There are over 1.21 lakh

elderly above 80 years in the state, with 1,136 being centenarians. In Chasak Bhatpri, an

83-year-old woman was among those who cast their vote in the Bharmaur constituency in Chamba, the farthest in the state, the poll panel said.

in two cases of robbery and burglary, police said. On Thursday around 4 pm, information was received that a two-month-old boy was kidnapped by an unknown woman

from Garhi area, they said. A team comprising subinspector Rajinder Singh, head constables Ravinder Giri. Sher Singh, Sachin Saroha, Neeraj Kumar and Dinesh Kumar, and woman constable Poonam was formed to crack the case. The team was led by SHO Amar Colony police station Pradeep

According to the police, the infant's mother informed that the kidnapper met her in Safdarjung Hospital and

introduced herself as member of an NGO working for Jachcha-Bachcha care.

Shweta promised to provide free medicine and consultation to the mother and the child. Later, she followed them on the pretext of examining the newly born baby, police said.

On Wednesday, the accused also came to the family's home at Mamraj Mohalla, Garhi, for the check-up of the baby.

On Thursday, she came to their home again and convinced the mother of the child to hand over the infant for outing. The mother asked her 21-year-old niece to accompany Shweta, a senior police officer said.

The accused woman came to Neem Chowk, Garhi and took the infant in her car with victim's niece Ritu. On the way, the kidnapper offered cold drink to Ritu, due to which she fell unconscious. Later, the kidnapper dumped Ritu in Ghaziabad, the officer

said. After gaining some consciousness, Ritu informed her family that the child had been kidnapped, police said. During investigation, police checked the CCTV footage of

the area and identified the registration number of the vehicle, they said. On Thursday around 4 pm,

father had died in October. During the last rites, she came to know that human sacrifice of an infant of the same gender "could revive her father and bring him to life," the officer said. To execute this supersti-

tion, she started searching for an infant boy in the area. She went to Safdarjung Hospital in maternity ward and introduced herself working in an NGO for newly born child and mother, police said.

Later, she met the victim mother. To win her confidence, she often visited the infant and the family, they said.

## **Gujarat Riots Convict's Daughter Gets BJP Ticket For Upcoming Polls**

AHMEDABAD: The Bharatiya Janata Party (BJP) has fielded the daughter of a 2002 post-Godhra Naroda Patiya massacre case convict from Naroda seat of Ahmedabad for the upcoming Assembly elections.

Payal Kukrani, 30, the daughter of Manoj Kukrani who is one of the 16 convicts in the Naroda Patiya riots case in which 97 Muslims were killed, is also among the youngest candidates fielded by the ruling party this time. She is an anaesthetist.

The Gujarat High Court had in 2018 upheld the conviction of Manoj Kukrani and 15 others in the Naroda Patiya riots case. Kukrani, who was sentenced to life imprisonment, is currently out on bail.

Talking about the BJP's move to field her, Payal Kukrani said, "I am grateful to Prime Minister Narendra Modi, Home Minister Amit Shah, state BIP president C R Paatil, Chief Minister Bhupendra Patel and all party workers and members. My mother is a corporator and my



be to develop the constituency and resolve the issues faced by the local people.

Her mother Reshma Kukrani, a local BJP corporator, said that she would provide complete support to her daughter and make sure that she wins the election.

The Kukrani family belongs to the Sindhi community that dominates the area. The BJP fielded Payal Kulkarni instead of giving another chance to sitting MLA Balram Thawani. Some BJP workers in the area have expressed unhappiness over her candidature as they believe that she is married to a non-Sindhi and hence is no longer a member of the community.

Former BJP minister Maya Kodnani was also one of the convicts in the Naroda Patiya riots case, but was acquitted by the high court in 2018. Kodnani had served as three-term MLA from the Naroda seat. She was arrested in 2009. She is also an

accused in the Naroda Gam riots case, one of the nine major communal riots that occurred in the wake of the train burning incident at Godhra. These cases were investigated by a Special Investigation Team (SIT).

The BJP has held the Naroda Assembly seat since 1990. Kodnani became the MLA in 1998 and retained the seat in 2002 and 2007.

Out of the total 61 accused in the case, the special SIT court had in August 2012 held 32 guilty, and acquitted 29 others. In its order on appeals in the case in April 2018, the high court had convicted 16 people.

A mob had killed 97 people, most of them from a minority community, in the Naroda Patiya area of Ahmedabad on February 28, 2002, a day after the torching of the Sabarmati Express at Godhra.

In the Godhra train burning incident of February 27, 2002, 59 'kar sevaks' were killed, triggering the worst communal riots in the history of Gujarat in which over 1,000 people, mostly belonging to the minority community, were killed.

### BJP Govt Delaying J&K Polls To Continue Its Proxy Rule: AAP

JAMMU: The Aam Aadmi Party (AAP) on Saturday alleged the BJP government was delaying the assembly elections in Jammu and Kashmir on one pretext or another to deny people their democratic rights.

"We demand setting up of an apex committee headed by the Union home minister Amit Shah for formulation of comprehensive road map on how Kashmiri Pandits will return and be rehabilitated back in valley," Bhat said.

He said it will be true tribute to "KP martyrs" that the entire displaced community returns back to Kashmir and settles there.

Bhat alleged that the rehabilitation package for Kashmiri Pandits announced by the Centre a few years ago is an eyewash.

### Bandipora Achieves Major Milestone In Power Sector

Reduces More Than 50% AT&C Losses; Billing Efficiency Increased To 72%

**BANDIPORA:** The Bandipora district has achieved a major milestone in energy conservation as it has been able to reduce the aggregate technical and commercial loss (AT&C) losses by about 50 percent by upgrading the transmission system in the district.

Deputy Commissioner (DC) Bandipora, Dr Owais Ahmad said that a large quantity of electricity gets wasted during transmission due to faulty and poor transmission systems which was a major worry amid energy crisis across the globe.

He said Bandipora has become the top performing district in the Kashmir division for reducing the AT&C losses as Average AT&C Losses for Bandipora decreased to 28.30% which was 53.71% during 2021.

He said that this milestone was achieved due to constant efforts of all concerned to upgrade the transmission lines and plug the loopholes that increase AT&C losses.

Dr Owais appreciated the people for lending their sup-

port in this regard and bearing with them during this massive upgradation process. He said with the improvement in transmission, the billing efficiency has also increased to about 72 percent, which led to the top rank in Kashmir division.

The DC said that operation of augmented facilities helped to reduce AT&C losses in the district. He appreciated the efforts of field functionaries of KPDCL for adopting the reforms on ground besides working in adverse weather conditions to augment the power infrastructure.

He said that the UT Government has initiated a large-scale capacity augmentation programme to address the power deficit and stated that the administration is committed to further reduce the AT&C losses in the district and appealed to people to continue supporting the efforts of the administration.

## Exorcise the Awe

otwithstanding the claims of unity made by the coalition leaders the state cabinet is a divided house. The past two years in office have proved beyond doubt that the Mufti Mohammad Sayed is the weakest Chief Minister State has seen in its recent history.

It is infact some key Congress ministers in the coalition government who have been calling the shots. They have been working overnight to strengthen their respective political constituencies. They have a brazen tilt towards Jammu and Kathua districts of Jammu province. One of them very intelligently prevailed upon the former chairman of Jammu and Kashmir Public Service Commission and got combined service selection list tailored as per his wishes. Despite public outcry against this list, Chief Minister Mufti Mohammad Syeed made the state cabinet to approve it. In spite of governments tilt towards Jammu under pressure of its coalition partner some of the cabinet ministers from the province still blame the government of discriminating against Jammu in the allocation of funds, appointments and promotions. This in fact is not a new phenomenon. Political leadership of Jammu, irrespective of their party affiliations have been complaining of discrimination against their province ever since mahraja rule ended in the state and ever since is being trumpeted by leaders of all hues, stature and ranks. The installation of what in common parlance is known as 'popular' rule in the State in 1947 was painted as 'Kashmir hegemony' by majority of Hindu politicians of Jammu province. Surprisingly even leaders of the ruling parties the National Conference and Congress belonging to the community joined the Hindu extremists and sang in unison with them the 'song of discrimination'. Agitations were launched against so called discrimination against Jammu. And most of the times these agitations derived inspiration and support from New Delhi. Some of prominent Delhi politicians actively participated in them.

Some agitations forced governments at Srinagar to appoint Commissions to look into the so-called regional imbalance and discrimination against the Jammu province. But findings of these Commissions particularly that of the Skiri Commission appointed in 1978 not only belied these allegations but proved that if there has been any discrimination it has been against Kashmir valley and Muslim dominated areas of Jammu province. It goes without saying that if there has been any discrimination it has been against the Kashmir province, Doda, Rajouri and Poonch districts. The Jammu politicians have every right to strive for the development of the province but not at the cost of Kashmir province. The Chief Minister Mufti Mohammad Sayed need to come out of the awe of his coalition partners and do justice to Kashmir and Muslim dominated districts of Jammu province in the allocation of funds, providing of jobs and trainings. He needs to realize that whatever public support he got by proxy during 2002 elections was from Kashmir and Muslim dominated areas of Jammu. The 2002 support was a fallout of the failures of the National Conference government and Farooq Abdullah's heavy reliance on New Delhi than on the people of the state. The PDP leaders need to know that their real judges are the people and not the coalition partners.

## Transgenders, Kashmir and Islam

Rashid alias Reshma, the debate around transgender their reception and evaluation by our religion – the religion of Islam and our society has prominently figured among social media denizens and people otherwise. Barmania and Aljunid, Caroline, Lee and others maintain in their studies that transphobia, discrimination and injustice, violence and persecution continue to be the fate of transgenders in Islamic countries. The scenario in Kashmir, though moderated by cultural inklings of inclusion and diversity, isn't all well and transgenders continue to face marginalisation and ostracism. While an attitude of criminal maltreatment is meted out to the transgender community, the plight is aggravated by the misnomer that this behaviour is sanctioned rather desired by the religion. It is often postulated that Islam demands from us the behaviour of exclusion and stigmatisation for transgenders. But this understanding asks for a proper and deeper understanding of the Islamic stand on the issue of transgenders lest our attitudes and behavioural latitude towards the community be distorted by our bias and insubstantial claims.

What are the actual Islamic rulings on the issue of transgenders and do they truly grant any legitimacy to our ill formed opinions on the subject?

To begin with, there is no monolithic practice prevalent among Muslims across the globe in their behaviour towards transgenders and the behavioural diversity is shaped by geography, culture and at times by the era or epoch referred to. Thus, we see a spectrum of behaviours from welcoming and inclusive to a level of rejection that can be marked by a range of actions ranging from social marginalisation to physical violence. The prevalent balance, despite the global diversity, is one of exclusion and otherisation. But these practices and behavioural attitudes are not sanctioned or legitimized by the theoria and praxis of Islam.

It must however be borne in mind that there are precedents from Seerah, Sunnah and the repository of Ahadith which point in opposite direction and those incidents are so explicit and frequent as to easily lead one to conclude as if Islam is transphobic. But a deeper and contextual understanding of these incidents wakes us up to the true import of these precedents and helps us avoid wrong inferences.

Various academics such as Alipour and Rowson point to references in the Hadith to the existence of mukhannath: a man who carries femininity in his movements, in his appearance, and in the softness of his

voice. The Arabic term for a trans woman is mukhannith as they want to change their biological sex characters, while mukhannath presumably do not/have not. The mukhannath or effeminate man is obviously male, but naturally behaves like a female, unlike the khuntha, an intersex person, who could be either male or female.

Ironically, while there is no obvious mention of mukhannath, mukhannith or khuntha in the Qur'n, this holy book clearly recognizes that there are some people, who are neither male nor female, or are in between, and/or could also be "non-procreative". The presence of effeminate men (mukhannath) during the time of the Prophet is well documented. However, almost all references justifying animosity towards transgender people in the Hadith have been quoted out of context, and they wrongly condemn transgender people, despite so many major Islamic scholars having argued that the Hadith actually refer to cross-dressers who want to deceitfully gain access to women's spaces . house because he had breached the trust of the Prophet but not because of his effeminate identity. The Prophet's prohibition was rather a response to his actions in this particular situation. Clearly, just like any other person, the principles of moral and ethical behavior were also applied to them and did not entitle them to speak or behave inappropriately. This hadith narration is commonly used by conservative Muslim scholars to justify hatred for effeminate men and transgender people as it is used as proof that Muslims should not allow them in their houses . In reality, the Prophet did not punish mukhanath unless they carried out immoral acts, nor did he try to 'cure' them. In one Hadith, the Prophet was recorded to have saved the life of a mukhanath when others wanted to kill him (Sunan Abu-Dawud, Book 41, Number 4910). In the narration, although he was exiled from Medina for immoral behavior, the Prophet still respected this person as a human being, sparing his life and allowing him to carry

Had th in reference to transgender have been narrated by many Islamic scholars like Ibn Majah, Al-Bukhari, Al-Tirmidhi, Ibn Hanbal and Abu Dawud.

There is considerable evidence that in pre-colonial Islamic communities, mukhannath served as servants as long as they had no sexual interest in women. They would then be allowed to enter women's private places such as harems and other exclusively female spaces .Those males whose effeminate qualities were innate and natural, and who did not experience sexual attraction toward women, received no blame, guilt or shame as they were not considered sinners and were not to be punished. Because of the regularity of mukhanath hired in women's spaces, there were men who sought to take advantage because they lusted after women and pretended to be mukhanath in order to gain access into women's spaces.

Al- Tabari took it as an example that the Prophet did not forbid a particular mukhanath, Hit, from entering the women's quarters until he heard the servant giving a description of the women's bodies in great detail.

out his religious deeds.

These surveys, bordering on history and the corpus of Hadith literature, reveal that prohibitions, if any, in respect of transgenders, were purely circumstantial and conditional. The class of Ulema needs to dispense fuller information along with contextual underpinnings to the populace to protect the transgender community from misdirected maltreatment and exclusion. Moreover, it is high time to rise up to the conscience and consciousness that transgenders have equal rights to the life of dignity and honour, of economic inclusion and participation in opportunities. To exclude and marginalise people on the basis of sexual orientations and trying to seek legitimacy for this behaviour from scripture is a task of folly which stakes both the dignity of transgenders and the sanctity of religion.




## BATTLE OF BAT AND BALL Final Showdown at MCG

## 'Popular Dietary Supplements May Increase Cancer Risk'

ntake of popular commercial dietary supplements like nicotinamide riboside (NR), a form of vitamin B3, could actually increase the risk of serious diseases, including cancer, a new study has found.

The team of researchers discovered that high levels of NR could not only increase the risk of someone developing triple-negative breast cancer but also cause the cancer to spread to the brain, the study said.

Triple-negative breast cancer is considered to be more aggressive when compared to other types of cancer as it grows quickly, is more likely to have spread by the time it is found and is more likely to come back after treatment

"Once the cancer reaches the brain, the results could be deadly because no viable treatment options exist at this time," said Elena Goun, the lead author on the study which is published in the journal Biosensors and Bioelectronics

"Some people take them (vitamins and supplements) because they automatically assume that vitamins and supplements only have positive health benefits, but very little is known about how they actually work," Goun said.

"Because of this lack of knowledge, we were inspired to study the basic questions surrounding how vitamins and supple-



ments work in the body," Goun said. Following the death of her 59-year-old father only three months after being diag-

nosed with colon cancer, Goun was moved

by his passing to pursue a better scientific understanding of cancer metabolism, or the energy through which cancer spreads

Since NR is a known supplement for helping increase levels of cellular energy, and cancer cells feed off of that energy with their increased metabolism, Goun wanted to investigate the role of NR in the development and spread of cancer.

"Our work is especially important given the wide commercial availability and a large number of ongoing human clinical trials where NR is used to mitigate the side effects of cancer therapy in patients," Goun said.

The researchers used this technology to compare and examine how much NR levels were present in cancer cells, T cells, and

healthy tissues.
"While NR is already being widely used in people and is being investigated in so many ongoing clinical trials for additional applications, much of how NR works is a black box - it is not understood," Goun said.

'So that inspired us to come up with this novel imaging technique based on ultrasensitive bioluminescent imaging that allows quantification of NR levels in realtime in a non-invasive manner. The presence of NR is shown with light, and the brighter the light is, the more NR is present." Goun said the findings of the study emphasise the importance of having careful investigations of potential side effects for supplements like NR prior to their use in people who may have different types of health conditions.

In the future, Goun would like to provide information that could potentially lead to the development of certain inhibitors to help make cancer therapies like chemotherapy more effective in treating cancer.

The key to this approach, Goun said, is to look at it from a personalised medicine standpoint. "Not all cancers are the same in every person, especially from the standpoint of metabolic signatures," Goun said. "Often times cancers can even change their metabolism before or after chemotherapy."

## 'Stressful Events May Worsen Long-Covid Symptoms'

dult patients with "major life stressors" were at least twice as likely to struggle with de-▶pression, brain fog, fatigue, sleep problems, and other long-term COVID-19 symptoms, a new study finds.

The death of a loved one, financial or food insecurity, or a newly developed disability were some of the strongest predictors - present in more than 50 per cent of those followed - of whether a patient hospitalized for COVID-19 would experience symptoms of long COVID a vear later, the study said

The analysis, published in the Journal of the Neurological Sciences (JNS), also confirmed the contribution of traditional factors to greater long COVID risk as shown by past studies older age, disability level to start with, and a more severe initial case of COVID-19, the study said.

"Our study is unique in that it explores the impact of life stressors along with demographic trends and neuro-

logical events as predictors of long-term cognitive and functional disabilities that affected quality of life in a large population," said lead study author Jennifer A. Frontera, NYU School of Medicine.

"Therapies that lessen the trauma of the most stress-inducing life events need to be a central part of treatment for long COVID, with more research needed to validate the best approaches,"

In analyses that compared factors against each other for their contribution to worse outcomes, life stressors including financial insecurity, food insecurity, death of a close contact, and new disability were the strongest independent predictors of prolonged CO-VID-19 symptoms.

These same stressors also best predicted worse functional status, depression, fatigue, sleep scores, and reduced ability to participate in activities of daily living such as feeding, dressing, and bathing.

The research used standard telephone survey tools in the field to measure level of daily function, clear think-

ing (cognition), anxiety, depression, fatigue and sleep quality.

The team attempted follow-up with each of 790 patients six months and a year after COVID-19 hospitalization within NYU Langone Health between March 10, 2020 and May 20, 2020.

Of these surviving patients, 451 (57 per cent) completed 6-month and/or 12-month follow-up, and of them, 17 per cent died between discharge and 12-month follow-up and 51 per cent reported significant life stressors at 12-months.

Gender was also a contributor, as past studies have found that women are more susceptible in general to, for instance, autoimmune diseases that could have an impact on outcomes. Additionally, undiagnosed mood disorders may have been unmasked by pandemicrelated stressors

A second study led by Frontera and colleagues, and published online September 29, 2022, in PLOS ONE, found that patients diagnosed as having long COVID neurological problems can be divided into three symptom groups.

## Per Capita Income Rose In Real **Terms By 33.4% Since Enactment** Of NFSA: Centre To SC

**NEW DELHI:** Per capita income of population in India has increased in real terms by 33.4 per cent since the enactment of National Food Security Act (NFSA) in 2013, the Centre has told the Supreme Court.

In an affidavit filed before the top court, the Union government said this rise in per capita income of people has taken a large number of households to higher income class.

"During last eight years, since the enactment of NFSA, per capita income of the population in India has increased in real terms by 33.4 per cent. The rise in per capita income of people is bound to have taken a large number of households to higher income class and they may not be as vulnerable as they were in 2013-14," the Centre said

The affidavit was filed in response to a plea seeking welfare measures for migrant workers.

The government has notified the National Food Security Act, 2013 on September 10, 2013 with the objective to provide for food and nutritional security in human life cycle approach, by ensuring access to adequate quantity of quality food at affordable prices to people to live a life with dignity.

The Act provides for coverage of up to 75 per cent of the rural population and up to 50 per cent of the urban popula-



tion for receiving subsidised foodgrains under Targeted Public Distribution System

Referring to the increase in per capita income, the Centre said the upper limit of 75 per cent for rural and 50 per cent for urban population who were considered vulnerable in 2013-14, would have gone down considerably.

"Non-exclusion of non-eligible households in NFSA increases the subsidy burden on the Union government," it said.

The Union government also informed the top court that about 4.7 crore ration cards have been added in the last eight years under NFSA.

"The overall national ceiling under NFSA is 81.4 crore beneficiaries and a few states are vet to reach their state ceiling. Actual national coverage is nearly 79.8 crore as on August

31. Under NFSA ceiling, there is still scope for adding approximately 1.6 crore beneficiaries for Antyodaya Anna Yojana and priority households categories," it said.

Migrant workers play a very vital role in building the nation and their rights cannot be ignored at all, the top court had earlier said while asking the Centre to devise a mechanism so that they receive food grains without ration cards.

It also observed that citizens are dying due to hunger despite our development and modalities should be set out to ensure that maximum migrant workers are given rations.

The apex court had said the welfare schemes devised by the Centre should reach a maximum number of workers and the state governments will have to cooperate and assist the Union of India

#### **No Need To Change Inflation** Target Of 2-6%; Oct Print To Be Lower Than 7%: RBI Guv

NEW DELHI: RBI Governor Shaktikanta Das on Saturday said there was no need to change the inflation target despite the central bank's failure to keep it below the 6 per cent upper tolerance level for 9 consecutive months while exuding confidence that the October print will be less than 7 per cent.

Inflation has been trending above the RBI's upper tolerance level of 6 per cent since January this year.

The Reserve Bank of India (RBI) Act mandates that in the case of the inflation target not being met for three consecutive quarters, the central bank has to submit a report to the government explaining the reasons and detail the remedial actions it will be taking to check the price rise.

Earlier this month, a special meeting of the Monetary Policy Committee (MPC) was held to finalise the report explaining the reasons for missing the inflation target for three quarters.

This was the first time since the onset of the Monetary Policy Framework which came into effect in 2016 that the RBI explained its actions in a report to



the government.

Speaking at the HT Leadership Summit on Saturday, Das said there is no need to change the goal post for inflation targeting as higher than 6 per cent inflation would hurt growth.

As per the mandate given to the Reserve Bank by the Union Government, the central bank is required to ensure that retail inflation remains at 4 per cent with a margin of 2 per cent on either side.

Quoting an RBI internal research, Das said inflation above 6 per cent for India would be detrimental to growth. It will be counterproductive because the financial savings and investment climate will be hit and India will lose the confidence of international investors if inflation remains above 6 per cent for a prolonged period, he noted.

1.09 Bn To USD 529.99 Bn **MUMBAI:** India's foreign exchange reserves dropped by USD 1.087 billion to stand at USD 529.994 billion for the week ended November 4 on a sharp decline in the gold reserves, the Reserve Bank said on Friday.

Forex Kitty Drops By USD

In the previous reporting week, the reserves had swelled by USD 6.561 billion to reach USD 531.081 billion, making it the biggest weekly jump in a year.

In October 2021, the country's forex kitty had reached an all-time high of USD 645 billion. The reserves have been declining as the central bank deploys the kitty to defend the rupee amid pressures caused by global developments.

Foreign currency assets (FCA), a major component of the overall reserves, decreased by USD 120 million to USD 470.727 billion during the week to November 4. according to the Weekly Statistical Supplement released by the RBI.

Expressed in dollar terms, the foreign currency assets include the effect of appreciation or depreciation of non-US units like the euro, pound and yen held in the foreign exchange reserves.

The gold reserves dropped by USD 705 million to USD 37.057 billion, it said.

The Special Drawing Rights (SDRs) were down by USD 235 million to USD 17.39 billion. **PTI**

#### IT, BPM Firms To See **Increase In Hiring Intent**

MUMBAI: With IT and business process management (BPM) sectors witnessing a slump in hiring in September due to margin pressures, a study has revealed that 51 per cent respondents believe that there would be an increase in hiring intent in the next six months.

However, around one-third (34 per cent) respondents said there is going to be a decline in the hiring intent, while 15 per cent believe that it would be business as usual, according to the CIEL HR study.

The study is based on an online survey of 10,00,000 employees working in top 50 IT/ BPM companies operating in India.

During the pandemic years, IT companies had hired massively to address the surge in demand driven by the wave of digital transformation across the globe, it noted.

Now that the demand has subsided, the companies are 'rightsizing' again, it said.

The study further revealed that the level of optimism in hiring intent was found higher among the respondents of smaller companies. On the other hand, the majority of respondents from mid and large sized companies seemed to be more pessimistic about the hiring outlook.

Out of the total job postings, foreign MNCs accounted for around 66 per cent of the jobs while Indian MNCs accounted for 18 per cent. PTI

#### 'India-US Trade May Reach USD 500-600 Bn By 2030'

NEW DELHI: Commerce and Industry Minister Piyush Goyal on Saturday exuded confidence that the India-US bilateral trade in goods and services will reach USD 500-600 billion by 2030 as their relation continues to strengthen. The trade between the two countries stands

at about USD 175 billion at present. On whether India will join the trade pillar of 14-member Indo-Pacific Economic Framework for Prosperity (IPEF), Goyal said it would depend on what India will get in return.

While 13 member countries have joined all four subjects -- trade, supply chains, clean economy and fair economy-- under IPEF, India has opted out of the trade pillar as of now. It

has joined the other three subjects. "With regard to joining the trade pillar of IPEF, India decides its strategy on its own terms...If you want binding commitments (from India) on different subjects, tell me what I am getting in return. It has to be good for my people and my country. What you give me in return will determine whether I will join the trade pillar. You negotiate and

if we see some advantage, then we will join. He was speaking at the Hindustan Times Leadership Summit 2022. On a free trade agreement with the US, the minister said America is not looking for a new trade pact with any country. The US is looking at India as its friend and a trusted partner, he added. PT

#### Serie A: Napoli 11 Points Clear

MILAN: Napoli could end the year with a double-digit points lead at the top of Serie A.

Goals from Victor Osimhen, Piotr Zieliński and Eljif Elmas saw Napoli beat Udinese 3-2 on Saturday for its 11th straight league victory and open up a significant gap over its rivals.

It was a nervy finale for the home side, however, following two late goals from substitutes Ilija Nestorovski and Lazar Samardžić.

The five teams immediately below Napoli don't play until Sunday, with four of them facing each other.

Whatever happens, Napoli is guaranteed to spend the rest of the year at least eight points clear as Serie A pauses for the World Cup and the traditional winter break.

It took Napoli just 15 minutes to break the deadlock as Osimhen headed home Elmas' cross for his seventh goal in his past six league matches. Osimhen also had a hand in

Napoli's second goal in the 31st as he went on the counterattack and sent a cheeky backheel pass to Hirving Lozano in midfield. Lozano picked out Zieliński, who took one touch to control in the penalty area before curling into the far side of the net.

Napoli's third goal also came from a counterattack. André-Frank Anguissa picked out Elmas, who was in plenty of space on the left and he cut inside to fire in at the near post.

Napoli appeared to be heading for a comfortable victory but Nestorovski pulled one back in the 79th and Samardžić reduced the gap still further three min-

## **Twitter Suspends \$8** Subscription Program After Fake Accounts Boom

witter Inc. suspended the \$8 subscription program it launched earlier this week to combat a growing problem of users impersonating major brands, a person familiar with the move said.

Existing subscribers will still have access to their account, said the person who asked not to be identified because the information is private. The move was reported earlier by the website Platformer.

The company has also reinstated "official" badges for highprofile accounts, with the gray badge reappearing below the profiles of businesses and major media outlets Friday based on an internal approved list, according to the person. The identification marker was rolled out earlier this week before being scrapped.

Twitter is struggling with impostor accounts since the company allowed paying subscribers to get verified blue check marks. One account claiming to be Nintendo Inc. posted an image of Super Mario holding up

a middle finger, while another posing as pharma giant Eli Lilly & Co. tweeted that insulin was now free - forcing the company to issue an apology. A purported Tesla Inc. account joked about the carmaker's safety record.

"To combat impersonation, we've added an 'Official' label to some accounts," Twitter Support tweeted on Friday.


Elon Musk tweeted the same day that all accounts engaged in parody must include "parody" in their name.

"Going forward, accounts engaged in parody must include 'parody" in their name, not just in bio." he had tweeted.

The world's wealthiest man, who acquired Twitter last month for \$44 billion, is facing a slew of challenges as top advertisers pull back from the platform amid concern over the company's ability to tackle impostors and hate speech. Musk, who has also seen resignations among his leadership team, said this week in his first address to employees that the company could face bankruptcy, Bloomberg News previously reported.



## **Ambani, Adani Among 13 Bidders For Future Retail**

Trms run by billionaires Gau-**≺**tam Adani and Mukesh Ambani are among the 13 companies that have submitted initial bids to acquire Future Retail Ltd, a filing by the debt-laden company said.

Ambani's Reliance Retail Ventures Ltd, a subsidiary of Reliance Industries Ltd, submitted the expression of interest (EoI) under insolvency proceedings initiated to recover dues Future Retail owes to lenders.

April Moon Retail Private Ltd, a joint venture between Adani Airport holdings and Flemingo group, also submitted an EoI.

The deadline for submission of EoI ended on October 20, Future Retail, which was once the country's second-largest retailer, said in the stock exchange filing.

Future Retail was dragged into bankruptcy proceedings by banks after it defaulted on loans and its lenders rejected a Rs 24,713-crore takeover of its assets by Reliance amid a legal

challenge by Amazon. Other entities that have submitted EOIs include Boomidala Enterprises Pvt Ltd. Capri Global Holdings Pvt Ltd, Shalimar Corporation Ltd, Nalwa Steel & amp; Power, United Biotech, WHSmith

Travel, and United Biotech Pvt Ltd. Consortium of B-Right Real Estate Ltd and Ayekart Fintech Pvt Ltd, Dharampal Satyapal Ltd, Dickey Alternative Investment Trust (DAIT), Payard Investments Pvt Ltd and SNVK Hospitality and

Management Pvt Ltd were other bidders.

State Bank of India (SBI), Bank of India (BoI) and 31 other lenders had submitted loan claims of about Rs 21,060 crore in August under the insolvency process.

"Certain issues pertaining to the expressions of interest received from the prospective resolution applicants have been noticed and the same has been duly communicated to the prospective resolution applicants by the resolution professional and/or his authorised representatives," the filing said without giving details.

It further stated that anyone having any objection to the inclusion or exclusion of a prospective bidder in the list may submit it by November 15.

#### SRK Charged Rs 6.88 **Lakh Customs Duty for Luxury Watches**

The bag containing watches was carried by Khan's bodyguard Ravi Shankar Singh, the official

As the screening process was on, Khan and his team were stopped at the GAT- a VIP termi-

nal- for at least an hour, he added. After some time, Khan, his secretary Pooja Dadlani, and three other members of the team were allowed to go, he said.

As the Customs duty payment counter at the GAT was not operational in the early hours, Customs officers took Ravi Shankar Singh with them to Terminal -II of the airport, where Rs 6.88 lakh was paid towards Customs duty for the watches, he said.

Though the challan was in the name of Ravi Shankar Singh, the duty was paid on behalf of Khan, the official said.

After the procedure to pay Customs duty was over, Singh was al-
