husband gets hypertensive. "I try to calm him down," Mumtaza said. "I keep telling him that this is just a cricket match but if his team loses, he thinks as if he has lost everything. He doesn't eat throughout the match and becomes very aggressive."

A father of two, Mumtaza's husband survived a heart attack back in 2010. Doctors then clearly advised her not to break any bad news to him. "But then," she says, "these cricket matches only come to torment me."

The tense cricket fans often abuse players and get into



arguments online. Even the commentators advise people during the close contest that "this match is not for weak-hearted people".

"And yet," wonders Mumtaza, "people still watch it."

A number of cricket matches lately proved to be nail-biting contests. These high-tension games only surged stress in the region where the cricket craze and mental distress is huge.

Several studies conducted from time to time have revealed the prevalence of anxiety, depression and post-traumatic stress disorder among the people of Kashmir.

According to a survey conducted by international huorganisation manitarian Médecins Sans Frontières or Doctors Without Borders (MSF), over 45 per cent of the population of Kashmir is suffering from mental distress.

"The clinical footfall of this distressed group surges during the high-voltage cricket matches," Dr. Yasir Rather, a noted psychiatrist and professor at the Institute of Mental Health & Neurosciences (IMHANS) in Srinagar, told Kashmir Observer. "The real problem is a mindset. If people don't take these matches seriously, then they can definitely save themselves from getting hyper."

But as of now, there may not be many cricket-related clinical cases around, said Dr. Masood Maqbool, a clinical psychologist at IMHANS, it still can't rule out the problem.

"Such patients should avoid watching the game by just checking the scores after 20 or 30 minutes," More on P6


'Do Not Fall For Those Instigating People'

2 IEDs Found **Near Police Post** In Jammu

Jammu: Two improvised explosive devices found near a police post were destroyed on Tuesday in a controlled explosion on the outskirts of Jammu, an official said.

The weight of each device was 500 grams and they were kept inside a black coloured backpack near their Phallian Mandal post in the Satwari area, he said.

Late on Monday evening, a patrol team found the backpack following which the area was cordoned off and a bomb disposal squad called to examine it, the police official said.

The squad found the two improvised explosive devices (IEDs) along with timers and later, they were destroyed in a controlled explosion around 12.25 am on Tuesday, the official said.

He said the timely detection of the IEDs, averted a major terror incident in Jammu

The official said a case has been registered and further investigation is on, and did not rule out the possibility of airdropping of the IEDs by a drone from across the border.

There's Only So Much A Robot Can Do

How can we make the best use of robots in shared urban spaces?

'ew cities should not be built to cater for robots and technology; instead robots must adapt to live with humans in existing cities. Imagine a city of the near future where robots

roam freely. They scoot along smooth footpaths, nimbly avoiding obstacles as they deliver groceries and medicines. They glide through supermarket aisles, detecting spills

and mopping them up before anyone can slip. They provide valuable backup support in busy, understaffed restaurants, efficiently taking food to tables of wait-

Robots are already doing these tasks. However, the utopian vision of efficient and problem-free robot helpers is a long way from reality. Recent reports highlight some difficulties: they have had trouble recognising people using wheelchairs on shared footpaths.

They have been labelled creepy and useless', and suspected of following shoppers for unknown reasons. In busy restaurants, they cannot navigate narrow aisles or customers' bags and coats.

So how can we make the best use of robots in shared urban spaces?

Cities are complex, dynamic and diverse this is part of the reason so many of us enjoy living in them.

But their unpredictability is what robots struggle to

cope with. While some robots can operate successfully in shared city spaces, many can't and there is a long way to go before they'll be able.


There are several reasons for this. Most importantly, the complexity of apparently simple tasks is an ongoing techni-

Although advances are constantly being made, research by Monash University found that there are fundamental reasons related to the logic of their programming that shape how robots perceive the urban environment.

The study found the growing army of robots has distinct ways of understanding the city through what is called robotic logics'. Two things are essential to their success: Predictability and connectivity.

Robots work best in situations where there are no surprises and where connectivity to bigger data networks which robots rely on to sense, categorise and make decisions about the world around them is available and reliable.

One solution is to design environments that are easier



for robots to navigate. Early examples are warehouses where people and robots are kept separate to avoid accidents. Or dedicated road lanes specifically for driverless vehicles, as has been proposed in New South Wales.

While such responses might be great for robots, by prioritising their needs, they risk diminishing what people value about urban environments by simplifying them to a level that robots can manage.

Instead, the question is to ask how robots can best negotiate the hurly-burly of our cities. Studies have shown people can tolerate glitches or failures in the technologies they use, as they come to understand their limits.

This means that even when people's expectations of robots are not met because people often imagine that robots are more capable than they really are they can still find ways

So, restaurant workers with concerns about whether they

will be replaced by delivery robots find that a crowded dining room will possibly literally trip up a hapless robot, so they only use the machine when the restaurant is less crowded.

There is growing acceptance that robots perform quite simple tasks and people can step in to help when necessary. This means thinking of robots less as replacements for human labour and instead as partners or helpers, akin to working animals, such as guide or cattle dogs.

A team from Monash University used an experimental scenario of a lost child in a shopping centre to explore how people understood a robot's limits.

They found people wanted to step into the role of decision-maker and leave less sensitive tasks such as information about shop locations to a robotic helper.

Another important shift in thinking is required in policy and regulation. Policies can sometimes struggle to keep up with quickly evolving technologies.



Instead, the question is to ask how robots can best negotiate the hurly-burly of our cities. Studies have shown people can tolerate glitches or failures in the technologies they use, as they come to understand their limits.

Experts have found that principles-driven approaches that prioritise people's needs without quashing innovative experimental technologies are possible.

Researchers have developed a checklist to help policymakers grapple with the complexity of new technologies and to guide policies on robots in public spaces.

This list links to the classic goals of public policy analysis which include defending people and property, promoting human flourishing, promoting efficiency and promoting social equity.

For now, robots work best when their environments are predictable - and it is hard to assume how future cities would adapt to their needs.

This means that rather than thinking about how we can simplify cities to accommodate robots, we need robots that work in existing urban environments in all their diversity and complexity.

To do this we must recognise the limits of robots' capacities and focus on how best to collaborate with them. If we can address this, then we can support the sustainable and fair introduction of robots into our shared urban spaces.

This is a challenge that needs to be addressed collectively by roboticists, policymakers, end-users of robots and urban residents alike.

2 Brothers Beheaded

RINAGAR: Two brothers of a slain police officer and a militant were among four people killed and two injured in violence in Jammu and Kashmir since last evening.

Reports said large number of unidentified gunmen raided the house of slain CIK inspector, Ghulam Hassan Wani in Sadrpora locality of Keygam Kandi, Kupwara last night and abducted his brothers Nazir Ahmad and Mushtaq Ahmad. Their beheaded bodies were recovered from the Kaudi this morning.

Ghulam Hassan alias Watali had been killed few months back. Reports said a militant was killed in during an encounter with security forces in their house in May. NAFA agency said the gun¬men equipped with machine guns and AK rifles conducted house to house searches before abducting the duo. Mushtaq worked as a clerk in Education department while Nazir Ahmad was an em¬ployee of the Forest Department. The agency added that residents had sought army help after the abduction but forces refused to in-tervene saying they will tackle the matter in the morning.

Gunmen killed a shopkeeper, Abdul Salam Bhat, a butcher by profession, at Qazigund in Anantnag district and injured two persons Idrees Ahmad son of M Shaban Kumhar and Syed Qurban son of Syed Akbar near Rainawari in downtown Sri¬nagar last night. In a fierce encounter with security forces a foreign militant of Lashker-eTaiba, Sadiq Hussain Abad was killed at Larnoo in Anantnag district last night.

A grenade attack on a bunker in Alamgari Bazar left at least six civilians injured. The grenade which reportedly was hurled at the bunker at around 5.30 in the evening missed the target. BSF person-nel stationed there later cordoned off the area for searches .Several residents said they were severely thrashed by the angry personnel.

Winters Tale

n a new electricity curtailment schedule announced by the Power Distribution Corporation on Monday, the non-metered areas in Srinagar will face a power cut of four and a half hours from November 15 every day. The curtailment in non-metered areas will grow to eight hours a day. The power cuts are going to make it further difficult for people to endure the harsh winter. More so, the forty day period of Chilla Kalan which will begin on December 20. That is, if the power department resorts to no unscheduled power cuts. The new schedule has been announced mechanically with little need being felt to give grounds for the decision to resort to it during what is veritably the most difficult part of the year in the Valley. The temperature in the Valley has declined steeply over the last week. This makes the use of electricity not only a source of light or warmth but perhaps, the only sign of life through the dark, cold nights and frosty, overcast days.

But government pretends as if the curtailment in winter is an accepted fact of life in the region. It could be so if it was not for the higher benchmark set by the current government in this regard. Last winter the Valley received a relatively better supply of electricity. People expect the government to work to provide a reasonable supply of electricity so as to make it easier to deal with the harsh cold. One hardly expects the administration to pass orders banning the sale of heating gadgets.

Metered areas have a right to an uninterrupted supply as the residents pay for the electricity they consume. In past, the metered areas did receive round-the-clock supply. But this is no longer the case. While the aim, by no means, is to show the previous administrations in an uncritical positive light, people are bound to ask as to why the present administration has failed to improve upon its own performance from the previous three winters. It is time that the administration thinks through the question and formulates an answer for the people of the state.

The debate about power in Valley, however, doesn't stop with the availability of the electricity through winter. It is a much larger debate about the inability of the successive governments to meet the domestic demand for power out of the region's own water resources. The issue is simple and it is this: we are a region that exports electricity but purchases power at a hefty cost for its own consumption. This calls for the government to strategize and act to ensure that if not in the near to medium future but atleast in the long term, we have adequate electricity for winter.

You're fired! Layoff crisis getting out of control at unicorns in India

ccording to 86 per cent of CEOs in India, compared to 71 per cent globally, a recession will have a 10 per cent impact on firm earnings during the following 12 months," said Ajoy Thomas, Vice President, TeamLease Services. "The layoffs are believed to be the result of a global funding slowdown that has also hit Indian start-ups this year, forcing them to conserve cash and discipline themselves."

HR experts however caution companies on such rash decisions. "Companies need to handle these situations in a humane manner. If companies take this decision as a temporary measure, I think the attractiveness of the brand as a positive one is lost. A lot of good candidates may not even come back when things improve," said Aditya Narayan Mishra, MD and CEO, CIEL HR Services. Mishra shares that he came across a case where an individual had taken leave to attend his wedding and when he came back he did not have a job. "The leadership team needs to be very transparent when they take such action. They should meet every person and talk to them," he added.


Experts said these layoffs are now spreading to other segments as well in the tech sector. For instance, Udaan is laying off 350 employees, or 10 per cent of its workforce of 3,000, as India's largest business-to-business e-commerce firm targets profitability, according to people familiar with the development. It is laying off people across department functions in a move to drive cost efficiency. The Bengaluru-based firm which is valued at \$3.1 billion, had already sacked 180 employees in June this year.

Top venture capitalists such as TC Meenakshi Sundaram, Founder and Vice-Chairman of Chiratae Ventures, said that if layoffs are inevitable, the companies should handle them with honesty and empathy. "This is not the first time for a funding slowdown or layoffs, nor will this be the last time," said Sundaram. "But it is important for people to manage the process much more sensitively and avoid biases."

Indeed, Thomas of TeamLease Services, said if layoffs have to take place, they need to be based on employee performance and keeping the workers informed about future actions. He said laid-off employees should receive severance pay for 45-90 days (depending on company policy) which also includes medical benefits and performance bonuses.

He said the maximum number of days an employer may lay off an employee is 45 days, per Section 25C of the Industry and Dispute Act of 1947. During those 45 days, the laid-off employee is entitled to compensation equal to 50 per cent of the total of his basic salary and dearness allowance, which would have been due to him had he not been so terminated.

Democracy
At Peril?

India stands at no risk with the changed Congress. U.S.-India bi-lateral ties have wide bipartisan support among both Democrats and Republicans alike. For the moment, New Delhi can rest easy no matter who is in at the helm

t seems as if the biggest bastion of democracy in the world will continue to be marred by unpredictable changes. The latest in the series could stem from the setback suffered by the Biden Administration in the country's midterm elections, last week

Usually in a democratic system, every ruling party suffers from the incumbency factor in mid-term elections it faces. However, in President Joe Biden's case the last week's results suggested that added to the incumbency, voters also punished him for the steepest inflation in 40 years.

The silver lining for the Democrats was the defeat at a much lower level as anticipated earlier. The results also suggested that voters voted against Republican efforts to ban abortion and to cast doubt on the nation's vote-counting process.

Moving Ahead

President Biden had framed the election as a test of U.S. democracy at a time when hundreds of Republican candidates embraced former President Donald Trump's false claims that the 2020 presidential election was stolen.

The slim majority in the House would allow Republicans to impair the rest of Biden's term, blocking priorities such as abortion rights and launching investigations into his administration and family.

President Biden, acknowledging the reality has said he is prepared to work with Republicans. He spoke with Republican House leader Kevin McCarthy, who has announced his intention to run for Speaker of the House if Republicans control the chamber. Biden said that the American people have made clear, that they expect Republicans to be prepared to work with me as well.

As the next House speaker, McCarthy may find it perplexing to hold the testy Republican caucus, with a hard-right wing that has little interest in compromise. Republicans may demand spending cuts in exchange for raising the nation's borrowing limit next year, a showdown that could spook financial markets.

Democrats have been able to retain control of the Senate, thus giving a breather to the Biden Administration. A number of "election deniers" - those who supported Trump's false claim that the 2020 presidential election was stolen from him - won on Tuesday but many who sought positions to oversee elections at the state level were defeated.

Model of American Diversity

A significant number of Muslims, including many Arab Americans, had a much stronger presence in the midterms. 145 Muslim Americans competed in election contests throughout the U.S. and a record 89 have won. Currently 29 American Muslims serve as state legislators in 18 states. Five Arab Americans have been elected to the nation's highest legislative office, as US senators. Six Arab and Middle East Americans continue to serve in the US House of Representatives:

As from an Indian angle, a record five Indian-American lawmakers from the ruling Democrat Party, including Raja Krishnamoorthi, Ro Khanna, Pramila Jayapal, Shri Thanedar and Ami Bera were elected to the House of Representatives, while several others were elected in state legislatures, in one of the most polarised midterm elections in the country.

Indian-Americans who have made it to various state legislatures include Arvind Venkat, Tarik Khan in Pennsylvania; Salman Bhojani and Suleman Lalani in Texas; Sam Singh and Ranjeev Puri in Michigan, Nabeela Syed, Megan Srinivas and Kavin Olickal in Illinois, Nabliah Islam and Farooq Mughal in Georgia; Kumar Bharve in Maryland, and Anita Samani in Ohio. Nabeela syed became the youngest ever member of any state legislature, by winning a seat for Illinois's General Assembly.

Surprisingly, prior to the elections, both the Democrats and the Republicans reached out to the Indian Americans in a big way. This was due to the fact that they were seen as a deciding factor in many key constituencies.

Impact on Ties with India, China Ukraine and Iran

India stands at no risk with the changed Congress. U.S.-India bi-lateral ties have wide bipartisan support among both Democrats and Republicans alike. For the moment, New Delhi can rest easy no matter who is in at the helm.

An aggressive American policy on China was shaped during the Trump-era, focusing more on the economic side of the relations. President Biden has kept in place most of the measures initiated by Trump, and taken a more sweeping approach to confront China. This includes human rights, industrial policy, democracy-versus-autocracy debate, and supportive declarations for Taiwan. But overall the optics may include Republicans trying to be seen as pushing back on China across the board.

As far as Ukraine is concerned, the White House has showed an unwavering support for Ukraine, but Republicans' control of Congress could complicate matters for Ukraine. Different camps within the Republicans could influence this. Future Speaker McCarthy had said last month that Republicans will not write a "blank check" for Ukraine if they win back the majority. McCarthy's comments are reflective of his party's growing scepticism about financial support for Kyiv as a growing number of Republicans, particularly those aligned with Trump's "America First" approach, question the need for federal spending abroad at a time of record-high inflation at home.

Meanwhile, Republican control of Congress could prove the death knell for the revival of nuclear talks with Iran, which the Biden administration has been desperately trying to restore. President Biden has been criticised by many Republicans for not doing more to support protesters who have been demonstrating for weeks against the country's clerical regime.

Using a legislation passed in 2015, the Republicans in the House and Senate can vote to express disapproval of a nuclear agreement with Tehran and block the president's power to lift sanctions on Iran's economy previously imposed by Congress.

The results have also shown the maturity of the American public, which has shown Trump that they will not tolerate his vitriolic brand of politics, unlike some other countries which are still under the spell of such type of politicians.

Overall, the coming two years doesn't bode an easy time for President Biden. His policies – both foreign and internal will be challenged at every stage. This may result in the administration getting bogged down over trivial matters and losing perspective to craft a more ambitious and proactive approach on other demanding issues at hand. The next two years may also prove to be a litmus test for the American democracy in a changed scenario of power sharing by the two political foes.

rate 20,000 megawatts of hydropower, Kashmir is still in darkness. Being the chief producer of electricity in India, Kashmir should have the least electricity crisis but that is far from the ground reality. The valley faces power cuts throughout the year but during winter it becomes very hard to live with electricity for several days.

Electricity, in the 21st century, is not a luxury rather a necessity, like air and water. But in Kashmir, even the capital city of Srinagar faces a lot of power cuts. And even when electricity is available the voltage is so low that a bulb doesn't work properly, let alone other heavy electrical appliances.

With such circumstances, people are left with no option but to go through unethical and illegal means like electricity theft. The PDD department needs to understand the necessity and provide electricity accordingly. That's the only solution to curb power thefts. Also, transformers burn at least every five days during winter, leaving people suffering for days.

The price people pay for electricity is unfair because first of all rates are higher than the supply and secondly, electricity should be cheap because it is generated domestically. Why would anyone pay such a huge

amount for a bare minimum? If the government had to purchase electricity from outside then it was somewhat justified.

One of the reasons for electricity theft is that many people don't consider it as theft because they feel it's their own as it is produced in the valley. It could be stopped only when the population is made aware that this is theft as most of the population doesn't consider it as theft. The clergy delivering Friday sermons should educate people regarding the theft.

The PDD should carry regular checks to make sure employees are not indulging in corruption and doing their work with proper ethics.

Whenever any field staff member is caught taking bribes and helping the public in thefts, strict action should be taken against them.

While government agencies should set an example by taking strong action against the field staff and public involved in the wrong-doing, at the same time PDD should update their infrastructure and make sure that the public is getting sufficient amounts of electricity during winters, so that they won't resort to theft.

SHOULD SCHOOLING LAST TILL WEATHER PERMITS?

The wintertime school debate is back in town following the recent official statement on the traditional winter vacation in Kashmir and the prompt public debate on the existing infrastructure and heating arrangements in schools.

ot that it's a new noise overtaking public platforms following the fading of the recent cricket commotion, but the concern created by the classic cold is real.

As the mercury is dipping in the valley, the worry about the normal classwork has prompted many to join the chorus and question the existing school infrastructure and heating arrangements.

The government curtly dismissed the din as a "futile fuss" as the "efforts are afoot to upgrade the school infrastructure".

The debate started when PK Pole, Divisional Commissioner Kashmir, said that the schools shall remain open as long as weather permits.

Pole was speaking to reporters during the inaugural ceremony of Indus Bank in Hari Singh High Street, Srinagar.

"There is no clarity needed," he said. "Every year, when there's heavy snowfall in plains including in the city, schools are closed for vacations.

It depends on nature and may be, the schooling shall continue beyond December 15, he said. "There's already clarity given by Director School Education Kashmir and every year, not just this season, schools shall remain open until there is major snowfall. It is all weather dependent."

Earlier, Tasaduq Hussain Mir, Director of School Education Kashmir (DSEK), said that there's no plan of winter vacations in Kashmir region as of now.

However, the order has come under fire from the parents and civil society members, saying that with the temperature dipping and lack of infrastructure in schools, the students will shiver in the classrooms.

Earlier, the government changed the academic calendar for Kashmir schools, shifting the annual examinations and fresh admissions from October-November to March every year.

"A winter tuition system was established across the valley in 2015," said Naeem Akhtar, former education minister, while joining the online debate.

"It worked very efficiently along with Super 50 coaching and winter academic camps for lower classes. The classrooms were equipped with heating arrangements. What happened to that? Why should wheel be reinvented?"

In the backdrop of the ongoing debate, Kashmir Observer talked to students, teachers and officials to understand the severity of the situation.

Eastern Ladakh: Army Focus On Setting Up Permanent Defences Using 3D Printing Technology

New Delhi: In a major technology push, Indian Army has envisioned construction of "permanent defences" along the Line of Actual Control in eastern Ladakh using cutting-edge 3D printing technology, a move that will save time and improve its defence preparedness, sources said on Tuesday.

3D printing technology uses complex software and robotic unit that helps in creating a structure through multiple stages from a digital model.

These 3D-printed permanent defences can withstand a direct fire by a T-90 tank from about 100 metres, they said.

Sources in the defence establishment said since the eastern Ladakh border standoff in 2020, shelters for about 22,000 troops have come up in the last two years, and these are relocatable, modern, compact, and can be lifted and erected in a few days.

The army has taken a number of steps to boost its capability development and achieve modernisation, and sources said trials on the use of 3D printed defences have been successful.

Besides building habitat for 22,000 troops and shelters for storing equipment have been constructed in the last two years. Nearly 450 A vehicles and guns can be stored in these shelters, the sources said.

The focus has now been shifted to "undertake construction of permanent defences and infrastructure to improve defence



preparedness" in extant working season apart from completion of ongoing projects in eastern Ladakh, they said.

The infusion of new technology is the key to achieve modernisation, they said, adding, 3D printing technology can help save time and cut cost compared to what is needed in construction of conventional units, like a bunker or a habitat for troops.

The eastern Ladakh border standoff had erupted on May 5, 2020, following a violent clash in the Pangong lake area. Both sides gradually enhanced their deployment by rushing in thousands of soldiers as well as heavy weaponry.

As part of a five-day disengagement process, Indian and Chinese militaries on September 12 this year moved back their frontline troops to the rear locations from the face-off site of Patrolling Point 15 in the Gogra-Hotsprings area in

eastern Ladakh and dismantled

temporary infrastructure there.

On the sustenance of Indian troops in harsh winters during this period, the sources said some of the shelters were made at 15,000 ft and 17000 ft for round-the-clock deployment, and hence drinking water, especially at high altitude, was a challenge in sub-zero temperature.

Water was accessed from

below ponds whose surfaces had icing, and water was still made available to troops in

Daulat Beg Oldi throughout

winter, they said.

"Also, these habitat were made over two years for troops' convenience, and these are modualar, relocatable structures. Solar fuel cells were procured for providing power," a source said.

They also said 'assault bridges' are coming in big way as part of the infrastructure push.

The recently inducted new generation plant equipment such as heavy excavators, spider excavators and light weight crawler rock drills were gainfully employed to expedite the progress in forward connectivity, sources said.

Nearly 150 km of operational tracks have been constructed in Northern Command, including permanent works like drains, surface and causeways constructed concurrently to enhance their longevity.

A 298 km road, projected to be completed in 2026, will provide alternate connectivity to Western Ladakh and the Zanskar Valley directly from the Manali axis. It also includes a 4.1 km twin tube Shinkun La tunnel for providing all weather connectivity, which is likely to be approved by the defence ministry soon, the sources said.

They added that under the Border Roads Organisation (BRO), there are 18 projects spread across the length and breadth of the country.

BRO has constructed more than 60,000 km of roads, 693 major permanent bridges totalling a length of 53,000 metres, 19 airfields and four tunnels running a total distance of nearly 19 km, including the Atal Tunnel which holds the world record for being the longest tunnel (9.02 km) in the world above 10,000 feet for the world's highest motorable road over Umlingla.

Currently, the BRO is constructing nine tunnels which include 2.535 km long Sela tunnel, which will be the highest bi-lane tunnel in the world once completed. Eleven more tunnels are under planning, the sources said.

Dismissed cop Sachin Waze seeks bail in money laundering case

Mumbai: Dismissed Mumbai Police officer Sachin Waze on Tuesday filed a bail application before a special court here in a money laundering case linked to former Maharashtra home minister Anil Deshmukh.

This was Waze's second application for bail under section 88 of the CrPc where the applicant is remanded to judicial custody at a post-cognizance stage and not arrested under the provisions of the Prevention of

Money Laundering Act (PMLA).

Waze has not been arrested

Waze has not been arrested under the provisions of PMLA thus the rigour of the Act will not be attracted to the Applicant, his bail plea said. It stated the court has granted bail to the accused in matters where they have not been arrested during the stage of investigation and requested the court to grant bail to Waze.

Special court judge R N Rokade after hearing brief arguments from both sides adjourned the matter for order on November 18. The Bombay High Court on October 4 granted bail to Anil Deshmukh in a money laundering case registered by the Enforcement Directorate. He was arrested by ED last November.

The ED's case is that Deshmukh had collected Rs 4.70 crore from various bars and restaurants in Mumbai through then Assistant Police Inspector Waze when he was the home minister.

The money was allegedly laundered and routed to the Nagpur-based educational trust controlled by the Deshmukh family, the ED has claimed.

Pakistani PM orders review of ban on Oscar-entry film 'Joyland'

Karachi: Prime Minister Shehbaz Sharif has ordered a review of the ban on Pakistan's Oscar entry "Joyland", his aide has said, days after the movie was banned for allegedly containing "highly objectionable material".

Written and directed by debutant Saim Sadiq, "Joyland" was banned by Pakistan's Ministry of Information and Broadcasting, a week ahead of its planned release on November 18 across the counti

Salman Sufi, an adviser to Prime Minister Shehbaz, late on Monday said that a high-level committee is being formed to assess the movie and review the ban.

"The committee will assess the complaints as well as merits to decide on its release in Pakistan," Sufi said in a tweet.

In a notification issued on Monday, the PM's secretariat informed about the formation of the committee to deliberate on complaints against the movie. The committee includes minister for political affairs and economic affairs, law and justice chairperson, minister for information and broadcasting, minister for communications, minister for board of investment and others.

The story of "Joyland" follows a patriarchal family, craving for the birth of a baby boy to continue the family line, while their youngest son secretly joins an erotic dance theatre and falls for a trans woman.

Sania Saeed along with Ali

Junejo, Aleena Khan, Rasti Faruq, Salman Pirzada, and Sohail Samir are part of the main cast. It is produced by Apoorva Guru Charan, Sarmad Sultan Khoosat, and Lauren Mann.

the medico advised. "They can even watch match highlights later in order to avoid stress."

Clearly, if the predominance of emotions during a game is uncontrolled, then the stress level will be high, said Dr. Abdul Majid, HOD at Department of Psychiatry, SKIMS Medical College, Bemina.

"Once you are under stress, you release catecholamine," Dr. Majid said.

"We call it sympathetic hormone as it can increase your heart rate, breathing and put a lot of exertion/stress on your heart. At that time, neurotransmitters in the brain can be disturbed because of the stress."

Since the stress level in the Kashmiri population is already high, mental health experts warn, the cricket contests will only exacerbate their underlying psychological distress, like panic attacks.

"Post-match," Dr. Yasir continued, "we see most of the patients, especially youngsters with chest heaviness, stress and other ailments."

Another psychiatrist told Kashmir Observer that he saw at least 10 such patients during the recent T20 world cup.

"People relate a simple cricket match with a larger issue and thus become stressful and anxious," he said. "This is not a good sign. People should take a cricket match as a game and enjoy it, rather than making it a matter of life and death."

But the social media posts reveal how much people take a cricket match "on the heart".

On 11 November 2021, a man from Central Kashmir's Budgam reportedly died due to heart-attack after Pakistan lost to Australia in a tense semi-final of the T20 World Cup in Dubai.

HC Junks Lal Singh's Plea Against Eviction Notice

JAMMU: The Jammu, Kashmir & Ladakh High Court on Tuesday dismissed former minister Choudhary Lal Singh's petition against an eviction notice issued to him and directed him to vacate the government residence allotted to him previously within six weeks.

Singh, the Dogra Swabhiman Sangathan Party president, was among several politicians who were served notices by the Estates department last month to vacate government accommodations at Jammu's posh Gandhi Nagar locality.

The former minister had, however, moved the high court against the notice on the pretext that he was covered under 'Z-category security'

The case came up for hearing before Justice Sanjeev Kumar Shukla, who dismissed the petition after hearing the arguments from both sides, senior Additional Advocate General Monika Kohli told PTI

She said the court gave six weeks' time to the former minister to vacate the bungalow.

In its notice, the Estates department had asked Singh, who has been occupying the bungalow for the past two decades, to vacate the building by November 15.

A two-time MP and three time MLA, Singh switched from the Congress to the BJP in 2014 and was also a minister in the previous PDP-BJP government, which collapsed in June 2018.

Several months before the fall of the government, Singh had resigned from the BJP and floated his DSSP, following an uproar over his participation in a rally in support of the accused in the rape and murder of an eight-year-old girl in Kathua in January 2018

Besides Singh, the government has also served a notice to PDP president and former chief minister Mehbooba Mufti, asking her to vacate her plush Fairview government bungalow in Srinagar.

Another former chief minister and National Conference leader Omar Abdullah vacated his official bungalow on Gupkar Road in 2020, even before the administration issued an eviction notice to him.

The change in entitlements for former chief ministers in the wake of the abrogation of Article 370 and the reorganisation of Jammu and Kashmir into two Union territories meant that they could not continue to live in the official residences provided to them in the erstwhile state.

Last year, the Jammu and Kashmir High Court had directed the government to evict former ministers and legislators who were in "illegal occupation" of government bungalows.

"It is very unfortunate that some former ministers, legislators, retired officers and politicians have illegally and unauthorisedly managed to continue to stay in the residential accommodations provided to them by the Government of Jammu and Kashmir, though they are no longer entitled to such accommodation," the court had said in an order in February last year.

The Estates department, in its status report filed in the court, named 89 former ministers and ex-legislators who continue to occupy government bungalows. Some of the prominent names in the list include J&K BJP chief and former MLA Ravinder Raina and former J&K deputy chief minister Kavinder Gupta.



Mainly Dry Weather Forecast In J&K

Gulmarg Records Minus 4.6°C, Drass Minus 15.0°C

SRINAGAR: Mainly dry weather has been forecast in Jammu and Kashmir for the next 24 hours even as mercury recorded a drop on Tuesday at most places with Gulmarg and Pahalgam resorts recording subzero temperature following snowfall over upper reaches.

"Mainly dry weather over the plains of Jammu and Kashmir with very light rain at one or two places on higher elevations," said a meteorological department official here regarding forecast for next 24 hours.

He said that there was no large change expected in the evening of November 18 and it was likely to remain mainly dry. There is possibility of light rain and snowfall on November 18 (night)-19, he said. However, he said, there was no forecast for any major snowfall till November 20.

In the last 24 hours till 0830 hours, he said, Gulmarg received 5 cms and Leh 1.2 cms fresh snowfall.

Regarding the temperature, he said, Srinagar recorded a low of 4.5°C against 3.4°C on the previous night. The temperature was 3.3°C above normal for the summer capital during this time

Qazigund recorded a low of 4.8°C against 4.5°C on the previous night. The temperature was way town of Kashmir, he said. In Pahalgam, the mercury set-

In Kupwara town, the mercury settled at 1.9°C against minus 1.1°C on the previous night, the official said. It was above normal north Kashmir place, he said.

Jammu recorded a low of 12.3°C against 12.4°C on the previous night. It was 1.1°C below normal for J&K's winter capital, he said. Banihal recorded a low of 2.2°C (1.9°C below normal), Batote 2.3°C (3.9°C below normal), Katra 10.4°C (below normal by 1.0°C) and Bhadarwah 1.0°C (2.2°C below normal).

In Kargil area of Ladakh, he said, the mercury settled at minus 4.2°C, Leh witnessed a low of minus 6.1°C and Drass, the world's second coldest place after Siberia, recorded minimum of minus 15.0°C. (GNS)

Panchayat Members' Body Demands Allowance For Gram Sabhas To Award Works Up To Rs 3L

JAMMU: A representative body of elected panchayat members on Tuesday alleged that the Jammu and Kashmir administration's decision to resort to e-tendering even for small works was depriving educated youths from local villages of employment avenues.

The All Jammu and Kashmir Panchayat Conference (AJKPC) also demanded that works up to Rs 3 lakh should be sanctioned by gram sabhas.

The AJKPC alleged that the works done by contractors under the capex budget in rural areas were of very low quality. The contractors also don't pay heed to the requests of gram sabha members while district officials ignore the panches and sarpanches, it said.

"Despite repeated prayers to the government and assurances by senior officers, even tenders for petty works are being allotted by e-tendering, which is not only undermining the autonomy of gram sabhas but also depriving the local ed-ucated youth of employment avenues," AJKPC chief Anil Sharma told reporters. He alleged that panchayat

members always complained that the works done by contractors in rural areas were of very low quality. The contractors do not have any accountability either, he said.

"Neither do the contractors pay heed to the requests of Panchayati Raj Institution (PRI) members nor do the officials listen to the prayers of the panches

and sarpanches," he said. The AJKPC president said the role of PRI members in checking the quality of works had been curtailed as Utilisation Certificates for works done under the district budget were issued by the respective administration.

It is insignificant that from which account the money is being spent for development works, there must be accountability of the contractors and government employees, he said. He cautioned officials of the district administration and the rural development department not to test the patience of elected representatives and muzzle the autonomy of PRIs.

AJKPC leaders also urged Lieutenant Governor Manor Sinha, the commissioner secretary of the Rural Development department, divisional commissioners of Jammu and Kashmir to take appropriate action to avoid confrontations and let PRIs and elected members work without interference.

They also demanded that Utilisation Certificates for works done in rural areas under the district budget should be issued by gram sabhas instead of the district administration to ensure transparency and accountability.

They also demanded that for works up to Rs 3 lakh, gram sabhas be allowed to identify deserving educated youth and self-help groups to execute the works in villages and panchayats to generate employment avenues and ensure quality work.
