Srinagar: Intravenous opioid use has surged among young population in Kashmir during Covid-19 with many patients having relapsed due to non-adherence to medications during the two years of pandemic, a study conducted by a Post Graduate Resident Department of Psychiatry (IMHANS) GMC Srinagar along with three other doctors has revealed.

The study conducted to find the various sociodemographic variables of substance use disorder

among patients and to study the change in the pattern of substance use disorder has showed that percentage of intravenous opioid use has in-

creased tremendously and that major chunk patients also relapsed due to non-adherence to


12 Locations In Srinagar, Anantnag, Kulgam Raided

How Bad Is It Really to Use Non-Stick Cookware?

Your frying pan is likely one of your most-used kitchen tools. Non-stick pans are especially convenient because they have a coating that makes them easier to use and clean. But while they're easier, there's some debate as to wheth-

er or not non-stick cookware is really safe. Here, we take a deep dive into what the existing research has to say on the safety of nonstick cookware.

Non-stick cookware makes it easy to cook foods like eggs and hash browns with less butter or oil. But, there's some controversy surrounding the potential health risks of chemicals used to make non-stick pans.

At high temperatures, non-stick coatings break down and can release harmful chemicals, but there's a lot we still don't know about how these chemicals affect us. The long-term effects of these chemicals accumulating in the human body aren't well understood.

When used as directed and at lower temperatures, non-stick cookware is relatively safe to use, though alternatives also exist.

What Is Non-Stick Cookware?

Non-stick cookware includes pots and pans that are coated with synthetic compounds designed to make the cookware easier to use and clean. This can include saucepans, dutch ovens, utensils and other types of cooking equipment,

but it's mostly associated with frying pans and shallow skillets.

The most commonly used compound to make non-stick coatings is polytetrafluoroethylene (PTFE), according to an October 2017 review in Environmental Science and Pollution Research International. It's most commonly referred to as Teflon — a brand name of the material.

Teflon is popular in cookware because it is resistant to heat and acts as a water repellant, so it can get very hot but allows liquid ingredients to move around so they don't adhere to the pan. It's also found in some textiles.

Other cookware materials of concern include perfluorooctanoic acid (PFOA) and perfluorooctane sulfonate (PFOS). These chemicals have been used for decades not only in cookware but in other household products like carpets and paper goods. It's highly resistant to heat, sticking and scratching.

Non-stick material is only used for the coating on the outer surface of the cookware. The core may still be made of other materials, such as stainless steel, aluminum, ceramic or other materials.Because chemicals like PTFE, PFOA and PFOS aren't as understood, ceramic nonstick coatings are becoming more common.

Potential Risks of Non-Stick Cookware

There are talks that non-stick pans and cookware made with chemicals like PTFE, PFOA and PFOS may raise the risk of certain diseases or have other negative health consequences.

The idea is that the non-stick coating breaks down and flakes off over time, allowing small pieces to get into the food that you eat, so the chemicals enter your body and cause harm. **Potential PTFE Risks**

Aware of the concerns surrounding PTFE. the leading maker of non-stick coatings, Teflon, suggest that Teflon non-stick coatings are safe to use up to 500 degrees Fahrenheit and contribute to a heart-healthy lifestyle because they lower the need for oil



website. But this may be Teflon biased, so let's take a look at the existing research.

Some studies show PTFE-coated cookware can release gasses and chemicals that are mildly to severely toxic to people, according to the October 2017 Environmental Science and Pollution Research International review. But the researchers say more studies are needed for firm conclusions on the long-term effects.

Non-stick coatings made with PTFE may

leach microplastics into food during the cooking process. Microplastics are very small pieces of plastic debris that enter our bodies through the degradation of plastics in our environment, and while we don't vet fully understand their effects on our health, they're a growing concern, according to a May 2021 article

in Nature. Thousands to millions of microplastics may be released during cooking with PTFE-coated cookware, according to December 2022 research in The Science of the Total Environment.

Potential PFOA and PFOS Risks

There are similar concerns for PFOA and PFOS coatings. Because it doesn't break down easily, PFOA exposure is very common in humans, but the health effects are largely unknown, according to the CDC.

Animal and human studies have linked these chemicals to a higher risk for various cancers, such as testicular and breast cancers, according to the American Cancer Society. But more research is needed on how they affect people.

What we do know is that agencies like the Environmental Protection Agency (EPA) have introduced measures to lower our exposure to PFOA and PFOS because they can accumulate in the human body over long periods of time. For this reason, many non-stick coatings no longer use PFOA and PFOS.

So, Is Non-Stick Cookware Safe?

To answer the question of whether or not non-stick pans are toxic, the short answer (as of now) is that we don't really know the longterm effects of using them, but they're considered safe when used correctly.

The safest way to use non-stick cookware is to follow the cooking and care instructions provided by the manufacturer. Typically, that means cooking at temperatures below 500 F. There is more of a potential risk when cooking at higher temperatures, so cooking on low and medium heat can help keep the

Cooking at lower temperatures may not eliminate all the risks, but the long-term effects of non-stick coatings are still not well-understood, and more research is needed to fully assess the safety concerns.

Today, PFOA and PFOS are less common in cookware made in the United States. However, they may still be present in cookware manufactured in other countries. PTFE is still used in U.S.-made products.

Alternatives to Non-Stick Cookware

Non-stick cookware made with PTFE and other chemicals is relatively cheap and easy to find, use and clean. There are a lot of pros to using non-stick pans, but the lack of research on the long-term effects has many feeling weary.

Luckily, there are other alternatives to nonstick pans and cookware you can feel safe using. Check out cookware made from other types of metal and natural materials from this list:

"I have faced many difficulties which everyone faces in any field but earning anything with hard-work always makes you feel happy," he said. "Despite working for decades, I am still passionate about making new things that are going to benefit the public".

He said: "The new things in this craft which I have made so far include motifs of shrines, lamp shades, table lamps and traditional utensils like Majma, handi and other things,' he said. "When I see the new

things which I have made are giving any benefit to the public, it gives me a peace of mind and ignites my passion to make more such things".

Earlier there was no government support but now the government has started organising awareness programmes to keep this art alive which is a very welcome step,

"Authorities had told me that registration is very hectic, however, when they saw my work, they provided me registration in just five minutes," he added. "I am now being invited by the government in Kashmir and other parts of India to make people understand about it and even students are sent here for practical work who are interested in this craft."

Bhat said that as the unemployment rate is increasing with each passing day, youth can easily establish their business in any craft and with the help of social media, they can sell pure products easily and not only earn livelihood for themselves but create opportunities for others as well—(KNO)



DC Reviews Status Of Works Under District Capex Plan

The DC after taking sector wise review of all works directed the officers to ensure 100 percent expenditure in the set time line by accelerating the pace of the works scheduled for completion during the current year. On the occasion, the DC was apprised that under District Capex, total 697 works were taken up out of which 307 works have been completed while rest of works are going on.

In this regard, a notice has been issued by the Government of Jammu and Kashmir's office of the Commissioner Food and Drugs Administration. Commissioner Food

and Drugs Administration, J&K, Shakeel-Ur-Rehman as per has informed that a sample of food article. 'Sweetened Condensed Partly Skimmed Milk' (Nestle Milkmaid) was lifted by Food Safety Officer, Zone II, Srinagar from the premises of M/S 'Daily Bazar Provisional Store, Saida Kadal, Rainawari area of Srinagar on 19 September 2022 for analysis of quality and safety parameters under Food Safety & Standards Act. 2006.

The Commissioner said that the Food Analyst, National Food Laboratory, Ghaziabad, where the said sample was analyzed has declared the sample as 'Unsafe & Sub-Standard'.

The banned product 'Sweetened Condensed Partly Skimmed Milk' (Nestle Milkmaid) vide batch number 00-520451ZA is being manufactured by M/S Nestle India Limited at Ludhiana Ferozpore region of Punjab.

The product has been declared unsafe as the sample shows the total plate count above the maximum prescribed limit and the milk protein in milk solids not fat below the maximum prescribed limit.

The general public has been informed to discontinue the usage of the food product with batch or lot number 00-

Commissioner Food and Drugs Administration, J&K, has asked all the stakeholder in possession of this product to recall this product from the market and also inform the Designated Officers about the stock position. (with KNT inputs)

ifferences seem to have intensified in the Pakistan government over the appointment of the new Army chief with top brasses of the ruling coalition making contradictory statements on the key issue.

The appointment of a successor to Army chief General Qamar Javed Bajwa, 61, who is set to retire on November 29, is an administrative matter. Under the law, the incumbent prime minister is empowered to select any one of the top threestar generals. Interestingly, Interior Minister Rana Sanaullah said consultations had been completed and the new Army chief would be appointed in a day or two. He said any delay in the matter would not be "appropriate".

Iran Accuses Israel, Western Spy **Agencies Of Plotting 'Civil War'**

Agencies

ran's Foreign Minister Hossein Amir-Abollahian has accused Israel and its Western allies of plotting a "civil war" in the protest-hit country.

Security services, Israel, and Western politicians had "made plans for a civil war and the destruction and disintegration of Iran", Amir-Abollahian wrote on Twitter on Thursday.

"Today, enemies have targeted the integrity of Iran and Iranian identity.

But, he added, they "must know that Iran is not Libya or Sudan" and that the "wisdom of our people has thwarted their plan".

His comment came after state media said 10 people, including a woman, two children and a police officer, were killed in two separate attacks by gunmen on motorbikes during protests in southern Iran.

General Hossein Salami, head of the Revolutionary Guards, said Iran was facing a "conspiracy".

"The United States, England, Germany, France, Israel, Saudi Arabia and their allies are preparing to fight God, his prophet and the martyrs," Salami said, quoted by Fars news agency.

"This is a huge conspiracy



against the nation, and some people inside the country have become puppets of the enemy to destroy the Iranian nation,' he added.

UNREST AND DEATHS

Demonstrations have rocked Iran since the September 16 death of Mahsa Amini, after her arrest for an alleged breach of the country's dress rules for women.

Amini's death and the following protests have drawn international condemnation of Iran's leadership, which has struggled to suppress the unrest and blamed foreign enemies and their alleged local agents.

Police Colonel Hassan Yousefi was stabbed to death on Thursday in Sanandaj, state media

A video posted by the state news agency IRNA showed protesters attacking a municipality building and other public properties in the West Azerbaijan region.

Iran was hit by a spate of attacks on Wednesday.

Seven people were killed in the southwestern city of Izeh in what state media described as a "terrorist attack".

Elsewhere, gunmen riding a motorcycle shot several members of the security forces in the central city of Isfahan, killing two people and injuring eight, according to state television.

Azerbaijan parliament approves opening embassy in Israel

The Azerbaijani Parliament on 18 November approved the opening of an embassy in Israel, making it the first embassy in Israel from a Shia Muslim majority country, according to the Times of Israel.

The new embassy will be based in Tel Aviv, where Baku already has a Tourism Office and a Trade Representative Office. Israel and Azerbaijan have had relations for 30 years, and there has been an Israeli embassy in Baku since 1993.

neighbor. Iranian Foreign Minister Hossein Amir Abdollahian accused Israel of having "established its presence in several regions of Azerbaijan," which Baku denied, according to Mehr News Agency.

Israel and Azerbaijan have a close defense relationship. Jerusalem has supplied military drones to Baku, which were used in its war against Armenia over the disputed Nagorno-Karabakh region.

The Stockholm International Peace Research Institute found that 69 percent of Azerbaijan's



Outgoing Israeli Prime Minister Yair Lapid praised the decision, calling Azerbaijan "an important partner of Israel and home to one of the largest Jewish communities in the Muslim world," according to the Times of Israel.

"The decision to open an embassy reflects the depth of relations between the countries," Lapid added.

Azerbaijan's move comes during a time of heightened tensions with Iran, including military exercises on both sides of the border area.

Iran and Azerbaijan share a 420-mile border, and there has long been speculation that Israel has launched covert operations in Iran from its northern arms imports in 2016-2020 came from Israel, accounting for 17 percent of Israel's arms exports in that period. About 40 percent of oil imported to Israel comes from Azerbaijan, according to Fars News Agency.

On 11 November, the Iranian Foreign Ministry summoned the ambassador of Azerbaijan to Tehran to protest the propaganda campaign waged by the country's officials and media against Iran, according to Armenpress news.

As Iranian authorities currently grapple with monthslong protests and nationwide demonstrations, the Iranian government views with concern the growing influence of Israel in Azerbaijan.

Palestine Declares Day Of Mourning After Fire Kills 21 In Gaza

t least 21 people have been killed and several been killed and several atter a others injured after a fire broke out in a building where residents attended a party in Gaza, health and civil emergency officials said. Footage circulated on social

media showed and witnesses said the whole residential building caught fire on Thursday in the Iabalia refugee camp in northern Gaza, sending up flames and smoke from the site. Witnesses said they could hear screaming but they could not reach the victims to offer help because of the intensity of the fire.

Gaza's civil defence unit confirmed in a statement that 21 people had been killed.

Jabalia is one of eight refugee camps in Gaza, home to 2.3 million people, and one of the most densely populated areas in the world

Hamas, which governs the Israel-blockaded Palestinian enclave, said the cause of the fire remained unknown and that several others had been injured, without providing figures.

PALESTINE TO MOURN DEATHS

The head of the Indonesian Hospital in Jabalia, Saleh Abu Laila, told the AFP news agency that the facility had received the bodies of at least seven children.

While the cause of the fire remained unknown, a spokesperson for the civil defence unit told AFP that supplies of fuel were stored in the house.

Palestine's President Mahmoud Abbas, based in the Israeli-occupied West Bank — a separate Palestinian territory called the fire "a national tragedy", his spokesperson said.

Abbas declared a day of mourning on Friday, with flags to be flown at half-mast, and offered to send aid to families of the victims to "ease their suffering", spokesperson Nabil Abu Rudeineh said in a statement.

A senior official with the Palestinian Authority in the occupied West Bank, Hussein Al Sheikh, said in reaction to the blaze that the PA had urged Israel to open the Erez crossing between Gaza and Israel for urgent medical evacuations of serious cases.

Shraddha's Ex-Colleague Reveals **Shocking Details Of Abuse By**

t was in November 2020 that Shraddha Walkar first spoke to me about the physical assault she was facing from Aaftab Amin Poonawala, says her colleague Karan, adding that she was about to approach the police but things were sorted between the couple due to the intervention by Aaftab's parents.

Karan, who worked with Walker in Mumbai till March 2021, remembers her as a "lively and energetic person". His chats with Walkar about the assault are do-

Talking to PTI in a Zoom interview, he says, "On normal days, Shraddha used to jump around in office, but on some days when she had fights with Aaftab, she isolated herself so that she does not have to lie. I cannot imagine Aftab going to this extent...'

Poonawala allegedly strangled Walkar, 27, on May 18 and sawed her body into 35 pieces which he kept in a 300-litre fridge for almost three weeks at his residence in South Delhi's Mehrauli before dumping them across the city over several days past midnight.

Demanding justice for Walkar, Karan says he is ready to cooperate with the police in whatever

The WhatsApp chats between Karan and Walkar have revealed a pattern of abuse when the victim lived with Poonawala in their



hometown Vasai near Mumbai. Similarly, pictures of Walkar dating back to 2020 with visible injury marks also surfaced on social media.

"Those chats are from November 2020 and that was the first time when she opened up about the domestic violence and the beatings that she was going through in her relationship with Aaftab," he says.

Recollecting how she had sent him a picture in which a black mark under her right eye and neck bruises were visible, Karan says he does not have that picture now.

All that is left with him are the chats and a medical report that Walker had shared with him in December when she had to seek treatment for her injured spine and neck due to the beating by

Hearing about the abuse, did he counsel her to move out of the volatile relationship?

Karan says, "When she started working with me, she never told me about it (domestic violence)... It was only in November (2020) when she was badly hurt and could not trust anyone that she talked about it...'

No Criminal Law Allows Bulldozing Houses In Name Of Investigation: High Court

GUWAHATI: The Gauhati High Court has stressed that bulldozing of a house is not provided under any criminal law, even if an agency is investigating a very serious matter.

Chief Justice RM Chhaya made this observation while hearing a suo motu case taken up by the high court regarding the demolition of the house of an accused in an arson case in Nagaon district of Assam. The Batadrava Police Station

was set on fire on May 21 by a mob following the alleged custodial death of a local fish trader, Safikul Islam (39), who was picked up by police the night before. A day later, the district au-

thorities had demolished at least

six houses, including Islam's, using a bulldozer purportedly in search of weapons and drugs hidden beneath the structures.

"Even if a very serious matter is being investigated by an agency, bulldozing of a house is not provided under any criminal law." Justice Chhava observed.

Emphasising that it requires permission to even search a house, he said, "Tomorrow if you need something, you will dig up my courtroom." The chief justice said that nobody will be safe if pulling down anyone's house is permitted in the name of an investigation. "We are in a democratic set-up," he added.

Pointing out that one 0.9 mm pistol was recovered by demolishing the house, as submitted in

the government affidavit, Chief Justice Chayya also raised apprehension that it could have been planted.

He maintained that incidents

of such bulldozing of houses

are done in movies, and even in those, the search warrant is shown before the act. The chief justice equated the bulldozing of the houses to an act in a 'gang war' and asked the Home

department to find better ways of

carrying out their investigation. "There is a purpose why 'law and order' words are used together...this is not the manner in which law and order is controlled," he said in his observation on Thursday.

The matter will be heard again on December 12.

PM Modi, Congress Pay Tributes To **Indira Gandhi On Her Birth Anniversary**

NEW DELHI: Congress leaders on Saturday paid rich tributes to former prime minister Indira Gandhi on her 105th birth anniversary.

Daily Wager Contesting In Gujarat Polls Pays ₹10,000 Deposit In ₹1 Coins

AHMEDABAD: A daily wage worker whose slum colony in Gujarat capital Gandhinagar was razed in 2019 to make way for a hotel, raised Rs 10,000 in Re 1 coins from his supporters and deposited that amount with the Election Commission so that he can contest the next month's Assembly polls.

Mahendra Patni, who is fighting the election from the Gandhinagar North seat as an independent candidate, paid the security deposit in coins earlier this week. He said the displaced residents of 521 huts in a slum near Mahatma Mandir in Gandhinagar that were demolished three years ago, asked him to contest the election as their representative.

Patni was one of the residents of the slum which was twice displaced, first in 2010 when the government constructed the Dandi Kutir museum dedicated to Mahatma Gandhi not far from the hotel

and then in 2019 when slum-dwellers were again forced to shift to a nearby area so that the hotel can be constructed

"I am contesting as an independent. I belong to a family of labourers and make my living as a daily wager. There were 521 huts which were razed to make way for a big hotel. Many of them were rendered jobless. We shifted to a nearby area, but have no water or electricity supply," he told PTI.

Aggrieved by the government's apathy, the residents of the slums as well as other daily wagers in the area collected Rs 10,000 in Re 1 coin and offered the money to him so that he can pay it as security deposit to contest the upcoming election, he said.

"Before being displaced, we had electricity in our slum. After we were forced to relocate to another area near the hotel, there is no water or electricity and no politician comes to our aid," Patni said.

Man Hires Killer To Murder Father For Insurance Money

man allegedly hired contract killers to murder his father to claim his accidental insurance money in Madhya Pradesh's Barwani district, police said on Saturday.

The death came to light when the accused approached Sendhwa police station on November 10 claiming that his 52-year-old father had died after being hit by an unidentified vehicle, superintendent of police (SP) Deepak Kumar Shukla said. After examining the accident site, the police concluded that it was a case of murder, he said. The CCTV footage from the area revealed that the vehicle that hit the victim had been doing rounds of the locality, Sendhwa po-

On November 10, the accused allegedly telephoned the contract killers to tell them that his father had left for his morning walk, he said. Following the investigation, one of the suspects Karan Shinde was arrested from Pune and during interrogation, he revealed the victim's son had promised to pay ₹2.5 lakh for the murder, he said.

Nephew-Uncle Brought Out Of Well After 11 Hrs

SRINAGAR: An uncle-nephew duo was rescued from a well after a tedious rescue operation, which spanned for over ten hours, at Chak-e-Hatmulla in Nagri area of North Kashmir's Kupwara district.

A joint operation was launched by police, army, SDRF, Fire & Emergency Department and locals soon after news about the trapping of a boy and a person in a well spread, reported news agency GNS.

AMU Cricket Violence

Case Filed Against Injured J&K Student

ALIGARH: A counter case has been registered against an Aligarh Muslim University student who suffered serious injuries after allegedly being hit on the head earlier this week when a tiff during a cricket match turned violent, a police official said on Saturday.

Sajid Husain, the victim, and Shobhit Singh -- who allegedly hit him on the head with a cricket bat -- are second-year students of the varsity's Zakir Husain College of Engineering and Technology, spokesperson Omar Peerzada had earlier said.

Husain, a native of Jammu and Kashmir, was rushed to Jawaharlal Nehru Medical College in an unconscious state,

Doctors at Jawaharlal Nehru Medical College have described the condition of Husain, who suffered serious head injuries,

The police action follows a report by Singh's father. Singh was arrested on Wednesday and is currently lodged in the district jail.

Circle Officer (Civil Lines) Shwetab Pandey on Saturday said based on CCTV footage from the varsity hostel, a case was registered against Husain under sections 323 (punishment for voluntarily causing hurt) and 506 (Punishment for criminal intimidation) of the Indian Penal Code (IPC) on Friday at Civil Lines police station.

On Friday, BJP MLC Manvendra Pratap Singh, who had met senior police officials, asserted that "one-sided action" in the case was not acceptable. Pushpendra Pachuri, regional joint convenor of the BJP's teachers' cell, demanded that both sides should be held accountable.

The varsity authorities have also constituted a three-member fact-finding committee to probe into the incident. The committee had been asked to submit its report within five days.

Peerzada said immediately after Wednesday's clash, Singh was escorted from the hostel and handed over to the police. He has been suspended and

barred from the varsity campus pending further inquiry, he said. A case has been registered

against him under Section 307 (attempt to murder) of the IPC at Civil Lines police station, officials had said.

J&K And Ladakh Will Be Single State Once **Again: Dr Farooq Abdullah**

JAMMU: The National Conference never sided with Pakistan and always stood rocksolid with India, its president Farooq Abdullah asserted on Saturday, as he targeted separatist-turned-mainstream politicians for trying to weaken the party. The former chief minister

advocated for restoration of statehood to Jammu and Kashmir and said the time is not far when Jammu, Kashmir and Ladakh will be a single entity once again.

In 2019, the Centre had abrogated Article 370, which granted special status to the erstwhile state of Jammu and Kashmir, and bifurcated it into union territories of Jammu and Kashmir and Ladakh.

"The National Conference (NC) never sided with Pakistan...when tribal raiders were at our doors and Pakistan founder Muhammad Ali Jinnah came rushing to my father Sheikh Mohammad Abdullah to seek his support, he decided



to go with India," Abdullah said. "Sometimes youngsters tell me that my father had done wrong but I make it clear to them that oppression will end. We should be thankful that we did not go to Pakistan, where a former prime minister (Imran Khan) was fired upon in the recent past, the military is dictating terms and people have no power," he said addressing a function here.

Referring to the 2019 development, the NC chief said that 'we hope they will restore the statehood to Jammu and Kashmir without any further

"It (restoration of statehood) is imperative. It was unfortu-

nate that our state was downgraded and divided. This time will also change. If you support us at the opportune time (at the time of elections), the time is not far when we will be together again as a single entity Jammu, Kashmir and Ladakh," he said.

Later talking to reporters, Abdullah launched a veiled attack on separatist-turnedmainstream politicians and said they made every attempt earlier to weaken the NC after getting money from Pakistan.

"Don't they (central government) fund those who were earlier sided with Pakistan. I do not want to name them. They were the same people who were getting money from Pakistan and distributing it here to weaken the NC," Abdullah said.

However, Abdullah said he will identify them when the time comes.

"The NC was their target because it was standing rock-solid with India and is still doing the same," he said.

On the seizure of properties

linked to proscribed Jamaat-e-Islami (Jel) for terror funding, he said he has no information about it.

Appealing to people to remain cautious against attempts to divide them on the basis of religion, Abdullah said that "if we want to make our country strong, we have to stand together".

"When elections are near, they will come to you and tell you that Hindus are in danger. India has a Hindu population of 70 to 80 per cent and do you think they will be in danger,' he said, adding deliberate attempts are being to create doubts in the minds of people for vested political interests.

He said the strength of India is unity in diversity and "we have to maintain this unity and strengthen it to make our country powerful".

Stressing on the need for restoration of a democratically elected government in Jammu and Kashmir, the NC leader said bureaucratic rule is no alternative to a popular government.

Div Com Jammu Reviews Status Of Land Acquisition For Airport Expansion


Transfer Of Land To Jammu University, Revenue Training Institute Also Reviewed

JAMMU: Divisional Commissioner, Ramesh Kumar on Saturday reviewed the status of land acquisition, land issues pertaining to the Jammu Airport Expansion Project, Transfer of Army land to Jammu University, Transfer of JDA land to Army at Nagrota, Transfer of state land to JDA in lieu of land to be provided to Army, Transfer of land 100 Kanals JDA land to Revenue Training Institute at Birpur in lieu of RTI land at Gole Gujral.

The meeting was attended by Deputy Commissioner Jammu, Avny Lavasa; Commissioner Jammu Municipal Corporation, Rahul Yadav; Deputy Commissioner Samba, Anuradha Gupta; Vice Chairman JDA, Pankaj Magotra; Director Animal Husbandry Shubhra Sharma; AC Central, Pritam Lal Thappa; besides officers of Airport Authority, Revenue Training Insti-

tute and other concerned officers. Seeking the details about Jammu Airport Expansion project, the concerned officers apprised that the land acquisition has almost



for Animal Husbandry Belicharna is pending. However, they said that around 240 Kanal land with structures and buildings was yet to be acquired.

It was further informed that alternative land has been provided to the Animal Husbandry Department for shifting its hatchery and office buildings. The land was provided in Nagrota and Chatha areas.

The Div Com also inquired about the present status of work on construction of Animal Husbandry buildings at Nagrota and Chatha. It was informed that the work was in progress at both the locations.

The Div Com instructed Director Animal Husbandry to person-

ally monitor the pace of work and ensure expeditious completion. Responding to the issues related to allotted land, the Div Com asked

DC Jammu to resolve the same for smooth execution of work on Animal Husbandry buildings. The Div Com stressed to vacate

the prioritized buildings at the earliest for smooth execution of work on airport expansion.

While reviewing Transfer of Army land to Jammu University, the Div Com asked VC JDA to expedite the process and transfer identified land to Army at Nagrota at the earliest, while the DC Jammu was asked to transfer state land to JDA in lieu of land to be provided to Army.

We contacted and communicated with different stakeholders academicians, officers, avid/voracious readers, renowned writers/ columnists, budding writers, (school and college) students, booksellers, etc. to know their opinion and viewpoint on these questions (especially on this question: Is the Book Reading Culture in Kashmir Declining in the Age of the Internet?)

s the culture of book reading dying or flourishing in Kashmir?"; "Fading Reading Culture"; "Book Reading Habit on Decline among Youth"; "Dwindling book-reading culture affecting Kashmir's young generation"; "Decline in Reading Culture"; "The changing habits of reading"; "Reading habits face challenge in internet age"; "Importance of Reading books"; "Books transport us to new worlds"; "Only way to Progress is to Read"; "Attracting youngest to reading culture"; "promotes book reading culture by encouraging establishment of domestic libraries". These are some of the headings—either of the opinion pieces or write-ups, editorials or news items, that were published in our local daily newspapers, mostly in the last few months (and few in the last year too). However, when we tried to peep into it a bit deeper, we found that last year too, there were few write-ups and news items which highlight the same issue.

In fact, some studies have been published in journals as well on this issue; two such examples (published in 2010 and 2019) are: "Reading Habits among College Students of Kashmir across Genders" (by S. M. Shafi and Fayaz Ahmad Loan, both from University of Kashmir) published in Trends in Information Management/TRIM (6, 2, July-Dec 2010, pp. 92-103) and "Reading Habits of College Students of Jammu & Kashmir: A Case Study of District Anantnag" (by Haamid Amin Mir, Ashfaq Ahmad Rather and Mohammad Rayees Bhat) in Library Philosophy and Practice (2019, pp. 1-12). Prof. Shafi and Dr Loan, in their study, concluded that gender is "the principal factor affecting reading habits of students as reading tastes and preferences between genders differ quite drastically" (p.101). Mir et. al., (who are working as Librarians in the J&K Education Department) in their study focused on the students of four (4) colleges of South Kashmir's Anantnag district with the objectives to ascertain and assess their "reading habits" and (most importantly) "the role of parents, teachers and librarians in promoting the reading habits". Their findings reveal that the "students mostly read books and other materials with an intellect of resolution and with explicit objectives" and they are mostly "assisted and motivated by their parents

in promoting their reading habits".

All these titles, whether opinion pieces, news items or research studies, have one theme in common: 'Book Reading Culture in Kashmir'. While some question on this narrative, others are of the opinion that the general trend is that book reading culture has declined in recent years and the major reasons put forward by most of them are the use of smartphones, social media platforms and handles by youth—for they spend most of their time either on using social media (like Facebook, Instagram, WhatsApp,

Twitter, etc.) and (playing) online games.

Reading, no doubt, is a wonderful habit; it is a kind of therapy, which not only works wonders but acts as a relaxing balm to frenzied minds and distressed nerves as well. Reading is considered one of the pleasant practices and spending time with books, or making friendship with books is considered as one of the most loyal camaraderie for books never betray the reader; they stay with him in ups and downs, in delight and distress, in company and solitude. Garrison Keillor has rightly said that a "book is a gift you can open again and again".

Reading, no doubt, increases knowledge; improves language; helps us to remain updated; increases our creative and critical thinking; imagination; clear perspective on various topics and issues; communicating one's ideas in different ways; and in understanding the actual picture.

However, we are living in an era,

which is described either as the age of internet, age of smartphones or an era of technology and electronic gadgets (like ipads, kindle, etc.). That is to say, modern technology and the revolution it brought have impacted the functional activities of all walks of life, forcing some drastic lifestyle changes in humans everywhere in the world" (Haroon Reshi, "Is the culture of book reading dying or flourishing in Kashmir?" Kashmir Images, 13th December 2021). The 'technological revolution', and the changes that the world went through in the last few years (including the COVID-19 global pandemic), have reinforced many of these changes; and Jammu and Kashmir (J&K) is no exception to these changes and challenges. All these changes have transformed our world significantly; and one such significant change is the use of internet-driven devices (especially smartphones and digital media) which has had an impact on the (style of) book reading culture in Kashmir.

It is generally observed that people now prefer to watch visuals and read electronic mode of content than (physical) book reading. "Earlier, the book lovers would be enthused to hold a book in hand, shuffle through its pages and smell the paper and ink. Now it is a small device you scroll, no smell of ink or paper, just lifeless words" (Reshi, 2021).

The fact is that the 'age of internet' and the 'era of smartphones' as well as 'excessive use of social media platforms/ handles' have impacted (significantly) the book reading culture. How much helpful or harmful has this impact been? What changes has the use of the internet/ smartphones brought (especially in book reading culture)? Has book reading culture faded or flourished with the use of the internet and smartphones?

In this context, we contacted and communicated with different stakeholders—academicians, officers, avid/voracious readers, renowned writers/columnists, budding writers, (school and college) students, booksellers, etc. to know their opinion and viewpoint on these questions (especially on this question: Is the Book Reading Culture in Kashmir Declining in the Age of the Internet?). Interestingly,

there are varied opinions on the question/ issue at hand. Some say it's good and has helped in making accessible the books which were unavailable or inaccessible; others believe that technology has no doubt brought changes, but it has not reduced the number of avid and voracious readers in our society. While others are of the opinion that the internet and smartphones have increased the number of readers, still others offer different opinions. Below are provided all these types of opinions and are arranged thematically.

VIEWPOINT 1: Avid Readers (Reading Section) in a society are always there, but in minority. Internet and Technology has affected them but their number has not declined

he avid readers, in the opinion of many, are always present in every society; but are found in the minority. This "Reading Section", despite different odds, keeps intact with the books, but history is witness to the fact that "Reading as an intellectual exercise ... can never be a mass activity."

Muhammad Maroof Shah (scholar, author and a prominent columnist) refutes the argument that internet has brought book reading culture to a standstill and is of the opinion that "there was no great book reading culture (in Kashmir) before internet that could decline. Only insignificant percentages (among avid readers) have shifted to ebooks or soft copies (PDFs) of books. The rest keep their attachment to books intact." For him, there has been a "marked shift" in mode and style of reading, for "e-books (have) replace(d) conventional books and as such (there is) decline in the conventional mode of reading but not (in

overall) reading culture" in our society. **Prof. Javaid Hassain** (Assistant Professor of Urdu at GDC Sogam) also shared a similar viewpoint on this question.

For Dr Altaf Hussain Yatoo (Assistant Professor of Islamic Studies and a regular bilingual columnist), "reading culture" in Kashmir has not declined but has been affected because he believes that the "Reading Section' of our society, amid all odds and pressures, is always on book hunt! However, that section which is over-possessed in phubbing was never serious in reading. The case of students, in my opinion, has not changed, because students, by and large, have always been note gathers which now they find in the digital form. It is a positive sign that the number of booksellers, publishers and writers has shown no decline at all.'

Similarly, Mushtaq Ul Haq Ahmad Sikander (a Srinagar-based Writer-Activist and Researcher) believes that the general trend found in Kashmir is that reading as an intellect activity has remained confined to a minority only and the use of social media handles has reduced this number further though he appreciates the use of electronic gadgets for reading purpose. "Reading culture in Kashmir like other parts of the world", for him, "is declining". Earlier too, only a few literate people were avid readers". For him, it is an "irony" that even "teachers and academics (in our

society) have very poor reading habits" and "with the advent of social media, the attention span of people has gone down. The constant habit of remaining connected 24x7 has adversely impacted the reading habit." However, "many readers are now opting for digital, kindle, ebooks and audio-books which gives the perception about the declining culture of manual hard copy book reading", he argues. "Reading as an intellectual exercise", he asserts, "will continue among the minority, as history is a witness and will continue like that, and it can never be a mass activity."

VIEWPOINT 2: Internet and Smartphones have affected the readership Qualities especially among youngsters

yed Mustafa Ahmad (a columnist from Hajibagh, Budgam), who has himself published a few write-ups on the theme of "Decline in Book Reading Culture", is of the opinion that the internet has affected the readers and readership qualities in the valley, especially among the young generation. Sharing his views, he said: 'The book reading culture in Kashmir in the age of the internet has almost vanished. There are hardly any people who read books. The new generation has lost touch with the book reading culturethanks to the omnipresence of the internet (especially social media)". Book lovers are very rare these days and owing to excessive use of smartphones and social media sites/ handles, "book reading culture in Kashmir is on the verge or brink of extinction.

Peer Jafar Akbar (a BA 6th semester student from our college, GDC Sogam), an avid reader, shares a similar viewpoint. For him, from the last decade, "technology boom has hit the reading habit in the younger generation. Students in this age of the internet prefer to spend time on mobile phones rather than reading some productive book". For him, "Kashmir valley, which was the hub of intellectualism once, is gradually losing its charm (of reading culture and readership qualities)". Few other students, being budding writers as well, also shared a similar viewpoint. All of

them see excessive use as well as misuse (especially by spending more time on social media sites/ handles) as the main cause of the fading of book reading culture. "Book reading is of utmost importance", says Shahid Shafi Shah (pursuing BSc from GDC Sogam and a budding writer) for they help "not only to improve the writing skills but also enable us to build a great vision". But "haplessly the habit of book reading had been diminished in Kashmir amid various causes. The root cause is the internet because nowadays, the youth of Kashmir are indulged in myriad execrable activities like (excessive use of) social media, drugs and other awful things which later have havoc ramifications". Another student from our college, Saqib Sarwar (an avid reader and a budding and passionate writer) also agrees with our question saying that the activity of "book reading is being ignored with the passage of time, because of quick access to the information through the internet". Fayaz Ahmad (BA 6th semester student and a writer) also shares a similar opinion on the harmful effects of reading culture; for him, "it's right to say that the internet (has) snatched book reading culture from us. Nowadays, every literate youth is busy with using social media and hardly anyone finds time for reading books' ', and thus one finds the "reading culture on a decline". Shayista Shaban (BSc 6th semester at GDC Sogam), shared similar opinions. She blames the internet for the cause of decline in book reading culture, especially in the younger generation. For her, "internet has affected badly the book reading culture in Kashmir", for everyone in his/ her "day-to-day life, depends wholly and solely on the internet". Even for finding quick answers to their minor problems or in clarifying their basic concepts, students hardly "consult any book or discuss (with their colleagues or teachers). They consult the internet for solving their problems and in getting quick answers for their questions". She further states that, "no doubt using the internet provides us basic information on all topics but it doesn't increase our mental ability and intellectual power."

school students also view the use of the internet as the main cause of decline in book reading culture in Kashmir. Saniya Zehra Dar (a class 9th student at the Army Goodwill School, Hanjik, Shariefabad, Budgam and a writer who has published a number of write-ups) also shared a similar opinion. For her, it's true that "the book reading culture in Kashmir is on decline in the age of the internet. Being a student, I have witnessed there is no inclination among the students towards reading books. The main topic of discussion among the students is social media. There is hardly any student who talks about books' For her, "the internet has brought the book reading culture to its knees and reviving it needs a collective effort and some serious thinking." Nighat Wani (a teacher from North Kashmir's Kupwara) too agrees with this viewpoint and considers use of internet, or spending extra time on screen, as a matter of serious concern: "Obviously book reading culture is declining in Kashmir; only a handful of book readers are present in the whole valley, that too of old generations. Our younger generation is least interested in reading books, magazines, etc. because they have become attracted to screens. It is a major concern and needs to be addressed". However, another school teacher (wishing anonymity). while sharing her viewpoint on the basis of her experiences and observations in the school, says that the diminishing book reading culture in Kashmir is because of two major reasons: (1) "books are expensive and school libraries have no updated stock of books"; and "students are not encouraged to spend their leisure time in the library", and thus it has "become very easy and cheap to find desired content on digital platforms.

It is interesting to add here that

Bilal Ahmad Sofi (a teacher and writer from Khushipora, HMT, Srinagar with a Master's in English Literature) also shares similar opinion and agrees with the question (posed) and is of the opinion that a reader of (physical) books is disregarded and someone reading on a gadget is considered to be a 'modern'. For him, "Teachers, as well as students, are not interested in reading books. The person who reads books now is being looked down upon, though exceptions are there. In the present times, book reading culture is (considered) a symbol of the traditional society. Modern age is all about PDFs and e-learning. So, reading books is an affront to society. In short, it is on decline". [To Be Contd.]

Do You Need To Take A Multivitamin? Here's What Experts Say

or a lot of people, their daily health and wellness routine includes taking a multivitamin every day. With the rise of personalized vitamins and more than a third of all Americans taking daily multivitamins, according to the National Institutes of Health (NIH), it's never been easier to cocktail the perfect nutritional regimen for your specific health needs. But all these options can also make things more confusing. What are multivitamins exactly? And does everyone need them?

"Multivitamins are generally a combination of various vitamins (and minerals) put together in a supplement and often referred to as a form of insurance against nutritional deficiencies," says registered dietician and adviser for Precision Nutrition Ryan Adams tells Allure. Adams adds that not every multivitamin is the same, as they contain different amounts of nutrients and can be tailored to specific types of people and lifestyles (like if you're pregnant or vegetarian).

"Multivitamins are great ways to pack a variety of essential vitamins into one or two daily pills," adds board-certified endocrinologist Brittany Henderson. "Other vitamins are more targeted whereas a multivitamin acts as a nutritional foundation to optimal health.

That said, multivitamins aren't magic pills that you take to fix all of your nutritional needs. Experts warn against solely relying on multivitamins to stay healthy. "A multivitamin can't take the place of eating a variety of foods and food groups," Alissa Rumsey, a registered dietitian in New York City and founder of Alissa Rumsey Nutrition and Wellness, tells Allure. "Vitamins and minerals found in foods are more readily absorbed and used than those found in supplements.'

It's all about balance and knowing that multivitamin use isn't totally cut and dry. So if this supplement is something you've been wanting to incorporate into your routine, here's what the experts want you to know about multivitamins, and how to tell if they're right for you.

What is a multivitamin?

There's no standard definition for what nutrients in what quantities need to be in a

supplement to make it a multivitamin, according to the NIH. However, there are a few common vitamins and minerals found in a range of multivitamins, says registered dietitian nutritionist Beth Warren, founder of Beth Warren Nutrition and author of Living a Real Life with Real Food. These include calcium, magnesium, vitamin E, vitamin D, several B vitamins, vitamin A, vitamin K, potassium, iodine, selenium, borate, zinc, manganese, molybdenum, betacarotene, and iron.

How To Keep Your Hair Healthy

Generally, multivitamins are made in pill, tablet, or gummy form with nutrient levels close to their Recommended Dietary Allowance (RDA), the NIH says. However, there are variations: Some multivitamins are designed specifically for kids, men, women, pregnant women, or senior citizens, and presumably contain more of the vitamins or minerals that these groups might need.

What does a multivitamin do for your body?

Despite what some ads may imply, a multivitamin won't magically turn you into an energetic superhero, and an oral vitamin for skin is not an instant fix for your complexion concerns. What it can do, though, is cover for deficiencies in your diet says, Gina Keatley, a certified dietitian-nutritionist practicing in New York City. "The more processed a food item is, the more likely it is that it will be deficient in vitamins and minerals," she explains. A multivitamin is supposed to provide for what processing can remove from our food. Registered dietitian and nutritionist Keri Gans, author of The Small Change Diet, points out that multivitamins can help us make up for nutritional shortfalls when we're not getting an adequate range of whole foods in our diets. They're "almost like a safety net to ensure that you are consuming plenty of important vitamins and minerals," she says.

Who can benefit most from taking a multivitamin?

Unless you're planning to become pregnant or are pregnant or have a particular nutrient deficiency, you probably don't need a multivitamin, Rumsey says. (And yes, there are risks to taking supplements if you don't actually need them — more on that below.) While research has found that multivitamins probably won't boost your

health as much as we've been lead to believe, they have the potential to be useful for certain groups of people. Keatley cites people who have poor-quality diets, people who have difficulty with digestion (such as those who have had gastric bypass surgery or have Crohn's disease), and the elderly as some potential candidates for multivitamin use. Rumsey also points to those who avoid animal products as a group that could benefit: "Vegans and vegetarians should consider taking a supplement that contains vitamin B12, and potentially calcium, iron, and zinc," she says.

According to the NIH, it's also generally recommended that people who want to become pregnant get 400 micrograms of folic acid a day (either through their diets or a supplement) to lower the risk of neural tube defects in newborns. In terms of other people who may want to consider a multivitamin, Keatley says the most common deficiencies in the U.S. are iron, calcium, and vitamins B12. Being deficient in any one of these will make you feel tired, which is a pretty vague symptom. Still, if you're struggling with fatigue, it's worth asking your doctor for a blood test to see if a deficiency could be to blame.

What Really Happens to Your Body When You Drink Diet Soda Every Day

he science is clear when it comes to the ill effects of too many added sugars in our diets — but what about zero-calorie sweeteners like those found in diet sodas?

Ongoing research on the sugar alternatives used to sweeten diet beverages has muddied the waters, leaving us all wondering whether diet soda is really as innocuous as we previously thought.

To set the record straight, we asked registered dietitians to shed light on what really happens to your body when you drink diet soda daily

Your Gut Health May Take a Hit

"Consumption of any carbonated beverage, including soda, can cause stomach irritation, along with bloating and heartburn," says Amanda Wahlstedt, RDN, a registered dietitian and founder of the private practice Roots to Leaves.

This is one of the many reasons why soda consumption can be particularly problematic for those with GERD or irritable bowel syndrome.'

The non-nutritive sweeteners (NNS) found in diet sodas may also alter the makeup of the gut microbiome, the trillions of microbes that live in the GI tract Regular intake of NNS like saccharin and sucralose has been linked to dysbiosis, or an imbalance of bacteria in the gut, per a January 2019 review in Advances in Nutrition.

Interestingly, the same study reported that aspartame, the primary NNS found in beverages like Diet Coke and Sprite Zero, may be less likely to alter the gut microbiome due to its rapid breakdown in the small intestine.

Yet other studies conducted in animals have reported that even low doses of aspartame may increase the concentration of bacteria like Enterobacteriaceae — which includes pathogenic bugs like Salmonella and E. coli — in the gut.

How drinking too much diet soda influences gut health is not entirely understood just yet. And experts point out that whether these study findings are even meaningful remains to be seen.

"The main limitation of these studies is that it is not known if the observed changes [to the gut microbiome] are actually bad and if these changes have any clinical relevance," says Paula Doebrich, MPH, RD, registered dietitian and founder of the private practice Happea Nutrition.

"In many studies, people do not consume sweeteners as frequently pre-trial, so changes to the microbiome are to be expected. We also need to know more about what constitutes a 'good' microbiome in order to draw recommendations from the current body of evidence.'

You Might Lose Weight

Swapping regular soda for diet soda can promote weight loss by reducing caloric intake. For example: If you typically sip a 16-ounce Coca-Cola every day, you'll cut out more than 1,300 calories a week by switching to Diet Coke instead.

But because not all calories are created equal, it's not guaranteed that opting for diet soda will deliver lasting weight loss. That's because the NNS found in diet sodas can influence blood sugar management

as well as taste preferences, both of which affect weight. (More on each of these topics below.)

It Could Affect Your Heart Health

Cracking open a can of the diet stuff daily isn't great news for your ticker. Researchers observed that people who drank the most artificially sweetened beverages (think: more than two per day) were significantly more likely to develop heart disease or have a stroke compared to those who rarely or never had the drinks, according to a February 2019 study in Stroke, a journal of the American Heart Association.

A comprehensive April 2022 meta-analysis by the World Health Organization also supports this association, with findings from prospective cohort studies showing that regularly having zero-sugar drinks is associated with a 19 percent greater risk of heart diseaserelated mortality.

It bears noting that these studies were observational, meaning they can only show association, not causation. More clinical research is

tions of glucose dysregulation.

Your Sugar Cravings Could Spike

On one hand, replacing regular soda with diet soda can be helpful for battling feelings of restriction. "Diet soda can be a great alternative for people who usually consume regular soda, as it can be an easy way to wean yourself off of sugar-sweetened beverages (SSBs) without depriving yourself of the taste," Doebrich says.

But because aspartame tastes 200 times sweeter than table sugar, per the U.S. Food and Drug Administration (FDA), some worry that drinking diet soda daily could actually set us up for more sugar cravings.

"There is some evidence suggesting that artificial sweeteners can actually alter our taste buds making us more inclined to reach for high-sugar foods," Wahlstedt says. "Since NNS tend to be much sweeter than table sugar, there is a concern that they may overstimulate our sugar-based taste receptors and make naturally sweet foods.



needed in order to determine cause and effect.

Your Pancreas May Get Confused

Whether you gulp down a glass of regular soda or the calorie-free version, your body may not actually know the difference — at least at first.

"Artificial sweeteners confuse our brains and bodies to some extent," says Nicole Avena, PhD, a neuroscientist and the author of Why Diets Fail (Because You're Addicted to Sugar).

"When we taste something sweet, our body and brain react by releasing insulin in expectation of the glucose that circulates in our blood as a result of eating something with sugar. But when we consume an artificial sweetener, we end up releasing insulin when it isn't necessary, since the sweeteners don't impact blood glucose in the way that caloric sweeteners can."

The problem? This can lead to an excess of insulin (which is produced by the pancreas) circulating in the body. That excess can cause cells to become resistant to insulin, creating issues with blood sugar regulation and increasing one's risk of developing type 2 diabetes

Indeed, people who drank diet soda every day were found to have a 67 percent greater relative risk of developing type 2 diabetes compared to people who did not drink diet soda, per a January 2009 observational study in Diabetes Care.

Again, observational studies cannot establish causation. Still, current research seems to suggest a potential association between greater diet soda intake and condilike fruit, less appealing.'

The bottom line: Diet soda, in moderation, can be a solid choice for those looking to break up with SSBs. But if drinking diet soda leads you to gravitate towards hyper-palatable, ultra-sweet products, it might just negate the supposed benefits (such as blood sugar control and weight management) of choosing a zero-calorie beverage.

What to Drink Instead

"Simple is better," says Wahlstedt, who recommends minimizing soft drinks and diet sodas and instead opting for DIY fizzy drinks. Here are a few options: Sparkling water with fresh

herbs (such as mint or basil) and fresh-cut fruit or veggies (like cucumber) added

"My favorite combination is lemon juice, sliced ginger and a little bit of honey in sparkling water for a homemade ginger ale," says Wahlstedt.

Add a splash of orange or cherry juice to sparkling water

Kombucha

Buy naturally sweetened fizzy beverages such as Spindrift seltzers or Sound sparkling teas

The Bottom Line

When it comes to diet soda, the old adage "everything in modera-

Export Duty On Steel, Iron Ore Cut; Tax On Some Raw Material Imports Hiked

NEW DELHI: The government has cut the export duty on steel products and iron ore with effect from Saturday in order to provide a fillip to the domestic steel industry and boost exports.

Besides, import duty on anthracite, coking coal and ferronickel -- used as raw material in the steel industry -- has been hiked, as per a finance ministry notification issued late on Friday.

The export duty concessions and import tax have been restored after a gap of six months. In May, the tariffs were tweaked in the wake of a sharp and steady rise in prices of steel and in order to augment the availability both of finished steel as well as raw materials required for steel manufacture.

With effect from Saturday, exports of specified pig iron and steel products as well as iron ore pellets will attract 'nil' export duty. Also, export duty on outward shipment of iron ore lumps and fines with less than 58 per cent iron content will be 'nil'.

In the case of iron ore lumps and fines with more than 58 per cent iron, the rate of duty will be 30 per cent.

As per the notification, import duty on anthracite/PCI, coking coal and ferronickel has been hiked to 2.5 per cent, while for coke and semi-coke it has been raised to 5 per cent, from 'nil' earlier.

The duty cut follows a meeting of Steel Minister Jyotiraditya Scindia with Finance Minister Nirmala Sitharaman earlier this week. The meeting was attended by Revenue Secretary designate Sanjay Malhotra, among other senior officials.



May hiked the export duty on pig iron and steel products to 15 per cent from 'nil', a move which was intended to discourage exports and increase domestic availability to help lower prices.

The tax on export of iron ores and concentrates was hiked to 50 per cent from 30 per cent, while on iron pellets a 45 per cent duty was imposed.

Steel industry has been demanding a rollback of the duties, saying local demand was not sufficient for domestic production.

In a statement, the finance ministry said, "The current measures will provide a fillip to the domestic steel industry and boost exports." Engineering Export Promotion Council (EEPC) said in the last few months in terms of volume, exports of major stainless steel and alloy steel items have shown a declining trend.

During October, engineering exports fell 21 per cent to USD 7.4 billion, primarily due to decline in shipments of steel and its products, EEPC said in a statement. Deloitte India Partner M S Mani said the reduction of export duties will bring cheer to domestic ore producers and make them freely compete in the international markets.

Forex Kitty Swells By USD 14.72 Bn To USD 544.72 Bn; Steepest **Accretion Since Aug 2021**

MUMBAI: India's foreign exchange reserves soared by USD 14.72 billion to reach USD 544.72 billion for the week to November 11, making it the steepest accretion since August 2021.

However, the reserves have fallen by over USD 110 billion since March as the RBI has been propping up the rupee amid global volatility.

According to the latest weekly data from the Reserve Bank, the forex kitty swelled by USD 14.72 billion to USD 4.72 billion for the week to November 11. The reserves were at USD 529.99 billion as of November 4.

Of the total addition, the value of foreign currency assets, which is the largest component of the reserves, rose by USD 11.8 billion to USD 482.53 billion for the reporting week.

Foreign currency assets consist of the effect of appreciation or depreciation of non-US currencies like the euro, pound, and the yen held in the foreign exchange reserves.



Gold reserves increased by USD 2.64 billion to USD 39.70

In the week to October 21, the reserves had fallen by USD 11793 billion to USD 524.52 billion.

The reserves had climbed by USD 16.7 billion in the tumbled from around 79.5 week to August 27, 2021, but the addition included USD 12.6 billion of one-time COV-ID restructuring support from the International Monetary Fund (IMF).

According to a treasury head at a private sector bank, the record USD 14.7-billion surge is due to the impact of an estimated USD 8 billion worth of recent overseas currency purchases by the RBI. clined by 96 paise or 1.18 per

India's robust gem and jewellery export performance in the first 6 months of 2022-23 helped maintain growth for the period April-October, despite a sharp dip in exports last month, GJEPC noted.

The decline in exports in October or November is a seasonal trend as manufacturing activities are either limited or units are closed because of Diwali, it stated.

"We had witnessed the usual pre-Diwali buzz as factories in India rushed to complete export orders in time for Thanksgiving and Christmas. The temporary closure of units, and absence of workers during Diwali usually results in a decline in exports post Diwali," GJEPC Chairman Vipul

The upcoming holiday season in the West and the Chinese New Year will give a boost to exports in November and December, he said. PTI

Russian strikes force Ukraine to face hours-long power cuts

Kyiv, Nov 19 (AP) Ukraine's electricity grid chief warned of hours-long power outages on Friday as Russia zeroed in on Ukraine's energy infrastructure with heavy artillery and missile attacks that have interrupted supplies to as much as 40 per cent of the country's people at the onset of winter.

Freezing temperatures are putting additional pressure on energy networks, grid operator Ukrenergo said.

"You always need to prepare for the worst. We understand that the enemy wants to destroy our power system in general, to cause long outages," Ukrenergo's chief executive Volodymyr Kudrytskyi told Ukrainian state television. "We need to prepare for possible long outages, but at the moment we are introducing schedules that are planned and will do everything to ensure that the outages are not very long.

The capital of Kyiv is already facing a "huge deficit in electric-ity", Mayor Vitali Klitschko told The Associated Press. Some 1.5 million to 2 million (15-20 lakh) people -- about half of the city's population -- are periodically plunged into darkness as authorities switch electricity from one district to another.

"It is a critical situation," he

Klitschko added that Russian President Vladimir Putin's military planners ap-parently are hoping "to bring us, everyone, to depression", to make people feel unsafe and "to think about, maybe we give up". But it will not work, he said.

"It is wrong, it is (a) wrong vision of Putin," he said. "After every rocket attack, I talk to the people, to simple civilians. They (are) not depressed. They were angry, angry and ready to stay and defend our houses, our families and our future."

Kudrytskyi added that the power situation at critical facilities such as hospitals and schools has been stabilised.

Those facilities were targeted overnight in the northeastern Kharkiv region, where energy equipment was damaged, according to governor Oleh Syniehubov. Eight people including energy crews and police were injured trying to clear up the debris, he said.

Moscow's attacks Ukraine's energy and power facilities have fuelled fears of what the dead of winter will bring. Ukraine's energy infrastructure had again been targeted on Thursday, two days after Russia unleashed a nationwide barrage of more than 100 missiles and drones that knocked out power to 10 million (one crore) people.

Those attacks have also affected neighbouring countries like Moldova, where a half-adozen cities across that country experienced temporary blackouts.

In the past 24 hours, Russian forces unleashed the breadth of their arsenal to attack Ukraine's southeast, employing drones, rockets, heavy artillery and warplanes that killed at least six civilians and wounded six others, the president's office said.

In the Zaporizhzhia region, part of which remains under Russian control, artillery pounded 10 towns and villages. The death toll from a Russian rocket attack on a residential building in the city of Vilniansk on Thursday climbed to 10 people, including three children. In Nikopol, located across

the Dnieper River from the Zaporizhzhia Nuclear Power Plant, 40 Russian missiles damaged several high-rise buildings, homes and a power line.

Beijing under semi-lockdown as new **COVID-19 cases hit China**

Beijing: The coronavirus situation in China has become grim again with the number of COVID-19 cases rising to over 25,000, including more than 500 in Beijing, prompting the city officials to advise millions of residents to stay home this weekend and undergo daily testing.

Beijing wore an eerie look on Saturday with most of its residents staying home after several districts in the city on Friday issued advisories to people, calling for less crossdistrict personnel flow and avoid unnecessary trips during the weekend.

An official from Chaoyang district, the worst-hit area and also the most populous district in the city, told residents to stay indoors during the weekend.

The sprawling district houses all top government offices, commercial hubs and thousands of residential communities.

The district government of Chaoyang also advised residents not to leave the area unless necessary, and if they do, they must provide negative nucleic acid test results taken within 48 hours, official media here reported on Saturday. After Chaoyang, other dis-

tricts of Dongcheng, Xicheng, Tongzhou, Yanqing, Changping, Shunyi and Haidian uploaded letters on their official media accounts, urging people to reduce cross-district personnel flow and avoid unnecessary

Some major shopping malls across the city have also suspended dining-in services following the current epidemic prevention and control measures.

Beijing on Friday reported 515 COVID-19 cases while the Chinese mainland recorded 25,000 cases, a very high by

Chinese standards, according to official data.

The periodic spikes in coronavirus cases in almost all the cities in China for the past two years which led to lockdowns and disrupted people's lives, supply chains and the economy, is wearing down people.

There are reports of sporadic public protests in the industrial city of Guangzhou.

Early this month, China modified its zero-COVID policy by doing away with its much-criticised "circuit breaker" policy of suspending international flights if any positive COVID-19 cases were detected on arrival and cut the quarantine time for international travelers from 10 to eight days.

With continued spikes in the virus, observers doubt whether China will further modify its COVID-19 policy to gradually open up to the world to revive its economy.

Dalai Lama receives Gandhi Mandela Award, 'Any problem can be solved through dialogue and peace'

"Any problem cannot be solved by war but through dialogue and peace," he said.

SDA Bans Constructions, Vehicular Movement To Thajiwas Glacier

Srinagar: Sonmarg Development Authority has imposed a blanket ban on the construction of activities and plying of vehicles towards Thajwas glacier area.

The order has been issued in compliance with the court directions that came up in 2017. Besides the ban on construction activity, repairs or renovations to the existing structures at Sonamarg has also been banned.

It has also accorded directions for the restriction of vehicular traffic and human interference towards Thajwas area in view of its eco-sensitiveness.

"As such it is enjoined upon all the field officers/officials (Engineering Wing) of Sonamarg Development Authority not to allow any construction activity including the internal repairs and renovations at Sonamarg"

Further, the officials posted at the toll post are directed to keep a close vigil on every movement of the vehicles entering in the tourist destination Sonamarg and not to allow any construction material within the jurisdiction of Sonamarg Development Authority.

The order reads that if any construction material is found at the tourist destination Sonamarg, it shall be treated as a dereliction of duties on the part of the enforcement team of SDA constituted under endorsement under the supervision of Ex. Engineer, SDA and shall be dealt with the iron hand under relevant provisions of Law presently in vogue in J&K.

according to the doctor, triggered social isolation, frustration, boredom, stress and panic among people

"To counter these emotions many people indulged into and relapsed back and started taking drugs again. This negative coping has led to immense increase in substance use in various populations," he said.

The doctor said that study reflects that people belonging to the age group 21-30 years are mostly using substances, specifically opioids and the percentage of people affected was significantly higher in this study (64.5%) as compared to the study conducted earlier (50.5%).

"This finding would reflect the frustration and free time this age group experienced due to the confinement in homes and closure of various recreational facilities as this group in the most active and outgoing age group) In the study, rural and urban population constituted 68.60% and 31.40% respectively. "This is because our hospital is a government hospital which is preferred by the rural population as compared to the affluent urban population who mostly visit private facilities due to the stigma associated with substance use disorder)," he added.

"The closure of various educational institutions and change in the delivery of education services such as online classes led to build up of tension and anxiety in young students besides that the lack of technical knowledge and excessive screen time spent in view of online classes has fuelled up the anxiety and stress among students. Likewise, people belonging to the economic sector, especially the selfemployed, faced huge economic setbacks due to closure of various business establishments and start ups and it is seen that people with substance use disorder develop increased severity when faced with unemployment or financial crisis," the doctor said.

Heroin was the most commonly used opioid (94.12%) compared to pharmaceutical opioids (5.88%). In contrast to a study conducted earlier, in which heroin was 84.33% and pharmaceutical opioids was 24.33%, he

He explained it by saying the resilience of the opioid market to various pandemic measures but pharmaceutical opioids were restricted.

In the study, the most common route of administration of drugs was intravenous 79.42% in contrast to studies conducted earlier where percentage of intravenous users is 7.91% and 51.53%) and it reflects that the

shortage of resources to procure the substance leading to a switch from oral/chasing to intravenous route as the amount required for the same effect is guite low when opioids are used intravenously, he added.

"The percentage of patients having positive serology was also greater. This could be explained by increase seen in reusing of needles due to lack to procure fresh needles and also increasing frequency of injecting in people with substance using behaviour and the percentage of patients who had sought treatment in the past was about 38.31% in comparison to only 13% and 11% of patients as per studies conducted earlier and this finding would be due to increased relapse during the pandemic as the various treatment facilities were shut down," he added.

The IMHANS de-addiction center where the study was conducted was the only centre in the valley that continued providing services both IPD and OPD to substance users during COVID

The need to continue services was felt by the IMHANS department because drug addiction was a parallel epidemic in Kashmir with more mortality and morbidity rate compared to Covid—(KNO)

scribes to threaten, the dossiers says, according to PTI. On Friday, the Editors Guild of India (EGI) condemned the threats, saying such pronouncements have further worsened the sense of fear and insecurity, which makes it impossible for

the journalists to work freely. The Guild strongly condemned the threats and called upon the union territory administration to create an atmosphere of security and trust, wherein the media is not compelled to take sides, and is able to work in a free environment with full security, it said in a statement.

The EGI said the journalists in Kashmir now find themselves in the firing line from both the state authorities as well as terrorists, in what is a "throwback to the years of heightened militancy in the 1990s". (With PTI

SYDNEY: A battling 94 from Steve Smith saw Australia to a series win against England with a game to spare after a 72-run victory in the second one-day international in Sydney on Sat-

Both sides rested their captains, with Moeen Ali deputising for Joss Butler, while Josh Hazelwood was the surprise pick to lead Australia with Pat Cummins sitting out.

After Hazelwood won the toss and elected to bat, two early wickets brought Steve Smith and Marnus Labuschagne (58) to the crease.

The pair put on 101 before Labuschagne departed with a top edge to mid-off trying to sweep Adil Rashid.

Smith was the slower starter of the two, with his 50 coming off 70 balls and containing only two boundaries.

But he upped the pace soon after, especially through his favoured leg side, and was assisted by Mitchell Marsh (50).

Chasing 280, a decent on a dry, bowler-friendly pitch, England got off to the worst possible start, losing two wickets without scoring a run.

Mitchell Starc (4-47) had Jason Rov strangled down the leg side off the second ball of the innings. Three deliveries later, he bowled Dawid Malan with a beautiful outswinger.

England eventually slumped to 208 all out.

The two sides meet for a third and final match in Melbourne on Tuesday.

Infantino Scolds World Cup Critics In Extraordinary Diatribe

DOHA: Gianni Infantino said he feels gay. That he feels like a woman. That he feels like a migrant worker. He lectured Europeans for criticizing Qatar's human rights record and defended the host country's last-minute decision to ban beer from World Cup stadiums.

The FIFA president delivered a one-hour tirade on the eve of the World Cup's opening match, and then spent about 45 minutes answering questions from media about the Qatari government's actions and a wide range of other topics. "Today Î feel Qatari," Infan-

tino said Saturday at the start of his first news conference of the World Cup. "Today I feel Arab. Today I feel African. Today I feel gay. Today I feel disabled. Today I feel a migrant worker." Infantino later shot back at one reporter who noticed he left women out of his unusual declaration. "I feel like a woman," the FIFA

president responded. Qatar has faced a litany of criticism since 2010, when it was chosen by FIFA to host the biggest soccer tournament in the world.

Migrant laborers who built Qatar's World Cup stadiums often worked long hours under

harsh conditions and were subjected to discrimination, wage theft and other abuses as their employers evaded accountability. London-based rights group Equidem said in a 75-page report released this month.

Infantino defended the country's immigration policy, and praised the government for bringing in migrants to work.

"We in Europe, we close our borders and we don't allow practically any worker from those countries, who earn obviously very low income, to work legally in our countries,"



Infantino said. "If Europe would really care about the destiny of these people, these young people, then Europe could also do as Qatar did

"But give them some work. Give them some future. Give them some hope. But this moral-lesson giving, one-sided, it is just hypocrisy.' Qatar is governed by a he-

reditary emir who has absolute sav over all governmental decisions and follows an ultraconservative form of Islam known as Wahhabism. In recent years, Qatar has been transformed following a natural gas boom in the 1990s, but it has faced pressure from within to stay true to its Islamic heritage and Bedouin roots. Under heavy international scrutiny, Qatar has enacted a number of labor reforms in recent years that have been praised by Equidem and other rights groups. But advocates say abuses are still widespread and that workers have few avenues for redress.

Infantino, however, continued to hit the Oatari government's talking points of turning criticism back onto the West.

"What we Europeans have been doing for the past 3,000 years we should be apologizing for the next 3,000 years before

we start giving moral lessons to people," said Infantino, who moved last year from Switzerland to live in Doha ahead of the World Cup.

In response to his comments, human rights group Amnesty International said Infantino was "brushing aside legitimate human rights criticisms" by dismissing the price paid by migrant workers to make the tournament possible and FIFA's responsibility for it. "Demands for equality, dignity and compensation cannot be treated as some sort of culture war - they are universal human rights that FIFA has committed to respect in its own statutes," said Steve Cockburn, Amnesty's head of economic and social justice.

A televised speech by Qatar's emir, Sheikh Tamim bin Hamad Al Thani, on Oct. 25 marked a turning point in the country's approach to any criticism, claiming it had been "subjected to an unprecedented campaign that no host country has ever faced." Since then, government ministers and senior World Cup organizing staff have dismissed some European criticism as racism, and calls to create a compensation fund for the families of migrant workers as a publicity stunt. As Climate Change Progresses, **Trees In Cities Struggle**

s the driest summer in Seattle's record books end-Led, trees across the city were sounding silent alarms.

It was the latest in a string of Seattle summers in the last decade, including a record-breaking heat dome in 2021, to feature drier conditions and hotter temperatures that have left many trees with premature brown leaves and needles, bald branches and excessive seeding - all signs of stress.

You see it in big leaf maples and hemlocks, just loaded with cones or seeds it's kind of their last-ditch effort to reproduce, said Shea Cope, an arborist at Washington Park Arboretum, a sprawling 230-acre (93 hectare) park north of downtown.

This summer was fatal for three significant trees in the park's pine collection, including an 85-year-old Japanese red pine infected with

Heat and drought force trees to spend energy surviving that would otherwise go to regeneration, growth or fighting off disease and pests, Johnson said. Everything outside is trying to eat a tree. The stresses become compounded.

Human-caused climate change also fuels more extreme weather such as intense wind, rain and freezing temperatures.

It's not the gradual change that's going to be the problem, it's these extreme swings of too much water. too little water, too much wind, and storm intensities are going to cause these rapid changes, said David Nowak. a retired scientist for the US Forest Service.
