The One Cheese Gut Health Experts Want You to Eat More Often

ead to any Middle Eastern restaurant and you'll likely find labneh listed in the mezze section of the menu, somewhere near the hummus. The creamy spread is a culinary staple in countries like Lebanon and Israel. It also happens to be one of the healthiest cheeses around.

Yes, cheese can be nutritious. "Dairy gets a bad rap, especially when it comes to gut health," says Jessie Wong, RD, a registered dietitian at Joy Nutrition Consulting. "There's a lot of misinformation out there about dairy being inflammatory when we know that long-term epidemiological studies have found it's actually [linked to a] reduced risk for osteoporosis, hypertension, cardiovascular disease and

Below, gut health experts explain what labneh is, how it's made and why you should eat it more often for a healthy gut microbiome.

What Is Labneh?

Labneh is a fermented dairy product that takes on a spreadable, cheeselike consistency thanks to the way it's

Sometimes called "yogurt cheese,"

labneh tastes tangy much like traditional yogurt but is significantly thicker in texture due to the fact that it's strained over a long period of time.

How Is Labneh Made?

Labneh can be made from many types of yogurt, including kefir, a fermented milk that doubles as drinkable

Before we learn how labneh's made, it's important to understand how its base, kefir, is produced.

Traditionally, kefir is made simply by combining kefir grains with milk. Confusingly, kefir grains aren't actually grains at all. Rather, kefir grains are a white, curd-like substance that's naturally flush with a diverse mix of good bacteria and yeast. The microorganisms in kefir grains act as fermentation agents, or a starter culture.

The process of fermenting the kefir grains and milk typically takes about 24 hours. The final product is probiotic-rich kefir.

"Kefir contains dozens of species of beneficial microbes, including bacteria and yeast mostly from the Lactobacillus and Saccharomyces genuses," says Colleen Webb, RD, a registered dietitian and gut health nutrition expert. These days, commercial kefir prod-

ucts typically utilize industrial starter

cultures to produce kefir, rather than the kefir grains themselves, according to an October 2021 review in Oxidative Medicine and Cellular Longevity.

OK, back to labneh. While many types of yogurt can be used to make labneh, whole milk kefir is an optimal base because of its natural probiotic properties. And making labneh from kefir is quite simple - all it takes is combining whole milk kefir and salt and then allowing the mixture to strain through a cheesecloth for about

a day.

When all of the liquid has been strained out, the curds left behind in the cheesecloth take on a thick, spreadable consistency. Enter: Labneh, aka kefir cheese.

Labneh delivers many of the same benefits as yogurt or cheese. But experts say labneh has a nutritional edge

1. It's a Source of Protein

Just like Greek yogurt and Icelandic skyr are heavily strained and therefore higher in protein, so too is labneh. A 1/4 cup of labneh has 6 grams of protein while a 1/2 cup serves up about 12 grams of protein, per the USDA.

Friendly reminder: Protein is critical for building and maintaining muscle mass, keeping our immune systems strong and promoting satiety.

2. It's Low in Lactose

Kefir is low in lactose thanks to its conversion into lactic acid during the fermentation process, per an October 2014 study in Food Science and Technology.

'Labneh is very low in lactose, so most people with a lactose intolerance can tolerate labneh without issue," Webb says. "It's a great option for those who struggle to eat softer cheeses, which usually are higher in lactose."

3. It Can Be a Great Source of Probi-

Unlike other cheeses like cheddar or brie, kefir cheese offers up gutfriendly probiotics. Just make sure the labneh label says it contains live and active cultures.

"One of the things that's so amazing about biology is the fact that we are not alone," says Bruce Hirsch, MD, a gut health expert, infectious disease doctor at Northwell Health and member of the Peggy Lillis Foundation's scientific advisory board. "The human body is a community of organisms and our relationship with the other life forms that exist within our body is extremely important."

Dr. Hirsch says he encourages people to think about the body as its very own ecosystem. "Living with healthy germs both in and on us is an extremely important component of wellbeing," he says. And the foods we eat can help those beneficial bugs thrive.

"Kefir has been shown to positively influence the balance of the gut microbiota, which has the potential to improve GI transit time, strengthen the gut barrier function and reduce inflammation," Webb says. "More specifically, research suggests it might reduce constipation and help to eradicate H. pylori infection.

Novel Artificial Enzymes Could Help 'Kill' Covid Virus: Study

cientists have developed artificial enzymes programmed to target the genetic code of SARS-CoV-2 and destroy the virus, an advance that may lead to a new generation of antiviral drugs for COVID-19 and its variants.

Enzymes are naturally occurring biological catalysts, which enable the chemical transformations required for our bodies to function -- from translating the genetic code into proteins to digesting food.

Although most enzymes are proteins, some of these crucial reactions are catalysed by RNA, a chemical cousin of DNA, our genetic material, which can fold into enzymes known as

ribozymes. Some classes of ribozvme are able to target specific sequences in other RNA molecules and cut

them precisely. In 2014, Alex Taylor and colleagues from the University of Cambridge, UK, discovered that artificial genetic material known as XNA -- in other words, synthetic chemical alternatives to RNA and DNA not found in nature -- could be used to create the world's first fully-artificial enzymes,

named XNAzymes. These artificial enzymes can cut long, complex RNA molecules and are so precise that if the target sequence differs by just a single nucleotide -the basic structural unit of RNA -- they will recognise not to cut it.

This means they can be programmed to attack mutated RNAs involved in cancer or other diseases, leaving normal RNA molecules well alone, the researchers said.

The study, published in the journal Nature Communications, demonstrated the use of this technology to successfully 'kill' live SARS-CoV-2 virus.

Creating new XNAzymes can be done in far less time than it normally

entertained.

takes to develop antiviral drugs, according to the researchers.

Taylor teamed up with Nicholas Matheson to show that these XNAzymes were active against live SARS-CoV-2 virus.

"It's really encouraging that for the first time and this has been a big goal of the field we actually have them working as enzymes inside cells, and inhibiting replication of live virus, said Pehuen Pereyra Gerber, who performed the experiments on SARS-CoV-2 in Matheson's lab.

"What we've shown is proof of principle, and it's still early days," added Matheson.

Taylor checked the target viral sequences against databases of human RNAs to ensure they were not present in our own RNA. Because the XNAzymes are highly specific, this should in theory prevent some of the 'offtarget' side-effects that similar, less accurate molecular therapeutics may cause, such as liver toxicity, the researchers said.

SARS-CoV-2 has the ability to evolve and change its genetic code, leading to new variants against which vaccines are less effective.

To counter this problem. Taylor not only targeted regions of the viral RNA that mutate less frequently, but also designed three of the XNAzymes to self-assemble into a 'nanostructure' that cuts different parts of the

virus genome.
"We're targeting multiple sequences, so for the virus to evade the therapy it would have to mutate at several sites at once," he said.

"In principle, you could combine lots of these XNAzymes together into a cocktail. But even if a new variant does appear that is capable of getting round this, because we already have the catalytic core, we can rapidly make new enzymes to keep ahead of it," Taylor added.

Pashtun-Style Celebration Puts Gun Licenses Under Scanner In Kashmir

A recent trigger-happy action of a Kashmiri man has renewed focus on the gun license scam currently being investigated by a federal investigation agency.

A video that surfaced on 12 November shows a man firing from his licensed pistol during a marriage ceremony in Allochi Bagh area of Srinagar.

The stunt shocked sundry, drawing parallels with Pashtun-style wedding celebrations.

Cops swiftly arrested Moin

Khan of Peerbagh for "endangering lives of others" and forwarded his handcuffed picture to Srinagar newsrooms.

Khan's case might be an exception, but the act has put the syndicate of gun licenses under scanner in Kashmir all over again.

These licenses are granted, renewed and cancelled under the Arms Act, 1959 and the Arms Rules, 2016, a top security official told Kashmir Observer.

"Depending on a threat perception, a person approaches his concerned police station with a plea for the authorized firearm," the official informed.



"The application is then forwarded to the Superintendent of police (SP) office. And after a

proper verification, it is sent to the Deputy Commissioner's office."

But while this remains a

standard issuance procedure, many officials that Kashmir Observer contacted for the story said that no such license has been sanctioned in the erstwhile state since 2018.

And yet, Jammu and Kashmir tops the list of states/union territories where arms licences with all India permission were issued during the past three years.

Among the total 22,805 fresh gun licenses issued across the country between 2018 and 2020, over 78 per cent-17,905-were issued in I&K alone, a Ministry of Home Affairs reveals in a report.

"A total of 2,435 licenses were cancelled throughout the country between January 1, 2018 and September 15, 2020 while only three were canceled in J&K," the report notes.

However, a senior police officer said that the government has banned issuing of firearms licenses in JK since 2018.

'The man arrested for his wedding stunt was given the license over four years ago," the officer said. "The Central Bureau of Investigation (CBI) has already asked all IK deputy commissioners not to provide or renew fresh | More on P10

JVC 'Baby Swap'

Newborn's Body Exhumed For DNA Sampling

Srinagar: Days after a family from Budgam district alleged that their newborn boy was swapped with a female baby at the SKIMS Bemina (JVC) here, the authorities on Monday exhumed the body of the newborn for DNA sampling to ascertain the truth.

'The body was exhumed in order to conduct DNA sampling and match that with those of the family members. The samples have been taken and it is going to take some time" SHO Bemina Ravinder Pal, told

Kashmir Observer Monday. Last week, a family from Patlibagh village of Budgam alleged that their newborn son was exchanged with a dead girl by the staff at the SKIMS (JVC). Following the serious charges, police had registered a case and started a probe to verify the allegations.

The family, however, had buried the newborn at their ancestral graveyard in Budgam.

According to the SHO, the body was exhumed in presence of the police party, officials from the health department and a Magistrate from Budgam.

However, Pal declined to give further information.

Medical Superintendent SKIMS Bemina (JVC) Shafa Deva told Kashmir Observer that the hospital administration is also carrying out an internal enquiry to probe the allegations.

Make Accountability Core Part Of Governance: LG

'It's Prime Duty Of Administration To Empower People, Make System And Process Transparent'

Jammu: Asserting that it is the prime duty of the administration to empower people, make the system and process transparent, the Union Territory Lieutenant Governor, Manoj Sinha on Monday directed the revenue department to remove encroachments from state land and plan for its land use.

"Close liaison should be maintained by the revenue department with civil administration, police authorities to detect any attempt to encroach upon the state land and safeguard it from unauthorized construction. Officials on the ground must ensure that the poor should not be harassed," Sinha said.

The LG passed these directions while chairing a high-level meeting to review the working of the Revenue Department at the Civil Secretariat here on Monday, an official spokesperson said.

Sinha asked the department to adopt a multidimensional approach in its endeavour for bringing transparency in the system.

Srinagar: Amid a worrying trend of drug and substance abuse, mostly among the youngsters, the Jammu and Kashmir administration Monday issued strict directions to the chemists on the sale of high dose X, H and H1 drugs across the Kashmir Valley.

In an official handout, the administration also mentioned do's & dont's to adhere for the sale of these scheduled drugs.

It makes it mandatory to mention on the prescription the date of dispensing, number of tablets dispensed along with stamp of chemist for Schedule H, H1 and X drugs,

an official spokesperson said The instructions, he said, state that all records and registers should be maintained as indicated in the Act/Rules besides they should be made available for inspection for the Commissioner of Food & Drugs Control

Centre Sets Up Panel To Identify Gaps In J&K's Urban Planning

Srinagar: With the Government of India setting up a high-level panel for identifying gaps in urban planning in Jammu & Kashmir, the administration of J&K on Monday constituted a committee headed by the chief secretary to coordinate with the central panel and implement its recommendations. Gyanvapi Case: Court To Hear Plea On Carbon Dating Of "Shivling" On Nov 30

PRAYAGRAJ: The Allahabad High Court today fixed November 30 for hearing a revision petition challenging the Varanasi district judge's order by which the lower court had refused the demand of carbon dating of a 'Shivling' claimed to have been found in the Gyanvapi mosque complex.

Justice J J Munir passed the order on the revision plea filed by Laxmi Devi and others.

On October 14, Varanasi District Judge A K Vishvesh had turned down the plea seeking scientific investigation and

no damages could be caused.
On behalf of the Anjuman Intezamia Committee which manages the Gyanvapi mosque, it was said that a 'vakalatnama' has to be filed in the meantime. 'Vakalatnama' is a written document signed by a client to allow his advocate to plead a case in a court on behalf of him.

Four of the five Hindu parties had sought carbon dating of the 'Shivling' found during a court-mandated videography survey of the mosque premises close to the "wazookhana", a small reservoir used by Muslim devotees to perform ritual ablutions before offering Namaz.

Cold and dark: Kyiv readies for 'worst winter of our lives'

KYIV: When the power is out, as it so often is, the highrise apartment overlooking Ukraine's war-torn capital feels like a deathtrap. No lights, no water, and no way to cook food. And no elevator by which to escape from the 21st floor should a Russian missile strike. Even when the electricity comes back, it's never on for long.

"Russian strikes are plunging Ukraine into the Stone Age," says Anastasia Pyrozhenko. In a recent 24-hour spell, her 26-story high-rise only had power for half an hour. She says the "military living conditions" have driven her and husband from their apartment.

"Our building is the highest in the area and is a great target for Russian missiles, so we left our apartment for our parents' place and are preparing for the worst winter of our lives," said the 25-year-old.

The situation in Ukraine's capital, Kyiv, and other major cities has deteriorated drastically following the largest missile attack on the country's power grid on Tuesday. Ukrainian state-owned grid operator Ukrenergo reported that 40% of

Gujarat Assembly Polls: 'Son' Rise In 20 Seats As Bjp, Cong Field Dynasts

Though frowned upon and favoured in equal measures by parties of different hues, dynastic politics is a traditional feature of electoral contests in the country and the next month's Gujarat Assembly polls are no exception.

The ruling BJP and opposition Congress have together fielded sons of sitting and former MLAs in at least 20 of the total 182 constituencies.

The opposition Congress has fielded 13 such candidates and the Bharatiya Janata Party (BJP) gress' Sangramsinh Rathwa, the son of former Railways minister Naran Rathwa, both making their poll debut. Sitting MLA from Sanand seat in Ahmedabad district Kanu Patel is the son of former Congress MLA Karansinh Patel. The Patel senior joined the BJP in 2017, paving the way or his son to contest from Sanand again.

The BJP has repeated Kanu Patel from the same seat. BJP's candidate from Thasra, Yogendra Parmar, is the son of two-time MLA Ramsinh Parmar, who had won on a Congress ticket in 2007 and 2012 before quitting the



to seven. Gujarat will vote in two phases on December 1 and 5. The counting of votes will be taken up on December 8.

According to analysts, political parties are at times compelled to give tickets to dynasts either due to the strong 'winnability' factor or in the absence of an alternative in the constituencies where these leaders wield clout.

When tribal leader and tentime Congress MLA Mohansinh Rathva severed his decades-old ties with the parent party and joined BJP last month, the ruling party rewarded him by fielding his son Rajendrasinh Rathva from Chhota Udepur seat.

The segment reserved for Scheduled Tribe (ST) candidates will witness a straight contest between Rajendrasinh and Conparty in 2017 but was defeated by a BJP candidate.

Shailesh Parmar, a two-time MLA of Congress from the Danilimda seat in Ahmedabad, is the son of former MLA Manubhai Parmar.

The Congress has once again reposed its faith in Shailesh for the upcoming elections. Another such contestant is former two-term MLA Mahendrasinh Vaghela, the son of former Gujarat chief minister Shankersinh Vaghela.

Mahendrasinh re-joined Congress last month and was fielded by the party from the Bayad seat. He represented the constituency as a Congress MLA between 2012 and 2017, switched over to BJP in 2019, and returned to his parent party- Congress- last month.

'Bharat Jodo Yatra' Set To Enter Madhya Pradesh On Nov 23

As per the available schedule now, the Bharat Jodo Yatra will start in Madhya Pradesh on November 23 morning after entering from neighbouring Maharashtra," MP Congress Committee (MPCC) media department chairman KK Mishra told PTI.

The yatra will start from Bodarli village of Burhanpur district at 6 am on November 23, he said.

Madhya Pradesh Congress Committee general secretary Rajiv Singh said the yatra will reach Burhanpur city on November 23 evening and enter neighbouring Khandwa district on November 24.

Earlier, AICC in-charge of Madhya Pradesh Congress J P Agrawal had on November 6 informed that the foot march was scheduled to enter the state's Burhanpur district on November 20 and proceed to other districts on November 22 after a day's rest.

The foot march, a mass contact initiative of the Congress, began on September 7 at Kanyakumari in Tamil Nadu.

It will pass through 12 states before culminating in Jammu and Kashmir after spanning a distance of 3,570 km over nearly 150 days.

Water Tank 'Purified' With Cow Urine After Dalit Drinks Water

NEW DELHI: After a Dalit woman drank water from a community drinking water tank in the Heggotara village in Karnataka's Chamarajnagar, 'upper caste' residents of the village reportedly drained out the tank and 'purified' it by washing it with gomutra (cow urine).

According to a report in the New Indian Express, the initial incident took place on Friday, November 18, during a wedding between members of the Dalit community. After the wedding, a woman, thought to be one of the bride's relatives who had travelled to Heggotara from a village in the neighbouring Mysore district, reportedly drank water from the tank in question.

This reportedly led to a local man from the area gathering others and berating the woman for doing so. After the woman left, the locals reportedly emptied out the tank and 'cleaned' it with cow urine.

The next day, the revenue inspector and other government officials visited the village and took note of a complaint by a local resident who belongs to the SC community.

On Sunday, Chamarajnagar Tehsildar Basavaraj and deputy director of the Social Welfare Department, Mallikarjun led a group of youths, accompanied by the police, around the village, where they drank water from all such reservoirs, denouncing the practice of untouchability.

This group also painted signs

on all such reservoirs making clear that any person is allowed to drink from them.

Further, the police reportedly took cognisance of a complaint filed by one Giriappa against the reported accused, Mahadevappa. The police reportedly said that a case will be registered and the accused will be charged under provisions of the Scheduled Castes and Scheduled Tribes (Prevention

of Atrocities) Act (SC/ST Act).

Thereafter, Karnataka infrastructure development minister V. Somanna, who is also the minister in-charge of Chamarajanagar district, also visited the district on Sunday and said that he directed the deputy commissioner to probe the matter further and apprehend those guilty.

"I Have No Aukat, Let's Discuss Gujarat": PM Modi Challenges Congress

In a veiled attack on Rahul Gandhi for walking with Medha Patkar, PM Modi said that their leader travels by putting his hands on the shoulders of the people who made Gujarat "thirsty".

PM Modi during his rally in Dhoraji on Sunday as well in an apparent swipe at Rahul Gandhi said that during the Bharat Jodo Yatra, the Congress leader walked with a woman who tried everything to derail the Narmada Project.

"You should ask them with what face are they coming to seek votes from you. They did everything to stall the Narmada project for decades together and ensured that no money including that from World Bank was able to come over to Gujarat. They were constantly maligning the reputation of Gujarat," PM Modi said on Sunday as on November 19, Rahul Gandhi was joined by activist Medha Patkar, in his Bharat Jodo Yatra, who spearheaded the Narmada Bachao Aandolan to prevent the displacement of locals due to the water of the Dam.

In some hagiographies Rishis and Sufis have been put in the same framework. For example in the case of Mir Mohammad Hamdani and Sheikh ul Aalam which led to Mir Mohammad Hamdani giving him Khat ul Irshad, which is in Arabic and at present is at Khangah-e-Moula.

Meaning that Sufi of a qubravi order is now permitting a Kashmiri rishi to take disciples in that Order (silsila).

The anxiety which was there regarding the 'unislamic' nature of 'rishis' was overcome in this manner.

He noted that Power has always played a role and in Kashmir Persian was a language of power. It was the language of court and administration. It became a language in which poets and

theologists. The tareekh writing is seen as a very conscious effort by historians (morikhs) as an act that can be conceived in the framework of Islam.

They begin with invoking God's name and Kashmir has special place, it is place where Islam is meant to flourish"

Tareekhs have a lot to say about those times and eminent people those days were rulers or saints.

During the chakh period we have a Persian poet Sheikh Yaqoob e Sarfvi who was a versatile genius, a poet and a jurist and among his works is panjgung which was written in the imitation of nizami and also a dewan of ghalas and rubiaat.

"Sarfi and Hubbi are the important poets of the Chakh period and a genuine lover of Ahlulbait (a.s)" he said.

As far as the Mughal period is concerned, it turned out to be the golden period for Persian poetry. Influx of poets from Iran to India began. They looked for a place near Iran, so they came to India.

Gani Kashmiri has a name in sabk e hindi and has surprisingly among other things written about the 'harshness of winter'.

During those times many poets called Kashmir home: Kaleem Kashani, Toghra Mashhadi, Saleem Tehrani, and Mir Elahi.

And many Kashmiri poets were born during the Mughal period, Mirza Darab Joya, Mirza Akmaluddin Kamil and Mohammad Aslam Salim.

Afghan period starts in 1753 upto 1819 and then Sikh period from 1819 to 1846.

The Afghan and Sikh periods are known for their oppression but poetry continued in the form of masnavis during the Afghan period.

Abdul Wahab Shaiq is one the poets who wrote Shahnama-e-Kashmir and is based on 60,000 verses and Mulla Taufeeq continued it. Mulla Shahabadi is another important poet who saw both Afghan and Sikh rule and two years of Dogra rule.

With the coming of Dogras Persian started to lose its eminence.

Mufti further defined Persian as a cosmopolitan language which spread from Ottomans in Turkey to Mughals in India and in the midst of all this, Kashmiris got an opportunity to make use of that.

He said for the revival of the language, there is no other way than to learn the language.

SPOs Rape 2 Women At Gunpoint In Lolab

ARAMULLA: A pair of special police officers assaulted two Dardpora women in Lolab forests last night. The perpetrators, who stalked the victims in the forest where they had gone to collect fire wood, have been identified as Nazir Ahmad Tantray, son of Ghulam Rasool Tantray and Manzoor Ahmad Lone, son of Jabbar Lone, both from Dardpora, Lolab, - the victims' na-tive village. They have been arrested by the police.

A NAFA report said in Srinagar that two pro-government gunmen had entered a Warpora household with the inten-tion of robbery. Finding the two women alone in the house - the rest of the family was away at a wedding - the Ikhwanis assaulted them at gun point and later carried them to the nearby forests to repeatedly subject them to the heinous act. The village was seething with rage after the two traumatized women returned this morning and recounted what had befallen them

ONS in Baramulla identified the victims as Shafiqua, daughter of Ghulam Nabi Mir, and Atiqua wife of Fayaz Ahmad NAFA, however, said that both were married and Shafiqua was the wife of Ghulam Nabi Mir. The report said the victims as well as the criminals belong to Warpora. The criminals have been arrested by Lalpora police and two AK rifles recovered from

Admin. Retrieves Over 75 Kanals Of **Land From Encroachers**

Srinagar: The District Administration Srinagar On Monday launched a massive anti-encroachment drive in various parts of the district and retrieved over 75 Kanals of State land at prime locations worth crores of rupees. The District Administra-

tion also raided the illegal mining site at Chandpora Nallah in Tehsil North of the district during midnight and seized three tippers and one JCB, and an FIR was also lodged against

A team of Revenue and Police Officers/ Officials headed by Teshildar Eidgah, Ishfaq Ahamd Khan conducted an anti-encroachment in Sangam area and retrieved 6 kanals of Government land. In this regard, proceedings under 107 crpc were also initiated against 30 encroachers.

Similarly, anti-encroachment drives were launched in Danihama and Haripora Harwan areas of North Tehsil of the district during which about 70 kanals of state land was retrieved from the land grabbers. The Teams headed by Tehsil-

dar North, Kaiser Mehmood removed 20 kanals of state land at Danihama, while 50 kanals of state land was also retrieved at Haripora, Harwan Besides, in order to control

The library also has around 5000 rare books and miniature paintings.

Ishrat said the manuscript collection of ORL is a treasure-trove of religious, philosophical, historical, literary and scientific writings.

The collection, she said, is rich in classical languages like Persian, Sanskrit and Arabic. These languages have left a deep impression on Kashmiri language by conditioning its growth in terms of forms and scope, she said and added that the Sanskrit, language of court and culture in 9th and beginning of 10th century in Kashmir contributes a number of religious, aesthetic and poetic articulations and are preserved in ORL.

A sale Counter has been also established at the Exhibition for the sale of exclusive books published by the Oriental Research Library Srinagar.

Tarigami Questions Delay in Completion of SSCProject

Srinagar Revamp Plan

he government is set to give Srinagar a Rs 980 crore makeover. The 4000 year old city is getting better urban mobility and water transport, pedestrian-friendly pathways and intelligent traffic management. Beginning March next year, Polo View is getting a facelift, "a colonial-era look." The market which was established by the former Prime Minister of J&K, Bakshi Ghulam Mohammad in 1954 has always been a tourist haunt and the new makeover is designed to further enhance its aesthetic appeal. It will become the first market in the city with a pedestrian-friendly pathway.

Recovering from the turmoil of the past three decades, Srinagar continues to live amid the echoes of the immediate past and the call of an uncertain future. Not that the change has not visited it. It has. But it has been primarily of a physical nature. There are scores of large shopping complexes coming up in the city. Along the major streets of Residency Road, Gogji bagh, Karan Nagar and also along Hyderpora, Sanat Nagar and the other areas, a brand new facade has lent a new gloss to the city.

There have been some bigger cosmetic changes like remaking of a large portion of the Jhelum embankment into a Chinar shaded riverside park which has kind of restored the famous boulevard along the river to its past colonial glory. Bund, as the boulevard is locally called, is a famous Jehlum side feature of the city, a darling of the tourists. It is the mooring site of the first houseboats in the Valley and in its heyday was seen as the oriental challenge to Venice

Srinagar has witnessed acres and acres of new colonies sprouting on its outskirts which have transformed its appearance. This has spawned an unprecedented real estate boom. The local developers have jumped into the fray in a big way, building flats and residential colonies, to cater to the large-scale migrations into the city from the countryside. The city's demography has been altered in the process. Without asserting itself in any conspicuous way, a shiny new Srinagar is coming up away from the downtown city and aspiring to become the new political and commercial hub.

The contemplated new changes in many ways are a search for the vintage old Srinagar when all was so serene. And for once, through a renewal of scenic resemblance with the past, it represents a bid for the restoration of the familiar old geography of peace.

A Tale of Forlorn Garbage Bins

Non-operational District Swachh Bharat Missions

In my previous articles, I have explained how services for waste management are not only the prerogative of people living in urban areas but this work has to be taken up in rural areas as well. The Swachh Bharat Mission Gramin explains this in detail. However, work is not being taken up on the ground. In fact, some months back, the Rural Development Department had tried to launch a rural waste management programme in J&K but this work has not been done on scientific lines as mandated under Municipal Solid Waste Rules 2016 (MSW Rules).

Before launching the programme, it was important to sensitise all about the work. Yet, the Government preferred to skip this entirely and instead jumped to supplying a large number of steel trash bins instead. The fate of these bins is interesting to note. Some have fulfilled their destiny of holding waste but no service has been put in place to actually empty them. Now, these trash bins – empty or filled – lie scattered or stolen.

Consequently, it now seems like this entire exercise is turning out to be a failure.

Through my social media campaigning, when I highlighted the grotesque images of these huge dustbins overflowing with trash through videos; some village panchayats did not install them at all (Photos from Gogge Pathri in Nagam block of Budagm district are a case in point). This has happened because employees of the Rural Development Department and members of panchayat have an apprehension that once filled, people will take pictures of these trash-filled and deserted trash bins and share them on social media. With no mechanism in place to actually empty them out, the best way, according to them, is to not provide dustbins at all. The ground level employees of the Rural Development department like Panchayat Secretary, Gram Rozgar Sevak (GRS) plus members of Panchayat (Sarpanch and Panchs) are now worried about what to do, as they are not trained to handle solid or liquid waste. Truly a situation quite keeping with the phrase, 'between the devil and the deep blue sea'.

Had the officials of the Rural Development Department properly studied the 2017 guidelines of SBM Gramin or its operational guidelines, there would not have been any chaos or confusion in implementing the Rural Waste Management programme in Jammu & Kashmir.

Moreover, the Government has also failed to constitute the District Swachh Bharat Mission (DSBM) committees at district level headed by Chairpersons of Zilla Parishad who are known as Chairpersons of District Development Council in J&K under Panchayati Raj Act 1989.

Swachh Bharat Mission

The Swachh Bharat Mission (SBM) was launched in 2014 to accelerate the efforts to achieve universal sanitation coverage. The programme was launched by Prime Minister Narendra Modi on 2nd October 2014 and under this national flagship programme, all villages, Gram Panchayats, Districts, States and Union Territories in India declared themselves "opendefecation free" (ODF) by 2nd October 2019; a feat which was celebrated on the 150th birth anniversary of Mahatma Gandhi. The Government claims that over 100 million toilets in rural India have been constructed. The official report of SBM Gramin reads:

"To ensure that the open defecation free behaviours are sustained, no one is left behind, and that solid and liquid waste management facilities are accessible, the Mission is moving towards the next Phase II of SBMG i.e ODF-Plus. ODF Plus activities under Phase II of Swachh Bharat Mission (Grameen) will reinforce ODF behaviours and focus on providing interventions for the safe management of solid and liquid waste in villages"

District SBM Gramin (DSBMG)

The operational guidelines of Swachh Bharat Mission Gramin clearly mention the role of Panchayati Raj Institutions (PRIs) in implementing Solid & Liquid Waste Management under SBM Gramin. From district to village panchayats, the roles and responsibilities have been explained in detail but unfortunately these guidelines are not being explained to PRI members. The operational guidelines is sued by the Ministry of Drinking Water & Sanitation explains the role of District Swachh Bharat Mission Gramin - DSBM(G). The guidelines 8.5, page 36 throw light on the constitution of district mission. It reads:

"DSBM(G) shall be headed by the Chairman of Zilla Parishad. The District/Deputy

Commissioner/Magistrate/CEO Zii Panchayat shall be the Executive Vice

Chairman. The members would be – all MPs/ MLAs and MLCs of the district and Chairperson of the concerned Standing Committees of the Zilla Parishad or their representatives; CEO/AEO of the Zilla Parishad. District Officers of Education, Health, Panchayati Raj, Social Welfare, ICDS, PHE, Water Resources, Agriculture, Information and Public Relation. NGOs can be identified by the DSBM(G) and co-opted into the Mission as members.

CEO of the District Panchayat/Parishad; the Executive Engineer of PHED/District Engineer of the ZP/ any other officer approved by SSBM(G) shall be the Member Secretary "

The guidelines make it mandatory that the DSBMG headed by Chairman DDC (Zilla Parishad) shall meet at least once a quarter. During these meetings, the district mission is supposed to plan and advise on implementation of the SBM (G) in the district with appropriate Information Education and Communication (IEC) strategies and convergence mechanisms with all line departments. In Jammu & Kashmir, however, bureaucrats are bypassing all this. Not one meeting has been convened by District SBM Gramin nor have these committees (District Missions) been constituted formally through a written order. Even the members of the mission including Chairpersons of DDC or its members, BDC Chairpersons have not been sensitized about SBM Gramin Phase II (solid and liquid waste management) nor have they been told what their role is to undertake the Rural Waste Manage-

DSBM Management Committee

Under the District Swachh Bharat Mission Committee headed by Zilla Parishad Chief (DDC Chairman) is another committee called District Swachh Bharat Mission Management Committee (DSBMMC). This is chaired by the District Collector/Magistrate and comprises all district level officers of relevant departments. Under it, all the Block Development Officers- BDOs/ Block level officers in charge of sanitation, shall be formed and shall meet once a month to plan and monitor the implementation of the mission. The Committee is to carry out regular Block and Gram Panchayat level reviews. The Deputy Commissioner or CEO Zilla Panchayat (ADDC in case of J&K) is to be the nodal officer responsible for the implementation of the mission. Remuneration of all government employees in the Mission would be borne by the State. The DSBMMC can engage technical experts as consultants to be supported under the programme.

Had these technical people been hired by the District Committees in J&K there would not have been chaos and confusion as the entire process of waste management would have been streamlined. The garbage bins won't have been overflowing with waste and other such bins won't have been dumped inside the Panchayat building premises.

In absence of proper training to PRI members and officials of the Rural Development Department; and non-implementation of operational guidelines of SBM Gramin phase II, waste management work is not being undertaken in J&K. In many villages, compost pits and soakage pits have been constructed but they are built haphazardly.

The Junior Engineers, BDO, Panchayat Secretaries, DDC members and Chairpersons need to be sensitized about their roles and responsibilities.

Book Reading Culture in Kashmir in the Age of the Internet

Fading, Flourishing or Fluctuating?

This is in continuation to our previous column, published on Sunday (20th November, page 6). Below are presented a few more viewpoints on this issue and concern.

VIEWPOINT-3: Internet made inaccessible books accessible to a common man; Internet has made Reading prerogative of the privileged and the subaltern alike

ontrary to the opinions presented in viewpoint-2 (that 'internet and smartphones have affected badly the readership qualities, especially among the youth') many believe that the internet is a blessing for the readers, for many reasons. Amir Suhail Wani (a Srinagar based columnist with many newspapers, including Kashmir Observer) is optimistic and sees this change as a positive sign as far as book reading culture in Kashmir is concerned. Refuting the claim that book reading culture has faded or declined, he says: "Many people believe that the book-reading culture is ebbing, but a simple survey of Amazon book sales and the data collected from local bookshops defies this judgment. On the contrary, e-books, online journals and research papers and gadgets like palmtops and Kindle have diversified the reading culture into electronic mode. People across all age groups and from different walks continue to cherish their reading habits. There is only one ill concern that social media platforms have transformed learning into an activity of boasting and useless debating and that's in a sense defeating the purpose of education which is 'formation, not mere information'.

A similar opinion is shared by a senior academician who views the existence of, and establishment of new booksellers (in the Srinagar city, like Kashmir Book Depot, Gulshan Books, Ali Mohd. and Sons, Bestseller, Password and others) as a sign and signal of the "thriving book reading culture". For him, it is of secondary importance what and how much a reader (be it a student or a common person) reads; what is important, and interesting to note, is that people read, he remarks.

It is interesting to add here that a class 12th student (namely Obaid Wani) from Sopore shared a similar opinion. Viewing use of the internet as a helpful tool in book reading, in his opinion, "there is no decline in book reading culture". He also believes that in some cases, "there may be (a decline), but overall there isn't. The internet, as everyone knows, has made our lives better and easier; so is the case with the book reading culture. It takes less time nowadays to read books, due to the internet, as we easily get access to the podcasts and summaries of the books we need to read".

Similarly, Mugees Ul Kaisar (a Philosophy pass-out from JNU, New Delhi and a regular columnist with many newspapers, including KO) is of the opinion that "internet or a smartphone can never replace or compensate the knowledge available in the (physical) books". Agreeing with our query, he is of the opinion that "all the people I know, who are very wellread, are in their 40s or older. In comparison, the number seems to (have) decreased now in our youth because of digital revolution in past decade and a half. That is, our elders seemed to have lesser distraction. If they wanted to know about something, they had almost no other option but to buy books." Appreciating the fact that internet has provided an easy and quick access to the information, he is not miscalculating its harmful effects: "We do not deny that internet makes huge amount of information quite accessible to wider audience, and we can learn a lot from it, but the information in the form of articles and YouTube videos are neither properly structured nor comprehensive. They may act as partial beginner introductions to things. Only books properly and comprehensively cover subjects. Moreover, classics of all sciences are always the most important, which are best accessed through books, whether hard copies or

In the opinion of Asif Tariq Bhat (a young Kashmiri language novelist), "Readers never die. However, in today's rapidly developing technology environment, readers experiment with new ways to slake their hunger for reading, whether it is through documentaries or audiobooks. The content thus reaches the reader via many paths and media. It is absurd to blame the internet for this. Speaking of the culture of reading books, voracious readers cannot have this thing taken from them".

Based on his own experiences as an avid reader and writer, Dr Shah Faisal (IAS), shared



a mixed response to our query, for he highlights the harmful effects of the internet and at the same time appreciates its benefits. For him, "book reading culture has taken a hit because of internet. My personal experience has been that whenever I don't have access to internet, I immediately return to (physical) books. And the moment, I am back online, I find myself so distracted. There is so much happening in this world. Breaking news is a part of life now. We also find it hard to read books because we are used to reading 280 character tweets. Social media makes it so difficult for us to get those quiet moments when we can pick up a book and get absorbed in it." However, he does not overlook the positive side of use of the internet and smartphones, for it has made available "many online resources": "PDF books, which can be read and shared without any charges, have made knowledge more accessible." Therefore, for him, "it ultimately depends on the judicious use of the internet and social media, as we can read much more than we used to read before the age of internet.'

Echoing a similar viewpoint, Prof. Ishfaq Hussain Bhat (Assistant Professor, English at GDC Sogam), and viewing the internet as a "double-edged sword", he is f the opinion that it has no doubt "revolutionized the world insofar as making books available/ accessible to people belonging to different walks of life, but it has badly affected reading habits". "Digital addiction", in his opinion, "is one of the major threats to reading habits because the users/ readers live in a constant FOMO (fear of missing out)" and it leads to "distraction". He also is of the opinion that we should not consider the increase in the number of booksellers in Srinagar or in the whole Kashmir valley as "a yardstick" for flourishing book reading culture. At the same time, he (being a teacher) cautions that "if the trend continues, we might soon see, with some exceptions, books being used as mere decoration items." Dr Mushtaq Ahmad Kumar (Assistant Professor, Kashmiri, GDC Sogam) also shared similar viewpoint on this question, adding that the "passion for reading has tremendously dwindled in the young generation due to various reasons—injudicious use of smartphones, mostly for entertainment purpose, being the primary one"

Danish Bashir (a BSc 6th semester student at our college and a budding writer and good orator) is of the opinion that no doubt "internet is beneficial for us as it provides us easy access to the study material that we need as well as gives quick fix solutions to our problems" but its use "ultimately leads the user to distraction" even if a user is reading a book. In contrast to this, "reading from a physical book not only helps us in concentrating on the topic we are reading, but also in absorbing and accumulating what one reads."

M. Azhar Ul Haq (a voracious reader who is currently pursuing PG in English at Central University of Kashmir) also views internet both as boon and ban for book publishing and reading. He says that it is true that "the IT revolution changed everything around us, including how and how much we read. I believe that the internet affected printing more than publishing and reading. Similarly, it facilitated access to quality literature produced across the world. Reading ceased to be a prerogative of the privileged: now, the subaltern can read."

"In general, the trend of studying today is more towards the digital world and Kashmir is no exception to it, as students here prefer to read books, magazines, newspapers and literature on various topics (of their interest) on the internet", says Mujtaba Farooq (MANUU-Hyderabad based PhD scholar and a regular Urdu columnist with local and national dailies). On the issue of diminishing reading culture, he is of the opinion that there are two main reasons; that (1) easy access and availability of the required study material (in digital format) for the students as per their need, literary taste and interest; and (2) spending a lot of time by using social media for entertainment, watching reels and short clips and playing games. These reasons, for him, "have had a significant negative impact on the study trend." He substantiates his viewpoint from the feedback received from some reputed booksellers of Srinagar (during a conversation). He further states that "one experiences an aesthetic feeling by reading a physical book, which cannot be attained by reading a book in digital format. Thus, it is imperative to turn back to read (physical) books."

Faiza Aijaz (who is pursuing PG in English Literature at Central University of Kashmir), as a counter-argument, raised the question (which is similar to the viewpoint highlighted by Dr M. Maroof Shah) "did Kashmir ever have a reading culture?" and answers it in negative saying that "the book reading culture never thrived in Kashmir." She further argues that any "intellectual activity, including book reading, has largely been a vocation of the privileged section of the society" in Kashmir but the "penetration of internet to the center and hinterland alike" has resulted in a "kind of democratization of book reading." "Kashmir, too, has begun to inculcate the habit of reading books", she remarks

otwithstanding the fact that in recent years we have come across a number of news reports of school going students publishing a book, the general trend is students are neither encouraged to read books nor are there any contents or schemes in the curriculum or pedagogy which could inculcate or refine reading habits among students. Saniya Zehra Dar (a class 9th student at AGS Shariefabad, Budgam) as quoted above, has made a confession that as a student she has not witnessed any "inclination among the students towards reading books" which she substantiates with the point that the "main topic of discussion is the social media" and "hardly any student talks about books." This is further validated by the opinion of a teacher who has observed that "students are not encouraged to spend their leisure time in the library'

Eyram Hamid Khan (a research scholar in the Life Sciences and a columnist who has written on this topic as well) answers our question as "simply Yes", because he believes that "everyone is addicted to the digital world, whether they are workers, students or professionals" and thus "not only have children [students] lost interest in reading books, but even adults are also hardly seen reading books anymore.' Khan, however, considers "broken educational system" as the "root cause of this issue", believing that "students reading habits are scarcely being instilled in them." For him, "Books are not something fascinating for the people anymore", and "intellectual endeavor has all but disappeared from their lives."

Resonating a similar standpoint, Dr Zaira Ashraf Khan (Assistant Professor, Islamic Studies at GDC Pulwama and an author) is of the opinion that "the depreciation in the reading culture trend starts from schools where reading isn't encouraged as source of intellectual development rather a means to crack exams and this trend continues all through life of a student at college too. They prefer easy to read and memorize notes/ booklets instead of a text. Reading feels more like an obligation for a student who looks for an escape." She also believes that teaching not the "art of reading a book" is also one of the reasons having resulted in the decrease of "the percentage of book lovers."

For Dr Bilal Ahmad Sheikh (who teaches History at GDC Sogam), one cannot deny the fact that "in the age of technology, the internet is consuming a good amount of time and people are left with too little free time to be spent on reading printed books. The people, particularly students, are largely dependent on internet for entertainment and information than books, which has decreased the importance of tradi-

tional libraries." "Because of growing influence of internet and social media", he opines based of his observations, "that though college libraries are rich in their collection", these days "students rarely have a regular habit of book reading" which is "greatly affecting the quality of educated youth in colleges and universities."

VIEWPOINT-5: What Booksellers (of Kashmir) Say on Book Reading Culture?

n January 2021, Muhammad Nadeem in the Mountain Ink published a feature story related to the book reading culture in Kashmir: "Is 'Book Business' Devouring Reading Culture in Public Libraries of Kashmir?" In this story, he mentioned, on the basis of inputs received from "some bibliophiles" that "Kashmir's reading culture is both falling and fading".

In a recent interview with Sani Yasnain of Bestseller, "one of the oldest bookstores in Srinagar" by Insha Latief Khan ("Bestseller attracts book lovers across Kashmir", Rising Kashmir, 9th November 2022, p. 8), it was mentioned that (1) Bestseller is "a major attraction among the book lovers across Kashmir" and to "create a reading culture among the younger generation, the bookstore offers sales on the best-selling books"; (2) Sani, an avid Urdu literature reader himself, believes that "even though the youth is inclined towards books, yet the reading culture is diminishing because of the high price of the books, which students find difficult to afford"; (3) Sani believes that "Students not reading the books would not be a reason for the reading culture to die. It's because the price of books has gone up from some years which doesn't let students afford the book"; (4) Sani believes that "even though the gadgets have eased lives but when it comes to reading, a hard copy is still preferred over the PDFs"; for him, the "physical appearance of the book and the feel it offers is different from the one you can get from soft copies"

Similarly, the owners of the online book store, LALCHOWK.IN, which claims to be 'Kashmir's largest and favorite online bookstore" with diverse choice of subjects and genres—including "academics, fiction, literature, competitive or Islamic books"—believe that while "we cannot specifically say that the reading culture is on decline, but generally speaking, internet has affected the common reader base in Kashmir and elsewhere", and the reason is simple: "great share of reader base has shifted towards e-books and audiobooks nowadays as they find it more portable and less time-consuming than a physical book reading session". For them, "the availability of news outlets (magazines/ current affairs) on the social media", is another factor responsible for diminishing reading habits of people, as has "put a stop on reading full time physical newspapers (and magazines)". They further state that "the reading culture is in decline everywhere (including Kashmir) due to the fast moving and news dissemination through the

Crux of the Discussion/ BOTTOM LINE: From the opinions, viewpoints and comments of different stakeholders, it becomes evident that:

- 'Reading section' or 'avid readers' are always present in a society, but there presence has been, and will always be, marginal; they will not be affected much by the socio-political, intellectual or technological developments and advancements taking place around the
- Use of the internet as well as smartphones has proved both a boon and ban for the book reading culture in Kashmir; the internet has no doubt made books accessible and available for a common reader, but reading a book on digital.
- Digital age has no doubt revolutionized the world but it has its harmful effects as well, and reading habits too have been affected by it (tremendously).
- Reading culture is not instilled and inculcated among the students at school or college levels.
- Even though the (electronic) gadgets have eased lives but when it comes to reading (a book), a hard (physical) copy is still preferred over a digital (PDF) copy; and the reading culture is declining everywhere (including Kashmir) as we are living in the 'digital age'.

Govt Issues Circular To Improve Assessment Rating Under BRAP, 2022

Asks All Admin Secretaries To Ensure Monitoring Of Integration Process With J&K Single Window System

SRINAGAR: In a bid to ensure better assessment rating under BRAP, 2022, the government on Monday issued a circular, directing all the Administrative Secretaries to ensure monitoring of the integration process and the progress of approvals of the respective services to achieve 100% feedback of users on Ease of Doing Business (EoDB) and Ease of Living (EOL) in Jammu and Kashmir.

A circular issued by Secretary to the Government, Piyush Singla, reads that "Attention of all Administrative Secretaries of Union territory of Jammu and Kashmir is invited towards initiatives of the Government under taken for simplifying regulatory burdens on businesses under Business Reform Action Plan (BRAP) of Department for Promotion of Industries and Internal Trade (DPIIT). Government of India."

"It has been observed that one of the key requirements under BRAP exercise is to integrate I&K Single Window Portal with other Departmental Portals/Online Systems whereunder, Government to Business (G2B) and Government to Citizens (G2C) services are being

provided. The integration of such services would require on boarding of these platforms with J&K Single Window Clearance System under BRAP, 2022," the circular issued under number 44-JK(GAD) of 2022, dated 21-11-2022, said.

"The integration of all portals which are providing G2B and G2C services under BRAP would redirect the applicants to a single platform of J&K Single Window Clearance System and departments would continue to use their respective service portals to approve or otherwise the applications within stipulated timelines notified under J&K Public Services Guarantee Act, 2011," it added.

"Accordingly, it is enjoined upon all the Administrative Secretaries to ensure monitoring of the integration process in consultation with Industries and Commerce Information Technology Department and NIC, J&K alongwith Department, monitoring the progress of approvals of the respective services to achieve 100% feedback of users on Ease of Doing Business (EoDB) and Ease of Living (EOL) in the Union territory of Jammu and Kashmir, so that better assessment rating could be achieved under BRAP, 2022," the circular added—(KNO)

BDOs To Register Births & Deaths At Shopian

DC Kupwara Issues Directions For Proper Implementation

'No Collateral Security Or Guarantor Required For Bank Loan Of Rs 10 Lakh'

KUPWARA: The District Development Commissioner (DDC) Kupwara, Doifode Sagar Dattatray, who is also Chairman DLRC Kupwara, on Monday issued a circular direction where under Banks and financial institutions were asked to implement the RBI guidelines regarding sanction of loan without collateral security or guarantor up to Rs 10lakh, in letter and spirit.

The circular reads as "The Ministry of Micro, Small and Medium Enterprises vide Office Memorandum bearing No. PMEGP/Policy/09/2021, ed:- 13-05-2022 has conveyed approval for continuation of PMEGP Scheme for five years from Financial Year 2021-22 to Financial Year 2025-26.

It is clearly mentioned in the circular of PMEGP guidelines that 'No Collateral Security will be insisted upon by banks in line with the guidelines of RBI for projects involving loan upto Rs. 10.00 Lacs in respect of projects forwarded to them by the agencies.

The circular further reads

that RBI Master directionslending to Micro, Small and Medium Enterprises (MSME Sector); "Banks are mandated not to accept collateral security in case of loans upto Rs. 10.00 Lacs extended to the units in the MSME sector. Banks are advised to extend Collateral-free loans upto Rs. 10.00 Lacs to all units financed under Prime Minister's Employment Generation Programme (PMEGP) administrated by KVIC"

The DDC further in the circular directions said that In view of the above mentioned guidelines, it is impressed upon all the Heads of Banks/ Financial Institutions to follow the guidelines in letter and spirit and extend collateral free loans without any requirement or guarantor upto a limit of Rs. 10.00 Lacs for PMEGP cases.

Any casual approach or reluctance on the part of any Bank Branch Manager shall be dealt with seriously and necessary disciplinary action as warranted under rules shall be initiated against the delinquent Officer / Official

Gandhi.' "Nehru jailed my father, while Gandhi dismissed my government...But I have a lot of respect for them because of their contribution

It not only provides job opportunities, but also develops work culture. People from outside come and work here, we get to learn from them. It leads to change in the work culture," he said.

The actor, a Kashmiri himself, said while it would take time for the cinema to evolve in the region, "if we want to narrate or showcase our own stories,



we have to open production houses, nurture local talent like they do in the south".

"If we want the whole country to see the stories from Kashmir, and that too with a new perspective, we have to bring a change ourselves. We have to show different stories from here, the stories about those topics which have not

The meeting discussed measures to be taken at different levels to ensure

fair and smooth conduct of the exams. While giving details of the forthcoming exams, the Chairman JKSSB informed that the Board has initiated the process for conducting written examination for selection against different posts through Computer Based Test (CBT) from November 29, 2022. "For the purpose dedicated centres have been identified in 4 districts of Jammu Division i.e Jammu, Udhampur, Kathua & Samba," he informed.

It was further informed that the test for Horticulture Technician Grade IV and Junior Stenographer have been scheduled from November 29, 2022, while the exam for Junior Engineer Civil (Jal Shakti Department) Exam would be conducted from December 5 to December 6, 2022 and the examinations for the post of Sub Inspector (Home Department) is scheduled to be held from December 7 to Dec 20. Giving details of steps taken, the meeting was informed that the Board has resorted to Third Party Audit of Computer Centres and installation of jammers in the exam centres for free and fair conduct of the test(s).

Maintaining that the credibility of centers was the vital factor in ensuring conduct of fair and transparent examinations, the Div Com directed the concerned Deputy Commissioners and SSPs to thoroughly scrutinize the conduct and past history of the identified centre well before the start of

He also asked the DCs and SSPs to inform JKSSB about the adverse report against the identified centres, if any. He stressed on putting in all possible measures for foolproof security, maintenance of law and order, provision of logistic support for successful conduct

of examinations. The SSPs were directed to deploy an adequate number of men and women police personnel for frisking and other

arrangements at various centres. The Div Com also directed DCs concerned to make available proper ar-

rangements of uninterrupted power supply, water supply and other amenities in the examination centres during the examinations and ensure that the candidates are not put to any discomfort.

The Div Com stressed that no electronic gadgets be allowed in the examination halls. He asked the KSSB to issue instructions for the information of candidates and also ensure wide publicity of these instructions.

The Div Com directed DCs to nominate observers/magistrates besides computer expert observers for each centre after checking the credentials.

Average Housing Prices Up By 5% In 8 Cities: Report

NEW DELHI: Average housing prices appreciated nearly 5 per cent across eight major cities in the first nine months of this year on account of rise in input costs and a strong revival in demand, according to property brokerage firm PropTiger.com.

The weighted average prices of residential properties in primary markets across eight cities stood at Rs 6,600-6,800 per square feet at the end of September quarter, as against Rs 6,300-6,500 per square feet at the end of the December quarter, PropTiger.com said in a statement.

REA India, part of Australia's REA Group and US-based News Corp, owns three real estate portals — Housing.com, PropTiger and Makaan.com.

"We are witnessing a modest price increase in the primary housing market. This is mainly because of the sharp rise in prices of key raw materials like cement and steel," the company's Group CFO Vikas Wadhawan said.

Apart from rising input costs, he said a strong revival in demand after the second wave of the COVID pandemic has put an upward pressure on prices.

"Housing prices are expected to further rise in the coming quarter on the back of robust demand, which is still strong despite the hike in the interest rates on home loans by around 2 per cent since May. Prices of key construction materials have eased but are still high as compared to the previous year," Wadhawan said. PTI

Bangladesh Suspends Five Policemen After Two Death Row Convicts Whisked Away From Court Premises

Dhaka: Authorities in Bangladesh on Monday suspended five policemen, including a court inspector and ordered a manhunt to recapture the two death row militants, who were whisked away from a court premises here under dramatic circumstances a day earlier.

Two Islamist militants, who were sentenced to death for killing prominent Bangladeshi-American secular blogger Avijit Roy and his publisher, escaped dramatically from the premises of a crowded court here on Sunday with the help of unidentified bikers who sprayed some chemical substance on police and created a smoke

screen before whisking away the convicts.

"Five policemen including the court inspector have been suspended for their apparent failure while investigations are underway," Dhaka metropolitan police's detective branch chief Mohammad Harunur Rashid told the media.

He said an investigation was underway to unearth the reason behind the incident and identities of those who whisked away these two convicts.

The Home Ministry on Sunday ordered a probe, while the police constituted a four-member nanel to investigate into the incident while elite anti-crime Rapid Action Battalion (RAB) launched a separate review.

Bangladesh Police have also announced a 2 million Taka (approx USD 19,428) for tipoffs leading to the convicts' recapture.

Police and court officials said Moinul Hasan Shamim and Abu Siddiq Sohel -- who were among four operatives of the outlawed terrorist group Ansarullah Bangla Team (ABT) being escorted to transition prison room following an indictment hearing in a different case -- escaped the court premises with the help of some unidentified motorcycle-

"Within moments the misreants appeared in the scene from nowhere and sprayed some chemicals on police guards that temporarily blinded them before whisking away the convicts," a police official said.

CCTV footage aired by TV channels showed two motor bikers wearing helmets carrying the two militants through a narrow road in front of the Dhaka Metropolitan Judges Court complex, while a plainclothesman was seen chasing them.

"The prisoners were just handcuffed, their legs were not shackled, a usual protective measure for dangerous criminals or militants," a court official said.

Hours after the incident, home minister Asaduzzaman Khan Kamal told reporters that a nationwide alert has been is sued to recapture them and an investigation launched to ascertain how the event took place.

Since the beginning of the probe on May 17, 2018, the CBI has collected documents pertaining to the issuance of said armed licenses allegedly spread over 22 districts of J&K.

According to the Enforcement Directorate, around Rs 40 crore were generated through grant of illegal arms licenses in IK.

In March 2020, the CBI arrested two IAS officers—Kumar Rajiv Ranjan and Itrat Rafiqui-for issuing thousands of licenses during their tenure as the district magistrates of Kupwara.

On 25 July 2021, the agency carried out raids across 40 locations across Jammu and Kashmir and Delhi, including the residence of senior IAS officer Shahid Iqbal Choudhary in Srinagar.

Three months later, the federal sleuths showed up at the residence of Baseer Ahmad Khan. The high-profile incident came a week after Khan was relieved as advisor to Lieutenant Governor Manoj Sinha.

The case was earlier unearthed by Anti-Terrorism Squad (ATS) of Rajasthan Police. The secret 'Operation Zubeida' initiated at that time led ATS to an inter-state racket engaged in making arms licenses from Jammu and Kashmir for people spread all across India.

The spokesperson said that the advisory directs chemists not to dispense medications if prescription is incomplete, has alteration(s) without any countersign by the doctor; also not to dispense tramadol, buprenorphine, tapentadol, codeine, methylphenidate for any online prescriptions.

"Also, not to dispense psychotropics to minors not accompanied by guardians and not to dispense a prescription when you have reasonable cause to believe that prescription has been

forged or obtained fraudulently and if forged, retain the prescription and forward it to the authorities," he said.

Moreover, he said, the advisory directs not to dispense medications if the chemists do not have required license-for drugs like Schedule X.

In-charge Divisional Control Room Tahir Magray said that this is the part of initiatives taken under Nasha Mukth Bharat by the govt including the toll free help line no 18001807202.

"Besides, govt is ensuring strict adherence to standing acts and laws related to Schedule X. H&H1 drugs so that any diversion of such drugs into unsafe hands and antisocial elements is averted," the spokesperson added.

2022 FIFA World Cup: England Down Iran 6-2; Argentina Face Saudi Arabia Today

DOHA: Bukayo Saka and Marcus Rashford put last year's European Championship loss behind them, combining to score three goals in England's 6-2 rout of Iran on Monday at the World Cup.

Both players missed penalties in the shootout loss to Italy in the Euro 2020 final and were then subjected to racist abuse. A year later, Saka scored twice at Khalifa International Stadium and Rashford came off the bench to add another with his first move of the match.

It has been a difficult buildup for England, but this was a performance that will provide encouragement to coach Gareth Southgate, who has recently endured the most troubled period of his England tenure.

He was booed after a 4-0 loss to Hungary in June and was humiliated by his own fans when they chanted, "You don't know what you're doing."

Hundreds of fans missed the start of the match because of an issue with digital tickets. When they eventually made their way to their



seats, they witnessed an utterly dominant display from England.

Jude Bellingham scored the first goal in the 35th minute — his first

international goal. Saka then got his first of the match in the 43rd and Raheem Sterling added another in first-half stoppage time. Saka scored his second shortly after the hour, but Mehdi Taremi pulled one back for Iran in the 65th minute.

Rashford struck six minutes later to extend England's lead to 5-1, and Jack Grealish also stepped off the bench to add a sixth in the 90th. Taremi added another for Iran from the penalty spot deep in injury time after John Stones was penalized for holding Morteza Pouraliganji's shirt in the box.

The game was delayed for several minutes in the first half when Iran goalkeeper Ali Beiranvand clashed heads with a teammate. He was eventually taken off the field on a stretcher with the score still 0-0.

His replacement, Hossein Hosseini, was left with the unenviable task of facing England's potent attack.

The match had a total of 29 minutes of injury time, 15 minutes in the first half and 14 in the second.

Alleged Match-Fixing: CBI Seeks Cooperation Of Indian Football Clubs

NEW DELHI: The CBI has registered a preliminary enquiry into alleged match-fixing in football matches in the country, officials said Monday.

During the enquiry which started about 15 days back, the CBI has sought and collected documents from the Delhibased All India Football Federa-

Under the scanner, is the role of an alleged match-fixer based in Singapore in rigging the results of matches, they said.

The officials refused to give any details about the suspects named in the preliminary enquiry and details of allegations as it could hamper the probe which is at a nascent stage.

They said the agency has received some documents while cooperation of several Indian football clubs in joining the investigation, they said.

The CBI cannot conduct searches, arrests or question through summons under the preliminary enquiry, they said citing the law.

The central probe agency depends on cooperation of stakeholders during the preliminary enquiry and registers an FIR when it has prima facie material indicating a crime, they said.
