## **Study Shows Increase In Lung Cancers During Last 5 Years In Kashmir**

Zaid Bin Shabir

Srinagar: In a shocking revelation it has come to the fore that 10 percent of critically ill patients in Kashmir suffer from lung cancer, making it the most common cancer reported in the valley in the last 5 years.

Experts have termed the revelations of the new research as an "imminent disaster" that will require a renewed focus on prevention to combat terminally ill diseases in Kashmir.

The study by five Kashmiri medicos, gives a detailed look at the threats posed by different profiles and patterns of cancers.

## **'Diagnostic Biomarker To Detect Rare Brain Condition With Higher Accuracy Found'**

esearchers have found a biomarker that identifies a rare brain disease called corticobasal degeneration (CBD) with higher accuracy than traditional diagnostic methods, according to a study. The biomarker that identifies a primary tauopathy increases CBD detection accuracy to 89 per cent compared to traditional methods that are only 25 per cent to 50 per cent accurate, scientists at the Washington University said.

Primary tauopathies are a group of rare brain diseases marked by rapidly worsening problems with thinking and movement, the study published in Nature Medicine said. CBD is a rare condition that can cause gradually worsening problems with movement, speech, memory and swallowing, and is one of the tauopathies.

The biomarker could be developed into a tool to screen potential volunteers for CBD-specific research studies and clinical trials and, eventually, to identify people who could benefit from CBD-specific treatments, the scientists said.

"Before, the only way to find out which primary tauopathy a person had was to wait until they died and then examine the person's brain under a microscope," said cosenior author Chihiro Sato.

"A patient comes in with stiffness, balance problems, slurred speech and memory issues, and it could be CBD, but it also could be progressive supranuclear palsy (PSP) or Alzheimer's or other diseases.

"This biomarker can reliably identify people with CBD, which means we can use it to enroll people in clinical trials. And, down the road, it may be key to initiating therapies," said Sato.

CBD is one of about two dozen brain diseases that are considered tauopathies because they share one critical feature: toxic tau aggregates in the brain. Tau tangles



are abnormal accumulations of a protein called tau that collect inside neurons.

In healthy neurons, tau normally binds to and stabilizes microtubules. However, in conditions such as in Alzheimer's disease, abnormal chemical changes cause tau to detach from microtubules and stick to other tau molecules, forming threads that eventually join to form tau tangles inside neurons.

Individual tauopathies involve different subtypes of tau and exhibit different patterns of damage to brain cells and tissues.

The collections of symptoms of the various tauopathies overlap, making it difficult

for doctors to tell one from another. This complicates efforts to study them and find treatments, the study said.

Tauopathies are classed as either primary or secondary, depending on when tau tangles appear in the course of the disease. In primary tauopathies, tau tangles form in the beginning, seemingly on their own. In secondary tauopathies, tangles form only after other changes have taken place in the brain.

For example, in Alzheimer's disease, the most common secondary tauopathy, the brain protein amyloid beta builds up for years before tau tangles appear.

As part of this study, the researchers used a highly sensitive technique to detect specific fragments of tau in the cerebrospinal fluid that surrounds the brain and spinal cord to search for distinctive forms of tau linked to primary tauopathies.

The team examined brain tissues and cerebrospinal fluid from people who had died with dementia and movement disorders, and whose specific diseases had been

confirmed at autopsy. The study population included people with one of five primary tauopathies – CBD, PSP, frontotemporal lobar degeneration with microtubule association protein tau mutations (FTLD-MAPT), agyrophilic grain disease, and Pick's disease - as well as Alzheimer's, and dementia not related to tau.

For comparison, they also examined samples from people without dementia.

Two particular forms of tau – microtubule binding region (MTBR)-tau 275 and MTBR-tau 282 - were unusually high in the brains and low in the cerebrospinal fluid of patients with CBD and a subset of FTLD-MAPT.

Further investigation showed that these forms of tau distinguish people with CBD from those with other primary tauopathies with 84 per cent to 89 per cent accuracy, depending on the disease.

"Even if there's an experimental drug available that specifically targets the kind of tau in CBD, it is very challenging to test it without a biomarker," study author Kanta Horie said.

"The trial might fail even when the drug works if the population is heterogenous. Drug trials that specifically target the kind of tau in CBD can be improved by enrolling correctly diagnosed patients.

"Having a biomarker opens up a pathway for pharmaceutical companies to improve clinical trials and accelerate research toward therapies for CBD," said Horie.

Prof Arifat Jan threw the light on the relevance of the Samvidhan Divas and emphasized the need for conducting such Programmes. He deliberated on the Genesis of the Indian Constitution and traced a brief history of its evolution over the decades. The welcome address was fol-

Learned speakers traced the origin of democracy in India to early vedic times and proclaimed that India is the benefactor of democracy to the rest of the world. Prof. Tafazul also alluded to the international Debates on the contribution of India to the Genesis of democracy given flip by Hon'ble Prime Minister Narendra Modi recent address at UN General Assembly. The programme concluded with the formal vote of thanks presented by Shahnawaz Muntazir, Assistant Professor (English) and Convenor Srinagar: The Srinagar City is surrounded with the heritage sites, but the non-implementation of the law to preserve these sites have resulted in reduction of such places in the past two

decades as the survey conducted by INTACH, J&K Chapter has revealed progressive loss of heritage sites in the City. "In the past two decades, a total of 12 per cent of the heritage

sites or buildings have been dismantled completely while six per cent are either in danger of disappearance or have been found in advance state of decay," Chairman INTACH, J&K Chapter, Muhammad Saleem Beg said.

He said that a total of 349 sites were identified and categorized as Grade I properties in the 2003 listing while only 49 percent out of them are in good or fair conditions. "We recently conducted a survey again for the smart city project and we have found that 51 per

cent heritage sites as per 2003 listing are either dismantled completely or showing signs of deterioration. Besides, six per cent out of them are in danger of disappearance or in an advanced state of decay," he said.

Beg further added that in 2010, a law was formed with regard to the preservation of the heritage sites, but was not implemented on the ground so far, which led to the demolition of the heritage buildings and poor condition of others as well. "Had the law been implemented, all the heritage sites would have been in good condition in Srinagar," he said.

The situation is because of the lack of seriousness as well as the accountability on the ground, he said and added the City is progressively losing the heritage sites every year, but there is a need to implement the law concerning the heritage sites.

Chairman INTACH, J&K Chapter while divulging the details said that during the new

survey conducted recently, a total of 17 new sites have been added in the Grade I category. With the addition of new 17 sites, the City has a total of 307 heritage sites at present, which need to be preserved and protected following the implementation of the law," he said.

"The central government recently came up with an industrial policy under which the heritage sites have been declared as industry as well. The government has said that it will provide a 30 per cent incentive for any activity to be started at the heritage sites. However, the J&K administration has unfortunately failed to recommend any single case to the central government so far, which would have helped in preserving the heritage sites," he said.

He added that there is a need to create awareness, ensure regulation and preservation of the heritage sites and steps in this regard are imperative at this juncture—(KNO)

## 5 Truckers Shot Dead

RINAGAR: Five drivers on way to Jammu with apple-laden trucks were gunned down and six others sustained injuries by unidentified gunmen in two different incidents near Banihal on Jammu-Srinagar highway last night.

According to reports, a group of eight to 10 unidentified gun¬men donning army uniforms appeared at Sher Bibi and Khar¬pur, respectively six and 10 km from Banihal between 8:00 p.m. and 9:00 p.m last night, and brought down the drivers on the pretext of checking their vehicles. After parking their vehicles along the road side, the truckers had retired for the night.

The gunmen segregated the drivers and conductors on the basis of religion after verifying their identity cards. Lining up the drivers from Sikh and Hindu communities, they opened fire killing five of them on the spot and injuring six others. The assailants managed their escape.

Of the deceased, two were identified as Jagitt Singh of Chral¬igund, Baramulla, and Rashpal Singh of Dhariwal, Punjab Those injured were identified as Ranjit Singh of Chandusa Baramulla,Lakhwainder Singh of Dhariwal Punjab, Anil Ku¬mar of Dhariwal, Pawan Kumar alias Nikka of Dhariwal, Sim-raniit Singh of Jagirpora, New Delhi and Mangal Kumar. The ill-fated trucks bore numbers JKU/4119.JK02G J425.PJS'4005, and PB-07E/ 9315.

The injured were rushed to Ramban and Banihal hospitals Later, they were shifted to the army hospital at Ramban.

The news of truckers killing evoked an instant reaction among the transport operators who called for a chakka jam and bandh in the transport yard and transport Nagar here to-day. Various organisations have given a call for Jammu bandh and wheel jam tomorrow in protest against the killings.

Protest demonstrations were held at Ramban and Batote against the killings. The protesters raised anti-Pakistan slogans.

Describing the killings as a desperate act of militants, the inspector general of police, R V Raju, told Observer News Ser-vice these were clearly aimed at disruption of essential sup¬plies to the Kashmir valley and to create communal tension in the state. He said security all along the 300-km long high¬way had been beefed up. Senior civil and police officials have rushed to the spot and were watching the situation.

Traffic authorities have imposed restrictions on moving ve-hicles on the highway. Random parking has been stopped and movement of vehicles after 6 p.m. is not allowed.

A KPS report from Srinagar said some of the injured were ad-mitted in the SK Institute of Medical Sciences at Soura, where they told the agency the gunmen in army fatigues spoke chaste Dogri. The incident sparked spontaneous shutdown in Bani¬hal and the president of Banihal Beopar Mandal, Shamsuddin Rahi, announced that the hartal would continue till the inves-tigation into the incident was completed.

It may be recalled half a dozen truck drivers were done to death in a similar incident at Mir Bazar Qazigund in the south Kashmir district of Anantnag last year. On that occasion, Kash-miri truck drivers were roughed up at Jammu, Udhampur and in New Delhi and their goods were destroyed.

During their regime, terrorists from Pakistan used to enter India frequently and kill our soldiers and even decapitated their heads. Despite that, Congress never uttered a word. Why? Because of their vote bank. I hope you know who is Congress' vote bank," the senior Bharatiya Janata Party (BJP) leader said.

He added PM Modi gave a strong message to the world by carrying out surgical and air strikes on terrorists after Uri and Pulwama terror attacks.

## **AIIMS Ransomware Attack: Key** Patient Data At Risk Of Leak, Sale On Dark Web, Says Experts

NEW DELHI: With the All India Institute of Medical Sci-ences (AIIMS), New Delhi, still struggling to get its servers up and running after a massive ransomware attack earlier this week, cyber-security researchers on Saturday said the most reported attacks in the healthcare industry, which rose during the pandemic, involve the leak or sale of databases on the Dark Web.

The exploited databases contain Personally Identifiable Information (PII) of patients and healthcare workers, as well as administrative information such as blood donor records,

and Accountability Act) compliance requirements, create awareness among users regarding cyber-attacks, online scams, and phishing campaigns, set up policies for secure passwords and enable multi-factor authentication (MFA)," a spokesperson of AI-driven cyber-security firm CloudSEK told IANS. The cyber attack on AIIMS shut down its main and backup servers.

The attackers hacked the ehospital service which manages the patient data system, affecting the outpatient department (OPD) and sample collection services.

Those behind the cyber attack have warned AIIMS to



ambulance records, vaccination records, caregiver records, login credentials, etc.

"Government agencies involved in the healthcare industry should abide by HIPAA's (Health Insurance Portability "prepare for a negotiation". Delhi Police are investigating the cyber attack.

Meanwhile, AIIMS officials said that all affected online patient services are now being run on manual mode.

## **Court Order To Pay Salaries To Imams Violates Constitution: Top Official**

NEW DELHI: The Central Information Commission has said the 1993 Supreme Court order allowing remuneration to imams in mosques was in "violation of the Constitution" and, besides setting a "wrong precedent", has become a point of unnecessary political slug fest and social dish Information Commissioner Uday Mahurkar, while hearing an RTI application filed by an activist demanding details of salaries to imams by the Delhi government and the Delhi Waqf Board, also observed that the order violated constitutional provisions that say "taxpayer's money will not be used to favour any particular religion". The Supreme Court in 1993 on a petition from the All India Imam Organisation had directed the waqf board to give remuneration to imams in mosques managed by it. He has directed that a copy of his order be sent to the Union Law Minister with suitable action to ensure enforcement of provisions of articles 25 to 28 of the Constitution in letter and spirit to keep all religions on par in terms of monthly remuneration to priests of different reli-

gions at the cost of the public exchequer -- both central and states -- and also other matters. "Further with regard to the judgment by the Supreme Court in the case between the 'All India Imam Organisation and ... vs Union Of India And Ors' on 13 May, 1993, that opened the doors to special financial benefits from public treasury to only imams and muezzins in mosques, the commission observes that the highest court of the country in passing this order acted in violation of the provisions of the Constitution, particularly Article 27, which says taxpayers' money will not be used to favour any particular religion," Mahurkar said.

Some avid supporters, who have already landed in the city, were housed in a temporary tent structure set up in the Allama Igbal Park near the venue of the rally.

Khan would leave his Zaman Park residence in Lahore at around 1 pm local time in a bullet-proof vehicle which was sent to his place. He is expected to address his supporters at around 6 pm.

It is not clear if the rally would disperse after his address and convert into a sit-in. However, the Rawalpindi city administration has given only one-day permission for the rally.

#### Khan, 70, said on Friday that despite being injured he is determined to head to Rawalpindi for the sake of the nation.

Khan in his message said that he was fighting for the real independence of the country and the struggle would continue until fresh elections were announced. We are fighting a war for the Hageegi Azadi. The one point agenda is elections, he said, as he accused the current government of destroying the economy and running away from elections due to fear of defeat. Separately, he told a news channel that if the snap elections were not announced and the government stuck to its stance of holding the general election on time next October, then the masses would throw out the incumbent rulers through force.

## **Thieves Steal Train Engine From Bihar Railway Yard**

n entire diesel engine was stolen part by part from a railway yard Tin Bihar's Begusarai district, police said on Friday.

The thieves dug a tunnel to the yard and started stealing parts, slowly doing away with the entire engine that was brought there for repairs, they said. "Last week, a case was registered at the Barauni police station for the theft of a diesel engine brought for repairs to the Garhara yard. In the course of the investigation, three people were arrested," said PS Dubey, the inspector of Railway Protection Force (RPF), Muzaffarpur.

Based on the information given by them during interrogation, searches were conducted at a scrap godown in Prabhat Nagar area of Muzaffarpur district and 13 sacks full of train parts were found, he said.

A search is on for the owner of the scrap godown, he added.

Recovered items include engine parts, wheels of vintage train engines and railway parts made of heavy iron, he said. "They had dug a tunnel to the railway yard and through it, they used to carry the locomotive parts and other items in sacks," said Dubey.

The gang is also involved in unbolting steel bridges and stealing their parts, he said.

Last year, a railway engineer of Samastipur Loco Diesel Shed was suspended after he allegedly sold off an old steam engine kept at the Purnea court premises.

The engineer had allegedly used a forged letter of the divisional mechanical engineer of Samastipur to sell the engine in connivance with other railway officials and security personnel.

SRINAGAR: As part of Afforestation activities in temperate regions of Jammu & Kashmir, the Department of Social Forestry has given a widespread start to plantation activities across various districts of valley.

The PCCF/Director, Department of Social Forestry, Roshan Jaggi in last one week visited various districts of Kashmir val-

ley to give start to the plantation activities involving Gram Panchayats, Educational Institutions, Village Panchayat (Plantation) Committees, NGOs, local people and Govt. Organizations like Police/Army etc.

Interacting with PRIs and local people at Kupwara, Baramulla, Pulwama and Anantnag, Jaggi informed that the Department will take up more than 12 lakh planation on community/panchayat fringe and degraded for-

est lands in the current winter season and about 925 Villages are expected to be get benefitted with these activities.

He disclosed that this year department has decided to complete substantial quantity of plantation targets before "Chilla Kalan" spell during which temperature

drops substantially and planation activities are withheld till March. Timely rains this year have provided enough soil moisture which is conducive for plantation activities in colder regions of J&K. Official spokesperson in-

formed that the Department is laying focus on augmenting the production of plantable grasses and leaf fodder by raising silvipasture units to make available good quality fodder free of cost

to local people, which has an important role to strengthen rural economy.

10 Lakh indigenous good quality fodder plants are being planted up in Jammu and Kashmir regions, besides some improved varieties of fodder grasses in collaboration with National Fodder Institute (IG-FRI), Jhansi. One such silvi pasture unit was taken at Goorinar Palhalan (Pattan), Baramulla wherein large-scale planation activity was taken up on 24th November, 2022 led by Director, Social Forestry himself.

Another thrust area of So-

cial Forestry Department is to modernize the nurseries to have sufficient production of quality planting stocks like clonal poplar, Eucalyptus, Bamboo, Fodder and Fuelwood, fast growing plants and also medicinal plants. İmproved clonal fast growing male poplar saplings are being distributed to local farmers under Farm Forestry Component to sustain the supply of quality raw-material to industries of plywood/ plyboard, pencil etc. These initiatives are aimed at increasing income of farmers.

Under Har Gaon Haryali, Department is extending its

activities to about 1602 villages during this year and Gram Panchayats, and local people and field staff functionaries are actively involved to take up plantations in each such village alongwith distribution of plants, seeds, seedballs amongst the farmers, students and other stake holders.

The Department had also organized a grand interaction with PRI representatives in which DDC/BDC members, Sarpanches and Panches besides local people participated and fruitful discussion took place to strengthen the activities of the department regarding creating more and more durable assets in Gram Panchayats which would yield financial returns.

75 percent proceeds from mature plantations go to Gram Panchayat Fund. The official spokes person further disclosed that during 2021 and 2022 more than 60 Gram Panchayats have received an amount of Rs. 350.00 lakh as part of 75 percent share from the harvesting of mature plantations in their respective panchayats, which is generating healthy competition amongst Panchayats to raise more and more plantations on vacant lands.



## Kathua Rape Case How the SC Exorcised the Ghost of Juvenility

**It is worth** noting that before wrapping up the matter, the apex court unequivocally struck a clamant note of caution in its concluding remarks and in the same breath went on to provide some food for thought to the government regarding the effectiveness of the object of the Juvenile Justice (Care and Protection of Children) Act, 2015

cently delivered a decisive verdict on the juvenility of one of the accused in the appalling Kathua rape-murder case. The verdict was an outcome of the appeal filed by the U.T. (then State) of Jammu and Kashmir against the order passed by the High Court of Jammu and Kashmir (at Jammu), that had affirmed the order of the CJM Kathua, declaring the said accused as a juvenile on the date of the commission of the offence. In its verdict, a division bench of the Apex Court, shutting the door on the claim of juvenility, held the impugned order of the CJM and the High Court, 'not sustainable in law', and thereafter set it aside and directed that the respondent accused should be tried as an adult in accordance with the law. Considering that, in this piece, I will briefly try to shed some light on the rationale behind the court's decision.

he Supreme Court of India re-

Overall, in this case, the only fundamental question, for adjudication, before the court was whether the accused was a juvenile on the date of the commission of the offence.

The answer regarding the determination of juvenility was rooted mainly in the provisions contained under Section 8 of the J and K Juvenile Justice (Care and Protection of Children) Act, 2013 as well as Rule 74 of the Rules framed under the Act. As stipulated therein, Rule 74 deals with the determination of age, and Subrule 3 of it under clause (i) and (ii) mentions particular certificates as a mode of age determination. However, clause (iii) of the sub-rule 3 provides that, "in absence of certificates mentioned in the clause (i) and (ii) or in case of any contra-

diction arising therefrom, the authority deciding the age issue may refer the matter to a duly constituted Medical Board, which shall record its findings and submit to the Juvenile Justice Board." In the instant case, as rightly argued by the appellant state, there was an obvious discrepancy or contradiction in the documentary evidence on record-in the form of certificates-disclosing the age of the respondent accused. In fact, the date of birth certificate issued by the School, and the order of the Executive Officer Municipal Committee specifying the date and birth of place of the respondent accused, were palpably at variance. Even the order of the Execute Magistrate per se was shrouded in irrationality as only 3 months of gap in date of birth was shown between the first and the second child, in it. Second, the letter of the Block Medical Officer of the Health and Family Welfare to the Superintendent of Police, stating with particulars that no such delivery had taken place at the municipal hospital, eroded the significance of the above order. As a result, there was no cogent or convincing evidence on record with respect to the correct date of birth of the respondent accused. In such circumstances, Sub-rule (3) (iii) of Rule 74 was supposed to kick in for the determination of age. The court, affirming the same, held that there is no good reason why the same should not be done. Further, it also emphasised that it was on the directions issued by the High Court that the Special Medical Board was constituted, and hence in absence of any cogent documentary evidence, there is no good reason for the court to ignore the report of the Board. Therefore, on this account also, the argument on behalf of the respondent accused that the said rule had no applicability, diminished in impact.

#### The interpretation of the word 'May'

Notably, the language in which Subrule (3) (iii) Rule 74 is clothed, is prima facie directory in nature as it uses the word 'may'. However, it is a well-established principle of interpretation that the word 'may' by itself is not conclusively directory in nature. It can be given a mandatory connotation and be read as 'Shall' where it appears to the court that the intention of the legislature demands so in light of the object, scheme, purpose, context, and other relevant considerations of the Act. In view of the same, in the instant case, the apex court held that considering the object of Subrule (3) of Rule 74, the word 'may' used herein has a mandatory import and thus be read as 'shall'. Next, the apex Court referred to Section 8 which lays down the procedure to be followed when a claim of juvenility is raised before any court, and Section 48 of the Act 2013, which refers to the presumption and determination of age before a competent authority. This analogy was essentially drawn to highlight that in both these sections the word 'shall' has been used by the legislature.

#### Reliance on a Case

The learned counsel on behalf of the respondent accused, inter alia, placed strong reliance, on a case in which despite the presence of medical opinion, the court has displayed a tilt towards juvenility of an accused. However, disregarding the same, the Court held that the said case was considered by this court in another case and it is now settled that the approach was taken given the peculiar facts and circumstances of that case and so it cannot be generalized. The court also asserted that there is no hard and fast rule regarding the acceptability of the documents; it would depend on the facts and circumstances of each case.

#### Conclusion

Taking all the relevant factors into consideration, the Court held that in the case at hand, the documentary evidence fails to inspire any confidence, so in the interest of justice, there is no option but to lean on the report of the Special Medical Board. This route led the court to the conclusion that the respondent accused is not a juvenile and consequently should be tried as an adult. It was this rationale that assisted the court in legally exorcising the ghost of juvenility in the case.

Moreover, it is worth noting that before wrapping up the matter, the apex court unequivocally struck a clamant note of caution in its concluding remarks and in the same breath went on to provide some food for thought to the government regarding the effectiveness of the object of the Juvenile Justice (Care and Protection of Children) Act, 2015.

working and living conditions for workers because of reforms introduced by the Qatari government. It adds, however, that there were still immense challenges in implementing these reforms. The reality is that terrible abuse and appalling living conditions remain a feature of life for many migrants.

The overarching problem, Ennis argues, is the exploitation of migrant workthe recently elected government strongly opposes same-sex marriage and its president rails against the "LGBT lobby".

In Qatar, sexuality is understood in terms of actions rather than identity. Under Qatari law, sexual relations outside of marriage and sodomy are both crimes, whether they're between a man and woman or a same-sex couple. So too are "immoral actions", a term which is undefined.

It's noteworthy that the US Department of State report in 2021, like reports in previous years, doesn't reference any actual prosecutions for same-sex sexual behaviour. In the British press, only a very small amount of the coverage of Russia in the run-up to its 2018 World Cup was about the football event. By contrast, almost half of the coverage on Qatar has been about the World Cup.

Reporting on Russia's invasion of Crimea, the bombing of Syria and human rights abuses was relatively disconnected from coverage of the World Cup there. In the one-dimensional, simplistic reporting on Qatar, however, human rights abuses are being closely connected to the World Cup, even when the two topics are not directly related. The result has been the extreme politicisation of the sporting event.

Painting a simplistic caricature of Qatar, moreover, is significant in shaping public opinion about the country. Most people in Europe and America know little about Qatar's people, history, political system and culture except for what they see in coverage of the World Cup.

#### 'Oriental despotism'

In France, where multiple municipalities are refusing to hold public screenings of World Cup matches in protest at Qatar hosting the event, the magazine Le Canard recently published a racist cartoon depicting Qatari footballers as terrorists, holding the country up as a spectacle of horrifying barbarism in a manner that evokes old ideas of "oriental despotism".

In 2021, the Guardian reported that a staggering 6,500 migrant workers had died since the World Cup was awarded to Qatar, seeming to imply that the deaths were connected to the World Cup.

"The 6,500 figure actually refers to all deaths of migrant workers from Pakistan, Sri Lanka, Nepal, India and Bangladesh, regardless of cause," says Marc Owen Jones, assistant professor of Middle East Studies at Hamad bin Khalifa University, Qatar. "It's not an 'excess' death figure."

The number of worker deaths actually linked to the World Cup is disputed. While World Cup organisers say that there have been three work-related accidents and 37 deaths from all causes, a report by the UN's International Labour Organisation says that there were 50 deaths in the construction industry in 2020 and raises questions about the way that deaths are categorised.

The Guardian's story was tweeted thousands of times and the "6,500" figure was picked up by journalists across Europe, especially in France, often being misinterpreted as suggesting that 6,500 migrants had died on World Cup construction sites. In Britain, the number was cited by a Sky News interviewer, speaking about World Cup-related deaths in a question put to Qatar's foreign minister. He replied that the figure was untrue.

And at a recent football match between Bayern Munich and Borussia Dortmund, fans held up a flag saying "15,000 deaths for 5,760 minutes of football - shame on you". The "15,000" figure stems from an Amnesty International report. It refers to the total number of deaths of all non-Qataris in Qatar between 2010 and 2019, not of construction workers on the World Cup, nor even only construction workers.

#### Reforms

exploiting the workers but their fellow citizens who serve as brokers and manage their contracts in Qatar and at home".

In recent years, reforms have somewhat improved the situation in Qatar. The kafala sponsorship system has been overhauled so that migrants can now change jobs without their employers' approval. Researcher Crystal Ennis, writing for Middle East Eye, notes that "improvements have taken place to bring regulations into line with international labour standards".

Qatar is now far ahead of its neighbours in key respects. In 2021, the government introduced a non-discriminatory minimum wage law. By the end of the year, it had reportedly paid \$165m in compensation to 36,000 workers.

In a new report, the International Labour Organisation highlights improved

ers in global labour market structures. It's not just the Gulf - some European countries also have serious issues with the abuse of migrant workers, but they receive little attention in the mainstream British media.

A global effort is needed to encourage safe and regular migration. Both Human Rights Watch and Amnesty International warn against an international boycott of the World Cup, arguing that it won't drive positive change. Strikingly, though, only seven of the qualifying football federations endorsed a campaign calling on Fifa to create a \$440m compensation fund for migrant workers. This was a more practical but less sensational demand.

#### LGBTQ+ rights

Of course, there are some irreconcilable differences in values between the British public and Qatar. One issue which has provoked particular outrage is LGBTQ+ rights - 62 percent of British people think Qatar's position on this issue alone should have barred it from hosting the World Cup.

It is of course vital to draw attention to horrifying reports of the arbitrary arrest and abuse of LGBTQ+ people in Qatar. Human Rights Watch recently documented "six cases of severe and repeated beatings and five cases of sexual harassment in police custody between 2019 and 2022", although Qatar strongly disputes the report's assertions.

But in terms of the criminalisation of homosexuality, there's nothing exceptional about Qatar's stance. In most Commonwealth countries homosexuality is illegal, and many of these are Christian, not Muslim, countries.

This raises the question of whether it's acceptable to travel to or engage with countries around the world such as Saint Lucia, Singapore and Nigeria. If it is, why is Qatar being singled out?

Nor does this issue pit Europe against the rest of the world. Around 100 towns and regions across Poland have declared themselves free of "LGBT ideology". In Italy, Its society is conservative. Public displays of affection between members of the same sex are forbidden, and any public display of affection can lead to arrest, including between a man and a woman. Holding hands, by contrast, is legal - including for two men and two women.

In the run-up to the World Cup, the emir of Qatar has maintained that LG-BTQ+ fans are welcome but must "respect our culture".

#### Complexity

It's worthy of comment that the world of football has never been renowned for its celebration of LGBTQ+ identities either. In May this year, Jake Daniels became the first male British footballer in over 30 years to come out as gay.

No country should be treated like it's beyond criticism. And any country that hosts a major sporting event must expect to face scrutiny over its human rights record.

But the orientalist depiction of Qatar as a land of exceptional barbarism functions as a form of virtue signalling, a selfcongratulatory but incoherent show of moral superiority.

Qatar is a young country - it was only founded in 1971 and it has developed dramatically in the last few decades. Last year, the nation held its first elections for the Shura Council, the state's legislative body. Qatar is a fast-changing country, and that's partly because of hosting the World Cup.

This could have been a chance for the world to learn more about Qatar. Instead, the opposite is happening.

Taking a moral stance is important, but can only be helpful if it's consistent and combined with a genuine attempt to understand the Other in all its complexity.

## What's Happening in Iran? (A Kashmiri Journalist's Perspective)

'Not everything is hunky-dory in Iran and one should not expect a sanctions-battered country to be an ideal place'

ntil not too long ago, Iran was consid-ered an "Island Of Stability In The Ocean of Troubles". However, two months ago, or to be precise, on September 13, 2022 all this changed. Or did it? At least the dominant mainstream media would like all of us to believe that it did and according to them, the fall of Islamic Republic is imminent. World has no access to the other side. Iran's voice remains choked and its perspective absent as the US, using its extraordinary power over cyberspace, has not only seized all domains of media based in Iran, but forced major satellite providers to stop uplinking Iranian channels. To know what is really happening on the ground in Iran, Kashmir Observer talked to Syed Zafar Mehdi, a Kashmiri journalist based in Tehran. Zafar moved to Tehran from Kabul four years back and has since been reporting from Iran for various media channels.

Apart from economic sanctions, Iran is facing a complete media blockade. News emanating from the country is only from Western sources and the impression they give is that the fall of the Islamic Republic is imminent. Is it so?

SZM. What the Islamic Republic of Iran is dealing with at the moment is a multi-faceted hybrid war, which encompasses crippling sanctions, media propaganda, and terro attacks. It's unprecedented in the sense that many inimical forces have come together, both overtly and covertly, to delegitimize and discredit the country's political system, which is undeniably more vibrant than many Arab monarchies that happen to be key Western allies. The agenda is clear - to bring about the "regime change" in Iran and make it a vassal state again, subservient to the West. That's where mainstream media's role comes into play. Western media's coverage of Iran has traditionally been lopsided and deceitful. It won't be an exaggeration to say that when it comes to Iran, corporate Western media acts like an extension of the hostile Western powers. In recent months, since the death of a young Iranian woman in police custody, media coverage of Iran has become increasingly toxic. Western media outlets have been hell-bent on painting a gloom-and-doom picture of Iran, to give the impression that things are completely out of control.

Islamic Republic has a significant follower base across Muslim world and there is deep concern about the disturbing turn of events. Iran's govt blames everything on the West while it's harder to digest this time given that the opposition has transcended Iran's borders as was seen in Qatar this week. There must be some merit in the grievances of those out in the streets?

**SZM.** Of course, there is resentment and people have grievances. Let's not forget the country has been reeling under decades of draconian sanctions, which have taken a heavy toll on ordinary people. Tenth months into the Ukraine war, inflation and food crisis have assumed alarming proportions across Europe. Imagine 43 years of economic war against Iran, and yet the country has not collapsed. The ugly turn of events in recent weeks should be seen as part of the "regime change" project. As pointed out by the Supreme Leader, inimical forces sought to create hopelessness among people but failed.

#### Does Iranian system of governance allow public protests and what has been its response to the events so far?

SZM- A young Iranian woman's death in police custody in mid-September triggered protests across the country. Protest, as per

of shootings and knife attacks, mostly targeting policemen and paramilitary Basiji forces. What's similar between 2009 and 2022 is the direct interference of Western regimes, intelligence agencies and media with an aim to foment unrest and destabilize the country. However, unlike in 2009, when leading Iranian political figures gave the initial call, this time the calls came from outside. Also, unlike in 2009, there is social media now that has played a key role in stoking unrest through misinformation and unsubstantiated claims.

#### How are events being aired by Iranian media? Do they cover all aspects or only push the official narrative?

**SZM-** Iranian media has in recent months mostly been busy in debunking the rampant disinformation disseminated by Western media, in particular the UK-based Persian language media outlets such as Iran International, BBC Persian, and Manoto. There is such gross distortion of facts about the situation in Iran that it's preposterous. When the Canadian prime minister tweets fake news like "15,000 people to be executed in Iran", the US national security advisor comments on the killing of a 10-year-old boy in Khuzestan by armed rioters and blames it on Iranian security forces, it shows how bizarrely the narrative has been hijacked.

So, with media being weaponized by Western regimes against the Islamic Republic, as part of the hybrid war, it becomes essential for the Iranian media to not only be the voice of the Iranian people but also debunk the fake news spreading like wildfire through social media platforms. And when they do that, sanctions are imposed. Press TV and many other Iranian media agencies were recently sanctioned by the European Union. Top IRIB officials were also slapped with sanctions by the US Treasury. It shows how the alternative voices that tend to challenge the dominant Western narratives are suppressed and silenced.

Misinformation about Iran has spread like

Iran's constitution, is an inalienable democratic right of citizens. In fact, soon after the shocking news broke out, President Ebrahim Raeisi ordered a high-level probe into the incident, parliament speaker Bagher Ghalibaf proposed reforms in the modus operandi of the country's morality police, and judiciary chief Mohseni Ejei assured justice and accountability. This was before the protests turned into deadly riots. Iranian authorities made it clear that they are willing to listen to protesters but will not tolerate anarchy, violence and vandalism. But, unfortunately, that's what happened.

#### If so, why are protests continuing?

**SZM-**Even before the forensic report came out, many Western leaders issued inflammatory statements, holding Iranian officials responsible for the young woman's death. A slew of so -called human rights related sanctions were imposed by both the United States and the European Union. Interestingly, the

a plague with deliberate attempts to poison the minds of readers and viewers outside Iran. There are a plethora of Persian-language media outlets targeting Iran from Europe, especially the UK based and Saudi-funded Iran International, engaged in a smear campaign 24x7. Most of the news they broadcast and Western media rely on these days will not count as journalism but as full-fledged media warfare. And, unfortunately, such media coverage is taken as gospel truth in much of the world, including in South Asia. Let's get this straight. It's not the same old-school journalism where facts are sacred and truth matters. Now it's all about the battle of narratives. And Western media has aggressively sought to impose its narrative through extreme measures, even to the extent of fueling unrest and bloodshed.

forensic report ruled out any foul play in the woman's death, attributing it to her underlying health issues. So, basically, the outcry in the West had nothing to do with women's rights per se. It was part of the "maximum pressure campaign" against Iran to bring about "regime change" in the country. It was an opportunity for the US and its allies to mount pressure on Iran and gain leverage in the ongoing nuclear deal talks.

Let's be honest about this. Many Western powers alongside the Israeli regime had a direct role in fanning the flames of riots in Iran in recent weeks. More than 40 foreign nationals were held by Iran's security agencies during the riots. A large cache of arms was supplied from the Iraqi Kurdistan region, which is the stronghold of Isareli spy agency. We saw against England last week, which they lost 6-2 - the worst defeat in two decades. Prior to the match, they didn't sing the national anthem, which created more headlines than the match itself. So, you can see what mattered to the Western media more"

fatal attacks on policemen and paramilitary Basiji forces, as well as destruction of public properties across the country, from Mashhad to Isfahan to Khuzestan. Even a popular shrine was attacked by Daesh and no Western leader condemned it.

#### Can you explain who the real opposition is and what their grievances are?

**SZM-** Not everything is hunky-dory in Iran, as I said, and we should not expect a sanctions-battered country to be an ideal place. People have many grievances and the government is duty-bound to resolve them. It cannot run away from its responsibilities. At least Iranians are not grappling with an energy crisis at the moment and not staring at a harsh winter, unlike European countries.

That brings us to the question of opposition. We should not look for an Iranian opposition outside Iran, something the Western leaders and the Western media want us to do. They have sought to project US-based monarchists loyal to the former Pahlavi dynasty, and terrorists affiliated with the MKO group based in Albania as the Iranian opposition. They don't represent Iranians. These groups have the blood of thousands of Iranians on their hands. They cannot be well-wishers of Iran or the people of Iran. So, they are and cannot be the real opposition.

The real opposition is within Iran, the ordinary people, who take pride in their country and its symbols, including the flag and national anthem. And this opposition is important to any democratic society. Their concerns are simple and legitimate - they want better lives, jobs, healthcare, and housing. They don't want so called regime change. This slogan belongs to the opposition that lives in far away West. And there is a total disconnect between them and the people in Iran. Western media props up the foreign-based opposition because their interests are aligned.

Forcible dress code is said to be an immediate trigger to recent unrest. Why do Iranian authorities enforce something which ideally

#### should be voluntary? Why this compulsion in the religious matter? Have Iranian clergy answered this burning question?

**SZM-**Iran is an Islamic Republic that was founded on the principles of Islam and the Islamic code of conduct. An overwhelming number of Iranians voted for this system in a referendum following the triumph of revolution in 1979. Hijab is one of the important elements in this school of thought and should not be seen as a symbol of oppression or subjugation, as scholars of Islam have long argued. A vast majority of women in Iran continue to voluntarily observe Hijab, not through force or coercion. Many don't observe it, let's be honest about it. I have been living in this country for the past 4 years, and I never saw a uniformed policeman rebuking a woman for not wearing a proper headscarf.

The tragic incident that triggered the unsavory turn of events recently could have been avoided. But it's sheer distortion of facts that she was beaten in police custody that caused her death. Scientific evidence does not support that claim. Having said that, there has been a long-running debate about introducing reforms in the modus operandi of the morality police. If Hijab is enforced or imposed, it will obviously backfire. There would definitely be reforms now, even though it is not an issue for Western regimes. All they seek is regime change in Iran, and that seems a far fetched idea.

## How different is the situation compared to 2009 when unrest erupted following controversial elections?

**SZM-** Many people and political pundits have drawn parallels between 2009 and 2022. The events in 2009 were triggered by allegations of vote-rigging by two prominent reformist figures - Mir-Hossein Musavi and Mahdi Karroubi - against then-president Mahmoud Ahmadinejad. The 2009 unrest however fizzled out quickly, unlike this time. Although deadly riots have now subdued in many parts of the country, the situation continues to be edgy and precarious with sporadic incidents

#### How do you see Iranian football team not singing the country's national anthem in Qatar? People outside Iran are baffled as in their countries this will be construed as treason. Is it the same case in Iran?

SZM-Football is a major obsession in Iran and footballers enjoy a massive fan following. In recent months, these players have been under tremendous pressure to support the antigovernment protests which I call riots, with unprecedented online bullying and abuse directed at them. They were even urged to boycott the national team and refuse to play in the FIFA World Cup 2022 in Qatar. This pressure campaign was part of the hybrid war bankrolled by hostile agencies and the paid media all coming together to attack the team through their online troll armies. It was evident when the team coach Carlos Queiroz was grilled by British media on the sidelines of the World Cup in Doha. He, however, knew how to shut them up.

These players - some of them play for top European leagues - even faced threats and that obviously played on their minds in their opening game against England last week, which they lost 6-2 - the worst defeat in two decades. Prior to the match, they didn't sing the national anthem, which created more headlines than the match itself. So, you can see what mattered to the Western media more. In other countries, not signing the national anthem in an international sports tournament may amount to treason, but Iranian authorities and people fully backed the team after the match. Iran's sports minister was stationed in Doha to look after the team. In the second match against Wales on Friday, the players sang the anthem with pride and won the match after a thrilling finish. It was the best answer to those who tried to de-legitimize and discredit them.

## **Vitamin B12 Deficiency Can Have Serious Consequences But Doctors Often Overlook It**

or several months during the summer of 2022, my dog Scout vomited at 3 am nearly every day. If you have a dog, you know the sound. And each time, she gobbled up her mess before I could get to it, making diagnosis of the cause difficult.

The vet and I eventually settled on my hydrangeas as the source of the problem but keeping Scout away from them didn't work. She started to seem tired all the time highly concerning in a typically hyper yellow Lab puppy.

Then one day Scout vomited up a hairball but not just any hairball. In dogs, hair normally passes easily through the digestive system, but this hairball was wrapped around a brillo pad that was too big to move through. Once this foreign object was removed, the overnight vomiting ended. Scout still needed treatment, though, for a different and surprising reason: The object had inhibited a step in her body's absorption of vitamin B12. B12 is an essential nutrient involved in proper functioning of blood cells, nerves and many other critical processes in the body.

I'm a registered dietitian, and I teach nutrition and food science to college students, but still I missed the B12 deficiency that was causing my puppy's fatigue. Doctors can just as easily be blind to it in people even though B12 deficiency is a common health problem that affects an estimated 6% to 20% of the U.S. population.

B12 is scarce in the diet, and it is found only in foods from animal sources. Fortunately, humans need only 2.4 micrograms of B12 daily, which is equivalent to one tenmillionth of an ounce a very, very small

amount. Without adequate B12 in the body, overall health and quality of life are negatively affected.

#### Signs and symptoms

One primary symptom of B12 deficiency is fatigue a level of tiredness or exhaustion so deep that it affects daily life activities.

Other symptoms are neurological and may include tingling in the extremities, confusion, memory loss, depression and difficulty maintaining balance. Some of these can be permanent if the vitamin deficiency is not addressed.

However, since there can be so many causes for these symptoms, health care providers may overlook the possibility of a B12 deficiency and fail to screen for it. Further, having a healthy diet may seem to rule out any vitamin deficiency. Case in point: Because I knew Scout's diet was sound, I didn't consider a B12 deficiency as the source of her problems.

#### How B12 is absorbed

Research is clear that people who consume plant-based diets must take B12 supplements in amounts typically provided by standard multivitamins. However, hundreds of millions of Americans who do consume B12 may also be at risk because of conditions that could be hampering their body's absorption of B12.

B12 absorption is a complex multistep process that begins in the mouth and ends at the far end of the small intestine. When we chew, our food gets mixed with saliva. When the food is swallowed, a substance in saliva called R-protein a protein that protects B12 from being destroyed by stomach acid travels to the stomach along with the food

Specific cells in the stomach lining, called parietal cells, secrete two substances that are important to B12



#### tion. One

is stomach acid it splits food and B12 apart, allowing the vitamin to bind to the saliva's R-protein. The other substance, called intrinsic factor, mixes with the stomach's contents and travels with them into the first part of the small intestine the duodenum. Once in the duodenum, pancreatic juices release B12 from R-protein and hand it to intrinsic factor. This pairing allows B12 to be absorbed into cells, where it can then help maintain nerve cells and form healthy red blood cells.

A B12 deficiency typically involves a breakdown at one or more of these points on the way to absorption.

#### Risk factors for B12 deficiency

Without saliva, B12 will not bind to the saliva's R-protein, and the body's ability to absorb it is inhibited. And there are hundreds of different drugs that can cause dry mouth, resulting in too little saliva production. They include opioids, inhalers, decongestants, antidepressants, blood pressure drugs and benzodiazepines, like Xanax, used to treat anxiety.

The last three categories alone account for easily 100 million prescriptions in the U.S. each year.

Another potential contributor to B12 deficiency is low levels of stomach acid. Hundreds of millions of Americans take anti-ulcer medications that reduce ulcercausing stomach acids. Researchers have firmly linked the use of these drugs to B12 deficiency although that possibility may not outweigh the need for the medication.

Production of stomach acid can also decrease with aging. More than 60 million people in the U.S. are over age 60, and some 54 million are over the age of 65. This population faces a higher risk of B12 deficiency which may be further increased by use of acid-reducing medications.

Production of gastric acid and intrinsic factor by the specialized parietal cells in the stomach is critical for B12 absorption to occur. But damage to the stomach lining can prevent production of both.

In humans, impaired stomach lining stems from gastric surgery, chronic inflammation or pernicious anemia a medical condition characterized by fatigue and a long list of other symptoms.

Another common culprit of B12 deficiency is inadequate pancreas function.

About one-third of patients with poor pancreas function develop a B12 deficiency.

And lastly, Metformin, a drug used by around 92 million Americans to treat Type 2 diabetes, has been associated with B12 deficiency for decades.

#### Treatment for B12 deficiency

While some health care providers routinely measure B12 and other vitamin levels, a typical well-check exam includes only a complete blood count and a metabolic panel, neither of which measures B12 status. If you experience potential symptoms of a B12 deficiency and also have one of the risk factors above, you should see a doctor to be tested. A proper lab workup and discussion with a physician are necessary to discover or rule out whether inadequate B12 levels could be at play.

In the case of my dog Scout, her symptoms led the vet to run two blood tests: a complete blood count and a B12 test. These are also good starting points for humans. Scout's symptoms went away after a few months of taking oral B12 supplements that also contained an active form of the B vitamin folate.

In humans, the type of treatment and length of recovery depend on the cause and severity of the B12 deficiency. Full recovery can take up to a year but is very possible with appropriate treatment.

Treatment for B12 deficiency can be oral, applied under the tongue or administered through the nose, or it may require various types of injections. A B12 supplement or balanced multivitamin may be enough to correct the deficiency, as it was for Scout, but it's best to work with a health care provider to ensure proper diagnosis and treatment.

## **One In Eight Older Adults Developed Depression For The First Time : Study**

pproximately one in eight older adults developed depression for the first time during the pandemic, according to a study conducted in Canada.

 $For those who \,had \,experienced$ depression in the past, the numbers were even worse, the study said. By the autumn of 2020 almost half (45 per cent) of this group of 20,000 older adults reported being depressed.

The researchers from University of Toronto analysed responses from the Canadian Longitudinal Study on Aging, whi ch collecter

"Health professionals need to be vigilant in screening their patients who had mental health problems at an earlier time in their life," said Birk.

The researchers identified several factors that were associated with depression among older adults during the pandemic, including inadequate income and savings, loneliness, chronic pain, trouble accessing healthcare, a history of adverse childhood ex-



low socioeconomic status during the pandemic.

"Many of these socioeconomic risk factors may have been exacerbated by the economic precarity of the pandemic, particularly for individuals with fewer resources. said co-author Margaret de Groh.

According to the study, individuals who experienced various dimensions of loneliness, such as feeling left out, feeling isolated, and lacking companionship had approximately 4 to 5 times higher risk of both incident and recur-

rent depression. "It is not surprising that the lock-down was particularly difficult for older adults who were isolated and lonely during the pandemic.

## **RBI** Pauses Onboarding **Of Online Merchants By Paytm Payments Services**

**NEW DELHI:** Banking regulator RBI has put a pause on onboarding of online merchants by Paytm Payments Services, even as the company said it will have no material impact on its business, according to a regulatory filing.

One97 Communications (OCL), which owns the Paytm brand, had proposed to transfer the payment aggregator services business undertaken by it to Paytm Payments Services (PPSL) in December 2020 to comply with payment aggregator (PA) guidelines of the Reserve Bank of India (RBI) but the banking regulator had rejected its application.

The company had re-submit-ted the required documents in September 2021.

Paytm said PPSL has now received a letter from RBI in response to an application for the authorisation to provide PA services for online merchants. As per the letter, PPSL is required to "Seek necessary approval for past downward investment from the company into PPSL, to comply with FDI Guidelines" and "not onboard new online merchants".

Paytm, in the regulatory filing, said it can resubmit the PA application within 120 calendar days. The company will not onboard new online merchants till the time approvals remain pending.

PAs are entities that facilitate e-commerce sites and merchants to accept various pay-



ment instruments from customers for completion of their payment obligations without the need for merchants to create a separate payment integration system of their own.

According to RBI's PAs guidelines, a single entity cannot continue to provide an e-commerce marketplace along with payment aggregator services and such payment aggregator services must be separated from the e-commerce marketplace business

Paytm further said there were no material observations from RBI and the move has no material impact on its business and revenues since the communication from the central bank is applicable only to onboarding of new online merchants.

"We can continue to onboard new offline merchants and offer them payment services including All-in-One QR, Soundbox, Card Machines, etc. Similarly, PPSL can continue to do business with existing online merchants, for whom the services will remain unaffected. We are hopeful of receiving the necessary approvals in a timely manner and resubmitting the application," Paytm said.

## **Key Changes In Capital Gains Tax Structure On The Anvil**

NEW DELHI: The Finance Ministry is looking at rationalising long-term capital gains tax structure by bringing parity between similar asset classes and revising the base year for computing indexation benefit to make it more relevant, an official said on Friday.

Currently, shares held for more than one year attract a 10% tax on long-term capital gains. Gains arising from sale of immovable property and unlisted shares held for more than 2 years and debt instruments and jewellery held for over 3 years attract 20% long-term capital gains tax.

The revenue department is now looking at rationalising the tax rates as well as holding period for calculating long-term capital gains and an announcement is likely in the 2023-24 Budget to be presented in Parliament on February 1. Also, a change in base year for computing inflation-adjusted capital gains is being contem-

plated, the official added. The index year for capital gains tax calculation is revised periodically to make it more relevant. The last revision took



year was updated to 2001.

Since the prices of assets increase over time, the indexation is used to arrive at the inflation-adjusted purchasing price of assets to compute long-term capital gains for the purpose of taxation.

"The whole effort is to make capital gains tax structure simple and tax-payer friendly and reduce compliance burden. There is scope for bringing parity in tax rates and holding periods for similar asset classes,"

#### Under the Income Tax Act, gains from sale of capital assets - both movable and immovable are subject to 'capital gains tax'. The Act, however, excludes movable personal assets such as cars, apparels and furniture from this tax. Depending upon the period of holding an asset, the long-term or short-term capital gains tax is levied. The Act provides for separate rates of taxes for both categories of gains. The method of computation also differs for both the categories.

## **SEBI Amends Norms,** Brings MFs Under Insider Trading Rules

NEW DELHI: Capital markets regulator SEBI has amended norms to bring buying and selling of mutual fund units under the ambit of insider trading rules. At present, insider trading rules are applicable to dealing in securities of listed companies or those proposed to be listed, when in possession of Unpublished Price Sensitive Information (UPSI). The units of mutual funds are specifically excluded from the definition of securities under the rules.

SEBI's latest decision follows the Franklin Templeton episode, in which the fund house's few executives were accused of redeeming their holdings in the schemes ahead of the six debt schemes shutting for redemption.

"No insider shall trade in the units of a scheme of a mutual fund, when in possession of unpublished price sensitive information, which may have a material impact on the net asset value of a scheme or may have a material impact on the interest of the unit holders of the scheme," SEBI said in a notification issued on Thursday. Under the new rules, asset

management companies (AMCs)



will have to disclose the details of holdings in the units of its mutual fund schemes, on an aggregated basis, held by the AMC, trustees and their immediate relatives on the platform of stock exchanges. "Details of all the transactions in the units of its own mutual funds... executed by the designated persons of asset management company, trustees and their immediate relatives shall be reported by the concerned person to the compliance officer of asset management company within two business days from the date of transaction," the regulator said.

Also, the SEBI has prescribed a minimum standard of code of conduct for designated persons in line with provisions of existing insider trading rules.

## **10 Trade Unions Boycott Finance Ministry's Virtual Pre-Budget Consultations**

NEW DELHI- Aj oint forum of ten central trade unions has decided to boycott the virtual pre-budget consultation with finance minister Nirmala Sitharaman on November 28, demanding a physical meeting with reasonable time to speak.

Pre-budget consultation is an annual exercise under which representatives of different sectors give suggestions and raise demands to be addressed through the Budget.

In a letter shot off on Friday, the forum stated, "Now your email dated November 25, 2022 under reference, makes it explicit that each central trade union will be allowed to speak for three minutes. This is a joke and we refuse to be part of such a cheap joke. We will not participate in the proposed video conference on November 28, 2022." Earlier on Friday, in a letter shot off to the finance ministry, the forum had jointly protested against a restricted video conference for pre-budget consultations.

"We are constrained to express our disappointment for



calling this meeting on virtual mode despite complete easing of Covid restrictions, and that to for 75 minutes only for consultation involving more than 12 central trade unions, may be more as indicated by the invitation letter. As per the labour ministry's physical verification,

there are 12 central trade unions in our country. That means less than five minutes or even less for each organisation, if time for customary opening remarks is taken into account," they forum

#### had stated.

Later on Friday, the forum received another letter from the finance ministry stating that each participating central trade union will be allotted three minutes to

make their suggestions. In response to the letter, the forum shot off another letter on Friday and stated that the CTUs therefore have decided to boycott the proposed video confer-

ence. The forum also urged the finance ministry "to seriously reconsider convening of a physical meeting with reasonable timeallotment for effective consultations in the pre-budget meeting with the trade unions." The

forum also invited the finance minister for an open debate about these policies without any time restrictions on her to defend policies followed by her.

The ten trade unions which form the forum are INTUC, AITUC, TUCC, SEWA, HMS, CITU, AICCTU, LPF, AIUTUC and UTUC. There are about a dozen central trade unions in the country, including Bhartiya Mazdoor Sangh (BMS). The BMS is not part of the joint forum.

## **Forex Kitty Grows For 2nd Consecutive Week; Rises** \$2.54 Bn To \$547.25 Bn

MUMBAI: In the second consecutive week of an increase in the kitty, India's forex reserves have grown by USD 2.537 billion to USD 547.252 billion for the week ended November 18, the RBI said on Friday.

In the previous reporting week, the overall kitty had swelled by USD 14.721 billion in the highest weekly rise since August 2021 to USD 544.715 billion.

It can be noted that in October 2021, the country's forex kitty had reached an all-time high of USD 645 billion. The reserves have been declining as the central bank deploys the kitty to defend the rupee amid pressures caused by global developments.

Foreign currency assets (FCA), a major component of the overall reserves, increased by USD 1.76 billion to USD 484.288 billion during the week to November 18, according to the Weekly Statistical Supplement released by the RBI on Friday.

Expressed in dollar terms, the

foreign currency assets include the effect of appreciation or depreciation of non-US units like the euro, pound and yen held in the foreign exchange reserves.

The gold reserves increased by USD 315 million to USD 40.011 billion, it said.

The Special Drawing Rights (SDRs) were up by USD 351 million to USD 17.906 billion, the apex



bank said.

The country's reserve position with the IMF was also up by USD 111 million to USD 5.047 billion in the reporting week, the apex bank data showed.

## Shirdi's Saibaba Temple **Gets Tax Exemption Of** ₹175 Cr. Here's Why

PUNE- The Sri Saibaba Temple Trust of Shirdi has been exempted from the payment of income tax of ₹175 crore levied in the last three years, its officials said on Friday. The exemption was granted following a Supreme

Court order, it said in a release.

While assessing the tax for the year 2015-16, the Income Tax Department assumed that Shri Saibaba Sansthan was not a religious trust but a charitable trust, and levied 30 percent income tax on the donations received in the donation box and issued a tax payment notice of ₹183 crore," it said.

The trust then filed a writ petition in the Supreme Court which "ordered a stay on the tax payable till the determination of tax," it said.

The Income Tax Department finally granted it exemption from the tax levied on the donation in the donation box, accepting the Shree Saibaba Sansthan as a religious and charitable trust.

Thus, Sri Saibaba Sansthan has been exempted from income tax of Rs175 crore levied in the last three vears." said the release.



## **Ukraine Works To** Restore Water, Power After Russian Strikes

**Kviv:** Ukrainian authorities endeavoured on Saturday to restore electricity and water services after recent pummelling by Russian military strikes that vastly damaged infrastructure, with President Volodymyr Zelenskyy saying millions have seen their power restored since blackouts swept the war-battered country days earlier.

Skirmishes continued in the east and residents from the southern city of Kherson headed north and west to flee after punishing, deadly bombardments by Russian forces in recent days.

The strikes have been seen as attempts at Russian retribution against Ukraine's beleaguered but defiant people after Ukrainian troops over two week ago liberated the city that had been in Russian hands for many months.

"The key task of today, as well as other days of this week, is energy," Zelenskyy said in his nightly televised address late on Friday.

"From Wednesday to today we have managed to halve the number of people whose electricity is cut off, to stabilize the system.

He said, however, that blackouts continued in most regions. including Kyiv, the capital.

"In total, more than 6 million subscribers are affected. On Wednesday evening, almost 12 million subscribers were cut off," Zelenskyy added.

He allowed himself a rare show of pique about how Kyiv

authorities were faring, alluding to "many complaints" with the rollouts of "points of invincibility" public centers where residents can stock up on food, water, battery power and other essentials in the capital.

"Please pay attention: Kyiv residents need more protection." he said. "As of this evening, 600,000 subscribers have been disconnected in the city. Many Kyiv residents were without electricity for more

than 20 or even 30 hours." "I expect quality work from the mayor's office," he said, alluding to the administration of Mayor Vitali Klitschko.

The president and the mayor have sporadically sparred since Zelenskyy took office in 2019. has accused Zelenskyy Klitschko and officials around him of corruption, while Klitschko contends the president's office has put him under political pressure.

Early Saturday, the Kyiv municipal administration said water connections had been restored throughout the city, but that about 130,000 residents remain without electricity.

City authorities said on Saturday morning that all power, water, heating and communication services would be restored within 24 hours.

The scramble to restore power came as Belgian Prime Minister Alexander De Croo met on Saturday with Zelenskyy in Kyiv. De Croo tweeted that

Belgium was "releasing new humanitarian and military aid," but gave no immediate details.

## Legitimate Right And Duty Of Every Citizen To Prevent Constitution From **Being Abused: Justice K M Joseph**

New Delhi: Supreme Court judge K M Joseph on Saturday said it is the legitimate right and duty of every citizen of the country to prevent the Constitution from being abused. He said each generation of citizens is duty-bound to remain

alert and safeguard the core values that the Constitution seeks to uphold and promote. Speaking at the valedictory function of the Constitution Day

celebrations at the Supreme Court, Justice Joseph said the adoption of the Constitution on January 26, 1949 marked the culmination of a long but uniquely peaceful struggle of millions, who stood shoulder to shoulder burying their differences based on religion, caste and the regions they hailed from. He said Article 51(A)(B) of the

Constitution declares it to be the duty of every citizen to cherish and follow the noble ideals that inspired India's freedom struggle. "Article 51 of the Constitution

declares that it is a fundamental duty for every citizen to promote harmony and the spirit of common brotherhood amongst all the people of India, transcending every religion, linguistic, regional or sectional diversity, and renounce practices derogatory to the dignity of women," Justice Joseph said in his welcome address at the function where

the chief guest. Addressing a large gathering of judges of the Supreme Court, high courts and district courts and lawyers, Justice Joseph said



the Constitution is a fine document as much as it is a noble document and an instrument.

"The Constitution of the country constitutes the chief mechanism for ordering the life of the nation and is not a mere document. It is the people who are charged with the duty of operating the Constitution, who alone can give a life to it. Each generation of citizens is duty-bound to remain alert in order to safeguard the core values that the Constitution seeks to uphold and promote.

"It is the legitimate right and duty of every citizen in every walk of life to prevent the Constitution from being abused.... Fraternity is one of the most-cherished ideals firmly enshrined in the preamble to the Constitution," he said.

Justice Joseph said the Constitution contemplates that India will be a secular country and envisages liberty as a fundamental norm.

"Liberty of thought, expression, belief, faith and worship are not merely words appropriately proclaimed in the preamble but they are meant to ignite

the minds and hearts of every citizen at all points of time, wherever they are," he said.

He added that while the country has achieved commendable progress, "we have a long way to go to fulfil the hopes and aspirations of the founding fathers of the Constitution".

Justice M R Shah, who delivered the vote of thanks, said unity in diversity is the identity of India.

"It is not just an ordinary day, but a day when we celebrate our rights and reaffirm our duties to make a commitment that the three pillars of the government of India will adhere and uphold the principles enshrined in our Constitution. It is said that even in a dictatorial government, there might be a Constitution but not necessarily constitutionalism," he said.

Justice Shah said like every judicial officer who has a picture of the preamble to the Constitution in his office, he would like to urge all the citizens to read the preamble in their native language at least once and if possible, keep a picture of it in their homes.

"This will remind them of the efforts that our freedom fighters had made to make India a sovereign, socialist, secular, democratic and republic country. It will also remind everyone of their fundamental rights and duties and let us create a constitutional culture that every citizen is aware of their rights which are vested upon them by the Constitution," he said, adding that the time has come to remind the citizens of their duties towards the nation.

### **Restoration Of Mumbai's Century-Old Museum Wins UNESCO** Asia-Pacific Award

New Delhi: The "heroic" restoration of the historic Chhatrapati Shivaji Maharaj Vastu Sangrahalaya in Mumbai has won a top award from UNESCO, with the jury hailing it as a project that "sets a standard" for the conservation of world heritage monuments.

The 100-year-old museum, part of the Victorian Gothic and Art Deco Ensembles of Mumbai's world heritage property, has received the Award of Excellence in this year's UNESCO Asia-Pacific Awards for Cultural Heritage Conservation that were announced on Saturday.

UNESCO Bangkok, in a statement, said, "The jury applauded the museum project for restoring 'a major civic institution in the historic city of Mumbai'.

"The jury noted, 'impressive in its scale, the project addressed extensive deterioration through well-informed architectural and engineering solutions, overcoming major challenges during the pandemic'". "The jury further remarked,

'executed to the highest level of technical excellence, the project sets a standard for the conservation of World Heritage monuments in India and beyond'," it said. The "heroic" restoration of

the Chhatrapati Shivaji Maharaj Vastu Sangrahalaya has received the Award of Excellence in this year's UNESCO Asia-Pacific Awards for Cultural Heritage Conservation, the statement said.

Chhatrapati Shivaji Maharaj Vastu Sangrahalaya was established as the Prince of Wales Museum of Western India in 1922.

Thirteen projects from six countries Afghanistan, China, India, Iran, Nepal and Thailand have been acknowledged for awards by an international jury in this year's awards programme.

Jury deliberations were carried out in November 2022 when members reviewed 50 entries from 11 countries from the Asia-Pacific region.

Besides, the Domakonda Fort of Telangana, and Byculla Station of Mumbai, are among the winners in the Award of Merit category, while the stepwells of Golconda in Hyderabad has won an award in the Award of Distinction category.

Topdara Stupa, Charikar, Afghanistan, and Nantian Buddhist Temple, Fujian, China, have also received the Award of Merit, the statement said.

"The awards give people a sense of pride and sense of ownership of their own heritage," Feng Jing, the Chief of the Culture Unit at UNESCO Bangkok, was quoted as saying in the statement.

Since 2000, the UNESCO Asia-Pacific Awards Cultural for Heritage Conservation programme has been recognising the efforts of private individuals and organisations in restoring, conserving, and transforming structures and buildings of heritage value in the region.

"In 80 per cent cases in this category, the families of these potential terrorists inform the JKP and security forces about their doubtful activities, and we have been able to bring back 13 of them in 2022, some even after joining the ranks," another senior officer said.

"We can tell you that denying social sanction to terrorists, their activities and radicalisation activities will usher peace in Kashmir," the officer said.

According to latest police data, there were 99 local recruitments in terrorist ranks in Kashmir this year, an all-time low over the last six years.

Out of these, 64 were killed and 17 arrested, the data said.

The comparative figures are: 136 in 2021, 167 in 2020, 140 in 2019, 201 in 2018, 147 in 2017 and 95 in 2016. Maximum local terrorists, according to data, are killed within a month of their joining the terror ranks while some are neutralised in two to three months. Twenty-nine civilians were killed by terrorists this year and these included three Kashmiri Pandits and Hindus each, 15 Muslims, apart from six non-local Hindus and two non-local Muslims. The officials said security situation in the Valley has improved "drastically" as there have been "no bandhs, no major internet shutdowns, no stone pelting incidents and zero killings of civilians" during operations of the security forces post the abrogation of Article 370 in 2019. A total of 169 terrorists (127 local terrorists and 42 foreign terrorists) have been killed in Kashmir this year, the data said.

(9.1%), stomach (9.0%), breast (6.0%), and colon (3.8%).

"Compared with that, the top five cancers reported from our center in 2012 were esophagus and gastroesophageal junction (17.2%), lung (11.9%), stomach (9.7%), colorectal (7.1%), and breast (6.5%)," the study has observed.

The study further added that Prostate cancer was reported in 3.4% of cases, which was much higher than that reported in 2012 (1.7%). Surprisingly, thyroid cancer (6.4%) was the fourth commonest cancer reported in females, while it did not figure in the top 10 cancers in the 2012 report. "Expectantly, cervix cancer did not figure among the top 10 cancers in women," reads the study.

Underlining the reasons behind sudden rise in cancer in Kashmir, the study observed that among all sedentary habits, a special type of tobacco use (hookah smoking) is one of the main factors behind lung cancer in the region.

"In this region, besides cigarette smoking, we have a popular tradition of hookah (hubble bubble) smoking, where smoke is inhaled after it passes through the water placed in an earthen container through which it gets filtered and cooled. This is also one of the important causes of passive smoking of family members, especially during winters. Because smoking is not popular among females in this region, it justifies the fact that lung cancer is not common in females," the study reveals.

Besides Hookah smoking, the study has also pointed towards use of a unique type of heating device (kangri) which is considered to be the major risk factor for the digestive tract, lung, and skin cancers seen in this region.

"However, the most notable observation made in this study is that of esophageal cancer. It was previously the most common cancer type since the cancer data were available in the valley and is now showing a declining trend.... However, other digestive tract cancers such as those of the stomach, gastroesophageal (GE) junction, colon, and rectum have shown a gradual increase and continue to be amongst the top 10 cancers monitored during the

The JKP officials said their main area of concern in Kashmir is terrorists picking up "soft targets" like labourers coming from other states and Kashmiri Pandits, while they also have "detected" some women over ground workers (OGWs) assisting im some recent terrorist activities.

'We have, however, ensured that those who target labourers and members of the Pandit community are neutralised immediately and also that they are not kept safe as much as possible," a senior officer said.

Another concern for the police is the recent seizure of some Turkeymade pistols from terrorists, which they said is an indicator that Pakistanbased handlers are providing weapons of that country to ultras operating in Kashmir.

The officer said there is also a fourth category of ultras in Kashmir whom they categorise as "potential terrorists.'

These are those who are radicalised, have joined or about to join the terrorist ranks but have not undertaken a

Slovenia: Slovenia's ruling Freedom Movement party (GS) said Saturday it had decided to stop using Twitter over concerns the social network was being used to spread fake news and hate speech.

"Considering the behaviour and announcements by Twitter's new owner and management, we can expect they will further open its doors to indecent communication and hate speech," GS said in a statement, referring to the platform's recent takeover by billionmer conservative prime minister Janez Jansa. Jansa, an avid user of Twitter

with over 100,000 followers in a country of two million, used the platform to attack critics and media -- while Golob said he would not use Twitter "to avoid the temptation of fast fingers".

The GS - which holds 41 of the 90 seats in parliament - said its Twitter account had been blocked for three weeks due to technical problems and over time it had realised it did not need it to efficiently address citizens.

## World Cup Fans In Qatar **Introduced** To Islam

DOHA: The Katara Cultural Village Mosque in Qatar's capital of Doha has become the focus of attention for World Cup fans who want to get to know about Islam.

Multilingual male and female preachers at the mosque explain the religion and tolerance of Islam to tourists. Electronic boards about Islam in more than 30 languages at the door are positioned to allow visitors to view them on their phones. And booklets introducing Islam in different languages are distributed to those who want them.

The Ministry of Awqaf and

Islamic Affairs in Qatar also launched a pavilion to introduce Islam and its teachings during the World Cup 2022.

World Cup fans encounter hadiths -- words, actions or habits of Prophet Muhammad -- on the walls of streets, describing the importance of good deeds.

The opening ceremony of the FIFA World Cup 2022 was last Sunday at the Al Bayt Stadium in Al Khor.

UNITED NATIONS: At least 50.000 migrants died while undertaking risking journeys in search of a "better life" across the world since 2014, according to the International Organization for Migration (IOM), a Geneva-based UN agency. The tragic milestone was con-

firmed in a new IMO report on Missing Migrants Project, which also maintains that little action had been taken by any country of origin, transit or arrival.

"While thousands of deaths have been documented across migration routes each year, very little has been done to address the consequences of these tragedies, let alone prevent them," Julia Black, co-author of the study, said in a statement.

The nationality for over 30,000 people in the Missing Migrants Project is unknown, which means that more than 60 per cent of those who die on migratory routes remain unidentified. Thousands of families are left "searching for answers," IOM said.

"As time goes by, there is no news," IOM said, quoting a Moroccan migrant in Spain in 2021 who was searching for his brother who disappeared 20 years ago on route to Europe.

Of the missing migrants whose nationality could be identified, more than 9,000 were from Africa. over 6.500 from Asia and another 3,000 from the Americas.

"Notably, the top three countries of origin – Afghanistan, Syria and Myanmar - are marked by violence, with many people fleeing their homes to seek refuge abroad", IOM said.

More than half of the 50,000 individual deaths documented occurred on routes to and within Europe, with Mediterranean routes claiming at least 25,104 lives.

European routes also make up the largest number and proportion of missing and presumed dead migrants, with at least 16,032 recorded missing at sea and whose remains have never been recovered.

Africa is the second-deadliest region for people on the move, with more than 9,000 migrationrelated deaths documented since 2014. Regional household surveys indicate that these figures are almost certainly a vast undercount.

And in the Americas, nearly 7,000 deaths have been documented, 4,694 of whom were heading to the United States. The US-Mexico land border crossing alone has seen more than 4,000 deaths since 2014.

IOM has also documented an-

other 6,200 deaths across Asia. "Children make up more than 11 per cent of the lives lost on migratory routes in Asia, the highest proportion of any region", according to the report.

It noted that of the 717 recorded child deaths linked to migration in the region, 436 were Rohingya refugees.

In Western Asia, at least 1,315 lives have been lost on migratory routes, many of which occurred in countries with ongoing conflicts, which make documentation of the missing extremely challenging.

At least 522 people arriving from the Horn of Africa have died in Yemen - often victims of violence - and 264 Syrian deaths have been documented during attempts to cross the Türkiye border. IOM stressed that "obligations under international law,

including the right to life, must be upheld at all times". The UN agency called for in-

ternational solidarity in prioritizing search and rescue operations; improving and expanding regular and safe migration pathways; and ensuring that legislation prioritizes the protection and safety of people on the move.

"Regardless of the reasons that compel or drive people to move, no one deserves to die in search of a better life", IOM's Ms. Black said.

## In A First, Self-Driving Bus Experiment Begins In South Korea Capital

South Korea's capital launched its first self-driving bus route on Friday, part of an experiment that engineers said aims to make people feel more comfortable with driverless vehicles on the roads.

The new vehicle does not look like a regular bus and has rounded edges as well as large windows that make it appear more like a toy than a technological breakthrough. This design is intentional, said Jeong Seong-gyun, head of autonomous driving at 42 Dot, the start-up responsible for the selfdriving technology that is now owned by auto giant Hyundai.

"This is the future," he told AFP, adding that the bus required "a considerable new type of design". The bus looks a bit "like Lego"

and is made of composite parts to help keep costs down and make it easy to replicate, he said. It uses cameras and radar to

sensors, Seong-gyun pensive added. The company's goal was to

make the technology low-cost, safe and easily transferable to many types of vehicles in the future, for example, delivery trucks.

For now -- with a safety driver monitoring closely -- the bus will drive itself around a small 3.4-kilometre (2.1-mile) circuit in downtown Seoul that takes around 20 minutes.

The public can board at two designated stops after booking a free seat through an app.

"I feel like I've just hopped into a time machine to visit the future," said Kim Yi hae-ran, 68, after her 20-minute ride during the launch of the bus Friday.

"I thought it might make me dizzy from a sudden acceleration but I didn't feel any of it."

The ride felt "very smooth and safe", which she said made her feel proud of the technological progress the South Korean company has made.
