'JeM CONSPIRACY CASE' **NIA Court Sentences 5 Convicts to Life In Jail**

New Delhi: A Delhi court on Monday awarded life imprisonment to five members of the Jaishe-Mohammad (JeM) for recruiting and training youths for terror activities across the country.

Special Judge Shailender Malik awarded the jail term to Sajjad Ahmed Khan, Bilal Ahmed Mir, Muzaffar Ahmed Bhat, Ishfaq Ahmed Bhat and Meraj-ud-din Chopan after they pleaded guilty in the case.

The judge also awarded a five-year jail term to Tanveer Ahmed Ganie in the case. The judge noted that all

the convicts were in conspiracy with each other to wage war against India.

It said that the convicts were "not only members



of JeM but they have been supporting/harbouring terrorists/members of JeM by providing them arms/ ammunition, logistic supports and explosives."

"The accused were also involved in enticing/ mo-

tivating locals of Jammu & Kashmir to go into militancy and arranging funds, etc. for carrying out terrorist acts and therefore they all are liable to be convicted for offence u/s 120B IPC as well as u/s 18 of UA(P)

Act," the judge said. The NIA lodged an FIR in March 2019 and started the investigation. The probe agency said

the convicts were trained by Pakistan-based JeM operatives to do reconnaissance of targets, arrange hideouts, and provides logistical support to terrorists and to carry out terror attacks in India.

The court noted that Mufti Abdul Rauf Ashgar, the brother of JeM chief Maulana Masood Azhar. along with other senior commanders of the JeM entered into a larger con-

Can People With A Family History Of Colorectal Cancer Reduce Their Own Risk

n India, colorectal cancer, which first appears in the colon or the rectum, is the sixth most prevalent cancer to cause mortality. It generally affects older persons and happens when colonic cells become uncontrolled (above 45 years). The polyps that originate inside the colon are typically the precursors to this type of cancer.

Over time, these polyps develop into cancerous cells. A tumour forms when the DNA of the colon's healthy cells mutates and the cells build up together. These cancer cells expand over time, invading neighbouring healthy tissue and wreaking havoc.

Although there is no known cause of colorectal cancer, those without a family history of the disease account for the majority of cases. However, one in three individuals with the illness also has a parent, brother, or kid who has experienced colorectal cancer.

This increases the risk for those who have had colorectal cancer in the past. The causes of the increased risk are not always evident, although the risk is higher if more than one parent, sibling, or child is affected by cancer or if their relative had cancer when they were younger than 50.

You should talk to your doctor and ask about the necessity to begin screening before the age of 45 if you also have family members with adenomatous polyps or a history of them. If you have had colorectal cancer, you should tell your close family so they can begin screening Colorectal cancer presents several symptoms and risk factors which can help in identifying it early.

These include- Symptoms

Constant changes in bowel habits diarrhoea or constipation and modifications in stool Blood or rectal bleeding stool

Persistent discomfort in the abdomen such as cramps, gas or pain Fatigue or weight loss

The symptoms of Colorectal cancer vary from patient to patient in terms of size, and location in the large intestine. Several people with colon cancer do not experience any symptoms in the early stages of the disease.

Risk Factors

Old age - While colon cancer can be diagnosed at any age but it is mostly found in people above the age of 50 years. There is no specific cause behind the diagnosis as the number is also increasing among young people. Personal History - If you have al-

ready had colon cancer or non-cancerous polyps then you are at a greater risk of getting colon cancer in future.

Inflammatory intestinal conditions

- It includes diseases like Crohn's disease and ulcerative colitis that can increase your risk of colon cancer.

Inherited Syndromes - A very small percentage of colon cancers are caused due to inherited syndromes like Familial Adenomatous Polyposis (FAP), and Lynch syndrome, which is also known as Hereditary Nonpolyposis Colorectal Cancer (HNPCC).

Family History - The risk of Colorectal cancer increases if you have a blood relative who has had the disease. If more than one family member has colon cancer then the risk is even greater.

Sedentary Lifestyle - People who are inactive or adopt a high-fat or low-fibre diet are at an increased risk of colon cancer. Alcohol consumption and heavy smoking put you at higher risk. Following a healthy lifestyle and getting regular physical activity can reduce your risk.

Type 2 Diabetes - Patients with type 2 diabetes (non-insulin-dependent) have an increased risk of colorectal cancer.

Obesity - People who are obese are at increased risk and have less favourable outcomes compared to people with normal weight.

Radiation therapy - This therapy when directed towards the abdomen to treat previous cancers increases the risk of colon cancer How can you prevent yourself from colon cancer?

responsible for dozens of violent attacks and hundreds of deaths across Pakistan since emerging in 2007.

"As military operations are ongoing against mujahideen in different areas .. so it is imperative for you to carry out attacks wherever you can in the entire country," it said in a statement.

On 27 November, 78 individuals took legal action against the former US officials and registered their case at the Federal Court of Appeal in Baghdad. Among those who took legal action is Muhandis' brother, Muhammad Hassan Jaafar al-Muhandis.

The IRGC and PMU generals were assassinated on 3 January 2020 in a US drone strike near Baghdad's International Airport. Two days after the attack, local lawmakers ratified a bill demanding the withdrawal of foreign presence led by the US and its allies

In recent months, the IRGC has launched several attacks against Kurdish militant groups residing in Iraq's autonomous Kurdish Region (IKR), calling



on the government in Baghdad and Erbil to expel the armed separatist groups fueling violence in the streets of Iran.

In addition, the commander of Iran's Islamic Revolutionary Guard Corps ground force, General Muhammad Pakpour, announced that troops would be sent to the country's Kurdish border regions to prevent "the infiltration of terrorists" from the Iraqi Kurdistan Region (IKR).

"Some armored units and special forces of the [IRGC] ground forces are currently heading to the border provinces in the west and northwest of the country," Pakpour said.

456 'Crorepati' Candidates **Contesting In Gujarat Assembly Elections: Report**

AHMEDABAD: As many as 456, or around 28 per cent, of 1,621 candidates contesting the upcoming Gujarat Assembly elections are 'crorepatis' who have declared assets worth ₹1 crore or more, the Association for Democratic Reforms (ADR) said on Monday.

The BJP tops the list with a total of 154 'crorepati' candidates, followed by Congress with 142, and AAP has 68. The average asset of candidates in the fray is ₹2.56 crore, the ADR report informed.

Bharatiya Janata Party's Jayanti Patel, contesting from the Mansa seat in Gandhinagar, is the richest candidate with declared assets of ₹661 crore, followed by BJP's Balvant Rajput of Sidhpur with ₹372 crore and Aam Aadmi Party (AAP)'s Ajitsinh Thakor, who is contesting from Dabhoi seat, with declared assets of ₹342 crore.

There are 221 'crorepatis' among the 788 contestants in the fray for the first phase of elections for 89 seats scheduled on December 1.

The number of such candidates stands at 245 out of the total 833 contestants in the fray for the 93 seats that will go

to polls in the second and final phase on December 5, as per the ADR report.

It said six candidates in the fray have declared "zero" assets, while another six have said their assets are worth less than ₹10,000.

Jayanti Patel, the richest candidate as per the ADR report, also has the highest liability at ₹233 crore.

In terms of educational qualifications, 42 candidates have declared themselves to be illiterate, 85 "just literate", while 997 have said they have studied between Classes 5-12. 449 candidates are graduates.

Informing about the age profile, the ADR report said two candidates are above the age of 80, 197 are between 61-80 years of age, 861 are between 41-60 and 561 in the 25-40 age group segment.

The report claimed a "close and alarming nexus" between money and muscle power hurt the principles of free and fair elections, 'participatory democracy' as well as the 'level playing field'.

"The present circumstances, therefore, demand an extensive deliberation by the voters so that the sanctity of elections is not ridiculed by the tenacious entry of tainted candidates and candidates with abnormal multiplication of assets," it said.

Driver Gives Lift To Men For Money. They Use Chilli **Powder To Steal SUV**

NOIDA: Two men, who allegedly robbed an SUV in Delhi on pretext of taking a lift and then overpowering its driver by using chilli powder, have been arrested by the Noida police, officials said on Monday. The car, a Tata Harrier belonging to a Noida Sector-93 resident who works in Delhi, was being driven by a driver who had offered ride to four strangers in return for money, an official said.

The strangers had entered the car in Noida and had gone to Delhi when they rubbed chilli powder on driver's eyes and overpowered him, before taking the vehicle towards Gurugram, Haryana where they dumped him, the official said, citing the FIR.

Two accused have been arrested and the car has also been recovered, Additional Deputy Commissioner of Police (Central Noida) Saad Miyan Khan said.

"A zero FIR was lodged in the case that took place in Delhi on September 23. The case was later lodged at the Noida Sector 20 police station. Further, officials at Phase 2 police station got a tip off about the suspects being in their area and nabbed them on Sunday," Mr Khan said.

Two of the suspects -Roshan Mishra and Anil Kumar - have been arrested while two more of their partners are yet to be caught, the officer said.

According to police, a normal first information report (FIR) has to be lodged at a police station in whose area of jurisdiction a crime is committed. But in case of a "Zero FIR", the complaint can be filed in any police station irrespective of the area of jurisdiction and it is later transferred to the appropriate police station for action.

The accused have been booked under Indian Penal Code sections 393 (robbery), 411 (receiving property dishonestly) and 34 (crime done by several people with common intention), the police said.

Charles Darwin's Signed Document To Go For Auction, **Could Fetch ₹9 Crore**

otheby's in New York will soon auction a document that Charles Dar-Swin signed and which supports his theory of evolution. The letter is anticipated to sell for over 1 million pound (Rs 9,85,21,780), a record price for a Darwin manuscript, as per the BBC.

There isn't much original Darwinian writing left because he didn't regularly archive his work. "If it does, and it's signed, it's almost always just with the abbreviated "C Darwin" or "Ch Darwin. It's very rare to have his name, "Charles Darwin", written out in full and in his own hand," the website states.

However, Professor John van Wyhe, the curator of the academic database known as Darwin Online, claims that it is particularly special because of what the great man chose to include on the page in addition to his signature.

"He includes a passage that appears in the third edition of On the Origin of Species. It's a really favourite passage, because he's trying to make the point that people might find his theory unbelievable and outlandish, but they said the same about Newton and gravity, and



nobody doubted the existence of gravity anymore. The same, he says, would be true eventually with evolution and natural selection," the professor told BBC.

The document was produced for The Autographic Mirror magazine. Hermann Kindt, its publisher, also printed facsimiles of famous people's autographs or handwriting alongside their biographies. Darwin jumped at the chance when he was asked if he would contribute. It was a chance for him to refute his critics, the outlet states.

According to the BBC, the letter reads, "I have now recapitulated the chief facts and considerations, which have thoroughly convinced me that species have been modified, during a long course of descent, by the preservation or the natural selection of many successive slight favourable variations.

AGuH Terror Module Busted In Sopore: Police

SRINAGAR: Police on Monday claimed to achieved a major breakthrough by busting a module of AGuH in Sopore by arresting the group's handler for north Kashmir besides four over-ground workers as well.

In a statement issued here, a police spokesperson said that upon an information by sister agency regarding movement of main terrorist handler, Sopore Police alongwith 22RR established an MVCP grid in Sopore. During MVCP, he said, two individuals identified as Mushtaq

Ahmed Bhat an alleged handler of Chanapora, Srinagar and Ishfaq Ahmed Shah resident of Budgam were arrested.

He further said incriminating material, arms and ammunition including 01 Pistol, 01 Magazine, 10 rounds and 3 Grenades was recovered from their possession.

On further interrogation and development of the information, the spokesperson said 2 more terror associates identified as Abdul Majeed Kumar resident of Bernate, Boniyar and Abdul Rashid Kumar resident of Pattan were also arrested. Besides incriminating material, he said, 1 Pistol, 1 Magazine, 10 rounds and 11 Grenades were recovered from their possession.

"Preliminary investigation revealed that the busted terrorist module of AGuH was being handled by Ahsaan Dar and one individual named Chaudhary from across the border (PoK), the spokesperson said.

"The module was instructed to ensure continuous supply of arms & ammunition in Kashmir Valley for conducting attacks on outsiders, civilians and Security Forces to instil fear in the minds of general public. The timely and effective action by Sopore police and 22RR by busting the terrorist module have resulted in averting a possible major tragedy," he added.

Meanwhile in Awantipora, the spokesperson said, Police along with 42 RR and CRPF recovered arms & ammunition including 202 AK rounds, 03 detonators, 7.62 mm 26 rounds, 02 rounds of Insas wrapped in Polyethene hidden under boulders at Bund Lalgam area of Awantipora.

3-Month Training Programme Started For Youth Aspiring To Join Forces In Samba

JAMMU: Authorities in Samba district of Jammu and Kashmir has started a three-month programme to train the unemployed youth desirous to pursue career in Army, paramilitary, police and allied forces, an official

said on Monday. Over 500 candidates have been shortlisted in the district to undergo the training programme, being conducted in collaboration with Mission Youth J&K, at each block

headquarter, the official said. The official said the physical test of desiring candidates by a team of doctors and physical education teachers

was conducted at the block development offices concerned under district youth training and empowerment program.

"Samba youth are traditionally attracted towards belt forces and it was their strong demand to provide for such a training programme," Deputy Commissioner, Samba, Anuradha Gupta said.

She said the programme which is funded under mission youth, envisages imparting of physical and academic coaching by professional trainers and constructive channelizing of the energies of youth through activities like sports, yoga, recreation, meditation, career counselling and drug de-addiction. Gupta said the training will be imparted to youth at centres established across different blocks of the district.

These centres would essentially include one sports ground for activities to improve the physical endurance of the candidates and one academic centre for imparting academic skills, she said.

She said retired Army men and other professionals appointed under the programme will impart physical training, while academic counsellors will train youth in academics required to face the recruitment examination.

Gujarat Polls

lthough it looks certain that the BJP will win again in Gujarat despite being in power for 27 years, the AAP's entering the fray has added a dash of drama to the poll scene. The AAP leader Arvind Kejriwal may not have rattled the game in the state but he has emerged as a conspicuous presence and unlike Congress has been able to set an alternative political discourse. For example, the BJP has been forced to react to his narrative about improving schools and healthcare facilities. But this hardly means that the BJP is on the defensive. In Gujarat, Modi remains the overarching leader, a son of the soil. Besides, the BJP's ideology, Hindutva is now the reigning creed which all parties grudgingly or otherwise nod to.

Kejriwal, once a proponent of the so called post-ideological politics in the country, has chosen to rebrand himself as a Hindu leader. And as he tries to expand into Gujarat and looks set to step into the vacuum of a national opposition party left behind by a depleting Congress, his nods to the BJP's ideological vision have become more noticeable.

There is now almost a tacit consensus on Hindutva in the country. And this makes the BJP even stronger as the party remains the sole authentic purveyor of the ideology. And no matter how much other parties hew closer to the BJP creed, they will always be seen as counterfeit, opportunistic copies of the original.

Despite a widely shared foregone conclusion about the outcome of Gujarat polls, a triangular context between the BJP, the AAP and the Congress has made Gujarat a centre of media attention. Congress has undergone some rejuvenation with the Rahul Gandhi's padyatra which has drawn both attention and participation. But whether it translates into votes for the party remains a moot point. Congress is also reported to be mobilizing people in rural Gujarat where the BJP is believed to be not as strong as in urban areas. It will be interesting to see how ther AAP and the Congress eventually fare in Gujarat. In any case, the outcome of the elections in Gujarat will set the stage for 2024. So far, there is not a distant sign that even a combined opposition is in a position to take on the BJP. But then two years is a long time in politics. It is quite possible that a political alternative can come up which could give a tough fight to the BJP. But as of now it looks unlikely that PM Modi faces any major political challenge, either in Gujarat or at the national level.

No Guests at Hygam Wetland

Hygam Wetland needs special attention from the Govt having been declared as Ramsar site

Since the last two weeks, I have been eagerly waiting to visit Hygam Wetland Reserve near Sopore. A Srinagar based Environmental Police Group (EPG) and its offshoot Green Citizens Council (GCC) have been planning a visit since a long time now. Finally, this Sunday (November 27th 2022), around 15 member teams from EPG/GCC visited Hygam Wetland Reserve. Pertinently, Hygam wetland reserve was declared as Ramsar site this year in August along with Shalabugh wetland.

During our visit to Hygam wetland, we could not see migratory birds in the area. This is a matter of serious concern. Infact, some experts in the group like Dr Riyaz Qureshi from Tourism Studies Department of Kashmir University were of the opinion that even though there were still chances of birds visiting in the coming weeks in a more more foggy and cold weather but it was also The wetlands in Kashmir are shrinking day by day. We have almost lost Hokersar, Anchar, Gilsar and Khushal Sar. Dal lake is on death bed and so is the Wullar lake. At a time when Hygam wetland has been declared a Ramsar site of international importance, it is the duty of the Govt to come to its rescue soon. Civil Society organisations, Educational Institutions, **Augaf Committees** around Hygam, Tarzoo . Sopore need to be sensitized about Hygam Wetland Reserve and other satellite wetlands of the area

vation and sustainable development. The Central Auqaf Committee during the last 3 years has organised almost a dozen workshops , conferences on wetland conservation. They have filed a petition before J&K High Court on unscientific garbage disposal near Niglee wetland area through Advocate Shafqat Nazir, legal advisor of EPG. The High Court gave a landmark judgement and the then Chief Justice Geeta Mittal personally visited the site in Ninglee where municipal solid waste was being dumped by Municipal Council Sopore. The illegal work was later-on stopped. In Fact, I had also moved a petition before the National Green Tribunal on the request of the Central Auqaf Committee Tarzoo.

On April 10th 2021, the five village panchayats in the Tarzoo area on the guidance of the Central Auqaf Committee adopted a joint resolution by invoking section 5 of the Forest Rights Act (FRA) 2006. The FRA empowers the Gram Sabha to protect the wildlife, forest, and biodiversity of the village and to ensure that adjoining catch ment areas, water sources, and other ecologically sensitive areas are adequately protected. Through that resolution, the village panchayats asked the district administration Baramulla and Municipal Council, Sopore to stop dumping solid waste in the forest land which was a severe threat to the environment and biodiversity of the area. Pertinently after closure of the Ninglee dump site, District Administration Baramulla had chosen another site which was forest land and panchayat land. Now that site has also been shut down due to the efforts of Central Augaf Committee Tarzoo Sopore.

Minnow's Beating Titans at Fifa World Cup

nce may be a coincidence. But twice need not be happenstance. The football World Cup in Qatar has already been marked — not marred — by upheavals. Goliaths - major footballing powers from South America and Europe — have been slaved by the proverbial Davids — rising forces from West and East Asia. Argentina, world champions twice, were the first to fall to unheralded Saudi Arabia in what can be said to be one of the biggest upsets in World Cup history. Any sense of schadenfreude that Germany, an old rival of Argentina, relished was quickly erased when Die Mannschaft were humiliated by Japan. Asian teams are not the only ones creating unexpected magic on the pitch. Croatia, a finalist in the 2018 edition of the tournament, was held to an honourable draw by Morocco, one of the flag-bearers of African football. Such has been the momentum of the David-slays-Goliath phenomenon in Qatar that further unexpected results in this World Cup cannot be ruled out.

Of course, minnows triumphing against titans is not new. In fact, there is something called the winner's curse, which has resulted in holders of titles bowing out quite unceremoniously in the early stages of the tournament. But Qatar seems to be heralding the promise of something novel: the contours of a new footballing world where the term, minnows, may no longer apply to most competitors. The fundamental reason behind this transformation is not far to seek. The globalisation of the game has resulted in a large contingent of players from football's Global South — Africa, Asia and South America getting accommodated in the world-class facilities offered by European giants to further hone their formidable skills. Club football has played a pivotal role in the democratisation of the Beautiful Game. The results are encouraging. The two goals that helped Japan topple Germany were scored by Japanese players who play in the German Bundesliga. It is imperative that the doors of these grooming facilities remain open and immune from the narrow political rhetoric that demands the death of migration that enriches both sport and polity. Arguably, the fall of footballing Goliaths is suggestive of a form of poetic justice. In a deeply stratified global order — Asia and Africa have been on the receiving end of colonial and climatic purges — the margin, it seems, can avenge itself on the centre occasionally, if only in sport.

Migratory birds who visit Hygam all the way from central Asia, Russia and Eastern Europe and even China include Shovelers, White Gheese Red Crested Pochards, White Eyed Pochards, Common Teal Coots etc. That the team could not spot any of these birds is a matter of grave concern.

Akhtar Hussain, an environmental science student and a bird watcher from Sumbal, had an interesting story to narrate during the visit. He registered having watched birds wanting to land near Khurwan Sar weltland around November 19th and failing to do so. He had documented this curious observation in photos as well.

Akhtar believes that migratory birds could not recollect that this was their own habitat as the colour of water had changed due to pollution and topography of the land also having changed due to constant land encroachments. He added that construction of houses near wetlands and vehicular sound was preventing migratory birds from visiting their designated habitats.

Encroachments around Hygam wetland

Media has been highlighting the encroachments of Hygam wetlands quite robustly . In the last few years, many reports were carried by local English dailies about choking this wetland. Yet, authorities at the helm have been unable to stop the land encroachment especially around Hygam which has been continuing for the past few decades. During our visit, we could see demarcated wetland areas having been converted into paddy fields. Infact, few apple orchards were also developed on Hygam wetland around its North Western shore.

The Hygam Wetland Reserve is spread over an area of around 1400 hectares of land mass but in villages like Hygam, Haritar, Lolpora, Gohul, Tengpora and Goshbug many encroachments have been seen.

Several residential houses , cattle sheds , and bathrooms have been constructed in addi-

tion to growing paddy and apples on the hundreds of kanals of wetland area. Local citizens told the visiting EPG delegation that around 80 plus illegal constructions have come up on the Hygam wetland in the last few years while hundreds of kanals of land has been converted for paddy cultivation.

Although there are several FIRs registered in local police stations, Police and Revenue Department officials are not taking steps to evict the encroachers. Infact, the Wildlife Department tried to undertake an eviction drive in the Hygam wetland area last year in June but the encroachers attacked the wildlife officials and even injured some of them.

Central Augaf Committee Tarzoo

The Central Auqaf Committee Tarzoo Sopore under the guidance of its patron Ajaz Ahmad Dar and other members has been actively working for conservation of environment in the area.

The special focus of this committee is on wetland conservation as the entire Tarzoo ,Darnambal , Hygam, Ninglee has huge wetlands which are in fact in the Wullar catchment area as well.

The Central Auqaf Committee Tarzoo is the first kind of religious organisation in Kashmir which is concerned about environmental conser-

Conclusion

The theme for the 2022 edition of World Wetlands Day which is celebrated on February 2nd every year is Wetlands Action for People and Nature . This theme highlights the importance of actions that ensure that wetlands are conserved and sustainably used. It is in fact an appeal to invest financial, human and political capital to save the world's wetlands from disappearing and to restore those we have degraded. The wetlands in Kashmir are shrinking day by day. We have almost lost Hokersar, Anchar, Gilsar and Khushal Sar. Dal lake is on death bed and so is the Wullar lake. At a time when Hygam wetland has been declared a Ramsar site of international importance, it is the duty of the Govt to come to its rescue soon. Civil Society organisations, educational Institutions, Augaf Committees around Hygam, Tarzoo, Sopore need to be sensitized about Hygam Wetland Reserve and other satellite wetlands of the area as well. School children should be mandatorily taken out for wetland walks by their teachers across Kashmir which will help them to know the importance of this important water ecosystem. Chief Secretary J&K Dr A K Mehta who is also the Chairperson of State Wetlands Authority should also intervene in this issue.

rinagar's classic countenance would once fuel fantasies with its grace and grandeur and spark poetic praises. But now, the rundown residences are defying the picture-perfect of what once was the Venice of East.

What remains now are the distorted dwellings - mostly long, symmetrical facades, looking east and west, with several windows for taking the air, fascinating staircases and a collection of Kashmiri artistry. These structures would constitute an

ideal-abode for craftspeople. However, the new non-indigenous structures have pushed and pulled this architectural history of everyone to obscurity.

And now, the future of these oldstructures has seemingly frozen in time and stares into the dark.

quintessence structures The around the seven bridges compelling the Bard of Jhelum, Agha Shahid Ali, to pen down glorious tributes are no longer a poetic panorama.

The urban structures no longer give an unobstructed view of the calm riverline. The official stand on this new wave is mere an architectural analogy created by the change. Unlike contemporary perspective struggling around a stack of steel cube like units, the intellectual appetite of yore was written in a pure genre of geniusness in old structures. The new addresses now resemble a row of fridges stacked vertically to building-size proportions. They're

iust tasteless experiments. Kashmir's heritage structures were once considered to be a pilgrimage. These buildings usually stand out against a crowd of much more generic surrounding structures.

For many international visitors. such buildings were an architecture nerd's equivalent of a celebrity selfie. These buildings today are in a conspicuous state of disrepair. Their bodies are pockmarked.

Since last year, everyone in Kashmir, especially in Srinagar, is doing a back-and-forth over the buildings' fate. These grand-old structures are now rendered bereft and doomed.

The impending time for such structures didn't come to pass and their dynamic vision is no longer woven into the fabric of the long-lasting architecture.



Much of the structural change is being attributed to the craftspeople. Unlike the old masters, the new architects are champions of the new style that express bitter-disappointment for its failure.

It's pretty understandable whv straight lines are easy and curves are hard. Most of the new structures are just collections of boxes. It's mostly like toddlers playing with rubber blocks.

When structures were made in the past, the process would yield the curves and master builders earned their respect with arches and wooden rooftops. However, the new shapes are mostly cheaper in style. It's the tyranny of time. Besides the structure, the wooden

windows have now changed into steel. It feels as if people vanished in these windows, and for the most part one cannot know, at least for a while, if they actually ever sit there as witnesses of the life and time in the valley.

It wouldn't be wrong to trust the oldtimers when they say that the classic craftsmen were hired to build



impossible things. However, the new architecture is no longer drawn to its culmination through the potential for magic and the glimmer of hope that invigorates the mundane.

The master artists learned the flaws and foibles of construction with each passing day. But, the latest mansions are a long and haphazard apprenticeship. It may be a delightful stunt but with a dead look.

In the cat race to promote cities that provide core infrastructure, give a decent quality of life to their citizens and apply smart solutions to improve services and infrastructure, these new projects push behind the idea of heritage and Kashmir's architectural history.

The new structures are like pop-up obstacles, piling on complexities. It shows the desperation to reach first. The old designer choices of materi-

al and design weren't just aesthetically fashionable, their main purpose of constructing a building was to function as a soothing place for the soul.

Much of the modernist architecture can be understood as waging war on the valley's architectural importance.

As extreme as the aesthetic of modern architecture seems today, many in the valley are sure that it is safe. But, the new design still looks like blank and empty boxes.

Even Agha Shahid was concerned about how ugly buildings had come up in place of the old ones and how original Kashmiri architecture, which is so unique, was slowly vanishing.

Now that traditional Kashmiri homes are facing an onslaught, it's hard to imagine any writer romanticizing Kashmir and glossing over the importance of architecture in life.

'Over 75% Indians With Hypertension Have Uncontrolled BP'

ess than one-fourth of hypertensive patients in India have their blood pressure under control, according to a study published in The Lancet Regional Health journal. Hypertension or high

blood pressure is an important modifiable risk factor for cardiovascular diseases (CVD), making it one of the significant contributors of premature death and morbidity.

The team, including researchers from National Centre for Disease Control, New Delhi, and Boston University School of Public Health, US, conducted a systematic review of 51 studies published after 2001 that reported hypertension control rates in India.

The researchers focused on community-based noninterventional studies which provide a realistic picture of control rates at the community level.

changes in control rates over the years, which the authors said, was never done before. The research found that 21 studies (41 per cent) reported poorer hypertension control rates among males then fo

rates among males than females, and six studies (12 per cent) reported poorer control rates among rural patients. The pooled hypertension

control rate in India during 2001 2020 was 17.5 per cent -- with significant increase over the years, reaching 22.5 per cent in 2016 2020, the researchers said.

Sub-group analysis showed significantly better control rates in the South and West regions, and significantly poorer control rates among males Very few

risk factors, they said.

"Less than one-fourth of hypertensive patients in India had their blood pressure under control during 2016 2020. Although the control rate has improved compared to previous years, substantial differences exist across regions," the authors of the study said.

"Very few studies have examined the lifestyle risk factors and social determinants relevant to hypertension control in India," they added.

In the study, hypertension control rate was defined as the proportion of patients with their blood pressure under control ie. a systolic blood pressure less than 140 mmHg (unit of pressure) and diastolic blood pressure less than 90 mmHg.

The review included 49 cross-sectional and two cohort studies covering 1.39 million population (73 per cent females) including 338,313 (3.3 lakh) hypertensive patients. Thirty nine studies had state-specific data covering 15 states and territories.

The mean hypertension prevalence across studies was 24.2 per cent, and 46.8 per cent of them were aware of their high blood pressure.

The researchers noted that India needs to develop and evaluate sustainable, community-based strategies and programmes to improve hypertension control rates.

"Hypertension is a significant contributor to mortality in India. Achieving better hypertension control rate at the population level is critical in reducing cardiovascular morbidity and mortality," the authors said.

The team also included researchers from Government Medical College,

researchers are training something new.

They want to develop drugs that stop the virus getting into the body in the first place. That includes nasal sprays that stop the virus attaching to cells in the nose.

Other researchers are looking at the potential for nasal sprays to stop the virus replicating in the nose, or to make the nose a hostile place to enter the body.

Here's where the science is up to and what we can expect next.

How could we block the virus?

"Viral blockade", as the name suggests, is a simple premise based on blocking SARS-CoV-2. In other words, if something gets in its way, the virus cannot attach to a cell and it can't infect you.

As SARS-CoV-2 is a respiratory virus, it makes sense to deliver this type of medicine where the virus mainly enters the body – via the nose, in a nasal spray.

There are various groups around the world working on this concept. Some research is still being conducted in the lab. Some agents have progressed to preliminary human trials. None are yet available for widespread use.

Heparin

Heparin is a common medicine that's been used for decades to thin the blood. Studies in mice show that when heparin is delivered via the nose, it's safe and effective in preventing the virus binding to nose cells. Researchers believe heparin binds to the virus itself and stops the virus attaching to the cells it's trying to infect.

A clinical trial is being conducted in Victoria in collaboration between multiple Melbourne-based research centres and the University of Oxford.

Covixyl-V

Covixyl-V (ethyl lauroyl arginine hydrochloride) is another nasal spray under development. It aims to prevent COVID by blocking or modifying the cell surface to prevent the virus from infecting.

This compound has been explored for use in various viral infections, and early studies

IGM-6268

This is an engineered antibody that binds to SARS-CoV-2, blocking the virus from attaching to cells in the nose.

A nasal and oral (mouth) spray are in a clinical trial to assess safety.

Cold atmospheric plasma

This is a gas that contains charged particles. At cold temperatures, it can alter the surface of a cell.

A lab-based study shows the gas changes expression of receptors on the skin that would normally allow the virus to attach. This re-

Researchers are designing genetic fragments that bind to the viral RNA. These fragments – known as "locked nucleic acid antisense oligonucleotides" (or LNA ASOs for short) – put a proverbial spanner in the works and stop the virus from replicating.

A spray of these genetic fragments delivered into the nose reduced virus replication in the nose and prevented disease in small animals.

How could we change the nose?

A third strategy is to change the nose environment to make it less hospitable for the virus.

That could be by using a nasal spray to change moisture levels (with saline), alter the pH (making the nose more acidic or alkaline), or adding a virus-killing agent (iodine). Saline can reduce the amount of SARS-CoV-2 in the nose by simply washing away the virus. One study has even found that saline nasal irrigation can lessen COVID disease severity. But we would need further research into saline sprays.

An Australian-led study has found that an iodine-based nasal spray reduced the viral load in the nose. Further clinical trials are planned.

One study used a test spray – containing ingredients including eucalyptus and clove oils, potassium chloride and glycerol. The aim was to kill the virus and change the acidity of the nose to prevent the virus attaching.

This novel formulation has been tested in the lab and in a clinical trial showing it to be safe and to reduce infection rate from about 34 per cent to 13 per cent when compared to placebo controls.

Barriers ahead

Despite promising data so far on nasal sprays for COVID, one of the major barriers is keeping the sprays in the nose. To overcome this, most sprays need multiple applications a day, sometimes every few hours.

So based on what we know so far, nasal sprays will not singlehandedly beat COVID. But if they are shown to be safe and effective in clinical trials, and receive regulatory approval, they might be another tool to help prevent it. studies reported data on social determinants or lifestyle Manjeri and KIMS Al-Shifa Specialty Hospital, Perinthalmanna, both in Kerala.

Jet Airways Plan To **Pull Out Of Bankruptcy Is In Tatters: Report**

MUMBAI: Creditors of Jet Airways and the company's new owners are deadlocked over a resolution plan to pull the airline out of bankruptcy, putting the carrier's future in limbo, according to sources.

Creditors may approach the aviation ministry to seek approval to liquidate Jet's assets if a resolution does not emerge during a critical court hearing on Tuesday, said a senior banker. 'There have been too many delays ... there are concerns the resolution plan may fall apart so we are looking to see if we can at least get something out of this deal via the liquidation

Kerala Govt Terms Unacceptable Mob Attack On Police Station; Church Seeks Judicial Probe

Thiruvananthapuram/ Kozhikode: The attack on a police station in Vizhinjam area by a large mob, allegedly of those protesting against the Adani port construction, was termed as "unacceptable" by the Left government on Monday, while the Latin Catholic church claimed "outside forces" were behind it and sought a judicial probe into it.

The ruling CPI(M) said the recent incidents of violence in the coastal area were reprehensible and claimed that some "mysterious forces" with vested interests were trying to create a riotlike situation there.

"In the name of protests, some were resorting to violence to create a conflict in the coastal areas and the state government should take strict action against the same," the CPI(M) state secretariat said in a release.

The Congress-led UDF opposition, on the other hand, blamed the government for "deliberately provoking" the protesters to take up violence by lodging an FIR against at least 15 Latin Catholic priests, including metropolitan Archbishop Thomas J Netto and Vicar General Eugene Pereira, over the violence at Vizhiniam on Saturday.

"If protest leaders (priests) were to be made accountable for actions of the protesters, then would Kerala Chief Minister Pinarayi Vijayan and CPI(M) state secretary M V Govindan be held responsible for protests and other actions of their party workers?" Leader of Opposition in the state assembly V D Satheesan asked while speaking to reporters in Thiruvananthapuram.

The Congress leader advised Vijayan to set aside his ego and directly hold discussions with



the protesting fisherfolk to convince them to end the agitation. Earlier in the day, Kerala Minister of Ports Ahammed Devarkovil said the government has been "very patient" till now in relation to the protests, but if the agitation attains a "criminal nature" -- where police personnel are attacked and injured and police property is destroyed -that was "unacceptable."

"Especially in a secular state like Kerala, we will not allow any kind of communal conflict." the minister said and claimed that the mob attacked houses and establishments of those not belonging to their community.

"We will go to any extent to ensure communal harmony in the state," the minister said while speaking to reporters in Kozhikode.

On being told that the Latin Catholic church, which is leading the protest against the port construction, has claimed that external forces were in play and were the reasons for the violence during the last two days,

Devarkovil said the government has received several reports and the same were being

investigated. Vicar General Pereira, who has been seen at the forefront of the protests, claimed "outside

forces" were behind the portrelated violence in the last two davs and said there should be a judicial probe into the incidents. At the same time, he also said the attack on the police station, injuries caused to the police per-

sonnel and the damage to property were not justifiable. State Finance Minister K N Balagopal said these unfortunate incidents of violence were happening when the project, an important one for the state, was at the finishing point and hoped that the matter can be resolved

amicably. Devarkovil too said that the project, which cost around Rs 7,500 crore, was important for the overall development of the state and therefore, its work cannot be stopped -- which is one of the seven demands of the

anti-port protesters.

He said five demands have been accepted and besides the stopping of the port construction, the only other demand that remained was providing kerosene at subsidised rates to fisherfolk.

The minister said kerosene was provided by the Centre and therefore, it was not up to the state to provide it at subsidised rates.

He also said that when the protesters were not abiding by repeated orders of the high court not to obstruct construction work or movement of materials for the project, it makes no sense for them to seek a judicial enquiry into the violence.

"So if there is an action, there will be a reaction," he said, but added that till date the government has not tried to suppress the protest by force in view of its public nature and presence of women and children at its forefront.

"However, we will have to implement court orders,' Devarkovil further said. Satheesan said that while the

Congress and UDF opposition led by it would never encourage the violence that occurred in Vizhinjam on Sunday, it had given several warnings to the state government that if they do not resolve the issue, the situation could turn dangerous.

He also alleged that the CPI(M) and the BIP were working together to derail the protest.

Senior Congress leader and former KPCC president V M Sudheeran said the agitators were seeking a proper study of the impact and consequences of the project on the coastal regions, but it has been "twisted into an anti-port agitation."

The $CPI(\hat{M})$, while blaming some vested interests for the violence at Vizhinjam, said that the state government has always worked to safeguard interests of the fisherfolk and would continue to do so.

Kerala Assembly Speaker A N Shamseer urged the protesters to withdraw their agitation and to cooperate with the state government as most of their demands were accepted.

Meanwhile. Kerala the Catholic Bishops' Council (KCBC) termed the Sunday violence as unfortunate, but said that the Centre and the state government were ignoring the protesters' demand for a proper study of the impact of the port construction.

They also opposed the police action of registering FIRs against the priests and sought an impartial and fair investigation into the violence at Vizhinjam.

Over 3,000 'identifiable persons' have been booked in connection with clashes during an ongoing protest against the Adani port project in Kerala's Vizhinjam area on Sunday night. As many as 36 police personnel were reported to be injured in the violence that ensued

SC Closes Proceedings Against Demolition Near Afzal Khan's Tomb, Says Razing Over

New Delhi: The Supreme Court on Monday closed the proceedings on an interim plea after taking note of the submissions of Maharashtra authorities that the demolition drive conducted to remove alleged unauthorised structures on government land around the tomb of Afzal Khan, the commander of the Adil Shahi dynasty of Bijapur, has

been completed. 'Now the demolition drive has been carried out and hence, so far as the interim application (challenging the demolition) is concerned, actually nothing survives," a bench comprising Chief Justice D Y Chandrachud and Justice P S Narasimha said while disposing of the interim plea of Hazrat Mohd Afzal Khan

Memorial Society against the demolition drive. It, however, kept the main appeal of the society pending for adjudication against two Bombay High Court orders asking the state government to demolish the illegal structures in and around the tomb. The Society had claimed the demolition could damage the tomb. The top court had on

November 11 sought reports from the district collector and the deputy conservator of forests of Satara in Maharashtra on the demolition drive conducted to remove alleged unauthorised structures on government land at the site.

At the outset, the bench perused the reports filed by the district collector and the deputy conservator of forests of Satara besides the pictures of the demolition drive and said they showed the extent of illegal constructions on forest land

Senior advocate N K Kaul, appearing for the state

government, said the tomb of Afzal Khan and another grave, which was found during the demolition drive, are "untouched" and "protected".

Kaul said that two dharamshala', built illegally on the government land, have been demolished.

The counsel for the Hazrat Mohd Afzal Khan Memorial Society, however, said he will like those razed structures to be re-built as the demolition was illegal.

Initially, the bench was of the view that the society should seek other legal remedy before appropriate forum as nothing survived in the main petition either. Later, it decided to keep the main petition pending when the counsel for the society argued on this aspect.

The Bombay High Court had, in its orders passed on October 15, 2008 and November 11, 2009, ordered the state government authorities to remove illegal structures in and around the tomb.

The state government's appeal against the HC orders were dismissed on account of delay.

The appeal of the society against these orders of the high court is pending.

Earlier on November 11, the top court was apprised by the Maharashtra government that the demolition drive, against which the instant plea was moved, was over and illegal structures built on government and forest land were razed.

Afzal Khan was killed by Maratha king Chhatrapati Shivaji Maharaj near the Pratapgad Fort in Maharashtra's Satara district and a tomb was built there in his memory later.

New Delhi: The Supreme Court said on Monday it will ask the Kerala High Court to consider afresh the anticipatory bail pleas of four people, including a former Director General of Police (DGP), in a case of alleged frame-up of scientist Nambi Narayanan in the 1994 ISRO espionage matter.

It was hearing the CBI's appeal against the high court order granting bail to former Gujarat DGP R B Sreekumar, two former police officers of Kerala --S Vijayan and Thampi S Durga Dutt, and a retired intelligence official P S Jayaprakash. "What we propose is this ..We will say high court to consider the anticipatory bail applications afresh without in any way being influenced by any observations." said a bench headed by Justice MR Shah.

'The floods that devastated Pakistan earlier this year was

very sad to see and has had significant impact on the country and the people. "The game has given me a lot in my life and I feel it's only right to give something back that goes far beyond cricket. I will be donating my match fees from this test series to the Pakistan flood appeal."

Iran's semiofficial ISNA news agency quoted Safiollah Fagahanpour, an adviser to the Iranian Football Federation, saying that the "measures taken regarding the Islamic Republic of Iran flag are against the law" of FIFA competitions.

"They must be held responsible," Fagahanpour said. "Obviously they want to affect Iran's performance against the U.S by doing this."

The Islamic Republic emblem, designed in 1980, is four curves with a sword between them. It represents the Islamic saying: 'There is no god but God." It also resembles a tulip or lotus.

At the top and the bottom of the flag, there are 22 inscriptions of "God is Great" as well, which honours the date on the Persian calendar when the Islamic Revolution took hold.

The flag has become a point of contention at the World Cup. Apparent pro-government supporters have waved it, shouting at those demonstrating over Amini's death. Others at matches have waved Iran's lion and sun flag, an emblem of its former ruler, the late Shah Mohammad Reza Pahlavi.

More security forces could be seen at Iran's last match against Wales. In the capital Tehran, anti-riot police – the same ones cracking down on protests – waved the Iranian flag after the Wales win, angering demonstrators.

LOS ANGELES: The world's focus has shifted to the war in Ukraine, but two major new documentaries aim to throw the spotlight back on Afghanistan, and the people left behind by the United States' rapid withdrawal last year.

National Geographic's "Retrograde" follows an Afghan general who tried in vain to hold back the Taliban advance in 2021, while Netflix's "In Her Hands" tells the story of the country's youngest woman mayor, who had to flee as the Islamists took over.

"We've forgotten about this story -- when was the last time we discussed the war in Afghanistan, or read an article about it?" said "Retrograde" director Matthew Heineman.

"Obviously there's still some coverage of it, but... not that many people are talking about this country that we left behind."

Zarifa Ghafari, the former mayor spotlighted by "In Her Hands," told AFP that back under the Taliban, Afghanistan is "the only country around the world nowadays where a woman can sell their body, their children, anything else, but are not able to go to school."

But at international political meetings, "Afghanistan is out of those discussions."

Irish Regulator Fines Facebook \$277 Million Over Data Privacy Breach

Dublin: Ireland's data privacy regulator imposed a 265 million euro (\$277 million) fine on social media giant Facebook on Monday, bringing the total it has fined parent group Meta to almost 1 billion euros. The penalty resulted from an

investigation, started in April 2021, related to the discovery of a collated dataset of Facebook personal data that had been made available online. Facebook was also ordered to make a range of corrective measures.

Monday's fine is the fourth Ireland's Data Privacy Commissioner (DPC) has levied against one of Meta's companies. It is Meta's lead privacy regulator within the European Union, and has 13 more inquiries into the social media group outstanding.

In September the watchdog hit its Instagram subsidiary with a record fine of 405 million euros, which Meta plans to appeal. The DPC regulates Apple, Google, Tiktok and other technology giants due to the location of their EU headquarters in Ireland. It currently has 40 inquiries open into such firms, including the 13 involving Meta.

The Irish regulator said in a statement that other relevant EU regulators agreed with the decision issued on Monday after it shared a draft ruling with them last month under the bloc's "one-stop shop" system of regulating large multinationals.

Iran frees hundreds after World Cup win over Wales

TEHRAN: Iran has released more than 700 prisoners after the national team's World Cup football victory over Wales, the judiciary's Mizan Online website said Monday.

It announced that "709 detainees were freed from different prisons in the country" following the 2-0 victory on Friday. Among those are "some arrested during the recent events," Mizan Online said, making indi-

rect reference to demonstrations which have shaken Iran for more than two months. It gave no further detail.

The ongoing protests were triggered by the September 16 death in custody of Mahsa Amini, 22, after her arrest by morality police for an alleged breach of Iran's strict dress rules for women.

Other Iranian media separately reported that prominent Iranian actor Hengameh Ghaziani had been released on bail after her arrest for having supported the protests.

Two of the most prominent figures detained over the demonstrations — former international footballer Voria Ghafouri and dissident Hossein Ronaghi — were also let out on bail, reports said.

State news agency IRNA reported on Monday that former state television host Mahmoud Shahriari, 63, had been released after two months in prison for "encouraging riots."

Iran on Friday scored twice deep into stoppage time to stun Wales and breathe new life into its World Cup campaign ahead of a politically charged showdown Tuesday against the United States. Iran lost its first World Cup match to England, 6-2.

Iran's judiciary says more than 2,000 people have been charged since the start of the protests.

United Nations High Commissioner for Human Rights Volker Turk last week said around 14,000 people have been arrested.
