After Kanger, Now Heating Gadgets Face Medical Advisory In Kashmir

Whith people in Kashmir having very limited options available to keep themselves warm during harsh winters, medicos are now warning that even modern heating gadgets available in the market are unsafe for use.

First it was favourite Kangri which was marked as dangerous linking the prolonged use of Kashmir's traditional firepot with malignancy and now medicos have gagged modern

heating-gadgets for their proximate use during winters.

The medical advisory of sorts has come amid the intensifying cold in the valley creating a significant market demand for electric blankets, heaters, blowers, electric water bottles, rod heaters, room radiators and other gadgets. In fact, to keep cold at bay, some people are even installing electric hamams in their homes.

However, the medical experts warn that people need to take precautions and avoid proximate use of heating to



- appliances. d "Using heating appliances d close to the body can lead g to many skin-related issues **SHOULD OPEN THEIR BODY TO DIRECT HEAT** and keep the heating appliance away from the children whose skins are soft and sensitive."

including Erythema ab igne (Naar tuet) and even skin cancers," Dr. Imran Majid, Director Cutis Institute of Dermatology Srinagar told Kashmir Observer. To beat the cold, the medico said, many people keep the heating gadgets close to their bodies without realizing the harm caused by the proximate use. "Another issue with heating

appliances is that they cause skin dryness, itching and allergies," Dr. Imran continued. "Elderly persons, especially diabetic patients using hot water bottles in close proximity to the skin, can have burns because of the heating appliances."

Earlier, some medicos had proscribed the prolonged use

of Kanger to avoid skin cancer. The traditional winter firepot is tucked in-between the thighs and legs or kept in contact with the abdominal wall to generate warmth during the winter menths

winter months. However, with the advent of technology, the people adopted a number of modern heating gadgets, especially in urban areas. But now, these modern heating appliances are facing the traditional firepot fate in Kashmir. Lately, Fareeda, a 48-year-old


The drone has been seized and the duo is being questioned, they said on Tuesday.

Govt Okays HR Policy For Anganwadi Workers, Helpers

Jammu: As a major step towards the empowerment of women in Jammu and Kashmir, the Lieutenant Governor, Manoj Sinha led administration on Tuesday approved the human resources policy for female Anganwadi Workers (AWWs) and Helpers working in the Integrated Child Development Scheme (ICDS) in the Union Territory.

The decision in this regard was taken in the Administrative Council (AC) meeting held here under the chairmanship of the LG, an official spokesperson said. The AC, he said, approved the proposal of comprehensive Human Resource Policy to govern the engagement, leave(s), promotion and other important aspects of this very vital work force of the department. AWWs and AWHs shall be redesignated as Sanginis (AWWs) and Sahayikas (AWHs).

"The unit for selection has also been re-defined in terms of electoral ward to remove any ambiguity in the selection process. The new policy also clearly lays down age criteria for selection, with domicile of UT being pre-requisite eligibility for competing in the selection process," he said.

As per the spokesperson, the minimum qualification for Aanganwadi Worker shall be 10+2 and maximum graduation and in case no 10+2 candidate is available in the Ward, 10+2 pass candidate from the adjoining ward shall be considered which would require prior approval of Mission Director, ICDS.

He said weightage shall be given to marks obtained in 10+2 and selection shall be done purely on merit basis. "Candidates with **More on P6**

BSF Shoots Down Two Pak Drones

To Change Corrupt Behaviour, Change The Message

Every day we are bombarded with messages that try to persuade us to change our behaviour for the good of ourselves and society. Eat less food! Wear a mask! Get vaccinated!

Millions of dollars are spent each year on information campaigns designed to foster more cohesive and inclusive societies.

In developing economies, this includes efforts to foster democratic attitudes and more effective political systems.

Say no to gender-based violence! Reject corruption! Do not sell your vote! Given how pervasive they are, the most

surprising thing about these campaigns is that many just don't work.

Some even make the situation worse. The reason why is important, because it tells us something about why it's so hard to change human behaviour.

Take anti-corruption campaigns.

Almost all of the programmes designed to reduce graft in high corruption countries include an awareness raising' component.

The idea is that through raising awareness about an issue, citizens will become more willing to reject requests for bribes and act against corruption.

The hope is they'll report it or vote against corrupt politicians.

But until the last five years, no one had systematically tested whether these messages were effective.

When researchers started to look into this, they got a nasty surprise: in most cases anti-corruption messages don't make citizens more likely to reject or condemn graft.

A test in Lagos, Nigeria, a nation with a history of high-level corruption, had some alarming results.

From 1200 randomly selected partici-



pants, it found people were actually more likely to pay a bribe.

The 1200 took part in a bribery game. They were told that paying a bribe would mean another participant would lose money much like in the real world.

Some participants received an anticorruption message and some did not.

Those who received an anti-corruption message were on average more likely to pay a bribe. In other words, the effect of the messaging was the opposite of what was intended.

This means the millions of dollars being spent on anti-corruption messaging in countries like Nigeria may not just be wasted it may actually be making things worse. Blame human nature.

Recent research in political and social psychology found that when we hear about topics that are pervasive, we tend to become cynical and focus on how big the problem is.

The way we behave is less shaped by what we are told to do than by what we believe our peers are already doing.

So, we are more likely to get vaccinated and follow social distancing protocols if we think all our friends have already done so than if the government tells us. The consequences of this for how governments need to communicate are profound.

If a campaign focuses on how corrupt the police are, or how few people are recycling, we point out how big the problem is and so run the risk of undermining people's confidence that a better future is possible while simultaneously suggesting that bad' behaviours are socially acceptable.

The effect of this double whammy is

perfectly illustrated by anti-corruption messaging which confirms people's most cynical inner beliefs that the system is beyond repair and the only way to get things done is to take part in corruption by paying bribes.

Individuals who were already particularly pessimistic about the prevalence of corruption were significantly more likely to be negatively affected by reading an anti-corruption message.

The biggest worry is that this logic doesn't only apply to corruption.

One study tested messages designed to prevent the theft of wood from Arizona's Petrified Forest National Park.

It found that signs that described the problems caused by others' behaviour stealing wood were most likely to increase theft.

A more recent paper on how to encourage people to respect social distancing protocols during the pandemic in Australia concluded that telling citizens that others are not following the rules is dangerous because people match their behaviour to perceived social norms.

Similar conclusions have been reached with campaigns to stop gender-based violence and vote-buying.

It's important, then, to realise that raising awareness may actually make the problem worse.

Before embarking on awareness-raising campaigns policymakers could try and design less problematic messages.

One way to do this may be by focusing on those who behave appropriately', and the negative feelings people hold about those who do not, rather than highlighting the extent of the problem.

Emphasising the strength of feeling within society and the number of people who want to see change can inspire and motivate rather than depress and discourage.

dementia. ECU Nutrition and Health Innovation Research Institute researcher and study lead Ben Parmenter said while there were many dietary sources of flavonoids, some had particularly high amounts. "In most populations, a small group of foods and beverages -- uniquely high in flavonoids -- contribute the bulk of total dietary flavonoid intake," he said

FCS&CA Fines Erring Shopkeepers In City

Central Market 'Kashmir Haat' Losing Sheen

Srinagar: Nearly a century old market-Government central market Kashmir Haat, is losing its sheen with each passing day as the business at the once famed marketplace has got badly affected with the businessman stating that bringing the bazaar on tourism map would help them to revive their business

Almost every shopkeeper at the market is claiming that despite the tourism boom in the Valley, the tourists don't visit them as the market is off-route and has been ignored so far.

Khurshid Ahmad, one of the traders, said that the market was started in 1937 when Maharaja Rulers forced the artisans to come up with the market to promote the local product.

"The tourists, parliamentarians and others would visit the market every day. But now,

it's unfortunate that the tourists hardly visit the market where everything is available including Shawls, dry fruit, papier Mache, woodcarving and other local produce," he said.

Ahmad further said that the tourists, who throng the other places have to move from one place to another to get the local produce, but the market despite having everything has been ignored.


"The tourism department should look into the matter so that the tourists would be able to get knowledgeable where the tourism market is," he said, adding that ignoring the market has forced many to switch to other jobs.

President of the market, Nisar Ahmad Kitaba said that the market is completely defunct at present. "This market is solely dependent on the tourists. There are 127 shops in the market and it is famous among people all across the globe.

However, the official apathy has deteriorated the situation of the businessman as well as the market," he said.

He added that the department concerned is now extending its support as the exhibitions are being organized here. "But, the situation has worsened to a large extent. We have appealed to the government to allow us to make local items available here till the situation improves and the tourists start visiting the place again," he said.

"Although the tourism is witnessing a boom in Kashmir, the market has become an oddsite for the tourists as mostly they visit Dalgate, Boulevard, Lal Chowk and other areas only. Now, we have appealed the administration to bring the market on tourism map, which would ensure the tourists visit the marketplace so that the business can be revived once again," he said—(KNO)

'50 Percent Indians Are Corrupt'

NEW DELHI: Almost 60 per cent of Indians using government ser¬vices end up paying bribes, according to a recent survey commis¬sioned by India's Central Vigilance Commission (CVC). But only 20 per cent actually filed complaints against such corrupt practices.

The study was carried out by the Centre for Media Studies (CMS), which interviewed 2,576 visitors to government offices in five cities across the country in November.

More than 60 percent of respondents said the problem of cor¬ruption was not being tackled seriously and that the judiciary was largely ineffective. Most of the respondents agreed the offices for securing driving licenses and civil supplies were the most corrupt in all five cities - New Delhi, Lucknow, Madras, Hyderabad and Pune.

One-third of respondents admitted to using "influence or fa¬vour" to get the service they needed. The survey noted that mem-bers of the business community and the self-employed topped the list of bribe givers. According to the survey, the government departments in Lucknow and Hyderabad were the most corrupt. About 42 per cent of people said the departments operated "Middle men" who acted as a paid conduit between the public and officials. The public departments covered by the survey included electricity and telephone boards, civil supplies, driving license and local and urban development offices.

Improving Security Situation

he Assistant Director General of Police Vijay Kumar on Saturday said that Ban-dipora, Kupwara and Ganderbal districts in Kashmir have zero active militants currently and the two prominent outfits, Lashkar-e-Toiba and Jaish-e-Mohammed, have gone headless after security forces killed their commanders. He set a two year deadline for completely wiping out the militancy. And as for the estimate of the militants active in the Valley, Kumar said the number has dwindled to two-digits. The Kashmir region comprising 13 police districts has 81 militants at present with 29 being local while 52 being of foreign origin. This is one of the lowest numbers, the militancy has been reduced to over the past three decades and should thus constitute a significant turn in the events following the withdrawal of Article 370 in August 2019. It is true that the last three years have witnessed a disproportionate increase in the killings of militants in Kashmir creating a possi-bility that militancy could be eradicated from the Valley. More so, at a time when the armed forces have also killed a majority of militants at Shopian, Pulwama and Kulgam, the places in South Kashmir that have emerged as militant strongholds in recent years.

The current phase of renewed militancy had begun around 2015 when the then Hizbul Mujahideen militant Burhan Wani used social media to persuade youth to take up arms. Soon scores of youth joined, taking the number beyond 300 in the following two years. The number stayed at over 200 up until last year. But now that number has reduced below 100, which is something that has probably happened for the first time. It almost now seems that militancy is on the way out. And should this happen, it would be the biggest development of the past three decades. And it would be a major milestone for New Delhi on the road to normalcy in Kashmir. This is happening against the backdrop of the loss of J&K's special status, and the evolving geopolitics of the region where India is now at loggerheads with China and Pakistan. The pacification of Kashmir would mean an end to India's Kashmir troubles and let the country focus on its economy and its other geopolitical challenges.

However, it is still premature to declare victory. Earlier also, the militancy in Kashmir came close to eradication twice: first around 1993 when pro-government insurgency spread and second around 2013 when number of militants had reduced to around 100 and South Kashmir had just 15 of them. So the situation in the coming months would be keenly watched. This could make it clear which way the valley is headed.

Not Just a Bajwa Protege

During General Qamar Javed Bajwa's term, Pakistan largely adopted a non-combative policy towards India. The key question is whether new Army chief General Asim Munir will change that

he appointment of General Asim Munir as Pakistan's new Army chief has generated a lot of media buzz in South Asia. And understandably so. His appointment follows a contentious tenure of his predecessor, General Qamar Javed Bajwa which saw Imran Khan's ousting as Pakistan's prime minister in its final year. General Munir has inherited a country which seems at war with itself with Imran Khan leading a nationwide protest. What is more, Khan is now at the peak of his popularity and his party is tipped to sweep the general elections whether they are held in the near future or on their scheduled time in October next year.

An Army chief is considered the sole sovereign in Pakistan's political structure, so General Munir holds the power to sort out the ongoing turmoil in the country. But how he would seek to achieve this has become the subject of intense media and political speculation. More so. when General Munir is believed to hold a grudge against Khan: He is said to have been shunted out by the latter as the Director General of the ISI after a short stint of eight months. So, there are two scenarios that can play out. One, General Munir would work to hold fresh elections which could end the current political instability in Pakistan. And second, the elections are held at their scheduled time which would mean a continuation of the current turbulence for a little more time, as by March the country would already be in an election mode. This may be why Khan has given up the demand for elections and instead sought to resign from all assemblies in a bid to force early polls. For now, Khan's priority

seems to be to keep his vast support base mobilized.

In any case, current turmoil in Pakistan has an expiry date. It can, however, prolong if the elections are not seen as free and fair by Khan and his party is denied power. A lot of how the situation turns out depends on how General Munir handles it as part of his internal challenges.

On the external front, it would be interesting to see how the new Army chief deals with India, particularly in regard to Kashmir. During Bajwa's term in office, Pakistan largely adopted a non-combative policy towards India. This despite the fact his term witnessed the 2019 Pulwama attack that killed over 40 security personnel leading to the first aerial dogfight between the two neighbours in 48 years. Earlier in 2016, Pakistan didn't respond when India carried out a surgical strike across the LoC.

What is more, Pakistan balked at militarily escalating the situation when in August Bajwa even made a pitch for the two countries to "bury the past," and move on. He also called for "geoeconomics" to replace geopolitics as Pakistan's worldview to ensure peace and prosperity in the region. India, however, remained cool to these overtures.

Would General Munir review his predecessor's internal and external policies? He might very well do so. It remains to be seen whether he takes steps to resolve the current crisis in Pakistan and order elections ahead of their due date, as desired by Khan. But considering he was removed as DG ISI by Khan, it seems unlikely he will take the side of Khan in the ongoing political tussle in the country. And this is also why he is believed to have been selected by the prime minister Shahbaz Sharif in the first place. In such a situation, the current instability in Pakistan is likely to linger on.

General Munir's approach towards India will be keenly watched. There is some apprehen-

ometimes all it takes is a spark. In China, it was a blaze. Within a month of President Xi Jinping securing an unprecedented third term after seeing off perceived or potential rivals, a challenge to his untrammelled powers and authority has arisen from the unlikeliest quarter — the Chinese street. A fire in an apartment block in the Xinjiang capital Urumqi killed 10 people because the fire services could not access the building locked down by local authorities in line with the state's zero Covid strategy. The awfulness of this incident seems to have touched a raw nerve across the country. Even if only in the hundreds yet, people, mainly youngsters, have been stepping out to protest over the last few days against President Xi's strict anti-Covid policies, with some momentum building up over the weekend as members of the public in major cities like Shanghai and Nanjing and the capital Beijing joined. The numbers at each protest site are not high, still they are unprecedented, organic and innovative - protestors are using blank white A4 sheets to demand freedom of speech.

Since the Tiananmen Square protest was brutally put down in 1989, there has been only one other instance of a large public protest, in 1999 by Falung Gong followers. That ended with a crackdown and the jailing of thousands. In 2020, the realisation that the government ignored a whistleblower doctor's warnings about Covid led to an outpouring of anger on social media, especially after he died of the disease himself, but there were no street protests. This time around, zero Covid has strained national patience with its sudden lockdowns in an apartment block, or a neighbourhood, even an amusement park with its visitors not allowed to leave. Towns and big cities have not escaped either, making China the only country in the world that is still using this measure to tackle its Covid cases. Travel to and from China has also not normalised yet. The football World Cup in Qatar, with lakhs of people flying in, must have been the last straw for audiences in China.

The expectation that President Xi would use the platform of the Communist Party of China Congress that took place in October to relax zero Covid rules, especially because of the damage the policy has wreaked on the economy, did not come true. In fact, he stressed the opposite — there would be no relaxations to the zero Covid policy. Xi, who has centralised powers in his hands, now personifies the Chinese state. Therefore it is not surprising that some of the anger is being directed at him openly. The long arm of the Chinese state may yet find a way to nip the protests before they turn into anything bigger. The world is watching to see how strongman Xi deals with this new domestic challenge.

2019 New Delhi revoked Article 370 that granted J&K an autonomous status under the Indian constitution - albeit, it did raise diplomatic ante which, in turn, achieved nothing. Pakistan also didn't escalate militancy in Kashmir, as many analysts had warned. Instead, a year after Kashmir's merger with India, Pakistan engaged in a backchannel dialogue with India and by February 2021 the two countries re-affirmed the 2003 ceasefire agreement along Line of Control.

There was suddenly a brief spell of bonhomie between the two countries. Both the then Pakistan prime minister Khan and General Bajwa called for dialogue and resolving Kashmir in a peaceful manner. sion in New Delhi that he might reverse General Bajwa's policy. But considering the tough geopolitical and the economic situation Pakistan is in, there seems little room for the country to return to its earlier belligerent approach towards India. But the Pakistan Army is known in India to be traditionally unpredictable and adventurous, so General Munir's moves will be closely monitored, particularly so, in the weeks and months to come.

strange. So here we have two types of bins, one that is more of an empty container than a dustbin, and the other overflowing with garbage and none of them are doing any favor to the environment ?

Even though the government of India from the past few years has launched various programmes like the Swachh Bharat Mission & adopted Solid Waste Management Rules 2016 I don't think that any of them has made our situation better. What we need is immediate action.

When Apollo 11 landed on the

moon and for the first time, humans set their feet on the moon, a picture was taken by the astronauts that showed us how our planet looked from the outside for the first time ever. It is considered to be the best picture taken in history because of the message that was sent after it, It said, "We set out to explore the moon, but discovered the Earth instead" and this is the picture that inspires millions of people to protect what is most important to us- our blue planet.

In this case, having a fact-checker in your organisation will help in correctly dealing with a situation and averting bad press.

To understand the reach we can look at the initiative called International Fact-Checking Network (IFCN) by the Poynter Institute which looks to bring together fact-checkers worldwide.

And to answer whether it is enough to stop misinformation - No. Fact-checking alone cannot stop the spread of misleading information.

TELL US SOMETHING ABOUT MEDIA LITERACY AND WHY IS IT SO **IMPORTANT?**

Media literacy has become of paramount importance today. With the ever increasing rise in fake news, we need to train and empower citizens and journalists alike to counter this rapidly growing misinformation disease. This can only be done through keeping abreast of latest tools and skill sharing from experts in various domains.

FactShala aims to bridge this gap between the two.

AS THEY SAY, MEDIA LITERACY DOES NOT MEAN "DON'T WATCH", IT **MEANS "WATCH CAREFULLY. THINK CRITICALLY". WHAT'S THE FACTSHALA'S PHILOSOPHY OF EDUCATION?**

FactShala has been built in mind not only on misinformation generated by conventional and social media but also on educating people about understanding media, analyzing content and equipping them with the skills needed to consume information critically.

Our training takes into account how one can think critically and out of the box. One has to be very observant when dealing with fake news and critical thinking helps to analyse patterns.

As BuzzFeed editor Craig Silverman puts it, "I also want to remind you of the first thing I talked about, which is that your brain is the most important tool. You have to be willing to look at the same sites and information again and again, to monitor them over time, and to apply the investigative mindset in order to find the points of connection or flaws.

DOES MEDIA LITERACY APPLY TO SOCIAL **MEDIA AND USER-GENERATED CONTENT?** ALSO DOES IT INCLUDE ONLINE SAFETY?

Media literacy is a holistic approach. It is inclusive and adopts a whole-of-society approach.

INTERNET WAS SUPPOSED TO BE A DEMOCRATIZING FORCE, WHAT WE SEE IS THAT WE ARE EXPOSED **TO INACCURATE INFORMATION. AS MISINFORMATION AND SO-CALLED "FAKE NEWS" CONTINUES TO SPREAD RAPIDLY ON THE INTERNET, OUR SOCIETY** HAS BECOME INCREASINGLY SHAPED BY FALSE INFORMATION. WHY ARE PEOPLE **SO SUSCEPTIBLE TO FAKE NEWS?**

Unfortunately, many of us live in 'filter bubbles' or enter into 'echo chambers'. We do not realise that we have been dragged so deep into these mines that regularly posting of articles makes us believe that they are true and we end up sharing them.

Most of the people who create fake news rely on evoking underlying biases that are already present in us and they stimulate that with morphed pictures or videos to shock or invoke a strong reaction.

AS IS RIGHTLY STATED, **MISINFORMATION HAS CREATED A NEW WORLD DISORDER. IT'S BIG,** IT'S SPRAWLING, IT'S HARD TO GET A HANDLE ON. IT'S FRIGHTENING WHAT IT CAN DO TO OUR LIVES. WHAT IS DRIVING THIS MISINFORMATION?

We have seen the effect of misinformation across various areas like politics (elections), health, etc. Some of these can be potentially devastating and lead to harmful actions taken by communities.

An incident which happened a few years back led to the unfortunate death of two people who were just passersby when the village folks mistook them for 'child snatchers'. The gruesome act was also recorded and shared online.

Fake news is deadly and needs to be curbed by putting in laws that penalise those who are creating them.

HOW IS MISINFORMATION ON SOCIAL MEDIA EVOLVING AND HOW "FAKE **NEWS" AND MISINFORMATION ONLINE IS CHANGING THE SOCIETY?**

Social media is the place where fake news is thriving.

It's unfortunate that a lot of people have suffered because of the spread of fake news. Many people have been wrongly quoted upteen times or past statements have been given a new twist to suit current ongoing news thereby stimulating propaganda.

HOW RESPONSIBLE ARE SOCIAL MEDIA **OUTLETS FOR MISINFORMATION SPREADING ON THEIR PLATFORMS? HOW DOES TECHNOLOGY ENABLE THE SPREAD OF DISINFORMATION? ALSO, WHAT ROLE** SHOULD MORE TRADITIONAL MEDIA PLAY IN ELEVATING OR DEBUNKING **GOOD OR BAD INFO?**

Social Media platforms like Twitter, Facebook, etc have to play an important role in debunking or atleast bringing to light the page or person behind the spread of mis/disinformation as these are the very places where such news is thriving.

Facebook has tied up with fact checkers across the globe to ensure

It is very useful at many levels. A full blown PR crisis can be averted if nor can the media alone do this. We have to act as a society together and work on this.

This is a good one. I would say 'other fact checkers'.

Today we have multiple fact checking organizations in India and almost everyone is tracking and correcting fake news. If one organization does put out a misleading statement, there are many others who would jump to correct them and this is also something we have seen in the past.

Doha: A top Qatari official involved in the country's World Cup organisation has put the number of worker deaths for the tournament "between 400 and 500" for the first time, a drastically higher number than any other previously offered by Doha.

The comment by Hassan al-Thawadi, the secretary-general of Qatar's Supreme Committee for Delivery and Legacy, ap-peared to come off the cuff during an interview with British journalist Piers Morgan.

It also threatened to reinvigorate criticism by human rights groups over what the toll of hosting the Middle East's first World Cup for the migrant labour that built over

200 billion worth of stadiums, metro lines and new infrastructure needed for the tournament. The Supreme Committee and Qatar's government did not immediately respond to a request for comment Tuesday.

In the interview, portions of which Morgan posted on-line, the British journalist asks al-Thawadi: "What is the honest, realistic total do you think of migrant workers who died from as a result of work they're doing for the World Cup in totality?"

The estimate is around 400, between 400 and 500," al-Thawadi responds. "I don't have the exact number. That's something that's been discussed."

But that figure hasn't been discussed publicly previously. Reports from the Supreme Committee dating from 2014 through the end of 2021 only include the number of deaths of workers involved in building and refurbishing the stadiums now hosting the World Cup.

Those released figures put the total number of deaths at 40. They include 37 from what the Qataris describe as



Ulema Have A Key Role To Play In Fighting Extremism: Ajit Doval

New Delhi: Ulema have a leading role in educating the people on the original tolerant and moderate principles of Islam and countering extremism with progressive ideas and thought, National Security Advisor Ajit Doval said Tuesday.

In his opening address at dia-logue on the "Role of Ulema in fostering a culture of Interfaith Peace and Social Harmony in India and Indonesia", Doval

said we need to work together to develop common narratives on deradicalisation. A delegation of Ulema and

representatives of other religions has come here with Coordinating Indonesia's Minister for Political, Legal and Security Affairs, Mohammad Mahfud MD.

The Ulema held a day-long dialogue with their Indian counterparts and other religious leaders at India Islamic

Cultural Centre on varied topics. In his opening address, Doval said, "Extremism and terrorism are against the very meaning of Islam because Islam means peace and well-being (Salamati/Asalaam).'

"In a democracy, there is no place for hate speech, preju-dice, propaganda, demonization, violence, conflict and misuse of religion for narrow ends," he said.

Underlining that both India and Indonesia have been victims of terrorism and separatism Doval said while the chal lenges have been overcome to a considerable extent, the phenomenon of cross-border and ISIS-inspired terrorism continue to pose a threat. "Cooperation of the civil so-

ciety is essential in countering the threat from ISIS-inspired individual terror cells and returnees from theatres like Syria and Afghanistan," he said. He said the essence lies in

disseminating our positive discourse far and wide and not merely reacting to the agenda set by inimical forces.

"State institutions also need to come together in detecting and identifying potential negative influencers and share information to counter their activities. In this, Ulemas, due to their deep connect with civil society, can play a vital role," he said.

He said the Ulema have a leading role in "educating the people on the original tolerant and moderate principles of Islam and countering radicalisation and extremism with progressive ideas and thought".

"Our youth should receive special attention towards this end. They are often the primary target of radicalisation, but if their energies are nurtured in the right direction, they can emerge as harbingers of change and building blocks of progress in any society," he said.

Doval said the Ulema must also be adept in the use of technology and use it to thwart propaganda and hate.

He said against the backdrop of tectonic shifts in the global order, India and Indonesia, given their rich history, diversity, shared traditions and increas ing bilateralism, have the potential to enhance prospects of peace, regional cooperation and prosperity in Asia.

India and Indonesia are home to the world's largest Islamic populations, Indonesia is the world's largest Islamic country, and India is home to the third largest Muslim population in the world, he said.

"Countries like India and Indonesia, with their experience of multi faith harmony and coexistence, can send a joint message to the world to eschew violence and conflict. This will be a powerful symbol of the determination of two large countries (together we have 1.7 Billion of the world population) to preserve and promote the true values espoused by religion," he said.

Doval said that together we should strive to propagate the moderate virtues of Islam as a beacon of hope and cooperation for the entire world.

In his keynote address, visiting minister Mahfud MD, NSA's counterpart in Indonesia, said we have many times witnessed people who use their religion as a doctrine of absolute truth and are quick to blame others.

"Ŵe have to go out of this and improve. Religion, I think, should be a source of peace, not the reason for discord, conflict, or violence. Religion should be a unifying tool, not a divisive instrument," he said.

The minister said the world is facing difficult challenges, ranging from poverty, climate change, food insecurity, pandemic, corruption, unemployment, armed conflicts, income inequality and human rights

around her legs and feet. When the "needle-pricking" didn't stop for three days, she was rushed to City's Noora Hospital where the doctors gave her immediate treatment and told her to avoid using electronic heating gadgets.

Apart from itching, there were rashes all over her legs. When she used to scratch them, she could sense skin cracking. "I was very worried," she said.

When Fareeda didn't respond to the treatment, she was rushed to the dermatology unit of SMHS Hospital where she found many patients like her.

"Most of them were using the heating blowers frequently," she said. "I wasn't alone facing the skin torment due to the heating appliances."

The people of Kashmir have sensitive skin which quickly reacts to any allergy, said Dr. Sajjad Ahmad, a dermatologist posted at Jawahar Lal Nehru Memorial Hospital, Rainawari, Srinagar.

"There are four basic types of healthy skin - normal, dry, oily and combination," Dr. Sajjad said. "Kashmiris fall in fourth category, as we've seen people with dry skin, eyes and lips getting skin related diseases more often."

During winters, the dermatologist said, people step out of their warm homes and develop cracks and become prone to infection. "Even if the people had to use the heating appliances during winter, they should use it judiciously," Dr. Sajjad said.

"People should open their body to direct heat and keep the heating appliance away from the children whose skins are soft and sensitive.'

But while people argue that they can't afford to spend winters without the heating gadgets, many medicos call for a monthly gadget review.

"A few years ago," said Dr. Nisar ul Hassan, President Doctors Association Kashmir (DAK), "an associate professor

of the SKIMS was charred to death during the night due to short-circuit in his electric blanket."

But while it's better to buy branded items to avoid any untoward incident, the doctor said, the heating appliances should get timely repairs and there should be ventilation in the room to avoid the rise of carbon monoxide inside the room.

"People should use these gadgets only when needed the most," Dr. Nisar said

BSF Shoots Down

The Constitution continues to be subverted by taking freakish excuses to deny Democracy to the people of J&K. The rulings of Supreme Court on time-bound restoration of democratic governments in States/UTs continue to be violated with impunity by the present rulers," read the memorandum.

In the memorandum, AAP has quoted various Supreme Court rulings on holding Assembly Elections within a period of six months in states and Union Territories where the assembly is prematurely dissolved. "It is now believed that the BJP may never allow elections in J&K as long as it remains in power. It is high time, therefore, that the ECI save the Constitution and democratic rights of the people of J&K," the memorandum read.

The memorandum further said that the J&K Legislative Assembly was suspended in June 2018 due to withdrawal of support by the BJP to the PDP. Thereafter, the Opposition parties, including the National Conference, Congress and the PDP offered to form the government claiming that they had the requisite numbers. They staked claim before the then governor on the strength of their majority in the legislature, yet the governor preferred to disolve the Assembly

The AAP pointed out that the Supreme Court on various occasions has held that Assembly Elections must be held within six months in all those States/UTs where Assemblies are pre-maturely dissolved.

In June 2018, the BJP withdrew support to the People's Democratic Party-led coalition government in Jammu and Kashmir. Since then, J&K has been without an elected government.

In August 2019, Jammu and Kashmir was stripped of its statehood and the special status granted under the Constitution. It was divided into union territories --- Ladakh and Jammu and Kashmir.

A joint statement issued by teach ing fraternity of Kashmir University and Jammu University here said that the decision was awaited since 2007 when the then union Ministry of Human Resource Development, Department of Higher Education, enhanced the age of superannuation from 62 to 65 years for teaching positions in centrally funded institutions in higher and technical edu-

cation institutions. "University Grants Commission (UGC) Committee in its report has also strongly recommended an increase in the age of superannuation of teachers to 65 years throughout the country in both State and Central Universities. The

Committee reached this conclusion after an in-depth analysis of the pros and cons of the matter," it reads

It added that the Economic Survey report for 2018-19 also recommended an increase in the retirement age considering the declining fertility rate and increased life expectancy. It stated that the services of healthier faculty beyond the age of 62 years needs to be better utilized because of the investments that have been made on them by the State during their studies, research career and for their capacity building.

"This decision is also far-reaching since it addresses the disparity that existed in the age of superannuation of teachers in the Central and State Universities in the Union Territory of Jammu & Kashmir despite similar recruitment, promotion and workload This disparity was discouraging very qualified and well-trained faculty from joining the State universities at higher positions," it reads

Concerns about Messi's health have dogged the seven-time world player of the year at the World Cup, starting from when he trained alone for two days before Argentina's opening game. He played the full 90 minutes against Saudi Arabia and also in the Mexico game, which he finished in some discomfort after turning his ankle late on.

Messi later confirmed it was nothing serious. But it only adds to the worries about the physical wellbeing of a 35-year-old player who is clearly pacing himself during matches, picking and choosing his moments to explode into life.
