A team, including researchers from the Indian Institute of Technology (IIT) Mandi, has developed a new material that can generate electricity from household light sources like LED or CFL.

A light-emitting diode (LED) is a semiconductor device that emits light when current flows through it while a compact fluorescent lamp (CFL) is a fluorescent lamp that uses a tube which is curved or folded to fit into the space of a light device.

The research, published in the journal Solar Energy, supports the internet of things (IoT) technology that is being increasingly used in mobile phones, smart homes, and other applications that require various kinds of real-time data.

These IoT devices are required to run independently without being dependent on electrical grids for power supply. Primary and secondary batteries are currently used to power such devices, the researchers said.

All batteries, irrespective of their kind, have a finite lifespan and are neither cost effective nor eco-friendly. Light-induced power generators are promising alternatives to batteries for powering such devices, they said.

Solar cells use the light from the Sun to produce power, but since many of the IoT are used indoors, solar light is not an option.

An alternative is to find methods to harness light from indoor lighting sources to generate enough power to run indoor devices such as sensors, gadgets, Wi-Fi routers, Radiofrequency identification (RFID) readers, etc.

Suicide Blast Targeting Police Truck Kills 3, Injures Over 20 In Pakistan

WhatsApp Bans Over 2.3 Million Accounts In India In October Agencies

NEW DELHI: Instant messaging and voice-over-IP service WhatsApp on Wednesday said the firm banned over 2.3 million accounts in the month of October, according to a spokesperson of WhatsApp.

In another statement, it said as many as 811,000 of these 2.3 million accounts were proactively banned, before any reports from users.

A WhatsApp's spokesperson in a statement said, "WhatsApp is an industry leader in preventing abuse, among endto-end encrypted messaging services. Over the years, we have consistently invested in Artificial Intelligence and other technology, state-of-the-art data scientists and experts, and in processes, in order to keep our users safe on our platform."

The spokesperson said, "In acordance with the IT Rules 2021 we've published our report for the month of October 2022. This user-safety report contains details of the user complaints received and the corresponding action taken by WhatsApp, as well as WhatsApp's own preventive actions to combat abuse on our platform." As captured in the latest monthly report, WhatsApp banned over 2.3 million accounts in the month of October, according to the spokesperson.

According to the firm's statement, in addition to responding to and taking action on user complaints through the grievance channel, WhatsApp also deployed tools and resources to prevent harmful behaviour on the platform. It said, "We are particularly focused on prevention because we bel is much better to stop harmful activity from happening in the first place than to detect it after harm has occurred." It said the abuse detection operates at three stages of an account's lifestyle: At registration, during messaging, and in response to negative feedback, which we receive in the form of user reports and blocks. The statement from WhatsApp said a team of analysts augments these systems to evaluate edge cases and help improve our effectiveness over time

Prannoy Roy, Wife Radhika Resign As **Adani Group Nears Takeover Of NDTV**

NEW DELHI: NDTV founders Prannoy Roy and wife Radhika Roy have resigned as the directors of promoter group vehicle RRPR Holding Private Limited as the Adani Group neared takeover of the television channel.

RRPR, which has been acquired by Adani Group, held 29.18 per cent stake in the news channel.

The Roys, however, still hold a 32.26 per cent stake in NDTV as promoters and have not resigned from the board of the news channel.

In a stock exchange filing late on Tuesday, New Delhi Television Limited said the two had resigned as directors on the board of RRPR Holding Private Limited (RRPRH) with immediate effect.

Prannoy Roy is the Chairperson of NDTV and Radhika Roy is an Executive Director.

The board of RRPR Holding has approved the appointment of Sudipta Bhat-



tacharya, Sanjay Pugalia and Senthil Sinniah Chengalvarayan as Directors on its board with immediate effect, NDTV said.

The three are nominees of Adani Group which had earlier this week had taken control of RRPR Holdings.

More than a decade ago, Roys had taken an interestfree loan of over Rs 400 crore from a company that the Adani group acquired in August. In exchange, they issued warrants that allowed the company to acquire a 29.18 per cent stake in the news group. RRPR, or Radhika Roy Pran-

noy Roy Holdings Private Limited, is the promoter of NDTV. It held 29.18 per cent stake in the news channel. The conversion of warrants into equity because of nonpayment of the loan, gave the Adani group entity almost all shares of RRPR Holdings.

Pugalia is the chief executive officer and editor-inchief of media initiatives at the Adani Group.

Post its acquisition, the Adani Group is also conducting an open offer running between November 22 and December 5 for a 26 per cent stake in NDTV.

RINAGAR: Six people, including four children, were killed and two others injured in separate incidents across ammu region since yesterday.

According to reports, unidentified gunmen barged into the house of a village defence committee (VDC) member, Gyan Singh, after hurling a grenade towards it and resorted to indiscriminate

firing on the inmates killing four of his minor children and injuring two others at Sharjao village

in Mahore area of Udhampur district last night.

Official sources said today that about 10 suspected militants first threw grenades on Singh's house at Jailanmarh-Sharjao village at around 2245 hours and then barged into it. The victims were sleeping at the time.

The victims were identified as Hoshiar Singh (15), Bika Devi (12), Anju (3) and Darshana Devi (12). Singh and another member of his family, who were injured in the attack had been admitted to hospital, the sources said.

However, a NAFA report said Singh's house was adjacent to an army camp. Security forces cordoned off the entire area this morning. However, no arrests were made.

In an encounter between the security forces and militants. two militants were killed at Gudesa in Banihal area of Doda district yesterday. The deceased were identified as Muhammad Hasil alias Usman r/o Banihal and Muhammad Raliq alias Bambar s/o Ghulam Targal.

Lingering War

In Ukraine has slipped under the radar. But the war is, meanwhile, going on, and the two sides are nowhere closer to either a military victory or on the path of a negotiated settlement. It is, however, true that Ukraine backed by NATO support has made some important battlefield gains. Russia despite reverses, remains still in a commanding position on the ground. While the war looks set to go on for now, it has left far-reaching implications for the geopolitics. In South Asia too, Ukraine war has tested the ability of the countries to navigate their relationship with the USled bloc and China-Russia sphere of influence.

example, in South Asia, India has found itself in a tough situation to straddle its alliance with the US and its longstanding relationship with Russia. And so far it has been successful in pursuing a tight balancing act. While New Delhi has gone along with the west as for as the illegitimacy of the war, it has refused to abandon Russia. The west has found it difficult to countenance this assertion on the part of India. As a probable result, recent months have witnessed a newfound warmth between the west and Pakistan. This shift became apparent by the sudden rekindling of US-Pakistan ties.

Though the US tilt towards India is still there, the US in recents weeks has made an effort to accommodate Pakistan which under Imran Khan was threatening to draw closer to China-Russia axis. But with Khan's loss of power in a no-confidence vote which he blames on the US, Washington has sought to repair its otherwise frayed relations with Islamabad and has also begun to respond to its concerns. The US has also made it known that it may be playing a furtive role to get India and Pakistan to restore engagement.

Developments like these have been a source of concern for New Delhi which sees it as a renewed appeasement of Pakistan. Many analysts in India see it as a punishment for India's pursuit of an independent foreign policy in response to the ongoing war in Ukraine. Besides abstaining from western resolutions against Russia, India continues to import oil from the country at discounted rates, something that has not pleased western countries.

But India has stood firm. Rather than joining the western camp, India has sought to play a mediatory role in resolving the Ukraine crisis. Prime Minister Narendra Modi during his meeting with Russian president Vladimir Putin on the sidelines of the recent Shanghai Cooperation Organization meeting told him that "this is not an era of war" and that the Ukraine issue should be settled by diplomacy. At the end of the day, India will be better served by serving its own interests and this requires the country to strike a balance between the demands of the west and the concerns of Russia, its longstanding ally.

The Collegium Debate

n a recent interview, Rijiju, who described the Collegium system as "alien" to the Constitution, said, "Never say that the government is sitting on the files, then don't send the files to the government, you appoint yourself, you run the show." Justice S K Kaul's response to this petulant framing of the matter as a Court versus government faceoff was measured: "It came from somebody high. Should not have. All I can say is, it should not have happened." The bare facts are that there are vacancies in the apex court while the government is refusing to approve the names cleared by the Collegium for appointment as judges. The Court had reiterated the same suggestions after the government returned the files for reconsideration. If propriety and the law suggest that the government approve them, the law minister has sought to discredit the process itself by suggesting that it is also unconstitutional.

For long, the judiciary and the government have had their disagreements on how SC judges are to be appointed. The Centre proposed the National Judicial Appointments Commission (NJAC) to replace the Collegium system in 2015, but a five-judge constitutional bench of the Supreme Court struck down the Act a year later. Clearly, the executive has not reconciled with the rejection of the NJAC. But as Justice Kaul said on Monday, "maybe you have reservations on the law... But till the law stands, it is the law of the law... if the government says it will delay or not adhere to the law of the land, tomorrow somebody else may say something like this about another portion of the law". As Justice Kaul said, the government should "look at the larger picture" The larger picture is dismal. Despite a 2020 judgment that fixed timelines to clear appointments, recommendations are stuck at the government's end. Such delays, Justice Kaul remarked, have affected recruitments with good candidates reluctant to join the judiciary. Shortage of judicial officers is a major reason for pendencies, which has been repeatedly flagged by the Court.

Yet, Rijiju has a point about the opacity in the system and, fortunately, judges, too, are veering towards the idea of institutionalising a system of transparency and evaluation that brings some sunlight into the appointment process without compromising its integrity. As this government has said so many times, and with reason, especially during Emergency anniversaries, that Indira Gandhi's idea of a "committed judiciary" is the death knell of a democracy. The Constitution is clear on the balance of powers, the Supreme Court's pushback against what tantamounts to overreach by the political executive is timely and welcome. In parallel, the court should step into overdrive when it comes to reforms within — that make it more transparent and accountable, the twin pillars on which independence often rests. *The Indian Express* Presidency, we shall present India's experiences, learnings and models as possible templates for others, particularly the developing world. Climate Change Warriors on an **Assertive Streak**

After successfully getting a Loss and Damage Fund established, the climate change warriors have also launched legal actions against unresponsive governments

They want the court to rule that the country's climate policies violate the human rights of its citizens. According to Anton Foley, spokesman for the youth-led initiative Aurora, which prepared and filed the lawsuit. Sweden has never treated the climate crisis as a crisis. Sweden is failing to fulfil its responsibilities and is breaking the law.

Earlier, in one of the most high-profile cases, Germany's highest court ruled last year that the government's climate targets must be adjusted to avoid undue burden on the young.

t seems that Climate Change is now gaining real traction and importance for the common people more and more, but our politicians are not ready to take any notice of these changes, which are going to have immeasurable negative impact on the lives of billions of people across the globe.

Besides calls for wealthier nations to provide compensation to underdeveloped countries to cover the costs of severe damage and losses, citizens of some countries have also initiated legal proceedings against their governments for inadequately addressing the climate change fallouts.

The month of November saw two environmentrelated incidents taking place. First, at the latest COP summit at Sharm El Shiekh in Egypt, termed as 'Africa's COP', the voice of the most-vulnerable and most-affected countries was heard with an agreement to establish a loss and damage facility.

However, progress is still snail-paced in terms of raising ambitions to curb greenhouse gas emissions. Leaders attempted to keep that goal alive at the Egypt conference, but did not increase calls to reduce carbon emissions.

November also saw hundreds of activists, including Greta Thunberg, marching through the streets of Stockholm to a court to file a lawsuit against the Swedish government for what they claim is insufficient climate action.

Lawsuit by Swedish citizens

Over 600 young activists signed an 87-page document, which would serve as the foundation for the lawsuit, which was filed in the Stockholm District Court.

The German government responded by pushing back its target for net zero emissions by five years to 2045 and laying out more ambitious near and medium-term steps to achieve that goal.

What emerges from this is that people all across the world are increasingly becoming aware of the damages wrought by the Climate Change, and also understanding that who is the main culprit for unleashing this catastrophe, in pursuance of greed and lucre.

What is loss and damage?

The Alliance of Small Island States at international climate negotiations in Geneva in 1991, first introduced the concept of loss and damage, but it was not seriously considered again until 2013 at the COP-19 climate conference in Warsaw, Poland.

The Warsaw International Mechanism for Loss and Damage was created with the aim of enhancing knowledge of the issue and finding ways to approach it. There has been little progress since then.

The Glasgow COP, last year rejected a proposal made by members of the G-77 group of over a hundred developing countries and China for a formal loss and damage financial facility. Instead, in a bureaucratic manner, the Glasgow Dialogue was established for further discussion on the issue and it's funding.

Critics have described the dialogue as "an excuse to delay further action." It seems as if the rich countries are dragging their feet on financing any such endeavour.

While historically, between 1751 and 2017, the United States, the European countries and the UK were responsible for 47% of cumulative carbon dioxide emissions, as compared to just 6% from the entire African and South American continents. Yet, the culprits have been slow to make financial contributions to ease the impact on the most affected countries. In 2010, Global North nations agreed to pledge \$100 billion (101 billion) annually by 2020 to help developing countries adapt to the impacts of climate change.

But according to the Organisation for Economic Cooperation and Development (OECD), which tracks funding, in 2020 wealthy countries pledged just over \$83 billion. That was a 4% increase on the previous year, but it still falls short of the agreed amount.

What's the impediment?

Though in principle, developed nations acknowledge the need to address loss and damage,

some amongst them argue for financing through existing climate funds, insurance schemes and humanitarian aid. Their reluctance is reflected in the European Union's briefing, for example, which said that it was "open to discussing L&D (loss and damage) as a topic but hesitant about creating a dedicated L&D fund.'

Former British PM and WHO ambassador for global health financing, Gordon Brown has realistically opined that the announcement of the new initiative - the global loss and damage fund - to right historical wrongs by compensating climatehit developing countries, might be a good feel factor but the real question is whether the developed world will really loosen its purse strings?

This breakthrough, he says, brought back memories of another initiative, the £100 billion a year agreed at the 2009 Copenhagen climate summit to help poor countries mitigate the effects of the climate crisis.

Brown says further that that money has never fully materialised. If 13 years' experience of the £100 billion fund that never was is anything to go by, eulogies of praise will soon turn into allegations of betrayal. Far from the loss and damage fund narrowing the credibility gap on climate action, it is likely to bridge nothing if money fails to flow from rich to poor.

What is needed, however, is not less but more aid to help developing countries tackle the dramatic consequences of an unprecedented series of crises. Indeed, developing countries, unlike advanced economies, had no fiscal, monetary, or social space at the onset of these crises, to raise the issue.

One key priority for the global community should be not only to increase aid but also to make it much greener to help developing countries tackle the challenge of climate adaptation in an effective manner. Green aid encompasses financial and technical assistance to governments and direct investments in projects in both mitigation and adaptation to climate change.

Israeli Filmmaker Reacts to Backlash On 'The **Kashmir Files'**

JERUSALEM: Unfazed by the widespread criticism of his comments against the Hindi film "The Kashmir Files", Israeli director and IFFI international jury chair Nadav Lapid said he stands by his remarks as he "knows how to recognise propaganda disguised as a movie".

Reacting to the backlash he received for calling "The Kashmir Files" a "vulgar" and "propaganda" movie, Lapid said making bad films is not a crime, but the Vivek Agnihotri directorial is "crude, manipulative and violent".

"Making bad films is not a crime, but this is a very crude, manipulative and violent propaganda film," Lapid said in an interview with Israeli newspaper Ha'aretz.

According to the filmmaker, he felt it was his "duty" to speak his mind as the head of the international jury.

"The truth is that I also couldn't help but imagine a similar situation that might happen one day soon in Israel, and I would be happy that in such a situation the head of a foreign jury would be willing to say things as he sees them. In a way. I felt it was my duty to the place that invited me," he said.

The award-winning filmmaker had called out "The Kashmir Files", which was screened at the International Film Festival of India (IFFI) on November 22 under the Indian Panorama section, at the closing ceremony of the nine-day festival in Goa on Monday.

The team of "The Kashmir Files", including writer-director Agnihotri, stars Anupam Kher and Pallavi Joshi, several BJP leaders including Goa CM Pramod Sawant as well as Israel's Ambassador to India Naor Gilon and Consul General to Midwest India Kobbi Shoshani panned Lapid. Sudipto Sen, one of the members on the jury, said remarks expressed by the Israeli filmmaker were his "personal opinion".

Lapid, known for his anti-establishment views, alleged that "The Kashmir Files" was "pushed into the official competition" of the festival.

"We learned that the film was pushed into the official competition of the festival due to political pressure... I feel as a foreigner who arrives there, you have an obligation to say the things that the people who live there may have a harder time saying

"In such contexts I don't believe in secrets and whispers. If you stand on stage and are asked to speak, what will you talk about? Only about the beaches you saw and the food you ate?" the filmmaker said.

"The Kashmir Files" had received both bouquets and brickhats for its portrayal of the exodus of Kashmiri Pandits during militancy in the early 1990s upon its March 11 release. It is one of the biggest Hindi commercial successes of 2022.

cepted he "of course did not know enough"

He, however, defended himself saying "you can also watch films by Leni Riefenstahl (a German filmmaker who glorified the Nazi Party) and know what you're seeing, without being a great expert on that period." "There are cases that are nuanced, but this is not the case. In a way. 'The Kashmir Files' makes life easy because it is so bare and aggressive, that it doesn't even mask itself intelligently," said the Parisbased director. On the criticism he has received from Israel diplomats in India, Lapid said his comments were "political" but not representative of his country

Amid the social media backlash and on-ground protests by Kashmiri Pandits in Jammu, the acclaimed director found support in Congress leader Supriya Shrinate, Shiv Sena MP Priyanka Chaturvedi, and actor Swara Bhasker.

He claimed he has received hundreds of emails and messages from cine personalities from India "who are happy about it" and for them "finally things were said that they believed in".

"Since this is a film that the Indian government encourages, I assume that the government there is not happy about it. But is a country only about its government? "I assume not. What I said is not comfortable for the Government of India, nor for the government in the making in Israel, which the ambassador there represents," Lapid asserted.

Asked if he would change anything in the way he expressed his opinion that led to the uproar, Lapid said he was invited to the festival as a director and he talked about a film's subject.

"I did not come to express one position or another on the conflict in Kashmir..." he said.

In another interview to Israel's news website Ynet, Lapid said at the IFFI stage India's Union Minister for Information & Broadcasting Anurag Thakur and Israel's ambassador discussed "fighting a similar enemy and are in a bad neighbourhood".

In the interview to Ynet, Lapid also said he shared his views at the closing ceremony with a lot of "discomfort and apprehension".

"I knew that this was an event that is terribly connected to the country, and everyone stands there and praises the government. It is not an easy position, because you are a guest.

"I am the president of the jury here, you are treated very nicely. And then you come and attack the festival. There was apprehension, and there was discomfort," he said. In countries that are increasingly losing the ability to speak the truth "someone needs to speak up", he said. "When I saw this movie, I couldn't help but imagine its Israeli equivalent, which doesn't exist but could definitely exist. So I felt I had to, because I come from a place that is itself not reformed, and is itself headed this way," Lapid added.

Delhi HC Allows Mehbooba To Withdraw Plea Challenging PMLA Provision

NEW DELHI: The Delhi High Court on Wednesday permitted PDP leader Mehbooba Mufti to withdraw her petition challenging the constitutional validity of a provision of the Prevention of Money Launder-

ing Act (PMLA). The lawyer appearing for the former Jammu and Kashmir chief minister told a bench of Chief Justice Satish Chandra Sharma and Justice Subramonium Prasad about her decision to withdraw the petition which was filed in March 2021. The petition also challenged

the summons issued to her by the Enforcement Directorate in a money laundering case and sought a stay which the court had earlier declined. The court was informed the

issues raised by the petitioner have already been addressed by the Supreme Court in a decision. Mufti had in her plea sought declaring section 50 of the Pre-



vention of Money Laundering Act void and inoperative, being unfairly discriminatory, bereft of safeguards, and violative of Article 20(3) of the Constitution. Section 50 of the Act empow-

ers the ED authority to summon any person to give evidence or produce records. All summoned are bound to answer the questions put to them and to produce documents as required by the ED officers, failing which they can be penalised.

Initially, the ED had summoned Mufti for March 15, 2021 but it did not insist on her personal appearance at that time. Thereafter, she was summoned for March 22, 2021. Mufti, in her petition, said

she has received summons from the ED under the provisions of the PMLA, purporting to call for 'evidence' on pain of punishment, whereas she is, to all intents and purposes, a subject of investigation. The plea claimed ever since

Mufti was released from preventive detention following abrogation of Article 370 of the Constitution, there has been a series of hostile acts by the State, against her, her acquaintances and old family friends who have all been summoned by the ED and a roving inquiry about her personal, political and financial affairs was made. The ED, it alleged, seized their personal electronic de-

vices in the course of inquiry. The Centre had told the high court last year it has filed a plea before the Supreme Court seeking transfer of Mufti's petition to the top court as several pleas concerning various provisions and scheme of

PMLA were pending there.

BSF To Train Kashmiri Shepherds' Dog Breed For CI Ops, Border Patrolling

JAMMU: The Border Security Force (BSF) has decided to train Kashmiri shepherds' dog breeds for ongoing counter insurgency operations and surveillances along the borders in Jammu and Kashmir.

'The BSF's National Institute for Dogs Training is an institute of excellence and right know we are promoting the Indian dogs breeds like Rampura hound, Rajapalayam Hound, and Mudhol Hound which we are currently under training," said Director General of Border Security Force, Pankaj Kumar Singh during Annual Press Meet

on its 57th foundation day. He further added that in Kashmir, "we are in process to train Bakerwals (shepherd) dog breed called 'Gaddi', which is very impressive."

'The 'Gaddi' hounds are very loyal to master, quick leaner and ably guarding the entire livestock in very harsh weather conditions, where others found difficult to even survive," he said The DG BSF said as per ex-

pert Dog trainers, the Indian dogs are quick learners and their probability of errors are relatively less than foreigner breeds. Once trained, these dogs will be introduced to the field for assisting troops on operations and patrolling activities at the borders.

"The Dog squads are very important component of security forces. In anti-terror operation in Jammu and Kashmir, the Dog team is the first responder in these operations. The success of these operations mostly depends on the highly trained Dogs," he said, adding that "Along with the usage of High Tech equipment like drones and cameras in antiterror operations, the trained canines from the dog squad are fitted with GoPro cameras and Walkie-Talkies used for giving commands to these dogs during operations. This has proven to be one of the main reasons for

He said that the Dogs from the Unit are sent first to detect the location of the hideout, the location of the hiding terrorists and detecting the arms and ammunition the terrorists are carrying.

"The cameras fitted on these Dogs are monitored through a control room.

These dogs are trained to enter the location of the hiding terrorists without getting noticed by terrorists. The dogs are also trained not to bark during these operations," he said, adding that "if these dogs are noticed by the hiding terrorists and are attacked by them. the dogs respond with an attack too. The handler of the dog always keeps a strong vigil as to how the situation is.

Forces use various breeds of Dogs in the Dog Units across India which includes Labradors, German Shepherds, Belgian Malinois and Great Mountain Swiss Dogs. So far Indian breeds, Mudhol Hound is part of these units too, the DG BSF said.

These dogs are used for various purposes like guard duty, patrolling, sniffing explosives including Improvised Explosive Devices (IEDs), mine detection, sniffing contraband items including drugs and attacking targets etc.

"We have eight major specialities of army dogs in the Indian army, they are used for explosive detection, mine detection, tracking, search and rescue operations, avalanche rescue missions and many other specialities which are as per the requirement," he said-(KNO)

Telcos To Stop 5G Services In High-Frequency Bands In And Around Airports

NEW DELHI: Telecom operators will need to shut down 5G services in high-frequency bands in and around airports following restrictions imposed by the Department of Telecom at the request of the civil aviation ministry, according to sources. Based on buffer and safety

zone details provided by the aviation ministry, the DoT has asked telecom operators to not install 5G base stations in the 3.3-3.6 Ghz band in the area of 2.1 kilometres from both ends of the runway and 910 meters from the centre line of the runway of Indian airports with immediate effect.

'Telecom operators will need to shut down 5G service in the 3.3-3.6 Ghz band only in and around airports based on the order. It is a temporary restriction. The services can be restored after DGCA (Directorate General of Civil Aviation) ensures that altimeters at all aircraft have been replaced. DGCA has not shared any timeline for completing the replacement exercise." a source told PTI.

Airtel is the only telecom operator that has installed 5G services at select airports, including at Patna, Bengaluru, Pune, Varanasi and Nagpur.

The DoT notice dated November 29 has asked telecom operators to tilt down 5G base stations to avoid interference of 5G signals with that of altimeters-- a device which helps pilots maintain the desired height of the aircraft.

The DoT in the notice said that DGCA is expected to complete the altimeter replacement exercise in a proactive and timebound manner.

DoT has requested DGCA to provide a timeline for replacement of radio altimeters and its filters with a sharp cut-off date. "Further, DGCA should communicate geo-coordinates of four corners of all the airstrips where such limitations or restrictions are required to be placed on 5G systems, within 30 days from issue of this letter," the notice dated November 29 said.

RBI's Modified Digital Lending Norms To Come In Effect From Today

NEW DELHI: The Reserve Bank's modified guidelines on digital lending that seek to protect customers from exorbitant interest rates by certain entities and also check unethical loan recovery practices will come into effect from Thursday.

Under the new norms, all loan disbursals and repayments are required to be executed only between the bank accounts of borrower and the regulated entities (like banks and NBFCs) without any pass-through/ pool account of the Lending Service Providers (LSPs).

Also, "any fees, charges, etc, payable to LSPs in the credit intermediation process shall be paid directly by RE and not by the borrower", the Reserve Bank said in a press release while conveying the regulatory stance.

Executive Chairman of Andromeda Loans, V Swaminathan, said, that since digital loans and online repayments have gained more prominence post-pandemic, the need of the hour is competent systems and processes that would further strengthen data privacy and security of confidential information shared between customers and regulated entities.

While the cost of compliance may be significant for busi-



nesses that haven't revamped their core business models, we need to trust the central bank as it tackles government issues and consumer complaints related to digital lending platforms, such as the deployment of arbitrary collection strate-

gies," he said. While issuing the guidelines in August, the RBI had said the instructions are applicable to the 'existing customers availing fresh loans' and to 'new customers getting onboarded'.

Founder, Vivifi Finances said the RBI has standardised the cost disclosures with a uniform Key Fact Statement (KFS) that details an all-in APR (Annual Percentage Rate), which factors in all the fees and interest

that are being charged to the customers, empowering them with the ability to compare this rate across banks and NBFCs.

"Licensed and compliant players will have an edge over fintechs with other NBFC partnerships, and are likely to see rising market share in the future," Pinapala said, and added the decision by the RBI will protect the consumer and level the playing field from the customer's perspective.

Core Sector Output Growth Slows To 20-Month Low

NEW DELHI: The growth rate in the production of eight key sectors slowed down to a 20-month low of 0.1 per cent in October on account of contraction in the output of crude oil, natural gas, refinery products, and cement, according to the official data released on Wednesday.

In October last year, these sectors expanded by 8.7 per cent. In September this year, the core sectors' output growth stood at 7.8 per cent.

Last time it was in February 2021, when the eight infrastructure sectors -- coal, crude oil, natural gas, refinery products, fertiliser, steel, cement and electricity -- recorded a negative growth of 3.3 per cent.

The growth rate during April-October this fiscal was 8.2 per cent as against 15.6 per cent a year ago. In October, crude oil, natural gas, refinery products, and cement output recorded negative growth rate.

However, fertiliser output rose by 5.4 per cent in the month under review.

The growth rate in the production of coal, steel and electricity slowed down to 3.6 per cent, 4 per cent and 0.4 per cent respectively. These numbers have implications on the

India To Grow 6.8-7% This Fiscal: CEA

NEW DELHI: The Indian economy is on track to achieve a 6.8-7 per cent GDP growth in the current fiscal. Chief Economic Advsior V Anantha Nageswaran said on Wednesday.

He said the economic recovery momentum is continuing and the GDP is averaging the 2019-20 level.

"Overall, the real GDP growth in 2022-23 is on track to be in the range of between 6.8-7 per cent," he said, adding that festival sales, PMI, bank credit growth and auto sales data show that the economy has maintained momentum despite strong global headwinds, especially higher input cost and monetary tightening.

After clocking a 13.5 per cent growth in April-June quarter, the economic expansion slowed to 8.4 per cent in July-September period. The growth in the first half of this fiscal (April-September) stood at 9.7 per cent. The economic growth last fiscal (2021-22) was 8.5 per cent.

The IMF (International Monetary Fund) has projected Indian economy to grow at 6.8 per cent this fiscal, while the RBI has pegged it at 7 per cent.

"In uncertain external environment and despite exports not doing as well as it did last year, domestic demand will drive GDP growth... Domestic inflation is expected to ease further on softening commodity prices and expectation of some good rabi crop," Nageswaran told reporters after the September quarter GDP numbers. PTI

The World Cup proved to be a major disappointment for Den-mark after reaching the semifinals in the 2020 European Championship. They slogged through a 0-0 draw in their opening match with Tunisia and then recovered in a 2-1 loss against France.

The Danes attacked from the start against Australia but could never break through with the Socceroos.

Captain Ben Stokes is among several England players who skipped Wednesday's optional training session after being laid low by the bug. Former captain Joe Root was one of five players who did attend.

"As far as I'm aware, a few guys are not feeling 100%,"

Root told a news conference. "I didn't feel great yesterday and I woke up a lot better today. So, hopefully, it's a 24-hour virus. Don't think it's like food poisoning or COVID or anything like that.

"We are trying to do absolutely everything right to make sure we are prepared for this game." England have named their starting 11, giving a test debut to Liam Livingstone and recalling Ben Duckett to open with Zak Crawley.

The Pakistan Cricket Board (PCB) said it was in touch with its English counterpart and added late on Wednesday that the two unanimously agreed to delay the decision on the commencement of the test until 7.30 a.m local time (0230 GMT) on Thursday.

"The two boards also agreed, subject to the England players not recovering well enough to take the field on Thursday, then the test will commence on Friday and will be a five-day match," the PCB said in a statement.

"In this scenario, the schedule of the second test in Multan and the third test in Karachi will remain unaffected and will be played as per original schedule -- Dec. 9-13 and Dec. 17-21."

BSF Procures **2 SUV-Mounted** Jammers, 100 Drones

New Delhi: The BSF has procured two SUV-mounted jammers, more than 1,400 hand-held thermal imagers and about 100 drones for surveillance and security activities along important Indian frontiers with Pakistan and Bangladesh, a senior officer said Wednesday.

The Border Security Force (BSF) has also identified a total of 635 "vulnerable patches" all along the 2,289-km-long international border with Pakistan and along West Bengal and Assam (as part of the India-Bangladesh border) for installing surveillance systems developed in-house by the force.

The force has procured two vehicle-mounted jammers, onboard Mahindra Scorpio vehicles, for protecting troops against remotely triggered IEDs during their movement in Jammu and Kashmir (from Jammu to Srinagar in convoys), the officer said.

A CRPF bus carrying 39 personnel, apart from one official on road opening duty,

were killed when a terrorist rammed an explosive-laden vehicle in their convoy on February 14, 2019 while they were moving on the Jammu-Srinagar highway.

The BSF has also placed orders for procuring a total of 1,424 hand-held thermal imagers (HHTIs) for its border security units, he said. The gadget is used to detect movement of terrorists along the front during night time and foggy climate. Almost 100 small and big

drones have been procured by the force for watching the border areas and "we have also received a sanction from the Union home ministry for purchase of an equal number of more such drones or unmanned aerial vehicles (UAVs)", the officer said.

The BSF, raised in 1965, has 193 battalions on ground at present and has an overall strength of 2.65 lakh personnel. It is primarily deployed for guarding Indian frontiers with Pakistan and Bangladesh apart from rendering a variety of duties in the internal security domain of the country.

India-US Military Drills Near LAC Violate The Spirit Of Sino-India Agreements: China

Beijing: China on Wednesday said it was opposed to the joint Indo-US military exercises being held near the Line of Actual Control (LAC), asserting that it violates the spirit of the two border agreements signed between New Delhi and Beijing.

The 18th edition of the India-US joint military exercise 'Yudh Abhyas' is currently underway in Uttarakhand, about 100 km from the Line of Actual Control (LAC). It aims to enhance interop-

erability and share expertise between both armies in peacekeeping and disaster relief operations. The nearly two-week exer-

cise began earlier this month. "The joint military exercise between India and the US close

to the LAC at the China-India border violates the spirit of the agreement between China and India in 1993 and 1996," Chinese Foreign Ministry spokesman Zhao Lijian told a media briefing here.

"It does not serve the mutual trust between China and India", he said in response to a question posed by a correspondent from Pakistan.

Chinese Foreign The Ministry's reference to the 1993 and 1996 agreements is interesting as India termed the People's Liberation Army's (PLA) attempts to move a large number of troops to the disput-ed areas in the LAC in eastern Ladakh in May 2020 violated the bilateral agreements which state that the boundary question is resolved through peace-

ful and friendly consultations.

The military exercise is



conducted annually between India and the US with the aim of exchanging best practices, tactics, techniques and procedures between the armies of the two nations. "The 18th Edition of India-

US Joint Exercise #YudhAbhyas commenced today at Foreign Training Node, Auli. The aim of Joint Exercise is to enhance interoperability & share expertise between both the Armies in Peace Keeping & Disaster Relief #IndianArmy Operations. #IndiaUSFriendship," the Indian Army tweeted on November 19.

The previous edition of the exercise was conducted at Joint Base Elmendorf Richardson, Alaska, the US in October 2021, officials said.

The Ministry of Defence here on November 15 had said that US Army soldiers of 2nd Brigade of the 11th Airborne Division and Indian Army soldiers from the Assam Regiment will be participating in the

exercise.

The joint exercise will also focus on humanitarian assistance and disaster relief

(HADR) operations. Troops from both nations will practice launching swift and coordinated relief efforts in the wake of any natural calam-

The exercise between the armies of India and the US will facilitate both armies to share their wide experiences, skills and enhance their techniques through information exchange. In August, the Chinese mili-

tary expressed similar concern over the India-US military exercises.

Since the June 2020 Galwan Valley clash between Chinese and Indian armies, bilateral ties between the two countries have taken a severe hit.

India has consistently maintained that peace and tranquility along the LAC are important to the overall development of bilateral relations with China.

Karnataka HC upholds ban on PFI with immediate effect

Bengaluru: The High Court of Karnataka has upheld the recent ban imposed on the Popular Front of India (PFI) and stated that the Centre has the power under the Unlawful Activities (Prevention) Act, 1967 to ban an organisation with immediate effect.

A single judge bench of Justice M Nagaprasanna on Wednesday pronounced the judgment in a petition challenging the Union government's recent ban on PFI. The ban was challenged by Nasir Pasha, a resident of Bengaluru and the state president of the proscribed outfit. "The proviso to sub-section (3)

of Section 3 permits the Central Government that in the event it is of the opinion that circumstances exist which renders it necessary for the Government to declare an association to be unlawful with immediate effect, it may for reasons to be stated in writing direct that the notification shall have effect from the date of its publication in the official gazette," Justice Nagaprasanna said in his

judgment. The Centre is empowered under the proviso to bring in any notification declaring any organisation to be unlawful with immediate effect, the judge said, adding that the only rider to this is that reasons should be recorded in writing. The government had issued an order banning the organisation

and its allied outfits for a period of five years with immediate effect on September 28. The Centre took this action after raids on the offices of PFI and the residences of its members across the country. The senior counsel for the pe-

titioner had argued that there

was no warrant to bring the notification into operation with immediate effect and there are no separate reasons recorded for the said purpose.

The counsel had submitted that a fundamental right under Article 19(4) of the Constitution cannot be taken away in a perfunctory manner without recording separate reasons for bringing into effect the notification with immediate effect.

However, the Union government contended that "in the notification itself sufficient reasons are indicated for bringing into effect the notification with immediate effect. Though no separate notification is issued, it is not a case where there are no reasons recorded in writing as is necessary under the proviso to sub-section (3) of Section 3 of the Act."

The High Court accepted the government's arguments. "A perusal at the notification under challenge would indicate that reasons are present in the notification itself. Article 19(1) (c) of the Constitution of India on which much emphasis is laid on is also hedged with reasonable restrictions to be imposed in certain circumstances under Article 19(4) of the

Constitution of India," it said. Citing earlier judgments that had upheld bans on organisations in similar circumstances, the HC dismissed the petition stating, "In the light of the judgment rendered by the High Court of Delhi in the case of Islamic Research Foundation which was considering the case of Mohammad Jafar rendered by the apex court and the fact that reasons are found in the impugned notification itself, I do not find any warrant that would entail interference at the hands of this court."

Replying to a question on Pakistan's alleged involvement in terror activities along the International Border, he said, "It is not possible that such activities (infiltration, drone flights) are done without the involvement of their (Pakistan) security agencies. They fully support them (terrorists) and are part of these operations." "We keep protesting with our Pakistan counterparts for these activities," he added. When asked about the terrorists who entered through the tunnel via Samba and engineered the attack on Sunjwan, he said, "The tunnel was detected and the terrorists who came through killed. It shows the coordination of the security forces." Calling narco-terrorism an effort to finance terror operations, Boora said, "We did not allow it to be successful on the Jammu border." Asked about the alleged involvement of a BSF officer in the recruitment scam being investigated by the CBI, he said the officer was being probed.

sub-inspector recruitment scam in the Union territory.

The Central Bureau of Investigation (CBI) arrested Singh on October 18 for allegedly using touts to get his son the question paper of the recruitment examination conducted by the Jammu and Kashmir Services Selection Board (JKSSB) in March.

Rejecting the bail plea, Justice Mohan Lal said there is every danger of the course of justice being thwarted, if the petitioner is freed on bail.

"Offence indicated against the petitioner is heinous and grave in nature and such types of offences are to be dealt with severity and with iron hands. Showing leniency in such matters would be really a case of misplaced sympathy," Justice Lal said in his 14-page order.

Advocate General Additional Monika Kohli, appearing for the respondents in the case, vehemently opposed the grant of bail to the accused arguing that the petitioner has indulged in criminal conspiracy with officials of JKSSB and the company assigned the task of conducting the written examination.

She said as many as 33 accused persons are indicted in the case registered against the petitioner who is the "mastermind" of the scam.

Kohli said the investigation is underway and more accused are likely to be arrested for sustained interrogation and if the petitioner/accused is enlarged on bail it will be difficult for the investigating agency to unearth the inter-state gangs operating in several states.

Agreeing with the argument of Kohli, who is also the CBI counsel, the was required to exhibit high integrity, official conduct and decorum above board, but has displayed a character of "unbecoming of a person of defence force".

"He has been found indulged in criminal conspiracy with other accused persons in a huge scam of irregularities in the written examination of J&K Police Sub-Inspectors posts in regard to leak of question papers and their sale in lieu of money, wherein the investigating agency so far has recovered a cash amount of Rs 61.79 lakh," he said.

The Jammu and Kashmir administration had cancelled the police subinspector recruitment process in July following allegations of irregularities and recommended a CBI probe.

On November 12, the CBI had filed a charge sheet against 24 persons, including Singh, who along with coaccused allegedly used a network of middlemen and officials of Jammu and Kashmir Police and central paramilitary forces to target aspirants willing to cough up Rs 20-30 lakh to get through the recruitment process.
