Student Enrollment Improved In J&K Schools During Last 4 Years GER In Higher Secondary Level Up By 10%, Secondary By 2 Percent

Srinagar: In the last four years, Jammu & Kashmir's Gross Enrollment Ratio (GER) in higher secondary and secondary level has increased by over 10 percent and 2 percent, respectively; reveal the figures emerging from Government of India's latest Unified District Information System For Education Plus (UDISE+).

As per the reports accessed and analyzed by Kashmir Observer, J&K's GER since 2018 has increased to 10.8 percent in higher secondary level in 2022 and 2.4 percent in secondary level in the past four years.

The data available with the

Kashmir Observer states that in 2018-19 J&K's GER in higher secondary level was 42.4 percent and in 2021-22 the figures increased to 53.2 percent. For the secondary level, in 2021-22, J&K recorded 60.5 percent against 2018-19's 58.1 percent. In 2019-20, J&K's GER in higher secondary level was recorded at 38.4 percent and in the same period, GER in secondary level stood at 58.7 percent.

Gross Enrolment Ratio or Gross Enrolment Index is a statistical measure used in the education sector by the Government to determine the number of students enrolled in school. The GER can exceed



100% because of early, late entry or grade repetition. Pertinently, in 2018-19 J&K had

28,654 schools including both secondary level and higher secondary level schools. However, in 2021-22, with an addition of 151 more schools, the total number of schools functioning in J&K increased to 28,805.

When compared with the data from previous years, the number of total schools in Kashmir came down. In 2020-21, with an addition of 276 more schools against 2018-19 data, the total number of schools functioning in J&K had increased to 28,930.

In 2019-20, J&K had 28,863 schools including both secondary and higher secondary level educational institutes.

Besides this, as per the reports, in 2021-22, J&K had a total 344485 students enrolled

in secondary level, of which 182592 were boys and 161893 were girls. In 2018-19, enrollment of students in secondary level in J&K was 3,22,717, of which, 171863 were boys and 150854 were girls. In 2019-20, J&K had a total of 328628 students enrolled in secondary schools of which 174451 were boys and 154177 were girls. In 2020-21, J&K had a total 337787 students enrolled in secondary level, of which 179809 were

boys and 157978 were girls. The report also added that in 2018-19, J&K's total student enrollment in higher secondary schools was 231398 including 123040 boys and More on P6

Centre, EC Defend J&K Delimitation Exercise, SC Reserves Verdict

New Delhi: The Centre on Thursday told the Supreme Court that a delimitation commission formed to redraw the Legislative Assembly and Lok Sabha constituencies in Jammu and Kashmir was empowered to do so.

Seeking dismissal of a plea challenging the government's decision to constitute a delimitation commission. Solicitor General Tushar Mehta, appearing for the Centre, told the top court that the Jammu and Kashmir Reorganisation Act. 2019 does not preclude the establishment of Delimitation Commission by the Central government. "By virtue of Sections 60-61, while the power to determine delimitation is conferred on Election Commission, Section 62(2) and 62(3) confers powers to carry out delimitation on the Delimitation Commission

constituted under Section 3 of the Delimitation Act." Mehta told a bench of Justices S K Kaul and Abhay S Oka which reserved its verdict on Thursday. On March 6, 2020, Union

Ministry of Law and Justice (Legislative Department) had issued a notification in exercise of power under Section 3 of the Delimitation Act, 2002, constituting a Delimitation Commission, with former Supreme Court judge (Retd) Ranjana Prakash Desai as the chairperson.

The Solicitor General also opposed the submission of the petitioners that Article 170 of the Constitution barred delimitation exercise on the basis of the 2011 census.

He said petitioners are wrong in their submission that delimitation exercise had to either happen on the basis of 2001 census or await "the first census after the year 2026." "The idea was More on P6

J&K Issues New Rules For Ladakh Deputations

Srinagar: The Lieutenant Governor Manoj Sinha led administration on Thursday notified new guidelines for the deputation of employees of Jammu and Kashmir to the Union Territory of Ladakh.

According to the guidelines, all the administrative departments/ HoDs/ controlling offices shall maintain a complete database of employees relating to their period of deputation/ service in Ladakh region.

While processing the proposals for deputation to Union Territory of Ladakh, the eligibility and suitability of the concerned employees and the interest of government work shall be given the utmost priority, the guidelines state.

"The convenience of the employees may also be considered, as far as possible," reads the guidelines. "Employees deputed

from Union Territory of Jammu and Kashmir shall, as far as possible be posted at or around the District/ Sub Divisional headquarters of Leh/ Kargil Districts," they further state.

As per guidelines, all proposals relating to deputation of employees to Union Territory of Ladakh and any repatriation from said Union Territory, shall be submitted to the General Administration Department for seeking approval of the competent authority in terms of the provisions of the Jammu and Kashmir Reorganization Act, 2019.

The government has also notified the calendar for transfers. According to the order, transfers of teaching staff shall only be ordered in the first month of the financial year i.e. April every year.

Three different cities on three separate continents are the best places for expats to live and work, according to a new sur-

Spain's Valencia topped the InterNations Expat City Ranking list 2022 - with respondents raving about quality of life, public transport and sporting opportunities - followed by Dubai, which was lauded for the welcome it gives new arrivals. Mexico City came in third for its affordability.

Not faring so well was Johannesburg, which ranked bottom of the 50-strong list, with those surveyed branding the South African city unaffordable and unsafe. Sitting just above it are Germany's Frankfurt and the French capital Paris, which both scored poorly when it came to affordable housing.

Miami was the highest-ranking North American city on the list, in 12th place, with New York clocking in at number 16 and Toronto in 19th position. In the UK, London limped in at 40th place.

Elsewhere in Asia, Bangkok came in sixth thanks to its low cost of living, Melbourne's work-life balance earned it eighth spot, and Singapore rounded out the top 10.

InterNations collected information from 11,970 expats living in 181 countries or territories. Fifty cities met the sample size requirement of at least 50 participants per destination.

'New Potential Drug Target To Treat Heart Disease Found'

cientists have uncovered details of a phenomenon that contributes to coronary artery disease, more commonly known as heart disease, an advance that may lead to new drug treatments for fighting heart disease, according to a study.

Soon after cholesterol and fat start depositing on the lining of the blood vessels that supply your heart, the smooth muscle cells that give the blood vessels strength and flexibility start to get bigger and multiply.

While scientists studying the phenomenon suspect these vascular smooth muscle cells are trying to help, this atypical behavior for these strong cells instead contributes to coronary artery disease.

In a bit of a vicious cycle, stents as well as bypass grafts used to treat coronary artery disease can prompt the same response.

report new insight into how the cells enable this unhealthy growth and a new target to intervene.

The endothelial cells that line our blood vessels are in constant communication with the layers of vascular smooth muscle cells that encase them and play

a key role in regulating our blood pressure, said Yuqing Huo, director of the Vascular Inflammation Program in the Vascular Biology Center at MCG.

In states of good health, for example, the two cell types share messages about how it is time for our blood vessels to dilate a little because we are exercising. Early in vascular disease, however the conversations change, said Huo, corresponding author of the study in the journal Circulation.

"They get the message that something is wrong," said Huo, and existing cells get exponentially bigger and start proliferating, which these cells don't normally do, perhaps in an effort to make more room inside for

blood to flow since cholesterol and fat are narrowing the existing passageway.

Normally, the smooth provide muscle cells strength. If they start to proliferate a lot, it changes their identity," Huo says.

Whatever the reason, the result is more narrowing and scarring of the vital passageway for blood and worsening disease. So, the scientists looked at the building blocks needed to enable the unhealthy response.

They knew that growing more and bigger cells required more DNA, RNA and the proteins they produce. To make that happen required more purines, one of two chemical compounds in the body used to make the building blocks of DNA, in this case adenine and guanine.

What they didn't know was precisely how these cells make more purine when faced with arterial disease, says Dr. Qian Ma, postdoctoral fellow with Huo and the study's first author.

Rath Yatra Begins To 'Liberate' Sufi Shrine

ew Delhi- Hundreds of VHP and Bajrang Dal activists chanting Vande Mataram swarmed the city of Chikamagalur In Karnataka today even as security was put **N** on maximum alert to thwart their attempts to occupy a shrine dedicated to a Sufi saint.

The VHP and Bajrang Dal have threatened to 'liberate' the shrine of sufi saint Baba Budangiri situated atop a hill some 30 kms from the city centre. The VHP Bajrang Dal activists swarmed the city as five Rath Yatras from different corners of Karnataka and one from Maharashtra wound their way through the busy thoroughfares before culminating in a rally.

The procession passed off peacefully under the watchful eyes of the rapid action force and the Karnataka Reserve Police which were deployed in strength.

Karnataka Chief Minister J H Patel said a tight security cover had been thrown at Baba Budanagiri Hill named after the disciple of Muslim Saint Hazrat Dada Hayath Meer Khalandar and warned of stem action against law breakers

The Karnataka High Court today directed the state government to take steps to preserve the Shrine's sanctity as top Union Ministry official M B Kaushal flew in here to review the

situation. In New Delhi, Union Home Minister L K Advani told parliament the centre was in touch with the Karnataka government to ensure communal harmony and peace at the Shrine as an agitated opposition sought to rap the Vajpayee government for not taking steps to stop the yatras.

The opposition led by Congress in Lok Sabha today charged the Vajpayee Government with not taking any action to stop the reported Rath Yatra being planned by VHP and Bajrang Dal activists to liber-ate a shrine dedicated to a sufi saint near Chikmagular in Karnataka.

Senior Congress leader P. Shiv Shanker warned during zero hour that permitting such a yatra would disrupt peace and communal harmony in Karnataka and have a direct fallout on the rest of the country.

While asking the Centre to take prompt action to stop the yatra, he demanded the house should also strongly condemn the move by BJP's frontal organisations.

Former Prime Minister H.D. Devi Gowda said both Hindus and Muslims, over the years, had been offering prayers at the shrine dedicated to Sufi Saint Baba Budangiri. There has been no question of a confrontation so far. Gowda asserted the Kar-nataka Government was capable of handling the situation and would not allow these activists to enter the shrine.

Shiv Shanker said by directly or indirectly encouraging such acts, the Vajpayee government had shown that it was not in a position to effectively run the affairs of the country. He said the minorities were restless

Slowing Economic Growth

India's economic growth has slowed to 6.3 percent in the third quarter of 2022-23 compared to 13.5 per cent in the second quarter due to the contraction in output of manufacturing and mining sectors, government data revealed on Wednesday. But despite the slower GDP growth in the July-September period, India remains the fastest-growing major economy ahead of even China which recorded a growth of just 3.9 percent in the quarter. Last year, India's economy had grown 8.4 percent in the third quarter. As is apparent, India's growth rate is now averaging pre-pandemic level, signalling a fast recovery from the contagion.

India's steady growth rate over the last one year will go a long way to bring the lost jobs back. The last three years have seen global economy go from crisis to crisis which hit the global economy, including that of India very hard. Russia's invasion of Ukraine which followed soon after the pandemic was receding made things worse. Its repercussions are still playing out across the global economy. One major fallout of the war has been that the world's three largest economies - the United States, Europe and China - are stalling. This has triggered worldwide inflation, fuelled by the pause in exports of food grains from Russia and Ukraine. The two countries are big food producers. Ukraine is the world's biggest producer of sunflower oil, and Russia is number two. Together they account for 60 percent of global production. They also account for 28.9 percent of global wheat exports. This temporarily caused the wheat prices to trade at their 15-year highs. But the prices have since retreated to levels last seen before the Russia's invasion.

This has also impacted India's economy. Inflation touched record levels this year pushing most essential items, including food products beyond the purchasing power of the common man. Those at the bottom of the pyramid have been hit the hardest. Situation has been further exacerbated by the growing unemployment. It was 9.5 per cent in the second quarter. The unemployment rate in urban areas declined to 6.6 per cent in third quarter as against 9.3 per cent a year ago. The continuing war in Ukraine will not be good for the world economy. If the war drags on in Ukraine, India's economy is likely to come under severe stress. Skyrocketing oil prices will also wreck the European economy. Therefore, it is incumbent on the world to come together to resolve the crisis in Ukraine and find a solution that addresses the concerns of all the parties involved. And if the war lingers, the global economy could very well plunge into recession. And India's economy won't be immune to it.

Qatar World Cup Old Wive's Tale of White Colonial Capitalist Greed

s the World Cup kicked off last week, liberal European and American attacks on Qatar's human rights record, including an Amnesty International report, filled the airwaves and social media, with much focus on migrant workers and LGBTQ rights and the religiosity of the country.

The passions that football has given rise to over the decades, however, seem oblivious to the colonial, racial, national and capitalist history of the sport.

Indeed, the question of human rights did not seem to perturb white liberals much before the 2018 games in Russia, or this year's in Qatar.

That liberal human rights concerns more often than not fully reflect those of the imperialist US and European countries is hardly coincidental.

Liberal hypocrisy

When England hosted the World Cup in 1966, homosexuality was still illegal, and remained so in Scotland until 1980 and in Northern Ireland until 1982. When the law was finally amended, it merely "decriminalised private homosexual acts between men aged over 21, while at the same time imposing heavier penalties on street offences".

As for workers' rights, ongoing discrimination against non-white workers was rampant, including in British trade unions.

Britain maintained its colonial holdings across the globe, from the then defiant white settler-colony of Rhodesia to Hong Kong and the Malvinas (Falkland) Islands to what were yet recent crimes against the Kenyan people who had just obtained independence in 1963. They were of little concern to human rights defenders.

Qatar itself was at the time under British colonial rule.

Britain then, as now, still had blasphemy laws and the Church of England remains its official religion. Still, it hosted the World Cup without complaint from Europe's civil libertarians, least of all from Amnesty International Amnesty refused to adopt them, as allegations of torture, in Amnesty's estimation, were not "justified".) When the World Cup was held

in the United States in 1994, half the US states had anti-sodomy and antihomosexual laws, and the widely disseminated claim that Aids was a "gay disease" had not yet subsided. The country was proceeding at the time with its sanctions against Iraq, which led to the death of half a million Iraqi children.

black men on the streets of US cities became a public scandal in 1991, when the video of police violence against Rodney King in Los Angeles went viral. This aside from the ongoing New Jim Crow system of incarcerating Black people in US prisons, to which the Bill Clinton administration contributed significantly; the use of prisoners as slave labour as permitted by the 13th

The campaign has been so intense that Israel, one of the world's biggest violators of human rights, including non-white migrant workers' rights, waxed moral about Qatar's record.

Fifa's president, the Swiss-Italian Gianni Infantino, responded to onship, established in 1919, and vied for the North African Cup, established in 1930.

Similar to other European colonialists, the Zionist movement, since its founding, was most invested in sports and athleticism. One of its founders, Max Nordau, emulated the Protestants by calling for a "Muscular Judaism". Nordau founded gymnasiums for Zionist Jewish youth across Europe.

Due to British influence and missionary schools, the Palestinians already had a few football teams at the beginning of the 20th century. Once the British conquered Palestine in 1917, they used their sports to normalise and integrate the Jewish colonial settler population they were introducing to the country through sports clubs, to which they invited the colonists and the natives to join, so as to forestall native Palestinian resistance.

But the plan did not work, and most of the teams remained separate and independent of the British. Soon, the Zionist colonists set up the Palestine Football Association, which remained exclusively Jewish (save for one Palestinian who joined only one of its directorate meetings), even though it marketed itself to Fifa as representing Mandate Palestine.

Only teams of colonists played in its championship, where the Zionist anthem was played.

Anti-colonial resistance

Despite British intentions, the colonised Palestinians, like the Indians and the Egyptians before them, saw football as a way to assert their anti-colonial nationalism. They organised more sports clubs in the 1930s independent of the British colonial government.

In 1931, the Palestinians established their own Arab Palestine Sports Federation, which had 10 clubs as members, but it would disappear amid the Palestinian Revolt of 1936-1939.

In 1944, despite ongoing British harassment, the Palestinians set up the Arab Palestine Sports Association, which 21 Palestinian clubs joined. By 1947 it had 65 clubs as members. It held its football championship games in 1945 in Jaffa. Indeed, a Palestinian team beat the British army team in a match that

Selective rage

Incidentally, Mr Guterres's revelation comes at a time when India is grappling with coming to terms with the brutal murders of two women: Shraddha Walker was killed and dismembered by her live-in partner in Delhi; soon after, a man in Uttar Pradesh murdered his former girlfriend in a similar manner. These grim crimes are, however, consistent with data on violence against women and girls. The Asia-Pacific region accounted for the highest number of intimate partner or family-related femicides in 2021. The National Crime Records Bureau has found that crimes against women have increased by 15.3% in 2021 over the previous year, while the general crime rate has risen from 56.5% in 2020 to 64.5% in 2021.

But these murders do not tell the whole grisly tale. Broader reactions to the women's deaths are instructive in ascertaining the embedded social malaise. Consider Ms Walker's case. In a telling indication of the prevailing socio-political mood in India, there have been relentless efforts to link the crime to 'love jihad', the bogey peddled by bigots who allege that the minority community lure Hindu women into marital unions. Another perverse sentiment was echoed by none other than a public representative — a Union minister — Kaushal Kishore, who blamed 'live-in' relationships for the abuse inflicted on women. Evidently, the civilised idea of women exercising their own agency in choosing their partners has no place in Mr Kishore's patriarchal universe. Shockingly, the victim has also been vilified for ignoring red flags; this only goes to show how superficial the collective understanding is of the underpinnings of abuse. This prevalent culture of victim-shaming can be put in perspective. Data from the National Family Health Survey indicate that such are the deep roots of toxic masculine mores that a significant percentage of married women end up justifying - and, hence, perpetuating — the violence that is inflicted upon them.

It is imperative that domestic abuse is understood as the consequence of larger processes. The inequitable distribution of power and resources among the sexes, to cite one of the structural anomalies, leads* to institutionalisation and even valorisation of violence against women. Law as a deterrent is in place. It must be complemented by timely and empathetic intervention to check abuse; there must also be adequate scope of rehabilitation for women lacking a support system. Equally important are discussions on agency, consent and bodily integrity; these must begin at the earliest, at home and school. Righteous indignation at the violation of women is not enough. It must be accompanied by the societal ability to identify concealed conditions that are catalysts of violence. *Telegraph India*

In 1974, when West Germany

hosted the World Cup, the population in that country was experiencing its latest wave of government repression.

In 1972 the West German government began to purge "radicals" from the civil service (which then included 20 percent of the West German workforce). West German trade unions routinely expelled "activist" members. The Federal Office for the Protection of the Constitution investigated 2.5 million citizens.

In fact, 800,000 applicants for civil service jobs were investigated regarding their "allegiance" to the constitution. A policy of blacklisting, or "Berufsverbot" - for signing petitions, joining demonstrations, etc - of those deemed guilty ensued.

A crackdown on universities, dismissal of teachers, and "voluntary" withdrawals of "questionable" books by publishers was the order of the day. Whereas Nazi anti-homosexual laws, which remained on the books, were repealed in 1969, official anti-homosexual discrimination continued in the country until 2000.

West German racism against Turkish migrant labour was also rampant. Indeed, most of the leadership of West Germany's Justice Ministry between 1949 and 1973 were former members of the Nazi party, including dozens of former paramilitary SA members.

The campaign has been so intense that Israel, one of the world's biggest human rights violators, waxed moral about Qatar's record

But West Germany hosted the World Cup without complaint from Europe's civil libertarians, least of all Amnesty International (which was urged to intervene on behalf of the Baader-Meinhof prisoners who staged a hunger strike in German prisons, protesting against torture. amendment to the US constitution, and the ongoing violation of Native American rights.

But the US hosted the World Cup without complaint from European and US civil libertarians, least of all Amnesty International (whose report that year criticised the death penalty, and police brutality, and the forcible return of Haitian refugees, but not anti-homosexual laws, let alone the abuse of migrant workers, etc).

When the US hosted the Olympics in 1996 in Atlanta Georgia, Amnesty's annual report did not even mention the Olympics and repeated its usual criticisms of the death penalty, police violence, and forced repatriation of Haitian refugees it had made in previous years. It did however release a short statement condemning the execution of one man by the state of Georgia.

In contrast, Human Rights Watch (HRW) released a report in 1996 about the state of Georgia's death penalty, anti-sodomy laws, racism, and anti-poor policies, criticising the fact that the city was hosting the Olympics despite this bad record (in its 1994 report on the US, HRW made no mention of anti-sodomy laws).

Neither group, however, was part of an international orchestrated campaign against the US being the host to the Olympics. Indeed, as the US, Canada, and Mexico will be hosting the next World Cup, no campaign has been raised as of yet about the three countries' ongoing human rights violations.

It should be noted that the US won the joint bid to host the 2026 games in 2018 during the Donald Trump administration.

Between 1863 and 1877, football rules were standardised, prohibiting any form of handling the ball. This would also coincide with the rise of the Protestant notion of "Muscular Christianity" that combined proselytising faith and sports to the heathens.

The imperial export of football would then begin in earnest. Its spread in Europe led to the formation of Fifa in 1904 by the football associations of France, Germany, Belgium, Sweden, Spain, Denmark, Switzerland and the Netherlands, which they called Federation Internationale de Football Association (Fifa).

Fifa established the World Cup in 1930. Europeans continue to control the sport's world governing body: all of Fifa's presidents have been white Europeans, except a white Brazilian president who was the son of Belgian immigrants, and one Cameroonian acting president who assumed office for less than five months in 2015-2016.

The British introduced their games to their colonies as a way of teaching the barbarians discipline and teamwork and inculcating Christian values. When they brought football to Calcutta in the 1880s, only British referees were allowed.

By 1911, an Indian team, the Mohun Bagan, defeated the British East Yorks Regiment 2-1. In Egypt, native teams began to play against British teams as early as 1916, and competed in the Olympics from 1924 onwards.

Not to be outdone, the French also brought football to their colonies in North Africa. Teams from Algeria, Morocco and Tunisia competed in the North African champiyear, to the cheers of Palestinians.

Whereas the Palestinian Association sent teams to play in neighbouring Arab countries and Iran, it was unable to register with Fifa, which had already recognised the Jewish colonists' association as representing Mandatory Palestine.

Arab sports associations protested against Fifa's decision. As the Zionist conquest of Palestine in 1948 was proceeding, Fifa was in the process of reconsidering the Palestinian and Arab applications.

But if colonised peoples used football against their colonisers to assert anti-colonial passions, it would also lead to endemic hooliganism among British and other European spectators, and to nationalist discord between the colonised themselves, especially in the Arab world.

In Jordan, football has been, since the late 1970s, one of the main arenas to stage an exclusivist Jordanian identity and nationalism against Palestinian identity and nationalism in the country. It is an ongoing conflagration which led last month to the death of a child, who was killed by another child after a match between Al-Wehdat and archrivals Al-Faisaly, leading to the intervention of public personalities from both sides to contain the crisis.

The continuing rivalry between the Algerian and Egyptian teams since 2009 led to diplomatic and popular enmity between the two countries. This aside, national pride in French-Algerian (Zinedine Zidane) and Egyptian (Mohamed Salah) players who play on European teams spans the entire Arab world.

iving with clinical depression can be particularly challenging because the disorder saps one's energy and capacity to carry out regular activities. It is precisely this lack of motivation that makes recovery so challenging. For the majority of us, our obligations to work, study, and our families need a certain amount of routine. However, clinical depression has a way of making us lose interest in, control over, and motivation for such large tasks, as well as for regular self-care. We need to establish a routine in these situations to get us through to happier days. But managing a routine might need a lot of concentration and willpower. Here are some ideas for using routine to your advantage when treating clinical depression.

1. MORNING ROUTINE: GETTING THE DAY STARTED:

Take a look at this scenario. As you lay in bed, your alarm clock rings. You're not at all interested in standing up. Isn't it odd how your bed grows more and more inviting as the excuses to get out of bed mount? Perhaps getting dressed and taking a shower seem as difficult as drafting that procrastinated business report. However, waking up, cleaning up, and dressed in something other than your favorite trousers might have a significant impact on how you feel. Break up your morning routine into smaller, easier-to-manage chores if the notion of accomplishing all these things at once seems overwhelming.

2. MONITORING YOUR ROUTINE

Try making a day planner and getting on a schedule if you find it difficult to establish and maintain a routine or if your routine contains a lot of bad habits. You can also use this planner as a journal to keep note of changes in your mood. You'll be able to identify patterns by contrasting your day's plans with what you accomplished for the day. This can help you identify habits that you might have previously overlooked. Utilize your planner to handle the activities or times of day that give you anxiety or worry. You can get ready for times when you experience depression by keeping track of your emotional patterns.

3. EXAMINE YOUR DAILY ROUTINE

Whether we are conscious of it or not, the vast majority of us usually run on a routine. Sleeping, eating, taking a shower, and working are common daily cycles. Tracking these recurrent behaviors enables us to proactively manage clinical depression symptoms and makes it easier for us to make mental health-related decisions. Keeping up good habits and avoiding bad mental and emotional decisions would be ideal, but depression sometimes prevents such good behaviors from occurring. Assessing your existing daily routine can help you to realize how the power of routine can benefit you.

WHAT SHOULD BE PART OF YOUR ROUTINE?

It's challenging to specify with precision what you should include in your daily schedule because everyone has different life goals and challenges. The affects of depression vary from person to person, too. However, when regularly practiced, the following actions can help alleviate depression:

Having a consistent bedtime and wake-up time. Even though it may be challenging for people with erratic schedules, doing this is essential if you're going through a depressive episode. Additionally, ensure that you receive enough sleep in order to maintain a healthy circadian rhythm, which will help regulate mood and brain health. Aim for regular sleep because difficulty getting asleep, trouble staying asleep through the night, or excessive sleeping may be symptoms of major depressive disorder. If maintaining consistency isn't your thing, tracking your sleep as part of your daily routine will allow you to assess your sleeping patterns.

Set aside time each day to concentrate on your self-care. Finding small victories in healthy tasks can be satisfying, even though it can be difficult to muster the energy for

self-care.

Having a poor appetite or overeating is one of the signs used to identify clinical depression. By including meals into your schedule, you may maintain a consistent meal plan. Get into the habit of regular intake, whether you eat the usual three meals a day or customize your diet to your demands.

Make it a habit to exercise to ward off and treat clinical depression. Our bodies produce a lot of endorphins during exercise, which can improve mood. When we exercise, the prefrontal and limbic regions of the brain produce large amounts of endorphins. You can thwart Major Depressive Disorder by consistently performing activities suitable to your skills.



My Town My Pride: CS Emphasis On Delivery Of Services, Efficiency Says Prabhari Officers To Mentor Their Towns For Few Years

Jammu: Chief Secretary, Dr Arun Kumar Mehta today remarked that the 'Prabhari Officers' for towns under 'My Town My Pride 2.0' should assimilate themselves into the ethos of these places as they are going to mentor these for few years.

He made these comments while speaking during an interactive session held to sensitize the visiting officers about this programme.

The meeting was attended by all the Administrative Secretaries, Divisional Commissioners, Deputy Commissioners and other senior officers besides the designated visiting officers for all the 78 ULBs.

Kashmir based officers participated in the meeting through video conferencing.

Dr Mehta impressed upon them to be proactive throughout this programme and have close allegiance with them so that the relationship is long-lasting and favorable. He observed that there are sufficient funds at the disposal of PRIs and they should be assisted fully to develop efficient plans for the people of respective areas.

The Chief Secretary also made out that focus should be on service delivery instead of creating the infrastructure only. He maintained that soft power like Aadhar Card, Golden Card, Property Certificate, Land Passbook, Ration Card, enrolment in Social Security Schemes are equally significant for people. He stated that these services empower people and make access to utilities easy. He asked the officers to create ample awareness among public about all the online services and portals created by the government during past few years.

He laid emphasis on formulation of different plans like City Tourism Plan, City Livelihood Plan, City Cleanliness Plan and others in consultation with the locals and elected Municipal bodies. He sensitized all the officers about the importance of such activities and called upon

Competition Among Congress Leaders To Abuse Me, Teach Them Lesson By Voting For 'Lotus': PM Modi

Ahmedabad: Prime Minister Narendra Modi on Thursday said there is a competition among Congress leaders as to who will use the most abusive words against him, referring to the opposition party president Mallikarjun Kharge's 'Ravan' jibe at him.

Before Kharge, another Congress leader had said the party will show Modi his 'aukat' (place), the PM said, apparently referring to Madhusudan Mistry's remark last month.

Addressing a poll rally at Kalol town in Panchmahal district of Gujarat, Modi said such abusive words used for him were an insult of Gujarat and its people because he was raised by the people of this land.

He asked people to teach the Congress leaders a lesson by voting for the 'lotus' (BJP's symbol) in the state elections. Kharge on Monday night ad-

dressed a rally in Behrampura area of Ahmedabad city where he said the prime minister asks people to vote "looking at his face" in all elections. "Are you 100-headed Co like Ravan," he had said. us

On Thursday, Modi said, "I respect Khargeji but he has to follow orders of the party high command. He was compelled to say that Modi has 100 heads like (demon king) Ravan."

"But, the Congress did not realise that Gujarat is the land of Ram Bhakts. Those who never believed in the existence of Lord Ram, have now brought in Ravan from Ramayana just to abuse me," the PM said.

"And, I am surprised they never expressed repentance, forget about tendering an apology, after using such cuss words for me. Congress leaders think it is their right to use abusive language for Modi and insult the country's prime minister," he said.

In an apparent jibe at the Gandhi family, Modi said Congress leaders are abusing him because their allegiance is towards a family, not India's democracy.

"For them, that family is everything. They will do anything to make the family happy. There is a competition among Congress leaders as to who will use the most abusive and most toxic slurs for Modi," he said.

One leader even used such words during his (leader's) Pakistan visit, the PM said.

He said the opposition leaders have used all kinds of slurs for him, like "he will die a dog's death, he will die Hitler's death and one even said he will kill Modi if he gets a chance".

Modi said such abusive words used for him were an insult of Gujarat and its people because he was raised by the people of this land.

"There is only one way to teach them a lesson. Vote for the BJP on December 5 by pushing a button (on EVM) near lotus. And I want to tell the Congressmen that our lotus will bloom more every time you indulge in mudslinging," he said.

Voting is underway on Thursday for the first phase of the Gujarat Assembly elections in 89 out of the total 182 seats in the state.

The remaining 93 seats, including Kalol, will go to polls in the second phase on December 5.

108358 girls. In the same category, in 2021-22, J&K had 294473 student enrollment including 157488 boys and 136985 girls.

As per the report, in 2018-19, there were 170449 total teachers in J&K including 90865 male and 79584 females. In 2021-22, there were 167106 teachers in J&K of which 86779 were males and 80327 were females. In the same category, in 2020-21, there were 172129 teachers in J&K of which 90119 were males and 82010 females. In the same category, in 2019-20, J&K had 173183 teachers including 91087 males and 82096 females.

The report further added that in 2021-22 the Pupil Teacher Ratio was 13 in secondary level and 28 in the higher secondary level. Similarly, in 2018-19, J&K's Pupil Teacher Ratio was 13 in secondary level and 21 in higher secondary level. In 2020-21, the Teacher Pupil Ratio (TPR) was 12 in secondary level and 26 in the higher secondary level and in 2019-21, J&K's TPR was 12.1 in secondary schools and 20.2 in higher secondary schools.

According to the data, the enrollment of Children with special needs (CWSN) was 17946 including 10489 boys and 7457 girls for the Primary to Higher Secondary (1 to 12) category in 2021-22. Regarding tenure of deputation, the government said the employees shall be deputed for a period of two years to Union Territory of Ladakh. "The period of two years shall be counted from the date of joining of such employees in the Union Territory of Ladakh", the order states.

The fresh guidelines state that an employee, who has completed the prescribed tenure of two years in the Union Territory of Ladakh, shall not be deputed to Union Territory of Ladakh for a second term. "However, in case of non- availability of suitable substitute and in case of specific request made by the Administration of Union Territory of Ladakh, an employee may be considered for deputation for another term, in the interest of administration," read the guidelines.

The guidelines further mentioned that no employee having residual service of less than two years shall be deputed to Union Territory of Ladakh. "In exceptional circumstances, and, if a specific request is made by the administration of union Territory of Ladakh, officers having less than two years residual service may be considered for deputation to Union Territory of Ladakh", the guidelines state. Rebutting the "false information", the Jammu and Kashmir Police said the police headquarters has made available adequate funds to all its units for salary of its employees including those covered under the NPS.

Earlier, Additional Director General of Police (ADGP), Kashmir, Vijay Kumar, also said the report was fake.

"Regarding a #fake news doing rounds on social media that the salary of Police personnel hadn't been paid for past 2 months. It's hereby clarified that every DDO has got sufficient funds in salary heads," the ADGP Kashmir said in a tweet.

It had said the last delimitation commission was set up on July 12, 2002 in exercise of powers conferred by section 3 of the Delimitation Act, 2002 after the 2001 census to carry out the exercise throughout the country.

The plea had said the commission had issued guidelines and methodology for the delimitation of assembly and parliamentary constituencies vide letter dated July 5, 2004 along with the constitutional and legal provisions.

"It clearly stated that the total number of existing seats in the Legislative Assemblies of all states, including UTs of the National Capital Region and Pondicherry, as fixed based on the 1971 census shall remain unaltered till the first census to be taken after the year 2026," the plea had said.

It had sought to declare as unconstitutional the notification dated March 6, 2020 constituting the delimitation commission to take up delimitation in the UT of J&K and states of Assam, Arunachal Pradesh, Manipur, and Nagaland by the Centre.

The plea had also challenged the consequential omission of Assam, Arunachal Pradesh, Manipur and Nagaland from the process of delimitation vide notification dated March 3, 2021, claiming that it amounts to classification and violates Article 14 (equality before law) of the Constitution.

"Once the transfer/ deputation order is issued with the approval of competent authority, the only ground for modification of such order shall be serious illness of the employee or his/ her spouse/ children fully dependent upon him/ dependent parents, to be certified by Standing Medical Board of Government Medical College in the Union Territory of J&K. The Board shall give a categorical opinion in such cases after examining the employee or his/ her spouse/ children/ parents," reads the order.

According to the guidelines, proposals for cancellation/ modification of deputation orders, wherever found genuine shall be submitted by the concerned administrative department only after receiving clear recommendation of Standing Medical Board to the effect that employee is medically unfit to serve in Union Territory of Ladakh or alternatively his/ her spouse/ children/ dependent parents suffer from an illness of the nature that warrant the presence of the employee at his home.

In order to enable settlement of pension cases, employees deputed to Union Territory of Ladakh, who are having less than 6 months residual service, shall be repatriated to Union Territory of Jammu and Kashmir at least 3 months prior to their date of superannuation. The employees of Union Territory of Jammu and Kashmir deputed to Union Territory of Ladakh shall be eligible for incentives, as may be made available to them in the Union Territory of Ladakh.

The guidelines further elaborated that if any question arises relating to interpretation or implementation of these guidelines, the matter shall be referred to General Administration Department for a decision thereon which shall be final.

across all districts of J&K. The 20 MW Rooftop Solar Power Plants on Residential Buildings shall be installed by the Jammu and Kashmir Energy Development Agency (JAKEDA), Science and Technology Department, under "Grid Connected Rooftop Solar Programme, Phase-II" of Ministry of New Renewable Energy at aproject-costofRs104Crore. These Rooftop Solar Power Plants will be connected with the Grid on Net Metering basis. Besides, providing a clean and

green environment through reduction of carbon emission, the generation of solar energy through Rooftop Solar Programme shall also offset power requirements of domestic consumers in Jammu and Kashmir. Under the new progressive and investor-friendly policy, the government would extend subsidy contribution equivalent to 25% of the project, for the installation of Grid Tied Roof top Solar Power Plants on residential buildings across all districts of UT of J&K. The project is to be completed by the end of November 2023 and shall be maintained free of cost for a period of five years by JAKEDA through the empanelled vendors.

SI Recruitment Scam **Court Rejects Bail Of Accused Teacher**

JAMMU: Chief Judicial Magistrate (CJM) Jammu Anjum Ara Thursday rejected the bail application of one accused teacher, Jagdish Lal, who as per CBI's charge-sheet, was involved in sale of papers in much publicized Sub Inspector Recruitment Scam.

As per a local news agencyKNO, while rejecting the bail application of accused Jagidsh Lal, the CJM Jammu after hearing both the sides observed that the chargesheet in the present case has been filed. However, it is evident from the record that CBI is conducting further investigation in the matter and will file subsequent charge-sheet in the case as there are more evidence to be collected by the non-applicant and there is possibility of involvement of many more accused in the interstate gangs operating in several present case of the recruitment and the leakage of paper of sub-inspectors.
