## **Protests Rock SKUAST Campus Over 'Molestation'**

Police Files Case, Accused Prof Suspended Pending Inquiry

**Srinagar:** Massive protests broke out at the Sher-e-Kashmir University of Agricultural Sciences and Technology (SKUAST), Wadura campus in North Kashmir's Sopore on Friday evening after a student charged her professor of sexual harassment.

A large group of students held a strong demonstration against the alleged harassment of a fellow student, raised slogans against the varsity administration and demanded justice. The situation became so tense that the District Commissioner Baramulla, Dr Sehrish Asgar had to personally intervene in the matter.

Taking to micro-blogging site Twitter, Dr Sehrish Asgar confirmed that police have registered an FIR in the matter and the accused professor has been suspended pending inquiry.

As per an official from SKUAST, the girl student (name withheld) had filed a complaint on Thursday against a professor, Mushtaq Ahmed Dar, of molesting her. "An FIR in the matter has also been lodged in Police Station Bomai," the official said. Meanwhile, as per an order issued by Registrar SKUAST, T.H.Masoodi, the professor has been suspended. Night Temperature Records Slight Rise In Kashmir

**Srinagar:** Amid the prevailing dry weather conditions, mercury witnessed a slight rise in Kashmir on Friday, even as most places in the Valley continued to record sub-zero temperature.

A meteorological department official said that Srinagar recorded a low of minus 0.2°C against minus 2.1°C on the previous night. The temperature was around 1.0°C above normal during this time of the year for the capital city, he said. On Sunday last, Srinagar saw minus 2.2°C which was the coldest night so far this season. Qazigund recorded a low

of 0.5°C against minus 2.0°C on the previous night, while in Pahalgam, the mercury settled at minus 1.4°C against minus 3.8°C on the previous



night and it was 2.0°C above normal for the south Kashmir resort, he said.

Kokernag recorded a low of 1.2°C against 0.2°C on the previous night and it was 1.7°C above normal for the place, he said.

Gulmarg recorded a low of minus 0.8°C against minus 1.0°C on the previous night, the official said. It was 2.3°C above normal for the world famous skiing resort in north Kashmir's Baramulla district, the official said.

In Kupwara town, the mercury settled at minus 0.4°C against minus 2.6°C on the previous night, the official said. It was **More on P10**  was added to the list of Ramsar sites in August this year. ### Board Fumes As Pvt Schools Override Govt Textbooks

'This Brings Non-Uniformity In Curriculum Taught In Schools'

**Srinagar:** In Jammu and Kashmir, many private schools 'override' the government prescribed textbooks—thus bringing a non-uniformity in the curriculum being taught in the schools.

According to a local news agency KNO, the Joint Secretary, Publication and Procurement for JKBOSE has said, "It has been observed that many private schools do not prescribe the textbooks published by JKBOSE especially for Elementary and Middle classes."

- Middle classes." "Instead these Private Schools prescribe textbooks from some private publishers which are sold to the students at exorbitant rates," the officer said.

In an official communiqué, Secretary further said, "The practice of prescribing textbooks from different private publishers by different private schools results in non-uniformity in the curriculum being taught in schools across the Jammu and Kashmir which is a highly undesirable situation."

The officer further said that in recent past some controversial content was observed in some textbooks of private publishers prescribed by various Private Schools, which has been viewed seriously by the government.

"As such, it is enjoined upon all the private schools to ensure that in the first phase the textbooks published by JKBOSE are implemented and prescribed by all the private schools across Jammu and Kashmir for classes 6th to 8th from the ensuing academic session, failing which necessary action | More on P10



## **'Early Life Experiences Could Have A Lasting Impact On Genes'**

Early life experiences can impact the activity of our genes much later on and even affect longevity, finds a new study in fruit flies.

According to the study, led by University College London (UCL), UK, the scientists report that gene expression 'memory' can persist across the lifespan, and may present a novel target for improving late-life health.

Gene expression refers to the conversion of the information encoded in a gene first into messenger RNA and then to a protein.

The scientists were building on their previous research in which they found that fruit flies fed a highsugar diet early in life lived shorter lives, even after their diets were improved in adulthood. Here, the study said, they uncover the mechanism likely explaining the finding.

"Health in old age partially depends on what a person experienced in their youth or even in the womb. Here, we have identified one way in which this happens, as changes in gene expression in youth can form a 'memory' that impacts health more than half a lifetime later," said Dr. Nazif Alic, lead author of the study, UCL.

In their previous study, the re-



searchers found that a high-sugar diet inhibited a transcription factor called dFOXO, which is involved in glucose metabolism and is known from multiple studies to affect longevity, so they now sought to enact the opposite effect by directly increasing the activity of dFOXO, the study said.

Transcription factors are proteins that regulate transcription, or copying, of information from DNA into messenger RNA, which is the

first and key step in gene expression. Messenger RNA is a form of RNA that carries information from DNA in the nucleus to the cytoplasmic sites of protein synthesis in the cell.

For this study, the researchers activated dFOXO by increasing its levels in female fruit flies during the first three weeks of the fly's adulthood.

The scientists found that these early-life experiences caused

changes to chromatin - a mixture of DNA and proteins that can be seen as the 'packaging' of DNA - that persisted and resulted in genes being expressed differently late in life.

This counteracted some changes that would be expected as part of the normal ageing process. These changes would eventually improve health in late life and impact the fruit flies' lifespan for more than a month, which is equal to half a fruit fly lifetime, later, the study said.

The researchers say their findings could lead to ways to impact late-life health in people as well.

"What happens early on in an animal or person's life can affect what their genes do late in life, for better or for worse.

"It may be that a poor diet early in life, for example, could impact our metabolism later in life by tweaking how our genes are expressed, even after substantial dietary changes over the years - but fortunately, it may well be possible to reverse this," said Alic.

"Now that we know how gene expression memory can persist across the lifespan to affect gene activity, we may be able to develop ways to counteract these changes later in life to preserve health and enable people to stay healthy for longer," said Alic.

Ashiq Hussian Posh (52), an artist from Naid Kadal Rangar Masjid Srinagar said that his family has been associated with the art of dyeing for the last 100 years. He said they were dyeing silk and woollen varn.

"We are earning our livelihood very well through this trade. But new generation, including my children, are not ready to take up this as their profession," he said. According to Posh, his son

who completed masters has refused to follow his father. Tariq Ahmad Posh (40) an-

other dyeing artist said that after finishing graduation, he got a job opportunity in a bank but he refused to join and started learning dyeing art. "I am earning my livelihood decently," he said.

Both Ashiq and Tariq said that if the new generation will learn the art, they can earn a livelihood there too. "But none is interested and we are worried it may die its own death," he added—(KNO)



Unidentified gunmen killed a couple and their daughter in a village in Mendhar sector of Jammu division late last night, reports reaching here said.

The masked men, reports said, armed with guns and knives forced their entry into the house of one Bhag Hussain at village Silva in Mendhar sector of Poonch and killed him along with his wife and daughter by slitting their throats during the dead of night.

The gunmen escaped from the area immediately after committing the crime. The deceased were identified as Bagh Hussain, his wife Shariefa and their daughter Shamima. Police blamed the militants for the killing. No group has owned up the responsibilitv so far.

Earlier also police had blamed the militants for the massacre of 16 members of a family in Salian village in the same district The state human rights commission had later refuted the police version .

Details about the incident are awaited. No independent version was available till late this evening. (Kashmir Observer, 03 December, 1998)

**Bharat Jodo Yatra Likely To Conclude On Republic Day In Kashmir**

NEW DELHI: In view of the upcoming 2024 Lok Sabha elections and state assembly elections, the Congress party has taken a big decision for the selection of a special day for the conclusion of the Bharat Jodo Yatra.

According to sources, in this context, the Congress has decided that the Bharat Jodo Padyatra, which started from Kanyakumari on September 7, will conclude on January 26 in Kashmir covering a distance of about 3500 km.

"In fact, the Congress was going to end this yatra by hoisting the national flag in Srinagar on February 20, but now under the new strategy, Rahul Gandhi will conclude his yatra by hoisting the flag in Srinagar on Republic Day," said sources.

According to Congress sources, after January 26, a plenary session of the Congress will also be held before February 7, in which the name of Congress Party President Mallikarjun Kharge will be approved, after which the new Congress Work-

ing Committee will be formed. Immediately after that major changes will also be made in the Congress organisation which have been postponed for a long time. A Meeting of the Steering Committee is also scheduled to be convened on December 4 at Party Headquarters in Delhi and three issues from Bharat Jodo Yatra, Plenary Session and Organizational Matters are on the Agenda, said the Congress sources.

In fact, Congress felt that it was impractical to undertake major organisational programs and changes in the midst of Rahul's Padayatra while delaying them could harm the party in future elections. That's why a way has been found by cutting down the time by choosing a favourable day of 26th January for the yatra.

If sources are to be believed, in that case, the target of January 26 will be achieved by increasing the daily distance of the journey a little, reducing the number of days in the coming states like UP, and Delhi and this will not make any difference in the journey.

## **Delhi Man Arrested For Blackmailing**, **Extorting \$48,000 From US Professor**

**NEW DELHI:** The CBI has busted a racket of "sextortionists", arresting one who allegedly blackmailed an economics professor at California University into shelling out USD 48,000 threatening him with making public his sexually explicit video chats with a female gang member, officials said.

Based on information received from the Federal Bureau of Investigation of the US, CBI arrested Rahul Kumar, a resident of Delhi's Asola, while the search for his purported girlfriend who lured the professor into sending explicit videos on Facebook chat is going on, they said.

The girl, who was chatting through Facebook, had befriended the economics professor of a prominent university on social media service chat platform, they said.

In conspiracy with her purported partner Rahul Kumar, diverted conversations she towards sexual connotations, eventually asking the professor to record and send his sexually



explicit video on September 10, 2021, they said.

was received. Once a video she told the professor that her boyfriend Rahul Kumar had recorded the video, they said.

The duo started blackmailing the US-based professor with threats to make send the video to authorities in the university and some prominent US-based journalists, they said.

"Rahul, using his accounts asolarahul@gmail.com and rahulrana6585@gmail.com, started sending extortionist threats related to the sexually explicit video chat to the professor demanding money and other valuable things from him for deleting the video and directed him to make the monetary pay-

ments to his PayPal account," the CBI FIR has alleged.

The alleged blackmail went on for over a year, during which repeated money transfers took place in the Paypal account of Rahul, as directed by him. Over USD 48,000 (approximately ₹38 lakh) was received from the victim, they said. Kumar later asked the profes-

sor for costly gifts such as Apple iPhone chargers and headsets, following which the professor filed a complaint with the US Department of Justice, which handed over the matter to the FBI, they said.

The FBI got in touch with the CBI where International Operation Division registered a case, tracked the person and arrested Rahul while the search for his purported

girlfriend is going on, they said. "A case was registered by International Operation Division of CBI against a private person resident of New Delhi & Others on certain allegations including sextortion of a Professor at a prominent University in the USA on the inputs received from the USA," CBI said in a statement.

#### Mumbai Class 8 Student **Gang-Raped By 2 Classmates In School**, **Case Filed: Police**

MUMBAI: Two boys allegedly raped their 13-year-old classmate inside the classroom of their civic-run school in Mumbai, after which the police registered a case against them, an official said today. The incident took place on Monday, he said.

"The girl was sexually assaulted by her two classmates, when their fellow classmates stepped out of the classroom for dance practice. The two accused indulged in the crime by taking advantage of the situation," an police official said. The girl and the accused are students of Class 8, he said.

"The incident left the girl in shock and she shared her ordeal with her family members, who immediately filed a complaint against the accused," the official said.

Based on the complaint, the police registered a case against the boys under Indian Penal Code (IPC) section 376 DA (gang-rape of a woman under sixteen years of age) and under relevant sections of the Protection of Children from Sexual Offences (POCSO) Act, he added.

The minor accused were produced in a juvenile court, which sent them to the juvenile detention centre at in south Mumbai. Further investigation is being carried out, said the police.

**Man Dies After Iron Rod Breaks** Window, Pierces His Neck On **Board Delhi-Kanpur Train**

"One person died in general coach by external object (iron rod) which damaged the window. The train was stopped at the Aligarh junction at 09.23 hrs," the railway spokesperson said.

The man was identified as Hrishekesh Dubey. He was sitting by the window when the iron rod pierced his neck.

Sources said some work was underway on the tracks when the incident happened. However, no confirmation has been received from the Railways so far.



#### **Dr Samiullah Performs Rare Liver Surgery**


SRINAGAR: In a first, a senior surgeon in Kashmir carried out a Liver resection for Cholangiocarcinoma in a patient and saved his life.

## Why Is 'Ability' The Norm?

s the world wakes up to International Day of Disabled Persons, speeches and sermons are being delivered across the globe while persons with disabilities continue to suffer unabatedly. The sufferings of persons with disabilities only seem to cumulate and aggravate in spite of these massive awareness campaigns. This brute state only reveals that the conscience of people hasn't been sufficiently stirred and insensitivity and indifference towards persons with disabilities continues to be the defining parameters of majoritarian behaviour. The laws, which have been laid out on paper, have been either insufficient or ineffective in curbing the violence and injustice committed against persons with disabilities in structural and astructural forms. Society too has maintained a status quo of marginalisation and subalternity towards persons with disabilities and this social numbness has only amplified and deepened the crisis of persons with disabilities. They are being deprived of a life of dignity, repeatedly made objects of satire and sarcasm and an attitude of pervasive bullying is legitimised against them. As a result, their already existing problems of physical disability are only compounded by the mental torture inflicted upon them.

The challenge of restoring a life of dignity to persons with disabilities has to have at least a bilateral approach - ethical and legal. It seems almost a universal preconception and a deep rooted human bias that persons with disabilities aren't full humans and are, in one way or the other, inferior to able-bodied persons. This bias seems to be rooted in the notion that individuals are to be evaluated in terms of their delivering capacities

As somebody suffering from cerebral palsy, life has been like an uphill task and despite securing for myself a niche in academic and social circles based purely on hard work and determination. a life of dignity is nowhere in sight. On a daily basis, I have to endure maltreatment and marginalisation, as people who are unable to understand my words, go on passing vulgar and demoralising remarks

and their potential to "contribute". Our civilizations, both eastern and western have made the delivering capacity of an individual as the sole

measure and criteria of worth, dignity and right to live. The mechanised rather technological society which we have found ourselves in, has drawn a dictum on stone that only those are entitled to a life of dignity who can be active agents of material generation: ones who can generate wealth and material resources, who don't rely on others' helping hand and personify 'strength' to mould the world and tailor it to their needs, thereby proving themselves to be "fruitful individuals for the society".

This perspective of understanding people in terms of their utilitarian merit has not only overshadowed the concept of humanity as such but also exposed people with

disabilities to vulnerabilities and discriminations of all sorts. It is extremely difficult for people, who are otherwise able-bodied, to understand the problems of and empathize with people with disabilities, for the psycho-social dimensions of these problems are so broad that only people with disabilities face them first hand and are rattled and broken by the same.

The challenges which people with disabilities face are augmented and multiplied by discouraging social framework, lack of logistical support and prevalence of social mores that deteriorate and aggravate their situation further.

This economization of values and the determination of people's worth in terms of their ability to contribute to the economic production has had detrimental consequences to the reception of persons with disabilities, hampering their claims to equality and a life of dignity.

A basic revision of outlook is need-

ed on this front and people are to be respected on the pure grounds of sanctity and dignity of life irrespective of their economic outcomes and their abilities to contribute to the society in general.

These insights stem from my first hand observation. As somebody suffering from cerebral palsy, life has been like an uphill task and despite securing for myself a niche in academic and social circles based purely on hard work and determination, a life of dignity is nowhere in sight. On a daily basis, I have to endure maltreatment and marginalisation, as people who are unable to understand my words, go on passing vulgar and demoralising remarks. I often contemplate the plight of those, who are still lesser privileged, have no space to vent the maltreatment and lack of courtesy meted out to them. The psychological repercussions of such happenings are so destructive that it takes a long time for a victim to recover from these episodes and sometimes the victim doesn't recover at all.

If the academic excellence, resilience, merit and recognition doesn't help a person to secure for himself/ herself a life of general social dignity, one is left wondering, what else needs to be done to secure one's right to life of dignity and respect - something which is so basic and inviolable a right that it should require no qualifications. When people with disabilities are disrespect ed, maltreated and given a realisation that they don't belong to the normal lot, the detrimental consequences can well be figured out and these consequences corner people with disabilities into helplessness, insecurity, depression and a feeling of pervasive meaninglessness of life.

This day, celebrated as "International Day of Persons with Disabilities", asks for the same kind of approach and understanding from us towards all those specially-abled people who live around us in the same environment with common values and cultural ethos. The purpose for the observance of this day is to widen our outlook and promote the understanding of the concept of disability and mobilize local, national and International support for the rights, dignity and well-being of persons with disabilities. It is observed with the aim of complete integration of persons with disabilities with the rest in different social, political, economic and cultural aspects of life.

Disability is a complex and multifaceted concept. Its meaning differs across territories along numerous associated legal, political and social constructs. Disabilities such as physical challenges, acid attacks or dwarfism are easy to identify but the disabilities like mental illness, specific learning disabilities, hearing impairments or autism are comparatively difficult and complex to identify without appropriate training. Hence, disability is more complex.

Disability, in simple terms, is a physical or mental condition or both, that limits individuals movement, activities or sense of perception.

In India, Rights of Persons with Disabilities (RPWD) Act of 2016 recognizes 21 disability conditions. It has replaced Persons with Disabilities (PWD) Act 1995

which recognised only seven disability conditions. The Right of Persons with Disabilities Act 2016 is in pure harmony with the United Nations Convention on Right of Persons with Disabilities and provides a legal framework, generates awareness about the rights of persons with disabilities and promotes equity based inclusion.

Of the one billion population of Persons with disabilities, 80% live in developing countries. It is estimated that 46% of the older people aged 60 years and over are people with disabilities and one in every five women is likely to experience disability in her life while one in every ten children is a child with a disability. Despite being so numerous, persons with disabilities are still overwhelmingly overlooked and are not treated the right way as any other human being should be treated.

The reality of experiences across the country are totally different from the international and national legal and constitutional provisions. Persons with disabilities are facing a lot of discrimination due to prejudices and biases in our society. It is most common in institutions which impart education.

The day which we are observing actually demands certain pledges from us for which we have to work hard. In order to facilitate the welfare and the overall development of the people around us with any sort of disability, we have to go a mile ahead and design things which may prove easy, relevant and helpful for the people with special needs.

1. The first step towards progress and prosperity is the early identification process. It is better that the identification process of the persons with disabilities should begin ideally at the

moment of birth. The needs of people arising due to the disability should be appropriately addressed and they should be supported to realise their full potential within the society.

2. The second step for welfare is proper education. Education is the single greatest tool for achieving social justice and equality. Education aims to benefit the way that no person loses any opportunity to learn and excel because of the circumstances of birth, background and any disability.

In the field of education there is the need to redesign the settings in order to have:

a) Equal opportunities for the children with special needs. (Democratic settings of the classroom)

b) Conducive educational environment for the children with special needs. (CWSN friendly infrastructure and supportive school environment)

- c) To facilitate the retention and completion of schooling of these children. ( Resource rooms with special teacher educators)
- d) To facilitate the cooperative living and mainstreaming of the children with special needs.( Those who learn together, learn to live together)
- e) To develop the knowledge, skills and understanding of key strategies critical for living a decent human life. ( Vocational courses)
- To involve these children with the other students of the school in all the activities of School.( School can serve as a nursery for an inclusive society)

full honour. In order to earn a livelihood we have to create suitable workplace conditions for them in accordance with their abilities, capacities and capabilities.

- II) Persons with disabilities deserve equal social and political status in society. The country must have a certain amount of affirmative action favouring the people with special needs because they have suffered in the past due to the disabilities. As the equal partners of the system, this section must have the equal opportunities to participate in the process of decision making. When they are at the helm of affairs they may legislate better policies and apply the same for their betterment.
- III) The next intervention which the persons with disability need is to have the special and need specific environment and engagement in the social, cultural, religious and economic fields. We have to create a genuine space for them in accordance with their special needs. This space is needed in the schools, hospitals, mosques, public parks, means of transport, cultural events etc etc. We do already have some space for them but it is not up to the mark and is not satisfying the ultimate aim.

The day which we do observe every year calls for the general attitudinal change and adjustment of the common masses in the society so that a large section of the people get the chance to live their life the way they deserve with all the rights, respect, dignity, honour and privilege. They never ask for sympathy and the things they do not deserve, they only ask for the respect, honour, position and power which we owe to them.





## 'Chemotherapy May Make Kids, **Grandkids More Disease Susceptible'**

A common chemotherapy drug could pass down increased disease susceptibility to children and grandchildren of adolescent cancer survivors, a study conducted in mice has found.

The research published in the journal iScience found that male rats who received the drug ifosfamide during adolescence had offspring and grand-offspring with increased incidence of disease.

"The findings suggest that if a patient receives chemotherapy, and then later has children, that their grandchildren, and even great-grandchildren, may have an increased disease susceptibility due to their ancestors chemotherapy exposure," said Michael Skinner, Washington State University, US and corresponding author on the study.

Skinner emphasized that the findings should not dissuade cancer patients from undertaking chemotherapy since it can be a very effective treatment. Chemotherapy drugs kill cancerous cells and prevent them from multiplying, but have many side-effects since they impact the whole body, including reproductive systems.

Given this study's implications, the researchers recommend that cancer pa-

tients who plan to have children later take precautions, such as using cryopreservation to freeze sperm or ova before having chemotherapy.

The results of the researchers' analysis showed epigenetic changes in two generations linked to the chemotherapy exposure of the originally exposed rats, the study said.

The fact that these changes could be seen in the grand-offspring, who had no direct exposure to the chemotherapy drug, indicates that the negative effects were passed down through epigenetic inheritance, the study said.

Skinner and colleagues at Seattle Children's Research Institute are currently working on a human study with former adolescent cancer patients to learn more about the effects chemotherapy exposure has on fertility and disease susceptibility later in life.

A better knowledge of chemotherapy's epigenetic shifts could also help inform patients of their likelihood of developing certain diseases, creating the possibility of earlier prevention and treatment strategies, Skinner said.

We could potentially determine if a person's exposure had these epigenetic shifts that could direct what diseases they're going to develop, and what they're going to



potentially pass on to their grandchildren," he said.

"We could use epigenetics to help diagnose whether they're going to have a susceptibility to disease." said Skinner.

For the study, researchers exposed a set of young male rats to ifosfamide over three days, mimicking a course of treatment an adolescent human cancer patient might receive. Those rats were later bred with female rats who had not been exposed to the drug. The resulting offspring were bred again with another set of unexposed rats.

The first-generation offspring had some

exposure to the chemotherapy drug since their fathers' sperm was exposed, but researchers found greater incidence of disease in not only the first- but also the second-generation, who had no direct exposure to the drug, the study said.

While there were some differences by generation and sex, the associated problems included greater incidence of kidney and testis diseases as well as delayed onset of puberty and abnormally low anxiety, indicating a lowered ability to assess risk, the study said.

The researchers also analyzed the rats' epigenomes, which are molecular processes that are independent of DNA sequence, but influence gene expression, including turning genes on or off, the study said.

Previous research has shown that exposure to toxicants, particularly during development, can create epigenetic changes that can be passed down through sperm and ova, the study said.

While other research has shown that cancer treatments can increase patients' chance of developing disease later in life, this is one of the first-known studies showing that susceptibility can be passed down to a third generation of unexposed offspring, the study said.

## 'New Single-Dose Drug 95% Effective **Against Sleeping Sickness In Adults'**

A new, single-dose oral treatment for sleeping sickness is 95 per cent effective in adults and adolescents, regardless of disease stage, and could be a key factor in eliminating disease transmission by 2030, according to a study published in The Lancet Infectious Diseases.

Developed by not-for-profit Drugs for Neglected Diseases initiative (DNDi) and Sanofi, acoziborole, unlike current treatments for sleeping sickness, does not require multiple days of treatment, hospitalisation or highly skilled health personnel, the researchers said.

Transmitted by the bite of an infected tsetse fly, sleeping sickness, or human African trypanosomiasis (HAT), is a neglected tropical disease, which can be fatal if left untreated.

The Gambiense human African trypanosomiasis (g-HAT) form of the disease is found across countries in west and central Africa with most cases in Congo.

Until 2019, treatment for patients in the earlier stage of the disease was a daily injection for seven or more days and, for patients in the later disease stage, an intravenous drip for seven days, which requires hospitalisation, the researchers said.

Patients were also required to undergo a spinal tap, where fluid is collected from the spine, to diagnose the stage of sleeping sickness to determine the most appropriate treatment, they said.

In 2019, fexinidazole was introduced, a 10-day oral drug developed by DNDi as a first-line treatment for both stages of the disease, but its administration still requires skilled staff and, often, hospitalisation.

The new prospective study looks at the efficacy of one oral dose of acoziborole in treating g-HAT.

"Sleeping sickness threatens millions of people across sub-Saharan Africa. Many of the people at risk live in remote rural areas where there is little access to adequate health services, and where acoziborole has the potential to revolutionise treatment for sleeping sickness," said Dr. Antoine Tarral, Head of Human African Trypanoso miasis Clinical Program at DNDi, and lead author of the study.

"It is administered in a single dose and is effective across every stage of the disease, thereby eliminating the many barriers currently in place for people most vulnerable to the diseases, such as invasive treatments and long travel distances to a hospital or clinic, and opening the door to screen-and-treat approaches at the village level. Tarral said in a statement.

## **'Air Pollution Linked With Multiple Long-Term Health Conditions'**

Exposure to traffic related air pollution is associated with an increased risk of multiple long-term physical and mental health conditions, according to a study. This is the largest

study worldwide -- conducted on over 364,000 (over 3.6 lakh) people in England -- to examine whether air pollu-

tion exposure is linked with the occurrence of multiple long-term health conditions, the researchers said.

The study, published in the journal Frontiers in Public Health, showed that high levels of traffic-related air pollution - fine particulate matter (PM2.5) and nitrogen dioxide (NO2) were associated with an increased risk of having at least two long term health conditions.

"Our research has indicated that those people that live in areas of higher traffic-related air pollution are at greater risk of having multiple health conditions," Ronaldson said.

However, the study does not prove that air pollution causes multimorbidity, but it does warrant further research in this area, the researchers said.

## **'PMKVY Projects Preserving**, Reviving Namda Craft Of Kashmir'

Namda project to benefit more than 2000 persons in 30 Namda clusters

SRINAGAR: The Pradhan Mantri Kaushal Vikas Yojana (PMKVY) 3.0 and its component; Recognition of Prior Learning (RPL) for upskilling of artisans and weavers of Kashmir is tremendously helping in pre-

serving and revival of Namda craft of Kashmir. The Namda project will benefit more than two thousand persons of 30 Namda Clusters from six districts of Kashmir (Srinagar, Baramulla, Ganderbal, Bandipora, Budgam and Anantnag) and

RPL initiative targets to upskill around eleven thousand artisans and weavers of Jammu and Kashmir. Namda craft is a rug made of sheep wool through felting technique instead of normal weaving

process. Earlier the export of this craft had declined and Central Government through this special project under PMKVY, of Ministry of Skill Development and Entrepreneurship (MSDE) has designed short-term training curriculum to preserve this endangered craft.

The project is being implemented in 25 batches in 3 cycles of training. Each training program is of ap-

proximately three and half months, which results in the cycles being completed in approximately 14 -16 months.

The Namda project will be an industry-based training program with beneficiaries involved in Namda Crafts Production who will contribute towards preserving and reviving the rich heritage associated with Namda craft in Kashmir.

This will also improve the access of existing artisans of Namda crafts cluster in Kashmir and will improve their prospects of employability. The objective of these projects is to boost and preserve the traditional Namda craft of Kashmir and upskill the local weavers and artisans to enhance their productivity through RPL assessment and certification.

The vision of the central Government is to revive and promote traditional and heritage skills and to give artisans support to make them economically sustainable.

Government is also offering artisans exposure to the international markets so that the world becomes aware of vibrant culture of Kashmir. #### Maruti Suzuki To Hike Vehicle Prices From January

NEW DELHI: Maruti Suzuki India will increase the prices of its vehicles 'substantially' from next month as it looks to offset the impact of rising input costs and make provisions to update the model range to conform to stricter emission norms which kick in from April 2023.

In a regulatory filing on Friday, the country's largest carmaker said it continues to witness increased cost pressure driven by overall inflation and recent regulatory requirements.

While the automaker makes maximum effort to reduce cost and partially offset the increase, it has become imperative to pass on some of the impact through a price increase, it added

The company has planned the price increase in January 2023 which shall vary across models, the auto major said without disclosing the exact quantum of the increase.

In an interaction with PTI, Maruti Suzuki India Senior Executive Officer Marketing & Sales Shashank Srivastava said that commodity prices still remain on the higher side if compared with two years ago.

"Besides there is general inflationary pressure on every input cost whether it is energy or material or manpower cost. Then there is requirement to conform to regulatory requirements," he said. PTI

#### **'Bank Credit Grows** Nearly 17% For Fortnight Ended Nov 18'

**NEW DELHI:** Indian banking system's outstanding credit grew by 16.96 per cent for the fortnight ended November 18, the Reserve Bank said on Friday.

The bank credit grew to Rs 133.29 lakh crore for the fortnight ended November 18 this year as against Rs 113.96 lakh crore on November 19, 2021, the Reserve Bank of India (RBI) said.

The deposit growth came at 9.30 per cent, with the overall base Rs 177.15 lakh crore as on November 18 as against Rs 162.06 lakh crore in the year-ago period, it said.

Interestingly, amid a war for deposits in the system as banks jostle to raise the liabilities to fund the elevated credit growth, the overall deposits in the system declined marginally during the fortnight as against the Rs 177.88 lakh crore as on November 4.

It can be noted that the current fiscal has seen a steady rise in credit growth in FY23 driven by a variety of reasons, including economic growth, borrowers' shift to the bank as against other credit substitutes amid rising interest rates, etc.

In FY 2021-22, bank credit rose by 8.59 per cent and deposits by 8.94 per cent. PTI

#### Rupee Falls 7 Paise To Close At 81.33 Against US Dollar

**MUMBAI:** The rupee pared its initial gains to settle down by 7 paise at 81.33 against the US dollar on Friday as the support from weak dollar was negated by weak domestic markets and gains in crude oil prices.

Forex traders said foreign fund outflows also weighed on investor sentiments. At the interbank foreign exchange market, the local unit opened at 81.11, but pared the gains and ended at 81.33, down 7 paise over its previous close.

During the day, the local unit witnessed an intraday high of 81.08 and a low of 81.35. On Thursday, the rupee appreciated by 4 paise to close at 81.26 against the US dollar.

"Weak US Dollar index supported the rupee. However, weak domestic markets, a surge in crude oil and FII outflows capped sharp gains,' said Anuj Choudhary - Research Analyst at Sharekhan by BNP Paribas. The US Dollar declined as US ISM manufacturing PMI slipped into contraction and positive riskier currencies such as Euro and Pound. Euro surged as the German trade surplus topped street estimates.

"We expect the Rupee to trade with a slight negative bias on risk aversion in global markets and fresh outflows by FIIs. However, softness in the greenback may support Rupee at lower levels. Markets may also take cues from US non-farm payroll data today evening, wherein it is expected to show a slower pace of hiring," Choudhary added. PTI

#### 'India To Continue Buying Oil From All Countries'

**NEW DELHI:** India will continue to buy crude oil from anywhere in the world, including Russia, to meet its energy needs, a top official said ahead of EU restrictions on Russian oil kicking in.

The executive body of the European Union has asked its 27-member countries to cap the price of Russian oil at USD 60 as part of the West's attempt to squeeze Moscow's oil revenues and limit its ability to wage war in Ukraine while keeping global prices and supplies steady. "Unlike Iran and Venezuela, there are no sanctions on buying oil from Russia.

So anyone who can arrange for shipping, insurance and financing outside of the EU can buy oil," the official said.

The price caps are part of the EU's plan to use its clout in insurance and shipping industries to crimp Moscow.

"We will continue to buy oil from anywhere in the world including Russia," he said.

Under the price-cap system that kick-in from December 5, companies shipping Russian oil outside of Europe would only be able to access EU insurance and brokerage services if they sell the oil at or under USD 60.

"So for all practical purposes, if I can send a ship, cover insurance and devise a mode of payment, I can continue to buy oil from Russia," the official said explaining how the mechanism works. PTI

#### SC Directs Centre, States To **File Responses On Plea Seeking Directions For Uniform Healthcare Standard**

New Delhi: The Supreme Court Friday directed the Centre and the states to file their responses on a plea seeking directions for a uniform standard of healthcare for citizens in line with the Constitution by adopting provi-sions of the Clinical

Establishments Act, 2010. A bench of Justices B R Gavai and Vikram Nath granted four weeks

to the Union of India and the state governments to file their replies.

The top court was hear-ing a plea filed by Jan Swasthya Abhiyan, Patients' Rights Campaign and K M Gopakumar which had also sought directions for operationalising all the provisions of the Act, as well as Clinical Establishment Rules, 2012 in order to ensure affordable and quality healthcare.

The plea had sought directions for notification and implementation of the conditions for registration of clinical establishments such as observance of minimum standards, display of rates for procedures and services. compliance with the standard treatment protocol, as provided in Sections 11 and 12 of the CEA read with Rule 9 of the Rules, 2012.

The petition had also sought directions that a grievance redressal mechanism be created for the patients at the district, state and national level national level till the lacunae in the CEA are filled by

a suitable legislation. The PIL said the duty to provide healthcare to citizens was put on the government under Article 47 of the Constitution; however, the public healthcare system did

not proceed as conceived and treats only 30 per cent of the patients, while the rest are treated by the private sector.

The petition contended that the public healthcare system suffers from a lack of public health infrastructure and human resources, non-availability of medicines, lack of public investment and forced dependency on the private sector.

The plea had submitted that there is an urgent need to develop the public healthcare system in India by providing proper infrastructure and sufficient budget to ensure that the maximum facilities exist in the public domain, not only in normal times but also at the time of emergencies such as COVID-19.

## **21 Uninhabited Andaman And Nicobar Islands Named After Decorated Soldiers**

# SC Quashes Kerala Hc Order Granting Anticipatory Bail To 4 In ISRO Espionage Case

New Delhi: The Supreme Court Friday quashed the Kerala High Court order granting anticipatory bail to four people, including a former Director General of Police (DGP), in a case of alleged frame-up of scientist Nambi Narayanan in the 1994 ISRO espionage matter.

A bench of Justices M R Shah and C T Ravikumar remanded the matter back to the high court and directed it to decide the issue within four weeks.

"All these appeals allowed. Impugned orders granting anticipatory bail passed by HC are quashed and set aside. All matters are remitted back to the HC to be decided afresh on it own merits. This court had not observed anything on merits for either of the parties. "It is ultimately for the HC to pass orders. We request the HC to decide the anticipatory bail applications at the earliest preferably within four weeks from date of this order," the bench said. The top court directed the registry of the high court to notify bail applications before the bench concerned within one week from today.

directed that for a period of five weeks and till the bail applica-tions are finally decided by HC on remand, the respondents may not be arrested subject to cooperation in the investigation," the apex court said.

The judgement came on the CBI's appeal against the high court order granting bail to former Gujarat DGP R B Sreekumar, two former police officers of Kerala S Vijayan and Thampi S Durga Dutt, and a retired intelligence official P S Jayaprakash. Šreekumar was then the Deputy Director of the Intelligence Bureau (IB).

August 13 last year, the high court had said, "There is not even a scintilla of evidence regarding the petitioners being influenced by any foreign power so as to induce them to hatch a conspiracy to falsely implicate the scientists of the ISRO with the intention to stall the activities of the ISRO with regard to the development of the cryogenic engine."

It had said unless there is specific material regarding their involvement, prima facie, it cannot be said that they were acting against the interests of the country.

all the causes responsible for degradation in the Wetlands and scientific prescriptions have been recommended to improve upon its hydrological regimes, pollution or loss of biodiversity," reads the report, a copy of which lies with Kashmir Observer.

It further says presently the plans are being prepared as per this Management Action Plan (MAP).

According to the report, the survey and digital delineation of Hygam Wetland Conservation Reserve has been completed jointly with the Revenue Department and Forest Demarcation Division. Further, work of installation of boundary pillars has been taken up and shall be completed in next year, out of 70 boundary pillars . 35 have been installed.

It says that some bunds like Cross bund and Gohal Tengpora Bund were established long way back (60 years ago) resulting in fragmentation of the Wetland.

"These bunds have been demolished by this division in last year i.e 2020-21 with the assistance of Revenue department, Forest Protection Force and Police retrieving thereby 2400 kanal of land from illegal encroachers," it informs.

The wildlife department says that presently the work on consolidation of the peripheral bunds is being taken on priority.

"In this regard raising/strengthening of bunds from Tiffin Shed to Kralkhud (2.5 Km's) and from Rinji to Lolipora (2.00 Km's) has been completed. This will help in restoration of water level and will redress apprehensions of encroachments," the report notes.

Over 145 panels have been installed around the periphery of the wetland during last year, previously these panels were damaged by "miscreants" and people showed resentment while installing.

The department says that restoration works like making of boat ways, pools, plugging of breaches is also being carried out regularly.

Regarding the pollution, the department says that the water quality monitoring of the wetland is being carried out periodically in order to monitor the status of health and plus of the wetland.

"The results reveal that water quality confirms the category B of primary water quality criteria which is within the prescribed permissible norms as per CPCB guidelines," the report adds. According to the department, a

capacity building workshop in order to collect samples for water quality monitoring was organized in collaboration with the pollution Control Board. "Now our field staff is collecting

samples and sending it to PCB for analysis," it says.

The department maintains that the division is regularly conducting antiplastic drives in and around Hygam Wetland by involving local schools, N,G.O's and other stakeholders and solid waste is being removed in order to keep this protected wetland plastic free.

On migratory birds and biodiversity, the department highlights that every year the Asia Water bird census is carried out by this division in association with some NGO's/universities/ colleges/ bird watching groups and media persons.

While refuting the reports of deteriorated condition and decline of bird species in the Hygam Wetland, the report said that the census has revealed that bird species which were previously recorded within the wetland have presently also been reported within the wetland.

The department said that as per the recent survey carried out by the division along with more than one lac migratory birds have been recorded in the wetland. The species include Mallard, shovlar ,pintail, common shelduck, crested poachards, Graylag geese ,Mor hens and other species.

It may be noted, a Srinagar based Environmental Police Group (EPG) and its offshoot Green Citizens Council (GCC) had visited Hygam Wetland Reserve last week and found no migratory birds.

Talking to Kashmir Observer, Wildlife Warden Wetlands, Kashmir, Ifshan Dewan said the news of like previous years, the migratory birds have arrived in this year as well and termed the report fake and baseless.



## **BCCI Set To Introduce** 'Impact Player' Rule In IPL

NEW DELHI: In its bid to provide tactical flexibility to the teams, the BCCI is all set to introduce the 'impact player' system in the upcoming edition of IPL where the captains will be able to replace one playing-XI member with a substitute player during the match.

BCCI had put the system on trial during the Syed Mushtaq Ali T20 tournament in October and the move was largely welcomed by the state teams.

According to sources privy to development, the matter was discussed at the IPL Governing Council on Thursday evening. The franchises have already been sent a note with regards to introduction of tactical substitution. "The matter has been discussed at the IPL GC meeting and BCCI will share the details soon," an IPL franchise



source told PTI on conditions of anonymity.

While the exact details are awaited, the playing regula-tions, followed during the Syed Mushtaq Ali Trophy, would be adopted.

According to the 'impact player', a team can have four pre-decided substitute players who can be pencilled as "tactical substitutions" and one of them can be used in a match situation.

However any such substitute has to be introduced, if required, into the match before or by the end of the 14th over of a team's innings.



## New Potential Drug Target To Treat Heart Disease Found: Study

Scientists have uncovered details of a phenomenon that contributes to coronary artery disease, more commonly known as heart disease, an advance that may lead to new drug treatments for fighting heart disease, according to a study. Soon after cholesterol and fat

soon after cholesterol and fat start depositing on the lining of the blood vessels that supply your heart, the smooth muscle cells that give the blood vessels strength and flexibility start to get bigger and multiply.

While scientists studying the phenomenon suspect these vascular smooth muscle cells are trying to help, this atypical behavior for these strong cells instead contributes to coronary artery disease.

In a bit of a vicious cycle, stents as well as bypass grafts used to treat coronary artery disease can prompt the same response.

Now Medical College of Georgia (MCG) scientists report new insight into how the cells enable this unhealthy growth and a new target to intervene.

The endothelial cells that line our blood vessels are in constant communication with the layers of vascular smooth muscle cells that encase them and play a key role in regulating our blood pressure, said Yuqing Huo, director of the Vascular Inflammation Program in the Vascular Biology Center at MCG.

In states of good health, for example, the two cell types share messages about how it is time for our blood vessels to dilate a little because we are exercising. Early in vascular disease, however the conversations change, said Huo, corresponding author of the study in the journal Circulation.

"They get the message that something is wrong," said Huo, and existing cells get exponentially bigger and start proliferating, which these cells don't normally do, perhaps in an effort to make more room inside for blood to flow since cholesterol and fat are narrowing the existing passageway.

"Normally, the smooth muscle cells provide strength. If they start to proliferate a lot, it chang-

es their identity," Huo says. Whatever the reason, the result is more narrowing and scarring of the vital passageway for blood and worsening disease. So, the scientists looked at the building blocks needed to enable the unhealthy response. They knew that growing more

and bigger cells required more DNA, RNA and the proteins they produce. To make that happen required more purines, one of two chemical compounds in the body used to make the building blocks of DNA, in this case adenine and guanine.

## East Pakistan Debacle In 1971 A 'Military Failure', Says Bilawal Bhutto

Pakistan's Foreign Minister Bilawal Bhutto-Zardari has termed the East Pakistan debacle in 1971 a "military failure," in a veiled jibe at the former Army chief Gen Qamar Javed Bajwa, who termed it a "political failure." Bilawal made these com-

ments at the Nishtar Park rally, which was organised to mark the 55th Foundation Day of his Pakistan Peoples Party (PPP). On the occasion, the PPP chairman revisited the history

of his party and recounted the achievements of its founder, his grandfather, Zulfikar Ali Bhutto. When Zulfikar Ali Bhutto took over the government, the

beople were broken and had lost all hope, he was quoted as saying by the Dawn newspaper. But he rebuilt the nation, restored the confidence of the people and finally brought our

people, and finally brought our 90,000 troops back home who had been made prisoners of war due to military failure'. Those 90,000 soldiers were reunited with their families. And that all was made possible due to politics of hope... of unity... and inclusion," he added.

Days before his retirement on November 29, Gen Bajwa



termed the East Pakistan debacle a "political failure," and complained that the sacrifices of the troops were never properly acknowledged.

He rejected the commonly held notion that 92,000 soldiers surrendered in the 1971 war and claimed that there were just 34,000 combatants, while the others were part of different government departments.

While addressing a Defence and Martyrs Ceremony at the General Headquarters in Rawalpindi last week, Bajwa said: I want to correct the record. First of all, the fall of East Pakistan was not a military but a political failure. The number of fighting soldiers was not 92,000, it was rather only 34,000, the rest were from various government departments.

Gen Bajwa, 61, retired on November 29 after getting a threeyear extension in 2019 by the then Prime Minister Imran Khan, who turned out to be the biggest critic of the Pakistan Army.

The East Pakistan debacle in 1971 saw Pakistan suffering a humiliating defeat to India. It saw East Pakistan secede

to form a new country called Bangladesh.

## Musk's Company Aims To Soon Test Brain Implant In People

Tech billionaire Elon Musk said his Neuralink company is seeking permission to test its brain implant in people soon. In a show and tell presentation livestreamed Wednesday night, Musk said his team is in the process of asking US regulators to allow them to test the device. He said he thinks the company should be able to put the implant in a human brain as part of a clinical trial in about six months, though that time-

line is far from certain. Musk's Neuralink is one of many groups working on linking brains to computers, efforts aimed at helping treat brain disorders, overcoming brain injuries and other applications. The field dates back to the 1960s, said Rajesh Rao, co-director of the Center for Neurotechnology at the University of Washington. But it really took off in the 90s. And more recently we've seen lots of advances, especially in the area of communication brain computer interfaces.


Rao, who watched Musk's presentation online, said he doesn't think Neuralink is ahead of the pack in terms of braincomputer interface achievements. But ... they are quite ahead in terms of the actual hardware in the devices, he said. The Neuralink device is about the size of a large coin



and is designed to be implanted in the skull, with ultra-thin wires going directly into the brain. Musk said the first two applications in people would be restoring vision and helping people with little or no ability to operate their muscles rapidly use digital devices.

He said he also envisions that in someone with a broken neck, signals from the brain could be bridged to Neuralink devices in the spinal cord. We're confident there are no physical limitations to enabling full body functionality, said Musk, who recently took over Twitter and is the CEO of Tesla and SpaceX.

In experiments by other teams, implanted sensors have let paralyzed people use brain signals to operate computers and move robotic arms. In a 2018 study in the journal PLOS ONE, three participants with paralysis below the neck affecting all of their limbs used an experimental brain-computer interface being tested by the consortium BrainGate.
