BJP Retains Gujarat For 7th Straight Term

Congress Wrests Himachal From BJP

New Delhi: Riding high on the charisma of Prime Minister Narendra Modi, the BIP on Thursday retained power in Gujarat for a record seventh straight term pulverising the opposition to secure the biggest majority ever in the state.

While the Bharatiya Janata Party(BJP) set new records in the home state of Modi and Home Minister Amit Shah with its "historic" and "phenomenal" victory for a three-fourths majority, it lost Himachal Pradesh to the Congress after a close fight, as the hill state continued with its tradition of nearly four decades in voting out the incumbent party.

The vote share difference for the winning Congress and the BJP in Himachal Pradesh was less than one per cent, a point also noted by Modi and BJP President J P Nadda in their address to party workers at the BJP headquarters in Delhi in the evening. While the Congress, which got a simple majority, polled 43.9 per cent votes, the vote share for the BJP in the home state of Nadda was 43 per cent.

As Modi continued to hold sway over voters and addressed 31 election rallies in Gujarat, the



BIP also checkmated the new entrant Aam Aadmi Party(AAP) in the first ever triangular contests in the state and pushed the Congress down to its all time low.

Gujarat state BJP president C R Paatil said Bhupendra Patel, the party's 60-year-old softspoken face in the state, would remain as the chief minister and his swearing-in ceremony would be held on December 12. Patel won the Ghatlodia seat in Ahmedabad by a huge margin of 1.92 lakh votes.

Modi said he was overcome with lot of emotions on the "phenomenal election results" in Gujarat.

He lauded party workers in the state, saying each of them is a champion. "This historic win would never be possible without the exceptionally hard work of our Karyakartas, who are the real strength of our party."

"People blessed the poli-

tics of development and at the same time expressed a desire that they want this momentum to continue at a greater pace. I bow to Gujarat's Jan Shakti," he said in a tweet.

At the party event, Modi said Gujarat has broken all records and created history.

The BJP, which focused on a development agenda and

overcame anti-incumbency yet

again without losing an election since 1995, also equalled the Left Front's feat of seven consecutive terms in West Bengal. The CPI(M)-led Front ruled the eastern state for 34 years from 1977 to 2011.

The BJP, for whom Hindutva remained a political strategy, got support from all sections bagging 155 seats and was leading in 1 in a House of 182. It garnered a vote share of nearly 53 per cent which was the highest for the party in the western state.

The BJP, which bagged 99 seats in 2017 Assembly polls with a 49.1 per cent vote share, surpassed its previous best showing of 127 seats More on P6

SC Tosses Out Curative Petition Over 'Mass Murder'

New Delhi: The Supreme Court has dismissed a curative petition seeking reconsideration of its 2017 order dismissing a plea which had sought investigation into the alleged mass murder of Kashmiri Pandits in the valley in 1989-1990.

A three-judge bench headed by Chief Justice D Chandrachud rejected the plea and said no case is made out.

"We have gone through the Curative Petition and the connected documents. our opinion, no case is made out within the parameters indicated in decision of this Court in

Rupa Ashok Hurra vs Ashok Hurra. The Curative Petition is dismissed," the bench also comprising Justices S K Kaul and S A Nazeer said.

The curative petition, filed by an organisation of Kashmiri Pandits, 'Roots in Kashmir', had said the apex court was not justified in dismissing the writ petition at the admission stage in 2017 merely on presumption that

the instances referred to in it pertained to 1989-1990 and no fruitful purpose would emerge as evidence is unlikely to be available at this late juncture.

"This really amounts to failure of justice or gross miscarriage caused to the petitioner in view of the fact that the petitioner has stated in the writ petition as well as in review petition that this court has not only entertained the writ petition and also passed necessary direc-

tion for trial etc. in cases where the incident pertains to even more than 30-32 vears," the peti-

tion had said. A curative petition is the last legal recourse in the apex court and is generally heard in-

chamber unless a prima facie case is made out for reconsideration of the verdict. The organisation had ini-

tially filed a writ petition in the top court seeking investigation and prosecution of several persons in connection with killing of Kashmiri Pandits during 1989-90, 1997 and 1998.

'Special court designated under NIA today granted bail to the chief editor of @ tkwmag @pzfahad in FIR No 70/2020 P/S Safakadal and FIR No 19/2022 P/S Pulwama, Ronga said in a tweet.

He said there was still one case pending in Jammu against the journalist.

"We have also challenged his detention under the Public Safety Act. It will come up for hearing on December 15," Ronga added.

Shah was arrested in February this year for "glorifying terrorism, spreading fake news, and inciting general public against law and order." Besides Jammu, cases have been registered against him in Pulwama, Shopian, and Srinagar.

Amarnath Yatra

Augment Infra At Distance From Riverbed: NGT

New Delhi: The National Green Tribunal has directed that necessary safeguards be adopted for the safety of pilgrims and protection of the environment during the Amarnath Yatra.

Along with augmenting infrastructure, the NGT said "activities and arrangements" be made "at a distance from the riverbed". The tribunal was hear-

ing a petition, which claimed that environmental and safety norms were violated in setting up tents for pilgrims on the dry riverbed near the holy cave of Amarnath. It added that because of

non-compliance norms, 16 persons on the yatra died during a flash flood on July 1.

In July, a bench of Chairperson Justice AK Goel said the tribunal sought a response on the issue from the Jammu and Kashmir administration. The authorities concerned had submitted a reply saying they were bound to comply with environmental norms and committed to ensuring that such disasters were never repeated.

The incident was a natural disaster and beyond the control of human efforts, the bench said not-

Fat Around Organs More Susceptible To Severe Covid Than Fat Under Skin: Study

■ cientists have found that the fat around the liver, intestines and other organs, or visceral fat, contributes more towards severe COVID-19 than does subcutaneous fat, or fat under the skin

as in "love handles", according to a study. Visceral fat is usually considered a risk factor for cardiovascular disease, diabetes

and high blood pressure.
The researchers at the State University of Campinas (UNICAMP) and the University of Sao Paulo (USP) also found that when visceral adipocytes, or tissues where fat is stored as an energy source, were infected, they produced a larger amount of pro-inflammatory cytokines, which warned the immune system of the existence of a threat to be combated.

To reach this conclusion, Marcelo Mori, a professor at UNICAMP and one of the leaders of the study, infected in the laboratory two types of adipocytes (fat cells): one obtained from human stem cells isolated from subcutaneous tissue and the other differentiated from stem cells taken from visceral fatty tissue.

"It was possible to observe that visceral adipocytes are more susceptible to infection by SARS-CoV-2. Viral load increased far more in this fat cell type than in subcutaneous adipocytes.

"We believe this was due mainly to higher levels of the protein ACE-2, to which the virus binds to invade cells, present on the cell surface," said Mori. The study is published in Nature Communications.

Mori's team at UNICAMP was the first in the world to show - in July 2020 - that SARS-CoV-2 can infect human fat cells and to suggest that adipose tissue serves as a reservoir for the virus, the study said.

"After that, other studies confirmed that adipocytes can indeed be infected, and when we analyzed samples from patients who died of COVID-19, we found the presence of the virus in adipose tissue to be relatively frequent, corresponding to about 50 per cent of cases," said Mori.

The group then decided to investigate whether there were differences between the way visceral and subcutaneous adipose cells responded to infection. As far as metabolic diseases were concerned, the evidence in the scientific literature showed



visceral fat to be the main villain, while subcutaneous fat tended to be neutral or even beneficial, the study said.

"We wanted to see if there was a similar association in the context of COV-ID-19," said Mori. "And in fact our model suggests that the more visceral adipose tissue there is in obese individuals, the more the virus can replicate, and this amplifies the inflammatory process." In subcutaneous adipocytes, on the other hand, the group observed a decrease in lipolysis, the breakdown of fats and other lipids by hydrolysis to release fatty

acids, which can be used as a source of energy during physical activity or fasting periods, the study said.

"Our hypothesis is that this represents an antiviral cellular response," said Mori. "There are studies showing that inhibition of lipolysis lowers the replica-tive capacity of SARS-CoV-2, which can be explained by the fact that the virus needs lipids to produce its envelope, as well as energy from cells to make copies of its genetic material." Reduced lipolysis in subcutaneous adipose tissue, therefore, could be positive for the patient and

bad news for the virus. Visceral adipocytes were exposed to different strains of SARS-CoV-2: the ancestral lineage originally from Wuhan, China, and isolated from one of the first Brazilians diagnosed with COVID-19; and the gamma variant (P.1.), which emerged in late 2020 in Manaus, the capital of Amazonas state in Brazil.

The difference in susceptibility compared to subcutaneous adipocytes was observed only in response to the ancestral

Scientists Find Out If New Cancer **Drug Can Come From Potatoes**

■ veryone is familiar with a can-lion deaths and 19 million ■ new cases were reported globally in 2020. Although treatments are constantly being improved, they can still harm healthy cells or have unpleasant side effects that are difficult for patients to deal with. Traditional medicine has a wealth of potential candidates for developing new, more targeted cancer treatments. The glycoalkaloids, bioactive substances found in many well-known crops including potatoes and tomatoes, were examined by a group of Polish researchers at Adam Mickiewicz University under the direction of Magdalena Winkiel to show their potential to treat cancer.

'Scientists worldwide are still searching for the drugs which will be lethal to cancer cells but at the same time safe for healthy cells," said Winkiel. "It is not easy despite the advances in medicine and powerful development of modern treatment techniques. That is why it might be worth going back to medicinal plants

that were used years ago with success in the treatment of various ailments. I believe that it is worth re-examining their properties and perhaps redis-covering their potential." Making medicine from poison: Winkiel and her colleagues focused on five glycoalkaloids - solanine, chaconine, solasonine, solamargine and tomatine - which are found in crude extracts of the Solanaceae family of plants, also

known as nightshades. This family contains many popular food plants - and many that are toxic, frequently because of the alkaloids they produce as a defence against animals that eat plants. But the correct dose can turn a poison into a medicine: once scientists have found a safe therapeutic dose for alkaloids, they can be powerful clinical tools. Glycoalkaloids in particular inhibit cancer cell growth and may promote cancer cell death. These are key target areas for controlling cancer and improving patient prognoses, so have huge potential for future treatments. In silico studies -- an important first step --suggest that the glycoalkaloids aren't toxic and don't risk damaging DNA or causing future tumours, although there may be some effects on the reproductive system.

"Even if we cannot replace anticancer drugs that are used nowadays, maybe combined therapy will increase the effectiveness of this treatment," Winkiel suggested. "There are many questions, but without detailed knowledge of the properties of glycoalkaloids, we will not be able to find out." From tomatoes to treatments: One necessary step forward is using in vitro and model animal studies, to determine which glycoalkaloids are safe and promising enough to test in humans. Winkiel and her colleagues highlight glycoalkaloids derived from potatoes, like solanine and chaconine - although the levels of these present in potatoes depend on the cultivar of potatoes and the light and temperature conditions the potatoes are exposed to.

Solanine stops some potentially carcinogenic chemicals from transforming into carcinogens in the body and inhibits metastasis. Studies on a particular type of leukaemia cells also showed that at therapeutic doses, solanine kills them. Chaconine has antiinflammatory properties, with the potential to treat sepsis.

American FBI Team Arrives In Sgr

EW DELHI: A two-member team of US Federal Bureau of Investigation (FBI) today left for Srinagar in connection with the mys-terious disappearance of the four foreigners kidnapped in 1995, official sources said. The sources said this was a routine visit by the FBI officials as per the requirement of the United States laws where they have to submit a report every quarter.

Six foreigners — John Childs and Donald Fred Hutchings (both US nationals), Paul Wells and Keith Mangan (UK nationals), Dirk Hasert (German) and Hans Christian Ostro (Norwegian) — had been kidnapped in July 1995 from Pahalgam hills in South Kashmir.

The group responsible for kidnapping identified itself as Al-Faran. While Childs managed to give a slip to his abductors, the head of Norwegian abductee was found severed near Anantnag in August 1995.

The fate of other four hostages despite hectic search operation carried by the government and later by German and British po¬lice remains unknown

Fallout of Ukraine war

hat global geopolitics is in flux following Ukraine war is clear from Saudi Arabia's decision to host Chinese president Xi Jingping for three days from December 7. During the visit, Jinping will attend a China-Arab summit. The visit will include a bilateral summit chaired by Saudi King Salman and attended by Saudi Crown Prince Mohammed bin Salman. As regional skepticism about the region's relationship with the United States, a vital security ally, has grown in recent years, Gulf Arab states have strengthened their ties with China and Russia. In doing so, Arabs have defied US pressure to choose sides. The relationship between the US and Saudi Arabia has soured in recent weeks after OPEC+ chose to decrease output despite the US urging an increase to offset current inflation.

If anything, the Arab defiance of the US is yet another stark example of how geopolitics is shaping up following the Russian invasion of Ukraine. Even though the US-led western coalition against Russia is holding up well, the rest of the world is increasingly asserting its autonomy in their response to the war. India too has refused to choose sides. For example, in South Asia, India has found itself in a tough situation to straddle its alliance with the US and its longstanding relationship with Russia. And so far it has been successful in pursuing a tight balancing act. While New Delhi has gone along with the West as for as the illegitimacy of the war, it has refused to abandon Russia. The West has found it difficult to countenance this assertion on the part of India. As a probable result, recent months have witnessed a newfound warmth between the west and Pakistan.

New Delhi sees it as a renewed appeasement of Pakistan. Many analysts in India see it as a punishment for India's pursuit of an independent foreign policy in response to the ongoing war in Ukraine. But New Delhi has refused to budge from what it sees in its core national interest. Besides abstaining from western resolutions against Russia, India continues to import oil from the country at discounted rates, something that has not pleased western countries.

But India has stood firm. Rather than joining the western camp, India has sought to play a mediatory role in resolving the Ukraine crisis. Prime Minister Narendra Modi during his meeting with Russian president Vladimir Putin on the sidelines of the recent Shanghai Cooperation Organization meeting told him that "this is not an era of war" and that the Ukraine issue should be settled by diplomacy. War is continuing nevertheless. Ukraine is far from being defeated. So isn't Russia, although it has suffered some reverses. But, meanwhile, the world around the site of war is changing.

BJP's Latest Win

s CM, Modi first addressed a national audience from the Gujarat stage before throwing his hat in the prime ministerial ring. And in this election if anything seemed more certain than a BJP victory, it was PM Modi's undimmed popularity. So yes, the BJP could have been forgiven for taking its winning streak, and Gujarat and the Gujarati voter, for granted in this election. It didn't – on the day after, its rivals would do well to pay attention to that ctory.

tention to that story. The BJP gave this election all it had. Its top leaders from Prime Minister Modi to central ministers, including Union Home Minister Amit Shah, campaigned in the state extensively. Uttar Pradesh Chief Minister Yogi Adityanath and star campaigner came calling too — in stark contrast to a listless Congress campaign that had shrunk and splintered into its local candidates and constituencies. In fact, the BJP was at work long before the campaign began – in the state's tribal belt, where the Congress has dominated traditionally, its push was visible, for instance, in the installation in district headquarters of Birsa Munda statues. In Saurashtra, where the Patidar quota agitation had contributed to the Congress's good showing in 2017, the BJP weaned away several Congress MLAs - of the Congress MLAs who crossed over to the BJP, raising its tally from 99 to 112, 9 belonged to Saurashtra. Congress complaints about money and muscle power sound much too plaintive - if even elected MLAs leave, not just those in search of a ticket, then it is a signal that the party must turn the mirror inwards. In 2021, in a sudden decision, the BJP's high command removed Vijay Rupani as chief minister, along with his entire cabinet, to blunt anti-incumbency — one of the party's many moves that showed that, a year before elections, even in its bastion, Modi's party was not banking on traditional formulas, but experimenting and thinking on its feet.

Of course, there was anti-incumbency in Gujarat. Distress had gathered at the lower ends of the class ladder, on issues like price rise, unemployment and the state's perceived retreat from education. There was discontent, as well, against a government that was seen to have become inattentive to the people because of long years of power. But in the end, if that restiveness did not show up at all on the final scoreboard, it owes not just to its opponents' lack of imagination and sloth, but also, and far more, to the BJP's own willingness and ability to keep working at it.

When Voters Become Fans

he state of global politics has economists, political scientists, and political philosophers floundering. We are witnessing a level of polarization rarely seen. From Turkey, Brazil, and the Philippines to Sri Lanka, India, and the United States, the center has not held, because people have either veered left or clustered around figures on the far right.

In authoritarian countries, such as North Korea and China, one usually cannot see authentic public expression of political demands. Yet the politics are still there, and they can become apparent during periods of severe strain, as is happening with the widespread backlash in China against the government's zero-COVID policy. Such moments suggest that the opposition is much larger than it may have seemed.

In any case, political polarization tends to nurture authoritarianism and empower self-aggrandizing demagogues who are skilled at rallying their followers behind hyper-nationalist causes. We have seen this dynamic play out to tragic effect with Russian President Vladimir Putin's war of aggression in Ukraine, and with the crackdown on minorities in Myanmar by the military junta.

All this poses a challenge to global stability, and calls for corrective policy interventions that straddle law, economics, and politics. However, it is not clear what those interventions should look like. We first must step back to consider what is underpinning the polarization in the first place.

One interesting hint comes from the FIFA World Cup in Qatar. Mainstream economics tells us that people's goals and ambitions are "exogenously" given, meaning they are hardwired into us. We want more and better food, clothes, cars, electronic gadgets, and so on. And since getting them requires money, people naturally strive to earn more and build up greater wealth. Yet what is not recognized even though prominent past thinkers from Thorstein Veblen to Tibor Scitovsky were acutely aware of it – is that many of our ambitions are endogenously created. Rather than being born with them, we acquire and cultivate them along the way.

Sports offer a perfect example of this. Though professional footballers get monetary rewards when they succeed, they would still try to win as many matches as possible even without that incentive. Scoring a goal is the ultimate aim. Even if one believes that the prospect of more money does drive some athletes to push themselves to the limit, what about the fans who travel great distances and commit inordinate amounts of time and money to the game? The desire to see "their team" win is an end in itself – a created target.

The lengths to which fans will go was evident recently in India, when a fight broke out between supporters of Brazil and Argentina. These were ordinary Indians with no connection to either country. Yet there they were, ready to scrap and risk their safety for an acquired cause. If nothing else, a soccer brawl is another exhibition of polarization.

dian voter, a tendency that affords the country a great deal of political stability, even if it also makes politics dull.

But political trends in recent years indicate that voters' ideological preferences are not necessarily exogenous, but rather created and fostered over time. After a voter decides to support Democrats or Republicans, that voter's partisan commitment will gradually acquire the character of sports fandom. Republican voters want Republicans to win, and Democrats want Democrats to win, not because they are expecting some fundamental change in their lives, but because they want to beat the other side. Today's political polarization calls into question longstanding assumptions about how electoral politics works. Consider the American mathematician Harold Hotelling's seminal 1929 paper. deeply influenced our understanding of electoral democracy and led to the influential "median voter theorem" (absorbed into political science by Duncan Black and Anthony Downs). According to Hotelling and the theorists he inspired, if you assume that people have exogenously given political preferences - spanning from extreme left to extreme right - it is easy to see how two political parties might maneuver to get the most votes. The rightwing party will move leftward on some issues, knowing that rightwing voters will still support it; and the left-wing party will do the same from the other direction.

In theory, then, the equilibrium will feature a clustering around the middle, where one finds half the voters from the left and half of those from the right – the very definition of the median. Hence, electoral democracy supposedly leads political parties to appease the me-

and polarization. Among other things, it implies that political parties do not just try to garner the support of voters with pre-existing preferences. Rather, they strategize to create those preferences. As we have seen, this can lead to vile forms of political competition, especially in an age of social-media filter bubbles that segregate news consumers and are designed to exploit their biases.

Escaping this trap will probably require novel forms of regulation. But since the most promising solutions are not yet evident, we had better start thinking creatively about what it will take to protect democratic institutions and the social fabric in an age when preferences have never been easier to manipulate.

Plastic Waste in Space Getting Recycled

lastic waste is an ongoing problem not only on Earth but in space also. A team of scientists in renowned organisations is now testing a novel way to convert discarded plastic in space into useful material. For example NASA is experimenting with space management in space through the reactor project. The system will subject waste material from space to

high temperatures to convert it into usable material. As part of the waste to base materials program, a team of scientists recently built reactors that successfully converted space debris into useful gas. In another example,

Scientists at the National Renewable Energy Laboratory are also developing a machine that turns plastic into a material usable in space itself. In this experiment the PETase


enzyme breaks down Poly Ethylene Terephthalate (PET) plastic into its basic components of terephthalic acid, (which initiates the entire process of recycling PET in space). The acid is then fed to bacteria, which convert it into another compound that can be used to make useful nylon. Scientists have already launched a soup of bacteria and enzymes into space as part of an autonomous sys-

tem designed to convert plastic waste into usable material. The most promising aspect of the latest experiment is that it works completely autonomously, allowing the bacterial soup to slowly break down the plastic, according to latest news reports.

PSYCHOTROPIC MEDICATIONS The Only Option or Is There More?

frequently receive questions from my clients seeking my opinion as a clinical psychologist regarding psychotropic medications. I'm frequently asked if I advise taking medicine to treat mental health issues including anxiety depression, and other such problems. After evaluating the severity of the condition, if I find that the severity of the client's condition is greater than a moderate level, I advise them to consult a psychiatrist to decide upon the medications. I want to clearly state my opinion on the usage of psychotropic medicines for mental disorders in this article and offer my point of view based on what I observe and understand about the role of medications in treating mental disorders.

Medicines can be beneficial. For some who suffer from crippling anxiety, for instance, medicines can lower down the severity of emotions and bodily sensations caused due to anxiety. Medication can give someone a "kick-start" if depression has robbed them of all motivation and they are unable to get out of bed in the morning. Additionally, medication may be necessary for stability and/or safety in those with severe mental health conditions including schizophrenia and Bipolar Affective Disorder and in such cases the patient may have to take such medicines the whole life. Therefore, depending on the individual circumstances, some persons may benefit from taking psychotropic medications that a psychiatrist has prescribed. For instance, a National Institute of Mental Health-funded study found that some patients who were prescribed the SSRI Paxil for moderate to severe depression also experienced improvements in their depressive symptoms, as well as decreases in neuroticism and increases in extroversion. These personality traits changed roughly twice as much in eight weeks after taking medications as they do for most adults over the course of their lifetime. In addition, psychotropic medicines can be a life saver especially in those with suicidal intent and can help have a better quality of life in those who have developed some organic mental illnesses such as Dementia, Alzheimer's Disease, Traumatic brain injury etc. Psychotropic medications can be very essential part of treatment for those who have developed substance use disorder.

2. The psychotherapy process can be assisted by medication. As is understood, most people find it challenging to concentrate on symptom alleviation and

personal growth when they are in crisis or are dealing with anxiety, depression, or other mental health issues. In such instances, medication can help in symptomatic relief, allowing them to put efforts they are expected by their therapist and hence it may increase their progress in psychotherapy. For instance, a study that was published in the Journal of the American Medical Association demonstrates that patient's attention deficit hyperactivity (ADHD) symptoms tend to significantly improve when cognitive behavioral therapy (CBT) is used in conjunction with specific psychotropic medication. However, the need for psychotropic and other medications is, of course, frequently reduced or eliminated as a result of effective

3. Medication may turn out to be harmful. We acknowledge that for some people, taking medicine is a critical component of the therapeutic process. However, like all drugs, psychotropic medications can have risks and side effects. These include physical side effects like dizziness, drowsiness, changes in appetite, disturbed sleep, and/or weight gain, as well as emotional and psychological side effects like mood swings, lack of interest in activities, or emotional numbness.

Antipsychotics can harm the brain permanently by causing Parkinsonism or Tardive Dyskinesia, or they can even be fatal if taken for too long or at the wrong dosage. This is corroborated by a 2005 Harvard Mental Health Letter article that describes the growing understanding of the dangers of SSRI antidepressants, including the potential rise in suicidal thoughts and behaviors in adolescents under the

age of 24

While studies have shown that some people benefit from taking these drugs, they have also revealed that other people may suffer long-term harm as a result of using antidepressants.

For those who keep on taking Benzodiazepenes for years together to deal with their anxiety or any other such mental health issue, they need to know that it creates more problems than solves it. Benzodiazepines are generally safe when taken as prescribed for short periods of time-no more than a few weeks. The chronic use of benzodiazepines can develop tolerance with repeated usage over time, which can manifest in one of two ways: either the person needs to use more benzodiazepines to get the desired effect, or the impact is noticeably lessened with continuing use of the same dose of benzodiazepines. Benzodiazepines increase the risk of addiction, withdrawal, cognitive decline, motor vehicle crashes, and hip fracture. The risk of overdose is particularly great when combined with sedative drugs such as opioids or alcohol. Thus, patients need to discuss the potential side effects of medication use with their consultant psychiatrist so that one may weigh the dangers against the potential benefits and determine whether an alternate form or parallel form of treatment such as psychotherapy would be more appropriate.

4. It's not always necessary to take medicine. While some mental illnesses may benefit from the use of psychotropic medicines, researchers at University of Pennsylvania found that a 16-month course of cognitive therapy was found to be both more affordable and marginally more effective at preventing a relapse into

depression than antidepressants alone when used for the same amount of time. According to a study that was published in the Journal of the American Medical Association, while antidepressants were beneficial for those with severe depression, people with mild to moderate depression benefited more from other types of treatment, such as counseling, than they did from medication.

from medications.

Medications may not be at all a treatment of choice. Research has shown that no psychiatric medicine can treat personality disorders such as Borderline Personality Disorder, Schizoid Personality Disorder etc. per se, though they may treat the depression, anxiety, mood dysregulation that develop alongside personality disorders. It has been found that psychotherapies of different modalities such as Dialectical Behavior Therapy, Schema Therapy, Psychodynamic Psychotherapy etc. is more beneficial in such cases than medicines.

Both the emotional process and the psychotherapy process might **be hampered by medication.** Once the medicine accumulates in a person's system over a long period of time, the patient may develop inability to feel certain emotions. For instance, a lot of people complain about their diminished capacity to laugh or cry or their diminished libido. Research from Evolutionary Cognitive Neuroscience shows how SSRI side effects, including decreased sexual interest, may alter one's sexuality and romantic relationships. Medication may also make it difficult for certain people to understand their emotions, masking underlying problems and delaying or preventing the effects of psychotherapy.

ROLE OF PSYCHOTHERAPY:

Many emotional and mental health problems cannot be reduced to a physiological/chemical imbalance. It would be quite immature to reduce psychological problems to just a chemical imbalance. Events in our lives—things that happen to us and around us—often serve as the source of and effect on psychological problems. Medication alone cannot "cure" every psychological condition because it does not alter how people mentally relate to their experiences. Medication—as the only therapy has the potential to be as ineffective as bandaging a bullet wound without first removing the bullet.

Focusing too much on psychotropic medications such as antidepressants as the only cure makes treatment of mental disorders such as depression too mechanical. Psychotherapy, as an add on, on the other hand, is frequently able to identify and treat some of the mental health issues, such as problems in temperament, abuses of different kinds, psychological trauma and anxiety, that may contribute to depression.

Through psychotherapy, a patient may be able to understand what they are battling with and hence it may eliminate confusion in their minds about their mental health issues. It may also make them well equipped to handle their life despite having symptoms of various emotional disorders and hence increase their quality of life. It may also eliminate the victim's attitude from their lives as just relying on medicines only decreases their self esteem and self confidence as they consider themselves victim of their mental illnesses.

As a conclusion to this article, I may say that we as a society need to be more mature in understanding the role of medications and psychotherapy while treating and receiving treatment for mental disorders so that we don't skew to only one side of treatment and hence pay huge prices. It is always better to start with psychotherapy and if the condition is severe enough to warrant the use of psychiatric medication, the patient should still be referred for psychotherapy so that basic root cause of the illness is addressed while medicines treat the symptoms.

AAP, AIMIM Split Minority Votes Of Congress In Gujarat, BJP Gains

Ahmedabad: The Aam Aadmi Party (AAP) and the Asaduddin Owaisi-led AlMIM seem to have dented the Congress's sway over votes of minorities in Gujarat in the just concluded Assembly polls, bringing down the main Opposition party's vote margin considerably in various seats across the state.

The minorities, primarily Muslims, have been loyal voters of the Congress for the last several decades, especially after the 2002 post-Godhra riots.

Assembly polls were held on December 1 and 5, and votes were counted on December 8.

According to Congress sources, the Bharatiya Janata Party (BJP), on most occasions post the 2002 riots, has made electoral calculations keeping in mind consolidation of Hindu votes irrespective of castes.

This prompted the main Opposition party to secure its minority votes, one of the last components of the Congress's old strategy of KHAM (Kshatriya, Harijan, Adivasi and Muslim) social engineering, which once used to be its winning formula in the state, they said.

However, the entry of the AAP and the Hyderabad-headquartered All India Majlis-E-Ittehadul Muslimeen (AIMIM) has not only disturbed Congress's minority vote bank but has also



helped the ruling BJP, which did not field a single Muslim candidate in the elections, at the cost of the Congress.

In the 2022 Assembly polls, traditional political parties fielded very few Muslim candidates in Gujarat, which has a 182-member Assembly. The Congress had fielded six Muslim candidates, while the Arvind Kejriwal-led AAP gave tickets to three members of the minority community.

The AlMIM contested 13 Assembly seats and fielded Muslim nominees on 12 of them.

The AlMIM might have failed to win a single seat and the AAP might have won just five, but they derailed the Congress's prospects and vote share in numerous seats by splitting their traditional votes.

In the minority-dominated Dariapur seat, considered a Congress bastion, sitting Congress MLA Gyasuddin Shaikh lost to BJP's Kaushik Jain by a margin of 5,243 votes. Shaikh polled 55,847

votes, whereas his nearest BJP rival bagged 61,090 ballots. The winning difference was made by AAP and AIMIM candidates, who polled 4,164 and 1,771 votes, respectively.

In Jamalpur-Khadia, the Congress's Imran Khedawala got a third consecutive term, but with a reduced mandate of 58,487 votes, down from 75,000 in 2017. AIMIM's state president Sabir Kabliwala bagged 15,677 votes and the AAP 5,887 in the constituency in Ahmedabad district. In the Bapunagar seat,

sitting Congress MLA
Himmatsinh Patel lost to BJP's
Dineshsinh Kushwaha by a
margin of 12,070 votes. AAP
and Samajwadi Party's (SP)
Muslim candidates made the
difference in margin between
the Congress and the BJP. The
AAP and the SP polled 6,384
and 3,671 votes, respectively.

In the Mangrol seat, twotime sitting Congress MLA Babubhai Vaja lost to BJP's Kargatiya Lakhabhai by 22,501 votes. The AAP and the AIMIM polled 34,314 and 10,789 votes, respectively, thus contributing in the defeat of the grand old party in the Assembly segment in Junagadh district.

The Congress won the Muslim and Dalit-dominated Danilimda Assembly segment in Ahmedabad, despite the AAP and the AIMIM cutting into its votes and the BJP putting up a strong fight. Sitting Congress MLA Shailesh Parmar won by defeating his nearest rival, BJP's Nareshbhai Vyas, by a margin of 13,525 votes.

Parmar polled 68,906 votes as compared to 55,381 ballots cast in favour of Vyas. AAP candidate Soma Kapadia polled 22,934 votes, while AlMIM's Kaushika Parmar garnered 2,464. Although Parmar won, his victory margin was much lower than in 2012 and 2017.

In the Godhra seat, Bharatiya Janata Party's CK Raulji defeated his Congress rival Rashmitaben Chauhan by 35,198 votes. Raulji bagged 96,223 votes, while Chauhan got 61,025. In 2017, the BJP's victory margin was just 358 votes.

Aam Aadmi Party's Rajeshbhai Patel secured 11,827 votes, while the AIMIM's Hasan Kachaba garnered 9,508 ballots, eating into Congress traditional votes in the communallysensitive Assembly seat of Godhra, where the burning of an express train had triggered state-wide communal riots 20 years back.

in 2002 when Modi was the chief minister. Congress holds the all-time record of 149 seats that it had won in 1985 under the leadership of Madhavsinh Solanki.

With a nearly 13 per cent vote share, the Arvind Kejriwal-headed AAP won only five of the 181 seats it contested. In a video message, the Delhi Chief Minister said though the AAP has not won many seats the votes the party got helped it attain the national party status. The AAP also called its showing impressive.

Union Defence Minister Rajnath Singh and Chief Minister Bhupendra Patel credited Modi for the party's "historic victory".

"The biggest credit for this victory goes to public's trust in the leadership of Prime Minister Narendra Modi, his popularity and credibility. Congratulations to him and thanks to the public," Singh said.

Amit Shah said Gujarat has rejected those who do politics of hollow promises, revadi (freebies) and appeasement. "Gujarat has given an unprecedented mandate to Prime Minister Narendra Modi's BJP, which worked for public welfare and development."

After giving a tough fight to the BJP in 2017 Assembly polls in Gujarat by winning 77 seats, the Congress has hit a nadir in the western state where the party's campaign, mostly shouldered by local leaders, has leaned on door-to-door canvassing for votes as its leader Rahul Gandhi chose to stay away to focus on the 'Bharat Jodo Yatra'. Rahul had aggressively campaigned in 2017.

The AAP also appeared to have played spoil-sport for the Congress. With a vote share of nearly 28 per cent, the Congress won 17 seats.

The BJP managed to improve its 2017 tally as the issues it faced in the 2017 state polls like the state-wide outburst of anger among the Patidar community and restlessness among the traders over the GST regime appear to have faded.

Hundreds of BJP workers thronged the party office in Gandhinagar as they danced and distributed sweets outside the Gujarat state party headquarters.

Though the opposition in Gujarat took on the Modi government over rising inflation, slowing growth and joblessness, the economic troubles apparently did not dent BJP's popularity in the state that has been a bastion of the party for decades and where Modi was chief minister from 2001 to 2014.

While the Congress was not expected to replicate its creditable performance of the last Assembly elections, a good showing by the AAP could have helped Kejriwal cement his place as a key challenger to Prime Minister Modi in the 2024 Lok Sabha polls. The AAP is also in power in Punjab.

The AAP had carried out a high-decibel campaign and emboldened by the victory in the Delhi municipal elections it had hoped its politics of welfarism will be accepted by the people in Gujarat.

Journalist-turned-politician Isudan Gadhvi, who was AAP's chief ministerial face, and Gopal Italia, the party's state president, were among the prominent losers from the party camp.

Several state leaders of the Congress party including its former leader of opposition Paresh Dhanani lost. However, its senior-most leader in the state, Arjun Modhwadia won while firebrand Dalit leader Jignesh Mevani reversed early losses to post a victory.

versed early losses to post a victory.

Patidar leader Hardik Patel, Alpesh Thakor and cricketer Ravindra Jadeja's wife Rivaba Jadeja were among the prominent winners for

In Himachal Pradesh, the Congress won 40 of

the 68 seats at stake followed by the BJP, which bagged 25. Independents won three seats.

The AAP, which had fielded candidates in 67 seats, failed to make a debut and had a meagre vote share of 1.1 per cent.

Congress leaders in Himachal Pradesh credited its general secretary Priyanka Gandhi for its win which came as a boost for the grand old party.

Chief Minister Jai Ram Thakur, who won for the sixth time from Seraj assembly seat in Mandi district, said he respects the mandate of the people and submitted his resignation to Governor Rajendra Vishwanath Arlekar.

Anti-incumbency against the BIP governa

Anti-incumbency against the BJP government and the issue of price rise coupled with the Congress promising restoration of the old pension scheme and providing Rs 1,500 to every adult woman in the state seemed to be the main factors that worked in favour of the Congress.

With the BJP slogan of 'Raj nahin, riwaaj badlenge' (changing tradition and not the government) being rejected by voters, Congress leader Rahul Gandhi thanked the people for the "decisive win" and assured them that every promise made by the party will be fulfilled.

All India Congress Committee (AICC) in charge of Himachal Pradesh Rajeev Shukla hailed Priyanka Gandhi's campaign and leadership, lauding the "hard work" put in by her.

Senior Congress leader Anand Sharma said the Congress victory will have resonance and ripple effect in the poll-bound states next year.

also sought transfer of investigation of all the FIRs and cases of murder and other allied crimes against Kashmiri Pandits in the years 1989-90, 1997 and 1998 to some independent investigating agency like the CBI or the NIA or any other agency appointed by the top court.

rhyme or reason in a society," the petition said. It said the apex court had appointed a special investigation team (SIT) in the post Godhra riots cases on the petitions filed before it.

The plea said, in the review petition, the organisation had mentioned that in similarly placed cases of 1984 anti-Sikh riots, the court had taken cognizance even after a lapse over 33 years.

If the state's machinery fails to protect a citizen's life, liberty and property and the investigation is conducted in a slipshod manner to help the accused, it is but appropriate that this court should step in to prevent undue miscarriage of justice which is perpetrated upon the victims and their family members, it said.

The plea claimed the top court had failed to appreciate that more than 700 Kashmiri

Pandits were murdered from 1989 to 1998 and FIRs were lodged in more than 200 cases, but not even a single FIR reached the stage of filing of charge sheet or conviction.

It further said the present writ petition has been filed by the petitioners, who claim to be the aspirants and have responded to the advertisement for various examinations to be conducted by the JKSSB. The two such examinations are JE and SI to which all the petitioners have responded to and applied.

The petitioners had sought a direction

to the JKSSRB not to conduct any examination through Aptech Limited, which has been "blacklisted" in the past.

The petitioners had further sought a direction to appoint some other agency, which is not previously blacklisted, for conducting such examinations through Computer Based Test Mode (CBTM) involving public employment.

For J&K's Metro Project, Source Of Funding 'A Major Challenge'

Project Cost Close To Rs 11000 Cr; Formalities Finalised, Waiting For GoI's Approval: MRTC Official

SRINAGAR: The much awaited J&K's mega metro project set to come up at the whopping Rs 11,000 Crore is set to begin but the technical glitch is that the sources of funding are yet to be explored to set the ball rolling

Mass Rapid Transit Corporation (MRTC) has completed all the formalities and have also sent the Detailed Project Report (DPR) in this regard.

An official not authorized to speak to media, told a local news agency KNO, on the condition of anonymity, that the DPR submitted for the metro rail projects are still in the approval process as the involvement of huge funds remains the reason for the delay in the

There is a lot of funding involved for the mega project and there is a need to find the sources of funding as well. This is something we are looking at...," the official said, adding that nonetheless the project is well created and well made.

"The alignments and other mandatory processes are well designed and created. They are touching on urban hubs, which require a modern urban mobility planning. Everything has been kept in mind and the DPR has been submitted in this regard," sources, privy to the project said.

Sources said that everything has been finalized by the MRTC, but the project has not been approved yet and would likely take some more time to get approved. "The ball is in the court

of the Government of India now. The project can be carried forward only after the nod of the union government," they

Pertinently, the Jammu and Kashmir government had submitted a Detailed Project Reports (DPR) of Rs 10, 599 crore for the metro rail projects in Jammu and Srinagar to the centre for the approval, which include Rs 5,734 crore for Srinagar and Rs 4,825 crore for

Notably, on completion, Srinagar and Jammu will become the first two non-major cities in India to have the rapid transport network functional.

As per the project, Jammu Light Metro will operate 17 hours a day round the year while Srinagar Light Metro will operate 17 hours daily during summers and 14 hours daily for

The metro rail lines will have only elevated corridors as the underground tunnels were not found feasible. The coaches of the Metrolite system will be modern, lightweight and made from stainless steel and aluminium with an air-conditioning system, as per the DPRs.

The Jammu Light Rail System will have a 23-kilometre length with 22 stations between Bantalab and Bari Brahmana whereas Srinagar light rail system will have a 25-kilometre length which includes a 12.5-kilometre length from Indira Nagar to HMT Junction and 12.5-kilometer length from Hazuri Bagh to Osmanabad with 24 stations (12 stations on each corridor).

Independents Win Bypoll To 2

SRINAGAR: Independent candidates on Thursday won both Hajin and Drugmulla seats in the District Development Council (DDC) bypolls held in Jammu and Kashmir, officials said.

While National Conferencebacked Amina Majeed won the Drugmulla seat in Kupwara district by a slender margin of

39 votes, Nazah Bano won the Hajin seat in Bandipora district by 423 votes.

Majeed got 3,259 votes while her nearest rival Shabnam Rehman got 3,220 votes. Nazah Bano got 2,706 votes against Peoples Conference candidate Ateega 2.283 votes.

The BJP candidates in the two seats fared poorly, managing less than 1,000 votes each.

The bypolls for these seats were necessitated after objections were raised against two women candidates who hail from Pakistan-occupied Kashmir but are married to local men, leading to a legal battle.


SRINAGAR: Democratic Azad Party (DAP) chief Ghulam Nabi Azad on Thursday said the Assembly elections in Jammu and Kashmir should be held within the next six months as people cannot wait till 2024.

KP Employees Seek PM's Help After Fresh Threats

JAMMU: Striking Kashmiri Pandit employees on Thursday sought Prime Minister Narendra Modi's intervention into their demand to be relocated from the Valley over targeted killings of non-muslims by terrorists.

The fresh demand comes after a militant group recently released a "hit-list" of 56 employees from the community.

Recently, a blog linked to The Resistance Front (TRF), an offshoot of the Lashkar-e-Taiba, published a list of 56 Kashmiri Pandit employees under the Prime Minister's Rehabilitation Package (PMRP), and warned of mounting attacks on them.

Kashmiri Pandit employees assembled under the banner of "The All Migrant (Displaced) **Employees Association Kashmir** (AMEAK)" at the relief commissioner's office here for the 211th day of the strike and staged a sitin to press their demand for relocation from the Valley to Jammu.

They raised slogans and displayed placards in support of

"We urge Prime Minister to look into our demand for relocation from the Valley in wake of the hit-lists of Kashmir Pandits issued by terrorist outfits and indifference of the government here," a protester told reporters here. He said the administration

is rubbing salt in the wounds

of the displaced employees instead of giving a healing touch and ensuring confidence build-

ing among the community. On one side terrorists are killing Kashmir Pandits through selective and targeted pattern, issuing hit-lists against them, on the other side LG administration is issuing diktats against the employees to return to duties in Kashmir, the protestors said.

The administration is also stopping the salaries of the employees, thereby punishing their families, they said.

The majority of Kashmiri Pandits, who were employed under the Prime Minister's package in 2012, have been staging protests threatening mass exodus since the killing of Rahul Bhat.

Bhat, a state revenue department employee, was shot dead by terrorists in the tehsil office in Chadoora town of Budgam district of J-K's Badgam district on May 22.

Bhat's killing sparked demonstrations by around 6,000 Kashmiri Pandit employees at various places demanding relocation outside the Valley.

Dogra employees, who returned to Jammu following the killing of their colleague Rajni Bala, are demanding their transfer to their native places in Jammu from Kashmir.

A resident of Samba district, Bala was shot dead by terrorists at a school in south Kashmir's Kulgam district on May 31
