Fresh Snowfall In Higher Reaches Of J&K

Srinagar: A few areas in the higher reaches of Kashmir received fresh snowfall on Friday, even as the minimum temperature rose and stayed above the freezing point at most places in the valley, officials said.

The famous tourist destination of Gulmarg in north Kashmir and Sonamarg in central Kashmir received fresh snowfall, the officials said.

They said there are reports of fresh snowfall in other areas in the higher reaches of the valley and Ladakh Union Territory as well.

Meanwhile, the minimum temperature across the valley, except in Gulmarg, stayed above the freezing point owing to a cloud cover, the officials said. Srinagar recorded the minimum

temperature of 1 degree Celsius.

The mercury in Pahalgam tourist spot in south Kashmir settled at a low of 0.7 degree Celsius, the officials said.

They said Qazigund the gateway town to the valley recorded a low of 0.2 degree Celsius, while the mercury in Kokernag settled at a low of 1.1 degrees Celsius. Kupwara in north Kashmir registered a low of 1 degree Celsius.

Gulmarg was the only weather station in the valley where the night temperature stayed below the freezing point at a low of minus 3 degrees Celsius, the officials said. More on P6

The Metaverse Offers Challenges And Possibilities For The Future Of The Retail Industry

n 1968, American computer scientist Ivan Sutherland predicted the future of augmented and virtual reality with his concept of the "Ultimate Display". The Ultimate Display relied on the kinetic depth effect to create two-dimensional images that moved with its users, giving the illusion of a three-dimensional display.

While the concept of virtual reality only focuses on the creation of three-dimensional environments, the metaverse – a term coined by Neal Stephenson in his 1992 book Snow Crash – is a much broader concept that surpasses this.

While no official definition of the metaverse truly exists, science and technology reporter Matthew Sparkes provides a decent one. He defines the metaverse as "a shared online space that incorporates 3D graphics, either on a screen or in virtual reality." Since the term was coined, the idea of the metaverse has remained more of a fictional concept than a scientific one. However, with technological advancements in recent years, the metaverse has become more tangible. Much of the recent hype happened after Mark Zuckerberg made the announcement to rename the Facebook brand to Meta. Many retailers have since jumped aboard the metaverse train.

Nike recently filed multiple trademarks allowing them to create and sell Nike shoes and apparel virtually. JP Morgan opened their first virtual bank branch. Samsung recreated their New York City flagship store in the virtual browser-based platform Decentraland, where they are launching new products and creating events.

While many retailers are capitalizing on the metaverse early, there is still uncertainty about whether the metaverse really is the future of retailing or whether it will be a short-lived fad.

Dispelling metaverse myths Much of that uncertainty around the metaverse stems from confusion about the technology. While examining the top keyword associations related to the metaverse on Google Trends, I found "what is metaverse" and "metaverse meaning" to be the top phrases customers searched for. To alleviate some of this confusion, it's important to dispel commonly held myths about the metaverse.

Myth 1: You need a VR headset to access the metaverse While an optimal experience in the metaverse can be achieved through VR headsets, anyone can access the metaverse through their personal computers. For instance, customers can create their avatars and access the metaverse in Decentraland on screen without a VR headset.

yth 2: The metaverse will replace reallife interactions Rather than replacing existing modes of communication, the Metaverse provides a more interactive mode of communication. New technologies always bring about predictions of the end of physical interactions. It's helpful to compare the metaverse with the rise of smartphones. Smartphones enhance communication by allowing people to interact with their social networks, but have not entirely replaced face-to-face interactions. The metaverse will be the same.

Myth 3: The metaverse is just for gaming While gaming remains the dominant



driver of user involvement with the metaverse (97 per cent of gaming executives believe that gaming is the centre of the metaverse today), it's not the only activity people can take part in.

In a recent survey, McKinsey & Company asked customers what their preferred activity on the metaverse would be in the next five years. Shopping virtually ranked the highest, followed by attending telehealth appointments and virtual synchronous courses.

Keeping expectations realistic In its current form, the metaverse lacks the technological infrastructure to deliver on market expectations. It may be appropriate to compare the metaverse with the dot-com bubble between 1995 and 2000 that was caused by speculation in internet-based businesses.

Similarly, there appears to be tremendous hype and expectations around what the technology can deliver in its current form. A recent survey of 1,500 consumers found that 51 per cent of people expect customer service to be better in the metaverse, 32 per cent expect less frustration and anxiety while dealing with customer service agents in the metaverse compared to phone interactions, and 27 per cent expect interactions with metaverse virtual avatar assistants to be more effective than online chat-bots.

While such expectations can appear reasonable, metaverse technology is still in its infancy stage, where the focus remains on developing infrastructure and processes for the future. The unrealistic expectations may potentially lead to a metaverse bubble as reality struggles to meet expectations.

Challenges for retailers As with any emerging technology, retailers need to be prepared for challenges posed by the metaverse. Some of these challenges include the following: Data security and privacy: With the novelty of metaverse technology and the wealth of personal data collected, the metaverse will be an attractive target for cyber-hackers. New approaches and methods need to be considered for a safe metaverse that customers can trust.

Experienced talent: Having the right talent that can create, manage and support experiences in the metaverse needs to be at the forefront of engaging with the technology. However, due to the novelty of the technology, finding such talent will be a challenge.

Regulations: With no clear jurisdictions and regulations in place, the safety of virtual spaces in the metaverse may be compromised and end up pushing customers away. Retailers need to ensure these spaces are safe and protected.

Scientists Discover World's Oldest DNA, Breaks Record By 1 Million Years

Scientists have stumbled upon two-million-year-old DNA for the first time -- breaking the record of world's oldest DNA discovery by one million years and opening a 'game-changing' new chapter in the history of evolution.

Microscopic fragments of environmental DNA were found in Ice Age sediment in northern Greenland.

Using cutting-edge technology, researchers discovered the fragments are one million years older than the previous record for DNA sampled from a Siberian far back in time. DNA can degrade quickly but we've shown that under the right circumstances, we can now go back further in time than anyone could have dared imagine," Willerslev said in a paper published in Nature.

The ancient DNA samples were found buried deep in sediment that had built-up over 20,000 years.

"The sediment was eventually preserved in ice or permafrost and, crucially, not disturbed by humans for two million years," said Professor Kjaer.

The climate in Greenland at the time varied between Arctic and temperate and was between 10-17 degree Celsius warmer than Green-

Pharmaceutical Godown Gutted, 2 Firemen Injured In Rajbagh Blaze

Srinagar- A pharmaceutical godown was gutted while a residential house and hotel were partially damaged in a fire incident in Rajbagh area of the city on Friday.

An official said that two fire-fighters were also injured during fire-fighting operations.

Sheikh Yamin Co-founder and Managing Director of Curve Electrics said that they have started the initiative of public sharing E-bikes in Srinagar and a successful trial run was held from Dalgate to Kashmir University on Friday. Pertinently, E-bikes draw

ties have permitted them to run 200 E-Bikes and in the next few days the E-bikes will be seen plying on the city roads. 'To begin with we will

launch 50 E-bikes at 11 docking stations in the city and in a few weeks we will ensure all 200 of them hit city roads" he said.

The docking stations are being set up at Islamia College, Dalgate, Botanical Garden, Nishat, Kashmir University, Illahi Bagh, Soura, TRC, Kothi Bagh, Raj Bagh , Sanat Nagar, Bemina among other places.

He said the E-Bikes are technology driven, GPS enabled and the maximum speed of the E-bike is 25km/ hour. These battery driven cycles can run up to 55kms per charge.

"On throttle, it has a speed

of 25km/hr but seeing the kind of traffic we have in the city, one can run at 17km/hr on an average," Yameen said.

"One can avail the commuting facility by showing his or her Aadhar card and phone number for the first time, thereafter they will only have to use their phone number" he said.

Yameen said the customers will be charged 0.90 paise per minute and the Payments have to be made at the docking station in online or offline mode.

'We want to make it a mode of transport and people should use it on a daily basis. It is expected to be a safe ride and it will save time, money, effort & above all environment" Yameen added.

She also said, "From last year, we were only allowed to use electric blankets but unfortunately, the electricity doesn't last for a long time due to the shortage of transformers.'

The students also said that many boarders have fallen ill because of the bone-chilling cold and some of them have returned to their homes.

12 Bangladeshis killed near Jammu

RINAGAR: Twelve Bangladesh nationals were killed when Border Security Force (BSF) jawans opened fire at a group of people attempt¬ing to sneak into Jammu region from across the border today, official reports here said.

The reports said BSF personnel noticed a group of persons attempting to sneak into Indian territory from Pakistan-controlled Kashmir (PcK) near Sangral village in R.S.Pura sector of Jammu in the wee hours today.

They mistook the intruders for militants and opened fire at them when they tried to flee back after being asked to surrender, the reports said, adding the deceased were totally unarmed.

In the past, a number of Bangladeshi nationals were either arrested or killed while making attempts to sneak into this side.

However, a Jammu datelined PTI report, weaving a cockand-bull story, said; "On being confronted by the BSF jawans and asked to sur-render, the intruders started running back, they (official sources) said

"Meanwhile, Pakistani troops resorted to firing from across the bor¬der forcing BSF jawans to retaliate. In the exchange of fire, the intrud¬ers were killed, the sources said.

"Senior BSF and police officers have rushed to the area and the bod¬ies of the intruders are being handed over to police for further investingation', the sources said."

Elsewhere in Kashmir valley, militants shot dead a civilian, in-jured a surrendered militant and a BSF jawan and abducted a villager, while security forces repulsed a militant attack on a police station since last evening, an official spokesman said.

Unidentified gunmen shot dead a farmer Abdul Aziz Dar inside his house at Putshahi-Lalpora in frontier district of Kupwara early today, he said.

Jammu and Kashmir police and CRPF jointly repulsed a militant at-tack on police station Lalpora in frontier district of Kupwara late last night, the spokesman said.

A group of militants opened heavy fire and hurled grenades on the police station. However, the police and CRPF contingent stationed there retaliated and repulsed the attack. No casualty on either side was reported, he added.

In absence of personnel well trained and efficient in Urdu language, it will be difficult and in a sense impossible for the officials to interpret land and revenue records, which stand transcribed in a typical Persianate-Urdu jargon. This will not only negatively impact the efficiency of persons entrusted with responsibilities in the revenue department, but is sure to give birth to flaws and failings

In a recent order, Jammu & Kashmir administration removed Urdu as a mandatory language of competency in the recruitment of Naib Tehsildar posts in the Revenue Department. Earlier, the J & K government had removed the Urdu language requirement for recruitment of the posts of Patwaris, who are the primary authority in the maintenance of land records and documentation. The move has received widespread condemnation from society, academicians and others concerned. People are aghast over the move and the repercussions of the move are being discussed widely. Earlier, the status of Urdu language as administrative lingua franca was diluted, causing anguish and anxiety in people.

Languages take decades and centuries to secure a place of prominence among people and cultures, before they rise to the status of official languages, touching upon the emotions and intellect of people. Not only do the people share an emotional bond with Urdu language, but it has been the official language

of the state for more than one and half a century. To demote a language of such long standing official demeanour with a single stroke of a pen without any consideration for the consequences of such a drastic move is an act of immaturity.

Urdu language served the purpose of indefatigable link and timeless anchor in strengthening the relationships of Kashmir with the immediate neighbours in general and India in particular. It served the irreplaceable role of a grand unifier, uniting the people from different climes and contexts in a unified ideological whole. The corpus of century old land and revenue records stands archived in Urdu language and to remove it as mandatory subject in a service like that of Patwari or NT is a gross miscalculation and misadventure. One is often left wondering as to what are the intentions beyond such moves, which not only betray the professional prerequisites and necessities and public sentiments, but fly in the face of logic and commonsense. In absence of personnel well trained and efficient in Urdu language, it will be difficult and in a sense impossible for the officials to interpret land and revenue records, which stand transcribed in a typical Persianate- Urdu jargon. This will not only negatively impact the efficiency of persons entrusted with responsibilities in the revenue department, but is sure to give birth to flaws and failings. In a scenario like this, efforts should have been made to foster and fasten our ties with Urdu language, quite contrary to what appears to be the administrative mandate.

Urdu is the language of culture, civilization and tradition. It is the repository of one of the world's richest literary and academic traditions. It houses apical works of scholarship on Islam and other themes of diverse span. It has raised and garnered poets and writers like Ghalib, Daag, Iqbal, Patras, Yusufi and thousands others, whose wit and wisdom continues to illuminate and inspire people across geographical and linguistic divides. It has exerted magnetic influence on people across the globe by virtue of its uniqueness, rich literary tradition and a sonorous aesthetics particular to it.

Jashn E Rekhta, as is being celebrated these days and the global attendance to this event is a testimony to the versatile and captivating nature of Urdu language. In such a situation, where Urdu is captivating people globally and it is accelerating in its outreach, the government, authorities and administration shall invest all men and machinery in collaborating with this process of global import, instead of turning the face away from it and leaving it in a state of shambles.

Urdu doesn't merely serve intellectual, administrative and international purposes, as outlined above, but is a grand unifier, a reference to which has already been made. A humongous industry like Bollywood moves on the levers of Urdu and all acts of movie making involve Urdu as an indispensable medium of communication. People from different parts of India are able to communicate with one another in Urdu easily - the ease and universality that is offered by no other language. The role of Urdu during India's struggle for independence stands well documented and needless to say that it continues to serve an indefatigable and indispensable role in defining and maintaining the morphology of the country. When these languages are discouraged and sidetracked in exams like the ones mentioned above, the treatment not only looks step motherly, but pushes the language to peripheries, something which spills beyond the boundaries of state and country and claims to have global consequences, and bad ones.

human speech is carried over into writing. In this century, that proportion has drastically increased thanks to social media. We tap out messages where earlier we would talk on the phone, or, in most cases, do nothing. At whatever level, a hugely greater section of humankind now composes texts.

Yet like tossing a few sandbags to stem this flood of verbiage, we contract words and phrases as never before. We splurge on words but skimp on letters. 'B4 u r' and 'C u l8r' have lost ground to the autoprompt: but FOMO, YOLO, ROFL, NIMBY and the like are extending their empire, sometimes themselves starring in autoprompt. (I leave the unenlightened reader, if there be any, to work out the puzzles.)

Such practices are new, but not the motive behind them. People have always tended to compress what they write. Medieval European scribes used a mystifying range of contractions. As the same squiggle served several functions, readers might be left unsure of the meaning. The motive was to save not only time but the costly vellum used to write on.

Even earlier in origin is shorthand or stenography, transcription keeping pace with speech. Abbreviations will not suffice for this: it needs a separate set of signs calling for special training. Those confined to the alphabet have to summarize as well as abbreviate, like students taking notes in class (another dwindling practice given surreptitious recording on mobile phones). There is excellent precedent for such speed writing. A problematic version of Shakespeare's King Lear is ascribed, though controversially, to a transcript made during a performance.

Acronyms were rare in earlier English. We find Latin tags like AM or AD, with the occasional English parallel like BC. In these examples, the letters are pronounced separately: technically, they are initialisms rather than acronyms. 'Cabal' is sometimes derived from the initials of five councillors of King Charles II of England in the seventeenth century; but the word actually refers to the mystical Jewish Kabbalah. The nineteenth century saw a few instances like OK, for the

facetious 'orl korrect', and 'on the Q.T.' (quiet). OK is now a word in its own right, 'okay'. The earlier twentieth century yields AWOL and 'aka' (usually in lower case). But these are jokey coinages at a colloquial level.

At what stage did acronyms become serious verbal currency? When did UNESCO, NASA, OPEC and SAARC find favour as nifty shortcuts, with enough vowels for easy utterance? Moving a step further, when did people designedly start naming their organizations with this factor in mind? When did they embark on a little harmless cheating by juggling the letters or adding extra vowels?

Today acronyms virtually constitute a reserve army of words. Just as we call our friends PK or KC, or famous people GBS or NaMo (a Hindi acronym, one of a growing list headed by Bhajpa), the Times Literary Supplement is now officially TLS, and Times Higher Education (the 'Supplement' long dropped) an awkward THE, complicating Google searches that ignore 'the' by default. Bureaucrats love acronyms. They browbeat common people by claiming mastery over a mystical world walled in by a random cluster of letters: ICDS or KMWSA, like an unguessable password. Even items unquestionably for public use, like the new names for Calcutta streets, can be lengthy constructs where initials are the only recourse: BBD Bag or BBRBB Sarani, which is scarcely respectful to the person commemorated (three people in the case of BBD Bag).

Government reports carry a list of abbreviations. (So do scholarly tomes: 'academic bureaucracy' can have more than one meaning.) But the most ingenious instances play off an acronym against its expanded form in a kind of pun, often bilingual. Till the other day, government acronyms were really initialisms. Nobody complained that BSNL or ONGC was unpronounceable and mystifying. MGNREGA, which has brought immense benefit to the common Indian, is an opaque tongue-twister. Aadhaar cards carry the exwhile the expanded form spells out the meaning in English: thus AYUSH (Ayurveda, Yoga and Naturopathy, Unani, Siddha, and Homeopathy) or PM POSHAN (Prime Minister's Overarching Scheme for Holistic Nutrition). In the latter, the prime minister features in the expansion; but an extra 'PM' is prefixed for good measure, as with virtually every recent scheme of the Union government. We all know what PM means.

Malvolio's tweaking of random letters brought him to grief. Today's word shrinkers know better. Government schemes sport acronyms like snappy brand labels, as though devised by professional marketing managers.

Such alphabet games afford harmless pleasure in these stressful times. Yet a nagging unease might spoil the fun. The scheme itself threatens to take on the colour of a publicity exercise: we may wonder whether its serious benefit is short-changed in consequence. To fuel our doubts, the original PM POSHAN, a child nutrition scheme, did not spend a paisa on actually dispensing food. Its successors work cosmetic changes, if that, on decades-old schemes without increasing the budget.

Shakespeare intrudes relentlessly. What is a word but air, says Falstaff in Henry IV. "Will it not live with the living? No." He might have said the same of acronyms had he encountered them.

s dawn breaks in Kashmir on 6 November 2022, an obituary flashes all across the social media: "Kashmir's Reshma is no more.'

Soon people start heading towards the ancestral house of this popular transgender, originally named Abdul Rasheed, to mourn her demise, and pay condolences to the family and largely, transgender community.

"We're devastated," says Bablu, president of Transgender community as she rushes to prepare for the funeral of her life-long friend who after a brief ailment of six months passed away at SMHS hospital, Srinagar.

In the early hours of the hazy frigid season, a huge crowd congregated to pray the Islamic funeral prayer. Reshma's body was finally put to rest in her inherited graveyard at Merjanpora.

At home, everyone sit together to recollect the unforgettable memories of this 58-year-old who is looked upon as an "icon" in his community. A hardworking sensational singer and a tailor by profession left with an everlasting impact on everyone who knew him as "Reshma."

Born in 1965, Reshma lived a simple life, and valued little things that she earned by the virtue of her relentless hardwork and innovative personality. Living an invisible yet meaningful life, it was in 2018, when one of her songs went viral on internet and she became a household name.

Soon after this, her enticing personality and her singing style gave her prominence, and she started receiving invitations for wedding ceremonies, and concerts from families all across the valley.

Knowing her liabilities, she decided to take this opportunity. At this time, despite being a member of a marginalized community with fewer resources, she pledged to invest in the family of her departed sibling - a family of five, and get them married and settled before her eyes

"She supported my family when there was no one to take care of us," says Shahzada, Reshma's sister-in-law. "She was a father and a mother to my children.3

Reshma's flair for composing songs, and pidginizing lyrics in a humorous way not merely helped her grow as an artist but bestowed her with a wider acceptance amongst the society - something that she yearned for last 53 years.

Her popularity also unexpectedly deposited confidence in other members of her community, and helped them become vocal about their rights. Standing at the forefront of the fight for her community, she guided and inspired many.

"Reshma urged us to work hard and live our lives with dignity," says Rahat, her colleague, a 40-year-old transgender. "She once told me: Do something that keeps your name alive even after your death.

A struggle of years, family support and patronage from her own community helped Reshma defer the jeers aimed at her but ordeal of 4000 transgenders in a nservative and conflict-ridden Kash-

source of livelihood we have. My room rent is Rs 3000 per month. Please tell me how much do I spend on my necessities and how much do I save?

Earlier Ramzan had contemplated shifting to some other place after her tussles with the landlord but being the only bread-winner, she would hardly find a place that she could afford. Moreover, her difficulties escalated when she had to spend most of her savings, during the Covid-19 pandemic phase.

Back in March 2021, the union mintry of social justice and empowerment issued a pandemic advisory stating "a subsistence allowance of Rs 1500 should be disbursed to each transgender as immediate support to meet their basic requirements".

of social justice and empowerment formulated a scheme – SMILE (support for marginalized individuals for livelihood and enterprise) which includes comprehensive rehabilitation of transgender persons including housing facility in the form of "Garima greh" that ensures clothing, recreational facilities and skill development programmes. However, no such work has been initiated in the

"One of my relatives even spat to my father's face and called him a father of filth.'

In his last days, Shabnum's father visited her for the first and the last time and asked for forgiveness.

"This is an indelible mark on my heart," she says. "My father didn't die a natural death. The taunts of people killed my father. And they're the ones who call themselves 'normal'."

BUDDING TRAUMA 1 Kashmi

According to psychologists, transgenders and gender-diverse persons experience significant health and wellbeing disparities when compared to their cis-gender peers and can be mitigated by individual-level factors such as strong family relationships.

'We shouldn't instil shame in our children," says Waseem Kakroo, a clinical psychologist of Srinagar. "If parents find themselves in a fix, they should find a professional to help them. It's better to talk to people with expertise in the field instead of hiding or perpetrating viois here. She's friends with her other roommates, but is terrified of Saniya.

Saniya is the elder one and knows how to guard these abandoned teenagers who come to live with her. She's worried about the younger generation that could be vulnerable to exploitation by men and women in the society.

"Since there's an emotional distress," Saniya says, "we easily fall in love."

She names few transgenders who were abused physically and emotionally, and then robbed off all the money they had earned. There're incidents of transgenders being gang-raped by a group of six drug addicts, and the one who was raped at a wedding ceremony, and a case of a minor who was abused at the school in the preceding year, to list a few.

In India, the sentence for rape is up to ten years in prison for a cis-gender. However, in the legislation set up in 2019 by the ministry of social justice, the penalty for any sexual abuse against a transgender doesn't exceed two years.

This bill ironically has been passed to empower and safeguard the rights of this marginalized community.

Saniya wants to raise these issues but is apprehensive about being misjudged and ignored. "Nobody comes forward to speak about these crimes," she says. "People are reluctant. We are facing multiple levels of oppression and don't have mainstream opportunities to report them.

She also points out how a section of people think that transgenders, significantly transwomen, dress to get exploited. "We know our limits," Saniva says. "It's unfortunate how people think we dress to attract men. If a cis-gender woman grooms herself, does that mean she should be raped?"

She extensively talks about the myth in the society that being a transgender is pretence involving emotions that are deceptive. However, medical science is providing long insights about their 'actual' condition.

"Fundamentally," says Dr. Hamid Zargar, a top endocrinologist of the valley, "sexual identity comes from proper development of sexual organs, and the endocrine system associated with them. However if there're some structural or hormonal anomalies it can lead to sexual ambiguity. This is a medical condition. and person needs to be evaluated on time. Most can be helped by assigning them a proper biological sex.'

Apart from the field of endocrinology, researchers in neuro-anatomy have been exploring the science of gender identity.

Many studies have revealed that there's a neurological difference between the brain of a cis-gender and transgender.

With reference to this, a research by Dr. Murat Altinay, MD Head of Transgender Mental Health at Center for Adult Behavioural Health, U.S.A. shows structural and functional similarities between the transgender brain and the gender it identifies with.

For example, a person who's born with male genitals and ends up identifying as a female often actually has some of the structural characteristics of a "female" brain. Moreover, the brain activity of transgender people tends to look like that of the gender they identify with. Other research studies, as Dr. Altinay writes, also show that brains of transgender people are somewhere in between, sharing characteristics of both male and female brains. For now, Saniya is worried about Farah and other transgenders in her community, and believes that it's only education that can unfetter them from the cycle of oppression, "and awareness is the first step towards acceptance".

mir still remains unattended.

This marginalized community continues to struggle for their rights, and fight discrimination in every aspect of their life. From finding home to homelessness, traumatic childhood to depressed adulthood and gender dysphoria to death on roads, the story is manifold.

LIFE OF A TENANT

Muhammad Ramzan emerges from her bed silently, and out-of-routine looks into the mirror that's hanging haphazardly on the wall of her single-room apartment.

This sexagenarian trans-woman lives on rent at one of the posh colonies of Srinagar. The building accommodates 25 people, among which 12 are from transgender community. "I've been living here for last 28 years," says Ramzan, who migrated from Pulwama to Srinagar in 1995.

The quality of this unvarnished room that's divided in two sections reflects the ordeals of her life – a make-shift kitchen with a row of utensils tucked in an open cupboard in one section.

And the other section is a place for sitting and sleeping. The accommodation feels cold, not like something that one would call home. Besides, there's no television or any other means of recreation.

This is how 90 per cent of the transgenders live in Kashmir- as tenants.

"This is our life," says Ramzan as she wears surma in her eyes. "We only come here to sleep."

Her face looks tired as she didn't sleep enough the other night. She arrived late after attending marriage ceremony of one of her clients.

In Kashmir, most of the weddings are managed by transgenders, and many of them either work as match-makers or artists who sing and dance at wedding ceremonies.

A match-maker for over 35 years now, Ramzan has presided over 300 marriages. Though intermittently, her encounter with the families has been disappointing.

"Even those families that are affluent negotiate too much, and sometimes they even don't pay," says Ramzan earning barely Rs 10 thousand a month. . "They fail to understand that this is the only

But transgenders in Kashmir couldn't avail the benefit as they lack basic documentation such as proof of residence, election cards and ration cards required for verification. Due to lack of awareness programmes by the concerned department, many remained uninformed of this "special scheme."

For the community, this failure of identification process has also been one of the major hindrances in receiving remuneration of Rs1000 which they're entitled to under pension scheme.

"After Covid-19," continues Ramzan, "many from our community were left with no work at all. We received no financial compensation from government. It was only with the support of some NGOs that we were able to make our ends meet."

Amid this apathy and at her ripe age, Ramzan wakes up early and wanders around in the city to find prospective clients, most of the times, by foot.

"I get tired now," she sighs. "Sometimes I feel hungry but I don't have energy to cook for myself so I go to sleep without taking dinner. Having my own shelter was my dream but I don't think I can fulfil that now."

In the same apartment, another transgender—Sahiba aka Arshad Sufi—calls Ramzan to inquire about a client.

"She accompanied us here in 2019 after the revocation of Article 360," pointing to Sahiba, a trans-woman in her mid-40s savs.

Sahiba was evicted of her rented place when she couldn't pay the rent. She's a matchmaker and a beautician too.

"My landlord abused me savagely, and called me names," says Sahiba, with a deprived tone. "I couldn't take it anymore, so I left. After all I am also a human being."

After she left the place, she struggled to get a place on rent and had to sleep in a shrine for a week.

The debate on the need for government sponsored accommodation for trans-people has been on-going for the past few years now.

One in hundred families sees the third gender an integral part and do not belittle their presence, says Shabnum, a 48-yearold transwoman residing in an old city. "Everyone else doesn't even want to stand next to us," she says. "We make relationships. What other job is more pious than this?"

Wearing a grey Kameez Shalwar and hand-knitted black skullcap, Shabnum with a youthful look turns unhappy. "I wanted to study," she says, "but my father got me discharged from school when I was 10."

Her typical feminine behaviourwearing makeup, sitting with girls in the class and playing with them—was what got him in trouble.

Her father told her to stop behaving like a girl. "But how I could tell my father that I can't stop behaving like something that I really am," Shabnum says.

Transgender, in medical terminology, refers to a person with a gender identity different from the sex assigned to them at birth. Like a transgender woman who lives as a woman today, was thought to be a male when she was born and a transgender man who lives as a man today was thought to be a female when he was born.

Moreover the term "transgender" is used to encapsulate various gender identities, including gender diverse individuals who identify outside the sociallyconstructed gender binary of male and female.

At the age of 16, due to constant trauma from her siblings and relatives, Shabnum had to run away from her home in Baramulla. Three decades later, hardly any of her family members except her father has paid her a visit to Srinagar home.

There are instances when a tinge of gloom passes over Shabnum's face, and it's when she talks about her parents. "My mother was ill and nobody took care of her," she says. "I had to return home despite knowing that nobody wants me there. I served my mother like a daughter, and she passed away in my arms.

After her mother's death, her relatives provoked her father to kill her as she would bring disgrace to their entire clan. "They tortured him with their words and ultimately his health deteriorated too."

placed at fringes and face a lot of abuse, humiliation and discrimination, however the startling revelation is how this cycle of violence starts at home, followed by victimization at school and ultimately being ostracized by the society, says Dr. Aijaz Bund, academic and prominent LGBT activist from Kashmir.

"We see gender in binaries or dichotomies," Dr. Bund added. "Anyone who transgresses these rigid binaries is eventually 'othered'. Existence of such a person is considered an abomination to family honour. Also, transgender phobia is so much that families disown their own children - sometimes unknowingly due to fear of the society, which is awful."

Amid these troubles, Sara unwittingly started to dress like a girl at the age of 8. She was taken birth as a boy to her parents.

"But I loved to powder my face, and wear Dupattas," says Sara, a 19-year old transgender. "But my mother used to beat me with a bathroom bucket, telling me: Cze kyah laans chuke (Are you a eunuch)?"

Sara was clueless as why she was treated so badly by her own mother. Most of times, her mother's unusual behaviour made her impulsive and she would start banging doors and windows.

"Even my father told me, Cze chukh mve gonhan hund saza (You're a punishment of my sins)," says Sara. "He never beat me, but his words pierced my little heart like an arrow."

Most of the times, Sara had to lull herself to sleep as she had grown fearful of her own parents. Both of them are educated and work in a reputed government organization.

At school, Sara's misery intensified as she was harassed by her classmates for the way she talked and behaved. "When I reached my puberty, my friends frowned at me," says Sara.

At that time, her sense of gender was still unclear to her. This psychological abuse pushed her into gender dysphoria.

Everyone was sceptical about Sara's identity, but her anxiety wouldn't have escalated if her parents would've listened, and helped her through this. "Back home," she says, "I wanted to talk to my parents about this humiliation, but they never received my cues."

lence on your child."

Kakroo also feels contrite about the absence of awareness programmes in educational institutes and in the society at large which could help sensitize people about gender issues, and protect transgenders from this trauma.

"Gaps in sex education creates confusion, and leads to misgendering," he says. "Due to which many transgenders live a life of uncertainty and have mental health issues such as depression, anxiety disorder and suicidal thoughts."

At this time Sara is seeing a psychiatrist. She still feels impulsive, and has sleepless nights. The memories of her harrowing childhood are there, frozen in the corner of her mind, in the same room that she never dared to escape from.

LURED AND EXPLOITED

Farah shies away from seeing a visitor. She has been reprimanded by her Guru. She was not home since morning and returned after a daylong get-together with her friends.

"For the entire day," says Saniya, a 34-year-old transgender – also the leader of the group, sternly like a mother, "Farah either is grooming herself or roaming unnecessarily."

Saniya sits on the edge of her kitchen counter, staring at Farah with anger. "The conditions are worse," she says. "We cannot trust anyone."

In this rented space, there're two rooms — a bathroom and a kitchen joined to a living room. Five transgender women live together in this apartment. From a distance, not raising her eyes, Farah stands nervously to wash cups in the basin. She steals some moments to check views on her recent WhatsApp status. She has just uploaded her picture in a new look.

Farah owns makeup from top-class international brands and loves to experiment with her face. She's not interested in match-making or singing. "I want to be a designer," she says excitedly.

Farah dresses like a woman, and no one would take her as a Trans until she speaks. "At home I saw daylight in cracks, as I was not allowed to socialize," says this 17-year-old trans-woman. "I told my parents that I want to live with my own community, so I came here." It has been three months since Farah

DEATH ON ROADS

Living a substandard life, transgenders who've been forsaken by their families often die on roads, and denied burial by their own families.

"Two of our elderly transwomen died on footpaths during the harsh winter season in 2018," says Aijaz Bund.

One among them was a 90-year-old transgender who was suffering with dementia and her body was lying outside UN office in minus 2 degrees for 20 days.

In 2021, another incident raised hue and cry when a dead body of a transgender was lying on the road with stray dogs mauling over it. "The body was burnt and spoiled like roadside debris," Dr. Bund savs.

In Kashmir, each household owns a family graveyard which is a private land for burying the dead but the abandoned trans-genders are rejected by the families even after their death.

"Strict action will be taken against such families who deny cremation of their family member," says Mohammad Shafiq Chak, Director Social Welfare Department. "We're devising a policy to set up rehabilitation homes, and a community graveyard for transgenders in Kashmir."

But the death isn't an end to their troubles, says Bund as he recollects one of the family members callously telling him: She has always humiliated us. Please don't bring her here.

"We need a place where we can bury them," he says, "with dignity like other human beings.²

Private Member's Bill On Uniform Civil Code Introduced In Rajya Sabha

New Delhi: A controversial private member's Bill that seeks to provide for a panel to prepare a Uniform Civil Code was introduced in the Rajya Sabha on Friday.

'The Uniform Civil Code in India Bill, 2020' was introduced in the Upper House amid protests from opposition parties. BJP MP Kirodi Lal Meena

moved for leave to introduce the Bill to provide for the constitution of the national inspection and investigation committee for preparation of a Uniform Civil Code and its implementation throughout India and for matters connected therewith during the private member's business.

However, opposition members from Trinamool Congress (TMC), Marumalarchi Dravida Munnetra Kazhagam (MDMK), Rashtriya Janata Dadl (RJD), Samajwadi Party (SP), Communist Party of India (CPI), CPI (Marxist), Nationalist Congress Party (NCP), and Congress protested against the introduction of the Bill saying, if passed, it will

"destroy" the social fabric and unity in diversity that is prevalent in the country. With the Opposition members seeking withdrawal of the Bill, Rajya Sabha Chairman Jagdeep Dhankhar called for

division and the motion for introduction of the Bill was passed with 63 votes in favour and 23 against it.

In the past, although the Bill was listed for introduction, it was not moved in the Upper House.

The Bill envisages a collection of laws to protect the personal rights of all citizens without considering religion.

"We have a private members' Bill that is totally unconstitutional, unethical, antisecular. It is being introduced as a private member's Bill by an indulgent government to test the waters in a very dangerous game. This is brinkmanship," Jawhar Sircar of the Trinamool Congress said.

He further said,"There is still time to refrain from making demonstrations of a temporary majority and inflict one sided opinion on a very secular and plural India."

MDMK MP Vaiko accused the ruling dispensation of "implementing one after another agenda of the RSS and BJP" and said,"They have finished Kashmir. Now they have come to common civil code."

He said it is leading towards "disaster of the country and its disintegration and minority people are terribly hurt".

Similarly, Abdul Wahab of Indian Union Muslim League (IUML) said the Bill has been attempted to be introduced many

times in the past and "this is a sort of provocation deliberately the BJP" and asserted that the uniform civil code cannot be implemented in India.

Leader of the House, Piyush Goyal objected to the allegations of the Opposition members.

"It is a legitimate right of a member to raise an issue, which is a directive principle of the Constitution...Let this subject be debated in the House. At this stage to cast aspersion on the government, to use the names of the very members of the constituent assembly to try to criticise at the introduction stage is uncalled for," he retorted.

Manoj Kumar Jha of the RJD said when the Bill came for introduction on many occasions earlier, the BJP requested Meena not to proceed further and good sense prevailed then. "I am witness to six such oc-

casions. What has changed I don't know," he said, adding at a time when cities, villages and families have been "divided", if such Bill was brought it would further divide the country.

Ram Gopal Yadav of SP said the Bill was against provisions of the Constitution related to fundamental rights and it should not have been allowed it to be introduced in the Upper House at all, requesting the Chairman to ask Meena to withdraw the Bill.

DC Kulgam reviews progress of works in KPDCL, PMGSY & other sectors

KULGAM: The Deputy Commissioner (DC) Kulgam, Dr Bilal Mohi Ud Din Bhat today chaired a meeting of officers of KPDCL, PMGSY and other departments to review their functioning and implementation status of schemes.

SC Dismisses PIL On **Religious Processions**

New Delhi: The Supreme Court on Friday dismissed a PIL filed by an NGO seeking framing of guidelines to regulate religious processions, brandishing swords and firearms, and grant of permission to such events by state administration, asking why such festivals are portrayed in poor light as a reason for riots. A bench of Chief Justice D Y

Chandrachud and Justice P S Narasimha refused to entertain the PIL filed by NGO Citizens for Justice and Peace, of which social activist Teesta Setalvad is the Secretary, saying law and order is a state subject and, moreover, issues like laying down the SOP (standard operating procedure) for grant of permission for religious processions are "judicially manageable" in a diverse nation like India.

"Why do we always want to portray that religious festivals are the time for riots? Let us look at the good which happens in the country. See, in Maharashtra during 'Ganesh Puja'. lakhs of persons gather but there are no riots," the CJI observed during the brief hearing.

Senior advocate C U Singh, appearing for the NGO, said the guidelines dealing with

permissions for procession are there but they are not implemented.

"There has to be overall guidance and no court, except the Supreme Court, is equipped to deal with the national issue," the senior lawyer said, adding, "Processions are taken out brandishing swords, firearms during religious festivals".

"In case of violation of permission, one has to invoke Article 226 (before the high court)," the bench said, adding the country is diverse and the conditions in one part are different from other parts.

It said law and order is a state subject and has to be handled by the state administrations.

"The law and order is the state subject. The issues from Kashmir to Kanyakumari are different. How can this court monitor this? These prayers are not judicially manageable. It seeks the roving writ of man-

damus...," the bench said. It said the Supreme Court cannot be dragged into every area of law and order. The counsel for the NGO then sought to withdraw the PIL which the court disallowed.

"Sorry. No withdrawal with these prayers. Dismissed," the bench said.

Several months ago, Latif's contract was terminated, for which the federal government offered no valid reasons.

Since then, the ETPB has been managing the affairs of the Kartarpur Corridor by appointing officers on an ad hoc basis.

The Economic Coordination Committee of the Federal Cabinet had in 2020 approved the establishment of the Project Management Unit (PMU) Kartarpur Corridor, a self-financing body for the

management and maintenance of Gurdwara Darbar Sahib Kartarpur under the administrative control of ETPB.

Earlier, the ETPB was only looking after the affairs of the Gurdwara Darbar Sahib.

In November 2019, the then Prime Minister Imran Khan formally inaugurated the Kartarpur Corridor as part of the commemoration of the 550th birth anniversary of Guru Nanak at a ceremony that payed the way for Indian Sikh pilgrims to visit one of their holiest sites, situated in Pakistan, without a visa.

the goal of achieving highest satisfaction. "Initially," Dr. Shah continued, "the drug addicts take the substance orally but when they

don't get the desired satisfaction, they inject the drugs into their veins. But after some time when the veins get blocked, they inject the drugs into their skin and because of contamination, the skin gets infected. It leads to scars and ulcers."

Dr. Shah who treated both the patients told Kashmir Observer that the duo's legs and other body parts were severely involved.

"But they weren't alone facing that torment," Dr. Shah said. "Due to substance abuse, there are thousands of drug addicts in the valley that had become victims of skin popping."

Earlier, Dr. Shah had carried out a study titled. "Prevalence and pattern of dermatological manifestations among substance users across Kashmir in north India" which revealed that "dermatological manifestations" are quite prevalent among substance users of the valley.

The study noted that Pruritus or itching was found to be the most common dermatological manifestation overall and statistically significant among heroin users.

The study included a total of 710 cases with 657 males (92.5 per cent) and 53 females (7.5 per cent). The male/female ratio was 12.4:1. The mean age of patients was 25 years.

According to the study, over 439 patients among 710 cases were infected with Pruritus, while 244 young patients were infected with oral problems-periodontal disease, thrush, stomatitis nicotinica, black hairy tongue.

The study, which Dr Shah carried along with Dr. Shagufta Rather and Dr. Iffat Hassan (HOD Dermatology) under the guidance of Dr. Arshad Hussain, professor at IMHANS, further revealed that 213 substance-abuse patients were found to be infected with Hyperhidrosis, 203 patients had stigmata of injectable drug use (track marks and sooting tattoos), 125 had acne vulgaris. Hesitation cuts were found in 116 patients, while facial hypermelanosis with Periorbital darkening were found in 89 patients. Plus, 69 patients were infected with skin popping scars.

The study was a cross-sectional research and was carried out for a period of 18 months. The samples were taken from patients of all age groups and gender, admitted at various drug de-addiction centres (DDC) from multiple districts within Kashmir valley.

The study further noted that the recognition of such "cutaneous signs" is important in these cases for more effective diagnosis and treatment. Creating awareness regarding such with substance use is also imperative.

"The pattern of substance use has seen a shift toward opioid use being highly prevalent in Kashmir Valley with heroin being most commonly abused among them compared to cannabis, being the most common substance used in the past," the study noted.

The most common substance used by study cases was heroin (515) followed by cannabis (334).

It noted that the oral involvement was fairly common in heroin users where the mode of administration was smoking. "Tooth decay and periodontal disease could be seen in many of these heroin users (19 per cent)," the study says. "30.7 per cent of injectable heroin users ended up with the presence of skin popping scars.'

It further observed that 18.8 per cent of injectable drug users had active skin ulcerations and skin and soft tissue infections.

Fresh Snowfall

The MeT office has said the weather will remain cloudy with intermittent light rainfall at many places of Jammu and in the plains of Kashmir

There is a possibility of light snowfall in the plains of Kashmir during December 9-10 forenoon, whereas few areas in the higher reaches of the valley may receive moderate snowfall, it said.

The weather office has predicted slight respite in cold during the next two or three days.

Meanwhile, Mughal road, connecting twin districts of Poonch and Rajouri with Shopian, remained closed overnight while authorities on Friday also shut Srinagar-Leh highway after fresh snowfall.

A traffic department official here however said that traffic was plying on Jammu-Srinagar highway, the only surface link connecting Kashmir Valley with the outside world. "Mughal road and SSG road closed for vehicular movement due 2 fresh snowfall," the official said.

Meanwhile, authorities in Anantnag have urged people of Larnoo and tourists to refrain from venturing out in landslide and shooting stone prone areas as well as from travelling on Sinthan pass and Margan pass roads from till December 11.

"In view of predictions by the meteorological Department for widespread rains, snowfall and bad weather conditions, people of Tehsil Larnoo and tourists are advised to refrain from venturing in landslide and shooting stone prone areas," Tehsildar Larnoo said in an

"Moreover rainfall/thunderstorm/snowfall may lead to disruption of traffic on Sinthan pass and Margan pass roads. People are advised to refrain from travelling on these two roads from (till) 11th of December 2022."

Also in compliance to the directions of SDM Kokernag, he said, SHO Larnoo and Naib Tehsildar Larnoo are directed to setup naka at Daksum and Gowran and restrict all kinds of vehicular traffic on Sinthan pass and Margan pass roads till December 11. "Moreover Assistant tourist officer Kokernag shall place 4 tourist guards at Daksum naka and Range officer Daksum shall place 4 forest guards at Gowran naka from 4pm to 9am on the days when the aforementioned roads are closed." (With agency inputs)

"Senior officers of Transport and Traffic departments must monitor all aspects of Road Safety on priority and there has to be effective coordination of all Departments in this endeavour." he added.

On being apprised about the installation of CCTV cameras on National Highways by the National Highways Authority of India, the LG asked the NHAI officials to carry out the task on all NHs of UT within a predefined time frame.

He also passed explicit directions to concerned officials for conducting safety audit of all major and internal roads at the earliest.

The LG also called for ensuring enforcement of safety laws and generating greater awareness among all stakeholders including drivers, transporters and youth.

"Involve School Education and Higher Education Departments for spreading the message of road safety," he added.

Divisional Commissioners were directed to take strict measures for removal of all encroachment from Roads including hoarding that creates barriers for safe driving.

The LG asked the Traffic Police to put a crackdown on over-speeding and ensure regular highway patrolling.

"Installation of road signages and speed limits boards should be given special focus, " he said.

Health department was instructed to explore the possibility of developing trauma centres facilities, if required anywhere.

Directions were also passed on adopting digital and automated systems and ensuring optimal utilisation of the existing equipment and digital technology installed on Highways and roads.

The final electoral rolls have a total of 83,59,771 electors -- 42,91,687 males, 40,67,900 females and 184 third gender.

During this special summary revision period, a record 11,40,768 claims were received for inclusion of names in the electoral rolls across the Union territory.

Out of these, 11,28,672 claims were accepted and only 12,096 claims were rejected. These included 3,01,961 claims of inclusion in the age group of 18-19.

A total of 4,12,157 requests for deletion were received, out of which 3,58,222 were accepted and 53,935 were rejected.

There has been an addition of 613 new polling stations in the Union territory.

The gender ratio of the final electoral Roll has increased from 921 to 948.

Panchayat System Cannot **Replace Elected Govt: PDP**

SRINAGAR: Though the 2018 local body elections in Jammu and Kashmir were a success, the panchayat system cannot replace an elected government, the Peoples Democratic Party has said

The former chief minister Mehbooba Mufti-led party made these remarks in its monthly newsletter 'Speak Up', amidst demands by the mainstream political parties in Jammu and Kashmir for conducting assembly polls in the union territory.

"The Supreme Court recently reserved its judgment on delimitation and GOI's justification for early delimitation was that they wanted to give Kashmiris 'immediate

democracy' "The panchayat elections were a success but a panchayat cannot replace an elected government. Democracy can never be instant or immediate because it is a process that goes beyond polling day," the party said. The PDP as well as the National Conference had boycotted the local body polls, seeking a guarantee from the Centre over the protection of Jammu and Kashmir's special status under Article 370 of the Constitution. However, the government revoked Jammu and Kashmir's special status and divided the erstwhile state into two union territories on August 5, 2019.

The newsletter claimed that since the abrogation of Article 370, the "atrocities" on Kashmiris have crossed all limits. "Since the abrogation (of Article 370), Kashmiris have seen nothing but strife. In

some ways, the constant lockdowns and never-ending communication blackouts inoculated us to the Covid lockdowns that came next. "While people elsewhere

were complaining about boredom and loneliness, Kashmiris were for the most part silent," it said

However hard the circumstances are, Kashmiris have learnt to make do, the newsletter said.

'The dystopian nightmare of these past few years has devastated us, but it has also made us anti-fragile. Since ancient times, people have been fortifying themselves with small doses of toxins to achieve hormesis. "It really makes you wonder if we've undergone a societal hormesis of some kind that enabled J-K to survive the worst circumstances that would have brought any other state to its knees," it said. Although adversity in small doses can be beneficial to achieve robustness, "it doesn't change the fact that we are being poisoned, slowly and steadily, one deadly measure at a time, be it our economy, industry, press, education or our civil society", the PDP said.
