LG Meets Power Minister, **Urges Higher Allocation To J&K**

New Delhi: The Jammu and Kashmir Lieutenant Governor, Manoj Sinha on Thursday held a meeting with the Union Minister of Power and New and Renewable Energy and requested higher power allocation to the Union Territory.

In the meeting held here, Power Secretary, Alok Kumar and other senior officials of the Ministry of Power and New & Renewable Energy were also present, an official spokesperson said Thursday.

He said various measures required to ensure uninterrupted power supply and improve power infrastructure in the Union Territory of J&K were discussed. The LG, he said, urged high-

er power allocation to J&K, to which the Union Minister of Power assured to examine this



request and take early action. The spokesperson said that the LG also shared the efforts of the UT Government toward building up transmission and

distribution infrastructure and steps taken to reduce the AT&C losses and improving the quality and reliability of power supply to the people.

"Union Minister of Power assured that the ministry will extend all possible assistance to ensure adequate availability of resources," he added.

Transit Accommodations In Kashmir MPs Panel Asks Centre To Set Timeline For Completion

Srinagar: A parliamentary panel has recommended to the Union Home Ministry to set a timeline for the completion of construction of the remaining transit accommodations for migrants in Kashmir Valley and ensure that the deadlines are adhered to.

In its report tabled in the Parliament, the departmentrelated parliamentary standing committee on Ministry of Home Affairs has said that it is disappointed to note that precious time of four year has passed just in deciding the issue of constructing transit homes at private or government lands.

"The committee notes that only 1,025 units have been completed or substantially completed, while 1,488 units

are still at various stages of completion. However, the status of the construction of the remaining 3,487 units is unclear. The committee is disappointed to note that precious time of four year has passed just in deciding the issue of constructing transit homes at private or government lands. Now that the issue has been decided, the committee, therefore, recommends that the MHA should set a timeline for the completion of construction of the remaining transit accommodations and ensure that the deadlines are adhered to," reads the recommendations made by the panel after the government submitted an action taken re-

Under the Prime Minister's Development Package, 2015 **India Slams Pak For Raking Up Kashmir At UN Press Trust Of India**

United Nations: India has strongly hit back at Pakistan for raking up the Kashmir issue in the UN Security Council, arguing that a country that hosted slain al-Qaeda leader Osama bin Laden and attacked a neighbouring Parliament does not have the credentials to "sermonise" before the powerful UN organ.

External Affairs Minister S Jaishankar's strong remarks came after Pakistan Foreign Minister Bilawal Bhutto raised the Kashmir issue while speaking in the Council open debate on reformed multilateralism on Wednesday.

Jaishankar said the credibility of the UN depends on its effective response to the key challenges of our times, be it pandemics, climate change, conflicts or terrorism.

"We are obviously focused today on the urgency of reforming multilateralism. We will naturally have our particular views, but there is a growing convergence at least that this cannot be delayed any further," said Jaishankar, who is chairing India's signature event on reformed multilateralism.

"While we search for the best solutions, what our discourse must never accept is the normalisation of such threats. The question of justifying what the world regards as unacceptable should not even arise. That certainly applies to state sponsorship of cross-border terrorism. Nor can hosting Osama bin Laden and attacking a neighbouring Parliament serve as credentials to sermonise before this Council," he said. | More on P10

Govt Seeks Explanation From DDOs Over Salary Release

Srinagar: The Government on Thursday sought explanation within a week from Drawing and Disbursing Officers (DDOs) as to why a sizable number of employees were paid salary for October despite them not registering them with the Jammu and Kashmir Human Resource Management System.

"In order to streamline the Human Resource Management System across various Departments of Jammu and Kashmir, the General Administration Department vide Circular No 35JK (GAD) of 2022 dated 12 October 2022 and Circular No 40-JK (GAD) of2022 dated 28.10.2022 advised all the emplovees to register themselves on JKHRM portal and to forward the service details to the concerned DDOs for verification/updation," reads a circular.

"Further, it was also impressed upon all the DDOs that the salary for the month of October, 2022 shall be disbursed in favour of those employees only who have registered themselves/updated their service details on the designated portal and the concerned DDOs have verified the same," it said, adding, "However, it has been observed | More on P10

Section 269:

Negligent act like to spread infection of disease dangerous to life: Whoever unlawfully or negligently does any act which is, and which he knows or has reason to believe to be Likely to spread the infection of any disease dangerous to life shall be punished with imprisonment of either description for a term which may extend to six months/ fine or with both.

Section 270:

Malignant act likely to spread infection of disease dangerous to life –Whoever malignantly does any act which is, and which he knows or has reason to believe to be likely to spread the Infection of any disease dangerous to life, shall be punished with imprisonment of either description for a term which may extend to two years / fine, or with both.

Failure to take the mandated steps may attract the Provisions of Sections 269 and 270 of the Indian Penal Code (IPC).

Study Finds Exercise, Mindfulness Don't Boost Cognitive Function In Older People

n extensive study that looked at whether mindfulness training and exercise could improve cognitive performance in older persons showed no such improvement after either intervention.

Researchers from the University of California, San Diego and Washington University School of Medicine in St. Louis examined the cognitive benefits of exercise, mindfulness practise, or both in older adults who reported agerelated memory changes but had not yet been identified as having dementia for up to 18 months.

The findings are published in JAMA.

"We know beyond any doubt that exercise is good for older adults, that it can lower risk for cardiac problems, strengthen bones, improve mood and have other beneficial effects -- and there has been some thought that it also might improve cognitive function," said the study's first author, Eric

I. Lenze. MD. the Wallace and Lucille Renard Professor and head of the Department of Psychiatry at Washing-ton University. "Likewise, mindful-ness training is beneficial because it reduces stress, and stress can be bad for your brain. Therefore, we hypothesized that if older adults exercised regularly, practiced mindfulness or did both there might be cognitive benefits -- but that's not what we found." Lenze and his colleagues still want to see whether there may be some cognitive effects over a longer time period, so they plan to continue studying this group of older adults to learn whether exercise and mindfulness might help prevent future cognitive declines. In this study, however, the practices did not boost cognitive function.

"So many older adults are concerned about memory," said senior author Julie Wetherell, PhD, a professor of psychiatry at UC San Diego. "It's important for studies like ours to develop and test behavioral interventions to try to provide them with neuroprotection



and stress reduction as well as general health benefits.

The researchers studied 585 adults ages 65 through 84. None had been diagnosed with dementia, but all had concerns about minor memory problems and other age-related cognitive declines. "Minor memory problems often

are considered a normal part of aging, but it's also normal for people to become concerned when they notice

these issues," said Lenze, who also directs Washington University's Healthy Mind Lab. "Our lab's principal aim is to help older people remain healthy by focusing on maintaining their mental and cognitive health as they age, and we were eager to see whether exercise and mindfulness might offer a cognitive boost in the same way that they boost other aspects of health.'

All study participants were consid-

ered cognitively normal for their ages. The researchers tested them when they enrolled in the study, measuring memory and other aspects of thinking. They also conducted brain-imaging scans.

The participants were randomly assigned to one of four groups: a group in which subjects worked with trained exercise instructors; a group supervised by trained experts in the practice of mindfulness; a group that participated in regular exercise and mindfulness training; and a group that did neither, but met for occasional sessions focused on general health education topics. The researchers conducted memory tests and follow-up brain scans after six months and again after 18 months.

At six months and again at 18 months, all of the groups looked similar. All four groups performed slightly better in testing, but the researchers believe that was due to practice effects as study subjects retook tests similar to what they had taken previously. Likewise, the brain scans revealed no differences between

the groups that would suggest a brain benefit of the training.

Lenze said the study's findings don't mean exercise or mindfulness training won't help improve cognitive function in any older adults, only that those practices don't appear to boost cognitive performance in healthy people without impairments.

"We aren't saying, 'Don't exercise or, 'Don't practice mindfulness,' Lenze explained. "But we had thought we might find a cognitive benefit in these older adults. We didn't. On the other hand, we didn't study whether exercise or mindfulness might benefit older adults who are impaired, due to dementia or to disorders such as depression. I don't think we can extrapolate from the data that these practices don't help improve cognitive function in anyone." Lenze said the researchers recently received funding from the National Institutes of Health (NIH) to continue following the group of adults who participated in this study.

DC Inspects Construction Site For Migrant Transit Accommodation At Zewan

Srinagar: The Deputy Commissioner (DC), Srinagar, Mohammad Aijaz Asad Thursday undertook a visit to Zewan area in Pantha Chowk Tehsil of District for onsite inspection of the works being taken up for construction of Migrant Transit Accommodations.

Chief Planning Officer, Mohammad Yaseen Lone, Assistant Commissioner Revenue, Raeis Ahmad, Tehsildar PanthaChowk, Rakib Ahmad, DYSSO, Balbir Singh and other concerned.

While inspecting the construction site for Migrant

Transit Accommodation at Zewan, the Deputy Commissioner took a detailed tour of the site where Migrant Transit Accommodations of 936 flats comprising 39 blocks are to be executed at an estimated cost of Rs 124 crore in the District.

Abduction Spree In Sumbal

RINAGAR: A series of ransom by pro-government gunmen in the Sumbal region of north Kashmir sparked off vehement protests to-day in the area. Thousands of residents demanding action against the gunmen staged a demonstration on the Sumbal Bridge, blocking traffic on the Srinagar-Bandipora highway this morning.

In the latest incident of the kind, gunmen had abducted a student, Ri¬yaz Ahmad Rathar of Waskoora, Ganderbal yesterday and sent word to his father, a fruit vendor to pay Rs 2 lakh for his son's release.

Similarly, gunmen are gearing up to extract a hefty amount from the owners of the Showhole floor mill for setting free their employee, Ghulam Muhammad Goiri, kidnapped recently, Sumbal residents said that pro-government gunmen had abducted nearly a dozen traders who frequent the town to reclaim loans. Former Iraqi Pm Under US **Protection, Faces Arrest For** Soleimani Assassination: Report

raqi lawmakers are considering arresting former Iraqi prime minister Mustafa Kadhimi for his alleged role in the assassination of Abu Mahdi al-Muhandis and Qassem Soleimani by the US in 2020.

During an interview with Iraqi news outlet Shafaq News on 12 December, a senior official in the State of Law Coalition, Fadhel Mwat al-Zerigawi, revealed lawmakers are mulling over the decision. He also claimed Kadhimi is being sheltered inside the US embassy.

"The available information confirms that [Kadhimi] is in the capital, Baghdad, and has not left the country. He is inside the Green Zone, and is sheltering in the American embassy," Zerigawi said on Monday.

He then added: "The next stage will witness the issuance of arrest warrants and investigations against Kadhimi for his involvement in the [theft of the century] case and the assassination of Abu Mahdi al-Muhandis and Qassem Soleimani."

High-ranking military sourc-es that spoke with Shafaq News on condition of anonymity revealed that Iraqi troops assigned to protect Kadhimi this week received orders to withdraw from his home in the Green Zone.

Back in 2020, Iran suggested it had discovered evidence suggesting Kadhimi - who at the time directed the Iraqi National Intelligence Service – was in-volved in the assassination of

NEW DELHI: India on Thursday successfully testfired nuclear-capable ballistic missile Agni-V that can strike targets at ranges up to 5,000 km, marking a significant boost to the country's strategic deterrence, people familiar with the development said.

The test-firing of the mis-sile from the APJ Abdul Kalam Island off Odisha coast came amid India's lingering border row with China. The Agni-V project is

aimed at boosting India's nuclear deterrence against China which is known to have missiles like Dongfeng-41 having ranges between 12,000-15,000 km.

Agni-V can bring almost the entire Asia including the northernmost part of China as well as some regions in Europe under its striking range. The Agni 1 to 4 missiles have ranges from 700 km to

3,500 km and they have already been deployed. The Agni-V missile has been successfully test-fired,

two people familiar with the matter said. There is no official word on the night trials of the missile.

The people cited above said the test validated a number of critical aspects of the weapon.

Direct Evidence Not Necessary To Convict Public Servants In Corruption Cases: SC

he Supreme Court on Thursday said a public servant can be convicted for illegal gratification in a corruption case on the basis of circumstantial evidence when there is no direct oral or documentary evidence against them.

A five-judge Constitution bench headed by Justice S A Nazeer said complainants as well as the prosecution should make sincere efforts so that corrupt public servants are brought to book and convicted so that the administration and governance become unpolluted and free from corruption. "In the absence of evidence

of complainant (direct or primary), it is permissible to draw an inferential deduction of culpability," the bench, also comprising justices B R Gavai, A S Bopanna, V Ramasubramanian and B V Nagarathna, said.

The top court said that even if direct evidence of the complainant is not available, owing to death or other reasons, there can be conviction of the public servant under the relevant provisions

NEW DELHI: The Central Board of Secondary Education on Thursday warned students and parents against a fake website of the board and asked them not to make any payments on the portal for downloading admit cards for class 10 and 12 exams.

"It has come to the notice of the board that certain unscrupulous elements have created a website resembling the official CBSE website www.cbse.gov.in.

"This fake website has been created with the address https://cbsegovt.com/ and is blatantly duping unsuspecting

students, schools and parents by sending messages to deposit money for creating and downloading the admit card for CBSE class 10 and 12, 2023 examinations," the board said in an advisory.

It asked the public and stakeholders to be "extremely careful and not respond to any such fake messages and websites".

The board does not take any fees directly from any students or parents for downloading admit cards, it added.

The class 10 and 12 board exams are slated to be held from February 15 next year. The board has, however, not announced the exam schedule yet.

Man Kills Friend Over ₹ 10 In West Bengal's Siliguri

SILIGURI: A 20-year-old man was bludgeoned to death with a rock in northern West Bengal's Siliguri allegedly by his friend over ₹10, police said on Thursday.

The body of Ramprasad Saha was found in the Baikunthapur forest, they said.

He went to the forest on Monday with his friends Subrata Das, 22, and Ajay Roy, 24 -- all of whom are addicts, they said. After getting high, Ramprasad Saha found he was out of money and then asked Subrata Das for ₹ 10 to buy more drugs, they added.

Soon, a fight broke out and Subrata Das allegedly bludgeoned him to death with a stone, police said.

Officers of Ashighar outpost of Siliguri Metro Police arrested Subrata Das and Ajay on Wednesday night, following which the case was cracked, they said.

Police said they are examining the role of Ajay during the entire episode.

Govt Sets Up Panel To Frame Export Policy For Agri Products

Initiative To Enhance Annual Agricultural Exports From Rs 190 Cr To Rs 3000 Cr In Next 5 Years

JAMMU: In its endeavors to boost agricultural export from the Union Territory, the Jammu and Kashmir government has constituted an expert committee to formulate a comprehensive Export Promotion Policy for identified potential exportable agricultural commodities.

The primary assignment of the committee would be to develop commodity specific export promotion recommendations which inter alia shall include strategic and operational aspects of the export. Besides, it shall provide all necessary technical inputs to Agriculture Production Department within a set timeline of one month for finalization and implementation on ground.

The main objective of the Export Promotion Policy would be to increase annual agricultural exports from current Rs190 crore to Rs 3000 crore over next 5 years. Besides, the policy would promote brand "J&K" for its pristine agro-climatic conditions, uniqueness and near organic quality. It would also diversify the UT export base and thereby empower farmers with adequate export opportunities. The policy would create an ambient ecosystem for export agricultural commodities from J&K.

The policy would lay em-phasis on bringing a paradigm shift in the approach from mere harvesting and selling of produce at local level to a demand driven supply activity with focussed attention on GI tagging, processing, stringent quality control, international certifications, traceability, branding and marketing of the produce. The diverse agro climatic conditions of J&K have resulted in development of niche crops offering adoption of holistic approach for promotion of agricultural exports. This shall help the growers in finding post-harvest solutions at better prices within

Furthermore, the document inter alia shall also focus on market access initiative through assistance by Export Promotion Organizations, Trade Promotion Organizations, National Institutions, Research Level Institutions, Universities, Laboratories and Exporters etcetera for enhancement of exports by accessing new markets or by increasing the share in the existing markets. Besides, assistance shall also be extended in establishing quality control setup, national/international certifications, GI, transport and marketing assistance and all other prerequisite shall be duly taken care of for identified Agriculture Products like apple, basmati rice, walnut, almond,

achieving the envisaged goals.

Implementation of Export Promotion Policy shall accel-erate the pace of achieving a vibrant and commercially viable agriculture by harvesting the competitive advantage of J&Ks geo-climatic diversity to the fullest. Besides, this will monetize agricultural produce through export promotion and shall add a new dimension to the agricultural economy of

Easing Inflation

nflation in India fell to an eleven-month low of 5.88 percent in November, mainly due to softening prices of food items. Finance minister Nirmala Sitharaman has expressed confidence that the government will further bring down inflation. She told parliament that the government is keeping a watch on the price situation of essential commodities. Reduction of food prices is good news for people, especially, the lower middle classes and poor sections of society, who could barely manage to get by. Early this year, soon after Russia invaded Ukraine, the prices skyrocketed, depleted savings of a large majority of people across the world, including in India reversed the economic gains made in the wake of the recovery from Covid-19 pandemic.

The year has also been tough for Indian economy. Ukraine war triggered a deceleration in growth after some robust recovery following the abating of the pandemic. Global wheat prices rose to 15-year highs. Russia and Ukraine account for 60 percent of global wheat production. They also account for 28.9 percent of global wheat exports. War disrupted the exports. But thankfully due to the agreement to unblock Ukraine's Black Sea grain exports, the prices have since retreated to levels last seen before the Russian invasion of Ukraine.

India's growth has been projected to decline to 6.8 percent after registering a healthy increase of 8.7 percent in the last fiscal year. The recent past has also seen a reduction in inflation and Indian Rupee has strengthened somewhat against the other currencies. This would help stabilize the economy.

The war in Ukraine thus remains a danger, though. If it drags on, the global economy, and with it, the Indian economy, is likely to come under severe stress again. Therefore it is incumbent on the world to come together to resolve the crisis in Ukraine and find a solution that addresses the concerns of all the parties involved. Otherwise, as prophesied by leading economists, the world is heading inexorably toward recession.

However, as things stand, it looks unlikely that the Ukraine war will come to an end anytime soon. It has become an unremitting tug of war between Russia and NATO, where a defeat could drastically reduce the losing side's geopolitical influence. So, the best solution to the crisis has to be a win-win for both. But neither side has shown an appetite for it so far. One can only hope that in the coming weeks and months, efforts for peace will gather momentum.

Be Political

ne hundred days is an acceptable period to assess an endeavour. The Bharat Jodo Yatra being led by the Congress leader, Rahul Gandhi, will set foot on 100 days tomorrow. This long march, which aims to spread the message of unity across 12 states, has been met with an unexpected public response. The exuberance of the people has been remarkable even in states where the Congress is not in power. The intelligentsia, a far diminished force, is of the opinion that the yatra offers a ray of hope to a land that has witnessed an unprecedented assault on its democratic and pluralist traditions by an elected government. There is also a view that the march can varnish Mr Gandhi's public image that has been at the receiving end of much criticism — manufactured or bona fide. Mr Gandhi's involvement in the march and his commitment to its cause, combined with his ability to lend an ear to the ground, could, the argument goes, facilitate a transition of his credentials as a leader in the public eye.

Of course, India has been a land of long marches with different goals. M.K. Gandhi had energised a subjugated nation with his march to Dandi. Decades later, L.K. Advani's motorised yatra was instrumental in the resurgence of Hindutva as well as the concomitant stress on India's inclusive framework. More recently, aggrieved farmers marched against an indifferent Central government, forcing it to retreat on contentious agricultural legislations. But these initiatives and many others had one common characteristic: they were social as well as political exercises. Surprisingly, Mr Gandhi and his party have taken pains to ensure that the Bharat Jodo Yatra remains apolitical at its core. Consequently, in terms of strategy and rhetoric, it has remained conservative instead of being radical. There is no doubting that some of India's most cherished traditions and, cynics would add, institutions are under duress. Protecting and replenishing these cannot be an apolitical exercise. The same goes for the woes of the common people, many of which have been highlighted in the course of the march. It is the political responsibility of the Congress to mobilise electoral opinion on matters such as the unprecedented rise in prices or unemployment. The Congress's repeated electoral debacles may have forced Mr Gandhi to paint the Bharat Jodo Yatra in a decidedly idealistic shade. But meaningful transformation, the kind that the yatra is hoping to achieve, cannot be attained without a political agenda.

NEUROPLASTICITY THE SCIENCE OF LIBERATION FROM IMPACT OF **GENES AND EARLY ENVIRONMENT**

The cells in our brain called neurons exchange chemicals with each other in order to communicate. These chemicals, known as neurotransmitters, move between neurons at locations known as synapses. When a child grows, learns, or responds to their environment, it leads to the development of new connections between neurons. This network of neurons contains everything including our knowledge, skills, memories, habits, and more.

The ability of the brain to modify the organization of its neural network is known as neuroplasticity. It has the capacity to grow new neurons, connect them to existing ones, and move or remove others. Since new alteration of previous neural connections and formation of new neural connections can lead to change in the behavior of a person, thus, the capacity for change in a person is known as NEUROPLASTICITY.

THE MECHANISMS OF NEUROPLASTICITY:

The brains of newborns are continually developing new neurons. As they develop, these cells form a huge number of connections. By the time a person reaches toddlerhood, they will have around twice as many neuronal connections as an adult will require.

The environment of the growing child will stimulate the brain, strengthening some connections. For instance, the neurons in charge of fine motor control will form connections when a youngster is taught how to sketch. The neurological connections for sketching will get denser and more established as a child practices it.

The brain removes neuronal connections it is no longer using during adolescence. The term "pruning" refers to this procedure. When inactive synapses are eliminated, the brain can concentrate its energy on creating new synapses for critical functions that are frequently used.

Because the neural pathways are easier to form at a younger age, synaptic pruning helps to explain why some things (like learning a second language) are easier to learn. However, the brain keeps changing and evolving over the course of a person's life. At any age, new experiences have the power to fundamentally alter the way the brain is wired and functions. However, an individual's overall level of brain plasticity will decline as they age. Brain changes could occur more gradually and with less



impact. Elderly brains can still learn and grow, but it will happen more slowly than for younger brains.

HOW NEUROPLASTICITY CAN LEAD TO **HEALING AND ADAPTATION?**

Some brains can't perform all of the functions that other brains can. A child who is born blind may already have some disabilities. After a stroke or a brain damage, a person may also lose their ability to function properly.

Neuroplasticity can help the brain overcome problems when a section of it is injured or impaired. Here are few strategies the brain can employ:

1) Relocate brain functions to an adjacent compatible region:

than letting the visual cortex go wasted. So a blind person can read Braille or traverse a room using touch rather than using light to process and understand their environment.

The longer a cortex has gone without input, the better the brain will typically be at translating sensory data. An adult who just suffered ear damage in an accident may have a harder time rerouting sensory signals than someone who has been deaf their entire life.

NEUROPLASTICITY AND PSYCHOLOGY

Counseling for mental health includes neuroplasticity as a crucial component. People in treatment are actually creating the new neural connections that promote resilience as they acquire new coping skills. The older neural connections that led to unhealthy behaviors and cognitive distortions will be replaced by new neu-ral connections as people develop new ways of thinking, emoting and behaving through psychotherapy.

Neuroplasticity can also be enhanced by some psychotropic medications. Neuroplasticity is typically decreased in depressed people. In many cases, antidepressants can promote neuroplasticity and even repair the harm caused by a depressive episode.

Thus treating mental illness basically involves enhancing neuroplasticity. E.g., Neuroplasticity is frequently used by the brain to make up for cognitive impairment in the early stages of dementia. The total neuroplasticity of the brain can be enhanced by aerobic exercise and mentally demanding activities. According to research, these activities can help dementia sufferers slow the onset of their symptoms. When implemented early enough, psychotherapies can aid in initiating neuroplasticity and help the person deal with the bad influence of their genes as well as the influence of adverse childhood experiences and hence they may not live the rest of their life being their victim.

In the next article, I will write in detail about the neuroplasticity and epigenetics of psychotherapy. Stay tuned!

Can More Physical Activity Prolong Life?

st of us know that regular exercise is important for our health and longevity. But with our busy schedules, many of us struggle to find the time to fit in a workout. Data from our latest study has shown that you don't need a lengthy workout to get health benefits from exercise.

The research revealed that as little as three or four minutes of short, vigorous activity bursts throughout the day were associated with a substantially lower risk of premature death from all causes compared with people who did none.

To conduct our study, we recruited 25,241 participants from the UK Biobank study who reported they did not do any leisure physical activity or recreational walking more than once a week. Around 56% of participants were female, with an average age of around 62 years.

To ensure we were getting an accurate picture of their activity levels, we gave participants wearable fitness trackers - similar to smartwatches which they wore on their wrist for a week. This allowed us to accurately monitor their activity levels throughout the day - something that most people struggle to recall.

We then linked the data collected at the start of the study with the participants' clinical records for an average of nearly seven years afterwards. This allowed us to check whether any of the participants had died, and the



cause of their death.

We were careful to statistically control our analysis for factors that might otherwise explain the results - such as a person's diet or whether they smoked. We also excluded any participants who were already diagnosed with cancer and heart disease

at the start of the study, as well as participants who died in the first two years of the follow-up period. This allowed us to ensure the results were more scientifically robust.

Surprisingly, even though participants had not reported doing any structured exercise, about 89% did record what's known as vigorous intermittent lifestyle physical activity on the tracker. This is physical activity that typically lasts for less than a minute, and usually happens are part of our everyday life. Some examples of this type of physical activity include playing with children and pets,

carrying shopping, climbing briskly upstairs, walking uphill or running to catch a train.

On average, participants recorded eight short bursts of activity each day, totalling just under four-and-a-half minutes. We found that just three to four short bursts of activity everyday was associated with up to a 40% reduction in premature death from any cause, as well as death from cancer. It was also associated with up to a 49% lower risk of death from cardiovascular disease.

The benefits tended to level off the more short bursts of activity a person got. The steepest gains were seen when comparing those with around four to five bouts per day to those who did none.

These results are striking but seem to align with what other research has shown. Small-scale trials have shown that very small doses of vigorous intermittent activity can improve cardiorespiratory fitness, a vital predictor of longevity.

High-intensity exercise training (short workouts between ten and 30 minutes, where short bursts of intense exercise are followed by periods of rest) has also been shown to have favourable effects on blood sugar control, cholesterol, blood pressure and obesity, which may lower risk of both cancer and cardiovascular disease.

But our study is the first to show a link between non-structured physical activity with positive health benefits. Everyday activity

A large proportion of adults don't meet current physical activity recommendations. One in four people in England do less than 30 minutes of physical activity a week.

Many cite time restraints as a reason. By showing in our study the health benefits that everyday activity can have, it may be easier to motivate people who don't regularly work out to include at least a few short bursts of activity into their day.

Existing physical activity guidelines across the world are based on studies which have looked at the benefits of structured bouts of continuous activity - often in the form of sports, gym workouts, or a daily run. But our study shows that future public health guidance on physical activity may want to consider specific recommendations on short bouts of activity that can easily be incorporated into daily living.

While the wearable trackers we used in our study didn't provide information on where these short bursts of activity happened, many simple, everyday tasks can be considered vigorous intermittent lifestyle physical activity.

So if you're someone who may struggle to fit in a workout or may feel daunted by the task, there are probably many things you could do in your daily life to help you stay healthy alongside many opportunities to increase the amount and intensity of the exercise you do.

'Cluster Headache Sufferers More Likely To Have Other Illnesses'

luster headache sufferers maybe three times more likely to have other medical illnesses such as heart disease, mental disorders, and other neurologic diseases.

According to a study published in the December 14, 2022, online issue of Neurology(r), the medical journal of the American Academy of Neurology, cluster headaches are short but extremely painful headaches that can occur many days, or even weeks, in a row. The headaches can last anywhere from 15 minutes to three hours. "Around the world, headaches have an incredibly negative impact on people's quality of life, both economically and socially," said study author Caroline Ran, PhD, of the Karolinska Institute in Stockholm, Sweden.

"Our results show that people with cluster headaches not only have an increased risk of other illnesses, those with at least one additional illness missed four times as many days of work due to sickness and disability than those with just cluster headaches. They also have a higher chance of a long-term absence from work," said Ran.

The study involved 3,240 people with



cluster headaches from age 16-64 in Sweden who were compared to 16,200 people who were similar in age, sex and other factors. The majority were men, which is common with cluster headache.

Researchers looked at work records and disability benefits to determine how many days during a year people were absent from work due to sickness and disability.

Among those with cluster headaches, 92 per cent, or 2,977 people, had at least one additional illness. Of those without cluster headaches, 78 per cent, or 12,575 people, had two or more illnesses.

Of those with cluster headaches, more

women had additional illnesses than men, 96 per cent and 90 per cent respectively.

The average number of days a person was absent due to sickness and disability was nearly twice as high among people with cluster headaches with 63 days compared to those without cluster headaches with 34 days.

People with cluster headaches and at least one additional illness had four times as many absence days compared to people with cluster headaches who did not have an additional illness.

"This information can help us as we make decisions on treatments, prevention and prognoses," said Ran.

Common Workplace Fumes, Dusts May Heighten Rheumatoid Arthritis Risk

ccording to research published online in the Annals of the Rheumatic Diseases, breathing in everyday occupational dust and fumes from substances including vapours, gases, and solvents may increase the chance of developing rheumatoid arthritis.

The results also suggest that they may increase the harmful effects of smoking and genetic illness vulnerability.

Rheumatoid arthritis (RA) is a chronic autoimmune inflammatory joint disease marked by excruciating pain and functional impairment. Up to 1 per cent of people worldwide are impacted.

It is well known that smoking increases a person's risk of developing rheumatoid arthritis, but it is unknown what effect inhaling dust and fumes from the workplace may have.

In a bid to find out, the researchers drew on data from the Swedish Epidemiological Investigation of RA. This comprises 4,033 people newly diagnosed between 1996 and 2017 and 6,485 others matched for age and sex, but free of the disease (comparison group).

Personal job histories were provided and used to estimate the amount of individual exposure to 32 airborne workplace agents, using a validated technique.

Each participant was assigned a Genetic Risk Score (GRS), according to whether they carried genes that could increase their chances of developing rheumatoid arthritis.

Rheumatoid arthritis is characterised by the presence or absence of anti-citrullinated protein antibodies or ACPA for short. ACPA positivity denotes a worse prognosis with higher rates of erosive joint damage. Nearly three-quarters of those with rheumatoid arthritis testing positive (73 per cent) and negative (72 per cent) for ACPA had been exposed to at least one work-



place dust or fume compared with around two-thirds (67 per cent) of people in the comparison group.

Analysis of the data showed that exposure to workplace agents was not only associated with a heightened risk of developing rheumatoid arthritis, but also seemed to boost that risk further by interacting with smoking and genetic susceptibility.

Exposure to any workplace agent was associated with a 25 per cent heightened risk of developing ACPA-positive rheumatoid arthritis, overall. And this risk increased to 40 per cent in men.

Specifically, 17 out of 32 agents, including quartz, asbestos, diesel fumes, gasoline fumes, carbon monoxide, and fungicides, were strongly associated with an increased risk of developing ACPA-positive disease. Only a few agents—quartz dust (silica), asbestos, and detergents—were strongly associated with ACPA-

negative disease. The risk increased in tandem high GRS, was associated with a very high risk of ACPA-positive disease, ranging from 16 to 68 times higher, compared with 'triple non-exposure'.

In particular, the risk of developing ACPA-positive rheumatoid arthritis for the triple exposed was 45 times higher for gasoline engine exhaust fumes, 28 times for diesel exhaust, 68 times higher for insecticides and 32 times higher for quartz dust (silica). The corresponding range for ACPA-negative disease wasn't significant.

This is an observational study, and as such, can't establish cause. The researchers also acknowledge several limitations to their findings: the study relied on personal recall; and while the exposure estimates were derived using a validated method, the results can be relatively crude.

And given that there are often several workplace agents in the air at any one time, it is difficult to pinpoint which ones might be the potential triggers. Nevertheless, the researchers conclude: "Occupational inhalable agents could act as important environmental triggers in RA development and interact with smoking and RA-risk genes, leading to an excessive risk for ACPApositive RA."

Picky Eater? Research Shows It Could Be In Your DNA

n the last 40 years obesity has been constantly rising. This has happened despite the popularity of all kind of diets ranging from low carb, paleo or even ice cream based.

Many scientists believe this is because cheap junk food has filled supermarket shelves and fast food takeaways. This food is high in calories and other not so healthy ingredients such as saturated fats, simple sugars, and salt. But it's designed to taste delicious. Taste is a dealbreaker when it comes to deciding what to eat, diet plans or not. Yet our understanding of what makes food taste good is limited.

My team's research explored how genes and biological processes influence which foods we find irresistible. We partnered with UK biobank to ask the participants in our study how much they liked 139 foods, rating them from one to nine on a questionnaire, with nine being the most delicious. UK biobank is a collection of almost 500,000 UK volunteers, who agreed to provide their personal information for scientific purposes. They were aged from 50 to 70 at the time of our study.

We sent the questionnaire by email and received close to 189,000 responses. The first step in our study was to analyse links between food people said they liked. For example if someone likes pears, can we expect them to also like apples and strawberries. We mapped the relationships between different foods.

Good taste We found food can be categorised in three groups: highly palatable foods which include meat, junk food and desserts; low calorie foods, mostly fruit and salad vegetables, but also oatmeal and honey; and acquired taste foods which are strong tasting foods children generally dislike but learn to enjoy such as coffee, alcohol and spices.

The map revealed some surprises. Foods didn't group by flavour type (such as sweet v savoury) but by how likeable they were. For example, a taste for fruit juices correlated more with preference for desserts rather than fruit. So fruit juice went in the highly palatable category rather than low calorie. Foods people think of as vegetables do not cluster together.

The mild tasting ones such as tomatoes or courgette are in the low calorie group while the strong tasting ones, like bell peppers or onions, were in the acquired taste group. Also sweet drinks like sodas clustered closer to meat and deep fried foods despite their sweet flavour.

We then looked at which differences in people's DNA could be linked to the types of food they relish. We identified 325 different genes, mostly in the brain, implicated in determining what we like to eat. When we looked at how much the three categories of foods correlated genetically between each other we found that the highly palatable foods had no correlation with the other two categories of foods. This suggests there are two biological processes. One regulates a weakness for highly pleasurable foods while another regulates the rest.

What's next Twin studies suggest food preference is 50% genes and 50% personal experience. The family environment plays a role in children's food preferences but not in those of adults. The shift happens around adolescence. It is still not clear how a liking for different food matures in children as no one has carried out largescale longitudinal studies. My team would like to try and fill this gap in research next.

For our study we also used MRI brain scans to look in more detail at which areas of the brain correlated with the three food groups. We once again found that enjoyment of highly palatable foods was associated with a larger volume of brain areas involved in perceiving pleasure in food.

'Home Prices Set For Steep 6-10% Jump This Fiscal'

MUMBAI: Home prices across the top six cities are set to jump 6-10 per cent this fiscal and 3-5 per cent in the next financial year because of a steep rise in raw material, labour and land costs, and relatively favourable demand-supply dynamics, a report said on Thursday.

The report by Crisil also said large residential realtors are on course to log a robust 25 per cent sales growth in 2022-23 and 10-15 per cent in the next fiscal.

The unsold inventory level is down to 2.5 years from four years pre-pandemic, and this has credit profile of the large realtors strengthening, the report said.

The agency expects residential prices to rise 6-10 per cent this fiscal and a further 3-5 per cent in the next across the top six cities due to the steep increase in raw material, labour and land costs. This, however, has not impacted demand for residences adversely, given a strong preference for larger homes as the hybrid work ing model continues in many sectors, it added.

The top six realty markets are the Mumbai Metropolitan Region (MMR), the National Capital Region (NCR), Bengaluru, Pune, Hyderabad, and Kolkata. The companies covered by the report are Brigade Enterprises, DLF, Godrej Properties, Kolte-Patil Developers, Macrotech Developers, Mahindra Lifespace Developers, Oberoi Realty, Prestige Estates Projects, Puravankara, Sobha and Sunteck Realty. RBI To Issue Next Tranche Of Sovereign Gold Bonds From Dec 19-23

NEW DELHI: The Reserve Bank will issue two tranches of Sovereign Gold Bonds, which will open for public subscription in December and March.

Sovereign Gold Bonds (SGBs) 2022-23-Series III will open for subscription during the December 19-December 23 period and the 2022-23-Series IV during March 06-10, 2023, the Finance Ministry said in a statement on Thursday.

These bonds are issued by the Reserve Bank of India (RBI) on behalf of the government.

The SGBs will be sold through Scheduled Commercial banks (except Small Finance Banks, Payment Banks and Regional Rural Banks), Stock Holding Corporation of India Limited (SHCIL), Clearing Corporation of India Limited (CCIL), designated post offices, and stock exchanges -- NSE and BSE.

The tenor of the SGB will be for a period of eight years with an option of premature redemption after the fifth year to be exercised on the date on which interest is payable, the Ministry said.

'The investors will be compensated at a fixed rate of 2.5% per annum payable semi-annually on the nominal value," it said. PTI

SC To Hear Pleas Challenging Electoral Bond Scheme In Last Week Of January

New Delhi: The Supreme Court said on Thursday it will hear in the last week of January 2023, a batch of PILs challenging laws permitting funding of political parties through the electoral bond scheme.

Electoral bonds have been pitched as an alternative to cash donations made to political parties as part of efforts to bring in transparency in political funding. A bench of Justices B R Gavai and Vikram Nath said the matter requires to be heard.

"This is a 2015 matter. You can't have such an emergency just before the penultimate day of the vacation...There is no election as of now. We will hear it in the last week of January, 2023," the bench said. Lawyer Prashant Bhushan,

Lawyer Prashant Bhushan, appearing for PIL petitioner NGO 'Association for Democratic Reforms', said there are several constitutional questions involved in the petitions which have a bearing on sanctity of the electoral process.

He said the issue of whether it should be referred to a Constitution bench can be looked at first.

The apex court said that this will also require hearing.

The top court was hearing PILs by NGO Association for Democratic Reforms, The Communist Party of India (Marxit) and other petitioners

(Marxist) and other petitioners. Earlier, Bhushan had sought urgent listing of the PIL by the apex court seeking a direction to the Centre not to open any further window for sale of electoral bonds during the pendency of a case pertaining to funding of political parties and alleged lack of transparency in their bank accounts.

The NGO, which had filed the PIL on the issue of alleged corruption and subversion of democracy through illicit and foreign funding of political parties and lack of transparency in the bank accounts of all political parties, had moved an interim application in March 2021 before the assembly polls in West Bengal and Assam seeking that the window for sale of electoral

bonds be not reopened. The NGO, in its fresh application filed in the pending petition, had claimed there was a serious apprehension that any further sale of electoral bonds before the upcoming assembly elections, including in West Bengal and Assam, will further increase illegal and illicit funding of political parties through shell companies.

On January 20, 2020, the apex court had refused to grant interim stay on the 2018 Electoral Bonds Scheme and sought responses of the Centre and the Election Commission to an interim application by the NGO seeking a stay on the scheme.

The government notified the Electoral Bond Scheme on January 2, 2018.

According to the provisions of the scheme, electoral bonds may be purchased by a person who is a citizen of India or incorporated or established in India. An individual can buy electoral bonds, either singly or jointly with other individuals.

Only political parties registered under Section 29A of the Representation of the People Act, 1951 and which secured not less than one per cent of votes polled in the last general election to the House of the People (Lok Sabha) or the Legislative Assembly of the state are eligible to receive electoral bonds. According to the notification, electoral bonds shall be encashed by an eligible political party only through an account with an authorised bank. The apex court had in April 2019 declined to stav the Centre's Electoral Bond Scheme 2018 and made it clear that it will accord an in-depth hearing on the pleas as the Centre and the EC have raised "weighty issues" having "tremendous bearing on the sanctity of the electoral process in the country".

1991 Pilibhit Fake Encounter

HC Commutes Life Sentence Of 43 Cops To 7-Year Rigorous Imprisonment

Lucknow: The Allahabad High Court on Thursday commuted life imprisonment awarded to 43 policemen in the 1991 Pilibhit fake encounter case, in which 10 Sikhs were killed after being branded terrorists, to seven-year rigorous imprisonment.

The court set aside the conviction of the police personnel by a trial court under Section

302 (murder) of the Indian Penal Code, saying the case falls under Exception 3 to Section 303 of the IPC which provides that culpable homicide is not murder if the offender, being a public servant or aiding a public servant, causes death by an act which he thinks is lawful. The Lucknow bench directed that the convict serve their sen

that the convicts serve their sentence in jail and also imposed a fine of Rs 10,000 each on them. The bench held all 43 policemen guilty under Section 304 (culpable homicide not amount-

ing to murder) of the IPC. Undoubtedly, the bench of Justices Ramesh Sinha and

Saroj Yadav said, the police

have to arrest accused persons and make them stand trial. "It is not the duty of the police officers to kill the accused merely because he is a dreaded criminal," it said. "In the present case, there

was no ill will between the appellants -- police personnel and the deceased persons. The appellants were public servants and their object was the advancement of public justice. "No doubt, the appellants

exceeded the powers given to them by law, and they caused the death of the deceased by doing an act which they, in good faith, believed to be lawful and necessary for the due discharge of their duty. In such circumstances, the offence that was committed by the appellants, was culpable homicide not amounting to murder," the bench said.

"The case of the appellants is covered under Exception 3 to the section 303 of IPC which provides that culpable homicide is not murder if the offender, being a public servant, or aiding a public servant acting for the advancement

of public justice, exceeds the powers given to him by law, and causes death by doing an act which he, in good faith, thinks to be lawful and necessary for the due discharge of his duty as a public servant without ill will towards the person whose death he has caused," it said.

On July 12, 1991, the convicted policemen stopped a luxury bus carrying Sikh pilgrims and forced 10 passengers to get off. A charge sheet filed in the case said the passengers were divided into groups, taken to different areas in a jungle and killed in "cold blood".

The policemen claimed the next day that 10 Khalistani terrorists had been killed. They claimed that some of the Sikhs in the bus were facing criminal cases and were armed.

The trial court had on April 4, 2016 found 47 policemen guilty of killing the Sikh men in fake encounters and sentenced them to life imprisonment. The policemen filed ap-

peals against their conviction. During the pendency of appeals, four of them died.

SC Grants Bail To Convict In Godhra Train Coach Burning Case

New Delhi: The Supreme Court on Thursday granted bail to a convict serving life imprisonment in the 2002 Godhra train coach burning case, noting that he has been in jail for the last 17 years.

A bench comprising Chief Justice D Y Chandrachud and Justice P S Narasimha took note of the submission of a lawyer, appearing for one of the convicts Faruk, that he be granted bail considering the period undergone till now.

Solicitor General Tushar Mehta, appearing for the Gujarat government, termed the offence as the "most heinous" in which 59 people, including women and children were burnt alive and sought hearing of the appeals of the convicts at the earliest.

The top law officer opposed the bail plea and said usually stone pelting is an offence of minor nature, however, in the instant case, the train coach was bolted and stones were pelted to ensure that passengers cannot come out.

Moreover, stones were thrown at fire tenders also, he added.

"He (the convict seeking bail) instigated others and pelted stones and injured the passengers. Under normal circumstances, pelting of stones may be a lesser offence... But this is different," he said. "In the facts of the case, the application of bail made by

application of bail made by Faruk... is granted. The applicant was convicted of offences punishable under Section 302 (murder) of the IPC and sentenced to suffer imprisonment for life.

"The High Court had dismissed his appeal on October 9, 2017. The applicant has sought bail on the ground that he has been in custody since 2004 and has undergone imprisonment for about 17 years. In view of the facts and circumstances of the case and the role attributed to the applicant, we direct the applicant to be granted bail subject to such terms and conditions as may be imposed by the sessions (trial) court," the bench said in its order.

The appeals against the conviction of several convicts are pending adjudication in the apex court.

Mehta said the appeals were ripe for the final hearing and now they can be listed.

The CJI then suggested the law officer to provide the details such as that of the cases to be heard and assured that he will examine the details.

Khan, who's also the chief executive officer of Srinagar Smart City Limited, said the government is keen to develop these heritage sites.

"It was important to list and categorise these sites," the commissioner said, "so that if the government decides to put some conservation restriction, this will become the basis of that strategy."

The survey was carried out when the city is getting a makeover under Rs. 980 crore worth Srinagar Smart City Project. Over 39 developmental tasks have been completed so far under the project, while 34 remain a work in progress, with 64 being executed in near future.

The INTACH survey has revealed that 51 per cent of the heritage properties in the city are in bad shape.

"In year 2021, we found that 49 per cent of the properties are in good condition while 33 per cent showing signs of deterioration," said Imran Ali, an official at INTACH.

"Three per cent properties are in advanced state of decay, while 3 per cent are in extreme dilapidation condition."

Also, Ali said, 12 per cent of the properties, mostly residential, have been completely destroyed by 2014 floods or dismantled by owners. "But many properties under Waqf board and constructed by the Mughals are in the good state."

Notably, there're 16 protected properties in Srinagar—12 of them are under Archeology Survey of India, while the rest is looked after by the J&K Archeology Department.

Previously, such structural survey was carried out in the year 2003, when around 349 heritage sites were listed.

Two decades later, Srinagar has reportedly lost 42 sites, leaving only 307 sites as the subject material for the new survey.

"These sites should've been protected under the law which is there but hasn't been implemented," Saleem Beg, convener INTACH, J&K Chapter, said.

In 2010, Beg said, the Jammu and Kashmir Assembly passed a bill—"Jammu and Kashmir Heritage Conservation and Preservation Act" with an aim to provide conservation and preservation of both tangible (any material or physical heritage like buildings, structures, artifacts, etc.) and intangible (any non-material cultural aspects like music, dance, drama,

n poetry) properties.

"As the law never saw the light of the day," Beg said, "the heritage residences are being converted into commercial buildings by the owners. The government should've taken steps to stop it."

But now, the SMC commissioner said, all the concerned departments are on the same page to conserve and preserve the heritage sites of Srinagar.

India Slams

Among the over 60 speakers listed for the debate was Bhutto, who in his remarks to the Council, raised the Kashmir issue. India's Permanent Representative to the UN Ambassador Ruchira Kamboj was chairing the debate when Bhutto spoke in the Council.

Later, as Jaishankar presided over the debate, he gave a strong response to Bhutto's comments.

He referred to the mastermind behind the September 11 attacks in the US bin Laden, who

was living in Pakistan's Abbottabad city and was killed in a raid at his hideout in May 2011 by US Navy seals.

Terrorists of the Pakistan-based Lashkar-e-Taiba (LeT) and the Jaish-e-Mohammed (JeM) had attacked the Indian Parliament complex in 2001, killing nine people.

Tensions between India and Pakistan have spiked since New Delhi abrogated Article 370 of the Constitution to revoke the special status of Jammu and Kashmir on August 5, 2019. India's decision evoked strong reactions from Pakistan, which downgraded diplomatic ties and expelled the Indian envoy.

India has categorically told the international community that the scrapping of Article 370 was its internal matter. It also advised Pakistan to accept the reality and stop all anti-India propaganda.

India has told Pakistan that it desires normal neighbourly relations with Islamabad in an environment free of terror, hostility and violence. **IAF Carries Out**

the French-manufactured jet joined the second Rafale squadron in Hasimara that increased its strength to 18 aircraft.

They said the second squadron of Rafale jets was to be part of the mega air exercise along with other key assets such as Sukhoi-30MKI aircraft under the Eastern Air Command.

An IAF official said the exercise was planned well in advance and it is not associated with recent developments in the Tawang sector.

On Monday, the Indian Army said troops from the two sides clashed along the Line of Actual Control (LAC) in the Tawang sector and the face-off led to "minor injuries" to a few personnel from both sides".

The face-off took place amid the over 30-month border standoff between the two sides in eastern Ladakh.

All frontline air bases and some key Advanced Landing Grounds in the Northeast are set to be involved in the exercise, said a source.

The Army and IAF have been maintaining a high state of operational readiness along the LAC in the Arunachal Pradesh and the Sikkim sector for over two years following the eastern Ladakh row.

The IAF scrambled fighter jets last week following China's increasing air activities on its side of the LAC in the Tawang sector of Arunachal Pradesh.

The deployment of some aerial platforms

including drones by China in the region preceded the Chinese attempts on December 9 to unilaterally change the status quo in the Yangtse area of the Tawang sector, the sources said.

They said a number of Chinese drones flew close to the LAC prompting the IAF to scramble the jets and increase the overall combat readiness.

Defence Minister Rajnath Singh on Tuesday told Parliament that the Indian troops bravely thwarted the attempt by Chinese PLA from "unilaterally" changing the status in Yangtse area of the Tawang sector and there were no fatalities or serious casualties to the Indian troops in the scuffle.

"On December 9, PLA troops tried to transgress the LAC in Yangtse area of Tawang Sector and unilaterally change the status quo. The Chinese attempt was contested by our troops in a firm and resolute manner," Singh said.

"The ensuing face off led to a physical scuffle in which the Indian Army bravely prevented the PLA from transgressing into our territory and compelled them to return to their posts," he said.

Despite not being able to play a lot of red-ball cricket of late, Sodhi has a strong first-class record featuring 279 wickets at an average of 33, with 16 fivewicket bags and two ten-wicket hauls. Phillips played his only Test against Australia at the SCG in January 2020, scoring a half-

century in the first innings. Like Sodhi, the 26-year-old Phillips has made his name in the T20I format, racking up 56 international caps and a current ICC T20I batting ranking of seven. Tickner featured in the New Zealand Test squads for the series against South Africa at the end of the home summer and away to England in the winter, but is yet to debut, after playing 20 white-ball internationals.

Trent Boult made himself unavailable for the tour, while Kyle Jamieson remains unavailable for selection as he continues his recovery from a back injury. Coach Gary Stead said the squad was looking forward to the prospect of playing Test cricket in Pakistan for the first time since 2003.
