'From Terrorist Hotspot To Tourist Hotspot': MHA Lists J&K Achievements In Year End Review

New Delhi: Jammu and Kashmir, which used to be a "terrorist hotspot", has become a "tourist hotspot" as 22 lakh tourists visited the Union Territory in 2022, nearly four times more than the previous highest, the Union Home

Ministry said on Tuesday. According to the 'Year End Review 2022' of the Home Ministry, released on Tuesday, the number of terror incidents in I&K decreased from 417 in 2018 to 229 in 2021, while the number of security forces personnel martyred has reduced from 91 in 2018 to 42 in 2021.

"Earlier, it was a terrorist hotspot and today it has become a tourist hotspot in Kashmir Valley. Earlier, a maximum six lakh tourists used to visit every year, whereas this year till now, 22 lakh tourists have visited. This has given employment to thousands of youth," the year end review said.

The ministry said there are no incidents of stone pelting in Jammu and Kashmir now as the government under the

Caffeine May Boost Athletic Performance, Study Finds

affeine may significantly improve athletic performance, according to a study which found that caffeine supplementation reduced sprint time in the 100-metre dash.

Caffeine, a stimulant that affects the nervous system, is a popular choice among athletes as a performance-enhancing aid.

The World Athletics, formerly known as the International Association of Athletics Federations, has recognised caffeine as an "ergogenic aid" in a consensus statement on nutritional strategy for athletics, the researchers said.

"While previous studies have investigated the effects of caffeine on running activity, evidence from these studies is not conclusive enough to support the World Athletics consensus," said Professor Takeshi Hashimoto from Ritsumeikan University in Japan.

"A majority of them have looked at its effects on single



sprint runs of less than 60 metres. Therefore, it was important to study the ergogenic effects of caffeine on the 100-metre sprint performance, Hashimoto said.

The study, published in the

journal Medicine & Science in Sports & Exercise, recruited 13 male collegiate sprinters.

In a preliminary test, the researchers determined the time it takes for each athlete to reach

peak blood plasma caffeine concentration after ingesting it.

Taking this into account, the athletes were called two more times for 100-metre time trials after ingesting either caffeine or pla-

While previous studies have investigated the effects of caffeine on running activity, evidence from these studies is not conclusive enough to support the World Athletics consensus

cebo supplements. As measures of performance, the researchers measured the sprint velocity and calculated the sprint time.

On discounting the effects of environmental factors, the corrected sprint time was used to examine the effects of caffeine supplementation.

The study showed that the corrected 100-m sprint time was shortened significantly for ath-

letes who received caffeine, with a decrease of 0.14 seconds compared to the controls.

This decrease in the time was largely associated with a decrease in sprint time for the first 60 metres of the sprint, the researchers said.

They also found that the mean sprint velocity for the 010 m and 1020 m splits was significantly higher in the athletes who received caffeine.

No significant difference was seen in the sprint time for the last 40 metres of the sprint, despite the shortening of the sprint time in the first 60 metres, according to the researchers.

These observations suggest that the caffeine supplementation provided more explosive acceleration to the sprinters in the early stage of the race, they said.

These results could translate to the enhancement of sports performance for athletes by enhancing the usage of caffeine as an ergogenic aid during sprints, the researchers added.

'Not Neurons, But Synapses, Form Working Memory, 'Hold' Info'

cientists have uncovered details about the functioning of the working memory, throwing light on how information is 'held' in the brain.

Neuroscientists at The Picower Institute for Learning and Memory, Massachusetts Institute of Technology, US, have found that a network of neurons 'holds' the information by making short-lived changes in the pattern of their connections, or synapses, the study said. Between the time you read the Wi-Fi password off the caf's menu board and the time you can get back to your laptop to enter it, you have to 'hold' it in mind. This is a classic case of working memory in action that researchers have strived for decades to explain.

Scientists compared measurements of brain cell activity in an animal performing a working memory task with the output of various computer models representing two theories of the underlying mechanism for holding information in mind. The study has been published in the journal PLOS Computational Biology. The results strongly favoured the newer notion that a network of neurons stores the information by making temporary changes to their synaptic patterns. They contradicted the traditional alternative that memory is maintained by neurons remaining persistently active, like an idling engine.

While both the models allowed for information to be 'held' in mind, only the versions that allowed for synapses to transiently



change connections, or "short-term synaptic plasticity", produced neural activity patterns that mimicked what was actually observed in real brains at work, the study said.

The idea that brain cells maintain memories by being always 'on' may be simpler, acknowledged senior author Earl K. Miller, but it doesn't represent what nature is doing and can't produce the sophisticated flexibility of thought that can arise from intermittent neural activity backed up by short-term synaptic plasticity.

"You need these kinds of mechanisms to give working memory activity the freedom it needs to be flexible," said Miller.

"If working memory was just sustained activity alone, it would be as simple as a light switch. But working memory is as complex and dynamic as our thoughts," said Miller.

Co-lead author Leo Kozachkov said matching computer models to real-world

data was crucial.

"Most people think that working memory 'happens' in neurons - persistent neural activity gives rise to persistent thoughts. However, this view has come under recent scrutiny because it does not really agree with the data," said Kozachkov.

"Using artificial neural networks with short-term synaptic plasticity, we show that synaptic activity, instead of neural activity, can be a substrate for working memory. The important takeaway from our paper is: these 'plastic' neural network models are more brain-like, in a quantitative sense, and also have additional functional benefits in terms of robustness," said Kozachkov.

Alongside co-lead author John Tauber, Kozachkov's goal was not just to determine how working memory information might be held in mind, but to shed light on which way nature actually does it. That meant starting with "ground truth" measurements of the electrical "spiking" activity of hundreds of neurons in the prefrontal cortex of an animal as it played a working memory game, the study said.


According to the study, in each of many rounds the animal was shown an image that then disappeared. A second later it would see two images including the original and had to look at the original to earn a little reward. The key moment is that intervening second, called the "delay period", in which the image must be kept in mind in advance of the test.

49 Mutton Shops Sealed In City

Additional Directorate, Food Civil Supplies and Consumers Department (FCS&CA) said that 49 mutton shops have been sealed in Srinagar district during the ongoing drive.

"The complaints have been

received against the mutton shopkeepers by the consumers, who claim that the mutton is being sold at exorbitant rates," he said.

He said that the drive will continue until and unless the violation is put to an end.

He also appealed to the consumers to buy meat at Rs 535 per kg. "There is no A grade and B Grade system in the mutton. The mutton rates have been set after consultation with the mutton dealers. Any violation in this regard is not tolerable," he said. (KNO)

Despite Committee Recommendations, KU Yet To Resolve Seniority Dispute

SKUAST-K VC to look after KU routine matters till Jan 22

Srinagar: Despite the recommendations put forth by the four-member committee, the authorities at Kashmir University (KU) are yet to resolve the inter-se seniority dispute of the University professors.

The issue came to limelight once again after J&K Lieutenant Governor (LG) Manoj Sinha has ordered that the Vice Chancellor SKUAST-Kashmir Prof. Nazir Ganai will look after KU routine matters till January 22 of 2023.

The arrangement has been made as the incumbent VC KU has gone to Australia with regard to some personal matters.

The move has however raised eyebrows on the varsity administration with the academicians expressing their concern saying why the administration was reluctant to resolve the seniority dispute of varsity professors.

"KU is one of the oldest

institutions but unfortunately it has not declared the seniority of its professors. It sends a wrong signal outside which is not good for the institution," a senior KU professor said, wishing not to be named.

"Is this such a big issue that it remains unresolved despite recommendations of the committee or the administration is delaying it deliberately," the Prof asked.

The professor said the delay in resolving the seniority dispute dents their reputation after the look after charge of VC is given to some professor from outside KU.

"Our VC has gone for 20 days' vacation while the VC SKUAST-K, who is already overburdened with his own matters within SKUAST, will look after the routine of KU. This is not a healthy arrangement," the professor said.

The seniority dispute remains lingering at a time when the J&K LG praised the KU for positioning itself as a centre of excellence in the country noting that KU was being talked about across the country because of its academic excellence and high rankings.

Earlier in 2022, the KU a four-member panel comprised Dean School of Basic and Applied Sciences Central University of Jammu Prof Devanand as chairman, while Director DIQA Kathua campus of Jammu University Prof Meenakshi Kilam, Director NIFT Srinagar Dr Javid Ahmad Wani and Education officer UGC Kishor Kumar were its members.

The panel had submitted its final recommendations after holding through deliberations on the issue and submitted the recommendations to the Vice-Chancellor KU.

"The matter was settled after the panel devised a formula on the basis of set norms wherein joining date of the professors was deemed as an essential criteria to finalise the recommendations," a KU

prof said.

Notably, the need to fix the disputed seniority arose after Professor Ghulam Mohiud-Din Sangmi in 2022 submitted an application to the then VC KU Prof Talat Ahmad and claimed that he was the senior-most professor in the University.

Prof Sangmi had also challenged the inter-se seniority list formulated by the University authorities in 2017.

Last year, the issue came to limelight after the The Chancellor's office asked the then VC KU to hand over the charge to the third person outside the university to hold the charge of in-charge VC KU amid the dispute in the seniority of the varsity professors.

Following this, the VC of Islamic University of Science and Technology (IUST) was given the charge to look after the routine matters of KU during the leave period of Prof Talat.

Meanwhile, the KU academicians have urged the J&K LG who is also the Chancellor of the J&K Universities for his personal intervention into the matter and resolve the seniority dispute of professors in KU.

"If there is dispute in the seniority between Serial 1 and 2, let the charge be given to the Prof who stands at serial 3 in the seniority list. That is better for the institutions instead of making arrangements outside the varsity," a senior Prof. said—(KNO)

Blast In Sabzi Mandi; 17 Killed 38 Injured

RINAGAR- At least 17 people were killed and 38 others wounded in a powerful land mine explosion in a crowded vegetable market near Batmalu in central Srinagar this morning. The dead were mostly shop-keepers but also included four security force personnel.

Reports also said that the security personnel present in the market resorted to firing in panic after the blast ripped through the market place. Twelve persons, two, of them security personnel, died on the spot an official spokes-man said adding scores of injured were rushed to hospital where five more were declared brought dead. The casualty figure was likely to rise as the condition of most of the injured was stated to be critical, doctors at-tending the injured said.

Several security personnel were at the market buying

vegetables when the bomb went off. The injured included a dozen members of the paramilitary Border Security Force (BSF) and Special Security Branch (SSB). A truck and a van belonging to each outfit were destroyed. The SSB is a new unit meant to guard top politicians in Kashmir. The BSF mans the country's land border with Pakistan.

The blast sparked panic in the morning crowd at the

market, witnesses said Security force personnel resorted to firing in panic but PTI news agency quoted official spokesman as saying that the Security personnel fired in self-defence. This caused further panic with shopkeeper and customers rushing for cover leaving behind the dead and wounded. "People were wailing, some could not run because they were wounded," a labourer at the site told pressmen.

No one claimed responsibility, but the police blamed

militants fighting to end Indian rule in Kashmir for the blast.
The vegetable market straddles a highway and lies sandwiched between Tattu Ground army camp and BSF picket.

Personnel of Central Reserve Police Force resorted to mild cane charge when large number of people mostly family members of dead and injured gathered outside the SMHS hospital. CNS said three persons were injured in the cane charge. CNS quoted a spokesman of Vegetable dealers association as saying that many people in the mandi died after security personnel opened indiscriminate fire.

Officials of the police hospital however told the agency that none of the injured brought there had gunshot wound. Scores of injured meanwhile were battling for their lives in SMHS, SKIMS and B&J hospitals. The injured included a five year old boy.

Six Years After Demonitization

he Supreme Court on Monday backed Prime Minister Narendra Modi's 2016 notes ban today in a landmark 4-1 majority judgment saying it was "not relevant" whether the objective of the overnight ban was achieved. One judge, Justice BV Nagarathna disagreed, terming the move "unlawful". In a strong dissenting judgment, Justice Nagarathna called the notes ban "vitiated and unlawful". He, however, agreed that the status quo could not be restored now. The judge noted that the entire exercise was carried out in 24 hours. Some 58 petitions challenged the Centre's decision to ban Rs 1,000 and Rs 500 currency notes overnight that instantly wiped Rs 10 lakh crore out of circulation. The government had argued that the court cannot rule on a case when there is no tangible relief available, saying it was tantamount to "putting the clock back" or "unscrambling a scrambled egg."

While supreme court decision on demonitization makes no real impact on the ground, it has momentarily jogged public memory on this issue. The demonitization disrupted the economy for some time, especially the small businesses. It took time for these businesses to find their footing again. There was also chaos on the streets for a few months.

In Kashmir, however, the demonitization didn't make much of a difference to the routine. One of the overriding rationales of the demonitization was that it will deal a mortal blow to terrorism and bring peace to Kashmir. The opinion on whether it actually did so remains debatable. For until after the abrogation of Article 370 in August 2019, the militancy and the public unrests continued unchanged in the Valley. In the last three years, the direct control of Jammu and Kashmir by the centre has made some visible difference in the ground situation. Public unrests have ended and stone-throwing has disappeared. But militancy is still far from over as the killings of innocent civilians in Jammu underlines yet again.

Coming back to impact of demonitization in Kashmir, there wasn't much. In fact, a week after Rs 500 and Rs 1000 notes being declared illegal tender in 2016, the Kashmir Valley was more or less back to normal. In Srinagar, the rush at the banks and the ATMs drastically moderated. This turn of events was surprising considering it was at variance with the official narrative about Kashmir being a hub of the unaccounted terror money. Why was it so? Economists in Valley had a more undramatic, common sense explanation. The demonitization had followed immediately after the Valley had observed an uninterrupted shutdown in the the preceding four months. Businesses were shut. Little money was in circulation. Most people thus didn't need to deposit money. Six years after the disruptive move, the Indian economy and with it, that of Kashmir has recovered from its debilitating impact. Whether demonitizations's objectives were served or not is immaterial now.

Bad to worse: On Benjamin Netanyahu's return

he return of Benjamin Netanyahu as Israel's Prime Minister for a sixth time marks a decisive shift in its domestic politics and its relationship with the Palestinians. If in the past his right-wing Likud party had formed diverse governing coalitions with centrist and relatively moderate parties, in the current six-party rightwing coalition, five are ultra-orthodox and far-right Jewish nationalist parties that make even Likud look moderate. The coalition agreement, a document that determines governing agendas, suggests that Mr. Netanyahu's government would pursue radical right-wing policies, seeking to expand illegal Jewish settlements in the occupied West Bank and East Jerusalem, remake the judicial system by handing more powers to Parliament over courts, and amend the Basic Law, removing hurdles for those with extremist views from contesting elections. Itamar Ben-Gyir, a far-right politician convicted for Jewish terror links and inciting racism in 2007, is the Security Minister, with powers over Israel's police force. Bezalel Smotrich, leader of the ultranationalist Religious Zionism Party, and now the new Finance Minister, wants to fund more Jewish settlements. Some of Mr. Netanyahu's coalition

members are also known for their anti-LGBT positions. For Mr. Netanyahu and Likud, the formation of Israel's most right-wing coalition is a natural progression of the politics they have followed. In the past, Mr. Netanyahu embraced ultra-orthodox and right-wing parties, pursued conservative agendas, walked back from peace and cracked down on the Palestinians, and deepened the occupation. It helped him become Israel's longest serving PM. But the Netanyahu era also reshaped Israel's politics, pushing it to the extreme right. The Prime Minister has dismissed criticism that his coalition would endanger Israel's democracy. At the same time, he has projected himself as a tough Prime Minister who would implement the coalition's agenda. "The Jewish people have an exclusive and indisputable right to the entire land of Israel," he said on Wednesday, referring to historical Palestine and suggesting that settlements would continue unabated. If the Knesset passes judicial reforms, the government, with the support of 64 MPs in the 120-member Parliament, can override even Supreme Court rulings. Besides, parties such as the Shas, the United Torah Judaism and Religious Zionism will influence the government's decisions that could alter the state-religion balance in a country where over 20% of the population are minorities. As Mr. Netanyahu's coalition seems determined to remake Israel's politics internally and deepen the occupation and subjugation of the Palestinians externally, it could also quicken the country's fall into an elected Jewish theocracy.

Rising temperatures across South Asia have amplified the intensity of floods, landslides and river-bank erosion in Kashmir. Human activities too serve as a major contributing factor in causing landslides, though most human-caused landslides can be prevented or mitigated.

While much is known about the severe environmental and humanitarian impacts caused by landslides in general, less is known about how gender and landslides in Kashmir stand correlated.

Since time immemorial, local communities in the region have relied on the tradition of using earthen stoves. This practice has been passed down through several generations, and to date, wood and dried leaves are collected by women and girls to be used as cooking fuel.

In addition, geographical factors like hilly terrains constrict opportunities that ensure their safe access to cleaner sources of renewable energy—as seen in villages in the Kupwara District for instance. The availability of wood makes for a fairly sustainable source of cooking and for keeping warm, especially during the winter months.

The use of traditional sources of energy in Kashmir such as fuel-wood, dung and agricultural residues remains a common practice. In fact, a Jammu and Kashmir wood balance study revealed that villages that lacked access to forest areas, relied on unclean energy sources like agricultural residues, cow dung and kerosene instead.

By losing access to and control over forest and land resources in the aftermath of landslides, women and girls have to rely on other unclean energy sources, which in turn accentuate the possibilities of respiratory issues such as bronchitis, asthma and phlegm. The study revealed that in such villages, the consumption of kerosene witnessed a monumental rise from just a litre to around 11.5 litres!

Further, gender sensitivities stand mostly ignored or overlooked during the project design and planning phases of infrastructure development, such as hydropower projects for instance. Upcoming projects like the Bursar Dam are located in high-intensity seismic zones and thus, reflect poor decision-mak-

ing and planning in landslide management practices.

Seismic activities surrounding dam locations must be determined in the initial stages of a project's concept phase. Geotechnical experts must be roped in for evaluating landslide hazards and suggest corrective techniques to decrease such risks.

Gender-sensitive planning

Gender-sensitive planning must include community-level consultations comprising all the female members of the communities to be affected, in attendance with their male counterparts, and holding discussions on matters of land-use zoning, conducting professional investigations and coming up with appropriate designs for reducing landslide risks.

Dam-induced displacements are known to affect all irrespective of age and gender. It restricts women and girls' access to clean water, and proper sanitation facilities and compromises their safety and mobility. At any plancerning agricultural awareness in Kashmir, so as to ensure higher adaptation in the aftermath of landslide disasters and build resilience among women in farming communities.

To this end, counselling sessions for women farmers must be held to generate awareness and ensure capacity-building. For instance, women farmers must be encouraged to replant on lost and damaged grounds, as erosion resulting from lost ground cover can trigger flash floods and additional landslides in the near future.

It is also important to preserve the traditional land use rights, cultural rights and the right to life of indigenous communities that remain affected and/or forcibly displaced by landslides— especially, women and children, as they are found to be most vulnerable among those affected.

ning stage, it is imperative to identify such vulnerable groups whose voices have remained traditionally suppressed in the decision-making processes.

Also, Kashmir's farming communities constitute women farmers in large numbers, who more often than not, remain overlooked when it comes to policy-making concerns. With time, changes in the gender roles in Kashmir's agricultural sector have been observed, with women farmers forming the 'invisible' hands of Kashmir's agricultural sector.

Women in the Gujjar and Bakarwal tribes for instance, are heavily involved cultivating maize in the mountainous areas of Kashmir. Despite being present in large numbers, women farmers remain constrained by their inaccessibility to credit, insurance and other such financial tools that help make lands more productive, even in the wake of natural disasters like landslides and earthquakes.


It is mostly their lack of awareness of government-sponsored insurance schemes that cover crop damage in light of such unforeseen events, leaving them highly vulnerable to the vagaries of nature in return. It is imperative to close such gender gaps con-

mains restricted to doling out cash grants and relief materials (such as food grains etc.). Evacuation efforts too are found replete with loopholes.

With factors such as the onset of heavy monsoons and COVID-19 restrictions at present, awareness generation campaigns for populations at risk for instance, have invariably taken a hit. Being aware of local evacuation plans, for instance, enables one to avail immediate assistance in the aftermath of landslide disasters.

Thus, raising awareness among Kashmir's female residents is of utmost priority—it enables them to render protection not only to themselves, but also to their children and other members of the family during the sudden onset of landslides, as also take adequate steps and measures for their safety and protection.

COVID CONUNDRUM

n 2020, we knew very little about the novel virus that was to become known as COVID-19. Now, as we enter 2023, a search of Google Scholar produces around five million results containing the term.

So how will the pandemic be felt in 2023? This question is in some ways impossible to answer, given a number of unknowns. In early 2020 the scientific community was focused on determining key parameters that could be used to make projections as to the severity and extent of the spread of the virus. Now, the complex interplay of COVID variants, vaccination and natural immunity makes that process far more difficult and less predictable.

But this doesn't mean there's room for complacency. The proportion of people estimated to be infected has varied over time, but this figure has not fallen below 1.25% (or one in 80 people) in England for the entirety of 2022. COVID is very much still with us, and people are being infected time and time again.

Meanwhile, the number of people self-reporting long COVID symptoms in the UK is around 3.4%, or one in 30 people. And the cumulative risk of acquiring long COVID grows the more times people are reinfected with COVID.

The UK's health system is under huge pressure, with very high pre-COVID waiting times having been exacerbated during the pandemic.

WHY COVID PROJECTIONS HAVE BECOME HARDER

During the early days of the pandemic, simple models could be used to project the number of COVID cases and the likely effect on the population, including demands for health care.

Relatively few variables were needed to produce the first projections. That was because there was one main variant of COVID, the original strain, to which everyone in the

world was susceptible.

But now, those simple assumptions no longer hold. Much of the world's population is estimated to have had COVID and there are significant differences between individual levels of protection in terms of which vaccines, and how many doses, people have received around the world. In total, 13 billion vaccine doses have been administered – but not equitably.

Modelling also works well when people act in ways that are predictable, whether this is normal, prepandemic behaviour, or at times of severe social restrictions. As people adapt to the virus and make their own assessment of risk and benefits of behaviour, modelling becomes more complex.

A reduction in surveillance also makes modelling more difficult. During the peak of the emergency response to COVID this was a priority, including surveillance of people with the virus, and surveillance of

variants. This allowed new variants such as omicron to be identified early and responses to be prepared.

The UK in particular produced two million COVID sequences up to February 2022, accounting for one-quarter of the world's genome sequencing output. But sequencing activity has subsequently decreased, which may increase the time it takes to identify new variants of concern.

THE PANDEMIC IS NOT OVER

There remain big differences in pharmaceutical and non-pharmaceutical interventions in place around the world, for example the use of masks, COVID testing and building ventilation. As governments loosen and at times re-tighten their responses to react to dynamic medical and social pressures, there is a risk that variants could emerge which evade some of the defences that populations have built up.

The next stages of the pandemic will also be influenced by people's

behaviour. For instance, how much we work from home and whether we reduce our social contacts when infectious.

There's no certainty that new variants will emerge that have an effect in the order of delta or omicron, but it is possible. Should this occur, it's important that plans are in place to respond in the context of waning interest in COVID and resurgent misinformation and disinformation.

BEYOND 2023 – THE NEXT PANDEMIC

It's pertinent to ask how much learning has taken place during the COVID pandemic to improve the response to the next pandemic.

During this pandemic, we've often seen short-term national interests prioritised, with a focus on national responses to vaccine equity while discounting the long-term global availability of vaccines. While laudable initiatives such as Covax were established, conceived to provide equitable access to COVID vaccines and

treatments, the challenge is to design incentives for nations to cooperate to reduce long-term global risks.

As with any political response, the priorities of the emergency phase can all too easily be forgotten, such as governments' abilities to manufacture vaccines. The UK government's sale of the Vaccine Manufacturing and Innovation Centre is an example of this. Capacity to develop and produce vaccines quickly would stand us in good stead for the next pandemic, but these priorities now have to compete against others that are more immediate or politically expedient.

The UK's COVID inquiry is bound to be presented with thousands of pages of evidence, with many submissions giving clear, self-consistent accounts of "lessons learned". Whether those lessons are put into practice is another matter entirely.

umans have been created in the best shape and have been described as the crown of all creations. Cinema hall owner can determine whether food from outside be permitted: SC

New Delhi, Jan 3: The Supreme Court ruled on Tuesday the owners of cinema halls are entitled to set the terms and conditions for sale of food and beverages and can determine whether outside food should be permitted within the theatre precincts.

The apex court set aside a direction of the Jammu and Kashmir High Court which had in July 2018 directed multiplex and cinema hall owners there not to prohibit movie goers from carrying their own food articles and water inside the theatres.

A bench of Chief Justice D Y Chandrachud and Justice P S Narasimha observed that cinema hall is a private property of the owner, who is entitled to have terms and conditions so long as they are not contrary to public interest, safety and welfare.

"Viewers visit a cinema hall for the purpose of entertainment. We are clearly of the view that the high court transgressed the limits in the exercise of its jurisdiction under Article 226 of the Constitution by ordering and directing the state to ensure that there should be no prohibition on a movie goer bringing eatables and beverages from



outside within the precinct of a cinema hall," the bench said.

The top court was hearing a batch of pleas challenging the direction given by the Jammu and Kashmir High Court.

The bench said whether or not to see a movie is entirely the choice of the viewer and, if he or she seeks to enter a cinema hall, they have to abide by the terms and conditions subject to which the entry is granted.

" .it is open to the theatre owner to determine as to whether food from outside the precinct of the hall should be permitted within," it said, adding that it is evidently a matter of commercial decision of a theatre owner.

The bench noted that during

the course of the arguments before it, the counsel appearing for the appellants stated that due arrangements are made for the supply of hygienic drinking water to the movie goers without levying any charge within the precinct of the cinema hall.

The apex court said it was also stated before it that where an infant or a young child accompanies the parents, as a matter of practice, the cinema hall owners have no objection to reasonable amount of food being carried for the child to serve the nutritional requirements.

it observed that whether or not to purchase, food or beverages after given admission to the cinema hall is entirely the choice of a movie goer.

"The property of the cinema hall constitutes a private property of the owner of the hall. The owner of the hall is entitled to have terms and conditions so long as such terms and conditions are not contrary to public interest, safety and welfare," it said.

Advocate Sumeer Sodhi, appearing for one of the appellants G S Malls Pvt. Ltd, argued the receipts issued by theatre owners have a specific condition mentioned on them to the effect that no outside food is allowed.

The court said the owner of a private property has the right to decide what can be brought in and what not subject to rules.

"Now, the regulation of what can be brought, what cannot be brought within the precincts of a private property . is for the owner of the property to decide, subject to statutory rules which regulate his activity," the CJI caid.

"Suppose, somebody starts getting 'jalebis' into the cinema hall, the owner could say you eat your 'jalebis' and wipe your hands on the seats," Justice Chandrachud said, adding, "I am just giving you an example."

The bench observed the fundamental aspect which needs to be noted is that the trade and business of conducting a cinema theatre is subject to regulation by the state which has framed the Jammu and Kashmir Cinemas (Regulation) Rules, 1975.

It said, admittedly, the rules contain no mandate compelling the owner of a cinema theatre to allow a movie goer to bring food or beverages within the precinct of the theatre.

The bench said it needed no emphasis that the rule making power of the state has to be exercised in a manner consistent

with the fundamental right of the hall owners to carry on a legitimate trade and business within the meaning of Article 19 (1)(g) of the Constitution.

In August 2018, the top court had stayed the high court direction to the cinema hall and multiplex owners of the state not to prohibit movie goers from carrying own food and water inside the theatres.

Besides the relaxation on carrying food items inside the theatres, the high court had on July 18, 2018 passed a number of directions related to cinema halls.

The high court had issued a slew of directions on a public interest litigation (PIL) filed by two lawyers, seeking a direction for the implementation of the Jammu and Kashmir Cinemas (Regulation) Rules, 1975 in their letter and spirit.

The PIL before the high court had sought a direction prohibiting the cinema hall owners from restraining the movie goers from taking outside eatables with them inside.

In its order, the high court had directed the state government, the licensing authority and district magistrates to ensure that a ban on polythene bags at multiplexes and cinema halls was strictly enforced.

Special Commissioner Team Visited Sultanpuri-Kanjhawala Road Stretch For Investigation: Delhi Police

New Delhi: Special Commissioner of Police Shalini Singh with her team has inspected the 12-kmlong stretch from Sultanpuri to Kanjhawala along which a 20-year-old woman was dragged after her two-wheeler was hit by a car in outer Delhi, police said on Tuesday.

Union Home Minister Amit Shah has sought a detailed report of the incident from the Delhi Police.

The Delhi Police has constituted an inquiry committee, headed by Special Commissioner Shalini Singh, and asked her to submit a report as early as possible in connection with the incident.

A senior police officer said that as part of the inquiry, Singh with her team on Monday night visited the crime scene and inspected the stretch of road in outer Delhi, where the woman was dragged by a car after she got stuck under it.

According to sources, the team's primary responsibility is to do an analysis of the stretch and suggest improvements to prevent similar incidents from occurring in the

uture.

It will also be looking if all Standard Operating Procedures were followed by the police and whether they responded in time to the incident, and on the basis of the outcome, assign responsibility.

"After it has done its analysis and recorded statements of police personnel who were the first responders, a detailed report will be submitted which may also include suggestions such as if extra lights, patrolling vehicles, and CCTVs need to be installed along the stretch," said a source.

The woman, who was the sole breadwinner of her family, was dragged for 12 kilometres under the car on the December 31 night and was found naked by a road in Kanjhawala, according to police.

Five men who were allegedly in the car were booked for culpable homicide among other sections on Monday even as the police came under charges of conducting a "shoddy investigation" in the matter.

All five accused were sent to a three-day police custody on Monday.
