Tourism Players Upbeat As Foreigners Returning To Kashmir After 3-Year Hiatus

After three year hiatus, the foreign tourists have final-ly returned to Kashmir as their footfall in the Valley witnessed a significant spike in the last year, much to the delight of the people associated with the tourism industry

Sarmand Hafeez, secretary tourism revealed that Jammu and Kashmir received some twenty thousand international visitors last year and more foreign guests are expected to visit the Valley this year.



"Most of the tourists were Southeast Asian and

Hafeez European countries," told Kashmir Observer.

A NUMBER OF HOTELS AND RESTAURANTS have been renovated. refurbished and re-started which has generated more employment."

It may be noted that the tourism sector witnessed a massive blow after New Delhi imposed a crippling lockdown ahead of the abrogation of special status of the region and divided the state into two Union Territories

on 5 August 2019. A year later in 2020, the foreigners' footfall in the Valley received another blow due to the outbreak of Covid-19 followed by backto back lockdowns and travel restrictions

However, in 2022, record breaking footfall of tourists was witnessed with over 24 lakh tourists visiting the Valley.

According to official data, In 2020, 3897 foreign tourists visited Kashmir, while in 2021, the number declined to 1615. However in 2022 around 20,000 foreigners visited the region.

"You must be knowing since there were travel restrictions in the last few years now the same has been revoked. We expect more footfall in 2023," Hafeez said.

He further said the foreigners are also getting easy access to visas. The return of foreign tourists has brought cheer to the tourism players in the Valley. Talking to Kashmir Observer,

noted businessman and Chairman Hoteliers Club, Mushtaq Chaya said that the foreign tourists spend more than domestic tourists which benefits the local | More on P10

J&K Integral Part Of India: MEA

New Delhi: India asserted on Thursday that Jammu and Kashmir is its "integral and inalienable" part in the face of certain comments on the region by Pakistan's Prime Minister Shehbaz Sharif.

"We have reiterated that Jammu and Kashmir is an inalienable and integral part of India. Article 370 is entirely a matter of India as well as our Constitution. It is our sovereign matter," Ministry of External Affairs (MEA) Spokesperson Arindam Bagchi told a media briefing.

"We do not see what is their locus on this," he said when asked about Sharif's tweet on Thursday urging the global community to play its part in "giving" the people of Kashmir their "right to decide their destiny".

Sharif also referred to India's decision to withdraw the special status of Jammu and Kashmir.

On August 5, 2019, India announced the withdrawal of the special powers of Jammu and Kashmir and its decision to bifurcate the erstwhile state into Union territories.

UK Saw Hottest-Ever Year in 2022

Dritain had its warmest year on record in 2022, official figures D showed Thursday, the latest evidence that climate change is transforming Europe's weather. The Met Office weather agency said the provisional annual average temperature in the U.K. was 10.03 degrees Celsius (50 Fahrenheit), the highest since comparable records began in 1884. The previous record was 9.88 Celsius (49.8 Fahrenheit) set in 2014.

'Outdoor Air Pollutants Linked With Asthma Attacks In Children, Adolescents'

oderate levels of two outdoor air pollutants, ozone and fine particulate matter, are associated with non-viral asthma attacks in children and adolescents who live in low-income urban areas, a study conducted in the US has found.

The study also identifies associations between exposure to the two pollutants and molecular changes in the children's airways during non-viral asthma attacks, suggesting potential mechanisms for those attacks.

The observational study, funded by the National Institutes of Health (NIH), US, is one of the first to link elevated levels of specific outdoor air pollutants in particular urban locations to distinct changes in the airways during asthma attacks not triggered by respiratory viruses, according to the investigators.

The findings are published in the journal The Lancet Planetary Health.

'The strong association this study demonstrates between specific air pollutants among children in impoverished urban communities and non-viral asthma attacks further augments the evidence that reducing air pollution would improve human health," said Hugh Auchincloss, acting director of the National Institute of Allergy and Infectious Diseases (NIAID), part of NIH. Asthma is caused by chronic inflammation

of the airways.

During an asthma attack, the airway lining swells, muscles around the airways contract, and the airways produce extra mucus, substantially narrowing the space for air to move in and out of the lungs.

Children who live in low-income urban environments in the US are at particularly high risk for attack-prone asthma. Asthma attacks provoked by respiratory virus infections - a common trigger - have been studied extensively, but those that occur independently of such infections have not, the study said.

In the current study, investigators examined the relationship between air pollutant levels and asthma attacks occurring in the absence of a respiratory virus among 208 children ages 6 to 17 years who had attack-prone asthma and lived in low-income neighbourhoods in one of nine U.S. cities, the study said.

Then, the researchers validated the associ-



ations they found between air pollutant levels and non-viral asthma attacks in an independent cohort of 189 children ages 6 to 20 years with persistent asthma who also lived in lowincome neighbourhoods in four U.S. cities, the study said.

The investigators followed the children prospectively for up to two respiratory illnesses or approximately six months, whichever came first. Each illness was classified as viral or non-viral and as involving an asthma attack or not, the study said.

The researchers matched each illness with air quality index values and levels of individual air pollutants recorded by the Environmental Protection Agency in the relevant city on the dates surrounding the illness, the study said.

The investigators subsequently adjusted their data for city and season to decrease the impact of these variables on the findings, it said.

According to the study, the scientists found that asthma attacks had a non-viral cause in nearly 30 per cent of children, two to three times the proportion seen in non-urban children, according to previously published reports. These attacks were associated with locally elevated levels of fine particulate matter and ozone in outdoor air.

The investigators linked changes in the expression of specific sets of genes that play a role in airway inflammation to elevated levels of these two pollutants by analyzing nasal cell samples obtained from the children during respiratory illnesses.

Some of the identified gene-expression patterns suggest that unique biological pathways may be involved in non-viral asthma attacks, the study said.

Given the study findings, it will be important to develop and test different strategies to see if they prevent or reduce pollution-associated asthma attacks in urban children, the study said.

These strategies may include treatments designed to counteract the harmful effects of elevated levels of outdoor air pollutants on airway inflammatory responses linked to nonviral asthma attacks, and devices for personalized monitoring of local outdoor air pollutant levels to inform asthma management, the study said.

Landlords Win 2-Decade-Old Legal Battle To Reclaim Shop

Srinagar: A court in Srinagar has ordered a tenant to handover shop to landlords, to bring to close a litigation instituted nearly two decades ago.

"Defendant (tenant) is directed to vacate and handover the possession of the suit shop to the Plaintiffs (landlords) within a period of two months and in default Defendant will be liable to pay to the Plaintiffs the damages at the rate of Rs. 1,000 (Rupees One Thousand Only) per day till the suit shop is handed over to Plaintiffs," the Court of Munsiff Sub Registrar Srinagar said in a judgment passed on December 3.

The landlords had filed the case in 2004, seeking directions to the tenant, Mohammad Syed Nazki, to vacate the shop situated at Killi Masjid Saraf Kadal Srinagar.

According to the landlords, they rented out the shop to the tenant in March

1987 and according to an agreement between them, the shop was to be handed over after one year.

However, the court observed, the tenant did not vacate the shop after the expiry of the agreement and handover it to them despite their repeated demands. The landlords, through their counsel Sajad Sofi, had contended that they need the shop back for their personal requirement as they are repeatedly in need of it so as to have a source of income to support their family. The landlords said that the tenant neither vacated the shop nor did he pay the rent from April 2002.

After hearing the parties, the court, besides ordering the tenant to vacate the shop within two months, also ordered him to pay the rent on account of occupation of the shop from April 2002 at the rate of Rs 75 per month along with 9% interest per annum. (GNS)

Srinagar: The authorities at Kashmir University (KU) continue to delay advertising vacant administrative positions including that of Registrar for more than a year, drawing flak from academics.

Insiders said that more than a year has passed since the post of Registrar fell vacant but the authorities are not making any effort to put the post to advertisement despite demands for the same.

Since January last year, when the three year term of Registrar Dr. Nisar ended, the J&K LG as University Chancellor issued instructions that Dr. Nisar shall continue till the new VC joins the University.

However, insiders sav. Dr. Nisar continues to hold the charge of Registrar allegedly without any official orders on his continuation as In-Charge Registrar.

"We have not s

trar," said a KU academician, wishing anonymity. "The temporary arrangement on the important administrative position like Registrar is not good for the institution."

The other posts which are vacant include Director IT, Director North Campus and Director DIQA which haven't been advertised despite repeated requests to the Vice Chancellor by stakeholders to end the temporary arrangement.

Insiders said that In-Charge IT Director is holding the charge since 2016 in total violation of the three year rotation policy for all heads of departments, coordinators and directors.



RINAGAR - Kashmiris spread throughout the country are having a tough time following the Fidayeen attack on the Red Fort in New Delhi.

In various cities, police and intelligence agencies have instructed hotels and inns to refuse accommodation to Kashmiris. Kashmiris residing in Jammu too are bearing the brunt of security measures which have been tightened on the advent of January 26.

Kashmiris have been told to vacate their rooms from nearly ail hotels in Delhi and those arriving from other cities are not being allowed to stay in the capital. Police and intelligence agencies have picked up scores Kashmiri students and traders for questioning over the last 10 days. Pakistan Threatens Taliban Over Failure To Curb Border Instability

n a statement to local media on 2 January, the Minister of Defense of Pakistan, Khawaja Asif, issued a harsh statement against the Taliban, blaming the leadership for failing to uphold promises on border security and stability.

Asif accused the leadership of the Islamic Emirate of Afghanistan (IEA) of harboring Pakistan-designated terrorist groups on its soil, which resulted in the deterioration of stability in the country. The remarks are in reference

to Tehrik-e-Taliban Pakistan (TTP), a militant group with close ties to the Taliban. The group aims to establish an Islamic Emirate in Pakistan, similar to the Afghan model.

According to Al-Jazeera, the TTP is responsible for more than 150 attacks inside Pakistan, which resulted in the death of dozens of civilians alongside members of the security services.

December 2022 was designated the deadliest month for security forces in the past decade, as the insurgency killed 40 Pakistani soldiers.

'They [TTP] are coming from across the Afghan side of the border to carry out these ac-

tivities." Asif told Geo News TV. He added that "they may have sleeper cells here [in Pakistan], but their overwhelming presence is on Afghanistan's soil, which is being used for cross-border terrorism."

Asif elaborated that they contacted Afghanistan's government officials about the situation and reiterated the need to uphold their obligation based on the Doha agreement with the US.

"We have been requesting the Taliban ever since they returned to power to stop the TTP from plotting terrorist activi-ties in Pakistan," Asif noted.

His remarks align with the statement issued by the National Security Committee (NSC) of Pakistan, which vowed not to allow any country "to provide sanctuaries to terrorists."

The council promised to "deal with the full force of the state," to crush those attempts, and those negatively sabotaging the border peace between neighboring states.

Although the statement made no reference to Afghanistan explicitly, the spokesman for the IAE, Zabihullah Mujahid, issued a swift commentary early on 3 January, to restore calm with Pakistan.

Imran Khan Alleges Former Ex-Army Chief Gen Bajwa Wanted To Get Him Killed

n a fresh attack on Gen (retd.) Qamar Javed Bajwa, Pakistan's ousted prime minister Imran Khan has alleged that the former army chief wanted to have him murdered and impose a state of emergency in the country.

Khan, the chairman of the Pakistan Tehreek-e-Insaf party, made the startling allegation during an interview with private Bol News channel in Lahore.

Khan, 70, had been at loggerheads with Bajwa ever since his ouster from power in April by a no-confidence motion. He suffered bullet injuries in the right leg on November 3 when two gunmen fired a volley of bullets at him and others standing on a container-mounted truck in the Wazirabad area. some 150-km from Lahore, where he was leading the long march to press for snap polls. Khan said he was being told by many to stop levelling allegations against Bajwa as he has retired, but he could not cover up the crimes that Gen Bajwa had committed, the Dawn newspaper reported, quoting the channel's Lahore bureau chief.



"wanted me dead". Khan has attacked Gen (retd.) Bajwa in the past. Bajwa is now the main target of Khan who not only sees him as the sole reason for all his failures in the government but also alleges that the retired general had toppled his government as part of a US conspiracy. Last month, Khan accused Bajwa of playing a "double game" against his government and said that he committed a "big mistake" by extending the tenure of then military chief in 2019. Gen Bajwa, 61, retired on November 29 after getting a three-year extension in 2019 by the then Prime Minister Khan. who turned out to be the biggest critic of the Pakistan Army. The powerful Army, which has ruled the coup-prone country for more than half of its 75 plus years of existence, has hitherto wielded considerable power in the matters of security and foreign policy.



The Ukraine conflict has already pushed the timelines for human spaceflight to the end of 2024 and the Indian Space Research Organisation (ISRO) plans to carry out an uncrewed mission to test and validate technologies for the Gaganyaan mission this year.

"It is not like sending a satellite to orbit. We cannot take chances when it comes to human beings. We are being cautious and careful. Globally, it took about 10 years for countries to develop human space flight capability, which we are doing in four," ISRO chairman S Somanath said.

BJP Govt Failed To Handle J&K Situation: Mehbooba

ANANTNAG: The BJP government has failed to control the situation in Jammu and Kashmir and is now arming locals to "further its agenda of creating a wedge" between communities, People's Democratic Party chief Mehbooba Mufti said on Thursday.

Arming people with weapons will only serve the BJP's agenda of creating an atmosphere of fear, suspicion and hatred. It will pit one community against the other," Mehbooba said.

She was speaking to reporters in Anantnag district after paying obeisance at the grave of her father, former Jammu and Kashmir chief minister and People's Democratic Party (PDP) founder Mufti Mohammad Sayeed.

The move to provide arms and ammunition to Village Defence Committees in wake of the Rajouri attack has exposed the BJP's claims that the situation has become normal in Jammu and Kashmir after the abrogation of Article 370, she said.

Mehbooba, also a former chief minister of Jammu and Kashmir, added, "If that were the case, why bring more security personnel into Jammu and Kashmir? Why arm the local people with weapons?

This only shows that BJP has failed in controlling the situation. Now they want to harass the people and increase the bloodshed by these measures." The PDP leader added that



the problems in Jammu and Kashmir needed a political solution and could not be resolved militarily.

"No power on earth can win a war against its own people. Jammu and Kashmir is already a military cantonment, there is no dearth of Army here. The Army has discharged its duties well over the past 30 years to the extent that the democratic system was restored and elections to the Parliament, Assembly and panchayats were held. But now, it is not the job of the Army.

"All the security experts and many former army officers maintain that Jammu and Kashmir is a political issue for which there is no military solution," she said.

Highlighting the need for dialogue, Mehbooba said the government was engaged in talks and reconciliation with China even after the neighbouring country committed acts of aggression in Ladakh. "There cannot be a military

solution... China martyred 20 of our soldiers and has occupied 2,000 square kilometres of our land (in Ladakh) but there is dialogue and reconciliation going on there," she added.

'Tourism Hotspot'

ammu and Kashmir has turned into "a tourism hotspot from a terrorism hotspot" and the security forces have gained "complete control" on terrorism in the union territory, the year-end review by the Ministry of Home Affairs states. The review reiterates the words of the national general secretary of the BJP, Tarun Chug. Speaking recently at a press conference in Srinagar, Chug said the BJP had transformed Kashmir from a centre of terrorism into a tourist destination. Chug was referring to the boom in tourism in the union territory over the last year. More than 20 lakh tourists, including 3.65 lakh Amarnath yatris and over ten thousand foreigners, visited Kashmir during 2022.

The MHA review also highlights the progress made in J&K over the last year on economic and security fronts. The union territory, the report said, witnessed a 54 percent reduction in terrorist incidents, 22 percent drop in recruitment of militants and 84 percent decline in the deaths of security forces. In real terms, the militancy related violence has decreased from 417 incidents in 2018 to 229 in 2021 while the number of slain security personnel had reduced from 91 in 2018 to 42 in 2021.

On the development front, the report says that the BJP government at the centre has brought an investment of Rs 56,000 crores in just three years. Under the Prime Minister's Development Package in Jammu, the report mentions, J&K got about 63 projects in hydroelectricity at a cost of Rs 80,000 crore.

It is true that J&K has gone through a makeover of sorts over the last three years, albeit the first two years were largely lost to Covid-19 pandemic. However, the last year was different: not only did the pandemic abate after the Omicron wave in the first three months of the year, the peace also largely held. That made it possible for the businesses to find their footing again and also for tourism to thrive. According to the tourist officials, the number of tourists Kashmir received this year is the highest so far, beating by far even the pre-turmoil period record. This has generated employment for the thousands of people who had lost their jobs during Covid pandemic. Going forward, the situation looks set to improve further. But Dangri village incident is a sobering reminder that peace in Kashmir can't be taken for granted. Here's hoping that 2023 makes J&K a truly peaceful place.



Dairy Farming Wave in Kashmir

A Possible Way Out of Soaring Unemployment

ewly established dairy units under the integrated dairy development scheme of the Animal Husbandry department are changing the face of dairy farming for the first time in Jammu and Kashmir . A large chunk of population used to rear local and nondescript cattle with very less production had thus rendered animal husbandry to only subsistence farming. Cross breeding program of the animal husbandry department through artificial insemination resulted in the induction of quality germplasm thus enhancing genetic potential and milk production.

Locally produced milk and milk products offered good market opportunities to producers. However, only certain communities took dairying as an economic enterprise and they too mostly adopted traditional dairying techniques. Therefore, beyond a certain limit, dairying couldn't get more profitable for them.

Modern dairy farming is h a science as well as an art and only aspiring, educated and talented vouth can change the face of dairy farming. Covid-19 and its ensuing economic impact had affected business sectors the worst. Woes of small businesses are still deepening and active employment has been reduced. Economic slump is acting as a great obstacle. In these bleak times for the economy, dairy farming is providing a fresh hope to farmers and youngsters alike. The integrated dairy development scheme of the Animal Husbandry Department is providing 50% subsidy on the establishment of dairy units, milk collection and processing units, pasteurization and packaging units, bulk milk coolers, paneer/khoya/butter/

Cheese/ ice-cream making machines, milking machines and milk parlors, milk ATMs and milk vans for transportation of milk. Support for transportation of processed milk products via air to any place in India in addition to biogas plants and Vermicompost units for environmental management of dairy farms is also being provided.

Hundreds of small to large dairy units have been setup in last two years under IDDS scheme of Animal Husbandry de-

costs have also largely increased but the procurement rate of milk from farmers has barely increased. In Kashmir, farmers are mostly dependent on the market for feed and fodder, this further adds to the input cost on milk and milk products. The sustainability of the commercial dairy sector under prevailing inflation and economic slump will largely depend upon an organized and competitive procurement chain, value addition and a diversified market for milk and milk products.

he Union government's proposed measures for regu-lating online gaming in a draft amendment to the Information Technology (Intermediary Liability and Digital Media Ethics Code) Rules, 2021 leave several questions unanswered. Some of these proposed measures, such as the establishment of a self-regulatory body, collection of know-your-customer (KYC) information from players, and appointment of a grievance officer within the company, are already in place. These are moves that industry bodies representing such companies have encouraged. States such as Tamil Nadu want much stricter regulation of the sector than what is being proposed by the Centre in the draft, particularly for gambling with real money. The Centre's draft remains ambiguous on the question of whether States can have additional restrictions. So far, the industry has staved off several bans by mounting legal challenges arguing that they offer games of skill and not those purely dependent on chance — a tenuous distinction for real money gaming. Still, games that require wagering are outlawed in the physical form under the colonial Public Gambling Act, 1867 or States' own gambling laws. A clear answer should come from the Union government on whether States are empowered to prohibit these games online as they do offline. While the gaming industry has huge potential as an economic driver of growth in India, there is strong case for robust regulation. Of skill or of chance, all online games impact individuals and society, in the short and the long term.

The government has indicated that the definition of an 'online game', which is limited in the draft amendment to wagering platforms, may be expanded in future to include all games broadly. Societies around the world have grappled with the effects of video games on young players, and the addictive cycles that some gamers can get stuck in; China, for instance, has limited the number of hours that young gamers are allowed to play daily, after which they are locked out for the day. Care and restraint must be exercised when pondering similar steps in India, lest the government introduces uncertainty for both small domestic game developers and large international studios with Indian audiences. The government has said the goal is to facilitate the industry and not hinder its growth. It has also indicated that in future, it will try to curb "violent, addictive or sexual content" in video games. There should be widespread public consultation to ensure that economic rights, individual freedoms, and social imperatives remain in balance.



Do You Have Anxiety Disorder? Here Is How Much **Psychotherapy Can Help**

Anxiety disorders are severe mental illnesses that produce intense worry or fear that persists over time and might possibly get worse. We all experience anxiety from time to time, but those who suffer from anxiety disorders tend to experience it more frequently, and it has a very detrimental and intrusive effect on their quality of life.

Research has found that women are more prone than men to experience anxiety, and hence experts now advise that screening for anxiety disorders should be done as part of regular medical care for women and girls over the age of 13.

What are the various types of anxiety disorders?

The various types of anxiety disorders are as follows:

- Generalized Anxiety Disorder: In gen-1. eralized anxiety disorder (GAD), there is excessive worry and anxiety about many different things. It is challenging to control this worry, and it frequently changes from one worry to another.
- 2. Agoraphobia: Agoraphobia is an intense and illogical fear of being trapped in a situation from which there is no way out. People frequently avoid situations where they might feel terrified, helpless, or imprisoned out of a fear that they will exhibit panic symptoms or other symptoms in front of others.
- **Panic disorder:** The symptoms of panic disorder include frequent, severe panic attacks that come on suddenly and without much or any warning. Rapid breathing, a heightened sense of fear, and rapid heartbeat are just a few of the physical and emotional signs of a panic attack Social Anxiety Disorder: A fear of 4. social situations is a symptom of social anxiety disorder (SAD), formerly known as social phobia. This phobia may be focused on certain scenarios, such public speaking, or it may be more broadly focused on a fear of numerous social interactions. 5. Selective Mutism: A childhood anxiety disorder called selective mutism affects speech. When children experience anxiety, humiliation, or dread in particular situations, such as at school or around strangers, they are unable to speak. **Specific Phobias:** A specific phobia is 6. an overpowering, unreasonable, and excessively fearful reaction to a particular situation or object. People who have a specific phobia exhibit acute symptoms such as sweating, sobbing, shaking, a quick heartbeat, and accelerated respiration when they come in contact with the source of their fear.

ity that it will if the therapist's theories are sound. Therefore, the only choice you have that gives you a chance for success is to trust your therapist.

The significance of having faith in your therapist is related to what I've found to be one of the single strongest predictor of a client's success in anxiety therapy as it might motivate you to do your therapy homework.

Although therapy is a place to learn and practice anxiety-reduction techniques, genuine change doesn't take place during therapy sessions. What matters most is how well you use the lessons you've gained in therapy outside of therapy sessions. I tell my clients that the actual healing does not happen in the session itself; the actual healing happens in-between the sessions where the client works patiently and persistently on what has been discussed in the session.

In my experience, clients who do their therapy homework improve, and clients who do not do their therapy homework do not improve, whether they are my own clients or the clients of the counselors I've supervised.

It frequently calls for risk-taking and doing things that appear counter-intuitive to complete therapeutic homework. In order to achieve long-term relief from their anxiety, clients who are successful in therapy generally approach it with a willingness to endure the short-term suffering brought on by therapeutic homework.

For instance, a client with contamination OCD (fear of germs) can be encouraged to touch objects they believe to be filthy (such as door handles, floors, toilets, and garbage

What are the various types of psychotherapies that clients can opt for?

Since no two people experience anxiety the same way, hence there is no "one size fits all" treatment. What works for one individual may not work for another.

Knowing as much as you can about your therapy options and then customizing them to suit your requirements is the greatest strategy to combat anxiety. Working with a professional therapist to find the greatest fit can be helpful in many situations.

Through therapy, you may learn more about how you feel, why you feel that way, what triggers you, and how you could alter how you react to them. Some therapy models impart useful methods for reframing negative thoughts and altering behaviors.



you to open up about how you have been feeling because of anxiety. Because anxiety is unreasonable, we may feel ashamed of what we're going through, which makes it easier for us to keep our suffering a secret from loved ones and even from ourselves. It can feel quite relieving to simply admit how much you've been suffering.

Therapists don't make their clients feel foolish or judged for feeling nervous. On contrary, therapists take your anxiety very seriously and understand everything you're saying. And whatever you share with a skilled therapist won't come as a surprise to them as they've dealt with a lot of cases just like yours.

It might be difficult to understand how anxiety started and "why you," as the saying

Or a client who is anxious about losing a relationship may be advised to cease asking their spouse for assurance, even though the uncertainty is intolerable and the assurance feels good.

You must experience anxiety in the short term if you want your anxiety to improve. In general, clients who are willing to push past momentary worry improve, whereas those who are unwilling to do so do not.

I sincerely hope that whatever we discussed above regarding anxiety and how a therapist can help you in dealing with it might prove useful as you begin your journey to treat your anxiety. Although it could seem intimidating at first, if you put in the

'From Chronic To Aggressive, How Blood Cancer In Some Can Progress As A Disease'

esearchers have identified an important transition point in the shift from chronic to aggressive blood cancer by conducting experiments in mice, providing a new intervention point for hampering the progress of the disease, according to a study.

The researchers at Washington University School of Medicine, US, have shown that blocking a key molecule, called DUSP6, in the transition pathway prevents this dangerous disease progression both, in mice with models of the disease and in mice with tumours sampled from human patients. The research appears in the journal Nature Cancer.


A type of chronic leukemia, or cancer of the body's blood-forming tissues, can simmer for many years. Some patients may need treatment to manage this type of blood cancer - called myeloproliferative neoplasms (MPN) - while others may go through long periods of watchful waiting.

However, for a small percentage of patients, the slower paced disease can transform into an aggressive cancer, called secondary acute myeloid leukemia, that has few effective treatment options. Little has been known about how this transformation takes place.

"Secondary acute myeloid leukemia has a grim prognosis," said senior author Stephen T. Oh, MD, PhD, an associate professor of medicine and co-director of the Division of Hematology at the School of Medicine.

"Almost every patient who develops acute leukemia after a history of myeloproliferative neoplasms will die from the disease. Therefore, a major focus of our research is to better understand this conversion from chronic to aggressive disease and to develop better therapies and, hopefully, prevention strategies for these patients," said Oh.

The study suggests that inhibiting this key tran-

sition molecule, DUSP6, helps overcome the resistance that these cancers often develop to JAK2 inhibitors, the therapy typically used to treat them.

JAK2 inhibitors are an anti-inflammatory therapy also used to treat rheumatoid arthritis.

"These patients are commonly treated with JAK2 inhibitors, but their disease progresses despite that therapy, so we're also trying to identify how the disease is able to worsen even in the setting of JAK2 inhibition," said Oh.

The researchers conducted a deep dive into the genetics of these tumours, both during the slow chronic phase and after the disease had transformed into the aggressive form while patients were taking JAK2 inhibitors.

The DUSP6 gene stood out as highly expressed

in the 40 patients whose tumours were analyzed in this study.

Using genetic techniques to delete the DUSP6 gene prevented the transition to aggressive disease in mice with models of this cancer.

The researchers also tested a drug compound that inhibits DUSP6 and found that the compound - only available for animal research - stopped progression of the chronic disease to the aggressive disease in two different mouse models of the cancer and in mice with human tumours sampled from patients.

Reducing DUSP6 levels both genetically and with a drug also reduced inflammation in these models.

Since the drug that inhibits DUSP6 is not available for human clinical trials, Oh and his colleagues are interested in exploring treatments that inhibit another molecule that they found is activated downstream of DUSP6 and that they showed is also required to perpetuate the negative effects of DUSP6. There are drugs in clinical trials that inhibit this downstream molecule, known as RSK1.

Oh's team is interested in investigating these drugs for their potential to block the dangerous transition from chronic to aggressive disease and address resistance to JAK2 inhibition, said the study.

"A future clinical trial might enrol myeloproliferative neoplasm patients who are taking JAK2 inhibitors and, despite that, show evidence of their disease worsening." said Oh.

"At that point, we might add the type of RSK inhibitor that's now in trials to their therapy to see if that helps block progression of the disease into an aggressive secondary acute myeloid leukemia.

"A newly developed RKS inhibitor is in phase 1 clinical trials for patients with breast cancer, so we're hopeful our work provides a promising foundation for developing a new treatment strategy for patients with this chronic blood cancer," said Oh.

JAMMU: Agricultural diversification is key to reduce the risk in farming activities and the J&K Government is constantly employing latest technological interventions to diversify agriculture sector across Jammu and Kashmir.

Domestic Air Passenger Traffic Grows 15% To Around 129 Lakh In Dec 2022: Report

NEW DELHI- Domestic air passenger traffic grew 15 per cent year-on-year to around 129 lakh in December 2022 but remained 1 per cent lower than the prepandemic level (December 2019), rating agency ICRA said on Thursday.

ICRA has also maintained a 'Negative' outlook on the Indian aviation industry.

In the April-December period of the current fiscal, domestic passenger traffic is estimated at around 986 lakh, registering around 63 per cent year-on-year growth and lower by approximately 9 per cent compared to April-December 2019 (pre-COV-ID levels), it said.

At the same time, the airlines deployed slightly higher capacity (less than 1 per cent) in the previous month over the yearago period, the rating agency said, adding that it, however, was lower by around 7 per cent

than the pre-COVID levels. According to ICRA, the domestic aviation industry operated at an estimated passenger load factor of around 91 per cent in December 2022 against approximately 80 per cent in December 2021 and about 88 per cent in December 2019.

The agency said it expects a fast-paced recovery in domestic passenger traffic in FY2023, aided by normalcy in operations. However, the earnings recovery for domestic airlines is likely to be decelerated due to sharp escalations in aviation



turbine fuel (ATF) prices and depreciation of the rupee against the US Dollar in the backdrop of increased competition.

"FY2023 is witnessing a quick recovery in domestic passenger traffic, aided by normalcy in operations and the waning impact of the pandemic," ICRA vice president Suprio Banerjee said. While a meaningful improve-

ment in passenger traffic is expected in FY2023, the pace of recovery in the industry earnings will be sluggish, and the industry is expected to incur a net loss of around Rs 150-170 billion owing to elevated costs, the report said.

However, this will be notably lower compared to the Rs 235 billion net loss in FY2022, primarily driven by a recovery in passenger traffic and lower interest burden, following the significant reduction in Air India Limited's debt before the divestment by the central government, it stated.

In the near term, the credit profile of Indian carriers will remain stressed until they are able to reduce their debt burden through a combination of improvement in operating performance and/or by way of equity infusion, it said.

'Housing Sales Momentum To Sustain In 2023'

NEW DELHI: Sales of residential apartments, which rose 68 per cent in 2022, are likely to sustain this year on likely moderation in inflation and better price deals from builders, according to JLL India.

In a statement, JLL India on Thursday said that the sale of apartments grew 68 per cent to 2,15,666 units in 2022 from 1,28,064 units in the previous year across seven major cities -- Mumbai, Delhi-NCR, Bengaluru, Hyderabad, Chennai, Kolkata and Pune.

Mumbai includes Mumbai city, Mumbai suburbs, Thane city and Navi Mumbai.

The annual sales of 2,15,666 units recorded in 2022, the highest in over a decade, next to the peak seen in 2010 at 2,16,762 units, it added. Data includes only apartments, while rowhouses, villas and plotted developments have been excluded.

On the outlook, JLL India said, "Sales momentum is likely to sustain in 2023 on the expectations of moderating inflation supporting a reversal in repo rate hikes".

"Moreover, likely measures from stakeholders, such as longer loan tenures and attractive pricing deals, will keep buyers' affordability levels within comfort," it added.

JLL India noted that the sales of apartments rose despite the rise in mortgage rates, property prices and global headwinds during 2022. PTI

SHORT TAKES **RBI Allows 6 Entities To**

Test Fintech Products To Deal With Financial Frauds

NEW DELHI- Six entities, including HSBC and Creditwatch, have been allowed to test their fintech products to prevent and mitigate financial fraud as part of the fourth cohort under the RBI's regulatory sandbox scheme.

Regulatory sandbox refers to the live testing of new products or services in a controlled/test regulatory environment for which the regulators may permit certain relaxations.

The Reserve Bank announced the opening of the fourth cohort under the regulatory sandbox in June 2022 for the prevention and mitigation of financial fraud.

The RBI said it had received nine applications under the fourth cohort, of which six entities have been selected for the 'test phase'.

The six entities are-Bahwan Cybertek, Crediwatch Information Analytics, enStage Software (Wibmo), HSBC in collaboration with Wibmo, napID Cybersec and Trusting Social.

The selected entities would commence testing their products in February.

The applications for the fourth cohort were received from June 15 to August 1, 2022. PTI

'Hopeful Of Improvement In FDI Inflows In Coming Months'

NEW DELHI- The commerce and industry ministry is hopeful of improvement in foreign direct investment (FDI) inflows in the coming months despite global headwinds, a senior government official said on Thursday.

Joint Secretary in the Department for Promotion of Industry and Internal Trade (DPIIT) Manmeet K Nanda said that usually investments and equity inflows improve towards the last quarter of a financial year.

FDI equity inflows into India contracted by 14 per cent to USD 26.9 billion during the April-September this fiscal, according to the DPIIT data.

The total FDI inflows (which includes equity inflows, re-invested earnings and other capital) too declined to USD 39 billion during the first six months of the current fiscal against USD 42.86 billion in the year-ago period.

She said that foreign inflows have a lot of effect because of the global slowdown that "we are seeing for the last 18 months...But we are hopeful, India has shown very great numbers compared to rest of the countries... So, we are hoping that we would be making up for all that would have been a drop by". She was replying to a question about the reasons for the decline in FDI and the way forward. PTI

Fresh Rs 140 Cr Bank Fraud **Case Against HDIL Promoters**

NEW DELHI- The CBI has booked HDIL promoters Rakesh Wadhawan and Sarang Wadhawan in a new bank fraud case involving an amount of Rs 140 crore pertaining to their subsidiary Guruashish Construction, officials said today.

The fresh action was initiated on a complaint from the Union Bank of India against the businessmen who are embroiled in a Rs-4,300 crore Punjab and Maharashtra Cooperative (PMC) Bank scam case, they said.

The bank has alleged that Guruashish Construction was a wholly-owned subsidiary of Housing Development and Infrastructure Limited (HDIL) engaged in the real estate business in Mumbai.

The Wadhawans were booked by the Central Bureau of Investigation (CBI) in October 2020 in connection with a Rs 200 crore alleged loan fraud from Yes Bank and have been facing investigation by multiple agencies.

They are also being probed by the Enforcement Directorate (ED) as part of another Prevention of Money Laundering Act case related to an alleged loan fraud at the PMC Bank involving an amount of more than Rs 4,300 crore.

The officials said the firm had allegedly entered into a Rs-3.167 crore development contract with the Maharashtra Housing and Area Development Authority (MHADA) for the development of 40 acres of land in Mumbai's Goregaon (West) in five phases. PII

New Delhi: Chief Justice D.Y. Chandrachud on Thursday recused himself from hearing a clutch of petitions seeking initiation of contempt action against comedian Kunal Kamra for publishing tweets mak-ing undignified and derogatory comments against the top court.

As a bench headed by Chief Justice Chandrachud and Justice P.S. Narasimha took up the petitions seeking contempt action against Kamra, the Chief Justice said the matter will be placed before a bench, where he is not a part, because the comments (tweets) were made on the order, which he had passed.

The top court listed the matter after two weeks. In 2020, Kamra had started tweeting, when the top court was hearing an appeal of Arnab Goswami against the Bombay High Court's order rejecting his plea for interim bail in a 2018 abetment-to-suicide case. A bench headed by then Justice Chandrachud had granted interim bail to Goswami.

BRO's 'Relentless' Efforts Kept Zojila Pass Open In Winters Despite Heavy Snowfall: Official

Srinagar: The strategic Zojila pass on the Srinagar-Leh national highway, connecting the Kashmir valley with the Ladakh region, has remained open through December and January despite heavy snowfall due to the relentless efforts of the Border Roads Organisation, a defence spokesperson said on Thursday.

BRO 'Karmyogis', with their relentless effort under 'Project Beacon', facilitated connectivity to Ladakh region by ensuring that the Zojila pass remained open despite heavy snowfall, the official said.

Zojila, which falls on Srinagar-Sonamarg-Gumri road, is located at an elevation of 11,643 feet and serves as the lifeline between the Kashmir Valley and Ladakh, the official said.

"Last year, Zojila Pass was kept open till January 3. This year once again due to the concerted efforts of Project Beacon, the Zojila Pass was kept open for the first time ever till January 6," he said. The spokesperson said the

extended opening of Zojila

pass was carried out by BRO for the first time in 2020 keeping in view the situation at the northern borders.

Since then, it has been continued in 2021 and 2022, the official said.

"Freezing temperatures of up to negative 20 degrees Celsius, insufficient oxygen, high winds and blizzards and frequent avalanches in this terrain did not deter the BRO karmyogis, who despite all

The spokesperson said more than 20 heavy duty plant equipments, including four state of the art snow cutters, were employed to keep the axis open. The BRO has also com-

pleted successful trials of route guidance and navigation system technology for snow clearance to enhance efficiency and safety while performing such operations, the official said.

'Project Beacon' has ensured connectivity to strategic requirements of Indian Army and survival requirements of

the local population of Ladakh, the spokesperson said.

The snowfall in last twothree days has resulted in slippery road conditions along Zojila Pass on the Srinagar Leh highway, causing disruption to traffic movement.

Detachments of 'Project Beacon' with pre-positioned equipments located at Gumri, Bajri Nallah, Baltal, Sonamarg and Gagangir played a key role in opening the pass despite inclement weather conditions, the official said.

"Day and night lost their relevance when six teams deployed at different locations worked 24x7 to keep the road open during extremely challenging conditions since the onset of winters in 2022. Approximately 13,500 vehicles crossed Zojila since November 25 while moving from Kashmir to Ladakh and vice versa," the spokesperson said.

Despite closure of Zojila Pass, snow clearance operations by 'Project Beacon' will continue unabated in order to keep the Sonamarg Tourist Destination open throughout the winters as per requirements of Kashmir Division, he added.

North India Reels Under **Cold Wave; Fog Affects Train Movement**

New Delhi: Several parts of north India reeled under severe cold and dense fog affected railway movement, with Delhi recording a minimum temperature of three degrees Celsius -- the lowest in January in two vears -- making it cooler than several hill stations.

Most people kept indoors and turned to space heaters and cups of hot beverages to keep themselves warm as frosty winds from the snow-clad Himalayas barrelled through the plains, including the national capital.

ture was lower than Dalhousie (4.9 degrees Celsius), Dharamshala (5.2 degrees Celsius), Kangra (3.2 degrees Celsius), Shimla (3.7 degrees Celsius), Dehradun (4.6 degrees Celsius), Mussoorie (4.4 degrees Celsius) and Nainital (6.2 degrees Celsius), according to official data.

Jammu and Kashmir too saw a dip in temperature, with capital Srinagar recording its coldest night of the season so far at minus 6.4 degrees Celsius on Wednesday night against minus 5.2 degrees Celsius the night before.

The India Meteorological Department (IMD) said dense fog blanketed several parts of north India and the situation would continue in the coming weeks

At least 12 trains were delayed by one-and-a-half to six hours and two rescheduled due to the foggy weather, a Railways spokesperson said.

According to the IMD, 'very dense' fog is when visibility is between 0 and 50 metres. 51 and 200 metres is 'dense', 201 and 500 metres 'moderate', and 501 and 1,000 metres 'shallow'. the

Over 20 companies comprising 2,000 troops will be deployed in militancy-prone and minority areas to strengthen security in the twin border districts, they said.

They said 15 companies have reached the border districts while the remainder will be reach in the next few days.

The CRPF personnel are being ferried from outside the union territory for their deployment in the region, they said.

A senior CRPF officer told PTI the security deployment is underway.

every 500 years, whereas in our current cli-mate it could be as frequently as once every three to four years," said Met Office climate attribution scientist Nikos Christidis.

Britain is not alone. France's average temperature was above 14 Celsius (57.2 Fahrenheit) in 2022, making it the hottest year since weather readings began in 1900. In Spain, preliminary data from the end of December indicated that 2022 was the hottest year since records started in 1961.

Last year saw summer drought and heat waves across much of Europe, with the temperature in Britain rising above 40 degrees Celsius (104 Fahrenheit) for the first time on record. Norway's Svalbard islands in the Arctic had their warmest summer in more than a century of record-keeping. The archipelago's average temperature for June, July and August was 7.4 Celsius (45.3 Fahrenheit), the Norwegian Meteorological Institute said.

Autumn brought more heavy rain in parts of Europe, including the mountainous Italian island of Ischia, where downpours in November triggered a massive landslide that pushed cars and buildings into the sea and killed at least a dozen people.

Unlike the U.S. and Canada, which have been hit by bitter cold and snowstorms, much of Europe is experiencing unseasonably warm winter weather.

In Germany, the year ended with the warmest New Year's Eve on record, with temperatures reaching 20 Celsius (68 Fahrenheit) in the south of the country. Belarus, Belgium, Czechia, Latvia, Poland and the Netherlands all set national record daily highs for Dec. 31 or Jan. 1.

As 2023 begins, many low and medium-altitude ski resorts in the Alps, the Pyrenees and other European ranges are suffering from a lack of snow.

In Bosnia, spring-like weather has foiled even artificial snow -- either it's too warm to make it, or it melts soon after being spit out onto the slopes. Along the slopes in Bjelasnica near Sarajevo on Wednesday, snow accumulation amounted to little more than several white patches on an otherwise grassy landscape of brown and green. (AP)

A Club-By-Club Look At Cristiano Ronaldo's Glittering Career

A club-by-club look at Cristiano Ronaldo's career ahead of the start of the Portugal superstar's time in Saudi Arabia with Al Nassr:

SPORTING (2002-03)

At the age of 12, Ronaldo left the island of Madeira and headed to Lis-bon for a trial at Sporting. He joined the club's academy and by age 16 was training with the first team. Ronaldo, a skinny, skillful winger, made his senior debut at 17 and was already earning admiring glances from big European clubs during his only full season at Sporting (2002-03), when he scored five goals and had five assists. The following preseason, Manchester United visited Sporting for a match to inaugurate the Portuguese team's stadium. Ronaldo's performance was so good – he tormented right back John O'Shea — that United's players urged their manager, Alex Ferguson, to sign him. Ronaldo was even introduced to United's players in the locker room after the game. Within a week, he had signed for United for 12.25 million pounds (now \$14.75 million).

MANCHESTER UNITED (2003-09)

It was during his first spell at United that Ronaldo became a superstar, developing from a supreme-



ly gifted but erratic winger into a prolific, fearsome striker. He scored 118 goals in 292 matches in all competitions, helping United win the Premier League for three straight seasons from 2007-09 – matching the club's achievement from 1999-2001. He also won the Champions League with United in 2008, scoring

the team's goal in the final that finished 1-1 before United triumphed in a penalty shootout. Ronaldo won the first of his five world player of the year awards in 2008, after a 2007-08 season when he scored 42 goals in all competitions. By that time, he was heavily linked with a move to Real Madrid but he stayed

at United one more season - during which he helped the team to a Premier League-League Cup double.

REAL MADRID (2009-18)

Signed for a world-record 80 million pounds (then \$131 million), Ronaldo gained more trophies and fame in a nine-year stint that was

defined by his rivalry with then-Barcelona star Lionel Messi and their combined scoring prowess. So prolific was Ronaldo, who mostly played as a center forward, that he averaged more than a goal a game in his time at Madrid – 450 goals in 438 games – to become its record scorer. He topped the 40-goal mark in eight of his nine seasons, reaching 60 in two of them. He won the Champions League in 2014, '16, '17 and '18 along with two La Liga titles and picked up more Ballon d'Or awards in 2013, '14, '16 and '17 amid a sustained period of excellence that lifted him among the greatest players to ever play the game.

JUVENTUS (2018-21)

Wanting to start a "new phase" in his career – amid a period when he and other top players in Spain were accused of tax fraud - Ronaldo secured another big-money move, this time to Juventus for 112 million euros (then \$131.5 million). It was a record transfer fee in the Italian league and he kept on delivering goals, scoring 101 times in 134 appearances and being the top scorer in two of his three seasons. He never won the Champions League with Juventus, though it was at the Italian club where he moved ahead of Messi in the overall scoring charts in Europe's top competition. He also won the league title twice (2019, '20).

MANCHESTER UNITED (2021-22)

"I'm back where I belong," wrote Ronaldo after he sealed a sudden, rather unexpected return to United amid reported interest from the team's local rival, Manchester City. A fee of 15 million euros (then \$17.75 million) to be paid to Juventus over five years seemed a bargain for United, which saw Ronaldo as the player to lead the club to its first Premier League title since 2013 and a place back on European soccer's top table. It didn't work out that way. He continued to score goals - there were two in his first match and 24 in all competitions, including hat tricks in successive home league games - but his reduced mobility and work rate affected United as a whole as the team finished sixth in the 2021-22 season, extending its run without a trophy to five years. Ronaldo missed the start of this season after returning late to training because of what was described as "personal reasons." Essentially, he wanted a move because United hadn't qualified for the Champions League. So began a standoff with United's new manager, Erik ten Hag, that saw him become a bit-part player and then deliver an explosive pre-World Cup interview with Piers Morgan that was the beginning of the end. A week later, his contract was terminated. (AP)


