## **Govt Hands Over Guns To VDGs In Rajouri**

Iammu: Authorities on Saturday distributed weapons among Village Defence Guards (VDGs), comprising local volunteers, in a village in Rajouri district of Jammu and Kashmir, an official said.

Rajouri Deputy Commissioner Vikas Kundal visited Bal Jarallan to inspect the allotment of guns and cartridges to the VDGs to bolster the security of the area. The weapons and ammunition are being provided to the VDGs by police

authorities, the official said.
Bal Jarallan had witnessed a

terror attack on February 19, 1999, resulting in the killing of seven people attending a marriage ceremony and injuries to an equal number. The village is four km away from Dhangri village, the scene of recent attack by terrorists which left six civilians dead and many others injured.

Interacting with the VDGs, Kundal assured that appropriate measures would be taken to maintain peace and tranquility in the district.

## **Ladakh Parties Not To Meet MHA Panel, Demand Statehood**

Put Four Conditions, Including Statehood; Safeguards Under 6th Schedule To Meet Any Empowered Committee

**Srinagar:** Days after Ministry of Home Affairs (MHA) set up a high-powered committee to discuss measures to ensure protection of land and jobs for the people of Ladakh, two major representative bodies of the region on Saturday laid four conditions for meeting any panel empowered to discuss issues, including statehood for the UT and constitutional safeguard under the sixth schedule of the constitution.

The Leh Apex Body (LAB) and Kargil Democratic Alliance (KDA), two major conglomerates of political, social and religious organisations on



Saturday held an emergency meeting at Jammu and unanimously decided not to accept the formation of the highpowered committee and not to attend any meeting conducted

under the aegis of the committee, saying it has not been mandated to discuss issues raised by the two bodies, reads a joint statement issued to Kashmir Observer. More on P6

**Ahead Of Snowfall** 

**Mercury Up** 

Srinagar: The minimum temperature across Kashmir rose by several degrees, comforting people from the intense cold ahead of a possible wet weather spell that may last a few days beginning Saturday, the weather department said.

Srinagar recorded a low of minus 1.4 degrees Celsius on Friday night up by over four degrees from minus 5.5 degrees the night before, officials said.

Qazigund, the gateway to the Valley, registered a minimum of minus 1.6 degrees Celsius, while Kupwara, a frontier district, recorded a minimum of minus 1.8

Kokernag in south Kashmir recorded a low of minus 1.4 degrees, the officials said.

The tourist resort town of Pahalgam in Anantnag district, which also serves as a base camp for the annual Amarnath Yatra, registered a low of minus 2.8 degrees Celsius -- up from minus 8.6 degrees.

The minimum temperature in Gulmarg, the famous ski resort town in north Kashmir's Baramulla district, recorded a temperature of minus 2.6 degrees Celsius up from the previous night's minus 5 degrees Celsius, the officials said.

The Met office said the weather was likely to remain cloudy on Saturday with a possibility of light snow in scattered places towards the night with a 75 per cent chance of light-to-moderate snowfall at many places on Sunday.

The weather will remain generally cloudy on January 10 and 11, but there are chances of widespread moderate snowfall and rain in the plains of Jammu, and heavy snowfall in the higher reaches, it said.

Kashmir is currently under the grip of 'Chilla-i-Kalan', the 40-day harshest weather period when the chances of snowfall are maximum and most frequent.

'Chilla-i-Kalan' begins on December 21 and ends on January 30. More on P6

## **G20 Summit: Chair Of W20 India Calls On LG**

Jammu: Dr Sandhya Purecha, Chair W20 India (Women-20), an official G20 engagement group focused on gender equity, met Lieutenant Governor Manoj Sinha, at the Raj Bhavan here on Saturday, an official spokesperson said.

Dr Purecha, he said, shared with the LG the vision and goals of W20 and efforts to mainstream gender considerations into G20 discussions and translate into the G20 Leaders' Declaration as policies and commitments that foster gender equality and women's economic empowerment.

"The Lt Governor assured cooperation and support of the UT administration to the W20 in its endeavours towards women-led development and an equal and equitable society," the spokesperson said.



Dr Purecha's meeting with LG comes at a time when the Union Territory administration is making preparations over a possible G20 summit meeting in Jammu and Kashmir this year.

Last month, LG Sinha chaired a high-level meeting and called for extensive preparations

ahead of the G20 meet. He said that the meetings under India's presidency is also an opportunity to share Jammu Kashmir's achievements and to showcase its rich cultural heritage.

**Srinagar:** A majority of Kashmiri Pandit employees, who had struck work following the killing of Rahul Bhat by terrorists last year, have returned to work, a senior official of the Jammu and Kashmir administration said here

"I reject this notion that all Kashmiri Pandit employees are protesting in Jammu. A majority of these employees have already joined their offices (and) we are releasing their salaries. They have understood the importance of reporting to work," Divisional Commissioner, Kashmir, Pandurang Kundbarao Pole told PTI.

Bhat, a Kashmiri Pandit employee, was shot dead by the ultras inside his office at Chadoora in Budgam district in May last year. The killing had sparked off protests by the Kashmiri Pandit employees

who refused to return to work. A group of protesting employees left the Valley and demonstrated in Jammu, demanding that they be relocated out of Kashmir till the security situation improved here.



#### **Delhi Records Coldest Night At 2.2°C**

elhi on Saturday recorded a minimum temperature of 2.2 degrees Celsius, five notches below the average and the season's lowest so far, according to the India Meteorological Department. Very dense fog reduced visibility at Palam to around 50 metres, affecting road and rail traffic. The visibility at the Palam observatory near the Indira Gandhi International Airport was 25

This is for the first time, students of Jammu and Kashmir will appear in the annual regular board examination in March and April session

respectively.
The official records state that annual regular exams of class 12th in soft zones tentatively will commence from March-04 while in hard zones the exams will commence from April-08.

Similarly, the BOSE has said that it is likely to hold annual regular exams of 11th standard from March-06 in soft zones and April-10 in hard zones respectively. Likewise, the exams of 10th

standard are likely to commence from March-09 while the exams of hard zones will begin from April-11

The Board of School Education (BOSE) has identified 444 such schools in the both divisions of Jammu and Kashmir for which annual regular examinations will be held in the month of April instead of March.

# **Anganwadi Workers Stage Protest Against HR Policy**

Srinagar: The Anganwadi & ICDS workers on Saturday staged a protest at the Press Enclave against the recently approved HR policy by the administration for female Anganwadi Workers (AWWs) and Helpers working in the Integrated Child Development Scheme (ICDS) of LEVE

of J&K.

The protesting Anganwadi workers said according to the HR policy the retiring age of the workers has been set 60, besides there are some clauses of the order which are not in the interest of workers.

"We are being told those Anganwadi workers who have attained the age of sixty years should sit at home, the move is unjustified and uncalled for " said an Anganwadi worker.

wadi worker.

The protesting Anganwadi workers said whereas the retirement age for Anganwadi workers in New Delhi and Ladakh is 65 years, it is 60 years in the Union Territory of Jammu and Kashmir.

They further said that after years of service, workers are being transferred from one ward to another.

"Our retirement age should be enhanced to 65 years to bring us at par with other Union Territories and status quo should be maintained with reference to our postings" they said.

The ICDS workers further said some decades back when they joined their duties, the number of malnutritioned children was much higher and the credit of improving the health scenario in Jammu and Kashmir goes to them.

However, they said, by approving the HR policy the admiration has not only failed in acknowledging their contribution but also put a question mark on their credibility.

Pertinently, the government in November this year approved the proposal of a comprehensive Human Resource Policy to govern the engagement, leaves, promotion and other important aspects of this very vital work force of the Social Welfare department.

Papier Mache artists are abandoning the craft in the face of low wages with the younger generation little interested in carrying forward the trade. But Hakeem Manzoor Ahmed of Ganai Doori Alamgari Bazar Srinagar is now training his son to keep the paper mache art alive.

Manzoor said that he was just 14-15 year old when he started learning this art from his elder brother who later abandoned it.

But Manzoor created a niche for himself by his unique papier mache products with different colour combinations.

"When this craft was in

decline, we got an offer to work at Jamia Masjid Charar e Sharief. People were surprised by our work and they started enquiring about us which opened doors for opportunity," he said.

"Since then I have worked on multiple projects including Ziyarat Dastgeer Sahab, Shah Hamdan Shrine Tral, Masjid at Police Lines Batamaloo, Khaqah-e-Moula, Naqshband Sahib shrine and currently we are about to start work at the shrine of Aishmuqam in Anantnag," he said.

"Decorative items of paper mache items are more common. But the paper mache artwork that I do on walls is truly unique. This work is found in ancient masjids and religious shrines. Such colourful and wonderful work is also found in houseboats and houses of some affluent," he added—(KNO)

# 30 Injured In Prison Riots

RINAGAR- At least 30 people, including a deputy superintendent of jail, were injured in a clash between detenues and CRPF jawans in the high security Kotbalwal jail near here today. A high-level en¬quiry has been ordered into the incident.

Trouble arose when jail of—ficials and CRPF personnel were inspecting one of the bar¬racks housing foreign militants around 1100 hours. According to NAFA, CRPF and police had gone to the jail with sniffer dogs on receipt of some information' A Pakistani militant identi¬fied as Khawaja is reported to have entered into an argument with the police who subjected him to a summary thrashing. This at¬tracted die attention of other detenues in the adjacent bar¬racks. Around 50 of them, mostly foreigners came out and started shouting 'provocative' slogans.

Sensing trouble, the police and CRPF personnel resorted lathicharge which was re¬sponded by the detenues with stone pelting. In the ensuing clash 36 detenues besides the deputy superintendent of po¬lice, Harish Kotwal, were in¬jured. Several visitors who had come meet their jailed relatives and some shopkeepers also started shouting slogans. They were chased away with some of them sustaining injuries in the process.

Later, a large number of visitors and shopkeepers sat on a dharna on the Akhnoor road and caused disruption in vehicular traffic. It was only after the CRPF commandant arrived at the spot that the situation was brought under control. He pacified the agitated inmates and the protesters and later reported the matter to the higher ups.

Taking a serious note of the incident, the director general of prisons, S S Ali, ordered a high level enquiry into it and asked the jail superintendent to submit a report immediately.

# Takeaways: High Performing Education Systems


ducation is not a mechanical system or a manufacturing process where we could design an algorithm, automate a set of standardised operations involved and expect the quantity and quality of products on predictable lines. The fact is that education is a man-made system, an organic process which is more or less based on the principles of agriculture. The analogy intends to elucidate that there are conditions under which learners thrive and conditions under which they don't. Therefore, the culture in which students and teachers work is of foremost significance among many factors which determine the quality of education and its outcome.

Culture is an organic term. While the concept of quality is constantly evolving, some universal benchmarks of 'quality education' include ability to think critically, creatively and the application of knowledge and skills to meet real life challenges. It is imperative that the foundations of an education system be laid on the principles that create and support conditions under which children learn in an effortless and seamless fashion.

Many countries around the world have established their global reputation as the 'best education systems' of the world and have come to be frequently accepted as reference models in global policy discourses as educational stars for other countries to emulate.

For instance, since 2011 education reforms, Canada has emerged as an educational leader in international assessment rankings. A enviable story of the Canadian system has been its capacity to integrate large immigrant students into the system with the same performance outcomes as native Canadians.

Similarly, the success of Singa-



pore's `Teach less, learn more' campaign together with the 'Thinking schools and learning nations' as well as the model of recruitment and retention of professionally competent teachers has raised Singapore to being one of the top performing education systems in the world.

Finland's education system too, which is widely acknowledged as one of the best systems in the world, climbed up the global ranking ladder in tandem with evidence-based reforms based on what has the greatest impact on teaching and learning. Finland regularly comes out at the top in science, maths and reading in PISA rankings. Finland's strong focus on personalised learning, school autonomy and a de-cluttered curriculum, has given students, teachers and flexibility to progress academically and professionally.

Quite noticeably, what all these high performing systems in the world be it Singapore, Canada, Finland or Shanghai do is not available in many other countries including India. If we look closely, there are many shared features of these successful educational systems. The first is that these systems individualise teaching and learning. Personalised education is premised on the recognition of uniqueness of each child and the refutation of a one-size- fits-all approach. As children have unique biographies, the system has to engage with their individuality. These systems have a very broad approach to education with a very broad and diverse curriculum which offers much flexibility of choice to individual learners.

The third important feature of these systems is that they attribute a very high status to the teaching profession. This makes teaching a highly attractive career choice for talented people. No education system in the world can be better than its teachers. We can't improve education if we don't get talented people to teach, give them constant support, encouragement, appreciation and professional development.

Top-performing countries take

two different approaches to ensuring well-trained teachers. In Finland and Canada, the training is 'frontloaded' and teaching is an attractive profession. In Singapore, Japan and Shanghai, teachers are expected to improve throughout their career, and are assessed against teacher standards or descriptions.

Yet another feature of these systems is that they devolve responsibility to school levels. Educational institutions operate with a great deal of autonomy. A system based on trust that relies on professional expertise of teachers as against control through the top-down directives from federal or provincial governments. The system recognises that education doesn't occur in the meeting halls of the policymakers. It is transacted in classrooms. Its actual players are the teachers and the students.

Any system that snatches the discretion from teachers and students, stops working. It is vital to put this autonomy back to the people on the spot. Contrary to these models, in most systems elsewhere, federal or provincial governments decide and dictate both curricular and operational aspects of academic business.

Such systems also put less emphasis on standardised assessments. These encourage learners to come up with their own solutions to problems based on personalised curriculum. The high performing systems offer inspiration and guidelines to us. Policy makers back home can make inferences from practices of the successful systems and test their applicability within our context.

wentieth-century political democracy was supposed to last forever. Though there were many variations of the British and the American models, the common thread that bound different democracies across the world was that governments were elected through the exercise of universal franchise. Almost all these democracies had economies driven by private capital and free markets. The threat to democracy was of some sort. This threat was considered more dangerous than dictators who assumed power after a military coup. This was because these dictators kept the economic structures intact and often allowed greater free play of international capital. A prime example of this was Chile in the 1970s. The socialist president, Salvador Allende, was overthrown and an authoritarian military dictator was installed with support from the Establishment in the United States of America. The economy did well in terms of corporate profits and national income while many people critical of the government were sent to jail, or went missing, never to be seen again.

In the twenty-first century, however, democracy has emerged as its own enemy. Governments elected through open elections have morphed into regimes that are described as illiberal democracies. The erosion comes from within the system. Institutions and processes that were the key players in a democracy began to get compromised and open to manipulations and ideological distortions by elected governments. There are many examples: the US, Turkey, Hungary, India, Brazil to name a few. These trends have triggered a variety of responses: is this the end of democracy? Is it a new system of government emerging? Is it just a temporary aberration?

To understand why democratic institutions and values have become vulnerable to attack from elected governments, it is important to know what makes democracies work in the first place. Democracy requires the voice of the people to be heard. Not just some particular voices but the voices of all citizens. Economic and social benefits are created and distributed amongst the population on the basis of the responses of the government to these voices. These benefits have to be perceived to be fairly distributed. Good governance has to be based on reason and responsibility.

This conception of good governance requires, in turn, a set of institutions that are nurtured and allowed to flourish — an efficient and responsive bureaucracy, an independent judiciary, a free media, and an open and critical academe. Without these, a good set of legislators may fail to govern, and an unresponsive set of legislators cannot be held accountable. This, in short, was the basic theory of democracy. The model of representative parliamentary democracy became popular and more

commonly observed in the twentieth century.

The economic and social benefits that a good democratic government is supposed to deliver imply that over time citizens experience economic development and enjoy higher levels of material consumption as well as greater political freedoms and civil liberties. However, there is one serious difficulty here, germane to democracy. The essence of political freedoms and civil liberties rests on treating all citizens as equals; there is no difference between a rich business tycoon and an unemployed worker living on the streets. The difference between the business tycoon and the unemployed worker is fundamentally economic. On the economic front, outcomes are necessarily unequal. The system of private enterprise and markets makes someone rich and someone poor: luck and ability combine in determining fortunes.

As economic development and growth took place in the twentieth century, there appeared a tension between the inclusive responsiveness of the government to the needs and the demands of citizens and the demands of big business to grow unencumbered by government regulations. The result of this tension was a foregone conclusion: the political players who formed the government needed

big business to bankroll their election campaigns. Government interventions in markets and in the process of economic development became unfashionable. This was the crux of neoliberalism where open markets and free international trade were deemed essential to keep the world economy afloat.

As a result of this, during the last three decades, the ability of governments to remain responsive to people's demands and requirements became limited. Democracy's proverbial 'man on the street' changed too. The leaps made by technology made populations impatient and more self-centred. The smartphone generation cares little for others; it has a strong belief in technology when it comes to solving all problems; being technologically savvy gives its members a great deal of confidence to control their own destinies. Hence, their articulated need for government is much less than what was thirty years ago.

The explosion of material goods that has become part of everyday life brought about new problems. Academics have been warning us about irreparable environmental damage that would restrict the way we live and work and also jeopardise life on the planet. This set of problems requires new interventions and cooperation between govern-

ments and corporations never known before.

From the typical government's point of view,

From the typical government's point of view, governing has become more and more complicated. New environmental challenges and acute problems associated with growing income and wealth inequalities require policies and interventions that would hurt some and benefit others. Profit-making would have to be redefined if the economy is to become sustainable. Complex technological connectivity has made the world more dangerous, with cyber crimes, pandemics, and terrorism adding to the problems of governance.

Twentieth-century democracy has made governability more difficult, bringing political openness and economic freedom under heavy stress. With an increasing number of people growing relatively poor, and another large segment of the population refusing to take its eyes off their cell phones, the easier option for governments was to keep political freedoms under check. This was one way of ensuring that governments had big business on their side while, politically, they could soften, stifle and silence voices of dissent.

To be able to do this effectively and systematically, governments have been changing the political narrative as much as possible. A sharp change in the narrative often serves to distract citizens from their immediate concerns. New narratives usually concentrate on the past, since the future is uncertain and complex. The past is glorified as an ideal society, and the historical evidence to that effect is concocted, or simply created through a set of lies. Another part of the changed narrative focuses on a common and easily identifiable enemy — usually a religious or racial minority or a migrant community — that is part of that society. These groups are supposed to represent a clear and immediate threat to the majority. This threat is used as a weapon to control the independence of judges, bureaucrats, journalists and academicians.

Openness itself becomes a threat to the political order. One does not have to be a revolutionary or a power-hungry military leader, anyone criticising the government is suspect and dealt with in a proper manner. The new narrative becomes the truth, the whole truth, and nothing but the truth. Twenty-first-century democracy is not awaiting the revolutionary socialist bang on its door; rather, it is succumbing to a whimper of impotence from within.


In the words of Dorothy Sarnoff, "Make sure you have finished speaking before your audience has finished listening.

# 'A TOUGH LITTLE SPARROW': How a ring helped me grieve my mother

t the tail-end of a social media distraction scroll, stared at my computer transfixed. There on my Instagram feed was the perfect signet ring: atop a gold band rested the engraved emblem of a sparrow perched on a branch looking blissfully over its shoulder. Its quiet contentment stirred in me a sense of hope I hadn't felt in quite a while. I wanted that ring. I needed that ring. And then I realised it already be-

longed to me. The jeweller had posted a picture of it on their page nearly a year and a half after I'd designed it and brought it home. Over the next few days, like a teenager, I found myself returning to the post to see how many hearts it had racked up. I felt embarrassingly proud that my little sparrow was faring well.

But amidst the oohs and ahs were people asking to purchase it - and the jeweller instructing them to contact the shop for a quote. I was astounded. This was my ring. With my design. To honour my mother. Could the jeweller legally offer her to the world? If so, was I prepared to share my mom?

I'd long wanted a pinky signet ring. They're so English. My parents grew up in London during World War II; I have dual citizenship and fancy myself more a Brit than an American, especially as of late.

My mother died of thyroid cancer in her late eighties, but her body had been giving out on her in so many ways for so long. Her last decade had been hard, though she rarely let on.

After her death, my dad, niece, and I went to London to sprinkle her ashes on her mother's grave. While there, I wanted to find a pinky ring as a remembrance to her.

A month before we were set to leave, I scouted out stores online we could dash into. I wasn't expecting much. But up popped one link and my breath caught short. Each ring was handmade and engraved by master craftsmen who'd honed their ancient trade the old school way by apprenticeship. The jewellery was elegant, timeless, substantive; I could conjure the weight of one on

my hand and knew this was my ring. My mom and I had had a tender but complicated relationship. When



I was five or six, my mother - red lipstick, Chanel No 5, diamond studs - let me know that the reason she'd given birth to me was so that she would never be alone.

"We'll always be best friends," she'd said firmly, kneeling beside

In part, I was delighted: I was her treasure. In part, even at such a young age, I felt tremendous pressure. How could I shine brightly enough to fill up this wondrous being's whole life?

"What if I let you down?" I queried, my eyes, as mom liked to say, as big as saucers.

"Oh, love," she said, "you could never let me down."

As I grew older, her refrain transfigured slightly into, "Isn't our relationship wonderful? So many mothers and daughters don't have this."

What it was we had wasn't clear, yet questioning it risked defiling my whole purpose. It wasn't until was much older that I realised how angry this agreement made me - as if I needed to earn my mother's attention by bestowing attention upon

For much of my life, I kept this simmering fury from my conscious mind, but I realise now it informed nearly all our interactions. Whether conjured or genuinely present, I found the expectations draining. I felt my mom wanted too much from me, wanted to be part of my life in a way that was too intimate for my comfort level, wanted to tell me things about her life, including her

relationship with my dad, that as her daughter I didn't want to hear.

In an effort not to buckle from the pressure I did my best to generate a forcefield of emotional-distancing armour that allowed me to be the good daughter we both wanted while keeping some semblance of

myself intact. My visit that summer to the jewellers I'd found online took me to Leather Lane in Hatton Garden, London's jewellery district. Narrow and winding, more like an alley with trappings of an outdoor market, it reminded me of the Lower East Side in the early eighties. My mind wandered back to when my parents would visit me there. People living in cardboard boxes lined the streets then. My mom would stop and talk to each of them. She would hold their hands, ask questions about their lives, listen deeply to their answers, then give everyone a hug goodbye. It took forever to get down

the street. The jewellers' storefront at the time was small, barely big enough to swing a cat, as my cockney grandmother would say. In the backroom, I slipped various sizes and shapes of rings from the velvet trays onto my finger. They were even weightier than I imagined. There were few things my mom loved more than jewellery and I felt her there thrilling over my shoulder.

Next, I met with the engraver who sketched out a sparrow from a photo I'd brought along, his workbench gloriously strewn with various worn

clamps, scrapers and chisels. When coming up with the design, I'd closed my eyes to connect with my mom and the first thing I saw was a

bird, my mother loved them. As far back as I can remember she cared

I wasn't surprised I'd conjured a

kept in their back garden, who regularly wandered into the house. My mother had loved her. The youngest of nine children, her brothers were off at war, her brothers-in-law had been taken prisoner and most of her sisters were involved in the war effort. There was the Blitz, the rations, a father who drank too much and a mother who wore her teeth to nubs trying to keep her family safe. I imagine her a lonely child, finding comfort from the merry strut of Sally Ann. No wonder she desired the guarantee of a best friend.

It took several weeks to complete my ring and once I slipped it on, I never wanted to take it off. I realised that more than a remembrance, my grief had taken the shape of this tiny bird. There's nothing regal or elegant about the chubby little brown feathered ave that's now permanently perched atop my finger.

It's not the sort of bird that usually graces an expensive trinket - but its friendly, communal manner is true to my mom's spirit, the spirit that tended to the unhoused people in New York back in the day.

A month before we were set to leave, I scouted out stores online we could dash

lit up in her presence. In many ways, I did, too. Generous beyond measure, she was always keen to treat me to that special something I couldn't swing for myself – be it a cosy sweater or pocket money for a trip. Every Easter in Manhattan friends flocked to my apartment as I opened the massive box of chocolate turtles, jellybeans, and homemade pumpkin bread my mother sent. I could call her any time of day or night and often she was expecting me; she seemed to intuit key moments of my life.

When she was alive, so much of her goodness had been buried beneath the exhausting bargain to complete her life. Now I could appreciate the beauty of her love without feeling like she needed my energy to survive. She was just lonely, too. This gentle sparrow became a reminder I was a beloved daughter not just someone's promised companion.

And now the jewellers wanted to allow others to have a piece of the mother I was just growing to properly appreciate, a piece of my grief. My initial impulse was to shoot them an email, instructing them they couldn't sell my design. But I waited a few days and kept counting hearts. I also kept filling my birdfeeder following the routine my mom had imprinted. The feeder was the first gift my parents gave me when I left Manhattan to be closer to them both in their eighties and my mom well into her health struggles - and bought my first home in Michigan. Dressed in my Boggs and J Crew parka, my version of my mom's Uggs and Burberry duffel, I felt her spirit move inside me - both of us most content when the birds are fed and their birdbath full.

In the end, I simply made a comment on the jewellers' post thanking them for their beautiful work. I claimed the ring as mine but didn't try to prevent others from owning it too. Now I imagine my tough little sparrow perched on fingers across the world and it delights me. Of course, the wearer wouldn't know any of this – not consciously, at least - but my mom would be there nonetheless, adopting each of them as a welcome member of her flock.

# **Court Refuses Police Custody Of Man** Arrested For Urinating On Co-Passenger On AI Flight, Says 'Go By Law'

New Delhi: A Delhi court on Saturday sent Shankar Mishra, accused of urinating on a woman co-passenger on an Air India flight, to judicial remand for 14 days while rejecting a plea by police for his custody.

"Just because there's public pressure, don't do this. Go by the law," Metropolitan Magistrate Anamika said after the police sought Mishra's remand for three days for custodial interrogation on the grounds that he was required to be identified by three cabin crew members, two captains and other co-passengers, who were also to be examined.

The court passed the order to send Mishra to judicial remand, noting that his custody was not needed for recording the statements of other witnesses and they can be quizzed in his absence.

Meanwhile, it posted for January 11 the consideration of the bail application of the accused.

"Considering all the reasons stated above... PC is not required for recording the statement of witnesses. They can be interrogated in his absence. Statements can be recorded, and there is no



requirement of his PC," the court

It noted that on the basis of the evidence, the accused prima facie did not cooperate in the investigation.

"Perusal of records shows that the accused was deliberately avoiding joining of investigation. In order to make further investigation, recording of statements of crew members, recording statements, his custody is not required," the magistrate said.

During the arguments, the court asked the police why it required his custody.

is not required for others' questioning, TIP (Test Identification Parade). Everything is known. Why his custody is required? Nobody else is to be arrested. There is no ground for PC," the court said.

On the court's query whether the police were expecting any co-accused in the case, the agency submitted that the cabin crew did not handle the situation and that they were also "complicit in the alleged offence".

Custodial interrogation is required for his identification by three cabin crews, two captains, and other co-passengers, who are also to be examined, police told the court.

Advocate Manu Sharma, appearing for the accused, opposed the police plea, saying, "A lot of noise has been made. Even if the incident is taken as true, all the offences my client is accused of are bailable.

The police, meanwhile, refused to hand over a copy of the FIR to an advocate appearing for the complainant, saying the "case has been so viral, we do not want to give a copy of the complaint to anyone but the complainant".

After the judge passed the order, the counsel for the accused sought bail, contending that since he was not required for interrogation, there was no need to keep him in custody.

The metropolitan magistrate said the bail application will be considered on January 11.

Bengaluru police had assisted Delhi police in arresting Shankar Mishra from Sanjay Nagar area in the city. Mishra allegedly urinated on the woman, a senior citizen, in an inebriated condition in the business class of the Air India flight from New York to Delhi on November 26 last year. The Delhi Police registered an FIR against him on January 4 on a complaint given by the woman to Air India.

"We therefore urge the hon-ourable Speaker of the Lok Sabha to take immediate action to refer the matter to the Committee of Ethics of the Lok Sabha for such action as may be deemed appropriate," it said.

Thakur had on December 25 in Shivamogga said Hindus have the right to respond to those who attack them and their dignity as she spoke about the killing of Hindu activists. Speaking at the Hindu Jagarana Vedike's southern region annual convention, she had also told the gathering to give a befitting reply to anyone who "infiltrates our house."

Though Thakur appears to have cleverly chosen her words to avoid criminal charges being made against her, the disguise is only a thin one, the former bureaucrats' letter said. "She is obviously fomenting hate against non-Hindu communities, and advocating violence against them."

Former Lieutenant Governor of Delhi Najeeb Jung, ex-foreign secretary Shivshankar Menon, former Indian Police Service (IPS) officers A S Dulat, Julio Ribeiro, and Amitabh Mathur. and ex-Indian Administrative Service (IAS) officers T K A Nair and K Sujatha Rao are among 103 signatories to the letter written by the collective 'Constitutional Conduct Group'.

#### **Surge In Respiratory Infections Linked To Spike In Heart Attacks, Strokes: DAK**

SRINAGAR: Doctors Association Kashmir (DAK) on Saturday said surge in respiratory infections during winter puts people at higher risk of heart attacks and strokes.

"If you catch respiratory infection, you are at increased risk of having a heart attack or stroke," said DAK President and Influenza expert Dr Nisar-ul-Hassan in a statement.

Dr Hassan said as winter sets in, cases of respiratory infections increase. The surge in respiratory infections has been linked to spike in heart attacks and strokes during winter months.

He said a study conducted at London School of Hygiene and Tropical Medicine has found strong evidence that recent respiratory infections increase the risk of heart attacks and strokes.

The researchers found that the risk of both heart attack and stroke doubled in the week following respiratory infection.

The risk is particularly high

among elderly and those with underling heart conditions.

The DAK President said respiratory infection causes acute and severe inflammation that builds up fat deposits in the inner walls of blood vessels. These fat deposits dislodge and get stuck in heart or brain, where they block the blood flow.

"Infection activates blood cells and clotting system leading to increased risk of blood clots," he said.

Dr Nisar said the number of heart attacks and stroke patients in Kashmir doubles in winter and respiratory infection is a major factor.

"The risk is similar to the risk seen for other known risk factors, such as high blood pressure, diabetes or smoking,"

"Preventing respiratory infections by vaccinating people against influenza and pneumococcus will help reduce the risk of heart attacks and strokes during wintertime," he added.

"He (Sayeed) had this belief that even if a country was powerful, it cannot win a war against its own people. Had this not been true then America would not have withdrawn from Vietnam, or Bangladesh would not have separated from Pakistan," she said at the event in Bijbehara area of south Kashmir's Anantnag.

Mufti attacked the BJP, saying it will replace the country's national flag with a saffron flag.

"We want to tell the people of our country that the BJP, which eroded our constitution in 2019, will destroy the constitution of this country in the time to come. They (BJP) snatched our flag, and in the times to come, they will snatch the Tiranga for which the people of the country gave their blood. They will replace the Tricolour with a saffron flag," the PDP

president said. She said the BJP has not only eroded J-K's constitution, but has also "bulldozed" the constitution of India. "By abrogating (Article) 370, they eroded the country's constitution as well." she added.

There was a time when a court ruled against then prime minister Indira Gandhi, Mufti said, adding, "Today, our chief justice says the courts are afraid of granting bail. You have to see the difference. Then a court ruled against a PM, now they are afraid of granting bail to innocents.'

Similarly, she said, when riots took place, the media used to question the government, but today, the media is "afraid".

'If today's media would have talked, then Stan Swamy would not have died in the jail. The media would have seen how J-K has



become a military garrison. There are troops everywhere," she said. The PDP president said the party does not have any differences with the Army and they have done their job, but asked if the situation had improved, then

why not send the troops back to

barracks. "If the BJP says that the situation in J-K has improved, then send the troops back to barracks. Then AFSPA should be withdrawn. However, you are doing quite the opposite. You are bringing more troops, you are arming the people here. How will this work?

"Which India are you trying to make? This is not the India which Sayeed used to talk about. His face used to light up when he used to talk about India," she said.

He said many people ask if Sayeed would have been alive, what

would he have done? "Had he been there, then his heart would have broken. This is not his India. This is Godse's India. We have not joined with this India, but with (MK) Gandhi's, (Jawahar Lal) Nehru's and Abul Kalam Azad's India," she said.

Accusing the BJP of "destroying" institutions, Mufti said people are being "oppressed", youth are being arrested and employees sacked.

"But, I want to tell people, do not lose hope. Sayeed would not have lost hope. I want to tell my workers don't lose hope," she added.

Meanwhile, Mufti's daughter Iltija Mufti said there was a huge difference between the India where she was brought up and the today's India.

"Mother Mary's statues were vandalised at many places when Christmas was celebrated. This is not Gandhi's India, but Godse's," she said while replying to a reporter's question about her mother's remarks that the country today is not the same to which J-K acceded to.

## **Govt Procures Machines Worth** Rs 78 Cr For Snow Clearance

SRINAGAR: The J&K administration has procured modern snow clearance machines worth Rs 40 crores out of the total budget of Rs 78 crores this year, while as the authorities on Saturday claimed that men and machinery have been put in alert mode in the wake of snowfall prediction.

Some of the machines with hydraulic power systems will be pressed for the first time during the road clearance.

Chief Engineer Mechanical Engineering Department (MED), Rasheed Ahmad Dar said that a total budget of Rs 78 crores were allotted to procure the machines and vehicles for snow clearance in Jammu and Kashmir. "The machines and vehicles worth Rs 40 crores have reached us so far while the machines worth Rs 38 crores will arrive soon," he said.

He said that at present there are three snow cutter machines available, which is meant for heavy snowfall and has been procured at the cost of Rs 18 crore. Besides, two trucks, 30-40 snow 4x4 trucks that are



specially meant for Kashmir are presently available.

Dar further informed that a total of 252 machines are available with the department for snow clearance. "The number of machines available with us was 150 only till 2020, but the number has been increased to 252," he said.

About the weather forecast by Indian Meteorological Department (IMD), Chief Engineer MED said that the man and machinery has already been geared up and a total of 15 control rooms including 10 district control rooms have been established.

He also said that there is

possibility of snowfall across Kashmir including Srinagar and special control rooms have been established at some areas including Gurez, Gulmarg and other places

The Chief Engineer further added that the road clearance over a total of 9000 kilometers falling under MED's jurisdiction will be ensured very swiftly.

However, he appealed to people not to park their vehicles on the roadsides to ensure that the road clearance work is not hampered. "The people should cooperate in this regard. The people should not park their vehicles on the

**NEW DELHI:** The Centre has banned the People's Anti-Fascist Front (PAFF), a proxy outfit of the militant group Jaish-e-Mohammed, for its involvement in militancy activities in Jammu and Kashmir and else-

The Union Home Ministry on Friday also designated Arbaz Ahmad Mir, a Lashkar-e-Taiba member, as an "individual terrorist" under the stringent anti-terror law Unlawful Ac-

tivities (Prevention) Act, 1967. In a notification, the ministry said the PAFF has been regularly issuing threats to security forces, political leaders and civilians working in Jammu

"The PAFF, along with other organisations, is involved in pro-actively conspiring both physically and on social media to undertake violent terrorist acts in Jammu and Kashmir and major cities in India," it said.

"Along with other organisations, the PAFF is indulging in radicalisation of impressionable youth for recruitment and training in handling guns, ammunition and explosives. The group has also been involved in terrorism. It has committed and participated in various acts of terrorism in India," the

ministry said. Therefore, exercising the powers conferred by clause (a) of sub-section (1) of section 35 of the Unlawful Activities (Prevention) Act, 1967, the central government declared the PAFF a banned organisation, it said.

In a separate notification, the Union Home Ministry said it has designated Arbaz Ahmad Mir, who hails from Jammu and Kashmir but is presently based in Pakistan and working for the banned militant group Lashkar-e-Taiba, as an "indi-

It said Mir has been involved in target killings and has emerged as the main conspirator in the killing of a woman teacher, Rain Bala, in Kulgam of Jammu and Kashmir a few

"Mir has been involved in coordinating terrorism in the Kashmir Valley and supporting terrorists by transporting illegal arms or ammunition or explosives from across the border," the ministry said.

"The central government believes that Mir has been involved in terrorism and therefore exercising the powers conferred by clause (a) of subsection 1) of section 35 of the Unlawful Activities (Prevention) Act, 1967 designated him as an individual terrorist," the notification said.

The RSS delegation too demanded a probe into the disarming of village defence committee (VDC) members without any government order.

The co-ordination between the Indian Army and the police needs to be stepped up with enhanced vigilance to prevent loss of innocent lives. This (Dhangri incident) is an example of governance and administrative failure in full measure," Nath,

an advocate, said on Saturday. She appealed to the central government to hold a fresh security audit of the region.

Offering her condolences to the victims' families, the Congress leader said, "It was heartbreaking and painful to watch the families who lost their loved ones in an instance of mindless violence as a result of a monumental security breach."

Nath said the tragedy could have been avoided if the authorities were vigilant enough.

"This tragedy could have been avoided had the administration been a little vigilant and alert as this attack took place days after the Sidhra encounter," she said.
