Amid Fire Fury, Rebuilding Becomes Herculean Task In Kashmir

very time a siren shatters the nocturnal si-lence, Jamsheeda tosses and turns in her bed. She was thrown out of sleep by the same sound last spring and rendered roofless. The tragic tune triggered by burning houses makes her now wonder about the ill-fated families losing their lifetime of means and memories in a jiffy.

"These frequent fire incidents remind me of my own misfortune," the woeful homemaker says. "They remind me of a life

filled with loss and agony.' As the valley is witnessing frequent fire incidents at the moment, the victims are talking about the raging disaster. One such tragedy reflects from the lanes of Gata colony in Srinagar's Noorbagh area.

Following the midnight blaze that damaged 22 houses in March 2022, the families lost everything that they had bought, saved, decorated, amassed in their lives. "At about 1:45 at night," recalls Bilal Sheikh, an inmate of the colony, "my wife's screams woke all of us. From the



window, I saw flames erupting. At that moment, I only tried to save my family.

Apart from clothes, beddings and utensils, these families lost important documents and

certificates of their children. 'I had also bought some wedding gold and items for my two daughters," Bilal says. "The calamity consumed everything." The inferno-type fire was sparked by a short circuit in Sheeraza Akhtar's house. By the time her family woke up, their two rooms had already become furnace. low freezing point at most places in Jammu and Kashmir, but stayed well above it in Srinagar and Kupwara, even as another western disturbance is expected to hit the Valley later this week, officials said on Tuesday.

Srinagar recorded a low of 1.8 degrees Celsius Monday night, up from 0.9 degrees the night before, they said. Qazigund, the gateway to the Valley, registered a minimum of minus 0.8 degrees Celsius, while Kokernag in south Kashmir recorded a low of minus 3.6 degrees, the officials said. The mercury in Kupwara, a frontier district, settled above the freezing point at a low of 2.7 degrees. The tourist resort town of Pahalgam in Anantnag district, which also serves as a base camp for the annual Amarnath Yatra, registered a low of minus 3.2 degrees Celsius – down from minus 0.7 degrees.

The minimum temperature in Gulmarg in Baramulla district was at minus 4.4 degrees Celsius, they said.

The day temperature across the Valley remained low for the second consecutive day as the mercury failed to breach the 10 degree Celsius-mark at all the weather stations.

Meanwhile, the MeT office said moderate snowfall is very likely at many places over the higher reaches. The plains in the Valley are expected to receive light to moderate snow. Light snowfall, with rains in plains of Jammu, is likely at many places in J-K, it said.

While the weather will stay cloudy on Tuesday and Wednesday, widespread moderate snowfall with rains in plains of Jammu and heavy snowfall over the higher reaches, is possible over two days after that, the weatherman said.

Kashmir is currently under the grip of 'Chillai Kalan', the 40-day harshest weather period when the chances of snowfall are maximum and most frequent.

Chillai Kalan begins on December 21 and ends on January 30. The cold wave continues even after that with a 20-day-long 'Chillai Khurd' (small cold) and a 10-day-long 'Chillai Bachha' (baby cold) following it.

....Attack Aftermath **50 Held In Rajouri As Searches Intensified**

Jammu: Over 50 people have been detained so far for questioning in connection with the attack on the minority community in Jammu and Kashmir's Dhangri village even as a massive search operation to track down the terrorists behind the strike continued on the ninth day on Tuesday, officials said.

Seven persons were killed and 14 others injured in the terrorist attack on January 1.

Following the attack, the administration strengthened Village Defence Guards (VDGs) comprising local volunteers and the border grid to keep a tight vigil on possible infiltration routes, the officials said.

They said police posters announcing a reward of Rs 10 lakh to anyone giving credible information about the terrorists have also come up at various places in the district.

A joint cordon and search



operation by the Army, police and CRPF is in progress at over two dozen villages where there were reports of terrorist presence before the attack, the officials said, adding special op-erational teams of Jammu and Kashmir police, moved from outside Rajouri, have also been deployed at designated locations.

Shehla Rashid In Tweet Trouble **Delhi LG Grants Sanction To Prosecute Former**

JNUSU Vice President For Tweets About Army

New Delhi: Delhi Lieutenant Governor V K Saxena has granted sanction to prosecute former JNUSU vice president Shehla Rashid Shora for her three year old tweets on the Indian Army, officials said on Tuesday.

According to officials at the LG office, the sanction is related to a 2019 FIR registered against her under IPC section 153A at Special Cell police station here on the basis of a complaint by an advocate Alakh Alok Srivastava. They said the sanction has been granted under section 196 of CrPC, 1973 which relates to

prosecution for offences against the State and for criminal conspiracy to commit such offence. "Section 196 1(a) says no

court shall take cognisance of any offence punishable under

Chapter VI or under section 153A, of Indian Penal Code ... except with the previous sanction of the Central government or of the state government," the L-G office said.

According to the officials, the former Jawaharlal Nehru University Students' Union (JNUSU) leader is accused of promoting enmity between different groups and indulging in acts prejudicial to maintenance of harmony through her tweets. The tweets by Shehla, dated August 18, 2019, had accused the Army of entering houses and 'torturing" locals in Kashmir.

The allegations were rejected by the Army as baseless.

'Biodiversity Of Large Urban Parks Affected By Surrounding Green Area'

cientists have found that biodiversity in large parks in urban environments can be affected by surrounding, smaller green areas.

The researchers from Tokyo Metropolitan University, Japan, surveyed two insect families inhabiting large parks in the Tokyo Metropolitan Area, one more mobile than the other, the study said.

According to the study, led by Associate Professor Takeshi Osawa, the more mobile family seemed to

The team characterized the quality of surrounding urban areas as habitats, using satellite data to gauge how smaller green spaces make the matrix either hospitable or inhospitable, the study said.

Through detailed surveys looking at each of the taxa found in traps, they were able to quantify both their abundance and the number of discernible species, the study said.

For Heteroptera, they found that both the number of species and individuals caught were correlated with the area of

benefit from surrounding areas, while the less mobile species did not.

The work highlights the importance of managing smaller areas in maintaining biodiversity, the study said.

Prominent green spaces in urban centres provide habitats for local wildlife and are vital to maintaining biodiversity.

However, that doesn't mean other areas are devoid of life: for example, such spaces are often surrounded by smaller, fragmented patches of green like gar-dens and roadsides which form a "hospitable matrix" surrounding the central park or grassland, the study said.

Though the composition and area of parks themselves are often the focus of studies, surrounding areas are often described as an impenetrable "sea" surrounding the central "island". Their impact on biodiversity remains to be addressed, the study said.

The scientists focused on two insect taxa, Carabidae, or the ground beetle, and Heteroptera. Heterop-tera can fly over long distances and are thus able to travel more and spread to the matrix, the study said.

This is direct evidence for how biodiversity may be affected by a network of smaller green spaces surrounding the main "island". On the other hand, they noticed that the diversity of Carabidae was unaffected, the study said.

In fact, the number of Carabidae caught was actually negatively correlated with surrounding green spaces. They believe this to be due to predators us-ing the hospitable matrix to access the central park area and present a threat to the beetles, the study said.

The team's work highlights the importance and often neglected role of fragmented green small, spaces in an urban environment which extends hospitable area for wildlife in parks and other prominent green spaces, effectively forming a larger "concealed island in the urban sea", the study said.

The scientists hope that these findings inform effec-tive conservation strategies

Women Work Harder Than Men, Finds **Anthropological Study In Rural China**

or most people around the world, physical work takes up a great amount of time and energy every day. But what determines whether it is men or

women who are working harder in households? In most hunter-gatherer societies, men are the hunters and women are the gatherers – with men

seemingly walking the furthest. But what's the labour breakdown in other societies? We carried out a study of farming and herding groups in the Tibetan borderlands in rural China – an area

with huge cultural diversity - to uncover which factors actually determine who works the hardest in a household, and why. Our results, published in Current Biology, shed light on the gender division of work across many different kinds of society. The majority of adults across the

world are married. Marriage is a contract, so one might expect roughly equal costs and benefits from the union for both parties. But unequal bargaining power in a household such as one person threatening di-vorce – can lead to unequal contributions to the partnership.

Leaving home

We decided to test the hypothesis that leaving your natal area after heterosexual marriage to live with your spouse's family may contribute to a higher level of workload. In such marriages, the new person typically isn't related to, and doesn't share a history with, anyone in their new household. Without blood relatives around them, they might therefore be at a disadvantage when it comes to bargaining power.

The most common form of marriage around the world is where women are the "dispersers", leaving their native home, while men stay with their families in their natal area. This is known as patrilocality.

The Conversation logo

Neolocality – in which both sexes disperse at marriage, and the couple lives in a new place away from both their families - is another common practice in many parts of the world. Matrilocality – where women stay in the natal family and men move to live with the wife and her family – is quite rare. And duolocality – where neither sex leaves home and husband and wife live apart – is very rarely seen. Luckily, in the diverse Tibetan

borderlands, all four of these different dispersal patterns can be found across various different ethnic groups.

Our study focused on rural villages from six different ethnic cultures. With our collaborators from Lanzhou University in China, we inter-viewed more than 500 people about their dispersal status after marriage, and invited them to wear an activity tracker (like a fitbit) to assess their workloads.

Our first finding was that women worked much harder than men, and contributed most of the fruits of this labour to their families. This was evidenced both by their own reports of how much they worked and by their activity trackers.

sure or social activities, or just hanging around and resting.

This may be partly because women are, on average, physically weaker than men, and may thus have reduced bargaining power. But we also found that individuals (be they male or female) who disperse at marriage to live away from their kin have higher workloads than those who stay with their natal families.

So if you are female and move away from home at marriage (as most women do throughout the world), you suffer not just in terms of missing your own family but also in terms of workload. When both sexes disperse and no one lives with their natal families, both sexes work hard (as there is little help from kin) - but the woman still works harder. According to our study, perfect sex equality in workload only occurs in instances where men disperse and women do not.

These results help us to understand why women globally disperse, but men generally do not. Dispersal is especially bad for men - adding about 2,000 more steps per day to their step count, but only adding about 1,000 steps per day for women.

Time and energy spent on farm-ing, herding and housework com-petes with free time. So substantial labour contribution to households in these rural areas can result in less time spent on rest. From an evolutionary view, giving up rest isn't favourable unless it contributes to higher fitness – such as enhancing offspring survival.

KU Advertises Six Administrative Positions

Academicians Welcome Move

Agencies

Srinagar: The Kashmir University (KU) authorities on Tuesday put several administrative positions including Registrar and Director IT to advertisement. The advertisement comes days after it was reported how temporary arrangement to these posts was promoting favoritism and monopoly.

Sources said that the decision to advertise these posts was taken after the Vice Chancellor Dr. Neelofar Khan passed instructions to immediately advertise these posts so that the same are filled up through proper channels.

'Some officers were trying to sabotage the advertisement and get it delayed to continue with the temporary arrangement but the VC pulled up the officers and ordered that the advertisement be issued without any delay," the sources added.

The advertised posts (all Tenure Positions) include Registrar Main Campus, Librarian Allama Iqbal Library, Director Directorate of Physical Education and Sports, Director Information Technology and Support System, Director North Campus Baramulla and Director Institute of Technology, Zakura.

The appointment to the post of Registrar shall be tenure basis for a period of three years and to other tenure posts for a period of five years, as per the Brief Advertisement Notice No.1 of 2023 Dated 10/01/2023

The Advertisement Notice mentions that the age of applicants should preferably be not more than 57 years for the post of Registrar and Librarian, while it will be 55 years for other posts.

The date for submission of online form/hard copy starts from January 16.

It was reported several times in the last seven months that the University authorities were allegedly promot-

ing favoritism on important administrative positions by not putting these positions to proper advertisement.

The three year tenure of In-Charge Registrar Dr Nisar had ended last year in January 2022 and was awaiting proper advertisement since then. Academicians of the University had alleged that the Registrar was continuing without any formal orders on continuation. The post of Director IT

has been held for the last more than six years by one Scientist allegedly owing to his proximity with the administration. The In-Charge Director has not been rotated for six years in total violation of the University's own three year rotation policy for all HOD's and Directors.

The Scientist has faced serious allegations related to his Ph.D Degree and grant of huge sums of money in lakhs as medical reimbursement to his late mother's treatment allegedly in violation of reim-

bursement rules. Sources said an inquiry is underway to ascertain the complaints made against the accused Scientist.

The academicians of KU have welcomed the Advertisement Notice and demanded that the process of recruitment should be fast-tracked.

"We appreciate the VC for opposing the forces who were opposing the Advertisement for the last six months," said an academician wishing anonymity.

The academicians have however demanded that the VC should immediately remove incumbent officials holding the advertised posts so that there is no favoritism in the recruitment process.

"If any of these officials happens to be an applicant for any of the posts, then the whole process will be doubtful from the beginning," they said, adding that if these officials do not intend to apply, then they should furnish an undertaking before the VC that they will not apply for any of the positions—(KNO)



4 CRPF Jawans Shot Dead By Colleagues

RINAGAR-: In a bizzare incident four personnel of Central Reserve Police Force were gunned down by their own colleagues at the Meteorological Station in Barzulla early today. Two more CRPF personnel were injured.

Reports said that at around four in the morning, the personnel of 87th battalion of the CRPF returned to the complex after finishing their night duty. Official sources said that their colleagues inside the complex mistook their entry as a militant raid and opened fire. Four Jawans were killed on the spot and two more were wounded critically, sources said. KPS however quoting official sources said a group of unidentified gunmen sneaked into the sub-headquarters of the CRPF hurling grenades and firing indiscriminately causing the death of four personnel. The news agency said the assailants escaped under the cover of darkness.

Inspector General of CRPF A Joshi however ruled out the hand of militants in the incident and said that the incident was a result of mistaken identity. He said a team headed by an officer of the rank of DIG has been constituted to investigate the matter. The dead have been identified as Head Constable K K Pandey, Man Singh, K S Budhe and Bupinder Ram. The injured CRPF personnel have been identified as B P Pai and Dinesh Singh.

CNS quoting defence experts has said that the tremendous pressure on security personnel was building up in the wake of Fidayeen attacks on security camps. Today's incident is indicative of the mounting psychological strain upon the security personnel.

Coping With Winter

he temperature in Kashmir Valley is experiencing a steep drop as we get to the middle of Chillai Kalan, the harshest 40day period of winter in Kashmir. Currently, the nighttime temperature goes below freezing point. The temperature at high altitude areas goes further down. Although the vision in Srinagar is still limited by the fog, recent days have been clearer and sunnier.

This is true that winter in Kashmir is a big draw for tourists from mainland India, more so in Chillai Kalan, which is generally associated with extreme cold and snowfall, a novelty for the rest of the country. Chilla Kalan has in the process acquired a certain cultural resonance. The period has also become a familiar fixture in the Valley's tourism calendar. It features in all tourism adverts which promise a picturesque snow-covered valley to prospective tourists.

But while tourists find the winter scenery enchanting, and are excited by the novelty of living in a much colder climate, what about Kashmiris? They have more practical concerns, as Chillai Kalan is a dreary and tedious part of their quotidian lives. They cannot be happy about the extended extreme cold season because, with it, their businesses suffer and the food supply becomes uncertain with the frequent closure of Jammu-Srinagar highway. The most pressing of all the issues is the power shortage, more so, in rural areas. Power breakdowns are also common, which bring mundane, everyday hardships in its train.

Winter in Kashmir may be quaint and idyllic, it also means harsh living conditions And the erratic electricity only aggravates this fact. Compared to past winters, nothing has changed for the better on the ground. In fact, in some aspects, the situation is only worse off. The power supply has reduced to a trickle in parts of the Valley, with long unscheduled power cuts the order of the day - albeit, in some urban areas including the situation on power front has been relatively better.

The debate about power in Valley, however, doesn't stop with the availability of the electricity through winter. It is a much larger debate about the inability of the successive governments to meet the domestic demand for power out of the region's own water resources. The issue is simple and it is this: we are a region that exports electricity but purchases power at a hefty cost for its own consumption. This necessitates the government to plan and take action to ensure that we have enough electricity for the winter, if not in the immediate to medium term, then at least in the long term.





Russia, Turkiye and UAE have initiated plans to start talks with Basher Al-Assad, an unthinkable step till date, and establish peace once again in war torn Syria.

It seems as if the pariah of the Arab world, Bashar Al-Assad, may soon get a reprieve, as the global and regional powers rally together to forgive him and try to bolster his regime. The latest efforts may also result in further weakening of the US influence in the region.

Turkish efforts

This change in Turkish stand is sponsored by Assad's major military ally Russia and the UAE, which have sought to improve Assad's standing in the Middle East to help balance Iranian influence in Syria.

Whereas several years ago, countries in the region would have looked at such a rapprochement negatively, they are now supportive and that may be construed as an important shift.

Events of the last week report that regional players Turkiye and UAE, in partnership with global player Russia have initiated diplomatic efforts to rehabilitate Syria's President Bashar al-Assad, and try to find an end to the decade-old war in Syria

Turkiye, which previously backed the 2011 rebellion against Assad, is now prepared to publicly recognise his rule over Syria and work to rebuild diplomatic, security and trade ties, in a complete about turn, in order to ensure peace on its southwestern border.

Basically, Turkiye wants Assad to rule out allowing the US-backed Kurdish dominated, People's Defence Units or People's Protection Units (YPG), to form an autonomous area in northern parts of the country that they currently control, as part of any future peace agreement, if the Turkish President Recep Tayyip Erdogan restarts any reconciliatory process.

Reports say that Erdogan floated the idea of meeting with Assad as recently as last Thursday, after high-level meetings between Syrian and Turkish officials earlier in Moscow. Erdogan has been reported as saying that, we will come together as leaders according to the developments, hinting at a meeting with Assad and Putin, soon.

Turkiye has lately indicated that it was preparing to put aside hostilities with neighbouring Syria. Frustrated by Washington's refusal to end military assistance to Kurdish militia in Syria, Turkish President Recep Tayyip Erdogan is seeking to resolve the matter through other brokers in the conflict.

yria's uprising quickly morphed into an international conflict drawing in Russia, Iran, Turkiye and the US and reverberating across the Middle East and Europe. Assad remains under US and European sanctions over the war, which according to UN estimates has killed more than 350,000 civilians.

US Response

Reportedly, the US is 'Very Concerned' about possible Turkish meddling in Syria. US State Department spokesperson Ned Price when asked last week, about a potential Erdogan-Assad meeting said that the US will not normalise and we do not support other countries normalising relations with the Assad regime.

But there are voices in the region that the US needs to understand that its presence in Syria is unnecessary and unjustified and further, countries in the region are increasingly acting independently of the US.

The YPG and allied fighters in northern areas of Syria bordering Turkiye are supported by the United States and estimated to control roughly a third of Syria's territory. Ankara views the YPG as a threat due to its ties to an outlawed Kurdish group, which has sought self-rule in Turkiye for decades. The Syrian government also opposes any form of eventual Kurdish autonomy in Syria.

It seems as if the

Erdogan has repeatedly warned of a Turkish incursion in northern Syria to push back the YPG, something the US has said could embolden Islamic State militants and other hardline fighters still present there.

Earlier, the Defence Ministers from Turkiye and Syria met for the first time in December last year since the civil war erupted in the Arab state in 2011, the high point so far in a rapprochement that's been months in the making.

Turkiye's Hulusi Akar and his Syrian counterpart Ali Mahmoud Abbas held talks at a summit in Moscow, hosted by the Russian Defence Minister Sergei Shoigu.

The discussions then had focused on the Syrian civil war and collaboration against 'all terrorist groups' in the Middle East state, Turkiye said, in a thinly veiled reference to Kurdish militia in Syria.

Erdogan's Gain

A political deal with Assad could help Erdogan claim a victory against the YPG without risking a military operation and greater US ire, the people said, adding that Russian and Turkish troops are expected to start joint patrols along border areas with northern Syria soon. Syria could also start coordinated patrols in the future there.

Syria remains under strict Western sanctions and is suspended from the Arab League. Improved relations between Turkiye and Syria will be a major success for Russia.

Ankara's new partnership with Damascus will strengthen the Kremlin's role in the Middle East and put pressure on Washington to pull out its remaining foothold in Syria.

Ghulam Nabi Azad's party undone

he last election for the J&K legislative assembly was in 2014. The Assembly was dissolved in November 2019, months after the BJP pulled out of the PDP-led ruling alliance and the government fell. The dissolution was controversial, and as it turned out, a precursor to the August 5, 2019 revocation of special status and division of the state into two Union Territories. It ensured that no elected government would be in place at that time to oppose or argue with the constitutional changes. The Centre's decision to jail political leaders of the main regional parties to prevent them from mobilising against the August 5 decisions deepened the political vacuum.

A new political tier was inserted by holding elections for the District Development Council. Delhi's attempt seemed to be to create a new political class, and wear down the established political parties in the Valley. The coming together of the National Conference, PDP, CPM, J&K People's Conference and a few other parties for the DDC elections posed a new challenge for the Centre. The alliance showed that the old regional parties still had a following. Against this background, the arrival of the DAP suggested the possibility of an election in the offing. The revision of electoral rolls after the completion of the delimitation exercise also pointed in this direction. However, it seems now that the next testing ground may be the J&K panchayat elections in 2023. An indication of this came with the State Election Commission's order to officials to update the panchayat election rolls. The results could provide a hint of whether and when the Assembly elections might be held in the new year.

The delay in holding assembly elections in J&K is unconscionable especially as the government repeatedly declares that the security situation is under control. It encourages the impression that it is Delhi's inability to turn the political climate in the Union Territory in a desirable direction that is causing the delay. The churn in the DAP, with exits of several Jammu region stalwarts — now it appears to be a party of the Chenab Valley only — who had left the Congress to join Azad, is comparable only to the high levels of discontent in the BJP's Jammu unit. Who else will leave Azad might become apparent when the Bharat Jodo Yatra reaches Jammu in the new year.

had originally proposed Turkiye repair ties with Assad last year during a meeting with Erdogan in Sochi. Now Erdogan has warmed to such a deal as he heads into elections this summer, the people said, as he seeks to use foreign policy to bolster his popularity at home.

Erdogan has asked Russia to ensure the safety of Syrian refugees who could return home as fighting eases. He wants to ease the political and economic cost of hosting the world's largest refugee population, or some 3.5 million people according to UN estimates. Pushing for a return, or the start of one, may help boost his popularity ahead of elections.

Al Is Getting Creative And Feels More Human

rtificial Intelligence (AI) is no longer the shiny new tech. The tech stream is past its sloshy beginnings and is arduously winding its way through complexities. Investors have become picky about funding AI startups. Despite the tightening purse strings, AI had its moments in 2022. It was a year of small but noteworthy breakthroughs. AI entered the phase in a technology growth trajectory when the focus is on performance and accuracy. The technology is simply trying to get better at what it started out to do.

In 2022, AI got better at generating original text, summarizing a lengthy piece of writing, giving more coherent answers. OpenAI's ChatGPT became rather eloquent at answering questions, having trained on large transformer-based language models that specialize in conversations. In essence, AI made itself useful for specific outputs like college essays.

The breakthrough technology in 2022 was Generative AI, producing impressive text, images and videos based on text prompts. OpenAI launched DALL-E 2, the most prominent among the text-to-art image generators. It connects written text to concepts, to produce images that are more realistic than their predecessors. Google and Meta gave us models that generate videos from text. Startups like Midjourney and NightCafe began challenging bigger rivals with their text-to-art tool. Stock-photo service providers incorporated image-generation models.

The fast-evolving diffusion model became the poster child for Generative AI, eclipsing the older genera-

tive adversarial networks (GANs). The model is based on thermodynamic principles. It progressively adds random noise to training data and then learns to reverse the process to remove the noise and rebuild clean data. New research improved the ability to predict what comes next in computer vision to rapidly generate videos after being trained on a video of At the source mo forms like

on a video dataset. At the same time, the opensource movement in AI by platforms like Hugging Face stimulated

forms like Hugging Face stimulated fainnovation. Stable Al's community-

based opensource model, Stability Diffusion allowed startups to build Generative AI tools for new kinds of content and art.

All this will broaden the scope of the Creator Economy in 2023. Generative AI has certainly lowered the barriers of our imagination. We can, in minutes, give shape to any concept our brain conjures. Generative AI startups are providing tools that will improve storytelling and brainstorming, write software code, find datapoints, write copy for ads, produce content for legal services, create new music and videos. New tools will make the best of our emails and presentation decks seem old and boring.

Yet there are limits to this rather seductive vision of AI. In 2022, AI felt more human, with flaws and all. While large language models improved, they got confident, even when they were wrong. Meta's Galactica, showed a high level of confidence, even for the very obvious false information. It is bad enough to be wrong. But being wrong and confident is a bigger problem and frankly annoying. Despite an extensive application of reinforcement learning against biases, it showed basic ones like preferring white male scientists.

We are now faced with the prospects of a vicious cycle of AI getting trained on Internet junk, and AI responses getting added to it, which then gets scraped again and used as training data. But why blame AI. It is trained on the information we put out there. Information by experts available online is written in an authoritative tone of voice. So, AI adopted a similar tone when mixing facts with fiction.

The improvement in the accu-

racy of confidence level will make Al generated text more palatable. Accomplished economists and scientists tend to have a good understanding of how much they don't know. They caution against the completeness of their own understanding, offer a caveat, or multiple plausible answers.

While purists worry about AI taking over our creative domain, futurists envision new frontiers of human creativity. The mundane parts of an artist's work, termed as creative labour, will be taken up by a machine. Freelance graphics designers, photographers and creators will reinvent their work. DALL-E 2 offers the paintbrush feature for users to add their own touch to AI generated images, making them more complex with multiple layers.

Generative AI is quickly getting embedded in design services like Canva and Figma. AI-generated essays, stories, poems or plain answers can be edited by users, thus saving time for a deeper analysis. Generative AI will make not just creators but all of us more productive in 2023.

Despite these risks, once the revenue model for Generative AI is fleshed out, we will experience its deeper influence in our digital lives. In 2010s, smartphone camera set off a chain of innovation, which led us to selfies, stories, and reels, spawning new occupations, and radically changing our society. Just as smartphone cameras made photographers out of everyone, innovation in Generative AI will make creators out of everyone.

ON NATIONAL HUMAN TRAFFICKING AWARENESS DAY

'LURED FOR JOB' Inside Kashmir's Child Trafficking Network

Rohan was brought to Kashmir with the promise of a high paying job. But little did he know that he would end up as a household worker in southern Kashmir's Pulwama area.

Before his unwitting valley visit, the minor was living in an ashram in Assam, where he used to work at weddings to earn his livelihood.

One day while returning from a wedding at night, he met a person who asked him if he wanted to earn more money. Rohan who had no one in his family except his little sister decided to go with the man in search of work.

Exhausted by the work, he slept on the train, unknown of the place the man was taking him. When he woke up he was on his way to Jammu.

"Rohan was brought to Pulwama through a consultancy firm who told us that he was an adult," said Tawseef Ahmad Ganai, a member of Child Welfare Committee (CWC), Pulwama.

When Ganai got information about Rohan, he alerted the District Child Protection Unit (DCPO) who gave the boy's custody to the CWC.

On examination, it was found out that Rohan was a student of 8th class, when brought to Kashmir— "meaning that he was around 13 years old," said Ganai.

The consultancy firm was given a warning and since then it is under the scanner of the CWC, Ganai told Kashmir Observer.

People believe that there is no human trafficking in Jammu & Kashmir, but they're wrong, said Mohammad Sharif Bhat, J&K and Ladakh head of NGO, Save the Children. "I've seen many people having minor non-Kashmiri servants in their homes," he said.

Three years ago, Bhat came across a minor girl from Kolkata who was found on a farm in northern Kashmir's Kupwara district. Alerted by the Information District Social Welfare Officer, the NGO soon rescued



"I took her to the hospital and mit

informed the concerned authorities," said Bhat. "It was later found out that the girl was suffering from tuberculosis."

As per the records of Save the Children, a majority of minors are trafficked to Kashmir from Jharkhand. However, according to a study by National Crime Records Bureau (NCRB) in 2019, most incidents of children missing are reported from Madhya Pradesh, West Bengal, Delhi and Bihar.

The common causes of trafficking were forced marriages, child labour, domestic help and sexual exploitation, among others, mentioned the study.

As per the data of 2011 Census, India had 10.13 million child labourers, between the age of 5-14, with Uttar Pradesh, Bihar, Rajasthan, Maharashtra and Madhya Pradesh being the most affected states. Kashmir receives many minors through consultancy firms who are employed as house workers.

A majority of such helpers are employed in Srinagar, said Farooq Ahmad, a Srinagar CWC member. Minor girls exceed boys in the city, he added, and their number is only increasing.

Recently, Farooq came across two-three minors who were brought to the valley through consultancy agencies. One of them was a minor girl from West Bengal whose mother had died and her father, a drunkard, sold her to the agency which brought her to Kashmir, Farooq told Kashmir Observer.

Due to the pandemic, the minor girl was kept at a shelter in Srinagar for some time, before sent to the West Bengal CWC. However, the condition in other districts of Kashmir is relatively better. According to Fahmeeda Maqbool, Chairperson CWC Ganderbal, the number of cases of non-Kashmiri minor helpers is quite less in her district.

On being asked how the CWC handles such cases, Maqbool said that at first the date of birth is checked and if it does not comply with the Child Labour (Prohibition and Regulation) Act 1986, the child is taken under the care of CWC, and strict action is taken against the offender.

The Child Labour (Prohibition and Regulation) Act 1986 prohibits employing children below 14 and 15 years, but there is no procedure laid down in any law for deciding in which employment children are banned.

The Act was first amended in 2016, a n d then again in 2017. The current Act prohibits the employment of children below the age of 14, but they can work in family business/ enterprises, only if they are nonhazardous.

Advocate Shah Faisal, J&K director of Human Right Law Network (HRLN), told Kashmir Observer that he comes across numerous cases of minors being held by people without their will.

"There was this case of a child from West Bengal who wanted to go back home but the household where he was working didn't let him leave," Faisal said.

"After I filed a complaint against the family to the Chief Magistrate, the child was brought immediately and proper action was taken against the family."

Another case which the advocate recalled is of a 15-year-old Rohingya girl who was sold in Delhi at Rs 70,000 to a Kashmiri, who married her soon after arriving in the valley.

The girl's uncle contacted Faisal and a writ petition was filed to rescue her.

According to the advocate, the consultancy agencies which bring minors to Kashmir violate

many norms. They provide a fake list, filled with fake numbers of parents of the minors, Faisal said. "While most of the agencies claim that the child does not have a birth certificate, they consider them above 18."

Even the families hiring minor helpers justify themselves by saying that without their assistance the child would starve, he said.

"But money paid by the families is not paid to the minor but to their agents," asserted the advocate. "This is totally an inhuman act which should be tackled strongly."

Delhi Logs 50 Hours Of Dense Fog In January, Highest Since 2019: IMD

New Delhi: Delhi saw around 50 hours of dense fog in January so far, the maximum in the month since 2019, a senior India Meteorological Department (IMD) official said on Tuesday.

Senior IMD scientist R K Jenamani also said the cold wave spell in Delhi in January this year was the longest in a decade.

"Delhi recorded a minimum temperature equal to or less than 4 degrees Celsius on 7 days (January 3 to January 9) in 2013, with the lowest minimum temperature of 1.9 degrees Celsius on January 6," he said.

This year, the national capital recorded a cold wave spell from January 5 to January 9, with the lowest minimum temperature of 1.9 degrees Celsius on January 8, according to the IMD data.

"Delhi has recorded around 50 hours of dense fog this month so far, which is the highest since 2019," Jenamani said.

The senior meteorologist attributed the long spell of intense cold to a large gap between two western disturbances, which meant frosty winds from the snow-clad mountains blew in for a longer-than-usual period. The city has recorded below-

normal maximum temperatures this month so far due to dense fog that reduced sunshine hours. Low day temperatures mean

early cooling and early fog

formation in the evening, he said.

The Safdarjung observatory had logged a minimum temperature of 3.8 degrees Celsius on Monday, 1.9 degrees Celsius on Sunday, 2.2 degrees Celsius on Saturday, 4 degrees Celsius on Friday and 3 degrees Celsius on Thursday.

Monday was also the fifth consecutive day that Delhi's minimum temperature was lower than most hill stations in Himachal Pradesh and Uttarakhand.

Chilly weather in Delhi since the start of January strained power grids and posed challenges to homeless people. It also prompted the Delhi government to extend winter vacations in schools till January 15.

According to the weather office, 'very dense fog' is when visibility is between 0 and 50 metres, and between 51 and 200 metres, it is 'dense', between 201 and 500 metres 'moderate', and between 501 and 1,000 metres 'shallow'.

In the plains, the MeT office declares a cold wave if the minimum temperature dips to 4 degrees Celsius or when it is 10 degrees Celsius and 4.5 notches below normal.

A severe cold wave is when the minimum temperature dips to 2 degrees Celsius or the departure from the normal limits is by more than 6.4 notches.

Muslims Must Abandon 'Boisterous Rhetoric Of Supremacy': Mohan Bhagwat

New Delhi: Muslims have nothing to fear in India, but they must abandon their "boisterous rhetoric of supremacy", RSS chief Mohan Bhagwat has said.

In an interview to Organiser and Panchjanya, Bhagwat also spoke in support of the LGBT community, saying that they too should have their own private space and the Sangh will have to promote this view.

"People with such proclivities have always been there; for as long as humans have existed... This is biological, a mode of life. We want them to have their own private space and to feel that they, too, are a part of the society. This is such a simple issue. We will have to promote this view because all other ways of resolving it will be futile," he said. Bhagwat said the newfound aggression among Hindus the world over was

due to an awakening in the society that has been at war for over 1,000 years. "You see, Hindu society has been at war for over 1,000

years this fight has been going on against foreign aggressions, foreign influences and foreign conspiracies. Sangh has offered its support to this cause, so have others. There are many who have spoken about it. And it is because of all these that the Hindu society has awakened. It is but natural for those at war to be aggressive," Bhagwat said.

The Rashtriya Swayamsevak Sangh (RSS) chief said India has been undivided (akhand) from the earliest times of recorded history, but was divided whenever the core Hindu sense was forgotten.

"Hindu is our identity, our nationality, our civilisational trait a trait that considers everyone as ours; that takes everyone along. We never say, mine is only true and yours is false. You are right at your place, I am right at mine; why to fight, let us move together this is Hindutva," Bhagwat said.

"The simple truth is this Hindusthan should remain Hindusthan. There is no harm to the Muslims living today in Bharat... Islam has nothing to fear. But at the same time, Muslims must abandon their boisterous rhetoric of supremacy. We are of an exalted race; we once ruled over this land, and shall rule it again; only our path is right, rest everyone is wrong; we are different, therefore we will continue to be so; we cannot live together they (Muslims) must abandon this narrative. In fact, all those who live here whether a Hindu or a

communist must give up this logic," the RSS chief said.

On the RSS' engagement with political issues despite being a cultural organisation, Bhagwat said the Sangh has consciously kept itself away from day-to-day politics but always engaged with politics that affect "our national policies, national interest and Hindu interest".

"The only difference is, earlier our Swayamsevaks were not in positions of political power. This is the only addition in the present situation. But people forget that it is the Swayamsevaks who have reached certain political positions through a political party. Sangh continues to organise the society for the organisation's sake," he said

"However, whatever Swayamsevaks do in politics, Sangh is held accountable for the same. Even if we are not implicated directly by others, there is certainly some accountability as ultimately it is in the Sangh where Swayamsevaks are trained. Therefore, we are forced to think what should be our relationship, which things we should pursue (in the national interest) with due diligence," he said.

Bhagwat recalled that the Sangh was earlier seen with contempt, but those days were now over.

Pakistan's Election Commission issues arrest warrants for Imran Khan

Islamabad: Pakistan's top election body on Tuesday issued bailable arrest warrants for former prime minister Imran Khan and other top leaders of his party in a contempt case.

The case is based on statements issued by top Pakistan Tehreek-e-Insaf leaders against the Election Commission of Pakistan (ECP) and Chief Election Commissioner Sikander Sultan Raja.

A four-member ECP bench headed by Nisar Durrani issued warrants against Khan and his close aides - Fawad Chaudhry and Asad Umar.

The election watchdog had issued notices against them in August and September last year in the exercise of its powers of contempt after the Pakistan Tehreek-e-Insaf (PTI) leaders repeatedly bashed the commission and Raja over what they claim is their partisan policy and their alleged favouring of Pakistan Muslim League

ing of Pakistan Muslim League-Nawaz (PML-N). At the previous hearing, the ECP had given the PTI leaders a last chance to appear before it.

During the hearing on Tuesday, the commission rejected the pleas for their exemption from appearance and issued arrest warrants against surety bonds worth Rs 50,000 each. hearing till January 17. Khan has been asking the ECP chief to resign for allegedly failing to play the role of a neutral election commissioner. The chief rejected the calls by asserting he was working as

per law. The senior leaders of Khan's party expressed their dismay and anger at the move.

Chaudhry and Umar, whose arrest warrants were also issued along with Khan, termed the ECP order as biased.

"The ECP's decision to issue a bailable warrant is an insult to the high court's decision," Chaudhry tweeted.

"The case had been fixed for January 17, which was moved up to today against the rules and the case was decided," he claimed and added that it was "yet another biased decision" by the ECP members.

He asserted that the PTI leaders would "pursue a contempt of court case against this decision in the high court".

Umar, who is PTI secretary general, reminded the electoral body to focus on its primary responsibilities instead.

"They are engaged in these tasks instead of conducting elections," he said.

Umar also said that "they are themselves in contempt of court for not having conducted Islamabad [local body] elections."

dreadful blaze, most of the survivors couldn't manage living. Almost all of them are dailywagers in the municipality on a monthly salary of Rs. 6,500. "My father had to avail a loan from his pension to support our family," Bilal says. "We're now finding it hard to repay that. My mother who has had 19 operations in past lost her oxygen machines in the fire. They're very expensive. I'm not able to afford the life support for her."

The tragedy has even affected the colony's mental health as most of the inmates are now availing treatment and therapy for depression, trauma and anger issues. "The tragedy has made me frustrated," Bilal continues to voice his anguish. "My pleas for help went unnoticed. Barring Rs 50,000 from neighbors and 1 lakh from government, I wasn't able to get any help. My paltry salary is not even enough to run home and repay our loan. Due to inflation, a rice bag now costs Rs. 1000. I've no idea what to do now."

The same trauma is troubling Fatima Bilal. Before the incident, this 17-year-old girl would teach some 40 kids of her locality. But after losing her home, she's now facing space constraints. "There're just two rooms now and my family stays in them," Fatima says. "I don't find any calm place at my house to teach these kids.' For the family of Mehvish, an 11-year-old handicapped girl living in the colony, the going is even getting tougher. They had bought a motorcycle to take this specially-abled girl to doctor every week. But the fire rendered it a mere scalded scrap. The family stayed at a marriage hall with no basic facilities for three months after the tragedy. They had no money for the medical treatment of their daughter. It worsened her condition. "She began screaming aloud for no reason," Mehvish's mother recalls. "Everyone used to get intimidated by that. Unavailability of medicines undid her entire treatment." Even schoolchildren were deeply affected by the incident. Sheeraza recounts how her sevenyear-old son, Sabran, lost his books, uniform, clothes and toys in the fire incident. "He was unable to go to school for three months after the incident," the woebegone mother says. "His school eventually gave him bag and books, but closed gates for him due to his casual dressing. We couldn't afford his uniform for which he was bullied by his schoolmates. Back home, his relentless queries on our new home would leave all of us heartbroken. He used to sit in a corner in the marriage hall and not talk to anyone." Some of these victims even lost their loved ones in the tragedy. Shakeela, a homemaker, recalls how her teen daughter, Asmat Bashir, died after coming under her burnt home's collapsed wall. "She was my youngest child and only daughter," the mother laments. "I don't worry about anything that happened to our house due to fire, but my daughter's death has left me shattered. I wish it would've happened to me more than her." The pain has indeed become personal for the fire victims of Kashmir, and so has the struggle for rebuilding. "We didn't even have a scarf on our heads when the fire erupted," Jamsheeda, the homemaker, says. "And now, the same thing is sadly happening to many others as these midnight flames are getting out of control in Kashmir."

RAJOURI ATTACK: Three families Lose Breadwinners

RAJOURI: The recent attack in Dhangri village in Jammu and Kashmir's Rajouri district left behind a trial of destruction with three families losing their breadwinners.

Seven persons belonging to a particular community were killed and 14 others injured when terrorists swooped on Dhangri on January 1, on the New Year Day, and fired indiscriminately on the local residents and left behind an improvised Explosive Device (IED) before fleeing under the cover of darkness.

While five persons died in the firing, two children --aged four and 16 -- lost their lives in the IED blast the next morning

Among the dead were two young brothers, a father-son duo and an ex-serviceman, who were the only breadwinners of their families.

Saroj Bala (58) is shell shocked and the only survivor in the family after her two sons -- Deepak Sharma (27) and Prince Sharma (21) -- died in the attack. Her husband Rajinder Sharma had died of a serious ailment four years ago.

Pritam Lal (55) and his 31-year-old son Shishu Pal, who were working as labourers to earn their livelihood, were killed by terrorists inside their house.

"I was cooking dinner for the family when the terrorists started firing in the village. They asked for identity cards and pushed me and my minor children -- a son and a daughter -- into a store room before firing on them," Shishu Pal's widow Neeta Devi told PTI.



She said her father-in-law used to work as a labourer in the village, while her husband

was working for a construction agency. Her mother-inlaw had died some years ago. "There is no one who can feed us," she said, as tears

streamed down her face. Satish Kumar (45), who retired from the Army three and a half years ago, was returning home when he heard firing shots.

Kumar gave his life saving his family from the terrorists, his brother-in-law Chaman Sharma said.

"After his retirement from service, his primary focus was taking good care of his family and education of his children. He was a man with a golden heart and was always available in happiness and sorrow for everyone," he said.

He said Kumar was fired upon by the terrorists while

he was trying to block their entry into his house and in the process his wife Saroj (36), daughter Arushi (14) and son Shub Sharma (17) also received bullet injuries as they came out to see what is happening at the gate.

"Saroj received a bullet injury in her lower back, Arushi in her leg and Shub Sharma in his knee. Both Saroj and Arushi are undergoing treatment in Government Medical College (GMC) hospital Rajouri, while Shub is admitted to a hospital in Punjab," Chaman Sharma said.

Dheeraj Sharma, a local sarpanch, demanded special attention of the government for the three families to help them cope up with the situation besides ensuring better education to the surviving children.

NC Asks Home Minister To **Convene APM To Bail Out' J&K From Uncertainty**

IAMMU: The National Conference on Tuesday urged Union Home Minister Amit Shah to convene an all-party meeting to "bail out" the people of Jammu and Kashmir from the prevailing situation of uncertainty and fear psychosis following targeted killings by militants.

It alleged that the Lieutenant Governor administration has "miserably failed" to handle the present situation in the Union Territory.

Rattan Lal Gupta, provincial president (Jammu), National Conference, asked the home minister to convene an allparty meeting to bail out the people of J-K from the prevailing situation of uncertainty and fear psychosis on account of frequent terrorists activities, especially against the minority community both in Kashmir and Jammu provinces.

Gupta, along with senior party leaders, visited Dhangri village in Rajouri on Monday to offer condolences to the bereaved family members of the victims of the terror attacks. Seven people were killed by terrorists in the village last week.

Jammu Police Seeks Details Of Tenants, Domestic Help From Landlords

JAMMU: The Jammu administration on Tuesday directed landlords to submit details of their tenants and domestic helps to the concerned police station.

The move comes after several instances, in which anti-national elements sought hideouts in residential areas in the guise of tenants and domestic helpers, have been reported in Jammu.

An order issued by Jammu District Magistrate Avny Lavasa said the landlords shall submit the details within three days of the issuance of the order.

"All owners shall, after the issuance of this order, within three days submit without fail the detailed particulars of the tenants as per the declaration

form to be signed by both the owner and the tenant, to the concerned police station, either in person or by registered post addressed to the concerned Station House Officer," the order read.

It said the step was taken after Jammu's Senior Superintendent of Police brought to Lavasa's notice that there was an imminent need to conduct verification following instances where anti-national and anti-social elements have sought hideouts in residential areas in the guise of tenants and domestic helpers.

It is necessary that some measures be taken to make the landlords and property owners accountable before renting out and making available their premises to tenants and domestic helps, she said.

"I consider the threat posed by such adverse elements as imminent danger to public safety and security, that warrants immediate preventive measures under Section 144 of CrPC," the top district official said.

The owners who have already let, sub-let, or rented out their houses on any date prior to the issuance of this order, shall submit the detailed particulars of tenants as per the declaration form to the concerned police station with immediate effect, the order said.

"Owners, who have allowed jhuggies on their lands, shall also be required to disclose the details as per the declaration form," she added. "Any person contravening


