Nearly 24% Population In J&K Own A Car: NFHS Survey

Tearly 24 percent of the population in Jammu and Kashmir own a car—highest in North India, the National Family Health Survey (NFHS) for 2019-21 has revealed.

Most of these private cars have been financed by different banks across the J&K, as per an official from Regional Transport Officer, Kashmir.

"Over 60 percent of private cars are financed by banks, many have cleared the loans,' said the official, wishing not to be named as he wasn't media.

As per the NFHS report, Jammu and Kashmir ranks third in India having the highest population with a car. Goa tops this list with 45.2 percent followed by Kerala at 24.2 percent.

The report further reveals that in Punjab 21.9 percent own private vehicles, while in Delhi and Haryana 19.4 and 15.3 percent population own personal cars.

An official from Jammu and Kashmir Bank said that the car loan cases have increased from the last ten years

was only 6000. According to reports over 24 lakh vehicles have been regis-

Army Proposes Housing Colony For Serving, Retired Soldiers In Jammu

Criteria For Applicants In Line With New Domicile Laws Of Jammu And Kashmir

Srinagar: The Indian Army has proposed a housing colony in Jammu city for the serving, retired and widows & parents of deceased soldiers meeting the requirements on the lines of new domicile laws of Jammu and Kashmir introduced after the abrogation of special status in August 2019.

The proposal for creating a housing colony in the winter capital has been mooted by the Army Welfare Housing Organisation (AWHO), a registered trust functioning on No Profit No Loss basis.

The organisation on Saturday started a demand survey for Jammu City for group housing to ascertain the demand from serving /retired Army personnel, widows & parents of deceased Army personnel who are in receipt of family pension. The housing colony will have 2 BHK/ 3 BHK/ 4 BHK and 5BHK flats.

The survey will conclude on April, 30 this year. According to the notification uploaded on official website www.awhosena. in, the desirous soldiers, serving



or retired, besides their families, have been asked to submit their applications with a demand draft of Rs 25,000.

However, the organisation has listed pre-conditions for participation in the demand survey.

"The applicant should be do-miciles of the UT of Jammu & Kashmir," reads the notification.

Divulging more details of the criteria, the notification says that the personnel who have resided for a period of 15 years in J&K, those who have studied in the UT for a period of seven years and appeared in Class 10th / 12th examination in any educational institutions located in J&K and the Defence personnel who have served in the J&K for 15 years and above are also eligible to apply.

The housing colony project, the AWHO said, will be planned based on the response received from the environment.

The notification further says that applicants will be given preference for allotment as per the seniority list of Demand Survey which will be based on the date of Demand Draft of Application Money.

It also adds that the money will be adjusted against the Registration amount at the time of conversion from Demand Survey to Annual Registration.

"If for some reasons the project does not take off within one year, the Application Money will be refunded without any deductions and simple interest will be paid on Application Money (interest will be calculated after one year from the date of receipt of application)," reads the notification.

"In case of premature withdrawal by an applicant, ie before launch of the scheme or before a period of one year, the Application Money will be refunded after deduction of 5% handling charges and no interest will be paid," it adds.

Pertinently, prior to the nullification of Article 370 and Article 35A of the Constitution, only state subjects were allowed to buy land and apply for government jobs in Jammu and Kashmir.

However, a year after abrogation of J&K's semi-autonomous status, the government of India notified the Jammu and Kashmir Grant of Domicile Certificate (Procedure) Rules, 2020, on May 18 and | More on P6

Inflation Bites: How Rising Food Costs Affect Nutrition And Health

lood for thought: rising grocery prices affect food choices and nutrition, and ultimately health, and even the health-care system

As a result of inflation, the cost of food continues to soar, with data from Statistics Canada reporting the latest price changes of foods purchased from groceries stores and restaurants.

In September, Canada experienced its largest yearly increase in foods purchased from grocery stores or restaurants (10.3 per cent). Food prices rose slightly less in October (10 per cent), but remain elevated, with November's increase coming in at 6.8 per cent.

In response to this rapid inflation, many Canadians took to social media, particularly TikTok, to share how much grocery shopping is costing and what they are getting for their money. Canada's recent lettuce shortage has resulted in price hikes for romaine and iceberg lettuce, with many grocery stores posting signs about the shortage and imposing purchase quantity limits, while restaurants have modified their offerings and altered their menus.

Why are food prices so high?

The COVID-19 pandemic and other global events continue to have worldwide consequences for health and the economy, with food prices being no exception.

Prices are driven up in several ways, including supply chain issues (things like processing, packaging and transportation), changes in consumer spending patterns, and previously mandated business closures forcing the redistribution of foods from restaurants to stores, as well as unfavourable growing weather conditions (things like heat waves, extreme rain/flooding, droughts and freezing).

As health behaviour researchers, we believe that many Canadians will undoubtedly feel the additional financial pressure at the checkout line, and many will eat less nutritious and cheaper food options.

In Ottawa, the cost of eating nutritious food for a single person was estimated at \$392 per month, based on data collected from May to June 2022. For a family of four, the cost jumps to \$1,088 per month.

Undoubtedly, low-income and fixed-income households will feel the biggest pinch (especial-

ly in one-person or single-parent households) and the short- and long-term health impact could add to our crippling health-care system.

How do rising food costs impact your health? With the rising cost of food, many Canadians are experiencing insecure or limited access to food. This can have various effects on health, such as a decrease in mental health, increased

risk of diabetes, higher rates of autoimmune

and infectious diseases, and injuries. Research has shown that increased household food insecurity is strongly associated with greater strain on the health-care system, with greater emergency room visits, longer hospital stays, more same-day surmore reliance on physician services and home care services, and higher

interfere

drug use. Older adults may also have health conditions with specific dietary requirements. With the increase in food prices, meeting these specific dietary needs may not be possible and can lead to additional health complications. Furthermore, the higher cost of food is put-

ting strain on food banks and school food programs, like the Ontario Student Nutrition Program. School food programs provide support to children by helping ensure their stomachs are full while promoting healthful eating practices

> School food programs have been shown to be beneficial for better academic outcomes and overall health in the short term, and food choices and behaviours in children are likely to continue into adult-

hood, making childhood an essential time to have access to healthy foods. Suboptimal during this stage also may nutrition with optimal growth and opment.

What can you do to save money?

One of the most expensive things about food is food waste. According to Second Harvest, Canada's largest food rescue organization, the annual cost of avoidable food loss and waste in Canada was \$1,766 per household.

Making a meal plan for the week, with a shopping list before you go to the grocery store, is a great way to buy only what you need and ensure you use up what you've purchased. If you are only going to use half the produce for one meal, make sure you have a second recipe for later in the week to use it up.

There are several online applications, such as Flipp or Reebee, that can also help you shop for sales or use coupons. Many food outlets allow price matching with other stores. Using loyalty program points is another option that can help pay for groceries. If you are a student or older adult, your local grocery store or retail drug store may offer discounts for shopping on a specific day of the week.

Lastly, eating with other people is not only associated with better diet quality and psychosocial outcomes but may also reduce food costs, as families are only making one meal for all to enjoy.

I Don't Want To Fill Jails: Farooq

'My Orders To The Police; Wherever You Find A Militant, Kill Him

RINAGAR- The chief minister, Dr Farooq Abdul¬lah, to-day said thai his gov¬ernment would give mili¬tants no quarter and hinted 'extra-ordinary security measures' to be undertaken in the state very soon.

Speaking today at a gather¬ing at the residence of former minister and National Confer¬ence MLA, Muhammad Dilawar Mir, whose brother was gunned down by unidentified gunmen at Rohama in Rafiabad vesterday, he said, "I don't want to fill jails. My orders to the police are; wherever you find a militant, dispatch him.'

According to Dr. Abdullah, militants were killing innocent people and therefore deserved to be paid in the same coin.

Referring to a meeting he had had with prime minister Atal Bihari Vajpayee, he said that he had told him that militants had not stopped killing innocents despite the prime minister's talk of peace. "Make one final push and fin-ish the matter off, I told the prime minis¬ter.'

He said that he had presented his formula long ago: Kashmir is an integral part of India; Pakistan should be given the territory under its control and the LoC converted into an international border; the Rawalpindi road should be opened; Kashmiris should be given internal autonomy and the Kashmir issue will dissolve automatically. "India will never give up Kashmir even if all Kashmiris

per¬ish." Desisting from his customary tirade against the Hurriyet, he said the APHC leader's visit to Paki¬stan would not alter the LoC. "I want to see how the Pakista¬nis react." Later. talking to NAFA, Dr. Abdullah said that he would be talking to the PM and the HM soon, and extraordinary secu-rity measures would be put in place after that. "We will not al-low our campaign against mili¬tants to be slackened." he said.



Our Greatest Poet We Didn't Celebrate

In his lifetime, Rahi did not receive the adoration and respect he deserved, which is a sad reflection on us as a community

As a creative being, he couldn't be bound by the unconscious groupthink that pervades so much of our everyday conversation. He couldn't take a mundane public stance circumscribed by the ephemeral political correctness of the day. This, however, didn't mean Rahi abdicated his responsibility

or all his stature as the greatest modern Kashmiri poet, Rehman Rahi died largely unnoticed. He also had a very modest funeral, otherwise a hallmark of a deceased person's social standing in our part of the world. As is generally the case with our cultural icons, he had long disappeared from our public discourse. People were barely conscious of his existence. Apart from a very small circle of connoisseurs of Kashmiri literature, his poetry wasn't read or even known to a predominant majority of Kashmiris. In his lifetime, he did not receive the adoration and respect he deserved, which is a sad reflection on us as a community.

But his death has caused a deep sadness and a sudden recognition of his beautiful and profound poetry which addressed our condition as a people caught in an intractable situation. In our social media age, his videos and poetry are being circulated online and shared on WhatsApp. In some of the videos being shared, Rahi recites his own poetry. This has made our new generation aware of him. One such poem is 'Karav Kya' which can be roughly translated as 'There's nothing that we can do.' Every word, rhyme and rythm of the poem speaks to our predicament.

Kathi zan assini vaar, karav kya Veterin vaenij baar, karav kya (What if we are powerless to speak, is there anything we can do) (What if heart succumbs to the strain of grief, is there anything we can do)

But as with any great literary figure, Rahi will not die with his physical demise. His exquisite poetry will live on. A poetry that not only articulates the condition of his people - their sadness, loss, pain and lack of hope - but also goes beyond it to deal with broader human condition. Witness to an extended span of Kashmir's troubled history, right from

the early twentieth century, Rahi crafted a whole new poetic idiom for Kashmir. One, which embraces in its aesthetic sweep not only the mysticism and folksiness of traditional Kashmiri poetry but also the larger spiritual and philosophical questions giving his work a universal appeal. Rahi was himself conscious of his achievement. Kashmiri poetry, he said in an interview, has always been rich in mystic elements, but it lacks intellectual content and modern sensibility. And he lent it that.

Rahi's distinction lies in that he single-handedly honed Kashmiri, a language with a modest intellectual pedigree, into an authentic medium

obliged him to take a political stand. And perhaps, rightly so. As a creative being, he couldn't be bound by the unconscious groupthink that pervades so much of our everyday conversation. He couldn't take a mundane public stance circumscribed by the ephemeral political correctness of the day. This, however, didn't mean Rahi abdicated his responsibility. He stayed first and foremost a poet and expressed himself through his poetry. And much more powerfully and profoundly so than a routine statement would ever do.

Rahi's panacea for our conflicted present was to return to our neglected mother tongue. Language, he once told

of aesthetic and philosophical expression. He not only composed great poetry but in the process nurtured and developed a language. He salvaged Kashmiri from the shadow of Persian and Urdu, which otherwise dominated the Valley's literary scene.

Rahi was the youngest in India to receive Sahitya Academy award in 1961. He went on to win Jnanpith award, India's highest literary prize, the first Kashmiri to do so. However, his acceptance of the awards—more specifically, that of the latter—was viewed as a contentious political act that at the time alienated many of his admirers in the Valley. But Rahi was a far bigger poet than his awards, and he wore his greatness lightly. Eventually awards became extraneous to his overarching literary persona.

A perennial grouse of a section of our society against Rahi was that he scrupuloulsly steered clear of commenting on the prevailing turmoil in the Valley. But the criticism never me, represented a community's basic identity rather than a political ideology.

"It (language) is the wellspring of a people's unique outlook, sensibility and cultural orientation," he said while lamenting the squeezing space for Kashmiri in our society. "The mother tongue is the storehouse of the collective memory, which connects a community to its roots and helps it define itself."

Unfortunately, not many of us have read his poetry. Let us hope that his death prompts us to recognise his greatness and claim him as our poet, a principal voice of Kashmiri sensibility. And, of course, may his passing also get us around to reading him.

Tinters are not exclusive to Kashmir. More than half of the world's population witnesses snowfall. As mentioned before, winters with snowfalls are almost everywhere in the world, but they are far ahead of us. It is because they do not waste time to see winters pass but instead make winters easy and suitable to work. Any argument that there is no money to bring such change is just living in a fool's paradise. We have enough money to get a tangible change along the same lines. We have young human resources

who want to work instead of staying inside homes. We will accept any change on the ground, however little that may be. Let us start by making resources available to help continue economic activities in winter. Electricity is one. Technically, it will push other sectors to help boost the local economy and will not bring unemployment down that skyrockets during winter months.

Delivery Agents in Snow: **Dedication or Exploitation?**

very year, whether it is linemen on electric poles or delivery agents walking over snow covered slippery roads, we see all being glorified through pictures and videos online. One such video made it online where the employer of a courier service proudly shared a video of their delivery executive with a heavy goods carrying bag, walking over a stretch of road cov-ered with snow. The video was supposed to act as a positive PR for their services but it backfired as soon as it was posted.

Labour laws and work place rules are safeguards to protect employees. However, sometimes, some situations are not addressed specifically. Perhaps, the weather

condition is one such factor. Nevertheless, it's the employer's duty to keep a defined temperature/amount of snowfall metric to determine whether or not employees can be asked to work. The employer should ideally have a policy to allow a voluntary day-off in case of heavy snowfall. Additionally, incase the employee decides to work, the employer must ensure the employee's safety and security. Adequate snow gear especially snow shoes must be provided.

ChatGPT, DALL-E 2 And The Collapse Of The Creative Process

n 2022, OpenAI – one of the world's leading artificial intel-Lligence research laboratories - released the text generator Chat-GPT and the image generator DALL-E 2. While both programs represent monumental leaps in natural language processing and image generation, they've also been met with apprehension.

Some critics have eulogized the college essay, while others have even proclaimed the death of art.

But to what extent does this technology really interfere with creativ-

After all, for the technology to generate an image or essay, a human still has to describe the task to be completed. The better that description the more accurate, the more detailed - the better the results.

After a result is generated, some further human tweaking and feedback may be needed – touching up the art, editing the text or asking the technology to create a new draft in response to revised specifications. Even the DALL-E 2 art piece that recently won first prize in the Colorado State Fair's digital arts competition required a great deal of human "help" - approximately 80 hours' worth of tweaking and refining the descriptive task needed to produce the desired result.

It could be argued that by being freed from the tedious execution of our ideas - by focusing on just having ideas and describing them well to a machine - people can let the technology do the dirty work and can spend more time inventing.

But in our work as philosophers at the Applied Ethics Center at University of Massachusetts Boston, we have written about the effects of AI on our everyday decision-making, the future of work and worker attitudes toward automation.

Leaving aside the very real rami-

fications of robots displacing artists who are already underpaid, we believe that AI art devalues the act of artistic creation for both the artist and the public.

SKILL AND PRACTICE BECOME SUPERFLUOUS

In our view, the desire to close the gap between ideation and execution is a chimera: There's no separating ideas and execution.

It is the work of making something real and working through its details that carries value, not simply that moment of imagining it. Artistic works are lauded not merely for the finished product, but for the struggle, the playful interaction and the skillful engagement with the artistic task, all of which carry the artist from the moment of inception to the

The focus on the idea and the framing of the artistic task amounts to the fetishization of the creative moment.

Novelists write and rewrite the chapters of their manuscripts. Comedians "write on stage" in response to the laughs and groans of their audience. Musicians tweak their work in response to a discordant melody as they compose a piece.

In fact, the process of execution is a gift, allowing artists to become fully immersed in a task and a practice. It allows them to enter what some psychologists call the "flow" state, where they are wholly attuned to something that they are doing, unaware of the passage of time and momentarily freed from the boredom or anxieties of every-

This playful state is something that would be a shame to miss out on. Play tends to be understood as an autotelic activity - a term derived from the Greek words auto, meaning "self," and telos meaning "goal" or "end." As an autotelic activity, play is done for itself - it is self-contained

and requires no external validation. For the artist, the process of artis-



tic creation is an integral part, maybe even the greatest part, of their vocation.

But there is no flow state, no playfulness, without engaging in skill and practice. And the point of Chat-GPT and DALL-E is to make this stage superfluous.

A CHEAPENED EXPERIENCE FOR THE

But what about the perspective of those experiencing the art? Does it really matter how the art is produced if the finished product elicits delight?

We think that it does matter, particularly because the process of creation adds to the value of art for the people experiencing it as much as it does for the artists themselves.

Part of the experience of art is knowing that human effort and labor has gone into the work. Flow states and playfulness notwithstanding, art is the result of skillful and rigorous expression of human capabilities.

Does that realization retroactively change the experience of listening? Does it take away any of the awe?

As the philosopher Michael Sandel notes: Part of what gives art and athletic achievement its power is the process of witnessing natural gifts playing out. People enjoy and celebrate this talent because, in a fundamental way, it represents the paragon of human achievement - the amalgam of talent and work, human gifts and human sweat.

IS IT ALL DOOM AND GLOOM?

Might ChatGPT and DALL-E be worth keeping around?

Perhaps. These technologies could serve as catalysts for creativity. It's possible that the link between ideation and execution can be sustained

if these AI applications are simply viewed as mechanisms for creative imagining - what OpenAI calls "extending creativity." They can generate stimuli that allow artists to engage in more imaginative thinking about their own process of conceiving an art piece.

Put differently, if ChatGPT and DALL-E are the end results of the artistic process, something meaningful will be lost. But if they are merely tools for fomenting creative thinking, this might be less of a concern.

For example, a game designer could ask DALL-E to provide some images about what a Renaissance town with a steampunk twist might look like. A writer might ask about descriptors that capture how a restrained, shy person expresses surprise. Both creators could then incorporate these suggestions into their work.

But in order for what they are doing to still count as art - in order for it to feel like art to the artists and to those taking in what they have made - the artists would still have to do the bulk of the artistic work themselves.

Art requires makers to keep making.

THE WARPED INCENTIVES OF THE INTERNET

Even if AI systems are used as catalysts for creative imaging, we believe that people should be skeptical of what these systems are drawing from. It's important to pay close attention to the incentives that underpin and reward artistic creation, particularly online.

Consider the generation of AI art. These works draw on images and video that already exist online. But the AI is not sophisticated enough - nor is it incentivized - to consider whether works evoke a sense of wonder, sadness, anxiety and so on. They are not capable of factoring in aesthetic considerations of novelty and cross-cultural influence.

Rather, training ChatGPT and DALL-E on preexisting measurements of artistic success online will tend to replicate the dominant incentives of the internet's largest platforms: grabbing and retaining attention for the sake of data collection and user engagement. The catalyst for creative imagining therefore can easily become subject to an addictiveness and attention-seeking imperative rather than more tran-

scendent artistic values. It's possible that artificial intelligence is at a precipice, one that evokes a sense of "moral vertigo" - the uneasy dizziness people feel when scientific and technological developments outpace moral understanding. Such vertigo can lead to apathy and detachment from creative expression.

If human labor is removed from the process, what value does creative expression hold? Or perhaps, having opened Pandora's box, this is an indispensable opportunity for humanity to reassert the value of art - and to push back against a technology that may prevent many real human

Cong MP Santokh Chaudhary Dies Of Cardiac Arrest During Bharat Jodo Yatra, March Halted For 24 Hours

Chandigarh: Congress' Jalandhar MP Santokh Singh Chaudhary died on Saturday after suffering a cardiac arrest during the Bharat Jodo Yatra in Punjab's Phillaur, following which the march was halted for 24 hours. He was 76.

leader Rahul Congress Gandhi, who visited the grieving family, expressed shock over his death and described him as a hardworking leader and strong pillar of the party.

Chaudhary, a two-time MP, was walking with Rahul Gandhi during the yatra in Phillaur in Jalandhar when he fainted, according to senior party leader Partap Singh Bajwa, who was also marching with other participants.

Chaudhary was rushed to a private hospital in Phagwara in an ambulance where he was declared brought dead. Later, his body was shifted to his residence in Jalandhar.

Chaudhary had joined the yatra in Phillaur Saturday morning and after some time, he felt uneasiness and fainted.

Jothimani, Congress MP from Tamil Nadu's Karur, who was also part of the yatra, said before collapsing, Chaudhary asked her "how are you Jothi".

"Still I couldn't get out of the shock. While we were walking, he stepped back and asked me with his trademark smile 'how are you Jothi, this is my constituency' and just got collapsed. It's heart breaking to see that he is no more," tweeted Jothimani.

The Gandhi-led yatra re-umed from Ladhowal in Ludhiana on Saturday morning as part of its Punjab leg.

Congress Punjab Amrinder Singh Raja Warring told reporters that Chaudhary earlier raised slogans 'Jodo Jodo, Bharat Jodo' to welcome Gandhi.

He said Chaudhary was very excited about the yatra as it was passing through his area. "The Chaudhary family has been associated with the Congress for a very long time."

Warring further said the family has decided to conduct the cremation at his native place at 11 am on Sunday.

Congress Meanwhile,

general secretary, communications, Jairam Ramesh said the yatra has been suspended for 24 hours following Chaudhary's demise. It will now start from Jalandhar on Sunday afternoon.

"Bharat Jodo Yatra will be suspended for 24 hours as a mark of respect for Santokh Singh Chaudhary, Congress MP from Jalandhar who passed away this morning. The Yatra will resume tomorrow afternoon from Khalsa Ground, Jalandhar," Ramesh said in a tweet.

He further said Gandhi's press conference which was scheduled to take place at Jalandhar on January 15 will now be held in Hoshiarpur on January 17.

Chaudhary, a Dalit leader, belonged to a family of politicians. His father Master Gurbanta Singh was a Dalit stalwart, an educationist and a former Punjab agriculture minister.

Chaudhary's elder brother Chaudhary Jagjit Singh was a local bodies minister. Chaudhary's son Vikramjit Singh is a Congress MLA from the Phillaur assembly seat.

Chaudhary was elected to the

Lok Sabha in 2014 and 2019. He had been MLA twice in 1992 and 2002 and was also minister in the Congress government.

The Congress MP's native village is Dhaliwal near Kartarpur in Jalandhar district.

Later, Gandhi visited the residence of Chaudhary and consoled his family members.

"Shocked by the sudden demise of Shri Santokh Singh Chaudhary. He was a down-toearth and hardworking leader, a good person and a strong pillar of the Congress family, who dedicated his life to public service from the Youth Congress to Member of Parliament. I express my condolences to the bereaved family," he said in a tweet.

Punjab Governor Banwarilal Purohit expressed his grief over the demise of the Jalandhar MP.

"I am shocked at the sudden, untimely demise of Chaudhary ji. He was a dedicated and hardworking leader. May his soul rest in peace," said the governor. Several Congress leaders vis-

ited the residence of Chaudhary in Jalandhar.

Role Of Regional Parties To Be Important For 2024 LS Polls: Amartya Sen

Kolkata: Nobel Laureate Amartya Sen asserted that it "would be a mistake" to think that the 2024 Lok Sabha election would be a one-horse race in favour of the BJP, and felt that the role of a number of regional parties would be "clearly important" for the upcoming general election.

The 90-year-old economist also said that though Trinamool Congress supremo Mamata Banerjee has the ability to be India's next Prime Minister, it is yet to be established whether the West Bengal Chief Minister could be able to pull the forces of public dismay against the BJP.

"I think a number of regional parties are clearly important. I think the DMK is an important party, the TMC is certainly important and the Samajwadi Party has some standing but whether that could be extended I do not know.

"I think it would be a mistake to take the dismissive view that there is no other party that can take the place of BJP since it has established itself as a party with a vision that is inclined in the direction of Hindus over the rest of the country," he told PTI in an exclusive interview here. several

parties including the Nationalist Congress Party (NCP) and the Janata Dal (United) have called for a new alliance including the Congress for the Lok Sabha polls in 2024. They have emphasised that a bipolar contest will ensure the BJP's defeat.

"The BJP has substantially reduced the vision of India. It has narrowed the understanding of India as just Hindu India and as a Hindi-speaking India in such a strong way that it would be sad if there is no alternative to the BJP in India today.
"If the BJP looks strong and

powerful, it has a good deal of weakness too. So, I think other political parties will be able to come to a debate if they really try. I do not know enough to be able to dismiss the anti-BJP parties together," he said.

On whether Banerjee could be the country's next PM, Sen said she has the ability.

"It's not that she does not have the ability to do it. She clearly has the ability. On the other hand, it's yet not established that Mamata can pull the forces of public dismay against the BJP in an integrated way to make it possible for her to have the leadership to put an end to the fractionalisation in India," the economist said.

The minimum in Kupwara, a frontier district, settled at minus 3.6 degrees Celsius. Pahalgam in Anantnag district, which also serves as a base camp for the annual Amarnath Yatra, registered a low of minus 5.9 degrees Celsius down from minus 2.4 degrees Celsius a night

The minimum temperature at Gulmarg in Baramulla district went down over 10 notches from minus 0.6 degrees Celsius to settle at minus 11 degrees Celsius making it the coldest recorded place in Jammu and Kashmir.

The meteorological office said the weather vill remain partly cloudy with moderate to dense fog over the plains of Jammu on Saturday.

Fresh feeble western disturbances are likely to affect Jammu and Kashmir from January 19 to 25. Light to moderate rain or snow is likely between January 23 and 24t, it said.

Experts Red Flag

Child expert Muzzafar Ahmed, Danishwar Rasool Dar, and Dr. Rameez state that the invention of the Mobile Phones, and the peculiar ways in which people are utilising the technology had prompted questions about whether improper usage of it could lead to addiction.

Nearly three years into the COVID-19 pandemic, screen usage has increased exponentially, especially among children, and as per a recent study published in JAMA Paediatrics, the average amount of time children spend staring at screens has risen 52 percent since the beginning of the pandemic.

According to a study conducted by the Kashmiri trio, some of the addictive characteristics in children is excessive permission given by some parents to their children for gaming in order to have some mental peace for a short period of time, and in single child cases, families who do not have anyone to play outdoor games with are showing more interest in mobile gaming to overcome their loneliness.

"Busy parents or Emotional Dependency: n today's world most parents are too preof cupied with their jobs and businesses to provide their children with adequate emotional support. Here children are taking emotional support from mobile gaming and becoming dependent," the study reads.

"The addictiveness of smartphones, immersion and role-playing in many games allow players to create their own character, leading them often in a fantasy world that can be heav-

ily influenced by their actions within it." It reads: "Players can get highly attached to these characters and the world they live in. Sadly, becoming over-attached to these fantasy worlds can lead to negligence towards realworld responsibilities.

Dr Muzzafar Ahmed, consultant clinical psychologist at Composite Regional Centre (CRC) Bemina, Srinagar while speaking about the side effects of mobile gaming said that from a psychological perspective, it was found that depression and anxiety are associated with gaming addiction in children, and same findings are reported regarding adults. "Anxiety can be triggered gradually in heavy users when their smart phones are unavailable.

The study further states that communication problems or a lack of social engagement, attention and concentration problems, behavioural problems, Avoidance of developmental tasks, negative role model issues, habits and disinterest in other aspects of life, and physical problems are all listed as side effects of mobile gaming and fallout of phone addictiveness.

Prof. Dr. Reyaz Malik, a prominent paediatrician in the valley, while expressing concern over the mobile addiction among children said that excessive usage of mobile screens affects the brain development of the child.

"There is a considerable increase in mobile addiction, not just among children but also among adults, but these smartphones usually leave negative mental health aspects in children because their brains are in developing phase," Dr. Malik said. He said there are some signs which parent

should be aware which indicate that their children are addicted towards smartphones and on the higher side are improper timing of sleep, being anxious, expressing anger or exhibiting aggressive behavior or prefer isolation. Urging the parents, Dr. Malik said that par-

ents should set an example by spending time with their families and children after they finish their day's work.

"Parents should keep their phones away and keep a family time wherein they will speak and be with their kids rather than being on phone, no screen time should be given space during family time. And even if the screen time is permitted, the exposure should be age-based and calculated," he added.

The study, while mentioning the prevention measures, states that parents should spend a lot of time with their children and always be there for them emotionally, and not let them play video games when they're with you.

"Make other physical activities or outdoor sports a part of the child's life as well. If children show some aggressive behaviour, as a parent, you must set boundaries and explain that this kind of behaviour is unacceptable. Be firm and demonstrate that such behavior carries consequences like time-out or being kept away from a favourite activity for the day," the study reads.

It states that parents should teach their children alternative ways to express their feelings-ways that are socially acceptable and should encourage them to pursue other hobbies and interests, particularly sports and other physical activities—(KNO)

NC Targets HM For 'Ignoring' Demands Of Protesting Youths

JAMMU: Senior National Conference leader Ajay K Sadhotra on Saturday criticised Union Home Minister Amit Shah for "ignoring the demands" of protesting youths as well as employees who fled Kashmir in the aftermath of the targeted killings last year.

Terming the visit of Shah to Jammu on Friday as a "total failure", he said creating hype was different than fulfilling the aspirations of the people.

'It is unfortunate that Jammu, the holy city of temples, has turned into a city of dharnas and protests by the BJP double-engine government. The Centre being the custodian of the interests of the people of Jammu and Kashmir, in the absence of a democraticallyelected government, cannot shirk its legitimate responsibilities," Sadhotra said in a statement here.

He said the protesting youths and reserved categories' employees working in Kashmir, Prime Minister Package employees, Rehbar-e-Khel workers and daily-rated and contractual segment of employees find themselves pushed to the wall with the home minister not speaking a word about them and ignoring their demands contemptuously.

He said denial of rights, especially withholding the salaries, is a gross human rights violation and its enormity becomes se-

vere as the youths have been agitating for several months now.

Sadhotra said the visit of the home minister had raised many expectations and generated hope among the protestors but "true to the character of the BJP they find themselves in lurch, as the ruling dispensation believes in not keeping its promises".

The NC leader cautioned the government against "testing the patience" of the striking workers and sought an immediate end to the ongoing dharnas by engaging them in talks and taking appropriate action on their demands.

Sadhotra also assailed the Centre and the J-K administration for failing in instilling a sense of security among the people in general and those living in the border areas in particular.

Referring to the recent twin terror attacks in Dhangri village of Rajouri that left seven people dead and 14 others injured, he said the two lives of the young children who died in an IED explosion after the initial attack could have been saved had the agencies concerned sanitised the site of carnage after the brutal killings.

"Nothing is being heard about the action taken against those responsible for the security lapse despite tall claims made by responsible people at the helm of affairs," the NC leader said, adding this has further aggravated the despondency among the people about their safety and security.



Rashford Scores Again As Man United Beats Man City 2-1
