How Recent Results Recreated Reservation Ruckus In Kashmir

reyond the festive cel-Bebrations and frenetic criticism, the recent results of the reservationridden Jammu Kashmir Administrative Services (JKAS) exam once again highlighted the growing marginalization of General Category in the region where merit is already passing through a series of litmus tests. Of the 187 successful candidates that the recent JKAS panned out with, more than



half belong to the reserved categories. A total of 90 candidates

qualified in the open merit, of which 22 belong to the reserved categories-most from the Residents of Backward Area (RBA) and Scheduled Caste (SC). The remaining 97 candidates in the reserved category have a bulk from the Scheduled Tribe (ST), RBA, Economically Weaker

Sections (EWS), and SC. A total of 19 candidates are from the ST, 18 from RBA, 18 from EWS and 16 from SC. Optionally, Backward Class category (OBC) has been restruc-tured as RBA in J&K.

"The result makes it certain," says Samreen Khan, a scholar, "that populace under the General Category is being trudged towards obliteration." With a handful of diminutive

opportunities and rugged competition with the reservation predicament, Khan says, the General Category populace is well-going to meet the perils of negligence. "The idea of reservation was never intended to be in force perpetually," she says. "The legislators contrived the policy to effectuate for ten years from the inception onwards."

Notably, the Constituent Assembly framed the

reservation policy for ten years after the Constitution of India was effectuated. It still runs unimpeded, and the question remains why?

NIA Court Orders Attachment Of Hurriyat Office

Srinagar: A special court of the National Investigation Agency (NIA) has ordered attachment of the office of All Parties Hurriyat Conference (APHC) in Rajbagh area of Srinagar.

Additional Sessions Judge New Delhi, Shalinder Malik has ordered that "Immovable property i.e; building office of All Parties Hurriyat Conference at Rajbagh which was earlier used as office of APHC, to be attached and necessary legal process be carried out in this regard."

In its application, the NIA claimed that there is sufficient evidence against Nayeem Khan - the accused Hurriyat leader who "partly owns the property".

NIA has submitted in the court that the "property was being used for planning and execution of terrorist and secessionist activities" and for other offenses and thus invoked the provisions of Section 33 (1) of UAPA to seek attachment of the property."

Human Activity Degraded More Than A Third Of Remaining Amazon Forest: Study

he Amazon rainforest has been degraded by a much greater extent than scientists previously believed with more than a third of remaining forest affected by humans, according to a new study.

The study shows that up to 38 per cent of the remaining Amazon forest area - equivalent to ten times the size of the UK - has been affected by some form of human disturbance, causing carbon emissions equivalent to or greater than those from deforestation.

The paper was led by an international team of 35 scientists and researchers, from institutions such as Brazil's University of Campinas (Unicamp), the Amazon Environmental Research Institute (IPAM), National Institute for Space Research (INPE), and UK's Lancaster University, it said.

The work is the result of the AIMES (Analysis, Integration and Modelling of the Earth System) project, linked to the Future Earth international initiative, which brings together scientists and researchers who study sustainability, the study said.

The findings, published in the journal Science, are the result of an analytical review of previously published scientific data, based on satellite imagery and a synthesis



of published data outlining changes in the Amazon region between 2001 and 2018, the study said.

The authors define the concept of degradation as transient or long-term changes in forest conditions caused by humans.

Degradation is different from deforestation, where the forest is removed altogether and a new land use, such as agriculture, is established in its place. Although highly degraded forests can lose almost all of the trees, the land use itself does not change.

The authors evaluate four key disturbances driving forest degradation: forest fire, edge effects or changes that occur in forests adjacent to deforested areas, selective logging such as illegal logging and extreme drought. Different forest areas can be affected by one or more of these disturbances.

"Despite uncertainty about the total effect of these disturbances,

it is clear that their cumulative effect can be as important as deforestation for carbon emissions and biodiversity loss," said Jos Barlow, a professor at Lancaster University, UK, and co-author of the paper.

The scientists assessed that the degradation of the Amazon also has significant socioeconomic impacts, which should be further investigated in the future.

many," says Dr. Rachel Carmenta, a co-author based at the University of East Anglia, UK.

"Few people profit from the degradation processes, yet many lose out across all dimensions of human well-being - including health, nutrition and the place attachments held for the forest landscapes where they live.

"Furthermore, many of these "Degradation benefits the few, burdens are hidden at present; recognising them will help enable better governance with social justice at the centre," said Carmenta.

In a projection made by the team for 2050, the four degradation factors will continue to be major sources of carbon emissions into the atmosphere, regardless of the growth or suppression of deforestation of the forest.

"Even in an optimistic scenario, when there is no more deforestation, the effects of climate change will see degradation of the forest continue, leading to further carbon emissions," said Dr. David Lapola, leader of the study and researcher at Unicamp.

However, "preventing the advance of deforestation remains vital, and could also allow more attention to be directed to other drivers of forest degradation."

The authors propose creating a monitoring system for forest degradation, as well as prevention and curbing of illegal logging and controlling the use of fire. One suggestion is the concept of "smart forests" which, like the idea of "smart cities", would use different types of technologies and sensors to collect useful data in order to improve the quality of the environment.

"Public and private actions and policies to curb deforestation will not necessarily address degradation as well. It is necessary to invest in innovative strategies." said Lapola.

Dr Rather said stringent action will be initiated against those found smoking near educational institutions or hospitals under Cigarettes and Other Tobacco Products (COTPA) Act.

"I request people to please avoid smoking as the same is the root cause of all cancers, especially lung and gastrointestinal cancers. Life is precious and I humbly request one and all to quit smoking. Since tobacco cells have been established in all district headquarters, those found involved in violating rules will be dealt with strictly," Director Health told the media here. He said the department realized a fine of rupees 3000 from violators who were caught smoking in public places. Dr Rather said the administration has taken

While 56.6 percent, half of the population use tobacco in frontier Kupwara district in north Kashmir, 52 percent population in Shopian district in south Kashmir consume tobacco followed by 49.9 percent in Anantnag, 48.8 percent in central Budgam, 38.4 percent in Srinagar and 35.4 percent in Kathua. Among the twenty districts of the Union Territory, Jammu province is the least tobacco consuming district with 26.5 percent population using tobacco products.

India needs small dose of dictatorship: Farooq

EW DELHI- Chief Minis¬ter Farooq Abdullah today said his government has accepted the extension of cease-fire by another month with great difficulty in the face of militants continuing to kill innocent civilians. Admitting that the borders were silent, Abdullah, who was a kev-note speaker at a panel discussion on experiment with democracy organised by the International Press Institute (IPI) world Congress, said foreign, groups of Osama Bin Laden and Lashkar-e-Taiba were continuing with their explosions of IEDs and lobbing of grenades.

Taking a dig at Pakistan's desire for annexation of Kashmir, Abdullah wondered that what Islamabad could do for Kash miri Muslims after it failed to accept Muslims from erstwhile East Pakistan (now Bangladesh).

Sounding a word of caution, the chief minister said the growing religious intolerance in the country is not a happy sign for the country's democracy and the need of the hour was to fight the growing fundamental¬ist elements from both—Hindu and Muslim communities

Abdullah said that a small dose of dictatorship was needed to govern a huge population like that of India.

Responding to Abdullah's suggestion on dictatorship, he said it is better to have more discipline than dictatorship.

The panel discussion was chaired by N. Ram, editor the Hindu. Other panelists included Vinod Mehta and Mark Tully. (KASHMIR OBSERVER, 29 January, 2001)

Senior US General Warns Of Possible Looming War With China

WASHINGTON: A four-star US Air Force general has warned of a conflict with China as early as 2025 — most likely over Taiwan - and urged his commanders to push their units to achieve maximum operational battle readiness this year.

In an internal memorandum that first emerged on social media on Friday, and was later confirmed as genuine by the Pentagon, the head of the Air Mobility Command, General Mike Minihan, said the main goal should be to deter "and, if required, defeat" China. "I hope I am wrong. My gut tells me we will fight in 2025," Minihan said.

Laying out his reasoning, Minihan said Taiwan's presidential elections next year would offer Chinese President Xi Jinping an excuse for military aggression, while the United States would be distracted by its own contest for the White House.

"Xi's team, reason, and opportunity are all aligned for 2025," he added.

A Pentagon spokesperson responded to an AFP email query about the memo saying, "Yes, it's factual that he sent that out.' Senior US officials have said in recent months that China appears to be speeding up its timeframe to seize control of Taiwan, a self-governing democracy claimed by Beijing.

China staged major military exercises in August last year, seen as a trial run for an invasion after a defiant visit of solidarity to Taipei by then House Speaker Nancy Pelosi, who at the time was second in line to the White House.

The United States switched recognition from Taipei to Beijing in 1979 but sells weapons to Taiwan for its self-defense.

A growing number of US lawmakers have called for ramping up assistance, including sending direct military aid to Taiwan, saying that Russia's invasion of Ukraine underscores the need for early preparation.

IAF's Black Saturday as 2 Frontline Fighters **Collide, Pilot Killed**

In a rare and tragic accident, two frontline combat aircraft of the Indian Air Force (IAF) crashed during a training mission in Madhya Pradesh's Morena district on Saturday, resulting in the death of a wing commander while two other pilots ejected safely. Defence experts said it is probable that the Russian-de-

signed Sukhoi-30MKI jet and the French Mirage-2000 had a mid-air collision, but there was no official comment on it from the IAF.

The deceased pilot of the Mirage aircraft was identified as Wing Commander Hanumanth Rao Sarathi, officials said, add-

ing that a high-level probe has been ordered into the accident. The two pilots of the Sukhoi

aircraft managed to eject and were taken to a military hospital, they said. The Mirage-2000, which is a single-seater jet, was flown by Sarathi.

"Two fighter aircraft of IAF were involved in an accident near Gwalior today morning. The aircraft were on routine operational flying training mis-sion," the IAF said in a brief

statement. "One of the three pilots involved sustained fatal injuries. An inquiry has been ordered to determine the cause of the ac-

The officials said the recovery of the flight data recorders of the two aircraft would throw some light on what led to the crash.

Morena Collector Ankit Asthana said the debris of both the aircraft fell in the Pahargarh area of the district. Some debris also fell in Rajasthan's Bharatpur, which borders Madhya Pradesh, he added.

Two pilots survived the crash, Asthana said, adding that the body parts of another were found in the Pahargarh area.

Earlier in the day, Bharatpur Superintendent of Police Shyam Singh had said an aircraft crashed in an open field in the Ucchain area.

Locals were the first to reach the site where the debris from one of the aircraft fell, police in Bharatpur had said.

According to an aviation expert, it was the first Mirage 2000 as well as Sukhoi-30MKI that the IAF lost in a mid-air collision

The SU-30MKI is a twin-seat-

er combat jet, while the Mirage 2000, manufactured by French aerospace major Dassault Aviation, is a single-seater aircraft.

Both the jets took off from the Gwalior Air Force station. The base has squadrons of both Sukhoi-30MKIs and the Mirage 2000 jets.

Aviation historian Anchit Gupta tweeted that mid-air collisions (MAC) are not that uncommon and at least 64 aircraft and 39 pilots have been lost in MAC in the last more than 70 years in India.

He said the country lost 11 Mig-21 aircraft in MAC, while the numbers for the Hunter and Jaguar aircraft are eight and five respectively.

Madhya Pradesh Chief Minister Shivraj Singh Chouhan, in a tweet, said: "The news of the crash of Sukhoi-30 and Mirage-2000 aircraft of the Air Force near Kolaras in Morena is very sad." "I have instructed the local administration to cooperate with the Air Force in quick rescue and relief work. I pray to God that the pilots of the planes are safe," he added.

Two pilots of the IAF were killed in July last year when their twin-seater Mig-21 trainer aircraft crashed during a training sortie near Rajasthan's Barmer.

In March last year, Minister of State for Defence Ajay Bhat told the Rajya Sabha that 42 defence personnel were killed in accidents involving aircraft and helicopters of the three services in the last five years.



New Gun Attack In **East Jerusalem After Synagogue Mass Shooting**

JERUSALEM: An assailant shot and wounded two people in east Jerusalem on Saturday, Israeli medics said, hours after a Palestinian gunman killed seven outside a synagogue in one of the deadliest such attacks in years.

Police said the suspect was "neutralized" following the latest gun attack in the Silwan neighborhood, just outside Jerusalem's old, walled city.

Israel's Magen David Adom emergency response service identified the victims as two men, aged 47 and 23, both with "gunshot wounds to their upper body." It did not identify those involved.

Police had earlier announced 42 arrests in connection with Friday's synagogue attack.

The mass shooting unfolded as a 21-year-old resident of Israeli-annexed east Ierusalem drove up to the synagogue in the Neve Yaakov neighborhood

and opened fire during the Jewish Sabbath. The bloodshed, which unfolded on International Holocaust Remembrance Day, marked another dramatic escalation in the Israeli-Palestinian conflict.

It came a day after one of the deadliest army raids in the occupied West Bank in roughly

two decades, as well as rocket fire from militants in the Gaza Strip and Israeli retaliatory air strikes.

There have widespread calls to de-escalate the spiralling violence, but tensions are rising. Crowds shouted "Death to Arabs" as Israeli Prime Minister Benjamin Netanyahu toured the scene of the synagogue attack late Friday.

Palestinians also held spontaneous rallies to celebrate the killings, in Gaza and across the West Bank, including in Ramallah where large crowds swarmed the streets chanting and waving Palestinian flags.

Several Arab nations that have ties with Israel-- including Egypt, Jordan and the United Arab Emirates – condemned the synagogue shooting.

The Lebanese group Hezbollah, one of Israel's most prominent foes, praised the attack as "heroic," voicing "absolute support for all the steps taken by the Palestinian resistance factions."

The gunman at the synagogue was shot dead by police during a shootout that followed a brief car chase after the attack.

There has been no indication that he had prior involvement in militant activity or was a member of an established Palestinian armed group.

BBC Arabic Radio Goes Off Air After 85 Years

Alastair Campbell, who used to be a strategist and adviser to former British Prime Minister Tony Blair, said the UK government has had to make "very difficult choices" since the weakening of the economy due to Brexit and other factors.

"I think they're very, very sad. I think that people underestimate the impact that the BBC has," Campbell told Al Jazeera,

that they see this as a really important, significant source of proper news gathering," Campbell said. "I actually think that the undermining of the BBC is at the heart of the govern-ment's strategy." The Arabic language station launched on January 3, 1938, from Egypt.

Hosam El Sokkari, former head of BBC Arabic, said the radio service was a "lifeline for lots of people in under privileged areas" as they listened to news via small and inexpensive devices.

"Now, they would have to use much more complicated and probably more expensive devices if they want to listen or enjoy the BBC services," El Sokkari told Al Jazeera from Cairo.

Acentury before #MeToo, French author Colette dumped a sleazy husband who took the credit for her work to throw herself into a life of free love that she fictionalised in groundbreaking novels about the lives of women.

France next week celebrates the 150th anniversary of the birth of the novelist whose uproarious life featured in the 2018 Hollywood biopic Colette, starring Keira Knightley.

Plucked from the Burgundy countryside by her first husband a literary agent 14 years her senior – he put her to work writing about her schoolgirl fantasies in the wildly popular "Claudine" books that he published under his own name.

Colette went on to cause scandal after scandal writing about hitherto taboo subjects like domestic violence, anorexia and fake orgasms, before becoming a music hall dancer, mime artist and



weightlifter.

She was also among the first women to wear trousers and have a facelift in a dizzying life that included three marriages and a multitude of affairs with both men and women.

As the American novelist John Updike said: "In the prize ring of life few of us would have lasted 10 rounds with Colette." Sidonie-Gabrielle Colette was

born in a Burgundy village in 1873 and was swept off to Paris at 20 when she married the womanising music critic Henry Gauthier-Villars, aka "Willy".

He introduced her to high so-

ciety salons frequented by novelist Marcel Proust and composer Claude Debussy, where she was gently mocked for her Burgundy accent and long blonde plaits.

Willy encouraged her to write about her life at school, telling her not to spare "the juicy details". Colette's mother had instilled in

her a love of nature that made her fiercely attuned to the senses, and she brought that to the page.

RIOT First, in 1900, came the homoerotic, coming-of-age tale Claudine at School, followed by Claudine and Annie, Claudine in Paris, and Claudine Married. All were instant bestsellers. After spicing them up, Willy put the books out

under his own name. Colette eventually moved in with her lover, cross-dressing noblewoman Mathilde de Morny, nicknamed "Missy", and filed for divorce after learning Willy had sold the rights to her books.

British-Indian Princess Sophia Duleep Singh Honoured With UK's Blue Plaque

LONDON: Sophia Duleep Singh, the daughter of Maharaja Duleep Singh - the last ruler of the Sikh empire - and the goddaughter of Queen Victoria, is to be honoured with a commemorative Blue Plaque in London.

Princess Sophia was among the leading suffragettes who fought for women's right to vote in 1900s Britain.

The Blue Plaque scheme, run by the English Heritage charity, honours the historic significance of particular buildings associated with historical figures and its 2023 cohort includes the 19th-century home of the British Indian Princess.

Case Registered Against AMU Student Over Video Of Religious Slogans Raised On R-Day

ALIGARH: Police on Saturday booked an Aligarh Muslim University student in connection with a video showing some NCC cadets purportedly raising religious slogans following a Republic Day function here, officials said.

The AMU authorities on Friday suspended a BA first-year student, Wahiduzaman, from the rolls of the university over the video and declared the campus out of bounds for him on the basis of "prima facie" evidence.

Superintendent of Police, City, Kuldeep Singh Gunawat said a case under IPC sections 153B (remarks likely to cause disharmony, or feeling of enmity or hatred or ill-will) and 505 (mischief) was lodged against an unidentified NCC cadet based on a complaint

filed by Yogesh Varshney.

The AMU has set up a threemember panel to probe the incident after two video clips of slogan shouting surfaced on social media Thursday evening.

Of the two, a 17-second clip showed a group of NCC cadets chanting "Allah hu Akbar" twice near a flagpole. The other one, a 19-second video, showed another group of NCC cadets shouting "Bharat Mata ki jai" and "Vande Mataram" in front

of a building. On Friday, BJP MP from Aligarh Satish Gautam had demanded that the police should take strong action against the student and not show any laxity.

A senior AMU official told PTI that a probe ordered by the AMU authorities would seek to find out what prompted the sloganeering to take place.

Controversies, Sparring And Barbs Kept Spotlight On Rahul-Led March

SRINAGAR: Rahul Gandhi's Burberry T-shirt and his scraggly beard, V D Savarkar and north India's chilling winters, the Kathua rape and Covid As the curtains fall, the Bharat Jodo Yatra replays in a patchwork of issues personal and the overtly political with controversies aplenty to ensure the spotlight seldom wavered.

The Kanyakumari to Kashmir yatra started from the southern tip of the country on September 7 and ends on January 30 in Srinagar, some 145 days and 3,500 km later. The crosscountry foot march stayed in the news almost right through, mostly for the barbs between the BJP and the Congress and occasionally for other reasons, including infighting in the opposition party.

It started during the first leg in Tamil Nadu with the BJP attacking Gandhi for wearing a Burberry Tshirt allegedly worth Rs 41,000. The Congress hit back back with a "Rs 10 lakh suit" and "Rs 1.5 lakh glasses" barb directed at Prime Minister Narendra Modi

It was just the beginning.

As the Gandhi-led yatra continued so did the sparring on social media platforms, TV debates and on the streets

During the early days of the yatra, the grand old party, for instance, tweeted a picture of khaki shorts, often associated with members of

the Rashtriya Swayamsevak Sangh, on fire. This triggered a backlash from the BJP, which accused the Congress of instigating violence.

And the BJP, in Tamil Nadu, accused the Congress of being anti-Hindu over Gandhi's meeting with a controversial Christian priest.

In Kerala, the Congress was left red-faced when a photo of Hindutva ideologue V D Savarkar appeared on a campaign poster near Kochi. The Ernakulam District Congress Committee, which arranged a massive preparation for welcoming the yatra, resorted to a fire-fighting exercise by immediately suspending the Congress worker responsible for it.

Gandhi's grey beard was at the centre of a war of words between the two parties with Assam Chief Minister Himanta Biswa Sarma claiming at a poll rally in Gujarat that the former Congress chief had started looking like the late Iraqi dictator Saddam Hussein. This drew a rebuke from the Congress which said he sounded like a "troll".

There were also times when dissensions within the party and its allies came to the fore.

The Maharashtra leg saw fissures surface between the Congress and its ideologically incompatible ally Shiv Sena after Gandhi attacked Savarkar over his mercy petitions to the British.

In Madhya Pradesh, a crisis erupted in the party in Rajasthan, the



Minister Ashok Gehlot slammed his former deputy Sachin Pilot and called him a 'gaddar' in an interview.

The matter was resolved in the nick of time and a show of unity was put up by Gehlot and Pilot with party general secretary, organisation, K C Venugopal brokering an uneasy truce just ahead of the yatra entering the desert state.

As the yatra entered Rajasthan, the spectre of Covid loomed large. Union Health Minister Mansukh Mandaviya wrote to Gandhi and Gehlot, asking them to consider suspending the march if Covid protocols could not be followed. Gandhi hit back saying the BJP was getting nervous and using Covid as an excuse to stop his march. The Congress and the BJP sparred

when former RBI governor Raghuram Rajan joined the march and then later when former army chief Gen (retd) Deepak Kapoor participated in the yatra in Haryana.

The two parties were at loggerheads again when Union minister Pralhad Joshi alleged that Gandhi was going on a holiday and that is why his Bharat Jodo Yatra had taken a long break December-end.

Congress general secretary Jairam Ramesh has repeatedly demanded an apology from Joshi for his remarks that Gandhi was going on a holiday. Gandhi spent the break in Delhi during the December-end break

Gandhi's white T-shirt, no sweater look in north India's famed winter was also the subject of much attention. He said he decided to wear only T-shirts during the march after meeting three poor girls "shivering in torn clothes" in Madhya Pradesh. That's when he decided that until

he shivers, he won't wear a sweater, the Congress leader said.

Gandhi Earlier this month, sparked a row when he said the Congress believes in 'tapasya', while the BJP is an organisation of 'pooja'. India is a country of 'tapasvis' (ascetics) and not 'pujaris' (priests), he said. The BJP slammed Gandhi, saying he Congress has "DNA of divide and rule". "Respect Tapasya but why denigrate Pujaris," a BJP spokesperson asked on Twitter.

Another controversy to hit the Congress was over Dongra Swabhiman Sangthan Sangathan Party (DSSP) leader Choudhary Lal Singh's

decision to join the Bharat Jodo Yatra, leading to objections from a section of the Congress and other parties.

Congress spokesperson Deepika Pushkar Nath resigned from the party on January 17 over the party agreeing to Singh's support to the yatra, alleging that he was responsible in sabotaging the 2018 Kathua rape case by "brazenly defending" the rapists of the eight-year-old girl. National Conference vice presi-

dent Omar Abdullah also opposed the participation of Singh.

In the latest row, senior Congress leader Congress leader Digvijaya Singh questioned the government's claims on surgical strikes and accused it of peddling lies.

This drew a furious reaction from the BJP, which said the opposition party was blinded by its "hate" for Prime Minister Modi and has "insulted" the armed forces.

There have also been casualties during the yatra.

Congress MP Santokh Singh Chaudhary died following a cardiac arrest during the Punjab leg. A Congress Seva Dal functionary died after collapsing in Nanded in Maharashtra.

Besides, a 62-year-old man from Tamil Nadu died and another person from that state was injured after being hit by a truck in Nanded when they were participating in the Congress' foot march.

Azad Is 'Mir Jafar' And 'Vote-**Cutter' Propped By BJP: Jairam**

AWANTIPORA: Senior Congress leader Jairam Ramesh on Saturday said he never thought former party leader Ghulam Nabi Azad would turn out to be a "Mir Jafar" and alleged that he had been propped up by the BJP to cut the Congress' votes in Jammu and Kashmir.

Pak Raking Up IWT Violation Without Any Reason: Jitendra Singh

JAMMU: Union Minister Jitendra Singh on Saturday said Pakistan is habitual of making unnecessary noises alleging violations of the Indus Waters Treaty (IWT), even though there has been none and India has always stood by its end of the pact.

ister of State in the Prime Minister's office comes on the heels of India issuing a notice to Pakistan seeking a review and modification of the IWT in view of Islamabad's "intransigence" in complying with the dispute redressal mechanism of the pact that was inked over six decades ago for sharing of waters of cross-border rivers. The step comes around 10 months after the World Bank

announced appointing a neutral expert and a chair of the Court of Arbitration under two separate processes to resolve the differences over the Kishenganga and Ratle Hydro Electric Projects following Islamabad's refusal to address the matter through bilateral talks.

"IWT has a long history after it was signed in 1960, giving control of three rivers each to India and Pakistan. While Ihelum, Chenab and Indus were given to Pakistan, India was given the control of Ravi, Beas, and Sutlej.

"The first phase of Shahpur Kandi dam project on river Ravi is nearing completion. The project was in limbo for the last 40 years and our share of water was also flowing across the border.

"Similarly, the Ratle project

in Kishtwar over Chenab was abandoned for eight years and the work on it started only last year under joint venture between the Centre and the UT administration," Singh told reporters on the sidelines of a function in Kathua district.

He said Pakistan has raised an objection and is claiming violation of the IWT but India's position is strong as there was no violation and the waters are allowed to flow into Pakistan as per the agreement, despite construction of dams and other projects.

"They are habitual of creating disturbances without any reason The concerned ministry has already taken up the issue with Pakistan," the minister said, adding the government will do whatever is necessary in the national interest.

Unabated Rise of Drug Abuse in Kashmir

Addiction is a neuropsychological disorder characterised by a persistent and intense urge to engage in certain behaviours, one of which is the usage of a drug, despite substantial harm and other negative consequences. Drug addiction, also called substance use disorder, is a disease that affects a person's brain and behaviour and leads to an inability to control the use of a legal or illegal drug or medicine. Substances such as alcohol, marijuana and nicotine also are considered drugs. When you're addicted, you may continue using the drug despite the harm it causes.

Drug addiction can start with experimental use of a recreational drug in social situations, and, for some people, the drug use becomes more frequent. For others, particularly with opioids, drug addiction begins when they take prescribed medicines or receive them from others who have prescriptions.

Globally, some 35 million people are estimated to suffer from drug use disorders and who require treatment services, according to the latest World Drug Report, released by the United Nations Office on Drugs and Crime (UNODC). The most widely used drug globally continues to be cannabis, with an estimated 188 million people having used the drug in 2017.

As per the study conducted by Institute of Mental Health and Neuro Sciences Kashmir (IMHANS-K) titled as "Prevalence and Pattern of Substance Use in 10 districts of Kashmir; A 2022 survey', J-Kashmir has surpassed the number of drug abuse cases in Punjab.

Thousands of youth in Kashmir are slipping into the dark alleys of drug addiction as the valley has been flooded with a huge quantity of heroin usage. The J-Kashmir administration had said as per a consumption survey there are at least 6 lakh residents affected by drug related issues in the region.

Over 33 thousand syringes are used to inject heroin by drug abusers in the Valley on a daily basis. Heroin is among the most common drugs used by these abusers. The study shows 90 percent of drug abusers are using heroin while the rest are using cocaine, brown sugar, and marijuana. The survey has also revealed that most of the drug abusers are in the age group of 17-33 years. Unemployed youth are one of the main consumers of these drugs. And



the number of drug abusers in the valley has crossed 67000, while 33000 are injected heroin using syringes. Drug use has become an easy escape from the fluctuating situations of life.

Among the most potential causes attributed to the skyrocketing drug abuse in Kashmir are, unusual increase in psychiatric disorders, uncertainty of the conflict, unemployment among the youth and non-availability of recreational activities.

Our youth see it as an escape from the uncertainty and trauma of living in a conflict region. But it has unnecessarily taken a heavy toll on our youth who are the future of our society.

Our valley is in the grip of an epidemic and the biggest victims of this epidemic are our youth. Over the last few years, there has been an extraordinary increase in anti-social crimes in our valley. It is said that the main reason for these crimes is the increasing use of drugs among the youth. Drug use has become a scourge for us which is giving rise to many social evils. The growing trend of drugs in the Valley should be of concern to all of us as it is eating up the vitals of our society.

Diagnosing drug addiction (substance use disorder) requires a thorough evaluation and often includes an assessment by a psychiatrist, a psychologist, or a licensed alcohol and drug counsellor. Although there's no cure for drug addiction, treatment options can help you overcome an addiction and stay drug free.

The eradication of drug addiction needs a multi-pronged approach. There is an urgent need for legal, social and religious measures to prevent drug addiction. Although the state government has taken strict measures to eradicate the scourge of drugs, several serious measures are needed to eradicate this epidemic. The laws that are in force for the prevention of drug abuse should be implemented in a better way and these laws should be enforced and made stricter. Cultivation, sale and misuse of cannabis and opium should be completely banned. It is necessary to have cooperation between the administration and the people. Only then can our society get rid of this evil.

There is an urgent need for measures not only by the government but also by the society to end this scourge. Civil society groups need to be mobilised to stop drug trafficking at the local level. Parents should monitor the activities of their children and protect them from getting addicted to drugs and falling into the clutches of drug addicts. Although there has been a lot of awareness among people about the harmful effects of drugs, this awareness needs to be spread to those areas and people who are unaware of it.

Another aspect of drug abuse prevention is the rehabilitation of victims of this scourge. But recovery must be consistent and victim-focused. The rehabilitation centres should take proper care of the psychological and emotional needs of the victims, so that the victims can fully recover and move towards a prosperous future. These rehabilitation measures include preventive education and awareness building, capacity building, skill development, vocational training and livelihood support for ex-drug addicts, among other relevant measures to stop this epidemic before it is too late.

n Tuesday, they reset the Doomsday Clock to 90 seconds before midnight. How did they know that Germany would agree to give Leopard 2 tanks to Ukraine on Wednesday? Now we're all doomed! Ninety seconds is barely time to tuck your head between your knees and kiss your posterior goodbye. The Doomsday Clock was thought up in 1947 by the Bulletin of the Atomic Scientists to dramatise the threat of nuclear war. They set it at seven minutes to midnight, and have been moving it back and forth every year since to tell us how close we were to a nuclear holocaust.

It dropped to 17 minutes to midnight after the end of the Cold War and the collapse of the Soviet Union in 1991. Now it's just a minute and a half the closest it has ever been — but may be it is just inflation, as with everything else. The Russians are certainly not panicking at the prospect of Leopard tanks with Ukrainian crews showing up to confront them in eastern Ukraine in a month or two (or three). A couple of weeks ago, Moscow hinted that this could be the step that 'forced' it to escalate to nuclear war, but that seems to have been the usual bluff.

Now that Western tanks actually are coming — American M1 Abrams, British Challengers, Leopard 2s from Germany and up to half a dozen other NATO members, probably Leclercs from France — the Russians are playing it cool. Kremlin's spokesman, Dmitry Peskov, said that the new tanks "will burn like all the rest." Some of them will burn, of course: there's no such thing as an invulnerable tank. But the current rate of exchange, with old Soviet tanks on both sides, is two or three-to-one in favour of Ukraine, mainly because its crews are better trained and more committed. With better tanks than the Russians as well, the Ukrainian advantage will obviously widen.

The question is: will it widen enough for Ukraine to take back more Russian occupied territory, and if so how much? The new tanks are not wonder-weapons, and the fact that they will come in four different types is a logistical nightmare: different ammunition, different spare parts, and even different fuel in the US's **Stop The Clock**

case. There will also not be very many of them, at least in this round of donations. A 'company' of tanks is fourteen or thereabouts, and Germany, the United Kingdom and Poland will be sending one company each. Smaller countries like Finland and the Czech Republic are unlikely to give more, and the United States of America is talking of about 30 M1s — two companies.

That means the total number of Western tanks being given to Ukraine is likely to be less than 100, whereas Ukrainians have always said that they need at least 300 to push the Russians back to their own borders. The long-planned Ukrainian winter offensive may have been cancelled because, first, the ground is still not frozen hard, and second, the new tanks will be in the hands of trained Ukrainian crews by the spring. The great Russian winter offensive is underway right now, but getting very little notice because it is making so little progress.

Let's assume for a moment that the Ukrainians will wait till spring, that the new tanks make a difference, and that the Russians lose a lot more ground. Would that justify putting the Doomsday Clock ahead to ninety seconds to midnight? Winning in Ukraine may be an existential

matter for the Russian dictator, Vladimir Putin, who has staked his reputation and perhaps even his life on making a success of the invasion, but it's not a life-or-death issue for the ambitious men around him. They certainly don't want to die for him, together with their entire families.

So the NATO assessment that a Russian resort to nuclear weapons in Ukraine is most unlikely, which underpins the NATO decision on the tanks, is almost certainly correct. How much of their country the Ukrainians can recapture remains to be seen, but they are at least free to try.

Faiz: I have played some good innings. But I can't recall at the moment which one I liked best.

Every good player always remembers his favorite inning

Faiz: I played one inning to make my nation proud. It presented me with several challenges. My heart was bleeding, yet no one was able to get me out. Anwar: Which inning was it?

Faiz: It was my second test, "Dast-e-Saba." My best inning, in my opinion, was "Dast-e-Saba." ("Dast-e-Saba" is Faiz Ahmed Faiz's second collection of poetry and it commemorates his confinement in Hyderabad jail.)

Anwar: Are you afraid of playing against fast bowling?

Faiz: I have never worn a helmet. Anwar: Why is that?

Faiz: Breathing in an air of freedom has its own appeal. What will I gain by carrying an unwanted burden on my head?

Anwar: But you must have had opportunities to wear a helmet?

Faiz: Brother, I was a different kind of player. Do not misunderstand me.

Anwar: I have heard that you have often

been clean-bowled.

Faiz: You should sometimes listen to the truth. I was always caught out. I have never been bowled out.

Anwar: Which side did you get caught out on the most often?

Faiz: Always on the right side since my left side was always strong. This was the reason I played even a right-direction ball towards the left, and in the slips, somebody always caught me out.

Anwar: Do you not play cricket as much these days?

Faiz: I am not playing any less right now, but there isn't another player in sight. How long would I play by myself?

Anwar: Okay, tell me one thing. Why is the selection committee always against you? Faiz: Brother, they are not opposed to me without a good reason. When a test player

himself is against the selection committee, then their anger is justified. Anwar: What do you believe is necessary

for one to play a good inning?

Faiz: A pen, some paper, and a newspaper.

These things must be good. Anwar: Do you bowl?

Faiz: I am a left-arm googly bowler.

Anwar: How are you as a fielder?

Faiz: I am a very good fielder, but I have missed so many fours.

Anwar: Why is that?

Faiz: The issue is that I can not bend down

Are Your Cats Fighting Or Playing? Scientists Analyse Cat Videos To Figure Out The Difference

ave you ever worried if the play between your cats was getting too rough? A new study published in Scientific Reports has investigated play and fighting in cats.

Their aim was to use simple behaviours anyone could observe to work out what was play and what might lead to fights.

This is important because the consequences of fights include injuries to animals and humans. At worst, you may even have

analysed statistically to work out which behaviours appeared together

in clusters From this, the researchers separated the videos into three categories of interactions.

Playful: included 40 per cent of cats from the videos and included wrestling and a lack of vocalising.

Type 1 diabetes is one of the most common chronic diseases in children, but the disease can also develop in

adults. In the disease, the body's own immune response destroys beta cells in the pancreas so that the body can no longer produce insulin. People with type 1 diabetes need to take insulin injections or use an insulin pump and strictly tract their blood sugar levels for the rest of their lives, which requires a lot of effort.

Medication To Treat Early Type 1 Diabetes

The beta cells die slowly, so everyone with newly developed type 1 diabetes continues to produce insulin during the first years of the disease.

"They benefit greatly from the remaining insulin their body produces. If they could just maintain this production,

treating type 1 diabetes would be much easier. So far, we have not had a good treatment for preventing beta cell death, but we have reason to believe that a medication currently approved for individuals with psoriasis could have a protective effect for individuals with type 1 diabetes," says Marcus Lind. Based on immunological patterns in the blood, currently researchers can determine with a high probability who will develop type 1 diabetes (stage 1 of type 1 diabetes) within a few years. About a year before the onset of the disease, they can then see disturbances in the blood sugar pattern with stress tests, even if criteria for diabetes are not met (stage 2 of the disease). When clinical onset occurs, it is classified as stage 3.

"If we succeed in identifying the immunological mechanism that is central to the destruction of beta cells, we will also be able to screen children and adults in the future and treat them even before the onset of the disease. Categorising cat 'fights'

The study, led by Noema Gajdoš-Kmecová from the University of Veterinary Medicine and Pharmacy in Slovakia and the University of Lincoln, UK, analysed 105 videos of interactions between 210 cats.

The research team then developed an ethogram – a list of specific behaviours used in the study of animal behaviour. These were put into six groups:

Inactive: head and body motionless and in a specific position, for example, crouching

Chasing: one cat runs in pursuit or another cat runs awayOther interactive activities: for example grooming, approaching, and raising fur on the back.

Non-interactive: activity directed towards themselves or an inanimate object, for example, drinking self-licking

ple landed in this group. Intermediate: group included 28 per cent of cats and was more

closely associated with the playful group than the agonistic group. Cats in this group interacted for prolonged periods with pauses in between.

As a crosscheck, these behavioural categories observed from the videos agreed fairly well with how the four authors, experts in cat behaviour, described each interaction.

What does this tell you about your cats' play?

If your cats are wrestling, they are most likely playing. When there is friction between cats in a multi-cat household, they tend to avoid physical contact. Instead, they'll use offensive or defensive manoeuvres that don't involve extended direct

contact, such as slapping. If your cats are vocalising, and chasing between periods of inactivity (such as crouching) they are most likely fighting Vocalisation is

Govt Pushes For Self-Sufficiency In Seed And Cattle Stock In J&K

JAMMU: Additional Chief Secretary (ACS), Agriculture Production Department (APD), Atal Dulloo Saturday reviewed plans for procurement of seeds and seed germplasm for the Union Territory, here at a meeting held here in the Civil Secretariat.

The Directors of Agriculture from both provinces provided updates on the registration of Certified Seed Producers (CSPs) to ensure availability of sufficient seed stocks for crops such as pulses, vegetables, paddy, maize, potato and oil seeds.

Atal Dulloo stressed the importance of ensuring that the seeds are tested and that the CSPs have the capacity to provide the required quantity. He also directed that the tendering process be completed well in advance and asked about the availability of funds with the departments. The Directors were instructed to ensure the availability of seeds before March 15, 2023

The ACS also directed the Directors to sign necessary MoUs with the National Seeds Corporation and to prepare their

farms for producing foundation seeds in order to achieve the required seed replacement rate in near future. The requirement of breeder seeds for the next financial year, its Rabi and Kharif seasons and subsequent years was also discussed.

The Director Agriculture Kashmir assured that the target of 250 registered CSPs would be achieved by the end of the current financial year and that sufficient quantities of paddy seeds are available.

In talks with the Animal Husbandry Department, the ACS emphasised the need for increasing semen stock and procurement of bulls to ensure that the UT is self-sufficient in cattle stock. He highlighted the importance of upgrading semen stock in the UT and the need for Artificial Insemination infrastructure for the production of high quality semen.

The Directors were instructed to issue tenders for procurement of bulls and to provide training in artificial insemination under the Multi-purpose AI Technician in Rural India (MAI-TRI) program.

Hindenburg Research: SBI Defends **Exposure To Adani Group**

NEW DELHI: Indias largest lender State Bank of India (SBI) said on Friday that its exposure to the Adani Group was well below the Reserve Bank of Indias (RBIs) Large Exposure Framework and was secured by cash generating assets.

The statement comes at a critical juncture with markets tanking on the basis of a short selling report from Hindenburg Research with the Adani Group caught in a maelstrom losing Rs 4.18 trillion in market cap in two trading sessions. The report by US-based investment research firm Hindenburg Research alleged that the group was engaged in "a brazen stock manipulation and accounting

fraud scheme". The conglomerate has called the report "maliciously mischievous, unresearched". It has said that it is "evaluating the relevant provisions under US and Indian laws for remedial and punitive action against Hin-

denburg Research". Indian banks have an exposure of around Rs 80,000 crore to the Adani Group, which is 38 per cent of the group's total debt.

"While as a matter of policy, we don't comment on individual clients, in the interest of setting the context right, we wish to clarify that SBI's exposure to Adani Group is well below the Large Exposure Framework. All exposure to the group from SBI is secured by cash generating assets with adequate TRA/Escrow mechanism in place, hence debt service will not be a challenge,"

said Swaminathan I., MD of corporate banking and subsidiaries at SBI, in a statement.

The SBI, however, did not comment on the amount of its exposure to the group.

With Indian equity markets roiled by a research report emerging from the US, everyone is curious as to what short selling actually means?

A 32,000-word report by American short-seller Hindenburg Research has left a Rs 4 lakh crore gash on the portfo-lios of bulge bracket Adani bulls which have been enjoying the gravity defying valuations since the Adani Wilmar public issue more or less a year ago. Every word shaving off Rs 12.5 crore from the valuation.

So, what is short selling? Simply put, someone takes position by selling stock or other securities or commodities which one does not own at the time. in the hope of buying at a lower price before the delivery time.

Investopedia describes it in the following manner - selling is an investment or trading strategy that speculates on the decline in a share or other security's price. It is an advanced strategy that should only be undertaken by experienced traders and investors.

Pakistan's Foreign Loan **Inflows Slow Down**

ISLAMABAD: Pakistan received only USD 5.6 billion in foreign loans during the first half of the current fiscal year, equal to about one-fourth of the annual budget estimate, due to the cash-starved country's failure to take timely decisions about reviving the IMF loan programme, according to a media report on Saturday.

Data compiled by the Ministry of Economic Affairs showed that foreign loan disbursements from July to December 2022 stood at a mere USD 5.6 billion, the Express Tribune newspaper reported, adding that the disbursements were not enough to finance the maturing foreign debt, making a severe dent in the foreign exchange re-



ber, which were not sufficient for making major repayments. In the past seven days, the

country paid USD 828 million to Chinese financial institutions. As a result, the official foreign exchange reserves slipped to

USD 3.1 billion. About 44 per cent of the loans received in December came from the Asian Development Bank (ADB), which gave USD

231 million. So far, the ADB has remained

Hyundai, Kia Sued In US For Lack Of Anti-Theft Technology

SEOUL: A Seattle City attorney in the US has filed a lawsuit against Hyundai Motor and its affiliate Kia for the lack of anti-theft technology in some of their models, the carmakers said.

In the suit filed in the federal court, Seattle City Attorney Ann Davison argued the carmakers' failures to install anti-theft technology in some vehicles led to a sharp increase of their car theft in Seattle and other regions.

The city said from 2021 to 2022, thefts of Hyundai and Kia cars increased by 503 per cent and 363 per cent, respectively, reports Yonhap news agency.

Hyundai and Kia expressed regret over the legal action in Seattle while apologising for the inconvenience to affected customers.

"In response to increasing thefts targeting our vehicles without pushbutton ignitions and immobilizing anti-theft devices in the United States. Hyundai Motor America has made engine immobilisers standard on all vehicles produced as of November 2021," Hyundai said in a statement.



In addition, the company has taken a series of actions to deter thefts of affected vehicles, including an upcoming software update set to be available from next month and provided at no cost to customers, it said.

Kia said it has been developing and testing enhanced security software for vehicles not originally equipped with an immobilizer and has started notifying owners of certain models of the availability of this software upgrade at no cost to customers.

Kia plans to make software upgrades available for most affected vehicles by mid-2023.

Forex Kitty Rises By USD 1.727 **Billion To USD 573.727 Billion**

MUMBAI: India's forex reserves increased by USD 1.727 billion to USD 573.727 billion in the week ended January 20, the Reserve Bank of India said on Friday.

This is the second consecutive week of a rise in the kitty after the USD 10.417 billion jump to USD 572 billion during the preceding week.

In October 2021, the country's forex kitty had reached an all-time high of USD 645 billion. The reserves have been declining as the central bank deploys the kitty to defend the rupee amid pressures caused majorly by global developments.

In October 2022, the reserves had swelled by USD 14.721 billion during a week.

During the reporting week, the foreign currency assets, a major component of the reserves, increased by USD 839 million to USD 506.358 billion, according to the Weekly Statistical Supplement released by the RBI on Friday.

Expressed in dollar terms, the foreign currency assets include the ef-



fect of appreciation or depreciation of non-US units like the euro, pound and ven held in the foreign exchange reserves.

The gold reserves continued to rise, jumping by USD 821 million to USD 43.712 billion, the RBI said.

The Special Drawing Rights (SDRs) were up by USD 68 million to USD 18.432 billion, the apex bank said.

The country's reserve position with the IMF was down by USD 1 million to USD 5.226 billion in the reporting week, the apex bank data showed.

Piyush Goyal Calls For Creation Of Network To Strengthen Start-Up Ecosystem

HYDERABAD: Union Minister for Commerce and Industry Piyush Goyal on Saturday called for the creation of an international network of mentors, investors and entrepreneurs to strengthen the global start-up ecosystem.

In a video address to the Inception Meeting of the Start-up 20 Engagement Group of G20 here, he said this network must support and inspire start-ups, act as a team to facilitate exchange of ideas, best practices and funding mechanisms and promote collaborations in research and development.

He said it is not just the role of individual nations to support innovation and added that it will have to be the collective responsibility of world nations to nurture a global effort to incubate start-up ecosystems in all parts of the world.

This creates a global start-up ecosystem that is inclusive, supportive and sustainable to address global



challenges. Goval said India was proud to highlight the progress and potential of the global start-up ecosystem as the host nation of G20. He noted that the Startup20 Group had been established under India's G20 Presidency for the first time, as part of India's special focus on innovation. Observing that innovation would be the strongest pillar that would help build a developed India in the 'Amritkaal', he said innovation has been a catalytic force for the economy and social and public good. "Innovation in today's world goes beyond achieving mere economic objectives as it also considers societal inclusion and environmental sustainability," he added.

Economically Weaker Sections (EWS). "Post-August 5, 2019," argues scribe Yawar Hussain in his recent report, "reservations stand at 60 per cent in Jammu and Kashmir."

It includes 8 per cent for SCs, 10 per cent for STs, 4 per cent for Other Social Castes (OSC), 4 per cent for Residents of Actual Line of Control and International Border, 10 per cent for RBA, 4 per cent for Pahari Speaking People (PSP), and 10 per cent to EWS. Besides, the report reveals, there is a horizontal reservation of 6 per cent for ex-Servicemen and 4 per cent for Physically Challenged People.

"The government also increased the yearly income ceiling for socially and educationally backward classes from Rs 4.50 lakh to Rs 8 lakh, helping more people become eligible for reservations.

The most recent census conducted for reservation quotas was in 2011 throughout India. The same was executed for J&K save the recent amendments brought about post-2019, essentially increasing the percentage of reservations using the old census. Observers in the valley believe that the principle of creamy layer exclusion ought to be taken into the ambit of the reservation. "But certain people assume undue advantage of the reservations," argues Imtiyaz Lone, an analyst writing on social issues. "In the disguise of their scheduled categories, these people play a gambit."

Going by the journal of 'Legal Services of India', members ascribed as the 'creamy layer' of a backward class are socially, economically and educationally advanced compared to the rest of the members of that community. "They constitute the forward section of that particular backward class and eat up all the benefits of reservations meant for that class without allowing benefits to reach the truly backward members."

Such unfair practices, Lone says, further entrench the reservation policy as the ones truly deserving are devoid of these benefits.

"The insubstantial absence of checks and balances on the part of the authoritative bodies leads to such malpractices," he says. "It remains imperative that a census is executed regularly for the maintenance of a track record of the reservation quotas. The creamy layer exclusion principle needs to be extended to all the categories of the reservation, irrespectively.'

The Supreme Court also adjudicated that the 'creamy layer' among the reserved category be kept out of the purview of reservation, which shall not exceed 50 per cent, cautioned the government that excess quota will result in reverse discrimination. "Equality of opportunity has two different and distinct concepts," the apex court notes.

There's a conceptual distinction between non-discrimination on principle, and affirmative action, under which the state is obliged to provide a level playing field to the oppressed classes, said a five-judge Constitutional Bench headed by Chief Justice Y.K. Sabharwal in M. Nagraj's case.

The bench opined that reservation is necessary for transcending caste, not for perpetuating it. Reservation has to be used in a limited sense, the court observed, otherwise it will perpetuate casteism in the country.

The equality of opportunity under Article 16(1) is for each citizen, while the special provision under Article 16(4) is for socially disadvantaged classes," the judges said. "Both should be balanced, and neither should be allowed to eclipse the other.'

Therefore if in a given case, the court finds excessive reservation under the state enactment, such enactment is liable to be struck down since it would amount to the de rogation

There is an evidence that above mentioned immovable property was being used for planning and execution of terrorist and secessionist activities and for offences for which accused has already been charged, therefore above said property i.e. building/office of APIIC situated to Rajbagh Srinagar (UT of J&K) may be attached u/s 33(1) of UA(P) Act."

Citing several judgments, the court of Additional Sessions Judge New Delhi noted that section 24 expands the expression of the "proceeds of terrorism" and makes it clear that such expression shall also include "any property intended to be used for terrorism".

"APHC was the place where meetings were held to strategize different protests, funding activities of stone pelting on security forces, recruiting unemployed youths to carry out unlawfül activities as well as terrorist activities to create an unrest in the erstwhile State of Jammu & Kashmir to wage war against the Government of India," were the major points that were noted by the Delhi court court.

Sidharth Luthra, ld. Sr. Advocatc appearing for NIA submitted that Section 33 is independent provision subsection (11) of which empowers the court to pass an order attachment of all or any property belonging to the accused facing the trial of offences falling under Chapter IV and VI of the Act.

The court said "Section 33 of the Act at least does not in any manner hinder powers of court to attach any such property of which accused is facing trial under Chapter IV and VI of the Act of which he may be partly owner, thus ordered the attachment of the office of All Parties Hurriyat Conference situated at Rajbagh, Srinagar. The BJP led central government, on August 5. 2019, revoked Article 370 that gave special

status to Jammu and Kashmir. "Rahul Gandhi's yatra comes like a breath at the party headquarters at M A Road here, following which a public rally at Sher-e-Kashmir Stadium here for which 23 opposition political parties have been invited.

Interestingly, this will be the first massive public gathering in Kashmir Valley after the abrogation of J&K's semi-autonomous status in August 2019. The Yatra, so far, has witnessed overwhelming response from the people of the Valley with men, women, kids and youth marching with Congress leaders. Coordinator of Bharat Jodo Yatra, Ghulam Amad Mir told Kashmir Observer that Gandhi will hoist the national flag in Lal chowk and his party is in touch with the administration to seek permission for the same.

He said the leaders from around 23 opposition parties are set to join Gandhi in the stadium where he will address the gathering. "Apart from congress workers, the general public including women and youth are likely to attend the gathering," he said.

Defending senior party leader Jairam Ramesh's comments that BJY will not discuss political issues of Jammu and Kashmir like abrogation of Article 370 and PAGD, Mir said that Yatra was meant for connecting people of the country and the party has limited the yatra on this issue only.

"Every state has different political issues, we can discuss it on other platforms but this vatra was meant for different issues," Mir added.

He further said that Congress has made their stand on the abrogation of Article-370 very clear and they will never change it.

It is a Centre-Left party. Every party veers around to the Congress point of view, to the middle path, the path of consensus and conciliation," ĥe said.

"So yes, we are the fulcrum. If we are going to take on the BJP, it is only a coalition around the Congress (that can do so)," he added.

Addressing a press conference at the Pradesh Congress Committee (PCC) office in Srinagar, Ramesh said after the Yatra, opposition parties will begin the process of talks and political negotiations, but the cross-country march had nothing to do with it.

"It's impractical to percept that a backward class always remains a backward class," the scholar quoted above says. "The reservation policy purposed to move the economically, socially and educationally downtrodden populace towards progression. And after a portion of this populace assume these benefits, the governing authorities are liable to make sure of the revocation of their reserved status."

Even the Supreme Court rules that the states are bound to review reservations from time to time as people cannot fall under a category permanently. "The whole objective of the reservation gets negated in that sense," the court observed.

Often is the case that the politicians play the reservation card to secure their vote bank, says Mehnaz Gani, a social activist. "Gradually," she says, "many other sub-communities start demanding reservation within a community and meritocracy gets slashed by all sides.'

It is more plausible, Gani says, if the government provides better aid to these scheduled categories than compromising on merit. "The concept of reservation was to exterminate disparities on various grounds, from education, workplaces and society by large. But how far have we come?"

Inequality has to be washed off the minds. which is hard to achieve with the perpetuity of reservations, the analyst quoted above says. "Often the merit of the people from reserved classes gets subdued and becomes inconspicuous owing to the stigma of reservations attached to them."

Relying on the decades-old census shall be fallible, he continues. "Perhaps, there could be a stratum of the population that has forever been oblivious and uninformed about the benefits of reservation. Renewing the census shall help such sections of society. The upper age limit is more for reserved categories than for the general category. Even the physically handicapped category has a year lesser than the other categories.'

Further, he says, many instances have shown a pattern of a certain reserved category faring well in competitive exams and falling in general merit.

"It falls on the government to check if these reserved categories truly deserve the reservation," the analyst says. "At the end of the day, reservations stand for equal representation. It should not stand for the over-representation of reserved ones and under-representation of the General Category.'

Barely able to walk about 500 metres amid jostling by the huge crowd, the yatra had to halt and Gandhi's security team advised him not to go ahead.

Gandhi then drove to the Khanabal area of Anantnag district where he stayed for the night.

On Saturday, Gandhi also stopped the yatra for a few minutes to pay floral tributes to the 40 CRPF personnel killed in a car bomb blast in Lethpora area of Pulwama district in 2019.

Gandhi laid a flower bouquet at the spot where the CRPF bus was blown up by a Jaish-e-Mohammad suicide bomber along the Jammu-Srinagar national highway four years ago.

"Today, paid my humble tributes to the 40 brave martyrs of Pulwama at their martyrdom site. The life of every soldier of the country is priceless. India will never forget their sacrifice," he said in a tweet in Hindi later.

The yatra which started from Kanyakumari on September 7 reached Pantha Chowk on the outskirts of Srinagar on Saturday.

After a night's halt there, the yatra would resume on Sunday morning from Pantha Chowk and would culminate near Nehru Park on Dal Lake Boulevard in the city. Sunday will mark the last walking day of the yatra.

"Long years of being in power has been detrimental to the organisational vitality. With the Bharat Jodo Yatra, this (organisational vitality) has gotten a booster and momentum but that has to be sustained," Ramesh said.

"We cannot go back to having conflicts within the organisation between leaders, clashes among different groups. One would expect that after the Bharat Jodo Yatra, we have found a higher purpose," he stressed.

The Bharat Jodo Yatra is a great cause involving a large number of Congress workers and the largeness of the cause must reflect in our behaviour and approach when it comes to a halt, otherwise, this will just be one episode, Ramesh said.

Focus On Kishan, Hooda In Must-Win 2nd T20 Vs New Zealand

LUCKNOW: India will have to raise their game a few notches as the hosts face a must-win situation in the second T20 International against New Zealand, in Lucknow on Sunday.

India were caught in a spin web on the Ranchi pitch as they lost the series opener by 21 runs on Friday.

The loss also highlighted India's bowling profligacy, especially by the pace duo of Arshdeep Singh and Umran Malik.

If tearaway pacer Malik conceded 16 runs in one over, Arshdeep leaked 27 runs in the 20th over, which put pressure on the India batters while chasing.

That expensive over from the young left-arm quick was the turning point as he was smashed for three sixes and a boundary.

India's batters were off to an inauspicious start with the top-three managing just 15 runs. The hosts ended up scoring 155/9, which would have been a par score to defend on the wicket, as indicated by Washington Sundar after the match. "150 would've



been par and we would've been very happy with it," the bounce back. India all-rounder said.

Skipper Pandya, however, is unlikely to bring in uncapped pace bowler Mukesh Kumar for the second T20I and will

probably back Arshdeep to While Shubman Gill, who

has been in red-hot form in the ODIs, has played just four T20Is and is still learning the nuances of the shortest format, the big concern will be the two key batters -- Ishan Kishan and Deepak Hooda.

Occupying the opening spot, Kishan is nowhere near the ominous form he showed while slamming a record-

If one just considers the T20Is, it's been a while since he last scored a fifty -- against South Africa on June 14, 2022.

Hooda, too, hasn't enjoyed much success as a lower middle-order batter and averages just 17.88 in the last 13 innings, with the highest being the unbeaten 41 against Sri Lanka at the Wankhede Stadium in Mumbai.

His innings of 10 runs from 10 balls at No. 7 on Friday lacked impact and the rotation of strike also came under scrutiny, especially when the New Zealand spinners were bowling.

While India are unlikely to try out newcomer Jitesh Sharma in the role of wicketkeeper-batter in the middle-order on Sunday, time is certainly running out for Hooda and Kishan.

Despite the loss on Friday, there was a huge positive for India in Washington Sundar, who not only bowled a tidy four overs of spin to take two wickets, but also emerged India's topscorer with a 28-ball 50 batting at No. 6.

With No.1-ranked T20I batthe last seven innings in both ODIs and T20Is read 37, 2, 1, 5, ter Suryakumar Yadav in terrific form, India would need someone at the top of the order to raise their game and do some big hitting, given that the Ekana Stadium has big boundaries.

The Kiwis, on the other hand, would look for another victory to secure a memorable series win in India and bounce back after getting thrashed 0-3 in the ODI series. They will once again rely heavily on their in-form duo of Devon Conway and Daryl Mitchell.

With this win, India finished at ninth position in the tournament and are tied with Argentina

In the first quarter, India showed attacking gameplay and made early inroads into the South African penalty circle. Nicholas Spooner of South Africa got a green card in the third minute.

The home side got an early lead in the fourth minute after Abhishek collected a pass coming into the scoring circle and smashed it in the nets taking the scoreline to 1-0.

After winning a penalty corner in 11th minute, skipper Harmanpreet Singh also joined the scoresheet with a brilliant

conversion.

India finally got a goal in the 45th minute. It was Shamsher Singh who scored the goal after Abhishek received an aerial pass, which he sent to Shamsher.

In the final quarter, Akashdeep scored a goal in the 49th minute. Jarmanpreet was stuck on touchline on the right side of the goal, he squared the pass and Akashdeep was able to get a touch. The scoreline was now 4-0 in favour of India.

South Africa managed to open its goal count in the 49th minute itself, Samkelo Mvimbi received an aerial pass and sent it past the goalkeeper PR Sreejesh. The scoreline was now 1-4.

In the 59th minute of the match, Sukhjeet came back and gave support to Akashdeep, whose shot lacked power. Akashdeep found the ball at the front of the net and scored the fifth goal for India. JOHANNESBURG: Batting sensation Shafali Verma will chase history when she leads India against England in the first-ever ICC Under-19 Women's T20 World Cup final in Potchefstroom on Sunday.

For all their success at the international stage, the Indian women's cricket team has never won a World Cup at any level and the young batter, who has been part of two World Cup and one Commonwealth Games final with the senior team, will look to bring the elusive title home.

The seniors have made the World Cup final on three occasions across formats only to have returned with bitter memories -- losing to Australia by 98 runs in 2005 and losing to England by 9 runs in 2017 in the ODIs, and in T20Is they went down in the 2020 final to the Aussies by 85 runs.

The youngster from Rohtak has been part of two World Cups across formats and she also witnessed another final defeat when India had settled for a silver medal in last year's Birmingham Commonwealth Games.

Usain Bolt Fires Business Manager Over Jamaica Fraud Case

SAN JUAN: Jamaican sprinter Usain Bolt told reporters Friday that he is baffled over how \$12.7 million of his money has gone missing from a local private investment firm that authorities are investigating as part of a massive fraud that began more than a decade ago. Bolt also said he has fired his

business manager, adding that it was not an amicable split.

When asked if he was "broke," the retired star athlete laughed. "I'm not broke, but it's definitely put a damper on me," he said. "It was for my future. Everybody knows I have three kids. I'm still looking out for my parents, and I still want to live very well."

Bolt's attorneys have said the athlete's account with Kingston-based Stocks and Securities Limited dwindled from nearly \$12.8 million to some \$12,000. They had given the company

Don't Take Selfies With Tourists Without Permission: Goa Government

Panaji: Next time when you are in Goa and want to take selfies with other tourists or click their pictures, take their permission before doing so in order to respect privacy.

This instruction forms part of an advisory issued by the Goa tourism department for tourists, and the set of directives is aimed to protect the privacy of travellers, ensure their safety and avoid getting cheated by unscrupulous elements, among other things.

"Do not take selfies and photographs without permission of other tourists/strangers, especially while sunbathing or sea swimming, so as to respect their privacy," according to the advisory issued on Thursday.

The advisory prohibits holidaymakers from taking selfies at dangerous locations like steep cliffs and sea rocks to avoid accidents and also highlights several other issues related to the tourism industry. The department has advised travellers visiting the coastal state not to destroy or damage heritage sites by scribbling graffiti or resort to other forms of disfiguring monuments. the Department of Tourism. "Consumption of alcohol in open areas like beaches, etc is prohibited and is a punishable offence. However, alcohol may be consumed responsibly inside the legally licensed premises like shacks/restaurants, hotels etc," the advisory said.

The department has said that tourists in Goa, which receives lakhs of holidaymakers every year from various parts of India and abroad, should refrain from hiring private vehicles/renting cabs/motorbikes that are not registered with the transport department and those that do not hold a valid permit.

"Tourists are advised not to entertain illegal touts or agents for booking water sports and river cruises. Tourists must insist on a registration certificate issued by the tourism department while booking such services and book such services only from registered travel agents or registered online portals," it said.

TEHRAN: One of Iran's top clerics, Nasser Makarem, has spoken out against the use of violence to force women into wearing the veil.

Iran has witnessed a wave of nationwide protests since the Sept. 16 death of Mahsa Amini, a 22-year-old ethnic Kurd, after her arrest for an alleged breach of the regime's dress code for women. Hundreds of people have been killed, including dozens of security personnel, and thousands have been arrested in the protests, which authorities generally refer to a "riots."

Makarem, a prominent cleric, said that he "does not consider violence and pressure to be effective in the hijab issue." "The president and ministers

should know that they are in a difficult situation; it is true the enemy is very active, but not all avenues are closed," he said, quoted by the IRNA news agency. 'The hijab issue is currently linked to political issues, and some people say that if they can remove the veil, the regime's system will be weakened," the cleric added.

Iran's Tourism and Heritage Minister Ezzatollah Zarghami earlier called for greater tolerance toward women not wearing mandatory headscarves.

Earlier this month, however, Iran's prosecutor general had called for police to "firmly punish any hijab violators.'

Iran has accused its foreign foes, including the US and Israel, of fomenting the protests that erupted over Amini's death in the custody of the country's morality police.

The cleric's remarks came as Israeli President Isaac Herzog urged the NATO military alliance

to toughen its approach to Iran, as Tehran supplies drones to Russia for its war on Ukraine.

"The crisis there goes beyond the boundaries of Ukraine, with the Iranian threat now at Europe's doorstep," Herzog said on a visit to NATO headquarters in Brussels.

"The illusion of distance can no longer hold. NATO must take the strongest possible stance against the Iranian regime including through economic, legal and political sanctions and credible military deterrence."

The figurehead leader became on Thursday the first Israeli president to brief NATO's main decision-making body.

"A terrible war continues to cause needless human suffering and compromise the well-being and welfare of millions," Herzog said.

"Our hearts continue to go out to the people of Ukraine as they defend their homes and their country," he said.

NATO chief Jens Stoltenberg said he had discussed "our support for Ukraine" with Herzog.

"The Ukrainian people are bravely defending their homeland and NATO allies and partners are helping to support their right to self defence," he said.

The NATO secretary general said Herzog's visit was a sign of the US-led alliance's "deepening partnership" with Israel.

Herzog pointed to bolstering cooperation on cyber-security, threats from space, drones, and energy resilience.

He said the two sides were slated to sign a new cooperation agreement "in just a couple of months, which lengthens the period of cooperation and expands it reach.
