# Administration Speeds Up Anti-Encroachment Drive In Kashmir

- 409 Kanal Land Worth Rs 240.58 Crore Reclaimed In Srinagar: Officials

Srinagar: A day after Lieutenant Governor, Manoj Sinha reiterated that the ongoing eviction drive was aimed at 'influential and powerful land grabbers', the Jammu and Kashmir administration on Saturday ran bulldozers on the properties of advocate Shabnum Lone, and former director information Farooq Renzu Shah in the twin districts of Srinagar and Budgam.

Besides it, land eviction drives were also carried out in Anantnag and Baramulla districts of the Valley as well.

According to officials, 409 kanal of prime state and Kahcharai land worth over Rs 240.58 crore was reclaimed from the influential land grabbers from all 7 Tehsils, including Eidgah, North Srinagar, Panthachowk, Khanyar, South Srinagar, Central Shalteng and Chanapora.

They said a joint team of revenue and Police headed by Tehsildar North, Kaiser Mehmood launched a massive anti-encroachment drive in



Dara and Danihama villages and retrieved 12 kanals of state and Kahcharai land worth Rs 3.60 crore from the land grabbers. In Ahal village of the Tehsil, the team, they said, also retrieved 35 kanal of land including a hotel worth Rs 35 crore.

#### J&K Eyes 10-15% Growth In Tourist Footfall This Year

**Mumbai:** The Jammu and Kashmir administration is expecting 15-20 per cent year-on-year growth in travellers visiting the Union Territory in 2023 and has developed 75 new destinations to reduce footfalls to the most visited places, a top official said on Saturday.

Over 1.8 crore people, including 20,000 overseas travellers, visited Jammu and Kashmir after the COVID-related restrictions were eased.

Jammu and Kashmir as an all-year-round destination is expecting 15-20 per cent growth in footfalls in 2023 compared to last year, J&K Special Secretary, Tourism, Amarjeet Singh said.

Tourism, Amarjeet Singh said.

"Looking at the growing interest of people wanting to visit Jammu and Kashmir, we have added 75 new destinations that have ample scenic beauty. This will not only reduce pressure from the popular places but also help in reducing the carbon footprint of the most visited place," Singh told PTI.

The government is focusing on homestays in these new destinations to maintain the scenic beauty and the ecology of the areas, Singh added.

Some of these new destinations are Bani in Kathua district, Aithem, Suchetgarh, Basholi, Sarthal, Pancheri, Ransoo, Budhal and many more, he noted.

"We have created basic infrastructure in these destinations and are promoting homestays. We want to maintain the existing natural beauty of these new places, which will be sustainable and attract people with an experience that will be in their memory for many years. More on P6

# Says Administration Keeping A Close Watch On Situation

Jammu: Lt Governor Manoj Sinha Saturday said the Jammu and Kashmir administration was keeping a close watch on two dozen structures in Doda developing cracks but denied the situation was akin to the land subsidence witnessed in Joshimath.

# **New Platform Aims To Develop Novel Therapies For Rare Diseases**

esearchers are working on a new platform that aims to develop several treatments, including gene and mRNA therapies, for three "rare" diseases which are estimated to affect about one million people

The Myo-Mission anchored by Ashoka University, Sonipat in partnership with 18 institutions and 38 investigators across India, will enhance capabilities for carrying out future clinical trials for Duchene Muscular Dystrophy, GNE Myopathy and Limb-Girdle Muscular Dystrophy (LGMD).

All the three diseases either lead to muscular weakness or muscle wasting, and can cause permanent disability.

"In India, estimates suggest that the three diseases combined affect about one million people. The burden of these debilitating, often incurable diseases is made greater by the rarity and lack of diagnosis and treatment options



in India," said Alok Bhattacharya, Professor of Biology at Ashoka University.

"Our goal is to develop patient cohorts, create a comprehensive database, and conduct research on disease progression to pave the way for clinical trials," Bhattacharya told PTI.

In its Phase 1, the mission plans to have five clinical centres in Mumbai, Bengaluru, Chennai, Delhi and Anand in Gujarat that have been

managing patients of these diseases. The mission researchers plan on different aspects such as developing systems or technology platforms for therapeutic molecules for treatment, as well as developing animal and cellular models for test-

ing purposes. The clinical groups associated with the mission will also monitor the progression of the disease for the Indian patients, the researchers said

Such models for diseases such as GNE myopathy and LGMD have not been done for Indian patients and are required for carrying out clinical studies and drug trials, according to a statement.

The mission researchers, who have applied for funding from the government, are aiming at multiple types of treatments. This is because not all types of therapies are suitable for all patients as well as different diseases, the re-

Availability of multiple therapies will help to provide clinical treatment to large fraction of patients, they said.

The platform being proposed are gene therapy, mRNA therapy, oligo-nucleotide-based therapies and small molecules that target known or novel disease associated molecules.

These technologies once developed, will also be useful for developing drugs for other diseases, according to the researchers.

A substantial fraction of all rare diseases are genetic disorders that mainly get inherited from parents. Since human beings have about 25,000 genes, a mutation in a set of genes carries a disease risk.

Globally, it is estimated that there are about 7,000 types of rare diseases out of which about 80 per cent are likely to have a genetic basis. The clinical methods of diagnosis for such diseases exist, however they are often not conclusive.

Usually, the final diagnosis can only take place through DNA sequencing of both parents and children, however, this method is expensive and not affordable for a large section of the population, especially in lower and middle income countries.

In India, about 500 rare diseases have been identified, Bhattacharya said.

The number of individuals suffering from one particular disease in the country may be small, however given the population size and number of such diseases, the overall burden is estimated to be quite large, approximately 7 crore individuals, he said.

### **DAK Calls For Population-Based Cancer Screening In Kashmir**

rinagar: On world cancer day, Doctors Association Kashmir (DAK) on Saturday called for population-based cancer screening in Kashmir valley.

"With cancer reaching epidemic proportions in the valley, screening people for cancer is the need of the hour," said DAK President Dr Nisar

Dr Hassan said cancer screening detects disease early and reduces the risk of dying

When a cancer is detected at an early stage, the chances of survival is dramatically higher than when detected at a later stage when the tumor has spread and the disease is more advanced.

"In a study survival rate for women diagnosed with cervical cancer at an advanced stage was just 15% compared to 93% when cancer was detected at an early stage," he said.

"Results from decades of research clearly shows that women whose breast cancer was detected early by screening mammography are less likely to need aggressive treatment, and are more likely to be cured."

The DAK President said with no screening. most patients in Kashmir seek medical attention at later stages of cancer.

"And when they come to an advanced stage, the treatment remains mostly ineffective and the chances of survival are less," he added.

Dr Nisar said people need to recognize that many cancers can be prevented by simple lifestyle measures

"Avoiding smoking, exercise and a healthy diet will reduce the risk of cancer," he said.

As per the union health ministry figures, Jammu and Kashmir has reported an estimated 51,577 cancer cases in last four years (2018-2022).

While lung cancer was found prominent among men, breast cancer was the most common cancer among women.

More than 22, 000 people have died due to cancer during the period of 2018 to 2021.

General Secretary DAK Dr Arshad Ai said there is a dire need to set up a separate cancer hospital in Kashmir.

# Rampant Use Of Polythene, **Single-Use Plastic In City**

Sale of polythene a 'big nexus', need public support to break it: SMC official

Srinagar: Despite the blanket ban on single-use plastic items, the rampant use of polythene is significantly contributing to the environmental pollution in Srinagar and other parts of the valley.

The authorities at the Srinagar Municipal Corporation (SMC) said they hold anti-polythene drives regularly and on a monthly basis while seeking public support to stop its use.

An official looking into the implementation of the ban on the use of polythene bags in Srinagar said that though regular drives are held, public support is needed to make the environment plastic and polythene-free

"To ensure the implementation of the ban of single-use plastic, we have a dedicated separate team with a nodal officer, but more than enforcement, it is public cooperation that can make a difference." the

The seized polythene bags are handed over to the J&K Pollution

Control Board, he added.

The High Court of Jammu & Kashmir and Ladakh (then High Court of J&K) banned the entry, use and sale of polythene bags at tourist destinations and healthcare institutions in 2006.

The official said that not just a dedicated team, the SMC has even empowered the Ward Officers to impose fines and seize polythene bags. He, however, added that the sale of polythene is a "big nexus", and to break it, they need public support. "People should understand and

realise how hazardous the use of polythene is for the environment and health," the official said. He said polythene bags are also the main reason for drain blockades. "It also leads to the contamination of water bodies," he added

Chief Enforcement Officer SMC said that the corporation is going to start many awareness programmes in the near future in schools where they will highlight the negative aspects of the usage of polythene bags and the damage it causes to the environment.

On June 18, 2008, the J&K government issued SRO 182 in accordance with the J&K Non-Biodegradable Material (Management, Handling, and Disposal) Act, 2007, banning all types of polythene bags in the state. However, successive governments have been unable to put the prohibition into effect.

In wake of that, Jammu and Kashmir Pollution Control Committee (JKPCC) last year issued a public notice prohibiting the production, stocking, distribution, sale and use of single-use plastic in the Union Territory.

In Srinagar, be it the roadside vendors selling fruits or vegetables, or shopkeepers; the use of polythene is open while the same is available in the wholesale markets as well.

In 2014, expressing displeasure over the non-compliance of its directions on the polythene ban, the High Court directed 14 deputy commissioners of the then-state to show cause as to why contempt proceedings should not be initiated against them "for defiance of the court or-

# 5 Sikhs Gunned Down In Srinagar

Indefinite Curfew In City Areas

RINAGAR - Indefinite curfew was imposed in parts of the city tonight fol-lowing killing of five per¬sons belonging to a particu¬lar community by some unidentified gunmen at Mehjoor Nagar today.

A vast area around the place has been cordoned off and house to house searches launched to apprehend the killers. The areas in which curfew was imposed fall in the jurisdiction of police stations Parimpora, Batamaloo, Rainawari, Ram Munshibagh, Sher Garghi, Sadr, Shaheed Gunj, Rambagh, Kot-

hibagh, Maisuma. Army and para-mili¬tary forces in strength have been deployed in these areas. According to reports, 6 to 8 gunmen swooped on Mehjoor Nagar locality across Rajbagh around 6 30 p.m. today and re-sorted to indiscriminate firing on a group of Sikhs there. They also entered a couple of houses. In the shoot out over a dozen Sikhs, including three of a fam-ily, were injured, some

of them seriously. The assailants who had reportedly come in a three-wheelers escaped from the area after the shoot-out. All those injured were rushed to various city hospitals where four of them succumbed to their injuries.

Those admitted in nearby Bone and Joint Hospital were

identified as Dharminder Singh (22) s/o Amarjit Singh r/o Aloochibagh, Amar Singh (35) s/o Prithipal Singh his mother, Chand Kour (48) and Balwant Singh (65) s/o Mai Chand Singh, all residents of Mehjoor Nagar. Of them, Balwant Singh succumbed to his injuries.

Four of the injured admitted in the SMHS hospital were

identified as Surjit Singh s/o Nirmal, Samir Pal Singh s/o Kanwar Nain Singh, Kanwar Nain Singh s/o Khayam Singh and Satinder Kour w/o Kanwar Nain Singh, residents of Mehjoor Nagar. Of them, Surjit Singh and Samir Pal Singh suc¬cumbed to their injuries (According to a report, one Gurmeet Singh had died on the

spot.) Some of those injured were shifted to the SK Institute of Medical Sciences where they were suited to in critical condi¬tion.

A NAFA report said late in the evening that army and para-

military forces had cor-doned off the Mehjoor Nagar locality and some adjoining ar—eas and started house-to-house searches. A Brigadier from 311 sub-area was stated to be com-manding the operation. The Inspector General of Police, Dr Ashok Bhan, was

camping in the area along with several sen-ior police officials.

Unconfirmed reports sug-gested that the security forces had entered several houses in the locality. A local agency rang up an acquaintance in the area twice this evening. The first time he talked to the friend, but when he rang up again, some-one picked up the phone made no answer, suggesting that there was something wrong in the house. Fear and tension has gripped the locality, and reports indicated many residents had fled from their houses out of fear.

This is the second major incident in which members of the Sikh community have been tar-geted. On the night of March 20, 2000, some unidentified gun-men massacred 35 Sikhs at Chattisinghpora, remote vil¬lage of Anantnag district A few days later the police claimed having killed the 'militants' responsible for the massacre However, subsequent develop-ments belied the police claim, and those killed by it turned out to be local civilian youth.

It may be recalled a judicial probe headed by Justice R Pandian

later indicted the police for the civilian killing following which the Chief Minister Dr Farooq Abdullah had an¬nounced setting up of a commis¬sion of enquiry headed by a re-tired or sitting judge of the Su¬preme Court to probe the Chattisinghpora massacre

Dr. Abdullah even ignored the Pandian Commission rec-ommendation to reinstate one Superintendent of Police on the plea that a linkage had been established between the Bragpora killing and the Chatisinghpora massacre. However, the commission of enquiry is yet to be setup.

# Will India Scrap **Indus Water Treaty?**

# Broken treaties are a sign of war

It is now only a matter of days that IWT will be a fig leaf of the past. The result of the 90-days deadline, only time can tell but the treaty which had withstood three wars is now slated to become a relic of the past, that too, in times of the apparent peace

t has not even been a week since BBC broke the news, quoting from the upcoming book of Former US Secretary of State Mike Pompeo, that after the Balakot strikes from India on Pakistan, in February 2019, there were apprehensions from New Delhi that Islamabad was preparing for a nuclearstrike on India.

Pompeo, according to the BBC report of January 26, has disclosed in his book, "Never Give An Inch: Fighting for the America I Love" that the US saved the region from an ultimate catastrophe by his (Pompeo's) deft-diplomacy. But, after the news had hit the public domain, only a day later, on January 27, a report from The Hindu said that India wants to modify the India-Pakistan Indus Water Treaty (IWT) signed between the two nations in 1960.

The biggest salvo has been fired by India on Pakistan, as now this 63-years-old treaty, which had weathered even the wars between India and Pakistan (1965, 1971, 1999) stands to be modified! The same report informed that India was compelled for the move, made officially on January 25, "owing to Pakistan's persistent objections regarding India's Kishenganga and Ratle hydropower projects in Kashmir.The notice was sent through Commissioners for Indus Waters that both sides have appointed under the treaty." The Indian step has come after Pakistan had approached the Permanent Court of Arbitrage at The Hague over two hydropower projects in Jammu & Kashmir which Indian officials claim that Pakistan stance is against the agreed mode of dispute resolution

This issuance of a notice of this kind, directly to Pakistan, perhaps for the first time since Independence, has quite understandably sent shock-waves across the whole spectrum, as India has been forced towards this step due to Pakistan's actions. According to NDTV, "India is seeking modifications in the treaty to make it easier for Pakistan to enter into intergovernmental negotiations, within 90 days, and rectify the 'material breach' of IWT. This process would also update IWT to incorporate the lessons learned over the last 62 years." Therefore, Pakistan has been issued a 90-days deadline to 'respond' or else supply

of such kind has ever happened between India and Pakistan.

Broken treaties are a sign of war. The Second World War had started when the Treaty of Versailles was violated but unlike any other treaty, this IWT had always been considered to be one of the world's most-sustained treaties. Yet now the threat of it getting-scrapped is being largely speculated in the public domain.

#### What constitutes it?

It was signed by Pakistan President Avub Khan and PM JL Nehru negotiated by the World Bank and despite conflicts India did not stop water from Indus, Jhelum, Chenab, Sutlei, Beas and Ravi and in fact had given unfettered access to them for Pakistan It can he anvone's guess that had India blocked the waters of these rivers, Pakistan was to be instead in great-troubled-waters! Jhelum, Chenab and Indus were to be for Pakistan to exercise its control while India contended with Sutlej, Beas and Ravi and even in it, Pakistan had the right to put-into any objections, as sanctioned through the IWT.

had every right to raise its objections, initiate a dialogue and discuss its modalities.

But, there have now been many views, particularly from Right-Wing associations, even by Parliamentarians too, that it is high time India scraps the treaty. All of these rivers pass through Kashmir, which quite understandably makes Pakistan all the more jittery over the Kashmir issue. In case Pakistan is to stamp its control on the Indian part of Kashmir, on hypothetical terms, the entire water issue of Pakistan was to be easily solved. But, that is not to

Pakistan became complacent and did not make compatible dams in the last six decades to meet its needs, while now India, had started to build Kishenganga Power Project (330 Megawatt, 5783 Cr, completed) and Ratle Hydro Electric Project 850 Megawatt, 5281 Cr and due to be completed soon). This raised Pakistan's evebrows and Pakistan contests that these two projects would hinder the water flow towards Pakistan and that India has breached the IWT. India contends that India was to ally Pakistan fears, as partners and as per sanctions of IWT. but Pakistan went ahead to call for a neutral expert by the World Bank in 2015, and also a separate arbitration into it too, to the angst of India. Pakistan wants India to stall these projects, which is impossible, as according to India, Pakistan has from its

side broken the IWT, as it has gone unilaterally for arbitration. In a series of tweets, senior advisor to the Ministry of Information and Broadcasting Kanchan Gupta has spelled the Indian position, about the impending dangers that India has now made its mind to make a final adieu

Pakistan has retorted on the Indian ultimatum, and a war of words has ensued between the two nations. Pakistan has accused India to have engaged in attention diversion from the proceedings of the court of Arbitration, already in place at Hague, as per Tribune India on January 28, the notice from India had come hours after it. Pakistan has submitted through its attorney that the "resolution of disputes raised by Pakistan was a demonstration of India's characteristic bad faith. Pakistan, on the other hand, has also said that 'any risk of conflicting outcomes that India apprehends can be arrested through coordination and cooperation between the two fora. Therefore, Pakistan is engaging with both fora." Pakistan has sought that the treaty cannot be unilaterally modified.

What however, ought to be referred is that on November 25, 2016, India's PM Narendra Modi, had already signaled, according to The Hindu that "the water that rightfully belongs to India under the Indus Water Treaty cannot be allowed to go to Pakistan and government was working towards a mechanism for optimum utilisation of every single drop of water from Satluj, Ravi and Beas rivers. Under the Indus Water Treaty, India has the right over water of Satluj, Beas and Ravi rivers. It rightfully belongs to our farmers, but this water is not reaching the farmer's field, instead the water is flowing to Pakistan." Therefore, the lines are now drawn. The PM's statement had come after the Uri attack, on September 18, 2016, in which 19 Indian soldiers were killed.

It is now only a matter of days that IWT will be a fig leaf of the past. The result of the 90-days deadline, only time can tell but the treaty which had withstood three wars is now slated to become a relic of the past, that too, in times of the apparent peace (sic). Let's see what happens next.



# To Read During Long Nights

inter solstice brings the shortest day and longest night of the year in the Northern Hemisphere. It's a great night to spend reading.

I've taught English and creative writing in snowy Binghamton, New York, for more than 40 years – reading, writing, reviewing and judging books all the while – so it's never hard for me to find something to read. Only to choose.


To save you the same indecision, I've picked five books for the darkest time of the year.

#### 1. Henry David Thoreau, "Walden Pond" (1854)

Thoreau's "Walden Pond" is America's most celebrated nature book, filled with the author's observations of the woods near Walden Pond in Concord, Massachusetts. "Walden" begins in July, but Thoreau welcomes winter in some of the book's most beautiful passages.

"The north wind had already begun to cool the pond," Thoreau writes, when he "went into winter quarters." Not that he stayed indoors much.

Most of us won't stretch out face down "on ice only an inch thick," as Thoreau reports doing, but we can read about him doing it while staying warm. Thoreau noticed frozen bubbles, stacked "like a string of beads" or "silvery coins poured from a bag." He catalogs – how he loves cataloging! – the



colors of the pond, from "transparent" to dark green to "opaque and whitish or gray." In winter he burned pine, decaying stumps, hickory, dry leaves and logs he'd dragged home while skating across the pond. Fuel provided him warmth, cooked food and company. "You can always see a face in the fire," Thoreau wrote.

In winter he welcomed rare humans, such as fellow writer Louisa May Alcott's father, Bronson. But mostly he encountered foxes, squirrels, chickadees, jays and a barred owl that he described as the "winged brother of the cat." Thoreau delights in the sound of the ice booming in a thaw and describes moonlit rescues of hikers he escorted back to the edge of civilization.

The five chilly chapters of "Walden" comprise a winter sampler for those who haven't read this mighty book — and for those returning to it.


#### 2. Robert Frost, "The Poetry of Robert Frost"


No poet sang of winter like poet laureate and New Englander Robert Frost. In his great "Stopping by Woods on a Snowy Evening" he pays homage to winter's solitude:

"Between the woods and frozen lake/ The darkest evening of the year."

"The Poetry of Robert Frost" weighs in at more than 600 pages. "You Come Too," a beautifully curated edition of poems for the young, is less than 100.

Both books contain popular midwinter favorites. Even their titles suggest the

poet's strong connection to winter: "Looking for a Sunset Bird in Winter"; "A Hillside Thaw" ("Ten million silver lizards out of snow!"); "Good-by and Keep Cold"; "A Patch of Old Snow."

In "Birches," Frost writes of branches that turn raindrops into ice crystals melted by sunlight

Shattering and avalanching on the snow-

Such heaps of broken glass to sweep away You'd think the inner dome of heaven has fallen.

Frost's poems are easily memorized and lovely to read aloud over any blustering gales.

#### 3. Dylan Thomas, "A Child's Christmas in Wales" (1952)

As Frost wrote for all ages, so did Dylan Thomas in "A Child's Christmas in Wales" – available in its original Tiffany blue New Directions paperback edition, decorated exquisitely with illustrations by Ellen

Raskin – a winter's poem made to be sung. We can even hear the poet chanting it aloud on his 1952 recording.

One need not be Welsh to love Thomas' seaside childhood. One need not even celebrate Christmas.

"One Christmas was so much like another," the poem opens, "that I can never remember whether it snowed/for six days and six nights when I was 12/or whether it snowed for 12 days and/12 nights when I was six."

#### 4. Italo Calvino, "If on a Winter's Night a Traveler" (1979)

Italo Calvino bundles magic, metafiction, philosophy, danger and love into "If on a Winter's Night a Traveler." It's Calvino's most mystifying work, challenging readers' assumptions about reading and storytelling.

Not exactly a novel, it comprises the first chapter of 10 invented novels by 10 imaginary authors. Is it still winter? a reader may

wonder. Was it ever winter?

As Calvino admits, "The only truth I can write is that of the instant I am living."

#### 5. James Fenton, "A Garden from a Hundred Packets of Seeds" (2002)

Some gardeners spend all winter dreaming. Others spend it busily planning.

"A Garden from a Hundred Packets of Seeds" proposes a radically old-fashioned approach – to grow a garden simply sprung from seed. Author James Fenton explains, "[S]imple-mindedness was a part of what I was after: buy a packet of nasturtium seeds and plant them, grow some very tall sunflowers – this is what gardening should be all about."

A garden doesn't need expensive starter plants or even a plan. The great question in life, as well as with gardens, is: What do I want to grow?

Winter unearths simplicity – the stark black-and-white vista it presents, the bareboned landscape. It encourages readers to follow suit by ridding themselves of the extraneous and making room for life. As the celebrated saying goes, "If you choose not to find joy in the snow, you will have less joy in your life but the same amount of snow."

Besides, as December ends, we turn the corner toward light.



# Jamia Nagar Violence: Discharging Sharjeel Imam And 10 Others, Court Says They Were Made 'Scapegoats', Dissent Has To Be 'Encouraged'

**New Delhi:** A court here on Saturday discharged 11 people including student activists Sharjeel Imam and Asif Iqbal Tanha, who participated in anti-CAA protests, in the 2019 Jamia Nagar violence case, saying they were made "scapegoats" by police and that dissent has to be encouraged, not stifled.

Noting that the accused were merely present at the protest site and there was no incriminating evidence against them, the court said dissent is an extension of the fundamental right to freedom of speech and expression, subject to reasonable restrictions.

It said investigative agencies need to discern the difference between dissent, which has to be given space, and insurrection that should be quelled.

The court, however, ordered the framing of charges against one of the accused, Mohammad Ilvas.

"Marshalling the facts as brought forth from a perusal of the charge sheet and three supplementary charge sheets, this court cannot but arrive at the conclusion that the police were unable to apprehend the actual perpetrators behind the commission of the offence, but surely managed to rope the persons herein as scapegoats," Additional Sessions Judge Arul Varma said.

The court faulted the police for failing to produce any WhatsApp chats, SMS or other proof of the accused interacting with each other and criticised it for "arbitrarily"

choosing to array some people from the crowd as accused and police witnesses, saying this "cherry-picking" by the police is detrimental to the precept of fairness

An FIR was lodged in connection with the violence that erupted after a clash between police and people protesting against the Citizenship (Amendment) Act (CAA) in the Jamia Nagar area here in December 2019.

Imam was accused of instigating the riots by delivering a provocative speech at the Jamia Milia University on December 13, 2019. He will continue to remain in jail as he is an accused in the larger conspiracy case of the 2020 northeast Delhi riots.

The judge said there were admittedly scores of protesters at the site and some anti-social elements within the crowd could have created an environment of disruption and havoc.

"However, the moot question remains -- whether the accused persons herein were even prima facie complicit in taking part in that mayhem? The answer is an unequivocal no," he added.

The court said the legal proceedings against the 11 accused were initiated in a "perfunctory and cavalier fashion" and "allowing them to undergo the rigmarole of a long-drawn trial does not augur well for the criminal justice system of the country".

"Furthermore, such police action is detrimental to the liberty of citizens who choose to exercise their fundamental right to peacefully assemble and protest. The liberty of the

protesting citizens should not have been lightly interfered with," it said.

The court said dissent is an extension of the fundamental right to freedom of speech and expression, subject to reasonable restrictions.

Referring to a 2012 verdict of the Supreme Court, the judge said the court is duty-bound to lean towards an interpretation that protects the rights of the accused, given the ubiquitous power disparity between them and the state machinery.

The court said the investigative agencies needed to discern the difference between dissent and insurrection.

"The latter (insurrection) has to be quelled indisputably. However, the former (dissent) has to be given space, a forum, for dissent is perhaps reflective of something which pricks a citizen's conscience," it said.

The court also said dissent has to be encouraged and not stifled, with the condition that it should be absolutely peaceful, without degenerating into violence.

The judge said the probe agency should have incorporated the use of technology or gathered credible intelligence against the accused.

"Else, it should have abstained from filing such ill-conceived chargesheets qua persons whose role was confined only to being a part of a protest," he said.

"Considering the fact that the case of the state is devoid of irrefragable evidence, all the persons charge-sheeted, barring Mohammad Ilyas, are hereby discharged for all the offences for which they were arraigned. They be set at liberty, if not wanted in any other case," the court said in its order.

It also said, "It is apparent that the police have arbitrarily chosen to array some people from the crowd as accused, and others from the same crowd, as police witnesses. This cherry-picking by the police is detrimental to the precent of fairness"

to the precept of fairness".

The court said photographs of llyas showed him hurling a burning tyre and that he was duly identified by police witnesses.

"Therefore, charges levelled in the charge sheet be framed... (against) accused Mohammad Ilyas," the judge said.

"Needless to say, the investigative agency is not precluded from conducting further investigation in a fair manner...in order to bring to book the actual perpetrators, with the adjuration not to blur lines between dissenters and rioters, and to desist from henceforth arraigning innocent protesters," he added.

The court posted the matter to April 10 for the framing of charges against Ilyas.

Noting that the charge sheets filed in the case had "nothing new to offer", the court said, "This filing of a slew of charge sheets must cease, else this juggernaut reflects something beyond mere prosecution and would have the effect of trampling the rights of accused persons".

The court said the accused were merely present at the spot and there was no incriminating

evidence against them.

"No overt act or participation in the commission of offences was attributed to them. There are no eyewitnesses who could substantiate the version of the police that the accused persons were in any way involved in the commission of the offences," the court said.

It also said there was no prohibitory order in the area where the protests took place.

The court said the charge sheet failed to elaborate on the unlawful common object of the accused and there was no evidence regarding the accused sharing the common object with each other and with the crowd in general.

The judge said the test of positive knowledge was also missing in the charge sheet.

"The accused were protesting against a piece of legislation and sloganeering against enactment thereof. Positive knowledge that their sloganeering would result in such a maelstrom is something that cannot be attributed to them sans any cogent proof," the judge said.

Quashing the charge of conspiracy, the court said the prosecution did not submit any proof that there was an agreement or conspiracy between the accused.

"The prosecution did not place any WhatsApp chats, SMS or even proof of the accused persons interacting with each other...even in the photographs, all the 12 accused are not standing side by side and in the video also, they are not seen signalling or talking to each other," the court said.

#### SC Notes Insurmountable Obstacles In Implementation Of Living Wills, Eases Procedure To Make It Workable

**New Delhi:** Taking note of the "insurmountable obstacles" in the implementation of advance medical directives of terminally-ill patients, the Supreme Court has eased the procedure to make it more workable.

A living will is an advance medical directive on end-of-life treatment.

The Supreme Court's 2018 order on passive euthanasia, wherein it recognised the right to die with dignity as a fundamental right and an aspect of Article 21 (right to life) of the Constitution, notwithstanding, people wanting to get a "living will" registered were facing problems due to cumbersome guidelines, prompting a reconsideration by the apex court.

Issuing a slew of modifications, a five-judge Constitution bench, headed by Justice KM Joseph, has made the role of doctors and hospitals more important in the mechanism.

The court has said the difficulties being encountered have been voiced by a large number of doctors and it has become absolutely necessary for the apex court to revisit its directions.

The court said a living will now be signed by the executor in the presence of two attesting witnesses, preferably independent, and attested before a notary or gazetted officer.

"It should specify the name of a guardian(s) or close relative(s) who, in the event of the executor becoming incapable of taking decisions at the relevant time, will be authorised to give consent to refuse or withdraw medical treatment in a manner consistent with the advance directive.

"The document should be signed by the executor in the presence of two attesting witnesses, preferably independent, and attested before a notary or gazetted officer," the bench, also comprising Justices Ajay Rastogi, Aniruddha Bose, Hrishikesh Roy and CT Ravikumar, said.

The witnesses and the notary or the gazetted officer shall record their satisfaction that the document has been executed voluntarily and without any coercion or inducement or compulsion and with full understanding of all the relevant information and consequences, it added.

According to the top court's 2018 order, a living will was needed to be signed by the person making it, in the presence of two witnesses and a judicial magistrate of first class (JMFC).

The top court also agreed to the suggestion that the executor shall inform and hand over a copy of the advance directive, if any, to the family physician.

The executor may also choose to incorporate the advance directive as a part of the digital health records, if any, it said.

"Buses should be delivered by April and operationalised at the earliest," Dheeraj Gupta directed the TATA motors.

He asked CEOs of Jammu Smart City Limited (JSCL) and Srinagar Smart City Limited (SSCL) to finalise routes in consultation with Deputy Commissioners as well as transport department of the Union Territory.

# **Zero Tolerance Policy Against Drug Abuse: DC Pulwama**

PULWAMA: The Deputy Commissioner (DC) Pulwama, Baseer-ul-Haq Choudhary on Saturday convened a meeting of the District Level Committee of Narcotics Coordination (NCORD).

At the outset, the DC discussed various issues related to menace of drug addiction, areas of concern, age group of addicts, hot spots of drug peddling, abuse, besides, cultivation of illicit poppy and cannabis in the district.

He emphasised on conducting awareness camps in schools and colleges on mass scale to sensitize the youth about hazards and ill effects of consuming drugs. The Education Department was asked to promote anti drug abuse awareness in all educational institutions and its ill effects on society. The DC directed CEO to ensure that no tobacco product is sold near educational insti-

tutions as per rules The DC directed all concerned officers for immediate completion of mapping of land used for bhang and poppy cultivation. He also directed CAO and CHO to explore avenues for growing alternative crops in these areas besides providing valuable inputs to land owners.

He asked officers of all line departments to make coordinated efforts to contain the drug peddling and break the supply chain besides taking stringent action against the persons involved in this dangerous trade.

Choudhary said, in order to combat this rising societal problem, multi-pronged rehabilitation, counseling and guidance policy is being implemented on ground to monitor drug abuse and take remedial measures to curb the menace.

He sought cooperation from the religious heads, families particularly from parents to overcome the menace among the youth which also leads to other social evils and crimes.

The DC assured the departments that all requisite support will be provided by the District Administration for saving youth from the ill effects of the drugs.

The DC directed Assistant Drug Controller Pulwama and CMO Pulwama to get CCTV cameras installed at all medical shops, establishments and clinical chemist/ druggist shops which lie within the limits of schools, colleges, hospitals and masjids so that overall surveillance with regard to the containment of drug sales is enforced.

He also directed the Assistant Drug Controller to establish a 24\*7 flying squad to check the unauthorized functioning of Chemists besides checking the sales of contraband drugs in the district.

Police Department The was asked to keep strict vigil against drug proliferation, consumption and intensifying awareness against such addictive substances involving concerned stakeholders from civil administration.

On the occasion, Officers apprised about the situation with regard to the drug menace and shared their suggestions and measures to be taken at District level to control the drug peddling and its consumption, besides measures for rehabilitation of drug victims.

# **Issue Formal Order To Spare Poor: Azad Urges LG**

SRINAGAR: Former Chief Minister of Jammu and Kashmir and the chairman Democratic Azad Party (DAP) Ghulam Nabi Azad on Saturday urged Union Territory Lieutenant Governor Manoj Sinha to issue a written order to authorities not to trouble poor and needy people who have small land holdings.

Addressing party workers here on Saturday, Azad said that the ongoing anti-encroachment drive by the government is triggering chaos and anxiety among the common people as the authorities are not abiding by the directions of LG and are mostly troubling the poor.

"Who shall we believe, the Raj Bhawan says poor will be spared, the divisional commissioner office issues different directions while on the ground district authorities have different yardsticks to remove encroachments," he said.

Azad said that his party wants a written assurance from LG that clearly mentions the parameters for the antiencroachment drive.

He also announced that his party was putting off UT-wide protests against the eviction drive following assurances from Home minister Amit Shah and Lieutenant Governor, Manoj Sinha that land will only be retrieved from mafias

"We have decided to call off the protests for now since we received assurance from the highest authorities. Let's



watch and see how things are unfolding on the ground," the former CM said.

However, Azad said that his party will not stand by the rich people who have encroached huge swaths of land and built mansions over it.

"Those who have captured small pieces of land and have built homes or shops to feed their families must not be touched by the authorities. We can't snatch their livelihood or render them homeless when it is the responsibility of the state to think and work for the welfare of people," he said.

Azad said that the tribal communities like Gujjar and Bakerwal are facing the worst conditions with this antiencroachment drive who are being snatched the land allotted for grazing their cattle and herds.

"These communities have been provided land to graze the cattle or herds for decades. But now the government in the name of Kahcharai encroachment is forcing them to vacate. Where shall they go? It is an inhuman and anti-poor approach which is not acceptable to us at all,"

he said. The former CM said that hundreds of families, especially Kashmiri Pandits during the peak of militancy from Chenab and Kashmir Vallevs were forced to migrate to relatively safer region of Jammu after selling all their assets back home to buy plots in the winter capital.

"They built homes in Jammu to escape militancy. Later, the successive regimes regularised the areas and provided them basic facilities like water, electricity and roads. Now the present government says they are all illegally settled and want to remove them. This can't happen and we will not allow it," he said.

### **DAK Calls For Population-Based Cancer Screening In Kashmir**

**SRINAGAR:** On world cancer day, Doctors Association Kashmir (DAK) on Saturday called for population-based cancer screening in Kashmir valley.

"With cancer reaching epidemic proportions in the valley, screening people for cancer is the need of the hour," said DAK President Dr Nisar ul Hassan.

Dr Hassan said cancer screening detects disease early and reduces the risk of dying from the disease.

When a cancer is detected at an early stage, the chances of survival is dramatically higher than when detected at a later stage when the tumor has spread and the disease is more advanced.

"In a study survival rate for women diagnosed with cervical cancer at an advanced stage was just 15% compared to 93% when cancer was detected at an early stage," he said.

"Results from decades of research clearly shows that women whose breast cancer was detected early by screening mammography are less likely to need aggressive treatment, and are more likely to be cured."

The DAK President said with no screening, most patients in Kashmir seek medical attention at later stages of cancer. "And when they come in ad-

vanced stage, the treatment

remains mostly ineffective and the chances of survival are less," he added. Dr Nisar said people need to recognize that many cancers

can be prevented by simple life-style measures. "Avoiding smoking, exercise and a healthy diet will reduce

the risk of cancer," he said. As per the union health ministry figures, Jammu and Kashmir has reported an estimated 51,577 cancer cases in last four

While lung cancer was found prominent among men, breast cancer was the most common cancer among women.

years (2018-2022).

More than 22, 000 people have died due to cancer during the period of 2018 to 2021.

General Secretary DAK Dr Arshad Ali said there is a dire need to set up a separate cancer hospital in Kashmir.

"That will strengthen cancer care in the population and improve patient outcome," he said.

Captain Ashton Turner, responsible for several rescue acts this season, clubbed five boundaries and two sixes to keep the match on a knife-edge, supported by Josh Inglis (26). When Turner was run-out for 53, Connolly and Hobson's breathtaking partnership swung the match.

Earlier, opener Josh Brown got the Heat off to a rollicking start, belting 25 runs in the first two overs of the match before being caught. Sam Heazlett (34) and Nathan McSweeney (41) then consolidated to create a solid foundation for the innings. Aggressive use of the batting powerplay in the 13th over backfired though and both Heazlett and skipper Jimmy Peirson (3) swiped Jason Behrendorff (2-26) to short fine leg.

After crunching a late 31 from 14 balls, Max Bryant skied a short Matt Kelly (2-37) delivery to keeper Inglis. The same fate awaited Neser, architect of Heat's semi-final chase against Sydney Sixers, one ball later as he went for a golden duck. Both sides entered the match short of star-power as injuries and international call-ups took their toll.

The Heat and Scorchers, aptly playing in temperatures nudging 40C (104F), were supported by a lively crowd of 53,886 -- a BBL final record.
