# **Eviction Drive Continues Despite Criticism, Protests**

### Land Retrieved From Two Former Ministers In J&K

**Srinagar:** Despite facing sharp criticism from the residents and major political parties of Jammu and Kashmir, the Union Territory administration continued its anti-encroachment drive on Monday and retrieved over 400 kanal of state and Kahcharai land, including 13 kanal of forest land from the illegal occupation of a former

According to reports, a joint team of revenue and forest department officials assisted by police appeared in the Sedow area of Shopian on Monday morning and retrieved over 13 kanal and 16 marla of forest land, illegally occupied by former minister Taj Mohi-Ud-Din. The entire chunk of land, reports said, measured around

The anti-encroachment team used JCB to pull down the chainlink fence used by the former Minister to secure the land.

A resident of the border town of Uri, Taj resigned from Congress last year and joined Ghulam Nabi Azad-led DAP.



In Ganderbal district, over 66 kanal of state and Kahcharai land was reclaimed during a anti-encroachment day-long drive, an official spokesperson said.

The drive, he said, was carried out jointly by civil administration in different tehsils of the district. The land retrieved on Monday from influential persons includes 58 kanal of state land and eight kanal of Kahcharai.

### **India Rolls Out New Haj Policy**

Hai Forms To Be Free Of Cost, 25 Embarkation **Points This Year** 

**Press Trust Of India** 

New Delhi: There will be 25 embarkation points for Haj-2023 and forms for going on the pilgrimage will be out very soon with the application being available free of cost, according to the Ministry for Minority Affairs.

The ministry said the Ha policy released on Monday will bring financial relief to pilgrims.

Haj package costs have been reduced by approximately Rs 50,000 as the money that was deposited with the Haj Committee for foreign exchange and items such as umbrella, bags and bed sheets would not be charged and these things can be arranged by the pilgrims themselves, sources said.

The new Haj policy stated that out of the total number of quota allocated to the government of India, 80 per cent will be allocated to the Haj Committee of India and the remaining 20 per cent will be allocated to private operators.

"Those who have performed Haj earlier through Haj Committee of India will not be eligible to apply. In the case of 'Mehram' (companion) for lady pilgrims and of companions accompanying pilgrims over 70 years of age, repeaters will be allowed on payment of additional charges as applicable from time to time," the policy stated.

# Powerful Quake Kills Over 2300 In Turkey, Syria,

Azmarin (Syria): A powerful 7.8 magnitude earthquake rocked wide swaths of Turkey and Syria early Monday, toppling hundreds of buildings and killing more than 2,300 people.

Hundreds were still believed to be trapped under rubble, and the toll was expected to rise as rescue workers searched mounds of wreckage in cities and towns across the area.

On both sides of the border, residents jolted out of sleep by the pre-dawn quake rushed outside on a cold, rainy and snowy night. Buildings were reduced to piles of pancaked floors, and major aftershocks or new

quakes, including one nearly as strong as the first, con-

tinued to rattle the region. Rescue workers and residents in multiple cities searched for survivors, working through tangles of metal and concrete. A hospital in Turkey collapsed, and patients, including newborns, were evacuated from facilities in Syria.

In the Turkish city of Adana, one resident said three buildings near his home were toppled. "I don't have the strength anymore," one survivor could be heard calling out from beneath the rubble as rescue workers tried to reach him, said the resident, journalism student Muhammet Fatih Yavuz. **Srinagar:** The weather department on Monday predicted another rain and snow spell in Kashmir Valley from February 9, even as the overnight snowfall draped the famous ski-resort of Gulmarg in a thick lashed the plains.

According to a meteorological department official, the weather would be "partly cloudy" ON February 7 and 8. However, he said widespread light to moderate snowfall and rain was expected at many places from February 9-11.

The official quickly added that "no major snowfall" was expected during the next one week.

He said that in last 24 hours till 0830 hours today, Srinagar received 5.2mm of rain, Qazigund 5.6mm, Kokernag 11.2mm, Jammu 1mm, Banihal 9.0mm, Batote 9.2cm, Katra 1.2mm, and Bhaderwah 3.6mm while Gulmarg received 35 cms (1.14-ft) of snowfall, Kupwara 5cms and Pahalgam 2cms.

Meanwhile, amid cloud cover, the minimum temperature saw further increase except at a few places with Srinagar recording a low of 1.8°C, the same as on the previous night. Today's minimum temperature, he said, was above normal by 2.2°C for the summer capital.

The study, published in the journal Science Advances, estimates a gap of around 14 years in remaining life expectancy -- the number of years a person can expect to live -- at age 10 between the least and most violent

"What we found most striking is that lifetime uncertainty has a greater association with violence than life expectancy," said Jose Manuel Aburto from Oxford's Leverhulme Center for Demographic Science.

"Lifetime uncertainty, therefore, should not be overlooked when analysing changes in mortality patterns,"

Using mortality data from 162 countries, and the Internal Peace Index between 2008-2017, the study shows the most violent countries are also those with the highest lifetime

ed deaths at young ages are the biggest contributor to this, while in Latin America, a similar pattern results from homicides and interpersonal violence,

However, lifetime uncertainty was 'remarkably low'' between 2008–2017, in most Northern and Southern Euro-

The researchers found that in highincome countries, reduced cancer mortality has recently helped to reduce lifetime uncertainty.

"Whilst men are the major direct victims of violence, women are more likely to experience non-fatal consequences in violent contexts," said study co-author Professor Ridhi Kashy-



### US Team To Assess Peace Process In J&K

ASHINGTON -A four-member US congressional team led try Edward Royce, Republican member of the House of Representatives from California and co-chairman of the congressional caucus on India, will visit India and Pakistan for 10 days from February 16 to assess the progress of the peace process in

The proposal for the visit came from David Bonior, member from Michigan, which has a large Pakistani community, besides Syrians and Iraqis. Indian American sources said Bonior espouses Pakistan's cause in the Kashmir dispute Talking to the United News of India, Democratic Representative

Jim McDermott, co-chairman of the India caucus, said the team would try to figure out if they could play any role in resolving the longstand-He, however, made it clear that the congressmen have no plan to

be interlocutors for the peace process.

Besides Royce and Bonior, the other members of the delegation are

McDermott and Joseph Pitts, a Republican from Pennsylvania.

"We want to look at the Kashmir situation, get a feel from both sides and try to figure out if there is any role for us," McDermott said, adding that the team would visit the Kashmir valley as well.

The congressmen are scheduled to meet both Indian and Paki-stani leaders during their visits to New Delhi and Islamabad, though no schedule has been worked out. They will also visit Lahore and the earthquake-affected areas of Gujarat. McDermott said the proposal was mooted during a chat he had with

Bonior a few days back. "We both came to a decision to contribute to the peace process in Kashmir and approached the House speaker to provide us a military plane to transport the delegation to India," he added.

He admitted the Bush administration had not moved as quickly as it should have in the Gujarat tragedy. "There is no need to wait for protocol as you see the human tragedy unfolding before you in a friendly country," he said, referring to the argument that New Delhi had not approached Washington for assistance.

The India caucus is also handicapped by the fact that President

George W Bush is just putting his administration together and there is no assistant secretary in the South Asia division in the state department who can debate proposals.

But the near unanimous resolution adopted by the House of Representatives expressing solidarity with the quake victims was intended to send a message to the White House that Congress is keen to see the executive branch act. "If only the tragedy had occurred five days earlier, things would have been different as the Clinton government was still there," McDermott added. US assistance to the earthquake victims should be a generous con-

tribution reflective of the .wealth of the country, he said. The congressman said a decision to fill up the vacancy caused by

the resignation of Assistant Secretary Karl F Inderfurth would be taken by the end of February. But the post of ambassador to India would need longer to be filled once the incumbent. Richard Celeste, demits office in Celeste has been asked to continue until alternative arrangements

are made. But "we may end up haying a long gap before the next ambassador is posted to India", McDermott said, referring to the long Senate confirmation process that will have to be gone through He said Senator Sam. Brownback, Republican from Kansas, is cur-

rently spearheading a move to have the remaining sanctions against India lifted. The 100-member congressional caucus will extend full support to the move. The desire to lift the remaining sanctions is widespread and pressure will build up on the new administration soon. "Everything in politics has a timing," McDermott remarked.

Srinagar: Some decades back, for most Kashmiris Kangri was the only portahle way for people to warm themse However, with the advent in technology and change in lifestyle, some city residents say they have given up the use of 'Kangri' and they no longer use the traditional Kashmiri firepot in their households. Badr-u-Nissa Bhat, a resident of Srinagar's old city area said that they have given up the use of Kangri many years back.

"My family gave up the use of Kangri when I was very young. They had apprehensions about my safety and the things around. I am not used to it" said Badr-u-Nissa, a Ph.D. scholar at Kash-

However, she says it is impossible

to stay warm without resorting to other advanced mechanisms to keep yourself warm in Kashmir.

"Two of our rooms have a Hamam facility and in other rooms we use radiators. I think these are efficient ways to heat up a room. But I am still fanaticized by Kangris." She said.

"Whenever I go to a relative's place, I don't miss a chance to get a 'Kangri Josh'.' Shadab Abbas, is another Old city

resident who says they don't use the traditional firepot to warm themselves. "Kangri comes with a lot of risk and there are better ways to warm ourselves.

We use a gas heater to warm up our rooms" Although some city residents may have given up the use of traditional firepot for warming themselves, most people say it is part of Kashmiri culture

### **Winter And Tourism**

hile the winter and the attendant snowfall create many hardships for people in the Valley, on the tourism front, things start looking up. In the famous health resorts of Gulmarg and Pahalgam, the snow has drawn tourists in droves. The high altitude areas and the famous tourist resorts have been receiving snow since December. According to tourism department figures, the hotel in Gulmarg are booked till March. At 8,960 feet, Gulmarg, Kashmir's wonderland of snow, is receiving a good number of tourists. According to the tourism department, the occupancy of the hotels in the famous hill resort is full. The hoteliers are upbeat, so is the tourism department.

Snowfall is a boon for tourism. It is important for its novelty for the ninety-nine percent of more than a 1.4 Indians, so they look forward to visit Kashmir in winter. The tourism department is also organizing national winter games at Gulmarg from February 10 under the "Khelo India" initiative. The big sporting event is projected to draw over 1500 participants. Anurag Thakur, Union Minister for Youth Affairs and Sports, and Manoj Sinha, Lieutenant Governor of J&K, recently inaugurated the Third Khelo India National Winter Games Anthem, Mascot, and Jersey. They termed Gulmarg a "Sports City," saying the resort would be able to welcome the largest number of 1500 players from across the country. The event promotes winter sports such as skiing, Alpine skiing, Nordic skiing, snow rugby, ice stock sport, snow baseball, climbing, snowshoe running, ice hockey, figure skating, and speed skating. Prime Minister Narendra Modi in February 2021 virtually inaugurated the second edition of the games.

The tourism department has also made tremendous efforts to bring tourists back to Kashmir. The J&K Tourism Department participated in this year's Outbound Travel Mart in Mumbai as part of its nationwide tourism promotional campaign. Thousands of holidaymakers, travel traders and tour organizing professionals thronged the J&K pavilion. The Jammu and Kashmir administration anticipates a 15-20 percent year-on-year increase in visitors to the Union Territory in 2023 and has planned 75 alternative destinations to lower footfalls at the most popular attractions.

More than 20 lakh tourists, including 3.65 lakh Amarnath yatris and over ten thousand foreigners, visited Kashmir during 2022. The Tourism department has said that an advertising campaign across major Indian cities and the opening of new destinations have helped. The UT government has also increased the options for tourists by developing more resorts. For example, Aharbal, Yusmarg, Tosamaidan, Gurez, historic old city in Srinagar, are finding a prominent place on the tourist map of Kashmir. These places need further development of tourist infrastructure and also wider publicity for people to visit. So current year could be hoped to bring more tourists to the Valley.

### Going Green

s an article presented at the World Economic Forum's Annual Meeting in Davos last month notes, India holds the key to hitting global climate change Largets given its sizeable and growing energy needs. With the country's population set to overtake China's some time this year, India's appetite for energy to propel the economy is set to surge exponentially. The transition to green alternatives from the current reliance on fossil fuels is therefore an urgent imperative and an opportunity to leverage this move to catalyse new industries, generate jobs on a sizeable scale, and add to overall economic output. In a nod to this, Budget 2023-24 devoted a fair amount of space to the green industrial and economic transition needed. With the electric vehicle (EV) revolution poised to take off as every automobile major rolls out new EV models to tap demand, the availability of indigenously produced lithium-ion batteries has become a necessity, especially to lower the cost of EVs. The Budget hearteningly proposes to exempt customs duty on the import of capital goods and machinery required to manufacture lithium-ion cells used in EV batteries. This ought to give a fillip to local companies looking to set up EV battery plants.

Another key proposal relates to the establishment of a viability gap funding mechanism to support the creation of battery energy storage systems with a capacity of 4,000 MWh. Energy storage systems are crucial in power grid stabilisation and essential as India increases its reliance on alternative sources of power generation including solar and wind. With wind turbine farms and solar photovoltaic projects characteristically producers of variable electric supply, battery storage systems become enablers of ensuring the electricity these generators produce at their peak output is stored and then supplied to match the demand arriving at the grid from household or industrial consumers. Ms. Sitharaman also set aside a vital 8,300 crore towards a 20,700 crore project for building an inter-State transmission system for the evacuation and grid integration of 13 GW of renewable energy from Ladakh. With its vast stretches of barren land and one of the country's highest levels of sunlight availability, Ladakh is considered an ideal location to site photovoltaic arrays for producing a substantial capacity of solar power. The transmission line will help address what had so far been the hurdle in setting up solar capacity in the region, given its remoteness from India's main power grid.

ammu and Kashmir has been taken over, literally, by infamous bulldozers. Demolition drives are being carried out, properties sealed and encroachers are being driven away. This has been the first resort from the government's end. But was it the only viable one?

Not so far away, early this year, in Gurgaon, the residents of unauthorised or illegal colonies located outside municipal areas in Gurgaon were given the option to apply for regularisation under the Harvana Management of Civic Amenities and Infrastructure Deficient Areas Outside Municipal Area (Special Provisions) Act 2021.

This isn't a singular case, in fact, the Parliament in March 2021, had passed the National Capital Territory of Delhi Laws (special provisions) second (Amendment) Bill 2021 to help regularise certain unauthorised colonies in Delhi by December 2023.

Notably, there are about 1,700 unauthorised colonies in Delhi alone. In fact, in 2019, the central government announced that it would give ownership rights to over 40 lakh living in unauthorised colonies in Delhi. The central government launched the Prime Minister-Unauthorised Colonies in Delhi Awas Adhikar Yojna for the same.

In the past, several unauthorised colonies were regularised even in Jammu city during NC-Congress Govt. Why can't the present Government take a similar stand now? increasing day by day. We have the least landholdings as compared to other states. If the Government doesn't allocate state land to people, where shall the people live? Our landmass is already choking because huge chunks of land been acquired by the Government for various infrastructural projects.

#### Defeating the purpose of Wel-

fare State The concept of the Welfare State is embedded in the Indian Constitution which reads, "The State shall strive to promote the welfare of the people by securing and protecting viduals but also amongst groups of people residing in different areas or engaged in different vocations. Therefore, a welfare state is based on the principles of equality of opportunity and equitable distribution of wealth. If residential colonies or shops are established on state land, let the local bodies decide about their fate through Deh Majlis (gram sabha) or ward meetings. If the Govt has managed to set up the institutions of lo-



citizens in general. It is quite obvious then that the welfare of citizens is of prime importance in a wel fare state.

Before independence, India was not a welfare state. British rule was in the interest of protecting and promoting the welfare of Indians. Whatever it did was in keeping with the interests of the colonial government and not in the interests of citizens. So, when India got its independence, its economic condition was very weak. There were social inequalities and all the vulnerable sections of the society such as women, dalits, children were deprived of basic means of living. The architects of the Indian constitution were very much aware of these challenges and that was the reason they decided that India would be a Welfare State.

The constitution has given us fundamental rights which are guaranteed to all the citizens under Part III of the constitution. These rights apply universally to all citizens residing in India, irrespective of their race, place of birth, religion, caste or gender. They are recognized by law as rights requiring a high degree of protection from the government and they cannot be violated by any Government.

Panchayat or Municipality is a

Fundamental Rights

and the Legislature of each of the States and all local or other authorities within the territory of India or under the control of the Government of India.

This definition makes it crystal clear that the state within the meaning of constitution of India means:

- Government and Parliament of India i.e the Executive and Legislature of the Union
- Government and Legislature of each State, Union Territory i.e the Executive and Legislature of the various States / UTs of India
- All local or other authorities (Panchayats, Municipalities) within the territory of India
- All local and other authorities who are under the control of the Government of India

#### Municipalities, Panchayats custodians of state land

In addition to the constitutional definition of state, there are numerous judgments of the Supreme Court and different High Courts that have made it clear that local bodies are covered under the definition of State. If Municipality or Panchavat is a state then the land located in its jurisdiction also belongs to this institution?

There are important judgments of high courts and supreme court which make it clear that state land belongs to the local bodies. In towns or cities, the municipal institutions

cal bodies in cities, towns and villages, why are they side-lined during the ongoing eviction and demolition drives? Why aren't Gram Sabha (Deh Majlis) in rural areas or Ward committee meetings in urban areas called to decide who shall be evicted and who shall not be?

Issuing orders from Civil Secretariat and getting it executed through District Administration or Revenue Department officials kills not only the essence of the Welfare State but also chokes the spirit of our local self governance as well. On one hand, the Prime Minister keeps talking about holding three-tier panchayat elections in J&K which his Govt claims to be a great achievement but when it comes to empowering institutions, these Government doesn't seem to be serious.

#### Context, Questions and Conclu-

The entire land of Jammu & Kashmir was purchased by Maharaja Gulab Singh for Rs 75 lakhs in 1846 from British India. Does this mean that the entire population of Jammu & Kashmir are illegal occupants and the land from Lakhanpur to Ladakh will again be

handed over to the state? The policies and programmes of a welfare state have to be rational and people's welfare should be the primary concern of the state. People are under stress due to ongoing eviction drives. Let this be halted and LG Manoj Sinha must soon devise a programme to streamline this entire process. Let Gram Sabha (Deh Majlis) and Ward Meetings be held to decide the issue of state land encroachments. If Panchayats / Gram Sabhas are empowered to allocate forest land to forest dwellers under the Forest Rights Act 2006, why can't the same thing be replicated in the case of state land allocation as well?

# Reading the Tectonic Clock in Kashmir



e must learn how to use the tectonic clock in our favour to avert devastating earth-

EARTHQUAKES occur when rocks fail to accommodate stress. Initially. rocks will deform and try to compensate for stress, which usually results in topographic changes such as uplift, subsidence etc. Once the stress exceeds what rocks can accommodate, they strain and eventually break. The sequence of earthquakes in the Jammu and Kashmir region should be experiencing strain release, which tells us that rocks are at a stage where breaking is possible. I have checked the depth of faulting, and it seems the rocks are breaking at 5 to 10 km depth, which is very shallow, and if it forms a significant fault, it could be dangerous.

Unfortunately, we do not know the type of faulting because of the small size of the quakes. However, the pattern of earthquake occurrence in the south of the Kashmir Basin is a reflection of internal faulting, which means that such earthquakes could be associated with faults other than the major Himalayan faults, such as the Himalayan Frontal thrust, Main Boundary fault, etc. It is good news because the maximum size of an earthquake on the fault that would accommodate the ongoing earthquakes in the J and K regions should not exceed magnitude 8.0 and would ideally be expected to fall between 6.0 and 7.0. If it reaches 7.0 and 7.5, it will cause considerable damage in the region, potentially cascading into a series of other issues such as landslides, floods, liquefaction, and so on.

Earthquakes in our part of the world are happening because of the ongoing collision between India and Eurasia, two continental plates that started their journey to collide a long time back. Therefore, no one can stop them from collisions, humans can not do that, and we have no technological advancement to stop

it. Actually, stopping collisional tectonics would create more problems than solutions, which we can discuss later in another post. Therefore, we cannot stop earthquakes from coming; they will come, only time is un-

known. I think that unknown time is a clock for us which is ticking. If we do not understand how to respond to the time given to us by the natural clock of faulting, we will turn a hazard into a major disaster, which will be our failure as a scientific, social, and responsible community.

Assuming there will be a big earthquake in the coming days, what could we do? Nothing much. Our houses are a pack of cards with no structural integrity to withstand ground shaking, which will become a catastrophe. We are not ready to face a big earthquake, which is something we should think about, and it should give us sleepless nights until we find a way to deal with it.

### IT IS A CHALLENGE FOR ALL OF US, AND WE HAVE TO SOLVE IT TOGETHER. HOW?

Let us start. The administration can draft a possible document where auditing of buildings will be done within a few months, and action-oriented planning will follow the auditing procedures to ensure what needs to be done to prepare the region for significant earthquakes. It should ideally involve a committee on earthquake hazards, which will work on one goal, how to stop an earthquake from becoming a disaster. It is possible, and we have all the resources to do it, but what it needs is a will, which is where we are lacking.

We have to first draft in our mind a solution on how to live with earth-quake hazards. It is where the will is needed; once we have it, the road towards achieving that goal will come nearer. As I said earlier, tectonic interaction between India and Eurasian plates gives us time to reflect, and if we don't, it will turn our region into what we saw in the neighbouring Muzaffarabad in the 2005 earthquake. Therefore, we must learn how to use the tectonic clock in our favour.

"The Revenue teams have retrieved approximately 18702 kanal of illegally occupied government land by various land grabbers till today which include 393 kanals of land from influential persons," he added.

Carrying placards, dozens of activists of the party assembled at the Maisuma market to register their anger against the eviction drive. The placards read "Kindly let us live peacefully" and "India is not Israel."

Party leader Nadeem Ahmad said the LG administration should stop the demolition drive which has badly affected the poor

"Who were affected by the demolition drive at Mehjoor Nagar yesterday? Was there any rich and influential person? They are poor people who are living hand to mouth," Ahmad told reporters.

He said if the government did not reconsider its eviction drive, the consequences would be very serious.

"Is Kashmir not for the people of Kashmir? You are giving land to outsiders while making Kashmiris homeless," he added.

The Haj application forms can be obtained from state and Union Territory Haj committees free of cost or can be downloaded from the website of the Haj Committee of India at hajcommittee.gov.in or through the android mobile application "HAJ COMMITTEE OF INDIA" available on play store.

Subject to the terms of Saudi Arabia, a single women may also apply, and the Haj Committee of India, may form a grouping with women who apply under the category, it stated.

The Consulate General of India in Jeddah will also facilitate separate living arrangements for women traveling alone for the pilgrimage, the policy said.

It said a maximum number of four applicants comprising the family members or

near relatives can apply in a single cover. While allotting seats of each state, priority would be given to the over 70 age category,

women and differently-abled. The distribution of the different states' and union territories' quota will proceed as in the current policy through draw of lots.

As announced earlier, the entire government discretionary quota stands cancelled from Haj-2023 onwards and will be merged into the general pool for the benefit of the common citizens.

The health certificate to be issued to the pilgrims by a medical officer will have information related to mandatory vaccinations and Covid vaccination.

The digital medical health certificate will be issued to the selected Haj pilgrim in collaboration with Ministry of Health and

Family Welfare (MoHFW). All selected pilgrims more than two years of age are required to possess a certificate of inoculation with a single dose of the cerebrospinal meningitis vaccine.

The pilgrims may be allowed to get health verification and a RTPCR test from their district health units. The test shall be preferably done through government Laboratories including facilities available in Government of India Hospitals, Hospitals of Railways, ESIC hospitals etc, according to the policy.

The pilgrims will be given a choice between the embarkation point of the area and the nearest economical embarkation point as per the difference in air travel costs from the previous year.

The embarkation points are Srinagar, Ranchi, Gaya, Guwahati, Indore, Bhopal, Mangalore, Goa, Aurangabad, Varanasi, Jaipur, Nagpur, Delhi, Mumbai, Kolkata, Bangalore, Hyderabad, Cochin, Chennai, Ahmedabad, Lucknow, Kannur, Vijayawada, Agartala and Calicut.

Also, this time all states and union territories (UTs) will be allowed to send an officer at the director level in the state or UT service and an officer of state or UT Haj committees, for looking after the pilgrims of their states

#### **Powerful Quake**

"Because the debris removal efforts are continuing in many buildings in the earthquake zone, we do not know how high the number of dead and injured will rise," Turkish President Recep Tayyip Erdogan said. "Hopefully, we will leave these disastrous days behind us in unity and solidarity as a country and a nation.'

The quake, which was centred on Turkey's southeastern province of Kahramanmaras, was felt as far away as Cairo. It sent residents of Damascus rushing into the street, and jolted awake people in their beds in Beirut.

It struck a region that has been shaped on both sides of the border by more than a decade of civil war in Syria. On the Syrian side, the swath affected is divided between government-held territory and the country's last opposition-held enclave, which is surrounded by Russian-backed government forces. Turkey, meanwhile, is home to millions of refugees from that conflict.

The opposition-held regions in Syria are packed with some 4 million people displaced from other parts of the country by the fighting. Many of them live in buildings that are already wrecked from past bombardments.

Hundreds of families remained trapped in rubble, the opposition emergency organisation, called the White Helmets, said in a statement.

Strained health facilities and hospitals were quickly filled with injured, rescue workers said. Others had to be emptied, including a maternity hospital, according to the SAMS medical organisation.

The region sits on top of major fault lines and is frequently shaken by earthquakes. Some 18,000 were killed in a similarly powerful earthquakes that hit northwest Turkey

The US Geological Survey measured Monday's quake at 7.8. Hours later, a 7.5 magnitude one struck more than 100 kilometres (60 miles) away. An official from Turkey's disaster management agency said it was a new earthquake, not an aftershock, though its effects were not immediately clear. Hundreds of aftershocks were expected after the two temblors, Orhan Tatar told

Thousands of buildings were reported collapsed in a wide area extending from Syria's cities of Aleppo and Hama to Turkev's Divarbakir, more than 330 kilometres (200 miles) to the northeast. A hospital collapsed in the Mediterranean coastal city of Iskenderun, but casualties were not immediately known, Turkey's vice president, Fuat

Oktay, said. Televisions stations in Turkey aired screens split into four or five, showing live coverage from rescue efforts in the worsthit provinces. In the city of Kahramanmaras, rescuers pulled two children alive from the rubble, and one could be seen lying on a stretcher on the snowy ground.

Offers of help from search-and-rescue teams to medical supplies and money poured in from dozens of countries, as well as the European Union and NATO.

The damage evident from photos of the affected areas is typically associated with a significant loss of life while bitterly cold temperatures and the difficulty of working in areas beset by civil war will only complicate rescue efforts, said Dr. Steven Godby, an expert in natural hazards at Nottingham Trent University.

In Turkey, people trying to leave the quake-stricken regions caused traffic jams, hampering efforts of emergency teams trying to reach the affected areas. Authorities urged residents not to take to the roads. Mosques around the region were opened to provide shelter for people unable to return to damaged homes amid temperatures that hovered around freezing.

In Diyarbakir, hundreds of rescue workers and civilians formed lines across a mountain of wreckage, passing down broken concrete pieces, household belongings and other debris as they searched for trapped survivors while excavators dug through the rubble below.

In northwest Syria, the quake added new woes to the opposition-held enclave centered on the province of Idlib, which has been under siege for years, with frequent Russian and government airstrikes. The territory depends on a flow of aid from nearby Turkey for everything from food to medical supplies.

The opposition's Syrian Civil Defense described the situation there as "disastrous."

In a hospital in Darkush in Idlib, Osama Abdelhamid said most of his neighbours died. He said their shared four-story building collapsed just as he, his wife and three children ran toward the exit. A wooden door fell on them and acted as a shield.

"God gave me a new lease on life," he said. In the small Syrian rebel-held town of Azmarin in the mountains by the Turkish border, the bodies of several dead children, wrapped in blankets, were brought to a hospital.

The Directorate-General of Antiquities and Museums in Syria said the earthquake has caused some damage to the Crusaderbuilt Marqab, or Watchtower Castle, on a hill overlooking the Mediterranean. Part of a tower and parts of some walls collapsed.

In Turkey, meanwhile, the quake damaged a historic castle perched atop a hill in the centre of the provincial capital of Gaziantep, about 33 kilometres (20 miles) from the epicentre. Parts of the fortresses' walls and watch towers were levelled and other parts heavily damaged, images from the city showed

The USGS said the quake was 18 kilometres (11 miles) deep.

Nearly 1,500 people were killed in 10 Turkish provinces, with some 8,500 injured, according to the president of the country's disaster management agency. The death toll in government-held areas of Syria climbed over 430 people, with some 1,280 injured, according to the Health Ministry

In the country's rebel-held northwest, groups that operate there said the death toll was at least 380, with many hundreds injured.

Huseyin Yayman, a legislator from Turkey's Hatay province, said several of his family members were stuck under the rubble of their collapsed homes.

"There are so many other people who are also trapped," he told HaberTurk television by telephone. "There are so many buildings that have been damaged. People are on the streets. It's raining, it's winter.'

#### **Gulmarg Turns**

Jammu recorded a low of 11.9°C against 8.3°C °C on the previous night. It was 2.4°C above normal for J&K's winter capital, he

Banihal, he said, recorded a low of 4.2°C (above normal by 3.2°C), Batote 3.1°C (above normal by 0.9°C), Katra 10.5°C (3.1°C above normal) and Bhadarwah 3.8°C (4.1°C above

Ladakh's Leh and Kargil recorded a low of minus 9.5°C and minus 14.0°C respectively, the official said. Meanwhile a medium danger level warn

ing has been issued in 4 districts in Kashmir. "Avalanche with \*MEDIUM Danger Level\* is likely to occur above \*2000 to 2400 metres\* above sea level over \*GANDERBAL, BANDIPORE, BARAMULLA & KUPWARA\* districts in next 24 hours". Jammu Kashmir Disaster Management Authority (JKDMA) posted on its official Twitter handle.

The advisory urged people to take precautions and avoid venturing in the avalanche prone areas till further orders.

conference here on Monday, Omar said the administration has already 'conceded' to the High Court that the present list mentioning people having allegedly infringed on the state property was "fabricated." He questioned the administration for running bulldozers despite the list being 'incorrect'.

The former Chief Minister also maintained that using bulldozers to retrieve land from encroachers should only be done as a last resort and not the first option.

"The government is supposed to give respite to the populace and heal their wounds rather than using coercive measures," he said, adding that the people of Jammu and Kashmir, without any political meddling, can also launch a peaceful protest like farmers did in the rest of India a few years ago.

When asked whether his party will move to the Supreme Court against the ongoing demolition drive, Omar said "I think our next step will depend on how the government responds to what I think are very reasonable suggestions. If there is a positive response, so be it, but if there isn't, then yes we will definitely consult some senior lawyers to see what options they suggest"

The NC Vice-President said that his sister approached the High Court with all relevant documents and the court has also pronounced its verdict in this direction.

"There has been chaos everywhere in J&K for the last one or two weeks. People are worried, unaware of reality. A list is issued in newspapers that mention names of several people including me and my party office. Raj Bhawan, IB office, R&EW, UNO, Army Public School, is also there in the list," he said.

"The list then disappears and then comes another leaving everyone surprised and panicked. My sister moved to the High Court as we knew that the house mentioned in the list at Gupkar Road is not illegal as its lease is still intact, which I think will expire after a few years," Omar said, adding, "If this happens to us, others too will be dealt in

the same way. This is the forged list making rounds on social media,'

The former Chief Minister asked the government to come up with a genuine list and put the same in the public domain as no due process is followed during the ongoing

"When they went to Nedou's, the media was aware but not the people living there. They broke open the main gate to make entry for the bulldozer and when the officer concerned was asked to check, he refused,'

Omar alleged that the officer claimed he was pressurized to "do something".

"Not only in Srinagar but the same reports come from other places as well. No notice was served to anyone, be it Nedou's, or Ali Mohammad Sagar," he said

He castigated the administration for not following the due course of law by serving a written notice to them or pasting the same on the gate of their houses.

"Have you pasted notices anywhere? Did you follow the law before creating this melodrama? You've threatened one and all, and if anyone asks questions they are bulldozed," he said.

The NC leader also alleged that an extortion racket is being run by the officials, who call people and demand money for removing their names from the list.

Omar called upon the government to immediately stop what he termed as a 'threatening and annoying campaign'. However, he quickly added that none amongst them wants anyone to hold state land illegally.

"Our aim is not that people are allowed to encroach upon the state land. However, there is a procedure to stop people from doing this practice. It doesn't happen by threatening and coercing. Bulldozer shouldn't be your first step in this direction, but as a last resort. So, we appeal to the government to stop using bulldozers," he added.

When asked about the pleas in SC challenging abrogation of Article-370, the NC Vice-President said "Our fight is known to everyone. It is a constitutional, legal and political fight that will continue. I truly believe, that if the government was confident in its defense, it would have pressed the SC for an early hearing"

"If not today than tomorrow, SC will have to hear this case. And we have an assurance from the current CJ that he will make sure that the hearings begin in this matter during his tenure," he added.

### **Bulldozers Shouldn't**

interested in humiliating people than retrieving state land from encroachers, Lone told reporters at his Church Lane residence.

"There is not a single day when videos of poor people being targeted for demolition are not coming in while the L-G is saying the poor will not be touched. Either the L-G Office is telling lies or the videos are fake. Addressing a news conference at his

church lane residence in Srinagar Lone said the objective of the ongoing eviction drive seems humiliation of Kashmiris. "What is the objective of the government?

Do they want to retrieve land or humiliate people? I think humiliation is more important for them," he said. Lone said that the current administra-

tion in J&K is not an elected regime and should leave bigger decisions for an elected "(President's Rule) It is a temporary arrangement. They cannot make decisions

on behalf of the people of J&K. They cannot make all decisions. They are not elected by the people," Lone told reporters here. Calling out it as an act of shamelessness, Lone while lashing out at authorities in the

presser said, "This is not any bravery when you have 300 personals including other officials at the door of a poor man and then you start vandalization and click photos to claim you have done a big job, it is a matter of shame.'

Lone alleged that all this is done by a cabal of officers, who are against the elected government and also against those who talk about the elections.

"These are all tourists here and after a couple of years not even one of them will be here or they will return after retiring and the damage will leave a societal impact",

"We have no objection to the anti-encroachment drive if it is against big land owners. The big landowners will bring their lawyers tomorrow and take back all the encroached land. However, it's only the poor who are being targeted and left to die," Lone said.

Accusing the government, Sajad Lone said that there are big names who have not been touched yet and that he will release their list very soon.

"I also have a list, let them finish after that we will release the list of those big and influential names who so far have not been touched yet", he said.

"Everything has its own procedure. Across India, there is a system of serving notices. None of the poor have been served notices here," Lone said. Lone, who was flanked by senior PC

leaders Peerzada Mansoor Hussain and Muhammad Ashraf Mir, said that the J & K administration is inventing homelessness by razing down the homes of poor people. "They are not giving any notice. The law of the land cannot be violated," he said, adding that only the poor are suffering due to the ongoing eviction drive in J&K.

Lone, once seen as close to Prime Minister Narendra Modi, also questioned the BJP-led Centre's claims of inclusiveness.

"I thought the PM is for everyone. But (it seems) 95 per cent encroachers are Muslims Kashmir has gone through a prolonged period of turmoil and the government should not disrupt people's lives, Lone said. "I do not know how they can win the hearts of people by demolishing their houses," he said

"I have never felt so helpless here. I want to ask my Prime Minister, who is my Prime Minister, who is the PM of the poor? Where will poor people go?" he asked

Lone, however, said he would not meet the Prime Minister on the issue.

Asked about the next course of action if the demolition drive continued, Lone said he would sit on a hunger strike in Delhi.

Addressing a press conference here, the Peoples Democratic Party (PDP) chief appealed to Opposition leaders in the country not to be a mute spectator to the "atrocities being committed by the BJP".

people? Is there a bulldozer policy," she said. "The brunt is borne by the people of Jammu and Kashmir. Whatever is happening since 2019 is an onslaught on our identity, on our economy, on our jobs, on our lands," Mehbooba said.

The former chief minister said the BJP is bulldozing everything including the Constitution. She said it scrapped Article 370 saying it will integrate Jammu and Kashmir with the rest of the country.

"I don't know about the integration but the destruction is massive. All the institutions including the media have been weaponized. They also want to subjugate the judiciary," she said.

Mehbooba added she would not say much to the judiciary to avoid a contempt case.

Ruling party members and ministers are free to say anything e.g. Kiren Rijiju who keep speaking against the judiciary and gets

away with it, she said "The laws brought in after Article 370 removal have been weaponized to an extent that when you visit Jammu and Kashmir, it will resemble Afghanistan because the bulldozer is there. After 370 they destroyed our identity, outsourced our jobs, our land, our minerals, our resources. When I say outsourced it means given to outsiders," she

### **J&K Congress Holds Protests** Against BJP, Adani Group

JAMMU: The Jammu and Kashmir Congress on Monday protested in support of the party's demand for a joint parliamentary committee (JPC) probe into the allegations of irregularities against the Adani group, and clashed with police at some places.

They also slammed the administration over the ongoing "arbitrary eviction" drive in the Union territory, saying it was great injustice with "landless tillers, small, marginal farmers and the common people".

In Jammu, hundreds of Congress workers, led by senior party leaders Vikar Rasool and working president Raman Bhalla, took out a rally from Shaheedi Chowk to City Chowk near the Life Insurance Corporation and SBI offices.

Raising slogans against the government, BJP, and Adnai group, they clashed with the police, with some of them trying to break the barricade to march forward.

"Today, we protested from Sansad to Sadakh (inside Parliament and outside it)

over the Adani issue. We demand that a JPC be set up to probe it. We also demand a probe by a retired chief justice into it," Bhalla told reporters at the protest.

Taking a dig at the BJP government for "investing" LIC and SBI money into the Adnai Group, he said, "How pub-



lic money has been invested in the group. It is matter of probe.

In Srinagar, led by senior party leader Mohammad Anwar Bhat, Congress workers raised slogans in favour of the IPC probe into the allegations fraud against the Adani Group levelled in a report by US-based short-seller Hindenburg research.

'We are protesting against the current situation of the country where the Adani-Ambani have looted the country. The LIC has invested thousands of crores in the Adani group while Jammu and Kashmir Bank also lost Rs 250 crore in it," Bhat told mediapersons inside the PCC headquarters in Srinagar.

He also alleged the eviction drive has been launched by the LG administration in Jammu and Kashmir so that the BJPruled Centre can give land to the Adani Group to "compensate" for its losses following the release of the Hindenburg report last month.

'We will not allow this to happen."

Congress chief spokesperson Ravinder Sharma said in Jammu the issue of "investment" of public money through the LIC and SBI into the Adani Group is a matter of serious concern and the Modi government has been "evading" questions in Parliament. "So a nationwide protest is being held near SBI and LIC offices by the party.'

According to the Opposition, the meltdown in Adani Group shares is a "scam that involves common people's money as public sector (units) LIC and SBI have invested in them".

The Adani Group has maintained it complies with all laws and disclosure requirements.

### **Man City Broke More Than** 100 Financial Rules: PL

LONDON: The Premier League has referred Manchester City to an independent commission over more than 100 alleged breaches of finance rules since the club were acquired by the Abu Dhabibased City Football Group.

League rules state that charges such as those faced by City could, if proved, result in a club being expelled from the Premier League in the worst-case scenario.

Offending clubs may alternately be deducted points, fined, or reprimanded.

City's alleged breaches stretch from the 2009-10 season to the 2017-18 campaign, the league said on Monday.

The club, who were acquired by City Football Group in 2008, are also charged with failing to cooperate with and assist the Premier League in its investigation, which was launched in December 2018.

City are alleged to have breached rules relating to the provision of accurate financial information, "in particular with respect to its revenue (including sponsorship revenue), its related parties and its operating costs,"



### **Turkey Earthquake:**

### **Footballer Christian Atsu** Reportedly 'Under Rubble'

Former Premier League footballer Christian Atsu is reportedly among the thousands of people trapped under rubble in Turkey after three massive earthquakes hit the country on

Christian Atsu joined Turk-ish Super Lig club Hataysport in 2021 after playing for English football giants like Chelsea, Newcastle United and Everton.

Media reports coming in from Turkey say that two players and members of Hataysport's support staff have been "pulled out of the rubble" but Atsu and the club's sporting director Taner Savut are still missing.

The team's goalkeeper Ahmet Eyup is also trapped under the rubble, according to reports.

More than 1,300 people died in the first earthquake measuring 7.8 on the Richter scale early Monday morning. Hours later with the families of those killed two more major quakes struck in the earthquake.

Atsu was part of the Magpies team which won promotion back to the Premier League in 2017 after joining on loan for the season from Chelsea, and later completed a permanent move.

Meanwhile, European football's governing body UEFA, EuroLeague Basketball and Real Madrid shared condolence messages with Türkiye on Twitter.

The thoughts of UEFA and the European football community are with the people of Türkiye and Syria, and all those affected by this morning's devastating earthquake," UEFA tweeted.

EuroLeague offered its condolences over the loss of lives in the quake, saying: " Our thoughts are with everyone affected by the recent earthquake in Türkiye."

Real Madrid also condoled
