Quake Deaths Pass 6,000 As Turkiye, Syria Dig For Survivors

Search Nurdagi (Turkiye)teams and international aid poured into Turkiye and Syria on Tuesday as rescuers working in freezing temperatures and sometimes using their bare hands dug through the remains of buildings flattened by a powerful earthquake. The death toll soared above 6,200 and was still expected to rise.

But with the damage spread over a wide area, the massive relief operation often struggled to reach devastated towns, and voices that had been crying out from the rubble fell silent.

"We could hear their voices, they were calling for help," said Ali Silo, whose two relatives could not be saved in the Turkish town of Nurdagi.

In the end, it was left to Silo, a Syrian who arrived a decade ago, and other residents to recover the bodies and those of two other victims.

Monday's magnitude 7.8 quake and a cascade of strong aftershocks cut a swath of destruction that stretched hundreds of kilometers (miles) across southeastern Turkiye and neighbouring Syria. The shaking toppled thousands of buildings



and heaped more misery on a region shaped by Syria's 12-year civil war and refugee crisis. One temblor that followed the first registered at magnitude 7.5, powerful in its own right.

Unstable piles of metal and concrete made the search efforts perilous, while freezing temperatures made them ever more urgent, as worries grew about how long trapped survivors could last in the cold.

The scale of the suffering and the accompanying rescue effort were staggering.

More than 8,000 people have been pulled from the debris in Turkiye alone, and some 380.000 have taken refuge in government shelters or hotels, said Turkish Vice President Fuat Oktay. They huddled in shopping malls, stadiums, mosques and community centers, while others spent the night outside in blankets gathering around fires. Many took to social media to plead for assistance for loved ones believed to be trapped under the rubble. Turkiye's staterun Anadolu Agency quoted Interior Ministry officials as saying all calls were being "collected meticulously" and the infor-

mation relayed to search teams. Turkish President Recep Tayyip Erdogan said 13 million of the country's More on P6

India Slams Pak For Raking Up Kashmir At UN

United Nations: India has slammed Pakistan for raking up the Kashmir issue in the UN, saving Islamabad harbours a deep sense of insecurity and orchestrated hatred for India and its secular credentials.

Responding to Pakistan's raisng of the Kashmir issue during a UN General Assembly (UNGA) meeting, Counsellor in India's Permanent Mission to the UN, Rajesh Parihar, said on Monday that Islamabad repeatedly utters falsehoods about India.

"I'm constrained to take the floor to respond to the frivolous remarks made by the representative of Pakistan against my country. While such a statement deserves our sympathy for a mindset, which repeatedly utters falsehood, it is important for me to set the record straight," he said in the UNGA.

Parihar said irrespective of what the representative of Pakistan believes or covets, the Union territories of Jammu and Kashmir and Ladakh were, are and will always be an "integral and inalienable" part of India.

"We expect nothing new from this delegation that harbours a deep sense of insecurity and orchestrated hatred for India and our secular credentials and values that my country stands for," he said.

25000 Vacancies Filled In J&K Till Dec 2022: MoS Home

New Delhi: The Ministry of Home Affairs (MHA) said on Tuesday that over 25000 vacancies have been filled and nearly 8000 posts have been advertised in Jammu and Kashmir till December last vear.

In a written reply to a question on vacant posts in Jammu and Kashmir, Minister of State for Home Affairs, Nityanand Rai informed the Lok Sabha that large scale recruitment drive has been carried out after formation of the Union territory in the most transparent manner.

J&K government, he said, has carried out several governance reforms, including in the area of recruitments in Government.

"33,426 vacancies Gazetted/Non-Gazetted categories have been identified in the Government of Jammu and Kashmir, out of which 25,450 vacancies have been filled till December, 2022. Recruiting agencies have advertised 7,976 vacancies for



recruitment," Rai said. He said that the identification of vacancies in the Government and recruitment is a continuous and on-going process.

"The same is taken up under Accelerated Recruitment Drive," he said.

Government of Jammu and Kashmir has taken various initiatives to bring down un-employment by implementing various self employment schemes through different departments by pro-

viding subsidized loans for

establishment of their own sustainable income generation units," he added

Giving further details, the Minister said that a number of self employment schemes like Mission Youth, Rural Livelihood Mission, Himayat, PMEGP. Avsar. being implemented providing employment opportunities.

During the current financial year, he said, 2, 01, 299 employments have been generated upto January 21, this year through such schemes.

Kashmiri Woman Pilgrim Dies Onboard Delhi Flight

Jodhpur: An IndiGo flight from Jeddah to Delhi on Tuesday made an emergency landing here in Rajasthan after a 60-year-old woman passenger fell ill -- and was later declared brought dead by a local hospital.

Her son said she was rushed to the hospital on landing, but it declared her brought dead.

The aircraft made the emergency landing around 10:30 am and a medical team took her to the hospital, officials said.

The woman's son Meer Muzaffar said he and his 60-year-old mother, Misra, were in Saudi Arabia on religious visit.

He said they had boarded the flight for Delhi, and later were to change for a connecting flight to Kashmir. "My mother complained of pain in her chest. I immediately informed the crew and it decided to go for an emergency landing in Jodhpur," he said.

Scientists Develop Completely Biodegradable Paper Straws

esearchers have developed ecofriendly paper straws that are 100 per cent biodegradable, perform better than conventional paper straws, and can be easily mass-produced.

The paper straws that are currently available are not entirely made of paper.

Straws made with 100 per cent paper become too soggy when they come in contact with liquids and cannot function as straws. Accordingly, their surfaces have to be coated. The researchers from Korea Research

Institute of Chemical Technology synthesised a well-known biodegradable plastic, polybutylene succinate (PBS), by adding a small amount of cellulose nanocrystals to create a coating material. The added cellulose nanocrystals are

the same material as the main component of paper, and this allows the biodegradable plastic to firmly attach to the paper surface during the coating process.

The new paper straws do not become soggy easily or cause bubble formation in carbonated drinks because the coating material uniformly and strongly covers the



surface of the straws, the researchers said.

Also, the coating material is made of paper and biodegradable plastic and therefore will decompose and degrade completely, they said.

"Turning a plastic straw we often use into a paper straw will not immediately impact our environment, but the differ-

ence will be profound over time," said lead researcher Oh Dongyeop.

"If we gradually change from using convenient disposable plastic products to various eco-friendly products, our future environment will be much safer than what we now worry about," Dongyeop said.

The research, published in the journal Advanced Science, found that these eco-friendly paper straws maintain their physical integrity in both cold drinks and hot drinks.

The team also found that the straws did not become soggy when used to stir various beverages such as water, tea, carbonated drinks, milk, and other drinks containing lipids, or upon prolonged contact with liquids.

The researchers compared the degree of sogginess of the new paper straws and conventional paper straws.

The conventional paper straw was severely bent when a weight of approximately 25 grammes was suspended after the straw was dipped in cold water at 5 degrees Celsius for one minute, they said.

In contrast, the new paper straw did not bend as much even when the weight was more than 50 grammes under the same conditions.

The new straws decompose well, even in the ocean. In general, paper or plastic decomposes much more slowly in the ocean than in soil because of the ocean's low temperature and high salinity, which impede growth of microbes.

Admin Asks Unregistered Courier Agencies To Get Registered

Srinagar: In order to ensure proper regulation of courier service agencies as per SOPs for delivery of shipments, the Deputy Commissioner/ District Magistrate Srinagar, Mohammad Aijaz Asad in an order issued here on Monday has asked all unregistered Courier Service Providers in District Srinagar to get registered with competent Authority within a period of 7 days, failing which they will not be allowed to continue their operations in the district.

The order stated that "Whereas, it has come to the notice of DM Srinagar through the Drug and Food Control Department, that some Courier Services are being misused for peddling of Psychotropic substances in District Srinagar".

Accordingly, vide order No. DCS/DDMO/Thq/22/1211-15 dated 04-01-2023 a Committee headed by Sub Divisional Magistrate East was constituted for verification of Courier Service Providers operating in District Srinagar.

Subsequently, the Committee vide communication, ALC/SGR/2023/60-62 dated: 27-01-2023 provided list of unregistered Courier Service Providers in District Srinagar. The order also stated that "The Courier Service Providers would ask for Aadhar identity proof, address, drug sale licence, purchase order copy of the medical products and other antecedents of the consignor and consignee while booking pharmaceutical preparations".

Furthermore, Courier Service Providers will adhere to SOPs for courier service agencies issued by Deputy Drug Controller Kashmir with respect to shipment of pharmaceutical consignments; else action under relevant provisions of law shall be initiated against the violators.

Pertinent to mention that during the month of January various instances have been brought into the notice of DM Srinagar with regard to trafficking of psychotropic substances through various Courier agencies for delivery to different parts of the Kashmir Division. Notably the DM was apprised by the Deputy Drug Controller Kashmir Shah Nighat that in the recent past on receiving credible inputs raids have been conducted during which huge quantities of psychotropic substances were seized. She said that in the month of October, during a surprise raid at Airport cargo logistic space of the Srinagar Airport about 7500 capsules of Spasmo-proxyvon were seized. Subsequently, special stress is being laid on strict adherence to SOPs for pharmaceu tical procurement.

Srinagar: Police on Tuesday arrested three employees of the Srinagar Municipal Corporation (SMC) for allegedly assaulting traffic cops who had issued a challan for violating the Motor Vehicle Act.

"An incident has come to notice wherein one SMC employee aggrieved by challan on not having HSRP, came back and broke a traffic booth with others, later assaulted traffic personnel on duty. In this regard FIR has been registered in Shergari PS against 3 delinquent SMC employees," the Srinagar police tweeted.

The police said all three accused employees were formally arrested after following legal formalities."The three had also kidnapped the traffic personnel in a car after creating a ruckus. FIR No 06/2023 stands registered in Shergari PS," it added.

However, the SMC employees alleged that they had demolished an encroachment of the traffic department which had infuriated the cops.

RINAGAR - People in the border district of Kupwara are intrigued at the reports of some militants being killed by the security forces and the special operations group (SOG) personnel in various encounters during the past few days. The identity and nationality of the slain 'militants' has not been disclosed.

According to reports, troops" of 18 Rashtriya Rifles (RR) had claimed killing of two unidentified militants at the Patukhari behak in Dardpora area of the district last night. Giving the details, it said an encounter took place during a patrol in which one militant was killed on the spot while the other died of his own after being injured. Both were buried in the forests.

Earlier, personnel of 32 RR and SOG had claimed to have killed two militants in Kalaroos forests during an encounter. Their identity was not disclosed and were buried in the forest.

People in Kupwara have expressed surprise at the unceremonious burial being given to the 'militants' without their identity being established or the last rites being performed as is otherwise required in such cases.

Turkey, Syria Quake

t least 5000 people have died in the major earthquake that hit Turkey and Syria. Several thousand buildings have been flattened in cities across a border region that is witnessing war, insurgency and refugee crisis. There are fears that the toll could further rise as the rubble is cleared. World Health Organization officials are estimating that up to 20,000 may have died. Turkey has now declared a state of emergency in ten quake-hit provinces to deal with the crisis and the world is mobilizing help for the victims of the natural calamity. Many countries have dispatched aid, personnel and equipment to help the rescue efforts in the two quake-hit countries. India has sent the first batch of earthquake relief material to Turkiye aboard an Indian Air Force aircraft.

But as Turkey and Syria begin to deal with the unfolding tragedy, the calamity is a wakeup call to us in Kashmir. In 2005 a big temblor that was 7.6 on Richter scale led to the loss of around 80,000 lives. Pakistan controlled Kashmir was worst affected with a predominant number of the people killed hailing from there. On this side of the then state, the quake caused devastation along the villages bordering Line of Control, particularly Uri and parts of Kupwara district leaving around 1300 people dead. If anything, Turkey and Syria quakes should warn us as to a possible repetition of this natural disaster in the region.

Already, a study by a prominent US seismologist Roger Bilham has warned that Kashmir Valley is likely to be hit by an earthquake of largest ever magnitude. But the study has not specified any particular time-frame. In what can be an apocalyptic scenario, Bilham said the quake could trigger landslides that would dam the river Jhelum, He also urged India and Pakistan to develop a cooperative plan to deal with the aftermath of a mega-quake in the union territory. But ever since the 2005 earthquake which initially alerted the government and the people to build stronger, reasonably quake resistant structures, the complacency seems to have again set in. The quakes in Turkey and Syria have thus come as an important reminder to us to become more mindful of our vulnerability to the natural disasters - flood being the another – and take pro-active measures to lessen the damage should, if God forbid, we experience another disaster. It is incumbent on the government not only to get its act together but also create public awareness to help people to better prepare for a possible future calamity.

illions have taken refuge in rebel-held Idlib, where most of them are dependent on aid. Its White Helmets have had to become expert at rescuing people from rubble. But they are in desperate need of search-and-rescue equipment, spare parts and fuel. The organisation also urged the international community to pressure Bashar al-Assad's regime - and Moscow, which supports it - to hold back on airstrikes. Though conflict in Syria has faded from international attention, the complex regional struggle - not only of the regime against rebels, but of Turkey against Kurdish groups and Israel against Iranian-linked targets - continues to claim lives in

the north and there are fears it could escalate. The mandate for Syria cross-border aid via Turkey has, thankfully, been extended until July. But, at present, Damascus allows it to enter via only one border point. It would be unconscionable if the others remained closed at this time of desperate need. Though the regime bears the primary responsibility for the suffering of its people, others must step up. Ankara's attempts to accelerate the return of Syrian ref ugees would exacerbate the situation were they to continue. The humanitarian response plan for Syria was already severely underfunded; less than half of the \$4bn needed has been provided - the lowest level since the crisis began. The need is all the greater now. Ensuring that aid reaches the most vulnerable will be difficult in the extreme. But every effort must be made. It would be not only tragic but shameful if the international community's failures were to compound

he passing away of former Pakistan president General Parvez Musharraf couldn't have come at a more telling moment in Kashmir's history: not only is there no engagement between India and Pakistan but New Delhi has also decisively taken Kashmir off the table from any discussions with Islamabad - the 75 year old issue that Musharraf came closest to resolving during his tenure. If lawvers' agitation hadn't happened, which eventually forced his ouster, India and Pakistan may have reached a breakthrough over the issue. And who knows the relations between the two countries might have entered a happily ever af-

It is now difficult to believe that during Musharraf's term, when the peace process between India and Pakistan was in full ings went from 961 in 2004 to just 100 in 2013. What is more, it was Musharraf who first instituted the ceasefire along the Line of Control in 2002. And it was this truce that India and Pakistan reaffirmed in February 2021. In a sense, one feature of the current uneasy calm between the two neighbours harks back to Musharraf era.

But in all other features, we have moved on from Musharraf's time. Since then, Pakistan has become a weaker country and has also lost much of its bargaining power on Kashmir. And going by the words of its prime minister Shahbaz Sharif, last year the country was bargaining for a plan to freeze the Kashmir issue for 20 years, reportedly in lieu of trade with India.

Earthquake Devastation in Turkey and Syria is a Warning for Kashmir

The earthquake occurrence in Turkey and the contiguous regions is not new. The hazards are well-known, mapped, and established by earthquake scientists long ago. Therefore, the potential of earthquake faults to host devastating earthquakes in Turkey was forecasted by geologists, which means that the ability of the fault to have earthquakes of magnitude seven and above was known. Yet, that crucial information was not put into practice, resulting in the devastation, which is yet to be fully scaled regarding the estimation of loss of life and assets. It is reported that populated regions in the border areas of Turkey and Syria were initially hit by the magnitude 7.8 quake, which caused widespread devastation. And then, another 7.5 magnitude earthquake occurred in the nearby region and caused much more damage, which has not been fully accessed. We could only wish and pray for the safety of all.

But the more significant question remains about our consistent failures due to our inability to secure life and assets. The earthquake hazard was known, but only the quake's timing was unknown, which perhaps we may never master because of the complexity of how faults behave. Therefore, we had enough time that we could have efficiently used to develop a robust scientific approach to building buildings to secure them from toppling like a deck of cards. We miserably failed, and that is our own fault. The earthquake hazard



What kind of structures and buildings have we constructed to withstand earthquakes? They are a deck of cards that are ready to topple. And we are not taking anything seriously, although we have all the information available to us that the region has the potential to cause a damaging earthquake in the future

was turned into a disaster by our failures to learn from our mistakes and to follow the available scientific wisdom. We are helping by sending aid and other lifesaving facilities, akin to digging a water well

when the fire is ongoing!
The entire Jammu and Kashmir

region is battling a similar fate, where earthquake hazards could turn into disasters. There is everything available that is needed just to do that. We have no ground preparation to handle magnitude seven and above quakes, which should send shivers down our spines. What kind of structures and buildings have we constructed to withstand earthquakes? They are a deck of cards that are ready to topple. And we are not taking anything seriously, although we have all the information available to us that the region has the potential to cause a damaging earthquake in the future. The timing is not known, which is a global problem in earthquake research where the timing of the incoming earthquake cannot be established. We should take this as an opportunity,

prepare for the worst, and plan for any eventuality.

Therefore, we must learn from the earthquake devastation in Turkey and use it as a warning to prepare ground for major earthquakes in Jammu and Kashmir. We are waiting for a major quake, which is based on scientific evidence, and that could cause devastation of enormous scales. Please follow the instructions on how to build earthquake-resistant structures and how to repair houses so that they can face major earthquakes. Time is ticking, we are on a tectonic clock, and we must prepare — now.

Can We Get Better At Predicting Earthquakes?

iven the devastation earthquakes cause, seismologists and public officials have long wanted to know when earthquakes will happen, and after the powerful 1964 Alaska earthquake, U.S. scientists proposed a worldwide research program on earthquake prediction.

In covering the initiative, Science magazine emphasized that "carrying out the proposal (i) would offer a fair chance to develop a method of giving warnings 'hours to days' in advance of major earthquakes and (ii) would, through engineering research, provide means of minimizing loss of life and property damage, even if a warning system were not achieved."

The public has been interested more in prediction than in mitigation, however. And in spite of major progress among scientists in understanding the earthquake process and what causes disastrous shaking, it seems there is substantial disappointment in the apparent failure of "earthquake prediction."


To some extent, this is an issue of semantics and objectives. Is the goal to predict an earthquake occurrence, predict ground motion due to an earthquake, or predict a disaster? Considering all of these, what is it that seismologists can and cannot do when it comes to predicting earthquakes?

EARLY WARNING

Fortunately, all earthquakes do not lead to disasters and, therefore, understanding where and why disasters are produced is the first goal of earthquake seismology.

But in our efforts to better predict earthquakes, we have to be precise about the timescale: is it a prediction that an earthquake is imminent – that is, within seconds, hours, or even days before the shaking? Or that it is likely to happen within years or tens of years?

Each of these predictions could be



useful, and the type of action this information would lead to depends on the location of the earthquake and the sociogeographic and economic circumstances.

For example, even if one cannot predict earthquakes themselves, the ability to predict ground motion shortly after the onset of an earthquake could allow one to send warnings seconds or minutes before the main shaking is expected to occur. This means that some critical infrastructure could be automatically switched off safely, such as trains and nuclear power plants, and the public could be alerted.

This form of early warning, produced after the earthquake (or at least after the beginning of the earthquake), is already in practice in several of the most populated and earthquake-prone places in the world.

PREDICTING VULNERABILITY

The vibrations we feel during earthquakes, and which could destroy buildings and other infrastructure, are the effect of the elastic waves that propagate from

the earthquake source through the rocks in the Earth's interior and along its surface. Earthquakes produce different types of waves, some more destructive than others.

These waves propagate with velocities of the order of kilometers per second, but the most damaging waves often arrive after the first waves. This means there is a time lag between the electronic signals sent by our instruments and the most damaging waves, creating opportunities for action. This field is called real-time seismology, and operational systems have been set in different regions of the world, including Japan, Italy, Mexico, and California. These systems do not predict the time of occurrence but act as a warning of activity.

For long-term intervals (years to decades), geophysics provides the basis for rational management of affected resources and seismic safety. The quantitative analysis of actual earthquakes allows one to decipher the local conditions prone to disastrous shaking for specific buildings. Therefore, it provides the basis for including land management in seis-

mic risk mitigation plans. In that sense, seismologists already provide the information required to adopt development policies oriented toward public safety.

Large improvements have been and will continue to be made, but it is difficult for the general public to appreciate the effectiveness of this approach (known as probabilistic seismic hazard analysis) because this type of "prediction" is expressed in terms of long-term probabilities, whereas the visible parts of earthquakes are the dramatic images of disasters in the news.

The public view of earthquake prediction typically concerns a deterministic (yes/no) assessment of whether or not an earthquake will happen on the intermediate timescale (hours to days). And it is precisely this field for which seismologists have not yet made definitive operational progress. The reasons for this are related to the complexity of the physical processes that cause earthquakes.

THOUSAND-YEAR BUILDUP

Earthquakes result from insta-

bilities at locations where the resistance to slipping (the friction) of a fault is close to the forces that come from the slow plate movements of the Earth.

Although not felt in our everyday experience, the solid Earth is an evolving system. Its inner parts are subject to thermochemical convection. That is, cold and heavy materials at the surface tend to move downward and, conversely, hot material from the deep interiors moves upwards, and these motions result in plate tectonics

Typical velocity of plate motion is of the order of centimeters per year. During an earthquake, the two sides of a fault slide at velocity of the order of a meter per second – about a billion times (!) faster than the steady-state background motion.

In other words, damaging earthquakes occur in seconds but have typically been in the making for tens, hundreds or sometimes even thousands of years. The time for us to observe the Earth is so short that we have no hope of assessing with fine precision when a critical state will be reached.

will be reached. Nevertheless, it has been recognized for a long time in experimental and theoretical studies that instabilities could be preceded by a change in a short time period relative to the long tectonic/geologic preparation. Such a preparatory phase, often referred to as initiation, is not systematically observed with present day geophysical methods, and one would be forgiven to think that the case is hopeless given the uncertainties about duration and amplitude of the initiation process. However, discoveries in recent years are giving a more encouraging pro-

'SLOW EARTHQUAKES'

Geodesy and seismology have seen substantial progress in detecting subtle changes in rocks below the surface. Continuous GPS recorders and advanced processing techniques allow for the detection of smaller and smaller motions. Both GPS and seismometers are increasingly deployed in large dense arrays, producing antennas with unprecedented detection capabilities.

In the past few years, these efforts have led to the discovery of new types of deformation processes. The most spectacular of these concerns the widespread observation of so-called slow earthquakes. Slow earthquakes are slipping episodes at depth with deformation velocities that are in between plate tectonic motion and regular earthquake slip.

The largest known slow earthquakes have magnitude of more than 7.5 when measured as regular earthquakes, and there is increasing evidence that, just as for regular earthquakes, slow earthquakes occur on a wide range of magnitudes. This suggests that deformation of the Earth occurs on a broad spectrum of timescales. That is, times in between the extremes of slow motions from plate tectonics and mantle convection and the ultrafast and

disastrous seismic ruptures.

The newly discovered transient deformations can be studied with geodetic measurements and by a refined analysis of seismic records. These have indicated that slow deformation is accompanied by a characteristic weak grind.

There is, therefore, hope that one day we could detect and monitor extremely slight changes in the rocks that would precede earthquakes. This is, indeed, a long way from "prediction" of precisely when and where a disaster will occur, but geophysicists will persevere and continue to make new discoveries

about the changing Earth.

For now, knowing earthquakes is one way to live with them, to be prepared, to know the vulnerability of our communities and to adopt sound policies for earthquake-safe environments.

Over 83,000 Posts Vacant In Central Armed Police Forces: Govt

New Delhi: More than 83,000 posts were lying vacant in the Central Armed Police Forces (CAPFs), such as the CRPF and the BSF, as on January 1, against the total strength of 10,15,237 posts, the government informed Parliament on Tuesday.

The forces in which the posts are lying vacant are Central Reserve Police Force (CRPF), Border Security Force (BSF), Central Industrial Security Force Indo-Tibetan Border Police (ITBP), Sashastra Seema Bal (SSB) and Assam Rifles.

"The current number of vacancies as on January 1, 2023 in the Central Armed Police Forces (CAPFs) and Assam Rifles are 83,127 against total sanctioned strength of 10,15,237," Union Minister of State for Home Nityanand Rai said in a written reply to a question in the Lok Sabha. He said 32,181 people were recruited between July 2022 and January 2023 and an additional

notified and are at different stages of recruitment, adding that it has been planned to conclude the exercise in 2023 itself.

It will be incorrect to say that the vacancies are leading to overtime work for the existing personnel, the minister added.

He minister said filling up vacancies is a continuous process and added that the home ministry has been taking and will continue to take earnest steps to fill up the vacancies expeditiously through UPSC, SSC and the forces concerned.

The CRPF is deployed for internal security duties, maintenance of law and order and antimilitancy operations in Jammu and Kashmir and the northeast.

The BSF guards the country's 3,323-kilometre-long border with Pakistan (except the 740-km-long Line of Control) and the 4,096-kmlong border with Bangladesh.

The CISF guards vital installations, such as nuclear plants, key industries, metro networks and other important government

The United Nations said it was "exploring all avenues" to get supplies to rebelheld northwestern Syria. Sebastien Gay, the head of mission in the country for Doctors Without Borders, said health facilities were overwhelmed, and medical personnel were working around around the clock to help the

Nurgul Atay told The Associated Press she could hear her mother's voice beneath the rubble of a collapsed building in the Turkish city of Antakya, the capital of Hatay province. But efforts to get into the ruins had been futile without any heavy equipment to help.

"If only we could lift the concrete slab, we'd be able to reach her," she said. "My mother is 70 years old, she won't be able to withstand this for long.

But help did reach some. Several dramatic rescues were reported across the region as survivors, including small children, were pulled from the rubble more than 30 hours after the earthquake.

Residents in a Syrian town discovered a crving infant whose mother apparently gave birth to her while buried in the rubble of a five-story apartment building, relatives and a doctor said. The newborn was found buried under the

debris with her umbilical cord still connected to her mother, Afraa Abu Hadiya, who was found dead, they said. The baby was the only member of her fam-

ily to survive from the building collapse in the small town of Jinderis, next to the Turkish border, Ramadan Sleiman, a relative, told The Associated Press. In the city of Aleppo, a Maronite Christian

convent opened its doors to hundreds of residents who fled their shaking homes.

"Based on our principles and ideas of receiving the most needy, we wanted to make sure that everybody who was scared or lost their house or was on the streets could find shelter here," said Brother George Sabah. "We opened every part of the convent. There isn't a space in the convent that isn't being used by people, including the elderly, children, men, women."

Turkiye has large numbers of troops in the border region and has tasked the military with aiding in the rescue efforts, including setting up tents for the homeless and a field hospital in Hatay province.

A navy ship docked on Tuesday at the province's port of Iskenderun, where a hospital collapsed, to transport survivors in need of medical care to a nearby city. Thick, black smoke rose from another area of the port, where firefighters have not yet been able to douse a fire that broke out among shipping containers toppled by the earthquake.

Turkiye's emergency management agency said the total number of deaths in the country had passed 4,500, with some 26,000 people

injured. The death toll in government-held areas of Syria climbed over 800, with some 1,400 injured, according to the Health Ministry. At least 900 people have died in the rebel-held northwest, according to the White Helmets, the emergency organisation leading rescue operations, with more than 2,300 injured. The region sits on top of major fault lines

and is frequently shaken by earthquakes. Some 18,000 were killed in similarly powerful earthquakes that hit northwest Turkiye in 1999.

J&K Launches GPS Based Attendance App For Teachers

App To Seek Feedback From Students Also Unveiled

JAMMU: With the launch of two applications by Chief Secretary, Dr. Arun Kumar Mehta on Tuesday, Jammu and Kashmir became first in the country to take online monthly feedback from students of class 6th and above about the performance of their teachers and carry out the GPS based attendance of teachers on daily basis.

The ceremony was attended by Principal Secretary Education; MD, Samagra Shiksha; Director School Education Kashmir/Jammu, Director Estates, Secretary JKBOSE and many other concerned officers.

Dr Mehta complimented the department for developing these applications and called them the powerful tools to take the education sector towards much higher efficiency and accountability. He remarked that these applications would ensure that an authentic feedback comes from the grassroots level from the ones who are directly involved in the learning process.

He enjoined upon the officers to monitor the progress at highest levels so that the results improve substantially. He maintained that the teachers in the government sector are best in terms of qualifications and training and they just need to focus more on academic activities to ensure improved results.

The Chief Secretary advised the department to make this feedback a benchmark while analysing the annual performance reports of the teachers. He said that the teachers who perform well, and are punctual and who also receive good feedback from students should be duly recognized and re-

warded by the department. He observed that such teachers should be preferred in career progression and other recommendations

The system is named as "SAMIKSHA" as it will be reflecting the true performance of the Teachers with respect to their inputs in the actual classroom, leaving no space for subjectivity.

It was given out that the student feedback forms are designed to get feedback from students on different teachinglearning techniques in the institution. Besides, the teachers are given unique usernames and passwords to verify their input and outcomes. The comprehensive report will be visible to all levels viz-Teachers, HOIs, ZEO, CEO, DSEK/J, and at UT level in the hierarchy.

The department has worked out some 25 parameters (questions) regarding teachers and school ambience, out of which 02 are optional. The school and teacher based questionnaire needs to be filled by the students once on a monthly basis grading them on a 5-point scale with Excellent, Very Good, Good, Average and Below Average results, as informed during the launch ceremony

Another app launched today was 'JK Attendance-SED' available for downloading on both Android and iOS. The application will give a peek into the daily attendance of teachers to even Directors and CEOs. The application will capture live location of the employee with Geo Coordinates and even allow his/her time specific tracking.

agement of attendance across all schools.


The same application would enable employees to make leave requests online. It would automatically send it for necessary approval and keep his/her leave account safe for viewing by the higher authorities.

BANDIPORA: The District Administration Bandipora on Tuesday facilitated airlifting of about 58 passengers between Gurez and Bandipora including 9 patients and 5 students appearing in JKSSRB exams.

Attacks On Vinícius A Problem Of Spanish Football: Ancelotti

MADRID: The hate attacks against Vinícius Júnior are a problem of Spanish football and must be dealt with, his Real Madrid coach Carlo Ancelotti said on Tuesday.

Vinícius, the Brazilian forward who is Black, has been subjected to hate attacks since he arrived in Spain in 2018. The most recent were on Sunday at a Spanish league game in Mallorca. Last month, his effigy hung off a bridge in Madrid before the derby against Atletico Madrid.

The question I ask is this: What does Vinicius have to defend himself against? What do his teammates have to defend themselves against?" Ancelotti said on Tuesday on the eve of Madrid's debut at the Club World Cup in Morocco.

"Is Vinícius the problem? It seems like the problem is Vinícius, but the problem is what happens around him. Period. "It is a problem of Spanish football. I am a part of Spanish football and I think it's a problem that we have to solve. Because it seems that Vinicius is the culprit, but he is being the victim of something that I don't understand."

Vinícius has been outspoken about the insults and often complained on social media of how he's been treated.

He was also targeted because of his dances while celebrating goals, and recently his team-

high number of fouls he was receiving in games. Last week, Valencia defender Gabriel Paulista was sent off after a vicious foul on Vinícius in a league game.

"Vinícius is an incredible person, with great values," teammate Federico Valverde said. "He is different than most on the field, he enjoys football in his own way, in a happy way. I don't think the rival fans are thinking about the person, they don't realize that he could be the son of anyone who is in the stands. People need to be responsible for what they do, they shouldn't take it out on a 22-year-old. You need to have respect."

Racism in Spanish football has attracted more attention recently but little has been done to punish anyone.

The Spanish league was investigating the attacks on Sunday at Mallorca after TV images showed someone calling him a monkey. Vinícius was also insulted after the match when he stopped to pose for photos and sign autographs for fans. Authorities have yet to find those responsible for hanging Vinícius' effigy last month, and so far teams have not been punished for the racist insults inside their stadiums.

The first trial against a fan who racially insulted a player in Spain is expected to begin this year following remarks by an Espanyol supporter against Athletic Bilbao forward Iñaki Williams mates called attention to the a few years ago. (AP)
