SC To Consider Listing Of Pleas Against Abrogation

New Delhi: The Supreme Court Friday said it will take a decision on early listing of petitions challenging the Centre's decision to abrogate provisions of Article 370 which had given special status to Jammu and Kashmir.

A bench comprising Chief Justice D Y Chandrachud and Justices P S Narasimha and J B Pardiwala took note of the submissions of senior advocate Raju Ramchandran, appearing for one of the parties, that the pleas needed an urgent hearing.

"All right. I will take a call on it," the CJI said.

On December 14, last year also, the pleas for urgent listing were mentioned before the bench by Radha Kumar, an academic and author, who had intervened in pending petitions.

Earlier on April 25 and September 23, last year, a bench headed by the then CJI N V Ramana, since retired, had agreed to list for hearing the pleas challenging the Centre's decision to abrogate provisions of Article 370.

The apex court will have

to re-constitute a five-judge bench to hear the pleas as ex-CJI Ramana and Justice R Subhash Reddy, who were part of the fivejudge bench which had heard the

Besides the two former judges, Justices Sanjay Kishan Kaul, B R Gavai and Surya Kant were part of the bench which, on March 2, 2020, had declined to refer to a larger seven-judge bench the batch of petitions challenging the constitutional validity of the Centre's decision to abrogate provisions of Article 370 on August 5, 2019.

Several petitions challenging the Centre's decision to abrogate provisions of Article 370 and the Jammu and Kashmir Reorganisation Act, which split J-K into two Union Territories Jammu and Kashmir, and Ladakh were referred to a Constitution Bench headed by Justice Ramana in 2019 by the then CJI Ranjan Gogoi.

Srinagar: The weather department on Friday predicted twoday spell in Jammu and Kashmir from February 19, even as the night temperature further rose at all places in the Valley, barring Pahalgam in South Kashmir.

Deputy Director. Meteorological department (MeT), Dr Mukhtar Ahmad said that the weather would remain mainly dry tomorrow while there is a possibility of light rain and snow at isolated higher reaches of Kashmir on February 19.

With the possibility of light rains, snow at isolated higher reaches of Kashmir, the weather would remain generally cloudy, he said, adding that on February 20th, there is a possibility of light rain in plains and light to moderate rain and snow in middle and higher reaches during 20th late afternoon to early morning of February 21st.

He further informed that from February 21-24th, the weather would remain occasionally cloudy with mainly dry weather.

The Meteorological department has also advised people to stay alert and away from avalanche prone areas.

JKP Gets Corner Shot Pistols Among New Weapons

Jammu: The Jammu and Kashmir Police has for the first time inducted three state-ofthe-art weapon systems, including the made-in-India 'Zen ShootEdge' corner shot pistol, to strengthen its arsenal as it counters various security and counter-terror challenges in the Union territory.

Personnel of the force are undergoing training with the newly inducted Tavor X-95 and MP-5 rifles and the 'Zen ShootEdge' pistol, officials said, adding the corner shot pistol facilitates shooting around corners and over the top of walls without exposing the user

"Recently, three new weapons were inducted into the force. The (police) force got these three weapons in which



there is a corner shot weapon. There was a dearth of such weapons in the force," Senior Superintendent of Police (SSP) Kulbir Singh told PTI here.

He said it is necessary to modernise the force's arsenal to meet and combat greater security and counter-terrorism challenges. "It is always expected that we upgrade our weapons. It has taken place in the past too," Singh said. More on P

'Snakes Can Hear More Than You Think'

A study by the University of Queensland discovered that snakes can hear and respond to airborne sounds in addition to ground vibrations.

Dr Christina Zdenek from UQ's School of Biological Sciences, in collaboration with QUT's Professor Damian Candusso, played three different sound frequencies to captive-bred snakes one at a time in a soundproof room and observed their reactions.

"Because snakes don't have external ears, people typically think they're deaf and can only feel vibrations through the ground and into their bodies," Dr Zdenek said.

"But our research -- the first of its kind using non-anesthetised, freely moving snakes -- found they do react to soundwaves travelling through the air, and possibly human voices," she said.

The study involved 19 snakes, representing five genetic families of reptile.

"We played one sound which produced ground vibrations, while the other two were airborne only," Dr Zdenek said.

"It meant we were able to test both types of 'hearing' - tactile hearing



airborne through their internal ear," she added.

The reactions strongly depended on the genus of the snakes.

"Only the woma python tended to move toward sound, while taipans,

through the snakes' belly scales and brown snakes and especially death adders were all more likely to move away from it," Dr Zdenek said.

> "The types of behavioural reactions also differed, with taipans in particular more likely to exhibit defensive and cautious responses to sound.

Dr Zdenek said the different reactions are likely because of evolutionary pressures over millions of years, designed to aid survival and reproduc-

"For example, woma pythons are large nocturnal snakes with fewer predators than smaller species and probably don't need to be as cautious, so they tended to approach sound," Dr Zdenek said.

"But taipans may have to worry about raptor predators and they also actively pursue their prey, so their senses seem to be much more sensitive." Dr Zdenek said the findings challenge the assumption that snakes can't hear sound, such as humans talking or yelling, and could reshape the view on how they react to sound.

"We know very little about how most snake species navigate situations and landscapes around the world," Dr

"But our study shows that sound may be an important part of their sensory repertoire," she added, saying, "Snakes are very vulnerable, timid creatures that hide most of the time, and we still have so much to learn about them.'

Microsoft May **Bring ChatGPT** Bing AI To Android, iOS Soon

icrosoft has started rolling out **the new** ChatGPT-powered Bing on desktops to early testers worldwide, and it will also be available on Android and iOS in the coming weeks, the media reported.

The tech giant is working on a "substantial optimised interface" for Bing. com's Chat UI for Android and iOS, which includes all-new OpenAI-powered content, reports Windows Latest, citing sources.

In an email sent out to testers, Microsoft confirmed that the mobile experience is not yet ready, according to the report.

"We don't have a mobile experience ready yet -- we are actively working on it and will have it ready soon. Until then, please continue to use the new Bing on desktop and download the Bing app from your favourite app store to ensure you are ready for the amazing experience when the mobile version is ready," the company said in the email.

Moreover, the report said that the company is still optimising Bing.com's Al UX for mobile form factors.

Meanwhile, Microsoft is also reportedly planning to demonstrate its new Prometheus model to its core productivity apps such as Word, PowerPoint, and Outlook.

In the coming weeks, Microsoft will detail its productivity plans for integrating OpenAI's language AI technology and its AI Model, reports The Verge, citing sources.



Dal Lake's Area Never Changed: VC, LCMA

Srinagar: The Lake Conservation and Management Authority (LCMA) on Friday said that the area of the world famous Dal Lake has never changed, claiming that the lake covers an open space area of 20.3 square kilometers.

Vice Chairman, LCMA, Bashir Ahmad Bhat said that the area on which the lake is spread has never changed as it always remained constant at 25 square kilometers.

'Three years ago, the open space at lake was just 13 kilometers as nearly seven square kilometers of the lake was infested with Lilly and other things,' he said, adding that the open

space of the lake was increased as all Lilly was removed from the lake, taking the open space of the water body to 20.3 square kilometers.

He further said that space would be increased further as many patches of land have been identified, where dredging has been started.

The Vice Chairman also said that navigation channels have also been restored previously, which were closed earlier, it helped to increase the circulation of water, adding that the main aim is to expand Dal Lake as much as possible without infringing any other thing.

"It is a live lake; almost all of the areas have vegetation. Infestation of the vegetation had in-

creased till two years ago, a substantial portion was occupied by Lilly, it would have turned into land mass, but all such infestations have been removed and currently, the open space has been increased to 20.3 square kilometres," he added.

Asked about the reports showing the lake squeezing from 21 square kilometres to 12.5 square kilometres from 1950 to 1998, he said that these reports are not based on facts. "The fact is since the survey conducted by Sir Walter Lawrence, nothing has changed. It was in fact 18.3 sq kilometres then, but now the open space has increased further. There were some hamlets, they were dredged out and helped to expand the lake sur-

Srinagar: Most of the sewage coming out of the houseboats gets dumped into Dal Lake, polluting the famous water body in Srinagar. The government says that the work on laying the sewerage system is already going on and the project is likely to get completed by March 2023.

The sewage coming out of the houseboats is presently getting dumped in the water body, which is further deteriorating the quality of water at Dal Lake. "Most of the sewage from the houseboats presently gets dumped into Dal Lake only, but after the completion of the sewage system, the sewage will be shifted to the treatment plant, which will ensure quality water in the lake," General Secretary of Kashmir Houseboat Owners Association (KHOA), Abdul Rashid Kolu said.

He said that the government started work last year in Septemthat the work was started soon after the Chief Secretary gave directions to come up with the sewage system, which is coming up at the cost of Rs 13.5 crore.

"The pipelines have been laid at several places, but the process has been completed yet," he said, adding that the work was started in September last year, but is presently at halt for the last two months.

Chairman of the association, G R Siea said the sewage system at Dal Lake for houseboats is much-needed and welcome steps, but the work at present has been stopped probably due to winters.

However, he said that the poles have been erected at many places and it is expected that the work in this regard will be started soon. "The work in Nigeen has been completed, the weather has forced the suspension of the work and we are expecting from March again," he said.

He added that the sewage system is the best thing to prevent the sewage coming from the houseboats. Superintending Engineer of

Lake Conservation and Management Authority (LCMA), Syed Muhammad Hidayat Ullah, said that a Delhi-based company has already been hired for the work and the work was stopped following the snowfall.

"The contractor has been persuaded and has been brought back after the improvement in the weather conditions. The work will be started soon and it is expected that the work will be completed by the end of March," he said.

Pertinently, the government had said that it is opening 20 navigation channels in Dal Lake, which will help to improve the quality water and free movement of locals and tourists into the interiors of the lake— (KNO)

Earthquakes: A monster is lurking beneath Kashmir, say experts

RINAGAR - Kash¬mir may not always be a spectator to the angers of the Earth, as meteorologi¬cal experts believe that we may witness a massive earthquake, registering above 8 on the Richter scale, in future. Nobody knows when- it can be to¬morrow or after a hundred years. But contrary to the locally held belief that Koh-i-Sulaiman and other hills of volcanic origin may erupt, the danger is mainly due to the tectonic activity in the entire Himalayan re¬gion; from the Hindukush in the west to Sadiya hills in the east.

Iwrlian Meteorological De¬partment has already placed central and south Kashmir in the high risk Zone 6 of the seismic map of India. This sig¬nifies an extremely high probability of earthquakes of very high magnitudes. These dangers arise from the fact that the Indian peninsular plate is pushing itself in to the Eurasian plate at a rate of 6 cm per year and this is build¬ing up pressure in the entire Himalayan region, thus pro¬voking tectonic activity. Earthquakes in this region are primarily the release of this pressure caused by the movement of plates deep within.

The point of worry is that the entire Himalayan region bar¬ring Kashmir and western Nepal has experienced major earthquakes, thus releasing some of the tension. Experts say that an earthquake measuring 8 on the Richter scale is due in these two legions. Seismologists call an earth-quake of above 8 magnitudes as 'great'.

But no one knows when this will happen as there is absolutely no reliable forecasting method available at this time. "Although we have minor earthquakes here, as the one last year of 6.2 magni¬tude whose epicentre was in the Hindukush, but we have not experienced any great one in the last 160 to 900 years. By hypothesis and statistical prediction we can sav mat Kashmir may witnesses a severe earth¬quake. But nobody knows when", says Surinder Paul, senior meteorologist and Deputy Director Indian Me¬teorological Department, Srinagar.

Experts dismiss as myths the views about cur-rent volcanic activity in Kohi-Sulaiman and other hills in the valley. Prof. Muhammad Ismail Bhat, headof the geology and geo¬physics department in Uni¬versity of Kashmir clarifies: 'These public fears have no basis, we do not face any danger from these hills nor is there any question of some volcanic activity going on inside them". Studies have revealed that these hills came into being some 280 million years ago because of volcanic eruptions, and remained active for another 100 million years. They have shown no activity for the past 180 million years.

The extensive media treatment of the causes behind earthquakes (after the Gujarat quake) has made terms like 'tectonic plates' and 'Richter Scale' almost household words, and public awareness about earth's temperament has increase substantially. The fact that earthquakes cannot be predicted with pinpoint accuracy, leave alone prevented, is being accepted with philosophical stoicism. One point of comfort has emerged from this deluge of specialised information, and experts have put it across with admirable clarity: 'Earthquakes do not kill people, buildings do.' There lies the hope for people in regions prone to earthquakes, if governments wake up in time, that is.

Kashmir's War on Drugs

Efforts are being made behind the scenes in the valley today to save young and restless from becoming victims of the substance abuse. But even as the syndicate of Samaritans is working tirelessly, the deep influx of drugs is only making it a tough task at hand.

ood turned militant in the back and winding alleys of Downtown Srinagar's Makhdoom Sahab locality in the recent past when the community members doubled as street vigilantes. Armed with sticks, they fortified their lanes to keep the sneaky drug-peddlers at bay. The self-styled street patrolling was perhaps one of the first conspicuous community mobilization efforts in the recent years and a shot in the arm in Kashmir's 'war on drugs' drive.

For years, the unruffled path passing through their residences would be frequented by unassuming addicts and 'dope-men'. The alleged "drug cartel"— purportedly used as a votebank by some local unionists—nearby has remained a "pain in the neck" for locals and the civil society members.

The vigilantes acted on "credible reports" that felons come in luxurious vehicles after sundown to supply drugs like heroin, brown sugar, cannabis and recreational drugs like Diazepam, Alprax and among others.

"Some people living in Sheikh Colony have been identified who are part of the deep-rooted nexus," Syed Basharat Andrabi, general secretary of Mohalla Makhdoom Sahab welfare committee—that decided to go for social boycott of these families—had alleged.

Surging drug menace in the area had enforced a new order. In nearby schools, the girl students were quietly dropping out. "Due to presence of drug addicts, movement of people especially females is hindered," Andrabi said. "If some elderly persons try to stop youth from consuming drugs, it results in a scuffle."

Streets to Surveys

The community campaign came when cops are everyday seizing contrabands and sending the peddlers behind the bar across the valley.

Reports say the number of addicts visiting Drug De-addiction Centre of Government Medical College in Srinagar has gone up to 5000, from earlier 500, patients annually.

According to a survey conducted by the United Nations Drug Control Program (UNDCP), around 70,000 people in Kashmir consume drugs.

Another survey done by the Ministry of Social Justice and Empowerment (MoSJE) in February 2019



found out that 600,000 people of the erstwhile state of Jammu and Kashmir use opioid drugs, while 80 percent of the drug addicts in Kashmir use heroin and morphine.

A study done by the Institute of Mental Health and Neurosciences (IMHANS) found out that the number of drug addicts in Srinagar and Anantnag districts has increased to 17,000. Roughly, the study says, Rs 3.7 crore is spent every day on drugs by addicts in these two districts.

Of late, these growing numbers and cases have prompted the community response, to "separate the grain from the chaff". This approach has already activated multiple counseling centres in the valley today.

Inside Counselling Centre

Mir Zubair could clearly tell an upsurge in dope cases in Kashmir when even 9-year-old Kashmiri child walks in for an emergency counseling session along with his distraught family members. He terms such cases as an 'innocence gone wrong'.

As a counselor at Concerned About Universal Social Empowerment (CAUSE), the non-government organization "working for the betterment of society", Zubair along with his welfare body has been organizing drug deaddiction awareness programs at Srinagar's Central Jail for four years.

"When we started working around 2010, there was denial at the administration as well as ground level on drug de-addiction," Zubair told Kashmir Observer "But now the scenario

has changed. There's more awareness amongst people in Kashmir."

The holistic reason for drug addiction in the valley is the social-political disturbance. "I usually receive patients in the age group of 12 and 25 years," he continued. "But at times, when a nine-year-old walks in for counseling, it takes every-body by surprise."

Why Do they Drug

For Arif, it all started with peer pressure. The trader taking trips to other cities would take heroin with his friends until one day his daughter saw him consuming it. She was shattered and started crying which triggered him to visit a drug de-addiction centre in Srinagar.

He was admitted for two months there, and started showing improvement, Aatira Ahad, who was interning at the centre that time, told Kashmir Observer. "We provided him medication and emotional therapy which motivated him to leave heroin."

Like Arif, when Junaid, 23, started taking drugs, he didn't know that it would be difficult to give it up. He resorted to drugs due to peer pressure, and when he thought of quitting, the withdrawal symptoms didn't let him do it.

Unsuccessful in getting positive results from therapists in Kashmir, he went outside to seek help but there was no relief

His parents lost hope and started uspecting him of finding reasons to

use drugs, but the corporate employee was actually struggling with the withdrawal symptoms.

When Junaid finally visited Dr. Arif Maghribi, a Srinagar-based mental specialist, he first talked about his family's 'no drug history'.

Dr. Maghribi wasn't surprised by his statement, since for many people it's a stigma in the valley to talk about drug addiction. The mental specialist treated him and also talked to his family about the issue.

ily about the issue.

"He was quite reluctant to bring his family in the initial days," Dr. Maghribi told Kashmir Observer. But after some days when the family realized that Junaid was working hard to give up his addiction, they accompa-

nied him to the mental specialist.

Currently, Junaid is working with a multinational company (MNC) and is living outside India. "His case makes it clear that family counseling is very important in a drug abuse case." Dr. Maghrihi said

case," Dr. Maghribi said.

But unfortunately, the mental specialist said, many parents lock their children in rooms with a religious book to de-addict them. The outcome of such steps, he warned, may adversely impact the addict and

even result in his death.

"People may start drugs due to peer pressure, depression, loss of loved ones, but once they become addict it is very tough to get out of the cycle," the doctor said.

"It's like, first you consume drug, then the drug consumes you." Beyond Makhdoom Sahab

What started in Makhdoom Sahab hasn't remained confined there only.

As awareness about drug and its destructive consequences is growing, many localities in Kashmir are acting as community watchmen.

"As a community, we can't behave like ostriches that bury their heads in sand to avoid problems," said Ghulam Hasan Khan, a resident of Galwanpora village in Budgam district.

A month before the abrogation of J&K's special status, Khan along with others held a massive protest against the rampant "drug trafficking" in their village. The protestors alleged that the drugs are being cultivated on over twenty kanals of land and is being sold out to even minors.

"We can't let drugs to devour our children," Khan said. "We must come together to spread the message that there's no hope in dope."

s a witness to the rise and fall of different artistic dynasties, an old dusky tree at the iconic Zero Bridge in Srinagar sends down its leaves, swirling onto the wet deck of the bridge to carpet its dull lurid floor. The pitiless frosty air born out of the bosom of Jhelum sways everyone clicking selfies and those sitting on the dilapidated benches made of oak tree.

Among many others, Zameer Ashai, dressed in discreetly dark and baggy jacket, drab pants running straight into his long suburban black boots, amiably looks at the river Jhelum with his sullen eyes reminiscing his lost legacy holding a chilled cup of tea. He doesn't empty the cup peculiarly as it remains his lone companion through his stay at the bridge during these days.

"I hardly see any of my colleagues here," says Ashai, a renowned Kashmiri TV artist, in a sober voice. "Currently, they're busy searching work to make ends meet."

The quintessential Zero Bridge has always been a parallel universe in a sense that over the time it has proven to be an aisle of creativity. The bridge brought together outrageously rich names of bedraggled DD Kashir who in early 2000 would enthrall people with their characters whose voices would reverberate in every Kashmiri home.

authorities saw as "Pakistani propaganda", DD Kashir was supposed to promote the talent within Kashmir to bring a sense of togetherness among people and authorities.

"As per the pledge taken while bringing DD Kashir into existence, the locals would be engaged and given livelihood," Ayash Arif, another veteran actor of DD Kashir, says.

"But post 2010, there were some unauthorized programmes which created rift between us and the authorities."

The dramatic duo of Ayash Arif and late Shadi

Lal Koul was known to bring laughter to Kashmiri homes. But the advent of cable TV allied with dull as dishwater attitude from DD Kashir did wonders for its great fall.

It was indeed overwhelming for the people seeing the local talent on their TV sets. But today, when OTT platforms are even swaying away the Cable TV audiences, DD Kashir has been pushed into a state of defunct and its artists in despair as they struggle to make ends meet.

Behind its fall and gradual fading from public memory is its old-school model, says Aijaz Rah, a local singing sensation and a prominent figure of DD Kashir.

"It could've done wonders till now but it has gone in a reverse direction," Rah says. "They don't hire new artists and on being asked they throw the entire weight on the absence of suitable budget."

Director DD Kashir, GD Tahir, didn't respond to repeated queries from Kashmir Observer on the stringent and incongruous attitude of the channel culminating fatal results for the artist community who once earned their bread from it.

And now, they're left dry pocketed. As alleged by many they are still awaiting the release of their payments.

"We're in deep distress as many of the families of our artist community are in starvation," Rah continues to voice the artistic anguish. Though Kashmir has throughout the course of

its history been a political theatre, but it is now taking a toll on the lives of the artists who remain clueless about their future.

Handoo is a suave man, whose work-in-progress—a study on the role of Alternate Financial solutions in augmenting financial inclusion in J&K—is about to shape up as a telling treatise.

Before wearing the hat of an executive dealing with ideas, the Srinagarite studied Media, Interest-free Banking & Insurance and Mid-Career professional courses in Direct taxes and allied laws.

Back in the tumultuous 1990, he worked in the J&K Bank for over a year, before joining Income Tax Department till the year 2021, when as Assistant Commissioner of Income Tax he voluntarily opted out of the Government service to explore opportunities beyond his comfort zone.

"The few skillsets that I acquired over the period of time come handy while dealing with modern professional challenges," he says. "My core area interests are in the fields of Alternate Finance, regulatory compliances and business planning."

As an Associate Fellow with the London-based Institute of Interest-free Banking & Insurance, Handoo terms Kashmir Angel Network or KAN a cohort of highly experienced members who have excelled in their own domains.

Moreover, we have to discount red flags, if any, present in the aspiring startups.

WHAT SETS YOUR APPROACH TO STARTUP SELECTION APART FROM OTHERS IN THE MARKET?

rankly speaking, we are the $oldsymbol{\Gamma}$ only ones in the private sector in J&K for the time being. But that doesn't make our job any easy. It in fact is a challenge. While we indulge in the core business activities, our engagement also extends to building an enabling ecosystem around the growth of startups, creating awareness towards modernised entrepreneurship and digitization. Nevertheless, our approach is thoroughly professional in following the due process as per industry norms. We conduct research from our side regarding the sector of economy that the relevant startup relates to, call for the meet up with founders, evaluate the team and their nitchdeck check the business model and the financial streams, conduct due diligence and review their business plan and take a call ahead. May I point out that the KAN represents a network of highly experienced members who have excelled in their own domains. That is the edge which provides unique insights and access to resources for startups and also helps us to identify the startup that others may overlook.

INCLUSIVITY AND DIVERSITY ARE CRITICAL IN ANY INDUSTRY. CAN YOU HIGHLIGHT THE IMPORTANCE OF THESE VALUES IN YOUR NETWORK'S INVESTMENT DECISIONS AND INITIATIVES TO PROMOTE THE GROWTH OF UNDERREPRESENTED ENTREPRENEURS?

Recently, we have tied up with Wadhwani Foundation, Bangalore, an important entity working for fostering startup ecosystem, to provide the entrepreneurs based in Kashmir a platform to scale up their ideas. Both these programmes are fully sponsored in order that the goal of inclusivity can be achieved.



WHAT STEPS DO YOU TAKE TO EVALUATE THE POTENTIAL OF A PROSPECTIVE INVESTOR, AND WHAT KEY CRITERIA DO THEY NEED TO MEET IN ORDER TO BE ACCEPTED INTO THE NETWORK?

An investor can get onboarded by registering on our website. There is a process in place for enrolment of an investor whose aspirations and ideas meet with ours. The investors are charged a nominal enrolment fee. Any investor who can invest annually with a minimum ticket size of Rs. two lakhs, and can be substantiated through his/her income tax return statements can become a member by submitting his KYC details along with requisite forms.

LET'S DIVE A LITTLE DEEPER INTO THE BENEFITS THAT ANGEL INVESTORS CAN EXPECT WHEN THEY JOIN YOUR NETWORK.

Angel investors can trust the due diligence made by an investor committee of KAN before they are given opportunity to invest in a particular startup. This process benefits the investors as their risk gets minimised. Members are provided a comprehensive pre and post investment support documentation, monitoring and portfolio management services. The investors get opportunity to invest in the best scalable startups which are shortlisted through a process-driven approach.

KAN also helps create opportunity to interact with other angel investors and meet individuals experienced in working with young companies. Members also have access to in-depth reviews, video recordings, and legal and financial due- diligence reports of shortlisted companies. We understand that the startup ecosystem is an ever-changing reality which demands updating of knowledge and timely access to opportunities. Through various efforts, we indulge in active learning, investing and networking opportunities for our members.

MEASURING SUCCESS IS CRUCIAL IN ANY BUSINESS. CAN YOU SHARE WITH US THE KEY METRICS YOU USE TO EVALUATE THE SUCCESS OF YOUR INVESTMENTS?

If you are referring to the com-Imercial returns for investments, then it is too early to delve into quantification in the initial period of investments. You know that angel investments are prone to risk as against debt finance from a bank or an institution. There are no guaranteed returns in equity-based investment that includes early-stage seed investments. However, the key performance indicators are definitely identifiable pointing towards success of an investment. It all depends upon the inherent scalable potential of the relevant startup which in turn depends upon its USP, sales strategy and success of the pilot launch/ MVP. Having accepted high risk, Angel investors usually expect their investments to grow a minimum of 3x to 5x if the startup lives upto its promise.

WOULD YOU MIND SHARING SOME INSPIRING SUCCESS STORIES OF STARTUPS THAT HAVE THRIVED UNDER YOUR GUIDANCE AND INVESTMENT PROGRAM?

Some really promising start-ups with disruptive and high potential of growth are onboarded with KAN which have been groomed and made investment ready. They have reached tipping point in their growth after intervention by KAN. Their mentorship sessions are being conducted by domain experts some of whom are sitting across the country. Investments in these startups are already happening. However, Non-disclosure clauses in our incubation agreements do not allow me to disclose the name of these startups.

BALANCING THE NEEDS OF STARTUPS IN YOUR PORTFOLIO WITH THE EXPECTATIONS OF INVESTORS CAN BE A CHALLENGE, CAN YOU DISCUSS HOW YOU NAVIGATE THAT BALANCE AND WHAT IT TAKES TO BE SUCCESSFUL IN THAT ROLE?

It is indeed a challenging task to Ibalance between the needs of startups and expectations of investors. But when you have a clear communication and transparency with both the parties involved; when expectations are set as such that both the parties understand the risks and the rewards of the investment, coupled with understanding of the startups SWOT, and maintaining regular communication are some important steps to maintain the balance between the needs of startups and expectations of investors.

FOR ASPIRING ENTREPRENEURS SEEKING FUNDING AND SUPPORT FOR THEIR BUSINESSES, WHAT ADVICE DO YOU HAVE FOR THEM IN TERMS OF WHAT THEY SHOULD LOOK FOR IN AN INVESTMENT NETWORK AND HOW TO PREPARE FOR THAT PROCESS?

This question is pertinent as it relates to the mission of KAN. The startups are in need of money and would normally accept wherever it comes from. But the angels that they look for should be experienced and transparent in declaring their investment goals. Startups must know in advance the terms of investment including the share of control that the angels are looking for and the return on investment that they expect. With this knowledge in possession, a startup could breathe easy while dealing with a potential angel investor network.

Our basic endeavour is to make the startups investment ready Therefore, we would like that the aspiring startups should prepare a competitive and comprehensive pitch deck that clearly explains their business idea, the problem or the business gap they have identified, its solution in quantified terms, market opportunity, and clear projections of their growth. They should be mindful of their business and financial model. It is important for the team to be receptive, open to suggestions, willing to learn and build relationships. We would like them to be actively involved in building their network. They must attend events like KANversations that are being organized for this purpose. It will help them to get an insight into the procedure and workings of the ecosystem and the culture.

They need to be sure of the funds they seek and should be ready with a satisfactory explanation about the purpose for which the funds are sought. Lastly, their proposal should be backed with projections.

HOW DO YOU PLAN TO CONTINUE TO GROW AND MAKE AN IMPACT ON THE ENTREPRENEURSHIP AND STARTUP INDUSTRY IN YOUR REGION?

AN is backed by passionately driven professionals working across the globe in various leadership roles. Our mission is to be recognized as the trusted and resourceful angel investment network locally and nationally. So as to say, our goal is to expand our network of investors sitting over transnational boundaries, and reaching out to new geographies, create new programs (like the one we have tied up with Wadhwani Foundation) or better resources to cater to the needs of startups.

We would like to create the first private sector incubation centre in the Valley as also to create an angel investment fund in the near future to improve the quality and reach of our operations and make it easy to cater to the funding needs of the startups in J&K.

CAN YOU WALK US THROUGH THE PROCESS OF HELPING STARTUPS ACHIEVE SCALE AND VALUE FOR THEIR

Angel networking is a tedious job but not when driven by passion and a team of likeminded domain experts who invest their time, energies, and expertise. When the team is driven by an urge to help startups in their journey to success, there is no looking back. Thankfully, this is our story so far.

We believe that the startups need to have a solid foundation which includes a clear vision and a properly researched business plan to achieve long term success; to better understand their target market and their competition to achieve their goals. They need resources which they have no access to. This access and support is being provided by the Angel network. We help them to refine and execute their business strategy, connect startups with investors, help them track key performance indicators (KPIs) and assess their progress over time. It is very crucial to measure progress to find the gaps and shortcomings if any and fix them in real time. When this process moves as per the laid down plans, startups can achieve promised scale for their ventures.

CHALLENGES ARE INEVITABLE, BUT THEY CAN ALSO BE OPPORTUNITIES FOR GROWTH. CAN YOU SHARE ANY CHALLENGES YOU FACED AS THE FOUNDER OF AN ANGEL INVESTOR NETWORK AND HOW YOU ROSE ABOVE THEM?

Angel network as a concept was hard to sell. The name resonates with one broker company and it took a lot of effort to make this distinction visible. Actually, the idea of a private player creating a platform for startup ecosystem was totally alien in our geography. Lack of awareness, insufficient technical expertise and mentors was another major challenge. Thereafter aggregation of resources was another. However, we got over these challenges by bringing together stakeholders working in different states as also as a result of relentless reach out.

WHAT DO YOU SEE AS THE FUTURE OF ANGEL INVESTING IN JAMMU AND KASHMIR, AND HOW IS YOUR NETWORK POSITIONING ITSELF TO ADAPT AND EVOLVE WITH THE CHANGING LANDSCAPE?

With every response that we get every day from the people of J&K and beyond the valley, be it on social media, or via calls, we feel that we have been successful thus far in creating our impact and influence on the business community and aspiring youth. Since angel investment is new to the Valley, a major challenge is to build trust around it by showcasing success stories in due course of time. This will go a long way in fostering the entrepreneurship culture and help in creating jobs thereby adding vital value to the economy of scale. We see ourselves in the next five years as being recognised as pioneers of angel investing in Jammu & Kashmir.

Dare to dream' and let the things around you conspire to turn your dream into reality. Dreamers are those who can plan to act. Men Found Charred In Car: Rajasthan Police Detains Half A Dozen People, Searching For Bajrang Dal Leader

Jaipur/Gurugram: The Rajasthan Police has detained half a dozen people and is searching for a Bajrang Dal leader and his associates in connection with the death of two Muslim men from the state whose charred bodies were found in a car in Haryana

Rajasthan Chief Minister Ashok Gehlot condemned the incident and said police have been directed to take strict action in the matter.

Nasir (25) and Junaid alias Juna (35), both residents of Ghatmeeka village in Bharatpur district of Rajasthan, were allegedly abducted on Wednesday and their bodies were found inside a burnt car in Loharu in Bhiwani on Thursday morning.

The families of the deceased alleged in their police complaint that the people who abducted the two men were from the Bajrang Dal.

"Half a dozen people have been detained and are being interrogated. Those named in the FIR are associated with the Bajrang Dal but whether they were involved in the crime or not is yet to be ascertained," Inspector General of Police, Bharatpur range, Gaurav Srivastava told PTI.

Junaid had a criminal record of cattle smuggling. Five cases were registered against him at different police stations, the officer said.

One of the key accused in the case is Mohit Yadav alias Monu Manesar, the Gurugram district president of Bajrang Dal and a member of a self-proclaimed cow protection team. He was earlier named in an attempt to murder case registered at Pataudi police station in Gurugram on February 7.

The police forces of Rajasthan and Haryana are trying to nab him. "Our crime unit and police station teams are searching for accused Monu. We hope he will be arrested soon," said Manbir Singh, Deputy Commissioner of Police of Manesar.

While on the run, Manu Manesar released a video message claiming his innocence in the latest case.

"My colleagues and I have no role but Rajasthan Police registered a case against me and my group members. I don't even know the deceased " he said

"At that time of the incident, I was in a hotel in Gurugram with my team members. I also share the CCTV footage of the hotel which showed our presence in the hotel. We were booked by the Bharatpur police wrongly and it is only a conspiracy to

defame my team and my organisation," he added.

Superintendent of Police of Bharatpur Shyam Singh said an FIR has been registered at Gopalgarh police station against five people -- Anil, Srikant, Rink Saini, Lokesh Singhla and Monu -- on the basis of a complaint lodged by the victims' family members and teams have been formed to nab the accused.

The accused have been booked under sections 143 (unlawful assembly), 365 (kidnapping), 367 (grievously hurt after kidnapping) and 368 (wrongfully keeping in confinement) of the Indian Penal Code (IPC), he said.

Asked about the involvement of cow vigilantes in the incident, the SP said it is a matter of investigation.

The Vishva Hindu Parishad (VHP) on Friday demanded a CBI probe into the matter and alleged that the Bajrang Dal's name was being dragged into the case due to "political bias".

Bajrang Dal is the youth

Bajrang Dal is the youth wing of the VHP.

Reacting to the allegation, VHP joint general secretary Surendra Jain said, "It seems that without preliminary investigation, the Rajasthan Police have assumed that the names taken by the smuggler's brother are responsible for the incident."

The VHP leader termed the incident "extremely unfortunate" and demanded that a CBI probe be ordered into the case, saying "the society in the state doesn't expect justice from the Rajasthan government which suffers from political bias." The Congress is in power in Rajasthan.

VHP leaders in Gurugram held a press conference and strongly condemned the registration of the case against the Bajrang Dal members.

Taking to Twitter, Gehlot condemned the killing.

"The killing of two residents of Bharatpur's Ghatmeeka's village in Haryana is condemnable. Rajasthan and Haryana police are coordinating with each other for the probe... Rajasthan Police has been directed to take strict action," the chief minister said.

Education Minister Zahida Khan reached Ghatmeeka village to take stock of the situation.

On the victims' families alleging the Bajrang Dal's role in the killings, the Rajasthan BJP said it is not justified to malign an organisation before the investigation is completed.

"Whether the accused have links with the Bajrang Dal or are cow vigilantes, it is a matter of investigation. It is not justified to malign any organisation. It will be better if the police take action against those who are guilty," state BJP spokesperson Ramlal Sharma told reporters.

Museum On Partition Coming Up Soon At Iconic Dara Shikoh Library In Delhi

New Delhi: Work is underway to covert the Mughal-era Dara Shikoh Library building in Delhi into a museum themed on the Partition, which will tell the story of the 1947 tragedy through interactive media.

Delhi Deputy Chief Minister Manish Sisodia visited the museum site on Friday and inspected the progress of the project.

His office said in a statement that building of the historic library, built in 1637, is being converted into a 1947 Partition Museum by the Delhi government under the leadership of Chief Minister Arvind Kejriwal.

"The second such museum in India, it will have seven galleries to explain the events leading up to the Partition, and Independence, migration, refugees, rebuilding homes, art, relationships and will also have a gallery of hope and courage," it said.

The museum will also feature a "virtual reality experience", donated belongings of people who witnessed the Partition, and a souvenir shop. The library will also serve as a cultural hub with exhibitions on different aspects of the city and its history. The museum is due to be opened soon, the statement said.

During his visit, Sisodia interacted with curators who provided him with a rundown of the work that had been completed on the project.

Sisodia said historical buildings located across Delhi symbolise the country's evolution over a period of time, adding the city government has "prioritised restoration" of these landmarks to help current generations understand the country better.

There could not have been a better place than the Dara Shikoh Library building to house the Partition museum, he said.

The Delhi deputy chief minister said that the museum would endeavour to depict the memories of the 1947 Partition as experienced by people.

The period transformed Delhi significantly and major parts of the national capital, including areas like Lajpat Nagar, CR Park and Punjabi Bagh, were established after the Partition, he added.

The museum's opening will also coincide with the 76th anniversary of India's independence, he said.

The museum would feature seven customised galleries designed to explain all aspects of India's Partition and the struggle for Independence to visitors. Witnessing the same rail coaches, ancient havelis, and replicas of refugee camps would be exciting and nostalgic for many, the statement said.

atement said. Sisodia further said that to



provide better experience to visitors, many people who witnessed the Partition, donated items such as clothes, utensils, books as well as belongings from refugee camps to the museum.

It will also have a special gallery dedicated to Sindh, the statement said.

Sisodia said the museum would also include a 'Gallery of Hope and Courage' which would display photographs, mementos, and experiences of people revisiting their ancient properties and places in Pakistan, decades after the Partition.

He also said in addition to the museum, the Dara Shikoh Library building would be converted into a hub for curated cultural experiences. It will display narratives and exhibitions on different aspects of the city and the individuals associated with it. Along with the museum, the building would have a cafeteria, souvenir shop, small library and a reading area, he added.

The Dara Shikoh Library building was originally built in 1637 by Dara Shikoh, the eldest son of Mughal emperor Shah Jahan. After the death of Shikoh, this mansion was handed over to Bahadur Shah I, heir apparent of Aurangzeb, the statement said.

"Sometime after his ascension, the property was handed over to Juliana Dias da Costa, a lady of Portuguese descent who played a prominent role in his court. Abul Mansur Mirza Muhammad Muqim Ali Khan (Safdarjung) bought the property very cheaply from the descendants of Juliana Dias da Costa and made it his residence," it added.

Under the British rule, it served as a British Residency for David Ochterlony, Archibald Seton and Charles Metcalf. In the 20th century, the property was also used as a school, a polytechnic and lastly as the offices of the Delhi State Archaeology Department, it said.

Thereafter, the Arts And Cultural Heritage Trust (TAACHT) was entrusted the building under the 'Adopt A Heritage' scheme by the department of art, culture and language, to set up the Partition museum, the statement said.

4 Hizbul Operatives Convicted In PMLA Case

NEW DELHI: A Delhi court on Friday convicted four operatives of the banned terrorist organisation Hizbul Mujahideen on money laundering charges in a case linked to terror funding in Jammu and Kashmir, the Enforcement Directorate (ED) said.

It said the court of Additional Sessions Judge-3 (Patiala House court) will announce the punishment on February 27.

The four terrorists convicted under the criminal sections of the Prevention of Money Laundering Act (PMLA) are Mohammad Shafi Shah, Talib Lali, Muzaffar Ahmad Dar, and Mushtaq Ahmad Lone.

They had pleaded guilty before the trial court for the offence of money laundering.

The case stems from an FIR filed by the National Investiga-

tion Agency (NIA) under various sections of the Unlawful Activities Prevention Act (UAPA), the ED said in a statement.

"Hizbul Mujahideen (HM), one of the most active terrorist organisations in Jammu and Kashmir, has been regularly receiving funds ... for carrying out terrorist activities.

"Investigation established that in the garb of Jammu Kashmir Affectees Relief Trust (JKART), Hizbul Mujahideen was actively involved in funding terrorist activities," the ED said.

ED had filed a chargesheet in this case against a total of 12 terrorists in April

2020. Out of them, eight have been declared 'proclaimed offenders' by the court, it said.

The federal agency has also attached assets worth Rs 1.22 crore as part of this investigation.

Saudi Bars Children Below 12 Years For Haj-2023

SRINAGAR: Saudi Government has decided to disallow the children below 12 years of age in a bid to ensure their safety, Haj Committee of India (HCoI), informed Friday.

A circular issued by the HCoI, reads that it is intimated that the authorities in the Kingdom of Saudi Arabia have decided that children below the age of 12 years are not allowed to proceed for Haj 1444(H)-2023 consider the fact that it is not dren under the age of 12 years to ensure their safety.

"In view of the position explained above, no application of children below the age of 12 years as on 30-04-2023 including infants will be entertained for Haj 1444 2023. Therefore, all Haj applications of the children below 12 years including infants registered till date will

be rejected for Haj 1444-2023," the circular reads.

The circular further reads that it is expected that the authorities in the Kingdom of Saudi Arabia might stipulate further health and administrative guidelines in view of the prevailing conditions. The same shall be notified accordingly in the due course of time.

HCoI member Er Aijaz Hussain said that the decision to disallow children below 12 years of age is aimed at ensuring their safety and the move is part of Haj policv 2023. He said that new health and administrative guidelines will be issued shortly.

Activist Alleges 'Timber Smuggling' In Prem Nagar Road Widening Project

SRINAGAR: An RTI activist from Doda has alleged corruption in the road alignment/ widening project from Khelani Pariyot to Prem Nagar with a design length 20.251 Km.

Adil Farooq, an RTI activist from Doda has submitted a complaint to LG's office earlier also.

In the complaint, a copy of which lies with Kashmir Observer, Adil alleges that in order to widen the road from Khelani Priyot to Prem Nagar, trees had to be cut down in Bhadarwah Forest Division.

Official sources revealed that the construction & upgradation of Road with Paved Shoulder of Road from Design Chainage 31 (Khelani Pariyot) to 51(Prem Nagar) (Design Length 20.251 Km) was e-Tendered by PWD (R&B) B.C Road Division Bhadarwah Falling in Compartments 30/Ch, 32/Ch & 33/Ch in Chirala Range of Bhaderwah Forest Division.

Adil alleges that the due process was not followed and cutting of trees was done by the Forest Department which is in

"The forest department did the marking of the road. According, technical sanction and administrative approval was issued for the work that had to be done. After the administrative approval was granted, FDC had to do a handover. However, that did not take place." Adil said.

"Instead of the State Forest Corporation (SFC), the trees were cut by the Forest Department." Adil also said that the Enu-

meration and Marking of Trees,

Poles & Saplings in all the compartments was conducted by Bhadarwah Forest Division of the Forest Department.

"The total No. Trees marked Comptt. 30/Ch were 45=997.50cft, Comptt. in 32/Ch were 153=4607cft, and in Comptt. 33/Ch were 269=4015cft totalling to 467= 9619.50cft and all the marked trees were Chir Species in different Dia-class/Girth." The complaint filed in the LG office reads.

"The Proper Marking of Trees was conducted and Lists of the same were submitted by the DFO Bhadarwah to the Chief Conservator of Forest Doda and then the same were countersigned and submitted to the Chief Conservator of Forest Working Plan Jammu. That a Formal Administrative Approval/ In Principle was issued/accorded by the higher authorities."

The complainant also alleges that after receiving the orders from Higher authorities, a formal letter was issued to the Divisional Manager FDC by the DFO Bhadarwah under his office No: DFO/BHAD/FCA/1227-28 on 24/05/2022 to put the said Road Marking in F-Tendering process of FDC to get the Trees extracted

through proper channel. "After receiving the letter from DFO Bhadarwah, The Divisional Manager FDC directed Range Officer Chiralla to initiate The Handing over the Process. The Range officer Chiralla reported that all the extraction has already been done illegally, all the 467trees =9619.15cft have been removed & converted."

Official sources have also revealed that as of now, there is no Green Standing Tree available, the road has already been upgraded without handing over these compartments to FDC. If not FDC who has ex-

tracted these markings. According to law, the FDC being the only legal agency for extraction of markings that too huge markings of approx. 10,000 CFT.

However, authorities have dismissed the RTI activist's accusations saying the complainant has vested interest and has procured official documents which in itself is 'illegal'.

Speaking to Kashmir Observer, Conservator Forests, Jitender Singh denied the allegations saying said the complainant/ activist has a vested interest in the case.

"There have been certain violations wherein some trees had been damaged and the debris had been relocated, in that case, they have been penalized" Jitender said.

As far as the cutting of trees is concerned, their number is

less than what is being said. "Whenever list for a project is made, it involves an exaggerated figure, however, on ground not more than 200 trees were cut down. It involves large number of trees with no timber val-

ue, they are not counted as well" "The complainant has procured the list of the marked trees from somewhere and he is getting deceived by that" Jitender added.

The RTI activist urged the LG administration to order an investigation by an independent agency in the project so that facts could be brought forth.

Territory. The step is aimed at incorporating technology, particularly artificial intelligence (AI) and Internet of Things (IoT), into agriculture to address challenges such as low efficiency, profitability and competitiveness.

"The proposal for sensor-based smart agriculture can be a transformative innovation for Jammu and Kashmir's agri-economy. A sensor-based pilot study will be conducted

Dulloo said that the incorporation of technology, particularly AI and IoT, into agriculture has the potential to address challenges such as low efficiency, profitability, and competitiveness. "This could lead to a more attractive and professional image for the industry", he said.

Having a total outlay of Rs 30.40 crore the project on sensor-based smart agriculture aims to integrate agriculture with technology, he said.

"The use of AI-based detection of pests and diseases using handheld sensor devices can significantly reduce the drudgery and cost

cent," Dulloo said.

The official said that the proposal also aims to develop algorithms for big data analytics for remote operations of IoTs and create a startup ecosystem in smart agriculture by networking with IITs and industries. Certificate and diploma

courses in AI &ML, IoT, and automation, and Blockchain technology will be launched to train skilled manpower for the new skillsets required in the industry, he said. "The outcome of the proposal will be 50-80

per cent increase in resource use efficiency, the development of a sensorbased grading and sorting system of apple, and the development of a decision support system (DSS) for pest and disease management", Dulloo said.

The official said that the real-time detection and variable rate spray using robotics and drones will reduce the production cost by 80 per cent. The proposal also aims to build a sensor corridor for livestock and phenotyping and yield prediction, he said. He further said that the trained manpower, consisting of graduates, certificate and diploma holders in IOT, AI fields will form a new startup culture in the sensor-based agriculture

system. Similarly, livestock rearing is currently done in poor environmental shelter, so there is a need for a sensor-based monitoring system for shed environment and an automanagement system for tagging of animals for identification, the official

"Thermal and pedo-sensors based heat detection and IoT-based sensors can be used for phenotyping and health management and yield prediction of livestock. Digital transformation in agriculture is one of the potential areas to mitigate the challenge of increasing output by 60% by 2040 to match the ever-growing population", Dulloo said.

"Yes, Chetan has tendered his resignation to BCCI secretary Jay Shah and his resignation has been accepted. His position had become untenable after the sting operation. He resigned voluntarily and

wasn't asked to resign," a senior BCCI source told PTI on condition of anonymity

Chetan Sharma was in Kolkata along with other



selection committee members for the Ranji Trophy final between Bengal and Saurashtra. They were there to select the Irani Cup team.

It is learnt that Chetan's comments did not go down well with the BCCI top brass, and the current national squad members also lost their trust in him.

"Coach Rahul Dravid, captains Rohit Sharma and Hardik Pandya have completely lost faith in him. He couldn't have possibly sat across the

table along with them for selection committee meetings as he had lost all respect. He paid the price for being a big mouth," said another BCCI source.

Mr. Sharma was seen allegedly revealing his internal discussions with head coach Rahul Dravid and Virat Kohli, along with casting serious allegations against some senior players in the team. He alleged that there was an ego tussle between former captain Virat Kohli and the former BCCI

president Souray Ganguly.
