# **Centre Moots Army Pullout From Kashmir Hinterlands: Report**

CRPF To Tackle Twin Challenges Of Law & Order Maintenance, Counter-Terror Ops Following Phased Withdrawal Of Army From Hinterland

Srinagar: The government of India is planning phased withdrawal of army from Kashmir Valley except from the Line of Control (LoC), to let the paramilitary Central Reserve Police Force (CRPF) to tackle the twin challenges of counter-terror operations and law and order maintenance, a media report from New Delhi said.

Ouoting officials in the security establishment, The Indian Express reported on Monday that the proposal to withdraw the Army from Kashmir hinterland has been under discussion for about two years and is at an "advanced stage" now with the involvement of the

Union Ministry of Defence, Union Ministry of Home Affairs, armed forces and the J&K police. According to the report, it has been proposed that the CRPF would fill in for the army personnel removed from the Valley to meet the challenges of both law and order and counter-terror operations. Jammu: Three more residential houses and a 33-kV power transmission line were damaged due to "sinking" of land in the hilly Duksar Dalwa village in Jammu and Kashmir's Ramban district, officials said on Monday.

#### 3.4-Magnitude **Earthquake Hits Katra**



RINAGAR -Refusal to 'bribe' a police department sleuth has cost an intending Hajj pilgrim the final green sig¬nal to proceed to the holv land. Even after travel documents. including pilgrim pass, had been issued to the pilgrim, au¬thorities have dashed his hopes of performing the Hajj and asked him to stav put at his Kupwara home.

According to a NAFA report, Habibullah Kashi s/o Budullah r/o Anwarabaad, Salkot (Kupwara district) had been se¬lected for this year's Hajj vide serial No 4478. He was scheduled to fly to Jeddah tomorrow. His flight has to take off from here at 10.30 a.m. He has already re¬ceived his pilgrim pass and other travel documents.

Surprisingly, the authorities have stopped his departure for the holv pilgrimage at the last minute. He has been asked not to leave his home. The di¬visional commissioner who is also the convener of the state Han committee is understood to have informed him that he would not be allowed to be proceed before CID clearance. His frantic efforts to reach the in¬spector general of police. CID failed as the letter's office avoided him.

Family sources told NAFA an official from the CID had ap¬proached Habibullah in connection with verification and allegedly demanded Rs 500. He expressed his inability to bribe the official as he was proceeding for a holy pilgrimage. The official might have forwarded an adverse report, they suspected.

# **Opposition Unity**

ith little over a year left until general elections, the much anticipated opposition unity still remains a mirage. However, the recent weeks have witnessed some fresh stirrings to this end with Bihar Chief Minister Nitish Kumar urging Congress to take a lead in uniting the opposition for 2024 national polls. He said if all opposition parties were to unite, the BJP would get less than 100 seats in the election. Congress, in its response, has asserted its importance and indispensability to an opposition alliance. Congress general secretary Jairam Ramesh has said that no alliance in the opposition can be successful without their inclusion. The party's plenary will discuss the necessary alliances for the upcoming state assembly polls as well as the 2024 election.

But an opposition alliance is far from materializing. True, the opposition looks to have found its bearings but it has to go a long way before it gets counted as a competitor to the BJP. One good thing is that Congress president Rahul Gandhi has shown some promise to rise up to the political challenge, even though his image makeover is still a project in works. As his recently concluded padyatra underlined, his speeches now carry more conviction. He has paid attention to his communication style: he now frames his arguments in a way that generate a bigger ideological contestation with the BJP- albeit, he still has a long way to go to match the prime minister Narendra Modi's overarching ideological challenge. It is true that the yatra has generated immense goodwill for Congress and Gandhi but the political ground is still far from shifting. Prime Minister Narendra Modi continues to be the unstoppable and all-powerful leader, and no other national leader, let alone Gandhi, comes close.

Also, Congress in its current shrunken state seems no match for the BJP. And that too at a time when Congress faces tough competition even from the AAP which is trying to fill in the political space vacated by the former. With its landslide victory in Punjab last year, the AAP shows promise. It hopes to replicate the performance in other states. Arvind Kejriwal has exhibited political smarts to get his party up and running out of nowhere.

But there is still one year to go before the general elections are held, and much can change during this period. One year is a long time in politics. As things stand, only a combined opposition could be expected to take on the BJP. Gandhi has also been trying to forge opposition unity but there are only feeble indications that he has had any success in the endeavour. It won't be easy to bring all the opposition parties together on one platform, more so, with several regional leaders nursing their personal ambitions. But for now Congress can take heart from Gandhi's successful yatra and hope to build on it. And hope that some sort a loose political alliance comes along in the near future.

# **Relentless And Unwinnable**

s the war in Ukraine reaches its one year mark on February 24, there is no indication that its endgame is anywhere near. US President Joe Biden is due to speak in Warsaw, a telling location for the anniversary event, and is likely to send a message to his Russian counterpart Vladimir Putin. The same day Putin is set to give his own speech in Moscow.

A year ago, the world watched in horror as Russian tanks rolled into Ukraine and headed towards the capital Kyiv. Moscow expected a rapid conquest, and installation of a pro-Russian regime. It didn't happen. Ukraine, armed to the teeth with NATO weapons, has succeeded in stalling the Russian advance, though there is no evidence that Moscow has lost the upper hand in the campaign. Russia has maintained the tempo of its military campaign, having controlled a vast swath of land towards east of Ukraine including Donbass and Crimea, captured earlier. In recent months. Ukraine has also been able to reverse some of Kremlin's military gains. Ukraine has reportedly liberated around 54 percent of the territory Russia seized since 24 February 2022. But this hardly means that Russia is losing the war. The war has been grinding on over the last year. The mighty Russian army has struggled to score victories and seems still a long way off from capturing Kyiv and with every passing month, such a prospect looks less likely. Russian military campaign has not been a shock and awe type of blitzkrieg unleashed by the US in Iraq and also in Afghanistan leading to the collapse of those countries' governments within the first month itself. The war's bigger challenge for the existing world order is still very much intact. Russia has thrown down the gauntlet at the west. And this is not the first time Russia has done it. A few years ago, Russia's interven-

tion in Crimea had brought back memories of the geo-politics of the cold war. Russia's increasing defiance of the West and China's inexorable rise have confronted the US and the EU with a new existential crisis. It is also altering global geopolitics and awakening the rest of the world to the reality of a declining US power. This is clear from how the nations and regional groupings have been balancing their relations with the US and China-Russia axis.

Over the last year, Gulf Arab states have strengthened their ties with China and Russia. In doing so, Arabs have defied US pressure to choose sides. The relationship between the US and Saudi Arabia has soured after OPEC+ chose to decrease output despite the US urging an increase to offset current inflation. Arab defiance of the US is yet another stark example of how geopolitics is shaping up following the Russian invasion of Ukraine. Even though the US-led western coalition against Russia is holding up well, the rest of the world is increasingly asserting its autonomy in its response to the war. India too has refused to choose sides. The country has found itself in a tough situation trying to straddle its alliance with the US and its longstanding relationship with Russia. And so far it has been successful in pursuing a tight balancing act. While New Delhi has gone along with the West as far as the illegitimacy of the war, it has refused to abandon Russia. The West has found it difficult to countenance this assertion on the part of India but has played along as New Delhi

loathe to do so for reasons that this could jeopardize its global military dominance. This makes the situation very complicated and not amenable to an early solution. More so, with both sides caught in a dead-end. Neither is willing to blink as the geopolitical stakes are too high. The war is rooted in Russia's legitimate fears of being encircled by the west and the NATO military bases reaching its doorstep. Many of the Eastern European countries that were once members of the USSR-led Warsaw Pact have become a part of NATO, heightening Russia's insecurity. And when Biden would deliver his speech in Warsaw on the war's anniversary, he would only deepen Russia's sense of siege. Poland, whose capital Warsaw is, was also once a member of Warsaw pact against the West. The country is now a key US ally and fulcrum of vast efforts to arm Ukraine. As of now, the war is about the defeat of the other side, not about a resolution through accommodation of each other's concerns and fears. So, it is likely to go on.

# Going off-course

rom reducing penury through providing off-season employment, and thereby improving household consumption among the invariably poor citizens who avail the scheme, to acting as insurance during monsoon deficient seasons, besides allowing for greater food security through increased productivity helped by the works generated, the scheme continues to be a robust welfare tool. This was even clearer during the pandemic, when thousands of migrant workers who left urban areas due to the lockdowns took up work under the MGNREGS in rural areas where demand for the menial but arduous work peaked. There is of course the case that the scheme has still not transcended into creating more useful assets beyond roads and irrigation canals and requires broadbasing and better implementation. But it must be said that the Union government's treatment of the scheme has graduated from a case of lukewarm acceptance of its need because of its popular impact to treating it as a fiscal burden.

Such a reading can be justifiably made if the reduced allocation for the scheme in the Union Budget, from 2.14% of overall outlay in FY23 to 1.33% in FY24, is considered. This was despite implementation in recent years experiencing wage delays and underfunding. This has also depressed demand, with formal requests for work only being a portion of the actual demand. Also, there is much evidence that Aadhaar-based payments have neither reduced corruption nor reduced wage payment delays while creating hurdles for officials and workers during implementation. Union Rural Development Minister Giriraj Singh has now said that the Act should be amended to change the contribution of funds from 100% by the government to a 60-40 split between the Centre and the States in order to make States "more vigilant regarding corruption". But this will only lead to further complications in funding. There has been a shrinking in the States' share of taxes following GST and the financial stresses during the pandemic. States taking up 40% of the funding burden would affect the payment of wages even further. Besides, MGNREGS is a demand-driven programme and salient especially in poorer States and it is incumbent upon the Centre to ensure its robust funding instead of putting the onus on individual States to do so. The government must change its approach towards the MGNREGS by recognising its potential in catering to the poor's right to work.

# International Mother Language Day **Introduce Kashmiri in Central Govt Schools Across Kashmir**

he Multilingual Education system is being propagated at international level as experts say that speaking more than one language keeps the brain healthy. Children who speak multiple languages, especially their mother language, give them better access to multiple cultures along with their own. Multilingualism has been proven to help a child develop superior reading and writing skills. The children with multilingual skills have overall better analytical, social, and academic skills than the children having unilingual skills. Even the international organisations like the UN have authenticated the fact that a multilingual education system with special focus on mother tongue is the best way of educating our children.

#### Mother tongue based multilingual education

The United Nations Educational Scientific & Cultural Organisation -UNESCO has been advocating for the mainstreaming of multilingual education based on mother-tongue. This helps better access to education for population groups that speak non-dominant languages, languages of minority groups like people of Kashmir when compared with the rest of India. Even the trust is given on indigenous languages as well which need to be promoted and propagated by including them in school curriculum. Multilingual education enhances the quality of education by underlining the importance of cultural and linguistic diversity as explained above. Multilingual education increases dialogue and interaction among learners and teachers. It facilitates participation and action towards sustainable development by giving access to new knowledge and new cultural expressions, thus ensuring global as well as local interaction on traditional and indigenous issues.

#### Inter Connected themes IMLD

The theme around this year's International Mother Language Day (IMLD) 2023 which is focussed on Multilingual Educational system explores the potential of multilingualism to transform education from a lifelong learning perspective and in different contexts. This theme is shaped around three interconnected themes:

• Enhancing multilingual education as a necessity to transform education in multilingual contexts from early childhood education and well beyond;

· Supporting learning through multilingual education and multilingualism in ir fast-changing global contexts and in

• Protecting and promoting the languages that are on the verge of extinction in different parts of the world and there is a possibility that these languages might disappear in the years to come. The main aim of celebrating the International Mother Language Day is to contribute to achieving Goal number 4 of Sustainable Development Goals (SDGs). Infact education is the heart of the 2030 Agenda for Sustainable Development. It is identified as a stand-alone goal and is also present as targets under other SDGs on health, growth and employment, sustainable consumption and production, and climate change. The SDG 4 focuses on:

- Ensuring lifelong learning opportunities for all, from early childhood to adult education:
- Ensuring equity, inclusion and gender equality;
- Ensuring effective learning and the acquisition of relevant knowledge, skills and competencies;
- Ensuring the relevance of lea

ing, in terms of vocational and technical skills for decent work as well as for global citizenship in a plural and interconnected world.

#### J&K Official Languages Act 2020

Keeping Multilingual educational needs into consideration the Govt of India declared Urdu, Kashmiri, Dogri, Hindi and English as the official languages of Jammu & Kashmir. The Jammu and Kashmir Official Languages Bill, 2020 was introduced in Lok Sabha on September 22, 2020. It became a law when the bill was passed by Lok Sabha and Rajya Sabha. This act received the assent of the President of India on September 26th 2022. This law was enacted to declare certain languages as official languages of the Union Territory of Jammu & Kashmir which include Kashmiri, Dogri, Urdu, Hindi and English. It was declared that English be used as the official language for the official purposes of the union territory of Jammu & Kashmir and the business in the Legislative Assembly of the union territory will be transacted in these of-

ficial languages. The law clarifies that English may continue to be used in the union territory for those administrative and legislative purposes for which it was being used before the commencement of the Act.

#### Kashmiri not introduced in Central schools

Even as Kashmiri or Urdu happen to be the official languages of Jammu & Kashmir, the same are not taught in the central Govt schools operating in Kashmir and Kashmiri speaking areas of Jammu. There are nine Kendriya Vidyalaya schools in Kashmir valley but not even a single school has formulated a plan to introduce Kashmiri in their school curriculum. Same is the case with seven Jawahar Navodaya Vidyalayas operating in Kashmir valley. Even some private schools having CBSE curriculum like DPS Baramulla & DPS Anantnag have also failed to introduce Kashmiri in their school. But I appreciate DPS Srinagar and Budgam for their role in promotion of Kashmiri and Kashmiri culture in their schools. In many states

the Kendriya Vidyalaya have introduced local regional languages in their school curriculum but no steps are taken for this in J&K whether it is Dogri or Kashmiri. Few years back the Kendriya Vidyalaya Sangathan (KVS) had agreed to keep Assamese language as a regular subject to be taught within the school hours for about 2 or 3 periods per week. The move came after a meeting of top CBSE officials and Assam Sahitva Sabha. Pertinently CBSE in a circular issued in 2019 stressed and made it compulsory for all schools affiliated to CBSE to introduce local regional language in the curriculum on the following grounds:

If at least 15 or more students opt to study an additional language, the teaching of the additional language may be taken up by the respective schools as per requirement beyond the school hours. Teaching staff and all other facilities such as classrooms, etc for the teaching of the additional language(s) should be made available.

The Principals may be directed to

make a comprehensive assessment of the requirement of teaching of the additional language(s) and evolve appropriate modalities in consultation with stakeholders.

#### Shina included in Gurez schools

Shina is a Dardic language spoken mostly in Gilgit, some parts of Baltistan and Chitral in Pakistan. In Jammu & Kashmir this language is spoken by a minority group who live in Gurez, Drass, some parts of Kargil and Chanderkot in Ramban. Shina was only a dialect until recently and had no defined text (lippi). As the new generation of Shinas were more focussed on Urdu and English, some local people decided to create a script (lippi) for Shina so that the Shina would not vanish from Gurez and other areas. A local NGO Dard Shin Development Organisation played a great rold in introducing Shina language in schools. Its former General Secretary Mohammad Ramzan Khan who is nomore with us now was the man behind this great mission. He did a great work along with people like Masood Samoon , Abdul Jabbar Chakkat and others to keep Shina alive. This language is now taught in Govt schools of Gurez as the JK Board of School education created text books for the school students as well. Shina was on the verge of getting extinct, but with the efforts of some local people, this language got a new life.

#### Conclusion

The Mother's tongue is vital in framing the thinking and emotions of people. Learning to speak in the mother tongue is very necessary for a child's overall development. Being fluent in the mother tongue, benefits the child in numerous ways. It associates him with his culture, ensures holistic development, and supports the learning of other languages. The UN has chosen "Multilingual Education – a necessity to trans*form Education*" as theme of this years International Mother Language Day which is celebrated across the world on Feb 21st every year. Multilingual education contributes to the development of inclusive societies. This allows better understanding of multiple cultures, worldviews and knowledge systems which help for better coexistence & conjunction. The central Govt schools like KVs, JNVs operating in J&K along with other CBSE schools who are yet to introduce Kashmiri or even Urdu in their school curriculum must start working on it soon.

# Luminaries of Language

On the occasion of the International Mother Language Day, the writer is recalling the legend of some splendid wordsmiths who've kept the spirit of language alive.

#### **Rakshanda** Afrin

mong the galaxy of kosher writers, Dinanath Nadim is considered as a literary icon. Kashmiri literature is incomplete without his mention. Nadim has penned down several operas and poems in his native language. His anthology-"Shihul Kul"—won him the Sahitya Academy Award in 1980s.

Nadim's partner-in-pen and the champion of his mother language, Akhtar Mohiuddin, is second to none. The author penned over fifty short stories in Kashmiri and is acknowledged for writing his characters and plots with universal image and appeal. He gave new dimensions and perspectives to Kashmiri literature. His Daud Dag (Disease and Pain) is considered to be the first novel written and published in Kashmiri. Akhtar's writings were mainly about reflections of human nature and provided his readers with thought provoking plots on themes of disparity between poor and the rich.

Considered as Kashmir's 'Master of Ghazal', Mohammad Amin Kamil's poems found a major voice in Kashmir's literary history. The influence of the progressive writers' movement had made him shift his writings from Urdu to Kashmiri primarily. Kamil is considered as a fearless literary icon from the valley who had written in almost every form of diverse literary works such as Nazm, Ghazal, opera, short story, poems. He is considered as one of the most multifaceted literary luminaries from the region.

The sole Kashmiri to be bestowed with Jnanpith, the highest literary award of India, Rahi began his career as a government clerk and, getting closely associated with the progressive writers' movement, he's now considered arguably the greatest Kashmiri poet. In his poems, Rahi mostly talks about the day to day problems in a commoner's life and predicament a common Kashmiri undergoes.

Renowned poet and critic, Mohammed Shafi Shauq is from modern day Kashmir, who definitely has been credited with redefining the origin of Kashmiri language. As a literary heavyweight, Shauq believes that Kashmiri is a different languagethan any South Asian language-deriving its origin from the Greek-Latin languages rather than Sanskirt or any Asian language as commonly believed. A former University of Kashmir professor, Shauq has compiled and written Kaesher Lugaat, a complete dictionary of Kashmiri language which is considered as the most accomplished work in Kashmir language.

under serious discussion at inter-ministerial level and it is understood to be feasible. In a way, the decision has been taken and it is a matter of when it will be done. Ultimately, however, it will be a political call," a senior security establishment officer told The Indian Express.

Quoting officials, the report said that the Army maintains a strength of around 1.3 lakh personnel in the entire J&K of which around 80,000 are deployed on the border. About 40,000-45,000 personnel from the Rashtriya Rifles have the mantle of conducting counterterror operations in Kashmir's hinterland.

"The CRPF is said to have a strength of close to 60,000 personnel in J&K, of which more than 45,000 are deployed in Kashmir Valley. J&K Police is 83,000 strong. Apart from this, a few companies from other Central Armed Police Forces (CAPF) remain deployed in the Valley. The figures for CAPFs fluctuate depending on the security situation in the Valley," the report said.

Quoting an unnamed Union home ministry official, the report said that the idea behind the deliberations was to not just claim normalcy in Kashmir but also make it visible.

"The government claims that terrorist violence incidents and killing of security personnel in J&K have reduced by almost 50 per cent since August 5, 2019, compared with the same period before it. "Since the August 5, 2019 decisions, violence in the Valley has steadily reduced. Stone pelting has almost vanished and the law-andorder situation is largely under control. However, a large presence of the Indian Army in the hinterland would sit oddly with claims of normalcy,' the official added. Sources in the security establishment told The Indian Express that in the discussions it was proposed that the Army be withdrawn in a phased manner. "May be the Army can be withdrawn first from a couple of districts such as Anantnag and Kulgam. Following this, the situation on the counter-terror front and the response of the people would be assessed. Depending upon the results, further steps towards more withdrawals would be taken. That's how it was done when the Border Security Force (BSF) was withdrawn from hinterland Kashmir in the mid-2000s," another official said.



# Tendering Process Of Vaishno Devi Ropeway In Last Phase: LG

#### **Observer News Service**

JAMMU: Jammu and Kashmir Lt Governor Manoj Sinha on Monday said the tender process for a ropeway for the Mata Vaishno Devi shrine is the final phase and the project will be undertaken with "utmost sensitivity" to safeguard the interests of local businesses.

The Shri Mata Vaishno Devi Shrine Board (SMVDSB) has approved a Rs 250-crore passenger ropeway project between Tarakote Marg and Sanji Chat along the 12km track to the revered shrine atop the Trikuta hills in Reasi district.

"The tendering process of the ropeway project is in its last phase and the work on the project will be undertaken with utmost sensitivity to ensure that local business is not impacted," Sinha, who is the board's chairman, told reporters after offering prayers at the shrine.

The Lt Governor, who also inaugurated the Tripti Bhojanalaya and the Prasad Kendra at the temple complex's Bhawan, said the ropeway project was approved to facilitate pilgrims, especially the



elderly and the differently-abled, to offer prayers at the shrine with much more ease.

The addition of the two facilities at the Durga Bhawan are part of the continuous efforts to provide a comfortable and satisfying experience to pilgrims visiting the shrine from across the country and abroad, he said.

"Over 3,000 pilgrims can be accommodated at the Durga Bhawan a day, and 750 visitors can have their food at the Bhojanalaya at one time," Sinha said. Officials said the 2.4-km-long ropeway project will be completed in three years. Using this facility, pilgrims can reach the temple complex in just six minutes compared

to the five to six hour trek, they said. Last year, 91.25 lakh pilgrims visited the shrine, the highest in nearly a decade.

Only 17 lakh pilgrims visited the shrine in 2020 when it was for the first time in its history closed for

five months due Covid. It reopened on August 16, 2020.

From 13.95 lakh pilgrims in 1986, when the SMVDSB took over the affairs of the shrine for better management, there has been a steady increase in footfall with each passing year, touching an all-time high of 1.04 crore in 2012 against 1.01 crore the previous year.

The arrival of pilgrims at the shrine touched 31.15 lakh in 1991 and reached 74.17 lakh in 2007. However, the number dropped to 67.92 lakh in 2008 which was attributed to the two-month long Amarnath land row agitation but again went up to 82 lakh in 2009 and 87.2 lakh the next year.

It dropped from 93.24 lakh in 2013 to 78.03 lakh in 2014 and further to 77.76 lakh in 2015 and 77.23 lakh in 2016.

The arrival of pilgrims increased to 81.78 lakhs in 2017 and 85.87 lakhs in 2018 but again dropped to 79.40 lakh in 2019 the year when the central government revoked special status of the erstwhile state of Jammu and Kashmir.
