## **Govt To Impose Property Tax In J&K From April 1**

## Property Tax Capped At 5% For Residential, 6% For Non-Residential

Srinagar: In a move that will have far reaching consequences, the Union Territory administration on Tuesday announced imposition of property tax in Jammu and Kashmir from April 1, this year. An official order issued today read

that in exercise of the powers conferred by Section 71A of the Jammu and Kashmir Municipal Act, 2000, the government has framed rules for levy, assessment and collection of property tax in the Municipalities and Municipal Councils of Jammu and Kashmir.

These rules have been called Jammu and Kashmir Property Tax (Other Municipalities) Rules, 2023. The Property Tax on Residential Property will be 5% of Taxable Annual Value (TAV), while the Property Tax on non-Residential Property will be 6 % of Taxable Annual Value (TAV).

The order has, however, exempted all the properties owned by Central and UT Government from payment of property tax. Only



service charge at the rate 3% of the taxable annual value has to be paid to the Municipality in respect of

such properties. Similarly, all the properties of the Municipality and all places of worship, including temples, mosques, gurdwaras, churches, shrines, etc and cremation and burial grounds have been exempted from payment of property tax.

exempted vacant lands, not appurtenant to a structure/building from property tax if there's a Master Plan in force in the area, under which any construction/development on such government has also vacant land is disallowed or if they have been put to agricultural use as per 6-monthly cropping surveys of the Revenue department.

The order was issued by H. Rajesh Prasad, Principal Secretary to the Government Housing and Urban Development Department.

It will be for the first time that such a proposal will be framed where the residents have to pay property tax on residential and commercial establishments.

Pertinently, the J&K was the only state in the country which was exempted from property tax. However, post abrogation of Article 370, the central laws were extended to the newly created UT and all the laws became applicable automatically.

It may be noted that in October 2020, the Ministry of Home Affairs (MHA) empowered the J&K administration to impose property taxes through the municipal corporations, municipal councils and municipal committees in the Union Territory. However the move was strongly opposed by the regional political parties prompting the government to keep the proposal on hold. More on P6

### **NGT Forms Panel To Suggest Remedial Measures**

**New Delhi:** The National Green Tribunal has formed a panel to conduct a study and suggest remedial measures for preventing environmental damage in light of the incident of land subsidence in Doda District of Jammu and Kashmir.

The tribunal was hearing a matter where it had taken cognisance of a media report on its own about the damage and displacement caused by "slipping of the earth".

According to the report, most houses in the area were damaged resulting in displacement of the inhabitants.

A bench of Chairnerson Justice A K Goel noted that a geological survey of the area was being conducted to ascertain the reasons for the incident. It said the issue was a "matter of concern" requiring "stringent preventive and remedial measures".

The bench, also comprising Expert Members A Senthil Vel and Afroz Ahmad noted the tribunal had earlier passed an order regarding the fragile areas in the Himalayan region and places including Shimla, Kasauli, Manali, McLeod Gani in Himachal Pradesh and Aravali hills in Rajasthan.

By the order, the green panel had constituted a committee of representatives of the departments concerned and experts to suggest remedial measures.

"On the above pattern, we direct the constitution of a joint committee to be headed by Chief Secretary, Jammu and Kashmir," the tribunal said.

Other committee member would include the Central Pollution Control Board (CPCB), Wadia Institute of Himalayan Geology, Govind Ballabh Pant National Institute of Himalaya and Environment, National Institute of Hydrology (NIH), Professor More on P6

## **Ladakh Sets Guinness World Record For Highest Frozen Lake Half-Marathon**

Jammu: The Union Territory of Ladakh has created history by successfully conducting its maiden 21-km trail running event in subzero temperature at 13,862 feet high Pangong Tso, which was registered in Guinness world record as the world's highest frozen lake half marathon.

Spread across the border of India and China, the 700-square kilometer Pangong Lake records a temperature of minus 30 degrees Celsius during winter, making the salt water lake frozen with ice.

The four-hour long marathon started from Lukung and ended at Maan village on Monday with no injury reported to any of the 75 participants, Leh District



Development Commissioner Shrikant Balasaheb Suse told

Named as the 'Last Run' to remind the people about the climate change and need to save the Himalayas, the marathon was organised by the Adventure Sports Foundation of Ladakh (ASFL) in collaboration with Ladakh Autonomous Hill Development Council, Leh, Tourism Department, Ladakh and Leh district administration.

"The first Pangong frozen lake half marathon is now officially registered in the Guinness book of world records," Suse said.

He said besides spreading the message of ecological awareness among the stakeholders through sports, the marathon was also aimed at promoting sustainable winter tourism in border villages of eastern Ladakh to generate livelihood opportunities for residents especially in winters which is part of 'vibrant village programme' announced by central government.

The run was flagged off by Chief Executive Councillor, LAHDC (Leh) Tashi Gyalson. Five energy stations were set up along the route, consisting of energy drinks, medical teams and oxygen support, More on P6

## **New 3D-Printed Superalloy Could Cut Carbon Emissions In Power Plants: Study**

esearchers have shown that a new 3D-printed superalloy could help power plants generate more electricity while producing less carbon, according to a new study.

Scientists from Sandia National Laboratories, US, created a superalloy, with an unusual composition that makes it stronger and lighter than stateof-the-art materials currently used in gas turbine machinery, the study said.

A superalloy, or a high-performance metal alloy, is an alloy with the ability to operate at a high fraction of its melting point.

As the world looks for ways to cut greenhouse gas emissions, the findings could have broad impacts across the energy sector as well as the aerospace and automotive industries, and hints at a new class of similar alloys waiting to be discovered, the study said.

The team published their findings in the journal Applied Materials Today.

"We're showing that this material can access previously unobtainable combinations of high strength, low weight and high-temperature resiliency," Sandia scientist Andrew Kustas said.

"We think part of the reason we achieved this is because of the additive manufacturing approach," said Kustas.



Additive manufacturing, also called 3D printing, is known as a versatile and energy-efficient manufacturing method. A common printing technique uses a high-power laser to flash-melt a material, usually a plastic or a metal. The printer then deposits that material in layers, building an object as the molten material rapidly cools and solidifies.

But this new research demonstrates how the technology also can be repurposed as a fast, efficient way to craft new

Sandia team members used a 3D printer to quickly melt together powdered metals and then immediately print a sam-

Sandia's creation also represents a fundamental shift in alloy development because no single metal makes up more than half the material. By comparison, the scientists said, steel is about 98 per cent iron combined with carbon, among other elements.

"Iron and a pinch of carbon changed the world," Kustas said. "We have a lot of examples of where we have combined two or three elements to make

a useful engineering alloy. "Now, we're starting to go into four or five or beyond within a single material. And that's when it really starts to get interesting and challeng-

ing from materials science and metallurgical perspectives," said Kustas.

About 80 per cent of electricity in the US comes from fossil fuel or nuclear power plants, according to the US Energy Information Administration.

Both types of facilities rely on heat to turn turbines that generate electricity.

Power plant efficiency is limited by how hot metal turbine parts can get.

If turbines can operate at higher temperatures, "then more energy can be converted to electricity while reducing the amount of waste heat released to the environment," said Sal Rodriguez, a Sandia

nuclear engineer who did not participate in the research.

According to the study, Sandia's experiments showed that the new superalloy - 42 per cent aluminum, 25 per cent titanium, 13 per cent niobium, 8 per cent zirconium, 8 per cent molybdenum and 4 per cent tantalum - was stronger at 800 degrees Celsius, or 1,472 degrees Fahrenheit, than many other high-performance alloys, including those currently used in turbine parts, and still stronger when it was brought back down to room temperature.

"This is, therefore, a winwin for more economical energy and for the environment,' Rodriguez said.

Energy is not the only industry that could benefit from the findings.

Aerospace researchers seek out lightweight materials that stay strong in high heat, the researchers said.

Ames National Laboratory, Iowa State University, US, scientist Nic Argibay said Ames and Sandia are partnering with industry to explore how alloys like this could be used in the automotive industry, they said.

"Electronic structure theory led by Ames Lab was able to provide an understanding of the atomic origins of these useful properties, and we are now in the process of optimizing this new class of alloys to address manufacturing and scalability challenges," Argibay said.

## **Most Health Claims On Formula Milk Not Backed By Evidence: BMJ study**

Most health and nutrition claims on formula milk products are backed by little or no high quality scientific evidence, according to a study published in The BMJ that used data from 15 countries, including India.

Common claims are that formula milk products benefit brain development, immunity, and growth in young infants, the researchers said.

However, the international team found that "transparency is still lacking" and that revised regulations are needed "to better protect consumers and avoid the harms associated with



## **Seminar On Domestic Violence Inaugurated At KU**

Srinagar: Vice-Chancellor University of Kashmir Prof Nilofer Khan on Tuesday inaugurated a national seminar on domestic violence.

The day-long seminar was organised by Centre for Women's Studies and Research (CWSR) in collaboration with Mission Shakti. Social Welfare Department, J&K. It was sponsored by the National Commission for Women (NCW).

In her presidential address, Prof Nilofer called for greater sensitisation and awareness at grassroots on the deleterious effects of domestic violence on society's overall development and progression.

She said academic institutions can play a great role in eliminating the "scourge" of domestic violence from society and bring about a perceptible change in the "mindset of people"

## **Old City's Burusho Community Hopes To Protect 'Burushaski'**

Srinagar: In the old city's Kathi Darwaza neighborhood, an elevated plain leads to Botraj colony where community of around three hundred "Burusho" people live. Originally hailing from Hunza, Nagar and Yasin major belts forming Gilgit Baltistan, the community has settled down in old Srinagar for more than a century.

Botraj colony largely comprises of Burusho people, locally known as "Botraj". They speak a language alien to the majority community in Kashmir.

Many linguists consider Burushaski a language isolate. Burushaski is spoken by around 300 people of the Burusho community of Kashmir and around 100,000 people of the Hunza, Nagar and Gupis-Yasin districts in Gilgit-Baltistan.

Raja Mehboob Ali Khan, a senior member of the community in his 80's says the community actually came from northern states of Hunza,

RINAGAR - The devil himself could not have conceived of tortures more horrible. Security forces drenched a local imam of Rafiabad with kerosene, set him alight, and flung him half-dead into his home, with a dire warning of consequence! still more hide ous if the family let out even a chirp about the incident. As the cleric hovers between life and death in hospital, his relatives say police have refused to reg¬ister a case.

Locals say the 35-year-old imam, Ghulam Hassan Kumar, of Shalakot, Rafiabad, was arrested by personnel of the 28th Rashtriya Rifles (RR) last Wednesday evening, i.e. the 14th of February, when he was on his way to the mosque. The RR-patrol which picked him up had accused him of signaling away some foreign mili¬tants, who they said, had been working near the place of Residents of the area and the imam's relatives and neighbours

say that Kumar's captors had torn off flesh from his arms and legs during his eleven-day-long 'detention'. He was flung into a blazing fire, and when he crawled out

badly burnt, he was put through another ordeal: kero¬sene oil was poured on his chest, and set on fire again When he miraculously sur¬vived the torture, the RR major

set him free on February 15. Dumping the imam near his home, he was warned neither to go to a hospital nor to inform anyone else. Ghulam Hassan had been l suffering his agony in silence, but seeing his condition deteriorate, some villagers and relatives mustered courage and shifted him to the Baramulla hospital. He is said to have sustained 90 per cent burns and doctors say his condition is critical. Relatives say they had tried to register an FIR but the police had refused to do so.

Meanwhile, Hassan has been shifted to the SMHS hospital here. (Kashmir Observer, 22 February, 2001)

### **Tourist From Gujarat Dies Of Heart Attack**



## Welcome Development

he centre is reportedly planning withdrawal of army from the Kashmir Valley in a fresh sign that the situation in the province is returning to normal after decades. The significant development follows three and a half years after the withdrawal of the special status of Kashmir.

The withdrawal will be done in a phased manner. The government is expected to start with districts where militancy has ended. The CRPF and Jammu and Kashmir Police will fill in the space vacated by the Army.

The decision, the reports say, has followed a careful assessment of the ground situation which has remarkably improved in recent years. Only the militancy which seemed to have been holding up so far has now also been sufficiently reigned in. The UT is now far more peaceful than it was before 2019, another condition for elections. The home minister Amit Shah recently highlighted in an interview that there has been a drastic decrease in terrorism-related incidents in the UT following the revocation of Article 370, and that development efforts in the region are contributing to the fast improving situation. He pointed to the figures on the evolving situation which vindicate the government.

A recent MHA review highlighted the progress made in J&K over the last year on economic and security fronts. The union territory, the report said, witnessed "a 54 percent reduction in terrorist incidents, a 22 percent drop in recruitment of militants and 84 percent decline in the deaths of security forces." In real terms, the militancy related violence has decreased from 417 incidents in 2018 to 229 in 2021 while the number of slain security personnel had dropped from 91 in 2018 to 42 in 2022.

One biggest indicator of the new normalcy has been the growth of tourism. And last year, number of tourists visiting Kashmir broke all previous records. According to the tourist officials, the number of tourists Kashmir received in 2022 is the highest so far, beating by far even the pre-turmoil period record.

On the development front, the report says that the BJP government at the centre has brought in an investment of Rs 56,000 crores in just three years. Under the Prime Minister's Development Package, the report mentions, Jammu and Kashmir got about 63 projects in hydroelectricity at a cost of Rs 80,000 crore. The fruits of these projects are likely to become visible in the coming years. And by then, hopefully, there wouldn't even be the need to deploy CRPF across the Valley.

## Sanitising literature

t is a curious conceit of well-meaning adults that makes them believe that children need to inhabit a world, even in their imagination, of padded walls and training wheels. In this patronising conception of childhood, the purpose of storytelling is a stifling, moralising pedagogy meant to create perfect little citizens — not a fun, transgressive way for children to find their own worlds and voice. For generations, Roald Dahl helped children — and sometimes even beleaguered adults — find humour (often dark and macabre) and irreverence. Now, nearly 33 years after his death, Dahl's publisher and estate are going to sanitise the writer's works to remove language they deem "offensive".

To be clear, Dahl's works for children do not carry expletives. They do call an overweight glutton fat. So, Puffin books will rework the classics. In Charlie and the Chocolate Factory, Augustus Gloop will be "enormous" rather than the fword and the iconic Oompa Loompas are going from being male to gender neutral. The desire to protect children from adjectives does not end at mere censorship. Entire passages will reportedly be inserted into the works of one of the most original writers. In The Witches, lines that say that witches are bald under their wigs will be followed by the following insertion: "There are plenty of other reasons why women might wear wigs and there is certainly nothing wrong with that."

First, the obvious point: The way to change what people read, and how they think, is not to censor and rewrite books but to write your own. What the well-meaning censors do not understand is that children's stories are not just about conforming to the fundamentalism of the day — whether regressive or woke. A cursory look at Grimm's fairytales will give you stories of cannibalism, kidnapping and even suicide. Roald Dahl's appeal for so many young people has been in his delicious wickedness. And if profit-hungry publishers have a problem with that, they should avoid the self-serving hypocrisy of trying to "fix" literature. They can just give up their copyright and forego the profits.

## **India at a Crossroads**

India is poised to become the world's most important country in the medium term. It has the largest population (which is still growing), and with a per capita GDP that is just one-quarter that of China's, its economy has enormous scope for productivity gains. Moreover, India's military and geopolitical importance will only grow, and it is a vibrant democracy whose cultural diversity will generate soft power to rival the United States and the United Kingdom.

One must credit Indian Prime Minister Narendra Modi for implementing policies that have modernized India and supported its growth. Specifically, Modi has made massive investments in the single market (including through de-monetization and a major tax reform) and infrastructure (not just roads, electricity, education, and sanitation, but also digital capacity). These investments - together with industrial policies to accelerate manufacturing, a comparative advantage in tech and IT, and a customized digital-based welfare system - have led to robust economic performance following the COVID-19 slump.

Yet the model that has driven India's growth now threatens to constrain it. The main risks to India's development prospects are more micro and structural than macro or cyclical. First, India has moved to an economic model where a few "national champions" - effectively large private oligopolistic conglomerates – control significant parts of the old economy. This resembles Indonesia under Suharto (1967-98), China under Hu Jintao (2002-12), or South Korea in the 1990s under its dominant chaebols.

In some ways, this concentration of economic power has served India well. Owing to superior financial management, the economy has grown fast, despite investment rates (as a share of GDP) that were much lower than China's. The implication is that India's investments have been much more efficient; indeed, many of India's conglomerates boast world-class levels of productivity and competitiveness.

But the dark side of this system is that these conglomerates have been able to capture policymaking to benefit themselves. This has had two broad, harmful effects: it is stifling innovation and effectively killing early-stage startups and domestic entrants in key industries; and it is changing the government's "Make in India" program into a counterproductive, protectionist scheme.

We may now be seeing these effects reflected in India's potential growth, which seems to have declined rather than accelerated recently. Just as the Asian Tigers did well in the 1980s and 1990s with a growth model based on gross exports of manufactured goods, India has done the same with exports of tech services. Make in India was intended to strengthen the economy's tradable side by fostering the production of goods for export, not just for the Indian market.

Instead, India is moving toward more protectionist import-substitution and domestic production subsidization (with nationalistic overtones), both of which insulate domestic industries and conglomerates from global competition. Its tariff policies are preventing it from becoming more competitive in goods exports, and its resistance

this scandal. But the optics of the Adani story are concerning.

There is a perception that the Adani Group may be, in part, helping to support the state political machinery and finance state and local projects that would otherwise go unfunded, given local fiscal and technocratic constraints. In this sense, the system may be akin to "pork barrel" politics in the US, where certain local projects get earmarked in a legal (if not entirely transparent) congressional vote-buying process.

Supposing that this interpretation is even partly correct, Indian authorities might reply that the system is "necessary" to accelerate infrastructure spending and economic development. Even so, this practice would be toxic, and it would represent a

to joining regional trade agreements is hampering its full integration into global value and supply chains.

Another problem is that Make in India has evolved to support production in labor-intensive industries such as cars, tractors, locomotives, trains, and so forth. While the labor intensity of production is an important factor in any labor-abundant country, India should be focusing on industries where it has a comparative advantage, such as tech and IT, artificial intelligence, business services, and fintech. It needs fewer scooters, and more Internet of Things startups. Like many of the other successful Asian economies, policymakers should nurture these dynamic sectors by establishing special economic zones. Absent such changes, Make in India will continue to produce suboptimal results.

Finally, the recent saga surrounding the Adani Group is a symptom of a trend that will eventually hurt India's growth. It is possible that Adani's rapid growth was enabled by a system in which the government tends to favor certain large conglomerates and the latter benefit from such closeness while supporting policy goals. Again, Modi's policies have deservedly made him one of the most popular political leaders at home and in the world today. He and his advisers are not personally corrupt, and their Bharatiya Janata Party will justifiably win re-election in 2024 regardless of

wholly different flavor of realpolitik compared to, say, India's vast purchases of Russian oil since the start of the Ukraine War.

While those shipments still account for less than one-third of India's total energy purchases, they have come at a significant discount. Given per capita GDP of around \$2,500, it is understandable that India would avail itself of lower-cost energy. Complaints by Western countries that are 20 times richer are simply not credible.

While the scandal surrounding the Adani empire does not seem to extend beyond the conglomerate itself, the case does have macro implications for India's institutional robustness and global investors' perceptions of India. The Asian financial crisis of the 1990s demonstrated that, over time, the partial capture of economic policy by crony capitalist conglomerates will hurt productivity growth by hampering competition, inhibiting Schumpeterian "creative destruction," and increasing inequality.

It is thus in Modi's long-term interest to ensure that India does not go down this path. India's long-term success ultimately depends on whether it can foster and sustain a growth model that is competitive, dynamic, sustainable, inclusive, and fair.

## Why Do We Need Philosophy If We Have Science?

o answer the question posed in the title above, one recalls Wittgenstein here who basically said that all the things that we can describe through science are not actually the things that matter most in our lives; the things that are actually most important are beyond discursive language and science. This is the whole Wittgenstein's critique of positivists who misinterpreted his early work. Ethics, religion, wisdom, art/aesthetics, joy, humility, poetry, meaning, beauty, openness to being/ reality, etc which are beyond totalizing reductive linguistic and scientific descriptions are in actual fact the highest ends of human life which make our lives worth living. These things essentially depend on one's (existential) orientation towards life/reality rather than abstract speculative & calculative truth finding as critics like Dawkins wrongly conceive.

Why is philosophy important? Why do we need it? Well, the point is that what is going on in one's "head" is far more important than the gadgets one possesses in one's "hand". We need philosophy/thought/psychology over and above mechanical robotic science & technology simply because we do not want people to bomb each other out with atom bombs! "Thought" is more important or dangerous (depending upon how one looks at it) than technology. Technology comes in service "thought", asking for its use. Moreover, it is philosophical discourse that drives the wheel of history. Industrial revolution and science/renaissance were themselves stimulated by philosophical ideas/ outlooks. Influence of, say, Locke's philosophy on French & American revolutions is hidden from none.

People ask: why do we need philosophy? What will it do? Well, philosophy as hikmah is wisdom which teaches the art of living. And it is here that philosophy (as traditionally understood) intersects with religion. Traditional philosophy/ hikmah, for example, says that selfish action invites misery; this is hikmah; this teaches us how to live life such that suffering is transcended and joy erupts from one's own being. What is more urgent than that? It is a reorientation towards life. It cannot be achieved by merely multiplying scientific calculations. Physics, chemistry, technology, etc do not help when we are loneliest at the st points of our lives darkest pits of our lives; when life asks us pinching questions of meaning & suffering; when we face inner turmoil; it is one's meaningful orientation towards life that helps and not fancy gadgets.

The world needs wisdom more than ever today. It is more relevant than technology which has suffocated both humans and the environment with its pollution and meaninglessness. Technological mindset reveals the world through a certain ontological commitment under which the world is perceived as an "object" i.e. everything, even human beings, is seen through the category of "resource" to be tapped into. This ontological attitude towards reality has been & continues to be disastrous for both the environment and the human race.

People say we need science because it is practical. Well, what is more practical than the question as to how to live daily life in a joyous way or how to find meaning, beauty, joy & contentment in a world that is fraught with suffering & alienation; how to develop virtue; how to avoid psychological suffering generated by ego pathologies; doesn't matter where human beings live, in whatever age they live - ego-energy is there; ego tantrums, selfishness, greed, arrogance, meaninglessness, loss of joy, frustrations, etc are eternal problems of mankind. Human being is not mere "calculation" but is an existential & aesthetic interface with reality; the immensely rich art and literature that human beings live by is a testament to that fact; the intangible bread of poetry - is fundamentally part of human life. This is why we can make the case that most of the human "truths" are "phenomenological" & "hermeneutic" rather than merely scientific.

At this point, however, an important clarification is in order. Philosophy is not to be narrowly reduced down to mere abstract speculative ratiocination. One of the most commonplace misconceptions that has gripped the popular discourse about philosophy is that it is equated with pure rational speculative enquiry. Such a perception fails to realize that this is purely West's definition of philosophy that is too post-Aristotelian (as even pre-Socratics in the Western philosophical tradition would not agree with such a definition). This is not how Islamic philosophy or traditional philosophy understands philosophy to be. Equating philosophy with mere "reason" is a mistake simply because traditional philosophy does not reduce human beings down to mere 'reason'. Human beings have higher noetic gnostic intuitive intellectual faculty (what is referred to as "fitri" intelligence or ayn-al-qalb). This is what Igbal criticized Kant on who had reduced human episteme down

to mere "twelve categories of understanding". Even in the modern Western philosophical tradition we find thinkers like Spinoza, Wittgenstein,

Henry Bugbee, Gabriel Marcel, Unamuno, Heidegger, Levinas, Jaspers, American Transcendentalists like Thoreau, Emerson and various others who move beyond the narrow constricting definitions of philosophy as mere rationalism.

Philosophy, as traditionally understood, means 'cultivating love for wisdom'. Hikmah/philosophy and kitaab/law, both stem from the same revelatory source. The Prophet comes to teach both "kitaab" and "hikmah" (yu'allimuhumul kitaaba wal hikmah). Therefore, philosophy is not what Descartes or Kant said – that is just a portion of Western philosophical tradition rather philosophy as traditionally understood is Sophia/wisdom/hikmah which every Prophet comes with and which then is explicated upon by the followers of Prophet i.e. the sages/hukamaa within a tradition, fleshing out the deeper essential truths of religion. Hikmah is the final fruit of reto each other. Due to the limitation of space, readers are requested to go through the works of Pierre Hadot on Ancient philosophy to see how

philosophy, in its traditional understanding, is actually an art of living. Wisdom, however, should not be confused with the popular uncritical obfuscating platitudes which Žižek rightly critiques. Wisdom has nothing to do with utilitarian sophistry. Wisdom is where metaphysics intersects with ordinary practical ethics.

Now, philosophy, even conceived as merely rationalistic speculative analysis, cannot be ignored at all. Philosophy as a rationalistic, linguistic, conceptual analysis is an inevitable necessity and cannot be avoided in any discipline at all. Philosophical analysis is highly important in second order investigations like Philosophy of Science where one studies the first principles and theoretical presuppositions on which scientific method rests. The theoretical frames of physical and social sciences cannot be conceived of without foundational philosophy.

When a young enthusiastic science student claims that 'I only believe in empiricism – nothing more and nothing less' one realizes the dire importance of re-playing the whole projectile of the British empiricist tradition with David Hume at its logical dead end followed by Kant's critique. Without antecedent theoretical tools, bare experience

is simply blind and useless as Kant showed. This was later on re-played within logical positivist tradition in similar tone when Neurath critiqued Carnap's protocol statements (bare experiential sense data). Carnap, like Hume, asserted that all we have is basic pure elementary sense data whereas Neurath clarified that we already are drenched in theoretical presuppositions without which our observation, data collection and interpretation lose all meaning. This is well established now, for example, again reiterated by Davidson and Sellars. The notion of bare elementary sense datum theory called as phenomenalism has long been debunked. Present day great physicists like Carlo Rovelli are successfully reacting against naïve scientism (that posits anti-philosophy attitude), by showing how science is intimately connected to philosophy. Any basic book on Philosophy of science can cure the fever of scientism.

Similarly, in addition to second order philosophical studies like 'Philosophy of Science', there are literary theories, sociological theories, political theories which are conceptual philosophical paradigms of the basic foundational principles on which these physical and social sciences stand. Without philosophical tools

we can never get around the edifice of any subject. Scientists are not empty vessels, going around collecting data; there are antecedent theories which condition & determine data collection, data acceptance or rejection and then its interpretation.

The world today needs - what people even condescendingly refer to as - "speculative philosophy" as Žižek notes, not only for the critical examination of the scientific method & implications of technology but also for deeper engagements in political & social theory. As long as human society exists, political philosophy shall remain relevant. People who do not appreciate philosophy fail to see that all the major political and ideological debates that pose significant influence on the world we live in today, say for example identity politics, is a direct end result of certain philosophical vantage points; for example, postmodern relativism, free voluntarism, fluidity in gender (I get to be what I "choose") is a direct end result of Cartesian and Kantian philosophy with cogito/self at the centre, in addition to celebration of Ockham's nominalism where all we have are particular individualities/identities & not any "universals", not to mention "self" being at the centre in the 20th century World War engulfed Europe's existentialist & absurdist thought where subject makes/constructs reality. This is why philosophy becomes important; it decides how people think, how they conceive their interface with the world and consequently the nature of their social and political engagements.

How to organize our societies; how to bring about a just distribution of resources; what is justice; these are all fundamentally philosophical questions. Moreover, we need to note with Žižek that even if philosophy may not provide grand answers to our questions but nevertheless it helps us see that sometimes the very way in which a question is framed is itself the part of the problem; philosophy in its foundational meta critique helps us see the hidden presuppositions which then definitely contributes towards the solutions.

In today's technocratic world, where the sole unilateral focus is on simply "doing"/getting things done, we need to pause for a while and "think" as to where we are heading towards. Whether it comes to environmental crisis, existential crisis, disproportionate deprivation of marginalized people, nuclear crisis or other political crises, humanity needs – what popular culture condescendingly refers to as – "idle speculative thinking"; humanity has never been in such a dire need of just clear "thinking".

## Why Do We Stop Exploring New Music As We Get Older?

A ccording to an estimate from the International Federation of the Phonographic Industry, an organisation that represents the international music industry, people around the world spend on average 20.1 hours per week listening to music, up from 18.4 hours in 2021.

We have more ways to access music than at any time in history and a whole world of unfamiliar styles to explore

The thrill of discovering new songs and new sounds can enrich people of all ages.

Except, most of the time, it doesn't. Our willingness to explore new or unfamiliar music declines with age. Multiple studies confirm the sentiments of US songwriter and musician Bob Seger:

Today's music ain't got the same

I like that old time rock 'n' roll

### EXPLORING NEW MUSIC

Academics use the term "openearedness" to describe our willingness to explore new music. Across our lives this willingness waxes and wanes.

Until around the age of 11, children are generally happy to engage with unfamiliar music. Early adolescence sees a reduction in open-earedness, but is accompanied by an intense increase in interest in music more generally. Open-earedness increases slightly during young adulthood, then declines as we age.

A major 2013 study involving more than 250,000 participants confirmed these changing behaviours. It also showed that the significance we ascribe to music after adolescence declines, and the amount of music we listen to reduces from a high point of 20% of our waking time during adolescence, to 13% in adulthood.

### SHIFTING PRIORITIES

Researchers have different, but generally complementary, theories to account for these population-level trends. Some interpret the observed decline in music engagement in terms of psychosocial maturation.

Adolescents use music as an identity marker and engage with it to navigate social circles. Adults have developed personalities and established social groups. As such, drivers to engage with new music are lessened.


One explanation for the age-based reduction in music consumption simply posits that responsibility-laden adults may have less discretionary time to explore their musical interests than younger people.

Some scholars question whether there is a straightforward link between the decline in the rate of new music consumption and increasing music intolerance.

Others argue against using chronological age as a predictor for stagnant musical taste without first considering the different ways we process and use music across our lifespan. Teenagers tend to be very aware of what they are listening to. Adults who use music as motivation or accompaniment for activities such as exercise or menial tasks may be less conscious of the extent to which they actually do listen to new music

firstly because our brains are developed to the point where we can fully process what we're hearing, and secondly because the heightened emotions of puberty create strong and lasting bonds of memory.

### SOUNDTRACK OF OUR LIVES

Neuroscience provides some fascinating insights into how and why our musical tastes develop. We know, for example, infants display an affinity to music they heard in utero.

Also, musical taste boils down to familiarity. In his book This is Your Brain on Music, neuroscientist Daniel Levitin writes:

When we love a piece of music, it reminds us of other music we have heard, and it activates memory traces of emotional times in our lives.

What we think of as our "taste" is simply a dopamine reaction arising from patterns our brain recognises which create the expectation of pleasure based on pleasures past. When we stop actively listening to new or unfamiliar music the link between the musical pattern and pleasure is

These same researchers point to age-related changes to hearing acuity – specifically a lowering tolerance for loud and high-frequency sound – as one cause for a reduced interest in new music for some people.

It may take a decade or two to get there, but the result is, eventually, "young people's music" will alienate and bring no pleasure.

So, are we doomed to musical obsolescence as we age? Far from it. Recent research suggests musical taste does not need to calcify but can continue to develop across our lives.

### EXPANDING OUR HORIZONS

Here are some tips if you want to train your musical taste to extend beyond the "old favourites" of youth:

1. cultivate different modes of listening including in formal (concerts), focused (solitary), casual (as an accompaniment to other activity) and social settings

make listening habitual
 be curious about what you're listening to. You can help your brain form new patterns by knowing something of the story behind the music

4. be patient and persistent. Don't assume because you don't immediately like an unfamiliar piece that it's not worth listening to. The more you listen, the better your brain will be at trig-

gering a pleasure response
find a friend to give you recommendations. There's a good chance you'll listen to music suggested to you by someone you like and admire

6. keep listening to the music you love, but be willing to revisit long-held beliefs, particularly if you describe your musical taste in the negative (such as "I hate jazz"); it's likely these attitudes will stifle your joy

7. don't feel you have to keep up with new music trends. We've 1,000 years of music to explore.

If, after making the effort, you still find new popular music hard to bear, take solace from songwriter Ben Folds, who says in his memoir:

Good pop music, truly of its moment, should throw older adults off its scent. It should clear the room of boring adults and give the kids some space.

### Naga Peace Talks Underway, **Hopeful PM Modi's Initiative** Will Bear Fruit: Shah

Tuensang (Nagaland): Union Home Minister Amit Shah on Tuesday asserted that Naga peace talks are underway and hoped that the initiative taken by Prime Minister Narendra Modi to bring lasting peace in the northeastern state will bear fruit. Addressing an election rally in Tuensang, Shah said there are some issues related to development and rights of eastern Nagaland and those will be addressed after the assembly elections.

"There was an insurgency in Nagaland before 2014... We started the peace process. I am hopeful that the initiative of Prime Minister Narendra Modi will bear fruit in bringing lasting peace in the state with the preservation of Naga culture, language and tradition," he said.

Eastern Nagaland People's Organisation (ENPO), the apex tribal body in the region, had called for a boycott of the assembly elections over their 'Frontier Nagaland' separate statehood demand.

"The Ministry of Home Affairs (MHA) has held discussions with ENPO and an 'agreed agreement' has been reached. But we could not materialise it due to the implementation of the Model Code of Conduct.

"I promise you all that after the elections, the agreement will be implemented through which all issues of eastern Nagaland will be addressed. There will be massive development in the region and you will get your rights," he said.

Asserting that several measures were taken in the last nine years of BJP rule at the Centre to bring peace in the Northeast, he claimed that there was a 70 per cent dip in violent incidents in the region during the period.

"There has also been a 60 per cent reduction in deaths of security forces, while civilian deaths have dipped by 83 per cent in the Northeast," he said.

Noting that Armed Force (Special Powers) Act, 1958 has been lifted from large parts of Nagaland by the BJP government, he expressed hope that the Act will be removed from across the northeastern state in the next three to four years.

Shah asserted that there has been an electoral seat-sharing agreement between only BJP and NDPP and no other party is connected to the alliance.

"It has come to my notice that some parties are misleading voters by saying that they have the support of the BJP. I want to clarify that we have only two symbols for Nagaland polls -- lotus (of the BJP) and globe (of the NDPP). We are fighting this election under the leadership of Chief Minister Neiphiu Rio, while PM Modi is the leader of NDA," he added.

Shah said budgetary allocations for tribes have been increased from Rs 21,000 crore in 2014 to Rs 86,000 crore in 2022.

He said more than 100 developmental projects, including 13 in Nagaland, have been finalised after conducting extensive studies using space technology.

"During the UPA rule, only Rs 1,300 crore was allocated for the development of Nagaland in 2009-10, which was in-creased to Rs 4,800 crore in 2022-23 fiscal by the BJP government," Shah said.

"In the last eight years, 53 developmental projects have been completed in Nagaland and 142 more are in the pipeline," he said.

Listing out the number of beneficiaries of various central schemes, he said, "Support us this election and I assure you that free medical treatment cap will be increased from Rs 5 lakh to Rs 10 lakh under Ayushman Bharat."

After the rally, Shah left for Dimapur, completing his twoday campaigning in eastern Nagaland, and flew to another poll-bound state Meghalaya.

## **Oreva Group Offers To Pay Rs 5 Crore Compensation To Victims**

Ahmedabad: Clock manufacturing firm Oreva Group on Tuesday made an offer before the Gujarat High Court to pay an 'interim' compensation totalling Rs 5 crore to the kin of those who lost their lives and people left injured when a British-era suspension bridge maintained and operated by the firm collapsed in Morbi town in October last year.

However, the court said the compensation offered by the company was not "just".

The suspension bridge on the Machchhu river in Morbi town collapsed on October 30 last year, killing 135 persons and injuring 56 others.

The assurance on 'interim' compensation was given in the HC by Ajanta Manufacturing Ltd (Oreva Group) during hearing of a suo motu (on its own) PIL admitted last year following the tragedy.

Senior advocate Nirupam Nanavaty, appearing for Oreva Group, told the court if the compensation is broadly divided among the affected persons, the kin of the deceased should get nearly Rs 3.5 lakh

while the injured will get Rs 1 lakh each, which according to the HC, was not "just".

"Is it just? You volunteered to pay a just compensation. Is it just according to you? This is not near to just compensation," noted a division bench of Chief Justice Sonia Gokani and Justice Sandeep Bhatt.

The bench posted the further hearing on Wednesday and asked Nanavaty to take instructions from his client whether the company would pay more compensation in the future because this payout has been termed as "not final".

The bench had earlier made it clear that Oreva's offer of compensation "will not absolve it of any liability".

Oreva Group, led by its MD Jaysukh Patel, was responsible for the operation and maintenance of the bridge with a special investigation team (SIT) formed by the state government citing several lapses on the part of the firm.

Nanavaty informed the court that the amount of Rs 5 crore is "ad-hoc" and "interim". He said Oreva Group "will deposit Rs 5 crore to the Gujarat government within two weeks and state can determine what amount is to be paid to the injured or to the kin of the deceased"

Moreover, the corporate entity has taken full responsibility of seven children who have lost both their parents in the tragedy, said Nanavatv.

These seven children will get all the required facilities such as residence and education, till they become majors. The company would also give them jobs as per their qualifications, said the senior advocate. Advocate General Kamal

Trivedi informed the court that the state as well as the Centre have so far paid a compensation of Rs 10 lakh each to the kin of the deceased and Rs 2 lakh to each injured person.

The Morbi police have arrested ten accused, including Oreva Group MD Jaysukh Patel, under IPC sections 304 (culpable homicide not amounting to murder), 308 (attempt to commit culpable homicide), 336 (act which endangers human life), 337 (causing hurt to any person by doing any rash or negligent act) and under 338 (causing grievous hurt by doing rash or negligent act).

## Digital Transactions To Soon Exceed Cash In **India: PM Modi**

New Delhi/Singapore: Prime Minister Narendra Modi on Tuesday expressed hope that digital transactions will soon surpass cash with Unified Payments Interface (UPI) increasingly becoming the most preferred payment mechanism in the country.

Modi after the launch of the cross-border connectivity between the UPI and PayNow of Singapore said about 74 billion transactions amounting to more than Rs 126 trillion, which is approximately 2 trillion Singapore dollar, was done through UPI in 2022.

"Many experts are estimating that very soon India's digital wallet transactions are going to overtake cash transactions," he said.

A large number of transactions via UPI demonstrate that this indigenously designed payment system is very secure, he said.

with his Modi along Singaporean counterpart Lee Hsien Loong witnessed the launch of cross-border connectivity between UPI and PayNow

via video conferencing.

The facility was launched through token transactions by Reserve Bank of India Governor Shaktikanta Das and Managing Director of Monetary Authority of Singapore Ravi Menon using the UPI-PayNow linkage.

Modi in a tweet said, "Today is a special day for India-Singapore friendship and for our efforts to deepen collaboration in FinTech and innovation. The participation of my friend, PM @leehsienloong made this morning's programme even more special."

Prime Minister Lee said the idea of linking PayNow and UPI was first conceived in 2018, when Modi visited Singapore.

"Since then, our two central banks have been working on this in earnest. Digital connectivity was also a key topic discussed at the inaugural Ministerial India-Singapore Roundtable (ISMR), which

was held in New Delhi last September. So I am very glad that the PayNow-UPI linkage has now become a reality," Lee explained.

"As we progressively add more users and use cases, the PayNow-UPI linkage will grow in utility, and contribute more to facilitating our trade and our people-topeople links," Lee said.

Cross-border retail payments and remittances between Singapore and India amount to over USD 1 billion annually.

"I hope this strong partnership between Singapore and India will continue to spawn innovative technology solutions and create more crossborder opportunities for our digital economies," Lee said.

Stressing that the linkage of UPI and PayNow is a new milestone in India-Singapore relations, Modi said, this will help people of both the countries to do cross-border transactions through mobile phone in an affordable manner.

Singapore is the first country with which cross-border Personto-Person (P2P) payment facility has been launched, he said. adding, this will help the Indian diaspora in Singapore, especially migrant workers/students and bring the benefits of digitalisation and fintech to the common man through instantaneous and low-cost transfer of money from Singapore to India and vice-versa.

Pointing out that the focus of the government is to promote innovation and modernisation, Modi said the Digital India programme of the government has enhanced 'Ease of Living' and 'Ease of Doing Business' and digital connectivity and has pushed financial inclusion. The Digital India programme has brought in significant reforms in governance and public service delivery.

The linkage will enable users of the two fast payment systems in either country to make convenient, safe, instant, and cost-effective cross-border fund transfers using their respective mobile apps.

"The SMC is the executive and implementing agency of the property tax. We can call a council and seek an amendment to this," corporator Danish Bhat told Kashmir Observer.

The notification further says that a person liable to property tax shall furnish to the Executive Officer or any officer authorized by him in this behalf the particulars of the property and the tax by 30 May of the financial year to which the return pertains.

"It shall be accompanied by a proof of payment in Form-2. Acknowledgment of filing of return shall be in Form-3. A copy of the acknowledgment along with the proof of payment of the second installment of tax shall be furnished by 30 November in cases where the payment is made in two installments," the notification reads.

"If any person fails to file return in due time, unless prevented by "sufficient cause", will have to the interest due for delay in payment, make the person from whom it is due liable to a penalty of Rs 100/- or 1% of the tax due, whichever is higher, for every month of default. The maximum penalty shall not exceed Rs 1000/," it adds.

JAMMU: Chief Secretary, Dr Arun Kumar Mehta on Tuesday in a meeting with traffic authorities made it amply clear that in no case should travel time between the two capital cities of the UT exceed beyond 7 hours on any day for light motor vehicles.

He made these remarks in a meeting called to review the traffic scenario on this road including that of the two cities.

The meeting was attended by Additional Chief Secretary, Principal Secretary, Divisional Commissioner, Kashmir; IG Traffic; Secretary, Transport; Deputy Anantnag/ Commissioners Ramban; SP Traffic, National Highway; District SPs, Jammu/ Srinagar/ Anantnag/ Ramban; Transport Commissioner and many other concerned officers.

Dr Mehta enjoined upon the traffic authorities to submit daily reports about the actual time taken to reach from one city to another. He told them to enhance their personnel on all the damaged portions of the road for better traffic management. He urged them not to let the traffic come to halt due to any of the hindrance. He asked them to improve the road surface damaged due to weather vagaries at all costs for smooth movement of the vehicles on this road.

The Chief Secretary impressed upon them to show zero tolerance towards road side parking hindering traffic flow. He directed for having



to deal with all the violators. He asked them to deploy traffic police personnel in busy places like markets etcfor continuous vigil and better traffic management on the highway.

Dr Mehta also took stock of the construction works on different projects presently under progress. **JAMMU:** As part of its efforts to improve services rendered under the AB PM-JAY/ AB PM-JAY SEHAT scheme, Health & Medical Education department, through it's 104 Call Centre, contacted 21,145 beneficiaries during the last six months out of the which 58% rated the services provided under AB PM-JAY/ SEHAT as excellent, 41 % rated the services as good and 1% rated the services as poor.

On the basis of the feedback of the beneficiaries, grievances received on CGRMS, CPGRAMS, JKIGRMS, feedback of Insurance Company and triggers received from National Anti-Fraud Unit (NAFU) of National Health Authority (NHA) and strictly as per the guidelines issued by NHA, State Health Agency (SHA) conducted audit of 100 % claims preferred by Empanelled Private Hospitals including highly utilized packages like Cholecystectomy (Removal of Gall Bladder). So far more than 60,000 cases have been audited during the current policy period. This is in addition to the audit of each claim being done by the Insurance Company. This ensures efficient claim scrutiny which prevents unnecessary procedures from being booked under the scheme. On the basis

of the audit, SHA imposed Rs.

3.06 Crores as penalty on the erring empanelled health-care providers and have taken action under guidelines against erring hospitals and treating doctors for violating standard treatment guidelines or for any other malpractice.

Government of Jammu & Kashmir under Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB PM-JAY) and AB PM-IAY SEHAT empowers every family of J&K with a financial protection of Rs 5 lakh annually for meeting health expenditure. Jammu & Kashmir was one of the first States/UTs to universalize AB PM-JAY. The scheme is being implemented in the Insurance mode. So far, under AB PM-JAY and AB PM-JAY SEHAT more than 7 Lakh treatments have been provided to J&K domiciles including treatments received outside J&K using portability option and the treatments amount to more than Rs. 1100 Crores. On an average the daily claim outgo is about Rs. 2

Crores now. Every 10 in-patients are facilitated by a Pradhan Mantri Arogya Mitra (PMAM) across all the empanelled health-care facilities of the Union Territory and there are about 425 such PMAMs working in Public Health-care facilities. Besides PMAM, Medical Coordinators have also been designated for each empanelled hospital for smooth processing of the case after admission of the beneficiary in the hospital.

Deputy Secretary to govern-ment, Masood Ahmad Wani said that on directions of the administration, the department needs to submit information regarding pursuing of post graduate degrees in various disciplines during in-service by incharge lecturers, masters and teachers so that it will finalize the seniorities.

According to the news agency–Kashmir News Observer (KNO), the officer said this in a communique to Directors of School Education of both Jammu and Kashmir regions.

"I am directed to request you to kindly furnish details of incharge lecturers, masters and teachers discipline wise having pursued their Post Graduate Degrees in various disciplines order issued in 2012. during service in regular as well as distance mode and are not fulfilling the conditions as laid down in 2017 as per the formats prepared by the department," it reads.

He said that the disciplinewise consolidated information as per devised formats should reach the School Education Department within two weeks time positively thereby enabling this Department to take further necessary action in the matter.

Stating the conditions laid down by the government in an order issued on November-2017 reads that, "The University or the institution awarding the degrees through distance mode are UGC recog-

nised and Established by an Act of Parliament or State Legislature.'

It also reads that the courses offered are approved by Distance Education Council (DEC) or All India Council for Technical Education (AICTE).

"The in service candidate, who have acquired their degree through Distance Mode prior to the issuance of Jammu and Kashmir Private Colleges (Regulation & Control) Rules 2005 shall be treated as recognised and valid, provided the Universities or the institutions from which they have obtained their degrees are recognized as per UGC guidelines and are DEC or AICTE approved," it reads.

The conditions further states that the courses in Science subjects where practicals are part of curriculum, the concerned University shall certify that the practicals have been conducted from the main campus of the University as envisaged in Clause (VI) of the government

through Distance Education Mode from off-campus which have been established by the State Universities beyond their territorial jurisdiction shall not be recognised.

"The in-service candidates should have obtained their degrees after seeking proper permission from the Competent Authority at the relevant point of time and the promotion of in-service candidates including Distance Mode degree-holders. shall be performance- based and their regularisation will be effected strictly as per their last three years' performance in their respective disciplines," it reads—(KNO)

### **Ladakh Sets Guinness Record For High Altitude Half-Marathon**

LEH/JAMMU: The Union Territory of Ladakh has created history by successfully conducting its maiden 21km trail running event in sub-zero temperature at 13,862 feet high Pangong Tso, which was registered in Guinness world record as the world's highest frozen lake half marathon.

Spread across the border of India and China, the 700-square kilometer Pangong Lake records a temperature of minus 30 degrees Celsius during winter, making the salt water lake frozen with ice.

The four-hour long marathon started from Lukung and ended at Maan village on Monday with no injury reported to any of the 75 participants, Leh District Development Commissioner Shrikant Balasaheb Suse told PTI.

Named as the 'Last Run' to remind

the people about the climate change and need to save the Himalayas, the marathon was organised by the Adventure Sports Foundation of Ladakh (ASFL) in collaboration with Ladakh Autonomous Hill Development Council, Leh, Tourism Department, Ladakh and Leh district administration.

"The first Pangong frozen lake half marathon is now officially registered in the Guinness book of world records," Mr. Suse said.

He said besides spreading the message of ecological awareness among the stakeholders through sports, the marathon was also aimed at promoting sustainable winter tourism in border villages of eastern Ladakh to generate livelihood opportunities for residents especially in winters which is part of 'vibrant village programme' announced by Central
