No Property Tax For Small Houses; Meagre For Small Businesses: Govt

J&K One Of The Last In The Country To Levy It With Minimum Financial Implications For People

Jammu: LG administration Thursday clarified that all the poor, marginalized having small houses with built-up area of up to 1000 square feet have been exempted by the government from paying any property tax to be levied from April onwards this year.

In a meeting chaired by the Chief Secretary to deliberate upon, what an official spokesman called misinformation created regarding property tax in Jammu and Kashmir, it was informed that Jammu and Kashmir was one of the last States/UTs to levy property tax and non-imposition of the tax was depriving local bodies to become self-sustaining.

The meeting attended by Additional Chief Secretary, Home: Principal Secretary, H&UDD; ADGP Jammu/Kashmir; Deputy Commissioners; SSPs; Commissioners of Jammu and Srinagar Municipal Corporations and other concerned officers was informed that levy of property tax was an essential part of urban sector reforms.

Urban Local Bodies (ULBs) are required to render multiple civic services in their jurisdiction and



need resources. The levy of this tax will improve the financial health of these institutions and improve services, besides creating employment.

While explaining the methodology of levying this tax in the UT, the Principal Secretary, H&UDD, Rajesh Prasad stated that there is no tax liability for those having built-up area of their houses less than 1000 sq ft besides the proportion of taxes is considerably lesser here than of other progressive States like that levied in other parts of the Gujarat Maharashtra, Karnataka and Delhi. Similarly, all places of worship, including Temples, Municipal Committees shall be Masjids, Gurudwaras, Churches, much lower than that of Municipal Ziarats, Cremation and Burial Corporations. Admin **Expects Rs** 150 Cr In **Property Tax**

he Jammu and Kashmir administration expects to get Rs 150 crore in revenue from property tax and the money will go towards bolstering municipal bodies to give people better civic services, an official said. Under the new property policy, he said, there will be a 10 per cent rebate for early submission, which can be paid in two equal instalments. The Jammu and Kashmir administration had on Tuesday ordered the imposition of property tax across its municipal areas from April 1. The tax rates will be five per cent of taxable annual value (TAV) for residential properties and six per cent for commercial properties, it had said.

"The government is expected to get Rs 150 from the property tax imposition in 2023-24. It is imposed for More on P10

Air Pollution Speeds Up Bone Loss From Osteoporosis: Study

ncreased levels of air pollutants such as nitrous oxides are associated with bone damage among postmenopausal women, according to a study.

Scientists at Columbia University Mailman School of Public Health, US, found that the effects were most evident on the lumbar spine, with nitrous oxides (NO) twice as damaging to the area as in normal ageing.

Previous studies on individual pollutants have suggested adverse effects on bone mineral density, osteoporosis risk, and fractures in older individuals.

The latest research, published in the journal eClinicalMedicine, is the first to explore the connection between air pollution and bone mineral density specifically in postmenopausal women, and the first to explore the effects of air pollution mixtures on bone outcomes. searchers said. These effects a happen throug death by way damage and c

Women's Health Initiative study, an ethnically diverse group of 161,808 (over 1.6 lakh) postmenopausal women. They estimated air pollution

(PM10, NO, NO2, and SO2) exposures based on participants' home addresses. The team used dual-energy

X-ray absorptiometry to measure bone mineral density (BMD) at enrollment and at follow-up at year one, year three, and year six. The magnitude of the effects of nitrogen oxides on lumbar spine BMD would amount to 1.22 per cent annual reductions -- nearly double the annual effects of age on any of the anatomisearchers said. These effects are believed to happen through bone cell death by way of oxidative damage and other mechanisms, they said. Our findings confirm that oxides, will reduce bone damage in postmenopausal women, prevent bone fractures, and reduce the health osteoporosis among postmenopausal women

poor air quality may be a risk factor for bone loss, independent of socioeconomic or demographic factors," said study first author Diddier Prada, an associate

Car and truck exhaust is a major source of nitrous oxides, as are the emissions from electrical power generation plants.

Osteoporosis impacts women more than men, with 80 per cent of the estimated 10 million Americans with osteoporosis being women, the researchers said.

Postmenopausal women are at higher risk, with one in two women over 50 experiencing a bone fracture because of osteoporosis, they said.

Ready To Go To Any Extent Over National Security: S Jaishankar On India

PUNE: External Affairs Minister S Jaishankar on Thursdav said the image of India today is that of a country that is willing to go to any extent to protect its national security.

He also cited a top International Monetary Fund official about 15 per cent of growth this year coming from India, and said India is "15 per cent of the solution" the G20 group of countries is looking for in

terms of economic growth. Addressing the 'Festival of Thinkers' organised by the Symbiosis International University here, he also said that data security and data privacy are the biggest challenges of the digital world, and issues connected to them are expected to be addressed during the G20 meeting.

"In the last few years, we have been tested for a long time on our western border. I think things are a little different now and everyone will agree. Few things had happened in 2016 and 2019, and we have been tested and we are being tested on our northern borders," he said.

How India comes through this test will show our ability to stand up, Mr Jaishankar said.

"We have today the image of the country which is willing to do what it takes to defend its national security. It (India) is a very forbearing country, a patient country, it is not a country that goes around picking fights with other people, but it is a country that will not be pushed out. This is a country that will not allow its basic bottom lines to be crossed," he said.

Opposition Leaders Slam Jaishankar, Point To His Father's **Comments On Gujarat Riots**

Opposition leaders on Wednesday lashed out at External Affairs Minister S Jaishankar for his remarks on China and the BBC documentary on Prime Minister Narendra Modi, with many of them pointing to his father's reported comments against the then Gujarat dispensation following the 2002 riots.

The Congress on Wedneslav called Jaishankar a "failed" minister and alleged that his remarks on the China issue have "demeaned" the valour of India's armed forces. Congress spokesperson Supriva Shrinate also alleged that foreign policy has been reduced to photo-ops and a chest-thumping exercise and is being used to secure contracts for a businessman. The opposition party's attack came over the minister's reported remarks urging people to not buy the narrative that somewhere the government is on the defensive or is being accommodative on the China issue. Jaishankar also reportedly hit out at the British Broadcasting Corporation (BBC) over



Referring to the Ukraine conflict, he said the pressures which came with that conflict were also the moment when our sense of independence and sense of confidence were tested. India is also becoming "the voice of the global south" and wants to go into G20 saying that "there is a large part of the world which is not sitting on that table but they have a legitimate interest and somebody needs to speak up for them, the minister said.

Israeli Troops Kill 11 **Palestinians In West Bank Clash, Medics Say**

NABLUS: Israeli troops killed 11 Palestinians, including at least four gunmen and four civilians, and wounded more than 100 people during a Wednesday raid on a city in the occupied West Bank, witnesses, militant groups and medical officials said. The Israeli military con-

firmed the operation in Nablus, saying troops shot back after coming under fire while trying to detain militants suspected of planning imminent

attacks. There were no Israeli casualties, the army said in a statement. The Palestinian militant faction Islamic Jihad said Israeli

troops had surrounded two of its Nablus commanders in a house, triggering a clash that drew in other gunmen. Explosions sounded and youths threw rocks at armoured troop transports. Palestinian sources said the

two Islamic Jihad command-

ers were killed along with another gunman. The fatalities included four civilians, among them a 72-year-old man and a 14-year-old boy.

The Palestinian Health Ministry said a 66-year-old man who suffered from gas inhalation during the raid died in hospital later on Wednesday. Medical officials said more than 100 Palestinians were wounded.

Nablus and nearby Jenin have been a focus of raids that Israel has intensified over the last year following a spate of lethal Palestinian street attacks in its cities.

Sixty-two Palestinians, including gunmen and civilians, have been killed in 2023, the Palestinian health ministry said. Ten Israelis and a Ukrainian tourist died in Palestinian attacks in the same period, according to Israel's foreign ministry.

Turkey Earthquake Deaths Rise To 43,556

ISTANBUL: The number of people killed in Turkey in this month's devastating earthquakes has risen to 43,556, the country's Interior Minister Suleyman Soylu said overnight.

Soylu told state broadcaster TRT Haber that there had been 7,930 aftershocks following the first quake on Feb. 6 and that more than 600,000 apartments and 150,000 commercial premises had suffered at least moderate damage.

Heavy Snowfall In US, Massive Power Outage, Over 1,500 Flights Cancelled



LOS ANGELES: Powerful winter storms lashed the US on Wednesday, with heavy snow snarling travel across wide areas, even as unusual warmth was expected in others. Blizzards forecast to dump up to two feet (60 cm) of snow swept across a vast band of the country from the West Coast to the Great Lakes, grounding flights and knocking out power to tens of thousands.

Warnings of heavy snowfall were even issued for usually sunny areas near Los Angeles, as well as for more typical winter weather spots in the far north. Forecasters with the Nation-

al Weather Service said two rounds of snow would wallop parts of Minnesota in a "historic winter storm (that) will likely lead to impossible travel."

"Heavy snow will combin with northeast wind gusts of 35 to 45 mph (55 to 70 kph)...This will lead to significant blowing and drifting snow with whiteout conditions in open areas. Some drifts may be several feet deep," a warning said. "If you must travel, keep an extra flashlight, food, and water in your vehicle in case of an emergency. Travel should be restricted to emergencies only. If you must travel, have a winter survival kit with you. If you get stranded, stay with your vehicle.' More than 1,550 flights within, into or out of the United States had been cancelled by 0000 GMT Thursday, according to Flightaware.com, with its

"Misery Map" showing Denver, Salt Lake City and Minneapolis-St Paul particularly badly hit.

Roads were also difficult, with Wyoming suffering from problems even on main highways.

"Please change travel plans if you are coming towards Wyoming," the state's department of transport posted on its Facebook page. "A major winter storm and multiday closures are likely on Interstates and secondary roads throughout Wyoming!

Åround 280,000 properties were without power across the country, according to Poweroutage.us, almost half of them in Michigan, where snow, sleet and freezing rain were icing power lines, making them vulnerable to gusting winds.

Sultan Of Oman To Visit Iran **Regarding Nuclear Talks**

The Sultan of Oman, Haitham bin Tariq, will visit Tehran to hold talks regarding the stalled nuclear negotiations between Iran and the US, Tasnim news agency reported today, 22 February.

Ali Alizadeh, a member of Iran's parliament, said to Tasnim that "Omani officials have recently indicated their readiness to play the role of mediator between Iran and the United States in order to bring the nuclear talks to a conclusion."

Moreover, he mentioned that "the Sultan of Oman had declared his intention to visit Iran shortly to deliver good news.'

Meanwhile, Iranian Foreign Minister Hossein Amir-Abdollahian emphasized that a revival of negotiations to reach a nuclear deal is still possible, according to Hispan TV.

"The path of negotiations is still open and messages are being exchanged



through intermediaries," Amir-Abdollahian announced on 22 February in a meeting with the National Security and Foreign Policy Commission of the Iranian Parliament.

According to the top Iranian diplomat, "the Omani authorities have repeatedly expressed their willingness to act as a mediator between Iran and the United States to conclude the nuclear negotiations."

He also revealed that the Central Bank of Qatar "has entered the dispute between Iran and the US" to play the role of mediator between the two sides regarding monetary and banking issues.

"I Eat Beef, Lifestyle In Meghalaya, No One Can Stop It": State BJP Chief

SHILLONG: Bharatiya Janata Party (BJP) state chief Ernest Mawrie said that there is "no restriction on beef eating" in Meghalaya and that he too consumes beef.

While talking to ANI, Ernest Mawrie said. "I cannot make a statement on the resolution adopted by other states. We are in Meghalaya, everybody eats beef, and there is no restriction. Yes, I eat beef too. There is no ban in Meghalaya. It is the lifestyle of the people, no one can stop it. There is no such rule in India also. Some states have passed some acts. In Meghalaya, we have a slaughterhouse, everybody takes a cow or pig and brings it to the market. It could be a hygienic one. So the people they have the habit."

At a time when BJP-ruled states like Assam had passed a bill to regulate cattle slaughter, transport and sale of beef and Assam Chief Minister Dr Himanta Biswa Sarma who is the face of BJP in North Eastern region has



been appealing to the people to restrict beef eating in the Hindu inhabited areas.

Refusing the allegations made by some political parties that BJP is an anti-Christian party, the Meghalaya BJP Chief said that it is just "political propaganda."

Property Tax

he imposition of property tax in Jammu and Kashmir is facing stiff criticism from the people and political parties. More so in Jammu division where the move has also triggered sporadic public protests and severe opposition from civil society groups. National Conference leader Omer Abdullah has asked the administration to leave this important decision for an elected government to decide, saying there should be "no taxation without representation." The PDP chief Mehbooba Mufti in a hard-hitting statement said that the tax was part of a plan to impoverish the people of the Union Territory. Similarly in Jammu, the tax has been opposed by parties other than the BJP. Democratic Azad Party leader Ghulam Nazi Azad has urged the administration to postpone the imposition of the tax for a few years till the economic situation in the union territory improves. Congress has also opposed the measure.

In a related development, the mayors of the twin capitals of the Union Territory have also spoken out against the tax. Srinagar City Mayor, Junaid Azim Mattu, termed the step "arbitrary" saying that it was not approved by elected Urban Local Body. Jammu Mayor, Rajinder Sharma, said that the property tax was imposed by the administration and not by the Jammu Municipal Committee.

The property tax follows the still ongoing campaign to retrieve the government land occupied by people which too has generated a deep public unease. The administration in its defense has said that by retrieving government land it was only doing its job. No less than Lieutenant Governor Manoj Sinha has reassured the people that only the big land grabbers will be targeted and that the poor people will be spared. The land being retrieved includes the Roshni land, which was earlier handed over by the previous governments to its occupiers under a scheme. The scheme, which was meant to raise Rs 25,000 crore to finance the purchase of hydropower projects from the centre by selling state land under unauthorized occupation turned out to be a damp squib. It has fetched only a few hundred crores since it was enacted in 2002 which makes the revenue earned from the land disproportionately less than the target. The administration is now citing this as a rationale to retrieve the land.

However, unlike the recovery of government land, levying a property tax touches everyone's skin, so it is facing a bigger public backlash. It remains to be seen how the administration assuages the public anger. At the same time it is true that considering the setback suffered by J&K's economy over the last few years, it would be difficult for people to pay the tax now.

Similar is the effect of Section 30(2), the 'tail' of the digital personal data protection bill 2022, India's first comprehensive privacy legislation. This seemingly innocuous provision will certainly kill the Right to Information Act, 2005. Participatory democracy in India will be halfdead as a direct consequence.

In one fell swoop, Section 30(2) prioritises the privacy of personal information over the right to information of citizens. In the original scheme of the RTI Act, personal information may have remained exempt from the scope of RTI disclosure only if two further conditions were met. First, such information should not have any public interest attached to it; second, if such information had to be disclosed to Parliament or the state legislature (say in response to a legislator's question), it would have to be disclosed to the citizen who had filed the RTI request.

As an example, if a judge had failed to disclose his/her assets as per the Supreme Court's own internal resolution, a citizen could ask for such information through a RTI request and it would have to be provided. The proposed amendment shuts this door. It simply states that anything that relates to personal information may be denied in an RTI request. Whether that personal information has public interest attached to it or not, or whether it has to be made available to Parliament or not, is immaterial. Privacy wins. Transparency must give way. How is this provision likely to be used? The former Central Information Commissioner and RTI activist, Shailesh Gandhi, has provided many telling examples — the redevelopment of Crawford Market in Bombay was halted after an RTI request disclosed that the developer would make a gain of Rs 1000 crore and the Brihanmumbai Municipal Corporation would only get Rs 40 crore. Again, a land parcel in Pune allocated to

the former president, Pratibha Patil, for building a post-retirement home was shown in an RTI request to be far beyond her entitlement. After public outcry, the former president chose to forego the land allocation. (https:// scroll.in/article/ 1042602/theseinstances-show- how-the-digitaldata- protection-bill-will- undermine-the-rti-act).

These requests can now be legally denied since they relate to personal information - the financial details of the developer, the address of the plot where Patil's new house was being built and so on. This is a self-serving amendment that is likely to damage good governance immeasurably.

The amendment is also conceptually unjustified. In principle, the right to privacy does not mean the right to do things in secret. If that were the case, privacy would include a right to take hard drugs inside one's home and to strike corrupt deals in hotel rooms. Instead, privacy implies the right to be able to do as one chooses, to be let alone on matters that are essentially selfregarding. But for holders of public office, parts of their life and associated personal information aren't self-regarding — they may certainly have public relevance. If bank accounts of public officials show disproportionate increases relative to income, then the public certainly has a right to know the source of such funds; similarly, the contact details of an elected representative should be available publicly, as should the record of disbursals made in a welfare scheme by a village official, including details of beneficiaries. On the other hand, some parts of their private lives may not have any public value except as gossip. But a one-size-fits-all solution of privacy trumping transparency in all instances, leading to a routine denial of RTI requests as the amendment has done, is egregiously wrong in principle. The blanket privileging of privacy over transparency is also a politically disempowering move. One of the key factors that catapulted the National Democratic Alliance under Narendra Modi to power in 2014 was the promise of a corruption-free India. The country had been rocked by the Commonwealth Games scandal, the corruption in house allotments in Adarsh Society, and the 2G corruption scandal. Each of these scams was uncovered in part because of persistent RTI queries that shone a light on several shady deals and questionable decisions. Were the RTI to exist in this amended form, such disclosures would neither have been possible, nor would the reputation of the then Union government taken as large a hit as it eventually did. It is politically myopic for any government today to foreclose such a possibility in the future, no matter what its short-term gains might be.

Needless to say, defenders of the amendment will point to the many instances where the RTI Act is and may be abused. Decision-makers may be deterred from taking bona fide decisions if motivated applications are filed; at other times, for a few eyeballs on social media, bogus RTI applications may be filed that hold up governance. But these are minuscule exceptions. A dispassionate assessment of RTI orders by Public Information Officers and appellate bodies shows how few and far between such bogus queries are in relation to genuine ones. It is no surprise that in the Global Right to Information Rating, a comprehensive assessment of the operation of all RTI legislations in the world, the Indian RTI Act is currently ranked 8th out of over 100 countries to have such laws. In this context, the fear of abuse is hugely exaggerated.

The only kind of State that has historically refused information to its citizens is a colonial State that rules by force and diktat, not by reason and consent. If India is serious about its emerging identity of a postcolonial State that refuses to play by the colonial playbook, it should drop the garb of the colonial State at home. Section 30(2) of the digital personal data protection bill takes the government from being one of the people to becoming one above the people. Dropping it is critical both for the government's own postcolonial image and the future of participatory democracy in India.

The EU's carbon tax

ow does the mechanism fare when it comes to cost competitiveness of covered goods? It must be noted that the sectors covered under the CBAM, except hydrogen, are covered under the EU ETS. That means these sectors have already undergone significant decarbonisation.

Therefore, non-EU products are likely to be much more carbon-intensive, leading to significant carbon tax under the CBAM. The free emission allocation that these sectors continue to benefit from under the EU ETS will be neutralised by applying the CBAM to only that portion of emissions not supported by free allowances.

Even then, the CBAM applied on embedded emissions at the EU-ETS carbon-price levels could inflict serious harm to exports from India and other countries to the EU. On top, there are the costs of emission measurement and certification that come with the CBAM.

A significant built-in equaliser in the CBAM is the provision to deduct any carbon price paid in the country of origin from the calculated CBAM taxation. With this provision, it is reasonable to imagine that many non-EU nations will try to implement some form of carbon pricing internally to stop the outflow of money. This may just be the nudge that India needs to create a national compliance market for carbon.

The EU is India's second-largest trade partner, according to the Union ministry of commerce and industry. The sectors covered under the CBAM are hard-to-abate, and the emission-intensity of Indian products from these sectors remains high

While the CBAM itself will be tested in the courts of law across the world, it is likely to prevail in the current or a modified format.

In fact, more countries like Canada and Japan are expected to implement similar tariff systems, eventually making carbon tax a norm in international trade. For many developing and least developed countries, this will be just one more slice of 'loss and damage' from climate change. However, for a fast-growing economy like ours, it is crucial to take action to decarbonise our industries and simultaneously raise our voices against discriminatory tariff regimes. Financial Express

Why Walking Through The Countryside 'Tames' Our Brain

(I'm going to the countryside over the weekend to disconnect."

This is a common refrain among people who, overwhelmed by the big city, seek to spend a few days in nature as a means of escape. We all know it works – a couple of days spent in rural relaxation and we return with our batteries recharged.

The sheer concentration of people in urban areas is growing faster than desired. Currently, more than half of the world's population lives in cities and the proportion is expected to continue to rise. It is estimated that, by 2050, seven out of ten people in the world will live in large municipalities. Many of us will spend up to 90% of our lives within buildings.

Life in the city has its advantages, but it also poses a significant mental health risk. In fact, mood disorders, anxiety and depression are up to 56% more common in urban settings than in rural ones.

GETAWAYS TO APPEASE THE AMYGDALA

There is a mechanism in the brain that allows nature to change our perception of things. It's called the amygdala.

This is suggested in a study from a few years ago. In situations of stress, the amygdala is activated more in city dwellers than people living in rural areas.

The amygdala is the region of the nervous system responsible for the control of emotions and feelings. This is logical because it is in a privileged position that allows it to establish connections with many different parts of the brain. One of these regions is the frontal lobe, which explains why the amygdala participates in the inhibition of behaviour and decision making.

The amygdala is also involved in other activities such as controlling

Leaving the city in search of trees and clean air is not always within everyone's reach. In this sense, we have an enemy: the massive and uncontrolled growth of cities, especially when urban planning does not include large green areas. Even if such areas are included, it it is of little use if they are for decorative purposes – not taking into account the benefits these areas could have for the mood of the city's inhabitants.

The impact of urban green spaces on mental health has been the subject of research for years. Many scientists point out the need to include natural elements in our city projects, taking into account the many benefits they bring to our psyche. While we wait for our cities to become greener, there is no other choice but to take great care of our natural environment. It is for our own good: we do not want to anger the amygdala.

We can intervene on the amygdala to help it avoid anxiety and stress.

It is possible to do it with medication – although science also offers us another cheaper and simpler option: just contact with nature.

A recent study has shown that repeated exposure to natural environments has a positive effect on amygdala activity. People in frequent contact with nature present less activity in their amygdala during stressful situations.

Interacting with the environment is, therefore, a way to improve mental health. The Japanese have a word for it: shinrin-yoku or "forest bathing".

Many other studies have reached

the same conclusion. They show that contact with nature increases our feeling of happiness and decreases mental anguish, since this contact reduces negative emotions and stress.

It also gives us greater capacity to manage daily tasks, improving the ability of the so-called "working memory", which allows us to temporarily store information in the brain. To this we must add an improvement in cognitive function – attention, memory, orientation – both in adults and children, with benefits in terms of imagination, creativity and school performance.

Another advantage of going out into the countryside is that it is an activity that can be done alone. People who walk alone in nature are less prone to depression and stress.

Like any good treatment, contact with nature also requires the right dosage. We need to spend at least half an hour in nature per week to feel the mental health benefits.

In conclusion, exposure to nature decreases amygdala activity and has beneficial effects on stressrelated brain regions. This suggests that walking in the countryside buffers the detrimental effects of city life. And, in turn, it potentially acts as a preventive measure against the development of some mental disorders.

esearchers have developed a first-of-its-kind small, flexible and stretchable bandage that accelerates healing by 30 per cent through the delivery of electrotherapy directly to the wound site.

In an animal study, published in the journal Science Advances, the new bandage healed diabetic ulcers much faster in mice than those without the bandage.

The bandage also actively monitors the healing process and then harmlessly dissolves -- electrodes and all -- into the body after it is no longer needed.

The new device could provide a powerful tool for patients with diabetes, whose ulcers can lead to various complications, including amputated limbs or even death, the researchers said.

It marks the first bioresorbable bandage capable of delivering electrotherapy and the first example of a smart regener-



ative system, they said.

"For people with diabetes, infections are even harder to treat and more dangerous," said Guillermo A. Ameer, from Northwestern University, who co-led the study. "For these patients, there is a ma-

One side of the smart regenerative system contains two electrodes: A tiny flower-shaped electrode that sits right on top of the wound bed and a ring-shaped electrode that sits on healthy tissue to surround the entire wound.

The other side of the device contains an energy-harvesting coil to power the system and a near-field communication (NFC) system to wirelessly transport data in real time, the researchers said.

They also included sensors that can assess how well the wound is healing. By measuring the resistance of the electrical current across the wound, physicians can monitor progress, the researchers said.

A gradual decrease of current measurement relates directly to the healing process. If the current remains high, then physicians know something is wrong, they added.

'Mobile Health Intervention Can Help Prevent Secondary Stroke'

bile health intervention can lead to improved lifestyle-related behaviours that can prevent secondary stroke, according to a study conducted in India whose findings were published in the Lancet Global Health journal.

Mobile health (mHealth) refers to the use of mobile and wireless devices to improve health and deliver care. The study was done across 31 stroke centres in India and the trial's intervention was a package composed of SMS text messages, health education videos and stroke prevention workbooks for patients.

The trial was conducted by SPRINT-India (Secondary Prevention by Structured Semi-Interactive Stroke Prevention Package) under ICMR's Indian Stroke Clinical Trial

Besides, 1502 patients in the intervention arm and 1536 patients in the control arm completed a one-year follow-up.

The trial used complex behavioral interventions to reduce the recurrence of stroke, the statement stated.

The results of the trial revealed that a structured semi-interactive stroke prevention package improved lifestyle behavioral factors and adherence to medication, which might have long-term benefits.

to the control arm (89 pc). The events like stroke, heart attack and death did not differ between the two groups (5.5 pc vs 4.9 pc) at one-year follow-up.

This may be because the follow-up period was too short or study centres were strokeready centers, which were already providing good quality care to stroke patients.

The findings of the SPRINT India trial have a long-term benefit for patients who had a stroke through mobile health interventions.

Dr Meenakshi Sharma said the trial provides hope in improving lifestyle and medical complications by leveraging technology in a resource-constrained setup.

In phase 2 which started in September 2022, four more stroke trials, which are very relevant to the country, have been initiated by ICMR. We would get answers to important treatments for stroke in the coming years.

Stroke (brain attack) is one of the leading causes of death and disability in India. There are two types of stroke; ischemic when there is a blockage in one of the brain arteries and brain hemorrhage when there is rupture and leakage of one of the arteries which supply blood to the brain, the statement said.

High blood pressure is the number one cause of ischemic and hemorrhagic strokes. High blood sugar, high cholesterol, smoking, obesity, alcohol intake, lack of exercise and unhealthy diet are the other reasons why stroke occurs.

In addition, after a stroke about 15 to 20 per cent of the patients in India develop another stroke (recurrence).

The main reasons for recurrence are discontinuing medicines, lack of control of BP, blood sugar, continuing smoking, alcohol intake, following unhealthy food habits, etc.

FM Pitches Framework To Regulate Crypto In Meeting With G20 Ministers

BENGALURU: Finance minister Nirmala Sitharaman on Thursday pitched for a global framework to regulate cryptocurrencies, besides firming up ways to tackle global debt vulnerabilities and strengthening multilateral development banks during bilateral meetings with her counterparts, including from US and Japan, ahead of the G-20 meeting.

The finance ministers of the G20 countries, which is a grouping of developed and developing nations, are here to participate in the two-day meeting of G20 finance ministers and central bank governors (FMCBG) beginning February 24. Under the G20 Presidency, In-

dia will be pressing for a global framework to regulate the cryptocurrencies, ways to tackle the aggravated debt vulnerabilities facing the developing nations mainly on account of the continuing geopolitical tensions and the pandemic.

It is feared that if left unaddressed, the mounting debt vulnerabilities of developing nations could trigger global recession and push millions to extreme poverty.

The minister so far has held separate bilateral meetings with the US Treasury Secretary Janet Yellen, Finance Minister of Japan Shunichi Suzuki, and Italian Minister of Economy and Finance Giancarlo Giorgetti ahead of the G-20 FMCBG meeting.



She is scheduled to have more than 10 such meetings.

In her meeting with Yellen, the finance minister discussed issues relating to crypto assets, strengthening multilateral development banks and global

debt vulnerabilities. "The two leaders exchanged views on #G20 #FinanceTrack priorities under #G20India Presidency in 2023. The two leaders discussed their perspectives on strengthening #MDB, #GlobalDebt vulnerabilities, #CryptoAssets, and #health, besides the Just Energy Transition Partnership #JETP and possible takeaways for the two sides," the finance ministry tweeted after the meeting.

In a separate tweet on Sitharaman's meeting with her Japanese counterpart, the finance ministry said the ministers exchanged views on priorities under G20 Finance Track 2023. "Both Ministers looked forward to close cooperation between Japan as #G7 Presidency and India as #G20 Presidency on strengthening of #MDBs, #debt related issues, financing cities of

cy for #CryptoAssets," it said.

Tens Of Millions Still Use Instagram In Iran Despite Crackdown: Meta

San Francisco: Meta on Thursday said that tens of millions of people in Iran are using Instagram despite government efforts to block the service due to months-long protests.

Iran has been rocked by citizen outrage since the September 16 death in custody of 22-yearold Mahsa Amini following her arrest for an alleged breach of dress rules for women.

"Instagram has been widely used by Iranians to shed light on the protests and the brutal response to them," Meta president of global affairs Nick Clegg said during a briefing.

"People have also shared Instagram footage of the protests with international media outlets, many of whom can't report directly from Iran."

Protests triggered by Amini's death resulted in authorities clamping down on speech and freedom of assembly, and limiting the use of the internet and apps such as Instagram, Clegg noted.

"Despite attempts to block Instagram, we're seeing tens of millions of people still finding ways to access it," Clegg said. Tactics to access the

image-centric social network service include using virtual private network software that encrypts and conceals online activity, said Meta head of security policy Nathaniel Gleicher. People in Iran are also using a

"light" version of the Instagram app released in Iran last year that is designed for places where internet bandwidth is meager, Gleicher added.

Meta has also put policies in place to remove posts that "outs" activists, journalists.

"It's an unfortunate reality that when a government wants to prevent its citizens from having access to public debate, they have a lot of tools in place that they can use to do that," Gleicher said during the briefing.

"But, we are seeing the Iranian efforts not be as effective as I'm sure they would like."

Since Amini's death, hashtags related to protests in Iran have been used on Instagram more than 160 million times, according to Meta.

Iran imposed sanctions this week on 36 individuals and entities from the European Union and Britain in reaction to similar measures against Tehran over its response to the protests.

Ex-Mastercard CEO Ajay Banga Nominated By US President To Lead World Bank

Washington: US President Joe Biden said Thursday that Washington is nominating former Mastercard Chief Executive Ajay Banga to lead the World Bank, after its current chief David Malpass announced plans to step down early.

The development lender has just started accepting candidate nominations in a process set to run until March 29, with the bank saying that women candidates would be "strongly" encouraged.

The president of the World Bank is typically American, while the leader of the International Monetary Fund is customarily European. Banga, 63, is Indian-American

and currently serving as vice chairman at equity firm General Atlantic. He was previously chief ex-

ecutive at Mastercard. Banga has "critical experi-

ence mobilizing public-private resources to tackle the most urgent challenges of our time, including climate change," said Biden in a statement.

Last week current World Bank President Malpass -- who was nominated to the post by Biden's predecessor Donald Trump in 2019 -- said he would step down nearly a year early, ending a tenure that was clouded by questions over his climate stance.

His term would originally have ended in 2024.

Banga's nomination comes amid a push for development lenders to revamp and address global problems like environmental issues more effectively. US Treasury Secretary Janet Yellen earlier said that lenders' core models, where countries borrow to make specific investments addressing developmental constraints, is "insufficient to meet the moment."

The United States is the World Bank's largest shareholder. Green transition -

Speaking to reporters, a senior US administration official said: "At Mastercard and General Atlantic, Ajay has made combating climate change and mobilizing private capital to help power the green transition a priority." "These are experiences and

priorities that will guide and drive his work in the years ahead at the World Bank," the official said.

In a separate statement, Yellen said Thursday that she applauded Biden's decision.

Banga "has the right leadership and management skills, experience living and working in emerging markets, and financial expertise to lead the World Bank at a critical moment in its history," Yellen said.

She added that his record of forging partnerships between the public sector, private sector and non-profits will serve him in helping to "mobilize the private capital and press for the reforms needed to meet our shared ambitions.

Deep Earthquakes Could Reveal Secrets Of The Earth's Mantle

The finding was made by measuring the lingering movement registered by GPS sensors on islands in the wake of a deep earthquake in the Pacific Ocean near Fiji. Published Feb. 22 in Nature, the study demonstrates a new method to measure the fluidity of the Earth's mantle.

"Even though the mantle makes up the largest part of Earth, there's still a lot we don't know about it," said Sunyoung Park, a geophysicist with the University of Chicago and the lead author on the study. "We think there's a lot more we can learn by using these deep earthquakes as a way to probe these questions." We still know surprisingly

little about the Earth beneath our feet. The furthest anyone has managed to dig down is about seven and a half miles before the increasing heat literally melts the drill. Thus scientists have had to use clues like how seismic waves move to infer the different layers that make up the planet, including the crust, mantle, and core.

One thing that has stymied scientists is a precise measurement of how viscous the mantle layer is. The mantle is the layer below the crust. It's made of rock, but at the intense temperature and pressures at that depth, the rock actually becomes viscous -- flowing very slowly like honey or tar.

"We want to know exactly how fast the mantle flows, because that influences the evolution of the entire Earth -- it affects how much heat the planet retains for how long, and how the Earth's materials are cycled over time," explained Park. "But our current understanding is very limited and includes a lot of assumptions."

Park thought there might be a unique way to get a measurement of the mantle's properties by studying the aftermath of very deep earthquakes.

Most of the earthquakes we hear about on the news are relatively shallow, originating in the top crust of the Earth. But occasionally, there are earthquakes that originate deep within the Earth -- down to 450 miles below the surface. These earthquakes are not as well-studied as shallower ones, because they're not as destructive to human settlements. But because they reach down into the mantle, Park thought they might offer a way to understand the behavior of the mantle.

Park and her colleagues looked at one particular such earthquake, which occurred off the coast of Fiji in 2018. The quake was magnitude 8.2, but it was so deep -- 350 miles down -- that it did not cause any major damage or deaths.

However, when the scientists carefully analyzed the data from GPS sensors on several nearby islands, they found the Earth kept moving -- after the earthquake was over.

The data revealed that in the months following the quake, the Earth was still moving, settling in the wake of the disturbance. Even years later, Tonga is still moving slowly down at a rate of about 1 centimeter per year.

"You can think of it like a jar of honey that slowly comes back to level after you dip a spoon in it -- except this takes years instead of minutes," said Park.

No Property Tax

Besides the property tax is to be assessed and paid on annual basis.

Elucidating further the Commissioner, Jammu Municipal Corporation, Rahul Yadav informed that the tax is progressive in nature with low tax on smaller assets and is linked to circle rates – lower the circle rate, lower is the tax liability of the owner. The tax also takes into account factors like age of the property, usage type and construction type etc to arrive on TAV for realistic capturing of value of property.

"Right now, they do not have money to sustain themselves, where will they pay tax? So, I will appeal to the government to hold it for four-five years till our economic situation gets better," he said.

"Let our tourism run smoothly for five-six years, our horticulture produce go to the market, our handicraft be exported, then perhaps we will be in a position to pay tax, " Azad added.

He said the government should have sympathy with the people and not form policies while sitting in offices, but by having discussions with the people.

The Jammu and Kashmir administration on Tuesday issued a notification for imposition of property tax in the union territory which will come into effect from the next financial year.

On the anti-encroachment drive to retrieve state land, Azad said the drive should be stopped. He also asserted that his government will re-implement the Roshni Scheme.

"It (anti-encroachment drive) should be stopped. If I form the government, then we will implement the Roshni scheme once again," he said.

The Roshni Act, officially known as Jammu and Kashmir State Land (Vesting of Ownership to Occupants) Act, 2001, was enacted during the regime of the then CM Farooq Abdullah. The law granted ownership of encroached land to encroachers to raise funds for different power projects of the government.

However, the law was implemented with few modifications in the tenure of Azad as chief minister from 2005-2008.

In 2014, the Comptroller and Auditor General's (CAG) report pointed out that many political persons from different parties had been benefited under the Act.

In November 2018, then governor Satya Pal Malik repealed the Act. On October 9, 2020, the High Court of J-K and Ladakh declared the Act "illegal, unconstitutional and unsustainable", and ordered a CBI probe.

Later, the government decided to retrieve such land.

the first time in J&K," Principal Secretary, Housing and Urban development department, H Rajesh Prasad, told reporters here.

He said that the step is for making municipal corporations and other bodies financially self-reliant. "It is a step for the benefit of the people."

"Better municipal services are expected to attract more investment and encourage more people to set up business in J&K. Revenue from property taxes will be used to improve infrastructure, build new parks, playgrounds, and maintain existing facilities," he said.

Since property tax is to be levied annually and can be paid in two equal instalments "it will not be a burden for the people" he said.

Prasad said municipal bodies have generated revenue of Rs 115 crore against operational expenditure of Rs 850 crore, which goes towards paying salaries and maintenance expenses.

He termed property tax one of the "essential pillars" of municipal financing world over.

"Tax rates in UT of J&K are notified in such a way that tax implications are progressive in nature with minimum implication to small businesses and Households," Prasad said, adding it is for the first time the Union Territory is introducing this tax and at a lower rate than its neighbours.

As it happens, Jammu and Kashmir is one of the last states or UT in India to levy a property tax, he said.

"Property Tax is linked with stamp duty tax of the area. So property valuation of different areas is captured differently with property in the old city area, or Sarwal, will be subject to lower property tax compared to upscale areas like Gandhi Nagar.

"Further, weightage to age of property, use type and construction type etc is used to arrive on Annual Taxable Value in a more comprehensive manner," Prasad said.

He said that under the new tax formula. residential houses with an area of up to 1,000 sqft will be exempt from property tax, while residential property with build up area of up to 1,500 square feet too will be given concession in relief for LIG and MIG category houses.

How Indian

Russia took everyone by surprise. Jiji along with several hundred students took an excruciating journey from Sumy to western borders after the war broke out in Ukraine.

The students were evacuated to India through 'Operation Ganga' conducted by the Indian government.

More than 17,000 Indians, mostly students, were evacuated from the war-hit Ukraine under the mission.

Several Indian medical students were left with no choice after their evacuation from Ukraine and have taken transfers to universities in other countries to continue their studies. Many have gone to Russia, Serbia, Uzbekistan,

and other European countries.

"The period after coming to India was very uncertain. We thought the war would end soon and we will be able to return. However, months passed and our student coordinator was also not giving straight answers," said Jiji.

Students have taken transfers to other universities through the academic mobility programme.

Last year in September, the Ministry of External Affairs and the National Medical Council (NMC) issued a notice through which the NMC would accept completion of their remaining courses in other countries (with the approval of the parent university/institution in Ukraine).

Jiji would complete her study in July 2023. "There are around 150 students in Russia that I

They put hoardings and banners welcoming them. They also posted photos of Indian students on their official Instagram pages.

One of the posts read: "150 Indian students from Ukrainian medical universities took transfers in Northern State Medical University,".

R B Gupta, president of the Parent's Association of Ukraine MBBS Students (PAUMS), claimed that around 2,500 students have gone back to Ukraine, and nearly 4,000 have taken transfers to other countries including Serbia, Russia and Uzbekistan.

'Those who have taken transfer are mostly fifth and sixth-year students as practicals are necessary. Around 3,000 students are still in India and taking online classes. While around 500 have changed streams also," he claimed.

Gupta, who for the last one year has been spearheading the campaign demanding onetime accommodation of evacuated students in MBBS colleges in India, said he has no hope that any help would come from the government side.

Gupta said his son, who is in his third year of MBBS, has taken transfer to a Serbian university after waiting for several months.

Ameen, 23, is in the last year of his MBBS and has taken transfer to a university in Uzbekistan.

Reflecting on the last year, Ameen, who goes by his first name, said: "It was hectic in terms of mental pressure regarding our studies. Mostly because we were uncertain about our online degree from Ukraine." Ameen came to Tashkent on December 10 to resume his study. He is pretty content with his decision to transfer.

"I decided to study in Uzbekistan because of the academic mobility programme. At the time, that was the only safe option according to NMC guidelines for Ukraine returnee students," he said.

Asked whether the transfer programme was heavy on his family's pocket, he said: "We had to pay extra fees for the continuation of the mobility programme but the university fee hasn't changed that much."

"Mobility is actually a choice. We can either go to Ukraine, study online or choose mobility. We have to pay 1,500 dollars extra for this. But you can be sure that you are getting enough practical classes," he added.

Among those who are still in India taking online classes is Kanishk, a second-year student. He is still uncertain whether to opt for transfer or go back to Ukraine.

"I am not sure. Right now I am taking online classes. We had a pretty rough year. Nobody is helping us. We are somehow managing through online classes. You can't learn to treat people through online classes," he pointed out.

Russia's Sports Exile Persists 1 Year After Invading Ukraine

KYIV: One year after the invasion of Ukraine began, Russia's reintegration into the world of sports threatens to create the biggest rift in the Olympic movement since the Cold War.

Russia remains excluded from many international sporting events, but that could soon change. Next year's Paris Olympics are fast approaching and qualifying events are under way. The International Olympic Committee is working to bring athletes from Russia and ally Belarus back into competition, but not everyone agrees.

If Russian athletes are to return to competition, the sports world must resolve two key issues that became clear in the days after the invasion: How can Russian athletes return without alienating Ukrainians? And what can be done about the Russians who support the war? As the first battles raged,

the Ukrainian fencing team refused to compete against Russia at a tournament in Egypt, holding up a sign reading: "Stop Russia! Stop the war! Save Ukraine! Save Europe!"

A year later, one of the biggest obstacles to a Russian return to sports is Ukraine's insistence it could boycott rather than risk handing its enemy a propaganda success or further traumatising Ukrainian athletes affected by the

war. Other European countries have also spoken of boycotting the Olympics if Russians are allowed to participate.

The last major Olympic boycotts came four decades ago when the United States and more than 60 allies skipped the 1980 Moscow Games. The Soviet Union and its allies retaliated by boycotting the 1984 Los Angeles Olympics.

The actions of specific athletes are a separate issue. Russian gymnast Ivan Kuliak taped a "Z" symbol to his chest, mimicking a marking used on the country's military vehicles, while standing on the podium next to the Ukrainian winner at an event in Qatar last March. He was banned for a year.

The IOC now says it will not support the return of any Russian athlete who has "acted against the peace mission of the IOC by actively supporting the war in Ukraine," but hasn't defined what that means in practice.

Sports organisations took swift action last year in response to the Russian invasion. A day after tanks rolled into Ukraine, Russia was stripped of the right to host the Champions League final in men's soccer and the Russian Grand Prix in Formula One. After four days, the IOC recommended excluding Russian and Belarusian athletes from events "to protect the integrity of global sports competitions and for the safety



of all the participants."

The Russian men's national soccer team was in the World Cup playoffs at the time, hoping to qualify for last year's tournament in Qatar, but Poland refused to play them. Russia was then excluded from the competition – four years after hosting the 2018 tournament and reaching the quarterfinals.

As the Paris Olympics come into view, the IOC has shifted its emphasis to what it says is its duty to avoid discriminating against anyone based on nationality, and to create a

path for Russians and Belarusians to compete as neutral athletes without national symbols. Safety concerns might be avoided, the IOC says, if Russia and Belarus were to compete in events in Asia, including Olympic qualifiers at the Asian Games in China.

The IOC points to tennis, where the men's and women's professional tours have allowed individual Russians and Belarusians to compete without national symbols. Belarusian player Aryna Sabalenka won the Australian Open last month.

Even in tennis, though, Russia and Belarus are excluded from national team competitions like the Davis Cup and Billie Jean King Cup, and they were also barred from playing in last vear's Wimbledon tournament.

Russia and its athletes have been at risk of being banned at each Olympics since the steroid-tainted 2014 Sochi Winter Games. Previously, it was because of Russian state-backed doping and then the country's attempt to cover up evidence of that scandal.

Ukraine says more than 220 of its athletes have been killed in the war, and hundreds of sports facilities lie in ruins. It points to precedents like the exclusion of Germany and Japan from the 1948 Olympics following World War II.

"If, God forbid, the Olympic principles are destroyed and Russian athletes are allowed to participate in any competitions or the Olympic Games, it's just a matter of time before the terrorist state forces them to play along with the war propaganda," Ukrainian President Volodymyr Zelenskyy told a summit of sports ministers and officials from more than 30 countries this month.

That summit produced a joint declaration full of skepticism for how the IOC's proposed neutral process could work, with particular concern about whether the many Russian athletes with ties to the military could compete. The IOC said on Tuesday it found those questions "constructive" but that the nations did not address its concerns about possible discrimination.

The clock is ticking for the IOC to find a solution for Russian and Belarusian athletes to have the opportunity to qualify for the Olympics. Qualifying has already begun in many sports and will start soon in

others.

While Russians have been largely excluded over the last year, Ukraine's athletes have had some notable successes on the world stage. Oleksandr Usyk, who took up arms in defense of Ukraine shortly after the invasion, returned to boxing and defended his heavyweight title against Anthony Joshua in August. High jumper Yaroslava Mahuchikh won a world championship silver medal in Oregon and Maryna Bekh-Romanchuk won the European triple jump title.

The Ukrainain men's soccer league resumed in August with some games interrupted by air-raid warnings – and Shakhtar Donetsk held its own in the group stage of the Champions League with a win over German club Leipzig and a draw against Spanish powerhouse Real Madrid.

In a statement on Wednesday marking the one-year anniversary of the invasion, the IOC didn't mention its efforts to reintegrate Russia and Belarus, but said the Olympics could promote "peaceful competition" between athletes from the likes of North and South Korea, or Israel and Palestine.

'Peace-building efforts need dialogue," the IOC said. "A competition with athletes who respect the Olympic Charter can serve as a catalyst for dialogue, which is always a first step to achieving peace." (AP)

Women's T20 WC: India Falter As **Australia Reach 7th Straight Final**

CAPE TOWN: India wilted under the pressure of a knock-out game yet again after skipper Harmanpreet Kaur's freak run out as defending champions Australia entered their seventh successive Women's T20 World Cup final with a five-run win here on Thursday.

India's shoddy fielding and catching allowed Australia to post a challenging 172 for four after Meg Lanning opted to bat in the semifinal.
