Property Tax Will Be Implemented In Consultation With Public: LG

Jammu- Amid outrage over the imposition of property tax, Jammu and Kashmir Lieutenant Governor Manoj Sinha on Saturday defended the move and said it will be implemented in consultation with the general public.

Property tax will ensure nancial self-sustainability financial of cities and improvement of public amenities, he said in a statement.

The Jammu and Kashmir administration on Tuesday ordered the imposition of property tax in municipal areas from April 1, drawing strong protests from people from almost all walks of life. Political parties are demanding an immediate rollback of the order.

Various organisations, including the Jammu Bar Association, have threatened to intensify the agitation despite repeated assurances by the administration that property tax



imposed in the union territory is the lowest in the country.

As per the government notification, the tax rates will be five per cent of the taxable annual value for residential properties and six per cent for commercial properties.

"Implementation (of property tax) shall be done in consultation with the general public.

7 Labourers From J&K Die In **UP Explosion**

Lucknow: In a tragic incident, at least seven migrant labourers hailing from Jammu were killed and more than 30 sustained injuries after a compressor exploded in cold storage in Uttar Pradesh's Meerut district on Friday.

Quoting an official a report said that the explosion took place in the afternoon and at least 40 workers were present on the site.

The deceased have been identified as Balwant, Baldev, Balbir Singh, Sat Pal, Ramesh Lal, Kalu all residents of Udhampur and Hoshiywar Singh of Ramban.

The labourers had come to Meerut to pick potatoes in the cold storage. Most of them were aged between 35 and 50 and were the sole breadwinners of their families.

According to the police, the incident took place in Daurala town. The deceased were inside the cold storage when a wall collapsed on them during the explosion. However, preliminary investigation revealed that the incident took place allegedly due to leakage of ammonia gas inside the cold storage that was used to store potatoes.

District administrative and police officials along with a team of the National Disaster Response Force (NDRF) have rushed to the spot, the police told reporters, adding that 27 people had been rescued from under the rubble and efforts were on to find others. The injured | More on P6

Jammu: The Jammu and Kashmir High Court has ordered the transfer of the trial in a nine-vear-old molestation case against a former Congress minister from a court in Srinagar to Jammu on his request, saying it cannot be stated that his apprehension of not receiving a fair trial in the valley is "unfounded".

health ter Shabir Ahmad Khan was booked for molestation on February 6, 2014 on the complaint of a woman doctor. the wife of a prominent separatist leader, at Shaheed Gunj

police station in Srinagar, which had led to his resignation the next day.

Khan filed a petition in the high court, seeking transfer of his trial from the court of Chief Judicial Magistrate, Srinagar to any other court of parallel jurisdiction in Jammu on the plea that he is apprehensive of a fair and impartial trial given the threat to his lawyer and surcharged atmosphere in the jam-packed court during the proceedings.

'...it is a fact of common knowledge that incidents of attacks on mainstream politicians and the people who do not subscribe to the separatists ideology are still taking place in Kashmir Valley.

"Therefore, it cannot be stated that apprehension expressed by the petitioner to his life at Srinagar while facing trial before the court is unfounded," Justice Sanjay Dhar has said in his four-page order on Wednesday.

The case was registered un-der Section 354 (assault or criminal force on a woman with the intention to outrage her woman) and Section 509 (word, gesture or act intended to outrage the modesty of a woman)

Sino, Pak Ties Worry US, Says In 'Serious Talks' With India

Washington: The US is deeply concerned that the loans being given by China to India's immediate neighbourhood - Pakistan and Sri Lanka - may be used for coercive leverage, a senior State Department official has said.

Concerning Chinese loans to countries in India's immediate neighbourhood (Pakistan, Sri Lanka, Nepal), we are deeply concerned that loans may be used for coercive leverage,' Donald Lu, Assistant Secretary of State for South and Central Asia, told reporters ahead of the India trip of Secretary of State Antony Blinken.

The top American diplomat is travelling to New Delhi on a three-day official visit from March 1 to 3.

Mr Lu said that the US is talking countries in the region comprising India to take their own decisions and not feel compelled by any outside partner.

"We are talking to India, talking to countries of the region



about how we help countries to make their own decisions and not decisions that might be compelled by any outside partner, including China," Mr Lu said.

Earlier in the day, Pakistani Finance Minister Ishaq Dar announced that the Board of China Development Bank (CDB) has approved a USD 700 million credit facility to the country.

Responding to a question Mr Lu said that there has been a serious conversation between India and the US on the issue of China.

"We have had serious conversations about China, both before the latest scandal over this surveillance balloon but in the aftermath. So, I fully expect those conversations will continue," he said.

Mr Lu. in response to a question, insisted that Quad is not a military alliance.

"The Quad is not, in fact, an organisation that is against any single country or group of countries. The Quad stands for trying to promote | More on P6


"It is a welcome step

Valley's Token Power Supply Dips To 1 1/2 Hr A Day Tower Restoration Yet To Pick Up

SRINAGAR - Despite of-ficial claims to the contrary, there was no perceptible im-provement in valley's power supply. Even after making, three units of the Pampore gas turbine operational since yesterday, the net avail¬ability of electricity to the consumers averaged a little lover one and a half hour in 21 hours. Something unprec¬edented, indeed.

Official sources told Kash-mir Observer the valley had been divided into 18 groups to whom electricity was being provided for one hour in every 18 hours by rotation. Follow¬ing the availability of another 60 mw of power from the three units of gas turbine, a 'generous' relief of two hours in given five days. This works out to a total of 8.30 hours power supply in 120 hours.

With the power minister, S S Slathia's claim of "suspected militants' having blasted three transmission towers in Banihal area emphatically blasted even by official circles, people have plamed the government of en¬gineering the total breakdown to deprive the valley of even the bare minimum of power during winter months to the advantage of warmer Jammu.

According to reports, even the divisional commissioner, Khursheed Ahmad Ganai, did not rule out the involvement of some contractors and power de-velopment department (PDD) officials in the blasting of the transmission towers. Nothing could be more damning for the power minister who has alleg-edly been employing circumlo¬cution and subterfuge to the hilt to escape the blame for the val¬ley's worst ever power crisis.

Meanwhile, according to CNS, the work on restoration of the transmission towers at Sher Bibi and Bonakot had not picked up yet A group of offi \neg cials from the power grid corpo \neg ration of India (PGCI) and the power development department (PDD) besides some labourers are reported to be camping at the two sites without taking up any actual work. The official claims of the work going on 'war footing' have proved to be a hoax, the report said.

Rajinder Singh reports from Jammu: Even the gov¬ernment promised improve-ment by Saturday with the temporary restoration of 220-KV tower, the power minis¬ter, S S Slathia told Kashmir Observer the valley would have to face power crisis for another week. He said resto-1 ration work was going on 'war footing' but it would take about two month. However, temporary restoration will be completed by February 27. He said 370 mw of power not be¬ing supplied to the valley at present was being saved with effect from February 17.

Downtown 'Kot' Laments

Notes on the Dying Gasps of Srinagar Downtown

o invert a saying , twist and graft it onto a theme that is close to my heart and that speaks to me, "You can take a boy from downtown Kashmir but you can't take away downtown from the boy". Yes, of course, I am not a boy but a man but my recollections of downtown Srinagar are fresh and vividexactly the same when family moved from downtown (Wattal Kadal, apparently a rendition of Walter Kadal- a bridge named after Walter Lawrence, a British surveyor and scholar who wrote an incisive but sympathetic book,' The Valley of Kashmir'). I have lived in many parts of the world, been exposed to different cultures and ways of life but I am and will remain the quintessential downtown kot.

I recall my downtown as a maze of alleys running into alleys, cobble stoned narrow lanes that criss-crossed each other, beautiful houses made of small bricks, and at times having sloping terraces where flowers would bloom in spring and summer. I recall my downtown as not a place on a map or an urban agglomeration but as a 'living space' where everyone knew everyone, by their first or last names and oftentimes with a nickname. I recall my downtown as that space where camaraderie and bonding came naturally to its denizens. I recall my downtown as a space where if any member of a household would fall sick or die, the whole mohalla(neighbourhood) would grieve. I recall my downtown as a space where post school, after my mother would feed me tsot(bread) dipped in Kahwa, I would dash to see my friends and fly kites, play marbles and explore its maze of alleys and lanes. I recall my downtown as a space where the local, mouth watering treats for children and adults alike were the Basrekh- hollowed round balls with one side open, bound by a dense coat or ground sugar paste, the Monje gooil(dried and fried lotus stems with a coating of flour, the tille karre(fried chickpeas) and so on. I recall my downtown as a space where the Kabaadi Waala(scrap dealer) would yell and women folk would haggle with him and sell him junk. I recall my downtown as a space where most of its women folk would spin Pash-



mina on their Yaendars (spindles) in their spare time for what was once a feature of downtown(Pashmina or Cashmere production and trade). I recall my downtown as the city of seven bridges connected by the then clear and gushing Jhelum river and its tributaries. My downtown was a space where grandmothers would, in winter, rub glycerin over us kids' blistering skin to heal it and narrate stories of the Djinns, the Pari's (fairies) and the Pasikdhar(the guardian angel who stood guard over each home). I recall my downtown as a space where during winters, when there was sparse electricity, we would under the glow of the lantern put small potatoes in the kangri(Kashmiri firepot with a cane frame), when the popping sound of the potato would mean it was roasted amd ready to be peeled and eaten, when fights(good natured ones) would break out between siblings over who would first eat the potato. I recall my downtown as a space where every denizen of the place would have 'teh' - a certain attitude and temperament (harmless) which loosely denoted

pride and a disposition which did not countenance the pride of anyone else. I recall my downtown as a space where the call to prayer, the azaan was a marker of time where even the raucous 'waane pyand'(young men sitting at and around corner shops and regaling each other with typical downtown wit and humor) would fall silent in respect.

Importantly, downtown Kashmir has been a site of great literary and mystical(Sufi) insights and experiences. Shrines dot the landscape of this heritage locality of ours and great litterateurs and Sufi poets were born and reached efflorescence and the apogee of their work(s) here. Some notable names include luminaries like Samad Mir, Shamas Faqeer, Hamdi Kashmiri, Rafique Raaz, G N Firaq and contemporarily, Ghulam Nabi Shahid, the late Rahman Rahi and the best ever oral historian Kashmir has ever produced, the one and only Zareef Ahmad Zaraeef.

The recollections can go on and on. And I can wax lyrically nostalgic about downtown Kashmir. But the

sad, prosaic fact that makes my eyes moist is that my or our downtown is dying. Hitherto the centre of gravity of Kashmir in every sense of the termeconomic, religious ,social, political, cultural and so on- which set the tone for the rest of Kashmir, profound sociological, cultural, economic, demographic changes are 'conspiring' to kill our downtown. In place of beautiful but old structures that exuded warmth have mushroomed ugly concrete structures. The local 'kaka's (loosely translated as uncle) dukaans(shops) have been replaced by ugly 'shopping complexes' The breakdown of the traditional family structure has meant that the well off have migrated to the suburbs leaving downtown to the not so well off. The traditional sweets of Kashmir's downtown- the monji gooil, the tille karre, the basrekh- are almost relics now. The camaraderie and bonding that was the hallmark of our downtown while it still exists to a small extent, is giving way to distance and less warmth. While delineating this 'list' which breaks my heart can also go on and on, downtown Kashmir's slow death must concentrate our minds. Obviously, downtown Kashmir as it was cannot be recreated, restored nor brought into existence in its pristine form. But it can stay and remain alive, in our hearts and minds. It is here that the spirit of downtown Kashmir can actually be re-enacted and restored for, in the ultimate analysis downtown besides being a real physical space is a state of the mind, a temperament and attitude. Let us then resolve to render downtown Kashmir as a lived reality of and in our minds. Let us make haste slowly and make downtown Kashmir once again part and parcel of our psychoemotional worlds. Yes it is cliche but I will conclude to underscore its urgency: make downtown real. Tomorrow may be too late!

Post Script: 'Kot' is a Kashmiri word that loosely translates as boy.

Putin cut himself loose towards the end of his speech by dropping a bombshell that Russia is suspending its participation in the New START treaty, which is its last nuclear weapons pact with the US. But the foreign ministry in Moscow has since clarified that Russia will continue to observe the terms of the treaty till 2026.

For Biden, with his rating dropping within Democratic Party, the steady decline of support in the public opinion for the war in Eurasia underscores that his narrative about democracy vs. autocracy is not taken seriously even in American opinion outside the neocon circle. Certainly, Biden wouldn't want the burial of the New START treaty as his presidential legacy.

For Putin too, although his stunning popular rating touching 80 percent makes his re-election in March next year a certainty, should he decide to seek another term, there are domestic pressures. The Russian public is politically erudite and questions will rise as time passes, given the slow pace of the Ukraine operations. Although Russian economy has done well to withstand the western assault, it remains an amalgamate of a siege economy and a war economy. Putin himself is acutely conscious of the need to assuage public concerns.

The Russian strategy all through has been to "grind" the Ukrainian military and force Kiev to negotiate but the US is only now realising that this was in reality a war of attrition. Biden has announced a new package of military assistance for Ukraine to the tune of \$460 million, which will include ammu-

nition for the HIMARS multiple launch rocket system as well as 155-millimeter and 120-millimeter shells for artillery. But, significantly, he did not make any promises regarding long-range missiles or fighter jets — although he predicted that the coming days will be difficult for Ukraine and pledged that the US will do everything necessary so that "Russia pays a high price."

To quote Jens Stoltenberg, NATO secretary-general, what is unfolding is "a war of attrition... a battle of logistics; as in how do you get enough stuff – materiel, spare parts, ammunition, fuel – to the front lines." But it can also mutate since the Western bloc is unable to define its end goal in Ukraine.

Putin warned that western weapon supplies to Kiev will trigger consequences. "The longer the range of
the Western systems being brought
to Ukraine, the farther away from our
borders we will be forced to push the
threat," he said. Plainly put, Russian
forces may create a buffer zone in the
region west of Dnieper River. Putin
called out the Western elite to realise
that "it is impossible to defeat Russia
on the battlefield."

This is the nearest he came to speaking about the future trajectory of the special operations. To be sure, Russia is closely watching that the support for the war in the US is steadily on the wane and this can impact Biden's political calculus as a divisive election campaign takes over. Of course, the Biden

Administration has secured substantial authorised appropriation enabling it to continue the high levels of support to Ukraine through the remaining 8 months of the financial year ending in October, and there is no question that the Western allies will also supplement.

That said, Biden had to settle for a modest roadshow with the Bucharest Nine in Warsaw on Tuesday, whereas, a grand spectacle of Old Europeans of Western Europe descending on Kiev/ Warsaw along with him would have been befitting the occasion. Arguably, it carries a certain message on "western unity."

Indeed, Putin's decision to play the New START card is timely. This is a display of "smart power" — war by other means. On the outside, this is an aggressive bid to engage Washington diplomatically, and at the very minimum intends to compel the US to exercise self-restraint while fuelling the war. Russia's permanent representative to international organisations in Vienna, Mikhail Ulyanov clarified on Wednesday that "The situation can be 'reversed' if the United States shows political will and makes honest efforts for the sake of general de-escalation and creation of conditions for the comprehensive operation of New START."

The hawkish US Under Secretary of State for Political Affairs Victoria Nuland reacted in an interview with Tass on Thursday that Washington is ready to start talks with Russia on the New START treaty "tomorrow" if Moscow

is prepared for it. "The US and Moscow have responsibilities to the world to keep our nuclear arsenal safe and secure, and we should do our jobs," she pointed out.

Nuland is usually not comfortable with such conciliatory idiom on matters regarding Russia — even bracketing her country with a power she regards disdainfully as a lower form of life in the global power dynamic. It only underscores Biden's desperate keenness to salvage the New START treaty in the fulness of time.

Indeed, there is the European dimension. The implications for European security are profound, as Putin is demanding that future nuclear arms control talks should also include the UK and France. Putin's announcement dramatically brings the nuclear threat to Europe's doorsteps.

Will the UK and France agree to bring their nuclear weapon stockpiles under international treaties? The US abandoned the INF (1987) without regard for European concerns. And, now, New Start Treaty is becoming a casualty of US' confrontation with Russia. Already, there is simmering discontent in Europe that the US has been the sole beneficiary of the Ukraine war. These undercurrents cannot be ignored.

How does all this add up? The expert opinion is that by March, the training will be completed for the new Russian recruits following the partial mobilisation of military reservists in September. Thus, aside the accent on

the "demilitarisation" of Kiev's forces in Donbass, the Kharkov, Zaporozhya and Kherson oblasts are also in Russian sights. Biden's dangerous incitement of Moldavia on Tuesday puts Moscow on guard as regards Ukraine's border with Transnistria — and a reminder that control of Odessa is absolutely vital.

In sum, Biden Administration is in a quandary since the facts on the ground show no tangible gains for its decision to wage a proxy war with Russia. Ukraine lost more territories following its abandonment (under US pressure) of the draft agreement negotiated in Istanbul in March. Four Ukrainian oblasts have become part of Russian Federation and Moscow is unlikely to part with them.

Biden knows only too well that Ukraine will overnight collapse without US military and financial backing. The rationale behind such a costly enterprise is debatable. The stigma of defeat will sink the current regime in Kiev, too.

The western plan, therefore, is to support another Ukrainian "counteroffensive" to make some, any territorial gains. But the chances of Kiev reclaiming the territories under Russian control are virtually nil. Meanwhile, war has created dynamics in the Sino-Russian strategic partnership.

Putin confirmed that Moscow is expecting a visit by the Chinese President Xi Jinping after the sessions of the highest deliberative and legislative bodies of China — the Chinese People's Political Consultative Conference and the National People's Congress — which will begin in Beijing on March 4 and 5. Conceivably, the launch of any large scale Russian offensive will remain in suspended animation until then.

Sleep and Stay Fit

hen we think of what makes athletes great, few of us would think that sleep might play an important role. But many of the world's best athletes say sleep is an essential part of their training routine and key in helping them to perform well.

Serena Williams, for example, strives to get eight hours of sleep each night. NBA star LeBron James aims for eight to ten hours per night, while NFL legend Tom Brady says he goes to bed early and gets at least nine hours of sleep.

It's no wonder, since sleep plays a key role in metabolism, the growth and repair of tissues (such as our muscles), and ensures memory, reaction time and decision making are all working optimally. All these processes impact sporting performance.

But it isn't just athletes whose athletic performance can benefit from proper sleep. Even amateur gymgoers can maximise the benefits of exercise for their fitness and health by getting enough good sleep each

Here are just some of the ways sleep benefits your fitness:

AEROBIC FITNESS

Exercise is great for improving aerobic fitness. It improves both aerobic capacity (being able to run or cycle faster with a heavier load) and efficiency (meaning your body requires less oxygen to run or cycle at the same pace).

One contributing factor to improved aerobic fitness is the function of the body's mitochondria. Mitochondria are small structures within the cells of the muscles that are responsible for creating the energy the muscle requires during ex-

Research shows that poor sleep (getting only four hours a night for five nights) can reduce the function of mitochondria in healthy partici-

pants. High-intensity interval training was shown to alleviate these impairments in the short-term (over a five-day period). But, it's currently unclear how these impairments would influence adaptations to exercise in the longer term, so it's best to get a good night's sleep if improving aerobic fitness is one of your goals. **MUSCLE GROWTH**

Sleep is also important if you're looking to build strength or muscle.

Muscle growth occurs when new proteins are added to the muscle structure – a process known as "muscle protein synthesis". This process is stimulated by exercise and food (specifically protein) intake, and can last at least 24 hours after a workout.

Research shows that even just a few nights of insufficient sleep reduces the muscle protein synthesis response to nutrient intake. This suggests that poor sleep may make it harder for the body to build muscle.

ANABOLIC HORMONES

Hormones act as chemical messengers that contribute to a range of functions throughout the body, such growth and development of tissues. Hormones which are involved with these building processes can be termed "anabolic" hormones.

Two anabolic hormones - testosterone and growth hormone, which are released during sleep – may also

be important for recovery from and adaptation to exercise. These hormones have multiple roles in the body, and are linked to improved body composition (lower body fat and higher muscle mass). A higher amount of muscle mass and lower body fat can be beneficial for exercise and health.

When sleep is restricted to only five hours per night (similar to the amount of sleep many working adults get), testosterone levels are reduced in healthy young men. Sleep restriction of a similar duration also alters the release of growth hormone during sleep. While more research is needed, there's a potential that these hormones may play a role in mediating the relationship between sleep and fitness, due to their link to improved body composition.

REFUELLING AFTER EXERCISE

Exercise often uses glucose (sugar) as a fuel source. Muscles store glucose from the foods we eat in the form of glycogen to meet the demands of exercise. Replenishing glycogen stores after exercise is a key part of the recovery process. It can take up to 24 hours to fully replenish stores, with the correct nutrient intake. The hormone insulin can be needed for muscles to absorb glucose in order to make glycogen.

Numerous studies show that in-

sufficient sleep reduces the effectiveness of insulin. This could impact on the body's ability to replace glycogen stores, with one study revealing reduced muscle glycogen stores after a night of sleep deprivation.

Depleted glycogen stores can impair subsequent exercise performance in the short and long term, so it is important to ensure glycogen stores are replenished after exercise.

HOW TO SLEEP WELL

Sleep is clearly important for your fitness, so here are some ways to ensure you get proper sleep each night:

- Develop a consistent bedtime routine: do things before bedtime that help you relax and wind down – such as reading a book or listening to relaxing music. A hot shower or bath before bed can also be beneficial as the drop in body temperature afterwards can help you to
- fall asleep quicker. Create a good sleeping en**vironment:** exposure to light during the night can reduce sleep quality, so try to block out as much light as possible. Aim to keep the room cool, but not too cold. An environment that is too hot or too cold can disrupt
- sleep quality. Be physically active during the day: research shows that physical activity is beneficial for sleep quality, so try to include some exercise or physical activity in your day.
- Keep a consistent sleep **schedule:** this will help to regulate your sleep-wake cycle, which has been linked to improved sleep quality.

If you are trying to improve your fitness make sure you're getting enough good quality sleep - aim for at least seven to nine hours of sleep each night.

Hormones and Hygiene

ormonal fluctuations and its effect on the physiology of the individuals has often been discussed in ms and newspapers. However, less attention has been paid to the subject of oral health, which is equally important, during such discussions. It thus becomes pertinent that some time is spent delving on what hormonal changes imply for certain sets of individuals, in particular. Individuals born with a womb, (women, non-binary individuals, trangender men among others) experiencing hormonal changes may be more susceptible to oral health problems . These hormonal fluctuations may include puberty, menstruation, or when using oral contraceptives, during pregnancy and at menopause. The people experiencing such biological cycles need to pay extra attention to their oral health during these stages as hormones affect the body's response to toxins that result from plaque build up leading to the development of periodontal disease.

For example, during Puberty- raging hormones can leave a teenager's gums red, swollen and bleeding. This is known as Gingivitis. Some teenagers may also find themselves developing canker sores which usually heal on their own.

For menstruators, there is an increase in levels of hormone progesterone due to which some individuals may experience oral changes that can include bright red swollen gums, swollen salivary glands, and development of canker sores or bleeding gums. Menstruation gingivitis usually occurs a day or two before the start of period and clears up shortly after period has started.

On the other hand, birth control pills (hormonal contraceptives) contain progesterone, which increases the level of that hormone in the body. These hormone changes can bring about an inflammatory response in the gums leading to sore, swollen or bleeding gums.

According to Journal of ADA (American Dental Association) women who use oral contraceptives are nearly twice as likely to experience dry socket after having a tooth

periods when a mentruator's body is in hormonal hyperdrive. Changing hormonal levels accentuates the gingival response to plaque. Nearly 60-75% of pregnant people have gingivitis that occurs when gingival becomes red and swollen and sometimes has a raspberry like appearance. There is an increased tendency to bleed, however it is usually painless. In some cases, the inflamed gingival forms discrete tumour-like masses which are referred to as pregnancy tumours. It is most common between second and the eight months of pregnancy (first and third trimester respectively). Partial reduction in severity of gingivitis occurs by 2 month postpartum, and, after 1 year, the condition of the gingiva is comparable to that of patients who have not been pregnant.

Approximately 40% of pregnant women have some form of periodontal disease (inflammatory disease of tissues surrounding and supporting the teeth). They may also be at risk for cavities due to changed eating habits.

Further, during menopause, the usual rhythmic hormonal fluctuations of the menstrual cycle end. There is a huge change in menstruating individual's lives, and this has direct implications for oral health. The oral symptoms include altered taste, burning sensation and increased sensitivity to hot and cold foods. The gingival and remaining oral mucosa are dry and shiny, they vary in colour from abnormal paleness to redness, and they bleed eas-

ily.

There are two critical changes to be aware of: Dry mouth and Bone loss. Dry mouth, also known as xerostomia, can result in the development of tooth decay and gum disease because saliva is not available to moisten and cleanse the mouth. It is important to know that dry mouth can also result from many prescription and over-thecounter medications.

The gradual loss in estrogen that occurs with menopause also puts older individuals at risk for loss of bone density (a condition called osteoporosis) which can lead to tooth loss. Receding gums, which expose more of the tooth surface to potential tooth decay, can be a sign of bone loss in the jawbone.

RELATION OF ORAL HEALTH PROBLEMS TO OTHER HEALTH

PROBLEMS Mouth is a gateway to the body. A healthy mouth can help you maintain a healthy body. Researchers have discovered a connection between declining oral health and underlying systemic conditions. Oral bacteria and the inflammation associated with a severe form of gum disease known as periodontitis might contribute to various diseases and conditions, including Endocarditis, Cardiovascular diseases and Diabetes as research shows that people who have periodontitis have a harder time controlling their blood sugar levels. Regular periodontal care can improve diabetes Further, pregnant individuals

with periodontal diseases have been reported to be at increased risk of adverse pregnancy outcomes, including preeclampsia, preterm delivery and low birth weight. There is a two-fold increased risk for preeclampsia (hypertensive disorder) in the presence of periodontal disease and it is a major cause of perinatal and maternal morbidity and mortality. Other conditions that might be linked to oral health include pneumonia and other respiratory disorders, rheumatoid arthritis, eating disorders and an immune system disorder that causes dry mouth (Sjögren's syndrome).

PREVENTION OF ORAL HEALTH

Hormones are a fact of life, but they don't have to interfere with an individual's ability to maintain a healthy smile at every age and stage of life. The best ways to keep your teeth and gums healthy involve basic care habits like brushing your teeth at least twice daily (preferably with a fluoride toothpaste). Floss your teeth at least once a day, clean your tongue to remove bacteria at least once a day, rinse mouth with antiseptic mouthwash at least once a day. When it comes to diet, decrease intake of sugars and eat a high-fibre, low fat diet that includes plenty of fruits and vegetables; drink fluoridated water, avoid tobacco products; replace toothbrush every three to four months; have your teeth cleaned by a dental professional every six months.

Taking everything account, the broader societal impact of improving oral systemic health cannot be overemphasized. We need to only educate ourselves and implement small logical changes in our practice.

"And then, in November you heard the Indian Defense Minister say the threat to use nuclear weapons by Russia is totally unacceptable and at odds with the basic tenets of humanity. So, I don't particularly see a reluctance to use the word 'war.' I think they use it all the time," Mr Lu said.

Ill-Gotten Assets Of 02 **More Drug Peddlers Seized IN Shopian**

SHOPIAN: Acting tough against drug traffickers, District Magistrate Shopian today ordered seizure/ freezing of illegally acquired properties of two more drug traffickers in the district.

The action has been taken under the provisions of Chapter VA of the Narcotic Drugs & Psychotic Substances Act, 1985. As per the orders issued today, the said properties shall not be transferred or any other use undertaken on it without the permission of the District Magistrate.

The Competent Authority under Narcotic Drugs and Psychotropic Substances (NDPS) Act, Shopian, accorded a seal of approval to freezing of illgotten properties of two more

drug peddlers who were given reasonable time period to prove credentials and produce the requisite documents that substantiate the property as legal.

The frozen property includes illegally acquired buildings and land from the proceeds of narcotics trade. The properties were purchased from ill-gotten money of drug trafficking within the last six years in the name of accused persons as well as in the name of their kith and kin.

The district administration has issued notices to several persons involved in the drug trafficking in the recent past and asked all of them to disclose the source of the acquisition of the properties and has in previous week frozen assets of 05 drug traffickers in the first instance.

PDP Takes Out Protest March Against Property Tax In J&K

SRINAGAR: Peoples Democratic Party (PDP) on Saturday took out a protest march here to demand roll-back of the Jammu and Kashmir administration's decision to impose property tax in the Union Territory.

The Union Territory administration on Tuesday ordered the imposition of property tax in municipal areas from April 1. The tax rates will be five per cent of taxable annual value for residential properties and six per cent for commercial properties, it stated.

Dozens of People's Democratic Party (PDP) activists led by Suhail Bukhari, its chief spokesperson, took out a protest march from the party headquarters near Sher-e-Kashmir Park here.

The party activists raised slorans against the imposition of the property tax and demand-

ed its roll-back. The protesters tried to march towards the Lal Chowk city

centre but were stopped by a contingent of police near the Traffic Headquarters. They later turned back and dispersed.

Bukhari alleged that the government was trying to economically weaken the people of Jammu and Kashmir.

"First, our political rights were taken away, then democracy was buried here, poor people were harassed in the name of demolition and their houses bulldozed.

"Now the property tax. The economic situation in Jammu and Kashmir has become worse in the last five years. There is no employment (generation), the industrial sector here is weak,'

The PDP chief spokesperson said the administration should have held people's hand "but, contrary to that the BIP government is trying to further the

troubles of the people". He demanded that the government roll back the decision.
