## **Two Militants, Soldier Killed In Awantipora**

## Police Says Slain Militants Were Involved In KP Bank Guard's Killing

Srinagar: Barely two days after a Kashmiri Pandit bank guard was killed in Pulwama district evoking sharp condemnation, police on Tuesday claimed to have shot dead two of his killers in an encounter in South Kashmir's Awantipora, in which a soldier also lost his life.

In a bravely executed operation, a police spokesperson said, a joint team of police, army and paramilitary CRPF launched a cordon and search operation (CASO) in Padgampora village of Awantipora on Tuesday morning.

During the searches, he said, militants hiding inside a mosque opened indiscriminate fire upon search parties. In the initial exchange of fire, he said, two Army men sustained grievous injuries while neutralizing one militant on the spot.

"One of the jawans later on attained martyrdom. Extreme caution and limited firepower was used in view of the sacred precincts. Civilians praying inside were also evacuated on time preventing any collateral damage," the spokesperson said. The joint team, he said, re-sumed search for the second militant, who had taken shelter inside a bathroom of an adjacent building

"Again caution was exercised and 14 civilians were rescued from the place before he was neutralized," he added.

## **Antarctic Glaciers Flow Faster In Summers, Exhibiting Seasonal Behaviour: Study**

Glaciers along Antarctica's coastline are flowing faster in the summer because of a combination of melting snow and warmer ocean waters, said researchers in a new study. On average, the glaciers, or giant blocks

of moving ice, travel at around one kilometre a year.

But the study has found a seasonal variation to the speed of the ice flow, which speeded up by up to 22 per cent in summer when temperatures are warmer. This gives an insight into the way cli-

mate change could affect the behaviour of glaciers and the role they could play in raising sea levels, the study said. The paper is published in the journal

Nature Geosciences. Up to now, study of the rugged Antarctic peninsula has been limited because of the difficulties scientists face getting on to the

glaciers to conduct fieldwork. But from space, advances in satellite technology are revealing new insights into the speed at which the glaciers are moving and draining water into the surrounding ocean.

The Antarctic Peninsula is the largest reservoir of frozen water on Earth. It is estimated that between 1992 and

2017, melt water from the glaciers increased



around the Antarctic alters during colder and warmer periods.

"One of the important findings of this study is that it reveals how sensitive glaciers in Antarctica are to the environment.

"We have known for a long time that glaciers in Greenland have a seasonal behaviour, but it is only now that satellite data has shown similar behaviour in Antarctica," said first author of the study, Ben Wallis.

The Antarctic Peninsula is the most northern and warmest region of Antarctica. It has a 1,000 km long mountainous spine, similar to the length of the east coast of Great Britain, and home to a rich marine ecosystem of seals, penguins and whales.

Along the west coast of the peninsula, the glaciers drain ice from the ice sheet directly into the Southern Ocean.

Analysis of the satellite data showed that the glacier speed-up occurs in summer as snow melts and the temperature of the waters in the Southern Ocean rise.

It is thought that water from the melting snow acts as a lubricant between the ice sheet and the underlying rock. As a result, friction is reduced and the speed at which the glaciers slide increases, the study said.

In addition, the warmer waters of the Southern Ocean erode the front of the moving ice, which reduces the buttressing forces it exerts to resist the ice flow, the study said.

"The Antarctic Peninsula has seen some of the most rapid warming of any region on Earth. "Continuing work like this will help gla-

ciologists monitor how quickly change is occurring, enabling accurate assessments of how Earth's ice will respond to climate change," said Anna Hogg, Associate Professor in the Institute for Climate and Atmospheric Science at Leeds and an author of the paper.

make a payment online, he ends up paying nothing" Adil said.


However, these aren't the only issues creating hurdles in the way for a cashless economy. Experts say, Kashmir has a long way to go for a cashless future.

Even though there are many street vendors in the summer capital who use the digital payment system, there are many who are hesitant to use online payments because of illiteracy and fear of losing money.

It is pertinent to mention, vendors in India constitute around 11% urban workforce.

It is estimated that around 10 million vendors are adapting to the changes in consumer payment methods.

In the financial year 2016, 5% vendors used online payment platforms, which increased to 15% of vendors in the FY2021 and it increased to 20% in FY2022.

supply, authorities gave it an quit burial this evening. Even after the power minister, S S Slathia, directed continued 4-hour daily (7 pm to 11 pm) operation of gas turbines to improve power availability, the 5-unit Pampore turbines screeched to an abrupt halt following orders from above.

According to reports authorities were forced to resort to 'distress load shedding of ru¬ral areas to enable maintain¬ing minimum supply to the city and some major towns besides the essential services. The 'revised' programme is to be further revised in keeping with the reduced availability ordered by the power managers in Jammu. Reports said the revised schedule, drawn up for 10 days, February 26 to March 7 had been worked out on the premise that about 100 megawatts of power would be available in ad-dition to that imported from northern grid and local genera¬tion. The valley was divided into two groups. A and B. Calculat¬ing a net availability of 430 mw to 460 mw, the revised schedule on even ' odd basis envisaged a fairly improved supply position.

Meanwhile, according to sources, the power generation from Uri project had improved over the past few days following a marginal rise in the water level of the river. From a meagre 50 mw, it shot up to 140 mw on Saturday and Sunday. Even to¬day, it hovered around 120 mw. The generation from the Lower Jhelum hydel project and other stations had also gone up ap¬preciably

Contrary to government's claims of heavy dependence on imports from the northern grid, and even the common belief, sources said, the valley exported 40 mw of power to northern grid for a brief while on Saturday and Sunday However, the PDD preferred to keep a tight lid over the report to avoid any embarrassment

On Saturday, the power minister had himself told Kashmir Observer that uni¬form supply would be ensured between rural and urban areas of the valley with the avail¬ability of 200 mw to 230 mw from northern grid. He had assured supply for nine hours on an average However, he okayed a further improvement to make it about 12 hours in 24 hours for which he ordered continued operation of (.he gas turbine.

Interestingly, the official handout issued after Slathia's Pampore visit yesterday boastfully screamed, "gas turbine in operation despite whop¬ping daily expenditure" Reminis¬cent of Mirza Galib's famous cou¬plet ke merey qail ke baad us my jafa se tauba / hai us zood pashaiman ka pashaiman hona," he (Slathia) expressed regrets on the inconvenience faced by the people in the valley due to blast¬ing of the transmission towers.

Now that the 'generosity' has been unceremoniously withdrawn the minister's (read government's) regret has proved to be shockingly short-lived

Even as, in the absence of permanent restoration, the 220-K V and 132-KV transmission lines may prove to be too fragile, like a slender thread, to ensure sustained import of power, a question mark will continue to hang over the state government's role in ensuring an equitable distribution of electricity between Kashmir and Jammu

# Martin Cooper, Father Of Cellphone, Sees Dark Side But Also Hope In New Tech

olding the bulky brick cellphone he's credited with inventing 50 years ago, Martin Cooper thinks about the future.

Little did he know when he made the first call on a New York City street from a thick gray prototype that our world – and our information – would come to be encapsulated on a sleek glass sheath where we search, connect, like and buy.


He's optimistic that future advances in mobile technology can transform human lives but is also worried about risks smartphones pose to privacy and young people.

"My most negative opinion is we don't have any privacy anymore because everything about us is now recorded someplace and accessible to somebody who has enough intense desire to get it," the 94-year-old told The Associated Press at MWC, or Mobile World Congress, the world's biggest wireless trade show where he was getting a lifetime award this week in Barcelona.

Besides worrying about the erosion of privacy, Cooper also acknowledged the negative side effects that come with smartphones and social media, such as internet addiction and making it easy for children to access harmful content.

But Cooper, describing himself as a dreamer and an optimist, said he's hopeful that advances in cellphone technology have the potential to revolutionise areas like education and health care.

"Between the cellphone and medical technology and the Internet, we are going to conquer disease," he said.



It's a long way from where he started.

Cooper made the first public call from a handheld portable telephone on a Manhattan street on April 3, 1973, using a prototype device that his team at Motorola had started designing only five months earlier. Cooper used the Dyna-TAC phone

to famously call his rival at Bell Labs, owned by AT and T.

It was, literally, the world's first brick phone, weighing 2.5 pounds and measuring 11 inches. Cooper spent the best part of the next decade working to bring a commercial version of the device to market.

The call help kick-start the cell-

phone revolution, but looking back on that moment 50 years later, "we had no way of knowing this was the

historic moment," Cooper said. "The only thing that I was worried about: Is this thing going to work?' And it did," he said Monday.

While blazing a trial for the wireless communications industry, he hoped that cellphone technology was just getting started.

Cooper said he's "not crazy" about the shape of modern smartphones, blocks of plastic, metal and glass. He thinks phones will evolve so that they will be "distributed on your body," perhaps as sensors "measuring your health at all times.'

Batteries could even be replaced by human energy.

'The human body is the charging station, right? You ingest food, you create energy. Why not have this receiver for your ear embedded under your skin, powered by your body?" he imagined.

Cooper also acknowledged there's a dark side to advances – the risk to privacy and to children.

Regulators in Europe, where there are strict data privacy rules, and elsewhere are concerned about apps and digital ads that track user activity, allowing tech and digital ad companies to build up rich profiles of users.

"It's going to get resolved, but not easily," Cooper said. "There are people now that can justify measuring where you are, where you're making your phone calls, who you're calling, what you access on the Internet.'

Smartphone use by children is another area that needs limits, Cooper said. One idea is to have "various internets curated for different audiences.'

Five-year-olds should be able to use the internet to help them learn, but "we don't want them to have access to pornography and to things that they don't understand," he said.


The inspiration for Cooper's cellphone idea was not the personal communicators on Star Trek, but comic strip detective Dick Tracy's radio wristwatch.

However, "there are many things that I have not yet learned," he said. "I still don't know what TikTok is."



eta-owned messaging platform WhatsApp is reportedly rolling out a sticker maker tool on iOS, which will allow users to convert images into stickers.

The new feature eliminates the need for third-party applications to create stickers, reports WABetaInfo.

After extracting a subject out of an image, users just need to paste it within a chat to create a custom sticker from an image.

If the feature is available, the platform will instantly turn the image into a sticker that can be added to the user's collection of stickers.

This tool was available to some users in the past few days, however, now it is rolling out to everyone on iOS 16.

Users now don't have to switch between different applications or tools to create and use their own stickers.

"This definitely saves time and makes the process of creating and using custom stickers faster," the report said.

Meanwhile, earlier this month, the messaging platform had added some new stickers to its avatar sticker pack for Android and iOS, following its announcement of the ability to create personalised avatars.

The "My AI" chatbot is available as an experimental feature for Snapchat+ subscribers and will be rolling out this week, the company said in a blogpost on Monday.

"My AI can recommend birthday gift ideas for your BFF, plan a hiking trip for a long weekend, suggest a recipe for dinner, or even write a haiku about cheese for your cheddar-obsessed pal." Users can also name the chatbot and customise the wallpaper for their Chat.

My AI, like other AI-powered chatbots, is prone to hallucinations and can be tricked to say almost anything.

While My AI is built to avoid any sort of biased, inaccurate, dangerous or misleading content, mistakes might however happen.

Also, users can press and hold any message from My AI to provide feedback.

"Please be aware of its many deficiencies and sorry in advance! All conversations with My AI will be stored and may be reviewed to improve the product experience," the company said.

"Please do not share any secrets with My AI and do not rely on it for advice," it added.

## LoC Villagers Look For Support To Market Traditionally Prepared 'Kalakand'

**RAJOURI:** Residing along the barbed wire fence of the LoC in Jammu and Kashmir's Nowshera sector, villagers engaged in producing sweet milk cakes, locally known as 'Kalakand', are eyeing government support to market it in and outside the Union territory.

Restricted by limited scope of sale of their produce, the villagers said, majority of households involved in the production of Kalakand often

have to throw away their surplus in the fields.

Kalakand is prepared by processing cow milk on wood fire in Sehar, Makri, Namb and Kadali villages, located ahead of the Anti-Infiltration Obstacle System along the Line of Control (LoC) in Rajouri district.

"Milk cakes produced in our village are of the best quality but unfortunately, we do not have any scope of sale in outer markets. Our sale is mostly in Army areas on the LoC," Kamal Parkash, a resident of Sehar village who makes a living by selling the sweet, told PTI.

He said the government should take steps to provide adequate scope to milk cake producers to sell their produce so that they can make a living properly.

"Our village is on the LoC facing Pakistan, and there are very few opportunities to earn a livelihood. Proper marketing of Kalakand can boost the economy of our area as a large number of people are engaged in its making," Parkash said.

More than a dozen forward posts of the Pakistani army are visible from the villages in the area. A majority of the houses here have splinter marks, reminiscent of the times when cross-border shelling was a routine affair before a renewed ceasefire agreement came into place two years ago.

Parkash said a majority of the households have milk-producing animals and they have to throw away surplus milk.

Vicky Kumar, another local resi-

dent, said they collect cow milk from houses in the village.

"The cow milk is processed for hours over wood fire and a meagre quantity of sugar is added to it. The product is healthy as no preservative, flavour or any other substance is added," he said, adding that despite a lot of effort, "we are struggling to get customers and a proper value for the product".

He said the majority of villagers in the area are dependent on agriculture and face various hardships due to bad roads, poor healthcare and strict security restrictions.

Army personnel guarding the border also lauded the villagers for producing "pure and very tasty" sweets. Senior scientist and head of the Krishi Vigyaan Kendra, Rajouri, Arvind Kumar Isher said his office was working on a project to ensure the sale of Kalakand outside LoC villages. "The need of the hour is that the

produce of the villagers be made available in markets of big cities like Jammu," he said.

## **First Phase Of Smart Traffic Management System Completed In Jammu**

JAMMU: The first phase of the intelligent traffic management and surveillance system (ITMSS) has been made operational in Jammu, a step that would help authorities better manage vehicular flow and catch violators.

The system is operational at 12 major locations in the city and activities are being monitored from a traffic department-managed integrated command and control centre.

"Operations (of the ITMSS' first phase) have started in Jammu," Vehant Technologies chief executive officer (CEO) and cofounder Kapil Bardeja said.

The project is being implemented in phases with system integrators, he said.

'The project was initiated in November 2022. Installations are going on and depending upon the installations with system integrators, the project will be completed soon,' Bardeja, whose firm has been tasked with implementation of the ITMSS in Jammu. He added that software solutions have already been deployed at some locations.

In the first phase, the ITMSS has been deployed and made operational at 12 major locations, including at Zorawar Singh Chowk, railway station, RBI Turning, G L Dogra Chowk, Panama Chowk, Jammu University Gate, Last Morh, Main Stop Gandhi Nagar, R S Pura airport, Gujjar Nagar Chowk and

Valmiki Chowk, officials said. The intelligent traffic management and city surveillance system will be in place at 38 junctions having traffic signals, once the project is completed



roads safer, they said.

The ITMSS automatically encrypts and transfers data of violation to a centralised server at the Traffic Police headquarters, the officials said.

"The system also facilitates echallan generation along with photo and video evidence which is then sent to the violator's mobile phone through SMS. The system is capable of 24X7 operations," an official said.

This solution will have an overview camera to capture the zoomed-out picture of an entire area when there has been a red-light violation, he said.

The officials said the network will read the number plate of an offending vehicle and store it in the database.

Based on the information received from these cameras, an adaptive traffic-control system can also alter traffic signal cycles in real time to respond to changing traffic conditions. Once fully-operational, the system is expected to cut down waiting time at traffic signals by almost half, they said.

"The red light violation detection system will allow traffic police to keep a track on violators and generate e-challan," an official said.

The system would consist of camera mounted sensors for better detection of traffic





## Triumph over Covid-19 pandemic

s the Covid-19 pandemic finally on its way out? It seems so. India recorded a negligible 169 new Covid cases in the last 24 hours, while the active caseload rose to 2,257. Similarly, there have been far fewer cases in Jammu and Kashmir. India has witnessed a drastic decline in the number of cases. This is despite the fact that China was recently overrun by a major Covid-19 outbreak leading to the deaths of reportedly thousands of people. The sudden surge in infections followed after the country ended its zero-Covid strategy and lifted the sweeping lockdowns following public protests.

That the infections didn't spread to India shows that the country has developed a certain herd immunity. One of the reasons could be that India experienced a nationwide explosion of infections during the virulent Delta wave in the beginning of 2021. Thousands died as a result. This, together with a successful vaccination programme, may have gone some way to build mass immunity among the people.

However, this is no reason to let our guard down. The virus is now a part of our lives and it has already become endemic. Besides, the new variants of the virus keep triggering fresh outbreaks. More so, in China where recent upsurge in infections is traced to the new Covid variants. Experts have now expressed fear that the virus may mutate its way out of vaccine immunity. Former World Health Organisation (WHO) chief scientist Soumya Swaminathan, Swaminathan has called for continued surveillance to avoid another wave that could potentially kill millions of people like Covid-19 did during the second wave that was dominated by the Delta variant of the virus.

But the overall trend remains one of a steep decline in cases. Though there is some cause for optimism here, things could still turn messy if the existing pandemic-related precautions are thrown to the winds. The Omicron wave early last year was gigantic in nature but its fallout was cushioned by the relatively moderate nature of the virus. The continuously mutating sub-variants of the Omicron virus could, however, in time trigger yet another wave. So people have to continue to take care.

Meanwhile, we can celebrate our triumph over the Covid pandemic with the least number of Covid cases and fatalities to date. In Kashmir, there is a greater need for precaution since it is a tourist place. Though the drastic reduction in new cases and fatalities is a heartening development, the situation can stay this way if people continue to be mindful of the virus. The end of the pandemic is also a boon for tourism in the union territory which has witnessed a bumper 2022 with over one crore people visitors. We can't afford to let this momentum slow down.

# "Going Global?"

**Apparently,** it seems that Saudi Arabia has embarked on an ambitious project to diversify the economy away from oil and shed its image as a conservative, closed-off state. Besides promoting new narratives of development and progress. Additionally, it has serious regional Saluaries and the second secon

over 19 sq. km. in capital Riyadh Authorities claim that plans have been created keeping sustainability and

environment in mind. The project would include green spaces, walking and cycling pathways, to improve the quality of life by encouraging active, healthy lives and social interaction.

#### What is Mukaab?

The main feature of the project has been named The Mukaab, a gigantic cube structure has been described as the future 'face of the city', and critics say it may even be the face of a new Saudi Arabia, focussing and generating more revenue through tourism than petroleum. At present, the plan is to fill the cube with 100,000 residential units as well as 9,000 hotel rooms.

In addition, it will also have over 80 entertainment and cultural venues. A renowned musemersive 'gateway into another world' that is completely powered by the latest digital, virtual, and holographic technologies.

In recent years, Saudi Arabia's abundance of oil money has sparked the design of some absolutely insane architectural projects. In 2021, MbS announced his \$500 billion futuristic Neom city in the northwest of the country, with promises of robot maids, flying taxis, and a giant artificial moon. And last year, he unveiled a giant linear city, The Line, which aims to stretch over 106 miles and house 9 million people. The one-trillion-dollar project will essentially be its own massive city in the middle of a desert once it's finished.

#### A New Kaabah?

Authorities claim that the project will add 180 billion riyals (\$48 bn) to the Saudi economy and "create 334,000 direct and indirect jobs," though the cost of the gargantuan project has not been mentioned.

New Murabba (square) and The Mukaab were widely ridiculed by social media users, both within and outside Saudi Arabia, apart from a large number of Muslims all across the globe, as soon as the plans were announced. Additionally, it has serious regional competition from neighbouring Dubai and the Qatari capital Doha, both of which have for decades tried to position themselves as regional tourism and investment hubs.

The kingdom already has an \$800 billion plan to double the size of the capital in the next decade, as well as transform it into a cultural and economic hub for the region, according to Saudi media.

Over the years Saudi Arabia, which has seen an economic boom and a desert country transformed into a modern developing country was essentially based on the petroleum industry.

In addition it earns billions in revenues through the Umrah and Hajj pilgrimages. In recent years, it has made travel to the kingdom friendlier for the pilgrims and expansion plans in the two holy cities of Makkah and Madinah are underway to accommodate more number of tourists.

As a strategy it also is promoting the Umrah pilgrimage more than the annual Hajj, as the revenues through Umrah pilgrims flows throughout the year and the government is not forced to spend more on providing facilities and security to the Umrah pilgrims, whose stay is much shorter as compared to the Hajj pilgrims. So far, the government was focussing more on promoting tourism, but with the ascension of MbS, it seems to have changed tracks. As his critics say he is pursuing a growth plan which seems more unIslamic than his parleys with the Israelis.

In its last meeting, held just a few days after the Union budget, the monetary policy committee of the RBI had voted to raise the benchmark repo rate by 25 basis points. Yet despite this dissent within the committee, the tone of the policy statement was marked ly hawkish. The MPC noted that calibrated action was warranted to break the persistence in core inflation. As per the detailed minutes of the MPC meeting released on Wednesday, the members who had voted in favour of the rate hike felt that it was premature to pause at this juncture. This suggests that despite expectations that the MPC had neared the end of the rate hike cycle, it is perhaps not done hiking rates.

Inflation data for January, released just a few days after the MPC meeting had concluded, seems to justify the hawkishness. Retail inflation, as measured by the consumer price index, rose to 6.52 per cent in January, up from 5.72 per cent in December, reversing the declining trend seen in the preceding months. Much of the surge was driven by food inflation — the consumer food price index rose to 5.94 per cent, up from 4.19 the month before, driven largely by cereals. Equally worrying, core inflation has continued to remain sticky. Inflation remained elevated in clothing and footwear, household goods and services, personal care effects and education, signalling that price pressures remain fairly broadbased across the economy. This surprise uptick in inflation is likely to complicate the policy choices before the MPC members when it meets next in the first week of April.

As monetary policy acts with a lag, Varma and Goyal have advocated for pausing at this moment to observe the full impact of the policy tightening so far on the economy before taking any further action. Cumulatively, the MPC has tightened rates by 250 basis points since the beginning of this rate hike cycle. However, with some analysts now expecting inflation to remain above the 6 per cent upper threshold of the RBI's inflation targeting framework in February as well, the hawks, who are looking for signs of a definitive decline in inflation, are likely to gain an upper hand. Since ages, women have been a victim of misconceptions surrounding menstruation which has been an impediment in their growth at the workplace. They face discrimination and are contrived to suffer menstrual pain in silence at the beehives. The severity of periodrelated pain and cramps (dysmenorrhea) experienced by women add to their mental strain. While this leave policy is not widespread world over, it is gaining traction in some foreign

countries like, Spain, Japan, Taiwan, etc., where legislations are already in vogue which entitle employees to paid menstrual leave. Providing "period leaves" for women can help companies promote gender equality and support the well-being of their women employees.

SEEKING FEEDBACK

Once you have a draft of RP, show it to an xperienced person like your professo

mission from International University of Japan. My response: restrained excitement with a bout of anxiety. Why? Because I had received such confirmations previously, and I had come to realise that they don't mean much without a scholarship. Of course, unless you want to self-finance your foreign degree. A lot of students take a loan and enrol in expensive programs abroad. They work part-time jobs to compensate for the lack of stipend. But not everyone can afford. Scholarship is freedom, while selffinancing international students are 'cash cows' for many European universities.

In February 2012 I received an email from University of London: "We are delighted that you have chosen to study at SOAS and very pleased to make you an offer of admissions to a Taught Masters programme." I was tempted to take a loan and study one year MSc State, Society and Development at this prestigious British university. But I decided against that after weighing pros and cons of such a move. I received a similar offer of admission from University of Edinburgh for MSc Nationalism Studies. I applied for Principal India Scholarship and Edinburgh Global Masters Scholarship in October 2011 to make it possible for me to study in Edinburgh. However, in June 2012, I received any email from them: "Competition for the awards was intense and I am afraid that I have to inform you that your scholarship application has not been successful." Earlier in April 2012, Central European University informed me that they will be unable to offer a place of study to me, adding that "Admission to Central European University is highly competitive, with over 5,000 individuals applying for approximately 600 student places for the academic year 2012/2013. As a result. the university is simply unable to offer admission to every qualified applicant."

It is hard luck sometimes, but I also know that I had made mistakes and taken the process casually. I realised guidance was important to mitigate the errors. Mantra was to pursue the whole thing systematically. My mentors were generous enough to help. They had secured funded PhD admissions in the US and knew what works. I drafted my Research Proposal and Statement of Purpose, emailed these documents to my mentors for their feedback and suggestions. I reworked the weaker areas in my application. In July 2012, I was selected for Konosuke Mastushita Memorial Foundation (KMMF) fellowship to study master's in international

I recounted my story because some aspirants out there might relate with it. It is to show to those who may embark on this journey soon that failure is part of the game but perseverance pays, that road to scholarship is paved with some hiccups but with right approach and proper guidance you shall reach your destination.

#### THE FIRST STEPS

Many undergrad students toy with the idea of studying abroad but most hesitate or feel dread when it comes to starting the process. Unfortunately, colleges in Kashmir do not prepare them for the task and they rely on information available online. Very few are able to find a mentor who can guide them properly. When I began my journey more than a decade ago there were not many resources, but today there are Kashmiri-led initiatives that help and guide aspiring students to apply for scholarships and funded admissions.

I along with my colleagues at Pend Online have conducted workshops about this. We have collaborated with Wath, an educational platform started by Adeeba Tak (University of Pennsylvania) and Moin Khan (Princeton University). Adeeba and Moin have provided many students structured guidance to get admissions in the US colleges. Similarly, KG-Kashmir Guidance, a Facebook group, have similarly mentored dozens of students since last six years. All these initiatives work pro bono.

Before you approach anyone for guidance. you must have basic documentation ready. Also bear in mind that the process will cost money, somewhere between 15000-40000 rupees depending on where you are applying.

First, apply for a passport. If your passport expires in a year, apply for renewal. Second, take English language test, such as IELTS or TOEFL. Third, scan your passport, IELTS/ TOEFL certificate, marks cards and degree certificates along with any work experience related documents.

You should prepare well ahead of time. Give yourself at least a year of preparation. Remember securing admission and securing funding are two separate processes (I will come to the latter in a while) and it will consume your energies. If you want to apply for an M.A programme in International University of Japan, the course begins in September (fall-term) and you need to start applying around December a year ahead. The application deadline is January, February and March and the admission results

#### **PREPARING CRUCIAL DOCUMENTS**

Statement of Purpose and Research Proposal are two most crucial documents that largely determine the application outcome at graduate level. Your CV, grades and work experience is important but these two are read first by the selection committee.

Much material is available online on how to write a good research proposal, but surfeit of information creates an overwhelming situation for many students. So, let me briefly summarize the key points. When you write your RP, the first paragraph should clearly state what you want to explore. In this paragraph your research question should come out explicitly. Write in simple and formal English. You should tell your reader why your topic is important and what new significant contribution your research will make to the existing literature on the topic. For this you must know what has been already written about the topic and what areas have not been sufficiently covered. Next you should explain which theoretical framework informs your research. You also need to clearly state the methodology you will be employing in your study. For example, semistructured interviews, surveys or archival research? In other words, how and where you are going to get your data from and how your proposed methodology will enable you to address your research questions. In the final section, you must outline a rough schedule of your research: what will you do in each year of your PhD. Divide years into quarters and fill each quarter with concise description of what you will do. For example, 'Jan-Apr 2023: Presentation of preliminary research

applies for PhD research proposals).

You can find sample PhD proposals online but remember template for each institution may differ. So be diligent. Choose wisely when searching online. You should be able to separate wheat from the chaff. I would recommend university websites like this one (https://www.ucl.ac.uk/ioe-writing-centre/ plan-your-assignment/write-a-researchproposal) or this (https://fass.open.ac.uk/ sites/fass.open.ac.uk/files/files/research/ sample-research-proposal.pdf)

It is always better to visit the website of your target university, because they usually put guideline documents on how to write a good research proposal. Each university has different word limit requirements. You must strictly follow it. If they ask for 2000 word RP, don't overwrite. They will see your discipline. You must tailor your RP according to the requirements of your target university.

#### **BACKGROUND CHECK**

There are two ways to write your RP. Either you chose your own topic which you really want to do or you develop a topic which matches the research interest of the faculty member at your target department or university. If you decide the former, find a professor with research interest closer to your topic. After all, most professors take those prospective students under their wings who they think would contribute to their own research area.

Once you identified your prospective supervisor, read his/her profile carefully (you will find the details in the 'People' or 'Faculty' section of their department's website). Go through a couple of his/her recent articles to see what kind of scholarship he or she has produced and what he or she has been researching lately.

Once you have done the background checking, compose a clear and professional email and send it to that professor (I will get to email etiquettes later). If the professor replies and shows interest in your topic, then you have accomplished an important milestone.

It is always advisable to apply to at least five to six universities, because you will be competing at the international level where far many prospective students apply to the same department. That is why you should keep your options and cast your net wide. For this you will need to spend a great deal on internet looking for the right match in each target university.

your friend or acquaintance who you think can help. Don't feel shy asking for the feedback. Shyness and inhibition is a big handicap and must be overcome to get things done. There is no harm asking for help, either you get a response or you are ignored. But at least you tried. It is also not inappropriate to remind the person whom you have sent your proposal. Sometimes people forget. Revise your RP by incorporating suggestions. Sometimes not all suggestions can be accepted, that is fine. Include what you think is useful to improve the proposal. Proofread it a couple of times. A polished document reflects well on you.

#### PREPARING YOUR CV

Some professors may ask for the CV or curriculum vitae (Greek for 'course of one's life'). Don't rush. Send only a latest and polished CV. Understand the difference between an academic CV and a regular job hunting resume (French for 'a summary'). Academic CV may be two to three pages long where you list all your academic achievements and highlight any work experience relevant to the proposed research. If you have any publications, put them in your CV. But remember only the relevant publications. If you have already accomplished something, such as articles in respected newspapers and magazines and work experience with a reputed organisation, put it there. Overall, your CV should complement and connect with your SOP and RP. It should help you market your candidacy by showing required skills for the position. Be attentive to fonts and alignment. Your CV should look neat and clear. Latest MS Word has readymade templates but I will recommend this link for you to see how you can frame your academic CV (https://www.ucl.ac.uk/careers/sites/careers/files/phd-applications. pdf) or this one (https://www.ucc.ie/en/ media/support/careers/CVGuideforPhDand-PostdoctoralResearchers.pdf)

## Decks Cleared For USD 100 Million Support By IFAD In J&K

**Jammu:** Lieutenant Governor, Manoj Sinha, gave a green signal to pose "Competitiveness Improvement of Agriculture and Allied Sectors Project in Jammu and Kashmir (JKCIP) to the Department of Economic Affairs (DEA) for financing through International Fund for Agricultural Development (IFAD) for project implementation in J&K.

The project shall contribute to the sustained increase in incomes of rural households by improving pre-production, production and post production verticals of agriculture. The project objective is to improve the competitiveness of the famers through a value chain approach with emphasis on export of high value agricultural commodities and development of business incubation centers and start-up support.

C o m p e t i t i v e n e s s Improvement of Agriculture and Allied Sectors in the Union Territory of Jammu and Kashmir (JKCIP) comprises of 4 components which inter alia includes value chain support with export focus, incubation and start-up support, support to vulnerable communities and project management. The project implementation would spread over 7 years (2023-2030) across all districts of J&K.

"The project will have a number of positive outcomes which will further complement the growth of agriculture & allied sectors in J&K, including export promotion of potential agricultural commodities and GGAP practices that would encourage export promotion like GI tagging, promotion of niche crops, certifications, quality control, laboratory/logistic support, branding facilities, marketing platforms and development of an organized value chain", said Atal Dulloo, Additional Chief Secretary (ACS), Agriculture Production Department.

"The project will also support activities focusing on tribal and other vulnerable communities which inhabit some of the most vulnerable landscapes such as hillsides, rangelands, semi-arid and arid lands and rely on climatesensitive natural resources to make a living. IFAD shall promote environmentally sustainable and climate resilient agricultural practices for them", he added. Implementation of JKCIP is a

Implementation of JKCIP is a part of the government's larger efforts to look beyond the objectives of Holistic Agricultural Development Plan (HADP) to capture the opportunities in global trade by tapping the competitive advantage of J&K viz agro-climatic diversity, monopoly in production of default organic crops (Walnut, almond, cherries), year-round vegetable production, niche crop advantage & pristine climate which catalyzes the opportunity to export high value agricultural commodities. Besides provisions of HADP, concerted measures shall be implemented through JKCIP to create an enabling environment to reform agricultural sectors and

better price realization. APD in collaboration with the Apex Committee under the chairmanship of Dr Mangla Rai has prepared an export promotion plan which is scheduled for ratification with the Apex Committee during 1-3 March, 2023 at SKUAST-Jammu. The plan after ratification shall construe an integral part of the IFAD project. The project shall also en-

courage complementarily and convergence with the Holistic Agriculture Development Plan through identification of common activities for financing with focus on augmentation of livelihood of tribal and other vulnerable communities. Another major goal of the IFAD project is to establish incubation centers to undertake skilling of more than 2.5 lakh entrepreneurs targeted under HADP projects, besides giving adequate focus on extension of support for training of trainers, demonstration set ups, entrepreneurship development and facilitating partnership with research institutions like ICAR, NFDB, NDDB. It shall also enable &foster establishment of agri start-ups.

The project includes a range of interventions to support commercialization & sustainability of agriculture through promotion of 300 new agritech start-ups, establishment of 60 vegetable, 117 Aromatic/ Red rice, Guchi, Kashmiri Chilli, saffron and medicinal plant production clusters besides establishment of 20 vegetable seed, 20 potato seed and 40 oil and pulse seed clusters. The project aims to create 6 mini-Centers of Excellences with 24 satellite centers for niche agri products and 4 mini-Centers of Excellences for fruit and nut crops besides establishment of 3 Export Hubs and 2 Business incubation centers.

Additionally, it aims to establish 60,000 integrated farming models for fringe and nomadic communities and establishment of 200 horticultural nurseries. The project would also undertake GI tagging, aggregation, processing and marketing of at least 6 agriculture and minor forest produce.



# **IND vs AUS:** India Thinking Of Simulating English Conditions In 4th Test

**INDORE:** India are on course to reach their second straight World Test Championship final and if they end up winning here, a pace-friendly track could be laid out in the final game of the series in Ahmedabad to prepare for the summit clash in London in June.

Before the start of the Border-Gavaskar trophy, India needed to beat Australia 3-0 or 3-1 to qualify for the WTC final and keep the destiny in their own hands.

India skipper Rohit Sharma doesn't want to jump the gun but, ahead of the third Test beginning at the Holkar Stadium on Wednesday, he said the team has already spoken about simu-lating English conditions in the fourth and final game against Australia.

There is a strong possibility that India might end up facing Australia in the WTC final.

"It will be a different ball game (facing Australia in England) for both teams, actually. There is definitely a possibility of that (Ahmedabad as preparatory game for WTC final). We have already spoken about it. We need to get the guys ready for it," Rohit said in a media interaction.

The WTC final will be played at The Oval in London from June 7-11, right after the IPL. Rohit Sharma said Shardul Thakur becomes an important member of the side in overseas conditions.

"The important one is Shardul Thakur, because he comes into the planning for us. We don't know how ready he is since he has just got married (laughs). We don't know how many overs he has bowled. But that thought process is definitely there.

"If we get the result we want here



(Indore), we might think of doing something different in Ahmedabad for sure.

"But we are not there yet. We have to win this game and then talk about it. That'll be the right thing to do," he said.

#### "YOU ARE NEVER IN ON THESE WICKETS"

India are well on their way to their 16th straight series win at home. Rohit feels reaching the WTC final will be a big achievement for his team, as winning even at home has not been easy.

"Yes there are home conditions but they are challenging conditions; it is not easy for the batters to score runs consistently." Australia have collapsed in the second innings of both the Tests and Rohit said it shows how hard it is to play in Indian conditions. "Yeah....that's the beauty of this game and the pitches we are playing on. It can happen to us as well, not just them. I played 200 balls in Nagpur and never felt set. It just takes one ball to grip or keep low and you are out. On pitches like this, you are never in.

"Yes, we have quality spinners who can change things around just like that but that does not give us the guarantee that we are going to win the Test or roll them over in one session. We have got to keep the discipline going," he said.

Rohit promised that the spinners will keep coming at the Australians relentlessly as the visitors look to find ways to slow down the momentum generated by Ashwin and Co.

"It comes very naturally to (Ravindra) Jadeja. Sometimes it is difficult as captain. If you want to push a fielder a couple of yards behind, Jadeja is already running in. It is a very valid point. You don't want to give the opposition time to think what they want to do. These are small tactical things that are very important," said Rohit.

Having scored the only hundred of the series, Rohit is expecting more runs from the top order and wants the lower-order comprising Jadeja, Axar Patel and Ashwin to carry on in the same vein.

"Last game specifically after 139 for seven, to get to 260 was a great effort. In this team, Axar, Jadeja and Ashwin bat in the lower order but Axar when he plays domestic cricket he bats at five. They all are quality batters. It doesn't matter whether runs come from top or lower order, the end result for the team is what matters. We are in a stage we can create that depth in our batting.

'Yes the runs have not come from the top order as expected but the quality they bring to the table that is what matters to us," said the skipper.

#### **"TEST MATCHES SHOULD BE ORGANISED EVERYWHERE IN COUNTRY**"

The crowd turnout in the first two Tests made a good advert for Test cricket and a big crowd is expected too on day one of the third Test here. When he was captain, Virat Kohli

wanted Test cricket to be played in five centres around the country but Rohit said it should be taken "everywhere'

"All the Test centres we are playing in, we have got decent crowds in almost every game. Delhi was quite surprising. The crowd in Delhi was superb. We have not seen many people turn up in big centres especially. That was how other centres started getting Tests. Test cricket should be played everywhere in India. Why just big centres? We want to take the game to all parts of India," he added.

GENEVA: Real Madrid defender David Alaba was racially abused on social media after voting for Lionel Messi, and Croatia coach Zlatko Dalic accused FIFA of disrespect on Tuesday in fallout from the soccer body's annual awards ceremony.

Alaba's vote as captain of Austria's national team placing Messi first, Madrid teammate Benzema second and Kylian Mbappé, the eventual runner-up, in third -- was among the results published by FIFA after the ceremony in Paris. That choice provoked anger from Madrid fans and others because Alaba, who is Black, voted for Messi, who spent 17 seasons at Barcelona, Real Madrid's biggest rival. "The Austrian national team vote for this award as a team, not me alone," Alaba wrote on his social media accounts. "Everyone in the team council is able to vote and that's how it's decided. Without doubt.' We Had To Fight Really Hard To **Reverse Momentum: Williamson**

WELLINGTON: New Zealand had to fight really hard against an "incredible" England to reverse the momentum in the hard-fought second match, Kane Williamson said on Tuesday after his side pulled off one

of the greatest Test victories. Following-on after conceding a 226-run lead at Basin Reserve, the former skipper batted more than seven hours in his knock of 132 to take them to 483, setting the visitors a 258-run target.

In a heart-stopping finish, New Zealand won the match by one run. 'It isn't quite fair to be

standing here after a game of cricket like that," Williamson said at the post-match presentation ceremony. 'The contributions we've seen from both teams, fantastic game of cricket to be a part of. For us as a team, we've been fighting away in the Test format for a while, it's kinda nice to get across the line in this one

'You always try to do the best you can for the team and it's never enough. We saw some really valuable partnerships to get us a total on the board and something to bowl at in the last innings. We had to fight really hard to reverse some of the momentum.

"This English team is playing incredible cricket at the moment. We were up against it coming into this game. To fight away, to complete and ultimately just get across the

line is a nice feeling." Williamson notched his 26th Test century to become the highest Kiwi run-getter in the longest format eclipsing Ross Taylor and was adjudged the 'Player of the Match'.

Talking about his own innings, the former captain said,"I was just trying to stick to the basics. We knew we were going to be challenged. There is so much quality in this English attack and the pitch offered a little bit throughout."

It was New Zealand leftarm pacer Neil Wagner (4/62) who did the star turn when he dismissed England's last man James Anderson, caught down the leg to signal the Kiwi win.

"And did Dominik Livakovic not deserve to be one of the five finalists for the Best FIFA Men's Goalkeeper after everything he did in Qatar?"

Dalic also noted that Morocco coach Walid Regragui was a candidate – finishing fourth for the coaching award won by Argentina's Lionel Scaloni despite Croatia beating that team in the third-place game at the World Cup and drawing in their group match in Qatar.

"Having taken all of the above into consideration, I have decided not to partake in the voting process for this year's awards," Dalic said, aiming a further barb at FIFA. "Both the time slots of our matches at the World Cup and the quality of refereeing especially at the semifinal match – made me feel that there was a lack of respect towards the Croatian team."

FIFA did not immediately respond to a request for comment.
