

Agri Land Of Pak-Based Militant Seized

Srinagar: In its ongoing action against militants operating from Pakistan, the NIA on Friday attached a property of The Resistance Front (TRF) operative Basit Ahmad Reshi in North Kashmir's Baramulla district.

The action follows the sealing of a Srinagar-based property of the chief of the Al-Umar Mujahideen, Mushtaq Zargar alias 'Latram', on Thursday.

Reshi, a "listed terrorist" under the Unlawful Activities (Prevention) Act (UAPA), has been operating from Pakistan after his exfiltration there. He has been found funding militant activities and acts in the Kashmir Valley, a National Investigation Agency (NIA) spokesperson said

The official said Reshi had joined militant ranks in 2015 and was involved in planning and executing an attack on a police guard post in Sopore that killed a constable and injured others.

He was earlier associated with banned outfit Hizbul-Mujahideen and at present, is involved in militant activities of the TRF, managing supplies of arms and ammunition as well as funds for the militant group from across the border, the spokesperson said.

The NIA said Reshi's agricultural land measuring 9.25 marlas has been attached under the provisions of the UAPA with the assistance of revenue and police officials.

Take Call On Mehbooba's Passport In 3 Months: Delhi HC

New Delhi: The Delhi High Court on Friday asked the passport authority to take a decision within three months on issuing a fresh travel document to PDP chief Mehbooba Mufti.

Justice Prathiba M noted the issue has been pending for two years and, following an appeal against the rejection, it has now been remanded to the passport officer concerned for

"Considering that the matter is remanded back to the passport officer and the initial rejection was two years ago, let the passport officer concerned take a decision expeditiously and in any case within three months,"

ordered the judge. The court's order came on a petition by Mufti seeking a direction to the authorities to take an early decision on her appeal regarding the issuance of a new passport.

The former Jammu & Kashmir chief minister said in her plea there was considerable delay in issuing a new passport to her despite reminders. She said no decision was being taken on her appeal.

The central government informed the court that counse an order was passed on the appeal on March 2 and the matter has been sent to the passport officer in Jammu & Kashmir for fresh reconsideration.

In view of the Centre's stand, the court observed, the petition was infructuous and no further orders were required.

Last month. Mufti had sought the intervention of External Affairs Minister S Jaishankar for the issuance of passport, saying she has been waiting for it for the past three years to take her 80-year-old mother on a pilgrimage to Mecca.

Rs 2 Cr Cash, Heroin **Recovered Near LoC**

lammu: In a major breakthrough in its drive against narco-terrorism, the Jammu and Kashmir Police on Friday recovered seven kilograms of heroin, over Rs 2 crore cash and a pistol from the house of a notorious drug peddler along the Line of Control (LoC) in Poonch district, a senior police officer sai

Additional Director General of Police, Jammu zone, Mukesh Singh said a major narco-terror module has been busted in the Union Territory, adding the search operation is still going on.

The recovery was made from the house of notorious drug peddler Rafi Dhana alias "Rafi Lala", who was recently detained under the stringent Public Safety Act, in Mandi sector, Singh said here.

He said police along with components of the National Crime Agency and the CRPF raided the house of Rafi near the LoC on specific information, leading to the recovery of seven kgs of heroin, over Rs 2 crore and a pistol with one magazine and 10 rounds and seven rounds of SLR. The counting of the cash is still going on, the officer said. With Friday's development, police and security forces have been able to bust a major narco-terror module in the Union Territory, Singh said.

Childhood Obesity In India Likely To Rise Over 9 Per Cent Annually By 2035: Study

Childhood obesity in India is likely to see an annual rise of 9.1 per cent by 2035, if prevention, treatment and support do not improve, according to a global study released ahead of World Obesity Day.

Observed every year on March 4, the goal of World Obesity Day is to stimulate and support practical actions that will help people achieve and maintain a healthy weight and reverse the global obesity crisis.

The report published by the World Obesity Federation predicts that more than half the global population will be overweight and obese within 12 years if prevention, treatment and support do not improve.

In India, around 11 per cent people will be obese by 2035, with an annual increase in adult obesity between 2020 and 2035 to be 5.2 per cent, it noted.

The report 'World Obesity Atlas 2023' shows that in 2020 boys in India had a 3 per cent obesity risk, but by 2035 the risk will likely go up by 12



per cent and for girls the risk was 2 per cent in 2020, but in

to 7 per cent. The report also shows that Indian women in 2020 had an obesity risk of 7 per cent, which will rise to 13 per cent by 2035. Men had a risk of 4 per cent in 2020, which will rise to 8 per cent in 12 years.

The study predicts that continued failure to improve prevention and treatment could contribute to a total economic impact of UD 4.32 trillion by 2035 nearly 3 per cent of global GDP. The likely impact on India's national GDP will be 1.8 per cent, the

The main reasons for rising obesity prevalence in lower income countries include shift to highly processed foods, greater levels of sedentary behaviour, weaker policies to control the food supply and food market-ing, and less well resourced healthcare services to assist in weight management and in health education.

"This year's Atlas is a clear warning that by failing to address obesity today, we risk serious repercussions in the future. It is particularly worrying to see obesity rates rising fastest among children and adolescents.

said Professor Louise Baur, President of the World Obesity Federation.

'Governments and policymakers around the world need to do all they can to avoid passing health, social, and economic costs on to the younger generation.

That means looking urgently at the systems and root factors that contribute to obesity, and actively involving young people in the solutions. If we act together now, we have the opportunity to help billions of people in the future," Baur said in a statement.

report shows The marked variations in preparedness across national income levels and geographical regions. For example, the average preparedness ranking for low income countries is just 154/183 compared to 29/183 for high income countries.

India has a preparedness of 98/183, which was marked as "average" by the report. All 10 of the most prepared countries are in Europe, while eight of the 10 least prepared countries are in the African region.

Unique Protest Against Smart Meter Installation Held At Rainawari

Women Blocks Road, Sings 'Medley Songs' To Oppose Move

Srinagar: A unique protest against installation of 'smart' power meters was held at Rainawari area in the old city on Saturday, with protesters, mainly women holding smart meters in hands, singing Kashmiri medley songs 'wanvun' so as to be heard by those sitting at the helm of affairs.

Protests against the move continue across Kashmir including Srinagar, ever since the process of installing smart meters began in the newly carved out Union Territory, with locals blaming previous regimes for putting people of J&K into 'dire-straits'

"This is not a road show, this is a real grief, take pity and stop oppressing poor" were the slogans protesters, mainly women, were shouting after blocking the

main road near Jawaharlal Nehru Memorial (JLNM) Hospital at Rainawari.

Protesters blocked the traffic movement on the busy road for around an hour. Traffic was restored after some officials reached the spot to pacify agitating women.

The protesting women alleged that the previous regimes for their political interests allowed the National Hydroelectricity Power Corporation's (NHPC) to take over J & K's potential source of income, which is now selling power to Kashmiri people at extremely exorbitant rates.

They said installing smart meters in Rainawari is a farfetched dream to be accomplished, as the residents would prefer to live in 'pitch dark' than to allow the government to install smart meters in the area, wherein people live 'hand to mouth'

Protests were held in several other areas of Rainawari including Mugal Mohalla with women holding smart meters in their hands singing Kashmiri medley songs (wanvun) to grab the attention of the people sitting at the helm of affairs.

"Why do we install smart meters, these are the previous regimes that robbed J&K of its only potential source of income and threw it into darkness. Why are we forced to install smart meters and pay hefty monthly bills when J&K supplies power to other states for free," Rehana, a protester, told the media.

Protesters said they will not allow smart meters to be installed in their area as they have been paying a good amount ranging from Rs 1000 to 1300 as monthly electricity bill.


NDTV news channel reported that Musharraf had ordered the release of 200 Indian civilians held in Pakistani prisons, but J i 1

The Case for Handicrafts

What is culture and civilization but a fabric made of the warp and woof of these socioeconomic mores, cultural continuities and the signatures of indigenous and vernacular goods. As the threads loosen, one after the other, the fabric of culture will clove asunder without much attention

man in his late fifties with a hunchback leans forward as he reads what is locally known as "Kalbaaf Taleem" (Carpet Weaver's instructions) and meshes threads. He will reach the final stroke in the next couple of days that will result in the fruition of a masterpiece – a piece of carpet that may decorate royal palaces, presidential houses or any other place of global repute. The weaver, who worriedly drives his apparatus on the carpet hung in front of him, is anxious about his wages. He is least aware that in his colourful threads, he weaves the culture, craft and civilization, all in one seamless flow – fusing all of it together in a piece of carpet.

But the sight has dwindled, the industry in shambles and the hopes of revival too bleak. This applies to almost all traditional crafts – Paper Machie, Wood Carving, Pashmina Works; all seem to have suffered the same fate.

Handicraft industry stands handicapped, unable to stay apace with emerging market trends, plagued by middlemen culture and pushed to footnotes by the wuthering apathy of government and concerned agencies. The decay of handicrafts is not only an economic misfortune, depriving us of our perennial occupations but is also a cultural and civilisational loss, no less than the loss of language, political autonomy, a sense of self-identity of the nation and people. What is culture and civilization but a fabric made of the warp and woof of these socio-economic mores, cultural continuities and the signatures of indigenous and vernacular goods. As the threads loosen, one after the other, the fabric of culture will clove asunder without much attention.

Profusion of machine made goods, the discomforting fraudulence, falling out of sync from market trends and the indifference of the government are some of the reasons that immediately come to mind while one tries to figure out the reasons for the decay of our artisanship and handicrafts. The first of these - the indiscriminate profusion of machine made goods seems to have no answer as history teaches us. The arrival of the printing press, for example, led to the downfall and absolute decadence of as large an industry as calligraphy and overnight made thousands of scribes redundant. In the presence of machine made goods, the hand-made goods only retain their importance for the elite with refined aesthetic sense and the simultaneous abundance of resources to meet these resources. But can this vast industry, the industry that includes dozens of specialised crafts survive on the whims of the economic elite? People, who are themselves in a state of economic constraint are little bothered



about the intricacies and superfine underpinnings of an artistic masterpiece and they are in no mood to purchase a good against the amount that can otherwise sustain them for a year. In an imbroglio like this, the government can and must play an active role by allocating remunerations to artisans, take the task of export into its own hands and assure that the finished goods reach the market places where they are needed the most. There is a dire need of capital infusion into this dying industry if the government wants to keep it alive and bring it on par with the global standards.

The conundrum of pervasive and malafide presence of spurious and fake items under the pretext of genuine handicrafts has been lately addressed by the concerned agencies by such means as GI tagging and product specific brand stampings. This might go a long way to help the customers to distinguish the fake from genuine and to save themselves of fraudulence and trickstery. The onus lies on the artisans to update themselves about GI tagging and its relevance to their product and the marketing thereof so as to carve a niche of their own in brand creation. Adjacent to fakery is the overwhelming ignorance of artisans to the emerging marketing strategies, the use of E-commerce and other online services which could have otherwise boosted their products and placed them at par with the global trends. Both government and NGOs are actively pursuing this case of updating the artisans on

this front and in this week itself, ELFA International, a Kashmir based humanitarian body organized a massive training and sensitization workshop with craftsmen drawn from almost across the spectrum and had threadbare sessions with them on emergent trends in production and marketing sector, informing them also of the steps taken by government in this direction. About the government, it can be said that the picture isn't entirely bleak but it is instead the lack of information about the schemes and initiatives taken by the government for the welfare of craftsmen that leads to missing out an opportunity. The schemes initiated by DHC at the central level and the ones implemented by HSC at state level all are for the up gradation of the crafts and craftsmen, but the ignorance of the same results in loss of opportunities.

The aforesaid remedies as figured out have to work in sync, in resonance to rejuvenate this otherwise gasping industry and while rescuing it and taking it to shores, there's a hope that we will be recreating not only employment for the coming generation, but connecting them to their roots, with dignity and prosperity.

A Pandemic-Ready World

The exercise to strengthen WHO's International Health Regulations Framework must balance sovereignty of member-nations with facilitation of timely action

ven as the world mostly refers to the Covid-19 pandemic in the past tense, the threat of future pandemics is presently engaging the attention of all countries through two major international initiatives convened by the World Health Organisation (WHO). International Health Regulations (IHRs) are being revised to increase the speed and efficiency of global health alerts. A new Pandemic Treaty is being negotiated to provide a more efficient and equitable response to a pandemic than witnessed recently. Both these initiatives will draw on the experiences of the Covid-19 pandemic to enhance global capabilities for responding to a new microbial threat.

IHR is the most important multi-lateral treaty that regulates the global architecture for health emergency preparedness, response, and resilience (HEPR). It commenced in 1969, for reporting on six infectious diseases. By 1973, the focus was on three diseases—cholera, yellow fever and plague. In 1995, the World Health Assembly (WHA) called for extending the scope to many sources of risk to human health (biological, chemical, radiological, and nuclear). The SARS-I pandemic catalysed a major revisit of IHR in 2005, calling on countries to assess and improve their national capacities for surveillance and response, and was to be accomplished by 2012. IHR 2005 required countries to notify WHO of any event which can potentially cause a 'public health emergency of international concern' (PHIEC) and to develop core public health capacities to investigate and control such threats. It enabled WHO to declare a PHIEC and coordinate a global response.

Despite this, the Covid-19 pandemic response revealed several weaknesses—both at several national levels and in global coordination. Many national health systems were inadequately prepared to recognise, report and respond to the escalating threat. Global sharing of information was neither uniformly prompt nor reliable. WHO's assessments and national reports were at variance and global technical assistance had to be provided



through filters of negotiated national government consent. Calls for revision of IHR mounted, both to expand its scope and to strengthen its implementation

Proposals for revision of IHR were placed before the 75th WHA in 2022, were debated in the 76th WHA this year and are being steered towards the adoption of a new-age IHR in the 77th WHA. A total of 307 amendments to the existing IHR have been tabled by member states. They will be debated to develop consensus on revisions.

The most radical amendments have been proposed by the US, which has been very wary of bioterrorism and pandemic threats from other countries. The US's Centers for Disease Control (CDC) work closely with WHO to monitor global trends. Covid-19 pandemic raised concerns about loopholes in timeliness, completeness and accuracy of outbreak reporting and speed of response, which the US proposals seek to plug. Amendments tabled by the US include proposals for rapid sharing of pathogen genetic sequence data and shorter

deadlines for reporting and responding to emerging threats. An amendment to Article 12 proposes to remove the need for WHO to consult and find agreement with the country, which is seen to be the origin of a potential threat. This will be done through the mechanism of an 'intermediate public health alert' that requires 'heightened international awareness'.

An amendment also proposes to give the six regional directors of WHO powers to declare a 'public health emergency of regional concern' (PHERC), avoiding delays of a global review and expediting coordinated regional responses. The US proposals allow WHO to rely on 'outside' information received from non-official channels, with only 24 hours given to the national government to respond before the information is made public. This is intended to overcome the tardiness or inaccuracy of national reporting but critics question whether third parties may use this channel to damage the reputation of countries. Consultation with countries is also not required before an PHE-

IC or PHREC is declared. Amendments propose to make deployment of WHO's technical assistance missions to countries mandatory, by replacing 'may' with 'shall'. This is supported further by amendments to Article 15, allowing WHO's Director General and Expert Committees to recommend the deployment of expert teams to a country experiencing a PHIEC.

Critics of the proposed amendments are concerned about the erosion of national sovereignty, if many of the decisions are taken by WHO on the basis of expert committees which consist of nonofficials and are often dominated by scientists from high income countries. There is concern that declaration of a PHIEC will provide a fast track to emergency use authorisation of drugs and vaccines with curtailed scrutiny of evidence on efficacy and safety. Annex 2 of the current IHR calls for declaration of a PHIEC when a SARS virus is detected. Should that be done even if the virus has a low infection fatality rate (IFR)? This has implications for people's mobility and livelihoods.

There is a compelling need to strengthen global surveillance systems for timely detection of serious threats to public health which not only pose danger to lives but also undermine economic security and social stability. WHO needs to be strengthened to act with speed, technical competence, objectivity, and capacity to coordinate global responses, whenever a PHEIC arises. It should do so without unduly undermining national sovereignty in making assessments and deciding on locally appropriate responses. The ongoing negotiations on IHR will have to find a fine balance between these goals. Alongside this effort to make IHR a 'fit for purpose' instrument, the new Pandemic Treaty which is being negotiated in parallel should usher in a new era of cooperation in global health.

What Is A Book In The Digital Age?

s a professional book designer, I've spent a decade observing electronic books from a cagey distance. A couple of years ago, I reluctantly recognised the need to engage with these alien book forms, both as a reader and a designer. It is the 21st century.

What I have come to realise is this: electronic books can do certain things that print books cannot, and therein lies their value. Enhanced electronic books are changing our definition and expectations of books.

My office, home and handbag are still stuffed with print books; eBooks (e for electronic) have not replaced pBooks (p for print) in my life. I find myself toggling between the two.

I consider the relationships between print and electronic books from the perspective of a reader and designer. What are these different formats, and how do they affect the way we produce and consume content?

THE SMELL AND FEEL OF PAPER

Let's get nostalgia out of the way quickly. Print books have a material quality that electronic books do not. For many of us, the intimacy of cradling a book close to our chest, hanging our head over it and shutting out the real world is a sacred ritual. The smell and feel of paper can never be replicated by a cold, hard screen.

Although it's possible to read an electronic book in a bath, it's less relaxing and more dangerous (not in a fun way). Browsing a bookstore or library and flicking through books is a social, embodied experience. Clicking on a screen is not.

Amazon.com has a complex algorithm to suggest books I may like based on previous purchases, but I'd rather have a librarian or bookseller make suggestions based on their expertise and a conversation, and walk out holding the book object. The tactile differences between page and screen will always be an issue for

those of us raised on ink and paper. But watch how a toddler tapping stubbornly at a magazine becomes annoyed that the image isn't changing. That child is unlikely to feel the same nostalgia for print as her parents, because her understanding of "book" will be significantly different

The technology we use to present and consume information has changed. The toddler who understands that tapping a glassy surface should make an image change demonstrates that technology is developing at an unprecedented rate, and unless we are constantly attentive we risk being left behind.

NEW TECH, NEW CHALLENGES

Although often linked, anxiety about the new is different than nostalgia for the old.

A print book is a beautifully simple technology to use. Pick the thing up, turn each leaf in sequence until finished. If literate, anyone can pick up and read any print book.

An electronic book is a more complex technology. An eBook requires a computer, eReader or tablet, and a power source to keep the device charged. It requires computer access to a website or digital catalogue where files can be downloaded, and an understanding of how to use it.

Pages aren't just turned, they are clicked and pinched and swiped movements that need to be learned, and vary between different devices and brands.

In other words, you need new kinds of literacy to even get to the text. Moreover, you need to keep up with constant development and updating of these devices and programs, and understand the value and limitations of different devices, formats and suppliers.

This market-driven mess is the major issue with current eBooks. Different eReaders are made by different companies - Amazon's Kindle, Barnes & Noble's Nook and the Sony Reader, to name a few. Then there are tablets, such as Apple's iPad, which perform a range of functions similar to a computer, one of which is enabling users to read eBooks through an app (short for "application", or computer program).

These different devices run on different software, and require different file types. An eBook that works on a Kindle may not work on an iPad. There is no single file type that allows an eBook to be published all devices.

ing and binding process of traditional book production may seem to reduce production time and costs, the confusion of designing for different platforms and devices means an entirely new and more complicated production process has been introduced.

Urgency to capture the market means many of these devices and the software/programs on them are released before they have been properly tested, and have faults that need to be addressed by constantly updating to newer versions of the software.

Amazon's Kindle Fire eReader, released just before Christmas 2011, was riddled with bugs and problems: volume-control glitches, an off-switch that was easily hit by accident, slow loading time and an unresponsive touch screen. Hundreds of articles and forums are dedicated to problems associated with iPads: overheating devices, Wi-Fi connec-

tivity issues, slow charging, apps and eBooks refusing to sync or download.

This can seem overwhelming when you could just pick up a print book and begin reading immediately.

Yet the complexity of the digital system is what allows eBooks to do astounding things, and offers versatility and accessibility impossible in

MORE PROS THAN CONS

The most immediate appeal of eBooks for digitally-reluctant readers is the efficiency afforded by an eReader. Packing for a vacation, a single device the width of a novella that contains hundreds of books is incredibly convenient and offers a previously unimagined variety of instantaneous

With an eReader, I could have slipped Tolstoy's entire oeuvre into my jacket pocket, with some Dostoyevsky for good measure. Then again, finding a power source in a yurt would have proved problematic.

Other appealing aspects of eBooks are immediacy and variety. Incredible numbers of eBooks, including many that are difficult to find in print, are available instantly from repositories, with no delivery time, and with many at a lower cost than print books.

The US-based online literary archive Project Gutenberg has more than 42,000 free eBooks - digitised books that have fallen out of copyright.

Most publishers offer new releases in both print and electronic editions simultaneously. These eBooks are direct translations of print books; the same text is scanned in, or typeset for an eReader, exactly as it would appear in the print edition. For those direct

translations, the difference between a print and electronic edition is a matter of the reader's preference. The content of the book is the same, only the format differs.

A RICHER READING EXPERIENCE

A more curious breed are "enhanced eBooks", which include audio-visual and interactive elements such as short videos and animations.

UK company Touch Press are leading that field. Their titles include an edition of T.S. Eliot's The Waste Land that contains a scanned draft of the manuscript hand-edited by Ezra Pound, an original video performance of the poem, and a suite of video interviews with poets, theatre directors and scholars discussing the cultural significance of the poem.

They have also produced an edition of Leonardo da Vinci's anatomical drawings that allows users to zoom at extraordinary resolution and compare Leonardo's theories against modern knowledge with 3D models of human anatomy, as well as interactive demonstrations.

Touch Press is also behind an animated, annotated periodic table of elements that has to be seen to be believed. Their highly interactive release. Gems and Iewels, allows users to rotate the pictures within the books to see the other side.

Touch Press' website manifesto

Books are one of the defining inventions of civilisation. Today publishing is being transformed by digital technologies. The aim of Touch Press is to create new kinds of books that re-invent the reading experience by offering information that is enhanced with rich media and that adapts dynamically to the interests and experience of the reader.

These kinds of publications are different than the eBooks that are straight translations from print to digital. They include audio-visual and interactive elements that cannot be reproduced on the page.

These are the eBooks that are changing the way we consider what a book is, and could be.

When Covid Politics Collides With Covid Science, Public Health Loses

In the covid now an afterthought rather than an emergency in the minds of many Americans, politicians and pundits are rushing to have the final word on who handled the crisis well — and who dropped the ball.

These recent declarations of pandemic winners and losers often ignore the iterative and uncertain nature of science in favor of blunt headlines and slogans bolstered by cherry-picked studies. And they often elide scientists' and policymakers' honest grappling with major decisions in the face of limited and evolving data.

"The Mask Mandates Did Nothing. Will Any Lessons Be Learned?" New York Times columnist Bret Stephens declared last month, flattening a highly nuanced, heavily caveated scientific study of mask-wearing into a single talking point. And after reports this week that the Energy Department concluded with "low confidence" that a lab leak in China likely caused the pandemic, several prominent Republicans touted it as ruling out a natural origin. They included Sen. John Barrasso (R-Wyo.), who tweeted that "China is responsible for COVID.'

Such black-and-white pronouncements can muddy the public's understanding of what worked (like vaccines), what didn't (ivermectin), and the wide gray area around other measures, like mask mandates or school closures, that scientists are still evaluating. Three years into the pandemic, the United States' political war over covid has eroded public trust in science, with the biggest drop - more than 20 percentage points among Republicans. That polarization makes responding to the next crisis, whether it's a pandemic or something

"Those who have dogmatic positions and are playing to the politics can be extreme, use hyperbole and be definitive in their pronouncements," said Timothy Caulfield, research director of the Health Law Institute at the University of Alberta. "Those who are trying to be close to what the science actually says have to have all these caveats and hedge what they say, and it's just like [they're] going to gunfight with a knife."

POLITICIZATION LEADS TO MISTRUST

Before covid entered the global con-

trust in science was largely bipartisan, with relatively small gaps between the

"There just wasn't much of a political divide," said Cary Funk, director of Pew Research's science and society team, which has tracked public opinion on the topic since 2016. But during the pandemic, a gap appeared — and it contin-

In January 2019, a Pew poll found that 88 percent of Republicans had a great deal or a fair amount of confidence that medical scientists act in the best interests of the public, compared with 87 percent of Democrats. By September 2022, only 68 percent of Republicans reported the same, compared with 91 percent of Democrats. The partisan gap is even wider -63 to 89 - for trust in scientists

That split didn't start right when the pandemic hit, said Funk. "For about six weeks, we saw very little partisan division about what was happening," she said. "But shortly thereafter, we started to see this political division open up, and that really became a hallmark of public opinion around everything connected with the coronavirus outbreak."

By that point, the country was in the throes of the first covid wave — battling a virus the world knew little about, while politicians sniped over how to handle it and who to blame.


President Donald Trump called the coronavirus a "new hoax" at a campaign rally in late February 2020, and continually downplayed the threat during weeks of daily White House press briefings. Democrats lobbed heavy criticism at Trump for moving too slowly and minimizing the potential risk, at times exaggerating how Trump's policies affected the nation's readiness to detect and fight pandemic threats.

"Those political cues can be very sticky and hard to strip away," said Rebekah Nagler, a health communication researcher at the University of Minnesota. "When you introduce that politicization element, you're inviting people to interpret new information through a political lens." A recent history of polarization around health policy, including support for the Affordable Care Act, may have also primed the public to take political sides on covid, she said.

In those early weeks and months, un-

the virus posed, how it spread and what could be done to stop it further fueled the partisan divide, creating an opening for mis- and disinformation to flourish.

"Politicization can involve the strategic elevation of uncertainty around science for political gain," said Sarah Gollust, a health policy researcher at the University of Minnesota.



In early 2020, "science was moving so rapidly, for good reason, as the scientific community was trying to make sense of a novel pandemic," she said. Scientists raced to post new findings online as preprints, bypassing the normal slow process of peer review, to get information out as quickly as possible. That created a flurry of often conflicting information that was challenging for the research community to sift through, much less the public.

"There was so much evidence being produced so rapidly, there was so much more to pick from and potentially elevate conflict," said Gollust.

SHIFTING GUIDANCE

Official guidance often shifted as a result of that evolving understanding and a dynamic environment. Initially, public health officials dissuaded people from buying masks to ensure limited supply

that sequence is not going to elicit trust." Often, public health officials failed to

clearly communicate the rationale for those changes. "Guidance was necessarily going to change because so much was unknown," said Nagler. But how those changes get communicated is crucial for maintaining trust, "I think CDC in particular really let us down by not being more transparent and clear about setting that expectation," she said. For example, in May 2021, the Centers for Disease Control and Prevention said vaccinated people no longer needed to wear masks indoors but abruptly reversed advice in July because of the delta variant. Administration officials tried to explain that the situation had changed, but not being explicit and forceful about that uncertainty upfront opened them up to charges of

"flip-flopping." "Political actors weaponized this uncertainty," said Caulfield. "It creates

sciousness in early 2020. Americans' certainty about the scale of the threat could be used by medical professionals. In opportunity for those who want to generate distrust to generate distrust because they can say, 'This institution said X, and now they're saying Y, that means you can't trust them," he said. Fast-forward to today, and virtually every aspect of the pandemic – from treatments to the value of masking – is viewed through a partisan or ideological lens.

"Once something becomes about ideology, it becomes very difficult to change people's minds," said Caulfield. "It almost doesn't matter what the science says."

Despite evidence that covid vaccines and boosters are safe and effective, uptake remains lower among Republicans, likely contributing to partisan gaps in covid deaths that emerged after the vaccine. And ivermectin — an anti-malaria drug touted by Trump in 2020, which study after study has shown to be ineffective for treating covid - continues to be pushed by some doctors, who are even expanding their recommendations to diseases like RSV and flu. (In the meantime, the promotion of ivermectin as a covid cure resulted in a rise in poisonings linked to the drug, which is also used to deworm horses and other animals.

While evidence against ivermectin is well established, questions around the effectiveness of policies aimed at reducing covid's spread, from masking to school closures, are still being studied. Answers are likely going to be complex and context-dependent, arising from many, many studies carried out in the coming years. Some questions, like whether the coronavirus was leaked from a lab or jumped naturally from animals to people, may never be definitely answered.

Polarization around these questions favors quick and easy answers, as the past several weeks have shown. Ideological actors can seize a study and label it as completely definitive when it's anything but, said Caulfield. But that nuance can get lost among those of a similar ilk. he said, creating a revisionist history of

"There's this profound cherry-picking, they select a favored scientific story, then try to ossify it as the truth," said Caulfield. "It's damaging on so many levels."

CAN TRUST IN SCIENCE BE REBUILT?

Three years into the pandemic, the trust-in-science partisan gap shows no

Covid politicization is still on display as candidates and potential candidates for the 2024 presidential race look to score covid points, and as House Republicans launch inquiries into the Biden administration's handling of the pandemic.

That has profound implications that go well beyond how we understand this pandemic — which is still killing more than 300 people a day in the U.S. — to what we do when the next public health crisis emerges.

Depoliticizing covid after so long may be challenging. "I wouldn't say I'm super optimistic about a reframing at this point, in part because these beliefs are so sticky," said Nagler. But there are strategies scientists and public health officials could employ going forward.

One is to be clearer about how science works. Emphasizing that the scientific process is our best way of making sense of the world, but that it's iterative and inherently uncertain, can go a long way, said Nagler. "We have some data to suggest that if you remind people about how science works, it can be somewhat protective in how they respond to conflicting health information," said Nagler. That doesn't change the messy information environment, she said, but it can improve people's ability to operate

For public health officials, being transparent about decision-making is crucial, said Kasisomayajula Viswanath, a health communication researcher at the Harvard T.H. Chan School of Public Health. "We have to admit that we don't know certain things and will get some things wrong, that's just the nature of science.' he said. "But we'll need to be honest and open [with the public] and provide that information," on how decisions are being made, he said. "This needs to come from the highest levels of government."

But public health messaging can't come solely from on high, Viswanath said. Local organizations and leaders often hold more credibility for community members, making them better messengers, he said. "We need to engage them in this process of rebuilding trust."

There's no easy way to reverse the loss of trust in science and public health - but "we don't have a choice," said Viswanath. "How we do that is the big question."

BJP, Cong Trade Barbs Over Rahul's Pegasus Remarks At Cambridge University

New Delhi: Congress leader Rahul Gandhi's remarks at Cambridge University that he was under surveillance triggered a political slugfest on Friday with the BJP accusing him of maligning India on foreign soil and the Congress hitting back by citing instances of Prime Minister Narendra Modi raking up internal politics abroad.

Gandhi, who is a visiting fellow of the Cambridge Judge Business School, during a lecture 'Learning to Listen in the 21st Century on Tuesday evening said Indian democracy is under attack and several politicians, including himself, are under surveillance.

Referring to the controversial Pegasus snooping issue, Gandhi alleged that the Israeli spyware was installed on the phones of a large number of politicians, including him.

"I, myself, had Pegasus on my phone. A large number of politicians have Pegasus on their phones. I've been called by intelligence officers who say please be careful what you say on the phone because we are sort of recording this stuff. So, this is a constant pressure that we feel," the 52-year-old former Congress chief claimed at the lecture, a video recording of which was posted on Twitter by Congress leader Sam Pitroda, ex-adviser to former prime minister Manmohan Singh.

Reacting to the remarks, Union Minister Anurag Thakur hit out at Gandhi over his claims of being under surveillance by intelligence agencies and accused him of maligning India on foreign soil after facing successive



electoral setbacks. "Pegasus is not in Rahul Gandhi's phone but in his mind," he said.

wondered Thakur Gandhi and other prevented Congress leaders from submitting their phones to a Supreme Court-appointed technical committee that probed the Pegasus snooping issue.

"We can understand his hatred towards the prime minister, but the conspiracy to malign the country on foreign soil with the help of foreign friends raises questions on the agenda of the Congress," the information and broadcasting minister told reporters here.

Thakur said Gandhi was aware of the electoral rout the Congress was facing in the assembly elections and had resorted to levelling allegations from foreign soil.

"Once again, the Congress lost in the elections but their bankruptcy was evident when they lost no opportunity to malign India from foreign soil," he said. Hitting back at Thakur and the BJP for its criticism of Gandhi, the Congress cited instances of Prime Minister Modi going abroad and allegedly raising internal politics and criticising the Congress.

"I have seen those foolish statements given by Anurag 'Golimaaro' Thakur," Congress spokesperson Supriya Shrinate said in an apparent reference to the 'Golimaro' slogans purportedly raised at a public meeting of Thakur last year.

She urged the information and broadcasting minister him to listen to Gandhi's full lecture.

On BIP's criticism that Gandhi was "maligning" the country from foreign soil, Shrinate said the kind of statements Modi had made in places such as Shanghai, Toronto, California, Seoul and Abu Dhabi on internal politics and against the leading Opposition party of the country, if those are recounted then the BJP will have no place to hide.

If they listen to Rahul Gandhi's lecture, they would get to know that he has talked about democracy and how the media, judiciary and the Opposition are intimidated and how it is important for agencies to remain impartial, she said.

(Gandhi) has talked strengthening democabout racy. Those who give statements of 'Golimaaro' from stage and become cabinet minister from minister of state, they can never understand the meaning of these remarks," she said.

Congress' head of media and publicity department Pawan Khera said the party would like to advise the BJP that they should stop such activities which are shameful to even discuss.

'So if they stop doing such activities, we will stop discussing them. There is an allegation on you (BJP) took the help of Israel to snoop into the phones of Opposition and your own leaders. They don't feel ashamed of that, but if it is discussed they feel shame," he said.

"What we can say for Rahul Gandhi's hallucinations. If he makes his (Congress) MoU with China public, we will be interested and people of India will also like to know. Who is interested in his telephonic conversations," BJP spokesperson Tom Vadakkan told reporters.

Vadakkan noted that the Supreme Court has closed the Pegasus matter.

Put Issues Related To Border In 'Proper Place', Work For Its Early Normalisation: Chinese FM Qin to Jaishankar

Beijing: India and China should put the boundary issue in the "proper place" in bilateral relations and work together to bring the situation at their borders "under normalised management" as soon as possible, Chinese Foreign Minister Qin Gang conveyed to his Indian counterpart S Jaishankar, the foreign ministry said here on Friday.

Qin's first in-person meeting with Jaishankar on Thursday came on the sidelines of the G20 foreign ministers conclave in New Delhi amid the over 34-month-long border row in eastern Ladakh. Qin took charge as Chinese foreign minister in December, succeeding Wang Yi.

India has been maintaining that its ties with China cannot be normal unless there is peace in the border areas.

Jaishankar conveyed to Qin that the state of India-China relations is "abnormal" as their talks focused on addressing the challenges in bilateral ties, especially that of peace and tranquillity in the border areas.

"We also had a brief discussion on what was happening in the G20 framework. But the thrust of the meeting was really on our bilateral relationship and the challenges in the bilateral relationship, especially that of peace and tranquillity in the border areas," Jaishankar said.

Qin told Jaishankar that both sides should implement the important consensus of the leaders of the two countries, maintain dialogue and properly resolve disputes, and promote the improvement of bilateral ties and the steady moving forward of the relations, state-run Xinhua news agency quoted an official press release from the Chinese

foreign ministry as saying. "The boundary issue should be put in the proper place in bilateral relations," Qin said, adding that the situation on the borders should be brought under normalised management as soon as possible.

China is willing to speed up the resumption of exchanges and cooperation with India in various fields, resume direct flights at the earliest date and facilitate people-to-people exchanges, Qin said.

He said that as neighbouring countries and major emerging economies, China and India have far more common interests than differences.

The development and revitalisation of China and India display the strength of developing countries, which will change the future of one-third of the world's population, the future of Asia and even the whole world, Qin noted.

He said "the two sides should view their bilateral relations in the context of the once-in-a-century changes in the world, understand bilateral cooperation from the perspective of their respective national rejuvenation, and be partners on the path to modernisation".

He said China and India have shared interests in many areas including safeguarding the rights and interests of developing countries, promoting South-South cooperation and addressing global challenges such as climate change.

China supports the Indian side in fulfilling its chairmanship of the G20 and is ready to strengthen communication and cooperation to safeguard the common interests of developing countries and international equity and justice, so as to inject stability and positive energy into the world, Qin said. assumed Presidency of the G20 on

December 1 last year. The talk between the foreign ministers came nearly eight months after Jaishankar held a meeting with the then-Chinese foreign minister Wang in Bali on the sidelines of a G20 meeting.

At the hour-long meeting on July 7, Jaishankar conveyed to Wang the need for early resolution of all the outstanding issues in eastern Ladakh.

Relations between China and India have virtually frozen ever since the eastern Ladakh military standoff between the two countries in May 2020.

In line with a decision taken at the 16th round of military talks, the two sides carried out disengagement from Patrolling Point 15 in the Gogra-Hotsprings area in September last year.

But the face-off between the two of the planet's biggest military forces lingered on in Demchok and Depsang regions though the Indian side pressed for completion of the disengagement in remaining friction points at the earliest.

On February 22, India and China held in-person diplomatic talks in Beijing and discussed proposals for disengagement in the remaining friction points along the Line of Actual Control (LAC) in eastern Ladakh in an "open and constructive manner".

"I want to tell you that property tax is in place in every state and Union Territory of the country. Jammu and Kashmir is the last region where property tax has been implemented," he

"But you need to understand the facts. Even before imposing the property tax in J&K, we decided to keep it minimum," he added.

If I speak about the figures, the LG said, whether it is Srinagar, Jammu or Kathua, there are only 5.20 lakh houses and out of these, 2.6L houses are less than 1000 sq ft and no tax is being imposed on them.

SRINAGAR: On world hearing day, Doctors Association Kashmir (DAK) on Friday warned against excessive use of earphones.

"Overuse of earphones at higher volumes over prolonged period of time can result in hearing loss," said DAK President Dr Nisar ul Hassan.

Dr Hassan said the younger generation is particularly vulnerable because they are glued to their personal listening devices like earphones, headphones and earbuds.

They plug these devices into their smartphones and listen to many hours at volumes exceeding the safe limit.

"Young people often choose volumes as high as 105 decibels," he said

"The safe sound levels are around 85 decibels for adults and 75 decibels for children."

The DAK President said more people are coming with hearing issues due to the overuse of earphones and headphones.

"Today's earphone users are going to be tomorrow's hearing aid users," he said.

PAAs To Replace Panchayat Secretaries As First Signatory For Govt Schemes

JAMMU: Expanding the functions and responsibilities of Panchayat Account Assistants (PAAs), the Department of Rural Development and Panhayati Raj, J&K has appointed them as the first signatories for all the government schemes run by the department.

According to an order issued today by the RDD & PR department in this regard, the PAAs shall now be responsible for uploading approved GPDPs on jk.panchayat portal, clearance of audit paras and OB items, responding to audit observations and recovering amount, if any, observed in the audit paras.

The order added that the PAAs shall now replace Panchayat Secretary as the first signatories in all government programmes including the Ma-

As the first signatory, they are responsible for ensuring that all financial transactions of the Panchayats are correctly recorded, verified and authorized before any payment is made.

Pertinently, a novel approach was developed in the UT to strengthen the Panchayati Raj system and ensure accurate accounting of finances in the Panchayats. For this, the Finance Department created 2000 Panchayat Accounts Assistant (PAAs) posts

in Rural Development Department vide Government Order No. 373-F dated 27-06-2019. After their appointment, they were assigned roles and responsibilities to maintain all records relating to Gram Panchayat Accounts wherein their primary responsibility was to check the accuracy of all financial transactions, to scrutinize the resolutions passed by the Gram Panchayat.

In addition to preparing responses to audit reports, they were also entrusted with the responsibility of reconciliation of revenue, receipt and expenditure figures with the office of Principal Accountant General Office of Jammu and Kashmir.

BUDGAM: As illegal Riverbed Mining continues in Shali Ganga stream in Panzan area of Budgam, the locals have now issued a legal notice through their counsel to the District Mineral Officer (DMO) Budgam and top Govt officers asking him to stop the illegal practice.

The legal notice which has been sent to DMO Budgam and Govt officials including Divisional Commissioner Kashmir, Director Geology & Mining JK Govt, Member Secretary Pollution Control Committee and Deputy Commissioner Budgam says that mining work allotted to one Abdul Rashid Mir (project proponent) through e auction at block number 10 in Shali Ganga nallah was blatantly violating Environmental norms and rules particularly the Jammu and Kashmir Minor Mineral Concession, Storage, Transportation of Minerals, Management and Prevention of Illegal Mining Rules 2016, Biological Diversity Act 2002, The Water (Prevention and Control of Pollution)Act 1974 and particularly Specific Condition number 53 of JK Environmental Impact Assessment Authority.

"The project proponent is leaving no stone unturned to destroy and damage the environment and has neither installed functional and op-



erational CCTVs on the mining site nor is selling the river bed material as per 50% concessional rates to local population and adjoining areas. Further the said PP is openly using JCB's, L&T, hydraulic excavators etc which is prohibited under mineral rules 2016 and conditions laid by JK Environmental Impact Assessment Authority," reads the legal notice issued by Badrul Dujja Advocate J&K High Court who is the counsel

for the petitioners. The locals have alleged that the project proponent had some unauthorized persons who have plundered the Shali Ganga to a great extent during the last one year.
