The officials said Pir, a selfstyled commander of the outfit, was shot dead in Rawalpindi on February 21.

# India Slams Pakistan's 'Propaganda' At UNHRC

Says Islamabad Has 'Unique Distinction' For Hosting Designated Terrorists

**Geneva:** Pakistan has the "unique distinction" of hosting the most number of UNSC-designated terrorists and terror organisations, and its policies are directly responsible for thousands of civilian deaths in the world, India has said as it slammed Islamabad for its "malicious propaganda" against it.

Exercising its right of reply to Pakistan's statement at the United Nations Human Rights Council (UNHRC) in Geneva on Friday, India said when it is not entirely focused on suppressing its own population, Pakistan actively lends its energies to aid, host and abet international terrorists.

"It has the unique distinction of hosting the most number of UNSC designated terrorists and terror organisations. Osama bin Laden lived next to Pakistan's premier military academy. Its security agencies have nurtured and sheltered Hafiz Saeed and Masood Azhar for decades," First Secretary of India's Permanent Mission to UN Seema Pujani said.

"These are but a few dreaded names from the annals of Pakistan's history of supporting terrorism. Pakistan's policies are directly responsible for the death of thousands of civilians around the world," she said in response to a statement deliv-

ered by Pakistan.
Pujani said Pakistan's obsession
with India while its population

the state's misplaced priorities.

Jammu: Director General of Police Dilbag Singh on Saturday said Pakistan is trying to push more terrorists, drugs and weapons into Jammu and Kashmir, where the graph of militancy is on decline with security agencies determined to finish terrorism.

He termed the recovery of seven kilograms of heroin, over Rs 2 crore and arms and ammunition from a house of a notorious drug peddler near the Line of Control (LoC) in Poonch district as a "big success", saying the security forces are working comprehensively to dismantle the entire support structure of terrorism in the Union Territory.

"We have checked infiltration (of terrorists) through underground (tunnels) and overground channels, but Pakistan is still making continuous efforts to push the terrorists in large



numbers into this side," the DGP told reporters on the sidelines of a function in Samba district.

He said the infiltration bids are made to fill the militant ranks and upscale the graph of militancy which is on decline.

However, police along with other security agencies are alert to frustrate any attempt to disrupt peace and determined to finish terrorism from Jammu and Kashmir, Singh said. More on P10

### **Lewis Superacids Produced, Could Reduce Non-Biodegradable Compounds Into Sustainable Chemicals: Study**

Chemists have succeeded in producing very special catalysts, called Lewis superacids, which can be used to split strong chemical bonds and accelerate reactions, according to

With this discovery of the chemists from the University of Paderborn, Germany, nonbiodegradable fluorine-containing hydrocarbons, similar to Teflon, and potentially even climate-damaging greenhouse gases such as sulphur hexafluoride could be converted back into chemicals that can be used sustainably, according to the study.

The production of these substances has so far proven to be extremely difficult, the study said.

The scientists have now published their results in the journal "Angewandte Chemie". Compounds that add pairs of electrons are called Lewis acids.

Because of this ability, they are often

used to speed up chemical reactions. Lewis superacids are stronger than antimony pentafluoride - the strongest Lewis

acid - and can break even the sturdiest "For strong bonds, you need very re-

active reagents, i.e., substances that react extremely readily with carbon-fluorine or sulphur-fluorine bonds, which are particularly stable," explained Jan Paradies from the Chemistry Department from the University of Paderborn.

"Intrinsically, these Lewis superacids are incredibly reactive, making them difficult to make and use.

# Mines Removal Likely To Delay Bus Service

SLAMABAD - Removal of landmines on both, sides of the Line of Control is one of the major problems that can delay the launch of the Muzaffarabad-Srinagar bus service.

Dawn quoting sources said on Sunday that senior military officers of India and Pakistan had established contact the other day and discussed early clearance of mines. The two sides would exchange information about the number of mines on each side of the border.

They did not rule out the possibility of the assistance in the form of technical know-how and financial help to carry out the job. Both India and Pakistan had planted thousands of mines along their border areas, including Kashmir, after wars in 1948, 1965,

Sources said the two countries had agreed that not only the mines -would be removed but a road would be built to facilitate the bus travel as the existing road on both sides of the LoC was in bad shape. Report said that Pakistan would provide funds to the army to get the road repaired and mines removed as early as possible.

# 'Neutral Maternal Behaviour Linked With **Epigenetic Changes In Children'**

Teutral maternal behaviour towards their infants has been linked with an epigenetic change related to stress response in children, according to a new study which added evidence to the importance of early development.

Epigenetics are molecular processes independent of DNA that influence gene behaviour.

In this study, researchers found that neutral or awkward behaviour of mothers with their babies at 12 months correlated with an epigenetic change called methylation, or the addition of methane and carbon molecules, on a gene called NR3C1 when the children were 7 years old.

This gene has been associated with regulating the body's response to stress, the study said.

"There is evidence of a relationship between the quality of maternalinfant interaction and methylation of this gene though these are small effects in response to a relatively small variation in interaction," said Elizabeth Holdsworth, a Washington State University biological anthropologist and lead author of the study.

The study is published in the American Journal of Human Biology. Other studies have connected extreme stress in early life, like neglect and abuse, to more dramatic methyla-

tion on this particular gene in adults. However, Holdsworth emphasized that the small difference indicated by this study may be an indication of normal human variation and it is hard to determine if there are any long-term effects.



For this study, Holdsworth and her co-authors analyzed a subsample of 114 mother-infant pairs from the Avon Longitudinal Study of Parents and Children, a project that tracks a cohort of children born in 1991 and 1992 in Avon. UK.

The researchers first analyzed data from an observational study of the mothers sharing a picture book with their children at 12 months, in which their interactions were coded on warmth.

The study focused on mothers be-

cause they are often infants' primary caregivers. The vast majority of the women in this sample were white, college-educated and from middleincome households, it said.

The range of warmth they displayed only varied slightly with the

"coldest" behaviour classified as awkward or neutral, but this is exactly what the researchers hoped to test: that if even small differences in social interaction could be linked to an epigenetic change, the study said.

The observed behaviour was then

compared against data from an epigenetic analysis of the children's blood samples taken at age seven, the study said.

The researchers found that the mothers showing awkward or neutral behaviour toward their infant correlated with a small increase of methylation on the NR3C1 gene, the study said.

This gene encodes a receptor involved in the regulation of the HPA axis - the interaction between the body's hypothalamus, pituitary and adrenal glands. This axis plays a role in stress response, including production of the body's primary "stress" hormone, cortisol.

The HPA axis can be activated by almost anything that requires a quick release of energy from reacting to a real threat to watching a scary movie to simply exercising.

The NR3C1 gene is known to be involved in activating this axis, but more research is needed to understand how methylation of that gene is associated with stress response, Holdsworth said, as some studies have shown increased methylation linked to hypo-reactivity, or blunted response while others have shown hyper-reactivity.

Researchers are working to uncover how these changes happen, particularly during infancy when the body is developing rapidly, as well as what they might mean, they said.

"Within developmental biology, we know humans grow to fit the environment that they're in, which contributes to normal human biological variation. It's not necessarily good or bad," said Holdsworth.



# **'Higher Omega-3 Levels Linked With Increased Protection** From Severe Covid'

higher level of omega-3 fatty acids may be associated with an increased protection from severe COVID-19 infection, according to a study.

The research, published in the American Journal of Clinical Nutrition (AJCN), explored the role of omega-3 fatty acids, especially EPA and DHA, and whether they might be protective against contracting or suffering adverse outcomes of COVID-19.

The researchers from Fatty Acid Research Institute (FARI) and the University of South Dakota, US compared the risk for three COVID-19 outcomes: testing positive, hospitalisation, and death as a function of baseline plasma DHA levels.

DHA levels (percentage of total fatty acids) were measured by Nuclear Magnetic Resonance (NMR) spectroscopy but were converted to Omega-3 Index (percentage of EPA+DHA in red blood cell) for this analysis.

The three outcomes were available for 110,584 subjects (hospitalisation and death) and for 26,595 ever-tested subjects (positive COVID-19 PCR test result).

These COVID-19 outcomes were assessed between January 2020 and March 2021.

In the fully adjusted models, subjects with the highest Omega-3 Index levels were 21 per cent less likely to test positive added.

than those with lowest levels, the researchers said.

The risk for a positive test was 8 per cent lower for each 1-SD (standard deviation) increase in plasma DHA percentage, they said.

Subjects with the highest Omega-3 Index levels were also 26 per cent less likely to be hospitalised than those with lowest levels, and risk for hospitalisation was 11 per cent lower per 1-SD increase in DHA percentage, the researchers

The team noted that South Korea and Japan have reported an extremely low severity of COVID-19 disease.

Although masking practices, social distancing policies and other population-wide interventions contributed to this. they noted that the Omega-3 Index values of healthy South Korean and Japanese individuals are about 8-12 per cent and 7 11 per cent respectively, which is much higher compared to those of 4-5 per cent in Western populations such as

"This study confirms previous findings that low omega-3 status is associated with increased risk for hospitalisation with COVID-19," said William S. Harris, President, FARI.

"We extended these findings by also showing reduced risk for testing positive with the infection and by providing evidence that the risk for death may also be reduced," Harris

When people go to extreme lengths to take an image to share on social media perhaps in remote or picturesque locations they can risk their lives.

So we need to move beyond describing selfies as a social phenomenon, fuelled by the rise of smartphones and social

We need to treat dangerous selfies as the public health hazard they really are. **MORE DEATHS, YEAR AFTER** 

Certain picturesque locations have been linked to selfie deaths. This includes Yosemite National Park in California. In Australia, we've seen people die at places including cliffs, natural pools and waterfalls. THESE ARE NOT ISOLATED

**INCIDENTS** One study found 379 people worldwide were killed due to selfies between 2008 and 2021, with even more injured. Incidents are more likely in young

adults, particularly males. Many are travellers or tourists (particularly in Australia and the United States). In Australia and the US, selfie takers tend to be injured or killed while solo, and commonly in locations very difficult for

emergency services to access. In countries such as India and Pakistan, selfie takers are more likely to die, tragically, as a group, especially near bodies of water, such as lakes.

Researchers have called for the introduction of no selfie zones around hotspots, such as tall buildings. Russian and Indian authorities have introduced these. Russia has launched a safe selfie guide.

But it's not clear how effective these strategies have been. If anything, selfie incidents seem to be increasing globally. MEDIA CALLS THESE

### **FOOLISH, SELFISH**

The media often portrays people involved in selfie incidents as foolish or selfish.

This seems to confirm our research showing media reports often blame the victim. Reports almost never provide safety information.

But taking selfies is a normal part of everyday life for millions of people. We need to stop judging people who are taking risky selfies, and in-



stead see risky selfies as a public health issue

#### WHY IS THIS A PUBLIC **HEALTH ISSUE?**

We've had similar problems with other activities we now see as public health hazards. These include driving without a seatbelt, riding a bicycle without a helmet, smoking cigarettes or excessive alcohol

consumption. These are all examples people once considered normal, which we now see as risky. Taking dangerous selfies needs to be added to that list.

By thinking of these selfies as a public health issue, we move away from victim blaming and instead need to effectively communicate risk to selfie-takers.

One example relates to the popular selfie hotspot, Figure Eight Pools in the Royal National Park, New South Wales, where people can be overwhelmed by big, freak waves.

Authorities have produced a colour-coded risk rating that takes into account ocean and weather conditions. People can go online to see if the risk of going to the pools is very low to extreme.

If we think of these risky selfies as a public health issue we also move towards education and prevention. Signs at selfie hotspots are

one thing. But we know signs are often ignored, or simply not seen. So we need to better com-

municate safety messages to selfie takers when and how they will actually take notice.

Our research with Instagram aims to do this by communicating directly to selfie takers through the Instagram app. The aim is to tailor safety messaging to Instagram users by geolocating them with known risky selfie spots sending users a safety alert in real time.

With the right communication strategy, we know we can reduce the number of these entirely avoidable tragedies.

5 tips to stay safe when taking selfies in nature

1. Think about weather and water conditions

Weather and coastal conditions can change rapidly. Just because the weather and waves don't appear dangerous when you start your selfie journey, they might be when you get there. Check before you go, avoid bad weather, and keep a close eye on tidal and wave conditions.

2. Don't walk past safety signs and physical barriers

Warning signs are there to provide life-saving information. Pay attention to signs and heed their advice. Don't jump or go around any physical barriers blocking access. They are likely there for a good reason. 3. Stay on the designated

path Staying on paths and trails is safest and also does fragile

4. Don't get too close to the edge. Be aware of crumbling edges

Don't trust cliff edges and be aware of unstable ground. Cliff edges are naturally eroding and your extra weight doesn't help. People have died from cliff edges crumbling away while standing on them.

5. No amount of likes' is worth your life

# **Construction Of** 'WDS' In Eco-Fragile Zone Raises Eyebrows

SRINAGAR: The construction of an alleged "waste disposal structure" at Kijpora, Kangan by the Rural Development Department has left at least two government departments up in arms against the

The alleged "waste disposal structure" that is coming up near the Environment park in the environmentally fragile zone has raised alarm bells among locals and environmentalists.

On 3rd March, 2023, the Department of Ecology, Environment & Remote Sensing Office of the Mass Media Officer, Srinagar vide letter No: NMO/DEE/22-23/1064 has written to the block Development Officer, Kangan that the dumping of solid waste is going on unabated on the rear side of Environment park which is resulting in inconvenience to visitors besides adding to the dog menace.

"It is requested that dumping of solid waste be stopped forthwith as it is endangering the fragile ecosystem of the park and Sindh River. Early action is solicited" the letter

In another letter, the Executive Engineer Irrigation & Flood Control Division, Ganderbal on 3rd March,2023 has written to the Assistant Commissioner Development vide letter no: IFCD/GBL/7204-11 that the Rural Development Department, Kangan have started the construction of cerned tehsildar has provided



Waste Disposal Structure at Kijpora without seeking NOC from this Department.

"The said construction is being carried out 137m away from present water course of Sindh Nallah and is 42m away from present water course of Wangath Nallah"

"It is requested to direct the concerned Block Development Officer (BDO) to stop the work till proper demarcation is received till subsequent report is received from the concerned quarters" the letter reads.

However, the concerned BDO said that he has received no such letters and negated the claims that the Department was constructing a

'waste disposal structure.' Speaking to Kashmir Ob-server, BDO Kangan Mohammad Arif denied the claims and said the land on which the construction is carried out is far away and the con-

the land extracts as well.

"Streams flow across Kangan. Does that mean we don't have to construct anything. We don't carry out any construction work until we get a nod from the Revenue Department" Arif said.

Arif further said that people think that we are constructing a dumping site, which is not the case.

"We are constructing a Segregation Shed in order to stop illegal dumping of waste. The Shed will host machines which will help in the scientific disposal of waste.

"This is not a waste disposal site." He clarified.

"In order to clear the dumping site, we are constructing this structure" he added.



### **Excavation Of Khellani Tunnel's** 1st Tube In Doda Completed

**JAMMU:** The National Highways and Infrastructure Development Corporation Ltd (NHIDCL) has completed the excavation of the first tube of the strategic Khellani tunnel along NH 244, an alternative road connecting Kashmir with the rest of the country.

The work on the 1.574 km tunnel, which is crucial for the Sudhmahadev- Goha Khalleni Chhatroo Khanabal highway project, started on March 25, 2021, to provide alternative allweather connectivity and shorten the distance between Doda and Kishtwar districts by 30 km, an official said.

"The breakthrough on the Khellani project was achieved on February 24 but because of the loose strata, we are in the process of stabilising it. Within another 10 days, the work will be completed and in the next 7 to 8 months, this tunnel will be made motorable," senior site engineer, NHIDCL, Harieet Singh told PTI.

He said the work on the second tube is also going on at a brisk pace and if everything goes as planned, the breakthrough is expected by April-end.

The Khellani tunnel, constructed at a cost of Rs 431.28 crore, will bypass the slideprone Batote-Pul Doda which has already been declared "unsafe" due to the reservoir of Baglihar hydroelectric project.

In 2008, around half a-kilometre patch of the highway between Batote and Pul Doda washed away due to capillary action caused by Baglihar pondage, the officials said.

The management staff of

APCO Infra-Tech Private Limited, which is the contractor of the Khellani tunnel project, are also positive to complete the construction of the tunnel in time after the breakthrough of one of the twin tubes of the tunnel.

"We started the work on this tunnel in March 2021 and we have completed above 85 per cent of the work and have already successfully made the breakthrough of the 1st tube. There are maximum chances that we will complete the work within time," Assistant General Manager, Khellani Tunnel Proj-

ect, Vinay Kumar Singh said. He said the road has been planned to reduce the travelling time for the inhabitants of the Doda and Kishtwar districts and boost the economy of the area besides providing an alternate all-weather road between Jammu and Srinagar.

Doda district Vice President of BJP, Sanjay Saraf credited the local member parliament and Union Minister Jitendra Singh for his efforts in sanctioning and fasttracking the work on the project.

"This road will change the fortunes of the people of Doda and Kishtwar as the tourism industry emerging as the mainstay of the economy of the region will surely get a major boost because visitors no longer will be compelled to ply on a dangerous and treacherous road, instead they can enjoy the shorter and safer journey," Saraf said.

In current times, inflation is a burning global issue. The main reasons (at global level) being geopolitical crisis, supply-chain disruptions, trade sanctions, erratic exchange rates and the aftermath effects of the COVID-19 pandemic.

Inflation is dangerous because it directly affects the standard of living of the people. These days, all the economies of the world—underdeveloped, developing and developed nations—suffer from inflation

Inflation, in simplest terms, can be defined as the increase in the prices of most goods and services (of common use) over a given period of time. It measures the average price change in a basket of goods and services over a given period of time. Due to inflation, the purchasing power of a currency unit decreases as goods and services get expensive and this decreasing purchasing power of the currency directly affects the cost of living of the people and their spending and buying habits.

For instance, you bought a list of household essentials last month at an expense of Rs. 2,000 but this month, the price of a certain food item in the same list has risen and that has led to an increase in the cost to (say) Rs. 2100. Now, you have two choices: either you may be forced to reduce an item from your buying list or buy the same list of goods by paying an extra amount of Rs 100. This extra Rs. 100, which you pay for the same list of goods is due to inflation. In every country inflation is measured by a central authority and in India, inflation is measured by "The Ministry of Statistics and Programme Implementation".

#### How is Inflation measured?

In India, the inflation rates can be measured at three levels: producer, wholesaler and retailer (consumer). Prices generally rise at each level till the commodity finally reaches the hand of the consumer. These are described very briefly below:

Consumer Price Index (CPI): It is an index measuring retail inflation in the economy by collecting the change in prices of most common goods and services used by consumers. CPI is based on 260 commodities, but it includes certain services too. CPI is also called a market basket; it is calculated for a fixed list of items including food, housing, apparel, transportation, electronics, medical care, education, etc. The base Year for CPI is 2012. This index is used to calculate the Dearness Allowance (DA) for government employees. In India, there are four consumer price index numbers, which are calculated, and these are as follows: CPI for Industrial Workers (CPI-IW), CPI for Agricultural Laborers (CPI-AL), CPI for Rural Laborers (CPI-RL) and CPI (Rural/ Urban/ Combined).

The Wholesale Price Index (WPI): This is the most popular inflation rate calculation methodology in India. The index used to calculate wholesale inflation is known as 'Wholesale Price Index'. This method measures the average change in prices of goods at the wholesale level. This inflation rate is often known as headline inflation. It shows the combined price of a commodity basket comprising 676 items. WPI (2011-12) reckons only basic prices and does not include taxes, rebate/ trade discounts, transport and other charges. The new series of WPI with base 2011-12 is effective from April 2017.

# Inflation: A Global Burning Issue

Causes of Inflation

There are two types of factors that can cause inflation in an economy. They are Demand Pull Inflation (DPI) and Cost Push Inflation (CPI). DPI factors include the rise in population, increase in money supply, black money, rise in income, excessive government expenditure etc., while as CPI factors include the increase in production costs, rise in Minimum Support Price (MSP), rise in international prices, hoarding and black marketing, rise in indirect taxes etc.

Rising prices are a cause of concern not only for our country but also for the world at large, as the price rise over time reduces the purchasing power of the consumer.

Looking at the data on inflation rates released last month (12th January, 2023), the National Statistical Office (NSO) reported that the country's retail inflation, which is measured by the Consumer Price Index (CPI), dropped to a 1-year low of 5.72% in December 2022 from 5.88% in November, 2022. This year, on 16th January, the Ministry of Commerce and Industry reported that the Wholesale Price Index (WPI), which calculates the overall

prices of goods selling at wholesale prices, hit a 22-month low of 4.95% in Dec'2022, from 5.85% in Nov'2022. This is for the first time in the calendar year-2022 that the CPI inflation hit below the RBI's upper margin of 6%.

Decline in the rate of inflation in December, 2022 is primarily contributed to the fall in prices of food articles, mineral oils, crude petroleum and natural gas, food products, textiles and chemicals & chemical products. However, major economies of the world—like the USA, the UK and other European countries—observed hikes in the inflation rates due to the Russia-Ukraine war. CPI inflation reached historically high levels in the US at 8.6%, at 9.1% in the UK and at 7.9% in Germany in May 2022. In Japan, where CPI inflation often remains negative, it increased to 2.4%. In comparison to these nations, India's inflation rate was the lowest because of the timely steps taken by the Reserve Bank of India.

At the global level, Zimbabwe (269.0%), Lebanon (162.0%), Venezuela (156.0%) and Syria (139.0%) have the highest rates of inflation in the world, as per the records/ data of October 2022. Overall, the data further indicated that more than 100 countries have inflation higher than India. Among the major economies in Asia, inflation in Sri Lanka stood at 64.30%. Iran, Pakistan, Kazakhstan and Myanmar had inflation of 52.20%, 26.6%, 18.8%, and 16.1%, respectively, in October 2022.

The heat of increasing inflation is not only felt by the economy at large, but also by the individuals; i.e., by the consumers who resort to savings from their earnings. Inflation, however, silently enters our pockets and eats up the hard-earned monetary wealth saved with different motives.

Inflation is not always a bad thing; instead, inflation at a moderate level is desired in the economies, especially in developing countries like India. Uncontrolled and unchecked inflation can ruin the whole economy. Therefore, the responsibility for the government, policy makers, politicians and economists is to protect and safeguard the common man from the rising prices. Both the central government and the central bank (Reserve Bank) should try to tackle inflation with their policies which are known as Fiscal and Monetary Policies respectively.

Inflation is increasing day by day. It is obvious that the rate of inflation in the next 10 to 15 years will be much higher than today. Therefore, the best way to beat inflation is to invest money in such avenues in which there is a possibility of getting returns equal to or more than the inflation rate. Additionally, keeping an eye over monthly released inflation figures apprises us of the current state of our currency. It is always a prudent decision to plan spending and investment as per inflation rates. Since inflation is a macroeconomic phenomenon with an impact at the micro level, therefore taking decisions judiciously at the micro level can help to restrict the inflation at the macro level.

# Time To Abandon Colonial Geography

For instance, most people are familiar with such expressions as the 'Middle East' or 'Far East'. The question that immediately comes to mind is, 'middle' or 'far' from where? In other words, what is the starting point that is used to designate a particular name for a region?

olonialism has had a profoundly negative impact on victim societies in many different ways. From stealing their resources to imposing alien systems of education and languages on well-establish traditional societies, the colonial experience has been an unmitigated disaster.

Colonized people were taught to hate their culture, dress and local languages. Under colonial rule, they were forced to acquire western education to get a job in their own country. This necessitated learning the language of their colonial master whoever it happened to be. English, French, German, Dutch, Flemish (Belgium version of Dutch), Spanish or even Portuguese were imposed on colonized peoples.

Theoretically, colonialism has ended but it would be wrong to assume that the colonized states of Asia and Africa have achieved true independence. The elites in these societies have more in common with their colonial masters in Europe than their own impoverished masses. Many of these societies are also quite dependent on their former, or not so former colonial masters.

There is another area where colonialism, or more specifically British colonialism, has had a major impact on how the regions of the world have been named. For instance, most people are familiar with such expressions as the 'Middle East' or 'Far East'. The question that immediately comes to mind is, 'middle' or 'far' from where? In other words, what is the starting point that is used to designate a particular name for a region?

It would be immediately obvious that the starting point is assumed to be the tiny island of Britain, that pompously calls itself 'great' Britain. There is nothing great about it. In its hay days—the eighteenth and nineteenth centuries—it may have been a military power, primarily because of its naval strength, but today it does not rank even among the middle powers. Yet its disastrous legacy continues

to plague the world.

Let us be clear, Britain is not the centre of the universe even if the British continue to believe in this myth. True, there is one area where the British enjoy an advantage. English is considered a universal language. No other language comes close, not even French, much to the chagrin of the haughty French.

The reason is simple. People of British origin settled (colonized) many parts of the world: North America, Australia, New Zealand and parts of Asia such as India and Malaysia, and Africa. That is quite



an achievement for people living in grime and hardly able to afford potatoes. In North America, Australia and New Zealand, they committed genocide of indigenous peoples. The North American settlement was predicated on another myth: that Christopher Columbus had 'discovered' America. He had done no such thing.

The North American continent was already populated by Indigenous peoples who had their own wellestablished culture. In fact, there is evidence from tablets found in the US bearing Arabic writings that prove Muslims had predated Columbus by many centuries.

The Indigenous peoples lived in harmony with nature, unlike the European settlers who have also caused irreparable damage to the environment. Had the European settlers not massacred the Indigenous peoples, the native population in North America would be nearly one billion strong. Through genocide, they have been reduced to a few million scattered on far-flung reservations.

Let us, however, return to the question of colonial language and how various regions have been named. Instead of the 'Middle East', it is more accurate to call it West Asia. We already have Central Asia. the region that is also called Eurasia. Instead

of the Far East, it should be called by its proper name, Southeast Asia.

Let us reverse the equation. Suppose we take the heartland of the Muslim world as the centre of the world. It is not an unreasonable assumption. Based on this, North America would be called the 'Far West', Europe as the 'Middle West' and tiny England, which is so insignificant, it would not even merit a mention. Australia and New Zealand would be called 'Far South'.

How is that for rearranging the world's geographical language and paying the colonialists back in their own coin? It is time for the rest of the world, especially the Muslims to abandon the political geography of colonialism and use more accurate expressions to describe the various regions of the world. Asia is the world's largest continent. It should assert itself more forcefully. A good starting point would be to refer to the various regions of the world by a more accurate designation.

ack in 1990, Prof. Syed Maqbool Ahmad (in an Urdu quarterly, 'Islam aur Asr-e Jadid', 22, 1: 5-18, pp. 6, 16) wrote: "Islamic Studies, as a subject dealing with the study of Islamic history, culture and civilization, is not a new discipline"; "its name is new", but the not the subject itself and the contents it covers, because "the discipline is as old as Orientalism itself." Orientalism, literally the study of the Orient/ East, is here taken specifically to mean the study of Islam and Muslims. This is the general conception of the discipline, which has passed through different stages/ phases before it got this specific name, as become evident from many works, including Mapping Islamic Studies: Genealogy, Continuity and Change (Azim Nanji, 1997), Approaches to Islam in Religious Studies (Richard Martin, 2001) and Bloomsbury Companion to Islamic Studies (Clinton Bennett, 2013), to name a few: Orientalism, Theology, Religious Studies, Areas Studies and Islamic Studies. The concept of Islamic Studies as a social science discipline "has a long journey in contemporary world, having different meanings and perspectives in Arab world and in Western world"

The history of Islamic Studies, both in the West and East, is centuries old. In the West, it has passed through different stages/ phases (beginning with Orientalism). In the East, including the Indian context, its history dates back, to speak from the academic/ teaching point of view, to the early decades of 20th century. Similarly, in J&K it was introduced from late 1980s.

It will not be unfair to add here that the history of subject is both 'extensive and complex'. It has passed through different stages, and has transformed, especially in the past few decades, tremendously. Keeping in view the significance of the subject, its long history both in Western as well as in Eastern/ Arab world and considering the fact that it is subject of utmost importance in India too, so there have been many attempts to narrate and recount its journey. Though most of these attempts have been made by the Western scholars (like Nanji, Martin, Bennett and others) with a more focus on the evolution and development of this subject within the western perspective, there are few attempts by the Muslims of India too to recount the journey of this discipline, at global level in general and in the Indian context in particular. Two (2) such recent attempts are: Prof. Mohd. Fahim Akhtar's Islamic Studies: Concept, Present Scenario and Future (published in August 2022) and Dr. Ashraf Amin's Islamic Studies in Academia: Evolution, Approaches and Prospects (published in January 2023): Former is a compilation of

the selected papers presented in a two day national seminar organized by 'Department of Islamic Studies' (DoIS), MANUU and Henry Martin Institute, Hyderabad (HMI) on April 24-25, 2019, while as later attempts to put Islamic Studies as a social science discipline] in the proper perspective by accounting and narrating its development in general and in Kashmir in particular, with the aim "at facilitating the understanding of Islamic Studies as a social science discipline and its current status in addition to its future prospects" (p.3).

The objective of the Seminar organized by DoIS, MANUU was "to elaborate and examine the achievements of Islamic Studies in recent past, and to chalk out the action plan for future." In this seminar, a total of thirty-two (32) papers (both in Urdu and English) were presented by senior and young faculty members and researches of the subject—from Kashmir to Kolkata. Out of these, eighteen (18) papers have been compiled in Prof. Akhtar's Islamic Studies: Concept, Present Scenario and Future, which are preceded by 'Message', 'Preface' and 'Introductory Remarks', respectively by the VC, Director of Translation and Publication Division, and HoD, DoIS, MANUU, and ends with Seminar Report (by Dr. M. Irfan Ahmad) and 'Suggestions and Recommendations' (by the senior and young paper presenters)

Compiled by Prof. Akhtar (Head, DoIS, MAN-UU), Islamic Studies: Concept, Present Scenario and Future consists of eighteen (18) chapters and are divided thematically under three (3) parts: Part-I, "Islamic Studies: Concept and History" (chapters 1-4); Part-II, "Institutions of Islamic Studies in India and their Contribution" (chapters 5-10); and Part-III, "Islamic Studies: Curriculum, Contemporary Relevance and Future (Prospects)" (chapters 11-18).

The main theme of the chapters 1 and 3 in part-I and chapters 11-15 in part-III is the discipline of Islamic Studies at the global and national level, its genesis and development in East and West, transitions and transformations of the subject rom early stages to the current times as well as contemporary relevance, challenges, and future prospects of this discipline. Few chapters threw light on the journey of the subject from 'Orientalism to Islamic Studies (chapter 3), contemporary issues/ trends in research to be explored in Islamic studies (chapter 12) and Chapters 2, 4 (in part-I), 5-10 (pat-II) and 16-18 (part-III) discuss the teaching and research, curriculum and contribution of various departments/ institutes of Islamic Studies, spread throughout India (like Jamia Milia Islamia, Aligarh Muslim University, Aliah University, MANUU, Osmania University, Lucknow University), contribution of Zakir Hussain Institute of Islamic Studies (JMI) and Islamic Studies through the Distance Education at MANUU as well as a general survey of the development of the subject in India, since 1920. Many chapters also provide comparative analysis and evaluation of the curriculum taught at various universities (chapter 17) as well as content analysis of selected courses like 'Islam in India' (chapter 16).


All in all, Islamic Studies: Concept, Present Scenario and Future is a valuable and significant contribution which will prove helpful to the students and researchers of Islamic studies not only to know genesis and genealogy of the subject at global level and in Indian context but also to know about the curriculum, teaching and research in this subject, while not overlooking its challenges and future prospects.

Dr. Ashraf Amin's Islamic Studies in Academia (published in January 2023 by a local publishing house) attempts to account and narrate the history of Islamic Studies, as a social science discipline, in general and in Kashmir in particular and tries to put it in the proper perspective y referring to the genesis and genealogy of this subject from Western and Islamic perspective by looking at its present scenario and taking into consideration the future prospects as well (pp. xii, 3). In the Introduction (pp.1-4), the author (presently working as an Assistant Professor, Department of Religious Studies, Central University of Kashmir) presents the overall objective and purpose of this work in these words: the book attempts "to acquaint the readers to the discourse on Islam and Islamic Studies in the Western and Muslim scholarly circles. The work is not an exhaustive account of the historical journey of Islamic studies in Muslim and Western scholarship but ... [it does] not fail in offering a healthy overview of Islamic studies as an academic discipline in Western and Muslim academia till date." (p. 3)

Divided into eight (8) chapters (excusing Introduction and Conclusion), preceded by Acknowledgements, Preface (pp. x-xii) and Introduction (pp. 1-4) and a Foreword (pp. vii-ix) by Prof. Sayyid Muhammad Yunus Gilani (presently at IIUM, Malaysia) and ends with Conclusion (pp. 97-101), Bibliography (pp. 105-110) and Appendix (pp. 111-146).

In his 'Foreword', Prof. Gilani (who is a pioneering figure in establishing Islamic Studies at Shah-i-Hamdan Institute of Islamic Studies (SHIIS), University of Kashmir in particular and in J&K in general, 'Teacher of the Teachers' in this field and has been aptly described by Dr Amin as "one of the unparalleled Islamic Studies scholars" [p. 113]) puts forth that "Islamic Studies is [an] all comprehensive and all-embracing discipline", which "aims at overall personality building of an individual on Islamic

lines" for it is "a life-long process of study and development" (p. vii). He appreciates the efforts of Dr. Amin in these words: "the author discusses the fallacies of the Western scholarship in understanding Islam and Muslims; he has considerably deliberated

upon the genesis of Islamic Studies within Islamic framework" and thus calls this book as a helpful reference guide in "understanding and comprehension of Islamic Studies as an academic discipline" (p. ix).

In its eight (8) chapters, the book throws light, albeit briefly, on the genesis ad genealogy, evolution and growth, methods and approaches, challenges and prospects of this discipline by discussing its 'Nature, Origin, Definitions', 'Western' and 'Islamic' contexts, Traditional and Modernist Approaches, place and position of Islamic studies as a social science subject, followed by three chapters on its place in Modern-day Academia, in Malaysian Seminaries and its history and growth in J&K. The

main points, arguments and historical facts vis-àvis the concept and growth of Islamic studies as a multi/inter/trans-disciplinary social science subject are summarized below:

The field of Islamic Studies, which is often taken for-granted (resulting in misunderstanding it), emerged as a formal social science discipline in the West at the dawn of the modern era, but a lot has changed since then (p. xi);

The emergence of the modern academic study of Islam in the West was primarily associated with the Oriental Studies or Orientalism, which later on witnessed two major developments: 'scientific study of the history of religion' (or as a part of Religious Studies) and studying Islam/ Muslims as a social science subject under the 'study of "other" cultures and peoples', revealing that its boundaries were constantly being revised (pp. 8, 9);

The study of Islam and Muslims in the Western academy has a long and perplexed history (p. 19);

Western studies of Islam progressed from viewing it in the 12th century as a Christian heresy or a false religion to more systematic and disciplined approaches in the late 16th and 17th centuries (p. 24);

The contemporary approach of Western scholarship towards Orient, especially the Muslim Orient, would be labelled as 'New Orientalism' that views Islam and Muslims in terms of 'anti-modernity and anti-democracy' (p. 32);

In Islamic framework, Islamic Studies is a faithbased study of Islamic religious sciences intended to preserve Islam through approximate interpretations for posterity (p. 37);

There are two major trends in studying Islam, viz., 'imperial prejudices' and 'systematic view'; and since the second half of 20th century, later has become 'general trend' (p. 43);

Pubic interest in Islam has increased dramatically in the first decade of 21st century, especially since the events of 9/11, which has powerfully affected the discipline of Islamic studies (pp. 74-75); and

Inter-disciplinary and trans-regional centres for the study of Islam and Muslims in modern world have been identified as key locations for the development of new approaches to Islamic studies (p.76).

This is followed by a chapter on "Islamic Studies in Jammu and Kashmir" (pp. 92-96) in which the author narrates the history of Islamic Studies as "one of the prime subjects in humanities and social sciences" which has seen an "increasing interest" among the students for its "multi-disciplinary nature" (p. 92). It provides a brief profile of the departments of Islamic Studies in a chronological order with a focus on their academic achievements since their inception, viz., SHIIS, University of Kashmir (KU; 1988), DoIS, Islamic University of Science and Technology (IUST; 2006), Department of Religious Studies (DoRS), Central University of Kashmir (CUK; 2017) and DoIS, Baba Ghulam Shah Badshah University, Rajouri (BGSBU; 2017). He describes these departments, respectively, as: SHIIS has "acted as pioneer in the progress and consolidation of Islamic studies in modern academia"; DoIS, IUST has "made a unique name in academics" by generating a "great atmosphere of learning and research"; DoRS, CUK is the "first of its type where religious understanding, religious literacy and Islamic sciences meet for a joint academic stride" and is "fine blend" of trans/inter/multi-disciplinary "approaches in religion and Islamic studies"; and DoIS. BGSBU, though youngest of all, has "outshined all other departments of Islamic studies in organizing seminars, workshops, conferences despite limited resources" (pp. 92, 93, 94, 95). However, one finds it surprising to note that the author has referred to the journal, Revelation (which is still in its infancy) published by DoRS, CUK but has ignored the SHIIS, KU's annual journal Insight Islamicus—published since 2001 and indexed in London-based Index Islamicus. Also, surprising is the fact that in profiling these departments, he has focused on faculty members of SHIIS, KU while in others he has not mentioned the names of any faculty member and even date of establishment of the department is not mentioned in each case.

These chapters, most of them being brief, are followed by 'Conclusion' in which he tries to summarize overall history of the subject from Western and Muslim perspectives and concludes that "Islamic studies, as taught in the west, is a discipline that seeks to explain what the Islamic [read as Muslim] world has achieved in the past and what the future holds for it" (p. 102).

In the Appendix (pp. 111-146), he has provided academic profile of the a dozen faculty members of Islamic studies who have worked are and/or working in the universities of KU, IUST, CUK and BGSBU.

Though addressed, and written for the students and scholars of Islamic studies, the book has many shortcomings; some of them include: inconsistency in referencing style and in Bibliography; incomplete or no references for many quotations and statements (see e.g., pp. 8, 16, 41, 5-56, 59, 62, 67); indirect/ secondary references for easily available/ accessible books (see e.g., pp. 41, 50, 52); typo errors (pp. 97, 133); and no coverage or profiling of Islamic studies departments of India.

Keeping aside these shortcomings, Dr. Ashraf Amin's Islamic Studies in Academia is a valuable reference guide for the students and scholars of Islamic studies which will prove helpful to them in understanding and comprehension of Islamic Studies as an academic discipline.

All in all, both these works by Prof. Akhtar and Dr. Amin make a substantial contribution to the literature (in Urdu and English) on narrating and describing the history of the discipline of Islamic studies as a social science subject at the local, national and global levels. Both will prove helpful in knowing and understanding the genesis, genealogy, growth, approaches, challenges and prospects of Islamic Studies as an academic discipline.

# Army Releases Photos Of Soldiers Playing Cricket In Eastern Ladakh

**New Delhi:** The Indian Army has released photos and videos of its soldiers playing cricket at a very high-altitude forward location in eastern Ladakh amid the lingering border row with China along the Line of Actual Control (LAC) in the region.

The Army's Leh-based Fire and Fury Corps, which is responsible for guarding the LAC in the Ladakh sector, released the photos and said, "We make

the impossible possible." The match was played at an altitude of 14,500 ft and reflects the high morale and enthusiasm of the soldiers deployed in the inhospitable terrain, sources in

the military establishment said. However, the exact location was not mentioned.

The Fire and Fury Corps said in a tweet on Friday that the cricket competition was organised at an "extreme high altitude" area in sub-zero temperatures.

"Patiala Brigade Division organised a cricket competition in an extreme high altitude area in sub-zero



temperatures with full enthusiasm and zeal. We make the Impossible Possible," it said. A short video clip of the match

has also come out. This comes amid the continuing standoff between Indian and Chinese troops in the Demchok and Depsang regions of eastern

Ladakh. Tensions erupted on May 5, 2020 following a violent clash in the Pangong lake area. The ties between the two countries nosedived significantly fol-lowing the fierce clash in the Galwan Valley in June 2020 that marked the most serious military conflict between the two sides in decades.

As a result of a series of military and diplomatic talks, the two sides completed the disengagement process in 2021 on the north and south banks of the Pangong lake and in the Gogra

In line with a decision taken at the 16th round of military talks, the two sides carried out disengagement from Patrolling Point 15 in the Gogra-Hotsprings area

in September last year.

But the face-off between the two of the planet's biggest military forces lingered on in Demchok and Depsang regions though the Indian side pressed for completion of the disengagement in remaining friction points at the earliest.

On February 22, India and China held in-person diplomatic talks in Beijing and discussed proposals for disengagement in the remaining friction points along the LAC in an "open and constructive manner".

# SC Releases Youth Awarded Death Penalty After Holding He Was Juvenile At Time Of Offence

New Delhi, Mar 3 (PTI) The Supreme Court on Friday ordered the release of a 20-yearold man, who was awarded the death penalty for rape and murder of a four-year-old child in Dhar district of Madhya Pradesh in 2017, after holding he was juvenile when the offence was committed.

A bench of Justices BR Gavai, Vikram Nath and Sanjay Karol said, "The conviction of the appellant (youth) is upheld; however, the sentence is set aside".

It said since the appellant at present would be more than 20 years old, there was no requirement of sending him to the Juvenile Justice Board or any other child care facility or

"Appellant is in judicial custody. He shall be released forthwith," the bench said and modified the November 15, 2018 order of the Indore bench of the Madhya Pradesh High Court by which it had confirmed his conviction and death sentence in the case.

The top court, which passed the verdict on the appeal of the youth, had ordered an inquiry by the trial court into the juvenility claim made by him.

"We have perused the report and also the material evidence led before the Trial Court on the basis of which the conclusion has been drawn by the Trial Court. The report is based upon documentary evidence as also oral evidence of the present head-mistress, the retired headmaster, five teachers of the primary institution and also the guardian of the appel-

lant," the bench said. It said it would also be pertinent to note that the institution is not a private institution but a government primary school and this court does not find any reason to disbelieve or even doubt the testimony of government servants both working and retired.

"In addition to the mark sheets by the institution, there is also the date of birth certificate issued by the institution. Further, the original Scholar register and other documents were also produced before the Trial Court in the inquiry.

"This Court, therefore, has no reason to doubt the correctness of the conclusion arrived at by the Trial Court regarding the date of birth of the appellant. We, therefore, accept the report of the Trial Court and hold that the appellant was aged 15 years, 4 months and 20 days on the date of the incident," the bench held.

The top court rejected the plea of the state government that the accused be sent for ossification test to ascertain his claim of juvenility on the ground that the state has not raised any objection during the inquiry done by the trial court.

"Secondly, ossification test will only give a broad assessment of the age. It cannot give an exact age. There is also an element of margin of plus or minus 1 to 2 years. Even if we permit the said test, it does not lead us anywhere. It will have no bearing on the assessment made by the Trial Court after the inquiry," it said.

Referring to the provisions of the Juvenile Justice (Care and Protection) Act, 2015, the bench said the law provides full coverage to a person who is established to be a child on the date of the offence to avail the benefits admissible to a child under the law, even if the case has been finally decided and also such person has attained majority.

KHROMOVE (UKRAINE): Pressure mounted Saturday on Ukrainian troops and civilians hunkering down in Bakhmut, as Kyiv's forces tried to help residents flee amid what Western

analysts say may be preparations for a Ukrainian withdrawal from the eastern city that Russian forces have spent months trying to capture.

A woman was killed and two men were badly wounded by shelling while trying to cross a makeshift bridge out of Bakhmut on Saturday, according to Ukrainian troops who were assisting them.

A Ukrainian army representative who asked not to be named for operational reasons told The Associated Press that it was now too dangerous for civilians to leave the city in Donetsk province by vehicle and that people had to flee on foot instead.

Bakhmut has for months been a key target of Moscow's grinding eastern offensive, with Russian troops, including large forces from the private Wagner Group, inching ever closer to

Kyiv's key eastern stronghold. An AP team near Bakhmut on Saturday saw a pontoon bridge set up by Ukrainian soldiers to help the city's few remaining residents reach the nearby village of Khromove.

Later, they saw at least five in the eastern Donetsk region.

# **Top Scientist Behind Russia's Sputnik V Covid Vaccine** 'Strangled To Death With A Belt

MOSCOW: Andrey Botikov, one of the scientists who helped to create the Russian COVID-19 vaccine Sputnik V, was strangled to death with a belt at his apartment here and police have arrested a suspect in connection with the murder, according to a Russian media report on Saturday.

Botikov, 47, who worked as a senior researcher at the Gamafor Ecology and Mathematics, was found dead in his apartment on Thursday, Russian 2020, according to reports. News Agency TASS quoted the Investigative Committee of the Russian Federation as saying.

Russian President Vladimir Putin honoured the virologist with the Order of Merit for the Father-

land award for his work on the leya National Research Center COVID vaccine in 2021. Botikov was one of 18 scientists who developed the Sputnik V vaccine in

> His death is being investigated as a murder, the committee, which is the investigating authority in Russia, said in a Telegram statement.

According to investigators, a

29-year-old young man strangled Botikov with a belt during an argument and fled. Law enforcement agencies said the murder was a domestic crime and the result of a conflict, the report said.

The suspect was arrested shortly after Botikov's body was found, the federal investigative agency said in the statement.

"The location of the attacker was established in short order. During the interrogation, he pled guilty and was charged. The defendant has a previous criminal record, as he stood trial on charges of committing a serious crime. In the near future, the investigation plans to petition the court to place the defendant in custody pending trial," the Investigative Committee said.

## **UN Nuclear Head Meets With Iranians Amid Enrichment Concerns**

# **Hubble Captures A Time-Lapse Movie Of DART Collision: NASA**

WASHINGTON: National Aeronautics and Space Administration's (NASA's) Hubble Space Telescope captured a series of photos of asteroid Dimorphos when it was deliberately hit by a 1,200-pound NASA spacecraft called DART on September 26, 2022, according to their statement.

Hubble's time-lapse movie of the aftermath of DART's collision collide with an asteroid in a binareveals surprising and remarkable, hour-by-hour changes as dust and chunks of debris were flung into space, NASA said in their statement.

Smashing head on into the asteroid at 13,000 miles per hour, the DART impactor blasted over 1,000 tons of dust and rock off of the asteroid.

The Hubble movie offers invaluable new clues into how the debris was dispersed into a complex pattern in the days following the impact, NASA said.

This was over a volume of space much larger than could be recorded by the LICIACube cubesat, which flew past the binary asteroid minutes after DART's impact, they said.

The primary objective of DART, which stands for Double Asteroid Redirection Test, was to test our ability to alter the asteroid's trajectory as it orbits its larger companion asteroid, Didymos, the agency said.

Earth, data from the mission will help inform researchers how to potentially divert an asteroid's path away from Earth, if ever necessary, the statement said.

The DART experiment also provided fresh insights into planetary collisions that may have been common in the early solar system.

"The DART impact happened in a binary asteroid system. We've never witnessed an object ry asteroid system before in real time, and it's really surprising.

"I think it's fantastic. Too much stuff is going on here. It's going to take some time to figure out," said Jian-Yang Li of the Planetary Science Institute in Tucson, Arizona.

The study, led by Li along with 63 other DART team members, was published on March 1 in the journal Nature.

The movie shows three overlapping stages of the impact aftermath: the formation of an ejecta cone, the spiral swirl of debris caught up along the asteroid's orbit about its companion asteroid, and the tail swept behind the asteroid by the pressure of sunlight, resembling a windsock caught in a breeze, the statement said.

The statement described that the Hubble movie starts at 1.3 hours before impact. In this view both Didymos and Dimorphos are within the central bright Though neither Didymos nor spot; even Hubble can't resolve Dimorphos poses any threat to the two asteroids separately.
