# **Ants Play An Important Part In Forest Regeneration: Research**

nts have a significant role in forest regeneration, according to a recent paper from Binghamton University, State University of New York.

Walk through an old-growth forest in early spring, and you'll be dazzled by wildflowers, their jewel-like tones shining from the forest floor. But in newer forests,

spring ephemerals such as trillium, wild ginger, violets and bloodroot are in shorter supply. The reason may lie with some less-flashy forest residents: Aphaenogaster sp., or the woodland ant.

"Not a lot of people have heard of them, but they are the powerhouse of moving seeds and called 'keystone dispersers,'" explained Carmela Buono, a Binghamton University doctoral candidate in biological sciences.

More than 95% of New York state forests -- including the Binghamton University Nature Preserve -- are secondary forests, which sprung up on land once cleared for agriculture. While parts of these

regenerated forests, such as the overstory, have recovered well, they are missing other aspects of biodiversity -- particularly when it comes to understory plants such as native wildflowers.

Many plant species rely on a mutual relationship with ants to disperse their seeds. In fact, northeastern North America is one of the major hotspots of ant-plant mutualism, although it also happens in parts of Europe, Australia, South Africa and in northeastern Asia, Buono said.

"These plants evolved with seeds that have an appendage rich in fats attached to them, and that's very attractive to woodland ants," she said. "Ants need fats just as much as protein and sugar, and it's hard to find foods rich in fats in the forest." Shiny black and medium-sized, woodland ants are a native species that lives in logs,

forest leaf litter and underneath rocks. Woodland ants take the seeds with fatty rewards back to their nests, protecting them from consumption by rodents and other organisms. Once the fatty appendages are consumed, the ants -- in a kind of insect housekeeping --

remove the seeds from the nest, dispersing them far from the original plant. It's a mutually beneficial arrangement. There are so many interesting, intricate parts of this

interaction depending on the types of seeds ants prefer, so you can get this beautiful mixing of flower species in forests," Buono said. How are old growth

#### forests different? Old growth forests are

rare treasures that play an important role in preserving species diversity, Buono pointed out. Pockets of the Northeast's ancient forest cover remain in some areas, often on land deemed unsuitable for farming. They differ from sec-

ondary forests literally starting at the ground level. Ground previously cleared for agriculture is flat, whereas old growth forests have a "pit and mound" topography. "It's uneven, from years

and years of trees falling over," Buono explained. The pits are left from the roots of toppled trees lifted out of the ground,

while mounds result from the extracted root and soil.

Species within the two types of forest are also different, with quick colonizers moving into younger woodlands. An established forest often features a greater number of shadetolerant plants in the un-

derstory. There are slightly fewer woodland ants in secondary forests, perhaps owing to their displacement during years of agricultural use. Differences in forest canopies and the amount of light that reaches the forest floor could also play a role, but that has yet to be explored, Buono said.

The real issue appears to be competition with invasive slugs, which are found largely in the regenerated woodlands and also have a taste for fatty seed appendages. Slugs often prefer forest edges, and secondary forests may be located closer to habitats that slugs prefer, such as open meadows or active farms, Buono said.

To restore newer forests to a healthier state, we need to look beyond the trees to the diversity of insects, which play a crucial role in the forest ecosystem, according to the researchers.

## **Sessions Court Sets Aside Conviction** Passed Against Managing Director Al Mehmood Builders.

Court of 4th Additional sessions judge Srinagar set aside the conviction passed against managing director of M/s Al Mehmood Builders Srinagar namely Sikandar Khursheed Dar after hearing an appeal against the order dated 5.5.2022 passed by trail court against him. Earlier the trail court vide order dated 5.5.2022 sentenced the Sikander Khursheed to undergo imprisonment of one year (including 6 months rigorous imprisonment) and also directed him to pay compensation amount of rupees 32,24000/= (Thirty two lakhs and 24 four thousand rupees) less by 4 lakh rupees which he had already paid during proceedings.

The Appellate Court after hearing Advocate Abrar Ahmad Bhat counsel for M/S Al Mehmood Builders set aside the conviction order dated 5.5.2022 and observed that the matter was already settled before the trail court by virtue of order dated 26.4.2022 and in pursuance to settlement rupees 4 lacs were paid by the MD of Almehmood Builders to the complainant as such directed the appellant to pay rest of the outstanding amount to the complainant with direction to the trail court to recover the lump-sum amount of rupees 20 lakhs less by rupees 4 lakhs from the appellant.

## **KU To Invite Online Applications** For PG Entrance Test Soon: VC

Vice-Chancellor Srinagar: University of Kashmir Prof Nilofer Khan on Monday chaired the Admission Advisory Committee to review the varsity's preparedness for admissions to various PG programmes and other professional courses for the academic session 2023.

In her opening remarks, Prof Nilofer said the University's admission process is recognised in academic and social circles as completely transparent and it is therefore important to maintain this benchmark through and through, a statement issued reads.

Asserting that the standard of the admission process has a direct bearing on the reputation and image of the institution, the Vice-Chancellor emphasized the need to make greater use of technological advancements to ease the admission process right from submission of online applications by the aspirants to declaration of the results.

After threadbare discussions on various issues, the Advisory Committee decided that the University's Directorate of Admissions and Competitive Examinations (DACE) will invite online application forms for admission to all programmes offered through University of Kashmir in the 3rd week of March 2023, following which the Entrance Test shall be conducted in the last week of April, 2023

For convenience of aspirants hailing from far-off areas of Jammu and Kashmir, the Vice-Chancellor instructed that besides the main campus, the entrance examination shall be conducted at all satellite campuses of the University including South Campus (Anantnag), North Campus (Baramulla) and Kupwara Campus for the session-2023.

'Our endeavor should be to take the admission process to the doorsteps of the aspirants," she said.

Calling for close monitoring of the Entrance Test by observers on the entrance test days, Prof Nilofer instructed that efforts should be made to ensure that the entire admission process culminates within the set timelines so that the academic session starts in time and the degrees are eventually awarded to the students in time.

# From KO Archives People Line Up For Historic Bus Travel

rinagar - Hundreds of enthusiastic people lined up at Re-gional Passport Office in Srinagar on Friday for application orms for travel on the first bus in 57 years to other part of Kashmir separated by a military Control Line.

New Delhi and Islamabad agreed in February to start (lie bus service between two capitals of Srinagar and Muzaffarabad on either side of the divide.

Significantly both rivals dropped their rigid stances and agreed demands by Kashmiris to use simple permits instead of passports of either country for traveling from one part to another of the divided state which people here regard as a single entity.

Kashmiris will use special permits, issued by both sides, to cross the Line of Control, instead of passports and visas. On the first day the Passport Office, designated as issuing authority, provided 100 application forms to people wishing to travel on April 7 and 14.

"We have issued 100 application forms to people wishing to travel on the Srinagar-Muzaffarabad bus on April 7 and 14." said passport officer John Silshi. Sixty people will be allowed to make the trip on those dates after security and intelligence agencies check their applications.

"It's a great day. I heard an announcement on radio and came rushing. Thank God I got the form! Now I hope that I will get a permit as well." said Mohammad Shafi as he clutched the document

However, many others were disappointed. Omar Imtiyaz from Baramulla said he could not apply for the permit. It wasn't immediately clear why.

"They should have issued more application forms." he said. "I have been waiting for this day since the service was announced. I am sad.'

The 105-mile bus route culling through the scenic Kashmir valley along the river Jehlum was a major all-weather trade route till 1948.

Recent heavy snowfall which blocked Kashmir's only road link with India created severe shortages of essentials in the Kashmir valley besides stranding thousands for the weeks together leading to deaths of scores of passengers. The road has been since come to be known as a killer highway. The reopening of new road is being viewed as a major development ever since Kashmir conflict began nearly six decades ago. 'Your research should begin and end with literature review. If the students are writing the last chapter of the research, it is a lifeline for the entire research process." He said.

# **Boom In Tourism**

record 2.5 lakh tourists visited Kashmir in the first two months of this year. Last year, over 1.6 lakh visitors were in the valley over these two months. The rising inflow of tourists follows the record number of arrivals last year. Around 27 lakh tourists, including 3.65 lakh Amarnath yatris and over ten thousand foreigners, visited Kashmir during 2022. The Jammu and Kashmir administration anticipates a 15-20 percent yearon-year increase in visitors to the Union Territory in 2023 and has planned 75 alternative destinations to lower footfalls at the most popular attractions.

Bollywood's return to Kashmir has also added to the prevailing atmosphere of normalcy and hopefully will bring more holiday makers to the Valley. Currently, actors Ranvir Singh and Alia Bhatt are shooting for Karan Johar's film Rocky Aur Rani Ki Prem Kahani in Valley. Last year, filmmaker Onir shot in Gurez, close to the Line of Control in north Kashmir, for his Chahiye Thoda Pyaar movie.

The tourism department has said that an advertising campaign across major Indian cities and the opening of new destinations have helped. The UT government has also increased the options for tourists by developing more resorts. For example, Aharbal, Yusmarg, Tosamaidan, Gurez, historic old city in Srinagar, are finding a prominent place on the tourist map of Kashmir. These places need further development of tourist infrastructure and also wider publicity for people to visit. So current year could be hoped to see more tourists visiting the Valley.

The growing tourism has gone a long way to shore up Kashmir economy and bring back employment lost to the successive security and Covid-19 lockdown. The boom the sector is also having a positive spillover effect on other sectors. The sector forms 6.8 percent of Kashmir's GDP and employs over two million people.

Over the last two years, a combination of factors has made the tourism boom possible: There is now a perception across the country that after the revocation of Article 370 J&K has been fully integrated into India and finally ushered in peace - which it no doubt has. The union territory, a recent MHA report said, witnessed "a 54 percent reduction in terrorist incidents, a 22 percent drop in recruitment of militants and 84 percent decline in the deaths of security forces." In real terms, the militancy related violence has decreased from 417 incidents in 2018 to 229 in 2021 while the number of slain security personnel dropped from 91 in 2018 to 42 in 2022. Here's hoping that this trend continues this year wello, a prerequisite for not only bringing more tourists to the valley but also helping the growth of the local economy overall.

# Why Isn't Mental Healthcare Act 2017 Being Implemented In J&K?

**Dementia isn't** the only problem that plagues J&K's mental health scenario. Anxiety disorders, depression and PTSD are prevalent in the

ne crisis of mental health issues in Jammu and Kashmir is quite evident. Over the years, the figures coming out of J&K have only painted a picture which is getting grimmer by the day. In a recently published report which quoted from a joint study published recently by the University of Southern California and All India Institute of Medical Sciences AIIMS- New Delhi, a considerably high percentage of people (11%) suffer from dementia in Jammu and Kashmir. Of these 11%, over 60% are prone to getting affected by Alzheimer's disease as well. In fact, dementia is not a single disease but encapsulates a range of disorders affecting the brain.

Dementia isn't the only problem that plagues J&K's mental health scenario. Anxiety disorders, depression and PTSD are prevalent in the Kashmiri population in high numbers. Year after year, reports have kept mapping the deteriorating condition of mental health in Kashmir. The uptick in suicides, especially during covid-19 pandemic, had also raised an alarm about a crisis that keeps getting worse. Very recently, a young 16-year-old from Sopore died by suicide. Yet another 21-year-old college student from Sugen Khag district in Budgam also died by suicide recently.

In Jammu & Kashmir, the obsoleteMental Health Act 1987 is being followed by the authorities at helm of affairs. The Mental Healthcare Act 2017 which repealed the Mental Health Act 1987 is not being followed. This law was enacted to conform with the United Nations Convention on Rights of Persons with Disabilities (UNCRPD) which is an international human rights convention which sets out the fundamental human rights of people with disability.

As per the provisions of the Mental Healthcare Act 2017, the Government has to constitute Central Mental Health Authority, State Mental Health Authorities and Mental Health Review Boards. The state mental health authorities are to be set up even in UTs with a legislature like J&K. The State Mental Health Authorities have been entrusted to supervise all mental health establishments of the State including UTs with legislature. In most of the Indian states, including J&K, these au(d) Register clinical psychologists, mental health nurses and psychiatric social workers in the State to work as mental health professionals, and publish the list of such registered mental health professionals in such manner as may be specified by regulations by the State Authority.

Train all relevant persons including law enforcement officials, mental health professionals and other health professionals about the provisions and implementation of this Act.

(f) Discharge such other functions with respect to matters relating to mental health as the State Government may decide. The Mental Healthcare Act 2017 says that the mental health establishments in the State before the commencement of 2017 Act, under the Mental Health Act, 1987 or any other law for the time being in force, shall be deemed to have been registered **Conclusion**

# Why India needs a Green Revolution 2.0

he fact that the country produces more foodgrains now during the rabi (winter-spring) than in the kharif (post-monsoon) season is testimony to the role of irrigation in drought-proofing. But what can farmers do with mercury spikes in February and March? These threaten rabi harvests, which were hitherto considered assured and immune from rainfall vagaries. While rabi crops were always vulnerable to spring thunderstorms and hail, the risks from them pale in comparison to that on account of shorter winters and advanced onset of summers.

The impact of temperature surge was seen in March 2022, when the wheat crop had just entered its final grain formation and filling stage. The heat stress led to early grain ripening and reduced yields. This year, February recorded the highest-ever maximum temperatures, thanks to the absence of active western disturbances that bring rain and snowfall over the Himalayas, whose cooling effect percolates into the plains. Currently, both minimum and maximum temperatures are ruling 3-5 degrees Celsius above normal in most wheat-growing areas. The next couple of weeks or more are going to be crucial. So long as the maximum remains within 35 degrees, there should be no danger of March 2022 repeating itself. But it only highlights how much of a "gamble on the mercury" agriculture has become.

Climate isn't the only risk farmers are confronting. Even as the prospects for wheat are uncertain, prices of onion and potato have crashed. Mustard, too, is trading below its minimum support price with the arrival of the new crop — a far cry from the situation a year ago when edible oil inflation had peaked following Russia's invasion of Ukraine. The dual risks from climate and prices may not be new; the difference lies in their frequency, volatility and intensity. Farmers, scientists and policymakers have to adapt to this reality. Green Revolution 2.0 has to be about varieties that can withstand extreme temperature and rainfall variations, while yielding more, using less water and nutrients. This should be accompanied by better crop planning and market intelligence: Farmers must know what to plant, how to manage their crop at various stages under different stress scenarios, and when to sell. Agriculture for today and tomorrow cannot be the same as it was yesterday.

#### Non implementation of Mental Healthcare Act 2017

While much has been talked about the crisis, one aspect that is often overlooked is that of legislation. One would have assumed that after the abrogation of Article 37 in August 2019, central laws pertaining to mental health would have been implemented in J&K. However, this is not the case. For instance, Mental Health Care Act 2017, a central law has not been working optimally. Interestingly,

thorities are not functional.

#### Functions of State Mental Healthcare Authority

As per the section 55 of the Mental Healthcare Act of 2017 the State Mental Healthcare Authority shall

(a) Register all mental health establishments in the State except those referred to in section 43 and maintain and publish (including online on the internet) a register of such establishments

(b) Develop quality and service provision norms for different types of mental health establishments in the State.

Supervise all mental health establishments in the State and receive complaints about deficiencies in provision of services. failed to enforce Mental Healthcare Act 2017 and doesn't have a defined Mental Health Policy. Infact, only three states: Karnataka, Kerala and Meghalaya have a mental health policy. The J & K administration must urgently make the State Mental Healthcare Authority operational and must also start drafting its Mental Health Policy in consultation with experts and civil society.

I am a local transport commuter and to be honest I experience a lot of sexual harassment in its diverse forms, just like all other girls do. But today when I left for the office in the morning, I was waiting at the stop for the transport when a very traumatic incident happened.

While standing there, other than unnecessary honking and gazing that were making me uncomfortable. I saw an altogether different side of that man who initially honked to an extent where he made it noticeable for me to look up at him. The guy had the audacity to stop his car in front of my feet, rub off his fogged window and invited me into his car while

smirking at my miserable startled self. I got numb, couldn't even move my body to run, or even confront the man for his sheer shamelessness. Somehow I mugged up my courage and went past him. It was only after I boarded a vehicle that I could understand what had happened and an unmatchable anger rushed in my blood. But all I could do was convert every ounce of that anger into a tear.

People might say that my crying showed my cowardliness or weak-

ness but the truth is that I didn't cry for only this incident but for all other such incidents I experience on an everyday basis or other girls do, irrespective of their age, religion, clothing etc.

Being a girl was not made difficult by the Creator, but we humans have constructed a society where it becomes difficult for her to exist.

# **This New Flu Virus Is Plaguing India Know All About Causes, Symptoms And Treatment**

lu outbreak in India: with symptoms like nagging and persistent cough, India is currently engulfed in a wave of flu. People across the country are suffering from a long cough that lasts for days and sometimes weeks.

According to doctors, the current flu is because of influenza A (H3N2). The doctors told Financial Express.com that there has been a significant rise in influenza infections. Currently, every other person across the country is down with fever, cough, loss of voice, and breathlessness.

According to the World Health Organization (WHO), the surge in flu cases in the country the spike in flu cases in the country is similar to the surge in the West between September and January.

"Doctors at Primus Hospitals in New Delhi are seeing an increase in instances of seasonal diseases, including viral infections like H3N2 influenza and other seasonal infections, as a result of the rapid shift in weather from cold to warmer temperatures. It is no secret that weather has a significant influence on overall health. Throughout the winter, as the number of cardiovascular illnesses grows, the number of viral infections climbs as well. When winter fades and summer arrives earlier, the number of patients reporting viral fever, cold and cough, and severe throat infections is fast growing," Prof Dr. SK Chhabra, Head of Department -Pulmonary, Sleep and Critical Care Medicine, Primus Hospital, Chanakyapuri, New Delhi told Financial Express.com.

A study published in the Journal of American Medical Association (JAMA) last month revealed that the surge was caused by low immunity among people and a decline in flu vaccination.

"Influenza virus infections declined glob-ally during the Covid-19 pandemic. Loss of natural immunity from lower rates of influenza infection and documented antigenic changes in circulating viruses may have resulted in increased susceptibility to influ-enza virus infection during the 2021-2022 influenza season," the report stated.

The influenza A(H1N1)pdm09, A(H3N2), and influenza B viruses occurred in a number of nations, as per WHO.

In India, influenza vaccines or flu shots are supposed to be taken every year never gained popularity.

According to WHO, there are four types of seasonal influenza viruses, types A, B, C, and D. Influenza A and B viruses cause seasonal epidemics of disease. The Centre for Disease Prevention and Control (CDC) maintains that influenza cases in India usually peak during monsoon season, June to September with secondary peaks during winter.

According to ICMR figures, H3N2, a sub-type of the influenza virus, is in wide circulation for the last two-three months—slightly more than the swine flu virus.

"There are a lot of patients coming with post-flu prolonged cough. Majority of paents are getting infected with flu causing



virus like influenza, RSV, adenovirus, rhinovirus etc. Post viral cough is a well known entity. A secondary bacterial throat infection usually occurs after getting flu which needs more care and treatment. The probable rea-sons for prolonged cough are air pollution hampering respiratory immunity, new mutant pathogens which need research, post nasal drip, allergic airway, reflux diseases (acidity), irrational use of antibiotics etc.," Dr Akshay Budhraja, Senior Consultant, Respi-ratory and Sleep Medicine, Aakash Healthcare told Financial Express.com.

In the last one month of 31 January, more than 451 cases and nine deaths have been reported, as per media reports.

"The current flu is caused by Influenza A from H3N2 strain. The patient suffers with high grade fever for 4 to 5 days along with sore throat for 7 to 10 days. This is often followed by productive cough producing sputum which last for 2-3 weeks. In these cases the patient has to be given either inhalation or oral steroids to recover. It is a threat to elderly patients with co-morbid heart conditions if they suffer from this virus and could lead to heart failure," Dr Samrat Shah, Consultant Internist at Bhatia Hospital Mumbai told Financial Express.com.

#### WHAT ARE THE SYMPTOMS?

According to doctors, flu signs and symptoms usually come on suddenly. People who are affected with flu experience the following symptoms:

- Fever
- Uncontrollable cough
- Sore throat
- Runny or stuffy nose
- Muscle or bo

Chhabra told Financial Express.com.

Dr. Chhabra also maintained that patients are experiencing similar issues as a result of climate change.

"Individuals with chronic illnesses, such as asthma, must exercise special caution during such weather shifts since they might provoke severe respiratory difficulties and asthma episodes. At this period, even small respiratory problems must be reported to a pulmonologist or a physician to avoid the condition from worsening," he added.

#### DIAGNOSIS

According to WHO, the majority of cases of human influenza are clinically diagnosed.

"Laboratory confirmation of influenza virus from throat, nasal and nasopharyngeal secretions or tracheal aspirate or washings is commonly performed using direct anti-

gen detection, virus isolation, or detection of influenza-specific RNA by reverse transcriptase-polymerase chain reaction (RT-PCR

the global health agency stated.

#### TREATMENT

WHO has outlined the following guide-

lines for influenza infection: Patients that are not from a high risk group should be managed with symptomatic treatment and are advised, if symptomatic, to stay home in order to minimize the risk of infecting others in the community.

Treatment focuses on relieving symptoms of influenza such as fever.

Patients should monitor themselves to detect if their condition deteriorates and seek medical attention Patients that are known to be in a group at high risk for developing severe or complicated illness, should be treated with antivirals in addition to symptomatic treatment as soon as possible.

Patients with severe or progressive clinical illness associated with suspected or confirmed influenza virus infection should be treated with antiviral drug as soon as possible.

Treatment is recommended for a mini-mum of 5 days, but can be extended until there is satisfactory clinical improvement.

#### **HOW TO PREVENT INFLUENZA INFECTION?**

According to Dr. Budhraja, the best way to avoid getting flu is by avoiding crowded places, practice good hand and respiratory hygeine, annual flu shot, keeping indoor air quality under control, wearing a pollution mask when outdoors and avoiding home remedies without consultation.

- The most effective way to prevent the disease is vaccination. Injected inactivated influenza vaccines are most commonly used throughout the world.
- Among healthy adults, influenza vaccine provides protection, even when circulating viruses do not exactly match the vaccine viruses.
- Regular hand washing with proper drying of the hands
- Good respiratory hygiene covering mouth and nose when coughing or sneezing, using tissues and disposing of them correctly
- Early self-isolation of those feeling unwell, feverish and having other symptoms of influenza
- Avoiding close contact with sick people
- Avoiding touching one's eyes, nose or mouth

#### WHO RECOMMENDS ANNUAL VACCINATION FOR:

- pregnant women at any stage of pregnancy
- children aged between 6 months to 5 years
- elderly individuals (aged more than 65 years)
- individuals with chronic medical 0 conditions
- health-care workers.

If you haven't already come across one of these videos, many of them involve young women declaring themselves to be "so lucky" - using affirmations such as: "I am so lucky, everything my heart desires will come to me.

Many of the videos give examples of recent fortunate events that have occurred on the back of using these positive affirmations: they may have received an unexpected windfall of money, got a golden job opportunity or enjoyed the holiday of a lifetime. But while this trend may have started with the best of intentions, it could actually do more harm than good.

Lucky girl syndrome is just the latest interpretation of the "law of assumption", which proposes that when we act as though what we want is already our reality - and believe it - then we are rewarded with the things we most desire in life.

The law of assumption is quite similar to the popular law of attraction" which emphasises the power of thoughts and beliefs - so what you believe becomes your reality. So if I believe that I'm successful and behave as a successful person, then I will be successful.

This type of "you-are-what-youthink" ideology is very persuasive

and popular because it's reminiscent of ancient wisdom. For example, Stoic philosophy suggests that the way we think about our situation determines our psychological state, not the situation itself. But unlike lucky girl manifesting, stoic philosophy also advocated for recognising that sometimes things don't go our way - and that this is an opportunity in itself to learn and grow.

Thinking your way to success sounds simple and its simplicity is appealing. But this is also the flaw of lucky girl syndrome. Although



research has found that successful people do have a positive mindset, it's not only their mindset that sets them apart.

For instance, a study of successful women leaders found they also work very hard, often sacrificing more pleasurable pastimes in favour of pursuing their goal. They also invest in relationships with others and prioritise learning and further education. So it isn't just luck that gets them to where they are.

Yet on the other hand, research does show that believing you're a lucky person is associated with a more

positive state of mind and a greater tendency for seeking out opportunities. People who consider themselves lucky are more likely to approach new situations with confidence and a sense of control and optimism.

This study also suggested that this sense of being lucky promotes positive goal-oriented behaviour, such as a commitment to working towards your desired future. Misplaced optimism

There is perhaps more of a dark side to lucky girl syndrome, which is hinted at in its name – seeing as it's called a syndrome not an approach, and particularly because it's aimed at women. Most videos on the topic talk purely of manifesting through thinking - there isn't much emphasis on action.

They suggest that what you put out to the universe is what you will get in return. So if you think you're poor or unsuccessful, this is what you'll get back. Obviously this is quite an unhelpful message, which likely won't do much for the self esteem of people who don't feel particularly lucky - let alone those facing significant hardship.

Future daydreaming, fantasy and visualisation is a normal and healthy thing we all do. According to research, we think about our futures twice as much as we think about our past. Thinking about our future allows us to explore and visualise all sorts of possibilities, predict our future based on our past experiences and plan strategies to meet our goals.

No doubt we can all benefit from creating a more positive, healthy mindset that will help us create a better future for ourselves.

But instead of asking the universe for more wealth, success and power, perhaps we should ask for more compassion, kindness and support from ourselves and for each other. Focusing on these human qualities is associated with greater life satisfaction than striving purely for material gain.

Instead of "lucky girl syndrome", if you want to change your mindset and be more positive, why not try loving kindness meditation.

This form of meditation encourages you to focus on compassion towards vourself, others and the world. Studies have found that engaging in compassion-focused meditation increases positive emotions, social connectedness and self awareness.

Studies have also found that connecting with others and sharing our hopes for the future can lead to better goal attainment and personal success. So instead of sitting alone manifesting, get out there and share your dreams with others.

# **Mere Breach Of Contract Cannot Give Rise To Criminal Prosecution For Cheating: SC**

#### PRESS TRUST OF INDIA

New Delhi: The Supreme Court has said a mere breach of contract cannot give rise to criminal prosecution for cheating and dishonest intention has to be shown right at the beginning of the transaction

A bench of Justices A S Oka and Rajesh Bindal said only the allegation of failure to keep a promise will not be sufficient for initiating criminal proceedings. "A breach of contract does not

give rise to criminal prosecution for cheating unless the fraudulent or dishonest intention is shown right at the beginning of the transaction. Merely on the allegation of failure to keep up promise will not be enough to initiate criminal proceedings," the bench said.

The court made the observations while setting aside an order of the Punjab and Haryana high court which had refused to quash an FIR against a man under Sections 420 (cheating), 120 B (criminal conspiracy) and 506 (criminal intimidation) of the Indian Penal Code in a case of sale of land.

The top court was hearing a plea filed by Sarabjit Kaur challenging the high court order.

Kaur had entered into an agreement to purchase a plot of land on May 27, 2013 with Malkit Kaur, wife of Surender Singh.

Lashing out at the government, Rabri Devi's son and Bihar Deputy chief minister Tejashwi Yadav said the CBI team's visit to the residence of his mother was a result of his family's "relentless opposition to the ruling BJP at the Centre".

## Mehbooba Welcomes Army **Court Recommendation**

SRINAGAR: PDP president Mehbooba Mufti Monday welcomed an Army court's decision to recommend life imprisonment for a captain of the force in connection with the killing of three labourers in a "staged" encounter in Amshipura area of Shopian district in 2020.

She expressed hope that an impartial probe would also be ordered into the Lawaypora and Hyderpora encounters that took place in 2021.

Retweeting a news report on the development, the former Jammu and Kashmir chief minister said, "Recommended punishment of life imprisonment for Captain involved in Amshipora fake encounter is a welcome step towards creating accountability in such cases. Hope an impartial probe is also ordered in Lawapora and Hyderpora encounters to prevent the repetition of such ghastly incidents (sic).

Completing general courtmartial proceedings in less than a year, an Army court has recommended life imprisonment for a captain in connection with the killing of three men in a "staged" encounter in Amshipura in south Kashmir in July 2020, officials said Sunday.

Captain Bhoopendra Singh was subjected to court martial after a Court of Inquiry and Summary of Evidence found that troops had "exceeded" powers vested under the Armed Forces (Special Powers) Act (AFSPA), they said.

The life sentence is subject to confirmation by higher army authorities, the officials said.

Later, while discussing the Army court's recommendation with various party leaders, Mehbooba said it is a positive step towards upholding the rule of law and ensuring justice for the victims.

"It sends a strong message that such acts of violence and abuse of power by those in uniform will not be tolerated," she added.

For ensuring accountability and inculcating a proactive will for responsibility and justice among security forces, Mehbooba said this case highlights the need for better accountability and oversight mechanisms within the armed forces to prevent such incidents from happening. "Going forward, it is crucial that the armed forces take concrete steps to ensure that their personnel adhere to the highest standards of professionalism

and ethical conduct," she said. That the accused was able to commit such a heinous crime and pass off innocent civilians as militants raise serious concerns about the "culture of impunity and lack of accountability that often pervades within the military", the PDP chief said.

To build trust between the civilian population and the mili-tary and work towards a peaceful and just society, Mehbooba conducting thorough sought investigations into Lawaypora and Hyderpora encounters and holding the perpetrators accountable for their actions.

She also pinned her hopes on the investigating agencies to probe the recent case, in which the body of Rashid Dar of Kunan village in Kupwara was found in a forest "after he went missing in army custody two months earlier".

also discussed and the stakeholder departments were asked to ensure the maintenance of the possession of the retrieved land.

"Measures to fight drug menace, prevention of bovine smuggling and maintaining communal harmony and peace in the district were discussed in detail. Keeping a close check on illegal constructions, illegal mining, and intensifying anti encroachment drives was also stressed upon," the spokesperson said.

Mahajan, he said, instructed to seize the vehicles used in the illegal activities, keep track of history sheeters and initiate strict action against violators of restrictions imposed under Section 144 Cr PC and other sections by the authorities.
