Srinagar: Kashmir has witnessed a rise in cases of mananimal conflict in recent times, with experts blaming the interference of humans in wildlife habitats as the main reason for such incidents.

"Human-wildlife has certainly escalated greatly in the past few years in Jammu and Kashmir," regional wild-life warden, Kashmir, Rashid Nagash said.

Jammu: One person was killed and six others, including two women, were injured when a massive landslide struck the strategic Jammu-Srinagar national highway in Ramban district on Tuesday, officials said.

The landslide hit the 270km highway at Seri village near Ramban town around 2.30 pm, leaving hundreds of vehicles stranded on both sides, they said.

**Srinagar:** People seeking revenue extracts and reports are facing a plethora of issues due to the indefinite strike called by Patwaris throughout all districts of Jammu & Kashmir since March 1.

Nisar Ahmad, a Srinagar resident said that owing to the strike called by Patwaris, he is not able to get a report for an income certificate.

"I have to submit an income certificate for my child in school and for the last five days, I have been visiting the Patwari office daily and return disappointed," he said.

Another Srinagar resident said the Patwari of his area was directed to make a spot visit against an application but owing to the strike, he is refusing to come.

"I had moved an application at my concerned tehsil office, and the Patwari of my concerned area was supposed to make a spot visit to issue a report but unfortunately he is refusing to come saying they are on an indefinite strike," he said. Similar reports were received

# **Twitter To Soon Let Users Post 10,000 Character Tweets**

Twitter CEO Elon Musk on Monday said that the micro-blogging platform will "soon" extend "longform tweets" to 10,000 characters.

When YouTuberA@ThePrimeagen, who posts videos related to coding, asked Musk, "the dev community and I were wondering if you could add code blocks to tweets?" Musk replied: "As an attachment? How many chars? We are extending longform tweets to 10k soon." Several users expressed their thoughts on Twitter CEO's post.

While one user said, "You're a crazy man Imao," another commented, "!! Wow! That's really good news. Actual microblogging!" Last month, the company had announced that Blue subscribers



in the US can post long tweets of up to 4,000 characters on the platform.

Only Blue subscribers can post longer tweets, but non-subscribers can read, reply, retweet and quote tweet to them.

280 characters, which still applies to non-subscribers.

Meanwhile, Musk had said that the micro-blogging platform is "spinning up subscriptions" so that users can "charge" their followers for specific content.

# **Authorities Snap Electricity In Habba Kadal After Locals Oppose Smart Meter Installation**

Srinagar: Authorities snapped electricity supply in Gadood Bagh and its adjoining localities in Habba kadal area on Tuesday, a day after the locals objected to what was alleged 'unjustified' move to install smart meters in the area.

The power supply in the area was snapped a day after locals staged a protest against smart meter installation, saying they cannot afford hefty monthly electricity bills being 'poor'.

Upset by the move, consumers across the valley have hit the streets to press for the revocation of the order, which they allege is aimed to force people to reel under absolute gloom.

"Being poor, we cannot afford fat monthly bills from smart meters. We literally live from hand to mouth and find it difficult to meet both ends as most of the educated youth in our locality are jobless" said Bilal Ahmad, a local resident.

"How far is it genuine to install smart meters when Kashmir's economy has been in shambles for the last 35 years" he questioned.

He said the government recently hiked Rs 50 on domestic Liquefied Petroleum Gas (LPG) and it's very difficult for an average person to support his family in such a situation.

"Prices of essential commod-

ities are touching the sky and the government instead of lessening the burden of common masses is overburdening them by introducing back-breaking schemes. How is it possible for a laborer or a roadside vendor to pay huge electricity bills from smart meters," said another local.

Locals living around Gadood Bagh and its adjoining localities said that they took to the roads and staged a protest after a team of Power Development Department (PDD) arrived in their area to install smart power meters.

"We vehemently objected to the move and did not allow smart meters to be installed in our area. Offended by the protest, authorities snapped electricity supply in our area, thus leaving us to reel under complete darkness," Nabla, an elderly woman, told Kashmir Observer.

She appealed to the administration to either revoke the order of installing smart meters in the valley or exempt the poor, given their desperate economic condition.

Near Total Bandh, Blasts And Grenade Attacks

# Poor Turn Out In Baramulla, Anantnag

rinagar-The polling for Lok Sabha constituencies of Anantnag and Baramulla was marked by a series of bomb blasts and poor turn out of voters besides a near total bandh .in all major valley townships, in response to a call given by the all-party Hurriyat Conference.

At least three security personnel sustained injuries when they were hit by splinters, following a grenade attack on a vehicle carrying them for election duty in Bijbehara town of Anantnag, this afternoon. 15 others had a narrow escape when a powerful device planted in a girls' school in Pattan exploded with a deafening sound. early morning, causing some damages to school and few adjoining buildings. Grenade attacks were also reported from Marhama Sarnal and Buchoo villages of south Kashmir district of Anantnag However no damage was caused by these, reports added.

Normal life in capital Srinagar and other valley towns was paralysed as near total general strike was observed on the call given by Hurriyat Conference, in connection with its poll boycott campaign. The general strike had a substantial impact on the voter turnout, in both Anantnag and Baramulla Lok Sabha constituencies, with lowest percentage recorded in Tral and Pulwama assembly segments of Anantnag constituency. Chief Electoral Officer S V Bhave however told news persons

this evening that polling passed off "peace-fully", though "minor incidents grenade throwing and bomb blasts" were reported from both the constituencies. Bhave, however claimed 30-35 percent polling in Anantnag and 40 percent polling in Baramulla. The percentage is lower from what was recorded in 1996 Lok Sabha polls when Anantnag had 46 percent turnout and Baramulla accounted

The lowest turnout in Anantnag constituency was in Pampore with just 13 percent votes polled while in Baramulla, the town voters responded to boycott call in a big way. In Anantnag, as the reports suggested, the voter turnout was much higher in the places known to be strong holds of senior Congress leader and former home minister Mufti Mohammad Syed. Again at this very few people came to cast their votes, what are otherwise called pockets of ruling National Conference, Same seemed to be the case in Baramulla, where NO strong holds registered a poor turnout even after all possible efforts of the party leaders to mobilise higher turnout. Unprecedented security measures had been taken by the

authorities to face the challenge of the militants to disrupt the poll process. Besides para-military personnel, Army was deployed in strength in both the constituencies.

Those whose fates were sealed in today's polling include former home minister Mufti Mohammed Sayed and minister of state for home Maqbool Dar in Anantnag. Also in the fray, there was Yousuf Taing, former secretary of cultural academy and a political novice, fielded by ruling National Conference.

In Baramulla, the real contest is between National Conference nominee and union minister Saifuddin Soz and a noted jurist Muzaffar Hussain Beigh who is fighting as an independent. There are twenty seven others in the fray including one from Congress and BJP each, but none of them seem to be anywhere in the fray. Beigh, it may be mentioned, was supported by all the opposition parties including the Congress whose senior leaders openly canassed for the Beigh



# **Towards Justice**

military court has sentenced to life in prison to the captain who was involved in the Amshipora fake encounter, in which three youth from the Rajouri region of Jammu and Kashmir were killed on July 18, 2020, and passed off as militants. The court found that Captain Bhoopendra Singh, of the Army's 62 Rashtriya Rifles, then stationed in South Kashmir's Shopian district, "exceeded powers vested under the Armed Forces (Special Powers) Act" during the encounter. The life sentence for Captain Singh is "subject to confirmation by higher Army officials, and the process involved in such cases is still on, according to army sources"

After the encounter took place in 2020, the police had accused Singh and two associates of planting weapons on the bodies of three labourers. To be fair to Army, even it was quick to blame its own personnel in this incident. Earlier, the Army had claimed to have killed three unidentified militants in the said encounter. But once their pictures were published in newspapers and circulated on social media, three families in Rajouri claimed they were their children and insisted they had had no terror links. According to the families, the trio had gone to Shopian to work as labourers. The Army was quick to order a high-level Court of Inquiry into the encounter and was quick to indict captain Singh which came as a pleasant surprise to people at the time. Army was also quick to confirm that the three youth killed in an encounter at Amshipora were civilians from Rajouri.

As the Amshipora case has once again showed, what matters is the accountability of the personnel responsible for any excesses, not the revocation of the AFSPA per se. Best possible way out is a willingness among the security agencies to act fairly and speedily in cases of rights violations. This is the only pragmatic solution under the circumstances. And Army by acting against its own personnel in Amshipora case has showed that it has zero tolerance for human rights violations. In past there was talk of making necessary modifications to the AFSPA to ensure that security personnel who commit human rights violations are accountable for their actions. But as its action in Amshipora case has once again proved, Army has an inbuilt legal mechanism to punish the erring personnel. And once a wrong has been done, the personnel responsible for it are duly punished.

# The Right Way to Women's Day About Muslim Women

In most – if not all – the mainstream feminist debates on Muslim women, the hijab serves as a symbol around which to mobilise efforts to emancipate these women. In Sirma Blige's words, it became an over-determined cultural signifier that mainstream feminists in the West associate with, among other things, the subordination of women to Islamic patriarchy and their developing of a false consciousness. The "subordination" argument rests on an assumption that women who wear the hijab were forced by men to wear it.

As for women who contend that wearing the hijab was their own choice, they are described as having developed a "false consciousness". Yet what both of these interpretations have in common is that they dehumanise Muslim women by denying them their agency. This implies that the veiled woman "does not know what is good for her" and that women in the West, by contrast, can teach her how to understand lofty concepts like agency and freedom.

Corollary to this form of Orientalist feminism is that Muslim women's voices are silenced, and their opinions on what the hijab actually means to them go unheard. What most veiled women have to say about the hijab is actually substantially different from the feminist critique. As anthropologists Saba Mahmood and Lila Abu-Lughod point out, the justifications most often given by Muslim women for taking up the hijab relate to modesty, piety and morality.

A person with the most basic knowledge of Islamic thought would not find these claims far-fetched. There is an agreement in the Islamic legal literature on the importance of dressing modestly, and there are rules on how to achieve that for both men and women. Hence, if feminists are to fully comprehend Muslim women's motivations for wearing the hijab, religion must be incorporated into the discussion. Whether these motivations stem from "true agency" or qualify as "free choices" are entirely subjective matters. For the headscarf is a neutral object; it only gains meaning through the symbolism that its wearer attaches to it. So how can feminists in the West (or anyone interested in the issue) understand Muslim women and the hardships they face? The first step, paradoxically, is to stop using the label "Muslim women" in discussions. The label is generic and broad to such an extent that it ceases to be useful or meaningful in any serious, nuanced exploration of the plight of the women it is concerned about

The second step in understanding the plight of Muslim women – or more accurately, the plight of any group of women – is to adopt what feminist academics call an intersectional approach. Intersectionality involves understanding that women around the world experience different kinds of oppression, and that their experiences are qualitatively different. To gain insight into their experience, one has to understand how different systems of oppression (such as gender, race, ethnicity, class, political conditions, nationality, disability, etc.) intersect to produce a specific experience

of oppression that is unique to certain women.

Simply put, the alternative approach that is needed is the development of a more accommodative form of mainstream feminism, one in which women in the West understand their non-Western counterparts in the latter's own terms, and treat them as equal partners, not helpless minors.

It is never discussed that in Kashmir, women don't even have access to mosques where they may have felt a sense of communion with the rest of the community. Such public spaces bring along a lot of knowledge, support and more importantly, inspiration. Yet, the Ahmads of the internet will not speak of such issues because the purpose of their whataboutery resides in sexism

# Capacity Building And Training For Women's Safety

HE advancement of women and the achievement of equality between women and men is a matter of human rights and should not be viewed in isolation as a women's issue for social justice. They are the only way to create a sustainable, just, and developed society. However, persistent patriarchal mentality and prejudice against gender equality will lead to poor recognition of women's rights; As it has been behind.

Regarding the deep-seated bias and poor recognition of women's rights in India, the Economic Survey 2018 noted that the desire for a male child has given birth to 21 million "unwanted" girls between 0 and 25 years old in India. According to the latest health index released by the NITI

Aayog, India's sex ratio at birth has declined in 17 of the 21 large states. This indicates a failure in the country's ability to curb female selective abortions after illegal sex disclosure.

As recently as March 2020, there were cases of infanticide in Usilampatti, Tamil Nadu. The deeply ingrained bias ironically suggests that it exists against genuine equality between both men and women. According to PISA test data, the notion that "boys are better at math" is unfounded. Yet this belief still exists. Crimes against women increased from 3,793 per million in 2016 to 3,886 per million in 2017, according to the NCRB report. Uttar Pradesh topped the list with 56,011 cases followed by

Maharashtra.
In the corporate world, women

still earn an average of 79 percent of men, who hold only 5 percent of the Fortune 500 CEO positions and represent an average of 17 percent of global board positions. Women lack access to informal networks that provide opportunities to work in high-profile projects, including attending conferences abroad or job opportunities. Early marriage, with or without the consent of the girl, is a form of violence, as it impairs the health and autonomy of millions of girls.


It is important to develop and implement policies that promote gender equality by creating and enforcing laws to protect women, as well as marriage, divorce and custody laws, inheritance laws, and the elimination of discrimination against women in property ownership. For

financial freedom, improving access to paid employment to women and ensuring equal pay for equal work is

extremely important.

However, women-centric development plans have been made due to gender-based budgets. The plan for safe cities to improve crime monitoring data collection system on violence against women and use of Nirbhaya Fund for better protection of women. Capacity building and training of service providers and law enforcement officers to handle cases of violence against women is of utmost importance at the nationwide level for women's safety.

ne of the fiercely debated and discussed topics/ issues in the present times is women in Islam. There are numerous misconceptions and misinterpretations related to their place and position and role and contribution. Numerous works deliberate on this topic, which, nevertheless, appear as never-ending one. A latest addition is Women in IslamWhat the Quran and Sunnah Say (hereinafter WI). Written by Professor Abdur Raheem Kidwai (Professor of English and Director of K.A. Nizami Centre for Quranic Studies at Aligarh Muslim University), this succinct, slim, and simple Volume demystifies and deconstructs the main misconceptions and misconstructions on this vital but sensitive issue and highlights the rights, status, role, and contribution of Muslim women in its real context.

Published by Kube Publishing (UK) in 2020, WI attempts to provide the readers with an opportunity to consider some of the references to women in authentic Islamic sources in order to shape an informed view, with an aim to let readers appreciate the high status that women enjoy in Islam (p. vii)

Divided into three main sections, preceded by a 'Preface (vii-x) and ending with Index (pp. 170-80), WI is a compiation of passagese from the Quran and hadith collections which refer to or address women specifically. Engaging the readers in a moment of reflection on the Islamic stance on womanhood: her existence as a creation of Allah, her purpose of life as a slave of Allah, her capacity for attaining self-development and proximity with Allah and her

accomplishments, it brings to the fore that the Quran repeatedly addresses and urges men and women to be active, positive stakeholders in the construction

of God-conscious society (p. ix). In the Preface, the author mentions that certain Islamic practices ... [and] aspects of the faith such as polygamy, divorce, patriarchy, segregation of the sexes etc. have been increasingly taken in isolation, resulting in imposing degradation and suffering upon women; while as, the primary Texts of Islam demonstrate that women in Islamin the capacity of a mother, daughter, and wifeare bestowed dignity and exalted status (p. vii). However, he does not overlook the fact that over the centuries, some socio-cultural practices in Muslim societies, past and present, along with patriarchal supremacy snatched this high status from them, which has given place to various prevailing misconceptions on this issue today (p. vii).

In Section-I, Quranic Verses and Ahadith Addressing and Referring to Women (pp. 3-136), Kidwai first presents a collection of 76 passages/ quotations from the Quran, which either address men and women collectively or to women specifically. with a brief explanation of many of them demonstrating gender parity. For instance, in the explanation of Q. 4: 32, Do not be jealous over what God has given more to some [men and women] than others', he writes: "The Quran is clear in pointing out that men and women will be recompensed alike; there is no distinction between men and women" (p. 6); in the explanation of Q. 55: 60, Can the reward for goof be anything except good?, Kidwai stresses that this Divine promise of reward is for everyone,

nationality or any other label (p. 21). Similarly, in the explanation of Q. 4: 34, Men are the protectors and maintainers of women....one of the highly contested, diversely debated verse and is one of the extremely (mis) interpreted, misconstrued and misunderstood versesKidwais explanation provides many clarifications: Since Islam does not lay any financial burden on women, it charges men with the responsibility to support their wife and family and hence his role as the protector. ... Wife-beating or any other form of domestic violence is completely ruled out in Islam and is a serious offence in itself (p. 43).

This is followed by a collection of 102 (numbering 178 in total) *Ahadith*/
Prophetic Traditions from various authentic Hadith books related to different aspects of women in different contexts.

Besides making numerous references to women in different contexts the Quran also portrays some women as role models, and, thus, Section-II, Women Specifically Mentioned in the Quran (pp. 137-158) provides an account of these women gleaned from the Quran and other authentic Islamic sources (p. 139). It is divided broadly into two sub-sections: Believing and Disbelieving Women in the Quran (pp. 139-155, 155-158). In former, it refers to Maryam (Mary), Oueen of Sheba, Pharaohs Believing Wife, Prophet Mosess Mother, Prophet Shuaybs Daughters, and Allahs Response to Some Womens Pleas, respectively, as examples of pious women. Among these, the longest account is dedicated to Maryam (AS), because of certain noticeable reasons: she takes pride of place among all the women mentioned in

the Quran; she is portrayed with enviable appellations like a *saintly woman* (as in Q. 5: 75) or being preferred to *all the women in the world* (as in Q. 3: 42); a whole Surah (Q. 19) is named after her; and she is prominent not only for being mother of Prophet Isa/ Jesus (AS), but the Quran heaps praise on her for her piety, her chastity, and her devotion to Allah (pp. 139, 140).

Among the Disbelieving or wicked women, Kidwai mentions the wives of Prophets Nuh/ Noah (AS) and Lut/Lot (AS), who are censured for their lack of faith (as in Q. 66: 10); Egyptian Potiphars Wife, known as Zulaykhah in popular lore, who appears as a temptress in the account of Prophet Yusuf/Josephs (AS) account (as in many verses of Surah Yusuf, Q. 12); and Abu Lahabs Wife (as in Q. 111: 1-5)who, along with her husband, were die-hard unbelievers and inveterate enemies of the Prophet (pbuh).

This is followed by Section-III, Women Hadith Narrators and Teachers (pp. 159-169), which, as the title clearly reveals, provides a list of some prominent Hadith scholars from early Muslim history with a view to exemplify the dynamic contribution that Muslim women have made to Islamic history (p. ix). These names and data (presented in this Section) are entirely based on Dr M. Akram Nadvis prolegomena to his multi-volume work on female hadith narrators, entitled al-Muhaddithat: The Women Scholars in Islam (Oxford. 2007). For example, in this section, it mentions names of the Companions who have narrated hadith on the authority of Aishah, Umm Salmah, Hafsa (RA), etc. It is interesting to add here that as many as 2764 Hadith feature in the six standard collections of Hadith [known

as *Sinan al-Sitta* or *Kutb-e-Sitta*] on the authority of lady Companions, which are not restricted to the personal hygiene and purification of women, but embrace a wide range of topics including prayer, fasting, Zakah, Hajj, food, clothing, business, jihad, marriage and divorce, death, the Hereafter, supplication, morals and manner and the Prophets illustrious life (p. 163).

Thus, highlighting a collection of

passages related to women, and women role models, in the Quran and hadith, providing a list of women Hadith narrators, and describing a succinct overview of the Islamic stance on womanhood, Kidwais *Women in Islam* fairly justifies both the title and aim of this volume: providing readers an opportunity to appreciate the high status that women enjoy in Islam.

There are few typos and technical errors in this book: e.g., names of all the Prophets are anglicised followed by the Islamic appellation (*Alayhi Salam*) in Arabic, which is an odd combination; and the number of verses in *Surah al-Lahab* (Q. 111) on page 158 is mentioned wrongly as 15 instead of five (5).

In sum, written lucidly, presented beautifully, and using the Quran and Hadith as the main sources, Kidwais *Women in Islam* portrays the place, role and contribution of women in its real context and defies the misconceptions about Muslim women. It is, indeed, a valuable and welcome addition to the literature on depicting women in Islam in their real and right context.

# 17 killed, over 100 injured as explosion rocks seven-storey building in Bangladesh's capital city

**Dhaka:** At least 17 people, including two women, were killed and over 100 others injured on Tuesday in a powerful "earthquake-like" explosion at a seven-storey building here in Bangladesh's capital city, police and local residents said.

Eleven firefighting units, comprising 200 firemen, were mobilised at the spot after the blast, which occurred around 4:50 pm (local time) at Old Dhaka's crowded Gulistan area, the fire service control room said.

"Sixteen bodies have been found (so far), but the toll could rise as the rescue operation is underway," a fire service official told reporters.

One person succumbed to his injuries at the hospital, raising the toll to 17.

"Most of the deaths were caused by brain hemorrhage," Health

Minister Zahid Maleque said. The cause of the explosion

could not be known immediately, but local residents suspected chemicals illegally stored inside the building, mostly used as an office and business complex, might have sparked the blast.

Several people have been trapped under the rubble of the building. "We have to cut through the concrete to rescue them. The fire service is working on it," an official said.

"At first, I thought it was an earthquake. The entire Siddik Bazar area was shaken by the eyewitness Safayet Hossain, a local shopkeeper, told The Daily Star newspaper.

"I saw 20-25 people lying in the road in front of a damaged building. They were seriously injured and bleeding. They were crying out for help. Some people

were running around in panic,"

He added that the locals were carrying the injured in vans and rickshaws to the hospital.

Alamgir, who was close to the blast site, said, "After the loud noise, people quickly came out of the building. There was panic on everyone's faces. The glass of the building's windows shattered and fell onto the street. Many pedestrians on the street were injured."

The Rapid Action Battalion's bomb disposal unit was rushed to the spot to inspect the buildings. Later, the Army bomb disposal unit also joined the mission.

"We cannot confirm yet if the blast was the outcome of any sabotage. But our bomb disposal unit along with military and police bomb disposal teams are working," said RAB director general M Khurshid Hossain.

"Our focus is on the rescue operation. The cause of the fire could be known only after investigations," fire service director general Brigadier General Mohammad Mainuddin told

Dozens of injured were taken to Dhaka Medical College Hospital, said DMCH police outpost inspector Bacchu Miah.

He added that all of them were receiving treatment at the hospital's emergency unit.

A huge crowd queued up in front of the DMCH blood bank to donate blood for wounded people responding to a call by the hospital authorities.

The building has several stores for sanitary products on the bottom floor and a branch of BRAC Bank was located in the building adjacent to it.

The blast shattered the glass walls of the bank and also damaged a bus standing on the opposite side of the road, reports said.

The police believe it was an accident not a case of sabotage but said they will investigate that possibility, according to Dhaka Tribune newspaper.

Fire officials said the blast occurred on the ground floor and the first two floors of the building were badly damaged.

The blast occurred two days after another exposition at a building in Dhaka's Science Laboratory area that killed three people and injured several

Last week, seven people were killed in an explosion at a private oxygen plant in the southeastern port city of Chattogram, injuring dozens others.

# HC refuses to advance hearing on plea against stopping namaz in Mughal mosque

New Delhi: The Delhi High Court on Tuesday refused to advance the hearing of a plea by the Managing Committee of the Delhi Waqf Board against the Archaeological Society of India (ASI) stopping namaz at Mughal Mosque in the city's Mehrauli area.

The counsel for the petitioner said the matter was "ripe for final disposal", and in view of the upcoming religious occasions, the hearing scheduled for August 21 should be advanced.

The central government counsel opposed the request and said he would file a response to the rejoinder filed by the petitioner.

"List on date already fixed." said Justice Manoj Kumar Ohri.

The grievance of the petitioner before the high court is that the officials of the ASI completely stopped the offering of namaz in the Mughal mosque on May 13, 2022, in an "absolutely unlawful, arbitrary and precipitous manner", without serving any notice or order.

In its reply to the petition, the Archaeological Survey of India said the mosque comes within the boundary of Qutub Minar and is within the protected area where prayers cannot be permitted.

During the submissions, petitioner's counsel M Sufian Siddiqui emphasised that the Mughal mosque was distinct from the "contentious" Quwattul Islam Mosque which is the subject matter of a suit before a lower court in Saket.

will have the consequences, and we have witnessed and recorded it scientifically from four decades that there has been a tremendous change in land use classification in the valley,"

Before human intervention, all wild lands used to be under forests that are known as grazing land, but, now, it has been taken up for agriculture or horticulture use, he said.

These horticulture landscapes have either been grown on the fringe of the forests or inside them, he added.

The regional wildlife warden said that these changes in the wildlife habitat have invited casualties over the years. While the conflict has escalated, the casu-

alties came down last year, owing largely to

According to the statistics, in 2013 and 2014, the total number of deaths was 28, which declined to 10 in 2022.

"In 2013, we had 28 killings and 333 injuries. But, these numbers have gone down to 10 deaths and 89 injuries in 2022. If we correlate the resources available at that time to the present scenario, we did not have training available and the department capacity was also not apt to address such issues. Although the casualty number has gone down, the wildlife appearances have significantly gone up," Naqash

However, he pointed out, child lifting cases by leopards in north Kashmir have been reported and were "recurrent".

He said every interaction cannot be termed as conflict and there have been appearances of such animals in human habitation which are categorised under conflict but are not in the real sense.

"When they see passages, these animals often resort to their original corridors without harming any life or property," he said.

Many wild animals such as leopards, black bears, and brown bears have adapted to live in human-dominated landscapes, Naqash said.

"Leopards are not restricted to jungles and have their territory now. These changes have made them often migrate to places where they can find a little shelter and food. Dogs are the main delicacies to them and they have developed a habit to urbanise, they feed and breed,"

The department acts as soon as it gets an SOS call, but these conflicts are not restricted to any particular area and so the department cannot set up a team everywhere, he said.

"So, to manage such things and take appropriate steps, the department has established 22 rescue control rooms around the Kashmir landscapes that are available round-the-clock,'

Detailing reasons for the escalation in the conflict, Wildlife Warden, Central Division, Altaf Hussain said the buffers between the human habitation and the forest areas have decreased.

"Our habitation areas, like the city here, have spread out and come close to the forests. The buffers have decreased. Food availability in urban or suburban areas has increased. Leopards

get shelter easily in the form of dense vegetation, and abandoned plots, so, with the availability of proper shelter and food, the animal can easily change its areas," he said.

Hussain said the animal does not know about the boundary, so, those who live close to

forests, have to take precautions. "But, they (humans) do not have to take steps themselves, rather call us," he added.

Hussain said the department has round-theclock station teams in high-conflict areas.

Nagash said with all the resources and training available, actions are prompt by the department to avoid any damages, but these are not long-term.

"Proper research on the changes in the habits of wildlife to further control is important. Strategies to balance this coexistence between humans and wildlife and awareness are equally important," he said.

to constitute teams to capture the wild beast. Wildlife department in its two minute and six second video advisory has said that the mananimal conflict can be easily prevented, if people take SOPs seriously and follow it dutifully.

"If people follow dos and don'ts, there will be less conflict between humans and leopards. Don't let kids play alone outside, put the lights on around your house at night, do not litter around your house as dogs feed on garbage and their number increases day by day," the advisory said, adding littering invites leopards to human habitats.

The advisory asked people not to plant grass around their homes or attend nature's call in

"It's highly recommended to keep an eve on abandoned structures with fencing around and make sure there is no grass or hedge plant grown or any temporary shed erected inside, keep such places neat and clean. Don't roam around a dense forest alone and keep close vigil on cattle and pet animals and keep them in protected and concrete cowsheds," the advisory says.

The department has also asked people to leave the animal being attacked and subsequently killed by leopard 'unattended' so as to avoid further losses.

"Don't chase away or attack leopards. Instead, inform the wildlife protection department immediately. Let's follow the SOPs and save life and property," the advisory adds.

JOHANNESBURG: South Africa have recalled middle-order batsman Ryan Rickelton and the spin duo of Simon Harmer and Keshav Maharaj for the second and final test against the West Indies at The Wanderers on Wednesday.

Coach Shukri Conrad has revealed the starting XI and says he had no concerns over the form of newly-installed captain Temba Bavuma, who got a pair of ducks in the 87-run first test victory in Pretoria last week.

Rickelton, 26, was a surprise absentee from the first match given his excellent domestic form that has seen him score 365 runs in five innings at an average of 121.66. He takes over from Keegan Petersen at number five in the batting line-up.

"You want to be consistent with selections and reward performance, but you can only select 11 players," Conrad told reporters on Tuesday.

'Ryan is definitely one that will be a big part of the side going forward.

The Wanderers is usually a wicket for the seamers with pace and bounce, but in recent times has slowed down and that has prompted the home side to pick both Harmer and Maharaj in the place of Senuran Muthusamy and injured fast bowler Anrich Nortje.

Bavuma became only the fourth player in test history to get a pair on their captaincy debut after Mark Taylor (Australia), Rashid Latif (Pakistan) and Habibul Bashar (Bangladesh), but Conrad says there has been no discussion about it.

# **Everyone Wants To Qualify** For WTC: Rahul Dravid **Defends 'Poor' Tracks**

AHMEDABAD: India's head coach Rahul Dravid doesn't regret one bit playing the ongoing Test series against Australia on spinner-friendly tracks as World Test Championship points are at premium and most countries are preparing result-oriented pitches.

While India lead Australia 2-1 in the four-Test series, the "poor" rating of Indore track by ICC match referee Chris Broad has once again raised questions about playing on rank turners, where all the games finished inside three days.

"I won't go too much into it. Match referee is entitled to share his opinion. Doesn't really matter if I agree with his reading or not. Doesn't matter what I think. But sometimes with WTC points at stake, you tend to play on wickets that produce results," Dravid was straightforward in his defence of the three tracks in Nagpur, Delhi and Indore.

mention that data analysis of tracks prepared by home teams in last few years has shown that the 22-yard strips in most places have been challenging. "It can happen, not only in In-

dia but across the world if you see, sometimes it is difficult to get that balance perfectly right for everyone and that can happen not only here but in other places as well," the man with 164 Test matches under his belt said.

Dravid did give a bit of idea as to what has been the trigger behind asking for these kind of raging turners. It was the 2021 Test match in Kanpur against New Zealand where India failed to pick up nine wickets on the final day.

There is a huge premium on results and if you draw a game like we did in Kanpur versus New Zealand, that sets you back in a home game. When you have 12 for a win and 4 for draw, you want to get a win ahead of a draw," he stated.

However, he didn't forget to as well as irritation when he spoke about the tracks in South Africa where India played three Tests early last year.

"We have played on some challenging wickets when we go overseas also. Played in South Africa recently (2022), where spinners were completely taken out of the game," he said curtly.

"And everyone wants to produce wickets where eventually one wants results. You will probably prepare wickets where the ball holds a bit more sway over the bat and that's necessary and part of the game," Dravid didn't deny the bowlers' advantage.

Someone cheekily asked about the critics, saying that during the head coach's playing days there used to be good batting strips on offer and 550 plus used to be scored.

"No one wants extremes but it can happen. I am not going to divulge personal conversations with my players and everyone There was a hint of sarcasm wants to win and qualify.'

# Sri Lanka Bid To Sweep New **Zealand & Reach WTC Final**

WELLINGTON: Sri Lanka will look to strike an early blow against New Zealand in Christchurch this week and hope Australia can thwart India to keep the World Test Championship (WTC)

With Australia already confirmed in the WTC final, Sri Lanka can join them by sweeping New Zealand in their two-test series if India are denied victory in the fourth test in the subcontinent. The series starts at Hagley Oval on Thursday, the same day India and Australia start their final test at the mega-stadium in Ahmedabad.

Sri Lanka has by far the harder assignment, needing to create history to leapfrog their south Asian rivals. They have never won more than a single test in New Zealand and their last victory was in 2006, when Mahela Jayawardene's team split a 1-1 series with the Stephen Fleming-captained hosts.

"Beating New Zealand in New Zealand is certainly going to be a huge task but last time we played some good cricket over here," veteran all-rounder Angelo Mathews told reporters on Tuesday, referring to their 1-0 defeat on the 2019 tour.

"We have to play fire with fire because they're going to come hard at us."

Sri Lanka have left no stone unturned in their preparations and recently held a training camp at a new facility in the hills south of Kandy to try to simulate New Zealand's cool conditions and bouncy wickets. With some rain forecast through the Christ-

church test, Dimuth Karunaratne's Sri Lanka might do well to follow England's attacking example and seek to move the game on quickly in pursuit of victory. Anything less than a win before the second

test in Wellington will put India into the WTC final. Mathews said Sri Lanka would stick to their style, having won three of their last six series and suffering their only loss to India away. "Obviously, the English are playing a different brand of cricket," he said. "No pressure at

all. We know that we've got to win both the
