

### Srinagar Attains 71 Percent CD Ratio

Srinagar: A meeting of District Level Bankers Review Committee/District Consultative Committee (DLRC/DCC) was held under the Chairmanship of Deputy Commissioner (DC) Srinagar, Mohammed Aijaz Asad here at meeting hall of the DC Office Complex to review the performance of the Banks and other Financial Institutions under various Government initiatives and sponsored schemes

At the outset, the Deputy Commissioner assessed the sector wise performance of the Banks in implementation of different Government initiatives and reviewed the achievements of Banks in lending to Priority/ Non Priority sectors under Annual Credit Plan.

On the occasion, the DC was apprised that an amount of Rs 2017.36 crore has been disbursed among 43197 cases in Srinagar District under different schemes thereby generating

self-employment opportunities for over 114943 unemployed youth of the District during financial year 2022-23.

The DC was informed that the target of generating 1.50 lakh Self Employment avenues for youth of Srinagar District is set to be achieved during the current financial year which is 3 times more than the 43000 accomplished during FY 2021-22.

While reviewing the bankwise movement of CD Ratio in the District, the DC was informed that total Deposits of the District Srinagar stood at Rs 33024.07 Crore and Advance at Rs 23418.30 Crore constitute 71 percent CD Ratio in the quarter ended in December, 2022.



AMANPOST - The automatic rifles have given way to spades and shovels, heavy artillery to earth movers and soldiers to construction workers. Troops in divided Kashnir are working frantically to convert what was a mine infested dirt track on one of the world's most heavily militarized frontiers into a peace road connecting the Indian and Pakistani sectors by bus

The hopes of millions of Kashmiris are riding on the success of the project, one of the most tangible signs of a fledgling peace after decades of enmity.

Agreement to launch the bus service has stoked huge anticipation on both sides, with people separated from their families or decades lining up in their hundreds for travel permits to make

05-mile journey. "I am really very excited," said Ghulam Mohammad Lolabi, 3, flashing a victory sign in Muzaffarabad, capital of Pakistani Cashmir, after grabbing an application form for the permit. "Many of my relatives' living there (in Indian Kashmir) have

lied," he said. "But I hope I can see those who are alive.'

Construction of the road began after nuclear-armed India and Pakistan agreed in February to launch an historic bus service between -the two Kashmirs, divided by a half-century-old military ease-fire line. The service 'it is hoped, will bolster the peace pro-ess between the South Asian rivals, whose competing claims over Kashmir have led to two of their three wars since independence in 1947. They went to the brink of another war in 2002. The 15-yeir insurgency in which tens of thousands of people

nave died in Kashmir has also held back peace efforts. India accuses Pakistan of aiding the Guerrillas but Islamabad says the insurgency is an indigenous movement

#### RECONNECTING THE PAST

This month, Indian and Pakistani soldiers removed all land nines on the track, which was last used by a bus in 1948, ahead of

the launch of the bus service on April 7. "The entire road has been demined. It is now safe for journey," Lieutenant-General Hari Prasad, who heads the Indian army's northern command, said at Kaman Post, the last border post on the Indian side. "We look at it as a very good step toward normalization of relations between India and Pakistan." he said. This is going to be the biggest confidence-building measure so far. Buses will man between Muzaffarabad and Srinagar restoring a service cut after the first war over Kashmir in 1947-48. A heavily mined 460-mile cease-fire line has I divided the scenic region ever since.

The bus service is the latest in a series of gestures between the neighbors to build trust since they embarked on a fresh peace

drive in 2003. A cease-fire has largely held since that year. This week, visiting journalists saw hundreds of Indian m Pakistani workers laying stones and rebuilding the last stretches of the Srinagar-Muzaffarabad road. The cease fire line at Kaman Post is marked by a small stream surrounded by towering mountains. A wooden bridge over the stream was blown up during the 1947-48 war and the remaining four piers are a symbol of the regions lustal of division -- two piers belong to India and two to Pakistan

Laborers of the two countries were strengthening the lira pillar on their respective sides ahead of building a new bridge. As workers raced to finish the job. Indian and Pakistani soldiers tood relaxed around the area, a far cry | from the daily artillery and gunfire exchanges prior to the cease-fire. "Everything will be ready before March 31, even before that."

Sardar Mohammad Rahim, a senior government official in Muzafarabad told Reuters.



The Municipality of Kupwara must be held accountable for its flagrant disregard for environmental health and human rights, as evidenced by the intentional dumping of municipal waste into the rivers below the bridges using machinery. Such actions represent a clear violation of the law and illustrate a blatant disregard for the well-being of those who rely on the water body for sustenance.

This instance serves as a prime example of how administrations may resort to beautification tactics to conceal deficiencies and violations. The Municipality of Kupwara, by adorning the bridges with decorations, sought to create a false impression of the town's cleanliness and beauty. Meanwhile, they have neglected their duty to maintain the environment and have contaminated the rivers with their waste, which directly impacts the lives of those who depend on the water body. This behavior is unacceptable and indicative of the Municipality's lack of concern and responsibility toward its citizens and the environment. It is crucial that such acts are addressed and remedied through appropriate legal and policy measures to prevent further harm to the environment and its inhabitants.

To address these challenges, the administration of Kupwara must prioritize the needs of the people over cosmetic improvements. The administration should invest in development projects that address the root causes of underdevelopment and mismanagement of resources. This includes investing in healthcare, education, and infrastructure.

The administration should involve the community in the decision-making process. By involving the community, the administration can gain a better understanding of the needs and priorities of the people. # Imran Khan Crisis Is Pakistan Facing Its Own January 6 Moment?

he day and night of March 14, as police and Imran Khan's supporters clashed in Lahore – the air in the swanky Zaman Park residential area thick with tear gas, bricks, sticks and petrol bombs – there was a moment when I asked myself this question: "Is this the moment?"

Political observers have asked themselves this question several times in Pakistan's history. "The moment" could be martial law, countrywide rioting, a decisive operation that leads to more violence, or a stand down from a standoff. The question seeks clarity, either an escalation or a concession to follow the rules of politics or the law of the land.

The pitched battle happened because police were following a court order to ensure Khan's presence for a hearing. Members of the former prime minister's Pakistan Tehreek-e-Insaf (PTI) party had been encamped around his Zaman Park residence in Lahore to protect him from arrest for months. The police were armed with tear gas and sticks. PTI supporters with petrol bombs and bricks.

In the end, more police officers were injured than supporters. "Khan is our red line" has been the rallying cry for months, while the police used brute force against Khan's followers during a protest on March 8, in which one political worker died.

#### Chaos is the new normal

Khan has been selective about which court summons to obey, citing se-

Dozens of cases have been filed against Khan – some serious, most politically motivated. It is an excessive number of cases, even against a politician who has opted for the path of most resistance to being removed from power.

He is not the first in the country's history: Politicians and political parties that fall afoul of the military establishment are removed and they eventually find resistance is futile. But then Khan is not following the normative rules of politics in Pakistan.

Most political leaders will choose to go to jail. It is a colonial tradition carried over into a post-colonial state that has not been able to evolve into a fully functioning democracy, so it is seen as a political rite of passage through the decades – from Zulfiqar Ali Bhutto to Benazir Bhutto, to her spouse Asif Ali Zardari, to Nawaz Sharif, to Maryam Nawaz Sharif.

The irony is that Khan has tried to use colonial resistance tactics to trigger elections – his chief demand since he exited the prime minister's office in April 2022 after a vote of no confidence. He ordered a "jail bharo tehreek", or "fill the jails movement", this February for workers and second-tier leadership. Dozens went to jail, while Khan got preemptive bails for his various court cases and the movement fizzled out.

Several days later after the Zaman Park clashes, the answer to the question "is this the moment" has been made clear – there is still no clarity, no easy

#### path out of chaos.

Prime Minister Shehbaz Sharif has offered a dialogue while Khan has indicated a willingness. But each is waiting for the other to make the first move. Over the last few years, ordinary political rivalries have morphed into deeply entrenched enmities. The normal arbiters – such as the military establishment and the higher courts – have become divided into politicised factions. Khan's party exited the lower house of parliament, where in a normal democracy, political contestations are sorted. Chaos is the new normal.

"Right-wing populism pokes away at the country's fragile compromises until they become active tensions," says Turkish writer Ece Temelkuran in her book How to Lose a Country. Pakistan seems to be at a stage where anarchy is marking time between populism and authoritarianism. What form remains to be seen is, whether it is civilian, military-fronted or just the military.

#### Who is in charge?

In an interview with Voice of America, Khan reluctantly conceded that the "one man" calling the shots is the current army chief, General Asim Munir. His reluctance emanates from a strategy where he seeks the approval of the army establishment behind closed doors but uses metaphors to attack military officers when it suits his political strategy.

The duality is a nod to the support he got from within the military during his ascent to the prime ministership in 2018, and an acknowledgement of where actual power lies in Pakistan.

For example, Khan was willing to offer a third extension in his tenure to former army chief General Qamar Javed Bajwa in exchange for early elections last year. Elections are due in Pakistan this October. After Bajwa declined, Khan accused the former army chief of conspiring with the US to overthrow him and called for a court martial. While he was prime minister, Khan had described Bajwa as "the most democratic army chief".

As commentator Raza Rumi has written: "The social classes that inhabit unelected institutions share Mr. Khan's weltanschauung which comprises exhibitions of public religiosity, hatred for traditional political elites, citing 'corruption' as the biggest issue, and a convenient, varying dose of antiAmericanism. This is why Mr. Khan is a formidable foe for the ancien regime. He is their creature and nemesis at the same time."

By using formidable propaganda tactics that tap into young Pakistan's sense of disenfranchisement, Khan has found an answer to traditional power centres, as evidenced by how his supporters resisted his arrest.

But what does this mean for the upcoming elections? Will they prove to be a magic cure-all? It does not seem likely given the lessons learned from Donald Trump and Jair Bolsonaro's supporters in 2020 and then in 2023. Perhaps the Zaman Park resistance was a foreshadowing. Given its fragile economy and divided polity, can Pakistan afford another disputed transfer of power?

In its editorial, the country's leading newspaper the Dawn wrote: "The democratic electoral process, which is supposed to act as the safety valve for the public's pent-up emotions, remains in limbo, and this may be why more people are feeling the need to act violently to assert their wishes in front of the state."

The current breakdown of the political process is not normal. Therefore, before elections, past and present grievances need to be settled between political parties, the judiciary and the military with an understanding of the rules of the game by the constitution.

Without a grand reconciliation, elections will merely be performative.

ASTING in one form or the other does exst in almost all the religions. However, fasting or 'Roza' as practiced by Muslims is an elaborate process of self-purification.

The' Qur'an says, "O ye who believe! Fast-ing is prescribed to you as it was prescribed to those before you, that ye may (learn) selfrestraint (Qur'an, A – Baqara, 2:183.)

The month of fasting or Ramazan involves a wide range of responsibilities on the part of those who observe fasting.

Normally the fast should not affect the daily avocations, and it should not be a pretext for neglecting normal duties. Islam never approves, much less demands, of keeping vigil during the whole night and passing the following day in sleep and indolence. Fasting should make one remember the hunger and starvation of the poor and develop empathy for the deprived



people. It is an opportunity to experience hunger so that people will understand the pain of the hungry and will go forward to help them. Ramazan fasting is also an exercise in self-discipline. For those who are chain smokers or who nibble food constantly, or drink coffee every hour, it is a good way to break the habit.

#### **PSYCHOLOGICAL DIMENSIONS**

The human body consists of physical, emotional, biological and spiritual parts. A balanced mix of these can lead to excellence. The fasting during the month of Ramazan orients the observer to the art of balancing the spiritual essentials with other parts. It helps curb the animalistic tendencies originating from the stomach, in full. It is an effective tool for sobering of a mind and reconstruction of our spiritual faculties.

#### **HEALTHCARE BENEFITS**

There are a number of healthcare benefits . which originate from the month of fasting. The basic among them being that Allah does many diseases. Ramazan fasting is a sentinel against disease, provided the fast follows the strict dietary rule: eaIt is categorically stated, "... Eat and drink, but waste not by excess, for Allah loves not wasters." (Al-Qur`an, 7:31). We also have additional prayers prescribed after the dinner during the month of Ramazan. According to one estimate, using a calorie counter, the amount of calories burnt during the special night prayer of Ramazan (tarawih) amounted to 200 calories. It is stated that this form of prayer as well as the five daily-prescribed prayers use all the muscles and joints and can be considered a mild form of exercise in terms of calorie output.

#### **CONCEPTS OF HOSPITALITY, NEIGHBORHOOD AND** CHARITY

The concepts of hospitality, neighborhood and charity are important virtues apart from self-purification, which the month of Ramazan is expected to imbibe among the followers of Islam. The Prophet had said, "Those who become happy on hearing the sound of

the footsteps of a guest, God will forgive their sins". It is thus a great incentive to practice the concept of hospitality.

The practice of the concept of neighborhood is equally important. It has wider connotations than its literal meaning. The Prophet had said, "One should behave de-cently with the whole of humanity and foremost among them is your neighbour." If one connects it with the concept of fasting, an immediate implication is that a true Muslim cannot see any human being hungry, even if it means having to sacrifice 'iftar' and to continue fasting for the next day. Similarly, a true Muslim cannot see a human being in pain or misery. It applies to both one's immediate neighborhood as well as humanity at large. What we are witnessing around us in the name of Islam is not Islam. In essence Islam in general and 'roza' in particular teaches a person to address human concerns and values.

On charity it is said that if one gives say a charity of rupees ten during the month of Ramazan, he will get 70 times more blessings in return. This is a great motivation and in reality an average middle class Muslims do follow this more meticulously than others. The rich on the other hand do it for the sake of fame & name. A Muslim is also expected to take stock of his personal wealth both cash and kind, every year and calculate 'Zakat' which is to be earmarked for distribution among the poor and needy.

Of the greatest advantages of fasting in the month of Ramazan is that its true observance inculcates in a person a habit of speaking the truth- a commodity that is becoming very rare nowadays. If a person speaks the truth, practices the concept of hospitality and neighborhood and gives charity as advocated above, he will certainly be entitled to God's blessings and protection, which we all need so desperately in these modern times.

# **Navigating People at Work**

ave you ever suffered through tales of greatness from a self-absorbed "friend" who reminds you of Michael Scott from "The Office" – and not in a good way? Have you been betrayed by a colleague out of the blue, undermined on a project by the office mean girl, or had a work friendship dropped altogether without explanation?

If any of these scenarios sound familiar, you may have been dealing with someone who has what psychologists term a "dark personality." These people score higher on three socially undesirable traits: narcissism, psychopathy and Machiavellianism.

As an organizational scholar, I've spent years studying personality traits in the context of the sales profession. In recent work, my colleagues and I focused on the ways people with these dark personalities succeed in sales organizations and the social factors that allow them to extend their successful tenures. Based on our research, here's a primer on these antagonistic personality types – and how you can unmask examples you encounter in your everyday life.

#### **DEFINING THE DARK** PERSONALITIES

Narcissists have the most familiar type of dark personality. They aren't shy about letting you know exactly how highly they think of themselves. At work, you might find the narcissist bragging about their superior sales skills, even though their performance isn't much better than the average

salesperson. Conservative estimates of narcissism in the general population fall around 6.2%.

While narcissistic behavior can be annoying, it's usually more tolerable than what the other two dark traits tend to serve up.

Functional - meaning noncriminal – psychopaths are particularly disturbing. Psychologists estimate they comprise up to 4% of the general population. Psychopaths have no qualms about exploiting others for their own benefit. Stubbornly antisocial, functional psychopaths generally have little empathy for others. They're more concerned about "getting theirs" by any means necessary. Psychopaths are quick to deflect blame and throw others under the bus, even if it means telling lies.

With their impulsive tendencies, psychopaths are prone to telling lies for no particular reason at all. If you find yourself in a group watercooler conversation and hear someone telling lies that don't seem to serve any purpose, vou might have stumbled on a functional psychopath.

In the workplace, at first a psychopath may seem charming. But eventually you'll likely find yourself either questioning their motivations, or becoming a victim of their destructive behavior. Though they can be harder to identify than narcissists with their nonstop bragging, psychopaths' egregious behavior tends to unmask them in the end. Machiavellians are the most prevalent of the dark person-

alities, estimated to be about 16% of the population. They



get their name from Italian Renaissance statesman Nicolo Macchiavelli, who believed the ends could justify immoral means. Less annoying than narcissists, less abrasive than functional psychopaths, Machiavellians are more subtle in the pursuit of their agendas. They forge ahead regardless of ethical considerations. Like lions, Machiavellians seem benevolent, watching their prey from

afar – until they strike. They're adept at playing the long game - it's their stealth, patience and subtle manipulation that make them a particularly dangerous dark personality.

Compared with a psychopath's unnecessary lies, you're more likely to overhear the Machiavellian in the group telling little white lies that are strategically designed to further a future agenda. For example, you might hear them flattering the colleague you happen to know will be getting a big bonus in the near future - the Machiavellian may be strategically laying the groundwork for being invited to help them spend it.

In short, targets of dark personalities likely find narcissists to be conspicuously and irritatingly self-centered, but generally innocuous. Psychopaths are less obvious in their bad behavior, but their transgressions can be quite severe. Machiavellians are less in-your-face than narcissists, and their nefarious actions are likely to be less severe than those of psychopaths. In the long run, though, a Machiavellian can leave you reeling from an unexpected betrayal to benefit their personal agenda.

As you consider these dark traits and how they show up in interpersonal relationships, you might sense a spark of recognition. Here are five tips for avoiding dark personalities in your own life or minimizing the harm they cause.

#### **1. DON'T FALL FOR FIRST** IMPRESSIONS

Dark personalities are experts at making great first impressions, drawing you in with humor and charisma. So, when you meet someone new, be wary of superficial appeal. Narcissists, with their tendency to talk themselves up, are the easiest to spot.

To identify the others, ask questions about past relationships and listen carefully for clues about who this person really is. Because dark personalities are almost always unmasked in the end, they're less likely to have long-standing friendships – an absence they may explain away by faulting others.

Just be mindful not to overcorrect and ditch a potential new work friend based only on first impressions, either.

#### 2. SHARE YOUR OWN (BAD) **EXPERIENCES**

When you encounter a dark

personality and the outcome is unpleasant, you might feel embarrassed for allowing yourself to be fooled or manipulated, or you might feel guilt or shame when you observe someone treating someone else badly. As a result, you might not want to talk about it. Dark personalities exploit that reluctance because your silence helps keep hidden their "core of darkness" - the antagonistic traits that define them.

So to help unmask the dark personality and keep others from meeting the same fate, sharing your experience, with discretion, is critical.

#### **3. MANAGE UP TO CLUE BOSSES**

Those with dark personalities are good at carefully managing the impressions they make on people in positions of power. So, at work, you can practice managing up to help your boss see the dark personality more clearly.

Share your experiences in a nongossipy way, such as expressing concern about incidents of incivility that you witnessed or requesting advice or guidance in dealing with a very boastful colleague who may be alienating prospects or customers. It may help your boss see through the facade and help you deal with the issue.

#### 4. PLUG INTO YOUR NETWORKS

On the flip side, remember to also listen to others. To avoid falling into a manipulator's web, tap into the network of those around you who share a link to the person in question. See if you can gather references regarding their behavior over the long term. Ideally, you can benefit from others' knowledge, without having to learn the hard way.

#### **5. BE AWARE OF YOUR OWN** BIASES

Don't underestimate the strength of a dark personality's machinations. When someone shares a personal story of betrayal, be wary of thinking, "that would never happen to me!" Dark personalities are experts in manipulating situations to serve their interests, and you may never notice vou're ensnared until it's too late. Considering yourself too smart or savvy to ever find yourself in the same predicament is misguided. As you apply these tips in your life, you want to be wary of becoming an armchair pscyhologist. Anyone can have a bad day – and everyone has. Instead of diagnosing friends, partners and colleagues based on what you think might be their underlying personality traits, focus on any bad behaviors you personally witness, and respond to the actions not what you think underlies them. Best leave that to the professionals.

If you are in charge of organizations or teams, consider having clear guidance and pathways of communication for individuals to report any concerning behavior they witness. By working together and sharing collective experiences, the rest of us can shine light on the workplace misdeeds of those with antagonistic personalities.

# Punjab Cracks Down On Preacher Amritpal Singh; 78 Supporters Arrested

Chandigarh: The Punjab government on Saturday launched a major crackdown against radical Sikh preacher and Khalistan sympathiser Amritpal Singh, with police arresting 78 mem-bers of an outfit headed by him, officials said.

The elusive preacher himself, however, gave the police a slip and escaped their dragnet when his cavalcade was intercepted in Jalandhar district, even as authorities stepped up security at several places and suspended internet services in the state till Sunday noon.

The police said it has launched a "massive state-wide cordon and search operations (CASO)" in the state against elements of 'Waris Punjab De' (WPD), headed by Singh, against whom several criminal cases had been registered.

During the operation, a total of 78 persons have been arrested so far, while, several others have been detained for questioning, it said.

Amritpal Singh and others are on the run and a massive manhunt has been launched to nab them, a police spokesperson said.

Some supporters of 'Waris Punjab De' chief shared some videos on social media claiming that policemen were chasing them. A video also showed Amritpal sitting in a vehicle and one of his aides could be heard saying policemen were after "Bhai saab" (Amritpal).

During the state-wide operation, nine weapons, including one .315 bore rifle, seven rifles of 12 bore, one revolver and 373

live cartridges of different caliber have been recovered so far, the police said.

The police spokesperson informed that the WPD elements are involved in four criminal cases relating to spreading disharmony among classes, attempt to murder, attack on police personnel and creating obstructions in the lawful discharge of duties of

public servants. An FIR dated February 24 stands registered against WPD elements for the attack on Ajnala Police Station, he added. Last month, Amritpal and his supporters, some of them brandishing swords and guns, broke through barricades and barged into the Ajnala Police Station on the outskirts of the Amritsar city, and clashed with police for the release of one of Amritpal's aide. After the incident, in

which six policemen including a Superintendent of Police rank officer had suffered injuries, the AAP government in the state had faced severe flak and was accused of kowtowing to extremists.

A heavy deployment of security forces had been made near village Jallupur Khera in Amritsar, the native place of Amritpal Singh, for the operation.

Dubai-returned Amritpal Singh was last year anointed the head of 'Waris Punjab De', which was founded by actor and activist Deep Sidhu who died in a road accident in February last year

Officials said Amritpal Singh has been maintaining close links with Pakistani intelligence agency ISI and terrorist groups based in foreign countries.

Amitpal Singh, who had even issued a veiled threat to Union Home Minister Amit Shah, has been trying to destabilise the situation in Punjab by indoctrinating and attracting Sikh youths into the fold of his outfit 'Waris Punjab De', sources said.

Meanwhile, Punjab Police asked people to maintain peace and harmony.

"Request all citizens to maintain peace & harmony Punjab Police is working to maintain Law and Order. Request citizens not to panic or spread fake news or hate speech," it said in a tweet.

Earlier this month, Punjab Chief Minister Bhagwant Mann had called on Union Home Minister Amit Shah and discussed with him the prevailing law and order situation in the border state.



Mohammad Haroon Malik said that people had rights like the Forest Rights Act in past also when Sir Walter Lawrence did land settlement in J&K around 1890, but after enactment of FRA these rights have been properly identified and people have not only individual and community forest rights but they have rights over the local non forest timber produce (NTFP) as well. He said that Govt of India has launched a scheme called Van Dhan Yojna wherein J&K Tribal Affairs Department has made a MoU with the Cooperatives Department for setting up Self Help Groups

(SHGs) for Scheduled Tribes (STs) and Other Traditional Forest Dwellers (OTFDs).

These SHGs can collect the minor forest produce at their own level and process the same. The Tribal Affairs Department will help in market linkages as well so that they get better returns from the same of these products" said Mohamad Haroon Malik

Sub Divisional Magistrate (SDM) Chadoora P N Hamid who is also the Chairperson of Sub Division Level Committee under Forest Rights Act in Chadoora Budgam in his address said that tribals and other traditional forest dwellers must focus on the education of their children. He said that under FRA several community forest rights have been already given to people in Doodh Ganga forest range especially and the administration was working to remain more focussed on this in future. SDM Chadoora said that he will be happy to hold more such workshops in future. Range Officer Doodh Ganga Range Tariq Nazir spoke about FRA in detail and the rights which people are entitled . We had discussed in team meeting as well to make a good start, to keep the ball in good areas and stick to our line and length," he said in conversation with fellow pacer Mohammed Siraj in a video posted on BCCI.tv. Siraj also claimed three wickets for 29 runs to play a huge role in India's win.

"When I get the new ball, I try to bowl inswing. Like when there is a left-hander, I try to bowl inswing. I wanted to take as many wickets in the powerplay. I got one wicket," he said.
