Srinagar: As Ramazan moon was not sighted anywhere in India or Pakistan till late hours on Wednesday Kashmir Grand Mufti Nasir-ul-Islam, like many others, made his customary announcement about the first day of fasting starting from Friday.

However a late night announcement from the neighbouring country that the Ramazan moon has been sighted put many of them in quandary. Interestingly Grand Mufti this time around maintained his stand breaking from the tradition of following Pakistan on the matters related to moon sighting.

Nasir-ul-Islam had said that no evidence from any part of the J&K was received about sightings of Ramazan moon and therefore, the first day of the fasting month will be on Friday (March 24).

Ruet-e-Hilal Committee officially announced the sighting of the Ramazan moon during late hours on Wednesday, mosque loudspeakers across Kashmir started blaring with announcements declaring Thursday as the first day of fasting.

When contacted Mufti Nasirul-Islam said he stands by his decision as the crescent wasn't sighted from any territory in Jammu and Kashmir.

Nasir ul Islam said that the office had entrusted its men across all districts of Jammu and Kashmir to see if the crescent is visible at any place. #### 12 Dead In Pak-Afghan Earthquake **Press Trust Of India**

Islamabad: A strong 6.8 magnitude earthquake with the epicentre in Afghanistan shook Pakistan, killing at least 12 people and injuring nearly 250 others in both the countries, authorities said on Wednesday. The earthquake's epi-

centre was Afghanistan's Hindu Kush region, while its depth was 180 kilometres, according to the Pakistan Meteorological Department. Tremors were also felt in many parts of north India, including the Delhi-National Capital Region.

#### **BSF Fires At Pak Drone In Samba**

# **Physicists Detect Neutrinos Created By Particle Collider, Experts Explain Significance**

hysicists have detected neutrinos created by a particle collider, where two beams of particles smash together at extremely high energy. The scientists, led by the Uni-

versity of California, Irvine (UCI), US, have claimed it to be a "scientific first".

According to them, the discovery is expected to deepen scientists' understanding of neutrinos, subatomic particles that also play a key role in the process that makes stars burn.

"We've discovered neutrinos from a brand-new source - particle colliders," said UCI particle physicist and FASER Collaboration Co-Spokesman Jonathan Feng, who initiated the project, which involves over 80 researchers at UCI and 21 partner institutions.

"These very high-energy neutrinos in the Large Hadron Collider (LHC) are important for understanding really exciting observations in particle astrophysics," said Boyd.

Brian Petersen, a particle physicist at CERN, announced the results Sunday on behalf of FASER at the 57th Rencontres de Moriond Electroweak Interactions and Unified Theories conference in Italy.

The results are the latest from the Forward Search Experiment, or FASER, a particle detector designed and built by an international group of physicists and

installed at CERN, the European Council for Nuclear Research in Geneva, Switzerland. There, FAS-ER detects particles produced by CERN's Large Hadron Collider.

Neutrinos, which were first spotted in 1956, were co-discovered by the late UCI physicist and Nobel laureate Frederick Reines and are the most abundant particle in the cosmos.

Since the groundbreaking work of Reines and others like Hank Sobel, UCI professor of physics & astronomy, the majority of neutrinos studied by physicists have been low-energy neutrinos. But the neutrinos detected by FASER are the highest energy ever

produced in a lab and are similar to the neutrinos found when deepspace particles trigger dramatic particle showers in our atmosphere.

"Neutrinos were very important for establishing the standard model of particle physics," said Boyd.

"But no neutrino produced at a collider had ever been detected by an experiment," said Boyd.

"Neutrinos are the only known particles that the much larger experiments at the LHC are unable to directly detect, so FASER's successful observation means the collider's full physics potential is finally being exploited," said UCI experimental physicist Dave Casper

# Vajpayee Swears By Secularism

Vows To Create New Work Culture

ew Delhi- Prime Minister Atal Bihari Vajpayee today declared that his coalition government will initiate speedy internal liberalisation of the economy, allow upto Rs 1,500 crore of foreign direct investment in states in the power sector and strive to create a new work culture.

The government is committed to speedy internal liberalisation of the economy, freeing it from all the growth-hindering bureaucratic and government controls, 72-year-old Vajpayee said in his first broadcast to the nation.

Vajpayee said in the turbulence of the world markets and in the new emerging regime of the world trade organisation, India's principle responsibility should be to safeguard and, promote the country's interest.

Asserting that a major area of focus will be restructuring centre-state relations and decentralising financial and administrative powers to states, he said as a first step, the government will urgently devise legal and executive changes so that decision can be taken directly by states in regard to sectors such as power. Even in regard to foreign direct investments upto, say, Rs.1,500 crore, he said.

In his broadcast, the Prime Minister said we must restore the credibility of public life and public institutions, making them once again reliable and independent pillars of state.

Noting that the country must give up the harmful path of confrontation, he said my government is unequivocally committed to the concept of secularism... we treasure it.

Stressing that his government would reach out to talent across the country, Vajpayee said it shall strive to create a new work culture, a world class working environment so that the best remain here to build our country, so that those who are now working elsewhere return, and put their prodigious acumen to work for their country.

The Prime Minister said he would personally monitor programmes for doubling female literacy within ten years, vastly improving medical care for daughters and mothers, protecting self-respect for women and empowering them politically through reservation in parliament and State Assemblies.

On relations with India's neighbors, Vajpayee said the BJP-led coalition will strain every nerve to accelerate the trend in the last few years to improve relations with neighbouring countries.

We are determined to be friend with all and precisely because we happen to be the largest country, we shall be all the more sensitive to the aspirations and needs of our neighbours that applies to Pakistan as much as to our other neighbours, he said. (PTI)

# Ill-Prepared For Disasters

ashmir was struck by another massive tremor on the night of March 21. The quake lingered for around two minutes, making it probably longer in duration. The buildings swung, the ground seemed to slip from under the feet, and trees went through a jittery high frequency motion. The people frantically rushed out of their houses, many screaming in panic. The scene echoed the one witnessed on October 8, 2005. But mercifully, the valley was spared the enormous loss of life and property. In 2005, around 80,000 people had been killed in the quake across the Kashmir divide with the disproportionate loss of more than 75000 lives in Pakistan Occupied Kashmir and around 1400 on this side. Thousands of residential houses were toppled, and the public infrastructure was damaged. But this time with God's grace, the loss is very limited. This is a positive difference now. The similarity is in the immediate government response to the disasters. Almost nothing seems to have changed between the two quakes.

True, the devastation wrought by the 2005 quake has since been overtaken by the unprecedented deluge that swept Valley in 2014 but this hardly justifies forgetting an older catastrophe and unlearning the lessons from it. Seconds after the quake on Tuesday night, the communication system broke down for around fifteen minutes, which created panic as people couldn't get through to their loved ones. However, while the communication infrastructure is a major worry on such extraordinary occasions, an institutional answer to a massive quake calls for an effective immediate response, that in our case is always missing. The reason is that our state has always been lax on disaster preparedness. The older a calamity, the lesser the urge to prepare for its recurrence. For example, since the 2005 quake, our building codes continue to remain lenient and our builders take short-cuts. Similarly, there hasn't been any focus on the safety of our schools which are housed in buildings vulnerable to high intensity tremors. If the government needed a reminder, March 21 quake has handed it one.

There is a critical need to enhance the level of our preparedness to face the calamities of the egregious scale, like earthquakes and floods. The fresh quake has come as an important reminder to us to become more mindful of our vulnerability to the natural disasters – flood being the another – and take pro-active measures to lessen the damage should, God forbid, we experience another disaster. It is incumbent on the government not only to get its act together but also create a public awareness to help people to better prepare for a possible future calamity.



# **Fasting or Feasting**

This is not to say that people aren't allowed to eat whatever is permissible, but to caution ourselves and the readers of the threat of gluttony and stomach worship in an otherwise month of fasting

the month of Ramadan set to dawn, Muslims are anticipating the mercy and blessings of Allah to descend in abundance, there is a simultaneous worry of sorts that grips people in general and Muslims in particular with the onset of this month - exorbitant rates, black marketing, inflation and skyrocketing of prices. It is often seen in the month of Ramadan that South Asian countries, the Muslim majority countries in particular, witness the ripples of surcharging, shortage, money minting and excessive profit gains. "It is common that during the festive seasons, prices of daily commodities, from onion to beef, cosmetics and accessories, clothing items etc rise exceptionally taking these out of the reach of lower-middle income groups of people. We observe this trend the most in the month of Ramadan. Even the government struggles to control the sky-rocketing prices. We often generalise that this is due to maleficent intentions of merchants and businessmen who try to make more profit during this month. Although this explanabeing produced is the mindset of diners, who expect nothing less than a tantalizing feast-like iftar – the meal taken by Muslims after sunset to break their daily fast during Ramadan. But much of this food goes uneaten. Around 25-50% of the food prepared in the Arab world during Ramadan is wasted, according to the United Nations Environment Programme's 'The State of Food

Waste in West Asia' 2021" report. The basic problem with our understanding of Ramadan is to think of it as the month of feasting instead of fasting. While we continue to observe the scruples of Shariah during the day, our Suboor and iftars are literally the singular events of gluttony, hyper-consumerism and acrobatics of show off and the race of spendthrift to leave others behind. Lavish iftar parties being thrown open and the means and methods followed are very much antithetical to the spirit Ramadan, inverting its purpose and creating an opposite binary. These praxis need to be amended to bring them in accordance with the spirit of Ramadan and the larger vision of Islam to avert the ills being incurred and to make Ramadan what has been truly defined as the month of blessings, healing and balance. The fact needs to be emphasised that our excess at Suhoor and iftar not only undo the physical and medical benefits of Ramadan earned during the day but these activities in excess also undo the spiritual merits of fasting and instead of bringing us any good heighten the chances of being caught in divine wrath for our conduct and unbridled consumption. The problem of inflation and scarcity of goods and food items pitched up above

also bounces back on the face of people on deeper scrutiny. It is observed that the demand for food items and other goods soars up and the items which are otherwise scarcely used are seen to be in huge demand during the month of Ramadan. This reinforces our premise that people, instead of harvesting the month of Ramadan for physical and spiritual control, let themselves loose upon eatables and the daily food intake and the diversity of food items increases without reason and rhyme. This is not to say that people aren't allowed to eat whatever is permissible, but to caution ourselves and the readers of the threat of gluttony and stomach worship in an otherwise month of fasting. This month, as scholars have pointed out, raises our consciousness to the plight and misery of those who can't otherwise afford two square meals a day. But can this end be achieved when we indulge in gluttony and excess at dawn and the time of fast breaking at dusk? What petrifies religion is the danger of transformation of living religious practices into rituals lacking meaning and rationale – and in this case with Ramadan, the threat of ossifving a living religious praxis into a dead ritual is at hand What is needed is to reclaim Ramadan, consciously and conscientiously and to shred away the false accretions attached to it to realise its spirit and to wake up to its true call.

### Now or never

PCC assessment reports typically take six-to eight years to put together; so, AR6 is very likely the last before 2030, by when the window for action to stay on the 1.5°C pathway would have closed. So, the need to act on IPCC's advice couldn't be more pronounced. AR6 is quite clear that the level of ambition on climate action currently endorsed by nations is nowhere near adequate. It says there is a "substantial gap" between the emissions resulting in 2030 if countries implement the Nationally Determined Contributions they submitted before the Glasgow Summit (2021) and the levels projected for modelled mitigation routes that limit warming to 1.5°C. Indeed, without a scaling up of NDC ambitions post 2030, median warming could clock 2.8°C by 2100. Without a strengthening of climate-action policies from the level they were at in 2020, we are staring at a 3.2°C warming of the planet by the end of the century. Anything above 1.5°C is projected to cause irreversible climate change with catastrophic effects.

Climate action financing, for both adaptation and mitigation will be crucial—the IPCC says average annual mitigation investment to be made over 2020-2030 to limit warming to 1.5°C is six times greater than current levels. Even a 2°C limit needs thrice the investment happening currently. It calls for "accelerated financial support for developing countries from developed countries and other sources", in the form of "scaled-up public grants for mitigation and adaptation funding for vulnerable regions". India, which is projected to be among the worst sufferers of long-term climate change effects among the larger countries, has hailed the report for endorsing the principle of climate justice. AR6 offers hope that the world can still keep to the 1.5°C pathway only if countries drastically scale up action to reduce emissions.

Given that a shared ruinous future awaits all nations if this doesn't happen, the developed countries can't continue to think of climate action funding for the rest of the world primarily in terms of debt and private-sector investment. A large chunk of this has to come in the form of grants, including for loss and damages. Developed nations also need to pay heed to UN secretary general Antonio Guterres's exhortation to advancing their Net Zero target to as close as possible to 2040. Only then will there be space for developing nations to transition to a Net Zero pathway without sacrificing growth. *Financial Express*

# Majoritarianism on March in Israel

srael's Parliament, The Knesset, on 14 March advanced a Parliamen-L tary Bill that would let lawmakers pass laws that the Supreme Court cannot overturn - a key piece of legislation in Benjamin Netanyahu and his allies' proposed judicial overhaul that has divided the country.

The new Bill aimed at weakening the Supreme Court passed first reading, alongside a bill that would protect PM from removal, and another that would allow more settlements in northern Israel. These laws have been passed despite months of protests against the first law.

The Knesset worked till the early hours of 14 March morning to pass the first reading of the bill, which has been one of the main priorities of Prime Minister Benjamin Netanyahu and his governing coalition of far-right and ultra-Orthodox religious parties.

#### **CONTROVERSIAL BILLS**

Earlier, on Monday night, in another win for Netanyahu, the parliament also advanced a bill that would make it harder to remove the prime minister over the corruption charges that still hang over him.

The bill would allow the parliament to declare a prime minister unfit to rule only due to physical or mental reasons and would replace a current law that allows the court or the parliament to remove a leader under other circumstances.

The new bill would require approval by three-quarters of the government, and could be overridden by the prime minister.

The proposed change to the rules overseeing the removal of a prime minister is of personal importance to Netanyahu, who returned to power late last year after Israel's fifth election in less than four years.

He is on trial on charges of fraud, breach of trust and accepting bribes, and denies the allegations. The proceedings have dragged on for nearly three years.

Another bill that passed the first reading would allow more settlements in the northern occupied West Bank, which would lead to the legalisation of settlement outposts considered illegal even under Israeli law.



The vote comes only weeks after Israeli settlers rampaged through a Palestinian town last month, killing one man and setting fire to dozens of homes and cars. Settlements in the occupied West Bank and East Jerusalem are already considered illegal under international law.

Palestinian citizens of Israel, who make up some 20 percent of the population, have been largely absent from the protests, in part because they suffer from discrimination in Israel and because of Israel's treatment of Palestinians in the occupied West Bank and blockaded Gaza Strip.

Israelis have killed at least 70 Palestinians this year under Israel's new government, many of them during Israeli military raids. It brings up the total of Palestinians killed in the occupied West Bank over the past year

#### to more than 220.

#### **CRITICISM OF THE BILLS**

The steps were the latest in a series of moves by Mr. Netanyahu's coalition to overhaul Israel's legal system. The Prime Minister and his allies say the effort is aimed at reigning in an activist court. Critics say the drive

would upend the country's democratic checks and balances, defang the Supreme Court, and concentrate power in the hands of Mr. Netanyahu

and his parliamentary majority. Speaking to members of his Likud party on Monday, Netanyahu lashed out at the Israeli media, saying they are broadcasting a "never-ending tsunami of fake news" against him. He reiterated his claim that the legal changes will strengthen Israeli democracy. We can find echoes of these sentiments elsewhere, too.

Netanyahu and his ultranationalist and religious coalition allies have pledged to plough ahead with the legal changes despite demonstrations by tens of thousands of Israeli protesters over the past two months. Business leaders, legal experts and retired military leaders have joined the protests against the judicial overhaul, and Israeli reservists have threatened to stop reporting for duty if the overhaul passes.

Opposition lawmaker Orna Barbivai said the bill was "a disgrace, which says the prime minister is above the law".

Natan Sachs, Director, Centre for

Middle East Policy at the Brookings Institute described this legislation as the most far-reaching revolution ever in the state's constitutional makeup. According to him this proposal would all but abolish the role of the Supreme Court as the sole check on executive and legislative power in Israel. In short, he says, in Netanyahu's new Israel, the slimmest of majorities could decide anything, and it is pure, unbridled majoritarianism.

UN High Commissioner for Human Rights Volker Türk has raised a range of concerns, which may pose a serious risk to the effectiveness of the judiciary to defend the rule of law, human rights, and judicial independence. He described these as changes going to the heart of a country's long-standing constitutional structure.

Israeli Opposition too is up in arms against the Bills, opposition leader Yair Lapid said that we are fighting for our children's future, for our country's future. We don't intend to give up. Leaders in the booming tech sector have warned that weakening the judiciary could drive away investors.

The overhaul has also prompted otherwise indifferent former security chiefs to speak out, and even warn of civil war. The plan has even sparked rare warnings from the U.S., Israel's chief international ally.

U.S. Ambassador Tom Nides at a podcast said that Israel should "pump the brakes" on the legislation and seek a consensus on reform that would protect Israel's democratic institutions.

As the critics both with and outside Israel say, these steps are in tune with the majoritarian policies of the ultra-right wing political elements in Israel and apart from providing a recluse to the prime minister from corruption cases they are also aimed at denying the right of self-determination to the Palestinians in the occupied territories.

Learn what to do during an earthquake, whether you're at home, at work, at school or iust out and about. Taking the proper a tions, such as "Drop, Cover, and Hold On", can save lives and reduce your risk of death or injury. During earthquakes, drop to the floor, take cover under a sturdy desk or table, and hold on to it firmly. Be prepared to move with it until the shaking stop.



#### WHEN INDOORS...

Stay as safe as possible during an earthquake. Be aware that some earthquakes are actually foreshocks and a larger earthquake might occur. Minimize your movements to a few steps to a nearby safe place and stay indoors until the shaking has stopped and you are sure exiting is safe.

- When you feel an earthquake, duck under a desk or sturdy table. Stay away from windows, bookcases, file cabinets, heavy mirrors, hanging plants, and other heavy objects that could fall. Watch out for falling plaster and ceiling tiles. Stay undercover until the shaking stops and hold onto your cover. If it moves, move with it.
- DROP to the ground; take COVER by getting under a sturdy table or other piece of furniture; and HOLD ON until the shaking stops. If there isn't't a table or desk near you, cover your face and head with your arms and crouch in an inside corner of the building.
- Stay away from glass, windows, outside doors and walls, and anything that could fall, such as lighting fixtures or furniture.
- If in bed when the earthquake strikes, hold on and protect your head with a pillow, unless you are under a heavy light fixture that could fall. In that case, move to the nearest safe place.
- Use a doorway for shelter only if it is in close proximity to you and if you know it is a strongly supported, load-bearing doorway.
- Stay inside until shaking stops and it is safe to go outside. Research has shown that most injuries occur when people inside buildings attempt to move to a different location inside the building or trv to leave.
- Be aware that the electricity may go out or the sprinkler systems or fire alarms may turn on. DO NOT use the elevators.
- If you are in a HIGH-RISE BUILDING, and not near a desk or table, move against an interior wall and protect your head with your arms. Stay indoors. Glass windows can dislodge during the quake and sail for hundreds of feet.
- If you're in a CROWDED STORE OR



- If you're in a WHEELCHAIR, stay in it. Move to cover, if possible, lock your wheels, and protect your head with your arms.
- If you're in the KITCHEN, move away from the refrigerator, stove, and overhead cupboards. (Take time NOW to anchor appliances, and install security latches on cupboard doors to reduce hazards.)
- If you're in a STADIUM OR THEATER, stay in your seat and protect your head with your arms. Do not try to leave until the shaking is over then leave in a calm, orderly manner. Avoid rushing toward exits.

#### WHEN OUTDOORS...

Stay there!

- If you're OUTDOORS, move to a clear area away from trees, signs, buildings, electrical wires and poles. Move away from buildings, streetlights, and utility wires.
- Once in the open, stay there until the shaking stops. The greatest danger exists directly outside buildings, at exits, and alongside exterior walls. Many of the 120 fatalities from the 1933 Long Beach earthquake oc-curred when people ran outside of buildings only to be killed by falling debris from collapsing walls. Ground movement during an earthquake is seldom the direct cause of death or injury. Most earthquake-related casualties result from collapsing walls, flying glass, and falling objects.
- If you're on a SIDEWALK NEAR BUILDINGS, duck into a doorway to protect yourself from falling bricks, glass, plaster, and other debris. If you're DRIVING , pull over to the
  - side of the road and stop. Avoid overpasses, power lines, and other hazards. Stay inside the vehicle until the shaking is over. Stop as quickly as safety permits and stay in the vehicle. Avoid stopping near or under buildings, trees, overpasses, and utility wires. Proceed cautiously once the earthquake has stopped. Avoid roads, bridges, or ramps that might have been damaged by the earthquake.

# **Media Trial Creates Narratives Which** Makes Person Guilty In Public Even Before Courts Decide: CJI Chandrachud

**New Delhi:** Media trial can have long lasting repercussions as it creates narratives which make a person guilty in the eyes of the public even before being convicted by a court, Chief Justice of India DY Chandrachud on Wednesday said.

While speaking at the 16th Ramnath Goenka Awards function, where he was the chief guest, he also said that responsible journalism is the beacon of truth that can guide us to a better tomorrow.

Flagging the dangers posed by trial by media, he said, "A major issue that has percolated our system is trial by media. The presumption of innocence postulates that a person is presumed innocent until found guilty by a court of law. This is one of the core tenets of law and legal processes.

He went on to add, "However, there have been instances when the media has carried narratives that make a person guilty in the eyes of the public, even before the court finds them guilty. This can have long-lasting

repercussions on the life of the affected individuals, as well as on due process.

On responsible journalism, he said, "It is the engine that drives democracy forward, based on the quest for truth, justice, and equality. As we navigate the challenges of the digital age, it is more important than ever for journalists to maintain standards of accuracy, impartiality, and responsibility in their reporting."

The 50th Chief Justice of India said, journalism ought not to be "elitist, exclusionary or for that matter a selective profession".

Emphasising on diverse representation in newsrooms, he said, "Another issue affecting the media is that of legitimacy. A diverse and representative newsroom is essential for media institutions to provide well-researched and complex stories that explore a multiplicity of perspectives and voices. Maintaining a diverse workforce is imperative for the longevity of any media platform."

'This is not just about providing different perspectives and viewpoints. Media institutions need to ensure that their

newsroom culture reflects the diverse news content they are producing. Otherwise, audiences may question their authenticity. Journalism ought not to be elitist, exclusionary or for that matter a selective profession," he added.

On legal journalism, the CII said that they are the story tellers of justice system shedding light on the complexities of the law.

"However, selective quoting of speeches and judgments of judges by journalists in India has become a matter of concern. This practice has a tendency to distort the public's understanding of important legal issues. Judges' decisions are often complex and nuanced, and selective quoting can give the impression that a judgment means something entirely different from what the judge actually intended. It is thus essential for journalists to provide a complete picture of events, rather than presenting a one-sided view", he said, adding that journalists have a duty to report accurately

and impartially. On social media, the CJI said that in the recent past, social media has been a game changer for journalists in more ways than one and online platforms have provided an opportunity to individuals to launch their own online media channels.

He said that in that way, online platforms have led to the democratization of the media and years ago, it was the paucity of space which was a constraining factor and now perhaps it is the paucity of reader patience.

"Readers have short attention spans. News is reduced to shorts on YouTube or reels on Instagram. Our attention spans have seen a steady decline with the advent of social media. It is now the norm for short titbits of information to be conveyed through 280 characters or in a few seconds. This is, however, an unsatisfactory replacement for long-form or investigative pieces", he said.

CJI Chandrachud, who gave awards to journalists said, in fact, there can be no replacement for such reportage and it is also proving to be a challenge for journalists to penetrate the echo chambers that social media has created and illuminate the truth.

### **BILKIS BANO CASE:** SC Agrees To Constitute Special Bench To Hear Plea Against Remission To Convicts

New Delhi: The Supreme Court on Wednesday agreed to constitute a special bench to hear a plea against the remission of sentence of 11 convicts in the Bilkis Bano gangrape case,

which also involves the killing of seven members of her family during the 2002 Gujarat riots. A bench of Chief Justice DY Chandrachud and justices PS Narasimha and JB Pardiwala

assured Bano, represented through her lawyer Shobha Gupta, that the new bench will be formed. Gupta mentioned the mat-

ter for urgent hearing and said a new bench needs to be constituted.

"I will have a bench constituted. Will look at it this evening," the CJI said.

Earlier on February 7, the plea was mentioned for urgent hearing by a fresh bench and the CJI had assured Bano's lawyer that he will set up one at the earliest.

Prior to this, the hearing on Bano's plea could not be taken up for hearing on January 24 as the judges concerned were hearing a matter related to passive euthanasia as part of a five-judge constitution bench. On that day, the petition

was listed for hearing before a bench of justices Rastogi and CT Ravikumar.

Both justices Rastogi and Ravikumar were then busy hearing, as part of a constitution bench headed by Justice K M Joseph, the pleas seeking modification of guidelines on the execution of a "Living Will or Advance Medical Directive" for permitting pas-

sive euthanasia. On January 4, a bench comprising justices Ajay Rastogi and Bela M Trivedi took up the plea, including some PILs. However, Justice Trivedi recused from hearing the case without citing any reason.

Bano had moved the apex court on November 30, 2022 challenging the "premature" release of 11 lifers by the state government, saying it has "shaken the conscience of society".

Besides the plea challenging the release of the convicts, the gang-rape survivor had also filed a separate petition seeking a review of the apex court's May 13, 2022 order on a plea by a convict. The review plea was later dismissed in December last year. All 11 convicts were granted

remission by the Gujarat government and released on August 15, last year.

The victim, in her pending writ petition, has said the state government passed a "mechanical order" completely ignoring the requirement of law as laid down by the Supreme Court.

"The en-masse premature release of the convicts in the much talked about case of Bilkis Bano has shaken the conscience of the society and resulted in a number of agitations across the country," she has said in the plea.

Referring to past verdicts, the plea said en-masse remissions are not permissible and, moreover, such a relief cannot be sought or granted as a matter of right without examining the case of each convict individually based on their peculiar facts and role played by them in the crime.

"The present writ petition challenging the decision of the state/ central government granting remission to all the 11 convicts and releasing them prematurely in one of the most gruesome crimes of extreme inhuman violence and brutality," it said.

# **National Institute Of Virology Being Set-Up In J&K**

The other significant change in playing conditions is penalising unfair movement by the wicketkeeper in case there is shift in position before the batter meets the ball.

In the event of unfair movement by the wicket-keeper, either umpire shall call and signal dead ball and inform the other umpire the reason for doing so. The bowler's end umpire shall then: "award the one-run penalty for Wide or No ball, if applicable or award 5 Penalty runs to the batting side. Inform the captain of the fielding side of the reason for this action. Inform the batters and, as soon as practicable, the captain of the batting side of
