

Tax Collections In J&K Up By 31%: CAG

Jammu: The tax revenue in Jammu and Kashmir touched Rs 11,707.28 crore in 2021-22 compared to Rs 8,876.99 crore in the previous year, marking an increase of 31.88 per cent, according to the Comptroller and Auditor General (CAG).

State Excise, State Goods and Services Tax (SGST) and Taxes on sales and trade showed the maximum increase of 32.31 per cent, 32.13 per cent and 27.46 per cent, respectively, the CAG said in its audit report on the Union Territory Finances for the year ended 31 March 2022.

The government's performance in the mobilisation of resources is assessed in terms of its own tax resources comprising revenue from its own tax and non-tax sources.

The report said there was an increase in all components of own tax revenue during 2021-22 which marked an increase of 31.88 per cent compared to the previous year.

"SGST, State Excise and Taxes on Sales/Trade showed maximum increase of Rs 1,554.95 crore, Rs 435.37 crore and Rs

410.70 cores respectively. The highest percentage increase with respect to 2020-21 was 536.67 per cent and 87.02 per cent under Taxes on Goods and Passengers and Land Revenue respectively," the CAG said.

The collection of taxes on vehicles increased from Rs 488.38 crore in 2020-21 to Rs 616.24 crore in 2021-22 (26.18 per cent) and stamp duty and registration fee from Rs 325.54 crore in 2020-21 to Rs 512.02 crore in 2021-22 (57.28 per cent).

Land revenue rose from Rs 60.57 crore in 2020-21 to Rs 113.28 crore in 2021-22 (87.02 per cent) and taxes on goods and passengers from Rs 0.90 crore in 2020-21 to Rs 5.73 crore in 2021-22 (536.67 per cent) and other taxes from Rs 319.22 crore in 2020-21 to Rs 376.60 crore in 2021-22 (17.98 per cent).

During 2021-22, it said the GST collection was Rs 6,394.31 crore compared to Rs 4,839.35 crore in 2020-21, registering an increase of Rs 1,554.96 crore (32.13 per cent). This includes advance apportionment of IGST amounting to Rs 4,334.63 crore.

Centre Begins Fresh Negotiations With Ladakh Parties

Srinagar: New Delhi has set the ball rolling to start fresh negotiations with Ladakh parties, who are demanding among other things, job, and land safeguards besides statehood for the Union Territory formed after the abrogation of Article-370 in August 2019.

According to reports, New Delhi has approached Leh Apex Body (LAB) and Kargil Democratic Alliance (KDA), an amalgam of trade unions, social, political and religious groups from Ladakh, to initiate a fresh dialogue to consider the demands put forward by them.

Cherring Dorjay Lakruk, member of LAB, told Kashmir Observer on Saturday that the Union Home Ministry has sought a revised proposal from the two bodies to begin a fresh round of dialogue to reach a conclusion.

He said some officials from the Union Home Ministry had met LAB Chairman and President Thupstan Chhewang in New Delhi recently and sought a revised proposal to bring an end to the political uncertainty in the cold desert. "Thupstan Chhewang informed us about the meeting. We are waiting for the representatives

of KDA who are in Jammu and are scheduled to arrive in Leh next week," Lakruk said.

He further said that once the KDA members are back to Ladakh, the two bodies will sit and decide the future course of action.

Lakruk however, said there is no official communication as of now.

Kashmir Observer reached out to Chhewang for his comments; however he didn't receive the calls.

Both the leaders from the Buddhist majority-Leh and Muslim majority Kargil are on the same page and have organised a number of protests to press their demands. The leaders have been demanding Constitutional safeguards on the lines of 6th schedule of the Indian Constitution.

The two groups were formed in the twin districts of Kargil and Leh including Apex Body and Kargil Democratic Alliance following the region's resentment against the central government for failing to provide constitutional, job, and land safeguard to the region created from the erstwhile state of Jammu and Kashmir in August 2019.

J&K's GSDP Likely To Double In Next 5 Yrs: Economic Survey

Jammu: Jammu and Kashmir's GSDP is likely to double in the next five years with emphasis on industries, agriculture, horticulture, tourism and the service sector, the Economic Survey 2022-23 of the Union Territory said.

The economic survey, which is a document presenting an elaborate picture of the economy of Jammu and Kashmir for the closing financial year, said that at current prices, the GSDP of the UT is expected to record a growth of 15 per cent which is at par with the national level.

"The economy of Jammu and Kashmir grew faster than the national average in recent years," said the report, which was released by Chief Secretary Arun Kumar Mehta.

It added that Jammu and Kashmir is expected to grow



at eight per cent as against seven per cent at national level during 2022-23 at constant prices

The UT's revenue performance (tax plus non-tax) is also expected to double during the current year, the report said.

Mehta observed that the document is vital in gauging the progress made by the Union Territory (UT).

The survey also applauded the time-bound policies, action plans and development strategies being implemented to carry forward and sustain the positive environment and momentum of economic development.

SKUAST-K To Take Corrective Measures After CAG Rap

Srinagar: Sher-i-Kashmir University of Agricultural Sciences and Technology (SKUAST) Kashmir on Saturday said the institute will take corrective measures wherever irregularities have taken place, days after the CAG highlighted shortcomings in manpower planning, appointments, career advancement and entitlements in the twin agriculture universities in the Union territory.

Speaking to reporters on the sidelines of a function at NIELIT Srinagar, SKUAST Kashmir Vice Chancellor Nazir Ahmad Ganai said the university will look into the findings of the report when it receives it.

"I have not seen the CAG report yet. As soon as we receive it, we will look into it," he said.

Ganai said when it comes to SKUAST Kashmir, "we are one of the fastest growing institutions nationally in efficiency,

transparency and in building innovations".

"...this is a report since the inception of the university till now, there could be some irregularities. Wherever there are, we will correct that. But, we will know only when we have the report with us," he said.

The VC said it would be premature to say what action the university would take as "the report is yet to reach us".

"There could be some irregularities in the past, but we look towards the future...how we become number one in the country," he added.

Highlighting shortcomings in manpower planning, appointments, career advancement and entitlements in the twin agriculture universities in Jammu and Kashmir, the CAG has called for immediate review of sanctioned strength to weed out redundant posts and adoption of UGC regulations in toto.

'Hostile Parenting Enhances Childrens' Risk Of Developing Lasting Mental Health Problems'

Children on the receiving end of 'hostile' parenting at age three were 1.5 times likelier than their peers to develop mental health problems qualified as 'high risk' by age nine.

Young children on the receiving end of 'hostile' parenting were 1.5 times likelier than their peers to be in the high-risk band of developing lasting mental health problems, a new study has reported.

Researchers charted the children's mental health symptoms at ages three, five and nine, studying both internalising mental health symptoms, such as anxiety and social withdrawal, and externalising ones, such as impulsivity, aggression and hyperactivity, together.

They found that 10 per cent of over 7,500 children studied were at a high-risk for poor mental health and that those exposed to harsh parenting were likely to fall in this group.

The study involved researchers from University of Cambridge, UK, and University College Dublin (UCD), Ireland, and is published in the journal *Epidemiology and Psychiatric Sciences*.

Hostile parenting involves frequent harsh discipline, that could be physical and/or psychological. It could, for example, involve shouting at children regularly, routine physical punishment, isolating children when they misbehave, damaging their self-esteem, or punishing children unpredictably depending on the parent's mood.

While the researchers make it clear that parenting style does not definitively determine mental health outcomes, they do argue that mental health professionals, teachers and other practitioners need to be alert to

children displaying poor mental health.

"The fact that one in 10 children were in the high-risk category for mental health problems is a concern and we ought to be aware of the part parenting may play in that," Ioannis Katsantonis, co-lead researcher, University of Cambridge, said.

"We are not for a moment suggesting that parents should not set firm boundaries for their children's behaviour, but it is

difficult to justify frequent harsh discipline, given the implications for mental health," said Katsantonis.

Using data from 7,507 participants in the 'Growing up in Ireland' longitudinal study of children and young people, scientists used Strengths and Difficulties Questionnaire, a standard assessment tool, to capture mental health data.

They gave each child a composite score

out of 10 for all their symptoms at ages three, five and nine.

They used a second standard assessment to measure the parenting style children experienced at age three.

Parents' tendencies towards each of three styles were measured - warm parenting (supportive and attentive to their child's needs); consistent (setting clear expectations and rules); and hostile.

Based on the mental health symptom development trajectories, the study broadly classified the children into three categories.

83.5 per cent of them were at low risk, with low symptom scores at age three, remaining stable or falling thereafter.

6.43 per cent of the participants were at mild-risk, with high initial symptom scores reducing with time but still being higher than the first group.

The remaining 10.07 per cent were high-risk, with high initial scores that increased by age nine.

Hostile parenting raised a child's chances of being in the high-risk category by 1.5 times, and the mild-risk category by 1.6 times, by age nine, the researchers found.

Consistent parenting was found to have a limited protective role, but only against children falling into the 'mild-risk' category.

To the researchers' surprise, however, warm parenting did not increase the likelihood of children being in the low-risk group, possibly due to the influence of other factors on mental health outcomes.

Jennifer Symonds, co-lead researcher and associate professor, UCD, said, "Avoiding a hostile emotional climate at home won't necessarily prevent poor mental health outcomes from occurring, but it will probably help."

Boulevard Accident Aftermath

Special Teams Formed To Curb Stunt Biking

Srinagar: Following the horrible road accident on Boulevard near SKICC last evening, resulting in the on-spot death of a 20-year-old youth, Traffic Police Srinagar on Saturday said special teams have been formed to identify individuals involved in stunt biking.

Senior Superintendent Police Traffic for Srinagar, Muzaffar Ahmad Shah said the department will take multilevel measures to curb stunt biking and rash riding by two-wheeler riders, besides identifying the boys involved in it.

"It is not restricted to Srinagar only; there are some boys from other districts who come to Srinagar for these stunts. We are in the process of identifying them and are compiling data on it," he said.

SSP City Traffic said they will seek assistance from the district police as well and will issue summons to those involved in stunt biking stunts through their concerned police stations.

"We are going to act tough and the repeated and habitual offenders will be dealt with sternly," the officer said, adding, "We have summoned a few and are trying to reach out to the maximum to counsel them afresh."

Speaking about Friday's accident, the officer said the incident is "painful". "I have been urging the parents to be more sensitive while agreeing to provide two-wheelers or any other vehicle to their children."

"In addition to law enforcement, parents have an important role in preventing such incidents. If they want to provide their children two-wheelers or other vehicles, they should make sure they have all the necessary documentation, safety equipment, and, most importantly, whether or not they are eligible to drive," he said.

Srinagar traffic police said last week that they now have specialized "Speed Radar Guns" to measure the speed of moving cars. They claimed that the technology will assist them to stop high-speed, stunt biking, and reckless driving by vehicles.

Tulip Garden Sees Record 1, 58, 000 Visitors In First 12 Days

Srinagar: Asia's largest Tulip Garden in Srinagar saw a record number of 1, 58, 000 visitors in the first 12 days, with a peak of 31, 000 visitors on the third day of its opening on March 22.

Officials told Kashmir Observer that the garden has sprouted with around 80 percent tulips so far and is expected to be at full bloom in the coming few days, if the weather remains favorable.

They said Asia's largest Tulip Garden situated on the foothills of Zabarwan mountain range saw a record footfall of visitors in the first twelve days of its opening.

They said the garden is likely to be closed for visitors from April 20; however it may continue till April 25, if the weather remains favorable.

They said the garden, which spans over 52 hectares of land, receives 20, 000 to 25, 000 visitors on an average a day.

"Tourists in hoards visited Tulip garden this year, a record number of 1, 58, 000 visitors visited the garden from March 20 till date. A single day spike of 31, 000 was witnessed in the garden on March 22. The footfall of tourists was better than in previous years," Tulip Garden in-charge, Inam-ur-Rehman, told Kashmir Observer.

Indira Gandhi Memorial Tulip Garden is presenting a mesmerizing look and is attracting both tourists and locals in hordes to enjoy the natural beauty.

In-charge Tulip garden further said the footfall of locals declined with the commencement of the holy month of Ramadan, however non-local tourists have been visiting the garden in

hordes since its opening twelve days ago.

"Since the footfall of local visitors declined in view of the holy Ramadan, non-local tourists visit the garden in hordes and I hope the tourist flow will further increase with the improvement in weather. 95 percent of visitors are non-local tourists," Inam told Kashmir Observer.

He said 16 lakh Tulips bulbs of 68 different varieties are in bloom at the Tulip Garden while four new varieties have also

said he has never seen anything so beautiful.

"This is mind blowing. I feel very happy to have come here. This garden is stunning. I think it is one of the most beautiful gardens, huge. So many tulips, so much beauty, many waterfalls, just so amazing. Truly a 'Jannat' (paradise)," he said. "I will keep coming here."

While most of the visitors were enchanted by the sight of the flowers, and could not help but take pictures of them, some,

been added in the nursery this year, he added.

"Besides 16 lakh Tulips, the garden has other spring flowers as well. The Floriculture Department has installed ornamental lights for the tourists who stay in the garden till late evening," he added.

Arun Kumar, a native of Gujarat who lives in South Africa,

who wanted to touch the bulbs, were dismayed at the fences surrounding the flower beds.

"I hope they have some more photographic places. They have covered the flowers with fences. We cannot go and touch tulips. It would have been amazing if we could do that," Surmil said. (With PTI Inputs)

'I Want To Be With My Family Now'

Farooq Announces Retirement From Politics

Jammu- The Chief minister Farooq Abdullah today made the dramatic announcement of his "retirement from active politics" when he said that he will not contest any more elections in future and nor will hold the post of the president" of the ruling National Conference. "I will not seek any election after the term of present Assembly is over and will quit as national Conference president, before the end of the term of my government" Abdullah said.

Farooq's announcement, both sudden and unexpected, stunned the entire House, especially the members of the ruling National Conference, which he made in course of his reply to the debate on the motion of thanks to the governor's address. "I want to devote my whole time to my family. Let the National Conference look for some new leader" Farooq said.

Abdullah's dramatic announcement was first taken by some members as an "April Fool" joke, but when he went on to talk about the issue, in course of his speech, the ruling party members could be seen in a state of shock and disbelief, both. Incidentally Farooq's "retirement" announcement comes within less than 24 hours of a similar statement made by the Prime Minister Atal Bihari Vajpayee in the Lok Sabha that it was his last election" and he would never contest again.

What has prompted Abdullah, to take such an extreme decision, political observers here believe, was the "poor performance of the National Conference" both on the political and administrative fronts, with senior leaders taking hardly any interest in strengthening the party at grass root level.

Abdullah expressed his displeasure over the performance of National Conference ministers, at the meeting of the party's working committee, at which he is reported to have openly talked about his intentions to overhaul his cabinet. "My first experience has not worked well. Now, there will be an altogether different team" Farooq is believed to have told his party leaders at the working committee meeting.

In his speech in the Assembly today, Abdullah showered praises on the BJP led government and appreciated its "secular pronouncements" expressing the hope that new government under the "inspiring leadership" Vajpayee would strengthen the country and promote brotherhood and amity. He also hoped that the tyranny of Pakistan on Kashmir would come to an end and "Azad Kashmir" under "illegal occupation of Pakistan" would once again become the part of this state. He referred to Pakistan's abetment to militancy and firing by its soldiers in border areas and said that Prime Minister Atal Bihari Vajpayee should "forcefully" tell Pakistan to stop all this. "We don't want war but peace. But at the same time we cannot allow the number of graveyards increasing", he said regretting that hot line between the Prime Ministers of India and Pakistan failed to stop the border firing. Abdullah ruled out any talks with the militants or other people, outside the gambit of Indian constitution and said that no Indian Prime Minister can ever think of a dialogue with people who had no faith in Indian constitution. "Who can accept militants or Pakistan's illogical plea that Jammu and Kashmir is a disputed territory", he wondered and said that even those who were aspiring to sit on the chair now held by Vajpayee, could have afforded to yield to such an "absurd proposition".

Without naming Hurriyat leaders, Abdullah said that some elements who while living in India are freely visiting Pakistan high commission in Delhi, enjoy dinners, accept money and other facilities and dance to the tune of that country. It is the greatness of India to have such people here and asked "is this possible in Pakistan". Without naming Mufti Mohammad Syed, who has been advocating an unconditional dialogue with the separatist political leaders and militants, Abdullah said those making such a demand should first consider the "national interest" before saying anything on the issue. The Mask of Sanity and Psychopathological Crimes in Kashmir

“Yet again, at the levels of the family and society, psychopathy can never be eradicated. So how are individuals - especially the young and the vulnerable - to be protected from psychopathic predators? All members of society must be sensitized and made aware of potential predators that lurk under the facade and veneer of civility and charm

Hervey Cleckley, an American psychiatrist, in his monograph, 'The Mask of Sanity' provided a vivid description of psychopathy. In this schemata, the mask referred to the well adjusted, even charming nature of psychopaths as a cover for their underlying pathology. This has a searing resonance in Kashmir where, in the recent past, unspeakable crime has surfaced- ranging from the murders of elderly parents, to chopping of a woman and murder of an 8 year old child, to name a few egregious ones. Maybe these crimes always existed and lurked under the surface of society and maybe these crimes garner attention because of the ubiquity of media. But whatever the case, the 'trend' is alarming' and insidious. What can be done about it? Can these kinds of crimes that have a clear pathological ingress be eradicated?

In the final analysis, while these crimes can be solved (amateurishness and clumsiness of the perpetrators) or effective policing methods, these can never be eradicated by mere policing. The problem is 'social' in the sense that it emanates from society and culture, given that culture can, at times, provide a gloss for psychopathology. So what is this phenomenon?

According to Wikipedia (a limited, public and non academic source), 'psychopathy is characterized by persistent anti-social behaviour, impaired empathy and remorse, and bold dis-inhibited egotistical traits'. These are the clinically recognized aspects and elements of psychopathy. The problem arises because a 'typical' psychopath obscures his or her condition with socially, inter-personally and culturally acceptable behaviour and is, oftentimes, charming. What are the underlying conditions of psychopathy or what leads to it?

I am neither a psychologist nor a



psychiatrist but culled from amateur readings of the phenomenon, it may be that distressed or distressing childhood experiences, cultural and social repression of the psyche, inhibited impulses, flawed validation, encouragement and at times discouragement of attitudes and behaviours, bad parenting, bullying, psychological violence and its untreated effects and some warped social and cultural incentives might be among the myriad causes that lead to psychopathy. There may also be physiological and chemical mis-alignment reasons for the same. If these elements hold, then obviously it is exceedingly difficult to check psychopathic behaviour let alone detect it. But if the problem emanates from social conditioning or more accurately flawed social conditioning then the partial solution lies in society.

How?

In the basic unit of society, the family, parents must be clued into the

behaviours and attitudes of their children. Psycho-emotional issues if and when they arise in children- a morose child who does not play with his or her peers (not always a psychological problem), who broods or articulates strange thoughts, does not engage with his or her studies, and so on must be doubly taken care of. He or she must not be bullied into changing behaviour but conditioned to be 'normal' by professional empathetic counselling. This can be the starting point. At a broader, aggregate social level, culture and sensibilities thereof must not obscure and put a gloss on pathological behaviour. If a problem is detected in an individual(s), society must rise to the occasion and get these individuals to seek help, albeit empathetically.

Yet again, at the levels of the family and society, psychopathy can never be eradicated. So how are individuals - especially the young and the vulnerable - to be protected from psychopathic predators? All members of

society must be sensitized and made aware of potential predators that lurk under the facade and veneer of civility and charm. This means being alert to, one, the fact that civility and charm while great attributed can at times be taken recourse to by predators to obscure their evil intents and two, no matter how 'close' or personal a given relationship- uncle, aunt, or even son or daughter, if persistent traits that define psychopathy are exhibited by a person, he or she needs to be treated or at times reported to the police. Here neither culture nor social sensibility must deter from reporting or treating these people. (Of course this can be misused but a proper and reasonable methodology to determine psychopathic behaviour, admittedly subjective, can help in checking abuse).

In the ultimate analysis, psychopathy, a universal phenomenon, is real and cannot be entirely eradicated from society. But a prudent starting point to check its abuse and prevalence would be awareness of the same. With respect to Kashmir, it also means that no matter the nature and stereotypes about us- gentle, hospitable and genteel people- there are psychopaths among us who use the same attributes and stereotypes to cover their fundamentally evil nature. This recognition can alert our society to the presence and dangers of psychopathy and hopefully prevent predatory murderous crimes. While, to repeat, psychopathy and the 'Mask of Sanity' it presupposes and puts, cannot be totally eliminated, awareness of the same can check its prevalence. This along with the prayer, 'May God protect All' is perhaps the best that can be done!

The Lessons of Badr

We are in the blessed month of Ramadan. Many great events occurred in this month including the revelation of the noble Qur'an, the battle of Badr, digging of the trench in preparation for the battle of Ahzab, the march on Makkah to liberate it from the mushriks and the battle of Humayn.

This is a long list. Let us focus on one event—the battle of Badr—that occurred in the month of Ramadan. Fasting was made compulsory for Muslims for the first time in the second year of the hijrah. Yet they were tested at Badr in their very first month of fasting. It was the most decisive battle in the life of the nascent Muslim community in the Arabian Peninsula in the early days of Islam.

Badr is located about 100 miles southeast of Madinah, where the battle occurred on the 17th day of Ramadan. This battle, more than any other, became the defining moment in early Islamic history. It distinguished those who participated in Badr from those that came after.

Led by the Prophet (pbuh), 313 companions had set out from Madinah to intercept the Makkkan caravan that was returning from Syria with goods. The caravan was led by Abu Sufyan, one of the leading Makkkan chiefs and among the staunchest enemies of the noble Messenger (pbuh).

For 13 years, Muslims were persecuted, terrorized and brutalized in Makkah for no other reason than that they proclaimed Tawhid, the Oneness of Allah (swt). They were finally forced to flee Makkah to save their lives. They were not allowed to take any of their possessions with them. They arrived in Madinah penniless and destitute.

What did the Makkkan mushriks do with the Muslims' goods that they had confiscated? They traded them to enrich themselves. Thus, Muslims had every right to retrieve their stolen goods.

Abu Sufyan had sent out his spies ahead of the caravan to seek information about what the Muslims were doing. When he was informed that the Muslims were coming for the caravan, he changed his route moving further south of Madinah and also sent an emissary to Makkah calling on the people to come and save their goods.

Led by Abu Jahl, another enemy of Allah and His Prophet, more than 1,000 heavily armed men set out from Makkah to finish the Muslims once and for all. That is when the two armies came face to face at the well of Badr.

Looked at purely from the material point of view, this was a complete mismatch. The 313 light-



ly armed Muslims had only a few swords, a few horses and bows and arrows. They were outnumbered by Makkah's 1000-strong mushrik army that was heavily armed.

The other challenge the Muslims faced was that they had to confront their own kith and kin—often brothers, sons or fathers—in battle. In addition to the physical odds, the Muslims faced this huge psychological challenge as well.

This is where a clear distinction emerges between those committed to Allah and His Prophet (pbuh) and those that take only worldly issues into account. Throughout history, earlier Prophets had to abandon their mushrik relatives. Nuh (as) was told to abandon his mushrik son, while Ibrahim (as) abandoned his mushrik father. And Lut (as) was commanded to leave his deviant wife behind.

Led by the Prophet (pbuh), the small group of Muslims did not flinch in their commitment to Allah. Their Imaan was so strong that they did not hesitate to fight and if need be, kill their own kith and kin. In Islam, the only relationship is that of Imaan. Blood relationships have to be abandoned if they threaten Islam. This is what distinguished Badr from the battles that followed.

And it was this commitment that enabled the 313 lightly-armed but dedicated Muslims to defeat the 1,000 heavily-armed Makkkan mushriks. Untested in battle, some Muslims were apprehen-

sive. This was even reflected in the tearful dua the Prophet (pbuh) offered beseeching Allah's help in this critical hour. With trembling hands, he (pbuh) pleaded for help.

“O Allah, if these few servants of Yours are defeated today, there will be nobody left to proclaim Your name.”

Allah was not going to let His beloved Prophet

down on this crucial day. The Prophet (pbuh) and his companions had suffered grievously for many years in Makkah and shown great patience in adversity. Allah's promised help was at hand as He showed the multitude of mushriks small in number to the Muslims (Surah al-Anfal: 43).

The Makkkan mushriks, supremely arrogant in their numbers and weapons, assumed that they would soon finish off the rag-tag band of a few hundred Muslims. Allah, however, had other plans. He had willed that the two groups meet to establish the power of Islam in the Arabian Peninsula (Anfal: 44).

The small group of Muslims confronted their enemy with courage and determination. It was the test of Imaan (faith-commitment to Allah) against shirk (associating partners with Allah).

Despite their small numbers, the Muslims were able to dispatch more than 70 Makkkan mushriks to hell. Among them were such Makkkan stalwarts as Abu Jahl, Umayya ibn Khalaf, Utbah ibn Rabi'ah, Shaybah ibn Rabi'ah and Waleed bin Utbah. A number of Makkkan mushriks were also taken prisoner. It was a crushing defeat for the mushriks and a great victory for Muslims.

The battle of Badr established an important Islamic principle: weapons alone do not determine the outcome of a battle. It is Imaan and the determination of fighters that ultimately establish who will be victorious. The lesson of Badr is witnessed repeatedly in different locales around the world even today.

Committed Muslims confronting massively armed enemy forces have been able to withstand their ground and come out victorious.

This has been witnessed by the people of Iran in their defensive war against Iraq and its western and eastern allies (1980-1988), by the Afghans against the Soviets (1979-1988) and again, against the Americans in Afghanistan (2001-2021). The Hiz-bullah confronted and defeated the Israeli army in May 2000 and again in July-August 2006. More recently, the Yemeni defenders have stood against the Saudi invaders for eight years (2015-2023).

Badr is alive and so are its lessons. Muslims must imbibe the lessons of Badr fully, especially in these troubled times when they face aggression from predatory powers abiding by no rules or law.

The blessed month is rooted in faith, history and culture, and few practices emphasize that as much as the use of miswak — a teeth-cleaning twig. Many Muslims use miswak during the day to maintain freshness, oral hygiene and to protect overall dental health. In the Islamic tradition, using miswak is a well-known sunnah of the Prophet Muhammad (peace be upon him).

Various ahadith document the elevated status and significance of miswak. Abu Hurairah once narrated that the Prophet (PBUH) said, "Were it not (for the fear) of overburdening my Ummah, I would have ordered them to (brush their teeth with) Siwak at every Salat." (Sahih Muslim)

Aisha narrated that the Prophet (PBUH) said, "The siwak is a means of purifying the mouth and pleasing the

Rabb." (Nasai)

Abu Hurairah further narrated that the Prophet (PBUH) said once on a Friday, "O Community of Muslims! Allah has made this day an Eid for you, so take a bath and needfully brush your teeth with siwak." (Tabarani, Majma'uz-Zawaid)

Modern science upholds some of the health benefits of using miswak.

As per a report published in Saudi Medical Journal, a number of scientific studies have demonstrated that miswak possesses antibacterial, anti-fungal, anti-viral, anti-cariogenic, and anti-plaque properties.

There is now increasing scientific evidence that miswak has medicinal properties and helps fight plaque, recession of gums, tooth decay, bleeding gums, Strengthen the enamel in your teeth, deep periodontal pocket and Leaves you with a healthy mouth.

Miswak can be sourced from various trees except for those known to cause harm, such as pomegranate and myrtle trees.

Although using miswak is not obligatory, Prophet Muhammad (PBUH) encouraged Muslims to use it.

To use a miswak, simply chew off about one centimeter of the twig at one end and then continue to chew it until it softens and forms bristles. The softening can be sped up by dipping the end in water to separate the fibers. Once bristles are formed, the miswak can be used like a regular toothbrush, without paste.

A study conducted at Bangor University, showed that talking out loud improved subjects' ability to learn and successfully complete tasks. "Our results demonstrated that, even if we talk to ourselves to gain control during challenging tasks, performance substantially improves when we do it out loud," wrote one researcher.

Some People Have Given 'Supari' To Dent My Image: PM

Bhopal: Prime Minister Narendra Modi on Saturday said some people are hellbent to sully his image and they have given a "supari" (contract) for this purpose colluding with certain people sitting in India and also outside the country.

Modi's veiled attack on Congress comes amid a slugfest between the Grand Old Party and BJP over Rahul Gandhi's "democracy under brutal attack in India" remarks in the UK and Germany taking note of Rahul's disqualification from Lok Sabha. The BJP has accused the Congress of "inviting foreign

powers" for interfering in India's internal matters.

The prime minister was addressing a gathering at Rani Kamalapati railway station after flagging off the semi-high-speed Bhopal-Delhi Vande Bharat Express train.

"There are some people in our country who have been determined since 2014, spoken publicly and declared their resolve that they will tarnish Modi's image. For this, they have given 'supari' (contract) to various people.

"Some people are sitting inside the country to support these people and some are doing their work sitting outside the country. These people have been

continuously trying to spoil and tarnish Modi's image," he said.

But India's poor, the middle class, tribals, Dalits, backward classes and every Indian has become the security cover of Modi, which made these people furious forcing them to adopt new tricks, he said.

Modi said such people have taken a pledge that "Modi Teri Kabra Khudegi".

"Amidst their conspiracies, every countryman has to pay attention to the development of the country and pay attention to building the nation," he said.

Slamming Congress without taking its name, Modi said previous governments were busy

with vote bank appeasement whereas his government is busy satisfying people.

"They (the previous governments) considered one family as the first family of the country. They ignored the poor and middle class, and the Railway is a living example of this (ignorance)," he said.

The prime minister also expressed deep grief over the stepwell roof collapse tragedy in a temple in Indore which killed 36 people and injured 16 on Ram Navami.

As Germany took note of Rahul Gandhi's disqualification from Lok Sabha, senior Congress leader Digvijaya Singh on Thursday thanked the German foreign

ministry and Richard Walker, Chief International Editor of Deutsche Welle, for "taking note of how the Democracy is being compromised in India through the persecution of Rahul Gandhi".

Sharing a screenshot of Digvijaya Singh's tweet, Union Law Minister Kiren Rijiju had said, "Thank you Rahul Gandhi for inviting foreign powers for interference into India's internal matters. Remember, Indian Judiciary can't be influenced by foreign interference. India won't tolerate 'foreign influence' anymore because our Prime Minister is:- Shri @narendramodiji".

Tax Collections

Of Rs 892.56 crore as Revenue Receipt on account of loss of revenue arising out of implementation of GST during 2021-22.

"Further, it also received Rs 3,845.49 crore debt during 2021-22 (total debt of Rs 5,945.29 crore as on 31 March 2022) as back-to-back loan from the central government in lieu of GST compensation, which would not be treated as debt of the Government of J&K for any norms which may be prescribed by the Finance Commission as per the decision of Department of Expenditure, Government of India," it said.

The CAG said the non-tax revenue receipts increased by 18.74 per cent during 2021-22 with respect to the previous year and major increase was under power, water supply and sanitation, Education, Sports, Art and Culture and Police, while medium irrigation and non-ferrous mining and metallurgical Industries showed a decline in receipt with respect to the previous year.

Receipt under Education, Sports, Art and Culture increased by 1,047.16 per cent during 2021-22 with respect to 2020-21, due to remittance of Rs 461.61 crore by Chief Accounts Officer (CAO) Samagra Shiksha J&K on account of salary of teachers, the report said.

It, however, said the collection under own resources fell short by 32.42 per cent of Budget Estimates.

"The UT Government could not achieve its own targets for own tax revenue and own non-tax revenue in the Budget Estimates. Own Tax Revenue fell short by 28.07 per cent and Non tax revenue fell short by 41.03 per cent of budget estimates," it said.

It said the UT's own resources (Own Tax Revenue and Own Non-Tax Revenue) of Rs 16,547.73 crore during the year 2021-22 was 36.77 percent of committed expenditure (salaries and wages, interest payments and pension) of Rs 45,000.95 crore for the year 2021-22.

Flags Incomplete

"...397 capital works having original estimated cost of Rs 1,518.66 crore, taken up by four departments (viz Irrigation and Flood Control Department, Jammu (61 works) and Jal Shakti (PHE) Department Kashmir (216 work), Jal Shakti (PHE) Department Jammu (119) and Mechanical Engineering Department Kashmir (one) targeted to be completed during the period 2012-13 to 2014-15 and 2017-18 to 2021-22 were incomplete at the end of the year 2021-22," the CAG said.

It said the cumulative expenditure of Rs 1,095.52 crore incurred on these incomplete works got blocked.

Giving the breakup, the report said one project was sanctioned in 2012-13, two in 2013-14, nine in 2014-15, two in 2017-18, five in 2018-19, 85 in 2019-20, 203 in 2020-21 and 90 in 2021-22 at a cumulative cost of Rs 1,518.66 crore.

The irrigation and flood control department, Jammu, made the highest expenditure of Rs 614.22 crore followed by Rs 246.95 crore by the Jal Shakti (PHE) department, Jammu, Rs 233.65 crore by the Jal Shakti (PHE) department, Kashmir, and Rs 70 lakh by the mechanical engineering department, Kashmir.

The CAG also pulled up the government for poor recovery of loans in the Union territory.

"During the year 2021-22, the Government of Union Territory of Jammu and Kashmir disbursed loans and advances of Rs 73.77 crore and recovered loans and advances amounting to Rs 1.03 crore. Out of total loans disbursed during 2021-22 loans amounting to Rs 40.00 crore was disbursed to J&K Road Transport Corporation Limited (JKRTC) which already had outstanding loans of Rs 439.23 crore ending 31 March 2021 (Rs 383.73 crore received from erstwhile State and Rs 55.50 crore from UT of J&K)," the report said.

It said as per last audited accounts for the year 2018-19, JKRTC booked losses of Rs 117.62 crore.

"Recoveries of loans and advances are not forthcoming from loss-making public sector undertakings. No assessment about potential recoverability of these loans has been made in the Fiscal Responsibility and Budget Management (FRBM) statements," the CAG said.

It said the government had a total outstanding loans and advances of Rs 168.25 crore ending 31 March 2022.

"In addition, there were loans and advances of Rs 1,740.44 crore disbursed by the Government of erstwhile State which were

outstanding ending 30 October 2019 and were yet to be divided between Union Territory of Jammu and Kashmir and Union Territory of Ladakh," the report said.

full-fledged Statehood for Ladakh, constitutional safeguards under the 6th schedule of the Indian Constitution, early recruitment process & PSC for Ladakh and separate Lok Sabha seats for Leh and Kargil districts.

Earlier, the Leh region witnessed massive protests in January this year after top environmentalist Sonam Wangchuk announced a five-day long climate fast at 18,380 feet high Khardung La pass to invite attention of the BJP-led Centre to address the demands of Ladakhis.

It may be noted that on 3 January, the Ministry of Home Affairs (MHA) constituted a high-powered committee headed by Minister of State Nityanand Rai to "ensure protection of land and employment" for the people of Ladakh.

Also, there has been a 70 per cent reduction of areas under the jurisdiction of the Armed Forces (Special Powers) Act, 1958," he said.

Noting that Mizoram's economy grew by 12.15 per cent in the last decade, especially under the leadership of Chief Minister Zoramthanga, Shah said the Centre will explore possibilities of investment in the tourism, bamboo and solar energy sectors in the state.

Dir Horticulture Led Team Visits Orchard Infected Areas In Baramulla, Bandipora

Assesses Extent Of Damage Caused By Infestation

SRINAGAR: A team of Horticulture Department Saturday visited to several areas in district Baramulla and Bandipora in light of reports of infestation of insects damaging the blossom in apple orchards.

The team was headed by Mr. G. R. Mir (JKAS), Director Horticulture Kashmir, accompanied by Mr. Zahoar Ahmad Bhat, Joint Director Horticulture, three other experts from the Department of Horticulture besides experts from SKUAST, Kashmir.

The purpose of the visit was to identify and assess the extent of the damage caused by the infestation and to determine the appropriate measures that can be taken to mitigate its impact on the apple orchards.

The team inspected various affected orchards in Kreeri area of district Baramulla and Asham area of district Bandipora and took stock of the severity of the pest. Speaking on the occasion Director Hor-

ticulture advised the farmers never to miss any of the spray recommended by the Department/SKUST-K. He emphasized on the orchardists to have a close liaison with the Department for better management of the pest.

The experts accompanying the Director identified the insect on spot as Leaf Roller, also called fireworm. The insect damages the blossom of the apple fruit crop thus reducing fruit set and subsequent fruit yield. The orchardists were given on spot advisory to spray Thiacloprid @ 40ml/100 litre of water or Chlorpyrifos @ 100 ml/100litre of water. The Ad-hoc advisory in this regard will follow.

Director also visited the Pesticide Testing Laboratory (PTL), Kreeri and took stock of its functioning. He also visited Fruit Plant Nursery Pattan where he took stock of various developmental activities and thoroughly deliberated on all the management practices being carried out.

36000 Pilgrims From J&K Performed Umrah In Last 7 Months

SRINAGAR: At least 36000 from Jammu & Kashmir performed Umrah since September 2022 till this Ramadan, indicating 50 per cent increase of pilgrims compared to last year in the Union Territory, J&K Association of Haj & Umrah Companies (JKAHUC) said on Saturday.

General Secretary of the association, Muhammad Younis Bhat said that the tour operations have suffered a loss of Rs 5-6 lakh each this Ramadan as they were expecting a huge flow of pilgrims for Umrah in this holy month.

"However, the rush of pilgrims remained less, especially due to the March session for students announced by the government. The tour operators had already booked the blocks of airlines in advance, but as the rush was not up to the expectations, the bookings had to be cancelled and thus lead to the losses of Rs 5-6 lakh each to the tour operators," he said.

He added that at least 36,000 people from across J&K performed Umrah since September 2022 till this Ramadan while 34000 among them are from Kashmir division, adding that the number of pilgrims has increased nearly 50 per cent compared to last year.

The General Secretary further stated that earlier there was only one airline, Air India, available for the pilgrims, but the association played a key role in ensuring an increase in the number of airlines and now three airlines including Air India, Indigo and Spicejet are available for the pilgrims.

During the winters, the tour operators were facing losses, but this year, there has been rescheduling of the flight operations as the flights are connected unlike previous years, he said, adding that the Indigo

earned highest amongst the three.

However, he appealed to the airlines to drop the pilgrims at Terminal 3 where the people from J&K get facilities.

Besides, the association also demanded immigration point at Srinagar international airport, saying that the process should be completed for pilgrims at Srinagar airport.

Reacting to the chaos over package for Umrah, he said that the main reason behind such an issue is the lack of coordination between the people and the tour operators, adding that the people have been demanding the cheapest package, thus the tour operators couldn't manage things with just a meagre amount. "There are three types of packages with tour operators made available at the association level, but people have been seeking cheapest packages, which becomes very difficult for a tour operator to manage the things and ensure proper arrangements for the pilgrim. The pilgrim should check each and everything while fixing the package and the tour operator too should make the things clear to the pilgrim so that there is no confusion among them," he said.

He further said that three packages are available, which include for 15 days, 21-22 days and one month, adding that most of the pilgrims opt for 21-22 days package.

About the upcoming Haj, the General Secretary of JKAHUC, said that the pilgrims must check the past history of the tour operators before fixing the package. He also said that there would be no increase in the amount payable for Hajj this year and the lowest package for a pilgrim will be Rs 6,50,000 like last year.

Asked about the video of

Hajis that went viral after they faced issues in Saudi, he said that there was no fault of the tour operators here, but it was because of the hotel that they faced hardships.

Moreover, he said that the pilgrims going for Umrah should prepare themselves for a 5-6 day stay at Medina as the erstwhile trend of staying for 40 prayers will come to an end as the rates have increased manifold.

The General Secretary further appealed people not to go after the low package and ensure proper check of facilities being provided to him/her while discussing the package.

"The pilgrims should be ready to accept the orders being issued by Saudi Arabia. The norms in Saudi are to be followed and people should be aware about it. They should be aware about economic class and deluxe class packages," he said and appealed to the tour operators to make things clear to the Hajis and ensure proper signature of the pilgrims while divulging the details.

Pilgrims are advised to attend orientation programmes to get aware about the facts, he said, adding that the people from Kashmir staying in Saudi Arabia should not add fuel to any situation, especially when there is any misunderstanding or any issue is taking place with the pilgrims.

He further said that the association has ensured accountability. "The cheating issues have taken place in the past, but we have been ensuring accountability. If there is any such complaint, the matter is being investigated thoroughly. There is no such case in the past three-four years, because the association has been playing key role and the people should meet us in case of any such complaint," he said—(KNO)

resident of Begumpur, North West Delhi and projected himself as managing partner at the particular company dealing in areca nuts.

The resident of Rambagh has alleged that he paid Rs.18 lakhs in different installments following the interactions with Patel at Pratap Park Srinagar and at a restaurant in Srinagar last year.

SRINAGAR: The Jammu and Kashmir government has allocated a substantial funding of Rs 7097cr in budget 2023-24 to develop a strong ecosystem for the cities, focusing on urban-rural partnership, enhancing market and business opportunities, job creation, filling gaps in education system and ensuring sustainable economic development in rural and urban pockets of the Union Territory.

The implementation of Panchayat Development Index helps in developing and replicating best practices that drive improvement across the socio-economic themes of Panchayats under newly approved Aspirational Panchayat Development Programme (APDP).

The identified Panchayats are given special focus to saturate inclusive development schemes which would serve as model Panchayats, an official said. He added the J&K government has selected the most backward 285 Panchayats (One Panchayat per Block) under APDP for holistic development.

The Jammu & Kashmir Municipal Development Index-2022 helps in rating, assessing and analyzing the performance and level of development of various municipalities/ towns of the UT. The urban reform incentive fund is meant for providing reform linked assistance to the ULBs of the UT based on the performance as per the benchmarks prescribed under The Jammu and Kashmir Municipal Development Index-2022.

The Budget has also been earmarked to declare all the villages and ULBs Open Defecation Free plus status (ODF plus).

Notably, Several Municipal Councils and Municipal Committees of Jammu division have self-declared as Open Defecation Free plus status after complying with all bye-laws and development done in Municipal limits as per the Swachh

Bharat Mission norms. Under initiative of "Har Gaon Ek Amrit Sarovar", 4041 Amrit Sarovars have been identified, out of which, 2420 have been completed and remaining will be completed before 15th of August 2023. The dream of elevated light Metro Rail in Capital Cities of Jammu and Kashmir will also be realized in this year's budget.

The government has also earmarked funds for new Townships and Housing Colonies for economically weaker sections (low income group/Middle Income group at Jammu and Srinagar.

Right Knee Injury May Cut Short Williamson's IPL Stint

AHMEDABAD: New Zealand captain Kane Williamson's further participation in the ongoing IPL has been put under doubt due to a right knee injury that he suffered during his team's winning effort against Chennai Super Kings here.

The 32-year-old got injured following a nasty fall while fielding on the boundary during the CSK innings. He had limped off the field in the 13th over on Friday. The extent of his injury is not yet known, but going by what was seen on Friday night, it did not seem a minor injury.

Williamson, who was making his Gujarat Titans debut, inter-

cepted a ball headed for a possible six off CSK opener Rituraj Gaikwad's bat. He managed to palm the ball into the field of play before it bounced onto the boundary ropes. But he fell awkwardly on the ground and clutched his right knee in pain.

He was taken off after receiving on-field treatment and did not come back to bat with B Sai Sudharshan coming in as a substitute fielder first and later he took Williamson's place in the Titans playing XI under the Impact Player rule.

An IPL source told PTI that there is little chance for Williamson to take further part in the IPL though the assessment of his injury is still going on. "Williamson will probably require ACL reconstruction and could be out of competitive cricket for indefinite period of time," said the IPL source.

Titans captain Hardik Pandya had said at the post-match press conference that he did not know how serious was the injury.

"It is knee (injury) for sure but I don't have any update about what exactly has happened. I don't know how serious the injury is and how much time it will take (to heal). Right now there is no time frame," Pandya said.

"I had just messaged him. He (Williamson) has gone for the scans, once he comes back after the scans and doctors check (on him), then only we will be able to know what exactly it is." In Auckland, New Zealand head coach Gary Stead said Williamson's injury was a big blow to the national team.
