Srinagar: The congregational Eid prayers are likely to be offered at the historic Eidgah here for the first time in three years, the Jammu and Kashmir Waqf Board said on Tuesday.

Talking to reporters at the Eidgah after conducting a review of the preparations for the congregational prayers that are offered after the culmination of the holy month of Ramazan, Jammu and Kashmir Waqf Board Chairperson Darakhshan Andrabi said if the weather permits, the prayers would be offered at the Eidgah this year.

This year, the Eid namaz will be offered at the Eidgah.... There is a good atmosphere in Kashmir now and it is the administration's endeavour to have the Eid namaz at the Eidgah," she said.

Andrabi said all arrangements will be put in place so that the prayer is offered smoothly.

"Today, Kashmir wants peace, development and prosperity. Let us not think about the past," she added. The Waqf board chairperson said the Eidgah is the face of the city and it will be developed and made better with proper facilities.

Deputy Commissioner (DC) Srinagar, Muhammad Aijaz Asad told reporters that the Waqf Board had raised several issues like drainage, encroachment, lighting and other things.

"A proper demarcation will be done to identify the encroached land of Waqf Board. A few works regarding the lighting, drainage and beautification of Eidgah will be started to restore all the utili-

ties of the Eidgah," he said. Pertinently, the Eid prayers have not been allowed at Eidgah since the abrogation of Article 370 in Jammu & Kashmir on August 05, 2019 as authorities were apprehensive of law-andorder problems.

Banihal Highway To Remain **Closed On Apr 7**

Jammu: The Jammu-Srinagar national highway will remain closed on April 7 for carrying out repairs in landslide-hit areas of Ramban district, officials said Tuesday.

The 270-km-long highway, which is the only all-weather road link between Kashmir and the rest of the country, was blocked several times due to landslides and shooting stones in the past few months and was in need of repairs.

"Based on the direction passed for undertaking important repairs and maintenance works on the highway, April 7 has been declared as a traffic dry day between Nashri to Navyuga tunnel", Senior Superintendent of Police (SSP), Ramban, Mohita Sharma said.

She said only emergency ve-hicles will be allowed to ply on the highway to and fro in Ramban section from 6 AM on April 7 to 6 AM on April 8.

Mughal road still closed

Meanwhile people from Poonch-Rajouri and Shopian are demanding re-opening of the historic Mughal road for vehicular traffic

The road connecting Kashmir via Shopian with Pir Panchal region in Jammu remains shut in winters because of snow.

Google Starts Testing Generative AI Features In Gmail, Doc

After announcing the upcoming generative artificial intelligence (AI) features to Workspace apps two weeks ago, Google has now started public testing them in Gmail and Docs.

The current trusted test programme includes consumer, enterprise and education users (over 18 years) in the US, reports Google.

This "small group" is invited by the tech giant to join and they must sign up and opt-in.

The testers can also leave the programme at any time. Users in the programme can use generative AI in Gmail to draft everything from a birthday invitation to a job cover letter. "Users can also have Google take what they've written and make it more elaborate or shorten it, including down to bullet points," the report said.

On the other hand, AI in Google Docs will make the text more detailed or rewrite it.

Also, it will help users to draft blog posts or even write song lyrics. Participants in the test programme will be able to send feedback through Gmail and Docs.

The company will expand the availability of the generative AI features "over time", the report said.

AI Tool Helps Remove Atmospheric 'Blur' From Cosmos Images: Study

Scientists have adapted a wellknown computer-vision algorithm, which works faster and produces more realistic images, and applied it to astronomical images from groundbased telescopes.

This innovation of the researchers of Northwestern University, US, and Tsinghua University in Beijing, China, could help remove errors and solve the "blur" in astronomical images, they said.

The research is published in the journal Monthly Notices of the Royal Astronomical Society.

"Astronomical images are used for science. By cleaning up images in the right way, we can get more accurate data. The algorithm removes the atmosphere computationally, enabling physicists to obtain better scientific measurements.

"At the end of the day, the images do look better as well," said Northwestern's Emma Alexander, the study's senior author. The blur, caused by the Earth's atmosphere through which the light coming from distant objects passes, becomes an issue when astrophysicists analyze images to extract cosmological data.

Studying the apparent shapes of galaxies helps astronomers in detecting large-scale cosmological structures' gravitational effects.

To tackle this challenge, Alexander's team combined an optimization algorithm with a deep-learning network trained on astronomical images, that included simulated data matching and 7.4 per cent less error compared to modern methods.



Consumers Complain Overpricing Of Mutton During Ramazan

Srinagar: Amid the holy month of Ramadan, people have accused the Food, Civil Supplies and Consumers Affairs (FCSCA) department of failing to regulate the prices of mutton which they say is being sold at Rs 650-700 per kg against the government notified price of Rs 535.

People from various parts of Srinagar that mutton sellers are openly selling it at exorbitant rates. They said there is the least inspection by the FCSCA department to check on "illegal profiteering".

'This is the holy month and we are being fleeced by the mutton shopkeepers. The month of Ramadan witnesses extra consumption of mutton but they are making it difficult for us by selling it at Rs 650 and at some places Rs 700 per kg," Touseef Ramzan, a Srinagar resident said.

"Mutton retailers are selling it at Rs 650 per kg, how is that okay when the government's declared price is Rs 535? I often have to argue with the shopkeeper over the rate. Why is the concerned department not

Similar reports were received from other districts of the valley where people have complained of overpricing of mutton by sellers.

Modest Covid Surge

ndia is witnessing a fresh spike in the Covid-19 infections. In the last twenty four hours around 3600 new cases were reported, almost the same number recorded a day before. This has forced India Inc to enforce stricter measures to combat the surge. Most large entities already have elaborate Covid protocols in place, and those are expected to continue. Measures that are being enforced include work-from-home protocols, regular testing at work sites, regular temperature checks and mask mandates. The new spike is fuelled by a latest subvariant of Omicron virus. Health experts have warned about the subvariant and its potential to trigger serious outbreaks. But so far, they haven't seen a major change in severity in individuals or in populations. But what has emerged as more concerning is the potential of the virus to become more transmissible and severe.

The World Health Organization has said it is keeping a close eye on COVID subvariant, which is driving a rise in COVID cases in India. WHO's CO-VID-19 technical lead and infectious diseases specialist said that one of the big uncertainties about the virus is that it hasn't settled into a predictable pattern but continues to evolve. The global health body has also recommended booster vaccination for the elderly and other vulnerable groups. Globally, Iran, Kuwait, Libya, UAE and Qatar have reported the biggest increases in Covid cases over the last 28 days. Indonesia too has reported a modest rise.

That said, India has witnessed a drastic decline in the number of COVID cases. This is despite the fact that China was recently overrun by a major COVID-19 outbreak leading to the deaths of reportedly thousands of people. The sudden surge in infections followed after the country ended its zero-COVID strategy and lifted the sweeping lockdowns following public protests.

That the infections didn't spread to India in large numbers showed that the country has developed a certain herd immunity. One of the reasons could be that India experienced a nationwide explosion of infections during the virulent Delta wave in the beginning of 2021. Thousands perished as a result. This, together with a successful vaccination programme, may have gone some way to build mass immunity among the people.

However, this is no reason to let our guard down. The virus is now a part of our lives and it has already become endemic. Besides, the new variants of the virus keep triggering fresh outbreaks. So, we can't afford to abandon precautions altogether.

Game Of Thrones



akistani politics is getting messier with each passing day. From alleged audio leaks of senior judges to alleged (non)interviews of a former army chief to a war of words between the Pakistan Democratic Movement government and Imran Khan's Pakistan Tehreek-e-Insaf, the political chaos in the country continues to grow. Moreover, there are visible cracks in the superior judiciary even as differences between the government and the judiciary continue to increase. Things have come to such a pass that there is bound to be a collision that may not end well.

Amidst all this, it seems that the elections in Punjab and Khyber Pakhtunkhwa will not be taking place till the general elections in October this year. Earlier this month, the Supreme Court's larger bench ruled in a 3-2 split verdict — that the elections should be held within 90 days in both provinces. It directed the Election Commission of Pakistan to propose a date for the holding of the polls that deviates to the "barest minimum" from the 90-day deadline. Finally, polls in Punjab were announced for April 30. But a week ago, the ECP announced the postponement of the upcoming elections in Punjab citing security reasons and said that the elections will now take place on October 8. The polls for Khyber Pakhtunkhwa that were set to take place on May 28 have also been delayed to October 8 by the governor. The PTI condemned this move and has taken the mat ter to court. The delay in polls in these two provinces has led to another constitutional crisis as the Supreme Court is hearing a petition by the PTI challenging the ECP's decision on the Punjab elections. The PDM government had already made it clear that it is in no mood to allow elections in Punjab and Khyber Pakhtunkhwa while a population census is ongoing. However, legal experts say that the decision by the ECP is weak and flawed. On the other hand, the government's justification to delay the polls was only to be expected. The political polarisation in the country has grown to such an extent that political parties don't even pretend to care for the law of the land. There were clashes between the police and PTI workers/supporters as Imran Khan continued

to evade appearing in court in the Toshakhana case. The scenes that played out on our television screens and on social media were surreal, to say the least. When Imran Khan finally decided to appear before the court, the judicial complex almost turned into a war zone. He, therefore, signed his appearance papers from his car That someone was accorded this leniency by the courts for so many months may seem bizarre to many but somehow, the judiciary is not bothered about accusations of institutional partisanship to one party. The top court in the country has come under fire for its judgments that allegedly favour the PTI. Now, there are voices within the superior judiciary that are lamenting the Chief Justice of Pakistan's discretionary powers to form benches and take suo motu cognisance. In a recent, detailed ruling, two judges of the Supreme Court wrote: "We find it essential to underline that in order to strengthen our institution and to ensure public trust and public confidence in our Court, it is high time that we revisit the power of 'one-man show' enjoyed by the office of the Chief Justice of Pakistan.' A day later, the government tabled a bill in the National Assembly to shift the powers of taking suo motu notice from the Chief Justice to a three-member committee comprising three senior judges so that the power does not remain with one officeholder. This will surely lead to a clash between the executive and the judiciary, something that we remember vividly during the Pakistan People's Party's tenure from 2008-13 when Iftikhar Chaudhry was the Chief Justice. The courts had dismissed the then prime minister, Yusuf Raza Gilani, and made it quite difficult for the PPP to rule. Political observers have pointed out that leaders of the Pakistan Muslim League (Nawaz) are also saying that if rules do not apply to Imran Khan, then they, too, will not follow the principles and rules that political stakeholders are expected to follow. Insiders say that the PML-N insists that if Imran Khan's popularity rose after the PTI used Article 5 to get rid of the vote of no-confidence — a move that was declared unconstitutional by the Supreme Court last year — then delaying polls

in two provinces would not harm the PDM government either. They also say that it is clear that Imran Khan, who had exploited the false foreign conspiracy narrative, is now trying to mend relations with the United States of America. So other political parties feel that they no longer have to play by the rules.

This sort of thinking amongst political stakeholders is dangerous. If nobody follows the rules of the game, the resultant political chaos will be uncontrollable and the damage to the country will be immense. The PML-N leadership has made it abundantly clear that it is fighting a war of survival. Ever since the PDM and its allies ousted Imran Khan as the prime minister through a vote of no-confidence in April 2022, the PML-N has become considerably unpopular due to rising inflation and the economic crisis confronting Pakistan. The PML-N blames Imran Khan's government for the crisis because it did not honour the commitments made to the International Monetary Fund during its tenure. As a result, the IMF is giving Pakistan a tough time. But it is no secret that the PML-N has not been able to manage the economy either. Buying time will not help the economy if there is political uncertainty in the country. Dialogue is the way forward.

İmran Khan has — finally agreed to sit with his political opponents to resolve the crisis. This, after he had continuousrefused to sit with his rivals when he was in government. But now the prime minister, Shehbaz Sharif, who extended an olive branch to Imran Khan on several occasions, has said that talks will be held with him only after he apologises to the nation for his wrongdoings. In this game of thrones, the PML-N wants to stick to power come what may and the PTI wants to be back in power. Unfortunately, democracy may turn out to be casualty in this political gimmickry.

arburg virus, which causes infection as deadly as Ebola, has been spreading like a wildfire in Africa. Now the US Centers for Disease Control and Prevention (CDC) has urged all travellers going to Guinea and Tanzania to take prevention to avoid catching the fatal virus. Furthermore, the health body is also sending personnel to help halt the spread of the virus.

The Marburg virus is an infectious illness with a high mortality rate and epidemic potential, according to the World Health Organization (WHO). The National Center for Emerging and Zoonotic Infectious Diseases will be sent by the CDC to respond to the outbreaks in Tanzania and Guinea, the organisation said.

Equatorial Guinea first reported the virus in February and since then the WHO has recorded nine confirmed cases and 20 additional probable cases, all of which have died. According to WHO, Marburg virus disease is a highly virulent disease that causes haemorrhagic fever, with a fatality ratio of up to 88 per cent. It is part of the filovirus family that also includes the Ebola virus, which has caused havoc in several previous outbreaks in Africa. The natural host of the Marburg virus is the African fruit bat, which carries the virus but does not fall sick from it.

Bats and other infected animals can transmit the Marburg virus. High fever, bleeding both internally and externally, and excruciating headaches are some of the symptoms of the viral illness.

After being infected, the Marburg virus can spread to another person by coming into direct contact (through cuts in the skin or ruptured mucous membranes) with the blood, secretions, organs, or other bodily fluids of an infected person, as well as by coming into contact with contaminated surfaces and materials (like bedding and clothing).

Marburg has no known cure or vaccine, but according to the WHO, early candidate vaccines as well as blood products, immune therapies and drug therapies are being studied as possible treatments.

The Lure of Dishonesty and Rewards of Ethics


ACH one of us faces a moral or an ethical dilemma or dilemmas at any given point in time. This is perhaps because we are human, defined as we are by foibles, weaknesses, temptations and so on. There is also a structural factor that overlays our human (ness); context and a given situation can present us with challenges that have a moral or an ethical flavour or ingress. For example, conditions of extreme poverty, say, an exigent need to feed one's hungry children, can make a perfectly ethical and moral person

commit theft or even worse. In this circumstance, the element of moral choice is overridden; it actually does not exist. (You either feed your children or they die of hunger). But these are extreme circumstances (with the caveat that for many deprived and underprivileged of the world, these are unfortunately the normal).

However, generally, and usually we all have a choice, if our mental faculties and the ability to reason are intact. Here the dilem-



ma is that of the prevalent mores in society. Say, if corruption is widespread and acceptable in it, what does the ethical or the moral person do? Be part of the game, so to speak and move on or be an outlier seen as an oddball by the rest? Or, say, if there are moral and ethical issues in society that are brushed under the carpet(as in hushed up), does one

stand up to and expose these or close one's eyes as well or even, at another extreme, to employ the jargon of economists, earn rents off these?

Practically, there's no easy answers or solutions to these dilemmas. But if one is ethical and moral, one may become a cynic if by omission or commission unethical behaviour

is prevalent in society. What then can a person do to remain wedded to a moral compass against the backdrop of unethical situations that present themselves?

For me, the answer is pretty simple and straightforward. As a Muslim, I am a believer. The corollary here is that an ethical path is laid out for me by my religion. This does not

then present nuanced moral and ethical ambiguity for me. (I say this in a very non -judgmental manner. I do not judge others for their ethical laxity, perceived or real). Each situation is unique, there is context, there are permutations and combinations, and each one of us is answerable for his or her own acts of omission and commission. Who am I to judge?

But, as a society, whatever and wherever one's given society might be, there are and must be ethical standards, that are usually universal, that must not be breached. For instance, a crime like murder is bad. There is universal consensus on this. Exploiting someone or abusing a person's vulnerability is immoral and unethical. The list goes on. How can these crimes and unethical behaviours be checked?

One answer is by the instrument of law and the state. While law and the state argument and recourse is a sound one but, in the final analysis, a good and ethical society is one where both there is minimal intervention by either. The well springs or ethics and morality must emerge from people. I am not aiming or alluding here to a moral utopia but merely suggesting that a 'good' society is one that is populated by good people, that is, moral and ethical people. This level and nature of morality and ethics can perhaps be arrived at by multi- pronged efforts: one, economic conditions and conditions that give short shrift to crime (this will not prevent crimes of a psycho-pathological behaviour). Two, persons in a given society must be morally and ethically aware and be constantly reviewing and sharpening their moral and ethical compass. Third, morality and ethics can be made chic. But this leaves the question of 'returns

from either moral and ethical behaviour or returns from unethical and immoral behaviour unaddressed. With respect to the latter, sometimes, it may seem that unethical behaviour yields returns such as economic and financial payoffs, and other forms of glitter. Is then, given the finiteness of life, unethical behaviour worth it? No. Not at all.

For one, for all the glitter and wealth effects of unethical behaviour, there are invariably opportunity costs- compromises have been made, prices(at times even in terms of life) are paid, or, in other words, a lot is mortgaged in return for unethical behaviour. There are then clear tangible benefits to be had from an ethical and moral orientation. But the most effective, important and long lasting benefit to be had from either is intangible: peace of mind, contentment and even happiness. Let us then strive to strengthen our moral and ethical compasses and live honest, happy and contented lives.

Rethinking AI and Assessment

hatGPT is a powerful language model developed by OpenAI -that has the ability to generate human-like text, making it capable of engaging in natural language conversations. This technology has the potential to revolutionise the way we interact with computers, and it has already begun to be integrated into various industries.

However, the implementation of ChatGPT in the field of higher education in the UK poses a number of challenges that must be carefully considered. If ChatGPT is used to grade assignments or exams, there is the possibility that it could be biased against certain groups of students.

For example, ChatGPT may be more likely to give higher grades to students who write in a style that it is more familiar with, potentially leading to unfair grading practices. Additionally, if ChatGPT is used to replace human instructors, it could perpetuate existing inequalities in the education system, such as the under-representation of certain demographics in certain fields of study.

There is also the potential for ChatGPT to be used to cheat on exams or assignments. Since it is able to generate human-like text, ChatG-PT could be used to write entire assignments or essays, making it difficult for educators to detect cheating.

For example, ChatGPT (meaning "generative pre-trained transformer") could be asked to "write an essay about the challenges that ChatGPT poses higher education in the UK". In fact, the first four paragraphs of this article were written by ChatGPT, in response to this exact request.

ChatGPT's response (and this is your human author writing now) actually amounted to more than four paragraphs, as it went on to ar-



ticulate its inability to fully replicate the expertise and real-world experience that human teachers bring to the classroom. This particular line of enquiry made me both appreciative of its concern for my job security, and somewhat cynical of its Machiavellian designs to win me over.

In my research and teaching, I am involved in developing assessment and feedback processes that enrich the student experience, while also equipping them with the skills they need upon graduation.

The truth is, if I was looking at 200 pieces of work submitted by firstyear undergraduate students on this topic, I would probably give Chat-GPT's efforts a pass. But far from being worried about the challenges this AI programme might pose, I see this instead as an opportunity to improve the way we assess learning in higher education.

FINDING OPPORTUNITIES

For me, the major challenge that ChatGPT presents is one I should be considering anyway: how can I make my assessments more authentic - meaning, useful and relevant. Authentic assessments are designed to measure students' knowledge and skills in a way that is particularly tailored to their own lives and future careers.

These assessments often involve tasks or activities that closely mirror the challenges students may encounter in real life, requiring them to apply knowledge and skills in a practical or problem-solving context. Specific examples might include asking a group of engineering students to collaborate on a community issue as part of the Engineers without Borders challenge, or inviting environmental science students to curate an art exhibition in a local gallery that explores the local impact of the climate crisis.

While there will always be a need for essays and written assignments especially in the humanities, where they are essential to help students develop a critical voice - do we really need all students to be writing the same essays and responding to the same questions? Could we instead give them autonomy and agency and in doing so, help to make their assessments more interesting, inclusive and ultimately authentic? As educators, we can even use

ChatGPT directly to help us develop such assessments. So, rather than posing the question that generated the start of this article, I could instead present students with Chat-GPT's response alongside some marking instructions, and ask them to provide a critique on what grade the automated response deserves and why.

Such an assessment would be much more difficult to plagiarise. It would also invite the students to develop their critical thinking and feedback skills, both of which are essential when they graduate into the workforce, no matter what their profession. Alternatively, ChatGPT could be used to generate scenariobased tasks that require students to analyse and solve problems they may encounter in their future careers.

This feels like a Pandora's box moment for assessment in higher education. Whether we decide to embrace ChatGPT in our pursuit of authentic assessment or passively acknowledge the ethical dilemmas it might present to academic integrity, there is a real opportunity here. This could help us reflect on how we assess our students and why this might need to change. Or, in the AI's own words:

ChatGPT could be a useful tool for creating authentic assessments, but it would still be up to the instructor to design and implement the assessment in a way that is meaningful and relevant for their students.

The sophistication and capability of AI technologies are accelerating. Rather than reacting with trepidation, we must find and embrace the positives. Doing so will help us think about how we can specifically tailor the assessment of students, and provide better and more creative support for their learning.

Infertility affects one in six people globally, says WHO report

New Delhi: An estimated one in six people globally are affected by infertility, according to a new report from the World Health Organization published on Tuesday. The global health body not-

ed that around 17.5 per cent of the adult population experience infertility, showing the urgent need to increase access to affordable, high-quality fertility care for those in need.

The new estimates show limited variation in the prevalence of infertility between regions. The rates are comparable for high-, middle- and low-income countries, indicating that this is a major health challenge globally.

Lifetime prevalence was 17.8 per cent in high-income countries and 16.5 per cent in lowand middle-income countries. WHO said.

"The report reveals an important truth: infertility does not discriminate," said Tedros Ghebreyesus, Adhanom Director-General at WHO.

"The sheer proportion of people affected show the need to widen access to fertility care and ensure this issue is no longer sidelined in health research and policy, so that safe, effective, and affordable ways to attain parenthood are available for those who seek it," Ghebreyesus said in a statement.

Infertility is a disease of the male or female reproductive system, defined by the failure to achieve a pregnancy after 12

months or more of regular unprotected sexual intercourse. It can cause significant distress, stigma, and financial hardship, affecting people's mental and psychosocial well-being.

Despite the magnitude of the issue, solutions for the prevention, diagnosis and treatment of infertility -- including assisted reproductive technology such as in vitro fertilization (IVF) -- remain underfunded and inaccessible to many due to high costs, social stigma and limited availability, WHO said.

"Millions of people face catastrophic healthcare costs after seeking treatment for infertility, making this a major equity issue and all too often, a medical poverty trap for those affected," said Pascale Allotey, Director of Sexual and Reproductive Health and Research at WHO.

"Better policies and public financing can significantly improve access to treatment and protect poorer households from falling into poverty as a result," Allotey said.

While the new report shows convincing evidence of the high global prevalence of infertility, it highlights a persistent lack of data in many countries and some regions.

The report calls for greater availability of national data on infertility disaggregated by age and by cause to help with quantifying infertility, as well as knowing who needs fertility care and how risks can be reduced.

"Pakistan is making repeated attempts to smuggle weapons, improvised explosive devices and grenades (in the recent past) but majority of these attempts were foiled as we have full control of the situation (on the borders)," Additional Director General of Police, Jammu zone. Mukesh Singh told reporters in Samba.

On Monday, security forces recovered three pistols, six magazines, four hand grenades and 48 rounds of ammunition from a packet believed to have been dropped by a Pakistani drone near the International Border in Samba district.

"I want to assure all that all the conspiracies hatched across the border will be foiled," Singh said, adding the shortcomings, if any, will be addressed to

Responding to a question about the possibility of terrorists trying to sneak into this side from Pakistan, he said there have

"The people raised many issues of concern like drug trafficking, weapon smuggling, illegal mining and bovine smuggling (during the meet). We will have one more meeting in the coming days and chalk out a proper action plan to address all these issues," the ADGP said.

He said the people were appreciative of the police campaign to make Samba a drugfree district.

Singh said the drug smugglers who had fled to other districts amid the crackdown will be identified and arrested.



Kunfer Tunnel Along Jammu-**Srinagar NH Nears Completion**

One Tube Likely To Be Opened Next Week

IAMMU: The work on the Kunfel tunnel connecting Peeda with Chanderkote along the Jammu-Srinagar national highway is nearing completion, with one of the twin tubes likely to be thrown open for traffic by the end of next week, officials said on Tuesday.

The construction of the 924-metre tunnel, which will bypass a nearly three-km landslide and accident-prone area in Ramban district, started in 2018 after a year's delay due to some issues related to awarding of contract by the National Highways Authority of India (NHAI). Gammon India Limited has been given the contract for con-

structing the tunnel. The tunnel is part of the ongoing four-laning of the 270-km Jammu-Srinagar national high-

way -- the only all-weather road linking Kashmir with the rest of the country. The first tube of the Kun-

fer tunnel is almost complete and we are expecting it to be opened for traffic within the next eight days," Deputy Commissioner, Ramban, Mussarat Islam told PTI. Islam, who is monitoring the

highway project on a daily basis, said laying of only 50 to 100 metres of pavement quality concrete (PQC) and construction of the approach road are pending and will be completed by the next week

"Inclement weather over the past few days played spoilsport and hampered the work on the approach road," he said.

On March 16, the NHAI dedicated the 880-metre T-5 tunnel on the highway to the public. The tunnel bypasses the most vulnerable stretch of Panthya in Ramban district.

The work on the four-laning project started in 2011 and includes a number of small and major tunnels, bridges and flyovers. The project is likely to be completed by the next year after missing several deadlines over the past decade.

"The first tube (T1) of the Kunfer tunnel is almost ready and will take a maximum of 10 days to become operational. Only some road construction is pending," said Salim Khan, deputy general manager of Gammon India Limited. Asked about the second tube (T2) of the Kunfer tunnel, he said it will be ready within two months. "The work is going on round the clock and will be completed as soon as possible. While the first tube is almost ready, the T2 is going through tunnel lining with 45 metres of excavation work yet to be completed," the official said.

Ramban Deputy Commissioner Islam said the most critical stretch of 66 kilometers of the highway passes through the district between Nashri and Banihal tunnels.

"We have got three tunnels in the past year and several other small tunnels and bridges are nearing completion and will bypass other critical spots on the road," he said.

The officials said work is also progressing smoothly on the Ramban flyover and several other bridges.

They said the completion of these projects will not only help resolve the issue of traffic jams on the highway to a large extent but will also cut down the distance between different points by several kilometers.



LAHORE: Babar Azam on Tuesday returned to the Pakistan team as captain of the ODI and T20 squads for the home series against New Zealand beginning April 14. Besides Babar, left

arm fast bowler Shaheen Shah Afridi also

returned to international cricket for the first time since the T20 World Cup in Australia last November.

Though Shaheen bowled and also captained the Lahore Qalandars franchise to their second successive title in the Pakistan Super League last month, a knee injury kept him out of a home Test series against England and later New Zealand.

The national selectors had rested Babar, Shaheen, Haris Rauf, Fakhar Zaman and Muhammad Rizwan for the recent T20 series in Sharjah against Afghanistan which Pakistan lost by 1-2.

All five seniors returned to the side for the five ODIs and five T20 internationals against New Zealand, which will be played in Lahore, Rawalpindi and Karachi from April 14 to May 7.
