J&K To Have American Type Road Infrastructure In Coming Years: Gadkari Says Kashmir To Kanyakumari Dream Road To Complete By 2024

Srinagar: Union Minister of Road Transport and Highways, Nitin Gadkare Monday stated that Jammu and Kashmir will compete with the United States of America in terms of road infrastructure in the years to come.

Minister also said the dream of having a highway from Kashmir to Kanyakumari will be realised by the beginning of the next year.

Interacting with the media at Lalit Grand Palace here after inspecting the ongoing work at Zojila Tunnel, Gadkare said Jammu and Kashmir will have 19 tunnels at a cost of Rs 25,000 crore while construction of 13.14 Kilometer long tunnel and approach road at a cost of Rs 6800 crore is in the progress.

Elaborating, the Union Minister also said a 7.75 meters single tube, 2 lane tunnel will pass under Zojila between Ganderbal district in central Kashmir and Drass town of Kargil.

"Kashmir to Kanyakumari road was a dream for us. From Rohtang to Ladakh, four tunnels will be constructed. From Leh, we will come to Kargil and join Zojila and Z-Morh tunnels.

'Zojila Tunnel Historic, Highest In Asia'

nion Road Transport and Highways Minister Nitin Gadkari along with a 13-member Parliamentary committee on Monday reviewed the construction work of the strategic Zojila tunnel, which will provide all-weather connectivity between Jammu and Kashmir and Ladakh. While terming the tunnel historic, the minister said that the project is part of a dream to connect the Kashmir valley with Kanyakumari. The Union minister also announced that the Z-Morh tunnel, which connects **Gagangir with Sonamarg** and provides all-weather connectivity to the resort in the Ganderbal district of central Kashmir, will be inaugurated in October this year.

"This is a historic and important tunnel in the history of India. The tunnel length is supposed to be the highest in Asia," Gadkari told reporters after inspecting the work on the site at an altitude of over 11,500 feet.

The Union minister led a 13-member delegation of the Parliamentary consultative committee on the ministry. The tunnel project through the mighty Zojila Pass at an altitude of 11,578 feet on the Srinagar-Kargil-Leh National highway is of strategic importance as the highway remains closed during winters due to heavy snowfall, cutting off the Ladakh region from Kashmir. Sharp Decline In RTI Applications In J&K

Findings Of CHRI Reveal 31 % RTI Receipts Less In 2021-22

Srinagar: Jammu & Kashmir Union Territory recorded a sharp decline in the number of applications filed with different departments under the Right to Information Act-2005 in 2021-22, a report by a transparency panel said on Monday.

According to an analysis of the Central Information Commission (CIC) annual report for 2021-22 by the Commonwealth Human Rights Initiative (CHRI), Jammu and Kashmir administration reported a 31.44% decline in RTI applications received in 2021-22 as compared to 2020-21. "Among the UTs, Jammu and Kashmir reported a 31.44% decline in the number of RTI receipts in 2021-22 (1,099) as compared with the 2020-21 figure (1,603)," the CHRI said in its findings.

The CHRI findings further reveal that although Jammu & Kashmir reported only 94 RTI applications carried over from 2020-21, it was nevertheless a 683.33% increase over the 2019-20 figure (12 RTI applications).

J&K Reports 50 New **Corona Cases**

Srinagar: Jammu and Kashmir reported 50 fresh covid-19 cases while there was no death due to the virus during the last 24 hours, officials said on Monday.

They said that 32 cases were reported from Jammu division and 18 from Kashmir Valley, taking the overall tally to 480223. Among the cases, 174303 are from Jammu division and 305919 from Kashmir Valley.

Providing district wise details of the cases, they said 20 cases were reported from Jammu, nine from Pulwama, seven each from Samba, six from Srinagar two each from Doda, Reasi, Kupwara and one each from

Poonch and Baramulla. There was no death either from Jammu division or Kashmir valley during the time. So far 4788 people have succumbed to the virus and among them include 2355 from Jammu division and 2433

from the Valley. Besides, they said, 16 Covid-19 patients recovered

from Jammu and Kashmir was also awaited, he said. He urged the bench to give them the last opportunity to furnish their responses.

The bench, while giving them six weeks to respond, said copy of its order be sent to the two states and the Union Territory informing them that the apex court will close the opportunity for accepting their responses if they fail to do so within the deadline.

The top court posted the matter for further hearing in July. The apex court was hear-

ing the pleas, including the one filed by advocate Ashwini Kumar

Upadhyay, which has sought directions for framing guidelines for identification of minorities at the state level, contending that Hindus are in minority in 10 states.

While hearing the matter on January 17, the apex court had expressed displeasure over six states and Union Territories (UTs), including Rajasthan and Telengana, not submitting their comments to the Centre on the issue of identification of minorities at the state level.

nished their comments on the issue. The status report, filed in the apex court in January, had said that comments from six states and UTs -- Arunachal Pradesh, Jammu and Kashmir, Jharkhand, Lakshadweep, Rajasthan and Telangana -- were still awaited.

Iltija Demands Regular **Passport For 10 Years**

Srinagar: PDP chief Mehbooba Mufti's daughter Iltija on Monday shot off a letter to the regional passport officer here, questioning the decision to issue her a country-specific passport for two years only, and demanding a regular passport for 10 years.

"As per rule 12 of the passport rules, duration of the passport has to be ten years. However, in my case it has been illegally curtailed to two years. In addition, the passport has been issued with an endorsement that it's only

valid for the UAE. "Both these decisions have been taken in violation of the mandate of the Passport Act," Iltija wrote in her letter to the regional passport officer Davinder Kumar.

Last week, Iltija was issued a passport for a limited period of two years to allow her to study abroad despite an adverse report by the Crime Investigation Department of police.

17 Graft Cases Filed By ACB In Last 3 Months

Srinagar: Taking tough action against the government officials involved in malpractices, the Jammu & Kashmir Anticorruption Bureau (ACB) has registered over 17 cases in the first three months of ongoing year against public servants for accepting bribes, besides their involvement in embezzlement of funds, disproportionate assets, and other cases.

According to official figures, the anti-graft body has registered only six cases in Jammu division, while 11 cases have been filed in Kashmir province—indicating



that the corruption in the Valley was much higher than the winter capital.

Three cases have been registered in Jammu city and one each in Udhampur, Doda and Rajouri districts. In the Valley, 7 cases have been registered in Srinagar, three in Anantnag and 1 in North Kashmir' Baramulla district, the data revealed. An official from the ACB told Kashmir Observer that the government has ordered a zero policy towards corruption and ACB was leaving no stone un-

turned to ensure the same. "Whenever we receive any complaint, we keep the person anonymous and without wasting any time we ensure the person, if found guilty, is behind bars," the official said, wishing not to be named.

How Parents Feel About Feelings Can Deeply Affect A Child's Development

ow our families express feelings, talk about feelings and react to feelings can have ripple effects into the next generation. When someone becomes a parent, the models they had can become embedded in how they in turn parent.

A parent's organised set of thoughts and feelings about their own and their child's feelings is what some psychologists call parental meta-emotion philosophy. Understanding this can make a big difference in parenting and children's development.

I lead research projects that investigate the usefulness of programmes that teach parents how to understand their feelings about feelings and guide their children in healthy emotional regulation and coping strategies.

The family emotional climate

All of us have a long emotional history that comes from the emotional climate we grew up with. Early experiences become ingrained in how we feel about feelings, and affect our ability to form healthy relationships.

Based on their emotional history, some parents become good at what psychologists call emotion coaching.

These parents have learned to recognise and accept their feelings, for example that it is okay to be sad. They are aware of their children's lowerintensity feelings and view their children's emotional displays as a time for connection and teaching.



Becoming aware of feelings

Other parents have learned to ignore or deny their feelings and develop a tendency to dismiss emotions. These parents tend to avoid uncomfortable feelings like sadness and anger. Emotionally dismissive parents will likely try to make uncomfortable feelings in children go away quickly or brush them off by saying things like you'll get over it.

Gaining the ability to be aware of, understand and manage feelings is an important part of child development. Studies have shown that parents who have an emotion coaching philosophy support their children's emotional regulation,

behaviour and social skills. The question is, how effective is teaching parents to understand their feelings about feelings at improving the family emotional climate and child development outcomes.

Parenting programmes

Parent education programmes teach parents about children's needs and development and offer them tools to enhance their parenting behaviours. Some parenting classes and programmes are delivered through organizations like family centres and social services.

Others are offered through medical clinics like pediatricians' offices. There are many programmes that help parents respond to children's challenging behaviours for example, teaching parents how to positively reinforce children's appropriate behaviours.

More recently, some parenting programmes have begun to focus on parents' feelings about feelings: emotion-focused parenting programmes. These programmes teach parents specific parenting behaviours that support their children's emotional needs.

Srinagar: With highest numbers of tourists visiting Kashmir, the builders of Shikaras in Kashmir say that demand is on rise as unemployed youth are earning their livelihood by signing up as a boatman in Dal Lake.

A third generation shikara maker, Ghulam Nabi of Baba Mohalla Dal Lake said since last 35 years, he has been making Shikara but demand has picked up since last year.

'As last year there was a good tourism season, the demand for Shikara has increased as more and more unemployed youth are starting Shikara so as to at least earn some money for themselves," he added.

According to him, they too have to face many challenges as timber is not easily available in the market

while rates are high. "It usually takes a person around 15-20 days to make one Shikara and in making it," he said.

A Shikara costs around 2.5-3 lakhs and around 35 ft of timber is required to make a boat.

But he complained that the government has never supported them while requesting the authorities to give them timber for continuing their craft

'I Lived Like Fish Without Water For 57 Years'

Kashmiri's Wait To Visit Father's Grave Ends

AWASI (MUZAFFARABAD) - Raja Naseeruddin was just three when his father died in a traffic accident. On Friday, 59 years later, he saw his father's grave for the first time. Naseeruddin was one of 19 Indian Kashmiris who travelled to Pakistan-controlled Kashmir by bus on Thursday, the first to run across the heavily fortified military line dividing

Kashmir in nearly 60 vears. "How can I express myself? I simply don't know how," said a earful Naseer after offering prayers at his father's simple grave in the mountain village of Lawasi.

" I don't remember my father, I was too young when he died." he said.' "Now, at least I feel relief to have visited his grave. I want to come here again."

Naseer's family, like so many others, was split apart by the Line of Control drawn across the scenic valleys of Kashmir. After his father was killed in 1946 near Muzaffarabad his mother took him to live with relatives near Srinagar.

A year later, with the armies of newly independent Pakistan and India were battling over Kashmir, Naseer was unable to return to his home Village — and so it was until this week. "Returning to my land, I feel like a fish being thrown back

Gulf Nation Ruler Warned Me Of Army Chief's 'Conspiracy': Imran Khan

LAHORE: A year after his ouster as the prime minister of Pakistan, Imran Khan on Monday said that he was cautioned by the ruler of a Gulf nation last year that the then Army chief Gen Qamar Javed Bajwa was conspiring to topple his government.

Last year in April, Khan was ousted as the prime minister of Pakistan and his government toppled through a no-confidence motion brought in Parliament by the opposition parties led by the Pakistan Muslim League-Nawaz (PML-N).

On Sunday, Khan, who is the chief of Pakistan Tehreeke-Insaf, issued a white paper on the one-year performance of the PML-N-led coalition and termed it the worst in the country's history.

"Before the no-confidence motion against me was tabled in April last year, the ruler of a Gulf country told me that my Army chief Gen Qamar Javed Bajwa was conspiring against my government to get his extension (from the PML-N and its allies). Bajwa was a mastermind of this conspiracy," Khan claimed.

He criticised Bajwa for destroying Pakistan merely for his extension which he could not



get despite a promise by (prime minister) Shehbaz Sharif.

Things have revealed later that the conspiracy to overthrow my government was not hatched by the US. Gen Bajwa hired former envoy to US Hussain Haqqani to launch propaganda that Gen Bajwa was pro-America and Imran Khan was anti-America," Khan said.

Following his removal, Khan had initially blamed the US for playing a role in his government's toppling.

However, later he held Gen. Bajwa responsible for the 'conspiracy' which resulted in his ouster. Months before his retirement in November last year, Gen Bajwa had repeatedly said that he was not seeking another extension in service. He also made it clear that the Pakistan Army has decided to distance itself from the country's politics.

Israel No Match for Iran's Army, Says Army Chief

The chief commander of the Iranian Army says the Israeli military, which heavily relies on sophisticated Western-built munitions, is no match for Iran's Armed Forces, dismissing hostile remarks by the Israeli army's chief of staff that Israel is "ready" to attack Iran even

without US support. Major General Abdolrahim Mousavi said on Monday that such comments are merely meant to boost the morale of the Israeli soldiers and fix the internal problems of the re-

"Anyone already familiar with the military capabilities of both sides knows well that the updated size and scale of the Zionist regime's military would maximally correspond only to one of the plentiful operations that Iran's Armed Forces undertook during the 1980-1988 Iragi-imposed war on the Is-

'The Zionist regime, which is sinking and the signs of its collapse are now becoming more evident than before, is too feeble to be viewed as a threat to the Islamic Republic of Iran. The actions of its leaders, which are far from rationality and prudence, will only accelerate the downfall of the regime," the

top General added. "We are ready to act against



Iran. The Israeli army has the ability to strike both in distant countries and near home," Israeli army's Chief of Staff Herzi Halevi said on Wednesday.

He further claimed that the Israeli military will enhance its capabilities for a pre-emptive strike on Iran in the next few years, and such a strike would be "overwhelming" despite the geographical distance.

Iran's Army chief has already dismissed Israel's military threats, saying the regime is unable to take an Iranian response to any hostile act that it may carry out given the political tensions it faces inside the occupied territories and its sense of insecurity in the broader region.

Addressing a meeting with senior Army commanders on December 22 last year, Mousavi said Iran is closely and constantly monitoring all the enemy's moves, and that the Armed Forces are fully ready to counter any threat at once.


China opposes Amit Shah's visit to Arunachal Pradesh days after renaming 11 places

BEIJING: China firmly opposes a visit by home minister to Arunachal Pradesh and views his activities in the area as violating Beijing's territorial sovereignty, a foreign ministry spokesperson told a news briefing on Monday.

China has renamed 11 places in what India regards as its eastern state of Arunachal Pradesh, which China claims as part of its territory.

"Zangnan is China's territory," spokesperson Wang Wenbin said in response to a question on the visit by Indian Home Minister Amit Shah.

"The Indian official's visit to Zangnan violates China's territorial sovereignty, and is not conducive to the peace and tranquility of the border situation."

Gyanvapi: SC To Hear On April 14 Plea Seeking **Nod For Ritual Ablution During Ramzan**

The Supreme Court on Monday agreed to hear on April 14 a plea by the Anjuman Intezamia Masjid committee seeking permission for 'wazu' (ritual ablution) at the Gyanvapi mosque complex in Varanasi during the month of Ramzan.

The apex court had on November 11 last year extended till further orders the protection of the area where a 'Shivling' was claimed to have been found.

The matter was mentioned before a bench headed by Chief Justice D Y Chandra-

Senior advocate Huzefa Ahmadi, appearing for the Masjid committee, requested the bench to take up the matter for hearing soon, saying the month of Ramzan is underway and adequate arrangements should be made.

He said the water for wazu is being used from a drum and the number of worshippers has increased in view of Ramzan.

The CJI said the matter will be taken up for hearing on April 14 by the bench also comprising Justice Surya Kant.

On March 28, the apex court had agreed to list for hearing on April 21 a plea of the Hindu side seeking consolidation of all suits filed in a Varanasi court pertaining to the Gyanvapi mosque complex row.

The bench had taken note of the submissions of lawyer Vishnu Shankar Jain that the district judge of Varanasi has deferred five times the decision on a plea seeking clubbing of all civil suits pertain-



ing to the dispute.

The apex court had earlier allowed the Hindu parties to move an application before the Varanasi district judge for consolidation of all lawsuits filed on the Gyanvapi mosque-Shringar Gauri row.

It had also directed the Hindu parties to file their replies within three weeks to the appeal by the Anjuman Intezamia Masjid committee challenging the Allahabad High Court order on appointment of a survey commissioner.

On May 17 last year, the top court had passed an interim order directing the Varanasi district magistrate to ensure protection of the area inside the Gyanvapi-Shringar Gauri complex where the structure claimed to be a 'Shivling' was found during a video survey ordered by the court of the civil judge (senior division) in Varanasi.

The mosque committee, maintained the however, structure was part of the water fountain mechanism at the 'wazukhana', the reservoir

where devotees perform ablutions before offering namaz.

The apex court had transferred the case to the district judge on May 20 last, pointing at the "complexities" and the "sensitivity" of the issue and saying that a more senior judicial officer should handle it.

In its May 17 last year order, the top court had directed protection of the area around the claimed 'Shivling' while also allowing Muslims to offer namaz in the mosque.

It had said the interim order shall remain in operation till the maintainability of the suit is decided by the district judge, and then for eight more weeks to allow the aggri parties to approach a higher

The Varanasi district judge is now hearing the plea by a group of women seeking permission for daily worship of idols of Hindu deities located on the mosque's outer wall. The Hindu side has also sought a survey of two locked basements in the mosque complex.

"Falls To New Depths..." Jairam Ramesh Slams **Ghulam Nabi Azad's Charge**

NEW DELHI: Congress leader Jairam Ramesh on Monday slammed former Congress leader Ghulam Nabi Azad and said that the latter falls to new depths with each passing day to demonstrate his true character and loyalty to Prime Minister Narendra Modi.

In a tweet, Jairam Ramesh said, "With every passing day, Ghulam Nabi Azad falls to new depths to demonstrate his true character and his loyalty to Mr Modi. His contemptible statements on the Congress leadership reflect his desperation to remain relevant. I can only say that he is PATHETIC."

The Congress leaders' reaction comes after Bharatiya Janata Party (BJP) spokesperson Ravi Shankar Prasad on Monday demanded answers from Congress leader Rahul Gandhi on the allegations made by Mr Azad that he meets "undesirable businessmen" during foreign tours.

While talking to the reporters, Ravi Shankar Prasad said, "Ghulam Nabi Azad made serious allegations that whenever Rahul Gandhi goes abroad, he meets 'undesirable businessmen'... With whom did Rahul Gandhi meet? What is the agenda? Is Rahul Gandhi working with anti-India businessmen to weaken the country?"

Notably, Mr Azad resigned from Congress over a difference of opinion with Congress leadership mainly Rahul Gandhi. He also led the 'G23' grouping which had demanded reforms in the party including independent internal elections.

His critics in Congress had accused Mr Azad of working closely with the BJP to destabilize Congress. Speaking to ANI, he rubbished the allegation calling it immature, stupid and

He said, "That is stupid. If G23 was the spokesperson of



the BJP, why they are made MPs by Congress? Why have they made them MPs, general secretaries and office bearers? I'm the only one who formed the party. The rest of the people are still there. It is an ill-conceived, immature and childish allegation.

After quitting Congress, Mr Azad formed his own political outfit called Democratic Progressive Azad Party in his home state of Jammu & Kashmir and has now penned a book titled 'Azaad: An Autobiography', in which the former Congress veteran wrote on his working relations with Indira Gandhi, Rajiv Gandhi, Sonia Gandhi, Rahul Gandhi and others. He also highlights incidents, events and Congress mismanagement.

He also said that he holds nothing against Congress and its ideology.

"I must say that having been in Congress since childhood, I don't want to expose and totally want to demolish Congress party. I may have some differences with leadership, I have no differences with Congress party or Congress ideology; two things one is Congress ideology and one is previous Congress leadership and one s present leadership. I have no difference of opinion with Congress ideology, no difference of opinion with earlier Congress leadership, of course here and there in my book I mentioned what went wrong during Nehru's time, Indiraji's time, what has gone wrong during Rajiv's time but I also said they were

World's Most Expensive Car Number Plate Sells For ₹123 Crore. It Reads...

Awealthy bidder has splashed out a world-record 55 million dirhams (\$15 million or ₹123 crore) for a rare car license plate in Dubai, smashing a bar set in the United Arab Emirates more than a decade ago.

Emirates Auction LLC sold plate number P 7 - which, at first glance, looks like the number 7 alone, with the P off to the side - on Saturday during a charity auction, according to the company. Proceeds will go to Dubai ruler Sheikh Mohammed bin Rashid's global food aid initiative, the 1 Billion Meals Endowment.

The UAE has made a habit of auctioning off vanity plates, used by the ultrarich to show off their status and wealth, for charity. The latest auction broke a record set in 2008 by local businessman Saeed Abdul Ghaffar Khouri, who paid 52.2 million dirhams for a plate bearing

the number 1 in Abu Dhabi. The identity of this weekend's auction

winner was not disclosed. Vanity plates have also fetched eyewatering prices outside the Middle East: Someone bought the single-letter "R" plate at auction in Hong Kong earlier this

year for HK\$25.5 million (\$3.2 million). For years, Dubai has been a safe space for the mega-wealthy to flash their

wealth and live a tax-free lifestyle. While other parts of the world worry about an economic downturn, the emirate's economy remains strong - with high oil prices benefitting its neighbors and most important customers. An influx of wealth has buoyed the real-estate market.

Even moderately-paid expats splash out on cars they can newly afford thanks to lower sales tax rates than back home. But the recent Covid-era boom has driven up rents and squeezed middle-class residents.

Businessman Balvinder Singh Sahni, known as Abu Sabah, purchased plate D 5 in 2016 for 33 million dirhams. "Dubai is a city of gold," he said in an interview Monday. "It's a city of big people, secure people, nice people. So everybody wants to show their status.'

Sahni told of how when he first visited the luxury hotel Burj Al Arab in 2006, he was refused entry because his car license plate had too many numbers. He was told he needed either a twodigit number plate - or a reservation. "It was always my dream to have a singledigit number," he said. "When I got the chance, and they told me this money all goes to charity, I went all in." A selfdescribed numbers guy, Sahni said the D 5 plate fit because his favorite number is nine, and if you add D (the fourth letter of the alphabet) with five, you get nine.

Agnihotri Discharged After Apologising In Court

NEW DELHI: Filmmaker Vivek Agnihotri appeared before the Delhi High Court today and tendered an unconditional apology in connection with a criminal contempt case over his alleged remarks against a judge of the court.

Accepting his apology, a bench of Justices Siddharth Mridul and Vikas Mahajan discharged Agnihotri of the contempt charge and cautioned him to remain careful in the future. The high court recalled the criminal contempt notice issued

to him and noted that an affidavit filed by Agnihotri also reflected the regret and remorse unconditionally expressed by him to the court.

"In view of the circumstances that Vivek Agnihotri stated that he has utmost respect for the institution of judiciary and did not intend to wilfully offend the majesty of this court, the notice to show cause issued to him is hereby recalled. Vivek Agnihotri stands discharged as the alleged contemnor," the bench said.

"Mr. Agnihotri we will be cautioning you to be careful in future," the bench told the filmmaker who appeared before the court in pursuance of its earlier direction.

In 2018, the filmmaker had put out tweets alleging bias against Justice S Muralidhar, who was then a judge of the Delhi High Court and is currently the chief justice of the Orissa High Court, as he had released rights activist Gautam Navlakha from house arrest in the Bhima-Koregaon violence case. Subsequently, contempt of court proceedings were initiated

against Agnihotri and others by the high court. On December 6 last year, the court asked the filmmaker to "show remorse in person" after he tendered an unconditional apology through an affidavit.

"We are asking him (Agnihotri) to remain present because he is the alleged contemnor. Does he have any difficulty in appearing before this court? He has to be present and show remorse in person," the court had said.

After Patient's Death During Surgery Press Trust of India MUMBAI: The National Consumer Dispute

Redressal Commission (NCDRC) has upheld a state commission's order directing a city-based hospital and a doctor to pay more than ₹12 lakh in compensation to the family of a senior citizen, 15 years after her death due to excessive use of anaesthetics during a surgery.

The NCDRC had on March 29 rejected the appeal filed by the doctor and the hospital. challenging the order passed by the Maharashtra State Consumer Disputes Redressal Commission in 2015 in favour of the vic-

The NCDRC held that though negligence was attributable to the anaesthesiologist, the hospital shall not be absolved from the vicarious liability.

As per the complaint filed by the daughter of the deceased woman, Kusum (66) was operated on by Dr Ajay Rathore, an orthopaedician, at Parel-based hospital for a fracture on her forearm on June 21, 2008. The anaesthesiologist was Dr Mulji

Khemji Gada (who died during the proceedings before the state commission). Though the operation was conducted in

the morning, the patient did not regain consciousness due to excessive use of anaesthesia. Her condition worsened further, she was intubated and put on a ventilator, it stated.

The patient was hospitalised for a long period in an unconscious condition. The neurologist, after performing a CT scan and MRI, diagnosed her with 'hypoxic encephalopa-thy'. Thereafter, the unconscious patient was shifted to another hospital, where she died on October 24, 2008. Initially, a complaint was filed before the district forum, Central Mumbai, which rejected her plea.

Nikam then moved the state consumer commission in 2015. In 2018, it ruled in her favour and ordered the hospital and doctor to pay her a compensation of more than ₹12 lakh. In 2019, the doctor and the hospital filed

appeals before the national consumer commission, denying any negligence. The NCDRC held that it is evident that the

anaesthesiologist had not performed the pre-anesthetic test properly. "In my view, it was the negligence and failure of duty of care from the anaesthesiologist, who administered an excessive

dose of ketamine and failed to manage the hypoxic event," it observed. It is pertinent to note that the anaesthesiologist did not even read the reports of in-

vestigations of the patient, the NCDRC said. The expert committee report from the department of Traumatology and Orthopaedic Surgery of Grant Medical College and Sir J J group of Hospitals had given stated that there was no medical negligence on the part of the operating surgeon.

The NCDRC, however, referred to the opinion of one of the experts, a neurosurgeon, who cited that as a certain parameter was low, it should have been built up before surgery and pre-anaesthetic fitness should have been recorded.

India's Priorities For G20 Presidency To Benefit Global South: Ex-Diplomat

SRINAGAR: India has set priorities for its G20 Presidency which will benefit the global south, former diplomat J S Mukul said here on Monday.

India assumed the Presidency of the G20 for one year from December 1, 2022, to 30 November 2023.

'We don't forget our friends in the global south. That's why the prime minister held a virtual summit of 125 countries to set the agenda for India's presidency. India, as the host, has invited organisations and countries from the global south. It shows the priorities," he said in his keynote address at a G20 University Connect event organised by the Central University of Kashmir.

He said events had been scheduled in 50 cities of the country to showcase "Incredible India as the mother of democracy".

According to the former ambassador to the Netherlands, the themes outlined by India for its presidency have green development and climate change mitigation at the top of the list.

"The global south needs technical support and finances to meet the challenges of climate change. The developed countries had agreed to pay USD 100 bn a year for mitigation of climate change. That would be one area where India would press," he said.

1.7 Lakh Students With 96.6% **Pass Middle Standard Exam**

"Gadkari is on a mu and Kashmir and we welcome him We appeal to him to announce a commission of inquiry into the wrong alignments (undertaken by the construction companies working on the four-laning Jammu-Srinagar national highway project) which resulted in frequent occurrences of shooting stones (from the hillocks overlooking the road)," Bukhari told reporters after addressing a workers meet in Ramgarh area of Samba district.

The work on the four-laning project of the 270-km highway, the only all weather road linking Kashmir with the rest of the country, has been going on since 2011.

"The contractors engaged by the concerned agency have undertaken the works without considering the fallout and have taken their money, but over the years, the highway has not been stabilised," he said.

Praising the Union Road Transport and Highways minister for his efforts, Bukhari suggested him to focus on construction of a tunnel on Mughal Road, an alternate route connecting the twin districts of Pooch and Rajouri in Jammu with south Kashmir's Shopian, which usually remains closed during the winter owing to heavy snowfall.

"You have promised a tunnel for Mughal Road (to make it an all-weather road). You are inspecting the works on Zojila tunnel (along Srinagar-Leh national highway) and you should also visit Mughal Road to see the progress of the tunnel besides

reviewing progress on Poonch-Loran and Poonch roads and Kishtwar-Dachhan tunnel," the JKAP president said.

He expressed his displeasure on the works being undertaken under Smart

Srinagar and Jammu for narrow- City project in the twin capitals of Srinagar and Jammu and said the breadth of the roads are being narrowed on the pretext of beautification.

"They are narrowing roads and need a lesson in a closed room. They are utilising Rs 1,000 crore each on the two projects and they should be made accountable as this money belongs

to the public," he said. Responding to a question about the resignation of Junaid Azam Mattu from his post of youth president of the party, Bukhari said he resigned from his post after the completion of

his term. "There is nothing wrong in his decision. He has completed his term as party youth president and we have got a new team after recent party elections. He has not resigned from the party and he will continue as Mayor of Srinagar," he said.

Second Warmest March

he European Union's climate monitoring agency's report that Earth had its second-warmest March on record with Antarctic sea ice shrinking to its second-lowest extent is cause for deep concern. The report is based on data from satellites, ships, aircraft and weather stations around the world and shows that temperatures were higher than average in most parts of the world, including North Africa, southwestern Russia, Asia, North America, South America, Australia, and coastal Antarctica.

It is clear that global warming is having a direct effect on sea ice, with the Antarctic sea ice extent being 28 percent below averag, the second lowest for March in the 45-year satellite data record. We are now at a point where dangerous tipping points could be reached. Furthermore, the report states that the past eight years were the eight warmest on record and that the record-breaking temperatures will figure among the coolest within three or four decades as global temperatures climb, even if planet-warming emissions drop quickly. It is time to take action. We must do our part to reduce our carbon footprints and push for more stringent. Climate change is an alarming reality that we can no longer ignore.

There are dire projections for health, the global food system, and economic productivity if no preemptive action is taken. Though the world is working towards capping the temperature increase at 1.5C, the prospects of this happening anytime soon look remote. Even with the temperature remaining at 1.8C, humanity could, by 2100, be exposed to periods of life-threatening climate conditions arising from the coupled impacts of extreme heat and humidity.

Over the last two years we have been witness to temperature increases across the world and to the havoc it has wrought. Last year, the world was buffeted by successive natural disasters that took thousands of lives and cost tens of billions of dollars. The countries such as Kenya, and Somalia witnessed droughts, Nigeria and Pakistan were wracked by devastating floods and vast swathes of the globe including the United States experienced unprecedented heatwaves. This has made people across the world understand the urgency of the creeping climate change and they want world leaders to act.

There is thus an urgent need for the world to come together and take remedial measures to pre-empt the catastrophe. In Kashmir too, climate change has led to considerable changes in weather patterns. Triggering alarm bells is the slowly shrinking glaciers that are the source of the Valley's water bodies. But the factors causing climate change are global in nature and so any effort to reverse the damage has to be backed by the world. And this should be done sooner than later.

atel, who was finally arrested in March, visited the union territory four times from October 2022, once with his family, on two other occasions accompanied by the businessman son of Hitesh Pandya, a senior official in the Gujarat chief minister's office, with another businessman once, and on one visit a doctor who wanted to organise a conference in Pulwama. He was given a bullet-proof vehicle, two escort vehicles and a dozen security personnel from the Seema Sashastra Bal. Patel held meetings with officials, projecting power with nothing more than a visiting card and a false designation, stayed in five-star accommodation courtesy of the administration, was even allowed to visit the Line of Control at Uri. They push their way around dropping names, all the while milking "naya" Kashmir for their own benefit. The administration has closed its eyes to these unsavoury develop-

ments even as it works to ensure there is no word of criticism. As a state of strategic national importance, J&K cannot be treated as a remote outpost of the ruling party where anything goes. Where guards can be lowered depending on who pulls the strings. Story of Waste Segregation Sheds

Create technical Human Resource, Ensure Behavioral change & Sensitize Engineers of REW about SWM Rules Water Act while executing Rural Waste Management works in J&K

wachh Bharat Mission -phase II has been operationalized in Jammu & Kashmir for almost one year now. The Rural Development Department has procured trash bins for crores of rupees across Jammu & Kashmir last year. Thousands of these bins were installed in villages but after a few weeks they were choked with trash and there was nobody to clear them. I had written a detailed piece on this issue last year in November titled, A Tale of Forlorn Dustbins.

Soon after that article was published, the Rural Development Department stopped further distribution of trash bins in many villages. The ground staff of RDD like Panchayat Secretaries, Gram Rozgar Sevaks (GRS) plus Sarpanches/Panches too felt that installing a trash Bin or dustbin was not the solution to address solid waste issues in rural areas because there was no facility available to clear these bins. They stopped further distribution of these bins made mostly of high quality steel. The Department of Rural Development last year also started work on construction of waste processing and collection sites which they call Segregation Sheds. This has become a common name for waste collection sites in rural areas. Between November last year to March end this year, hundreds of such sheds were constructed in rural areas of Jammu & Kashmir. Unfortunately, engineers of the Rural Engineering Wing (REW) allowed construction of these sites near water bodies and roadsides which will not only engender lives of people especially children but is again Solid Waste Management Rules 2016 constituted under the Environmental Protection Act of 1986 by Ministry of Environment Forest & Climate Change Govt of India.

Violation of SWM Rules 2016

The Govt of India under Ministry of Environment Forest & Climate Change in exercise of the powers conferred by sections 3, 6 and 25 of the Environment (Protection) Act, 1986 and in supersession of the Municipal Solid Waste (Management and Handling) Rules, 2000 Solid Waste Management Rules were constituted through a gazette notification dated 8th April 2016. This rules apply to every urban local body, outgrowths in urban agglomerations, census towns as declared by the Registrar General and Census Commissioner of India, notified areas, notified industrial townships, areas under the control of Indian Railway airports, air bases, Ports and harbours, defence establishments, special economic zones, State and Central government organisations, places of pilgrims, religious and historical importance as may be notified by respective State government from time to time and to every domestic, institutional, commercial and any other non residential solid waste generator situated in the areas except industrial waste, hazardous waste, hazardous chemicals, bio medical wastes, e-waste, lead acid batteries and radio-active waste, that are covered under separate rules framed under the Environment (Protection) Act, 1986.

In Jammu & Kashmir, many rural areas fall under the outgrowths in urban agglomerations and SWM Rules 2016 apply to such areas like outskirts of Srinagar or Jammu Municipal corporation or other smaller municipalities (councils or committees). In addition to it the Water (Prevention and Control of Pollution) Act also called Water Act 1974 was enacted in 1974 & it applies to every area whether rural or urban.

Violation of Water Act 1974

By setting up Segregation Sheds, Compost units near Water Bodies in villages the Rural Development Department (RDD) especially its Rural Engineering Wing (REW) is openly violating the Water Prevention and Control of Pollution Act 1974 and they can be prosecuted for the same of someone files a simple complaint before local magistrate or the National Green Tribunal. The preamble of Water Act 1974 says that this law is to provide for the prevention and control of water pollution, and for the maintaining or restoring of wholesomeness of water in the country. The Act was amended in 1988. The Water (Prevention and Control of Pollution) Cess Act was enacted to provide for the levy and collection of a cess on water consumed by persons operating and carrying on certain types of industrial activities. This cess is collected with a view to augment the resources of the Central Board and the State Boards for the prevention and control of water pollution constituted under the Water (Prevention and Control of Pollution) Act, 1974. The Act was last amended in 2003. Section 24 of

Water Act 1974 prohibits use of stream or well for disposal of polluting matter. The relevant section reads:

Subject to the provisions of this section, no person shall knowingly cause or permit any poisonous, noxious or polluting matter determined in accordance with such standards as may be laid down by the State Board to enter (whether directly or indirectly) into any [stream or well or sewer or on land] or no person shall knowingly cause or permit to enter into any stream any other matter which may tend, either directly or in combination with similar matters, to impede the proper flow of the water of the stream in a manner leading or likely to lead to a substantial aggravation of pollution due to other causes or of its consequences.

A person shall not be guilty of an offence under sub-section (1) of Water Act 1974, by reason only of having done or caused to be done any of the acts like (a) constructing, improving or maintaining in or across or on the bank or bed of any stream any building, bridge, weir, dam, sluice, dock, pier, drain or sewer or other permanent works which he has a right to construct, improve or maintain or depositing any materials on the bank or in the bed of any stream for the purpose of reclaiming land or for supporting, repairing or protecting the bank or bed of such stream provided such materials are not capable of polluting such stream. Even setting up these structures on roadsides is dangerous as it will invite dogs and will be a great threat to people especially children who won't be able to walk during school time from such areas?

gated in these sheds nor had any mechanical segregator been installed anywhere which can mechanically segregate the waste into biodegradable and non -bio-degradable waste. There is no facility available in fact to dispose of the hazardous waste material like used diapers or sanitary napkins or used syringes etc.

Solution

With regard to implementing a rural waste management programme the following things need to be done:

Massive Information Education and Communication (IEC)programme need to be taken up in association with local Imams, religious leaders and schools

The people who have been provided with compost pits and soakage pits need to be guided and handheld how to use them. For this matter technical agencies and NGOs need to be hired as mandated under 6.10.7 of Swachh Bharat Mission Gramin.

The guideline number 6.11.2 says that in order to implement the projects professionally, Specialists/ Consultants/Agencies from the fields of IEC, Human Resource Development, School Sanitation & Hygiene Education, SLWM, Monitoring and Evaluation etc may be hired at the State and district levels for the project period. The SBM Gramin guideline number 6.11.3 says that State / UT Governments are advised to post a government officer as a full-time Block Sanitation Officer (BSO).

SBM G guidelines has made it mandatory for every Gram Panchayat (GP) to have one Support Organization (SO) like an NGO member etc associated with it for assisting in fur-

Segregation Sheds

As a student of climate action and waste management, I am unable to understand why the Rural Development Department calls the waste collection points Segregation Sheds. If Govt is already providing Rs 5500 through local Panchayats for construction of compost pits in every house to treat the biodegradable waste and Rs 11000 are being given to set up Soakage Pits for treating liquid waste, why shall mixed waste (kitchen waste and plastic waste etc) be carried to a site and again segregated into biodegradable and non biodegradable waste in a segregation shed?

Technically, only Non-biodegradable waste and hazardous waste like used diapers or sanitary pads should be taken to the segregation shed. In many areas these sheds have been constructed last year but I haven't come across a single place I visited in Budgam, Ganderbal, Pulwama or other places where waste is segre-

thering the sanitation programme. The State and District Missions are supposed to take necessary steps for providing supporting organisation to each panchayat. This is lacking in J&K and we get no desired results on ground.

and we get no desired results on ground.

The Rural Engineering Wing (REW) while executing the works under SBM Gramin Phase II must be sensitized about laws like Environmental Protection Act 1986, Solid Waste Management Rules 2016 and Water Act 1974 so that they take due care of these laws and rules while making civil constructions. It must be made mandatory upon those households who have been provided with compost pits to treat all the kitchen waste there and regular inspections should be done for the same

Conclusion

At an average Rs 4.50 lakhs are provided to each Panchayat for constructing segregation sheds, compost pits and soakage pits. For 5000 village panchayats in J&K, a whopping amount of Rs 225 Crores has been allocated. In addition, crores of rupees have been spent on purchase of steel trash bins as well. Rs 23.40 lakhs are available given to each panchayat halqa every year plus share from DDC and BDC grants. This makes it clear that we have no deficiency of funds under the rural infrastructure and waste management sector especially from the last 3 to 4 years. What we lack is the dearth of technical human resources who could have made SBM Gramin successful. This is a big lacuna which needs to be addressed. Waste management is not at all about undertaking civil works or purchasing a large number of trash bins. This is more than that and demands behavioural change. Let us all become part of this change.

n a misty March day, Ghulam Rasool Najar sits steady to craft a new house-■boat with a grand artist's devotion. Frequent hammer thuds on wood echo his derelict houseboat yard in Kashmir capital, Srinagar's famed Dal Lake. Najar's snow-white beard, parched face and intense looks give away his gravity as a veteran craftsman struggling to retain the vintage hook in houseboats — the floating marvels, called a shimmering specimen of Kashmir's rich artistry.

The feisty octogenarian occupies a quintessential carpentry workplace in the middle of the lake bereft of tourists. The long-faced locals here own houseboats, having no match in the world.

Many call this part of Srinagar as an 'amphibian world'. It houses the famous Hanji community of Kashmir in a loose cluster of hutments and houseboats. A meandering corridor from the bustling Dalgate side—a prominent sightseeing area in the mountainous region—takes one into the backwaters filled with a sense of pity and site of pollution, forcing many to give up on their glorious vacant

But one man-Najar-standing tall beyond his retirement age is making it sure to continue to make houseboats as the pride of Kashmir.

Much before Najar's birth, the art of houseboat-making had started when the World War-I was raving the empires across the globe. Somewhere in 1918, a bunch of war-weary Imperial British had arrived in Kashmir as duck-hunters and

To live closer to the lake full of ducks, they constructed houseboats. Construction process needed the local manpower and expertise. Srinagar being an artisan hub played its great role in beautifying these floating houses. Among those artists were the houseboat carpenters.

"Houseboat carpenters are completely different from other carpenters," Najar says, between his intermittent silences and frequent metal thuds. "The art of making houseboats involves three different teams who work in tandem. One team forms the base, other one makes the whole structure, while the third team chips in with the interior designs."

One among those pioneering carpenters was Najar's father, Mohammad Hanief. "My father was considered as the finest artist of his times," he says, with a faint smile.



Among Hanief's craft marvels is a Sufi shrine in Srinagar – the place known for housing some revered and carpentry-rich shrines. But after his sudden death, Najar as a Class 2 student, had to step into his father's 'big' shoes.

It was 1952, and Najar got his first gig as an apprentice of his father's friend for a shrine-repairing in Srinagar. It was the beginning of his long carpentry journey, which would shortly pass through the lake for houseboat-making.

"I made my first houseboat in Srinagar's picturesque Nigeen Lake," Najar

Being a relatively less crowded water body, the Nigeen Lake was famous among foreigners of yore for its meditative calm. Later Naiar would make a houseboat called Khyber in the Dal Lake. After that, there was no looking back.

Today, nearly 70 years after Najar started his rare carpentry, houseboats in the Dal Lake have become mesmerizing art-pieces. But at the same time, the perpetual political problem in the region has taken a huge hit on the industry.

Kashmir being the UN-recognised dispute between India and Pakistan saw the two nuke-armoured South Asian neighbours waging three wars on it. By late eighties, as militancy erupted in Kashmir, the region's high-end foreign tourism the lifeline of houseboat industry- collapsed, more so, in the face of a torrent of travel advisories shot by western countries.

As the armed conflict dragged on, the government imposed a ban on building new houseboats 'to prevent pollution' in

"It was a bizarre decision," Najar says. "Instead of coming to the rescue of the conflict-battered houseboat community, the government imposed sanctions on it and shattered the once thriving industry."

With the result, many houseboat carpenters were forced to switch over to other means of living. However, a handful of carpenters, including Najar, stayed put. His obscure tribe managed to prolong their ties with the fading art by sustaining on the occasional houseboat repairing

But for his amazing skill and dogged resilience to keep the heritage promise intact, Najar, the elderly 'wouste' (master) holds a great sway and admiration over the houseboat community.

To his credit, he says, are around 45 percent of the houseboats in the lake. It usually takes him around 15 months to make one houseboat.

"Back in the day, when Kashmir was peaceful and packed with tourists and travellers, we used to work endlessly, without compromising on quality," he says. "Even today houseboat owners seek my services. Yes, the demand is less, but I'm still very much passionate about my

His keenness as a craftsman saw him producing some exceptional floating ar-

In the year of 1983, on one foreign tourist's description, Najar made a famous Butterfly Houseboat in Nigeen Lake. "It took me four years to complete it," he recalls with a glint in his eyes. "That is one of my masterpieces."

Today, only a few good looking houseboats—a symbol of rich Kashmiri artistry—are left in the lake. And most of them are Najar's creation.

"From once 2500, the number of houseboats has now come down to 915," says Manzoor Pakhtoon, owner of group of houseboats in the Dal Lake. "The houseboat decline can be prevented by supporting the skillful houseboat carpenters, like Najar. These veterans should be engaged in training sessions and workshops, so that the next generation grappling with a biting unemployment could earn their decent living and take their legacy forward."


But inside the houseboat yard, Najar sulks over the state of affairs.

"We're into different times now," he breaks a fleeting silence. "Earlier, foreign tourists knew the value of art and artists. But today, this craft has just become a mere formality." Sadly, even the lake he helped shine with his skill is fast losing

There're rampant constructions going on at certain places right under the nose of the regional authorities. Residential houses, concrete buildings and black tops have already made inroads in the water body. "Dal Lake was once a cleanest water body in the valley, but its slow death and the government's apathy has marred its

beauty," Najar laments.

However, in the lake lacking the yesteryears' buzz and business, the 'wouste' continues to hold the fort. But what happens next, after the master departs and abandons the yard completely, is the question haunting the already distressed houseboat community of Kashmir today.

Scientists Develop Eco-Friendly 3D Printed Polymer Parts From Terrestrial Insects


n international team, including researchers from India, has successfully developed a method of using a compound from terrestrial insects to manufacture eco-friendly polymer composite parts with the 3D printing method.

The researchers, including those from Sri Ramakrishna Engineering College in Tamilnadu, used Chitosan derived from chitin, a compound found in the exoskeletons of arthropods such as insects, as well as in sea creatures such as the shells of crabs.

The 3D printing technology is a form of manufacturing which has become popular in recent times due to its ability to produce complex shapes and geometries difficult to achieve using traditional manufacturing techniques.

As a result, the demand for raw material for 3D printing is on the rise. It is crucial to ensure responsible usage of raw materials for 3D printing to meet the UN Sustainable Development Goal 12, i.e., promoting sustainable consumption and production patterns.

Terrestrial insects are a potential source of chitosan due to their abundance, accessibility, and relatively high chitin content in their exoskeletons.



There are several potential benefits to extracting chitosan from terrestrial insects, including sustainable and ecofriendly production.

Insects are a sustainable source of chitosan, as they can be easily farmed and harvested in large quantities without contributing to environmental pollution.

In contrast, traditional sources of chitosan such as shrimp and crab shells

can be unsustainable and have negative environmental impacts.

The study, published in the Journal of Polymers and the Environment, investigated the feasibility of developing an environmentally friendly composite material using 3D printing technology,

PLA is the most widely used plastic filament material in 3D printing.

The composite material with 0.5 per cent by weight chitin reinforcement had the lowest tensile and flexural

strength compared to other composites produced using additive manufacturing, the researchers said.

The reduction in strength and stiffness of the chitin/PLA and chitosan/ PLA composites, in comparison to neat PLA, was attributed to the decreased interfacial bonding between the reinforcement and matrix, they said.

The chitin/PLA and chitosan/PLA composites demonstrated enhanced ductility relative to neat PLA, with the 0.1 weight per cent chitin composite showing the highest ductility, the degree to which a material can sustain stress.

The study concluded that chitin and chitosan could contribute to toughening the PLA composite.

The team also found that the density of the composites increased with increasing concentrations of chitin and chitosan.

The Chitin/PLA and Chitosan/PLA composites exhibited good thermal stability, and could have potential applications for food product packaging based on their compressive properties, the researchers added.

Other researchers in the study are from Singapore Institute of Technology, Newcastle University in Singapore, Mahidol University in Thailand, and Universiti Teknologi Malaysia.

A Possible New Mechanism Behind **Earth's Self Cleaning Process Uncovered**

Despite the absence of sunlight, special atmospheric conditions could produce hydroxide (OH) molecules, which power atmosphere's self-cleaning mechanism by reacting with pollutants and eliminating them, according to a new study.

The researchers of the study, including one from University of California, Irvine (UCI), US, report that the presence of a strong electric field at the interface of airborne water droplets and the surrounding air can create OH by a previously unknown mechanism.

"You need OH to oxidize hy-

drocarbons, otherwise they would build up in the atmosphere indefinitely," said Sergey Nizkorodov, professor of chemistry at UCI.

"OH initiates the reactions that break down airborne pollutants and helps to remove noxious chemicals such as sulphur dioxide and nitric oxide, which are poisonous gases, from the atmosphere," said Christian George, an atmospheric chemist at the University of Lyon in France and lead author of the study.

A key player in atmospheric chemistry, researchers said that a deeper and fuller understanding of OH sources and sinks is important to mitigating air pollution.

The new mechanism uncovered has been published in the journal Proceedings of the National Academy of Sciences

Before, researchers assumed that sunlight was the chief driver of OH formation.

"The conventional wisdom is that you have to make OH by photochemistry or redox chemistry. You have to have sunlight or metals acting as catalysts," Nizkorodov said.

What this paper says in essence is you don't need any of this. In the pure water itself, OH can be created spontaneously by the special conditions on the surface of the droplets," Nizkorodov said.

After inaugurating a day-long workshop on "Consumer Protection in the northern states" held in Chandigarh, Consumer Affairs Secretary Rohit Kumar Singh emphasized the role of technology in strengthening the consumer protection ecosystem and the importance of infrastructure and human resources

in consumer commissions. The Secretary said, "State heads should ensure that BIS Certification is enforced on required products for consumer safety," an official statement said. He also discussed the time dissemination project by

Indian Space Research Organisation (ISRO) to reduce India's reliance on Western countries for time accuracy. Nidhi Khare, Additional Secretary in the Consumer Affairs Ministry, stressed the use of digital technology to protect consumer rights, reduce the pendency of cases in consumer commissions, and the importance of moving towards

mandatory e-filing. She highlighted the work of the ministry on misleading advertisements, endorsement guidelines, e-commerce platforms, and direct selling guidelines, and urged consumers to be cautious of misleading ads on all platforms. She also made consumers aware of gambling games, products without BIS Certification, and influencers promoting products, the statement added. According to an official source, Singh had mentioned in his letter to the ministry that Covovax is a world class vaccine approved by the DCGI, WHO and USFDA and it should be included on the CoWIN por-



tal as a heterologous booster dose for adults.

RBI Issues Detailed Norms For Outsourcing Of IT Services By Banks, NBFCs

NEW DELHI: Reserve Bank of India on Monday came out with detailed norms for outsourcing of IT services by banks, NBFCs and regulated financial sector entities to ensure that such arrangements do not undermine their responsibilities and obligations to cus-

In its 'Master Direction on Outsourcing of Infor-Technology mation Services', RBI said that Regulated Entities (REs) have been extensively leveraging IT

tomers.

and IT-enabled Services (ITeS) to support their business models, products and services offered to their customers. In February last year, the cen-

tral bank proposed the issuance of suitable regulatory guidelines on outsourcing of IT services with an aim to ensure effective management of attendant risks. Later, draft norms were issued.

According to RBI, the underlying principle of the directions is to ensure that outsourcing arrangements neither diminish REs' ability to fulfil its obligations to customers nor impede effective supervision by the

With a view to provide REs adequate time to comply with the requirements, the norms will come into effect from October 1, 2023.

A RE shall take steps to en-

sure that the service provider employs the same high standard of care in performing the services as would have been employed by the RE, if the same activity was not outsourced, the central bank said.

According to the central bank, a RE should not engage an IT service provider that would result in reputation of RE being compromised or weakened.

Notwithstanding whether the service provider is located in India or abroad, REs should ensure that outsourcing should neither impede nor interfere with the ability of the RE to effectively oversee and manage its activities, as per RBI.

Further, REs have been told to evaluate the need for outsourcing of IT services based on comprehensive assessment of attendant benefits, risks and availability of commensurate processes to manage those risks.

Retail Loan Securitisation Rises 56% To Rs 1.76 Lakh Cr In FY23

NEW DELHI: Retail loan securitisations jumped a robust 56 per cent to Rs 1.76 lakh crore in the just concluded fiscal 2023, while that of wholesale rose to around Rs 6,600 crore, coming out of the pandemic blues finally, says a report.

The secondary market for standard retail assets has seen a robust growth of 56 per cent in FY23, reflecting the resilient retail asset pools in the secondary market as well as the preference of banks to grow their retail assets to meet priority sector lending requirements, according to a Care Ratings analysis. Such robust growth was possible as bank lending to NBFCs grew 32 per cent and there is a positive correlation between interest rate and relative premium for augur well for securitisation market, the agency said.

'We expect the market to continue to grow but at a moderate pace in FY24," senior directors Sanjay Agarwal and Vineet Jain said in a note. The total volume, including direct assignment transactions, rose to Rs 176,000 crore from around Rs 1,13,000 crore in FY22, led by direct assignments which constituted around 61 per cent of the total securitisation market with passthrough certificates (PTCs) making up the remaining volume. The credit quality of retail assets remained resilient, and the total credit growth of banks increased by just over 15 per cent,



while bank credit to NBFCs grew by more than twice that rate.

The two main drivers of growth for the securitisation market continue to be the priority sector lending requirement and the need to expand the retail asset book. The robust growth also shows that the regulatory changes in December 2022 did not have any material impact on the overall volumes except that securitisation volume by fintech lenders were negatively impacted in the second half of the fiscal. With new originators PSL assets. Both these factors from universal banks—up 30 per cent, small finance banks, NBFCs and HFCs coming to the market, driven by higher demand for retail assets. DA transactions dominated the market volume and mortgage-backed securitisation transactions comprised the lion's share of it with 50 per cent. Assetbacked securitisation and microfinance loans constituted around 31 per cent and 19 per cent of the volumes, respectively. DA transactions grew around 49 per cent, while PTC volumes, mainly driven by ABS pools, contributed around 76 percent of the total PTC issuances, with around Rs 42,500 crore coming from vehicle financing, followed by MFI loans contributing around 13 per cent.

Unruly Passengers: DGCA Issues Advisory To Airlines, Reiterates Norms To Deal With Such Incidents

NEW DELHI- Aviation regulator DGCA on Monday issued an advisory to airlines reiterating the existing provisions in place to deal with unruly passengers.

The advisory comes against the backdrop of rising incidents of unruly passengers onboard flights and also on a day when a male passenger was deboarded by Air India from a Delhi-London flight for causing physical harm to two cabin crew members.

In an advisory, DGCA said there are provisions under the Civil Aviation Requirement (CAR) for action to be taken by the airline to deal with unruly passengers.

Besides, it said the responsibilities of pilots, cabin crew members and the director of inflight services are also men-

tioned in the CAR. DGCA said that in the recent past, it has noticed a few inci-



craft, consumption of alcoholic beverages resulting in unruly behaviour, altercations between passengers and sometimes inappropriate touching or sexual harassment by the passengers onboard an aircraft during the flight, wherein "post holders, pilots and cabin crew members have failed to take appropriate actions".

"Such incidents have potential of compromising the safety of aircraft operations," the Directorate General of Civil Aviation (DGCA) said.

The watchdog has advised the heads of operations of all airlines to sensitise their pilots, cabin crew and post holders on dents such as smoking in air- handling of unruly passengers through appropriate means.

The measures can be "but not limited to training programme for ensuring effective monitoring, maintenance of good order and discipline on board the aircraft so that safety of aircraft operations is not jeopardised in any manner," the advisory said.

DGCA regulations provide for classifying unruly passenger behaviour into three levels and such people can face flying ban for varying periods.

Unruly behaviour such as physical gestures, verbal harassment and unruly inebriation are classified as Level 1 while physically abusive behaviour like pushing, kicking or sexual harassment will be classified as Level 2.

Life threatening behaviour such as damage to aircraft operating systems, physical violence like choking and murderous assault will be considered as Level 3.

In Asian markets, Seoul and Japan ended in the green, while Shanghai settled lower.

Rahul Gandhi has ties with 'undesirable business', alleges Ghulam Nabi Azad; BJP asks Rahul to clarify; Cong attacks Azad

New Delhi: Former Congress veteran Ghulam Nabi Azad's allegation that Rahul Gandhi has ties with "undesirable businessmen" triggered a political row on Monday with the BJP asking Gandhi to clarify the "serious charge" made against him.

The Congress hit back at Azad alleging that with every passing day he "falls to new depths" to demonstrate his loyalty to Prime Minister Narendra Modi. Azad's contemptible statements on the Congress' leadership reflect his desperation to remain relevant, the Congress said.

In an interview with the Malayalam News channel Asianet News on Sunday, Azad, referring to the Gandhi family, said,"the entire family has associations with businessmen, including him (Rahul). I can give you 10 examples of where he would go, even outside the country, to meet people who are undesirable businessmen."

Seeking an explanation from Rahul Gandhi over the allegation, senior BJP leader and former Union minister Ravi Shankar Prasad said,"Ghulam Nabi Azad has made a serious allegation that whenever Rahul Gandhi goes on a foreign tour, he meets many 'unwanted businessmen."

"Who are these 'unwanted traders' and what are their interests? Is Rahul Gandhi trying to weaken India at the behest of anti-India businessmen and working against Modi ji (PM Narendra Modi)?," he said at a press conference in Patna.

Prasad also wondered why Gandhi is maintaining a "stoic silence" over the alleged involvement of Congress leaders in "a number of scams".

"Revelations made by Azad are serious in nature... Rahul Gandhi needs to clarify," the senior BJP leader said.

Azad's charge on Sunday came a day after Rahul Gandhi had taken a swipe at some leaders who have quit the Congress in recent years and some of whom have joined the BJP, while keeping up his offensive against the government over the Adani issue.

Hitting back at Azad, Congress general secretary Jairam Ramesh said, "With every passing day, Ghulam Nabi Azad falls to new depths to demonstrate his true character and his loyalty to Mr (Narendra) Modi."

"His contemptible statements on the Congress leadership reflect his desperation to remain relevant. I can only say that he is pathetic," Ramesh said in a tweet

In a sharp counter-response to Ramesh, BJP general secretary (Organisation) BL Santhosh said, "with every passing day you are becoming a bigger trumpeter for 'Emperor without clothes."

Coinciding with the launch of his autobiography, Azad has been giving a series of interviews, slamming the Congress leadership and the party and said one has to be "spineless" to remain in the Congress party.

He also made some disparaging remarks against Rahul Gandhi as he squarely blamed him for his ouster from the party.

Congress leaders from Jammu and Kashmir also hit out at Azad on Monday, saying his criticism is a manifestation of "treachery and highest form of ungratefulness" towards the Nehru-Gandhi family on his part.

"Former Congress LOP in Rajya Sabha should also have counted out of turn' promotions, favours and positions both (official and organisational) he enjoyed during his four decades in power due to Nehru-Gandhi family's blessings and trust reposed in him," Ghulam Ahmad Mir, Saifuddin Soz and Tariq Hameed Karra said in a joint statement.

Hailing from a remote area of the Doda district, Azad was recommended by late Mufti Mohd Sayeed to Madam Indira Gandhi, who made him a youth leader without any political background or fan following, they said.

"Then he (Azad) was rewarded with a party ticket to contest the Lok Sabha elections from Maharashtra where Madam Gandhi herself campaigned and ensured his victory by a thumping majority, with the result he made his entry in Lok Sabha for the first time.

"Since then, the Nehru-Gandhi family, whom Azad is now targeting, made a sea of opportunities available for him. He was elected to the Rajya Sabha many times, subsequently made the Union minister a number of times without facing elections,

which he should also count while speaking against the Gandhi family," the statement stated.

Azad, who floated the Democratic Progressive Azad Party after quitting the Congress, had recently said that Rahul Gandhi was the primary reason why he and many others had left the party and claimed it was not in the hands of Congress Parliamentary Party chairperson Sonia Gandhi or even party president Mallikarjun Kharge to ensure his return to the party fold even if they wanted.

The Congress leaders said Azad was defaming the party to create confusion among the masses in view of the Gandhi scion's constructive role and the appreciation he was receiving for "fighting the battle against crony capitalism and organised loot of the nation's wealth on the part of the Narendra Modi government".

Meanwhile, Priyanka Gandhi Vadra also came out in support of her brother saying she is proud of her brother who faces injustice with dignity and won't back down from the truth no matter how many desert him.

Preventive Detention Laws Colonial Legacy, Must Be Used Only In Rarest Of Rare Cases: SC

New Delhi: Preventive detention laws in India are a colonial legacy with a great potential to be abused and must be used only in the rarest of rare cases, the Supreme Court said on Monday.

The top court said courts must analyse cases arising from such laws with extreme caution to ensure there are checks and balances on exercise of power of the government.

A bench of Justices Krishna Murari and V Ramasubramanian made the observations while setting aside a detention order for a man accused in a gold smuggling case.

"Preventive detention laws

"Preventive detention laws in India are a colonial legacy, and have a great potential to be abused and misused. Laws that have the ability to confer arbitrary powers to the state, must in all circumstances, be very critically examined, and must be used only in the rarest of rare cases.

"In cases of preventive detention, where the detenue is held in arrest not for a crime he has committed, but for a potential crime he may commit, the Courts must always give every benefit of the doubt in favour of the detenue, and even the slightest of errors

in procedural compliances must result in favour of the detenue," the bench said.

The apex court said every procedural rigidity must be followed in entirety by the government in cases of preventive detention, and every lapse in procedure must give rise to a benefit to the case of the detenue.

"The Courts, in circumstances of preventive detention, are conferred with the duty that has been given the utmost importance by the Constitution, which is the protection of individual and civil liberties.

"This act of protecting civil liberties is not just the saving of rights of individuals in person and the society at large, but is also an act of preserving our Constitutional ethos, which is a product of a series of struggles against the arbitrary power of the British state," the bench said.

The top court's judgement came on an appeal filed by Pramod Singla challenging an order of the Delhi High Court which had rejected his plea to quash the detention order against him on the grounds of delay in considering his representation.

J&K To Have American

Gadkari told reporters here.

The minister was in the union territory to attend the second meeting of the Parliamentary Consultative Committee on Road Transport and Highways.

Gadkari said when the BJP government was formed at the Centre in 2014, we prepared a roadmap for road infrastructure in Jammu and Kashmir

"Since then we have undertaken projects worth Rs 1.25 lakh crore in Jammu and Kashmir Once these projects are complete, the tourist footfall to Jammu and Kashmir will increase by four times. People go to Switzerland, our J&K is more beautiful," Gadkari said.

The minister said Jammu and Kashmir administration has identified 13 acres of land for creating roadside facilities for tourists.

"The tourism increase will lead to job creation for locals. In the coming few years, we will take the road network of Jammu and Kashmir to American standards," he added.

In an announcement focusing on pilgrim tourism, Gadkari announced plans for construction of a tunnel between Sheshnag and Panjtarni on the Amarnath yatra route which, he claimed, will reduce the yatra time from the current three days to just nine hours.

"A 110 kilometre road from Khanabal to Panjtarni will be constructed for the ease of Amarnath yatris at a cost of Rs 5,300 crore. The DPR for 73 km stretch from Khanabal to Chandanwari will be done in July 2023.

"The DPR for a 37 km stretch from Chandanwari to Baltal via Panjtarni at a cost of Rs 3,500 will be done in October this year. A 10.8 kilometre-long tunnel will be constructed between Sheshnag and Panjtarni," the minister said.

According to the minister, the Srinagar Ring Road (from Galander in Pulwama district to Ganderbal district), which is being constructed at a cost of Rs 4,660 crore, will ease the traffic congestion and pollution in the city.

Further, the minister made the announcement of construction of a tunnel at Pir Ki Gali on Mughal Road, connecting Poonch in Jammu region to Shopian in the Valley.

"The Rs 6,000 crore project includes a Rs 5,000

crore tunnel at Pir ki Gali, which comprises the construction of an all weather road," he said.

He gave details of the ongoing road projects in the union territory, saying it will reduce the

travel time on most routes.
"Tunneling on the Jammu-Srinagar corridor has reduced the distance by nearly 20 per cent. The travel time has already been reduced to 5.5 hours (between Jammu and Srinagar). It can be reduced further by two hours once the ongoing works on the remaining five tunnels are com-

plete," he added. With inputs from PTI **'Zojila Tunnel**

of central Kashmir, to Minimarg, in Drass town of Kargil district of Ladakh, is 13 km long with an approach road of 18 km.

Gadkari said the estimated cost of the project was Rs 12,000 crore, but, after discussions with experts and international consultants for a year, its cost was brought down by Rs 5,000 crore.

"This is the first time in the history of our country that we have a saving of Rs 5,000 crore as far as the estimated cost is concerned. This is a very difficult task, the people are working here in minus 26 degrees," he said.

This is to be a state-of-art-project and with the cooperation of J-K LG Manoj Sinha and his administration, it will be very helpful for us, he said.

Laying out a roadmap for connecting several cities across the country, Gadkari said the Zojila tunnel is one of the important things of "our dream to connect Kashmir to Kanyakumari". This will be connectivity between north to south, he added.

He also applauded engineers and contractors, saying it is very difficult to work here.

The union minister said about 38 per cent of the work has been completed, and a part of the project will be inaugurated this year for providing relief to the people.

"With the permission of the prime minister, the LG, we want to try to inaugurate a part of the project because that will give relief to the people," he said.

According to Harpal Singh, Project Head of Megha Engineering and Infrastructure Ltd, which is constructing the project, the total length of the project from Sonamarg to Minimarg is 31 km. From Sonamarg to Baltal, it is 18 km, and then the main tunnel from Baltal to Minimarg is 13 km long. The work is going on at a rapid pace on both projects.

Gadkari said the project once completed would develop tourism in the area.

"The tourism in Kashmir will be increased 3-4 times and tourism is a sector which creates maximum employment avenues," he said.

"I have requested LG and JK government to plan resorts, and adventure sports, and just like Switzerland, we can develop a lot of things here, he said.

People are already coming here, Baba Amarnath road is here, so we can increase the tourism potential here, which will create more employment potential for the people of J-K. It will eradicate the poverty in Ladakh and J-K, the minister added.

He said former prime minister AB Vajpayee at the time of the Kargil war, visualised that we should have a good road between Ladakh and Srinagar.

"This is under the leadership of prime minister Narendra Modi that we have started this and we are hopeful that we will get this tunnel (completed) as early as possible," he said.

Asked about its significance in terms of

defence forces on the Indo-China border, Gadkari said while he would not like to comment on the defence point of view, the project is very important because the previous war the country fought was Kargil, for which the tunnel will provide all-weather connectivity.

"So, this is the area we are going to develop and there will be no migration of the people and the most important thing is this will be the world attraction just like Switzerland and people from India and abroad will come here for tourism and it is going to increase the employment potential in this area which will be a great thing," he added.

To a question on developing airstrips near the country's borders, the minister said the government is working on 29 road-cum-airstrip projects, out of which nine have been completed.

"Somewhere, we need permission from the airforce, it is in the process. At the time of emergency, we can use those," he said.

Asked once the breakthrough of the tunnel is achieved, would the army be allowed to travel on the rough tunnel if need be, Gadkari said whatever has to be done at the time of emergency, it will be done at that time.

"In times of emergency and in the interest of the country, a result is achieved with positivity. There has not been a such need, and there is no possibility of such need, but, if there arises a need, then we will surely do what our defence forces say," the union minister said.

Later, the minister inspected the work progress on the Z-Morh tunnel, and announced it will be inaugurated in October this year. "We will inaugurate Z-Morh tunnel in October. This will help the people a great deal and also help increase tourism, and employment opportunities," Gadkari said.

During the event, JK LG Manoj Sinha requested the union minister that local youth be given more employment opportunities in the project. The minister assured Sinha that the contractor has been directed to provide maximum employment opportunities to the local youth.

India will meet Australia at the Oval from June 7-11 for their second consecutive appearance in a World Test Championship final.

Laxman, as the head of NCA, is not only overseeing the rehabilitation module of centrally contracted in-

Perks Of BCCI's Honorary Job: First Class Travel, Suite Room & USD 1000 Per **Day On Foreign Trips**

NEW DELHI: An office bearer of the all-powerful BCCI will now be paid a daily allowance of USD 1000 on foreign tours and will fly first-class.

The increase in allowances doled out to the BCCI office bearers was tabled in the Apex Council meeting on Sunday but came into effect last October. The per diem (daily allowance) has been revised after more than seven years. Earlier, the officer bearers of the world's richest board used to get USD 750 per day on overseas tours.

The office bearers, including the president, vice-president, secretary, treasurer and joint-secretary, will be also be entitled to Rs 40,000 per day for meetings within India and business class travel, according to the BCCI document accessed by PTI. For 'work travel', they will be paid Rs 30,000 a day. room both on domestic and of IPL chairman has also been bracketed in the office-bearers' category.



Council, including two representatives from the Indian Cricketers' Association, will get Rs 40,000 per day for their quarterly meetings and USD 500 on overseas tours. However, it is usually the office bearers who travel overseas for work.

The board has also revised They can also book for a suite the allowances for the members of its state units who will overseas trips. The allowances now get Rs 30,000 per day during domestic travel and USD 400 on foreign travel.

which picks the head coach of both men and women national teams, will be paid Rs 3.5 lakh each for meetings. Foreign travel is unlikely in their case but each of them is entitled to an amount of USD 400 per day for this.

It is to be noted that a BCCI office bearer's post is an honorary one. Its well-paid employees like the CEO will get a daily allowance of USD 650 on foreign tours and Rs 15,000 per day within India.
