# Ministry Report Paints Grim Picture Of J&K's Water Bodies 'Over 23% Water Bodies In J&K Have 'Dried Up, Beyond Repair'

Srinagar: The maiden survey released by the Ministry of Jal Shakti has presented a dismal picture of the water bodies in ammu and Kashmir, revealing that over 23 percent of them have 'dried up and are beyond repair',

According to the first Census of Water Bodies released by the Ministry, there are over 24 lakh water bodies across the country, and over 9,700 water bodies in J&K, of which over 76



per cent are 'in use'. As per the census, a total of 9,765 water bodies have

been enumerated in J&K, out of which 99.2% (9,687) are in rural areas and the remaining

0.8% (78), are in urban areas, noting that the majority of the water bodies are ponds.

The water bodies include 5256 ponds, 179 tanks, 37 lakes, 441 reservoirs, 29 water conservation schemes/percolation tanks/ check dams and 3832 others.

"Out of 'in use' water bodies, a major proportion of water bodies are used for domestic/ drinking purposes followed by irrigation purposes," the report says.

The report further revealed

encroachment in 103 water bodies out of all the enumerated water bodies, out of which 95 are ponds

Out of all water bodies, 1.2% (122) are covered in the District Irrigation Plan/State Irrigation Plan.

Among these 44.3% (54) are reservoirs, 31.1% (38) are ponds and the remaining 24.6% (30) are tanks and water conservation schemes/percolation tanks/check dams. Out of 'in use' water bodies, 93.0% (6,968) are benefitting one (01) city/town, 6.8% (510) water bodies are fulfilling requirements of 2-5 cities/ towns and the remaining 0.2% (15) water bodies are benefitting more 177 than five (05) cities/towns.

The census was launched under the centrally sponsored scheme, "Irrigation Census" in convergence with the 6th Minor Irrigation Census in order to have a comprehensive national database of all More on P6

### **NIA Attaches Properties Of Hizb Chief's Sons**

Srinagar: Investigation Agency (NIA) on Monday attached a house and two kanals of land belonging to Hizbul Mujahideen chief Syed Salahudeen's two sons in Jammu and Kashmir's Budgam and Srinagar districts, officials said.

A team of NIA officials first attached a house in Ram Bagh area here registered in the name of Syed Ahmed Shakeel, son of Salahudeen, they said.

"The house, registered in the revenue records in the name of Syed Ahmad Shakeel, was attached by the NIA on court orders under the Unlawful Activities (Prevention) Act," an NIA official said.

Later, the team went to Soibugh in Budgam district, the ancestral place of Salahudeen, and attached a plot of agricultural land measuring two kanals (10,880 square feet), the officials said.

The land is registered in the name of Salahudeen's another son, Shahid Yusuf.

Notice boards announcing the attachments were installed at both the premises by the NIA sleuths.

Besides, the NIA also seized six shops in Awantipora area of Pulwama district in a case relating to a 2018 attack on CRPF Group Centre at Lethpora, J&K.

In a statement, the NIA said it attached two properties of the sons of designated terrorist Syed Mohammed Yusuf Shah @ Syed Salahudeen, the selfstyled Supreme Commander of Hizb-Ul-Mujahideen (HM) and Chairman of United Jihad Council (UJC).

"The immovable properties of Shahid Yusuf and Syed Ahmed Shakeel, located in Kashmir in Soibugh Tehsil, Distt. Budgam and Nursing Garh, Mohalla Ram Bagh, have been attached under section 33(1) of UA(P) Act," the NIA said.

# Over 40 Detained, More Troops Join Search Ops

Jammu: Over 40 persons have been detained for questioning as part of a massive operation currently underway to track down the militants involved in the Poonch attack, officials said on Monday.

Additional troops have been inducted to further intensify the cordon-and-search operation (CASO) in Bhata Dhurian-Tota Gali and neighbouring areas. As the operation entered fourth day on Monday with engagement of multiple security agencies, the entire belt is put under cordon, they said.

Five Army personnel were killed and a sixth was seriously injured when their vehicle caught fire during a militant at-tack in Jammu and Kashmir's Poonch on Thursday.

According to the investigation, the militants likely hid in a culvert on a stretch of the Bhimber Gali-Poonch road before they attacked the truck that was

carrying army jawans, officials

A sniper is believed to have targeted the army truck from front before his associates showered bullets and lobbed grenades at it from opposite sides, apparently giving the troops no time to retaliate, they added.

"Militants used steel core bullets that can penetrate an armoured shield," officials said, adding, "before fleeing, the militants also stole soldiers' arms and ammunition."

The armoured vehicle was found riddled with more than 50 bullet marks, they said.

During the search operation, troops came across a few natural cave hideouts in the area, which could possibly have been used by the militants in the past, they said, adding the troops are also looking for any improvised explosive devices (IEDs) militants may have planted in the densely forested areas. # TWG Meeting In J&K Will Be An **Important One: Tourism Secy**





# **NASA Scientists Identify New Stellar Danger To Planets**

stronomers using data from NASA's Chandra Xray Observatory and other telescopes have identified a new threat to life on planets like Earth: a period during which intense X-rays from exploded stars can affect planets over 100 lightyears away.

The finding, published recently in The Astrophysical Journal, has implication for the study of planets outside the solar system and their habitability.

This threat comes from a supernova's blast wave striking dense gas surrounding the exploded star. When this impact occurs it can produce a large dose of X-rays that reaches an Earth-like planet months to years after the explosion and may last for decades, the researchers said.

Such intense exposure may trigger an extinction event on the planet, they said.

The study is based on X-ray observations of 31 supernovae and their aftermath-mostly from NASA's Chandra X-ray Observatory,



Swift and NuSTAR missions, and ESA's XMM-Newton—showing that planets can be subjected to lethal doses of radiation located as much as about 160 light-years away.

If a torrent of X-rays sweeps over a nearby planet, the radiation could severely alter the planet's atmospheric chemistry, the researchers said.

For an Earth-like planet, this process could wipe out a significant portion of ozone, which ultimately protects life from the dangerous ultraviolet radiation of its

host star, they said.

It could also lead to the demise of a wide range of organisms, especially marine ones at the foundation of the food chain, leading to an extinction event, according to the study.

After years of lethal X-ray exposure from the supernova's interaction, and the impact of ultraviolet radiation from an Earth-like planet's host star, a large amount of nitrogen dioxide may be produced, causing a brown haze in the atmosphere, the researchers said.

A "de-greening" of land masses could also occur because of damage to plants, they said.

Among the four supernovae, SN 2010jl has produced the most X-rays. The authors estimate it to have delivered a lethal dose of Xrays for Earth-like planets less than about 100 light-years away.

There is strong evidence-including the detection in different locations around the globe of a radioactive type of iron-that supernovae occurred close to Earth between about 2 million and 8 million years ago. Researchers estimate these supernovae were between about 65 and 500 lightyears away from Earth.

Although the Earth and the solar system are currently in a safe space in terms of potential supernova explosions, many other planets in the Milky Way are not, according to the researchers.

These high-energy events would effectively shrink the areas within the Milky Way galaxy, known as the Galactic Habitable Zone, where conditions would be conducive for life as we know it, they said.

# **Big Push For Opposition Unity**

he Opposition unity in India received a fresh push during the Monday meeting between West Bengal Chief Minister Mamata Banerjee, Bihar Chief Minister Nitish Kumar, and RJD chief Tejashwi Yadav. In her address to the media, Banerjee emphasized the need for all like-minded parties to come together and fight the ruling BJP unitedly in the upcoming 2024 Lok Sabha elections.

The idea of Opposition unity in India is not just about defeating the BJP, but it is also about offering a viable alternative to the people of India. The BJP, which won a decisive victory in the 2019 Lok Sabha elections, has turned out to be politically invincible, with prime minister Narendra Modi at the helm.

Opposition parties in India have always found it challenging to come together due to ideological differences, personal egos, and a lack of trust. However, the recent developments suggest that some parties are now willing to put aside their differences and work towards a common goal. Mamata Banerjee, who in recent past had grown averse to the idea of Opposition unity, is now actively pushing for it, and her recent meetings with other Opposition leaders indicate that she is seri-

The meetings between Banerjee, Kumar, and Yaday, are significant as they represent a coming together of parties from different regions and ideological backgrounds. Nitish Kumar, who heads the Janata Dal (United), has been a BJP ally for several years, but his recent statements suggest that he is determined to forge a united opposition front against the BJP. Tejashwi Yadav's RJD is a major player in Bihar, and his support will be crucial for any Opposition alliance in the state.

However, the road ahead for Opposition unity is not going to be easy. The Congress, which is the largest Opposition party in the country, has been accused of being a hindrance to such unity. Several regional parties are wary of joining hands with the Congress, and there is a growing feeling that the Congress needs to take a backseat and allow other parties to take the lead. The recent meetings between Mamata Banerjee and other regional leaders suggest that there is a growing consensus that the Congress needs to play a supporting role in any Op-

Opposition unity is not just about coming together before the elections; it is about building a long-term alliance that can offer a viable alternative to the BJP. It will require a lot of effort and trust-building among parties that have been bitter rivals for years. However, the meeting between Mamata, Kumar, and Yadav, and before this between Kumar and Rahul Gandhi followed by a meeting betwen Gandhi and Sharad Pawar, offer a glimmer of hope that Opposition unity is possible in India. If Opposition parties can put aside their differences and work towards a common goal, they can offer a better challenge to the otherwise entrenched BJP.

# It Is A Welcome Initiative

t a time when stressed aquifers pose difficult ecological, economic and policy challenges — including for the government's flagship scheme of providing drinking water to every household — the significance of this database cannot be overstated. With details on the size, encroachment status and storage capacity of the water bodies, the report could help policymakers arrive at informed decisions on matters as diverse as urban

planning and rural employment generation schemes. The Centre has been conducting a census of minor irrigation structures every five years since 1986. Much of the data indirectly compiled from the population Census by government agencies has also focused on minor irrigation works. The irrigation-centred approach was, to an extent, a fallout of the inclination of successive governments to view tanks, ponds and canals as economic utilities, rather than critical resources for human and ecological well-being. In the past two decades, there have been some attempts at course correction. The UPA government, for instance, launched the Repair, Renovation and Restoration of Water Bodies scheme in 2005 and MGNREGA works have focussed on reviving traditional water bodies. But the lack of a comprehensive database has meant that these projects have not done sufficient justice to their objectives. The significance of the current study is underscored by the fact that it counted nearly five times the number of repositories enumerated by the last minor irrigation survey in 2013-14. The past studies did not have much data on urban centres. The enumeration of tanks, lakes and other water sources in cities and towns was left, largely, to civil society outfits and academic institutions. Such endeavours did provide valuable insights into the depletion of lakes in cities such as Hyderabad, Ahmedabad, Chennai, Srinagar and Bengaluru. The government's

entry into the field is sure to make the data richer. That said, such enumeration initiatives will not do adequate justice to their objectives if they remain top-down affairs. Making panchayats, municipalities and other local bodies the nodal points for future water body surveys as well as roping in civil society groups in the endeavour could help policymakers arrive at a better picture of the water crisis, and frame solutions.

In Fact all the international days related to climate, environment, ecology, water, forests have very catchy themes every year but I always wonder are the world bodies, institutions including the UN really serious about protecting the planet earth? The theme Invest in our Planet emphasizes the importance of investing in planet earth for a sustainable future, but are we, especially the governments across the world, really serious about this? Are governments seriously thinking about the future? At a time when our mother earth is facing serious climatic challenges, it demands immediate action as well. In Fact there is a great role of NGOs, individuals, business community and corporates as well, but unless governments don't act seriously, commemorating the days like World Earth Day, World Environment day with some attractive themes are meaningless. My experience and observation is that actions of the Govt bodies are altogether different when it comes to protecting the planet earth from environmental destruction? I have experienced this during the last 10 years while working in the sustainability sector in Kashmir and observing environmental disasters taking place before my eyes. Government's across the world especially in South Asia are more concerned about promoting the corporates rather than ecology or environment. The Govt's in Himalayan states have to be more cautious while building roads, highways, railways and tunnels through high altitude mountains and around the glaciers. While doing this they must think about the mountain ecosystem as well. The recent landslides and shooting stones coming down from mountains around Srinagar Jammu highway should be an eye opener for our construction companies.

Investment in Kashmir

The best investment in Kashmir is investing for a clean and green Kashmir by ensuring massive plantation drive, strengthening our agriculture and horticulture sector, controlling plastic pollution, undertaking scientific waste management programmes, cleaning up lakes, rivers and streams and not going ahead with massive concrete constructions like making huge highways and roads around high altitude areas and glaciers. This type of investment will have long lasting benefits for Jammu & Kashmir which includes economic, social, and environmental benefits. Investing in sustainable initiatives in J&K and other Himalayan states of India like Himachal, Uttarakhand, Ladakh, North East India will also lead to economic growth, create jobs, and promote social equality. It will also help in conserving natural resources and protecting the ecology and environment of the region. By investing in sustainability sectors like organic agriculture and horticulture practices, renewable energy and ecotourism in J&K and other Himalayan states will lead to economic growth as well. It will create job opportunities in different sectors such as clean energy, green transportation, and sustainable tourism. The growth of this sector will also increase the demand for green jobs and will create opportunities for innovation and entrepreneurship in the sustainability sector. **Controlling Riverbed Mining** 

During the last three to four years the Riverbed Mining (RBM) has destroyed our river ecosystems across J&K. Not only are our rivers targeted but even the small streams are being mined for riverbed material like sand, gravel, boulders etc and for this huge cranes, JCBs are being used which are not at all allowed as per J&K Minor Mineral Concession Rules of 2016 & Specific Condition No. 53 of State Environmental Impact Assessment Authority which provides environmental clearance for riverbed mining. The riverbed

mining rules stress on manual mining and giving jobs to local labourers. The guideline no 53 says JCBs, Hydraulic excavators, L&T excavators cannot be used in river bed mining (RBM) at all. The guideline reads

'Mining shall be done manually minimally supported by semi-mechanized methods. Heavy machinery like JCBs, Excavators, L&T hydraulic excavators etc should not be allowed. Emphasis should be given to locally available labour force to address socio economic condition of locals"

There is not even a single riverbed mining block across J&K where minerals are extracted manually by labourers. In every river and stream one can see huge hydraulic cranes and JCBs being used for this work. The excavation is done in broad daylight and the Geology and Mining Department, State Environment Impact Assessment Authority (SEIAA) have been unable to put an end to this illegal practice. This author reported these illegal practices several times but have been ignored. In Fact I had to move a petition before the National Green Tribunal (NGT) who banned this work in the Shali Ganga stream in Budgam. The construction company challenged the order in the Supreme Court and I had to fight this battle in the apex court as well. Ironically, National Highways Authority of India (NHAI) became party to this case in Supreme Court and supported the stand taken by the construction company NKC Projects Pvt Ltd which is constructing Srinagar Semi Ring Road. I only wanted the company to follow its DPR and Environmental Management Plan (EMP). Infact there is no mention about extracting RBM from Shali Ganga or

streams are meant for providing riverbed material (RBM) to local population in 2 kms radius and at 50 % discount rates, but the material is sold to construction companies which is completely illegal practice.

It has to be understood that these guidelines have actually been proposed by the Ministry of Environment, Forests & Climate Change (MoEFCC) Govt of India. The Supreme Court of India & National Green Tribunal (NGT) as well have given several orders in this regard. Infact, guideline No.71 says that mineral blocks cannot be sublet to third parties without written approval from state environmental impact assessment authority (SEIAA) but in a majority of the cases the Project Proponents have already sublet the work to 3rd parties in J&K.

#### **Destruction of Karewas**

I have written a lot about Karewas in the past. Their destruction is quite visible now in many parts of Pulwama, Budgam and Baramulla districts. We owe a lot to the fortune of Kareawas which are the plateau-like landforms that remain tucked away in the folds of the surrounding mountains, particularly the Pir Panjal range of the Himalayas that borders the valley on the southwest. Known as karewa or Wodder in local dialect, these plateaus are 13,000-18,000 metre-thick deposits of alluvial soil and sediments like sandstone and mudstone. This makes them ideal for cultivation of saffron, almonds, apples and several other cash crops.

In the past Karewas were plundered during construction of Qazigund Baramulla rail line. Now again they are targeted as a huge amount of clay is being excavated by construction company NKC for filling the agricultural land, wetlands, Jhelum flood plains enabling construction of 58 kms Srinagar Semi Ring Road project between Pampore to Ganderbal via Budgam

Narbal. There is no clay mining plan for clay mining in J&Ks karewas. The excavations are done without obtaining any Environmental Clearance (EC) from J&K State Environment Impact Assessment Authority (JK SEIAA).

Huge poclain cranes, JCB's

L&T Machines are excavating the clay and soil and the same is transported in trucks (tippers) & used at construction sites between Pampore and Narbal. This also emits huge dust which causes air pollution and destroys the road surfaces in most of the areas in Budgam. This has also affected the apple, plum and other fruit orchards as huge dust has destroyed the flowers of these fruit trees because dumping of muck and clay during the last one month has affected these trees. The aggrieved farmers need to be compensated. The clay mining mafia has destroyed state land near Karewas and even the proprietary land of people is being targeted in their absence. The Government is not able to even generate any revenue during clay mining on state land. Very recently a large patch of Karewa land (2 acres aprox) owned by one Ghulam Hyder who originally hails from Budgam but has been living in Delhi for the last 30 years was raised to ground as illegal clay mining has destroyed his proprietary land during the last 3 to 4 months. He went to the police and administration but he didn't get any help even as the site is just 1 kms away from Police Station Budgam and the District Mineral Office

is also located nearby.

The State Environmental Impact Assessment Authority -SEIAA, J&K Pollution Control Committee (PCC), Geology & Mining Department and several other Govt institutions are all well aware about illegal riverbed mining, clay mining in Karewas and other activities in Jammu & Kashmir which are causing destruction of our environment, but they never act and instead become collaborators in these illegal practices. When these environmental bodies, Govt institutions talk about sustainable development or commemorate days like world earth day or world environment day etc, I call it a sheer mockery and a ridiculous activity? When it comes to protecting our ecology and environment the authorities at helm in mountain states have to be more cautious and that is why i say that best investment in Kashmir is to do investment in sustainable development.

# Wrath of Climate Change

As scientific predictions become reality, the emergency is becoming palpable, indisputable, and widespread, with dramatic weather events reported with an ever-increasing frequency. Such patterns have disastrous, far-reaching effects on the natural world, global food supplies, health, infrastructure, and more. The climate disaster is here with soaring heat across Jammu, erratic weather phenomenon with increasing and devastating cloud bursts, and flashfloods in Jammu and Kashmir leading to deaths and damage to property

worth lakhs. Scientific studies indicate that extreme weather events such as heat waves and large storms are likely going to become more frequent or more intense with this human-induced climate change.

J&K is a mountainous area, which is very susceptible to global warming and climate change. Climate change and warming are global trends, and their impact on Jammu and Kashmir is significant. In the last few months, especially in July 2022, we have witnessed increasing cloud bursts and Flash Floods. Devastating cloud bursts hit the Balthal (Songmarag), Doda, Poonch, Kathua, and many other districts in Jammu and

Kashmir leading to deaths, injuring many, and damaging property. Erratic rainfall, snowfall patterns, and unusually warm winters are some of the characteristics of climate change in Jammu and Kashmir.

According to a report, the temperature in Jammu and Kashmir has risen by an average of 1.2 degrees Celsius against a global increase of 0.8 to 0.9 degrees Celsius over the last 100 years. The increasing average temperature has resulted in melting glaciers and greater precipitation, which could lead to disaster in the state. The early snowfall, heat waves

in winters, cloud bursts, and Flash Floods in summers are indicators of Climate change in Jammu and Kashmir and the effects of climate change are already being felt in the Kashmir valley. The 2014 devastating Flood caused by the cloudburst was the first indicator of global warming in Jammu and Kashmir.

According to a report prepared by the State Disaster Management Authority, since 2010, many flash floods and cloudbursts which have hit J&K resulted in the killing of 300 people. In 2022 alone cloud bursts killed almost 40 people and injured many in Jammu and Kashmir. The revenge of Climate change is increasing and we should act

to prevent this increasing wrath.

As climate change continues, it will likely lead to more frequent and severe natural hazards. The impact will be heavy. Climate change causes poverty and food shortages and forces even higher numbers of men, women, and children to flee their homes. The increasing disasters speak for themselves. Policymakers, humanitarian and development organizations alike need to address, prevent and lessen the fatal impact of climate change before it's too late.

ow long do you spend staring at a screen every day? According to one report, the average person spends about seven hours a day on screens connected to the internet. And that figure is going to be even higher if your job is mainly done in front of a computer.

Most of us over-use digital devices, spending too long either working or enjoying being distracted on phones, tablets, laptops or even VR headsets. We are accused of being addicted to tech and warned of the dangers to our physical and mental health.

One significant paradox here is that we often retreat into the digital world to escape the stresses of the physical world, but can end up simply collecting other kinds of digital and physical stress along the way.

As a parent, I became concerned a few years ago about the effect my digital life was having on my work and family. I did some research of my own, changed the way I used my devices and even wrote a book about the dangers of what I call the "digital inferno".

It's only in recent years that longer-term studies have been published on the issue. And taken together, these studies comprise a growing and significant body of knowledge, that is hard to dismiss or ignore: too much tech can cause issues for us humans.

To be clear, digital devices offer significant benefits – think connection, education, entertainment. The danger is when our overuse of them be-

comes toxic to our health.

From a personal perspective, eye strain, neck ache, poor sleep, stress, repetitive strain injuries of all kinds and impaired hand function are just a few of symptoms I've had over the years thanks to my overuse of screens and devices – and research shows I'm far from alone.

If any of these symptoms describe you (or anyone you know), or you just feel too much of your life is taken up with staring at a screen, then you might find my advice on how to regain control of your tech helpful.

# How to regain control 1. Practice Putting Down Your Digital Devices Consciously

Reep them out of sight and put them away when you aren't using them, especially at night. Banish them from the bedroom, get an alarm clock (so you aren't using your phone alarm) and you'll sleep better without the late-night scrolling. And get out of the habit of watching TV with your phone next to you. Just focus on one task at a time without the distraction of another screen.

### 2. Set Yourself Screen Time Limits

Too much screen time can give you headaches. Be mindful of the way your use your tech and make use of features like voice notes, which allow you to stay up-to-date with communication without staring at a screen for a long time

3. Stop Allowing Digital



Distractions

Constant interruption can induce physical and mental stress. Turn off notifications and alerts when you want to fully focus on a task. And keep your phone off your desk. Research shows that having your phone nearby, even if it's not

buzzing or ringing and even if the power is off, can hurt your performance.

#### 4. Schedule Proper Digital-Free Time

Depression and anxiety is one result of digital overload. So getting away from

your digital world for a while is important. Take a walk in nature, read a book, go for a bike ride – anything that takes you away from the screens for a while.

5. Make Screens Easier On The Eyes Screen overuse can strain our eyes and affect our eyesight. Don't squint at tiny screens to do work that would be better done on a larger-screen laptop. Reduce the blue light on devices and make use of all the other helpful accessi-

bility features. Start with that

screen glare. And also make sure the volume doesn't burst your ear drums.

### 6. Take Control Of The Chaos Of Information Overload

Organise your phone, computer and tablet so you can use them more efficiently. Some apps really do help you take charge of your life and work more calmly and effectively. Time-tracking apps measure how much time you're spending (wasting) on your screen – prepare to be horrified! We regain mastery over our digital devices when we become more proactive in

#### 7. Sit Well When You Are Digitally Engaged

Slouching over a phone or hunching over your laptop will harm your neck and your back. Sit upright, stretch regularly and exercise often – without your phone.

### Be A Digital Decider

These seven tips should help you regain a sense of control over your digital life. For me, it's all about sleeping and waking better after leaving my phone downstairs. It's about having dedicated, planned digital time and specific times when the phone has no place in what I'm doing.

Yet it's also about enjoy-

# IIM Survey Finds Mann Ki Baat Has Reached 100 Crore Listeners

New Delhi: Nearly ninety six percent of the population is aware of Prime Minister Narendra Modi's monthly radio programme Mann Ki Baat.

The programme has reached 100 crore people who are aware and have listened to the programme at least once. These statistics were revealed in an exhaustive study commissioned by Prasar Bharati and conducted by Indian Institute of Management, Rohtak. The findings of the study were brought out in a press conference by Gaurav Dwivedi, CEO, Prasar Bharati and Dheeraj P. Sharma, Director, IIM Rohtak.

Sharma, speaking about the findings of the study further said that 23 crore people tune in to the programme regularly while another 41 crore constitute an occasional audience that has the scope of being converted into a regular audience.

The report delves into the reasons behind the popularity of PM's radio broadcast and lists out the most liked characteristics that hook people to the broadcast. A powerful and decisive leadership that speaks to establish an emotional connect with the audience is cited as reason for the following of the programme. The Prime Minister has been credited by the population of the country as knowledgeable and having sympathetic and empathetic approach. Directly engagement with the citizens and guidance is also cited as a reason for the trust the programme has established.

The study has tried to gauge the impact Mann Ki Baat has Communication style of the host (Hon'ble PM of India)

had on the population over the 99 editions so far. It states that a majority of listeners have become aware of governments working and 73% are optimistic and feel the country is going to progress. 58% of listeners have responded saving their living conditions have improved while a similar number (59%) have reported increased trust in Government. The general sentiment towards the Government can be gauged from the fact that 63% people have said their approach to the Government has become positive and 60% have shown interest in working for nation building as per the survey.

The study distributes the audience across 3 platforms

with 44.7% people tuning in to the programme on a TV while 37.6% access it on a mobile device. Viewing the programme is favoured over listening to it, as 62% of the respondents between the age of 19 to 34 preferred watching it on a TV.

Hindi grabs a major chunk of listeners of Mann Ki Baat with 65% audience preferring it over any other language while English comes in at second place with 18%.

Speaking about the profile of respondents, Director Dheeraj Sharma informed that the total sample strength of 10003 was polled for this study of which 60% were males while 40% were females. This population was spread over 68

occupations sectors with 64% being from the informal and self-employed sector while students constituted 23% of the studied audience.

Sharma further said that Data was collected from North, South, East, and West regions of India using snowball sampling with approximately 2500 responses per zone, through a psychometrically purified survey instrument

Gaurav Dwivedi informed the audience that apart from 22 Indian languages and 29 dialects, Mann Ki Baat is broadcast in 11 Foreign languages excluding English namely, French, Chinese, Indonesian, Tibetan, Burmese, Baluchi, Arabic, Pashtu, Persian, Dari and Swahili. He said the Mann ki Baat is being broadcast by more than 500 broadcast centers of All India Radio.

Going into the thought process behind commissioning of the study, Dwivedi stated that that from time to time there was a thought that we must get more well-rounded feedback in terms of the overall programme and not for particular episodes only. He further informed that while digital sentiment on Mann Ki Baat is readily available, the same is not in the case with traditional media due to certain limitations. With this perspective, the task of the survey was awarded to IIM Rohtak on 18th April, 2022.

About Mann Ki Baat:

The popular program on All India Radio, Prime Minister's Mann Ki Baat was started on 3rd October, 2014 and is broadcast on last Sunday of every month at 11 AM on entire AIR and DD network. The 30 -Minute program is completing 100 episodes on 30th April 2023. Mann Ki Baat is translated by AIR into 22 Indian languages, 29 dialects and 11 Foreign languages, apart from English. It includes Hindi, Sanskrit, Punjabi, Tamil, Telugu, Kannad, Marathi, Gujarati, Malayalam, Odiya, Konkani, Nepali, Manipuri, Kashmiri, Dogri, Maithili, Bengali, Assamese, Santhali, Sindhi. It provides a comprehensive inventory of India's water resources, including natural and man-made water bodies like ponds, tanks, lakes, and more, and to collect data on the encroachment of water bodies.

The census also highlighted disparities between rural and urban areas and varying levels of encroachment and revealed crucial insights into the country's water resources.

The census has cited that out of 2036 ponds that are not in use, 974 are dried up, 21 have turned into construction, 19 because of salinity, 193 are destroyed beyond repair, one each is affected due to industry and salinity, and 827 are others.

The report further reveals that there are 36% (3,519) natural and 64% (6,246) man-made water bodies. Out of 3,519 natural water bodies, 99.5% (3,502) are located in rural areas whereas the remaining 0.5% (17) are located in urban

"Out of 6,246 man-made water bodies, 99% (6,185) water bodies are located in rural areas and the remaining 1% (61) are located in urban areas. Most of the man-made water bodies have original cost of construction up to Rs.50,000/," it noted.

As per the census, out of 9765 water bodies, 3519 are natural, and 6246 are man-made.

According to the census, 9209 water bodies in J&K, and Ladakh have never been repaired. Only 115 water bodies were repaired before 2009. In 2009, 11 water bodies were repaired; 51 in 2010; 20 in 2011; 34 in 2012; 71 in 2013; 38 in 2014; 59 in 2015; 24 in 2016; 54 in 2017; 34 in 2018, and 45 were repaired after 2018.

The census further reveals that over 2272 not-in-use water bodies in J&K and Ladakh, including 2026 ponds, 29 tanks, 6 Lakes, 26 reservoirs, 6 water conservation schemes/percolation tanks/ check dams, and 169 others. Further, out of 9765 water bodies, 5016 are public owned, and 4749 are privately owned.

public owned, and 4749 are privately owned. As per the census, 7431 water bodies are in use in rural areas, out of which 718 are used for irrigation, 12 for industrial, 97 for pisciculture, 5935 are for domestic/ drinking, 19 are recreation, 49 are for religious, 129 are for groundwater recharge, 472 are others.

In the urban area, 62 water bodies are in use, one for irrigation, 51 for domestic/drinking, 7 for religious, and 3 for others.

The information on all important aspects of the water bodies including their type, condition, status of encroachments, use, storage capacity, status of filling up of storage, etc was collected. It covered all the water bodies located in rural as well as urban areas that are in-use or not in-use.

The census also took into account all types of uses of water bodies like irrigation, industry, pisciculture, domestic/ drinking, recreation, religion, ground water recharge etc. Census has been successfully completed and the All India and State-wise reports have been published.

are lodged in Delhi's Tihar Jail since their arrests in October 2017 and August 2018. They were chargesheeted on April 20, 2018 and November 20, 2018, respectively. The duo had been receiving funds from abroad from the associates of their father and overground workers of HM, it added.

Salahudeen, who had fled to Pakistan in 1993, was designated as an individual terrorist by India in October 2020. He continues to operate from Pakistan, from where he is guiding and instructing Hizbul cadres as well as activists of UJC, also known as Muttahida Jihad Council (MJC) which is a conglomerate of around 13 Pakistan-based Kashmir centric terror outfits.

Besides instigating and operationalising militant activities in India, primarily in Kashmir valley, Salahudeen has been raising funds and routing finances to India through hawala channels and international money transfer channels for furthering the militant activities of HM cadres.

The NIA launched investigations in November 2011 into the criminal conspiracy to raise/collect/provide funds to commit militant acts and distribute funds among the groups and their sympathizers in J&K for the purpose of "committing terrorist acts".

The Special Cell of Delhi Police had initially registered a case in January 2011 and the case was subsequently taken over by the NIA. Chargesheets as well as supplementary chargesheets were filed against eight accused in the case, including in 2011 and 2018.

In Gulmarg, there will also be a technical session on the promotion of film tourism, he added.

Representatives of various states, the film industry, producers and others will be there and those from the states will share information about their film tourism policies, Singh said.

India is currently chairing the influential bloc and more than 200 meetings will be held across 55 locations, culminating with the annual G20 summit on September 9-10.

### **Nothing Wrong In** Dr Farooq's Remarks On Poonch Attack: JKPCC Chief

**JAMMU:** There was nothing wrong in the remarks of National Conference president Farooq Abdullah on the recent militant attack on an Army vehicle in Poonch, Jammu and Kashmir Congress chief Vikar Rasool Wani said on Monday.

He also said former J-K governor Satya Pal Malik's recent disclosures, especially with regard to the 2019 Pulwama suicide attack, exposed the BJP's "fake nationalism" and demanded an inquiry.

"I don't think Farooq (Abdullah) Sahib has said anything wrong. The casualties of the security forces are the outcome of security lapse. First it was said that lightning struck the (Army) vehicle (in Poonch) and later it was confirmed that a militant attack had taken place," Wani told reporters at the party headquarters here.

He was responding to a question about BJP's criticism of Abdullah over his statement that top security officials should look into the lapses that led to the killing of five soldiers in the militant attack.

"The area (where the attack took place) is closer to the border. There must be a security issue which they need to check. There has been a mistake somewhere, they should look into it They have started operations in Pooch and should not harass or arrest innocent people," Abdullah had said.

The BJP reacted angrily to Abdullah's statement with its senior leader and former deputy chief minister Kavinder Gupta saying that "Abdullah accused investigation agencies of harassing common people in the name of the Poonch terror attack probe. He should not mislead the people and rather ask them to join the probe to punish the culprits as soon as possible.

Wani said after Malik's recent sensational disclosures on Pulwama suicide attack that claimed the lives of 40 CRPF personnel in February 2019, people are thinking who was behind the deadly incident which might have been done for election benefit.

There should be an inquiry to make things clear," the J-K Pradesh Congress Committee (JKPCC) president said, ruing the silence of Prime Minister Narendra Modi on the matter. Wani said the Congress conthe RSS and the BJP.

demned the Poonch attack in strongest terms. "We lost five soldiers...I am living in Banihal along the Jammu-Srinagar national highway and if we stop conducting searches or road opening patrol duties, anything can happen.'

"When tight security protection is in place, many attempts by terrorists to carry out blasts on the highway were thwarted with timely detections of explosive devices. So when there is information about movement (of terrorists), it is the duty of the government to ensure security," he added.

Wani also said the Gandhi-Nehru family was the worst victim of terrorism with two former prime ministers, Indira Gandhi and her son Rajiv Gandhi, losing their lives to the menace, while hundreds of Congress, National Conference and PDP workers were killed by terrorists in J-K over the past three decades.

"If they (BJP) blame us for terrorism, it is their frustration. We have faced terrorism and will continue our fight against it," he said.

The Congress leader accused the BJP of deceiving people in the name of nationalism over the past nine years and said Malik's disclosures about the Pulwama terror attack exposed the "fake nationalism" of the saffron party.

"He (Malik) is telling the truth and people now understand the BJP very well. The day is not far when the Congress will emerge strong once again across the country. We will sweep upcoming assembly elections in Karnataka and will also emerge number one in J-K," he said.

Meanwhile, District Development Council (DDC) member, Kulgam, Anayatullah Rather returned to the Congress fold after leaving the Democratic Progressive Azad Party (DPAP) led by Ghulam Nabi Azad.

"Rather, a former general secretary of JKPCC, had joined Azad as a founding member of his new party under his influence. All of those who have joined him are returning because they have secular ideology," Wani said.

He alleged that the DPAP is internally linked to the BJP, asserting it was quite evident when Azad recently showered praises on Modi and opposed Rahul Gandhi at the behest of

# **Nomads Continue Annual Migration** To Kashmir's Upper Reaches

**QAZIGUND:** Keeping their centuries old tradition alive and with rise in daily temperature, the bi-annual seasonal migration of Gujjars and Bakerwals from Jammu's forest plains to Kashmir's high pastures is in full swing.

Every year, lakhs of people from nomadic tribes, mainly the Gujjars and Bakerwals, migrate to the Valley when temperatures soar in the plains of Jammu in April-May before returning ahead of the onset of winter.

Liyakat Ali, a tribal on seasonal migration to Kashmir said that their family has started to shift towards highland pastures Kashtradition.

He said that they used to face a lot of problems during their journey. The government has now provided them with transport facilities which he described as a positive measure for his community.

"We are thankful to LG Manoj Sinha-led administration for introducing transport services for tribal people which reduced 300 kilometers on-foot journey of four weeks to just 1-2 days", he said.

The government introduced

the transportation service for migratory tribal families, covering the journey on National Highway, Mughal Road and other major roads.

"More than 16,000 migratory tribal families benefitted last year after spending summer months in Kashmir pastures and being brought back in trucks to their destination in various districts of the Jammu division", an official said.

He said the transportation system put in place by the Tribal Affairs Department has reduced the travel time from 20-30 days on foot to 1-2 days while it has also helped in smooth traffic management.

Musheer Ahmed rector, Tribal Affairs department said they have kept vehicles available for nomadic community but tribal people prefer journey on foot as they have using pastures enroute for fodder of their animals.

He said it is an old traditional and seasonal practice and it takes them around one month to reach their respective places.

"We have been contacting I&K Road Transport Corporation to provide vehicles so as to take them from one place to another

whosoever contacts us", he said. Principal Chief Conservator of Forests for J&K, Mohit Gera said that the forest department is the nodal department under forest right act for tribal communities.

"We have our forest for fodder programme under which fodder production is being increased besides that forest product and some medicinal plants are being gathered by tribal people,"

Last year the government had sanctioned a policy for sustainable collection and utilization of non-timber forest products under which tribal people will get

He said that the forest department along with other d ments are working together for the welfare of tribal communities and their claims are being looked into by the Deputy Commissioner concerned and grass production is being increased in forests and routes used by tribal communities.

"We have been providing grass and seeds for non forest areas as well while units are being established in forests," he said. adding that land is specially kept for grass where they are getting this grass," he said—(KNO)

# **Farmers Turn Bhaderwah Town Into** 'Capital Of Lavender'

JAMMU: A 33-year-old resident of Bhaderwah town in Doda district of Jammu and Kashmir claims to have helped at least 2,500 farmers in Chenab region to increase their income manifold by switching from traditional maize and paddy farming to lucrative lavender cultivation.

Touqeer Bagban, a resident of Mohalla Vasuki Dhera in Bhaderwah town, belongs to a farmer's family and owns a cedar wood extraction oil unit. "I always wanted to uti-

lise local available natural resources to create jobs and provide profitable livelihood avenues for the small and marginal farmers," Bagban said.

Touqeer, a class 12 dropout, got inspiration from a workshop organised by IIIM (Indian Institute of Integrative Medicine) in 2014 and convinced his family to switch from traditional farming of growing maize and paddy to cultivation of aromatic plants.



His 74-year-old father Gaffar Bagban is well aware of the medical and aromatic plants grown widely in high altitude Himalayan mountain. Gaffar also encouraged his son to engage locals in lavender farming.

Inspired by his father's ideas and subsequent IIIM workshop, Touqeer started motivating and encouraging other farmers to start cultivating aromatic and medicinal plants.

"Initially, I found no taker for my ideas and it seem a herculean task to make it possible from switching to the new way of farming,"

Touqeer said. He travelled extensively in the lengths and breadths of the region to promote his ideas and convince farmers to switch to the new crops.

"I even offered and assured farmers that I will bear all the losses if they don't find growing of aromatic and medicinal plants profitable in comparison to their traditional crops,"

The farmers gradually began to switch from traditional crops.

Tougeer added.

In 2016, the Ministry of Sciences and Technology along with CSIR-IIIM started Aroma Mission and the initiative started gaining momentum.

As a result, presently 2,500 families are growing exotic lavender and Bhaderwah has become the leading producer of lavender in India.

After seeing the interest and success story of the farmers, he said Bhader-

wah was not only named as the capital of lavender in India but the Union government also included lavender under the 'One District One Product' for promoting the crop in Doda district. Union minister for sci-

ence and technology Jitendra Singh installed 11 lavender distillation units in Bhaderwah.

Tougeer, after resounding success of bringing purple revolution and becoming instrumental in making Bhaderwah the capital of lavender in India, has ventured in value addition of locally grown aromatic plants.

"We have been getting rave reviews for our products from the word of mouth as lavender soap. rosemary soap, balm, incense sticks, hair oils and sanitizers are selling like hot cakes," he added.

Touqeer's venture has also helped more than 100 women find livelihood by working in lavender fields and nurseries.

Lavender flowers grow in temperate areas and are drought-resistant.

We will not accept any their protest in January, former wrestler and now BJP affiliate Babita Phogat had mediated between the aggrieved wresters and the government.

However it seems that wrestlers are not happy with the way Babita, who was part of the government's oversight panel, conducted herself.

"Maybe she loves politics more than the wrestling now," Vinesh said, while taking a jibe at her cousin sister. Sakshi said their legal team was contemplating approaching the apex court.

"We will go to the Supreme Court. If we are wrong in levelling the allegations, then a counter FIR should be filed against us," she said.

**MANCHESTER:** Year-end exams don't come much tougher than the one facing Erik ten Hag and Manchester United.

The Dutch manager was hired to return the storied club to its former glories after a decade of decline. Against Manchester City in the FA Cup final he will get the chance to show how far United has come in his first season in charge.

While a one-off match cannot judge an entire campaign, the contrast in emotions for United's fans will be stark depending on the outcome.

A win on June 3 would not only secure a second trophy for Ten Hag — after the League Cup — but also serve as a statement of intent that he is building a team ready to go head-to-head with City, perhaps as soon as next season.

Defeat wouldn't necessarily

directly block City's attempt to emulate that feat will likely be an extra incentive.

"I understand, of course, the feelings from the Man United fans about it," Ten Hag said Sun-

United beat Brighton 7-6 on penalty kicks after the FA Cup semifinal match at Wembley ended 0-0 through extra time.

On Saturday, City made light work of second-division Sheffield United in a 3-0 win, also at the national stadium.

This will be the first time the Manchester rivals have played each other in the FA Cup final, but there are parallels to be drawn with the semifinals match between them in the same competition in 2011.
