New Injectable Cell Therapy To Treat Osteoarthritis Developed

cientists have developed a new injectable cell therapy to treat osteoarthritis that they say reduces inflammation and also regenerates the cartilage.

Osteoarthritis affects over 520 million people worldwide who deal with pain and inflammation. It is typically induced by mechanical or traumatic stress in the joint, leading to damaged cartilage that cannot be repaired naturally.

"We studied what goes wrong in osteoarthritic joints, compared these processes to functional environments, and used this information to develop an immunotherapy cell treatment,' said lead author Johanna Bolander of Wake Forest Institute for Regenerative Medicine (WFIRM) in the US.

Osteoarthritis is a disease of the joint system. The joint includes a synovial membrane a connective tissue that lines the inner surface of the joint. The membrane functions to protect the joint and secretes a lubricating fluid filled with cell elements needed to maintain a healthy environment and to provide friction free movement.

In healthy joints when an injury occurs, the body recruits an army of inflammatory cells and sends them to the injury site to contribute to cleaning of the damaged tissues.

However, in the osteoarthritic joint, a traumatic injury leads to inflammation of the synovial membrane and cartilage damage.



"With time, the inflammation worsens, leading to degradation of the cartilage lining the joint bones and chronic inflammation in the surrounding tissues. For patients, this causes severe pain, swelling and often limits daily activities," said study co-author

Gary Poehling, an orthopedic surgeon at Atrium Health Wake Forest Baptist. The study, published in the journal

Science Advances, set out to investigate what is taking place in the osteoarthritic joint environment that keeps the healing process from happening.

The team isolated cells from the joint fluid of osteoarthritic patients, separated the cells from the fluid and investigated them alone, but also in the presence of the autologous fluid. Separated from the fluid, they saw

is known about functional tissue rethat the cells had the ability to underpair, a cell therapy was designed that can overcome the inflammatory environment and also regenerate cartilage.

"Cartilage activated immune cells that target inflammation, combined with progenitor cells aid tissue regeneration," said Anthony Atala, senior author and director of WFIRM.

"It's really a dynamic communication between these two cell populations that are crucial for the efficacy of the treatment," Atala said.

The combination of cells leads to simultaneous treatment of several of the aspects involved in osteoarthritis: synovial inflammation, cartilage degradation, subchondral bone sclerosis and innervation of pain sensory neurons.

The therapy was tested in a preclinical model and was found to have the ability to reverse cartilage damage in the synovial membrane and diminish the inflammation as well.

To evaluate clinical efficacy, a compassionate use study was conducted in nine patients with confirmed osteoarthritis who each received one or two injections.

Efficacy was evaluated through scoring of pain and functional living, MRI scans pre- and post-treatment and a biopsy from one patient was obtained.

Once treated, the patients experienced improved quality of life, ability to participate in recreational activities, and reduced pain, the researchers said.

Additionally, MRI studies confirmed cartilage regeneration, they added.



While extending warm greetings on the occasion, the DC expressed hope that this


Swami Saraswati told PTI that special prayers were aimed at fostering a sense of brotherhood and love among the people in the valley.

Sayeed, Mangat Clash At Cabinet Meeting

AMMU - Deputy Chief Minister Mangat Ram Sharma snubbed Chief Minister Mufti Mohammed Sayeed at a cabinet meeting here Tuesday, telling him he was not a "headmaster" who could dictate terms to his seniors in politics.

Sharma walked out of the cabinet meeting in a huff, the second time he has done so in the past 16 months. He later flew to New Delhi, telling reporters he would apprise the Congress party leadership about Sayeed's "dictatorial behaviour

Cabinet meeting was later postponed to April 22. On Jan 24, almost in similar circumstances. Sharma walked out of a cabinet meeting on being overruled on the appointment of Kashmir's senior most Indian Administrative Service officer KB. Pillni as chairman of the State Public Service Commission.

Ultimately, Sharma had to relent and reconcile to the choice of the chief minister.

Tuesday's walkout followed a verbal duel between the two over the use of 'improper' language by Sharma while conversing with Chief Secretary Sudhir S Bellorla.

The meeting was to discuss a major administrative and police reshuffle in the state.

Sayeed termed Sharma's conversation with the chief secretary as 'improper.

'You should not use such language with the chief secretary,' Sayeed told Sharma in the presence of the entire cabinet and some top officials

Sharma allegedly told Belloria 'kar do Jl' (do it) instead of

'kar deejlye' while marking the agenda for the day. Sayeed corrected him in front of the cabinet after which the deputy chief minister replied that he did not have to be (taught how to deal with the bureaucracy. Sharma told Sayeed: "I am senior to you in politics by 11

years. You cannot treat me like a headmaster, and I am leaving."

Sharma then burst out of the meeting Sayeed, the sources said, rubbed salt into Sharma's wounds by saying: "If you want t0 go, no one is going to stop you." He suggested that Congress President Sonia Gandhi should be informed about this incident. Chief Minister was quoted as saving. "How can the govt run amid this indiscipline?"

Let Mideast Peace **Inspire South Asia**

he world is witnessing a significant shift in glob-al power dynamics, with China's influence on the rise while the United States' dominance continuing to wane. China's recent offer to mediate peace talks between Israel and Palestine is just one example of its growing role in regional diplomacy and global leadership. As the United States' involvement in conflicts such as the Iraq and Afghanistan wars has led to more conflict than solutions, China's approach of encouraging dialogue and cooperation may prove more effective in addressing longstanding rivalries in Middle East.

If anything, China's sudden proactive effort to broker solution to entrenched conflicts reveals its ambition to position itself as a global peacemaker, a role traditionally reserved for the United States. The Gulf countries are recognizing that the United States may no longer be the most reliable security guarantor, and they are trying to diversify their portfolio of external partners, which has enhanced the geopolitical agency of the regional countries. With China expanding its footprint in the region, the unilateral dependency on the US diminishes.

China's recent diplomatic offensive in brokering the restoration of ties between Iran and Saudi Arabia shows clearly that it is becoming much more than an economic powerhouse and is adopting a more proactive foreign policy. The launch of the Chinese Global Security Initiative further highlights China's efforts to rebrand its international role as a responsible and great power.

China's rising position as a global leader is evident by the huge influx of state leaders lining up to meet Premier Xi Jinping. Leaders from Spain, France, Singapore, Malaysia, and the European Union have all met with the Chinese leader, despite Beijing's unwavering support for Russia. China's renewed influence in the Gulf has not gone unnoticed, and it has been recognized by the UK-based thinktank Chatham House in a recent report.

China's offer to mediate peace talks between Israel and Palestine is a testament to its growing influence and potential as a global leader. Its diplomatic efforts to resolve regional conflicts are expected to be more effective in achieving long-term peace than the involvement of the United States as a global policeman. The peace that follows a China-mediated productive engagement among the estranged Gulf countries could potentially lead to stronger ties and cooperation among them, establishing Beijing as a global peacemaker.

As China's influence continues to rise, the world can expect to see a shift in the global power structure, with China playing a more significant role in regional diplomacy and global leadership. The United States must adapt to this changing landscape and find ways to work collaboratively with China to achieve common goals, including peace and stability in the Middle East. In South Asia, we should try and emulate the West Asia peace effort. This alone will guarantee regional prosperity and, of course, connectivity in a region where almost one-fourth of the global population lives. At the same time, if China's wants to be taken seriously as a global peacemaker, it has to try and mend fences with India. cease aggression and seriously address the lingering border issue.

Lost Peace Process

The late S K Lambah's book, which discusses the promising peace process between India and Pakistan during 2003-07, leaves one with a sense of regret for what could have been accomplished

PORTHODIS IN COMPLEX PRIME PLACE

n his book, 'In Pursuit of Peace,' the late Indian diplomat S K Lambah provides a comprehensive account of the behind-the-scenes efforts to secure peace between India and Pakistan by resolving Kashmir, their decades old bone of contention. Lambah was a skilled diplomat who had access to all shades of political leaders in Pakistan. The "accord" reached by the two countries on Kashmir aimed to make borders irrelevant without redrawing them, with key elements such as bus services between two parts of Kashmir already in play during Manmohan Singh's term as Prime Minister. However, this was not to be, and hostilities continue to dominate the relationship between India and Pakistan. Lambah's book documents the inability of diplomats from both countries to reach a mutually beneficial agreement that would ultimately allow their people to live in harmony.

The book also highlights the possibilities for peace that presented themselves over the past quarter century, including the Delhi-Lahore bus service that began in 1999, the visit of Prime Minister Atal Bihari Vajpayee to Islamabad in 2004, General Pervez Musharraf's visit to India in 2005, and the near-reopening of consulates in Mumbai and Karachi, among others.

However, the current state of affairs is far from promising, with no direct flights, hardly any visas issued, and no bus or train services between the two countries. Lambah notes that India-Pakistan hostilities have become an instrument of political mobilization and that the painful memories of partition are being revived. He rightly points out that hate is the guiding political philosophy of both countries today, and as long as this remains the case, no channel, front or back, will work.

Overall, "In Pursuit of Peace" offers a glimpse into the complexity of the relationship between the two countries and the challenges that must be overcome to achieve lasting peace.

That said, Lambah's book is the second on the promising 2003-07 peace process between India and

tween the two nations was underpinned by a sustained back-channel contact, first between Tariq Aziz and Brijesh Mishra, then Aziz and J N Dixit - who allegedly first broached the idea of an "out-ofbox-solution to Kashmir" to Kasuri – followed by the one between Aziz and Satinder Lambah.

What transpired during these years has since been told and repeated. The broad outlines of the contemplated solution - no border re-adjustment, demilitarization, self-governance, and joint mechanism - are now a common knowledge. The book offered a new perspective by delving into greater depth and providing more comprehensive details than had previously been available.

For example, Pakistan had agreed to withdraw troops from the part of Kashmir controlled by it after India demanded a quid pro quo for doing the same on this side of the border. And the two countries had agreed to conclude an "agreement within one year over reduction of troops and the process of demilitarization".

Kasuri credited Pakistan for the progressive decline in militancy in Kashmir during the period. According to him, Pakistan had set up centres to wean away militants through a process of DDR -De-radicalization, Disengagement and Rehabilitation.

The rest is history. The agreement could not be concluded. The lawyers' agitation and Musharraf's slipping grip on power towards the end of 2007 ensured that the agreement remained confined to non-papers. Then Prime Minister Manmohan Singh's expected visit to Pakistan - first in 2006 and then in March and May 2008 - to sign the deal was indefinitely put off and never again seriously contemplated. In August 2008, Musharraf exited the scene and the backchannel couldn't be sustainably re-established since.

The situation has considerably transformed since, and almost in every sense: regionally in terms of the growing power disparity between India and Pakistan, and in J&K too, which has since been divested of its special status and downgraded into two federally controlled units, in other words, two union territories.


Human Soul: The Sole Source of Universal Spirituality

The Science Behind Motion Sickness

y first experience with motion sickness was as a col-Lege student, standing on the back of a marine research vessel looking at interesting things dredged from the seafloor off the California coast. It was a day trip, the weather was good and the sea was calm. I was unaware of the boat's gentle pitching and rolling, instead concentrating on the mud and organisms on a table in front of me.

Then, slowly I began to feel warm and to salivate. I felt exhausted, although I was well rested. There were intense waves of nausea, and I began vomiting. It was a long afternoon. Once back on shore, I felt as if I were still moving. I didn't feel back to normal until the next day.

In retrospect, this was the perfect situation for a bout of motion sickness. I was focused on my immediate environment – the table covered with ocean specimens – which was visually stable. My eyes were unaware that we were, in fact, shifting up, down and side to side with the waves. But my inner ear was signaling all of this movement to my brain. Sensory signals from the muscles and joints of my body were providing information that was like a cross between the visual input from my eyes and the balance feedback from my inner ears' motion detectors.

In short, my senses were in conflict. I was in an environment that conflicted with a lifetime of expectations about how sensory information usually combined to inform me about the world. My brain recognized something was wrong and attempted to save me from things that it was designed to deal with - poisoning or other illness. To my brain, emptying my stomach contents and forcing me to rest and recuperate seemed the perfect solution.

For me, this event preceded a lifetime of work studying the vestibular system, which are the inner ear and brain structures and functions that allow you to remain oriented and stable in space. In my laboratory, my colleagues and I reproduce these kinds of complex motions and conflicting sensory inputs and study how the brain uses them during development, in normal adult behavior

and in disease. Ultimately, we hope to produce treatments for people who are disabled by a loss or disruption of these senses.

MISMATCH OF A GREAT SYSTEM AND UNUSUAL SITUATION

Any moving environment can trigger motion sickness. It's not usually



due to illness or pathology. Instead, motion sickness is the result of your nervous system functioning optimally, based on what it's learned throughout your life.

When processing sensory information and generating motor commands, the brain constantly monitors and adjusts its inputs and outputs to perform the tasks of life efficiently. For example, to see clearly while turning your head, your brain moves your eye opposite and equal to the motion of your head. It does so based on feedback from the sensors in your inner ear that focus on balance. Your brain constantly monitors this reflex behavior, making continual adjustments to make sure that your eye and head movements match perfectly.

The efficiency of this system is based on experience and outcome, and it works well. It helps you get better at coordinating your movements and maintaining your balance while you're growing, and helps you recover from imbalance and disorientation due to injury, illness and aging later in life.

The downside of this process is that the nervous system is unprepared for things with which it has no experience. It explains in part why astronauts experience transient nausea while adapting to weightlessness, why sailors get seasick and why watching a movie on your iPad in the back seat of a car or playing an immersive virtual reality video game may become unpleasant. Human beings did not evolve as a species to do these things.

So someone who is motion sick is really exhibiting skillful and optimized functioning in a uniquely challenging and suboptimal environment.

CHANGES OVER THE LIFE SPAN

Typically, infants and very young children do not experience motion sickness. Older children are highly prone to motion sickness as they learn typical relationships between the different senses.

TECHNIQUES TO DEAL WITH MOTION SICKNESS

If you experience motion sickness, there are several strategies you can use to feel better.

The first is to resolve the conflicting sensory information that your situation is creating. Look at an Earth-stabilized reference – focusing at the shore or horizon if you are on a boat, for example, or moving to the front seat in the car and looking out the window. This way, you align the incoming visual and inner-ear vestibular information.

The second strategy is to reduce the information that is causing the conflict. There are several medications that work by suppressing inner-ear vestibular information, and others that change the way that sensory information is processed centrally in your brain.

You can also try to prevent the output of this conflict. Essentially, you can sabotage the central nervous system's attempts to save you from your situation by short-circuiting the mechanisms that produce the motor response of vomiting. Taking anti-nausea drugs reduces nausea without necessarily resolving the sensory conflict that induced it.

You can eventually adapt, through repeated experience, to many novel situations. When your brain learns a new normal, it allows you to function with fewer unwanted symptoms in the challenging environment. For example, NASA is developing preconditioning countermeasures to allow astronauts to transition from Earth's gravity to the weightlessness of space more quickly and with fewer symptoms of motion sickness.

Studies like these will extend the range of environments in which human beings can function and allow us to explore and ultimately live in what are, to us, novel and new worlds.

Pak Raises Kashmir At **UN, India Hits Back**

'Will Not Waste Council's Time In **Responding To Such Mischievous** Remarks: Indian Ambassador'

United Nations: India tore into Pakistan after it raised the issue of Jammu and Kashmir at a Security Council meeting here, prompting India's permanent ambassador to the United Nations Ruchira Kamboj to assert that she would not waste the Council's time by respond-ing to such "mischievous" remarks.

Kamboj's stern response to Pakistan came in her remarks at the UN Security Council open debate on "Maintenance of international peace and security: Effective multilateralism through the defence of the principles of the Charter of the United Nations" chaired by Russia, President of the Council for the month of April.

With Russian Foreign Minister Sergey Lavrov presiding over the debate, Pakistan's Permanent Representative at the UN Munir Akram referred to Jammu and Kashmir in his statement.

"Lastly, this august forum has today heard some mischievous remarks by a permanent representative arising purely out of ignorance and lack of an un-derstanding on the basic facts

of decolonisation," Kamboj said on Monday.

"I will not be wasting the time of this Council in responding to those remarks. Our advice to that delegation is please refer to our numerous rights of reply that we have expressed in the past," she added.

Pakistan consistently rakes up the issue of Kashmir at various UN platforms, irrespective of the agenda and topic of dis-

cussion at the meetings. Tensions between India and Pakistan spiked after New Delhi abrogated Article 370 of the Constitution to revoke the special status of Jammu and Kashmir on August 5, 2019.

India's decision evoked strong reactions from Pakistan, which downgraded diplomatic ties and expelled the Indian envoy. India has categorically told

the international community that the scrapping of Article 370 was its internal matter.

It also advised Pakistan to accept the reality and stop all anti-India propaganda. India has told Pakistan that it desires normal neighbourly relations with Islamabad in an environment free of terror, hostility and violence

Their personal mobile phones with inbuilt SIM cards were also seized. Accordingly, a case was registered and an investigation initiated, he said.

During the investigation, another co-accused - Sozeith resident Aqib Jamal Bhat -- was apprehended and on the basis of his disclosure, an improvised explosive device (IED) he had allegedly hidden in a pit near the railway track at Rangreth was recovered.

The IED was destroyed on the spot by a bomb disposal squad, the police spokesperson added.

Investigations established that the three accused allegedly worked as militant associates for two militants Momin Gulzar Mir and Basit Ahmad Dar and under a well-knit criminal conspiracy, were providing logistics support to them, he added.

J&K Govt To Revive Traditional Millet Cultivation On 8,000 **Hectares Of Land**

JAMMU: The Jammu and Kashmir administration has set a target to revive the cultivation of traditional millet crops on 8,000 hectares of

land in the Union Territory. The process will begin by providing seeds of seven varieties of millets to the farmers with 100 per cent subsidy in 10 districts of Jammu region.

The administration in February this year also approved a Rs 15-crore project to prop up nutri cereals, besides promoting and enhancing millets production and consumption in the Union Territory.

The project aims to revive traditional millet growing in around 8.000 hectares of land and double the productivity per-hectare from 10 to 20 quintals, the officials said.

The project, to be implemented over a period of three years, aims to promote cultivation of millets, increase their value addition and generate entrepreneurship opportunities for farmers, additional chief secretary at Agriculture Production Department Atal Dulloo said.

As part of the project, the agriculture department has earmarked an area of 1,400 hectares for growing millets and farmers are being provided seeds with 100 per cent subsidy.

"The year 2023 is the international year of millets. In Jammu division, the agriculture department has earmarked 1,400 hectares for the production of millets. We have seven different varieties of millets. We are going to provide seeds to farmers on 100 per cent subsidy around 10 districts of Jammu division," Joint Director, Agriculture(Input), A S Reen told PTI.

He said these seeds are water-re-

silient and good for wetlands (Kandi land). "We have selected the areas and will distribute the seeds to farmers soon. It is a high-value crop and its export demand is very high," he said.

Reen said that if a farmer wants to start a small processing plant, the government is providing Rs 4 lakh to Rs 5.25 lakh subsidy.

"We are also promoting Millet restaurants and providing Rs 2 lakh subsidy to them for introducing millet-based food," he said.

Millets are known as the "miracle grains" or "crops of the future" due to their resilience to climate change. They can grow in drought-prone areas and do not require large amount of water or external inputs, making them an ideal crop for small scale farmers in Jammu and Kashmir, the officials said.

The Centre is actively promoting the cultivation, processing and marketing of millets and in the past declared 2018 as the 'National Year of Millets'.

The United Nations General Assembly, following a request from the Indian government, has declared 2023 as the 'International Year of Millets' to raise awareness about the health benefits and sustainable production and consumption of millets.

Dulloo said the government is also focusing on creating awareness about millets among the farming community.

"Despite growing awareness and popularity of millets, their production and consumption is still limited and there are several challenges that need to be addressed. One of the significant challenges is the lack of awareness and knowledge about millets among farmers and consumers," Dulloo said.
