CBI Grills Ex- Guv Malik For 5 Hours Over Bribe Claim


New Delhi: The CBI questioned former Jammu and Kashmir governor Satya Pal Malik for nearly five hours Friday in connection with its probe into the alleged insurance scam in the Union Territory which came to light after his statement that he was offered bribes to clear related files, officials said.

A Central Bureau of Investigation (CBI) team arrived at the Som Vihar residence of Malik in the R K Puram area of the national capital around 11.45 am to seek clarifications over his claims, they said.

Officials said the exercise continued for nearly five hours during which several questions were lobbed at him about the claims made in his statements recorded with the CBI last year.

This is the second time in seven months that Malik, who served as governor of various states, was quizzed by the CBI.

Officials, however, clarified that Malik is not an accused or a suspect in the case so far.

His statement was recorded in October last year after he concluded his gubernato-rial responsibilities in Bihar, Jammu and Kashmir, Goa, and Meghalaya.



Study Sheds Light On Role Of Glucose In Brain Activity

esearchers have shed light on how neurons, or nerve cells, consume and metabolise glucose, as well as how these cells adapt to glucose shortages.

The researchers from Gladstone Institutes and UC San Francisco (UCSF), US, said that the new findings could lead to the discovery of new therapeutic approaches for those diseases and contribute to a better understanding of how to keep the brain healthy as it ages.

'We already knew that the brain requires a lot of glucose, but it had been unclear how much neurons themselves rely on glucose and what methods they use to break the sugar down," says Ken Nakamura, associate investigator at Gladstone and senior author of the study published in the journal Cell Reports.

Many foods we eat are broken down into glucose, which is stored in the liver and muscles, shuttled throughout the body, and metabolized by cells to power the chemical reactions that keep us alive.

Scientists had proposed that glial cells, or cells found in the tissue of the central nervous system, consume most

of the glucose and then fuel neurons indirectly by passing them a metabolic product of glucose called lactate. However, the evidence to support this theory had been scant.

Nakamura's group provided more evidence in this regard by using induced pluripotent stem cells (iPS cells) to generate pure human neurons. This had been hard so far for scientists to generate cultures of neurons in the lab that do not also contain glial cells.

Then, the researchers mixed the neurons with a labelled form of glucose that they could track, even as it was broken down. This experiment proved the ability of neurons to take up the glucose themselves and process it into smaller metabolites.

Using CRISPR gene editing, the researchers removed two key proteins from the neurons to investigate how they were using metabolised glucose products. While one of them enabled neurons to import glucose, the other was required for glycolysis, the main pathway by which cells typically metabolise glucose.

They found that removing either of these proteins stopped the breakdown of glucose in the isolated human neurons. "This is the most direct and clearest

evidence yet that neurons are metabolising glucose through glycolysis and that they need this fuel to maintain normal energy levels," said Nakamura, who is also an associate professor in the Department of neurology at UCSF.

The team next engineered mice's neurons, but not other brain cell types, to lack the proteins required for glucose import and glycolysis.

The mice were found to develop severe learning and memory problems as they aged, suggesting that neurons rely on glycolysis for for normal functioning, Nakamura explains.

"Interestingly, some of the defi-cits we saw in mice with impaired glycolysis varied between males and females," he added. "More research is needed to understand exactly why that is." The team also studied how the neurons adapted themselves in the absence of energy received through glycolysis - as might be the case in certain brain diseases.

They found that neurons used other energy sources, such as the related sugar molecule galactose. However, the researchers found that galactose was not as efficient a source of energy as glucose and that it could not fully compensate for the loss of glucose metabolism.



Presentation Convent School 'Violates' FFRC **Transportation Fee Orders**

Observer News Service

Srinagar: The Government Fee Fixation Committee for Private Schools (FFRC) Friday said that Convent Presentation Higher Secondary School Rajbagh was violating its orders by charging excessive transportation fees from the students.

In this regard, the Chairperson of the com-Justice (Retd) mittee, Sunil Hali has given one last opportunity to the school to appear before FFRC to explain its position by or before May-02.

Hali in a communiqué to the school has said that in pursuance to the complaint filed by the parent, notices were issued to the School Management.

"The main grievance of the complainant was that the School was charging Rs 1480 per month from the students as bus fee," Hali said.

It also said that the committee in October-2022 after detailed discussion with the stakeholders including the school had allowed a hike of 14 percent to the schools on the fee being charged by them in October 2019.

In September-2021, the school admitted that the school was charging Rs 1480 per month.

FFRC also said that the order was resolved in presence of the complainant. Transport Service provider, Principal and Manager of the school.

"Therefore as the order issued in October-2022 you were required to hike the bus fee by 14 percent from the amount which was being charged," Hali said, adding the school could hike the fee from 1480 by 14 percent as provided by the order in October-2022.

The committee also said that a notice was issued to the school management to appear before the committee on April-26-2023 to explain their position as to why their school was charging fees over and above the prescribed fee by this committee.

It said that in reply, the school management has said they have referred to some dispute between the complainant and school which is pending in the court of law. "It has no bearing to the present context in which the notice has been issued to you."

Hali said that the law will take its own course in case the complainant has committed any crime and it was irrelevant for the present proceedings.

He also said that the reply to the notice issued by this office is that the order issued in October-2022 relating to the fixation of Transport Charges does not apply to your school as it applies to those schools who are providing their

own transport. "Also as per your explanation you have outsourced this business to some Private transporter,'

RINAGAR: A file that broke-out in Pahlipora jungles of Dachigam this afternoon had spread to a larger area by this evening, devastat¬ing flora and fauna, reports said. The cause of the fire could not be ascertained Residents told ONS on phone in the evening that they could see flames raging in the jungles

According to the residents of the nearby areas smoke was seen billowing from out of the forest at around 4 pm and officials were immediately informed, who rushed to the spot in about an hour's time. By then the fire had caught speed and it spread in all directions devastating the thick forest cover in the area. Dachigam is known for its thick plant growth, which is home to hundreds of wild animals, including rare species of Hangul.

Residents living in Nishat Shalimar and Harwan areas told Ob¬server News Service this evening that fires raging in the jungles could be seen from a distance. They feared that by morning it could spread to other jungles nearby and devastate entire Dachi¬gam, which is a national wildlife park. It bears mention that Valley witnessed widespread forest fires last year which left vast tracts of forests in ashes.

s I perused my Facebook feed very recently, a chilling headline caught my eye: "Man Arrested for Cruelty to Dog Tied to Scooter." This begs the question: how many more instances of this kind of depravity, or even organised animal cruelty, are happening beyond our awareness? The sad truth is that animal cruelty has been a pervasive issue for ages, from inflicting pain and harm for specific gain, such as entertainment or zoosadism, to neglect and omission. This despicable behaviour has taken on different forms, from malnutrition, beating, transportation, research, and even slaughter.Even though animals were created to serve humans. we have always added to their misery and agony in one way or another.

mal experimentation and invest in innovative and effective alternatives that will truly advance medical progress.A startling revelation has been uncovered by a research published in the Annals of Internal Medicine. It exposes that universities often overstate the findings of animal experiments conducted in their labs and frequently promote research that has little to do with human health, all while failing to provide crucial details and recognize important limitations. The media also doesn't seem to be presenting the complete picture, as one study found that news stories about scientific meetings often leave out essential information, leading to a distorted perception of the science presented. Additionally, scientists rarely share the results of animal experiments that didn't yield expected results, leaving the public in the dark about the inefficacy of animal experimentation.

Strategies to Combat Animal Cruelty

Assume responsibility as a pet owner. Attend to your pet's needs and enrich its life with positive experiences. By setting an example of kindness, we can combat animal cruelty. Provide shelter to abandoned animals by fostering them to help them recover and find permanent loving homes. Interfere and report incidents of animal abuse, cruelty or neglect. Take action to stop animal mistreatment and seek help from others if necessary. Teach children to respect animals and demonstrate how to treat them with kindness. Support strict laws for animal welfare and stricter penalties for animal cruelty.Provide shelter to animals in need. You can make a significant difference in the life of an animal that has been mistreated by taking them out of harm's way.

Recognize that animal neglect can be linked to domestic violence. Often, animal abuse and domestic violence go hand in hand. By reporting suspected incidents, you may be able to help both the animals and the affected family. On World Veterinary Day 2023 **Promoting Diversity, Equity and Inclusiveness**



Growing Stray Dog Problem Is Evidence That The Sterilisation Programme Has Failed

The conflict between people and stray dogs in India has crossed the threshold of tolerance. While cases of young children being mauled to death by packs of dogs are in the news now, this phenomenon is not new. Over the last five years, more than 300 people – mostly children from poor and rural families – have been killed by dogs. Worse still, dogs are responsible for over 20,000 rabies deaths. A 2017 study showed that homeless dogs in rural areas can also be devastating for wildlife. Over 80 species, of which more than 30 are on the endangered list, were targeted by dogs in wilderness ar-eas. This mounting evidence points to a failure on the part of the government to implement policies that are both practical and humane to dogs, people, and wildlife.

But why are we facing such a problem with dogs? There is no one answer. The concept of dog "ownership" is nebulous for most Indians, with only a small fraction of urban dwellers falling into the category of what is now called "pet parents". Most dogs in rural areas are associated with households that feed them but do little else in terms of healthcare or welfare. In urban areas too, people from all walks of life feed dogs on the streets but very few take any direct responsibility. Ultimately it is the responsibility of the state to ensure that the lives of humans and domesticated animals are safe and secure. This is where the problem lies. The Animal Welfare Board of India, a statutory body under the Prevention of Cruelty to Animals Act, promulgated the Animal Birth Control (Dogs) Rules in 2001 (now replaced with the even more draconian ABC Rules 2023). This policy was meant to control both the dog population, as well the deadly rabies virus.



However, the ABC rules are not based on scientific evidence and violate guidelines provided by the World Health Organisation and the World Organisation for Animal Health for preventing rabies. The ABC Rules require a programme named after this year's Oscar-winning movie — Everything Everywhere All at Once. A sterilisation programme is most effective when it targets the majority of the popu-

lation in one go, is carried out continuously over the years, and when there are very low chances of new individuals coming into the population. This scenario is applicable only on islands, or where human settlements are very widely spaced.

It is easier said than done for a country with a dog population of 60-80 million. To expect a developing country like India to invest thousands of crores of rupees to set up the necessary infrastructure, and deploy lakhs of people to catch dogs, operate on them and take care of them, is a pipe dream. Especially considering that many regions of this country do not have adequate infrastructure for public health

Even if they are sterilised, dogs that continue to live on streets will still bite, chase people and vehicles, get into accidents, suffer from hunger and disease, and remain in conflict with people. Where resources are available, dog density will continue to increase, especially if people feed dogs on the streets. The only long-term solution is to implement strict pet ownership laws, prohibit people from carelessly feeding dogs everywhere, and set up facilities funded by animal welfare organisations that can either house dogs for life, or humanely euthanise them so they don't suffer on the streets. This policy is implemented across the world and was also espoused by Mahatma Gandhi over a century ago when he exhorted local authorities to build a pinjrapole for dogs or eliminate them altogether.

As long as dogs are homeless on the streets, the idea of a rabies-free India, with harmonious co-existence between people and dogs, will be a utopian dream. Keeping dogs homeless is bad for dogs, bad for people, and bad for wildlife.

India-China border situation 'generally stable': China's defence minister Gen Li tells Singh

Beijing: After India firmly told China that its violation of the border pacts has "eroded" the entire basis of bilateral ties, China's defence ministry on Friday said the situation at the border is "generally stable" and both sides should put the boundary issue in an "appropriate position" and promote its transition to "normalised management".

defence minis-China's ter General Li Shangfu, who is in New Delhi to attend Shanghai Cooperation the Organisation (SCO) Defence Ministers conference, held a 45-minute-long meeting with his Indian counterpart Rajnath Singh on Thursday during which the two ministers discussed the standoff at the eastern Ladakh area since May 2020.

At the meeting, Singh told Gen Li that China's violation of border agreements "eroded" the entire basis of ties between the two countries and that all issues relating to the frontier must be resolved in

accordance with the existing pacts. A Chinese Defence Ministry statement issued here on Friday said that during the meeting the two sides exchanged views on militaries and bilateral relations. Gen. Li pointed out that "currently, the situation on the China-India border is generally stable and the two sides have maintained communication through military and diplomatic channels"

"The two sides should take a long-term view, place the border issue in an appropriate position in bilateral relations, and promote the transition of the border situation to normalised management," he said.

"It is hoped that the two sides will work together to continuously enhance mutual trust between the two militaries and make proper contributions to the development of bilateral re-

lations," Li told Singh. He said that as major neighbouring countries and important developing countries, China and India share far more common

interests than differences. The two sides should view bilateral relations and each other's development from a comprehensive, long-term and strategic perspective, and jointly contribute wisdom and strength to world and regional peace and stability", he said.

The Indian government sources in New Delhi said Singh conveyed to Li that after disengagement in remaining friction points in eastern Ladakh, there should be a movement towards

de-escalation and expressed hope for a "positive response". In a statement, India's defence ministry said the two ministers had "frank discussions" about the developments in the India-China border areas as well as

bilateral relations. "The Raksha Mantri categorically conveyed that development of relations between India and China is premised on the prevalence of peace and tran-quillity at the borders," it said.

"He added that all issues at

the LAC need to be resolved in accordance with existing bilateral agreements and commitments," the ministry said in New Delhi

Singh "reiterated that violation of existing agreements has eroded the entire basis of bilateral relations and disengagement at the border will logically be followed with de-escalation," it said.

The talks took place hours after Li arrived in Delhi to attend the meeting of defence ministers of the SCO on Friday.

Singh also conveyed to Li that India wants to improve relations with China but it can happen only after peace and tranquillity are restored at the border, the sources said.

Defence Minister Singh categorically stated in the meeting that military cooperation between the two countries can progress only if peace and tranquillity are established at the border, they said.

In a tweet, Singh said: "Held discussions with China's

Defence Minister, General Li Shangfu in New Delhi.'

India has been slamming China's deployment of a massive number of troops and its aggressive behaviour along the LAC in eastern Ladakh in violation of pacts on border management.

The meeting between the two defence ministers took place days after the Indian and Chinese armies held the 18th round of military talks on ending the border row.

In the Corps Commander talks on April 23, the two sides agreed to stay in close touch and work out a mutually acceptable solution to the remaining issues in eastern Ladakh at the earliest. However, there was no indication of any clear forward movement in ending the three-year row.

On March 2, External Affairs Minister S Jaishankar held talks with his Chinese counterpart Qin Gang on the sidelines of a conclave of the G20 grouping in New Delhi.

It may be noted that following the devastating floods in 2014, the central government sanctioned a plan for the comprehensive flood management of the Jhelum River and its tributaries. The project was funded through the Prime Minister's Development Package, and divided into two phases.

The phase-I was completed by the end of 2020 after missing several deadlines. The government said that this phase – which mostly involved the dredging of the river to remove sediment - would enhance the discharge carrying capacity of the Jhelum from 31,800 cusecs to 41,000 cusecs.

The official said Phase II of the plan would increase the carrying capacity of river Jhelum and its flood spill channel by 20,000 cusecs through dredging. At present, the carrying capacity of Jhelum is around 31,000 cusecs while that of the flood channel is around 8,700 cusecs.

Following the incessant rainfall in the valley from the last four days, the river Jhelum has once again swelled up and giving nightmare to the people who witnessed 2014 deluge.

However, Chief Engineer I&FC Kashmir, Naresh Kumar told Kashmir Observer that there were no flood threats and the Jhelum was flowing below danger mark.

"There were floods in the Tangmarg area of North Kashmir. The authorities have issued advisory to people not to venture out in that particular area but overall the situation is good. The rains have stopped now" he added.

to three months. A local named Nisar and his family were providing all support from food to shelter. The material (explosives) had come from Pakistan through drone. They picked up the weapons and provided them to the terrorists. Weapons, grenades and ammunition explosives were included in that," he said.

He added that security forces are identifying more local support.

"They will be working on it strongly. The terrorists choose places close to forests, where they get local support and also have escape route into forests," he said.

Giving further details about the module, Singh said Nisar has been a militant for a long time.

"He was working as OGW of Pakistan origin LeT commander in the 1990s. He was under our radar. We had picked him two to three times in the past for interrogation. He was in our list of suspects and was picked this time too," he said.

"When interrogated, we found he was fully involved along with other family members," the DGP said.

On the modus operandi, he said that the militants first did recce of area, understood the terrain and considered aspects like speed of the vehicle to come down to zero in view of downhill terrains and sharp turn at the place of attack.

"They came close and ambushed the vehicle. Then they fired on the vehicle which got damaged. The troops got injured. They planted an IED, set it afire and exploded it," he said.

Singh said there is floating population of militants coming from Pakistan.

"They remain here for several months. They do recce and such acts. We have neutralised several of them also in the past. Two to four such terrorists remain active during a period of time." he said

"Now, therefore, in the interest of law and justice, it is enjoined upon all the registered dealers, officers/officials of the motor vehicle department, the general public, insurance agencies, and other stakeholders, not to make any sale/purchase or to register any vehicle involving a minor," the order reads.



"We urge the Lieutenant Governor Manoj Sinha to intervene in the matter and impress upon the authorities concerned to ensure our regularization as per service rules. Despite the SAC decision vide 258/22/2019 Dated-22/10/2019 to complete the regularization of all power engineers as a one time exemption in two months, more than four years have passed, no tangible progress has been made in this direction so far," he added.

Justice Tashi Rabstan Visits District Jail Amphalla In Jammu

JAMMU: Justice Tash Rabstan, Judge, High Court of J&K and Ladakh and Executive Chairman, J&K Legal Services Authority accompanied by Amit Kumar Gupta, Member Secretary, J&K LSA on Friday visited District Jail, Amphalla Jammu, where he was received by Secretary DLSA Jammu, Superintendent District Jail, Additional SP ,City Jammu, Chief Legal Aid Defense Counsel, Jammu and other jail staff.

On his arrival, Justice Tashi was given a ceremonial guard of honour, where after, he visited the e-mulakat center, where a jail inmate hailing from district Pulwama in Kashmir valley was having a virtual meeting with his parents and other family members. Justice Tashi was informed that whenever a iail inmate or his family member approaches the jail authorities for e-mulakat, the same is organized.

The Executive Chairman, J&K LSA enquired about the number of convicts serving their sentences and also about the under trial prisoners belonging to UT of J&K as well as other States and foreign nationals, upon which the Justice Tash Rabstan was informed that there were 06 foreign nationals lodged in the jail, out of which one is a national of Burma detained under PSA, one Bangla-

deshi national convicted in Foreigners Act. one Dutch national facing trial under 302 RPC, one Pakistani national and 3 Bangladeshi nationals whose trial is going on.

Iustice Tashi Rabstan later visited the male as well as female blocks and interacted with the inmates to enquire about the medical and other facilities provided to them. Subsequently, he also inspected the V.C facility, OPD unit, dental section, inmate calling area, vocational center as well as 10 bedded hospital located inside the jail.

The Superintendent of the jail informed Justice Tashi that the District Jail Amphalla, Jammu has a capacity of 426 persons, whereas, presently more than 700 inmates are residing in the jail. He further informed that out of the sanctioned strength of the staff he is managing the affairs of the jail with only 50% staff.

Justice Tashi appreciated the efforts made by the Govt. in general and Dept. of Prisons in particular for maintaining the standard of living in jail and providing all the basic necessary facilities like hygienic food, medical facilities and skill training etc., to the inmates. All the inmates of the jail during interaction admitted that they are being represented in their respective cases by the lawyers either engaged by them or provided by Legal Services Authority.

Neeraj Chopra Extends Support **To Protesting Wrestlers**

NEW DELHI: Olympic gold medallist Neeraj Chopra on Friday extended his support to the protesting wrestlers and called for "quick action" from the authorities in order to ensure that justice is served.

Chopra expressed his disappointment a day after Indian Olympic Association (IOA) president PT Usha came down heavily on the wrestlers for hitting the streets to resume their protests instead of approaching its athletes' commission to lodge their complaints against Wrestling Federation of India (WFI) chief Brij Bhushan Sharan Singh, who has been accused of sexual harassment and intimidation.

Ace javelin thrower Chopra, who scripted history by winning India's first-ever gold medal in athletics at the Olympics, said "it hurts" to see fellow athletes taking to the streets in search of justice.



He tweeted, "It hurts me to see our athletes on the streets demanding justice. They have worked hard to represent our great nation and make us proud. As a nation, we are responsible for safeguarding the integrity and dignity of every individual, athlete or not. What's happening should never happen.

'This is a sensitive issue, and must be dealt with in an impartial and transparent manner. Pertaining authorities must take quick action in order to ensure that justice is served.'

Guardiola Keeps Focus On PL As Real Madrid Looms

MANCHESTER: Manchester City manager Pep Guardiola is ignoring the widely held narrative that his team has pretty much wrapped up another Premier League title and can now start focusing on winning the Champions League for the first time. For Guardiola, one of his big-

gest challenges now is to keep his players in the present following City's 4-1 win over Arsenal on Wednesday. Nothing, he said on Friday,

has been decided. 'The reality is, we are behind," Guardiola said. "If the championship finished today,

they are champions." City might be in second place and two points behind Arsenal, but the defending champions are in charge of the title race after outplaying the long-time leaders at Etihad Stadium. City has two games in hand against West Ham and Brighton next month - and can move into first place, albeit possibly for only a couple of days, by

winning at Fulham on Sunday. Arsenal next plays against Chelsea on Tuesday and will be seeking its first win in five games after a dip in results right at the wrong time.

Listen to most soccer fans and scroll through social media, and you'd be forgiven for thinking the title race is already over.

"It's normal," Guardiola said, "that is the tendency — after what we have done in the past, Arsenal not being champions for a long time, we being undefeated in 15 games, seven in the Premier League.

"But I said to the players after Arsenal, what happened to Arsenal in the last games – three draws and one defeat - can happen to us. They say it's impossible. No, my friend, it can be possible. You can lose games and drop points in one week. If we are aware of that, it will be easier for us to not drop points."



For that reason, Guardiola has no intention of even starting to think about the two-legged meeting with Real Madrid in the Champions League semifinals as City seeks the one big title to elude the club.

The first leg is in Madrid on May 9, before which City plays three times in the Premier League - a competition Guardiola has previously said is his priority.

Now, as City bids for a Premier League-Champions League-FA Cup treble to match Manchester United's achievement from 1999, Guardiola is treating every game the same.

When you are 10-15 points behind the leader, then maybe you prioritise the Champions League but we haven't got the time to prioritise anything," he said. "The Premier League is so nice, so attractive. Being the champion is right now a similar level than you can tell me about the Champions League.

"The people say, Why? Because you don't have it (the Champions League).' But the Premier League is the Premier League. It's 11 months, it's every week, every week. My attention is Fulham, then West Ham and then it will be Leeds, 100%. After Leeds, I have enough time – not much because it is Saturday-Tuesday – but of course my (coaching) team will help me a bit to prepare for Madrid.'' (AP)
